Food prices push inflation higher

New Delhi, July 12: India's retail inflation rate rose for the first time in five months in June due to a sharp rise in food prices, government data showed Friday.

The Consumer Price Index (CPI) based retail inflation which was 4.8 per cent in May 2024 and 4.87 per cent in June 2023 (previous low) has increased to 5.08 per cent in June, 2024. Inflation in the food basket was 9.36 per cent in June, up from 8.69 per cent in May, according to the data released by the National Statistical Office. The government has tasked the Reserve Bank of India (RBI) to ensure that the CPI inflation remains at 4 per cent with a margin of 2 per cent on either side.

The RBI projected the CPI inflation for 2024-25 at 4.5 per cent, with Q1 at 4.9 per cent, Q2 at 3.8 per cent. Q3 at 4.6 per cent, and Q4 at 4.5 per cent. The central bank mainly factors in the retail inflation while deciding its bimonthly monetary policy

New Delhi, July 12: The Supreme Court Friday granted interim bail to Delhi Chief Minister Arvind Kejriwal in a money laundering case lodged by the Enforcement Directorate (ED) in the alleged excise policy scam but he will remain in jail as the CBI had arrested him in a related matter.

A bench of justices Sanjiv Khanna and Dipankar Datta referred to a larger bench, preferably of five judges, for in-depth consideration of three questions on the aspect of 'need and necessity of arrest' under the Prevention of Money Laundering Act (PMLA).

"Given the fact that right to life and liberty is sacrosanct, and Arvind Kejriwal has suffered incarceration of over 90 days, and that the questions referred to above require in-depth consideration by a larger bench, we direct that Arvind Kejriwal may be released on interim bail ..., on the same terms as imposed vide the order dated May 10, 2024," the bench said in its 64-page verdict.

The bench said any undue indulgence and latitude to ED will be deleterious to the constitutional values of rule of law and life and liberty of persons. **P9**

India population peak in 2060s June 25 'Samvidhaan

India is going to remain the world's most populous country throughout this century even as its population is predicated to decline after hitting the peak in the early 2060s, according to a report published by the United Nations Department of Economic and Social Affairs, Population Division. The country's current estimated population of 1.45 billion is set to increase to 1.69 billion by the early 2060s

United Nations, July 12: India's population is projected to peak in the early 2060s at about 1.7 billion and then decline by 12 per cent, but the country will remain the world's most populous throughout the century, the United Nations has said.

The World Population Prospects 2024 report, released here Thursday, said that the world's population is expected to continue growing over the coming 50-60 years, reaching a peak of around 10.3 billion people in the mid-2080s, up from 8.2 billion in 2024. After peaking, the global population is projected to start declining gradually, falling to 10.2 billion people by the end of the century.

India, which surpassed China



as the world's most populous nation last year, will continue to hold that position through 2100.

'The population of India, which is expected to remain the world's largest throughout the century, will likely decline by 12 per cent after reaching its peak in the early 2060s at about 1.7 billion," the UN report published by the United Nations Department of Economic and Social Affairs (DESA), Population Division said.

Responding to a question by PTI on population projections for India, Senior Population Affairs Officer, Population Division, UN DESA Clare Menozzi said at a press conference that "India is currently the largest country in the world in terms of population, and it is projected to stay so throughout the century. The population is

currently estimated at 1.45 billion, and it's supposed to increase further" to 1.69 billion.

"It's supposed to peak around the 2060s in size and then it starts to slightly decline. So by the end of the century, India is projected to be around 1.5 billion, but still the largest country in the world by a large margin.

The report said that China's population, currently 1.41 billion in 2024, will fall to 1.21 billion in 2054 and further decline

to 633 million by 2100. "It is anticipated that China, the country currently with the world's second-largest population, will likely experience the largest absolute population loss between 2024 and 2054 (204 million)," followed by Japan (21 million) and Russia (10 million). "Longer-range population proiections are more uncertain" for

"However, due to its large size and sustained low level of fertility, China is also likely to record the largest population decline of any country through the end of the century (786 million people). By 2100, China is projected to have lost more than a half of its current population and to have returned to a population size comparable to that recorded in the late 1950s (50 per cent probability).

Currently, nearly one-fifth of all countries and areas, including China, Italy, the Republic of Korea and Spain, are experiencing what is sometimes referred to as 'ultra-low' fertility, with fewer than 1.4 live births per woman over a lifetime. The report added that the global fertility rate currently stands at 2.25 live births per woman, down from 3.31 births in 1990.

"More than half of all countries and areas globally have fertility below the replacement level of 2.1 live births per woman. This is the level required for a population to maintain a constant size in the long run (without migration), with each generation being followed by another of roughly equal size," it said.

Pakistan is projected to overtake the US as the third-largest country in the world, with a population of 389 million in 2054.

Strong action against indiscipline: SJTA chief

Bhubaneswar, July 12: Strict action will be taken against those who indulge in indiscipline during the Bahuda Yatra of Lord Jagannath in Puri, a senior official said Friday amid outrage over the idol of Lord Balabhadra falling on some servitors during Rath Yatra.

After taking charge, Shree Jagannath Temple Administration (SJTA) chief administrator Arabinda Padhee said care will be taken so that such incidents do not happen again.

'We will take strong action against the persons who will indulge in unruly behaviour because we have noticed that some unauthorised persons were climbing the chariots and carrying mobile phones during Rath Yatra which is not allowed," he said.

Twelve servitors were injured when the idol fell while being taken out of the chariots after they reached Gundicha temple. It was alleged that several servitors were busy taking photos and videos on their mobile phones when the idol fell due to loss of balance.

"We seek forgiveness from the Lord for what happened. As per the decision of the temple managing committee, a committee has been formed and we should wait for its report," Padhee said.



Hansaria submitted that the concern is about preventive measures to be put in place as incidents of violence against doctors are occurring quite often.

Justice Khanna said the court cannot direct legislation, and nowadays, every hospital has a police officer or security in place

The senior advocate said this is not the situation in all hospitals and most of the medical institutions in rural areas lack such security apparatus.

Observing that anybody who indulges in violence can be dealt with under the Indian Penal Code, the bench said the only question is the implementa-

Step up measures to curb VBDs: CS 3 NEW MEDICAL

Bhubaneswar, July 12: At a time when vector-borne diseases (VBDs) like dengue and malaria are taking several districts into the grip, Chief Secretary Manoj Ahuja directed all the depart ment secretaries to stay alert for prevention and control the same.

In a letter the secretaries, the Chief Secretary said, "During monsoon and post monsoon pe riod, outbreak of vector borne diseases such as dengue and malaria are likely to increase. Further, occasional spells of rainfall can also result in an unprecedented rise in these cases. Moreover, dengue possesses a significant public health challenge due to its rapid spread & potential severity. Addressing dengue requires coordinated efforts at every level. Though dengue was known to be a mostly urban centric disease, now it has been observed that rural areas are also affected by it due to rapid urbanisation & population movement."

The letter also said, "Most VBDs can be controlled if appropriate preventive measures are undertaken collectively at the district level. Timely control & prevention measures are of paramount importance to reduce morbidity and mortality due to dengue and other VBDs.

Highlighting the role of all line departments in this regard, the Chief Secretary said these de-

Gaza, July 12: Israel's offensive in Gaza has pulverised most of its sports facilities and equipment but that has not stopped boxing coach Osama Ayoub training Palestinian girls in a tent camp that offers no protection from air strikes or shelling.

The boxing club, where girls once learned to jab, build their stamina and make friends, has been demolished.

There is no protective equipment, ring or punch bags in the open-air sandy space between the tents where displaced girls now practice - a mattress and pillow will have to do - but Ayoub says the training has helped


them overcome their fear of war. "They started going out on

the street. They started going out at night. Their personalities became much stronger, and even their families saw that they are stronger," he said.

It's all about improvisation. One very young girl unleashes punches barehanded and weaves left and right to dodge imagi-nary fists. "Throw a right," yells the coach, who then puts up his own fists for the girls to punch in turn.

Bhubaneswar, July 12: Tata Power-led power distribution companies (discoms) have invested ₹4,245 crore in infrastructure expansion and network upgradation in the state over the past three to four years, the company said Friday.

The company operates four discoms in joint ventures with the state government - TP Central Odisha Distribution (TPCODL), TP Western Odisha Distribution (TPWODL), TP Southern Odisha Distribution (TPSODL), and TP Northern Odisha Distribution Limited (TPNODL), collectively serving a customer base of over

Of the total investment, ₹1,232 crore has been allocated through various government-backed schemes. This includes laying of 2,177 circuit km (Ckm) of 33 kilovolt (KV) lines and 19,809 Ckm of 11 KV lines, as well as adding 30,230 distribution transformers to improve the distribution network's reliability across rural and urban areas, the company said.

Additionally, the company has commissioned 166 new primary substations (PSS), with 55 per cent of them being automated. These efforts have led to an average of 23.68 hour of power supply per day in urban areas and 21.98 hour in rural areas, exceeding national averages.

Furthermore, the network im provements have contributed to a reduction in Aggregate Transmission and Distribution (AT&C) losses, averaging 17.79 per cent in the state during the financial year 2023-24, the company added.

Crocodile nest numbers go down in Bhitarkanika



This year, the enumerators spotted 114 estuarine or saltwater crocodile nests in four wildlife and forest ranges under Bhitarkanika National Park against last vear's 122

Kendrapara, July 12: The recently conducted census has registered a fall in the number of crocodile nests this year in the famous Bhitarkanika National Park in this district.

A total of 114 estuarine crocodile nests were spotted in four wildlife and forest ranges within Bhitarkanika National Park by the enumerators, Divisional Forest Officer (DFO) of Rajnagar Mangrove (Forest) and Wildlife Division, Sudarshan Gopinath Yadav, said Friday.

Last year, the Bhitarkanika National Park authority had spotted 122 nests of estuarine crocodiles in the Kanika, Gahirmatha, Mahakalapara, and Rajnagar wildlife and forest ranges under Bhitarkanika National Park, Yaday informed.

According to Yadav, the Forest personnel have spotted 102 crocodile nests in the Kanika Forest and Wildlife Range, 10 nests under the Rajnagar Forest and Wildlife Range, and one each at the Gahirmatha Forest and Wildlife Range and the Mahakalapara Forest and Wildlife Range.

Last year, the Forest personnel had spotted 107 nests of crocodiles in the Kanika Forest and Wildlife Range, 12 nests under the Rajnagar Forest and Wildlife Range, one crocodile nest in the Gahirmatha Forest and Wildlife Range, and two nests in the

Generally, crocodiles tend to form nests in the same spot or nearby areas where they previously laid eggs as they are acquainted with the location.

Female crocodiles lay eggs inside the mangrove forest near the water bodies of the park and guard the eggs until the hatchlings emerge. During the nesting season, crocodiles lay eggs by creating mound-like nests with mangrove leaves. Hatchlings generally emerge from the nests after about 60 to 70 days.

As female crocodiles in Bhitarkanika National Park grow up to 14 feet, they can lay nearly 45 to 60 eggs. If a female crocodile grows longer than 14 feet, she is likely to lay more eggs, Forest officials said.

As many as 50 eggs from a wild nest were collected from the Kanika Forest and Wildlife Range to be incubated in captivity under semi-natural conditions at the Crocodile Breeding and Research Centre in Dangamal within Bhitarkanika National Park, the DFO said.

The 49-year-old captive albino, Gori, and the 21-year-old captive female albino, Mali, laid eggs a week ago in their nest and are now guarding the eggs, after a gap of three years, ACFin-charge of the Kanika Forest and Wildlife Range, Manas Kumar Das, said

Balasore, July 12: The Balasore District police in a bid to curb the menace of theft or dacoity in the jewellery shops and establishments have issued Standard Operating Procedure (SOP) guidelines for the owners.

Balasore Superintendent of Police Sagarika Nath held discussions with the shop owners Friday in presence of the DIG (Eastern Range) Satyajit Nayak.

The SP besides sharing a helpline number to the shop owners and managers through which they can share any suspicious information, urged them to install cloud storage based CCTV systems which will act as force multipliers for the police.

She also asked the jewellery shop owners for mandatory character verification of all individuals employed in their shops.

The SP also suggested introduction of a register where any individual or customer entering the shop would fill in their Name, ID proof and phone

The shop urged to remain alert and cautious of individuals entering their establishments posing as customers.

The district police came on their toes after a plan to commit dacoity targeting jewellery shops was foiled recently by the special squad of Balasore Police.

"Two miscreants who came to Balasore for advance reconnaissance supposedly to commit loot of jewellery shops were apprehended and handed over to Ranchi Police where they have previous antecedents. Evidence of recce of one renowned jewellery shop was found on their mobile phone. This incident prompted police to alert the jewellery shop owners and issue safety advisories for them," Nath said.

Berhampur, July 12: Berhampur University here has decided to set up two dedicated gardens within its campus, aimed at preserving endangered plant species and promoting medicinal plants

Vice-Chancellor Geetanjali Dash said the primary goal of these exclusive gardens is twofold - to safeguard endangered plant species and to cultivate medicinal plants for educational and research pur-

poses in the field of botany. She emphasised the educational benefits for students and researchers who will have access to a diverse array of plant species. Padmalochan Hembram, an assistant professor in the Botany department overseeing the drive, said they have identified around an acre for setting up a garden for endangered species and another for medicinal plants.

In the garden for endangered species, 200 saplings of 73 various species will be planted, while the latter will feature over 300 plants from 93 medicinal species recognised by the National Medicinal Plant Board.

Hembram informed that they have already gathered 50 species each of endangered plants and medicinal plants from various locations within and outside the state to populate these gardens.

NSA Reshuffle

The National Security Council Secretariat has undergone several notable changes recently, while also maintaining some continuity. Previously Secretary (West) in the External Affairs Ministry, Pavan Kapoor has been appointed Deputy National Security Adviser (NSA). This move is part of a series of appointments that include Rajinder Khanna, who has been promoted from Deputy NSA to the newly established role of Additional NSA. Khanna, a former chief of India's external intelligence agency, Research & Analysis Wing (R&AW), is stepping into a pivotal role that didn't exist before.

Another key appointment is T.V. Ravichandran, an IPS officer currently serving as Special Director in the Intelligence Bureau. He replaces Khanna as Deputy NSA. Ravichandran's initial tenure is set to last until his retirement on August 31, 2024, after which he may continue on a contractual basis. This reshuffle follows the recent appointment of Vikram Misri as the next Foreign Secretary, effective from July 15.


These changes mean that under NSA Ajit Doval, who is now in his third term, there will be one Additional NSA and three Deputy NSAs. The Appointments Committee of the Cabinet has played a crucial role in arranging these appointments, ensuring a blend of fresh perspectives and experienced leadership within the NSCS.

The strategic nature of these appointments might hint at potential future shifts within the NSA office itself. Delhi is currently abuzz with rumours of a major reshuffle of key secretaries and other significant positions, possibly in September. While these moves appear subtle, they could signal broader changes within India's national security

WB: Accusations fly against top officials

West Bengal Governor C.V. Ananda Bose has stirred up quite the controversy by writing to Union Home Minister Amit Shah, urging strict

action against West Bengal's Chief Secretary B.P. Gopalika and two senior police officers, Kolkata Police Commissioner Vineet Kumar Goyal and Deputy Police Commissioner (Central) Indira Mukherjee. These letters, sent last month, accuse the offi



cers of serious misconduct, claiming they have blatantly violated All India Services (AIS) conduct rules and acted as "willing accomplices in the misdeeds of the ruling dispensation".

Sources have informed DKB that the Union Home Ministry has initiated disciplinary action against Goyal and Mukherjee for allegedly maligning the office of the state Governor by "promoting and spread-

Bose's detailed notes have created quite a stir in the babu corridors of North Block. Reportedly, in his letters, Bose outlined how the officers, particularly Chief Secretary Gopalika, have openly disregarded the Constitution and conduct rules. He warned that failure to take action could further deteriorate the integrity of the Services and harm national interests. The governor accused Gopalika of aiding and abetting corruption and highlighted issues like job recruitment scandals and alleged lawlessness in the state.

Bose also added allegations against Goyal and Mukherjee, linking them to an investigation into sexual misconduct allegations against him. These accusations seem to be part of a broader effort by Bose to clear his name, as he has previously dismissed the sexual harassment claims

Interestingly, Bose's letters come amidst speculation about his potential removal from his post in Bengal. Factors such as dissent among state BJP leaders and the common practice of reshuffling Raj Bhavan after a new regime takes office in Delhi, fuel these rumours. Despite this, sources indicate that the bureaucratic follow-up on Bose's letters has already begun, making his tenure's continuity less critical.

Bose's time as governor, which began on November 22, 2022, has been anything but smooth. Initially welcomed warmly by Chief Minister Mamata Banerjee, their relationship quickly soured due to his perceived alignment with the BJP. Bose has faced numerous clashes with the Trinamool Congress, which has accused him of being a Central government puppet, especially after sexual harassment allegations against him surfaced.

The drama continues to unfold, as it is expected that Chief Minister Mamata Banerjee will retaliate strongly. Watch this space for updates.

Gujarat HC dismisses babu's cadre transfer plea

The Gujarat High Court has just thrown out the petition of Hitesh Kumar Makwana (IAS: 1995: TN), who was seeking a transfer from Tamil Nadu to his home state of Gujarat. The court pointed out that such a change at the tail end of his career would cause a domino effect on other appointments within the cadre.

Makwana has been battling this issue legally since 1996, almost right after his cadre was assigned. He argued that based on the 2:1 ratio for cadre allotment favouring outsiders and insiders, he should have been placed in Gujarat as an insider. After being denied by the Centre, he took his case to the Central Administrative Tribunal (CAT) and then escalated it to the High Court.

However, the Centre stood firm, stating that Makwana had no inherent right to be placed in his home state's cadre. They emphasised that cadre allocation is an administrative matter and can only be subject to judicial review in clear cases of discrimination.

So, after years of legal wrangling, the court's decision brings this longstanding fight to a close. It's a reminder that cadre allocations, while seemingly bureaucratic, have broader implications and are not easily

his summer of recordbreaking heat waves and contentious elections around the world offers a valuable opportunity to reflect on the role individuals can play in driving positive change. By building coalitions and amplifying the voices of those most affected by crises, we can muster the courage and political will needed to overcome seemingly insurmountable global challenges.

Climate change and biodiversity loss are prime examples. As a longtime environmental-justice advocate, I have seen firsthand the profound impact of both on frontline communities and indigenous peoples. These populations have been hit the hardest by these interlinked crises, which jeopardize their livelihoods, health, and cultural heritage.

The diverse land and marine environments that sustain indigenous communities also underpin life and society as we know it. We depend on healthy ecosystems for food, shelter, water, medical advances, and disease prevention. More than 50% of the world's GDP, estimated at \$44 trillion, depends on nature. Crucially, thriving ecosystems act as natural carbon sinks, absorbing up to 50% of the greenhouse gases produced by human activities.

By threatening critical carbon sinks like rainforests and oceans, biodiversity loss exacerbates climate change, which in turn accelerates environmental degradation, leaving millions of people, as well as countless plant and animal species, increasingly vulnerable. The good news is that we can reverse this: by fostering resilient and diverse ecosystems, we can mitigate the effects of climate change and create a virtuous circle that protects frontline communities.



Amid the largest mass extinction in more than 65 million years, protecting biodiversity is more urgent than ever. Studies show that nearly half of the world's animal species are currently experiencing rapid population declines, with Latin America and Africa facing the most severe loss of biodiversity

While these developments paint a bleak picture, there has been some progress in addressing the biodiversity crisis. In 2022, at the United Nations summit on biodiversity in Montreal (COP15), the parties to the UN Convention on Biological Diversity approved the Kunming-Montreal Global Biodiversity Framework (GBF). This landmark agreement, which required years of coalition building and advocacy campaigns, outlined a strategy to stop and reverse nature loss, including the ambitious target of preserving at least 30% of the world's land and seas by 2030.

Under the GBF, developed countries pledged to provide the Global South, where most of the world's remaining biodiversity is located, with at least \$20 billion annually by 2025 and \$30 billion annually by 2030. If fulfilled, these commitments would enable developing countries to implement ambitious national biodiversity action plans, thereby safeguarding the world's most climate-vulnerable populations.

Unfortunately, the world is currently far from achieving these goals. A new report by the London-based think tank ODI reveals that, of the 28 countries it assessed, 23 have failed to fulfill their biodiversity financing commitments as of 2021 (the latest year for which data are available). To meet their 2025 targets, these countries would need to double their

The gulf between climate pledges and action appears even more troubling when one considers that \$20 billion per year represents only 1.1% of the \$1.8 tril lion that countries around the world spend annually on environmentally harmful subsidies. These resources, equivalent to 2% of global GDP, support sectors like fossil fuels and industrial agriculture, which account for most greenhouse-gas emissions and drive biodiversity loss.

To protect the planet's natural assets, governments must align their spending with their stated values. The European Union's new Nature Restoration Law, which aims to restore at least 20% of the EU's land and seas by 2030, and all degraded ecosystems by 2050, represents important step in this direction.

To be sure, there is much more to be done. Ahead of October's UN biodiversity conference in Colombia (COP16) policymakers and climate advocates must continue to build global coalitions to close the biodiversity financing gap. They must also ensure that when it comes to conservation and restoration projects, the communities most affected by environmental degradation– especially indigenous peoplesare included in the decisionmaking process.

Protecting and restoring biodiversity is crucial to supporting the recovery of our planet's natural ecosystems and mitigating the worst effects of climate change. At COP16, global leaders will have the chance to create a virtuous circle of change. Ensuring a sustainable future requires that they seize this opportunity.

The conundrum of essential religious practice-

It has also empowered the state to put restrictions for ensuring 'public order, health, and morality', regulate and restrict any economic, financial, political or other secular activity associated religious practice'. Further it has vested in the

state to make laws for social welfare and reform'. With public demonstrations of religiosity on the rise and spirituality and secular spirit on the wane in India, the latest decision of Justice Swaminathan of Madras High Court in the P Navin Kumaran Case (2024) upholding the practice of devotees rolling over the banana leaves on which other devotees had taken food as an essential practice has raised the hackles of many discerning analysts. The major debating points are; how to determine what constitutes essential religious practice and to what extent the judiciary has been consistent in their decision making.

Devotees believe that such an act would confer on them spiritual benefit. Justice Swaminathan has overruled an order given by Justice Manikaran in 2015 outlawing such a practice. Justice Swaminathan believes that the right to move in Article 19(1) (d0) includes the right to roll over banana leaves. This right is not traceable to only Article 25(1) but also to the also to the right to privacy under Article 21. What Article 25(2) contemplates is not regulation by the state of religious practices as such, except when they run counter to public order, health, and morality. This judgement begs the question of whether rolling over on used banana leaves is not an unhygienic practice. Further, can the right to privacy be invoked in a public space? Surprisingly, Justice Swaminathan observes" If right to privacy includes sexual and gender orientation, it would also include people's spiritual

Matt Case (1954) the Supreme Court had ruled that what constitutes the essential part of religion is primarily to be ascertained with reference to doctrines of that religion. In an interesting case, while the Calcutta High court found Tandav dance by Anand Margis an essential practice, the Supreme Court in Avadhuta Case (2004) overruled it by looking at earlier judicial verdicts and not religious texts. Since Anand Marg came into existence in 1955 & Tandav dance from 1966, the court felt that faith had existed without practice. By this logic, no Jewish, Christian or Islamic practice can be protected if it was not considered integral during the life time of Moses, Christ or Muhammad!

There have been, however, a few edifying judgements like Church of God Vs Colony welfare case (2000) where the court while banning loud speakers in religious places had held that 'undisputedly no religion prescribed that prayers should be performed by disturbing the peace of other nor does it preach that they should be through

Invoking Article 17, which bans untouchability, excluding women in the age of 10-50 based on their menstrual status for entering the temple, Justice Chandrachud observed 'has no place in a constitutional order founded on dignity and liberty."

It was CJ Lathman of Australia who had observed in the Adelaide Company case (1943) : What is religion to one is superstition to another. CJMC Chagla in the State of Bombay vs Narasu Appa Mali Case (1951) had rightly observed: What the state protects is religious faith and belief. If the religious practices run contrary to public order, morality or health, then religious practices must give way before the good of the people of the state as a whole. The Courts. instead of substituting for clergy or priests to interpret religious texts, should stick to the constitutional restrictions of morality, health and public order.

Himachal Pradesh's shrinking snow cover

Shimla experiences almost negligible snow spells during the last two winters


Shimla, July 12: The seasonal snow cover in Chenab, Beas, Ravi and Sutlej river basins in Himachal Pradesh decreased by 12.72 per cent in 2023-24 compared to 14.25 per cent in 2022-23, a statement issued here Friday

During the early winter months of 2023-24 (October to November), the Chenab, Beas and Sutlej basins showed negative trends in snow cover, whereas the Ravi basin showed a marginal increase, reflecting a positive trend, the statement quoting a study said.

However, results for the peak winter months indicated significant declines in all the basins -- 67 per cent in Sutlej, 44 per cent în Ravi, 43 per cent in Beas and 42 per cent in Chenab in January 2024, according to the study conducted by the State Centre on Climate Change, under the aegis of the HP Council for Science, Technology, and Environment (HIMCOSTE).

In February, a positive trend was observed in all basins, with an increase in snow cover, con tinuing into March 2024.

Based on the analysis, it was observed that the decline was 15.39 per cent in the Chenab basin, 7.65 per cent in Beas, 9.89 per cent in Ravi and 12.45 per cent in Sutlej in 2023-24, leading to an overall decline was 12.72 per cent. Director-cum-Member

 Concrete steps like switching over to e-vehicles and renewable energy, which will help in reducing greenhouse gas emissions, need to be taken so that the rise in temperatures can be checked

"We have information about the total snowfall during the winter season from the various observatories operating throughout the State but its spatial extent reflecting that how much area is under snow, cannot be ascertained. But it has now become possible to map the geographical extent of the area

covered under snow during winter season from October to April by using satellite data of different resolutions," Rana said.

Based on various studies, the temperature in the Higher Himalayan Region is comparatively higher than the low-lying areas, which is affecting Himalayan reserves, evidenced by the fact that most of the glaciers are losing mass, Chief Secretary Prabodh Saxena said.

A significant shift in snowfall patterns during winters has also been observed, affecting river discharge during the peak

summer season, Saxena said. Shimla has experienced almost negligible snow spells during the last two winters, indicating major changes in weather patterns and if this continues, water shortages may occur in the coming years, he added.

K'taka to challenge CWRC order on water release

Despite a 28% deficit in rainfall, an all-party meeting will be convened to decide the state's next actions

Bangalore, July 12: Karnataka Chief Minister Siddaramaiah Friday said an appeal will be filed against the Cauvery Water Regulation Committee's (CWRC) directive to the State to release one tmcft of Cauvery river water to Tamil Nadu daily till the end

of this month. After a meeting with Deputy Chief Minister DK Shivakumar, who is also the Water Resources Minister, Ministers from the Cauvery river basin area, and officials, he also said that an allparty meeting will be held July 14 to decide on the state's next course of action.

On July 5, the Krishnaraja Sagar dam recorded a water level exceeding 100 feet, yet remains below its full capacity of 124.80 feet. Between June 1 and July 9, Karnataka experienced an inflow of just 41.651 tmc ft into its four reservoirs, marking a 28.71% shortfall compared to historical averages.

"Despite forecasts for normal rains this time, there is a deficit of 28 per cent in inflow so far. This was clearly stated by us in our stand before the CWRC. Also, we requested not to take any decision till the end of July, still CWRC has asked to release one tmcft of water every day from July 12," Siddaramaiah said.

He said today's meeting opined that the government should file an appeal against this order before the Cauvery Water Management Authority (CWMA).

"All parties are together on Karnataka's water issue Therefore, an all-party meeting will be held (July 14)," the Chief Minister said.

Union Ministers, Members of Lok Sabha and Rajya Sabha Members from the State and MLAs from Cauvery river basin region will also be invited to the meeting, he said, adding, the government will decide its next move taking everyone into con-

Siddaramaiah said 5000 cusecs of water is being released to Tamil Nadu at Biligundlu which is equal to the Kabini dam inflow.

A total of only 60 tmcft of water is available in all the four reservoirs of Cauvery basin in the state, he pointed out, adding that "We also need to provide water for agricultural activities. So, keeping in mind the deficit rains, we have requested to wait till July end."

Tamil Nadu has raised concerns that Karnataka did not maintain necessary environmental water flows between February and May 2024. As the current year is classified as normal, Tamil Nadu asserts that the water flow at Biligundlu should align with the Cauvery Water Dispute Tribunal's award, which has been upheld by the Supreme Court.

Lightning strikes kill 21 in Bihar

The complaint was lodged by the ruling party's Undi MLA K Raghurama Krishna Raju, who was a YSRCP Lok Sabha MP between 2019 and 2024 but had a fallout with Reddy at an early stage.

Besides Reddy, police booked senior IPS officers PV Sunil Kumar and PSR Sitaramanjaneyulu and retired police officer R Vijay Paul and former Guntur Government General Hospital superintendent G Prabhavati, the official said. Vijay Paul and Prabhavati have superannuated.

'Raju sent his police com-



plaint through mail one month ago and after taking legal opinion, I registered a case at 7 pm Thursday against the former CM and others," the official told PTI. Raju, a former MP, also alleged that he was subjected to "custodial torture," the official added. Police booked the five accused persons under IPC Sections 120 B, 166, 167, 197, 307, 326, 465 and 506 read with 34. Police invoked the Indian Penal Code (IPC) as the case is three years old. The case was booked at Nagarampalem police station in Guntur. TDP leader Raju's 2021 arrest case came to he lodged a complaint against Reddy and some officials over it

He accused the former CM and the senior officials of "plotting" a criminal "conspiracy" against him. Raju, 62, alleged in his complaint that senior IPS officers Sunil Kumar and Sitaramanjaneyulu, police officer Vijaya Paul and government doctor Prabhavathi were part of that "conspiracy.

He was arrested in May, 2021 in the middle of the Covid-19 second wave. "A false case was registered against me by the CB-CID of the Andhra Pradesh government. I was arrested May 14, 2021 without due process, I was bullied, unlawfully physically pulled inside the police vehicle, and forcibly taken to Guntur the same night," Raju alleged in the complaint.

Terming the apex court's order "historic" for the entire country, AAP Rajya Sabha MP Sandeep Pathak noted some decisions of the court determine the direction

in which the country will move. While granting interim bail to Kejriwal, the top court said it is up to Kejriwal to decide if he should continue as Chief

It also referred the questions concerning the legality of his arrest in the Enforcement Directorate (ED) case to a larger bench. The court said since the matter is concerned with the right to life and the issue of arrest has been referred to a larger bench, Kejriwal be released on interim bail.

AAP Rajya Sabha MP Pathak said, "The court has studied this case and sent it to a larger bench. We believe that whatever the Supreme Court does, it will be good for the country and will give direction to the country in

Bharadwaj said the court has considered that Section 19 of the Prevention of Money Laundering Act (PMLA) under which ED has arrested Kejriwal, is "subjective".

The AAP is hopeful that Kejriwal will also be granted bail in the excise policy case filed by the CBI, Bharadwaj said. However, Delhi BJP chief Sachdeva said that following the apex court's order, Kejriwal has no right to receive government allowance, use a government of Delhi's Chief Minister.

NEET-UG HC grants CBI custody of 13 accused

National Testing Agency (NTA) over the alleged irregularities in NEET-UG 2024 results in Patna, Bihar

New Delhi, July 12: The Patna High Court Friday granted the CBI the custody of 13 people arrested by the Bihar police in connection with NEET-UG paper leak case.

The central probe agency will now be able to question these accused in custody and also confront them with kingpin Rockey alias Rakesh Ranjan who was arrested Thursday.

The agency had sought the custody of the 13 individuals, arrested by the state police, who were subsequently sent to judicial custody following a brief period of police remand.

The CBI plea was turned down by the Exclusive Magistrate, CBI, Patna July 2 on the grounds that the statutory period seeking police custody within the first 15 days since the arrest had elapsed.

The CBI challenged the order in the High Court saying that it had taken up investigation in June and should be given chance to examine the suspects arrested by the state police.

The central agency had said the accused arrested by the state police had not even undergone 15 days of police custody. According to sources, the accused were in the custody of the Patna Police and Economic Offence Units of the Bihar Police for just two to four days and sent to judicial custody. The CBI argued that it may be given the custody of these accused for the remaining period of their police remand which could be from 11-13 days which was granted by the High Court. The agency's own FIR on a reference from the Union Education Ministry pertains to a "comprehensive investigation" into the alleged irregularities in the ex-

Another rocket failure for China

Beijing: A Chinese rocket start-up has suffered yet another launch failure, resulting in the loss of three satellites as part of a commercial constellation being assembled for global weather forecasting and earthquake prediction. Hyperbola-1, a 24-metre high solid-fuel rocket produced by iSpace, lifted off Thursday from the Jiuguan Satellite Launch Centre in China's Gobi Desert. "The rocket's first, second and third stages flew normally, but the fourth stage suffered an anomaly and the launch mission ended in failure," the company said.

7 Indians among 60 missing in landslide

Indian nationals are among more than 60 passengers who are believed to be missing after two buses were swent away by a massive landslide and pushed into a swollen river in Nepal early Friday, officials and media reports said. The two buses carrying 65 passengers went missing in the Trishuli River in the landslides at Simaltal area along the Narayanghat-Mugling road in Chitwan district.

Tax hikes for rich: **Putin signs bill**

Moscow: Russian President Vladimir Putin Fridav endorsed a bill that raises income taxes for the rich, part of efforts to help fill government coffers during the fighting in Ukraine, Putin signed the bill into law two days after it was approved by both houses of parliament. The legislation, which envisages a progressive tax on personal income, is a major change from the flatrate tax that was widely credited with improving revenue collections after it was introduced in 2001.

Indian techie drowns in US

Washington: A 26-year-old Indian IT professional working in California drowned in the famous Glacier National Park in the US state of Montana while on vacation with friends, according to park authorities. The victim has been identified as Siddhant Vitthal Patil, the National Park Service said in a statement. Patil, who was a technology professional, was hiking above the gorge June 6 on Avalanche Lake Trail, where he fell off a large rock into Avalanche Creek.

Prachanda loses trust vote

EX-PREMIER KP SHARMA OLI SET TO BE NEW NEPAL PRIME MINISTER

Kathmandu, July 12: Nepal Prime Minister Pushpa Kamal Dahal 'Prachanda' Friday lost a vote of confidence in Parliament after coalition partner CPN-UML withdrew its support to him, a development that will lead to the formation of a new government led by ex-premier K P Sharma Oli.


Prachanda received only 63 votes in the 275-member House of Representatives (HoR) and there were 194 votes against the motion. At least 138 votes are needed to win the vote of trust.

A total of 258 HoR members participated in the voting while one member abstained.

Prachanda, 69, chairman of the Communist Party of Nepal-Maoist Centre (CPN-MC), had survived four trust votes since he assumed the Prime Minister's post December 25, 2022.

He faced the same predicament vet another time because former Prime Minister Oli-led Communist Party of Nepal-Unified Marxist Leninist (CPN-UML) withdrew support from the Prachanda-led government last week after inking a powersharing deal with the largest party in the House, the Nepali Congress (NC).

Earlier, Speaker of the HoR Dev Raj Ghimire put Prachanda's Vote of Trust for voting according to Article 100 Clause 2 of the Constitution. After voting was

As the HoR session began in the early afternoon, embattled Prachanda sharply criticised the Nepali Congress and the CPN-UML for striking an alliance "out of fear" rather than shared principles and accused them of pushing the nation toward regression.

Prachanda voiced concerns about potential regression and autocracy, asserting that the NC and the CPN-UML had joined forces as good governance began to take root in the country.

Washington, July 12: US President Joe Biden mistakenly introduced Ukraine's President Volodymyr Zelenskyy as his Russian foe Vladimir Putin at a NATO summit Thursday in a blunder just hours before a press conference that could decide the fate of his reelection bid.

The 81-year-old quickly corrected himself, and Zelenskyy quipped that he was "better' than Putin, but the gaffe intensified concerns about Biden's mental acuity after a disastrous debate performance against Donald Trump two weeks ago.

"And now I want to hand it over to the President of Ukraine, who has as much courage as he has determination, ladies and gentlemen, President Putin, Biden said as he announced a NATO-Ukraine compact at the summit in Washington.

Biden turned away from the lectern before coming back and exclaiming: "President Putin! He's going to beat President Putin. President Zelenskyy, I'm so focused on beating Putin we gotta worry about it. Anyway, Mr President.

The error drew gasps from the room but Zelenskyy, Ukraine's wartime leader against Russia's 2022 invasion, laughed

Fellow leaders at the summit have fielded questions about Biden, and their answers have



largely been supportive.

'Slips of the tongue happen, and if you keep a close enough eye on everyone, you will find enough," German Chancellor Olaf Scholz said after the President's latest gaffe.

French President Emmanuel Macron said Biden had appeared 'in charge," while British Prime Minister Keir Starmer said he was on good form.

But his latest verbal slip could not have come at a worse time as Biden is due later Thursday to give what the White House has called a "big boy" press conference, his first major appearance since the debate.

The solo appearance, a rare unscripted encounter with reporters, comes amid growing calls in his Democratic Party for him to step aside.

The press conference was due to start at 6:30 pm but is expected to run around an hour late.

Islamabad, July 12: Pakistan's Supreme Court Friday ruled that Imran Khan's party was eligible for more than 20 seats reserved for women and minorities in Parliament, in a major legal victory for the jailed former Prime Minister, who demanded the resignation of the election commission chief

Candidates backed by Khan's Pakistan Tehreek-e-Insaf (PTI) party, who had contested and won the February 8 elections as independents after their party was stripped of its election symbol, had joined the Sunni Ittehad Council (SIC), a political alliance of Islamic political and Barelvi religious parties in Pakistan, to form a coalition of convenience.

The SIC had filed a plea challenging the Peshawar High Court (PHC) decision upholding the Election Commission of Pakistan (ECP) move to deny its share in reserved seats in the assemblies.

A 13-member full bench headed by Chief Justice Qazi Faez Isa heard the case. The ruling in the keenly awaited case is viewed as a major setback to Prime Minister Shehbaz Sharif's ruling coalition though there is no



immediate threat to the federal government.

Chief Justice Isa had announced after the proceedings Tuesday that the panel decided to reserve the verdict for mutual consultation, which it announced Friday. A majority of eight judges

ruled in favour of SIC by overturning the orders of the top election body and the judgment of the Peshawar High Court. The judgment was announced by Justice Mansoor Ali Shah.

"The order of the Election Commission of Pakistan, dated 1st of March 2024, is declared to be to ultra vires to (beyond the powers of) the Constitution, without lawful authority and of no legal effect," according to the verdict.

The verdict further declared that the Pakistan Tehreek-e-Insaf was a political party and eligible for reserved seats. "The Pakistan Tehreek-e-Insaf (PTI) was a political party, remains a political party", the order said while instructing the PTI to submit a list of its reserved seats candidates within 15 days.

India abstains on UNGA resolution

The resolution demands Russia to immediately cease its aggression against Ukraine

United Nations, July 12: India has abstained in the UN General Assembly on a resolution that demanded that Russia immediately cease its aggression against Ukraine and urgently withdraw its military and other unauthorised personnel from the Zaporizhzhia nuclear power plant.

The 193-member UN General Assembly adopted the resolution Thursday with 99 votes in favour. nine against and 60 abstentions, including India, Bangladesh, Bhutan, China, Egypt, Nepal Pakistan, Saudi Arabia, South Africa and Sri Lanka. Those voting against the resolution included Belarus, Cuba, North Korea, Russia and Syria.

The resolution titled 'Safety and security of nuclear facilities of Ukraine, including the Zaporizhzhia nuclear power plant' demanded that Russia "immediately cease its aggression against Ukraine and unconditionally withdraw all of its military forces from the territory of Ukraine within its internationally recognised borders."

It also demanded that Russia urgently withdraw its military and other unauthorised personnel from the Zaporizhzhia nuclear power plant and immediately return the plant to the full control of the sovereign and competent authorities of Ukraine

to ensure its safety and security. It called for the "immediate cessation of the attacks" by Russia against the critical energy infrastructure of Ukraine, which increases the risk of a nuclear accident or incident at all nuclear facilities of Ukraine.

The draft resolution was introduced by Ukraine and was sponsored by over 50 member states, including France,

Germany and the United States. It called upon Moscow, until it returns the Zaporizhzhia nuclear power plant of Ukraine to the full control of the sovereign and competent authorities of Ukraine, to provide the International Atomic Energy Agency Support and Assistance Mission to Zaporizhzhia with timely and full access to all areas at the plant that are important for nuclear safety and security to allow the Agency to report fully on the nuclear safety and security situation at the site.

In the explanation of the vote before the vote on the resolution, Russia's First Deputy Permanent Representative Dmitry Polyanskiy said the General Assembly has "unfortunately" adopted many documents that are non-consensual, politicised and do not reflect reality.

"Make no mistake votes in favour of today's draft will be regarded by Kyiv, Washington, Brussels and London as evidence of support for their policy of further escalating the Ukrainian conflict to the detriment of steps taken by a sensible part of the international community to find a peaceful, sustainable and long-term solution to the conflict," he said.

Japan announces disciplinary action against defence officials

Tokyo, July 12: Japan's defence ministry announced disciplinary action Friday against more than 200 senior officials and service members over mishandling of classified materials and other misconduct, an embarrassment that could undermine Tokyo's efforts to work more closely with United States and other partners in the face of China's growing threat.

Defence Forces have been under scrutiny over allegations that members of the navy violated the sensitive information protection law, as well as other misconduct such as falsely claiming allowances for special assignments, or wrongfully claiming free meals at base cafeterias. Ministerial staff were also accused of abuses of power.

The Ministry and its Self



Defence Minister Minoru Kihara apologized, saying the problems "significantly damaging to the public trust" for the ministry and Japan's defense forces. "I'm keenly aware of my responsibility."

He blamed a lack of discipline across the organization.

Kihara said the ministry's investigation found that classified information was mishandled on 38 destroyers and submarines, but said no sensitive information leaked outside of military or caused any harm. People without appropriate clearances were were routinely assigned to duties that involved sensitive information.

Seoul, July 12: The US and South Korea signed joint nuclear deterrence guidelines for the first time, a basic yet important step in their efforts to improve deterrence toward North Korea's evolving nuclear threats.

Meeting Thursday on the sidelines of a NATO summit in Washington, President Joe Biden and South Korean President Yoon Suk Yeol commended what they called "the tremendous progress" that their countries' alliance have made a year after creating a joint Nuclear Consultative Group.

The two leaders authorized the US-ROK Guidelines for Nuclear Deterrence and Nuclear Operations on the Korean Peninsula" that was signed by their defense officials earlier Thursday, according to South Korea's presidential office. ROK

Kim Tae-hyo, a deputy national security director in South Korea, told reporters that South Korea and the US will conduct ioint military exercises to help implement the deterrence guidelines. He said the US would commit specific nuclear assets to a role in deterrence plans, but experts added that this does not mean it would place nuclear weapons in South Korea

Specifics of the guidelines, which Seoul called confidential, were not available, though the US will certainly retain control of its nuclear weapons.

"The key is how to integrate South Korea's conventional weapons and America's nuclear weapons to launch joint, massive retaliation to North Korea. when it carries out nuclear strikes on South Korea," said Kim Yeol Soo, an expert at South Korea's Korea Institute for Military Affairs.

He said prospects for South Korea-US coordination are bright if Biden is re-elected in the November election, but could suffer a setback if former President Donald Trump returns to the White House.

North Korea is expected to respond angrily to the announcement, as it has previously accused its rivals of using the consultation group to plot a nuclear attack on the North. Worries about North Korea

have further deepened since North Korean leader Kim Jong Un and Russian President Vladimir Putin in June signed a deal requiring each country to provide aid to the other if it is attacked, and vowed to boost other cooperation. Analysts say the accord represents the strongest connection between the two countries since the end of the Cold War.

Ireda net profit surges over 30%

New Delhi: Indian Renewable **Energy Development Agency** (Ireda) Friday reported over 30 per cent growth in its net profit to ₹383.69 crore for the June quarter, mainly on the back of higher revenues. "IREDA has achieved Profit After Tax of ₹383.69 crore (in 01), marking an impressive year-on-year growth of 30.25 per cent," a company statement said. According to the statement, its net profit was ₹294.58 crore in the quarter ended June 30, 2023. As the largest pure-play green financing NBFC in the country. it stated that Ireda achieved a new industry standard by publishing its audited financial results within only 12 days.

Govt delays privatisation plans

New Delhi, July 12: India plans to overhaul more than 200 staterun firms to make them more profitable, signalling a departure from Prime Minister Narendra Modi's aggressive privatisation programme that has struggled to take off, government sources said.

The programme to privatise a major portion of India's lumbering \$600 billion state sector announced in 2021, had slowed ahead of the general election in April-May and now faces more resistance after Modi lost his majority in parliament and had to rely on coalition allies to return to office. Expected to be unveiled as


part of the annual budget July 23 by Finance Minister Nirmala Sitharaman, the new plans include selling large parcels of underutilised land owned by these companies and monetisation of other assets, said two officials who are aware of the policy. Some aspects are yet to be finetuned, they added. The aim is to raise \$24 billion

in the current April-March fiscal year and re-invest the funds in the companies, while setting fiveyear performance and production targets for each company, instead of short-term targets.

The plans to overhaul state firms have not been reported previously.

In an interim budget presented before the election, the government did not provide any figures on stake sales for the first time in more than a decade.

"The government is shifting focus from indiscriminate asset sales to enhancing intrinsic value of state-owned companies." said one of the officials.



Among other plans, the government intends to introduce succession planning in majorityowned companies alongside a proposal to train 230,000 managers across firms to prepare them for senior roles, the officials said.

Currently, the government appoints top executives in stateowned companies.

The government is likely to implement a plan that includes training of managers, professional recruitment to company boards and incentives for high performance from the 2025/26 fiscal year, with the expectation that increased autonomy would make companies more competitive.

The 2021 announcement to sell most state-run companies included two banks, one insurance company and firms in steel, energy and pharmaceutical sectors besides closure of loss-making companies.

But India has been able to only complete the sale of debtridden Air India to the Tata Group, while rolling back plans to sell some others. Only a 3.5% stake in LIC has been sold besides

'We find the valuations of many PSU stocks to be quite bizarre, when compared with their fundamentals," Sanjeev Prasad of Kotak Institutional Equities said in a note.

'Some of these companies will require extraordinary assumptions and a massive turnaround in their operations (and financials) to justify their current market caps.

But the government views the market's response as a mark of investor confidence, said a senior official at the NMDC, India's state-run iron ore company.

State firms were expected to pay substantially higher dividends to the government, compared to earlier estimates of ₹480 billion (\$5.8 billion) in 2024/25, said the second government source. Analysts however said India risked missing the opportunity to cash in on the booming valuations of state companies.

The government could raise about ₹11.5 trillion (\$137.75 billion) at current market capitalisation by selling minority stakes in state-owned companies, while maintaining 51% stake, CareEdge Ratings said in a note last week.

December and 2.5 per cent in November 2023. The previous high of IIP was recorded at 11.9 per cent in October 2023. During the April-May period

this fiscal, the IIP growth was 5.4

per cent against 5.1 per cent in the preceding financial year. India's Index of Industrial Production grew by 5.7 per cent in May 2023, according to a state-

ment by the Ministry of Statistics & Programme Implementation. As per the data, the mining output growth accelerated to 6.6 per cent in May against a 6.4 per cent expansion in the year-ago month. The manufacturing sec-

tor's growth decelerated to 4.6 per

CCI finds Apple abused position in apps market

India latest in growing antitrust scrutiny of Apple globally

New Delhi, July 12: An investigation by India's antitrust body has found that Apple exploited its dominant position in the market for app stores on its iOS operating system, engaging "in abusive conduct and practices", a confidential report showed.

The Competition Commission of India (CCI) has been investigating Apple Inc since 2021 for possibly abusing its dominant position in the apps market by forcing developers to use its proprietary in-app purchase system. Apple has denied wrongdo-

ing saying it was a small player in India where phones that use Google's Android system are dominant.

in its 142-page report which is not public but was seen by Reuters, said Apple wields "significant influence" over how digital products and services reach consumers, especially through its iOS platform and App Store.

"Apple App Store is an unavoidable trading partner for app developers, and resultantly, app developers have no choice but to adhere to Apple's unfair terms, including the mandatory use of Apple's proprietary billing and payment system," the CCI unit said in the June 24 report.

"From the perspective of app developers, Apple iOS ecosystem is indispensable.



Kolkata derby in **Durand Aug 18**

Kolkata: Reigning champions Mohun Bagan Super Giant will take on Downtown Heroes FC of Kashmir in the inaugural match of the Durand Cup here July 27, while the much-anticipated Kolkata derby between them and East Bengal, which will also be the last group game, will take place August 18. The 133rd edition of Asia's oldest and world's fifth oldest tournament will be played in four cities - Kolkata, Kokraihar in Assam, Shillong in Meghalaya and Jamshedpur in Jharkhand. A total of 24 teams have been divided into six groups with the group toppers and two best second-placed teams slated to qualify for the knockouts.


Gambhir explains selection policy

New head coach wants capable players in all formats of the game

New Delhi, July 12: India's newly appointed head coach Gautam Gambhir said that his approach to picking players won't be based on a particular format. He feels players who are 'good enough' should play in all three formats. An action-packed schedule lies ahead of Gambhir and the Indian team.

"I'm a very strong believer in one thing, that if you're good, you should be playing all the three formats. I've never been a big believer in injury management. You get injured, you go get recovered. It is as simple as it gets," Gambhir was quoted as saying by Star Sports.

"When you're playing international cricket and you're good enough, you ask any of the top players, if they want to play all the three formats. They don't want to rest, and they don't want to be labelled as red ball players or white ball players. I am not a big believer in identifying people that, we're going to keep him for Test matches or other formats." Gambhir added.



Gambhir said professional sportspersons have a very short work span and they must utilise it. "As professional cricketers, you've got a very small span when you're playing for your country, and you want to play as much as you can. And when vou're in very good form, go ahead and play all the three for-

While talking about his approach towards the game, there was only one message from Gambhir, play with honesty.

"There's only one message, try and play with honesty. Try and be as honest as you can with your profession," he said. "I've been aggressive on the

his attacking prowess, scoring 37 goals and providing 49 assists.



Berlin, July 12: One is the best team in the tournament, on the brink potentially of a new era of success because of a teenage wonder-kid, an outstanding midfield and a tweak in philosophy. The other team are a survivor, limping to the end with big moments, resilience and an oft-criticised coach who has another chance to end his country's long wait for a major men's title.

The Euro 2024 final between Spain and England here Sunday is dripping with narrative with one arguably standing out above the rest.

Inside Olympiastadion, the historic venue here built by the Nazis for the 1936 Olympic Games, Lamine Yamal - a day after his 17th birthday – will look to crown his breakthrough



as soccer's newest superstar by leading Spain to a first major men's trophy since the 2008-12 era.

Yamal has been the shining light in the tournament. If his three assists before the semifinals hinted at his undoubted promise, Yamal's spectacular curling shot that propelled Spain to a 2-1 win over France signalled a new star had arrived.

However, it's the central mid-

field that has given Spain the edge over all of their rivals. Rodri, perhaps pound-for-pound the world's most effective player, and Fabian Ruiz are the axis on which Spain thrives.

'They have been the best team," England coach Gareth Southgate said of Spain. "But we are there and from what we have shown to this point, we have as good a chance as they do."

Southgate's team are back in the title match – their first ever outside England – and are an increasingly confident underdog, with potential match-winners dotted throughout the team in Jude Bellingham, Phil Foden,

Bukayo Saka and Harry Kane. "They are able to inflict a lot of damage, even without playing in a very fluid way," Spain defender Dani Vivian said. "They

have quality to hurt you.
