### SIM BOX SEIZURE **Racket linked** to Bangladesh

Bhubaneswar, August 17: A day after the Laxmisagar police arrested a West Bengal native in connection with the possession of seven SIM boxes, over 1,000 SIMs, and other electronic devices, Twin City Police Commissioner Sanjeeb Panda Saturday said the illicit activities were taken up under the supervision of a Bangladeshi national.

"Accused Raju Mandal, a native of North 24 Paraganas in West Bengal, ran the operation from a rented accommodation in Mahadev Nagar area of the City, with the help of Assadur Zaman from Bangladesh. After Raju took the house on rent, October 21, 2023, Assadur came to Bhubaneswar via Agartala and assisted him in setting up the SIM boxes. During the period, the latter stayed at Lingaraj Hotel near Bhubaneswar Railway station. Besides, Assadur bore the monthly expenses of Raju to carry out the illicit activities". revealed Panda, adding that the City cops would take the help of national agencies to nab Assadur, who is absconding.

As per the preliminary investigations, Raju made a series of calls to Pakistan and China along with Middle Eastern nations, evading the international telecom gateways of India. He used those to escape GPS location trackers for his dubious activity and give the police a slip. The SIM boxes have been smuggled from Bangladesh while the used SIMs are registered in the names of several people from West Bengal.

### 20 coaches of Sabarmati **Express derail in Kanpur**

Kanpur, August 17: Twenty coaches of the Ahmedabadbound Sabarmati Express passenger train derailed near Govindpuri station in Kanpur early Saturday after the engine hit an 'object placed on the track'. Agencies are investigating the possible involvement of anti-social elements in the incident, railway officials said.

There were no casualties in the derailment that occurred between Kanpur and Bhimsen railway stations at around 2.35 am, disrupting traffic on the route. According to the Railways, seven trains were cancelled and three were diverted due to the derailment.

Railway Minister Ashwini Vaishnaw said that the

Intelligence Bureau and Uttar Pradesh police were looking into the incident and arrangements were being made for the onward

### journey of passengers. In a post on X, Vaishnaw said, "The engine of Sabarmati Express (Varanasi to Ahmedabad) hit an object on the track and derailed near

Kanpur at 02:35 am today. "Sharp hit marks are observed. Evidence is protected. IB and UP police are also working on it. No injuries to passengers or staff. Train arranged for passengers for onward journey to Ahmedabad." Asked about the incident, Police Commissioner, Kanpur, Akhil Kumar said,"It is premature to reach a conclusion on whether it is an accident or an act of mischief, but it could be anything."

## Nadeem 'unhappy' over father-in-law's buffalo gift

Islamabad, August 17: After bagging a gold medal in javelin throw at Paris Olympics, Pakistan athlete Arshad Nadeem expected at least a five-acre of land from his father-in-law. However, he ended up getting only a buffalo from his wife's father. The Olympic gold medalist's wife Avesha said she had no inkling about what her father was up to. She only came to know about it from an interview, shared Ayesha.

Nadeem has been bestowed with several honours and rewards after his javelin throw gold at Paris. From PKR 150 million to gold crowns and civil awards, Nadeem has received immense tribute from his nation. But none have created as many headlines as the unique gift that his father-in-law had gifted him. Arshad's father-inlaw - the father of his wife Ayesha - gifted the star athlete a buffalo. Now, Nadeem and his wife have joked about the gift, with Nadeem requesting something else instead.

"It's just a buffalo, he could've given me five acres of land instead!" joked Nadeem, in an interview to Pakistan-based news channel ARY News, much to the amusement of the interviewer. "But I thought, 'okay, a buffalo is not bad either", he added.

Nadeem's wife Ayesha admitted that her father had not told her about the gift, and that she had learnt about it from an interview

"I did not know either, I got to know from an interview," said Avesha.

"I told her 'He's so rich and he gave me a buffalo?' I asked her to tell him to give 5-6 acres of land, but she hasn't yet!" joked Nadeem

After his 92.97m Olympic record throw earned him gold, Arshad has received a hero's welcome upon his return to Pakistan.



"When Tripathy didn't get the bribe, he illegally sold the scrap to a dealer and misappropriated the entire amount (Rs 5,85,356)," it pointed out. "It was also alleged that Tripathy had collected huge amounts as bribes from various transporters/suppliers on grounds of evasion of taxes," it added.



"Language is very essential for economic development. For instance, a language barrier should not hinder someone from explaining their medical issues to a doctor or accessing banking services," Bapna said during his short visit to IIM-Calcutta.

The tech giant has launched Google Gemini, formerly known as Bard, an artificial intelligence chatbot that supports more than 40 global languages, including

nine Indian languages. Bapna added that Google's ongoing focus is on continuously improving language quality and expanding support for more Indian languages in the future.

Currently, the chatbot supports nine Indian languages -Hindi, Bengali, Gujarati, Kannada, Malayalam, Marathi, Tamil, Telugu and Urdu.

Bapna noted the complexity of India's multilingual environment, where people often use multiple languages simultaneously. This presents unique challenges for AI models, as they must correctly identify and apply the appropriate dictionaries to understand and generate accurate responses, Bapna said.

The deceased were identified as Rajendra Dibaka, Anumal Dibaka, Nilu Dibaka and Dharmi Dibaka in the village. Meanwhile, eight persons have reportedly been afflicted with the disease by Saturday.

The patients first experienced diarrhoea and vomiting and then small nodes or lumps developed on their bodies resulting in death, villagers said. The sudden death of four persons has sparked panic and scare among the villagers with the

### 60 students hospitalised after having mid-day meal

According to sources, 200 students study in Jamera UGME School from Class I to VIII. The students were served egg curry and rice as part of the mid-day meal programme Saturday.

However, as many as 60 stu dents complained of stomach ache and vomiting after eating the mid-day meal. Out of them 25 became critical whom the teachers with the help of vil lagers rushed to the nearby health centre.

numbers of affected persons increasing in the village.

On being informed, a medical team rushed to the village and started treatment of the affected persons. Apart from water samples, the team also collected the faecal samples of the affected persons for examination, the Chief District Medical Officer (CDMO) Dr Lal Mohan Routray said.

Jubagudi village is situated at about 27 km distance from Chandrapur block. Over 100 families including 19 tribal households reside in the village. However, scare of the unknown disease has gripped the village for the last few days.

A villager Rajendra Dibaka was the first person to get affected. He experienced diarrhoea and vomitting and later developed lumps on his body. He was admitted to the district

headquarters hospital in Rayagada where he underwent treatment and returned home. However, he died soon after.

Similarly, three other persons Anumal Dibaka, Nilu Dibaka and Dharmi Dibaka having similar symptoms died within a span of 10 days. Villagers alleged that they are yet to be provided with proper medical care and treatment despite the death of four villagers.

They said some of the patients have resorted to traditional herbal medicine as except for an AYUSH doctor there are no more doctors to provide them treatment. The CDMO said a medical

team reached the village and started treatment of the afflicted persons after his department was informed. Moreover, doctors at the Chandrapur community health centre (CHC) have been directed to provide proper medical care to the afflicted persons in Jubagudi village. "The reason behind spread of the disease and other details can be ascertained only after the reports

on examination of faecal and water samples are available to us," he said.

### Civil Code Conundrum

n his 15 August address, the Prime Minister said his government would work towards changing India's personal laws. He said "after  $\blacksquare$  75 years of a communal civil code, it is crucial to move towards a secular civil code. Once this shift takes place, it will eliminate religious discrimination and will bridge the gap felt by ordinary citizens.

The personal laws govern marriage, divorce and inheritance. The BJP has had a curious relationship with this subject from the founding of the Republic. Dr Ambedkar had proposed modest changes to Hindu personal law especially on the question of inheritance for women. He identified the two dominant forms of traditional inheritance law and modified one of them to make inheritance fairer for women. This was not acceptable to the RSS' political formation.

In its 1951 manifesto the Jana Sangh opposed the Hindu Code Bill, saying social reform should not come from above but from society. In 1957, it said that such changes were not acceptable unless rooted in ancient culture. 'Riotous individualism' would ensue as a result. In its manifesto of 1958, the party wrote: "Joint family and indissoluble marriage have been the basis of Hindu society. Laws that alter this basis will ultimately lead to the disintegration of society. Jana Sangh will therefore repeal the Hindu Marriage and Hindu Succession Acts.

Over time, as nuclear families became common and divorce became acceptable in society, the party dropped this position without explaining why.

In its 1967 manifesto, it called for uniform civil code. From here on, this appeared in all the party's manifestos and it promised its voters it would enforce it if it came to power. The BJP had an absolute majority in 2014 and 2019 and in both elections it had promised a uniform civil code in its manifesto but it did not legislate it or produce a draft

Now that the party has been reduced to 240, the promise has been made again but who is to fulfil it? Where is the draft law made by Modi and his ministers? It does not exist, of course. In the 15 years that this country has seen a BJP government there has been no draft, only speeches. The reason no draft exists is that it is not an easy problem to solve. For the BJP and its votaries, 'uniform civil code' or 'secular civil code' is a placeholder for the abolition of polygamy. But to get rid of it, the BJP will have to target more than just Muslims. The aspects relating to Hindu Undivided

Family are not the only ones that will have to be resolved.

Most are familiar with Article 370, which the BJP long targeted and then gutted in 2019 but fewer likely know of the very next Article, 371, which says "no Act of Parliament in respect of religious or social practices of the Nagas (and) Naga customary law and procedure... shall apply to the State of Nagaland unless the Legislative Assembly of Nagaland by a resolution so decides."

What happens to a Secular Civil Code that is against Naga custom? We do not know. The BJP doesn't either. In March 2018, the Nagaland Bar Association submitted a memorandum to Nagaland Chief Minister Neiphiu Rio saying several Central laws pertaining to personal laws in the State are "badly contradictory and opposed to the Naga social customs and practices. Apart from the provisions of Article 371A of the Constitution of India, legislative power in matters of personal law is vested with the State Legislature.

The laws mentioned were the Indian Succession Act, 1925; Special Marriage Act, 1954; Indian Divorce Act, 1869; Births, Deaths and Marriages Registration Act. 1886: Guardians and Wards Act. 1890: and Family Courts Act, 1984, The Bar Association said these laws "are required to be substituted by our own State Acts." Similar provisions in 371 safeguard customary law for Mizos (371G).



our years ago, at the height of the COVID-19 pandemic, governments were scrambling to protect their populations and prevent an economic meltdown. No one would dispute that addressing this existential threat was the top political priority back then.

As a former Prime Minister and director-general of the World Health Organization, I was impressed by the coordinated international response to COVID-19. To be sure, there were large inequalities within and between countries, resulting in society's most vulnerable paying too high a price, especially when it came to vaccine access. But I saw reason to hope that the pandemic's devastating impact would prompt a political sea change and lead to a greater commitment to future preparedness, prevention, and response.

I was wrong. It is depressingly obvious that the lessons of COVID 19 are being forgotten. The world remains stuck in the familiar cvcle of panic and neglect that has characterised this past pandemic. Political leaders are largely ignoring current threats, including COVID-19 (which has not been consigned to the history books, despite no longer being a public-health emergency), H5N1 bird flu, and dengue fever. And new pandemics with potentially catastrophic outcomes will almost surely occur, especially as climate change and environmental degradation worsen.

These are not hypothetical risks. Recently, WHO Director-General Tedros Adhanom Ghebrevesus declared the latest outbreak of mpox in East Africa a "public-health emergency of international concern." Not only must the international community now rally behind affected African countries and

Even before COVID-19 hit, I had been warning that our failure to break this vicious cycle was putting us at grave risk. In September 2019, the Global Preparedness Monitoring Board (which I co-chair) issued a report highlighting the acute risk of a devastating global epidemic or pandemic. Little did we know how prescient our warnings were And now we find ourselves in a new phase of neglect, which can only be understood as a failure of political will. For all the pious words uttered in the COVID-19 era, heads of state and governments are failing to address the inequalities that stymied recovery efforts. It is unacceptable that rich countries have done so little to make the next pandemic response more equitable - and therefore more effective.

In June, for example, the 77th World Health Assembly failed to finalise a new pandemic accord,

to – global equity.

Moreover, if the past four years have taught us anything, it is that WHO-led processes alone are not enough to tackle the existential threat of pandemics. Other multilateral institutions should take up the cause of improving preparedness. The United Nations' Summit of the Future in September, as well as the upcoming meetings of the G7 and the G20, must highlight the urgency of this challenge and encourage world leaders to act. More visible advocacy for global health security in these fora could be crucial in securing the political leadership and financing needed to bring about meaningful change.

To that end, the group of former political leaders known as The Elders supports the adoption of an emergency platform a set of protocols that would allow UN leaders to respond quickly to global shocks - at the Summit of the Future. World Trade Organization members should also agree to review, as proposed by Colombia, the implementation of the agreement on Trade-Related Aspects of Intellectual Property Rights. The TRIPS agreement governs patent protection for vaccines and treatments, and thus plays a key role in pandemic-response efforts.

Recommitting to pandemic preparedness is essential. But it also should be part of a broader revival of multilateralism. Only through compromise and collaboration can we confront humanity's gravest challenges.

disha has become a notable example of disaster management and climate adaptation. Frequent cyclones, floods, and coastal erosion have driven the state to implement adaptation strategies praised globally for their effectiveness. Odisha toward a "zero casualty" goal, transforming it into a global model of proactive disaster management.

While reducing fatalities is undeniable, the long-term social and economic impacts on affected communities are often overlooked. Social and economic displacement is one major issue.

tion. Wealthier individuals and communities often have better access to government programmes and resources, enabling them to take full advantage of the support. In contrast, poorer and marginalised groups struggle to access these benefits, leaving them more vulnerable to climate change impacts. For example, the shift to-

ture-based solutions, such as expanding mangrove plantations and promoting sustainable agriculture practices, can provide\_ immediate protection while ensuring the long-term health of ecosystems and communities.

Additionally, efforts must be made to ensure that adaptation benefits are distributed equitably, with targeted support for vulnerable groups. This includes enhancing access to resources and technologies for smallholders, ensuring that marginalised communities have a voice in decision-making, and addressing the social and economic impacts of relocation and other adaptation measures. In conclusion, Odisha's journey from frequent disaster-induced tragedies to a global model of climate adaptation is impressive. However, as climate change's impacts grow more severe, it is crucial to critically assess the sustainability and equity of these efforts. By adopting a more holistic and inclusive approach, Odisha and other regions can build resilience that stands the test of time. However, this disrupts community ties, severs connections to ancestral lands, and imposes new economic challenges as people adapt to unfamiliar environments.

Moreover, the emphasis on hard infrastructure like cyclone shelters and embankments often comes at the expense of more sustainable, nature-based solutions. Nature-based solutions, such as restoring mangrove forests, can provide multiple benefits: they offer a natural barrier against storm surges and support local livelihoods through enhanced fishery resources. Yet, despite their potential, these solutions represent only a small fraction of adaptation efforts in Odisha. Over-reliance on structural interventions can unintentionally alter natural hydrological systems, increasing vulnerability elsewhere.

While the benefits are widely recognised, they are not evenly distributed across the popula-

wards climate-resilient agriculture, including introducing saline-tolerant rice varieties, has largely benefitted larger landholders who can afford the necessary inputs and technologies. Smallholders often lack resources to implement these changes, making them more prone to crop fail ure and economic loss.

Furthermore, the focus on disaster risk reduction sometimes overshadows the underlying drivers of vulnerability, such as poverty, inequality, and lack of access to basic services. Addressing these root causes is essential for building true resilience. Without tackling these fundamental issues, even the most effective adaptation strategies will fall short of ensuring long-term sustainability and social justice.

Odisha's experience offers valuable lessons for other regions facing similar climate challenges. While the state's disaster management successes are commendable, as climate impacts intensify, a more balanced approach is necessary. This approach should prioritise immediate disaster risk reduction and long-term socio-ecological resilience and equity. Scaling up na-

## **School stabbing in Udaipur** sparks communal tension

Jaipur, August 17: Mobile internet was suspended for 24 hours in several areas of Rajasthan's Udaipur and all schools were ordered to remain shut after a Class X student allegedly stabbed another boy at a government school, triggering communal violence in the city, officials said.

The incident took place Friday, they said, adding that the student injured in the attack is undergoing treatment at the district hospital while the accused is under detention.

The house of the accused boy has been razed by the district administration using JCB machines, the officials said. The demolition was carried out in the presence of police personnel.

"Fear of the administration is necessary for someone who commits a crime. It was found in an investigation that the house of the accused was built on forest land and action was taken in ac cordance with rules. A notice was served and action was taken." Udaipur District Collector Arvind Poswal said

A team of three doctors has been sent from state capital Jaipur to Udaipur by a special plane for the treatment of the injured boy, the collector said, adding that his condition is stable.



## AI tool that thinks like a chef, generates 1.18L recipes

New Delhi, August 17: Can an AI-generated recipe help someone win a cook off?

Ratatouille, an artificial intelligence (AI)-powered tool, developed by a professor and a research scholar of the Indraprastha Institute of Information Technology (IIIT), Delhi, could make this possible.

Designed to think like a chef, the tool can generate more than 1.18 lakh unique traditional recipes from 74 countries, claimed its developers -- Prof Ganesh Bagler and PhD scholar Mansi Goel of the institute's Infosys Centre for Artificial Intelligence.

The IHM panel of chefs evaluated 1,472 recipes on a scale of zero-to-five, where zero meant the recipe was fake and five meant it was genuine, he said.

Next, the developers planned to evaluate the recipes by actually cooking them and using sensory panels to assess taste, flavour, aroma, and aftertaste.

This helped make the AI-generated recipes not only novel but also palatable, Bagler said.

The project, which aimed at enhancing culinary creativity by leveraging AI and making food computable, has been published in the Nature Partner Journal, 'Svstems Biology and Applications'.

The idea to come up with such an AI tool struck Bagler while he was taking a class at the IIT-Jodhpur in 2015.

"It started with my curiosity about food. I realized over time the potential (of the project) for industrial and societal applications. The field of computational gastronomy, which originated in India, offers significant opportunities for innovation and improvement," he said.

"While AI can't replace the creative aspect of cooking, it can assist chefs by generating recipes and offering new ideas. We aim to support chefs in exploring new culinary possibilities and making personalised recommendations, Bagler said.

Ratatouille can assist in making meal kits and in nutrition coaching by offering customised recipes, the professor said and added that he plans to offer this as a B2B service and is open to making data available for nonprofit purposes. The one challenge, he feels that this project may face is collecting data as per individual needs. "We've gathered data at the cultural level but need more individual-level data for personalised recommendations. Ensuring the quality of this data is critical," he said.



Gurugram: Ambience Mall in Gurugram was evacuated Saturday after it received an email claiming that a bomb had been planted on the premises, police said. The threat turned out to be a hoax. Bomb and dog squad teams were rushed to the spot and the search operation lasted four-and-a-half hours, police said. The Ambience Mall management received a bomb threat email at 9.27 am, police said. The email, which was sent from hiddenbones101@gmail.com, read, "I planted bombs in the building. Every person inside the building will be killed, none of you will escape. You deserve death. I planted the bombs in the building because I hate my life. The people behind this attack are Paige and Nora," Assistant Commissioner of Police, DLF (Gurugram), Vikas Kaushik said, "The search operation at Ambience Mall is over and nothing has been found.

### Health min reviews Monkeypox situation

New Delhi: There are currently no reported cases of Monkeypox in India even though cautionary measures will be put in place to prevent and control the spread of the disease, the Union health ministry said Saturday. At a review meeting held during the day, although the possibility of a few imported cases being detected in the coming weeks was not entirely ruled out, it was assessed that the risk of a large outbreak with sustained transmission is low for India at present. Since WHO first declared the outbreak a public health emergency of international concern in 2022, a total of 30 cases were detected in India with the last case being reported this March, the Health Ministry said in a statement.

Meghalaya HC bans single-use plastic

Shillong, August 17: The Meghalaya High Court has banned single use plastic in temples and shops across the state. The High Court Bench headed by Chief Justice S Vaidyanathan also advocated for introduction of tetra pak cartons, which are primarily made from paper and could be an effective alternative to replace plastics. The fight against plastics is not just an environmental crusade, but a battle for the health and future of our planet.

To begin with, such a move can be started from temple premises. Temple authorities must ensure that there is no usage of



plastic bags in and around the worshipping places," the Division Bench said in an order while hearing a PIL on the matter on Friday.

"CCTV cameras shall be installed in all temples, so that if anybody carries plastics inside the temple, that can be curtailed

to some extent," it added.

The bench also imposed a ban on shops from storing and using plastic bags proposing heavy fines to be imposed on violators.

"If any shops are found to have stored plastic bags, a heavy fine should be imposed on them and if the practice is continued,

such shops should be kept under lock and seal," the bench stated. Directing the state government to be vigilant, the bench also ordered that the plastic items are stopped at the entry level it-

self. "A periodical raid should be conducted in all shops and the Government of Meghalaya should think of imposing huge amount of fine against those

of Meghalaya," it said, adding that strict enforcement of law will help eradicate plastic from society. Citing how strong laws in Singapore force the same

The Union Public Service Commission (UPSC) Saturday advertised 45 posts -- 10 of joint secretaries and 35 of directors/deputy secretaries -- to be filled through the lateral entry mode on contract basis. It is the biggest tranche of lateral recruitment being undertaken by the Centre, an official said.

The government of India has submitted the requisitions for lateral recruitment of joint secretary and director/deputy secretary level officers.



Accordingly, online applications are invited from talented and motivated Indian nationals willing to contribute towards nation building to join the government at the level of joint secretary or director/deputy reads the secretary..., advertisement.

The vacancies in different ministries/departments with headquarters at New Delhi, are to be filled on contract basis (on deputation for officers of states/UT cadres, public sector undertakings (PSUs), autonomous bodies, statutory or-

ganisation, universities, recognized research institutes) for a period of three years (extendable to five years depending upon performance) through website https://www.upsconline.nic.in by September 17, it said. The 10 posts of joint secre-

taries are in Home, Finance and Steel ministries among others. Thirty-five posts director/deputy secretary-level will be filled in the Ministry of Agriculture & Farmers Welfare, Civil Aviation and Information & Broadcasting among others.

The latest induction through the lateral entry mode - referred to as the appointment of specialists (including those from the private sector) in government departments -- is aimed at bringing fresh talent and perspective into the governance.

The lateral recruitment in the central government, has been undertaken since 2018 to appoint persons for specific assignments, keeping in view their specialised knowledge and expertise in the domain area. The officers at these levels play an important role in policy-making.

In an interim order passed against several known and un-

known entities on a lawsuit filed by the show's producer, Justice Mini Pushkarna said if the exparte ad-interim injunction is not granted, the plaintiff will suffer

an irreparable loss. The plaintiff, Neela Film Productions Private Limited,

said it has statutory rights over several registered trademarks in India pertaining to its show and



its characters, some of its trade marks being "Taarak Mehta Ka Ooltah Chashmah", "Ooltah Chashmah", "Taarak Mehta", "Jethaalal", "Gokuldhaam" etc.

The court was informed that while the plaintiff enjoys the copyright of the show's various characters and animations, some entities are, in an unauthorised manner, selling merchandise, such as T-shirts, posters and stickers, bearing the images and dialogues of characters from the show through websites and e-commerce platforms.

It was also claimed that content was generated through the use of artificial intelligence or deepfakes of characters as well as video games.

"An order of ex-parte ad-interim injunction is passed, thereby restraining the defendant nos. 1 to 12 and 14 to 21 (including the John Doe parties) ...

from, in any manner, ... publishing ... offering for sale on their websites ... the plaintiff's copyrighted material/registered trademarks, including, but not limited to the title, the characters, format and underlying materials in the said show or anything else, which otherwise amounts to an infringement of the plaintiff's copyright/registered trademarks/passing off of the goods/services offered by the defendants," the court said in an order passed on August 14.

The court further ordered that YouTube videos, which contain characters or material from the show, including pornographic content, are required to be brought down by those making the uploads.

In case the infringing videos are not brought down within 48 hours, the Information Technology (IT) ministry and the Department of Telecom will ask the respective internet service providers or intermediaries to suspend all links or videos, the court said.

It also granted liberty to the plaintiff to notify YouTube to block or suspend all the infringing links and directed the platform to provide the plaintiff with the necessary details of + the offending uploaders.

Asit Kumar Modi, the producer of the show, expressed his relief at the high court's decision and said it sends a strong message that such infringement of the show's intellectual property will not be tolerated.

### Rana can be extradited to India, says US Court

Washington, August 17: In a major setback to Pakistani-origin Canadian businessman, Tahawwur Hussain Rana, who is sought by India for his involvement in the 2008 Mumbai terror attack, a US court in California has ruled that he is extraditable to India under the extradition treaty between the two countries.

'The (India US Extradition) Treaty permits Rana's extradition," the US Court of Appeals for the Ninth Circuit said in its ruling Thursday.

Ruling on an appeal filed by 63year-old Rana, a panel of judges of the US Court of Appeals for the Ninth Circuit affirmed the District Court in the Central District of California's denial of his habeas corpus petition challenging a magistrate judge's certification of his as extraditable to India for his alleged participation in terrorist attacks in Mumbai.

Rana, currently lodged in a iail in Los Angeles, faces charges for his role in the 26/11 Mumbai attack and is known to be associated with Pakistani-American Lashkar-e-Taiba (LeT) terrorist David Coleman Headley, one of the main conspirators of the terror incident.

Under the limited scope of habeas review of an extradition order, the panel held that Rana's alleged offence fell within the terms of the extradition treaty be tween the United States and India, which included a Non Bis in Idem (double jeopardy) exception to extraditability "when the per-son sought has been convicted

or acquitted in the Requested State for the offence for which extradition is requested".

A total of 166 people, including six Americans, were killed in the 2008 Mumbai terror attacks in which 10 Pakistani terrorists laid a more than 60-hour siege, attacking and killing people at iconic and vital locations in Mumbai

## Polio: Gaza's new battle Key Russia bridge

Gaza sees first polio case in 25 years as UN calls for mass vaccinations

Cairo, August 17: The threat of polio is rising fast in the Gaza Strip, prompting aid groups to call for an urgent pause in the war so they can ramp up vaccinations and head off a full-blown outbreak. At least one case has been confirmed, others are suspected and the virus was detected in wastewater in six different locations in July.

Polio was eradicated in Gaza 25 years ago, but vaccinations plunged after the war began 10 months ago and the territory has become a breeding ground for the virus, aid groups say. Hundreds of thousands of displaced Palestinians are crowded into tent camps lacking clean water or proper disposal of sewage and garbage.

To avert a widespread outbreak, aid groups are preparing to vaccinate more than 600,000 children in the coming weeks. They say the ambitious vaccination plans are impossible, though, without a pause in the fighting between Israel and Hamas

### Deadly violence persists despite ceasefire talks

Russia says Ukraine used Western rockets to destroy bridge in Kursk region

Moscow. August 17: Russia's foreign ministry said Ukraine had used Western rockets, likely US-made HIMARS, to destroy a bridge over the Seym river in the Kursk region, killing volunteers trying to evacuate civilians.

## Perry's death sheds light on toxic celeb-doc relationships

**ACCORDING TO PROSECUTORS. DOCTORS AND A 'KETAMINE QUEEN' TOOK ADVANTAGE OF PERRY'S** ADDICTION AND **PLAYED A ROLE IN HIS DEATH**

Los Angeles, August 17: "Friends" actor Matthew Perry's tragic death has highlighted the secretive and toxic relationship that has long existed between troubled celebrities and the doctors who service their addictions.

Perry, who had a long history of substance abuse, was found dead in the hot tub of his luxury Los Angeles home last year with extremely high levels of ketamine in his system.

Federal drug officials said the star had become addicted while seeking treatment for depression and "turned to unscrupulous doctors" when legal sources refused to increase his dosage.

"Instead of 'do no harm,' they did harm so that they could make more money," Anne Milgram of the Drug Enforcement Administration told a press conference this week.

The allegations against doctors Salvador Plasencia, who has pleaded not guilty, and Mark Chavez, who agreed to plead guilty to conspiracy to distribute ketamine, appear eerily reminiscent of other celebrity cases.

For instance, Michael Jackson's doctor Conrad Murray was convicted in 2011 of involuntary manslaughter for administering a lethal dose of a powerful surgical anaesthetic to the megastar.

Elvis Presley and Marilyn Monroe to Prince and Tom Petty have all been linked to the fatal consumption of controlled substances obtained

from med

ical professionals. "The rules go out the window with famous people, and it constantly leads to tragedy," said Harry Nelson, a prominent Los Angeles-based healthcare attorney. "It's crazy."

'A TRAP'

But Nelson, who has been personally involved in more than a dozen "front-page, headlinenews tragedies" involving famous actors, rock stars and athletes, said the full picture is often more complicated.

Celebrities have a genuine need for privacy. Going to a doctor for

a prescription, followed by a pharmacy to collect the drugs, is not feasible for troubled A-listers who are frequently hounded

by paparazzi. Yet doctors can quickly become awed by the "romance and excitement" of proximity to worldfamous stars, who are likely to display a higher "sense of entitlement" regarding their treatment demands than typical patients. In order to "stay in the good graces of that person and con-

tinue to have this privileged role," doctors can end up rationalizing: "I'm gonna do what that person wants, even if it's against better judgment," said Nelson

"But it's a trap. It's a trap for both the celebrity patient, and for the doctor," he added.

### **'KETAMINE QUEEN'**

Among the five people who have been charged in actor Matthew Perry's death due to a drug overdose last year is a woman called Jasveen Sangha. popularly known as "the Ketamine Queen". According to investigators, Sangha provided the lethal dose of ketamine that led to Perry's death. Sangha, a 41-year-old dual

British and American citizen, has been under the radar of federal authorities for her involvement in the distribution of dangerous narcotics. Dubbed the "Ketamine Queen of Los Angeles," Sangha allegedly ran a drug operation out of her North Hollywood home, where officials claim she stored, packaged, and distributed various narcotics.

### **EL NINO HITS SOUTHERN AFRICA** 68mn suffering from drought

Harare, August 17: About 68 million people in Southern Africa are suffering the effects of an El Nino-induced drought which has wiped out crops across the region, the regional bloc SADC said Saturday.

The drought, which started in early 2024, has hit crop and livestock production, causing food shortages and damaging the wider economies.

Heads of state from the 16-nation Southern African **Development Community** (SADC) were meeting in Zimbabwe's capital Harare to discuss regional issues including food security.

Some 68 million people, or 17% of the region's population, are in need of aid, said Elias Magosi, SADC executive secretary.

"The 2024 rainy season has been a challenging one with most parts of the region experiencing negative effects of the El Nino phenomenon characterised by the late onset of rains,' he said.

It is Southern Africa's worst



drought in years, owing to a combination of naturally occurring El Nino - when an abnormal warming of the waters in the eastern Pacific changes world weather patterns - and higher average temperatures produced by greenhouse gas emissions Countries

including Zimbabwe, Zambia, and Malawi have already declared the hunger crisis a state of disaster, while Lesotho and Namibia have called for humanitarian support.

The region launched an appeal in May for \$5.5 billion in humanitarian assistance to support the drought response, but donations have not been forthcoming, said outgoing SADCchair Joao Lourenco, President of Angola.

### Windfall tax on crude cut

New Delhi: The government has slashed windfall tax on domestically produced crude oil to ₹2,100 per tonne, from ₹4,600 per tonne with effect from Saturday. ### **Focus on ESG in securities mkt** India needs more reforms to create jobs: Gopinath

New Delhi, August 17: Markets regulator Sebi has proposed expansion of the sustainable finance framework in the securities market by introducing a new category of financial instruments.

This category will include Social Bonds, Sustainable Bonds, and Sustainability-linked Bonds in addition to the current green debt securities. It aims to provide issuers with flexibility in raising funds for projects that align with environmental, social, and governance (ESG) objectives.

In a consultation paper released Friday, Sebi proposed that issuers, in addition to existing green debt securities, be allowed to raise funds through issuance of social bonds, sustainable bonds, and sustainability-linked bonds. These bonds will collectively be known as ESG Debt Securities. This will enable issuers to

raise money for more sustainable projects, assisting in closing the funding gap for the Sustainable Development Goals.

Sebi said it received representations from market participants including the Confederation of Indian Industry to expand the scope of the regulatory frame-

work pertaining to sustainable finance to include Social Bonds, in addition to existing Green Debt Securities as a mode of raising sustainable finance, in line with global practices.

As per the consultation paper, Sebi said, it "proposed to introduce the concept of Sustainable Securitised Debt Instruments for the purpose of providing originators of the underlying credit facilities which are within such international or domestic frameworks for sustainable finance, and thereby provide investors as well an opportunity to participate in the sustainable

securitised debt instruments." The consultation paper also addressed the initial and continuous disclosures for sustainable securitised debt instruments

that would be based on international frameworks.

Initial disclosures could be made in the offer document for the securities. while continuous disclosures might be included in annual reports or other mandated formats.

The markets watchdog also suggested that issuers of ESG debt securities and sustainable securitised debt instruments appoint an independent external reviewer or certifier, to facilitate transparency and credibility. The review could take vari-

ous forms including, secondparty opinions, verification, certification, or scoring/ rating.

The Sebi has invited comments and suggestions from the public on the consultation paper by September 6.



New Delhi, August 17: India will need to undertake a lot more reforms to continue its growth trajectory and make sure that enough jobs are created in the country, IMF deputy managing director Gita Gopinath said Saturday.

Addressing an event here, Gopinath further said that India will be required to reduce import tariffs if it wants to be an important player in the global supply chains.

"Significant improvements have been made by the government over the years in terms structural reforms," Gopinath noted. While noting that the world is in an environment where trade integration has been questioned, Gopinath said it is important for India to remain open for global trade.

'Tariff rates in India are higher than in its other peer economies. If it wants to be an important player on the world stage and an important part of global supply chains, it is going to require reducing those tar-



iffs," the eminent economist said.

Gopinath said it is a tremendous aspiration to get to a developed country status but it does not happen automatically, and requires ongoing, consistent efforts, pretty broad scale, across many areas to deliver on that.

"India has grown well in terms of its overall growth rate, and at 7 per cent, it is the fastest-growing major economy in the world. The question is, how does one keep up the momentum and raise it further so that you can increase per capita incomes in India to get to being an advanced economy," she said.

To a question on taxation, she

said India has parallels with other developing countries, where most of the tax revenue that is collected is indirect taxes and not direct taxes, not in the form of income taxes.

'We have been advising other developing countries too, that it is helpful to broaden the personal income tax base and so that you can have more income coming from there," she said.

Referring to the cut in corporate tax rate by the Modi government, Gopinath said although it was helpful it is less the tax rate that matters, but what matters is just making sure that there are no loopholes and there are not

too many leakages that happen in terms of tax exemptions. "It is very important to have

sufficient progressivity in your tax system...making sure that you are (India) getting enough from your capital gains tax from your capital income tax is going to be critical," she said.

Gopinath also suggested that now there is better technology to implement property tax and this is again another area where work is needed.

## Majority of blue-collar jobs pay less than ₹20K per month: Report

New Delhi: Allowing the plea of Mitsubishi Heavy Industries, the Insolvency Appellate Tribunal NCLAT has set aside the order passed by NCLT, which had restrained the Japanese multinational engineering from encashing the Performance Bank Guarantee submitted by its contractor Punj Lloyd. NCLAT said NCLT "committed an error" by allowing a plea filed by the RP of Punj Lloyd to restrain Mitsubishi Heavy Industries, State Bank of India and other banks who have given counter guarantee to invoke the Bank Guarantee. "Order passed by the Adjudicating Authority (NCLT), thus is unsustainable," said a National Company Law Appellate Tribunal bench.

### NCLAT sets aside restraining order

Mumbai, August 17: Majority of blue-collar jobs in India pay within the salary range of ₹20,000 or less per month, suggesting that a substantial portion of the workforce is grappling with financial strain, struggling to meet essential needs such as housing, healthcare, and education, a report has said.

Over 57.63 per cent of bluecollar jobs fall within the salary range of ₹20,000 or less per month, indicating that many workers earn close to the minimum wage, tech-enabled blue collar recruitment platform WorkIndia said in a report. In addition, the report revealed

that about 29.34 per cent of bluecollar jobs are in the moderate earning bracket, with salaries ranging from ₹20,000-40,000 per month.

Workers falling under this cat-

egory, experience marginally improved financial security but are far from achieving a comfortable standard of living, it said

The income in this range may cover necessities but it leaves little room for savings or investments, which highlights the economic vulnerability of a large segment of the blue-collar workforce, it added.

'The data reveals a significant concentration of low-wage jobs and limited opportunities for higher earnings within the bluecollar sector. This disparity not only reflects the economic challenges faced by a large portion of the workforce but also has broader implications for social stability and economic growth," WorkIndia CEO and co-founder

Nilesh Dungarwal told PTI. Addressing these issues may require targeted interventions such as skill development, wage



reforms, and the creation of more high-paying job opportunities, he added.

The report further revealed that a very small segment of the workforce, constituting only 10.71 per cent, get salaries over ₹40,000-60,000 per month.

This higher earning bracket among the blue collar reflects the presence of specialised skills or experience among these workers, yet the restricted availability of such positions suggests

that upward mobility within the segment remains challenging, it said

Only 2.31 per cent of blue-collar jobs offer salaries exceeding ₹60,000, which is an extremely small percentage that signifies the scarcity of well-paying opportunities in this sector, it stated.

Positions in this top bracket are typically highly-specialised or involve significant responsibility, making them accessible only to a select few, the report added.

The report is based on an analysis of job data collected from the WorkIndia platform over the past two years, which includes over 24 lakh job postings across various industries.

The report said, field sales positions lead the list of the highest-paying blue-collar roles, with 33.84 per cent of roles offering salaries above ₹40,000 per month. This is closely followed by back office roles as 33.10 per cent get over ₹40,000 and tele-calling positions with 26.57 per cent earning more than ₹40,000, it stated.

Meanwhile, in the accounting field, 24.71 per cent of jobs offer salaries above ₹40,000 per month, driven by the need for accurate financial management.

Business development roles, which are crucial for expanding company operations, offer competitive pay, with 21.73 per cent of positions exceeding ₹40,000 per month, said the report.

Interestingly, it found that skilled cooks and receptionists also fall into the higher salary bracket, with 21.22 per cent and 17.60 per cent of these roles, respectively, earning above ₹40,000 per month.

Delivery jobs, while essential, have the lowest percentage in this category, with only 16.23 percent of roles offering higher pay, it added.
