#### **Israel ready for** ceasefire: Blinken

Tel Aviv: US Secretary of State Antony Blinken said Monday that Israel has accepted a proposal to bridge differences holding up a ceasefire and hostage release in Gaza, and he called on Hamas to do the same, without saying whether it had addressed concerns cited by the militant group. Blinken spoke after holding a meeting with Israeli Prime Minister Benjamin Netanyahu earlier in the day. The US, Egypt and Qatar have spent months trying to broker an agreement, with the talks repeatedly stalling. "In a very constructive meeting with Prime Minister Netanyahu today, he confirmed to me that Israel supports the bridging proposal," Blinken told reporters. "The next important step is for Hamas to say 'yes'.'

#### Two dead in bike mishap

Baripada: Two youths were killed after their motorcycle hit a roadside tree in Mayurbhanj district, police said Monday. The deceased were identified as Shyam Marandi (20) and Sundar Marandi (24) of Ulidihi village under Moroda police station area. It is suspected that the mishap occurred in the wee hours of Monday due to heavy rains, police said. Villagers found the motorcycle and the bodies in a paddy field on the Chitrada-Dantiamuha road in the morning. After hitting the tree, the duo fell into the water-filled farmland and subsequently died, police added.

#### **CBI** gets court nod for Roy's polygraph test

Kolkata: A local court here Monday granted CBI permission to conduct a polygraph test on Sanjay Roy, accused in the rape-murder of a woman doctor at RG Kar Medical College and Hospital, an official said. The CBI is yet to schedule a date for the test, he added. Rule requires that the accused be brought before a magistrate, who will ask if he agrees to the polygraph test, the official said. "The court has granted us permission to conduct the polygraph test on Roy, he said. Meanwhile the CBI grilled former principal of RG Kar Sandip Ghosh for the fourth consecutive day Monday.

### ₹60K boost for PMAY

Beneficiaries to get ₹1,80,000 instead of the existing ₹1,20,000

Bhubaneswar, August 19: The financial assistance under the Pradhan Mantri Awas Yojana (PMAY) will be increased by ₹60,000 to ₹1,80,000 from the existing ₹1,20,000, Odisha Panchayati Raj and Drinking Water department Minister Rabi Narayan Naik stated here Monday. The minister added that a guideline in this regard will be issued soon.

"A financial assistance of ₹1.2 lakh was provided to the beneficiaries under the Pradhan Mantri Awas Yojana. This will be increased to ₹1.8 lakh. A notification in this regard will be released soon. If MGNREGA is included, the beneficiaries will get around ₹2 lakh," Naik stated.

"Similarly, beneficiaries were earlier being provided with ₹12,000 for construction of toilets. Now, that amount will be increased to ₹20,000. "Our goal is that every residence in the state including those in remote rural areas will be a model house with a proper toilet and clean drinking water facility," Naik added.

The minister informed that the state government will soon launch the 'Odisha Antyodaya Gruha Yojana'. Under this scheme houses which suffer damages due to fire accidents, elephant attacks and other natural disasters will be provided



financial assistance for repair work, Naik informed.

Naik was asked to comment on the 'Mo Ghara' scheme launched by the previous BJD government. "The housing scheme of the previous BJD government was a political stunt and no one has benefitted from the scheme. People have no interest in the scheme,' Naik stated.

"We on the other really want the living conditions to improve in Odisha. It is one of the main reasons why the PMAY fund has been hiked," the minister added.

The minister also shared details about the roadmap prepared for the development of 500 tribal villages in Odisha. "We will try to safeguard their traditions and ensure proper road connectivity. There will also be provisions for providing clean drinking water and including the youth of the tribal communities to the mainstream by providing them with necessary training to earn money," Naik informed.

### Govt to rescue Odia Rape horror continues workers from B'desh

Bhubaneswar, August 19: Migrant workers from Odisha we will start the process of bringwho are working in Bangladesh and have since been stranded in the country, will soon be brought back to the state, Labour and **Employees State Insurance** Minister Ganesh Ram Singh Khuntia informed here Monday.

According to rough estimates more than 5,000 Odias are currently stranded in the violencehit neighbouring country. Atrocities against minority communities, especially Hindus have been on the rise since the fall of the Sheikh Hasina-led Awami League government and Odisha is concerned about its natives stranded there, the minister informed.

"The Odisha government is concerned about the situation in Bangladesh," Singh Khuntia told reporters. "The chief minister has called a meeting to discuss this issue and it will be held soon. We will plan a roadmap to bring back the stranded workers,' the minister added.

 $Singh\,Khuntia\,informed\,that$ district labour officials have been

asked to prepare a list of Odias currently working in Bangladesh. "Once the database is prepared ing them back as per the instructions of the CM," Singh Khuntia stated.

The minister also stated that there may be cases where Odia workers may have migrated to Bangladesh without informing the district officials. In that case, discussions will be held with Bangladesh authorities so that they can also be brought back, the

minister added. Singh Khuntia stated that since most of the Odia labourers are Hindus, it is imperative that they be brought back for their safety. 'We have come to know that many of them are interested in coming back to Odisha and do not want to continue with their jobs in Bangladesh," the minister stated. He added the repatriation process is expected to start

within the next 15-20 days. It should be stated that many temples were ransacked and Hindus were attacked after the fall of the Hasina government. Even though the violence has subsided, there is still cause for worry

Chennai, August 19: A minor girl was raped and sexually assaulted and at least a dozen others were sexually abused at what turned out to be a fake National Cadet Corps (NCC) camp in Tamil Nadu's Krishnagiri, police said here Monday. Eleven people, including the organiser of the camp, the school's principal and two teachers have been arrested for their alleged involvement in the case

Investigations have revealed that the private school did not have a NCC unit and a group approached the school management with the claim that hosting such a camp would qualify them for one, police said. The school failed to conduct back-



ground checks before hiring the

group for the camp. A total of 41 students all minors), including 17 girls, participated in the three-day camp held earlier this month. The girls were accommodated in the school auditorium on the first floor, while the boys stayed on the ground floor. However, not a single teacher was assigned to supervise the camp. After the end of the camp, a number of girls alleged that they have been sexually assaulted after being lured out of the auditorium. Medical tests confirmed the allegations of rape and sexual assault.

"The school authorities were aware of the sexual offences but chose to suppress the matter instead of informing the police. The students were allegedly instructed to not take it seriously and not to talk about it to their parents," district superintendent of police, P Thangadurai was quoted as saying by NDTV.

The senior police official informed that all the accused have been charged under the stringent Protection of Children against Sexual Offences (POCSO) Act.

In another shocking incident, a 13-year-old girl was allegedly gangraped for five days by five men in Arunachal Pradesh's Daporijo. Even though the girl was abducted from her house forcefully and taken to the residence of one of the accused July 22, she mustered courage only recently to file a police complaint. The police arrested Monday the five accused under the POCSO Act.

In another case, five persons have been arrested for their alleged involvement in the gang-rape of a teenage girl in a bus belonging to the Uttarakhand government. Dehradun senior superintendent of police Ajay Singh said Monday that those arrested include the driver and the conductor. Singh added that the incident took place August 12.

### 3rd elephant death in state in 24 hours

Bhubaneswar, August 19:\_\_\_ 'Ramu' the well-known tusker residing inside the Chandaka-Dampara Bharatpur sanctuary on the outskirts of this city, breathed his last Monday. There are conflicting reports as to how Ramu died. Some stated that the tusker was electrocuted after coming in contact with a live wire while others said that the animal had swallowed a crude bomb which exploded leading to its death.

This is the third elephant death in the state in the last 24 hours. Two elephants had died Monday in Sambalpur and Sundargarh districts. While one elephant died after coming in contact with a live wire, an elephant calf was run over by a goods train.

A team of Forest department and OUAT officials reached the spot where Ramu breathed his last and sent the body for postmortem. They said only after the report comes, the real cause behind Ramu's death can be ascertained.

### Pune food joint wins battle of 'Burger Kings'

US CORPORATION HAD FILED A SUIT IN AN EFFORT TO PREVENT THE PUNE-BASED RESTAURANT FROM USING ITS NAME

Pune, August 19: After over a decade of litigation, a Pune court recently dismissed a trademark infringement suit filed by United States' (US) fast-food giant 'Burger King Corporation' against a Pune-based burger joint from using the iconic name 'Burger King' as per a report in

Bar and Bench, Monday.  $The \, controversy \, started \, after \,$ 'Burger King Corporation', which manages a global network of 13,000 fast-food restaurants, filed a suit against Anahita and Shapoor Irani, the owners of Pune's 'Burger King' joints in Camp area and Koregaon Park.

The US Corporation, founded

in 1954, had just entered the Indian market in 2014. After learning that a restaurant with the same name had been serving locals since 2008 with the trademark application No. 1209146, it filed a suit claiming that the use of their name by the Pune restaurants was causing irreparable harm to its brand reputation. The US Corporation sought

permanent injunction from the court to restrain the Punebased restaurant from using the 'Burger King' moniker. They claimed trademark infringement and sought damages and a permanent injunction.

Judge Sunil

Vedpathak decided in favour of the Pune restaurant. He noted that the city's 'Burger King' had been using the name and brand since 1992, long before the US Corporation registered its trademark in India.

The court empha-

sised that while the international conglomerate had not operated under the name in India for almost 30 years, the Pune restaurant had regularly supplied its customers under the 'Burger King' brand, making its use of the name legitimate and authentic. 'With respect to relief of perpetual injunction is concerned,

admittedly the plaintiff has started to provide services through restaurant under its trademark Burger King' in India particularly in the year 2014 whereas

since 1991-92 the de-

fendants are using

trademark

'Burger King' to provide restaurant services. Even the plaintiff has not placed on record the registration certificate about registration of its trademark in India under class 42 prior to 1991-92. So, considering the fact that defendants are prior user of trademark in question, I am of the opinion that the plaintiff has no cause of action to seek relief of perpetual injunction," the court observed.

The court was of the view that the Pune establishment has been conducting their business for long with the said name without interruption. Therefore, they are the honest and prior user of the name and not the US Corporation, it added.

Berhampur, August 19: On day when siblings were celebrating Raksha Bandhan across the country, a boy stabbed his minor sister to death in this town. The accused was identified as Ashutosh Panigrahi (23) while his cousin Prajukta Panigrahi was just 13 years old. The tragic incident happened at a place under Bada Bazar police limits in this city. According to sources, the de-

ceased along with her family members had gone to her relative's house. There in a fit of rage, Ashutosh picked up a knife and attacked Prajukta and her brother Ayushman, (14) stabbing them repeatedly.

Immediately after the gruesome stabbing, Ashutosh fled to the Hinjilicut bus stand and tried to jump before a Bandhabahalbound bus from Jharsuguda to die by suicide. He sustained critical injuries and has been admitted to a hospital here.

To get that kind of budget from digital and satellite rights—because on these platforms, male-centric films tend to perform much better compared to a film centered around a woman. I think that's where the difference lies," she added.

Later he lodged a complaint with the Airfield police. Acting on the complaint, the cops searched Suraj for over three months before finally nabbing

### No DJ music during Ganesh Puja festivities



Bhubaneswar, August 19: The Commissionerate Police has banned the use of disc jockeys (DJ) during Ganesh Puja celebrations in the twin cities of Bhubaneswar and Cuttack

The Ganesh puja will be celebrated September 7.

Police Commissioner Sanjeeb Panda said this after holding a meeting with the puja organisers in the Silver City. Similarly, Bhubaneswar deputy commissioner of police (DCP) Prateek Singh held another such meeting here Sunday.

In both meetings, the organisers have been asked not to use DJ music during the puja, including idol immersion processions.

The idol immersion ceremony in Cuttack is scheduled for September 15, 22 and 29. The puja committees have been asked

to seek permission from the local police station seven days before,

Similarly, the puja committees in Bhubaneswar will hold the immersion processions September 8, 11 and 15, said DCP

Ganesh Puja committees have been asked not to play DJ music and install CCTVs in their pandals, he said, adding, "We have directed them to use traditional musical instruments instead of DJs during the procession."

Strict action will be taken for forcible collection of donations from the people, he warned.

The police will deploy adequate number of security personnel in the Capital city to regulate traffic during the puja.

DJ owners, however, opposed the move and said the ban order will affect their livelihood in the upcoming festival season.

### Rapid rise in students cycling to school in rural India

New Delhi, August 19: There has been a rapid rise in the number of students cycling to school in rural areas and the "silent revolution" is being led by girls, especially in Bihar and West Bengal, new research has found.

The scholars at the Indian Institute of Technology (IIT), Delhi and the Narsee Monji Institute of Management Studies (NMIMS) also found strong evidence that bicycle distribution schemes (BDS) have helped increase cycling in states where these were implemented and the biggest beneficiaries were rural girls

According to Srishti Agrawal, a PhD scholar at IIT-Delhi's Transportation Research and Injury Prevention Centre, gender norms, affordability of bicycles, distance to school, and safety on roads are likely the major determinants of cycling to school in India.

"Nationally, cycling to school levels increased from 6.6 per cent to 11.2 per cent over the decade (2007 to 2017). These levels nearly doubled in rural India (6.3 per cent to 12.3 per cent) while remaining stable (7.8 per cent to 8.3 per cent) in urban areas. Among the four population sub-groups, the largest increase in cycling was among girls in rural areas," Agrawal said. The research published in the

prestigious "Journal of Transport Geography" found that in a large majority of states, cycling share increased for both genders, with a greater increase among girls.

The greatest increase in cycling among girls occurred in rural Bihar where levels increased eight-fold. In West Bengal, cycling among girls increased three-fold making it the state with the highest cycling levels among rural girls across the

"The cycling levels among girls almost doubled in the rural regions of the following: Assam, Chhattisgarh, Jharkhand, Madhya Pradesh, Odisha, Tamil Nadu and Uttar Pradesh. The cycling levels declined significantly in rural areas of Manipur for both genders," the report



Aditi Seth from NMIMS, Mumbai said the phenomenal rise in cycling levels across a large part of the country, is a "silent revolution"

"We use the term silent to not only indicate the absence of traffic noise, cycling is associated with, but also to highlight a complete lack of attention on this trend and its underlying reasons within the community of transport researchers, policymakers, or practitioners.

"For instance, we did not find a single research paper pub-

lished in a transportation journal that studied the travel behaviour impact of bicycle distribution schemes, which we found are the drivers for the growth and widespread use of cy-

cling in many states. "We call it a revolution because cycling levels increased among girls in a country which has high levels of gender inequality in terms of female mobility outside the home, in general, and for cycling, in

particular," Seth said. In urban areas, cycling levels Researchers at IIT-Delhi and NMIMS, Mumbai found that girls are leading the 'silent revolution'. According to their study, Odisha is among seven Indian states where cycling levels among girls almost doubled rural areas

either declined or remained constant in more than half of the states among both genders. In a few states, where cycling levels increased, there have been significant jumps.

For girls, cycling levels increased 10 times in Tripura and quadrupled in the states of Arunachal Pradesh and Bihar and tripled in West Bengal.

For boys, cycling levels increased from no cycling to 5.8 per cent in Arunachal Pradesh. more than tripled in Delhi and doubled in the states of Chhattisgarh and West Bengal. In urban areas of the states

(Haryana, Maharashtra, and Punjab) where cycling share declined for both genders, the decline was greater for boys compared to girls.

"We found strong evidence of the positive impact of bicycle distribution schemes on cycling levels. Overall, cycling levels increased by an average of 3.6 percentage points in states with BDS and by 0.8 percentage points without BDS. States with the largest growth in cycling levels were often the ones where BDS was implemented, particularly in rural areas," said Rahul Goel,

Assistant Professor, IIT-Delhi. "Also, the effects of BDS were more prominent in rural areas, because a large proportion of students (more than 70 per cent) are enrolled in government schools, which are the type of

schools that are eligible for BDS. "In comparison, the majority of the students in urban areas are enrolled in private schools where BDS is not applicable and hence its impact is small," he

Bhubaneswar, August 19: Odisha Police, which recently busted a major SIM box racket in the state, will send a special squad to Ranchi to seize another SĪM box there with Jharkhand Police's help, a senior officer said, Monday

The racket was busted August 16 when police arrested West Bengal resident Raju Mandal in

During the operation, authorities seized five active SIM boxes, two reserve SIM boxes, and over 750 SIM cards, along with routers and other equipment from Mahadev Nagar area under Laxmisagar police station limits here.

According to police, the racket was being operated by a

Bangladeshi national who used the setup in the Capital city here to reroute international calls from Pakistan, China, and West

Notably, SIM boxes are used to hide original phone numbers and are often employed for cybercrime, hate speech, terrorist acts, extortion, and other illegal activities, posing challenges for law enforcement agencies.

Twin city police commissioner Sanjeeb Panda said, "According to our investigation, there is another SIM box in Ranchi. Our police team will go there to conduct a search and seizure operation with the help of local police."

During questioning, Mandal said he had been operating SIM boxes from multiple locations, including Cuttack and Ranchi.

Following this information, a

perts, conducted a raid on a house in Madhupatna area of Cuttack Sunday and seized five SIM boxes. 236 active SIMs, 310 reserved SIMs, routers, a broadband connection, and other materials.

Panda said that Mandal had rented the house in the City here in December 2023, under the pretence of running a cloth business. He paid the rent of Rs 8,000 per month through PhonePe, police said.

Asadur Zaman, a 30-year-old from Feni, Bangladesh, had arrived in Cuttack in December to set up the SIM box operation, with Mandal responsible for maintenance. Asadur had an Indian visa valid until October 24, 2024, and had entered India via Integrated Check Post (ICP) Agartala October 21, 2023 before departing for Bangladesh December 24, 2023, through ICP Haridaspur (WB), police added.

Mandal was also known to visit Bangladesh by bus via Basirhat border and occasionally visited Bangaon for small-time

It was there he met Asadur and the two planned to establish a SIM box operation in India. Mandal would travel from North 24 Parganas weekly to maintain the SIM boxes, including overseeing internet and electricity services, police said.

Police have traced three bank accounts — two in Mandal's name and one in his wife's name — and are awaiting fur-

Bhubaneswar, August 19: The East Coast Railway (ECoR) has successfully commissioned a Freight Train Examination and Routine Overhauling (ROH) facility at Sarla station under Sambalpur division to meet the growing industrial demands of western and southern Odisha, official sources said, Monday.

The project, executed by RITES Limited in collaboration with the Gati Shakti Unit (GSU) of the Sambalpur division, involves an investment of around ₹200 crore and was completed in June this year.

The Sambalpur division, one of the fastest-growing divisions in Indian Railways, plays a crucial role in serving the key industries of the region, including steel, aluminium and coal sectors.

The development of the freight depot at Sarla station was essential to improve operational performance and support the industrial growth in the region.

Prior to this development, the absence of a nearby freight train examination facility forced rakes to be examined at distant locations, affecting the efficiency of operations.

The ROH shed, a new G+1 station building, an electric substation, offices, a trainee hoshave been developed at a cost of ₹160 crore by RITES Limited. These facilities were commis-

sioned in June 2024. The GSU has developed one additional loop line and two freight the ROH and sick line work are examination lines at an approximate cost of ₹40 crore. Full electrification of these lines was completed in August 2024.

"The Sarla yard was remodeled with 64 new turnouts and 10.4 TKM of new tracks, along with the conversion of PI to distributed EI of Kyosan make, with 195 routes commissioned," ECoR sources said.

The new Sarla yard was successfully commissioned June14 last, and freight train examinations commenced June 25 while the first ROH outturn was achieved August 13 last, they said.

The vard has a monthly capacity to handle 90-100 train examinations and ROH of 100 wagons, significantly boosting loading performance while improving safety and reducing the Turnaround Time (TAT) of BTAP (aluminium-carrying wag-

ons) by 30 per cent. In a first for Indian Railways, being operated on a complete outsourcing model, with skeletal staff ensuring efficient operation of the freight depot.

The development of the freight depot at Sarla station is expected to stimulate economic growth in the Sambalpur region by attracting industrial and commercial activity, while also creating jobs, they pointed out.

The proximity of the facility to major industrial hubs such as Jharsuguda and nearby sidings enhances the operational efficiency of freight operations in the region.

'With the commissioning of the new Sarla yard, the ECoR is now well-positioned to support the expanding industrial landscape of Odisha, contributing to the region's economic prosperity and ensuring smoother, more efficient freight operations across the Indian Railways net-

nowsing videos on TikTok or YouTube can be a hitand-miss affair, with gems lurking amid mediocre efforts. But researchers have found that switching to another video, or skipping forwards and backwards in the same one, actually makes people more bored.

Dr Katy Tam at the University of Toronto Scarborough, the lead author of the research, said boredom was closely linked to at-

"We feel bored when there's a gap between how engaged we are and how engaged we want to be," she said. "When people keep switching through videos, they become less engaged with the videos and they are looking for something more interesting. This can lead to increased feelings of boredom.

The results appear to chime with other studies: as the team notes, previous research has suggested that while boredom relief is a driver for people to use social media or smartphones, the use of such technology ap-

Experimental Psychology: General. Tam and colleagues report how they carried out seven experiments involving a total of more than 1,200 participants.

The first, involving 140 participants, revealed that people tended to switch between videos more when they rated the content more boring, while the second - an online survey involving 231 participants - suggested people thought having the option to skip through a video or switch to another would make viewing a video less boring.

However, the team's subsequent experiments suggest this is not the case.

Data from a group of 166 undergraduates suggests participants felt more bored when allowed to skip about within a video than when they were not able to, while results from 159 undergraduates revealed they reported higher levels or boredom when given a collection of fiveminute videos they could switch



between, compared with a single 10-minute video.

The researchers found similar results when the latter experiment was repeated with 174 undergraduates who were allowed to pick their own videos from YouTube – although the size of

However, when they looked at the results from 175 participants of a broader age range, they found no difference in reported boredom when the participants were given fiveminute videos they could switch between, or a single 10minute video to watch. What's more, unlike in the earlier experiments, the order in which participants undertook the viewing tasks had an influence on their levels of reported boredom.

Tam said one explanation for the differences could be demographics, noting the later experiments involved participants with a broader age range and

lier experiments 'We speculated that people of different ages may have different habits when it comes to watching videos and switching,' she said. "How people consume videos and how this affects boredom may vary based on age and digital media habits, but further research is needed to explore

Ultimately, said Tam, it could be worth taking your time before hitting the fast-forward or skip buttons, and find ways to stay focused while watching videos.

'Our research shows that while people fast-forward or skip videos to avoid boredom, this behaviour can actually make them feel more bored," she said. "Just as we pay for an immersive experience in a movie theatre, enjoyment often comes from immersing ourselves in videos rather than swiping through

### **Errant officials in quarry quandary**

Row over 14 black stone quarries operating in proposed reserve forest areas

Jajpur, August 19: Leasing out any portion of a reserve forest (RF) or proposed reserve forest (PRF) land for mining is illegal as per law. However, a forested area under Dharmasala tehsil and Cuttack forest division in Jajpur district has allegedly been destroyed by leasing out 14 black stone quarries on the PRF land. After an inter-departmental inquiry uncovered the wrongdoing, errant officials are now in a quandary.

Extraction of black stones from the PRF land has not only led to depletion of green cover but also affected the bio-diversity in the area.

Earlier, wild animals like leopards, bears, elephants, barking deer and porcupines used to be seen in the forest. However, the destruction of forest cover, illegal stone extraction in quarries. blasting of explosives and lack of water sources have led to an exodus of wild animals from the

Moreover, the PRFs at Asia-Charinangal, Balarampur, Madhupur, Bandhapali,

Kantigadia, Maulabhanja and Bairagiri areas are on the verge of extinction for similar rea-

Reports said that the state Mining and Revenue departments have leased out 14 black stone quarries on a PRF land. The extraction of minerals has severely affected the bio-diversity in the forest area. The matter came to light after the DFO of Cuttack forest division wrote a letter (August 2) to the Jajpur Collector asking him to cancel the lease of one quarry inside the

Later, acting on the direction of the Collector, a joint team of Minor Minerals. Forest and Revenue departments conducted a probe and found 14 black stone quarries operating inside the proposed reserve forest area,

This has established that the lure of easy money through black stone mining has resulted in illegality and wrongdoing among the government officials. The disclosure has caught the errant government officials on the wrong foot as they are now trying to come clean on the issue by

shifting the blame on others.

Sources said the Forest department had declared 15 forest blocks under Cuttack forest division in Jajpur district as PRFs under Odisha Forest Act-1972 and Section 4(1) of Indian Forest Act-1927. These declarations were made in between 1970 and 1980. The move was necessitated to protect the rich bio-diversity in these forest blocks and to safeguard the interest of the peo-

Subsequently, the Cuttack DFO wrote a letter (7170, dated-September 13, 2019) to the Jajpur Collector apprising him about the declaration of PRFs. Later, in another letter (7283, dated-August

2, 2024) to the Jajpur Collector he asked him for cancellation of Anjira BSQ-7 in Maulabhanja

However, the district administration, instead of taking any action, chose to remain silent which led to the destruction of forest cover. Sources said 14 black stone quarries spread over 114.12 hectare land in Maulabhanja PRF in Dharmasala tehsil have been given on lease. The extraction of black stones still continues unabated from quarry no-1, 4, 7, 10, and 17 in Anjira hill. The DFO in his letter has asked the district Collector to cancel the lease of Anjira quarry no-7 which he claims to be on PRF area, August 2.

Acting on the direction of the district Collector, the joint team which started its probe from Friday has found that not only Anjira quarry no-7 but 14 quarries are operational inside the

Similarly, the miners are also looting black stones from two more PRF areas in Balarampur and Kolha areas in the district.

Leasing out quarries for black stone mining in PRF areas is illegal but the government officials have dared to give these quarries on Environmentalists are waiting to see what action the state government plans to take against theses unscrupulous officials.

When contacted, deputy director Jay Prakash Nayak of Minor Minerals department said that the PRFs have not been demarcated nor there is any mention about it in the district survey report (DSR). The cluster mining plans have been\_ sanctioned earlier on the basis of which the black stone quarries were given on lease, he

### Secret meeting place of freedom fighters lies in neglect

Rayagada, August 19: A secret meeting place of freedom fighters and the Samagra Vikash Prayog Kendra (SVPK) at Gopalbadi village under Kolnara block in this district are lying in a state of neglect and in dilapidated condition due to lack of proper upkeep and maintenance. Even though the country celebrated its 78th Independence Day, Thursday, nothing much is being done for the upkeep of the SVPK and the meeting place of the freedom fighters by the district administration.

celebration Independence Day reminds us of the sacrifice by freedom fighters for the country to free it from the British rule

The SVPK was established with an aim to bring in all round development of tribals in the area through education, agriculture, health and livelihood initiatives and make them self-reliant.



However, now it lies in ruins. Local intelligentsia has al-

leged that these two places are not even decorated on special occasions like Republic Day and Independence Day. They blamed the officials of various departments of the district administration for the dilapidated condition the two places are

currently facing. Locals also blamed officials

of the Utkal Khadi Mandal (UKM) for the rot that has set in. The Utkal Khadi Mandal was established in 1920 to promote the use of Khadi which was a symbol of self reliance and a way to boycott British goods.

Incidentally SVPK is a subsidiary of Utkal Khadi Mandal which has its office in Bhubaneswar. However, officials of UKM rarely have time for SVPK. No funds are allotted for the development and upkeep of SVPK.

The secret meeting place of freedom fighters was on a 27acre land surrounded by hills at Gopalbadi village under Kolnara block. As the place is not easily accessible, the freedom fighters used it as their secret ren-

Eminent freedom fighters like

Gopabandhu Das, Nabakrushna Choudhury, Jay Prakash Narayan, Rama Devi, Nana Saheb and Malati Devi used to frequent the place regularly. They used to hold meetings to inspire the young freedom fighters.

At that time, the freedom fight-

ers used the SVPK to make people in the area self-reliant through poultry farming, agriculture, livestock farming and weaving clothes. Freedom fighters like Mukteshwar Beuria Annapurana Moharana and Biswanath Pattnaik contributed a lot in developing the area. 'Bhoodan' leader Vinoba Bhave also visited this place during his visit to this district in 1951.

After India became independent in 1947, people in the area took up livestock farming and used to sell cow milk. However, due to lack of maintenance the centre now remains locked. Roofs and walls of many of the rooms are in dilapidated conditions while wild shrubs

have grown all over the verandah and in adjoining gardens. The historical importance of the place has faded into oblivion

Headmaster Bijay Kumar Nayak of Utkal Khadi Mandal Madhyamika Vidyapitha said that the centre was built with a noble purpose. Hence it should be renovated immediately to keep the memories of the freedom fighters alive.

Locals have asked the district administration to again launch programmes like livestock farming which will help in empowering the people financially. Prabhas Chandra Sethi, assistant secretary of Utkal Khadi Mandal in Bhubaneswar said plans for establishment of a school and hospital in the area are underway. They are likely to be set up in the next couple of years, Sethi said. He added that measures will be taken to preserve the land where freedom fighters met during the struggle for independence.

### Tragedy in Sudan

t has to be seen to be believed how the poorest of the poor in a third country are used as pawns in a power game played by richer and more powerful nations. These powerful governments, who stand to only profit, commit almost a war against humanity by pretending to resolve bloody conflicts, while in reality adding fuel to fire.

The ongoing conflict in Sudan is a case in point. It has already taken a heavy toll of lives - 150,000 people - while on an average 10,000 children are getting displaced each day. Girls as young as eight are being raped by fighters, according to a report by Unicef. Worse still is the fact that babies born of sexual violence are being abandoned.

Nature too seems to be conspiring against the Sudanese population. Famine is intensifying and 25 million people are experiencing acute hunger, as the warring groups block aid deliveries. US special envoy to Sudan, Tom Perriello, has warned that starving women and children are being used by the army and paramilitary fighting against each other as their arsenal. The destruction in the country's agriculture heartland shows darker days are ahead.

The International Organization for Migration has also expressed concern that the situation has reached breaking point. Heavy rains and flooding have exacerbated the humanitarian crisis.

The root cause of this human tragedy, far worse than any of the ongoing war, is the conflict that began more than a year ago, when the Sudanese Armed Forces (SAF) under Gen Abdel Fattah al-Burhan and the Rapid Support Forces (RSF) under Mohamed Hamdan Dagalo. known as Hemedti were locked in deadly war to gain control over the

Efforts to clinch a ceasefire deal last week ended in a fiasco after the Sudanese military did not turn up for talks in Geneva. Only the RSF attended the meeting. The latter was organically the creation of the army and the two had collaborated to overthrow the civilian democratic government in 2021 in a coup d'état. They wiped out the gains of the popular uprising that toppled the Islamist dictatorship of Omar Al-Bashir in 2019. However, RSF leaders can hardly claim to be peacemakers while continuing the terror campaign.

The opening failure of ceasefire talks in Geneva recently has, once again, brought back the civil war under international spotlight. The talks aimed at creating conditions for a truce in the conflict that has already forced 11 million people from their homes and 2.3 million others to flee to neighboring countries. With the warring groups blocking access to food aid, 25 million people in Sudan - more than half the population – are suffering from severe hunger.

The involvement of third parties is compounding matters further as the warring groups are getting a steady supply of arms from at least three countries. While Egypt and Saudi Arabia support the official army, the RSF receives backing from the United Arab Emirates and Russia. It is such a vicious circle that numerous armed groups and, willingly or unwillingly, tens of thousands of civilians have been sucked into the vortex of the conflict. In this climate weapons are available in far greater quantities than staple foods.

An Amnesty International report states weapons manufactured in China, Russia, Serbia, Turkey, the United Arab Emirates and Yemen are being delivered to Sudan, particularly in Darfur, despite the UN embargo that has applied to this western region of the country since 2004.

Everyone says third party interference must end if any viable ceasefire is to be enforced through political negotiations involving the Sudanese civil society. However, no one knows how and currently it seems only strong international pressure can bring about a change. The world at large cannot feign ignorance as millions suffer in a country three times as big as France.



### **WOMEN & WORKPLACE SAFETY**

**FEMALE DOCTORS AND NURSES STILL FEAR FOR** THEIR SAFETY **EVEN INSIDE A** HOSPITAL

25-vear-old nurse Aruna Shanbaug was sexually assaulted by a male sweeper in Mumbai's renowned King Edward Memorial Hospital. He choked her with a dog chain and raped her and left her for dead. The assault resulted in brain damage, paralysis, cortical blindness and cervical cord injury. She was found the next morning, but not dead. This was in 1973. For the next fortyone years she remained in a vegetative state, cared for by the staff of the hospital. They refused to vacate her bed despite pressure from the Municipal Corporation to move her out of the hospital. She eventually died in the hospital. Many people had campaigned for euthanasia for her which was refused by the highest court. Her case led to a landmark legal judgment permitting passive euthanasia in India. But her ordeal will always remain a blot on society and a matter of shame. Even after fifty-one years, as the recent brutal rape and murder of a trainee doctor in a Kolkata hospital tells us, not much has changed. Female doctors and nurses still fear for their safety even inside a hospital. It also strongly highlights the issue of workplace safety

for women. This is one of the contributory factors affecting women's participation in the workforce. As such India has had one of the lowest workforce participation rates for females among all G20 countries. It declined from around 30% in 2004 to 20% by 2017. It has improved in the past few years after COVID. The sharp decline is attributed to a variety of supply and demand factors. On the demand side is the reluctance of employers to hire women, either in blue collar manufacturing or in white collar services sector. Work opportunities are not expanding fast enough. Another strange demand side reason is a law which was meant to be women friendly. The national law for compulsory maternity leave

perversely led to less not more recruitment for women.

On the supply side are factors such as social and cultural norms which prevent women from taking up jobs outside home. Or the priority given to household work and care giving to children and the elderly. Women do nearly 90% of household work, which is unpaid work. This ratio is most adverse against women, when seen as male to female sharing of housework across different societies in the world. In Africa and many Western countries, the share tends to be more equal, but not so in South Asia. Additionally, women workers are much more active in agriculture, where too their work remains hidden and unpaid.

But another important factor is workplace safety. The National Crime Records Bureau reveals that there is a 20% increase in reported gender crimes in the past four years. This is an underestimation because a large number of crimes go unreported. For fear of reprisal, the stigma attached to the victim and no confidence in police investigation. The case of the 2001 Kolkata rape from the same hospital proves how investigation was botched and the perpetrator was not punished. There are the additional factors of the victim blaming syndrome and misogynistic attitudes which deter women from lodging formal complaints. There was an advisory from Assam's Silchar Medical College Hospital urging female students and doctors not to venture out at odd hours. This is not an isolated example of societal attitudes whose message is, women be careful, there are rapists out there.

In a 2021 research paper by Tanika Chakraborty and Nafisa Lohawala, the authors estimate the impact of fear of violence on female participation rate in workforce. They report that "For every additional crime per 1,000 women in a district, roughly 32 women are deterred from joining the workforce." So it is not just the prevalence of crime but the threat of sexual violence that can deter women from taking up formal sector jobs. This results in a sort of self-censorship. The irony is that female enrolment in colleges and higher education is rising, and they often outperform their male colleagues in academics. In most medical schools the incoming female enrolment is more than 50%, but the proportion of practicing female doctors is still less than 15%. This is a national loss, if a woman doctor is lost to society. It is not just for child and family care that she drops out, but it could also be due to workplace safety issue.

After the Nirbhaya case, the laws were tightened against sexual violence. We also have stringent laws against child abuse. Yet the laws have not stopped reported sexual crimes from grow ing as the NCRB data shows. The issue of rising sexual violence against women is not just a matter of ensuring more safety and getting justice. It also adversely affects India's economy. India's low female labour force participation rate is coupled with a gender wage gap. This makes it a double whammy. If both these issues are addressed there will be a big jump in employment, earning and output. It is as if India is ignoring the immense growth potential of half its human capital. The policy solutions to increasing women in formal employment are manifold. For instance in Japan Prime Minister Shinzo Abe championed "womenomics" of which one major component was starting half a million State funded high quality creches. In India too there will be legal, fiscal and social policies to encourage more women to join the workforce. This could also take the form of reservation of certain jobs only for women, or providing them free public transport, or exempting them from income tax. Culturally too the attitudes and language have to reflect granting women more autonomy for their decisions, and acknowledging their identity independent of just being a dear "sister", "mother", "wife" or "daughter", i.e. only defined in relation to males. But most of all let us not forget that workplace safety will remain a prime concern. If women have to constantly worry about the threat of sexual violence at work or in public places, that will always be a negative factor in increasing their participation in the workforce.

### When growth obscures grim realities

IT IS IMMATERIAL WHETHER INDIA **WILL BECOME A DEVELOPED COUNTRY OR NOT BUT PEOPLE SHOULD HAVE A DECENT AND MEANINGFUL LIFE WHICH IS** MISSING BY A BIG **MARGIN** 

Day speech outlined a series of ambitious goals designed to drive India's future growth and global standing. Hailing Independence Day 2024's theme of 'Viksit Bharat at 2047', he echoed his aspiration to transform the country into a developed economy by 2047 or achieve high-income status within a generation.

Drawing inspiration from the nation's freedom struggle, PM Modi emphasised the power of collective determination, stating, "If  $40\,\mathrm{crore}$  people can break the shackles of slavery to gain freedom, just imagine what can be achieved by the resolve of 140 crore people.

However, during pre-Independence period, people were inspired by the sacrifice of leaders and joined the freedom struggle to liberate the country from imperial shackles. But today, dominance of hedonism, consumerism, greed and corruption are demotivating others to sacrifice. Politicians are found more entwined with corruption and criminal activities today.

The dream of Viksit Bharat by 2047 is devoid of reality and Indians are made to believe the hype that a grievous blunder for India to succumb to such publicity stunts. There are major structural problems that need to be fixed in the country to meet its potential.

Further, the 2047 deadline is far away. Nobody has seen tomorrow and everybody is dead in the long run. Talking about 2047 is just a ploy to make people forget their present problems of poverty, hunger, price rise, unemployment and inequality.

Currently, the Indian economy stands at \$3.6 trillion, making it the fifth-largest economy in the world after the US, China, Japan, and Germany. India continues to be the third largest economy in terms of purchasing power parity since 2011 which reflects the real size of the economy. No

change in the last 13 years. According to a report by India Ratings and Research, India should grow more than 9.7% consistently to reach \$30 trillion by 2046-47, which may not be easy. To maintain almost the same rate of growth with a higher base for the next 25 years needs something special. It depends upon real GDP growth, inflation (GDP deflator) and INR/USD ex-

The World Bank's latest report titled "World Development Report 2024" warns that India could be one of the 100 countries that are likely to fall into the middle-income trap if it does not play its cards well. The World Bank said that India will take 75 years to reach a quarter of the US' GDP and income per capita at the current rate.

For the current fiscal, low-income economies are defined as those with a GNI per capita, calculated using the World Bank Atlas method, of \$1,145 or less in 2023; lower middle-income economies are those with a GNI per capita between \$1,146 and \$4,515; upper middle-income economies are those with a GNI per capita between \$4,516 and \$14,005; high-income economies are those with more than a GNI per capita of \$14,005. Until 2006, the World Bank classified India as a low-income country. In 2007. India moved to the lower-middle income country and since then it has remained there. India has to move to a high upper middle-income and then high-income economy, which is a distant dream.

For countries that are diffi-

per capita income, economists turn to the standard of living for measurement. The United Nations' HDI ranks countries on three parameters: life expectancy, education, and per capita income. The countries are scored between 0 and 1 based on these three parameters. A country with an HDI index over 0.8 is generally considered developed. India attained an HDI score of 0.644 in 2022, positioning it at 134 out of 193 countries in the UN's

2023-24 report. GDP is not an indicator of the well-being of society. It is an indicator of economic activities which is spurred when richer sections of society produce and consume more. High growth obscures the grim realities of inequality, inflation, social discrimination and detrimental impact of privatisation. It is immaterial whether India will become a developed country or not but people should have a decent and meaningful life which is missing by a big margin.

When the Centre first appointed the "lateral entrants" in September 2019, care was taken to pick them primarily for nonsensitive ministries and, after some drop outs, there are at present 57 of them serving the government in different capacities. All this said, the bureaucracy has not been allowed any leeway by the National Democratic Alliance (NDA) government at the Centre. According to reports, the performance of the existing lateral entrants has been reasonable. It is hoped that the subject-matter experts will bring in the much needed innovation and liveliness to the departments without trampling upon the authority of career bureaucrats.

### J&K polls no cakewalk for any single party

IMMEDIATELY AFTER THE ANNOUNCEMENT WAS MADE BY THE CHIEF ELECTION COMMISSIONER IN NEW DELHI. A CHURNING OF SORTS IS TAKING PLACE IN THE POLITICAL PARTIES

Srinagar, August 19: With the Election Commission of India (ECI) announcing the 3-phased Assembly polls in J&K, it seems that a hornet's nest has been stirred up among the political parties in the Union Territory. Immediately after the an-

nouncement was made by the Chief Election Commissioner (CEC) in New Delhi, a churning of sorts is taking place in the political parties and the most affected by this development are the newly formed parties like the Democratic Progressive Azad Party (DPAP) headed by former chief minister Ghulam Nabi Azad, the J&K Apni Party headed by Syed Altaf Bukhari and the People's Conference (PC) headed by Sajad Gani Lone.

A senior leader and a close confidante of Azad, Taj Mohiuddin said Saturday that he would rejoin the Congress after announcing that he was leav ing the DPAP.

Taj left Congress immediately after Azad left it. Now it is going to be a 'homecoming' for the senior leader. Azad did not field any candidate in the Lok Sabha elections in Kashmir. However, his candidate, GM Saroori from Jammu's Kathua-Udhampur constituency lost the Lok Sabha election to Jitendra Singh of the BJP.

As was expected, Azad's parting ways with Congress after almost a lifetime association of over 50 years has finally cost him heavily. Reports now suggest



that Ghulam Nabi Azad is most likely going to rejoin the Congress

J&K Apni Party fielded its candidates Mohammad Ashraf Mir in Srinagar and Zafar Iqbal Manhas in Anantnag-Rajouri Lok Sabha seats and both candidates lost badly.

The two candidates lost their security deposit during the Lok Sabha elections. Worse than that, the J&K Apni Party did not get majority votes in any Assembly segment of these two Lok Sabha constituencies. Sajad Gani Lone of the PC fought the Baramulla Lok Sabha seat. Both Sajad and former chief minister and vice president of the National

Conference (NC), Omar Abdullah

were defeated by the incarcerated

Awami Ittehad Party founder,

Engineer Abdul Rashid Sheikh. Sajad Gani Lone and Omar Abdullah, however, polled respectable number of votes and both saved their security deposit.A senior leader and former minister, Choudhary Zulfiqar Ali of the J&K Apni Party met Union Home Minister Amit Shah Saturday and is likely

to join the BJP soon. The BJP is well entrenched in the Jammu division, but it is still trying to find its base in the Kashmir Valley.

Farooq Abdullah's NC has a strong presence in the Valley (Kashmir) and also an appreciable political base in the Muslim-dominated Assembly segments of the Jammu division. This is the apparent position, but this might not be the end

Engineer Rashid has already emerged as a potential challenge to the NC in Kupwara, Bandipora

and Baramulla districts. Sources close to Engineer Rashid told IANS that the incarcerated leader is likely to field candidates of his party in these three districts. In Baramulla, Kunwara and Bandinora districts Engineer Rashid can upset the otherwise well-entrenched NC.

It is also likely that after they got disgruntled with Pakistan, the separatists especially those belonging to the banned Jamaate-Islami could field proxy candidates in the south Kashmir districts of Shopian, Kulgam, Anantnag and Pulwama.

Believing that the Jamaate-Islami proxies cannot win Assembly seats would be behaving like the proverbial ostrich hiding one's head in the sand.

Youth of Jamaati families who joined militancy have either been killed or detained to prevent them from disturbing the law and order situation.

If the Jamaati youth choose to

fight Assembly elections on their own without declaring any affiliation with the Jamaat, it is constitutionally and legally impossible to prevent them from joining the democratic space.

Expecting that since these youth belong to Jamaati families and thus they would not win public support could be wrong as per past history.

In 1987, all anti-NC political parties fought the Assembly election and nothing short of blatant rigging by the then NC government kept the conglomerate, Muslim United Front (MUF) from winning a good number of seats. What the anti-NC forces could not achieve in 1987, can be done in 2024 given the assurance of completely free, fair and fearless elections by the ECI.

The PDP headed by former chief minister, Mehbooba Mufti may be down, but not out. It can still win some seats to make its presence felt.

J&K Assembly has 90 seats out of which 74 constituencies are for the general category, nine for Scheduled Tribes and seven for Scheduled Castes.

Given the above scenario, it will be politically naive if the NC or any other party believes that getting the simple majority of 45 seats is a cakewalk.

The destiny of all political parties lies in the hands of the voters and believing that the voters would stand in one queue for any single political party would be expecting the impossible.

Chief Secy told to submit monthly report on inspections

New Delhi, August 19: Delhi Lieutenant Governor VK Saxena has directed Chief Secretary Naresh Kumar to submit a monthly report on the inspections conducted by senior officers in the aftermath of deaths due to complete collapse of civic infrastructure this monsoon, officials said Monday.

In a written communication to the Chief Secretary, Ashish Kundra, the Principal Secretary to Saxena, said the LG has advised that an institutionalised mechanism be put in place for scheduled inspections by senior officers of facilities under their charge

It would help them obtain a first-hand feel of the core problems being faced by citizens and take corrective policy or regulatory measures. The Chief Secretary shall circulate a uniform format of inspection report to all departments and submit a monthly report on number of inspections done by each officer, read the letter.

Kundra also pointed out that even the Delhi High Court has taken a serious note in the matter of desilting of drains in the national capital and has made stinging observations.

The LG has observed that this monsoon has seen the complete collapse of civic infrastructure, leading to unfortunate and avoidable deaths of citizens. The underlying problems are symptomatic of endemic neglect, he said in the letter.

Drains have not been desilted for years, sewer lines are choked leading to flooding even in planned colonies, he added.

According to LG Saxena, all of this point to a complete absence of senior management oversight in the city, Kundra's letter said.

Sharing the LG's directions on the issue, Kundra said all head of departments (HOD), secretaries, principal secretaries, or additional chief secretaries need to draw up a schedule of field inspections and ensure that all assets or areas are inspected thor-

The inspection note of the principal secretary or secretary

of the department shall be submitted to the chief secretary with a copy endorsed to the LG Secretariat and the minister-incharge, he said.

According to Saxena's directions, the inspection note should summarise the core problem observed with the corrective meas ures invokes. The report should be annexed with geo-tagged pictures of before and after the intervention.

The communication to Kumar also fixed the frequency of inspections to be conducted by secretaries of the department concerned on a fortnightly basis while the HODs have to do them on a weekly basis.

The principal secretaries have also been advised to conduct inspections every fortnight.

The officers have also been directed to review the institutional mechanisms prescribed under various central and state acts and ensure that these are fully functional, the letter read.

Formulation of any rules, authorities, boards under these laws should be taken up within three weeks, it added.

The LG also insisted that there should be a robust mechanism of field level inspections at district level under the district magistrates (DM).

The inspection notes need to be submitted to the divisional commissioner who shall then send a consolidated note to the chief secretary, Kundra said.

District magistrates. SDMs

and ADMS shall undertake inspection twice a week in areas of public delivery services, focusing on road infrastructure, drains, sewage management, education, transport, etc. The executive engineer, deputy directors, and other related officers shall invariably accompany the district magistrate during the inspections. The inspections should cover all kind of settlements such as rural, urban, planned areas, JJ colonies, unauthorised

colonies, etc, the letter read. The DMs have also been asked to interact with the resident welfare associations in their jurisdictions once a month to find out the issues faced by local people and resolve them.

### Article 370, statehood restoration among NC manifesto's guarantees

Srinagar, August 19: Restoration of Article 370 and Jammu and Kashmir's statehood as well as implementation of the autonomy resolution passed by the erstwhile Assembly in 2000 are among the National Conference's 12 guarantees announced in its manifesto for the upcoming polls.

In June 2000, the NC government under Farooq Abdullah passed a resolution in the Assembly seeking to restore the pre-1953 constitutional position in the state. It was, however, rejected by the Union Cabinet headed by then Prime Minister Atal Bihari Vajpayee.

The Narendra Modi government abrogated Article 370, which gave special status to Jammu and Kashmir, in 2019 and bifurcated the erstwhile state into two Union Territories -- Jammu and Kashmir and Ladakh

Releasing the manifesto at a press conference here, NC Vice President Omar Abdullah said the party is making only those promises it can deliver. He described the manifesto as the NC's vision document and a roadmap

The manifesto makes 12 broad promises, including striving for the full implementation of the Autonomy Resolution passed by the Jammu and Kashmir Assembly in 2000.

The manifesto promises that the Jammu and Kashmir Assembly, in its first list of business after elections, will pass a resolution against the Centre's decision to strip the region of its statehood and special status.

Assembly elections in Jammu and Kashmir will be held in three phases September 18, September 25 and October 1. The results will be announced October 4.

Last December, the Supreme Court directed the poll panel to hold Assembly elections in Jammu and Kashmir by September 30.

New Delhi, August 19: Combining the old with the new, Ghantewala, the Mughalera outlet in Old Delhi's bustling Chandni Chowk, reopened its doors after almost a decade this week with its famed ghee soaked 'sohan halwa' and 'Karachi halwa' sharing space with healthier alternatives such as ragi laddus.

Established in 1790 by Lala Sukh Lal Jain, Ghantewala, one of the popular landmarks of 'Dilli 6' was forced to pull down its shutters in 2015 due to dwindling sales.

However, come 2024, the Mughal-era shop witnessing popular demand for its products on-

line is now back to its old address, this time in a new swanky avatar, attracting its patrons with the same old wafting aroma of desi ghee and the sweet mix of khoya, coconut and rich nuts.

"My whole family was extremely sad when we had to close the store in 2015. Many customers would come and complain to us, 'Where would we eat good quality sweets now, especially our favourite 'Sohan Halwa'," Ghantawala owner Sushant Jain told PTI.

"Finally, two-three years ago we started selling our legacy sweets online, and the kind of response we got from customers pan-India was too overwhelming. That is when we decided that we should start our physical outlet again," Jain said.

The 'Sohan halwa', a ghee dripping gram flour biscuit of Persian origin, has been a trademark delicacy of the shop since the beginning.

Giving a sneak peek into the rich history of the shop, and even food inflation over the



years, is the picture of its 1954 menu featured in the renovated outlet's 'wall of fame' where 'Sohan Halwa' is priced at almost

The current price for Sohan Halwa at the shop is ₹1,100 per kg -- an astronomical increase of over 18,000 per cent since 1954.

The wall of fame also displays pictures and testimonies of its eminent clients, including the likes of former prime ministers Jawaharlal Nehru, Indira Gandhi, Rajiv Gandhi, and Morarii Desi, and even acclaimed painter MF Hussain.

Aryan Jain, 23, son of Sushant Jain and the eighthgeneration descendant of Lala Sukh Ram, said the new outlet will be a balance of tradition and innovation.

So, besides the tried and tasted 'Aloo laccha', 'Mysore Pak', 'Dalmoth', 'Pista Lauj', the new menu also includes gluten-free delicacies like Ragi (Finger Millet) Laddu and sweetmeats made of dry fruits, containing natural sweeteners.

The menu also offers Delhi's famous street foods Chhola-Bhatura and chaat -- all prepared in desi ghee. "I am not selling just some

sweets and 'chaat' here, what I am mainly selling here is the legacy which I have inherited from my great great grandfathers," said Aryan, who recently pursued a degree in Hotel Management to add more expertise to the family business.



### **Modi to visit Ukraine**

This trip comes about a month after he met Russian President in Moscow

New Delhi, August 19: As Prime Minister Narendra Modi embarks on a nearly seven-hour visit to Kyiv this week, India Monday said it is willing to provide all possible support required to help find a peaceful solution to the Russia-Ukraine conflict.

The Ministry of External Affairs (MEA), announcing Modi's August 23 trip, said it would be a "landmark and historic" visit, the first by an Indian prime minister to Ukraine since diplomatic ties were established between the two countries over 30 years back.

The prime minister will travel to Kyiv from Poland in a train that will take around 10 hours. The return trip will also be of the same duration, people familiar with the matter said.

A number of world leaders including US President Joe Biden also travelled to Kyiv by train from the Polish train station near the Ukrainian border.

Before travelling to Ukraine, Modi will pay a two-day visit to Poland August 21 and 22.

The prime minister's visit to Ukraine is taking place amid Kyiv's fresh military offensive into Russian territory.

Modi's visit to Kyiv comes weeks after his high-profile trip to Moscow that triggered criticism from the US and some of its Western allies "India has substantive and in-

dependent ties with both Russia and Ukraine and these partnerships stand on their own," Tanmaya Lal, Secretary (West) in the MEA said at a media briefing.

The visit will build on continuing engagement between India and Ukraine, he said.

"I would like to say that this is not a zero-sum game. The prime

### Docs give OPD services outside Nirman Bhawan

New Delhi, August 19: Medics are offering elective outpatient services on the road outside Nirman Bhawan Monday, calling it a symbolic protest, as they continued their strike for the eighth consecutive day over the rape and murder of a trainee doctor in Kolkata.

Doctors sat with sheets of paper showing their names and specialisations -- ortho OPD, neurology OPD, psychiatry OPD, PMR - on the road in front of the office of the Ministry of Health at Nirman Bhawan Monday.

A doctor sitting on the road to check patients said, "At the hospital, there is no safety or protection. At least here, we have police around us, so we can treat patients here. We have no option but to fight for ourselves, as nobody is doing anything besides offering us sympathy and empty assurances.'

"The OPD we are operating here is a symbolic protest. We are both protesting and offering OPD services," Doctor Ansar

"We want the CBI to catch the culprits (of the Kolkata rapemurder incident) and for the court to impose the maximum punishment. We urge the government to ensure that no such incidents occur in the future." Around 300 to 400 people gath-

#### **CRPF** inspector killed in terror attack in J&K

Jammu, August 19: A CRPF inspector was killed when the terrorists opened fire on a patrol party in Jammu and Kashmir's Udhampur district Monday, officials said.

The CRPF along with the Special Operations Group (SOG) of the local police was fired upon by the terrorists around 3:30 pm in the remote Chill area under Dudu Police Station jurisdiction of Basantgarh, the officials said.

Central Reserve Police Force (CRPF) Inspector Kuldip, belonging to the G company of the 187th battalion, was hit by a bullet and later succumbed to his injuries while being taken to the hospital, they said.

The Udhampur Police posted information about this incident on its official X handle.

"During area domination patrol at Chill, Dudu, exchange of fire took place between terrorists and joint parties of JKP and CRPF. New Delhi, August 19: Upping the ante over the lateral entry issue, the Congress Monday accused the BJP of "snatching reserveration" and handing out posts meant for SCs, STs, OBCs, and EWS to people of the RSS.

president Congress Mallikarjun Kharge claimed that while his party-led government had brought in lateral entry to appoint select specialists and experts in some sectorspecific posts as per their utility, the Modi government has made provision for it to "snatch the rights" of Dalits, tribals and backward classes.

Leader of Opposition in the Lok Sabha Rahul Gandhi alleged that the government's move of recruiting public servants through lateral entry was an attack on Dalits, OBCs and adivasis. He accused the BJP of seeking to snatch reservations from 'bahujans'.

The Congress has strongly criticised the government after the Union Public Service Commission (UPSC) Saturday issued a notification for recruiting 45 joint secretaries, directors and deputy secretaries

through lateral entry -- referred to as the appointment of specialists (including those from the private sector) in government departments.

"Lateral entry is an attack on Dalits, OBCs and adivasis, Gandhi said on X.

"The BJP's distorted version of Ram Rajya seeks to destroy the Constitution and snatch reservations from bahujans," the former Congress chief said.

In a post in Hindi on X, Kharge said, "Why is the provision of lateral entry by the Modi government an attack on the Constitution? Instead of filling jobs in government departments, the BJP has eliminated 5.1 lakh posts in the last 10 years by selling the share of Government of India in PSUs alone.

Casual and contractual recruitment has increased by 91 per cent, he claimed. Posts for SCs, STs, and OBCs decreased by 1.3 lakh by 2022-23, he alleged.

"We had brought lateral entry to appoint select specialists and experts in some sector-specific posts as per their utility. But the Modi government has made provision of lateral entry not to appoint experts in the government but to snatch the rights of Dalits, tribals and backward classes,' Kharge said

#### **Centre approves 25%** increase in security at all central govt hospitals

New Delhi, August 19: The Health Ministry has allowed enhancement of security deployment by 25 per cent at all union government hospitals, official said, amid protests by resident doctors demanding a central law following the alleged rape and murder of a trainee doctor at a Kolkata hospital.

Officials said that apart from the standard security protocol, the deployment of marshals would also be approved based on individual demands by government hospitals after they conduct their security assess-

Official sources, however, said bringing a central law based on the RG Kar case "will not make any huge difference" as the alleged rape and murder of the junior doctor at the Kolkata facility was not a case of patientdoctor violence.

Crimes and rapes are already covered under existing laws, they said.

They further said that 26 states and Union Territories including West Bengal, Uttarakhand, Delhi, Haryana, Maharashtra, Assam, Karnataka and Kerala have passed legislations to protect healthcare personnel. In all these states these offences are cognisable and non-bailable.

"So, bringing in an ordinance or even a Central law, that too based on the RG Kar case which was not a patient-doctor violence incident, will not make any huge difference," an official source said.

### Top Court to hear plea August 20

New Delhi, August 19: The Supreme Court is scheduled to hear Tuesday a suo motu case, ahead of other matters, related to the rape and murder of a postgraduate medic at the RG Kar Medical College and Hospital in Kolkata amid the ongoing nationwide doctors' strike over it.

A bench headed by Chief Justice DY Chandrachud, which had taken cognisance of the incident, has kept the matter on top of the cause list for hearing at 10:30 am Tuesday.

The suo motu cognisance of the case, titled "In Re: Alleged rape and murder incident of a trainee doctor in RG Kar Medical College and Hospital, Kolkata and related issue", assumes significance in view of the fact that Calcutta High Court is already in action and has transferred the probe into the case to the Central Bureau of Investigation (CBI).

The top court may widen the spectrum of judicial scrutiny, keeping in mind the ongoing nationwide protests, especially by the doctors and their concerns.

The doctors' strike over the rape and murder of the medic completed a week Sunday and is now entering its second week, causing difficulties for patients.

### Security in NE a concern: Think tank

THE POLITICAL **INSTABILITY IN BANGLADESH HAS DIRECT REPERCUSSIONS BOTH ON SECURITY** AND DEVELOPMENTAL **PROJECTS IN NORTH EAST INDIA, SAYS** THINK TANK SHARE

Guwahati, August 19: Former foreign secretary Harshvardan Shringla has said that India needs to engage with those in power now in Bangladesh, as instability in the neighbouring country has a direct impact on the security scenario of the Northeastern region.

Shringla said this at a programme in which a report on policy options for India in dealing with the current Bangladesh situation was released.

The report, to be submitted to the Centre, was prepared by a think tank Society to Harmonise Aspirations for Responsible Engagement (SHARE).

The political instability in Bangladesh has direct repercussions both on security and developmental projects in North East India, security and defence experts, who are members of SHARE, said at the event.

"India has to engage with those in power or those behind the powers in Bangladesh as stability in the neighbourhood has a direct import to the security scenario of North East India.'

'We have two core concerns, Bangladesh's territory not be used in any manner inimical to its (India's) interests and ensuring the safety of Hindus and other minorities in the neighbouring country," the former ambassador to Bangladesh said.

Shringla also said that the recommendations in this report are prefaced by three key facts, it remains uncertain who is currently responsible for policy making in Bangladesh, there is palpable anti-India sentiments in the neighbouring country, and finally, economic stability and employment generation there.

The report will submitted to the Prime Minister's Office (PMO) and the National Security Advisor for implementation, former Eastern Command GOCin-C Lt General R P Kalita (Retd) said at the event.

Ex-Ladakh Lt Governor R K Mathur said that care has been taken to ensure the recommendations are "implementable and acceptable to all sections and ideologies" as the neighbouring country goes through socio-political upheaval.

'The recommendations are divided into short, medium and long-term so as to ensure a staged approach to policymaking on India's part which is mutually acceptable," the former defence secretary said. Assam Chief Information Commissioner Bhaskar Jyoti Mahanta, highlighting the recommendations, said dialogue with all stakeholders is in India's core interests, especially with regard to tackling a possible refugee crisis in the Northeast which has a border of 1885 kms with Bangladesh.



**BLINKEN SAYS ISRAEL AGREES TO A US-BACKED PROPOSAL FOR A CEASE-FIRE AND CALLS ON HAMAS TO DO SAME**

Tel Aviv, August 19: US Secretary of State Antony Blinken said Monday that Israel has accepted a proposal to bridge differences holding up a ceasefire and hostage release in Gaza, and he called on Hamas to do the same, without saying whether it had addressed concerns cited by the militant group.

Blinken spoke after holding a 2 1/2 hour meeting with Israeli Prime Minister Benjamin Netanyahu earlier in the day, and was expected to travel to Egypt Tuesday. The United States, Egypt and Qatar have spent months trying to broker an agreement, with the talks repeatedly stalling.

He did not say whether the so-called bridging proposal addressed Israel's demands for control over two strategic corridors inside Gaza, which Hamas has said is a nonstarter, or other issues that have long bedeviled the negotiations.

"In a very constructive meeting with Prime Minister Netanyahu today, he confirmed to me that Israel supports the bridging proposal," Blinken told reporters. "The next important step is for Hamas to

Blinken had earlier said the time is now to conclude a Gaza cease-fire agreement that would



return hostages held by Hamas and bring relief to Palestinian suffering after more than 10 months of devastating fighting

Blinken's ninth mission to the Middle East since the conflict began came days after mediators, including the United States, expressed renewed optimism that a deal was near. But Hamas has expressed deep dissatisfaction with the latest proposal. and Israel has said there were points on which it was unwilling to compromise.

The trip, days before new talks expected this week in Egypt, came amid fears that the conflict could widen into a deeper regional war following the targeted killing of two top militants in Lebanon and Iran that were attributed to Israel.

Kyiv, August 19: Moscow said Monday Ukraine had struck a third bridge in an assault on Russia's Kursk region which Kyiv says is aimed at carving out a buffer zone and wearing down Russia's war machine.

Ukraine says it has seized over 80 settlements in an area covering more than 1,150 square km of Kursk since its surprise strike on the Russian region August 6, the biggest invasion of Russia since World War Two.

But Ukrainian forces are on the defensive elsewhere and

face a battle to protect the strategic eastern city of Pokrovsk, where Russia has steadily advanced in recent weeks in heavy fighting more than two years since Russia's full-scale invasion.

'We are achieving our goals,' Ukrainian President Volodymyr Zelenskyy wrote of the twoweek-old incursion into Kursk on the Telegram messaging app Monday, adding that more Russian soldiers had been taken

Russia said a third bridge had been struck and damaged on the Seym River that winds through the Kursk region bordering northeastern Ükraine.

Ukraine has not yet commented on the strike, but Kyiv's air force chief has previously said his forces have destroyed two

bridges to weaken Military analysts enemy logistics.

Military analysts said the bridges were part of critical supply lines for Russian troops defending the area. Reuters could not troops defending independently confirm the damage to the bridges or the



"Symptoms started more than a week ago with fever, which was followed four days later by findings of a distinct rash on the face, back, nape, trunk, groin, as well as palms and soles," the Philippine DOH said in a statement.



ronment to the Universal Declaration of Human Rights in 2022 which further opens the possibility to take governments to the courts, it's not easy.

Gen Z is growing up in an era

where the impacts of climate

change are both immediate and

undeniable and it's leaving them feeling powerless. Generation Z, those born between 1995 and 2010, make up 30 per cent of the global population. In Australia's latest census, Gen Z accounted for 18.2

per cent (or 4.6 million) of the

country's 25 million population. Unlike previous generations, who had time to gradually adjust to the realities of environmental transformations, Generation Z is acutely aware of the ecological crises unfolding around them, leading to a deep sense of environmental anxiety.

**Distress and fear** 

As a result, many digitally connected, globally aware Gen Zers experience intense climate anxiety, characterised by chronic



fear, distress and deep concern

for the planet's future. A survey of Australian Gen Z university students was conducted between September 2021 and April 2022 with 446 participants which revealed that climate change is their top environmental concern.

They often feel let down by older generations, governments and institutions, whose actions

seem inadequate in the face of the growing evidence about the environmental threats the world and Australia in particular face.

More than 80 per cent of the young people participating in the survey expressed significant worry and many experienced severe climate anxiety.

This anxiety manifests in various forms, including eco-anxiety, solastalgia (distress trig-

gered by environmental changes) and climate grief, reflecting the complex emotional landscape of a generation coming of age amid a global environmental emergency.

The situation Gen Z faces and their future prospects are further exacerbated by the complexity of other developments resulting in what is known as a polycrisis, a "great disagreement, confusion, or suffering that is caused by many different problems happening at the same time so that they together have a very

#### big effect **Existential threat**

Eco-anxiety, a chronic fear of an environmental catastrophe, arises from the perception that climate change poses an existential threat.

For many in Gen Z, the overwhelming nature of this threat leads to persistent worry and stress. This is also fuelled by the sense of urgency and responsibility they think they have to comply with.

Gen Z is witnessing their local natural environments and the broader global ecosystem undergo rapid, often destructive and irreversible changes, including biodiversity loss, species extinction and the degradation of ecosystems.

Many experience profound grief which is tied not just to physical harm, but also to the loss of hope for a stable and prosperous future.

With 96 per cent of Australian Gen Zs believing that climate change is human-made, young people are experiencing heightened levels of stress, anxiety and depression as they grapple with the realities of a warming planet.

For some members of Gen Z, the constant stream of climaterelated news, coupled with personal experiences of climate-related calamities, such as wildfires, floods, droughts or cyclones, leads to a form of trauma that can have long-lasting effects on mental health.

#### Banks tapping alternative sources: RBI

Banks are tapping alternative sources like commercial paper and certificates of deposit as deposit growth lags credit growth, RBI August Bulletin said Monday. In the primary market, certificates of deposit (CD) issuances amounted to Rs 3.49 lakh crore during 2024-25 (up to August 9), significantly higher than Rs 1.89 lakh crore in the corresponding period of the previous year. This increase amid deposit growth lagging credit expansion prompted banks to rely on alternative funding sources, as per the RBI article. Commercial paper (CP) issuances also increased to Rs 4.86 lakh crore during 2024-25 (up to July 31), sur passing Rs 4.72 lakh crore in the corresponding period of the previous year, driven by NBFCs' higher borrowings in the CP market, it added. While unveiling bimonthly monetary policy, Reserve Bank Governor Shaktikanta Das expressed concern over household savings moving towards alternative investment avenues and asked banks to mobilise deposits through innovative products and services by leveraging their vast branch network. "Banks are taking greater recourse to short-term non-retail deposits and other instruments of liability to meet the incremental credit demand. This, as I emphasised elsewhere, may potentially expose the banking system to structural liquidity issues," he had said. About system liquidity, the bulletin said it remained in surplus during July and August so far on the back of an increase in government spending, the return of currency to the banking system and the Reserve Bank's forex operations. The average daily net absorption under the liquidity adjustment facility (LAF) increased to Rs 1.52 lakh crore from July 16 to August 15, 2024.

"Segregation of such DTR dues is purely an administrative act and this will not preclude the recovery officers from recovering the amount so segregated as DTR as and when there is a change in any of the DTR parameters," Sebi said in its annual report for 2023-24.

As of March 31, 2024, Sebi identified 807 cases as DTR, with a total outstanding of Rs 76,293 crore, up from 692 cases amounting to Rs 73,287 crore the previous year, according to the report.

Among these 807 cases, 36 are pending due to ongoing proceedings in State PID courts, National Company Law Tribunal (NCLT), National Company Law Appellate Tribunal (NCLAT) involving Rs 12,199 crore.

Additionally, 60 cases are before court-appointed committees, with Rs 59.970 crore at stake.

These two categories together account for 95 per cent of the total amount yet to be recovered. With regard to 140 DTR certificates falling under untraceable category, 131 relate to individuals and nine relate to companies amounting to Rs 13.3 crore and Rs 15.7 crore, respectively.

### Festive season pushes airfares by 25 per cent

New Delhi, August 19: Airfares are heading northwards for the festival season, with the average one-way ticket price on key domestic routes being 10-15 per cent more for Diwali and 20-25 per cent higher for certain flights to Kerala cities for Onam, according to an analysis.

An analysis done by travel portal ixigo for PTI showed that the average one-way economy class fare for non-stop flight on Delhi-Chennai route during October 30-November 5 period is 25 per cent higher at Rs 7,618.

Ahmedabad routes, respectively. On certain other routes, fares are higher in the range of 1-16 per cent, as per the analysis.

Ixigo's Group Co-CEO Rajnish Kumar said travel demand for Diwali is on the rise with airfares higher than last year.

"Popular routes like Delhi-Chennai, Mumbai-Bangalore, and Delhi-Hyderabad are seeing average one-way fares ranging between Rs 4,000-5,000, marking a 10-15 per cent Y-o-Y increase as the festival approaches," he said. On the other hand, fares have

also dropped in the range of  $1\,\mathrm{per}$ cent to 27 per cent on certain routes for the given comparison period. While the ticket price for Mumbai-Ahmedabad flight has declined 27 per cent to Rs 2,508, the fall is 25 per cent at Rs 4,890 for Mumbai-Udaipur flight.

In the case of Bangalore-Hyderabad flight, the fare has dropped by 23 per cent to Rs 3,383 and by 21 per cent to Rs 7,826 for Mumbai-Jammu flight, the analysis showed.

Also, an analysis of airfare trends on select routes for the upcoming festival in Kerala showed that prices have increased in the range of 1 per cent to 25 per cent on certain routes.

At the same time, ticket prices have fallen around 6-35 per cent on some routes.

The figures are average oneway fare for non-stop flights for departure during the September 6-15 period this year compared to August 20-29, 2023 period when Onam was celebrated.

A 30 per cent rise in fare to Rs 4,102 has been registered for Hyderabad-Thiruvananthapuram flight for the given comparison period. A similar quantum of increase is there for Mumbai-

#### Domestic air traffic rises 7.3% in July

Indian carriers flew more than 1.29 crore passengers in July, an increase of more than 7.3 per cent compared to the year-ago period, official data released Monday showed. However, the air traffic in July was lower compared to 1.32 crore people carried by the domestic airlines in June this year. IndiGo continued to dominate domestic air traffic with its market share rising to 62 per cent in July while that of Air India dropped to 14.3 per cent. Last month, the domestic market share of Vistara climbed to 10 per cent while that of AIX Connect and SpiceJet declined to 4.5 per cent and 3.1 per cent, respectively, as per the data released by the Directorate General of Civil Aviation (DGCA). Also, Akasa Air and Alliance Air's share slipped to 4.7 per cent and 0.9 per cent, respectively. In July, domestic air traffic touched 129.87 lakh compared to 132.06 lakh in June this year and 121 lakh in July 2023.

"Travel demand for Onam festivities has surged this year, with flight bookings and searches for travel to Kerala in the second week of September doubling compared to last year. Average airfares to key cities like Cochin, Calicut,

Thiruvananthapuram have risen by 20-25 per cent year-on-year,' Rajnish Kumar said.

There have been persisting concerns over high airfares, especially during peak and festival seasons. Against this backdrop,  $\rightarrow$ Civil Aviation Minister K Rammohan Naidu, earlier this month told Lok Sabha, that the ministry was planning to introduce an online mechanism to address grievances to ensure passengers were not exploited by unnecessary fare hikes.

### Antil aims new world record Advani clinches

He bettered it with a world record throw of 70.83 metres at the 2023 Para Championships and improved it further at the Hangzhou Para Asian Games (2023) to win gold with an effort of 73.29 metres. F64 category is for athletes

with problems in the lower limb(s), those competing with prosthesis or those affected by leg length difference.

"My long-term goal is to achieve a distance of 80m but at the Paris Paralympics, I will try to win gold with an effort of 75m," the 26-year-old told PTI-Bhasha in an exclusive interview.

The athlete, who lost one of his limbs in a road accident in 2015, won the gold medal at the Para World Championship in May this year with an effort of 69.50 metres.

Mumbai, August 19: Ace cueist Pankaj Advani of ONGC extended his dominance on the green baize as he completed a grand double by winning the senior snooker title at the Western India Billiards and Snooker Championships 2024 here.

Advani, the proud owner of 27 world titles, showed steely resolve to shrug off a strong challenge from Railways' bespectacled cueist Kamal Chawla 6-4 in a long-drawn final that lasted close to seven hours at the Khar Gymkhana billiards hall Sunday

Advani sealed his win with the frame scores reading 11-72, 31-58, 95-40, 52-42, 69-43, 43-74, 22-59, 75-62, 84-58, and 58-10.

The Bangalore-based Advani, who had earlier in the day defeated S Shrikrishna in the threehour session billiards final, has now won seven consecutive titles (4 snooker and 3 billiards) in Mumbai over the past two years.

#### ATHLETE RESPONSIBLE TO **MAINTAIN WEIGHT: CAS**


New Delhi, August 19: The Court of Arbitration for Sport (CAS) while rejecting wrestler Vinesh Phogat's appeal against her disqualification reasoned that it is an athlete's responsibility to stay within the weightlimit and no relief can be provided on that count but termed as "draconian" the consequence of failing the weigh-in on the second day.

Vinesh was disqualified from the Paris Olympics after failing to make weight on the second day of the competition. Scheduled to compete in the gold medal bout in the women's 50kg category. Vinesh was found overweight by 100g August 8.

The UWW rules state that a wrestler has to clear the weighin on both days of the competition. While UWW allows a 2kg weight tolerance in many international competitions such as Ranking Series event, there is no such buffer at the Olympics.

Vinesh had become the first Indian woman wrestler to qualify for the Olympic final and her disqualification created a flutter in the wrestling world, especially after her stunning victory over the legendary Yui Susaki, who had not lost a single bout in her international career before bumping into Vinesh.

....the Sole Arbitrator has concluded that the Applicant, of her own free will, entered into the 50 kg wrestling category and well knew that this required her



to maintain a weight for competition below 50 kg. Article 7 of the Rules provides, relevantly, that each contestant is deemed to be taking part of her own free will and is responsible for herself and is entitled to compete in only one weight category, the one corresponding to her weight at the time of the official weigh-in," the detailed CAS order, which was published Monday, stated.

"The Applicant is an experienced wrestler who had previously competed under the Rules. There is no evidence to the contrary, or any evidence by the Athlete that she did not understand the weight requirements. She voluntarily entered the 50 kg category and, from the evidence, undertook a regime to keep within that weight limit. Her evidence was that she did not have sufficient time to complete a weight loss program, not that she somehow found it interfered with her bodily rights.

An ad-hoc division of the CAS had August 14 rejected her appeal and the decision was given after three postponements.

### Cummins leans on all-rounders

Melbourne, August 19: Australia Test captain Pat Cummins expects greater workload with the ball for all-rounders Cameron Green and Mitchell Marsh against India in the Border-Gavaskar Trophy this summer.

#### WCA panel to address 'broken, unsustainable' cricket schedule

New Delhi, August 19: The World Cricketers' Association (WCA) has formed a six-member panel to review the cramped international calendar which it believes is "broken and unsustainable"

Formerly known as FICA, the WCA hopes to get a "clear and coherent structure" in which international cricket and domestic leagues can co-exist, according to a report.

WCA has members from 16 different boards, except BCCI and PCB. The WCA chairperson Heath Mills said they had "given up hope" that the game's leaders could es-

tablish a coherent structure. "One of those solutions, which WCA says 84% of the players they have spoken to are in favour of, is ring-fenced windows to ensure international cricket and do-

mestic T20 leagues can co-exist,' added the report. The scheduling model, which it said was "broken and unsustainable" and "confusing and chaotic" which was forcing play-

ers to choose between "representing their country and optimising their careers. The review will be conducted by a six-member team led by former head of the Australian Cricketers' Association Paul Marsh and he will be joined by former Pakistan cap-

#### tain Sana Mir, former FICA head Tony Irish, ex-ECB CEO Tom Harrison, and head of sports at Disney Star Sanjog Gupta.
