WB passes Bill seeking death for rape convicts

Kolkata, Sept 3: The West Bengal Assembly Tuesday unanimously passed the state antirape Bill that seeks capital punishment for rape convicts if their actions result in the victim's death or leave her in a vegetative state, and life sentence without parole for other perpetrators.

Other significant features of the proposed 'Aparajita Woman and Child Bill (West Bengal Criminal Laws and Amendment) Bill 2024' include the completion of probes into rape cases within 21 days of the initial report, a reduction from the previous twomonth deadline, and a special task force where women officers will lead investigations.

The proposed law, which requires assent from the Bengal Governor and then the President, when enacted, would mark a significant development in the state's legal framework against sexual crimes. Speaking during the discussion on the Bill, CM Mamata Banerjee termed the proposed legislation as "historic" and demanded the resignation of PM Narendra Modi, Union Home Minister Amit Shah and the CMs of all states that have "not been able to implement effective legislations to safeguard women"

The Bill also proposed to amend the newly-passed Bharatiya Nyay Sanhita 2023, Bharatiya Nagarik



Suraksha Sanhita, 2023 laws, and the POCSO Act, 2012 "in their application to the state of West Bengal to enhance punishment and to constitute the framework for... expeditious investigation and trial of the heinous act of violence against women and chil-

According to the Bill, any fine imposed shall be "fair and reasonable" to meet the medical expenses and rehabilitation of the victim or their next of kin, if applicable, as may be determined by the Special Court and should be paid within the period fixed by it.

The Bill was passed after the Opposition BJP MLAs lent their support to it even as Suvendu Adhikari alleged that Banerjee moved the Bill to "divert attention from public anger and protests' over the gruesome crime.

Adhikari accused the TMC government of having "failed to prevent incidents of rape and sexual abuse of women during its tenure" but assured his party's support for the Bill.

Bhubaneswar, Sept 3: Relenting to mounting criticisms from both within the party and Opposition over his statement in the Assembly Monday that there was no justification for a bench of the High Court in the state as per a Supreme Court ruling, Chief Minister Mohan Charan Majhi Tuesday sought to make amendments to his earlier stance by informing the House that the issue of setting up of such a facility in western Odisha is under "active consideration" of the state government.

Majhi said this in a statement before the commencement of the Zero Hour.

The issue of setting up a High Court bench in western Odisha is under consideration of the government," he said.

Stating that his government is committed to the delivery of speedy justice to the people, Majhi gave a clear message in the Assembly that his government was not averse to setting up a high court bench in the state.

Earlier Monday, while replying to a written question in the Assembly, Majhi had told the House that "as per the Supreme Court verdict, there is no justification in having a bench of high

court in any part of the state. Majhi's statement in the Assembly raised an outrage with



members from ruling BJP also protesting the idea. The Opposition BJD and the Congress have criticized the state government over Majhi's statement in the House.

Senior BJP lawmaker and veteran leader from western region, Jaynarayan Mishra said, "We (BJP) have not withdrawn the demand for a HC bench in western Odisha. The CM has referred to the Supreme Court judgment, but the state's population and HC cases are increasing. Why can't Odisha have an HC bench when Uttar Pradesh has three.

and other states also have them?" BJD MLA from Bolangir Kalikesh Singh Deo who had asked the written question, said, "Today, the CM clarified that the matter is under consideration. He should give an assurance on the floor of the House on whether a circuit bench or a permanent bench of the HC will be set up in Bolangir and also mention the stipulated time frame.

Singh Deo said the Supreme Court observation that the circuit bench demand had become obsolete with the passage of time and with the advent of technology while asking lawyers in Sambalpur to end their agitation after it had turned violent in November 2022.

"There was no verdict from the Apex Court on HC bench. Technology is not a replacement for a second bench or circuit bench. Bolangir has first right for a permanent bench since it had a bench in the pre-Independence era," Singh Deo said.

Earlier, Singh Deo had mentioned that prior to Independence, there was a high court bench in Bolangir, According to the Accession Treaty, it is binding on both the state and Central governments to provide the same facility. There would be no issue in having a high court bench if the government was willing, he said.

The lawyers of Western Odisha and members of the Central Coordination Committee for setting up the HC bench in Western Odisha, have also resented the

chief minister's statement. Responding to the CM's clarification, Central Coordination Committee convenor, Ashok Das said that wrong facts were presented before the Majhi as the SC had made no observation on setting up HC bench.

NO BAR ON BENCH: CM Student shot dead by cow vigilantes

Faridabad, Sept 3: A Class XII student was allegedly chased in 23 by a group of five cow vigilantes who mistook the boy for a cattle smuggler, police said Tuesday.

All the five accused -- Saurabh, Anil Kaushik, Varun, Krishna and Adesh-- have been arrested, the police said.

During interrogation, the accused revealed that August 23 night, they had received information that some suspected cattle smugglers driving two SUVs - a Renault Duster and a Toyota Fortuner - were recceing the city and picking up cattle.

They mistook the victims, Aryan Mishra and his friends, Shanky, Harshit and two girls who were travelling in a Duster for those cattle smugglers.

They then asked Aryan's friend Harshit who was driving to stop. However, he didn't because their friend Shanky had a feud with somebody and they thought they had sent goons to kill them.

As Aryan and his friends did n't stop, the accused men chased the vehicle for about 30 kilometers and intercepted it near the Gadhpuri toll in Palwal on the



Aryan Mishra, a Class XII student, was shot on his neck and chest by five cow vigilantes August 23, and died at a hospital a day later, police said

Delhi-Agra National Highway, a senior police officer said.

The accused men then opened fire at the Duster, and a bullet hit Aryan - who was in the passenger seat - near the neck. He was shot again when his friend finally stopped the car. The second bullet hit Aryan in the chest. When the attackers saw two girls in the car, they realised they may have shot the wrong person, and fled. Aryan died at a hospital a day later. The accused have been sent to judicial custody, police said, adding that the weapon and the car used in the crime have been recovered.

Russian missile strike kills 41 in Ukraine ASSOCIATED PRESS

Kyiv, Sept 3: Two Russian ballistic missiles struck a military_ training facility and nearby hospital in a central-eastern region of Ukraine, killing at least 41 people and wounding 180 others, Ukrainian President Volodvmvr Zelenskvv said Tuesday.

The strike occurred in the city of Poltava, the capital of the region of the same name, officials said. Poltava is located about 350 kilometres (200 miles) southeast of Kyiv. The city is on the main highway and rail route between Kyiv and Ukraine's second-largest city, Kharkiv, which is close to the Russian border.

The strike appeared to be one of the deadliest carried out by Russian forces since the war began more than 900 days ago February 24, 2022.

"One of the buildings of the (Poltava Military) Institute of Communications was partially destroyed. People found themselves under the rubble. Many were saved," Zelenskyy said in a video posted on his Telegram channel.

"All necessary services are involved in the rescue operation," he added. He said he had ordered "a full and prompt investigation" into what happened. Zelenskyy didn't provide any further details.

AI anchors 'protecting' reporters in strife-hit Venezuela

ne of Venezuela's newest news anchors sits on a stool, dressed in a flannel shirt and chinos as he delivers the day's headlines.

He goes by "El Pana." Venezuelan slang for "friend." Only, he's not real.

El Pana, and his colleague "La Chama," or "The Girl," are generated using artificial intelligence, though they look, sound and move realistically.

They were created as part of an initiative dubbed "Operation Retweet" by Colombia-based organization Connectas, led by director Carlos Huertas, to publish news from a dozen independent media outlets in Venezuela and in the process protect reporters as the government has launched a crackdown on journalists and pro-

"We decided to use artificial intelligence to be the 'face' of the information we're publishing," Huertas said in an interview, "because our colleagues who are still out doing their jobs are facing much more risk."

At least 10 journalists have been arrested since mid-June and eight remain imprisoned on charges including terrorism, according to 'Reporters Without Borders'

"Here, using artificial intelligence is... almost like a mix



between technology and journalism," Huertas said, explaining the project looked to "circumvent the persecution and increasing repression" from the government as there would be no one who could face arrest.

It is worth mentioning here that back home in Odisha, the Odisha Television Limited, a broadcast and digital media company, had launch the state's first multi-lingual AI anchor 'Lisa in July 2023.

Venezuela's Opposition and human rights groups have said recent arrests of protesters, Opposition figures and journalists are part of a government crackdown meant to quiet a sometimes violent, month-long election dispute.

The country's communications ministry did not respond to a request for comment about the AI journalism initiative. No official has responded to repeated requests for comment by Reuters about the arrests of journalists in recent weeks.

Both the Opposition and President Nicolas Maduro claim victory in the July 28 election. Maduro, in power since 2013,

is backed by the supreme court and the electoral authority, which has not published full vote tallies because of what it says was a cvber-attack.

The Opposition has shared what it says are more than 80 per cent of vote tallies, showing a resounding win for its candidate Edmundo Gonzalez. Some international observers and many Western countries have said election conditions were unfair and demanded full tallies. Protests since the vote have led to at least 27 deaths and 2,400 arrests, and detentions of Opposition figures and protesters have continued as part of the government's "Operation Knock Knock.'







Bhubaneswar, Sept 3: The Congress Tuesday demanded a statement from Chief Minister Mohan Charan Majhi on neighbouring Andhra Pradesh's 'efforts' to set up a hydropower project in Kotia, a disputed area along the border between the two states.

During the Zero Hour of the Assembly proceedings, Congress Legislature Party SIGNED AN MOU WITH (CLP) leader Rama Chandra Kadam expressed concerns over alleged intrusion in the Kotia cluster of villages in Odisha's Koraput district.

He also claimed that several tribal villages in the Kotia region in Odisha could be inundated for Andhra Pradesh's proposed 1200 MW hydropower project'.

"It is strange to know that the Odisha government is silent when the Andhra Pradesh administration is going all out to set up a hydropower project in the Kotia region. They will use Odisha's land and water while the people in the Kotia cluster of villages will suffer. The state government's silence has encouraged the Andhra Pradesh authorities to continue with its efforts," Kadam said in the Assembly.

The Congress leader claimed that around 1200acre of land, comprising villages and forests, would be affected due to the proposed hydropower project and wondered how Majhi being a tribal is unable to understand the hardship that tribal people may face in Kotia under Pottangi block of Koraput district.

Congress MLA Raazen Ekka echoed Kadam.

Bhubaneswar, Sept 3: At least 68 people were killed in attacks by elephants and other wild animals in the state during the current year, Forest, Environment and Climate Change Minister Ganesh Ram Singkhuntia told the Assembly,

While replying to a written question of BJD legislator Arun Kumar Sahoo, the minister said besides human casualties, 1.087 houses and crops over 2315.79 acre land were also damaged in incidents of the human-wildlife conflict in different forest divisions of the state during the current vear.

To prevent human habitations located near forest areas from elephant and other wild animal attacks, the government has been taking steps for the roll out of an artificial intelli-

gence (AI) supported e-surveillance project at Bharatpur in Chandaka forest division, Hindol of Dhenkanal division and Bantala in Angul division on a pilot basis, he stated.

With the help of AI, Forest officials can monitor the movement of wild animals and accordingly, human habitations can be put on alert in advance, the minister said. A maximum of 14 people were

killed in wild animal attacks in the Dhenkanal forest division, while eight such deaths were reported from the Keonjhar forest division, the minister said.

Similarly, wild animal attacks claimed six human lives in each of the Bonai and Rourkela forest divisions, five people were killed in such attacks in the Angul forest division.

Among others, Athagarh and Baripada divisions reported four human deaths each.

Bhubaneswar, Sept 3: The state government Tuesday said its flagship scheme 'Subhadra' is a 'commitment' to the women and not a 'betrayal' as alleged by the Opposition BJD and Congress.

This was stated by Deputy Chief Minister Pravati Parida, in charge of the Women Child Development department, while speaking during a discussion on the Subhadra Yojana in the Assembly.

Protesting the DCM's statement, the BJD and the Congress

walked out of the Assembly. Parida said that the Opposition has become intolerant as the state's BJP government within the first 100 days has been able

to implement such a 'revolu-

tionary' scheme for the welfare of the women.

Parida said over one crore women of the state would get ₹10,000 per annum for five years under the scheme. Each beneficiary will get a total of ₹50,000 in five years, she said.

BJD member Arun Sahoo, however, criticised the state government for including women only in the age group of 21-60 years in the scheme even as the BJP in its election manifesto had an-

nounced to provide financial assistance to all women in the

state.
"We do not understand why the women in the age group of 18 years to 21 years were excluded from the scheme. Women get the right to vote at 18, but are denied benefits from the government scheme for them," Sahoo said.

Though the BJP has been claiming to be an 'infant' government of only 90 days, Sahoo alleged that it has cleverly deleted women below 21 years and above

"A woman who is at the age of 59 years will get only one instalment of ₹5,000. Is it women empowerment?" he asked.

Congress member Sofia Firdous wondered how the women's economic condition would improve if she gets only ₹800 per month under the scheme.

"What can a woman do with ₹10,000 a year in two instalments?" she asked.

The state government is all set to launch the scheme on Prime Minister Narendra Modi's birthday September 17, CM Mohan Charan Majhi said at a party function here.





SC: No ban on Sahara Group to sell properties for depositing ₹10K-cr

New Delhi, Sept 3: The Supreme Court Tuesday said there is no embargo on Sahara Group to sell its properties for depositing around ₹10,000 crore in SEBI-Sahara refund account for returning investors' money.

In a series of directions August 31, 2012, the top court had directed that Sahara Group firms - SIRECL and SHICL - would refund the amount collected from individual investors or group of investors, with interest of 15 per cent per annum to SEBI from the date of receipt of the subscription amount till the date of repayment within three months. A bench of Justices Sanjiv

Khanna, M M Sundresh and Bela



M Trivedi expressed its displeasure over the Sahara Group not depositing the amount as directed by the court. Senior advocate Kapil Sibal, appearing for the Sahara Group, said the company was not given opportunity to sell its properties and moreover no one came forward or is coming forward to purchase the properties as there was embargo on selling them.

"There is no embargo on Sahara Group in selling its properties for depositing the remaining ₹10,000 crore out of ₹25,000 crore ordered by the court. Only thing was that it should not be sold below the circle rate and if it is to be sold below the circle rate, then prior permission of the court is to be sought," the bench told Sibal. It said more than 10 years have

passed and the Sahara Group has not complied with the order of the court. "SEBI is seeking around ₹10,000

crore. You need to deposit it. We want a distinct plan, so that the property can be sold in a transparent manner. We will rope in SEBI also in this exercise," the bench further added.

Following searches, Nayak was found in possession of two multi-storey buildings, a 3-BHK flat worth ₹1.30 crore and a duplex over 1,800 sqft area in the Capital city, two market complexes with 19 shops, 11 plots. deposits to the tune of ₹53.53 lakh, household articles worth ₹54.70 lakh and over ₹9.85 lakh in cash, the anti-corruption wing said in a press statement. "After thorough search and inventory, the income, expenditure and assets of Navak were calculated and he was found in possession of DA of about ₹5 crore, which is over 519 per cent of his known sources of income," it said.

"A case under Section 13(2) r/w 13(1)(b)/12 of the Prevention of Corruption (Amendment) Act, 2018 was registered against Nayak and he was taken into custody after he failed to give satisfactory response," it added. Nayak was posted as a mining officer at Koraput in 2014 and after seven years, he was transferred and posted at Talcher as mining officer in 2021. He was later promoted to the rank of deputy director of mines, it pointed out.

plants like mulberry, cinnamon, cloves, amla, and saffron. The garden now supports a diverse ecosystem, attracting insects, butterflies, birds, and even wild animals.

He successfully planted around 31 varieties of fruitbearing trees and medicinal plants using his indigenous knowledge. The species includes Cinnamomum tamala (Indian Bay Leaf), Chebulic Myrobalan, Belleric Myrobalan, Indian gooseberry, guava, custard apple, spondias, bael, sapodilla, lychee, coconut, elephant apple, Ashoka tree, lemon, pomelo, dragon fruit, bamboo, moringa, Arjuna tree, pomegranate, silk cotton tree, beechwood tree, fig, velvet apple, mango, and

Pupun's work, though largely unrecognised beyond his community, speaks volumes about the power of individual action in the face of environmental challenges. His story is a reminder that true impact does not always require a large platform or widespread recognition; sometimes, it is the quiet, persistent efforts of individuals like Pupun that make the most sig-

nificant difference. Yet, despite his relentless efforts and significant impact, Pupun remains unrecognised and unknown beyond his community. His story is one of silent sacrifice, proving that true commitment to a greener planet can thrive even in the most isolated corners, without the need for accolades or digital fame.



Putin & ICC

ussian President Vladimir Putin's visit on 2 September to Mongolia, a member state of the International Criminal Court (ICC) that has issued an arrest warrant against him since 2023, is yet another example of the waning influence of international institutions that were set up with the objective of keeping the world in order. Mongolia was bound to arrest Putin as mandated by the court's founding treaty, the Rome Statute. The ICC has accused Putin of being responsible for the abduction of children from Ukraine, where a war of Russian aggression has raged for two and a half years. Instead, the Central Asian country rolled out a red carpet to welcome the Russian president, much to the chagrin of Ukraine and its Western allies.

Ukraine's foreign ministry stated that Mongolia's decision not to arrest Putin under an ICC warrant represents a "significant setback" for the international criminal law system. Heorhiy Tykhyi, a spokesperson for the Ukrainian foreign ministry, remarked: "Mongolia has permitted a wanted criminal to escape justice, thus sharing in the responsibility for the war crimes."

Mongolia, home to only 3.3 million residents yet vast in land area, has historically managed its foreign policy under the influence of Russia and China, with which it shares deep historical and economic connections. Of late, to enhance its autonomy from these dominant neighbours, Mongolia has sought to cultivate friendly relations with various "third neighbour" countries, such as the United States, Germany, Japan, and South Korea. This strategy aims to establish Mongolia as a unique player on the global stage, positioning it as a neutral venue for diplomatic discussions. However, Putin's visit presented a challenge for the country as it navigates its commitments and alliances within the Western-led international order, which includes the ICC, while also striving to maintain amicable relations with its influential neighbours.

The Russian leader received a rousing reception in Ulaanbaatar's main square, greeted by a guard of honour clad in striking red and blue uniforms inspired by the personal guards of Genghis Khan, the 13th-century founder of the Mongol Empire. Putin and Mongolian President Khurelsukh Ukhnaa ascended the red-carpeted steps of the Government Palace and paid their respects at a statue of Genghis Khan before proceeding inside for their discussions. A small group of protesters attempted to display a Ukrainian flag prior to the ceremony but were escorted away by the police, while a few demonstrators held posters that read: "Get war criminal Putin out of here."

Prior to his visit, Ukraine had urged Mongolia to surrender Putin to the court in The Hague, even as the European Union voiced concerns that the Central Asian country might not carry out the warrant. Anyways, the ICC does not possess a robust enforcement mechanism, and member states may be exempt from making arrests if it conflicts with specific treaty obligations or diplomatic immunity granted to

Putin's undeterred visit highlights the limited ability that global bodies have to hold Moscow, or for that matter any violators of international laws, accountable for crimes against humanity. Similar has been the impact of the hordes of sanctions imposed on Russia. Following its invasion of Ukraine in February 2022, the US, UK and the EU, along with nations such as Australia, Canada, and Japan, have imposed over 16,500 sanctions against Russia. Yet, the Russian war machine continues ravaging innocent lives. This once again demonstrates the toothless tiger status that international laws and sanctions have gained for themselves. Such events will make their implementation even more difficult in future





CONTINUATION OF BIDEN'S POLICIES WOULD STILL ADVANCE AMERICA'S RELATIVE DECLINE AS A TRADING COUNTRY, JUST NOT AS QUICKLY AS TRUMP'S TARIFFS WOULD



to do: raise US tariffs on imports from China to 60%, and impose a 10% tariff on imports from all other countries. These policies would hurt Chinese exports to the US the most, but many other countries' US exports would also decline, though a few - those providing substitutes for Chinese goods - might benefit.

Economies that depend on supply chains that include China would also suffer. Many South Korean and Japanese firms export parts and components to China, where they are combined with China-made parts and components, and possibly assembled into final products, for export to the US and elsewhere. This implies that any reduction in Chinese exports to the US would translate into a reduction in exports from Japan, South Korea, and others like them. Efforts to bypass the problem by shifting supply chains to India, Vietnam, and elsewhere might partly offset this effect, but such solutions are likely to be both costly and incomplete.

The effects of the "Trump trade shock" would not end there. If the tariffs hamper growth in China, Chinese demand for imports could fall, dealing yet another a blow to economies for which China is a leading trading partner, such as Japan, South Korea, and Southeast Asian countries.

Trump's proposed tariffs would also have two less obvious effects - neither of which is

desirable for the US. First, they would act as a drag on US exports to many countries, because the overall US trade deficit is determined less by America's own trade policy than by a shortage of US national savings relative to investment. Given that Trump's proposed tariffs would be unlikely to raise US sayings significantly, a reduction in US imports would be matched by a reduction in US exports. With that, America's relative importance as a trading partner for many countries would decline. Second, Trump's tariffs would

undermine the world economic order that the US led the way in creating. The Trump measures would violate America's legal obligations under the World Trade Organization. But, with the US having spent years weakening the WTO's dispute-settlement mechanism, the body is unlikely to be able to check Trump's protectionism. This would reinforce the sense that the US does not play by the rules and would encourage other countries particularly those grappling with high levels of inequality to implement retaliatory tariffs or other protectionist policies. (Populist politicians often tout trade barriers as a solution to inequality.)

The contours of Harris' likely trade policy are less clear. One can imagine her upholding US President Joe Biden's approach to trade, which is slightly less erratic than Trump's, but remains a blight on Biden's economic-policy legacy. In fact, a continuation of Biden's policies would still advance America's relative decline as a trading country, just not as quickly as Trump's tariffs would.

But there is another possibility. Taking inspiration from two other recent Democratic presidents, Barack Obama and Bill Clinton, Harris might seek to revive US leadership in global trade, not least by rejoining the Comprehensive and Progressive Trans-Pacific Partnership (CPTPP), with Australia, Brunei Canada, Chile, Japan, Malaysia, Mexico, New Zealand, Peru, Singapore, and Vietnam

The CPTPP evolved from the Trans-Pacific Partnership - an agreement that Obama spear headed, but was never ratified, owing to Trump's 2017 decision to withdraw from it. It was thanks to the Japanese leadership that the CPTPP was ratified the following year.

Beyond expanding market access among member countries, the CPTPP imposes institutional requirements affecting the conduct of state-owned enterprises (SOEs), government procurement, and subsidy rules. Given this capacity to induce institutional reform within member countries, the CPTPP can be considered a kind of "WTO plus."

The CPTPP might even drive reform among prospective members. Though China does not currently meet the agreement's requirements, it has applied to join, signaling its willingness to reform SOEs and market access. A CPTPP that includes China but not the US is hardly in America's interest

A Harris administration might also reverse previous administrations' tariffs on Chinese imports, which amount to a tax on US consumers, especially middle-class and low-income households. Harris must be able to explain to the American public that tariffs are self-defeating, as they raise the cost of living without creating new jobs for American workers.

There is no guarantee that Harris will pick the right trade advisers or overcome protectionist pressures within her party. But if she does - if she combines a relatively open trade policy with domestic redistribution – she may usher in a global trade revival that boosts the US economy and enhances US global leadership. With Trump, by contrast, there is little reason to expect anything more than another negative shock to global trade, resulting in far more losers than winners.

Where Afghan women pursue their dreams

very now and then, I hear **√** someone using the phrase 'greatest country in the world." It's often an American politician, but I've heard it from leaders of other countries as well. I prefer the phrase "one of the great countries in the world," because there are a number of great countries in the world—and one of them, I've concluded, is Scotland.

I am basing my conclusion on irrefutable scientific evidence: I conducted a random survey of people attending the World Pipe Band Championship.

No, what actually convinced me that Scotland is a great country was a BBC article about 19 female medical students who were banned from attending university in Afghanistan. These students recently arrived in Scotland, where they will complete their medical studies.

The Scottish government amended their student funding laws to treat the Afghan students as domestic students, giving them free tuition and cost of living support.

Since the Taliban returned

to power in 2021, "a generation of Afghan women who had been studying at universities to become doctors, lawyers, teachers and engineers have been stuck at home," according to the Linda Norgrove Foundation, which was instrumental in getting the medical students to Scotland.

"Gender should not be a barrier to accessing education,' said Scotland's Education Secretary Jenny Gilruth, who met the students at Edinburgh Airport to welcome them to

Outrage after an unmet promise to keep docs safe

Kolkata, Sept 3: Five years ago, the government of West Bengal state in India pledged to clamp down on violence against doctors. It promised public hospitals better security equipment, female guards to support female physicians and controlled entry points, according to an internal government memo seen by Reuters.

None of these measures had been implemented at the public hospital where a young female doctor was sexually assaulted and killed August 9, allegedly by a police volunteer, four trainee doctors there told Reuters. Instead, in the days leading up

to the homicide-assault, which prompted nationwide outrage and a doctors strike, only two male guards manned RG Kar Medical College and Hospital, they said. They were supplemented by a few closed circuit cameras that did not comprehensively cover the sprawling premises, according to the

One of the doors of the lecture hall where the doctor had been resting during a 36-hour shift when she was attacked had no lock, said two other trainee doctors who had also slept there. The air conditioning in the designated break room had malfunctioned, they said.

After two doctors at a different hospital were assaulted by a patient's relatives in 2019, West Bengal had promised to install effective security equipment and systems, regulate entry and

Demanding justice for the deceased woman medic of RG Kar Hospital, thousands of people, including doctors and paramedics of private facilities, formed a 13-km human chain along an arterial city road Tuesday, an unprecedented event in the city's history in recent years. Participants of the human chain standing on the median divider of Eastern Metropolitan Bypass between Ultadanga and Patuli - linking the northern and southern parts of the city. Since the protestors did not obstruct crossings during their one-hour stay on the road from 5 pm, this mode of agitation did not affect vehicular traffic movement along the busy road as hundreds of vehicles plied uninterrupted, a police officer said. The participants waved the tricolour and held placards which read 'For how long we have to wait for justice', 'Hang the rapists' and 'Justice for our sister'. People from all walks of life, office goers and commuters, besides people from neighbourhood pockets along the route, took part in the protest.

Reuters interviewed 14 female doctors at government hospitals in West Bengal and elsewhere in India about their challenges in a country where women's safety is a long-standing concern.

They described poor working conditions, including aggressive treatment from the families of patients and having to sleep on benches in dimly-lit corridors due to a lack of rest facilities.

Some doctors spoke of napping in break rooms with no locks during lengthy shifts, only to have people barging in. Others described confronting male patients who photographed them without permission, claiming that they were documenting evidence of their treatment.

Cong abstains from voting in Tripura

Agartala, Sept 3: The Congress Tuesday abstained from voting in the election to Tripura's lone Rajya Sabha seat in which the ruling BJP and Opposition CPI(M) fielded candidates.

The Congress and CPI(M) had fought the Lok Sabha and Assembly elections together.

"We have not boycotted the Rajya Sabha elections. The party decided to abstain from voting in protest against the recent farcical Panchayat elections which is a threat to democracy," senior Congress MLA Sudip Roy Barman told the reporters.

The BJP secured victory unopposed in 71 per cent of the seats in the three-tier Panchayat polls in Tripura. The Opposition parties alleged that they could not field candidates in those 71 per cent of seats because of the terror tactics of the ruling party.

In the Rajya Sabha election, the CPI (M) fielded former MLA Sudhan Das against the BJP's Rajib Bhattacharjee, who is the party's state unit president.

"The CPI(M) has not consulted us before selecting or fielding a candidate for the Raiva Sabha elections. They could have boycotted the elections to protest the largescale terror during the three-tier Panchayat elections. One candidate of the CPI(M) was murdered in Belonia during the polls," Roy Barman said.

He said the Congress can join the CPI(M) in protests against the atrocities of the BJP but it is not necessary to fight all elections together.

28 foreigners shifted to transit camp after tribunal's verdict

Barpeta (Assam), Sept 3: A total of 28 people, including nine women, from Barpeta district of Assam were shifted to a transit camp in Goalpara after they were declared foreigners by a tribunal, police said Tuesday.

It was a heart-wrenching scene for the family members when their dear ones were packed in a bus at the office of the Superintendent of Police Monday and taken to the dedicated detention centre, now called a transit camp.

Barpeta Superintendent of Police Sushanta Biswa Sarma said, "These people were declared foreigners by the Foreigners Tribunal after proper hearings. As per its order, we carried out the transfer of these foreign nationals to the camp."

The Tribunals are quasi-judicial bodies that decide the citizenship status of persons living in Assam who are suspected to be foreigners.

Around 100 Foreigners Tribunals functioning in Assam. According to the protocol, these people will be sent back to their country of origin after due process by the Ministry of External Affairs, provided they do not move to the Gauhati High Court.

Guwahati. Sept Implementation of the Centre's flagship 'Pradhan Mantri Kisan Samman Nidhi' (PM-KISAN) scheme in Assam has been plagued by problems, ranging from 35 per cent of the applicants being found ineligible to the recovery of a mere 0.24 per cent of funds released to these nonentitled beneficiaries, as detected by the Comptroller and Auditor General (CAG).

A performance audit of the scheme from December 2018 to March 2021 found that out of the 41,87,023 applications from the state, 10,66,593 (25 per cent) were rejected by PM-KISAN portal and Public Financial Management System.

Subsequently, the state government declared that 11,72,685 (37 per cent) out of the 31,20,430 beneficiaries were ineligible through an inquiry conducted from May-July 2020 across

A mere 0.24 per cent of the funds released to these ineligible beneficiaries were received back till October 2021, which was not refunded to the Ministry of Agriculture and Farmers Welfare, the CAG report, tabled in the state Assembly recently, said.



The CAG report also pointed out that the inquiry initiated in May 2020 on order of the chief minister, following complaints from different quarters regard ing anomalies in the beneficiaries list, had found 15,59,286 ineligible names during verification across the state from May to

Among the different categories of ineligible beneficiaries were non-farmer beneficiaries, government employees and pensioners, and multiple entries.

As per the verification report, 11,31,152 (72.54 per cent) of over 15 lakh ineligible beneficiaries

were found to be untraceable. When the auditors pointed to the difference in the figure of ineligible beneficiaries furnished by the state nodal officer (SNO) (11,72,685) and the one mentioned in the report of verification (15.59.286), the state government

said that "another verification was being conducted and as such. the figure was dynamic"

The audit, carried out in 10 disricts selected based on saturation level of beneficiaries, found lack of monitoring and non-adherence to guidelines for the implementation of the scheme at various stages.

In addition to the 10 districts, Barpeta was also selected considering the largest number of ineligible beneficiaries in the

Twenty-two blocks from the selected 11 districts, with three villages in each block, were taken for the audit, covering 15 beneficiaries' records (totalling 990) each from the selected villages.

The performance audit revealed that the state government did not maintain a database of landholding farmer families to identify potential beneficiaries.

The state government, last year, inked memorandums of agreement (MoAs) with four central public sector undertakings (CPSUs) for the development of 13 stalled hydro projects in the northeastern state.

Of them, five projects with an installed capacity of 2,626 MW have been allocated to NEEPCO, five others with 5,097 MW capacity awarded to (SJVN) and two plants of 3,800 MW to NHPC and one of 1,200 MW to THDC.

An estimated investment of ₹1,42,000 crore will be made in executing the projects in the state, the official said.

Chakraborty referred to a statement by Mullick September 1 when the actor-turned-TMC MLA asked the state award recipients to return their honours if they join protests against the rape and murder of the doctor of RG

Kar Medical College and Hospital. "I have been paid an amount



of ₹25,000 too with the certificate, if I remember correctly. Kindly provide me the means by which I can return the amount. Looking forward to your positive response," she said in the letter.

"Had never compromised, will never do it. I had thought the award had been given in recognition of my merit... But I will keep standing on the road, demanding justice, legal and so-

cial, both," she said. Earlier, Bengali theatre personality Biplab Bandyopadhyay



said in a statement that he is returning the award conferred on him earlier this year by the Paschimbanga Natya Akademi and the ₹30,000 monetary grant.

The state government and the "partisan" police force want to "hide facts" following the rape and murder of a woman doctor in RG Kar Hospital August 9, he alleged.



23rd Law Commission constituted 9 Naxals gunned down in Bastar

Dantewada, Sept 3: Nine Naxalites, including six women, were killed in a fierce encounter with security forces in Chhattisgarh's Bastar region Tuesday, a top police official said, in the latest offensive against Maoists which has gathered pace after a change of government last year.

The gunfight broke out at around 10:30 am in forests along the border of Dantewada and Bijapur districts when a joint team of security forces was out on anti-Naxal operation, Inspector General of Police, Bastar Range, Sundarraj P told

Personnel belonging to the state police's District Reserve Guard (DRG), Bastar Fighters and 111th and 230th battalions of the Central Reserve Police Force (CRPF) were involved in the operation.

The operation was launched Monday night based on inputs about the presence of cadres belonging to Maoists' PLGA (People's Liberation Guerrilla Army) Company No. 2, west Bastar and Darbha division on the hills of inter-district border, he said.

The exchange of fire between Naxalites and security personnel took place multiple times in forests near Lohagaon, Purangel and Andri villages under the Kirandul Police Station area (Dantewada district). After the guns fell silent, bodies of nine Naxalites, including six women -- all clad in 'uniform' -- were recovered from the spot, informed the senior IPS officer.

Chief Minister Vishnu Deo Sai hailed security forces for

their latest success against Magists and asserted his government has resolved to end the Left-wing extremism by March 2026

A cache of weapons, including one SLR (Self-Loading Rifle), one 303 rifle, 12 bore rifle, 315 bore rifle, BGLs (barrel grenade launchers) and explosives, items of daily use and other Maoist-related materials were recovered from the spot, IPS officer Sundarraj said.

After the latest offensive, 153 Naxalites have been gunned down in separate encounters in the Bastar division, comprising seven districts -- Kanker, Kondagaon, Narayanpur, Bastar, Bijapur, Dantewada and Sukma -- so far this year, he said.

During the same period, 669 Naxalites have been arrested, while 656 others have surrendered before police in the division, the officer added.

Preliminary investigation suggests the slain cadres belonged to the west Bastar division committee and PLGA Company No. 2 of Maoists, but their identity was yet to be ascertained, Dantewada Superintendent of Police Gaurav Rai said.

Blood stains found at the encounter site indicate several other Naxalites may have been injured or killed in the gunfight, Rai said, adding reinforcement was sent to the spot for conducting further search operation.

Hailing security forces involved in anti-Naxal operations, Chief Minister Sai said after the BJP government assumed office in Chhattisgarh (in December last year), it has been fighting resolutely against Left-wing extremism in the state.

New Delhi/Mumbai, Sept 3: Under pressure from the government, Netflix India Tuesday said it has included the real and code names of the hijackers of the Indian Airlines aircraft depicted in the web series 'IC814: The Kandahar Hijack'.

"For the benefit of audiences unfamiliar with the 1999 hijacking of Indian Airlines Flight 814, the opening disclaimer has been updated to include the real and code names of the hijackers,' Shergill, Vice President, Content at Netflix India, said in a statement after meeting Jaju. She said the code names in the series reflect those used during the actual event. The real names of



the hijackers were Ibrahim Athar, Shahid Akhtar Sayed, Sunny, Ahmad Qazi, Zahoor Mistry and Shakir. However, the series referred to the code names used by terrorists -- Bhola, Shankar, Doctor, Burger and Chief. "India has a rich culture of storytelling and we are committed to showcasing these stories and their authentic representation,' Shergill said. A senior govern-

The web series had triggered a row after a section of viewers objected to the humane projection of terrorists and reference to their Hindu code names, contending that distortion of real identities of hijackers amounted to misrepresentation of historical events

Chopper crashes off Gujarat coast; 3 ICG crew missing

PORBANDAR: Three crew members went missing after an Indian Coast Guard (ICG) helicopter on a rescue mission crashed into the Arabian Sea off Porbandar coast in Gujarat, officials said Tuesday. The incident occurred Monday night after the agency launched an operation around 11 pm to evacuate an injured crew member on board a tanker which was sailing close to Porbandar, the ICG said in a statement. While one of the four crew members on board the ICG's advanced light helicopter (ALH) was rescued. "On 02 Sep 2024, India Coast Guard ALH helicopter was launched at 2300 hrs to evacuate an injured crew member from the Motor Tanker Hari Leela off Porbandar, Gujarat. The helicopter had to make an emergency hard landing and ditched into the sea. One crew member recovered, search for the remaining three crew members is in progress," the ICG said.

'Road mishaps behind 43% of unintentional injury deaths'

New Delhi, Sept 3: Road crashes are the biggest cause of deaths due to unintentional injuries in India, accounting for more than 43 per cent of such fatalities, with overspeeding being the leading rea-

son, according to a new report. The other contributors to deaths due to unintentional injuries are drowning, falls, poi-

soning and burns. The report titled "National Strategy for prevention of unintentional injury", compiled by the Ministry of Health, was launched during "Safety 2024", the 15th World Conference on Injury Prevention and Safety Promotion, 2024.

'There were 4,30,504 deaths from unintentional injuries and 1,70,924 deaths due to intentional injuries in India in 2022. From 2016 to 2022, there has been a marginal increase in deaths due to unintentional and intentional injuries. Road Traffic Crashes (RTCs) are the highest cause of unintentional injuries (43.7 per cent)," the report said.

While drowning accounts for 7.3 to 9.1 per cent of such fatalities, falls contribute 4.2 to 5.5 per cent, poisoning 5.6 per cent and



burns 6.8 per cent, it added. The report noted that despite efforts to improve road safety, India continues to grapple with a high number of fatalities due to road

traffic injuries (RTIs).

The mortality ratio remains constant at approximately 86 per cent for males and 14 per cent for females. "Over-speeding is the leading cause of these deaths, accounting for a staggering 75.2 per cent of fatalities. Other major contributing factors include driving on the wrong side of the road (5.8 per cent) and driving under the influence of alcohol or drugs (2.5 per cent)."

"Analysis of RTIs reveals a significant disparity in mortality rates based on location. Rural areas bear the brunt of RTI fatalities, with a staggering 67.8 per cent of deaths occurring there compared to 32.2 per cent in urban areas. Furthermore, the data suggests that open areas and residential zones might be particularly dangerous, with potentially higher fatality rates compared to other locations," the report said. National highways, which have a share of only 2.1 per cent of the total road length in the country, account for the maximum number of road fatalities and were responsible

for 45 lives per 100 km in 2022. The three-day conference is being hosted by the Indian Institute of Technology (IIT), Delhi, George Institute for Global Health in collaboration with the All India Institute of Medical Sciences (AIIMS), National Institute of Mental Health and Neuro Sciences (NIMHANS) and is co-sponsored by the World Health Organisation (WHO).

Etienne Krug, Chair, International Organising Committee for World Conferences on Injury Prevention (IOC), WHO, highlighted the need for continued action to prevent road traffic deaths, falls and violence.



New Delhi, Sept 3: The Centre Tuesday moved the Supreme Court alleging "unpardonable" non-cooperation by the West Bengal government in providing logistical support to the CISF, tasked with providing security at the RG Kar Medical College and Hospital in Kolkata, where a trainee doctor was raped and murdered.

In case of their failure to do so, the Centre urged the apex court to initiate contempt proceedings against the state government officials concerned for "wilful non-compliance" of the court orders. The apex court August 20 had termed the rape and murder case of a medic at the hospital as "horrific" and issued a slew of directions including setting up of a 10-member National Task Force to formulate a protocol for ensuring the safety and security of doctors and other health care professionals.

Besides, the top court had taken a serious note of mob violence in the hospital and the allegation that the Kolkata police fled the scene. and ordered deployment of CISF at the hospital to enable doctors to resume work. In an application filed in the case the apex court has initiated on its own, the MHA said the plea "concerns the deployment of CISF personnel at the R G Kar Medical College, including the hostels where the resident doctors are staying to ensure their safetv".

"The CISF personnel deployed at R G Kar Hospital are facing

residents/workers in the RG Kar Medical Hospital under the orders of this court," the application said. It said such non-cooperation was not expected from a state government in a tense situation as the present one. The safety of doctors, women doctors in particular, must be the top priority for the state, the application said. It said a state government, duly elected by the people, is supposed to be fair in its conduct, especially when it concerns the security of its residents.

The application claimed that such a course of action has been adopted by the state to "willingly create hurdles" and to jeopardise the larger solution-oriented approach adopted by the apex

court. It alleged the state was willingly not making commodating unit," it KOLKATA efforts towards finding a solution to the problem HORROR and was causing injustice to its residents.

The application referred to non-availability of adequate accommodation, security gadgets, and paucity of transportation facilities, and said CISF personnel were facing a lot of difficulties in performing their duties, especially the lady contingent.

While hearing the matter August 22, the top court had torn into the Kolkata police over the delay in registering the unnatural death of the woman doctor, who was raped and killed at the hospital, calling it "extremely disturbing", and questioned the sequence of events and the timing of the procedural formalities.

WB Health Dept finally suspends Sandip Ghosh

Kolkata: The Health Department of the West Bengal government on Tuesday finally suspended Sandip Ghosh. The Health Department announced Ghosh's suspension though an official order issued late on Tuesday evening. However, instead of Health Secretary NS Nigam, the order was signed by an officer on special duty in the Health Department. "In view of the ongoing criminal investigation against Sandip Ghosh, Ex-Principal, RG Kar Medical College & Dispital, Kolkata, Ghosh is placed under suspension under Rule 7(1c) of West Bengal Services (Classification, Control and Appeal) Rules, 1971, with immediate effect," the order read. However, representatives of the medical fraternity have questioned the late action by the state government which is already under fire for reportedly shielding Ghosh in the aftermath of the rape-murder case.

He added any decision regarding an alliance will be taken with the approval of Aam Aadmi Party (AAP) national convener Arvind Kejriwal, who is currently in jail in excise policy-related cases.

There were several reports

claiming that Gandhi, in a meeting of Congress' Central Election Committee (CEC) Monday, expressed interest in the possibility of an alliance with AAP for assembly polls in Haryana.

Singh, however, said any official stand on the issue will be made by AAP's in-charge of Haryana affairs Sandeep Pathak and state president Sushil Gupta.

Delhi minister Atishi said the decision will only be taken after Kejriwal is released.

Congress leaders in Haryana, however, have rejected the possibility of any alliance with AAP in the state. Recently, senior

Congress leader in Haryana Kumari Selja said her party is strong in the state and will fight the elections on its own.

Earlier, the Congress and AAP, partners in the Indian National Developmental Inclusive Alliance (INDIA), had a seat adjustment for Lok Sabha polls in Delhi, Haryana and Gujarat. In Haryana, AAP state president Gupta was the lone party candidate in the Lok Sabha polls in the state. He lost to BJP's Naveen Jindal. Gupta recently asserted that AAP is ready to strongly contest on all the 90 assembly seats in Haryana on its own "with an alliance with the people of the state". The Congress and AAP contested the Lok Sabha polls independently in Punjab.

Six-year-old girl abducted, gangraped, murdered; two held

Gaya (Bihar), Sept 3: A six-yearold girl was allegedly abducted, gangraped and murdered by two youths in Bihar's Gaya district, police said Tuesday.

After murdering the girl, the accused dumped her body on the banks of Morhar River in Uchirvan village under the jurisdiction of Sherghati police station. Both the accused have been arrested.

According to an FIR lodged by the family members of the victim, the two accused had allegedly kidnapped the girl from her house while she was sleeping and gangraped her before killing her Monday night.

"After sexually assaulting the girl child, the accused murdered the victim and threw the body near the river," a statement issued by the district police said.

"Police received a call that the body of a girl child was lying on the banks of Morhar River in Uchirvan village. A police team immediately reached the spot and sent the body for post-mortem examination," it said. One of the accused was first arrested and later his accomplice was also nabbed, the statement said. "During interrogation, the duo confessed to having committed the crime. Police are also trying to nab other accused, if any, involved in the case," it said.

Malayalam film actor Nivin Pauly_ booked for rape

Kochi, Sept 3: Actor Nivin Pauly was Tuesday booked for the offence of rape on a complaint by a 40-year-old woman that he sexually assaulted her over a year ago in Dubai, police said.

An officer of Oonnukal police station, where the FIR under section 376 of the IPC was registered, said that there are six accused, including a woman, in the case. The first accused is a woman and Pauly is the sixth accused, the officer said.

According to the woman, the incident occurred over a year ago in Dubai, the officer said, and declined to give further details. Pauly is among the many actors and directors who are facing allegations of sexual harassment or rape by female actors following the publication of the Justice K Hema Committee report.

The committee was constituted by the Kerala government after the 2017 actress assault case and its report revealing instances of harassment and exploitation of women in the Malayalam cinema industry.

Following the allegations of sexual harassment and exploitation cropping up against several actors and directors, the state government August 25 announced the establishment of a seven-member special investigation team to probe them.

8 devotees killed in road accident

Chandigarh: Eight people were killed and 10 others injured after a truck hit a stationary vehicle carrying devotees in Haryana's Jind district, police said Tuesday. The accident occurred past midnight in Bidharana village on the Hisar-Chandigarh national highway when the devotees were travelling from Kurukshetra district to a temple at Gogamedi in Rajasthan. The truck, bearing a Rajasthan registration number, was loaded with wooden logs when it hit the stationary vehicle. SHO of Sadar Narwana police station Kuldeep said, "The truck rammed into the light commercial vehicle in which the group of devotees was headed to Gogamedi. At the time of the incident, the devotees had taken a brief halt and their vehicle was stationary."

Suspected water contamination sickens over 300

Noida: More than 300 residents, mostly children and women, of a Noida Extension group housing society fell ill with an infection caused by suspected water contamination, officials said Tuesday. Alarmed by the complaints of diarrhoea, vomiting, fever and stomach ache en masse, the local health department team swung into action and set up a temporary camp at the society for check-up and treatment. The local Greater Noida Authority also checked the water supply in the society in which it found no fault but took samples of water for test as a precautionary measure, according to an official statement. Raj Kumar, a media professional and resident of Supertech Ecovillage 2, said the issue came to light when residents were discussing water shortage on a WhatsApp group Monday evening.

Wearable devices could help detect early signs of Cov: Study

New Delhi, Sept 3: Wearable devices that track one's physical activity, such as smartwatches, could help detect early signs of disease, including COVID-19, heart conditions and falls, a new study has suggested.

Researchers from the University of South Australia reviewed 28 studies, including 12 lakh participants, and found that smartwatches and activity trackers could correctly identify COVID-19 status in 88 out of 100 people, similar to results from rapid screening tests.

They also found that data from wearable devices could be used to identify atrial fibrillation in 87 out of 100 people, in which the heart beats irregularly and faster than normal.

Falls were detected in 82 of 100 people using these activity-



tracking devices. The findings are published in the Journal of Medical Internet Research mHealth and uHealth. While originally designed for tracking fitness and physical activity, including exercise, wearable technology now also displays blood pressure, heart rate, along with sleep quality, skin temperature,

stress levels and more.

"Our systematic review shows that wearable activity trackers have significant promise in detecting COVID-19 and heart conditions in real-world settings, which has the potential to improve personal health monitoring," lead researcher Ben Singh from the University of South Australia said.

The researchers said that majority of previous studies have looked at detecting COVID-19, with a smaller number of studies focused on cardiac conditions and falls.

Even as the wearable devices largely showed good sensitivity and specificity, the most promising results were found for the detection of atrial fibrillation, for

which the wearables showed high sensitivity and specificity, the authors said

Sensitivity and specificity are measures indicating how often a device shows true or false positives or negatives.

"The most promising results were observed for the detection of atrial fibrillation, with figures that compare favourably to other clinical tests," the

authors wrote. "Wearable trackers not only 🗦 empower people to proactively manage their health, but they enable them to detect health issues in real-time. This means that they can respond to any concern quickly, and hopefullyavoid any serious health issues,'

Singh said.

B'desh court acquits ex-PM

Dhaka: Bangladesh's former Prime Minister Khaleda Zia has been acquitted in five separate cases, including one filed over allegations of celebrating a "fake birthday" and another for supporting war criminals, a media report said Tuesday. Washington: The US is close to an agreement to give Ukraine long-range cruise missiles that could reach deep into Russia, but Kyiv would need to wait several months as the US works through technical issues ahead of any shipment, US officials said. Liu Pengyu, a spokesperson for China's embassy in Washington, said, "China has no intention and will not interfere in the US election, and we hope that the US side will not make an issue of China in the election.'



Their physical savings have also risen in the post-pandemic years to over 12 per cent of GDP and could rise further. They had reached 16 per cent of GDP in 2010-11, he said in a keynote address at the Financing 3.0

The offer for sale (OFS) for over 11.90 crore shares or 6.78 per cent stake will open Wednesday for institutional investors. Retail investors will get to bid in the share sale offer Thursday.

At the floor price of ₹395 a share.

the share sale would fetch about ₹4,700 crore to the exchequer. Shares of GIC Re closed at ₹421.25. down 0.13 per cent over previous close on the BSE. The floor price is at a discount of 6.23 per cent over Tuesday's closing price on BSE. "Offer for sale in General Insurance Corporation of India (GIC) opens tomorrow for Non-Retail investors, Retail investors and Employees of GIC can bid on Thursday. Government will divest 3.39% equity with an additional 3.39% as green shoe option," DIPAM Secretary Tuhin Kanta Pandey said in a post on X.

As per the OFS, the government proposes to sell up to 5,95,12,000 equity shares (representing 3.39%) Sept 4 for non-retail investors only and Sept 5 for retail investors. The government could decide to exercise the greenshoe option and sell an additional 3.39% stake taking the total share sale to 11.90 crore shares or 6.78%.

Luxury property frenzy set to drive up home prices

Bangalore, Sept 3: Home prices in India are set to rise steadily over the next few years, driven by demand for luxury properties from cash-rich individuals, according to a Reuters poll of housing experts who forecast rent increases will outpace consumer inflation.

While economic growth in Asia's third-largest economy is likely to outpace its major peers, policy experts warn the benefits are increasingly being funnelled to a select few, leaving millions of job-seekers, especially young people, out of the

growth story. With a supply of affordable homes dwindling and those with cash cornering the property market, many aspiring first-time buyers are being forced to keep

After growing 4.3% last year,

national home prices in India were expected to rise 7.75% this year, an upgrade from the 6.0% predicted in May, according to the median forecast from the Aug. 20-Sept. 2 survey of 16 property market experts.

Home prices are then expected to increase 6.0%-6.25% in the next two years. Average home prices in India broadly refer to housing in major cities.

'Housing demand is heavily tilted towards the luxury housing segment. This maintains a seemingly unstoppable growth curve while affordable housing continues to bleed," said Anuj Puri, chairman at ANAROCK Property Consultants.

"Tellingly, there was no new affordable supply. It is little wonder that developers are aligning supply with the prevailing demand and are launching more luxury housing projects now."

In a country of over 1.4 bil-

lion people, demand for housing is driven by a few, yet the sheer scale of the market is staggering, offering developers incentives to focus on the ultrarich as profit margins tighten in the affordable segment.

Ultra-high-net-worth individuals in India typically own more than two properties, with

nearly 12% of them planning to buy another home this year, according to Knight Frank's wealth

Even after the Reserve Bank

of India (RBI) raised interest rates by 250 basis points from May 2022 to Feb. 2023, India's housing market trends barely moved. A post-pandemic frenzy

among high-income earners fueled rising prices, further stretching affordability.

When asked what will happen to affordability for first time home buyers over the coming year, property market experts were nearly split, with 10 saying it would improve and eight say-


ing worsen. "First we have to agree this market is not for everyone. There's a bare minimum income for entry, and with income expected to grow faster than house prices in tier-one cities, affordability will improve only for those who are wealthy and generate enough income," said Pankaj Kapoor, managing director at Liases Foras.

"If your income is 5-10 lakh rupees (\$5,961-\$11,922), which is average, and the house price is over 50 lakh, you cannot afford in the cities where the jobs are. Even if you find something within your budget, it will be in a far-off location, making it impractical to live there and commute to work.

Ajay Sharma of Colliers International said housing affordability will worsen as housing value increases outstrip salary growth and added "key residential hubs in Bangalore, Mumbai, Pune and Gurgaon will continue to see rental increases

due to focused demand.' A lack of well-paying jobs in smaller towns is driving people to flock to larger cities in search of better opportunities, which has pushed rents much higher in the last few years.

When asked how much will average urban home rents change in India over the coming year, 16 housing experts gave a median forecast of 6.5%-10%, outpacing a consumer price inflation forecast of around 4.5% for the next two fiscal years.





Antil revels in glory Bronze for Deepthi in 400m

JAVELIN THROWER SAYS NEERAJ CHOPRA'S ADVICE AHEAD OF THE PARALYMPICS HELPED

Paris, Sept 3: Carrying a back injury for more than a year, history-making Indian javelin thrower Sumit Antil's path to Paralympic glory was paved with a 'sweet sacrifice' and several sleepless nights.

The 26-year-old faced a tough choice in the build-up to the Paralympics here – give up his favourite sweets or put his career at risk due to rapid weight gain and a back injury that troubled him before the Asian Para Games in Hangzhou last year where he won a gold.

Antil grudgingly gave up sweets on the advice of his physio Vipin, followed a strict training regimen and shed around 12 kilograms in just two months.

Antil's sacrifice paid off Monday when he became the first Indian man and only the second Indian overall to defend a Paralympic title, clinching gold in the F64 category with a record throw of 70.59m.

This new mark bettered his previous Paralympic best of 68.55m set in Tokyo Paralympics three years ago.

"I've reduced around 10-12 kilos. My physio, Vipin bhai, told me that the weight was putting pressure on my spine. So, I cut out sweets, which are my favourite, and focused on eating right," Antil revealed while talking to the media Tuesday here.

Fixing his back by taking adequate rest is the first thing Antil will do after his return to India. "Rest is crucial for the type of injury I have," Antil stated.

Antil also thanked his coach (Arun Kumar) for always knowing what he needed, staying up nights to plan his schedule, and putting in a tremendous effort. "It's been two years with my coach, and he's like an elder

brother to me. He knows exactly what I need and when I need it," Antil pointed out.

Antil dreamed of becoming a wrestler and was inspired by Olympic bronze-medallist Yogeshwar Dutt. However, in 2015, his life changed when a tractor accident led to the amputation of his left leg below the knee. He then moved on to para javelin and has already entered the annals of Indian sports.

Montevideo (Uruguay), Sept 3: Uruguay icon Luis Suarez announced his retirement from international football Monday, confirming that he will hang up his boots following Friday's 2026 World Cup qualifier against Paraguay here. "Friday will be my last match for my country," an emotional Suarez, 37, told a press conference. "It was not an easy decision to make, but I do it with the peace of mind that I will give my maximum until the very last game of my (Uruguay) career," the forward stated.

"I am 37 years old, there are a lot of talented players, and I know it would be difficult to get to the next World Cup," Suraez added.

The former Barcelona and Liverpool striker is widely regarded as one of the greatest players of his generation and will retire from international football as Uruguay's top scorer with 69 goals from 142 appearances.

Suarez, who was infamously

kicked out of the 2014 World Cup after being handed a four-month ban for biting Italy's Giorgio Chiellini made his debut for Uruguay in 2007. Suarez said Monday that inspiring Uruguay to that Copa crown had been the highpoint of his career. "I wouldn't trade the Copa America title for anything," he said. "It was the best moment of my career and something I will always cherish

A dynamic, skillful attacker with a lethal eye for goal, Suarez was also never far from controversy. He was also one of the villains of the 2010 World Cup in South Africa, when his cynical handball on the goal-line denied Ghana what would have been a late winner in the quarterfinals. Suarez was sent off for that offence and Ghana subsequently missed the ensuing penalty, allowing Uruguay to sneak into the semi-

finals after a penalty shootout. Suarez also featured in this summer's Copa America where he was used largely as a substitute by coach Marcelo Bielsa. He scored his 69th international goal in a third place play-off victory over Canada.

BANGLA SCRIPT HISTORICAL **SERIES SWEEP AGAINST PAK**

Rawalpindi, Sept 3: Bangladesh completed a six-wicket victory over here Tuesday and achieved an historic sweep of their two-Test series against Pakistan. Needing 143 runs on the final day with 10 wickets in hand, Bangladesh knocked them off for the loss of four wickets with Shakib Al Hasan hitting the winning boundary.

Bangladesh recorded only their second bilateral series win of two or more Tests away from home: the last was against the West Indies in 2009. The tourists won the opening Test by 10 wickets. The visitors' second innings finished on 185-4, and Shakib was unbeaten on 21 and Mushfigur Rahim on 22 not out. The Bangladesh top-order
