Subhadra 1st instalment to all by March 8

BHUBANESWAR: All beneficiaries of Subhadra Yojana will get their first instalment of Rs 5,000 by March 8, 2025, Deputy CM Pravati Parida said, Wednesday. However, the second instalment will be credited to beneficiaries' accounts on International Women's Day (March 8), she said. Parida said one crore women will get the benefits of Subhadra Yojana in phases. "So far, 92 lakh have applied for the scheme. We hope the applicant number will cross one crore within next week," she said, adding that 25,11,000 women have so far received the first instalment.

STEEL CITY HORROR Minor gangraped

It appears that there is no let-up in crimes against women in the Steel City, as a minor girl was allegedly gangraped at Raghunathpalli by five men recently - the second such incident in a week

Rourkela, Sept 25: At a time when the furore over the gangrape of two minor girls from Jharkhand in the Steel City here is yet to die down, a 17-year old girl was allegedly gangraped by five people, Sunday night.

Police registered a case and launched an investigation after the survivor's father lodged a complaint at Raghunathpalli police station here, Tuesday evening. A medical examination was conducted on the survivor while four police teams launched a manhunt to nab the culprits.

A police team, dog squad and scientific team also reached the spot and conducted a probe. Chatters were abuzz that police have detained some youths and their family members after a police complaint was lodged.

Police said that the survivor, a resident of an area under Plant Site police station, is also a student of a reputable college in

MAN MURDERED WHILE HAVING TEA

Rourkela: Three masked miscreants hacked a man to death and attacked his brother in-law near Chhend petrol pump in Sector-7 area, Wednesday, when they were having tea. The deceased was identified as Mohd Shakir of Chakradharpur in neighbouring Jharkhand and the injured Mohd Amir. The incident took place when Shakir was having tea with Amir near Kalpataru Ashram beside the petrol pump and the miscreants on a bike attacked them with sharp weapons. Shakir died on the spot while Amir managed to escape. Cops began a probe.

the city. The incident occurred when she, along with two of her friends, had visited a hotel and bar under Civil Township.

It is alleged that the male acquaintances of her friends accompanying her to the hotel were also present there. Later, her friends left the place leaving the survivor alone in the hotel.

There three youths lured her to a park near Traffic Square and took turns on her. Her father grew apprehensive and searched for her after she failed to turn up at home by late at night. Later, he found her inside the hotel. The FIR mentions that more persons are involved in this crime.

The survivor's father lodged a complaint at the police station with the help of some social activists, Tuesday. Police have picked up some youths on suspicion and are questioning them on the basis of an FIR, sub-divisional police officer (SDPO) Upasana Padhi said.

Speaking to mediapersons, Rourkela DIG Brijesh Kumar Rai said, "The incident occurred September 22. Four special teams led by Additional Superintendent of Police (ASP) PS Nayak were formed to nab the accused per-

sons after an FIR was filed. The survivor has been medically examined and her statements recorded. Police are prepared to control such repeated incidents and taking all steps to deliver speedy justice to the survivor, Rai asserted. The DIG expressed his inability to divulge further details in the case fearing impediment to the probe and

can only speak after completion of the investigation, he added.

Meanwhile, a police team led by the SDPO scanned the CCTV footage of the hotel and collected details regarding the survivor and her friends during their stay in the hotel.

Bangalore murder accused ends life

Bhubaneswar, Sept 25: Odisha police Wednesday found a man, the key suspect in the brutal killing of a woman in Bangalore, hanging from a tree in Bhadrak district, an officer said.

The police also recovered a diary, believed to be belonging to the deceased man Mukti Ranjan Ray, 30, in which he confessed to killing the

woman whose dismembered body was found in the refrigerator of her house in the southern metropolis.

Bhadrak SP Varun Guntupalli

said Ray, a resident of Bhuinpur under Dhusuri police station, was the prime suspect in the woman's murder. He was allegedly on the run following the discovery of the body parts of Mahalakshmi, a 29-year-old woman. Her body was found chopped into 59 pieces.



Bhubaneswar, Sept 25: Soon after assuming office as the inspector in-charge (IIC) of Bharatpur police station – which is presently in the eve of storm over the alleged custodial torture of a woman and her male friend from Indian Army - Monday, Deepak Kumar Khandayatray performed a 'special puja' and some other rituals at the police station, allegedly in contravention of Section 238 (causing disappearance of evidence) of Bharatiya Nyaya Sanhita (BNS).

City-based advocate Sourachandra Mohapatra said before commencing the rituals it is likely that they would have cleaned the place, in a bid to eliminate evidence, which is essential for the investigation. This act is an outright contravention of Section 238 of BNS, erstwhile 201 in IPC. "The question is whether

out for any task". "The 'havan' (homa yagya) was performed only to ensure that peacefulness prevails inside the police station," he added.

Notably, Khandayatray rose to the ranks of inspector in 2021 and was posted at Navagarh Sadar police station. Later, he was posted as IIC of Itamati and Pipli police stations. He was also serving at the DCP office here.

Khandayatray said the old Bharatpur police station was under CCTV surveillance. "CCTVs were removed after the inauguration of the new PS in March. Owing to technical glitches, the installation process was halted for some time," he said.

The priest who conducted the rituals said it was done to ward off the evil forces at the police station. He added the rituals continued for over two hours in the police station. Khandayatray replaced Dinakrushna Mishra who, along with four other cops, had been suspended on an order of the DGP over the issue.


Orchid glory for Similipal

Bhubaneswar, Sept 25: The Similipal National Park is not only a treasure house of nature with scenic beauty and lush green valleys, but also a tiger and biosphere reserve replete with diverse flora and fauna. Adding more feathers to its cap, scientists have discovered two epiphytic orchids, the indicator species of a healthy forest.

According to a report, around 100 species in 41 genera of orchids are found in Similipal of Mayurbhanj district. This is against 144 species under 53 genera found in Odisha till date.

Two epiphytic orchids have been discovered in Similipal recently by renowned orchidologist Sarat Chandra Misra. While one is 'Dendrobium Prasannae S

Misra said orchid flower has unique floral plan. Out of the three petals, the rear one, known as the lip, is differently shaped and also Prasannae' the lip is broadly oblong with an abruptly ending short tip the stems are drooping, long and slender. 'Oberonia similipalensis', on the other hand, is a much smaller curious-looking plant with knife-shaped slender leaves. Its lip is broadly ovate, undivided, with deeply cut the edges.

The former species has been named after late Prasanna Kumar Dash, former minister and Speaker of the Odisha Assembly, an ardent environmentalist and watchdog of the Similipal forest.

When the Odisha Environmental Society (OES) mooted the proposal for declaring Similipal as a Biosphere Reserve, it was Dash who, as the president of OES, pursued the proposal both at the state and Central level







NEW DELHI: Union Jal Shakti Minister CR Paatil will visit Odisha Thursday to participate in activities under the ongoing Swachhata Hi Seva campaign, aimed at promoting sanitation and cleanliness across rural India, officials said. The minister will be joined by Chief Minister Mohan Charan Majhi as the duo will review the state's efforts in waste management, Open Defecation-Free (ODF) Plus status, and sanitation initiatives under the Swachh Bharat Mission-Grameen (SBM-G), according to an official statement issued here Wednesday.

SHIPBUILDING, REPAIR FACILITY IN STATE SOON

New Delhi/Bhubaneswar, Sept 25: Odisha is among the five states which will soon have shipbuilding and repair clusters, according to Union Minister for Ports, Shipping and Waterways Sarbananda Sonowal.

"Recognising the strategic importance of shipbuilding and ship repair, the ministry is developing dedicated clusters in Maharashtra, Kerala, Andhra Pradesh, Odisha, and Gujarat, Sonowal said Wednesday while highlighting the major accomplishments of his ministry in the first 100 days of the third term of the NDA government.

In the next five years, the ministry projects container handling to reach an impressive 40 million TEUs (twenty-foot equivalent unit), creating 2 million job opportunities across the country.

Jawaharlal Nehru Port Authority (JNPA) alone will scale up its handling capacity from the current 6.6 million TEUs to 10 million. he added.

The minister also said that 3,900 acre land has been allotted to Deendayal Port Authority (DPA) and V.O. Chidambaranar Port Authority for setting up of

hydrogen manufacturing hubs. This will attract more than Rs 5 lakh crore worth of investment in the coming years, he added

He also said JNPA is going to become the first Indian Port to attain a Container Handling Capacity of 10 million TEUs in the coming months.

Sonowal said International **Container Transhipment Port** (ICTP) at Galathea Bay, Great Nicobar Island, will serve as a major transhipment hub.

"After 25 years since the establishment of Kamarajar Port, the addition of Vadhvan Port marks a significant milestone in India's maritime journey, alongside the recent notification of Galathea Bay as a major

port," he said. He underscored the foundation of Vadhvan Port, India's first major port project of the 21st century, poised to become one of

the largest all-weather deep water ports with a capacity of 298 MMTPA

According to him, this mega port is expected to create 1.2 million employment opportunities and place an Indian port among the top 10 container ports globally, significantly improving international shipping connectivity and reducing transit times and costs.

Ports, Shipping and Waterways Secretary TK Ramachandran said in the first 100 days, the ministry has taken bold steps to implement key reforms, such as the establishment of the Indian Maritime Centre and the Indian International Maritime Dispute Resolution Centre, both of which will bolster India's standing as a global leader in maritime infrastructure and logistics.

"We are on track to achieve the ambitious goals of the Maritime India Vision 2030 and Maritime Amritkaal Vision 2047, which focus on sustainable growth, enhanced connectivity, and improving the ease of doing busi-

ness", Ramachandran said. Responding to a question on Chabahar Port, he said the government had signed a contract and now the contract has been operationalised and the port is doing very well.

'We are also now going global in Sri Lanka, in Myanmar, in Bangladesh, India Ports Global Ltd (IPGL) is taking over operations of some of the terminals of few ports," Ramachandran said.

Ports, Shipping and Waterways additional secretary Rajesh Kumar Sinha said the ministry is working on a proposal to incentivise vessels who use green fuel.

Bhubaneswar, Sept 25: Nursing staff at state-run hospitals and healthcare centres launched a statewide agitation Wednesday over their 10-point charter of demands that include regularisation of contractual workers and scrapping of the outsourc-

ing system. Suchismita Dash, president of the Odisha Nursing Employees' Association (ONEA), said the group has repeatedly presented their demands to the state government but has received no response.

Stating that nurses have begun their protest without disrupting emergency medical services. Dash warned that they might



opt for 'cease work' from September 27 if their demands were not addressed.

In the meantime, Health Secretary Aswathy S held diswould be considered sympathetically at the appropriate time, Dash expressed dissatisfaction with the outcome of the meeting and said the association would proceed with their planned agitation.

Meanwhile, the government has urged nursing staff to refrain from further agitation. withdraw their strike, and return to work immediately.

Nurses launch statewide protest

Bhubaneswar, Sept 25: The Sub-Divisional Judicial Magistrate court here Wednesday allowed the Criminal Investigation Department (CID) to conduct polygraph test on Dinakrushna Mishra, the suspended inspector in-charge (IIC) of Bharatpur police station, in connection with the alleged torture of an Army officer and sexual assault on his fiancée in custody.

The court also granted permission to CID to take Mishra to Gandhinagar in Gujarat for conducting the polygraph test.

Under polygraph test, also known as a lie detection test, a person's physiological responses to questions are analysed to determine whether the person is lying or telling the truth.

Before granting permission to the CID for the test, the court sought consent of the accused police officer who said that he had no objection to being subjected to the scientific investigation.

"I am innocent. I am not involved in the commission of the offences as alleged against me. I do not have any objection to undergo narco-analysis, polygraph or brain fingerprinting tests. I am giving my consent on my own accord and free will," the accused police officer told the court.

The court accepted the CID's

proposal to conduct polygraph test on the accused police officer after realising that the sequence of the events in this case occurred within the four walls of the police station without any eyewitnesses and therefore scientific methodology may give a proper direction to the investigating agency to reach at the truth, the order said.

The CID also pleaded before the court that the investigating agency was finding it difficult to confirm the veracity of the allegations and also the counter allegations in the absence of CCTV cameras at the police station.

An Army officer was allegedly subjected to torture and his fiancée to sexual assault by policemen when they went to Bharatpur police station September 15 to lodge a complaint of road rage.

Improved support for women farmers need of hour: CIWA

Arun Kumar Panda, Head of Division of Gender, Family and Community Studies at CIWA, emphasises the stark disparities faced by

women in agriculture

New Delhi, Sept 25: In a push for gender equality in India's agriculture sector, a senior official from Odisha-based Central Institute for Women in Agriculture (CIWA) Wednesday stressed the urgent need for gender-sensitive policies and improved support for women farmers

Speaking to PTI, Arun Kumar Panda, Head of Division of Gender, Family and Community Studies at CIWA, emphasised the stark disparities faced by women in agriculture.

'Compared to men, women are lagging in agriculture - a reality often referred to as a gender issue." Panda stated.

The official pointed out several key areas where women farmers face significant challenges.

In case of land rights, only 13.75 per cent of women have land registered in their names, a direct result of patriarchal family structures. This is impacting their ability to access loans and other resources.

They lack access to resources. the official said. He added extension services, crucial for agri-



cultural development, predominantly cater to men, with mere 18-20 per cent reaching women farmers

As far as technology adoption is concerned, women farmers often lag in adopting new technologies due to lack of awareness and limited education, he added. To address these issues, Panda

called for a multi-pronged ap proach.

He said there is a need to prioritise collection and analysis of gender-disaggregated data to inform policy decisions; enhance women's financial inclusion through improved access to finance, cooperatives, and microcredits; and establish robust monitoring mechanisms to evaluate gender policies effectively. He also called for increase in

number of women in extension services, promoting 'gender-sensitive extension services'.

CIWA, the only institute under the Indian Council of Agricultural Research (ICAR) dedicated to women farmers, is at the forefront of developing women-friendly agricultural innovations. The institute has created various tools to reduce drudgery, including a manual hand ridger and a pedal-operated coconut dehusker.

Addressing the absence of women in high-level agricultural roles, Panda noted a shift in narrative from women's development to women-led development. "The time will come, and definitely this problem will also be addressed." he asserted.

The CIWA official stressed the importance of targeted policies to promote gender equality, calling for increased government investment in ২ female-specific training and skill development programmes.

As India strives for agricultural progress, bridging the gender gap emerges as a critical step towards inclusive growthand empowerment of women farmers.



Rourkela, Sept 25: It seems that the delay in Talcher-Bimalagarh railway link in Sundargarh district is finally over. Eight companies participated Monday in the bidding process for the laying the tracks between Bimalagarh and Mahudhia. People are hopeful that with the bidding over, any one of the eight will be allotted the project and work will begin on the 35-kilometre stretch between Bimalagarh and Mahudhia

The bidding process was conducted at the East Coast Railway office in Bhubaneswar. Among those who participated in the bidding, only one company is from Jharsuguda.

The project had been lying in a limbo for quite some time now. However, with the BJP coming to power in Odisha, the project, which was launched in the early 1960s, got a new lease of life. Since the unveiling of the plan to build the new railway tracks, land acquisition has been a major

They added that the laving of 35-km track at a cost of ₹535 crore will be completed by October 2026. 

Economics & Empathy

The outcome of November's US presidential election will have profound consequences for democracies worldwide and for geopolitical flashpoints like Ukraine, the Middle East, and Taiwan. But the potential economic fallout could be equally far-reaching. In today's interconnected global economy, with supply chains stretching across continents, policy missteps in the United States could reverberate around the world, fueling trade wars, inflation, and unemployment.

Election campaigns are rarely conducive to sound policymaking, as candidates often make ambitious promises without considering their feasibility. This is especially true of the 2024 election, with studies suggesting that both Democratic and Republican policies are likely to increase the deficit over the next decade.

The focus on short-term fixes and immediate relief could have a significant impact on America's long-term fiscal health. According to the Penn Wharton Budget Model, Vice President Kamala Harris' economic policies could raise the federal deficit by \$1.2 trillion by 2034. While alarming, this figure pales in comparison to the potential impact of former President Donald Trump's proposed policies, which are expected to increase the deficit by \$5.8 trillion over the same period.

Harris and President Joe Biden have been heavily criticised for presiding over the highest inflation in 40 years. But inflation has fallen dramatically since peaking in June 2022, prompting the Federal Reserve to cut its policy interest rate by 50 basis points last week. Despite this, Trump continues to attack the Biden administration over price increases, promising to tame inflation by, for example, expanding domestic oil drilling While macroeconomic experts are not al-

ways right when it comes to potential policy outcomes, there are times when their concerns are well-founded. Trump's economic proposals are a case in point.

Consider Trump's proposed tariffs. If elected, he plans to impose a 10 per cent tariff on all imports to the US and a 60 per cent tariff on Chinese goods. He also aims to curb outsourcing to foreign producers, promising to "build American, buy American, and hire American" and threatening to "punish those who ship jobs and factories overseas or to places like Mexico.'

Although targeted tariffs can sometimes make economic sense, applying them across the board would inevitably drive up costs and create inefficiencies. Discouraging outsourcing may appear beneficial, but blocking US companies from accessing

cheap labour abroad would make American products less competitive globally, harming the economy and reducing demand for labour in the long run.

The current debate about outsourcing is often framed as a battle between workers in wealthy countries and those in developing economies. But this overlooks the fact that outsourcing is fundamentally a labourversus-capital issue. Every time a job is moved overseas, profits increase, benefiting owners while workers bear the costs. The solution is to tax capital and redirect some of the revenue to workers without sacrificing competitiveness. Yet Trump, who has pledged to cut corporate taxes, has embraced the opposite approach.

Argentina's experience should serve as a cautionary tale about the threat that Trump's policies pose to America's economic prospects. In the early twentieth century, Argentina experienced remarkable growth, with some even predicting that it would eventually surpass the US economically. But in 1930, José Félix Uriburu launched a military coup and declared himself president. Backed by the far-right Nacionalistas, he restricted immigration and nearly doubled tariffs by 1933. Consequently, Argentina's economy stagnated, and its hopes of rivaling the US were dashed.

To be st macroeconomic policymaking is inherently fraught with error and uncertainty. This is why simple correlations, such as pointing out that economic indicator Y worsened under President X, are misleading and largely irrelevant. Political leaders are not expected to know everything; they are expected to have empathy for ordinary people and base their decisions on sound reasoning and the best available scientific knowledge. Trump falls far short of this ideal. His lack of empathy is evident in his dehumanising rhetoric, especially his claims that migrants are "poisoning the blood" of the country. Throughout his career, he has consistently shown disdain toward the disadvantaged. At a time of rising geopolitical tensions and economic turmoil, the US needs a president who may not have all the answers to the world's problems but genuinely cares about ordinary people and approaches policy challenges with empathy, integrity, and humility. Only one candidate fits the bill.

ing the recent outcry over the death of EY executive Anna Sebastian Peravil due to excessive workload, another tragic incident has emerged in Chennai. A techie named Karthikeyan, who had been working at a Pallavaram-based firm for the past 15 years, was found electrocuted, entangled in live wires. His family revealed that he had been battling depression due to work pressure and was on medication. We are often overwhelmed by a barrage of questions that disturb our minds, yet we find no answers because we prioritise competition over positive cohabitation. These recent incidents are not new to us: we have long ignored the sensitivity of the issue, waiting for more such

tragedies to occur. The issue of suicides among MNC professionals in India is indeed alarming. A report of Business Insider (2022) reveals that, India's major cities, that attract many people seeking better job opportunities and livelihoods, have unfortunately become hotspots for suicides. The four major cities - Delhi (2,760), Chennai (2,699), Bangalore (2,292), and Mumbai (1,436) together account for nearly 35.5% of all suicides reported from 53 cities. With the latest data showing a sharp rise in suicides in India, employers are being urged to reduce workplace stress and train managers to support employees' mental wellbeing.

Factors such as long hours, tight deadlines, heavy workload, job insecurity, and conflicts with colleagues or bosses contribute significantly to this issue. Notably, renowned MNCs despite offering attractive remuneration package and alluring incentives, place immense pressure on white-collar professionals in India, pushing many to the brink. A typical busy office often reveals signs of high work-related stress, including long hours, job strain, and poor future prospects. These factors are vividly illustrated in the letter by Anita Augustine,

the mother of the late Anna Sebestain, which details the toxic work environment and prevalent work pressure at the Pune EY office.

After this incident, I spoke with some of my friends working in MNCs and learned some daunting facts about their work culture. They highlighted how companies glorify long working hours and normalise working on weekends. They also mentioned that employees are expected to be ready with their systems even on off days to provide data and figures whenever required. From these observations, it is clear that these companies operate like total institutions, leaving little room for employees to breathe. In some cases, they are strictly allowed to carry their laptops even on their planned vacations and leaves.

In his 1897 book, Suicide: A Study in Sociology, Durkheim describes suicide as a 'social fact' and highlights how high levels of regulation and integration can drive individuals to take their own lives. This classic work remains relevant today, as we observe employees in MNCs being treated like robots, compelled to work in highly regu lated environments, and forced to conform to corporate culture.

Sometime ago, Infosys cofounder Naravana Murthy had suggested that Indians work a minimum of 70 hours a week for

two to three years to offset the economic slowdown caused by the COVID lockdown. This proposal faced widespread criticism, with opponents citing studies that show regularly working long hours can lead to severe physical and mental stress, and is a significant risk factor for increasing suicidal thoughts and intentions. Recent statistics highlight a dramatic rise in suicides among professionals. According to alarming data from the National Crime Records Bureau (NCRB) for 2021, approximately 50 people in India are believed to commit suicide every week due to career or workplace problems. The NCRB report also revealed that a total of 164,033 people died by suicide in India in 2021, marking a 7.2% increase compared to 2020. However, many experts believe that the available statistics on suicides in India are underestimated and unreliable. Numerous suicides are not included in official statistics for various reasons. Additionally, if a suicide occurs outside of work hours or away from the work-

place, it may not be classified as work-related, even if the victim's family and police suspect that job-related stress or other factors contributed to the death. While many Indian companies are still not fully aware of

the risks associated with anxiety and depression among em-

ployees, and how to prevent, reduce, and manage these issues, some handful of employers recognise the importance and benefits of fostering a mentally healthy workplace culture. The term "handful" reflects how we often overlook mental health issues, not viewing them as legitimate concerns. We openly discuss physical health problems, but mental health remains stigmatised and less accepted in society. Many of us worry about being judged by colleagues or having our struggles labeled as 'mental' and shared with others. This fear leads to reluctance to speak openly about our feelings. It's crucial to recognise that our brains are constantly active, and just like our bodies, they can experience challenges. We need to foster an environment where mental health is acknowledged and discussed

without stigma. Both large and small firms should initiate safety and wellbeing programmes, emphasis ing their commitment to addressing suicide directly with employees. A dedicated day should be planned to enhance the mental and emotional well-being of associates. Additionally, multinationals should promote a 24/7 helpline, peer-based counseling, professional counseling, staff support, and guidance on managing mental and physical health. Each location should have a specific local advice line for professional counseling. To combat work-related stress and employee isolation, companies should implement team-building and enjoyable activities in the workplace. Leadership should emphasise humility and thoughtfulness, considering the impact of their actions on local communities, the planet, and future generations.

The key lessons from the recent incidents should be to create a conducive environment where employees feel comfort able sharing their concerns and feedback without being judged or bullied.

uring the course of a hearing not long ago, a Supreme Court Bench had raised a query whether the incarcerated Chief Minister of National Capital Territory (NCT) could or could not sign on official files while sitting inside the prison he was lodged in. The hearing pertained to a petition, filed by eligible convicts, against undue delay in disposal of their application for remission of jail term. The remission file had

been gathering dust for want of signature of the imprisoned CM. The question should have ideally been broader - whether an imprisoned person can continue to hold the chair of CM.

The imprisoned CM has since secured bail from the SC and thereafter resigned from the post. The resignation appears to have been prompted by the bail conditions and political strategy. However, the larger question about continuity in office of an imprisoned CM needs to be addressed, should a similar scenario arise in future.

I have retired from a public sector bank where the service

rule stated that an employee behind bars for more than 24 hours was liable to be suspended from service without an ado. Moreover, a parallel departmental enquiry would have also ensued presuming the employee would have committed some act of omission or commission necessitating arrest by law-enforcement agencies. Here it had been many months but the imprisoned CM stayed ensconced, figuratively speaking, in the chair unscathed. The question that the SC Bench should have asked and answered was whether an imprisoned person could continue in the CM chair. If CM was wrongly arrested, he should have been let free by the courts immediately. Otherwise, the continuance of the imprisoned CM in chair was not tenable. If an arrested government employee is liable to be suspended from service at once without granting even a reasonable time to the accused to obtain bail, why the same rule should not apply to the head of government of NCT.

In another instance during the same period, a CM of a state, anticipating his arrest, resigned

from the post in the nick of time. By anointing his colleague as stop-gap CM, the tribal leader made sure that there would not be any governance deficit besides projecting optics of political morality. He resumed the mantle of CM only after getting bail from the High Court which had later been endorsed by the SC.

The Chief Minister of NCT, before himself being arrested, did not bat an eyelid to sack his cab inet colleagues when they were arrested. The same yardstick should have been applied to self also. How was the government of NCT running as the imprisoned CM had not been holding any cabinet meetings, nor been signing any official files? A government employee is

suspended immediately from service if arrested whether for misusing the office one is holding or for some purported crime in personal capacity. Here the arrest had been made for alleged corruption in official role. Therefore, the continuance in office was not tenable. In corruption cases the accused should ideally return to office only after

being exonerated from all charges. But because the trial process is unduly long, and there being suspicion of arrest arising out of political vendetta, one should at least wait for bail before returning to office. Can a government employee, howsoever higher in hierarchy, continue to hold the office he is accused of misusing for corrupt practices? The answer is big 'NO'.

The legal eagles can also ask many ancillary questions. Whether the CM will be treated on leave for the period he stayed in jail? Was the imprisoned CM getting all the pay and perks without discharging any of the duties? Was there an arrangement of officiating CM? If an officer of Chief Secretary level is arrested by agencies for purported corruption, will the officer continue to still be Chief Secretary while being in jail for months together? Ironically, the imprisoned CM himself was once a bureaucrat and is likely to be well-versed with the service rules.

Netanyahu problem

Sir, This refers to "Lebanon death toll reaches 550," OrissaPOST, Sept 25. Monday's deadly airstrikes by Israel in southern Lebanon mark a huge escalation in the 11month-old conflict. But blame also lies with Hezbollah, which has been baiting Israel for months with Beirut doing little to rein in the militant group. The militant group's calculation was that it could continue low-level strikes against Israel in solidarity with Hamas in Gaza. This would stretch Tel Aviv's military resources and impact its economy, but its calculation went wrong. Hezbollah thought it could absorb whatever Israel threw at it. But the pager and walkie-talkie bombings last week hit the group hard. True, Mossad's modus operandi has raised worldwide concerns about weaponising everyday electronic devices. Arab nations - who were troubled by Israel's Gaza operation - will not mind the offensive against the Shia militant group. Plus, if Iran steps in at some point, it's a jackpot for Netanyahu as even a future US administration will be forced to stand with him. In all this, the world, not just West Asia, has a Netanyahu problem.

Women voters concerned about rising electricity bills

The election campaign of all the major political parties in Jammu and Kashmir revolved around the revocation and restoration of the erstwhile state's special status but women voters are more worried about the rising electricity bill amounts. An elderly woman, waiting for her turn to vote at a polling station in the heart of Srinagar city Wednesday told a visiting foreign diplomat that she is concerned about the erratic electricity supply and the rising bill amounts. "The electricity supply has been destroyed and tariff meters have been installed. Now they say water consumption will also be metered." the woman in her late 60s told the US Deputy Chief of Mission in Delhi, Jorgan K Andrews. While the woman refused to identify herself, she said she spoke her heart out hoping that the diplomat's intervention will bring some relief to poor people from the rising electricity bill amounts. Unaware that foreign diplomats were invited here only to witness the Assembly poll process, the woman said she is hopeful that the "Angrez" will take up the matter with the Central government led by Prime Minister Narendra Modi. The second phase of polling for the three-phased Jammu and Kashmir Assembly election is being conducted Wednesday. A significant number of women voters queued up before the polling stations here. They were more concerned about basic amenities like electricity, water and foodgrains through the public distribution system. "The monthly electricity bill has risen from ₹1,400 last year to ₹2,750 this year. We want to vote for a government that will roll it back,' Haseena Bano, a resident of the uptown Bazullah area, said. While the electricity tar iffs have remained unchanged for several years in Jammu and Kashmir, the Power Development Corporation has revised the load agreements and that has nearly dou bled the monthly bills of the consumers who are paying at a flat rate.

New Delhi, Sept 25: Cars slow down, feet falter and eyes swivel to the many murals on the walls of schools, hospitals and homes in Delhi's Lodhi Colony, the quiet neighbourhood that has come to be known as Lodhi Art District over the last 10 years.

Hanif Kureshi, the creative lead behind India's first public art district and the visionary artist and designer remembered for "making art democratic", died from cancer in Goa Sunday. He was 41.

The gigantic murals, some freshly painted and others at different stages of their fully-lived vibrant lives, stand as quiet witnesses to the passing of the man who started the street art movement across the country, beginning with the government staff residential colony in 2015.

One-year service bond for medics: Delhi govt

New Delhi: Delhi government has introduced a one-year mandatory service bond for medical students passing out from All India Quota and State Quota in both undergraduate (UG) and postgraduate (PG) programs from medical institutions in Delhi. Srinagar, Sept 25: The second phase of polling in the Jammu and Kashmir Assembly elections saw a voter turnout of over 56 per cent Wednesday, with the democratic exercise passing off peacefully amid tight security.

While there was significant participation in key constituencies in 26 seats spread over six districts with long queues of voters at polling stations since early morning, 20 of these segments recorded a marginally lower turnout than in the 2014 Assembly elections, when the overall voting was 60 per cent.

The first phase of polling, held September 18, saw an estimated 61.38 per cent voter turnout, while the final phase is set to take place October 1 in the crucial elections being held after 10 years.

Jammu and Kashmir Chief Electoral Officer P.K. Pole announced a preliminary turnout figure of 56.05 per cent, stating that it might change as polling continued in some areas, including Hazratbal and Reasi.

He emphasised that the election proceeded smoothly, with only minor incidents reported.

"There were some stray incidents, but there is no need for re-polling anywhere," Pole stated during a press conference after polls closed at 6 PM.

The highest turnout was recorded in the Shri Mata Vaishno Devi constituency, with 79.95 per cent of registered voters exercising their franchise. Other notable turnout figures

New Delhi, Sept 25: The Supreme Court Wednesday cautioned courts against making comments that may be construed as "misogynistic" or directed towards a particular "gender or community" and said no part of Indian territory can be called Pakistan.

The apex court's strong observations came as it closed the suo motu proceedings over Karnataka High Court judge Justice V Srishananda's alleged objectionable comments during court proceedings. The Supreme Court also noted that he had apologised for his observations during open court proceedings September 21. A five-judge bench headed by Chief Justice D Y Chandrachud observed that since Justice Srishananda was not a party to proceedings before it, "we

desist from making any further observations save and except to express our serious concern about both the reference to gender and to a segment of the community"

The top court September 20 took suo motu cognisance of the judge's comments against a woman lawyer during court proceedings in a case and his reference to a Muslim-majority area in Bengaluru as "Pakistan" in another. "Casual observations may well reflect a certain degree of individual bias particularly when they are likely to be perceived as being directed to a particular gender or community," the bench, also comprising Justices Sanjiv Khanna, B R Gavai, Surya Kant and Hrishikesh Roy, said Wednesday.

"Courts, therefore, have to be careful not to make comments in the course of judicial proceedings which may be con-



strued as being misogynistic or for that matter prejudicial to any segment of our society," it said.

Referring to the text of a report submitted before it by the

registrar general of the Karnataka High Court, the bench said it amply indicated that observations made in the course of proceedings there were unrelated to the course of proceedings and should have

best been eschewed.

The perception of justice to every segment of society is as important as the rendition of justice as an objective fact," it said.

"Such observations are liable to be construed in a negative light, thereby impacting not only the court of the judge who express them but the wider iudicial system," it said.

After the bench dictated the order in the court room, General R Attorney Venkataramani referred to some messages on X about the observations and termed them "absolutely vitriolic". "Now you have seen the nature of the observations. We can't call any part of the territory of India as Pakistan. Because that fundamentally is contrary to the territorial integrity of the nation," the CJI observed.

Mumbai, Sept 25: The Bombay High Court expressed concerns Wednesday regarding the police shooting of Akshay Shinde, the accused in the Badlapur school sexual assault case. stating that the incident could have been avoided and emphasised the necessity for a fair and impartial probe.

A division bench comprising Justices Revati Mohite Dere and Prithviraj Chavan also raised pertinent questions over the manner in which the shoot out was executed. The bench said while it was not impugning the police's integrity, it insisted on the importance of clarity in the

investigation. It also stressed the necessity for a fair and impartial investigation into the circumstances surrounding the shooting. During the proceedings, the court underscored its expectation that the police would address all aspects of the case transparently. "If we find that the investigation is not conducted properly, we will be constrained to issue appropriate orders," the bench warned.

The court scheduled the next hearing for October 3, by which date the police are expected to decide on a complaint filed by the father of the deceased, requesting a First Information Report (FIR) against the involved police officers. "We are not suspecting the police on their activities but come clean on all aspects." the bench said.

It also directed the immediate transfer of all case files to the Maharashtra Crime Investigation Department (CID) for further inquiry.

"Why have the files not been handed over to the CID yet? The preservation of evidence is crucial. Any delay raises doubts and speculation," it stated.

The judges raised pointed questions about the circumstances of the shooting, suggesting that it may have been preventable if police had attempted to subdue Shinde before the incident escalated.

The bench said while it was not raising any suspicion at this stage, it was very hard to believe that Shinde managed to seize a pistol from a police officer and opened fire.

The bench also noted that the officer who shot at Shinde was a police inspector who has experience on how to react in such a situation.

The court said it is not very easy to unlock and open fire from a pistol.

They questioned the rationale behind shooting him in the head rather than aiming for a less lethal area, such as the legs or arms. Justice Chavan said he has used a pistol several times and it is very hard to use.

The region hosts around 74,000 MSMEs, but many face crises due to challenges such as a lack of affordable finance, rapidly changing technology and inad-

equate infrastructure, it said. MSME EPC chairman Dr D S Rawat, while releasing the study report in New Delhi Wednesday, said many startups have come up and helped the region in providing jobs, but some of them are in deep crisis in the absence of hand-holding either by large units or institutions To address these issues, the

EPC has recommended that state governments establish high-powered committees to prioritise the challenges faced by MSMEs. They suggested developing a



roadmap to create a conducive environment for tapping into the region's potential, focusing

on skill development, opening showrooms for MSME products, and connecting these enterprises

with research and development centres and global marketing agencies.

The study emphasised the need for a new financing model that involves the DoNER ministry, multilateral institutions, and private players to enhance industry attractiveness and foster entrepreneurship. The proposed 'Single Window' system aims to simplify processes for MSMEs and attract private investments, it added.

Major challenges include geographical barriers, underdeservice providers to offer customised solutions to MSMEsin technology, product development, and marketing.

Wildfire rages in **Ecuador's capital**

Quito: A raging wildfire filled Ecuador's capital of Quito with smoke and threatened homes Tuesday as authorities rushed to control the blaze at a time when a historic drought has stretched resources and patience. President Daniel Noboa said the armed forces had been deployed to fight the fire, which started around midday in the bohemian Guapulo neighborhood and gradually spread to nearby residences and forested areas Some tearful residents worked desperately to put out flames. according to a Reuters witness. No deaths or serious injuries have been reported. Ecuador's worst drought in over 60 years has plunged the hydropower-dependent country into an energy crisis as diminished reservoirs leave hydroelectric dams offline.

Russia's secret war drones project

Saint Petersburg, Sept 25: Russia has established a weapons programme in China to develop and produce long-range attack drones for use in the war against Ukraine, according to two sources from a European intelligence agency and documents reviewed by Reuters.

IEMZ Kupol, a subsidiary of Russian state-owned weapons company Almaz-Antey, has developed and flight-tested a new drone model called Garpiya-3 (G3) in China with the help of local specialists, according to one of the documents, a report that Kupol sent to the Russian defence ministry earlier this year outlining its work.

Kupol told the defence ministry in a subsequent update that it was able to produce drones including the G3 at scale at a factory in China so the weapons can be deployed in the "special military operation" in Ukraine, the term Moscow uses for the war.

Kupol, Almaz-Antey and the Russian defence ministry didn't respond to requests for comment for this article. China's foreign ministry told Reuters it was not aware of such a project, adding that the country had strict control measures on the export of drones, or unmanned



aerial vehicles (UAVs)

Fabian Hinz, a research fellow at the International Institute for Strategic Studies, a Londonbased defence think-tank, said the delivery of UAVs from China to Russia, if confirmed, would be a significant development.

"If you look at what China is known to have delivered so far, it was mostly dual-use goods, it was components, sub-components, that could be used in weapon systems," he told Reuters. "This is what has been reported so far. But what we haven't really seen, at least in the open source, are documented transfers of

whole weapon systems.' Still, Samuel Bendett, an adjunct senior fellow at the Center for a New American Security

think-tank, said Beijing would be hesitant to open itself up to international sanctions for helping Moscow's war machine, and that more information was needed to establish that China was playing host to production of Russian

Seoul, Sept 25: Border police in China's northeast have been given quotas to identify and expel undocumented migrants. one key aspect of broader surveillance that is making it harder for North Korean defectors to evade capture, according to previously undisclosed official documents and a dozen people familiar with the matter.

China has implemented new deportation centres, hundreds of smart facial-recognition cameras and extra boat patrols along its 1,400-kilometre frontier with North Korea, according to a Reuters review of more than 100 publicly available government documents that outline spending on border surveillance and infrastructure.

In addition, Chinese police have begun to closely monitor the social media accounts of North Koreans in China, and collect their fingerprints, voice and facial data, four defectors and two missionaries told Reuters. Stephen Kim, a missionary who helps North Koreans defect, told Reuters that based on his contacts with some 2,000 defectors, more than 90% of those currently in China had registered personal and biometric data with the police.

The measures took effect since the Covid-19 pandemic and have ramped up from 2023

New Delhi: There is a "critical need" for coal imports, and the country has reported a marginal rise of 0.9 per cent to 90.51 mt in the April-July period of FY25, according to an official statement. Gold hits all-time high of ₹77,850; silver soars ₹3K

New Delhi, Sept 25: Gold prices surged ₹900 to hit a fresh record high of ₹77,850 per 10 grams in the national capital Wednesday amid a rally in precious metal rates in the global markets, according to All India Sarafa Association.

The precious metal of 99.9 per cent purity had closed at ₹76,950 per 10 grams Tuesday.

Silver soared ₹3,000 to ₹93,000 per kg on fresh off take by industrial units and coin makers. It had ended at ₹90,000 per kg in the previous close.

Additionally, gold of 99.5 per cent purity also climbed ₹900 to hit all-time high level of ₹77,500 per 10 grams. The metal had finished at ₹76,600 per 10 grams in the previous session.

Gold prices in the international markets is likely to surpass USD 3,200 per ounce in the near future, Surendra Mehta, National Secretary at India Bullion and Jewellers Association (IBJA), said.

"Gold's bull run continues as prices hit yet another alltime high at ₹76,000 per 10 gm on futures. Prices remain supported by a weaker dollar, expectation of more rate cuts from global central banks, safe haven demand, and inflow of ETF funds," Pranav Mer, VP -Research (Commodity & Currency) at BlinkX and JM Financial, said.

According to traders, persistent buying by jewellers and a strong trend in the international markets were among the factors that aided the rally in gold prices.

On the other hand, in the futures trade on the MCX, gold contracts for October delivery hit a fresh record high of ₹997, or 1.33 per cent, to ₹76,000 per 10 gram on the exchange.



Valuation concern: Equity funds' cash holdings surge

Mumbai, Sept 25: Indian equity funds' allocation of cash relative to their asset size rose to a 5-year high at the end of August, as fund managers are worried about markets being too rich and other macroeconomic risks around US elections and Chinese growth.

According to Morningstar data, active equity funds in India with a fund value of at least \$1 billion held an average of 5.39% of their portfolios in cash as of end-August, their highest levels in five years.

Although the rise in cash levels is partly due to inflows and the launch of new funds, caution is also a factor.

"The elevated cash levels among fund managers may suggest an expectation of a potential stock market correction as

While the market has been performing well, there are potential risks such as economic slowdown, interest rate regime change, geopolitical tensions and market overvaluation

After lacklustre earnings growth in the first quarter of this fiscal year, which saw more than half of Indian companies miss consensus earnings ex-



pectations, fund managers are also worried about valuations.

"There are valuation concerns as pockets of markets are looking over-stretched," said Abhishek Goenka, founder and chief executive of IFA Global.

The forward price-to-earnings (P/E) ratio for MSCI India's largecap index is at 22.8 times, an 18.6% premium to the 10-year average, while the MSCI India mid-cap index is trading at a 67.7% premium and the small-cap index at about 40% premium to their respective 10-year averages.

"Currently, valuations for midcaps look elevated, hence, there might be a possible correction in mid-caps," said Anil Rego, founder and fund manager at Right Horizons.

Morningstar data showed the ICICI Prudential Value Discovery Fund, with a fund value of about \$5.9 billion, saw its cash allocation climb to 14.7% by the end of August from 7% at the begin ning of the year.

Similarly, the SBI Long Term Equity Fund, which has a fund value of \$3.3 billion, increased its cash holdings to 9.8% in August from 4.46% at the start of the year. The Quant Small Cap Fund, valued at \$3 billion, also saw its cash allocations rise significantly to 15.7% in August from just 2.15% at the start of the year.

However, some analysts don't believe that these high cash levels portend a market crash.

"Usually, bouts of deep correction happen when the markets are fully invested. If the markets are circumspect and exercising caution, we may see 3%-5% corrections getting bought into. The cash will start getting deploved and that would support the markets," Wright Research's Sonam Srivastava said.

Swiggy filed its offer document April 30 through the confidential pre-filing route, keeping details undisclosed for the time being. Swiggy, founded in 2014, had a valuation of nearly \$13 billion in April. The company's annual revenue stood at USD 1.09 billion as on March 31, 2023 and has more than 4,700 employees, according to Tracxn, a global startup data platform. In April, sources had previously stated that Swiggy received shareholders' approval for an IPO to raise ₹10,414 crore fund through issue of fresh equity shares and an Offer-For-Sale (OFS).

A fan of team events, Erigaisi is excited about the upcoming Global Chess League, which he calls the 'IPL of chess'. "I like that it's a team event. I enjoy team events and also I like the rapid format. It is definitely the IPL of chess," Erigaisi signed off.

With Indian youngsters shining on global stage, the nation is celebrating them as the golden generation of chess players and Erigaisi believes that the camaraderie between him, D Gukesh and R Praggnanandhaa, fuels their collective success and elevates their game.

"We can certainly call this the golden generation of India. Like 2003 born to 2006, let's say. And I'm the oldest one in there. We all know each other for a pretty long time and have a healthy rivalry also. It helps. It's like when someone does well, the others also get motivated and want to do equally well," Erigaisi pointed out. "In the end our goal is to win," he added.
