I felt suffocated in the organisation because of the prevailing atmosphere," said Satpathy in his reply to criticism by BJD spokesperson Lenin Mohanty who said it would be better if he left the party. He drew the ire of BJD after he said that Naveen should take responsibility for the party's debacle in the Assembly polls, and that VK Pandian should not be blamed for it as he was not the leader of the party.

Odisha wins top spot for

New Delhi, Oct 14: Odisha has been recognised as the top winner in the 5th National Water Awards 2023, with Uttar Pradesh securing the second spot, the Ministry of Jal Shakti said Monday. Gujarat and Puducherry jointly secured the third spot in the awards, which cover nine categories, honour outstanding contributions to water conservation and management across India.

Jal Shakti Minister CR Paatil announced the results. The award ceremony will be held October 22. Odisha's remarkable achievements in water conservation include the construction of over 53,000 water conservation and rainwater harvesting structures and the renovation of 11,000 traditional water bodies, a senior official said. Additionally, 21,000 wastewater treatment plants were set up, transforming over 90,900 hectares of irrigated land to micro-irrigation systems, benefitting 87,000 farmers. The state has also made significant strides in afforestation, completing the plantation of 9 crore saplings, the official said.



Task force to check distress migration

In a tit-for-tat move, Canada too has asked six Indian diplomats to leave the country after its police collected evidence they were part of an Indian government "campaign of violence"

India's decision to recall High Commissioner Sanjay Verma and some other diplomats came shortly after the Canadian Charge d'Affaires Stewart Wheelers was summoned to the Ministry of External Affairs (MEA). Wheelers was bluntly told that baseless "targeting" of the Indian envoy and other officials was "completely unacceptable". The Washington Post, quoting unnamed Canadian officials, reported that Canada Monday ordered six Indian diplomats to leave the country, including Verma and the top consular official in Toronto.

In a late evening statement, the MEA said India has asked six Canadian diplomats including Wheelers and Deputy High Commissioner Patrick Hebert to leave India by or before 11:59 pm

In its reaction to Canada's charges against Verma, New Delhi described them as "concocted" and "preposterous imputations" and ascribed the allegations to the "political agenda of the Trudeau government that is centred around vote bank politics"

Meanwhile, the Royal Canadian Mounted Police (RCMP) Monday made serious allegations against India. "They use organised crime elements. It has been publically attributed and claimed by one organised crime group in particular -Bishnoi Group. We believe the group is connected to the agents of the Government of India,' said Brigitte Gauvin, Assistant Commissioner, Federal Policing, National Security, RCMP.


Trio of professors win Economics Nobel Retail inflation hits 9-month high

Stockholm, Oct 14: The Nobel memorial prize in economics was awarded Monday to Daron Acemoglu, Simon Johnson and James A. Robinson for research that explains why societies with poor rule of law and exploitative institutions do not generate sustainable growth.

The three economists "have demonstrated the importance of societal institutions for a country's prosperity," the Nobel committee of the Royal Swedish Academy of Sciences said at the announcement in Stockholm.

Acemoglu and Johnson work at the Massachusetts Institute of



Technology and Robinson conducts his research at the University of Chicago

'Reducing the vast differences in income between countries is one of our time's greatest challenges. The laureates have demonstrated the importance of societal institutions for achieving this," Jakob Svensson, Chair



of the Committee for the Prize in Economic Sciences, said. He said their research has provided "a much deeper understanding of the root causes

of why countries fail or succeed.' Reached by the academy in Athens, Greece, where he is due to speak at a conference, the Turkish-born Acemoglu, 57, said he was surprised and shocked by

'You never expect something like this," he said.

Acemoglu said the research honoured by the prize underscores the value of democratic institutions.

"I think broadly speaking the work that we have done favours democracy," he said in a telephone call with the Nobel committee and reporters in Stockholm.

But he added that "democracy is not a panacea. Introducing democracy is very hard. When you introduce elections, that sometimes creates conflict."

New Delhi, Oct 14: Soaring vegetable prices pushed the retail inflation rate to a nine-month high of 5.49 per cent in September, according to government data released Monday

The consumer price index (CPI)-based retail inflation rate was 3.65 per cent in August and 5.02 per in September 2023. The previous high inflation rate was witnessed in December 2023 at 5.69 per cent.

As per data released by the National Statistics Office (NSO), the inflation rate in the food basket rose to 9.24 per cent in September compared to 5.66 per cent in August and 6.62 per cent



"It is likely that the increase in inflation rate for the month of September 2024 is due to high base effect and weather conditions." NSO said.

According to another data released Monday, the wholesale

price inflation (WPI) rose to 1.84 per cent in September as food items, especially vegetables, turned costlier.

The wholesale price index (WPI)-based inflation was 1.31 per cent in August. It was (-) 0.07 per cent in September last year.

The Reserve Bank of India (RBI), which kept the key shortterm lending rate unchanged earlier this month, has been asked by the government to ensure the CPI inflation rate remains at 4 per cent with a margin of 2 per cent on either side.

The annual inflation rate in the vegetable basket in September was nearly 36 per cent and in-'pulses and products' it was 9.81 per cent. Fruits, too, were dearer.



CITY BIDS ADIEU TO MAA DURGA

Cuttack/Bhubaneswar, Oct 14: As the five-day Durga Puja festivities wrapped up peacefully across Odisha, idol immersion was held amidst tight security in the twin cities of Cuttack and Bhubaneswar Monday.

Cuttack, a major centre of attraction during Durga Puja, saw all roads leading to Devi Gada on the left embankment of Kathajodi river for the immersion, which proceeded smoothly without any untoward incidents. This year, Bhubaneswar hosted 187 puja pandals while Cuttack featured 170.

The clay idols of Maa Durga, accompanied by beautifully decorated tableaux, were taken in majestic processions to makeshift ponds for immersion, supported by a significant police presence.

Notably, procession parties in Cuttack and Bhubaneswar refrained from using vehicles for manual music or DJs. Puja committees had agreed with district administrations to adhere to the slogan 'No Liquor and No DJ' during the immersion processions.

"The two-day-long immersion festival will continue throughout Monday



night and conclude by Tuesday morning," Police Commissioner Suresh Dev Datta Singh said.

Singh, along with Cuttack DCP Jagmohan Meena and other senior officers, is overseeing the processions from a temporary CCTV control room set up at Dargha Bazaar police station. Approximately 444 CCTV cameras have been installed along the procession routes in Cuttack, with footage being monitored round-the-clock by police. Earlier, the puja rituals

wrapped up Sunday evening with Bijaya Dashami celebrations, which included the burning of Ravana effigies at several locations

No longer with BJD, says Amar Satpathy

Bhubaneswar, Oct 14: Former minister Amar Prasad Satpathy, a six-time MLA, Monday said he was no longer associated with the BJD as he did not renew his membership.

Satpathy, who was unhappy after not getting nom-

inated in this year's Assembly polls, made the comment in reply to criticism by BJD spokesperson Lenin Mohanty who said it would be better if he left the party.

He drew the ire of the BJD after he said that former CM Naveen Patnaik should take responsibility for the party's debacle in the Assembly polls, and that VK Pandian should not be blamed for it as he was not the leader of the party.

"I am no longer associated with the BJD. I have not renewed the membership of the party during the drive undertaken by it recently. I felt suffocated in the organisation because of the prevailing atmosphere," he said. Reiterating his earlier

statement, Satpathy said, "We made Naveen Patnaik the leader. He had been credited for the victory of the party in the past and now, he

should take responsibility for

the defeat. He (Pandian) was not our leader though he came to the party through Patnaik. Why should we blame Pandian whom we had not made leader?'

Satpathy, a founding member of the party, was elected to the Assembly in 1990, 1995, 2000, 2009, 2014 and 2019. This

time, he was replaced by Odia film star Varsha Priyadarshini, who lost to BJP's Amar Kumar Naik.

The BJD failed to open its account in

the Lok Sabha and secured 51 seats in the 147-member Assembly, losing to the BJP. Stating that he was independent of any political party for now, Satpathy said, 'Though many parties, including the BJP, are in touch with me, I have not taken any decision." Mohanty said the BJD will not be affected if Satpathy quits and joins another political outfit. After the party's electoral loss, many leaders have been public about their resentment.

Former MP Pradeep Majhi has been critical of the alliance talks ahead of the polls, while ex-minister Badri Narayan Patra claimed that the results would have been better if Patnaik toured the state.

According to religious texts, the origin of 'Goshani Jatra' dates back to around 12th Century AD, almost when the Srimandir was built

while the immersion of all the 'Goshani' deities are made on 'Ekadashi' day, only the idol of Kakudikhai is immersed on 'Dashami' as it is done for Goddess Durga. The biggest 'Goshani', however, is Barabati and she is regarded as the elder sister of 'Kakudikhai'.

Mythology experts opine that 'Goshani' is a unified goddess of goddess Lakshmi, Saraswati and Kali. However, idols of Ganesh, Kartik, Ganga and Yamuna are also seen near the deity. The unique 'Goshani' PUR culture is indigenous RITAGE WA to Puri and the tradition is nowhere seen in any part

Aruha hill turns mound of misdeeds

With illegal mining, smuggling of minor minerals yet to see a let-up and a crusher unit coming up close to a school with dubious clearances, irregularities galore surround the Aruha hill in Jajpur

POST NEWS NETWORK

Jajpur, Oct 14: Despite many efforts taken by the state government to contain rampant plunder of minor minerals, there has been no let-up in illegal quarrying and smuggling of black stone, murram and soil from Dharmasala tehsil area in Jajpur district.

It has been over a year since the state government established the office of the deputy director of Minor Minerals department in Jajpur district as part of its move to curb the smuggling. However, this has failed to stop the illegal mining and smuggling of minor minerals. Instead, the illegal practice, depriving the state's exchequer of huge earnings, has only flourished over the years.

The Jajpur district administration has directed for deposit of penalty and closure of the quarries after mining of black stones beyond the permissible limit was proved at Aruha black stone mines under the Dharmasala tehsil. However, some unscrupulous miners continue to extract and smuggle murram from the area.

The murram is being used for establishment of a crusher unit named 'Mass', located at about 300 metres from Tarakasuni Primary School in Aruha panchayat. Similarly, the Jajpur Road-Cuttack rail

This has left the local residents surprised as they questioned the wisdom of the district administration in giving permission for establishment of a crusher unit which is likely to cause deafening noise and will lead to air pollution in the area.

Apprehending severe sound and air pollution, over 100 students and their guardians have sought the intervention of the district Collector, demanding to save them from the problem which is likely to impact their health and studies.

Peeved over the development, locals have written to the dis-

trict Collector demanding closure of the illegal black stone quarry and crusher unit and necessary action for violation of norms. They have also forwarded the copies of their complaints to the deputy director of Minor Minerals department, secretary of Steel and Mines department and the regional officer of State Pollution Control Board (SPCB) at Kalinganagar in the district.

According to the complaints, the district administration is yet to collect the penalty which was levied on the concerned leaseholders following satellite mapping held earlier.

However, surprisingly, the district administration has registered a certified case against one of the three leaseholders while the names of two of them have been excluded by allegedly showing them undue favour. It has been alleged that this is in direct contravention of the norms t, for environmental clearance. According to the complaints, two of the quarries BSQ-2 quarry no-1/16-17 and 34/21-22 are situated at a distance of about 300 metres from the primary school. Moreover, three of the quarries BSQ no-1 quarry no-35/21-22 and quarry no-36/21-22 lie at a distance of about 200 metre from the railway line. The presence of the quarry might endanger the railway line anytime as residents expressed concerned over its security.

This apart, four stone crushing units are in operation near these quarries on plot number-2733, 2594, 2704 and 2705 for which the students have been seriously affected by the deafening sound and air pollution emanating from the units.

Residents Nirmal Nayak, Harihar Sahu, Pratap Rana, Anand Behera, Pramod Behera, Anam Behera, Sahadev Rana, Mohan Nayak, Chittarnjan Jena and over 100 others have demanded a proper probe into these irregularities and sought stringent action against the wrongdoers.

Chh'garh Kabbadi player dies during match in Nuapada POST NEWS NETWORK

Nuapada, Oct 14: In a tragic incident, a Kabaddi player collapsed on the court and died just a few minutes before the end of the final match at Tarbod village under Komna block and police limits in Nuapada district, Monday.

The deceased was identified as Khageshwar Rathia, 26, a native of Dumdumchuan village under Sareipali police limits of Mahasamund district in neighbouring Chhattisgarh. A pall of gloom descended in the area after reports of his death spread.

He had arrived here to participate in an inter-state Kabaddi tournament representing Potapara Kabaddi team under Pithora police limits in Mahasamund district of Chhattisgarh.

The tournament was organised on the occasion Durga Puja festival at the weekly market ground in Tarbod village. As many as 24 teams from Nuapada, Bargarh, Bolangir and Chhattisgarh were participating in the tournament.

The incident occurred when Khageshwar was returning to his side after a raid.

He was nearing the midline when he suddenly collapsed on the field and failed to get up. Coplayers and members of the organising committee rescued him and rushed him to the Tarbod primary health centre and later shifted him to the district headquarters hospital after his condition deteriorated. However, doctors pronounced him dead at the district headquarters hospital. Police handed over the body to his family members after conducting a postmortem. Tarbod outpost police registered a case and launched an investigation, OIC Gouri Shankar Das said.

New Hope

new government has come to Jammu and Kashmir after its first election in 10 years, shifting some powers from the Union's nominee, Lt Governor Manoj Sinha, to the Cabinet. This is good news. Much has been made of the fact that this was the fairest election in decades. This is also a positive development but it should be expected that democracies progress rather than regress electorally over time.

Along with free elections and a partial return to self-government, the claim has also been made that Kashmir is now safer than before. This is a complex issue and we need to examine the data here.

Militancy began in Kashmir in the late 1980s. The South Asia Terrorism Portal maintains data on violence across the region. In 1989, a total of 92 people were killed in Kashmir. The next year, violence exploded and took 1,177 lives, of whom 862 were civilians, 132 security forces personnel and 183 militants

The number increased in 1991 (to 1393) and 1992 (1909) and, in 1993, 2,567 people were killed. Of these, the number of civilians (1,023) and security forces personnel (216) remained about the same as before, but the number of militants killed shot up to 1.328. This remained the case for the next few years, though there was also a gradual increase in the number of deaths in the security

forces, which reached 441 in the year 2000 when almost 3,000 people were killed in Kashmir.

This was staggering levels of violence because the population of Kashmir without Jammu is only that of an Indian metropolis (about 5 million, smaller than Bangalore). Fatalities peaked in Kashmir in 2001, when a total of 4,011 people were killed. Of these, 628 were in security forces, 1,024 civilians and 2,345 militants. The next year, 2002, the number dipped for the first time by 1,000 to end at 3,098 dead, and the year after that, meaning 2003, further to 2,507. What explains the dip in fatalities after what was a long-term escalation?

The two events of significance are the 11 September attacks in the US, following which Pakistan said it had become a partner in the "war on terror;" and the attack on the Indian Parliament three months later in December 2001, in which nine Indians and five attackers died.

After the second event, India mobilised for war on the Pakistan front and pressurised Pakistan to act against those sending terrorists over. On 13 January 2002, Pakistan said it had banned Lashkar-e

Taiba (LeT) and Jaish-e-Muhammad (JeM), the two most active and lethal groups in Pakistan. Prime Minister Vajpayee demobilised after the ban.

India has long said since that the ban was a fraud and that Pakistan was not serious about clamping down on terror. It is certainly true that the Pakistan army and its wings have nurtured these groups and used them over time. It is difficult to say, given the opacity with which the Pakistan military establishment functions, whether this has changed We can however look at the data

In Kashmir, from over 4,000 fatalities in 2001, the number went to 3,000 in 2002 and 2,000 in 2003. The number fell again in 2004 to 1,788 and to 1,125 the next year. In 2007, the number fell to under 1,000 (744 killed) for the first time since 1990. It fell further to 548 in 2008, then 373 in 2009. then 181 in 2011. It did not go above 200 in any year till Manmohan Singh left office in 2014

This appears to have shifted somewhat since with fatalities going above 200 in four years, above 300 in two years and above 400 in one year. Last year, 2023, they fell to below 200 again for the first time since 2015, but it would not be wise to see a single data point as a long term indicator.

Consider what has happened in Pakistan in the same period. Though Pakistan had seen extreme levels of violence in Karachi in the 1980s and 1990s, this was violence that was not sectarian but political (between, for instance, the migrants from India, the so-called Muhajirs, and the Pashtuns). In 2000, 2001 and 2002, while Kashmir was burning, Pakistan fatalities from terrorism were 166, then 295 and then 257. In 2003, the year after then president Gen (retd) Pervez Musharraf banned the JeM and the LeT, an assassination attempt was made on him twice. In the first, a bomb was set off as his convoy crossed a bridge, and on Christmas Day 2003, two suicide bombers tried to ram their cars into his convoy. Sixteen people were killed but Musharraf escaped. The next year, fatalities rose sharply to 925, of whom 208 were security forces personnel and 302 militants. In 2006, they reached 1,466. In 2007, another attempt was made on Musharraf's life when his plane was attacked as it was taking off. A total of 3,594 people died that year. This doubled to 6,683 in 2008. In 2009, the most violent year in the history of Pakistan, 11,317 people were killed, including 1,012 security forces personnel and 7,884 militants. In India, in the same period, 373 people were killed in Kashmir as we have seen. In 2010, the Pakistan army began to smother the violence and fatalities fell to 7,342 and then again to 6,050 the following year. In 2013 and 2014, deaths were at 5,000, falling to 3,685 in 2015 and then 1,797 and 1,269 in 2016 and 2017. In 2019, the number went below 400. However, it has since risen to about 1500 a year for each of the last two years The long term trends on violence in Kashmir on the other hand are positive and India must secure these gains further. Free elections are a democracy's best response.

ENRICH-THY-NEIGHBOUR

rith all major trading countries increasingly resorting to unilateral action to advance their own so cial, economic, environmental, and security goals, the world economy desperately needs a clear normative framework to determine the rules of the road. A useful starting point is for everyone to agree, in principle. not to deploy beggar-thy-neighbour policies. This may sound reasonable, but is it feasible? Aren't countries relying on such policies too often to be dissuaded from changing their ways?

Actually, no, they are not. The perception that they are is rooted in a conceptual confusion between policies with adverse cross-border spillovers and policies that truly are beggar-thyneighbour. It would indeed be hopeless - and counterproductive-to try to discipline all policies of the former type. Fortunately, beggar-thy-neighbour actions constitute only a small subset of such policies. Hyper-globalisation floun-

dered largely because of its ambition to overregulate policies with international spillovers. By focusing on genuinely beggarthy-neighbour policies, we can target the real source of the problem and make more headway in international negotiations.

To understand the significance of this distinction, consider the classic case in which one country's policy produces harms abroad, specifically by weakening another country's terms of trade (prices of exports relative to imports). Initially formalized by Jagdish Bhagwati, this "immiserizingtrade" scenario was later used by Paul Samuelson to argue that China's economic growth could hurt the United States.

Consider two policies in particular. First, when the Chinese government subsidises research and development that enhances the country's competitiveness in high-tech products and lowers their prices on global markets, the US and other advanced

economies are hurt, because these are the areas of their comparative advantage. Despite the harm, however, we would not consider it proper to ask China to remove such subsidies, because our intuition tells us that supporting R&D is a legitimate tool to promote economic growth, even if others incur losses The second policy is an export

ban on rare earths or other critical minerals for which China is the principal global supplier. China benefits by increasing prices on world markets and making its exporters more competitive, owing to their access to cheaper inputs. But this is a clear instance of a beggar-thy-neighbour policy. China's gains are the result of an exercise of global monopoly power that forces losses onto foreign producers.

A policy is beggar-thy-neighbour when the benefit provided to the domestic economy is made possible only by the harm that it generates for others. Joan Robinson coined the term in the 1930s to describe policies such as competitive devaluation, which, in a situation of generalised unemployment, shifts employment from foreign countries to the domestic economy. Beggar-thy-neighbour policies are generally negative-sum for the world overall.

Distinguishing beggar-thy-

neighbour policies may be difficult in practice, because no country is likely to own up to them. But clarifying the kinds of actions that are truly objectionable, and narrowing the scope of disputes accordingly, would likely lead to better economic outcomes. It also would make for better politics, because governments would be encouraged to engage in a more productive discussion about what they are doing, why they are doing it, and the likely consequences. Applying this perspective to the real world, one finds that the bulk of industrial policies in China and the US today are not beggar-thy-neighbour.

In fact, many should be considered enrich-thy-neighbour. The clearest example is the broad range of green industrial policies that China has deployed over the last couple of decades to bring down the price of solar and wind power, batteries, and electric vehicles. These policies have been doubly beneficial to the world economy. They generate innovation spillovers, reducing costs for the world's producers and lowering prices for consumers. And they accelerate the transition from fossil fuels to renewables, partly compensating for the absence of carbon pricing.

When industrial policies appropriately target externalities and market failures - as in the

case of green subsidies - they are not something to worry about. Moreover, while we can raise legitimate concerns about cases where these conditions are not met, the fact remains that the costs of inefficient industrial policies are borne primarily at home. It is domestic taxpavers and consumers who pay in the form of higher taxes and prices. Bad industrial policies are less beggar-thy-neighbour than beggar thyself.

Of course, other countries may face costs as well. But that doesn't mean it is desirable for trade partners to have a say. It is neither realistic nor reasonable to expect governments to be more responsive to other countries' arguments about what is good for them than to their own convictions. Trade partners are always free to impose their own safeguards, even when the policies they are responding to are not beggar-thy-neighbour.

For example, if a government is worried about national se curity or adverse consequences for local labour markets, it should have the freedom to introduce export restrictions or tariffs to address these concerns Ideally, such responses will be well-calibrated and targeted narrowly at the stated domestic goal, rather than being designed to punish countries that are not engaged in beggar-thy-neighbour policies

Distinguishing the small number of beggar-thy-neighbour actions from the vast array of other policies with cross-border spillovers is an important first step to easing trade tensions. Doing so would allow international negotiations to focus on the real problems, leaving governments free to pursue legitimate policy goals at home. Working toward a world of selfhelp is largely good economics and good politics.

Han Kang received the Nobel Prize "for her intense poetic prose that confronts historical


FORMER MAHARASHTRA MINISTER BABA SIDDIQUE SHOT DEAD IN MUMBAI, INVESTIGATION **UNDERWAY, SUSPECTS APPREHENDED, POSSIBLE GANG INVOLVEMENT PROBED**

New Delhi, Oct 14: Incarcerated gangster Lawrence Bishnoi (31) alias Balkaran Barar was all of five when the infamous blackbuck poaching case involving Bollywood star Salman Khan took place in 1998 during the filming of "Hum Saath-Saath Hain" in Rajasthan, irking the Bishnoi community which revers the animal.

Twenty-six years down the line, the notorious gangster's deep resentment against Salman even while in prison continues to make headlines, especially after the gunning down of former Maharashtra minister and NCP leader Baba Siddique (66), known to be close to the Bollywood actor, by three assailants in Mumbai last week.

The Mumbai Police suspects Siddique was killed at the behest of Bishnoi after a purported Facebook post surfaced claiming "Jo Salman Khan aur Dawood gang ki help karega apna hisab-kitab laga ke rakhna (whoever helps Salman Khan and the Dawood gang,



keep your accounts in order)".

The comments were posted by one Shubuu Lonkar, whom the police suspect to be Bishnoi gang aide Shubham Rameshwar Lonkar. A senior Delhi Police officer told PTI that the intent of the Bishnoi gang has now gone beyond taking revenge against Salman.

"The gang is now trying to penetrate Bollywood, an area once ruled by Dawood Ibrahim, and set up its own D-Company," the officer said.

Despite being lodged in prison,

Bishnoi has allegedly managed to execute murders of many highprofile people, including Punjabi singer Siddhu Moosewala in 2022. Karni Sena chief Sukhdev Singh Gogamedi in 2023, besides orchestrating firing outside the residences of singers AP Dhillon and Gippy Garewal in Canada, the officer said.

In September 2023, the gang claimed responsibility for the killing of Khalistani sympathiser Sukha Duneke.

The terror-crime-extortion syndicate was also responsible for the **RPG** attack on Puniab State Intelligence headquarters in Mohali in May 2023, allegedly on the directions of Harwinder Singh alias Rinda, a member of the Pakistan-

based pro-Khalistan terror outfit Babbar Khalsa International (BKI). According to the police, the animosity between Bishnoi and

Salman first became public in 2018 when Bishnoi said during a court appearance in Jodhpur. "We will kill Salman Khan. Evervone will know once we take action. I have not done anything as of now, they are accusing me of crimes for no reason."

Since then, the popular actor has received multiple threats to his life, with the matter reaching a tipping point in April this year when gunshots were fired outside Salman's Bandra residence by two shooters reportedly belonging to the Bishnoi gang who were later arrested.

As per Delhi Police records, Bishnoi himself never killed anyone yet he has become one of the most dreaded gangsters, running the gang with "impunity" from a Gujarat prison with a modus operandi similar to that of fugitive underworld don Dawood Ibrahim Kaskar.

According to the National Investigation Agency (NIA), Bishnoi now enjoys a 700-member strong gang spread across the country, including sharpshooters, with the help of other notorious gangsters such as Goldy Brar. Sachin Thapan. Anmol Bishnoi, Vikramiit Singh. Kala Jatheri, and Kala Rana.

Meitei, Kuki, Naga MLAs of Manipur to meet in Delhi

IMPHAL: For the first time since the ethnic violence broke out in Manipur last year, a number of MLAs of Meitei, Kuki and Naga communities are set to hold a ioint meeting in New Delhi Tuesday under the supervision of the home ministry, officials said. Three Naga MLAs will attend the meeting in the national capital, while the exact number of Meitei and Kuki legislators to participate is not yet clear, they said. "The talks are part of the Centre's efforts to facilitate a dialogue between the warring communities and seek a solution to the crisis," an official told PTI. Over 200 people have been killed and thousands rendered homeless in ethnic violence in Manipur since May 2023. "From the Naga side, three MLAs - Awangbou Newmai, L Dikho and Ram Muivah – will be attending the meeting in New Delhi. Bahraich (UP), Oct 14: Scores of people, some armed with sticks, walked along the cortege of a youth killed during a Durga procession here amid cries for justice from his family and others Monday, a day of escalating tensions that saw shops being burnt and angry crowds walking the streets.

The last rites of 22-year-old Ram Gopal Mishra, who died during the communal violence that broke out in Maharajganj area near Rehua Mansoor village in Mahsi tehsil Sunday, were performed amid heavy police presence.

About half a dozen people were injured in stone pelting and firing that followed after Mishra died. Police officials said the internet services have been suspended in Bahraich district as a precautionarv measure.

The sources confirmed three arrests in the case so far and added that a case has been registered against six identified and 24 unidentified persons for murder and other sections of the Bharatiya Nyaya Sanhita (BNS)

About 30 people have been de-



tained in connection with the unrest. Police said raids were on to arrest Salman, who is among the named accused in the case.

There were protests at several places and slogans raised against police and administrative officials, even as police forces conducted flag marches in the area. Black smoke billowed into the sky from some shops, houses and vehicles set ablaze. Munni Devi, mother of Mishra,

China holds military drills around Taiwan

Taipei: China deployed an aircraft carrier, other ships and warplanes in large-scale military exercises surrounding Taiwan and its outlying islands Monday, simulating the sealing off of key ports in a move that underscores the tense situation in the Taiwan Strait. China's Defence Ministry said the drills were a response to the Taiwanese President's refusal to accept Beijing's demand that self-governed Taiwan acknowledge itself as a part of

the People's Republic of China under the rule of the Communist Party. The drills came four days after Taiwan celebrated the founding of its government on its National Day, when Taiwanese President Lai Ching-te said in a speech that China has no right to represent Taiwan and declared his commitment to "resist annexation or encroachment.'

Texas, Oct 14: SpaceX in its fifth Starship test flight Sunday returned the rocket's towering first stage booster back to its Texas launch pad for the first time using giant mechanical arms, achieving another novel engineering feat in the company's push to build a reusable

moon and Mars vehicle. The rocket's first stage "Super Heavy" booster lifted off at 7:25 am CT (1225 GMT) from SpaceX's Boca Chica, Texas launch facilities, sending the Starship second stage rocket toward space before separating at an altitude of roughly 70 km to begin its return to land, the most daring part of the test flight.

The Super Heavy booster relit three of its 33 Raptor engines to slow its speedy descent back to SpaceX's launch site, as it targeted the launch pad and tower it had blasted off from. The tower, taller than the Statue of Liberty at over 400 feet, is fitted with two large metal arms at the top. With its engines roaring, the 71 metres, tall Super Heavy booster fell into the launch

tower's enclosing arms, hooking itself in place by tiny, protruding bars under the four forward grid fins it had used to steer itself through the air. "The tower has caught the rocket!!" CEO Elon Musk wrote on X after the catch attempt.

SpaceX engineers watching the company's live stream roared in applause. The novel catch-landing method marked the latest ad-

vance in SpaceX's test-to-failure development campaign for a fully reusable rocket designed to



loft more cargo into orbit, ferry humans to the moon for NASA and eventually reach Mars, the ultimate destination envisioned by Musk.

Meanwhile Starship, the rocket system's second stage or top half, cruised at roughly 17,000 miles per hour 89 miles up in space, heading for the Indian Ocean near western Australia to demonstrate about 90 minutes into flight a controlled splashdown. As Starship reentered Earth's

atmosphere horizontally, onboard cameras showed a smooth, pinkish-purple hue of superhot plasma blanketing the ship's Earth-facing side and its two steering flaps, intense hypersonic friction displayed in a glowing aura. The ship's hot side is coated with 18,000 heat-shielding tiles that were improved since SpaceX's last test in June, when Starship completed its first full test flight to the Indian Ocean but suffered tile damage that made its reentry difficult.

Starship this time appeared more intact upon re-igniting one of its six Raptor engines to position itself upright for the simulated ocean landing. The SpaceX live stream showed the rocket touching down in the nighttime waters far off Australia's coast. then toppling on its side, concluding its test mission.

G20 summit: Ukraine urges Brazil to arrest Putin

The Hague: Ukraine's top prosecutor said he had received intelligence indicating that Russian President Vladimir Putin may attend the G20 summit in Brazil next month, and called on authorities there to carry out a warrant for his arrest if he showed up. The International Criminal Court (ICC) in The Hague issued a warrant for



Putin in March 2023, roughly a year after Russia's full-scale invasion of Ukraine, accusing him of the war crime of deporting children. Russia denies allegations of war crimes and the Kremlin has dismissed the ICC warrant as "null and void". When asked if a decision had been made on whether Putin would attend the meeting of the world's 20 leading economies, Kremlin spokesman Dmitry Peskov told reporters Monday: "No. When a decision is made, we will let you know."

North Korea to blow up border roads with South

Seoul: North Korea is getting ready to blow up roads that cross the heavily militarised border with South Korea, Seoul said Monday, amid an escalating war of words after the North accused its rival of sending drones over its capital Pyongyang. North Korean troops were working under camouflage on the roads on their side of the bor-



der near the west and east coasts that are likely preparations to blow up the roads, possibly as early as Monday, South Korea's military spokesman said. North Korea Friday accused South Korea of sending drones to scatter a "huge number" of anti-North leaflets over Pyongyang, in what it called political and military provocation that could lead to armed conflict. Lee Sung-iun, a spokesman for the South's Joint Chiefs of Staff, declined Monday to answer questions over whether the South Korean military or civilians flew the drones.

WHO prequalifies first mpox vaccine

Geneva, Oct 14: The WHO said Friday it had for the first time prequalified a mpox vaccine, a move expected to speed up access to the jabs to fight an epidemic raging in Africa.

The announcement came on the heels of the arrival of the first MVA-BN vaccines to the Democratic Republic of Congo (DRC), the epicentre of the epidemic.

"This first prequalification of a vaccine against mpox is an important step in our fight against the disease, both in the context of the current outbreaks in Africa and in future," WHO chief Tedros Adhanom Ghebreyesus said in a statement.

We now need urgent scale up in procurement, donations and rollout to ensure equitable access to vaccines where they are needed most to prevent infections, stop transmission and save lives

WHO's prequalification listing is used to evaluate the quality. safety and efficacy of medical



products like vaccines, paving the way for the United Nations and other international agencies to procure them.

The list is also used by lowerincome countries without the means to carry out their evaluations to fast-track procurement approvals. The WHO declared an international emergency over mpox last month, concerned by the surge in cases of the new Clade 1b strain in the DRC that

spread to nearby countries. DRC has recorded nearly 22,000 cases and 716 deaths linked to the virus since January.

So far, some 200,000 vaccine doses have been delivered to the DRC by the European Union. along with about 50,000 from the United States.

Li's visit is the first by a Chinese premier to Pakistan in 11 years, Pakistan's Prime Minister's Office said. Pakistan's Prime Minister Shehbaz Sharif received Li at the airport.

Lahore: Pakistan's law enforcement agencies have arrested more than 200 workers of Imran Khan's party in the Puniab province to thwart its planned protest in Islamabad during the SCO summit, police said Monday. The Pakistan Tehreek-e-Insaf (PTI) had announced to hold a demonstration at the D-Chowk in the capital during the two-day Shanghai Cooperation Organisation summit that is scheduled to begin Tuesday. "We have intensified the crackdown against active members of the PTI in different parts of the province and arrested over 200," a senior police officer told PTI. The officer said more arrests are likely by Monday night as there has been a strict order from the government to stop the PTI workers from reaching Islamabad from Punjab.

Israel kills 21 in north Lebanon

Beirut, Oct 14: An Israeli airstrike hit an apartment building in northern Lebanon Monday, killing at least 21 people, according to the Lebanese Red Cross.

There was no immediate comment from the Israeli military and it was not clear what the target was. The strike hit a small apartment building in the village of Aito, which is part of the country's Christian heartland in the north and far from the Hezbollah militant group's main areas of influence in the south and east. Videos from Lebanese media showed a large plume of smoke rising from the hilly village, with several destroyed cars next to a severely damaged building, as people tried to remove bodies from beneath rubble and trees

The strike came a day after a Hezbollah drone attack on an army base in northern Israel killed four soldiers, all of them 19 years old, and severely wounded seven others in the deadliest strike by the militant group since Israel launched its ground invasion of Lebanon nearly two weeks ago. On Monday, Prime Minister Benjamin Netanyahu visited the army base and soldiers injured in the attack, vowing that "we will continue to strike Hezbollah without compassion in every part of Lebanon, including in Beirut."

Earlier Monday, an Israeli airstrike on a hospital courtyard in the Gaza Strip killed at least four people and triggered a fire that swept through a tent camp for people displaced by the war, leaving more than two dozen with severe burns.

The Israeli military said the strike in Gaza targeted militants hiding out among civilians, without providing evidence. In recent months it has repeatedly struck crowded shelters and tent camps, alleging that Hamas fighters were using them as staging grounds for attacks.

New Delhi, Oct 14: India, the world's third largest oil importing and consuming nation, saved ₹1.06 lakh crore in foreign exchange during the last decade by mixing biofuels in petrol, Oil Minister Hardeep Singh Puri said Monday

Speaking at the CII Bioenergy Summit here, he said the percentage of ethanol, extracted from sugarcane and other biomass, blending in petrol has risen from 1.53 per cent in 2014 to 15 per cent.

Encouraged by these results, the government has advanced its target to 20 per cent blending for 2025, he said.

"From 2014 to August 2024, ethanol blending (in petrol) has generated foreign exchange savings of ₹1,06,072 crore, reduced CO2 emissions by 544 lakh tonnes, and achieved crude oil substitution of 181 lakh tonnes,' he said.

Additionally, the government has set an ambitious targets for Sustainable Aviation Fuel (SAF), aiming for 1 per cent blending in 2027 and 2 per cent in 2028, positioning India as a leader in bio-mobility

Emphasising on India's robust economic growth, he said



the country will drive 25 per cent of global energy demand over the next two decades.

Bioenergy will be crucial in meeting this demand while advancing climate goals and rural development.

Currently valued at \$44 billion (as per Wood Mckenzie), the minister said that the bioenergy market is projected to grow to \$125 billion by 2050. If global net-zero targets are achieved, this figure could surge to \$500 billion, he added.

RE output zooms

New Delhi: Led by solar and wind energy, India has crossed the 200 gigawatt (GW)-mark in renewable energy (RE) production in the month of September. As per latest data from the Central Electricity Authority (CEA), the renewable energy-based electricity generation capacity (including small and large hydro, biomass and cogeneration and waste-toenergy) crossed the 200 GWmark in September. The total **RE** production reached 201,457.91 MW, driven by solar at 90,762 MW and wind energy production at 47,363 MW. The country's total non-fossil fuelbased power capacity now stands at 46.3 per cent of the total installed electricity generation capacity.

Realty deals shine

New Delhi: The Indian real estate sector saw 25 deals worth \$1.4 billion in September quarter, driven by Qualified Institutional Placement (QIP) issues launched by developers. according to a report by Grant Thornton. Consulting firm Grant Thornton Bharat released the report 'Real Estate/ REITs Dealtracker -Providing M&A and PE deal insights' Monday. "The quarter maintained strong deal volumes with 25 deals, marking an all-time high in terms of deal volumes and the second-highest values since Q2 2023," the report said.

New Delhi, Oct 14: Gold prices rose ₹200 to revisit the all-time high of ₹78,700 per 10 grams in the national capital Monday on persistent buying by stockists and traders even as the precious metal lost steam globally, according to the All India Sarafa Association.

The yellow metal had closed at ₹78,500 per 10 grams Friday. Silver jumped ₹500 to ₹93,500 per kg on the back of fresh industrial demand. It had ended at ₹93,000 per kg in the previous close. Additionally, gold of 99.5 per cent purity climbed by ₹600 to reclaim its all-time high level of ₹78,300 per 10 grams.

The metal had finished at ₹78,100 per 10 grams.

Earlier, gold prices hit a record ₹78,700 per 10 grams October 7. Despite a weak trend overseas, the precious metal gained in the domestic market, mainly due to an increase in demand

from jewellers, traders said. In futures trade on the Multi Commodity Exchange (MCX), gold contracts for December delivery declined by ₹207 or 0.27 per cent to trade at ₹76.100 per 10 grams.Silver contracts for December delivery plummeted ₹929 or 1.01 per cent to ₹90,761 per kg on the MCX.

Bangalore, Oct 14: India has a plan to carve out a beachhead in the battle for commercial space, officials say: crunching space data, building small satellites and launching them cheaply into orbit rather than challenging heavyweights such as SpaceX head-on. In particular, it is taking aim

at providing cost-effective services and hardware to sectors such as communications, agriculture and commodities, where high-quality data is a precious resource



worth \$14.54 billion by 2031, and a related data services market pegged at \$45 billion by 2030.

Since February, India has opened its space sector to private players and created ₹10 billion venture fund to support space startups. It has also unveiled plans for crewed space exploration and a mission to Venus, but the focus is on developing commercial ventures

In many ways it will be an uphill fight. Other countries such as Japan and China have advanced space industries, and designs on cheap launches. Spaceflight itself is difficult; the startup landscape globally is littered with failed boosters and satellite designs.

For India, "the tech is there and the ability is there... but space is tricky and very competitive, and while private companies have shown that they can create a niche for themselves, we need more proof of concept," said Namrata Goswami, a space policy expert at Arizona State University

The space downstream market is, at the end of the day, a software play," said Aravind Ravichandran, founder of France-based advisory firm Terrawatch Space.

The consultancy Euroconsult forecasts that between 2023 and 2032, about 26,104 small satellites - weighing less than 500 kilogrammes (1,100 lb) - will be put in orbit, averaging 1.5 tons of daily launch mass. The firm expects the overall small satellite industry to be worth \$110.5 🛁 billion in the next decade.

But India has only about 2% of market share in commercial space activities, demand is still largely dependent on global clients, and well-established US, Russian and Chinese companies are formidable rivals.
