### Hamas chief dead: Israel

Jerusalem: Hamas leader Yahya Sinwar, mastermind of the October 7, 2023 attack that triggered the Gaza war, has been killed by Israeli forces in the Palestinian enclave, Israel said Thursday. The Israeli military said it had killed Sinwar, 62, in an operation in the southern Gaza Strip Wednesday. "After completing the process of identifying the body, it can be confirmed that Yahya Sinwar was eliminated," it said

### Saini takes oath as Haryana CM

Chandigarh, Oct 17: Nayab Singh Saini, the proverbial dark horse who became star of the BJP's victory in the Haryana Assembly elections, was sworn in as Chief Minister of the state Thursday in a grand ceremony attended by Prime Minister Narendra Modi and a galaxy of leaders, including Odisha Chief Minister Mohan Charan Majhi.

Thousands of people packed into the Dussehra Ground to watch Governor Bandaru Dattatreya administer the oath of office to the low profile OBC leader and 13 oth-

ers. For the BJP, the messaging was not just in its show of strength with a power-packed dais seating its CMs, ministers and NDA part-

ners but also in its choice of the day - Valmiki Jayanti.

Sage-poet Valmiki is the author of the Hindu epic Ramayana and a revered figure, especially among Dalits. The PM congratulated Saini and his ministerial colleagues on their swearing-in and described the team as a wonderful mix of good governance and experience. "This government will realise the dreams of people and take the state's development to a new high," he said in a post on X in Hindi.

"I am confident that the double engine government will leave no stone unturned in serving the poor, farmers, youths and women besides all other sections of society," Modi said.

### State reconstitutes task force for NEP

Bhubaneswar, Oct 17: The state government Thursday reconstituted the task force for proper implementation of the National Education Policy (NEP), 2020, official sources said.

According to the School and Mass Education (S&ME) department, the 13-member task force will be headed by the Development Commissioner.

Principal Secretaries of S&ME, ST and SC Development, Minorities and Backward Classes Welfare, PR and DW, Finance, W&CD, Skill Development and TE. Sports and Youth Services departments are among the members of the task force.

"Further, six thematic subcommittees have been reconstituted to deal with different components of NEP, 2020 with representatives from other departments and directorates functioning under the S&ME department, and experts in the field of education as special invitees,' according to a notification issued by the S&ME department. "The chairperson may invite other experts/relevant persons to participate in any particular meeting of the committee/sub-committee for discussion in any specific issues on the smooth implementation of NEP, 2020," it added.

Notably, the state government had in October 2020 formed a task force and six sub-committees to study the NEP, 2020 and submit its recommendations to the Centre.

# Citizenship Act Sec 6A valid: SC Hooch kills 25 in Bihar

A Constitution Bench of the Supreme Court, in 4:1 majority, upheld the validity of Section 6A of the Citizenship Act, 1955 that confers citizenship to immigrants, especially from Bangladesh, who entered Assam on or after January 1, 1966 but before March 25, 1971. The contentious provision was added to the Act following the signing of the 1985 Assam Accord between the then Rajiv Gandhi government at the Centre and various agitating groups in the northeastern state, which has long been embroiled in controversies surrounding citizenship and illegal immigration.

New Delhi, Oct 17: In a significant judgement, the Supreme Court Thursday upheld the constitutionality of Section 6A of the Citizenship Act which grants Indian citizenship to immigrants from specified territories, including Bangladesh, who entered

Assam on or after January 1, 1966 but before March 25, 1971. Chief Justice of India (CJI) DY

Chandrachud and Justices Surya Kant, MM Sundresh, and Manoj Misra further underscored the necessity for more robust policy measures to curb illegal immigration. Section 6A was inserted in 1985 into the Citizenship Act of 1955 following the signing of the Assam Accord between the then Rajiv Gandhi government at the Centre and the agitating groups led by Prafulla Mahanta including All Assam Students Union in the state. The verdict is believed to give a boost to those opposed to grant of Indian citizenship to immigrants who en-

tered Assam after March 25, 1971. According to the provision, all those who came to Assam on or after January 1, 1966 but before March 25, 1971 from specified territories including Bangladesh at

the time of commencement of the Citizenship (Amendment) idents of Assam, can register for Indian citizenship. As a result, the provision fixes March 25, 1971 as the cut-off date for granting citizenship to migrants, particularly those from Bangladesh, re-

siding in Assam. While the CJI, Justices Kant. Sundresh, and Misra upheld the constitutional validity of Section 6A, Justice JB Pardiwala dissented in a minority verdict. Holding the cut-off date of March 25, 1971 as rational, the C.J., writing for himself, said Section 6A was included with the objective of reducing the influx of migrants to India and dealing with those who had already migrated. The C.II said Section 6A was not violative of Articles 6 and 7 of the Constitution, which stipulates a cut-off date for conferring citizenship to migrants from east and west Pakistan at the "commencement of the Constitution".

#### **CONG SLAMS NDA GOVT, SAYS TRADE OF SPURIOUS LIQUOR RAMPANT**

Patna, Oct 17: In one of the biggest hooch tragedies in Bihar since the state went dry in 2016, at least 25 people have died after consuming spurious liquor in Siwan and Saran districts, a top officer said Thursday.

DGP Alok Raj said that while Siwan accounted for 20 fatalities, five deaths have been reported from Saran even as 12 people have been arrested for allegedly selling spurious liquor and they were likely to be 'tried under the most stringent laws and punished by the court'.

According to officials in the two districts, tragedy befell Maghar and Auriva panchavats of Siwan and Mashrakh in Saran Tuesday night when a number of locals treated themselves to liquor. The officials also said that more than 20 people were still battling for life at hospitals, many of them



having lost their eyesight as a side effect of the spurious liquor.

The Congress slammed the NDA dispensation over the fatalities.

In a post in Hindi on X, Kharge said, "So far, 36 people have died due to spurious liquor in 16 villages of Siwan and Saran in Bihar, which is extremely painful and saddening." "The opportunistic double (engine) government in Bihar is responsible for taking the lives of hundreds of people!" he added.

Congress leader Privanka Gandhi Vadra also hit out at the NDA government over the fatalities, saying liquor ban is in force in the state but illegal trade of spurious liquor is rampant.

## 237-yr-old copy of US Constitution up for auction

Washington, Oct 17: A rare copy of the US Constitution, printed 237 years ago and sent to the states to be ratified, is being auctioned in North Carolina starting 03:30 am IST October 18. Brunk Auctions is selling the copy — the only of its type thought to be in private hands. The minimum bid of \$1 million has already been made.

This copy was printed after the Constitutional Convention finished drafting the proposed framework of the nation's government in 1787 and sent it to the Congress of the ineffective first American government under the Articles of Confederation, requesting they send it to the states to be ratified by the people.

It's one of about 100 copies printed by the secretary of that Congress, Charles Thomson.



Just eight are known to still exist and the other seven are publicly owned.

Thomson likely signed two copies for each of the original 13 states, essentially certifying them. What happened to the document up for auction between Thomson's signature and 2022 is not known.

Two years ago, a property

in eastern North Carolina that

was once owned by Samuel Johnston. He was the governor of North Carolina from 1787 to 1789 and oversaw the state convention during his last year

in office that ratified the Constitution.

The copy was found inside a

squat, two-drawer metal filing cabinet with a can of stain on top, in a long-neglected room piled high with old chairs and a dusty book case, before the old Johnston house was preserved.

The document was a broad sheet that could be folded one time like a book.

Along with the Constitution on the broad sheet printed front and back is a letter from George Washington asking for ratification. He acknowledged there will have to be compromise and that rights the states enjoyed will have to be given up for the nation's long-term health.

Auction officials are not sure what the document might go for because there is so little to compare it to. The last time a copy of the Constitution that was sent to the states sold, it was for \$400

In 2021, Sotheby's of New York

sold one of only 14 remaining copies of the Constitution printed for the Continental Congress and delegates to the Constitutional Convention for \$43.2 million, a record for a book or document.

Other items up for auction in Asheville include a 1776 first draft of the Articles of Confederation and a 1788 Journal of the Convention of North Carolina at Hillsborough where representatives spent two weeks debating if ratifying the Constitution would put too much power with the nation instead of the states.

The auction was originally set for September 28, but the auction house delayed it after Hurricane Helene caused catastrophic damage through Asheville and the rest of the North Carolina mountains.

# No cyclone, heavy rains likely Oct 24, 25: IMD DG

### COASTAL DISTRICTS TO EXPERIENCE 60 KPH WIND DUE TO DEPRESSION OVER BAY

Bhubaneswar, Oct 17: Coastal districts of the state are likely to receive heavy rainfall October 24 and 25 due to a depression over the Bay of Bengal, even as DG, India Meteorological Department (IMD) Dr Mrutyunjaya Mohaparta Thursday allayed fears of a cyclone during that period.

Speaking to Orissa POST, Mohapatra said that a cyclonic circulation is likely to form over the Andaman Sea around October 20. "Due to its impact, a low pressure area will form over east-central Bay of Bengal October 22," he said. It will turn into a depression and move in north-west direction over the Bay of Bengal October 24.

Mohapatra said due to the impact of the low pressure, light rain fall activity will begin October 23 which will intensify by October 24 and 25. "Most of the coastal districts will receive heavy rains during these two days," he said.



Asked if the state was bracing for a cyclone, as reported in a section of the media, Mohapatra said, "It is too early to predict anything now. As per our predictions so far, there is likelihood of a depression froming over the Bay of Bengal by October 24 which will cause heavy rainfall. Due to the depression wind speed up to a maximum velocity of 60 kph will be experienced," he

Bhubaneswar Thursday issued warning regarding a fresh upper cyclonic circulation that is likely to form over the north Andaman Sea around October 20.

For Friday, the IMD forecast that light to moderate rain/thundershower is very likely to occur at one or two places over the districts of Mayurbhanj, Keonjhar, Balasore, Bhadrak, Jajpur, Cuttack, Kendrapara, Jagatsinghpur, Khurda, Puri, Ganjam, Gajapati, Rayagada, Kalahandi, Koraput, Malkangiri, Nawarangpur districts. Dry weather is very likely to prevail over the rest districts, it said.

On Saturday, thunderstorm with lightning is very likely to occur at isolated places in the districts of Balasore, Bhadrak, Jajpur, Kendrapara, Cuttack, Jagatsinghpur, Puri, Khurda, Nayagarh, Ganjam, Gajapati, Mayurbhanj, Keonjhar, Rayagada, Kalahandi, Nawarangpur, Koraput, Malkangiri, it added.

filed a complaint at the Bharatpur police station, which was not registered. He then approached a Bhubaneswar court, seeking its

intervention, police said. On the directive of the court, the Bharatpur police registered a case October 12 and started an investigation, they said.

The case was filed against Kumar, former state Congress

president Sarat Pattanayak and senior party leader Biswaranjan Mohanty, a police officer said.

As per the complaint, the

Bhubaneswar-based businessman had entered into a deal with Kumar and Pattanayak to supply LED TVs and vehicles for campaigning during the Lok Sabha and Assembly elections in the

The deal was finalised for ₹1.5 crore, but the Congress leaders allegedly denied him payment of ₹1.42 crore after the polls, the officer said.

Reacting to the allegations, Pattanayak said he was not aware of the matter and did not sign any such agreement.

"A particular group of people has conspired to defame me,' he alleged.

Mohanty added: "The allega-

## Fake call centre gang earned ₹1L per month

Bhubaneswar, Oct 17: A six-member cyber criminal gang which was busted by the Commissionerate Police Wednesday for running a fake call centre out of a rented apartment in Sundarpada area, generated a monthly income of ₹1 lakh from their con act, Deputy Commissioner of Police, Pinak Mishra said Thursday.

He said the disclosure came during the interrogation of the leader of the gang, Haider Ali, who said the money was raised by his team by sending fraudulent emails to clients, impersonating as customer care agents and providing fake phone numbers to induce them into making fraudulent transactions.

Mishra said preliminary investigations revealed that the accused were sending these fake emails to both national and international clients who had subscribed to var-



ious antivirus software, posing as customer care representatives for two antivirus companies.

Additionally, police discovered that the six accused were using laptops and mobile phones to make and receive calls from US citizens via Skype.

A local court remanded Haider Ali, 34, and his five associates

Sameer Mobin, 26, Md Javed Hussain, 26, Md Tosif, 23, Faizan Alam. 24 and Shaaib Raza.22 – all from West Bengal, to 14-day judicial custody Thursday.

Briefing reporters, Mishra said, "We have requested the court to allow us five-day remand of the accused to get more details from them. Some investigation agencies have also contacted us to interrogate them.

Police are currently working to identify the local contacts in Odisha who helped the accused to operate the fake call centre. "Investigations are also underway to determine how many people have fallen victim to the gang and the extent of the fraudulent activities involved," he said.

Six laptops, 11 mobile phones, routers and cables were seized from the possession of the accused during the raid by the cyber police.

Mishra said the seized electronic devices have been sent for forensic analysis and a police team will be dispatched to Kolkata to verify the suspects' details.

He said the cyber sleuths will grill the six men to uncover their alleged role related to various aspects of the case, such as anti-national activity, financial fraud, and money-laundering among others.

# Water crisis threatening world food production, says report



Report says urgent action needed to conserve resources and save ecosystems that supply fresh water

New Delhi, Oct 17: The water crisis could jeopardise more than half of the world's food production and cause an average global GDP loss of 8 per cent by 2050, with lower-income countries facing up to a 15 per cent loss, according to a new report.

The report by the Global Commission on the Economics of Water, an international group of leaders and experts, said that weak economic systems, destructive land use, and the persistent mismanagement of water resources, combined with the worsening climate crisis, have placed the global water cycle under unprecedented stress.

"The water crisis threatens more than half of the world's

economies and its role in preserving critical ecosystems.

The underpricing of water globally has encouraged its excessive use and led to the misplacement of water-intensive industries, such as data centres and coal-fired power plants, in areas most vulnerable to water

Proper pricing, subsidies, and other incentives are needed to ensure water is used more efficiently in every sector, equitably across populations, and sustainably in the long term, the report said.

"The global water crisis is a tragedy, but it also presents an opportunity to transform the economics of water. We must start by properly valuing water to recognise its scarcity and the many benefits it provides," said Ngozi Okonjo-Iweala, Director-General of the World Trade Organisation and a co-chair of the commission.

The report also said that current approaches focus primarily on visible water sources, such as rivers, lakes, and aquifers, while neglecting the importance of 'green water' - moisture in soils and plant life, which is vital for maintaining stable rainfall patterns and supporting the storage of carbon in the soil.

A stable supply of 'green water' is critical for maintaining steady rainfall patterns, which are essential for economies, livelihoods, and mitigating climate change, the re-

The introduction of short-acting opioids and advanced inhalation agents has helped patients experience less drowsiness and postoperative nausea," she added

The passengers, Tushar Priyadarshi and his wife, had come from Bangalore and had hired a taxi in Bhubaneswar to visit Joda in Keonjhar district

When the taxi reached near Panikoili on NH-16 Wednesday night, Tushar asked the driver to stop the vehicle near a hotel

After the couple returned to the vehicle post-dinner and left the hotel, they found their gold jewellery including a chain, three pairs of earrings, a diamond ring and ₹2,000 in cash missing from their bag, a police officer said.

Priyadarshi asked the driver to take them back to the hotel, where they narrated the ordeal to the hotel owner.

As the driver saw the owner checking the footage of a CCTV camera installed in front of the hotel, he dumped the luggage of the passengers and sped away with the vehicle towards Chandikhole on NH-16, the officer said.

"We have arrested the driver and registered a case under relevant sections of BNS and seized his taxi," Panikoili police station Inspector-in-Charge Ranjan Kumar Pradhan said.

He also demonstrated how he buried some of the body parts near the water body and dumped the rest parts in the fish tank.

The probe indicated that Gurupada was not on good terms with his wife and mother-in-law for the past few months and always quarreled with them at the slightest pretexts. His wife had deserted him and was living outside the state. The incident occurred when she had come home to apply for Subhadra Yojana.

The dispute between Gurupada, his wife and motherin-law over domestic issues and misappropriation of money took an explosive turn. September 27. Kasuhalya and his mother Jamuna were returning home after applying for Subhadra Yojana when Gurupada waylaid and attacked them with sharpedged weapons, SDPO Saurav Otta said.

## Jumbo squad staff trampled to death during operation

Keonihar, Oct 17: An official of elephant squad was trampled to death while driving an elephant herd into the forest near Jharbeda village in Naranpur section of Keonjhar sadar range late Wednesday night. The deceased has been identified as Basanta Mahanta (45) of Gobindapur village.

The incident occurred when Basanta was engaged with other squad members in an operation to drive away an elephant herd. An atmosphere of fear and tension is gripping the area following the death.

According to sources, a herd of six elephants had entered the farmlands near Jharbeda village and destroyed the paddy crop. Acting on a tip-off, Sadar Range officer Ajit Kumar Das along with the elephant squad staff went to the area to chase away the elephants.

During the operation, a tusker got separated from the herd and suddenly chased the forest staff. While all the forest officials ran away, Basant fell to the ground. The tusker dragged him with its trunk and trampled him. Later, Forest department personnel rescued him in a critical condition and brought him to



Keonihar district headquarters hospital, where the doctor declared him dead.

"The tusker got separated from the group and attacked at once. He couldn't pay attention to that. That's why such an incident happened. Compensation will be given in case of crop loss. Therefore, villagers are being cautioned not to try to chase the herd away," said Dhanraj HD, Divisional Forest Officer, Keonjhar.

'Care will be taken to ensure that no untoward incident takes place further and the staff or common people are not harmed," the DFO said.

"The deceased elephant squad member will get an ex-gratia of ₹1.52 lakh from the service provider and ₹6 lakh from the government. The wife of the deceased will get a minimum pension of ₹2,000 and their daughter will get ₹500 per month once she turns 18," he added.

'The compensation amount is less than the actual losses forcing people to remain on guard always to protect their wealth and crops," said Bhagirathi Nayak, a farmer and tribal leader.

Sources said massive deforestation is taking place as there is no ban on illegal felling of trees. Every year, more and more forest land is being used for non-forestry purposes such as mining operations. Also, an increase in elephant population in Keonjhar division has given rise to elephant-human conflicts.

On the other hand, it is alleged that such incidents are occurring due to lack of proper training and management.

### Eggs hurled at ex-Dharmasala MLA's vehicle

Jajpur, Oct 17: Tension erupted in Jajpur district Thursday after some youths hurled eggs at the vehicle of BJD leader and former Dharmasala MLA Pranab Kumar Balabantaray.

Balabantaray was elected to the Assembly from Dharmasala seat on BJD tickets in 2014 and 2019 and is perceived to be close to the party leadership.

### NTPC defers ash pond hearing after protests

Rourkela, Oct 17: Following massive protest by villagers. National Thermal Power Corporation (NTPC) has postponed a proposed 'public hearing' scheduled for Friday. The protest was led by sarpanch Nalini Singh and had the full support of local MLA Jogesh Singh. Singh has been spearheading

the protest for the last several days calling for postponement of the public hearing. The villagers were alleging that the administration was not listening to the request of MLA Singh and was planning to go ahead with the meeting Friday.

Meanwhile, it is learnt that NTPC has agreed and finally postponed the public hearing till mid-November. NTPC authorities could not be contacted in this regard. However, the MLA confirmed that NTPC has postponed the public hearing for at least one month.

Public resentment grew when the PSU wanted to construct an ash pond near Darlipali. The villagers, especially those staying in three nearby hamlets, were part of the protest against the ash pond along with Darlipali residents. They demanded the pond should come up at least 500 metres away.

"The NTPC in violation of rules constructed the ash pond



just 200 metres away from Barobega village. People residing there are suffering due to severe pollution," said Singh.

Besides, the MLA made it clear that NTPC should first listen to the public grievances and then hold a public hearing; else no pond would be allowed in the vicinity. "The NTPC is not paying heed to the public demand. My point is public interest should be protected," said the MLA.

"Now NTPC has agreed to postpone it and it will be held next month. But our point is to shift it to a minimum of 500 metres away from the locality," he added.

The other proposal given to NTPC is to shift the villages and settle them elsewhere and then construct the ash pond there.

"The state government has also written to the NTPC in this regard and the proposal will be sent to the NTPC headquarters for shifting the villages," said Singh. If the second proposal is accepted then nearly 150 families will be displaced.

"The police have cracked down on gam-

bling in different areas in the district. We can't allow gambling in the name of tradition," Berhampur Superintendent of Police Saravan Vivek M said.

Ganjam SP Suvendu Patra said he has already instructed the police officers to launch a special drive and crack down on gambling dens. The drive would be continued for some more days, he said.

Notably, Ganjam district consists of two police districts — Berhampur and Ganjam.

### **Promise & Peril**

n a landmark report, the Global Commission on the Economics of Water recently identified water markets as a fundamental solution L to the world's escalating climate-driven water crisis. The logic is simple: When something is scarce, it becomes more valuable. By pricing water appropriately and creating markets to allocate water based on demand, we could promote more efficient use and incentivise conservation. Yet while the concept of water markets appears promising, Chile, Australia, the United States, and other countries' experiences show that implementation can prove challenging.

Water markets have been heralded for their ability to allocate water more efficiently. When individuals or organisations are allowed to trade water rights, water is allocated to those who value it most. In Chile, one of the first countries to implement a national water market, agricultural producers can purchase water from other regions or industries that have a surplus. Owing to this flexibility, the system allows for highvalue crops to flourish even during droughts.

By helping to reduce inefficient water use, Chile's water market boosted agricultural productivity over time. Between 1985 and 2018, waterintensive agriculture in the Atacama and Coquimbo regions grew significantly as water markets allowed for

more flexible allocation to high-demand The same principle has been applied in Australia's Murray-Darling Basin, where farmers trade water rights to adapt to fluctuating water availability. As Bloomberg re-

ports, the water trade in Australia is about AU\$4 billion per year (\$2.7 billion) and has made Australia the ninth-largest food exporter in the world. The same markets can also incentivise water conservation. California's Central Valley also allows agricultural water trading, enabling farmers to cope with periodic droughts by purchasing water from more resource-rich

But Chile's experience also highlights the pitfalls of water markets. Far from being a panacea, Chile's water market has led to significant inequalities. Large agribusinesses have acquired substantial water rights, leaving smaller farmers and communities with little access. With wealthier players dominating the market, marginalised communities are priced out.

Such outcomes raise serious equity concerns. Water is not just an economic com-

modity; it is a basic human right. A system that allows the wealthiest to buy up the most water risks undermining access for those who need it most. After water rights in northern Chile's Limarí Valley were consolidated among a few large agricultural companies, smallholders lacked sufficient water during dry years. And similar trends have been observed in California, where a small proportion of water-rights holders control a significant amount of available water, disproportionately benefiting large-scale agriculture.

Moreover, water markets can lead to environmental degradation. In Chile, diverting water to agricultural use has at times compromised the ecological health of rivers and wetlands. In Australia, over-extraction of water has led to severe environmental consequences, including the collapse of river ecosystems and the depletion of surface water and groundwater resources, threatening biodiversity.

California has encountered similar challenges. Although water trading has helped balance supply and demand in some regions, it has also exposed deep inequities. The Central Valley's small-scale farmers struggle to compete with larger agribusinesses for water, while poorer urban communities face higher water prices. In times of drought, the market-driven system tends to favour those who can afford to pay leaving behind the most vulnerable populations.

Speculative water hoarding is also a growing problem. In California, some entities have withheld water from the market, waiting for prices to rise, effectively turning water – a vital resource – into a financial asset. This has contributed to localised shortages and driven up prices in already water-stressed areas.

Beyond market failures, there are deeper issues of equity and justice to consider. Wealthier entities' ability to buy up rights means that water markets are prone to monopolisation. This has been a persistent issue in Chile, where large agribusinesses and mining companies corner the market, especially in drought-prone areas.

Another challenge is that water markets often clash with traditional or prior water rights, leading to legal and social conflicts. In Chile, prior rights holders, including indigenous communities, have suffered displacement as water rights have been commodified and sold off to larger entities. Such injustices raise fundamental questions about the ethics of commodifying a resource that many communities view as a


More broadly, implementation of water markets is a fraught, complex process. Transboundary water conflicts - where water sources cross regional or national borders - are a growing concern. Markets that allow one region to trade away water that is needed downstream risk sparking conflict between jurisdictions. For example, the Colorado River Basin, shared by seven US states and Mexico, has become a source of rising tensions as upstream water trading affects downstream users. Strong regulatory frameworks are essential to prevent such conflicts, but creating them requires significant political will and resources.

The promise of water markets lies in their potential to address scarcity by incentivising conservation and efficiency. But the risks they pose, especially to equity and environmental sustainability, cannot be ignored. Chile, Australia, and California provide valuable lessons on the limits of market-driven water management. Monopolisation, speculative hoarding, and environmental degradation are all significant risks when water is treated purely as a commodity.

The key is to devise a balanced approach. Water markets must be carefully regulated to ensure fair access, prevent market concentration, and protect ecosystems. Hybrid systems that combine market mechanisms with robust public oversight and community management could offer a more equitable and sustainable solution. Governments should also uphold the rights of vulnerable communities and recognise water as a public good, not just a tradable asset.

# **NOBEL LESSONS FOR INDIA**





**INCLUSIVE POLITICAL INSTITUTIONS ALLOW WIDE SECTIONS OF SOCIETY TO GOVERN THE COUNTRY AND MAKE DECISIONS THAT BENEFIT THE MAJORITY** 

The three winners of this year's Nobel in Economics -- Daron Acemoglu, Simon Johnson and James A. Robinson -- have two eminently readable books to their credit; Why Nations Fail? (2012) and The Narrow Corridor (2019). The 2012 book is an indirect polemic against theories explaining global inequality: the geographical theory of Jeffrey Sachs, the theory of ignorance of the elites of Banerjee & Duflo, and Max Weber about the influence of protestant ethics on economic development. It distinguishes institutions that are either extractive or inclusive. Inclusive societies protect property rights, do not allow unjust property alienation, and integrate workers to increase labor productivity. Inclusive political institutions allow wide sections of society to govern the country and make decisions that benefit the maiority. These institutions are the foundations of all modern liberal societies. Without such institutions, power will be purloined by a small section of society.

Harking back to the history of colonialism, the authors bring out how European colonies had a dramatic and divergent impact across the world, depending on whether the coloniser focused on the extraction of resources or the setting up of longterm institutions for the benefit of European migrants. This resulted in a reversal of fortune, where former colonies that were once rich became poor (as in the case of India demonstrated in Dadabhai Naroroji's Drain theory), while some poor countries with the help of institutions were able to garner some generalised level of prosperity.

Arvind Subramanian, former CEA, criticised the conclusions of Why Nations Fail by citing how neither India nor China fit this narrative. China has become rich despite not having inclusive institutions, while

India has barely grown despite its all-inclusive institutions. Acemoglu countered this criticism by stating that their theory distinguishes between economic and political institutions. It is not political institutions that contribute to growth directly, but it is the economic institutions that are shaped by political institutions. Political institutions played a role in directing economic reforms since 1978 in China under Deng. In the case of India, Acemoglu observes that castebased inequality, poor quality of democracy and flawed political institutions contributed to its poor economic institution.

Acemoglu told reporters recently that data collected by Freedom House and V-Dem show that public institutions everywhere are getting weaker and support for democracy is at alltime low. While admitting that China is a bit of a challenge to analyse, they believe that extractive requirements can produce temporary economic growth as long as they are politically centralised. China's growth is based on adapting existing technology and rapid investment and not the anxiety-inducing process of creative destruction that produces lasting innovation and growth. By importing foreign technology and exporting low-end products, China is playing a spirited game of catch-up.

The Narrow Corridor by Acemoglu and Robinson provides an illuminating insight as to how a good state requires a good balance between the power and capacity of the state on one hand and the simultaneous power of the society to hold the state in check and guarantee basic human rights and a minimum standard of living. Countries like China and Russia with strong state apparatuses but inadequate checks on their power suffer from extreme inequality, lack of innovation, and a general lack of human rights. On the other hand, in the US the power and capacity of the state are extensive and capable but restrained by guaranteed rights and democratic participation. Though the US has promoted opportunity and liberty for many people, much work remains to be done in terms of access to quality education and health care, race relations, and equitable imposition of taxation.

Nobel Prize in Economics was first awarded to Jan Tinbergen in 1969, who had famously ruled that one policy instrument is required to combat one policy target; the repo rate to control inflation. This year's Nobel laureates seem to take a leaf out of him, by correlating a country's

prosperity with the quality of institutions. Research into inequality has featured strongly in recent awards in economics. Claudia Goldin got it last year and demonstrated how and why gender differences in earning and employment rates have changed over time in the US. Banerjee & Duflo, winners of the 2019 Nobel, provided reliable answers about the best ways to fight global poverty. The laureates this year are possibly aware that the variable of each historical situation would prohibit the extraction of general results. Therefore, they have highlighted the importance of the quality of institutions as a distinguishing independent variable that would determine the success or failure of a nation.

In the context of India, the Nobel laureates offer invaluable insights. Fukuyama observes that "India is famous for high levels of corruption and clientelism, excessive rules and bureaucratic red tape. The capacity of the government to make policies, enforce rule of law & public services need to be substantially improved." Acemoglu also high lights how corruption and caste-based inequality contribute to its poor economic institution. The recent clamor of caste-based reservation by a major political party would further roil India's tryst with a merit-based economy The most sinister trend is the way institutions like ED, CBI, and I Thave become 'caged parrots' of the government. Of late the independence of constitutional bodies like the Election Commission of India is also being questioned. This year's Nobel in Economics has salience both for ushering greater inclusiveness and ensuring the independence of India's institutions. A small class of oligarchs must not convert their economic resources into political power.

# Andhra CM unveils 6 'game changer' policies

Amaravati, Oct 17: Andhra Pradesh Chief Minister N Chandrababu Naidu Wednesday announced six "game changer" policies in various sectors, in cluding industries, MSMEs and food processing with an objective to create 20 lakh jobs in the state and said his government was looking at attracting ₹30 lakh crore investment in the next five

Naidu said the state is also hoping to get USD 10 billion in foreign direct investments.

He further said the Gross Value Addition (GVA) from the manufacturing sector which is pegged at ₹3.4 lakh crore in 2024, would be taken to ₹7.3 lakh crore by 2029, creating five lakh new jobs.


Explaining the key initiatives in the policies, Naidu said the state is hoping to realise ₹5 lakh crore out of the targeted ₹30 lakh crore investment.

He also said the exports from the state would be doubled to USD 40 billion from the existing USD 20 billion in 2024.

The chief minister announced the six policies as AP Industrial Development Policy 4.0, AP MSME & Entrepreneurship Development Policy 4.0, AP Food Processing Policy 4.0, AP Electronics Policy 4.0, AP Industrial Park Policy 4.0 and AP Integrated Clean Energy Policy 4.0.

"At a time we brought six poli cies. We exercised a lot on these six policies (and) we said only one thing in the polls (that cre ating) 20 lakh jobs is the goal of this government and we will work (towards it. These six policies will be a game changer, said Naidu, addressing a press conference at the Secretariat, following a Cabinet meeting.

Calling it one of the best incentive structures for industries in India, he said this policy offers incentives up to 62 per cent for the first 200 early investors and up to 72 per cent incentives for value-addition investors who engage in component manufac-

## Computer-based model to determine liquor availability in AP

### THE MODEL WILL CAPTURE DATA RELATED TO MARKET DEMAND AND ACCORDINGLY SUPPLIES WILL BE DECIDED

Amaravati, Oct 17: Premium international whisky brands of popular liquor companies including Diageo have hit the outlets in Andhra Pradesh with the implementation of the new liquor policy, effective October 16

In keeping with the new policy, a new 'computer-based model' will determine the brands to be supplied to retail outlets, an official said.

The model will capture data related to market demand and accordingly supplies will be decided. "It will be a market-driven approach determined by demand and supply dynamics," the official told PTI.

Besides Diageo, brands of several noted manufacturers including Pernod Ricard and

he added. The official said the brand that sells more will be procured more. However, every registered liquor brand will be given an opportunity to sell their products.

After scrapping the old liquor policy, the N Chandrababu Naidu-led NDA government is implementing a brand new liquor policy from Wednesday. Elaborating the model, the official noted that initially liquor brands will be allowed to supply 10.000 cases in the market to be followed by the market-driven model which will kick in the

market dynamics cycle. Based on liquor sales over the past three months, brands will be allowed to sell 150 per cent of that quantum.

New Delhi, Oct 17: India Thursday said it had shared with the Canadian government security-related information regarding members of the Lawrence Bishnoi gang and other gangs, seeking their arrest, but so far "no action" has been taken by Ottawa

"They have taken no action so far, which are our core concerns. And, there is a political motive behind it, which you know... No action taken on our security concern," Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal told reporters.

He said this in response to a query during his weekly briefing here as he fielded a volley of questions on India-Canada ties. a day after Canadian Prime Minister Justin Trudeau testified before a Commission of Inquiry.

Jaiswal, in response to another query, said "as far as my information is concerned, there are 26 extradition requests (from India) pending with the Canadian side" over the last decade or more. The MEA spokesperson said the current diplomatic row with Canada has been precipino evidence" in support of the serious allegations Ottawa chose to level against India and Indian diplomats.

The MEA spokesperson's comments assumes significance given the claims made by Canadian Prime Minister during the inquiry.

Testifying before the public inquiry, Trudeau claimed the Indian diplomats were collecting information on Canadians who are in disagreement with the Narendra Modi government and passing it to the highest levels within the Indian government and criminal organisations like the Lawrence Bishnoi gang.

On a query on extradition requests from India, the MEA spokesperson said that besides the 26 extradition requests, there are several "provisional arrest requests of

Director General of Police (DGP) Prashant Kumar said those arrested have been identified as Mohammad Faheen, Mohammad Sarfaraz and Abdul Hameed, who are named accused in the FIR -- and two others Mohammad Taleem alias Sabloo and Mohammad Afzal. According to Kumar, a police team arrested Faheen and Taleem. Acting on the information given by the duo, the team went to recover the weapon used in the murder in the Nanpara area, however, it came under fire from Hameed, Sarfaraz and Afzal.

In retaliatory firing, Sarfaraz and Taleem were injured. A doctor at the local Nanpara health care centre said, "Two people were brought here around 2.35 pm. One of them was Sarfaraz and the other was Taleem.

### Krishnagar woman murder: SIT formed

Kolkata, Oct 17: The preliminary autopsy report of the deceased young woman from West Bengal's Krishnagar indicated that she had sustained antemortem burns with no acid or other chemicals involved in those injuries, a senior official involved in the post-mortem examination said Thursday.

The report also noted the absence of external injuries, suggesting that the wounds on her face may have been self-inflicted, the official added. "These are preliminary findings and we must wait for a comprehensive conclusion," the doctor told reporters after the post-mortem was conducted at the Jawaharlal Nehru Memorial (JNM) Hospital in Kalyani, Nadia district.

The process was videographed and conducted in the presence of a magistrate. Meanwhile, after surveying the location where the body was found, Assistant Director General (ADG) of South Bengal, Supratim Sarkar, announced the formation of a Special Investigating Team (SIT) to probe the matter. He added that the SIT would be assisted by the state CID. "The SIT will operate under the supervision of the Krishnagar Police District SP." he said.

During the investigation, forensic experts recovered a matchbox and a bottle, which likely contained kerosene, according to another police officer.

There are indications that the woman may have inflicted the wounds on herself and set herself on fire. The circumstantial evidence suggests this," the officer noted.

of them responsible. In a separate application submitted last month seeking a CBI probe, the victims argued that the then district collector was present at all the meetings related to the awarding of the contract to Oreva Group for the maintenance of the bridge, but his state-

### Plot to kill Salman: Bishnoi gang member held **Somy Ali requests**

Mumbai, Oct 17: The Navi member of the Lawrence Bishnoi gang in connection with an alleged plot to kill Hindi film industry actor Salman Khan, an official said Thursday.

The accused, Sukha alias Sukhbir Balbir Singh, was apprehended from Panipat in Haryana by a team of Panvel Town police (in Navi Mumbai)

Wednesday, he said. He had allegedly given a contract to Bishnoi gang members to kill Khan, the official said. Sukhbir Singh was in touch with his alleged handler Dogar, who

is based in Pakistan, he said. Singh along with the Bishnoi gang members had planned to



use weapons from Pakistan, such as AK-47s, M16s and AK92s, to execute the alleged plot to kill Salman Khan, the official said. He will be produced before a court after being brought to Navi Mumbai, the police said.

## Reduce overcrowding of jails: MHA to states, UTs

### OVERCROWDING IN PRISONS, ESPECIALLY THE ISSUE OF LARGE NUMBER OF UNDERTRIALS, HAS BEEN A MATTER OF CONCERN FOR THE GOVERNMENT. THE HOME MINISTRY SAID IN A COMMUNICATION TO STATES

New Delhi, Oct 17: The Union Home Ministry has asked all states to take steps, including implementation of a specific provision of the Bharatiya Nagarik Suraksha Sanhita (BNSS) 2023, for providing relief to undertrial prisoners and reduce overcrowding in jails.

It said that for addressing the issue of long detention of undertrial prisoners and their hardship, it has been taking various progressive steps, including grant of financial aid to the states and union territories for providing relief to such prisoners in seeking release

from prisons. The ministry said that Section 479 (1) of the BNSS, which has come into force with effect from July 1, 2024, provides for such relief. Section 79 says that if an



up to one-half of the maximum imprisonment specified for his offence under the law he shall be released by the court on bail.

However, the relief is not available in the maximum punishment is death sentence or life imprisonment. A new Proviso has been added under Section 479 (1) of the BNSS,

first-time offender (who has never been convicted of any offence in the past) he shall be released on bond by the Court, if he has undergone detention for the period extending up to one-third of the maximum period of imprisonment specified for such offence under that law'.

The Section 479 (3) of the BNSS casts a specific responsibility upon the Superintendent of Prisons, where the accused person is detained, to make an application to the concerned court for release of such prisoners on bail.

The home ministry said the Supreme Court, in its order dated August 23, 2024, in 'Inhuman Conditions in 1382 Prisons' noted that the provisions of Section 479 of BNSS shall apply to all undertrials in pending cases irrespective of whether the case was registered against them before July , 2024, the date when the new law came into effect.

The Court has directed the Superintendents of Jails across the country that wherever accused persons are detained as undertrials, their applications may be preferred to the concerned courts, upon completion of one-half or one-third of the period mentioned in sub section (1) of Section 479, for


their release on bail. "All states and UTs are requested to take note of the specific legal mandate cast on the Superintendent of Prisons under their jurisdiction and disseminate this information to all relevant ranks, particularly the Superintendent of Prisons, and monitor the effective implementation of the new provisions of BNSS, as cited above,' the communication said.

For assisting the state and UT prison authorities in quick identification of eligible prisoners, the ministry has made appropriate provisions in the national E-Prisons portal, enlisting types of offences that prisoners have been charged with, the maximum sentence for the offence committed, the date of completion of one-half or one-third of the maximum period of imprisonment specified for an offence under the relevant law by a prisoner, etc.





### **SECTION 6A OF**

### Origin, issue, top court verdict, explained **CITIZENSHIP ACT**

New Delhi, Oct 17: Section 6A, which was incorporated in the Citizenship Act 1955 following the signing of the 1985 Assam Accord, was upheld by the Supreme Court. The following explains the special provision of the law and its possible ramifications.

#### What is Section 6A of the Citizenship Act 1955?

Section 6A was inserted into the Citizenship Act as a special provision to deal with the citizenship of people covered under the 1985 Assam Accord signed by the then Rajiv Gandhi government with the All Assam Students Union (AASU), then headed by Prafulla Kumar Mahanta, who later twice became Chief Minister of Assam. It is referred in the law as "special provisions as to citizenship of persons covered by the Assam Accord".



The provision provides that those who had come to Assam on or after January 1, 1966, but before March 25, 1971, from specified territories, including Bangladesh, and since then are residents of Assam, must register themselves under Section 18 for citizenship. These people were barred from registering as citizens of India for 10 years from the day of their detection as per the provision of the Assam

Accord. As per Assam Accord, those who had come after March 25, 1971, are bound to be deported from India. As a result, the Section 6A fixes March 25, 1971. as the cut-off date for granting citizenship to migrants, particularly the ones from Bangladesh, residing in Assam.

#### Why the validity of Section 6A was challenged in the top court?

The Assam Sanmilita Mahasangha and many other petitioners challenged the provision, saying that it singles out Assam and has facilitated mass immigration. They claimed that Assam's demography has changed drastically due to the citizenship being granted to immigrants who claim that they entered Assam before the March 25, 1971. They wanted 1951 as the cut-off year for detection and deportation of illegal immigrants from Assam. The petitioners had challenged Section 6A first in 2012 while arguing that Section 6A was discriminatory, arbitrary and illegal so far as it provides for different cutoff dates for regularising illegal migrants who entered Assam and the rest of India

### What apex court held?

In a majority verdict, the Supreme Court Thursday upheld the constitutional validity of Section 6A of the Citizenship Act, 1955. Chief Justice of India

(CJI) D Y Chandrachud, writing for himself, upheld the validity and said the magnitude of influx of migrants in Assam is higher as compared to other states considering the smaller land size and the detection of foreigner is an elaborate process. Besides, Justice Surya Kant, who wrote for himself and Justices M M Sundresh and Manoj Misra, concurred with the CJI and held that Parliament had the legislative competence to enact such a provision.

The majority verdict held that cut off date of March 25, 1971 for entry into Assam and granting citizenship is correct. Justice J B Pardiwala, however, dissented and held Section 6A as unconstitutional.

He said the open-ended nature of Section 6A had become more prone to abuse due to the advent of forged documents.

#### **Mixed reactions** AASU, which has spear-

headed a six-year-long agitation against illegal immigrants in Assam between 1979 and 1985, welcomed the Supreme Court judgment. The influential students body said the Supreme Court has given its stamp of approval to the Assam Accord under which all those who had entered Assam illegally must be detected and deported from the country. However, Matiur Rahman, a former AASU leader, who filed the original petition in the Supreme Court on behalf of the Sanmilita Mahasabha, an Assam-based organisation, challenging the inclusion of Section 6A in the Citizenship Act, said he was not expecting such a verdict. He termed the ruling as "unfortunate" saying it will makethe state a "dumping ground" for foreigners.



### **US' B-2 targets Houthi rebels**

Dubai: US long-range B-2 stealth bombers launched airstrikes early Thursday morning targeting underground bunkers used by Yemen's Houthi rebels. officials said. It wasn't immediately clear what damage was done in the strikes. However, it is incredibly rare for the B-2 Spirit to be used in the strikes targeting the Houthis, who have been attacking ships for months in the Red Sea corridor over the Israel-Hamas war in the Gaza Strip. The Houthis' al-Masirah satellite news channel reported airstrikes around Yemen's capital, Sanaa, which the group has held since 2014. They also reported strikes around the Houthi stronghold of Saada. They offered no immediate information on damage or casualties.

### Suicide bomber attack in Somalia

Mogadishu: Seven people died and six others were injured after a suicide bomber detonated an unidentified device at a café outside a police training school in Somalia's capital, Mogadishu, police said Thursday. Police say the victims included officers and civilians who were having tea outside the General Kaahiye Police Academy Thursday. The al-Qaeda linked militant group, al-Shabab, claimed responsibility for the attack through a statement published on its affiliate website. The group has in the past carried out attacks in Somalia. Resident Mohamed Ali said he heard a loud blast. "The café was full of people enjoying their tea, and then everything was chaos," he said.

### Italy's crackdown on surrogacy

Rome: Italy's Parliament made it illegal Wednesday for couples to go abroad to have a baby via surrogacy, a pet project of Prime Minister's Giorgia Meloni party which activists say is meant to target same-sex partners. The legislation extends a surrogacy ban already in place in Italy since 2004 to those who go to countries such as the United States or Canada, where it is legal, imposing jail terms of up to two years and fines of up to 1 million euros (\$1.09 million). Earlier this year, Meloni called surrogacy an 'inhuman' practice that treated children as supermarket products, echoing a position expressed by the Catholic Church.

# Israel confirms Hamas chief's death

The Israeli military says it has killed Yahya Sinwar in an operation in the southern Gaza Strip

Jerusalem, Oct 17: Hamas leader Yahya Sinwar, mastermind of the October 7, 2023 attack that triggered the Gaza war, has been killed by Israeli forces in the Palestinian enclave, Israel said Thursday.

His killing marks a huge success for Israel and a pivotal event in the year-long war, although there are a number of possible

The Israeli military said it had killed Sinwar, 62, in an operation in the southern Gaza Strip Wednesday.

"After completing the process of identifying the body, it can be confirmed that Yahya Sinwar was eliminated," it said.

There was no immediate comment from Hamas

In Israel, families of hostages held by Hamas in Gaza said they hoped that a ceasefire could now be reached that would bring home the captives. In Gaza, pounded relentlessly by Israeli forces for a year, residents said they believed the war would go on.

Israeli Foreign Minister Katz said: "This is a great military and moral achievement for Israel and a victory for the entire free world against the axis of evil of radical Islam led by Iran."

He called Sinwar a "mass murderer who was responsible for the massacre and atrocities of October 7", the Hamas-led attack on Israel that triggered the Gaza war. Defence Minister Yoav Gallant addressed Hamas fighters, saying it "is time to go out,  $release \ the \ host ages, raise \ your$ hands, surrender.

## China prefers Harris over Trump

Beijing, Oct 17: China will prefer Kamala Harris to Donald Trump as the next US presidential considering that bilateral ties deteriorated sharply during the latter's presidency leading to serious confrontation, a senior member of the Chinese national advisory body said on Thursday.

The Chinese government prefers not to comment on the US presidential election because it doesn't want to be accused of interfering in American domestic politics, Jia Qingguo, member of the Standing Committee of the national advisory body CPPCC said.

The Chinese People's Political Consultative Conference (CPPCC) is a key component of the state governance system and a distinctively Chinese political institution.

The views of the Chinese general public are divided over Harris and Trump, but "I would prefer Harris because of the bad experience with Trump. We don't want to have that experience again," he told BBC in a rare comment voicing Beijing's preferred choice in the US presidential election.

During Trump's presidency, the relations declined sharply



in serious confrontation. "From China's point of view, US Vice President Kamala Harris, who has worked under President Biden, represents the continuity,' he said.

Trump, during his Presidency was quite emotional and spread a lot of bad information about China, said Jia, who is also the Director of the Institute of Global Cooperation and Understanding of the Peking University.

"We have problems with the Biden admiration too," but Biden inherited a lot of tough measures initiated by Trump against China for the reasons of domestic politics and perhaps out of his ideological conviction, he said, adding, "Under Biden, the US policy towards China is more stable, predictable.

"We are re-engaging with each other. Officials are meeting with each other, talking about issues,' which he said is stabilising the relations.

While following a tough policy towards China, including firming up US policy to challenge Beijing's claims over the disputed South China Sea and Taiwan, and restricting China's ambitious move to export its electric vehicles, Biden, however, has maintained regular dialogue with President Xi Jinping to keep the tensions under control.

### **Over 250 students** held as protesters ransack campuses



Lahore, Oct 17: At least 250 students were arrested Thursday in Rawalpindi for violence during protests against an alleged on-campus rape in a Lahore college as the agitation spread to other cities of Punjab province in Pakistan.

The protests erupted Monday in at least four boys' and girls' campuses of the privately-owned Punjab Group of Colleges following social media reports that a female student at the Gulberg girls' campus in Lahore had allegedly been raped by a security guard in the institution's basement.

Police claimed they have the suspect in custody, but he has denied the allegation.

Punjab Chief Minister Maryam Nawaz has blamed jailed former Prime Minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party for spreading fake news on social media and said that no such incident had taken place. On Wednesday, a large number of students held demonstrations in Jehlum, Faisalabad, and Gujrat, demanding justice for the alleged rape victim.

On Thursday, protests spread to Lahore, Rawalpindi, Gujrat, Attock, Sargodha, and Vehari districts of Punjab. The student protesters ransacked a college building in Rawalpindi, forcing police to fire tear gas to disperse them.

Later, 250 students were taken into custody, the police said.

The police said legal actions were being taken against those involved in disrupting peace. The guilty would be punished, they added. "Police personnel have been deployed at various locations across the city," Rawalpindi Police said on X, adding that it was fully prepared to deal with any law and order situation.

"Parents are requested to keep their children away from illegal activities. The future of children can be ruined in case of legal action," it added.



# India poised to be 3rd largest economy by '30: S&P

Rising population presents challenges, says the global ratings agency

New Delhi, Oct 17: India is poised to be the third largest global economy by 2030 but rising population presents mount $ing\ challenges\ in\ basic\ service$ coverage and growing investment needs to maintain productivity, S&P Global Ratings said Thursday.

It said emerging economies have high ambitions for the next decade and beyond with India aiming to become a \$30 trillion economy by 2047, from the current \$3.6 trillion.

"India is poised to be the fastest-growing major economy over the next three years and the third largest globally by 2030. Its 2024 entry into JP Morgan's Government Emerging Market Bond Index could provide additional government funding and unlock significant resources in domestic capital markets. This is only a first step --investors will continue looking for improved market access and settlement procedures," S&P said.



India is currently the fifth largest economy

In its report titled 'Look forward Emerging Markets: A decisive decade', S&P said emerging markets will play a crucial role in shaping the global economy over the next decade, averaging 4.06 per cent GDP growth

through 2035, compared to 1.59 per cent for advanced economies.

By 2035, emerging markets will contribute about 65 per cent of global economic growth. This growth will be driven mainly by emerging economies in Asia-Pacific, including China, India, Vietnam and the Philippines.

"Also by 2035, India will be cemented as the world's thirdlargest economy, with Indonesia and Brazil ranking eighth and ninth, respectively," S&P said.

India, it said, has also taken measures to improve its weak fiscal flexibility by boosting its capital expenditure, further supporting long-term growth.

But population challenges are meaningful, with the country expected to have the world's largest population by 2035. This presents mounting challenges in basic service coverage and growing investment needs to maintain productivity, S&P said.

Stating that India is positioned to grow its economy in the next decade, the US-based agency said as the next decade approaches, the economic trajectory of emerging markets will likely be heavily influenced by their governments' design and execution of long-term growth strategies.

# Musk's win raises prospect of price war with Ambani

### IGNORING ASIA'S RICHEST MAN, MUKESH AMBANI, GOVT SIDES WITH MUSK ON SATELLITE SPECTRUM ALLOCATION

New Delhi, Oct 17: Having just lost a battle with Elon Musk over how India's satellite spectrum is awarded, Asia's richest man Mukesh Ambani could face a bigger challenge if Musk's Starlink launches services in India and the two go head-tohead on price.

India's government said Tuesday it will allocate spectrum for satellite broadband administratively and not via auction, hours after Musk criticised the auction route being sought by rival billionaire Ambani as

Musk's Starlink, a unit of SpaceX which has 6,400 active satellites orbiting earth to provide low-latency broadband to 4 million customers, has publicly expressed interest in launching in India, but its plans faced re-

Ambani, who runs India's biggest telecom company, Reliance Jio, had tried since last year to seek a "balanced competitive landscape" and wanted to keep Musk at bay, as experts say a spectrum auction would have required much more investment and deterred foreign players.

Reliance, which has dominated India's telecom sector for years, is now concerned that after spending \$19 billion in airwave auctions it risks losing broadband customers to Musk, and potentially even data and voice clients later as technology advances, a person with direct knowledge said Thursday.





Sindhu sinks Han to Vivaan, Naruka light up India's day enter quarterfinals

Odense (Denmark), Oct 17: PV Sindhu overcame a sluggish start to defeat World No. 7 Han Yue of China in a thrilling contest, progressing to the quarterfinals of the Denmark Open Super 750 badminton tournament here Thursday. Sindhu currently ranked 18th, won 18-21, 21-12, 21-16 in a second round match which lasted 63 minutes. This marks her first win over a top-10 player since defeating Han in the Malaysia Masters final in May.

A finalist in the 2015 edition here, Sindhu, the lone surviving Indian in the fray, will next face either Indonesia's Paris Olympic bronze medallist Gregoria Mariska Tunjung or Denmark's Mia Blichfeldt in only her third quarterfinals this year.

Sindhu, who returned medalless from Paris for the first time in three Olympics, has an overwhelming 10-2 record against Tunjung but the two haven't played each other this year so far. Sindhu and Han started with



short rallies, splitting the initial eight points but Sindhu conceded five straight points to fall behind. She looked to extend the rallies to tire out her opponent, who had played a 79-minute opener Wednesday.

Han led 14-10 after the break, with Sindhu faltering in her aggressive approach. Poor execution of shots saw her struggle at 13-17. A body return cramped Sindhu, allowing Han to grab six game points, but the Indian saved four before Han won the game with a cross-court shot.

In the second and third games, Sindhu dominated the show to emerge a winner.

New Delhi, Oct 17: Two young shotgun marksmen from Jaipur, Vivaan Kapoor and Anantieet Singh Naruka, lit up an otherwise lacklustre Indian campaign, winning a silver and a bronze on the concluding day of the yearending ISSF World Cup Final

here Thursday. Vivaan, the 22-year-old trap shooter and 26-year-old Olympian skeet marksman Anantjeet, clinched the biggest medals of their careers at the famed Karni Singh Range as the hosts ended the elite competition with two silver and an equal number of

bronze medals. Vivaan shot 44 in the final as he was beaten to the gold by Paris Olympics silver medallist from China, Qi Ying, who shot 47. Vivaan had earlier shot 120 out of 125 in the qualification round to finish third and make it to the six-shooter final.

"It is a significant confidence booster as this is my first individual medal in the senior cir-

"I told myself that I am competing at the same level as them

(top shooters). So I am not second to anyone, this is how one wins a medal," Vivaan said after the medal ceremony.

Naruka gave an equally commanding performance in the men's skeet final but was unlucky to finish with a bronze medal, partly due to the malfunction in the clay target ma-

chines, which upset his rhythm. Twice during the final a snag in the clay target-throwing machine just when Anantjeet was about to take aim, forced the tall marksman to wait for a few minutes. He finally shot 43 to finish third, while Italy's Tammaro Cassandro and country-mate Gabriele Rossetti clinched the top two positions with scores of 57 and 56 respectively.
