



# SAIF STABBED AT MUMBAI HOME

Mumbai, Jan 16: Hindi movie star Saif Ali Khan was repeatedly stabbed by an intruder in his high-rise apartment in upscale Bandra early Thursday and rushed to hospital with the blade still lodged in his spine, an audacious attack that raises intriguing questions about security and celebrity life in the financial and showbiz hub.

The 54-year-old, who received six stab injuries, including in his neck, was out of danger following an emergency surgery at the Lilavati Hospital, where he was taken after the attack outside his younger son Jeh's room around 2.30am.

The entire family was at home in the 12th-floor apartment along with their five house helps. In a statement to the police, Jeh's nanny Elivama Philip, who first encountered the armed attacker, said he asked for ₹1 crore. The intruder did not force his entry or break into the actor's flat but possibly sneaked in at some point during the night with the intention of robbery, police officials said. The attacker made his escape through the stairs.

Recounting the horrific events of the night, Philip said she was sleeping on the floor in Jeh's

room and woke up around 2am when she heard a sound and saw a man move towards the sleeping child. Panicked, she rushed to pick him up and was pushed away by the man, armed with a wooden stick and a long blade. Another nanny was also sleep-

ing in the same room.

"I sat up to see who was in the bathroom... I saw a thin and short man come out and go towards Jeh's bed," Philip said in the statement that forms the basis of the police FIR on the incident. The man, she said, pointed a finger at her and warned her 'Koi awaz nahin (don't make any noise).

"In the scuffle, he attacked me with the blade. I got injured on my wrist. I asked him what he wants. He said he needs ₹1 crore," Philip, who has been

working with the star couple for four years, said in her statement.

Hearing her scream, Khan and Kareena rushed out of their room. The intruder, who Philip said was between 35-40 years old, then attacked Khan with a knife. During the commotion, another house help also rushed out to raise an alarm. The intruder then ran away. CCTV footage showed the alleged assailant, wearing a red scarf and carrying a backpack, scurrying down the stairs from the sixth floor of the Satguru Sharan building.

#### **Hindenburg shuts shop**

WASHINGTON/NEW DEL-HI: Hindenburg Research, which made international waves with campaigns targeting billionaire Gautam Adani that wiped billions from market value of his group companies, will disband, its founder Nate Anderson announced. Announcement by Anderson, 40, who started Hindenburg in 2017, came just days before Donald Trump's inauguration as the new President of the US. While he cited the toll of the rather intense, and at times, all encompassing nature of the work as the reason for his decision, critics were quick to link the shutting down Hindenburg's alleged ties with George Soros and the so-called deep state being under significant pressure from the incoming Trump administration.

# **Cabinet okays 8th Pay Commission formation**

New Delhi, Jan 16: The Union Cabinet, chaired by Prime Minister Narendra Modi. Thursday approved setting up of the 8th Pay Commission to revise salaries of nearly 50 lakh Central government employees and allowances of 65 lakh pensioners. "The Prime Minister has

approved formation of 8th Pay Commission for Central government employees. The chairman and two members of the commission will be appointed soon," I&B Minister Ashwini Vaishnaw told reporters here. Seven pay commissions have

been constituted since 1947. The 7th Pay Commission was formed in 2014 and its recommendations were implemented January 1, 2016. Its term will

"Setting up of the 8th Pay Commission in 2025 will ensure that its recommendations are received well before the completion of the term of the 7th Pay Commission," Vaishnaw said.

Later in the day, the PM said that the government's decision to constitute the 8th Pay Commission will boost consumption and improve the quality of life.

He said on X, "We are all proud of the efforts of all government employees, who work to build a Viksit Bharat. The Cabinet's decision on the 8th Pay Commission will improve quality of life and give a boost to consumption.'

Pay commissions hold extensive consultations with Central and state governments and other stakeholders before giving recommendations to the government. The pay commis-

sion has a key role in deciding salary structures, benefits and allowances for government employees. Most of the state-owned organisations follow the commission's recommendations.

Sources said the government's move will benefit nearly 50 lakh Central government employees and 65 lakh pen-

In Delhi alone, about four lakh employees will benefit from the recommendations of the panel. Delhi is going to Assembly polls February 5, 2025.

The 7th Pay Commission saw an expenditure increase of ₹1 lakh crore for fiscal 2016-17.

Usually, every 10 years, the Central government constitutes a pay commission to revise the remuneration of its employees. The pay commission also recommends the formula for the revision of dearness allowance and dearness relief for Central government employees and pensioners with a view to compensating them

for inflation. Several state governments also revise the remuneration of their employees on the lines of the pay commission recommendations.

# India's feat in space docking

Bangalore, Jan 16: In a major boost to India's ambitious future space missions, ISRO Thursday successfully performed the docking of satellites as part of the Space Docking Experiment (SpaDeX) and announced that post docking, control of two satellites as a single object was also achieved.

"India docked its name in space history! Good Morning India. ISRO's SpaDeX mission accomplishes historic docking success. Proud to witness this moment!" ISRO said in a post on 'X'

With the successful docking of satellites - Chaser and Target, India has become the fourth country after the US, Russia and China to accomplish the technological feat.

In space, docking technology is essential when multiple

to achieve common mission objectives. The docking experiment is crucial for the smooth conduct of the country's ambitious future missions, including Chandrayaan-4, setting up of a space station and landing an astronaut on the Moon.

New Delhi, Jan 16: The chaos of deplaning is spiralling out of control. Travellers are increasingly ignoring unwritten etiquette, leading to frustration among passengers. Some push past others despite arriving early, while others slowly gather their belongings, holding up the entire row. Though airlines have improved boarding processes, deplaning remains a free-for-all with little regulation.

Satish Kumar, a frequent traveller, recalls a Bangalore flight where a woman, in her 40s, attempted to shove through passengers to exit first. When Kumar's girlfriend

rows to go, the woman responded that no rules required it. And she was right. Kumar, 32, believes common

courtesy is clear - deplane in row order, letting the row ahead go first. Following this can ease tensions and make travel smoother for everyone.

The challenge of exiting an airplane efficiently continues to frustrate travellers. A primary issue is the increase in carry-on luggage, which leads to congestion in the aisles. Airlines have responded by installing larger overhead bins and monitoring baggage policies more strictly.

Smita Deshmukh, a frequent flyer from Mumbai, recalls a



time when deplaning took just five-six minutes. With lower checked baggage fees then, carry-on bags were less common. Now, Deshmukh exits immediately when the seatbelt sign goes off but only allows others to pass her once before holding her position to keep order. "Sometimes I've got to enforce courtesy," she said.

Airlines offer no universal guidelines for connection times, forcing some passengers to rush between flights. A member of All India Cabin Crew Association, who wished not to be named, said, "Flying is a group project. And kindness makes deplaning faster."

Naresh Gupta from Jaipur sympathises with stressed travellers and lets them pass when possible. However, he notes how selfish behaviour

can slow things down. Some airlines have introduced row-by-row deplaning

to reduce aisle chaos. Flight attendant Nisha tight connections to politely ask for help, instead of demanding it. Satish Naik, a systems ad-

ministrator, has researched some boarding methods. He proposes alternating rows starting with window seats in the back—reversing this for deplaning would allow more passengers to access their luggage simultaneously.

Naik, however, takes a more relaxed approach. "I usually wait until the plane is almost completely empty, preferring not to fight the crowd.

In the end, cooperation and courtesy are vital to making the deplaning process smoother for everyone.

# ECoR achieves 200 MT freight loading in just 290 days

**Highest ever freight loading by any zone surpassing previous records**

Bhubaneswar, Jan 16: The East Coast Railway (ECoR) has shattered all previous records by achieving an unprecedented freight loading milestone of 200.13 million tonne in a remarkably swift 290 days during the 2024-25 fiscal, an official statement said Thursday.

This marks the highest-ever freight loading by any zone in the history of Indian Railways, reinforcing ECoR's leadership in freight transportation and operational excellence, it said.

The ECoR reached this landmark January 15, 2025, surpassing its own record set in the



previous fiscal year (2023-24) when it took 295 days to cross 200 million tonne.

During this period, ECoR has unloaded a record of 183.5 million tonne of freight, further highlighting its remarkable performance in freight han-

The feat was accomplished 15 days ahead of last year's pace and comes on the back of a strong performance in previous years, where it took 366 days (2019-20), 360 days (2020-21), 320 days (2021-22), and 310 days (2022-23) to achieve similar milestones

Over the period, ECoR handled a total of 200.13 million tonne, up by 1.6 per cent from 196.779 million tonne in the previous fiscal year. The zone's performance in freight handling remains robust, and it continues to be a crucial en-

abler of economic growth. The major commodities

loaded by ECoR included coal (119.637 MT), raw materials for steel plants (7.67 MT), pig iron and finished steel (15.991 MT), iron ore (24.426 MT), cement (0.88 MT), food grain (2.226 MT), fertiliser (5.477MT), mineral oil (2.317 MT), freight in contain-

er (4.372 MT) and other goods (17.159 MT). This apart, the ECoR has also seen an increase in revenue generation, earning ₹20,288.041 crore, which represents a 1.28 per cent growth compared to

the previous fiscal year.

"The achievement of 200 million tonne within a span of 290 days is a direct result of meticulous planning, excellent coordination with industries and government entities, and the tireless efforts of its work force," a senior official said.

Balasore/Baripada, Jan 16: Armed police forces are being deployed to assist forest personnel in patrolling poaching-prone areas of Similipal Tiger Reserve (STR) spread over Mayurbhanj and Balasore districts, officials said Thursday.

The decision was taken after the state Forest department suspected that a melanistic tiger was killed in November last year in the STR, the world's only habitat, where an estimated 13 black-striped cats remain.

Police had January 12 arrested four people in Mayurbhanj district after the skin and nail of a tiger was seized from their possession.

Earlier, six others were also apprehended in Balasore district after claws of the same tiger were recovered from their

"A total of 10 people have been arrested in connection with the death of a melanistic tiger. The poachers have admitted that they killed a oneand-half-year-old tiger," STR field director Prakash Chand Gogineni said.

The police are making elaborate arrangements to assist forest officials in checking the wildlife poaching in Similipal and adjacent areas, he said.

"Two platoons (1 platoon comprises 30 personnel) of armed police force are being provided to forest officials for conducting joint patrolling and flag marches in sensitive villages near Similipal Tiger Reserve to counter poaching," Mayurbhanj SP Varun Guntupalli told reporters at Baripada.

At a press conference in Balasore, Police Eastern Range DIG Satyajit Nayak Thursday said that armed police forces have been trained to assist forest personnel in patrolling and flag marches in the reserved areas


"Specially trained armed police forces will assist the forest personnel in Balasore and Mayurbhanj forest divisions to protect wildlife," Nayak said.


Around 40 police personnel in Mayurbhanj and 50 in Bagudi range of Balasore have been given armed training for this purpose.



# Parle Biscuits fined ₹14.4L for misleading ad



Khurda, Jan 16: The Additional District Magistrate (ADM) of Khurda has imposed a fine of ₹14.4 lakh on Parle Biscuits Private Limited for printing misleading information on packets of 'sugar free' biscuits in violation of the provisions under the Food Safety and Standards Act (FSSA), 2006.

The order came recently in response to a complaint by a Food Safety Officer (FSO) from East Coast Railway (ECoR), Khurda Road Division, alleging false claims regarding the sale of food products. Under Section 68 of the FSSA, the ADM directed the concerned parties to deposit the fine amount within one month of receiving the notice.

The penalties include ₹3 lakh on Bhagabati Food Private Limited, ₹3 lakh on the franchise operators, ₹1 lakh for a distributor in Jatni, and ₹20,000 on a salesman operating stalls on platform number 6 and 7 at Khurda Road railway station. The salesman, licensed under ECoR, was found responsible for selling improperly labeled products.

The ADM instructed the parties to ensure compliance by making necessary amendments to product labeling, addressing discrepancies such as misleading 'sugar-free' claims Failure to comply with the directives and deposit the fines within the stipulated period may result in further legal ac-

tion, the ADM said.

Based on received information, FSOs, in coordination with the enforcement team, inspected stall number 5 at platform number 6 and 7. The inspection was conducted under the FSSA 2006, to verify product quality During the inspection, a packet of biscuits from Parle company was found with an improperly labeled declaration that appeared suspicious. The packet displayed unclear information sources said. The product label indicated it was sugar free, with four sealed packets weighing 327.6 gram each.

On May 30, 2023, the Bhubaneswar food laboratory is sued a report which confirmed that the product was mislabeled and violated Section 3.1(j) of the Food Safety and Standards (Advertising and Claims) Regula tions, 2018. Subsequently, the food safety officer filed a complaint with the ADM's court against the vendor. Based on the evidence, the court delivered its verdict.

# PMLA court frames charges in Rose Vally scam

Bhubaneswar, Jan 16: The special court under the Prevention of Money Laundering Act (PMLA) here has framed charges against individuals and entities involved in the multi-state Rose Valley chit fund scam, informed the Enforcement Directorate (ED), Bhubaneswar Zonal office in a press release Thursday.

As per the press statement, the agency had earlier attached moveable properties worth ₹332 crore in 2014 and 2015 through provisional attachment orders in this case. The value of the attached properties is currently at over ₹400 Crore, which includes the in-

"A prosecution complaint was filed in 2016 against Gautam Kundu and Shibamoy Dutta, promoters of the Rose

Valley Group. On 15.01.2025, the Special Court framed charges against the accused paving the way for restoring the attached properties to legitimate claimants, with the court's approval. This marks an important milestone in delivering justice and protecting the rights of defrauded investors," informed the ED.

The case against Rose Valley Group was also being investigated in the Kolkata Zonal Office, Guwahati Zonal Office and Agartala Sub Zonal Offices of ED. In Kolkata Zone, in one case ₹12.36 Crore, along with accrued interest totalling ₹19.40 Crore, has already been handed over to the Asset Disposal Committee (ADC) formed by Calcutta High Court and has been further resituated to the victims.

Further properties worth ₹1,172.68 crores of the ponzi firm, including ₹147.64 crore in



movable assets and immovable assets valued at ₹1,025.04 crore have also been attached by ED Kolkata and are in the process of restitution. The value of immovable property, with a deed value exceeding ₹1,000 crore at the time of purchase, is likely

to be worth much more today. Similarly, in Guwahati, assets worth ₹38.30 Crore have been secured, while in Agartala, immovable properties worth ₹8.01 Crore have been attached. ED is expediting the framing of charges in these cases and is

working in close coordination with the one-man Asset Disposal Committee for expedited monetisation and restitution of these assets to the rightful claimants and victims of the fraud.

Notably, the special court (PMLA) in Bhubaneswar has also framed charges in 9 other cases since September 2024. These cases relate to bribery scandals, extortion, chit-fund scams, builder investor disputes, bank frauds, narcotics trade and illegal wildlife trade.

The total value of confirmed properties attached in these cases stands at approximately ₹160 crore as of date. It is also important to mention here that ED, Bhubaneswar Zonal office has filed 75 prosecution complaints (chargesheets) at the special court (PMLA) to date.

### Search For Answer

he COVID-19 pandemic killed an estimated 7.1 million people worldwide, causing global life expectancy to decline by 1.6 years between 2019 and 2021. It disrupted economies, destroyed livelihoods, and strained social cohesion in many countries. Yet no one has been held accountable for it. Will US President-elect Donald Trump change that? Five years after the emergence of SARS-CoV-2 (the virus that causes COVID-19), we still do not know where the pathogen first arose. Did it emerge naturally in the wet markets of Wuhan, China, or did it escape from the nearby Wuhan Institute of Virology (WIV), where studies into bat coronaviruses were underway?

We do know that China's government allowed what might have been a local outbreak to morph into a global health crisis. After the first COVID-19 cases were reported in Wuhan, Chinese President Xi Jinping's regime censored reports about the disease and hid evidence of human-to-human transmission for weeks. Meanwhile, travel to and from Wuhan was allowed to continue unhindered.

Unlike the Muslim gulag in Xinjiang province or naval-base construction in the South China Sea, however, Chinese authorities could not conceal the "novel coronavirus" for long, nor could the rest of the world ignore it once the secret was out. So many people contracted COVID-19 so quickly that many hospitals were soon overwhelmed, leaving many victims to be treated in tents.

China's government then shifted from concealment to damage control. State media reframed the crisis in Wuhan as a story of successful recovery, while touting unrealistically low mortality rates. Meanwhile, Xi thwarted international efforts to initiate an independent forensic inquiry into COVID-19's genesis, which he claimed would amount to "origin-tracing terrorism." The only "investigation" he allowed was a 2021 joint study with the World Health Organization that China controlled and steered.

While Trump, who was president for the first few months of the pandemic, often highlighted the link between China and COVID-19, his successor, Joe Biden, effectively let China off the hook. Less than a week after his inauguration, Biden produced a presidential memorandum urging federal agencies to avoid mentioning the virus' geographic origins.

Biden's goal was to stem a rise in bullying, harassment, and hate crimes against Asian Americans and Pacific Islanders. The toxicity of America's partisan politics meant that pushing back against racism - which Trump and his cohort often stoked – also meant shutting down any discussion of China's role in causing the crisis. Social-media platforms, mainstream media, and some prominent US scientists (who hid their conflicts of interest) also aided the suppression of debate about COVID-19. The partisan divide over whether to investigate China's responsibility for COVID-19 persists to this day. Just last month, Democrats challenged a 520-page report - produced by the Republican-controlled US House Select Subcommittee on the Coronavirus

Pandemic – which concluded, after a two-year investigation, that the virus likely escaped from the WIV, faulting the report's methodology. So, while some US government agencies - including the Department of Energy and the FBI – have given credence to the lab-leak theory, there remains no consensus in Washington.

Failure to get to the bottom of where COVID-19 originated may not only allow China to evade responsibility; it will also weaken the world's ability to prevent another global pandemic. But there is reason to hope that the incoming Trump administration will revive the search for an answer. Beyond Trump's own willingness to point the finger at China, some of his cabinet picks – notably, Robert F. Kennedy, Jr., as Secretary of Health and Human Services and Jay Bhattacharya as director of the National Institutes of Health (NIH) – challenged prevailing narratives about COVID-19 (albeit sometimes in dangerous ways).

An effective investigation will require considerable transparency from the US. The NIH, the US government's medical-research agency, was funding studies on bat coronaviruses at the WIV as far back as 2014. The NIH knew that the work was risky: it was being done in China precisely because the US has stricter rules governing "gain-of-function" research, which involves modifying a biological agent's genetic structure to confer on it "new or enhanced activity," such as increasing a pathogen's transmissibility or virulence. The NIH continued to fund research at the WIV even after multiple State Department cables flagged the lab's lax safety standards, stopping only after the pandemic began (when it also removed the description of gain-of-function research from its website).

Making matters worse, we now know that the WIV has been carrying out classified research on behalf of the Chinese military since at least 2017. A 2021 State Department fact sheet acknowledged that some US funding for civilian research could have been diverted to secret Chinese military projects at the institute. One rule of thumb in forensic investigations is to "follow the money," so the Trump administration should start by disclosing the full extent of US funding of coronavirus research in China. But investigators will also have to "follow the data," meaning that the US will have to disclose the results of the research it funded in Wuhan, which was part of a collaborative US-China scientific programme.

Holding China accountable for its role in the pandemic is only the first step. To safeguard humanity's future, the Trump administration will also have to address a more fundamental issue: dangerous "gainof-function" research is still taking place in some labs in China, Russia, and the West. The genetic enhancement of pathogens represents the greatest existential threat to humankind ever produced by science, even greater than nuclear weapons. By tightening rules on such activities or, ideally, prohibiting lab research that could unleash a pandemic - Trump would leave an important positive legacy

# **DEATH OF AN ALLIANCE**

BJP is desirable but I am not sure it is feasible," said a senior INDIA bloc leader in June 2023.

Those cautionary words from a veteran politician have proven to be prophetic. Just over 18 months after a disparate gathering of leaders came together in the summer heat of Patna to forge an unlikely anti-BJP grouping, the alliance has quickly unraveled. The INDIA bloc is almost dead, only the last rites need to be performed, most likely once the high stakes Delhi Assembly elections are done and dusted.

In a sense, there is certain inevitability to the script that is playing out. An alliance that was formed only to stall the Modi 'char sau par' juggernaut was never going to endure once the 2024 general elections were over. With Modi back in the prime ministerial seat, albeit with vastly reduced numbers, state-level compulsions have taken over from national priorities. Did anyone seriously expect Mamata Banerjee and the Left to find any meeting ground in Bengal? Could Lalu Yadav and Nitish Kumar, friends turned foes turned 'frenemies' in Bihar have ever really trusted each other? Were Omar Abdullah and Mehbooba Mufti going to stay on the same side in a battle for supremacy in Kashmir? And for how long could Shiv Sena (Uddhav faction) harmonise its not so distant militant Hindutva past with its more nebulous present? Modi and BJP were the common enemy for a national election but in a state battle, the equations were bound to change.

Nowhere is this more apparent than in Delhi. Eight months ago, the Congress and the AAP fought the Lok Sabha elections in alliance in the national capital even while taking each other on in Puniab. It was an uneasy combination, seeking to benefit from political arithmetic but singularly devoid of any chemistry.

After all, as a political start-up, the AAP rose on the debris of the Congress in Delhi. It was Arvind Kejriwal's India Against Corruption campaign in 2011 that enfeebled the Manmohan Singh government and created an anti-establishment mood for BJP to capitalise upon in 2014 general elections. It was Kejriwal who humbled a three-time Congress CM, Sheila Dikshit, in 2013, eventually forming a government in Delhi for first time with outside support from Congress. A grand old party surrendering primacy to a political newbie, the decline of the Congress in the national capital was rapid. The party hasn't won a single seat in Delhi in a decade since.

Which is why it is no surprise that the Delhi Congress has chosen to now chart its own path. A fraught history leaves its inescapable scars behind. What is surprising though is just how there has been so little effort from either side to even try and find common ground. Instead, we are witnessing a spiraling war of words that can only provide more comfort to the BJP. Ironically, it was as recently as September 2024 when Rahul Gandhi had reportedly green flagged an alliance with AAP for the Haryana Assembly elections. However, the state Congress, supremely confident of winning the elections, sabotaged alliance overtures. Now, with the Congress having lost the Haryana and Maharashtra elections, the party is in no position to call the shots. This time, it is Kejriwal's turn to play 'ekla chalo re' politics, the AAP even going to the extent of asking for the Congress to be 'thrown out' of the INDIA bloc. Without the Congress, the only pan-Indian party within the alliance, there is no force large enough to act as a magnet to settle internal contradictions.

In hindsight, individual

egos and ambitions are at such cross-purposes that it is astonishing that an INDIA alliance was even attempted in the first instance. Nitish Kumar. the original proponent of the alliance was also the first to opt out, his hope of being made the convenor of the grouping being vetoed by his peers. Mamata Banerjee, who has never forgiven the Congress for tying up with the Left in Bengal, will not play second fiddle to a Rahul Gandhi, someone she views as decidedly a political junior. And the Congress leadership, a section of which was carried away by its 99 LS seats and remains oblivious to ground realities, still sees itself as a natural party of power. Sharad Pawar, the one leader who might have played the role of coalition-builder, is now 84 and after the Maharashtra defeat and the break-up of his party, doesn't have the political heft left to mend differences within.

But there is a lesson in the collapse of the INDIA that goes beyond its stakeholders. In the

has created the spectre of the country being pushed towards a single party, single leader 'elected autocracy'. It is the fear of being totally marginalised that brought the Opposition together. But this grouping had little in common beyond visceral anti-Modiism. Just like the Janata Party experiment in the 1970s was kickstarted by a desire to get rid of Indira Gandhi at all costs, the INDIA alliance emerged out of an obsessive Modi fixation. However, oppositional politics cannot survive on short-fix prescriptions devoid of any ideological moorings. The Janata Party lasted just over two years, the INDIA bloc has had an even shorter innings. At least, the Janata Party had the towering persona of Jayaprakash Narayan to guide it for a while; the INDIA bloc hasn't had the enlightened leadership nor even a common minimum agenda to shape its trajectory.

The alliance's demise would suggest that the BJP is back to where it was at the start of 2024, a dominant force that will simply bulldoze any opposition to its ascendancy. For democratic-spirited citizens, a divided Opposition must be of grave concern, especially given the tendency of the Modi government to use institutional power to constantly push its opponents on the defensive. The 2024 general elections had opened a small window of hope that politics would now see a more level playing field contestation between the NDA and its political rivals within and outside Parliament. The rapid implosion of the INDIA bloc implies a possible return to a more bruising politics where a domineering government will be tempted to flex its muscles once again in crushing all dissenting voices. An 'Opposition Mukt Bharat' is not what India needs.

# The myth of declining poverty

**UPDATING POVERTY BY TAKING INFLATION INTO ACCOUNT INSTEAD OF CHANGE IN COST OF LIVING OF DIFFERENT PERIODS IS A FLAWED METHOD** 

common method used to estimate poverty in India is based on the income or consumption levels and if the income or consumption falls below a given minimum level, then the household is said to be Below the Poverty Line (BPL). India has not estimated poverty since 2011-12. The Planning Commission which was calculating poverty based on calorie intake derived from the monthly per capita consumption expenditure (MPCE) data of NSSO has been dismantled. Niti Aayog, which replaced the commission. calculates poverty sporadically based on data from the National Household Family Survey.

Meanwhile, using the latest annual Household Consumption Expenditure Survey (HCES) data for August 2023-July 2024, SBI, in a report, claimed a significant decline in headline poverty ratio in rural areas to 4.86% in 2023-24 from 7.2% in 2022-23. Similarly, the poverty ratio in urban areas fell to 4.09% from 4.6% during the same period. Overall, the poverty rates in India could now be in the range of 4-4.5% with almost minimal existence of extreme poverty, the report said. The report estimated the monthly poverty lines

of weather.

in 2023-24 at Rs 1,632 (Rs 54.40 a day) for rural areas and Rs 1,944 (Rs 64.80 a day) for urban areas by adjusting for decadal inflation and the imputation factor in the poverty line set by the Suresh Tendulkar Committee in 2011-12. Earlier in 2011-12, an expert group headed by Tendulkar had estimated the poverty line at Rs 26 a day for rural areas and Rs 32 a day for urban areas. According to the committee, in India, 25.7% was BPL in rural areas whereas it was 13.7% in urban areas. As a whole, 21.9% were BPL in 2011-12.

However, updating poverty by taking inflation into account instead of change in cost of living of different periods is a flawed method. Further, the inflation measured through price deflator does not take into account hidden inflation. The rising cost of health, education and lifestyle expenses are not reflected in inflation.

Pronab Sen, former chief statistician of India, said that povertv lines are usually estimated by basing them on certain developmental norms, which keeps on improving as time progresses. Simply adjusting the Tendulkar line for inflation is completely wrong on account of the changes in consumption basket and the

difference in the methodology of earlier consumption surveys

Methodologically, the current HCES uses a modified mixed reference period in which the recall period for expenditure on items like edible oil, egg, meat, milk, vegetables and fruits is 'last 7 days'. For items like clothing, bedding, footwear, education, durable goods and medical, it is 'last 365 days'. For all other items, the recall period is 'last 30 days'. Earlier consumption expenditure surveys used the mixed reference period method in which only two categories of recall periods existed. Besides, the sampling methodology has also undergone a significant change in the current HCES. While discussing poverty, rarely the impact of transient poverty (TP) is discussed which leads to erosion of purchasing power of people. TP is different from chronic poverty, which is a long-term state of deprivation. TP is a temporary state of poverty that can be caused by external shocks, such as war, natural disasters, climate upheaval, global warming financial crises. pandemics, sudden changes in household conditions, such as ioblessness or inflation. Similarly, certain schemes may increase the income levels of poor temporarily and provide a false picture of reduced poverty. But when those schemes become unavailable, poverty goes up. The food

assistance scheme is one of them. The World Bank defines extreme poverty as living on less than \$2.15 per day in 2017 PPP terms. This line is based on the median national poverty line of 28 low-income countries. Now the World Bank says that almost 12.9 crore Indians are living in extreme poverty in 2024. As per UNDP's multidimensional poverty index, as of 2024, 23.9 crore Indians are plagued by multidi-

mensional poverty. The abysmal poverty is also reflected in other indices. More than half of India's total population (55.6%) is unable to afford a healthy diet, according to the UN State of Food Security and Nutrition in the World report published on July 24, 2024. India had 19.46 crore undernourished people between 2021 and 2023 This was 13.7 per cent of the total population. Hence, poverty should be redefined in monetary terms which can ensure a decent life.

# Illegal blasting threatens lives, livelihoods in Jajpur

Regular blasting for illegal stone mining in areas under Dharmasala tehsil has led to tremors in villages with houses and various infrastructures developing cracks

Jajpur, Jan 16: Illegal blasting for stone mining by some leaseholders and black stone traders in Dharmasala tehsil of Jajpur district has posed serious threat to life and properties of local residents.

Sources said illegal mining activities have gone from bad to worse in Dharmasala tehsil despite directives from the Director General of Mines Safety (DGMS) and the state mining department. Numerous leaseholders and black stone traders have been accused of extensive blasting, leading to life-threatening consequences for local

Villagers' protests against large-scale blasting at mines numbered 34/2020-21 and 36/2020-21 on Aruha hill, where over 10 feet deep pits were dug without safety precautions, Monday are cases in this point. Residents of Muraripur, Aruha, Jogada, Khunta, Thanuwal, Guarang, and Kantamalia villages have accused mine operators of carrying out illegal activities without appointing mines manager and ensuring necessary safety measures.

The issue extends beyond these villages. Reports indicate that approximately 50 unauthorised mines in Dharmasala tehsil operate day and night without leases, despite repeated calls for intervention and drawing the attention of the state Revenue minister. Even after Revenue officials and Dharmasala legislator raising the matter with authorities, little action has been taken to curb these operations. The MLA has urged the authorities to grant lease to the non-leased quarries

According to the district Minor Minerals department, there are 84 black stone mines in Dharmasala tehsil, of which only 22 have received clearance for mining with e-transit passes. Although qualified black stone mines have remained owners of operational mines are allegedly charging exorbitant prices, with boulder rates jumping from ₹250 per tonne to ₹500. This has made home construction and infrastructure development increasingly difficult for lower and middle-income groups.

In November, MLA Himanshu Sekhar Sahu wrote to the state ministers of Commerce and Transportation as well as Steel, and Mines, urging immediate corrective actions.

He demanded to prepare action plan as per norms and make the non-operational mines operational. However, reports suggest that certain officials and black stone operators are profiting from illegal activities, leading to allegations that mining leases are not being granted lawfully. This has reportedly resulted in significant revenue losses for the government.

There are indications that people are preparing for large-scale protests against illegal black stone mining in the coming days.

When contacted, Jajpur's Deputy Director of Mines, Jayaprakash Nayak, stated that necessary action will be taken regarding allegations of illegal blasting after conducting a proper investigation. Additionally, plans are underway to lease 20 to 22 mines in accordance with the law by February. Efforts are being made by the department to curb illegal extraction through raids and appropriate

# Many question 'lawlessness' in Mumbai

Mumbai, Jan 16: Film celebrities and politicians, including West Bengal Chief Minister Mamta Banerjee, Arvind Kejriwal and Chiranjeevi, expressed shock over the attack on Saif Ali Khan at his home in Mumbai with several others questioning lawlessness in the city.

The 54-year-old actor, who was injured after an intruder attacked him with a knife at around 2.30 am Thursday at his Bandra home, was hospitalised and underwent surgery. He is out of danger, his representative said. Banerjee and Kejriwal wished for the actor's speedy recovery in their social media posts.

"It's very concerning to hear about the attack on noted actor Saif Ali Khan. I pray for his speedy recovery, trusting that the law will take its course and those responsible will be held accountable. My thoughts and prayers are with Sharmila Di, Kareena Kapoor, and the entire family during this difficult time," Banerjee posted on X. Kejriwal said, "Shocked to hear about the attack on Saif Ali Khan. Wishing him a speedy recovery and strength to his family during this difficult time."

Shiv Sena UBT leader and Raiva Sabha MP Privanka Chaturvedi said the incident at Saif's residence is another "high profile attempt on life" after the firing outside superstar Salman Khan's home and the murder of NCP leader Baba Siddique. "The attack on Saif Ali Khan yet again raises questions on Mumbai Police & the Home Minister. This is after

Actor Pooja Bhatt tagged Mumbai Police in a post and questioned the "lawlessness" in the city, which is home to several celebrities as well as top industrialists.

subburbs, have never felt so unsafe before," she said. Chiranjeevi wrote, "Deeply Disturbed by news of the attack by an intruder on #SaifAliKhan. Wishing and praying for his speedy recovery.'

Imtiaz Ali, the director of Saif's 2009 movie "Love Aaj Kal", shared a picture of the actor on Instagram Stories and wrote, "My brave brother." Parineeti Chopra said,"Get well soon Saif.

Sonu Sood posted on X, "Saddened to hear about the unfortunate attack on Saif Ali Khan. My thoughts and prayers are with him for a swift recovery and a full return to health. Stay strong, brother. #SaifAliKhan" Actor and BJP MP Ravi Kishan, who worked with Saif on films such as "Agent Vinod"

"Praying for Saif's speedy recovery. #SaifAliKhan," he wrote on X

Actor Neil Nitin Mukesh wrote, "My prayers with Saif sir and the entire family. This is very sad indeed!! May your bravery and love for your familv be rewarded with healing. strength, and peace. Get well soon." The intruder fled from the spot following the incident which took place at Saif's 12th floor house in Satguru Sharan building in Bandra area.

The actor's representatives described the incident as an "attempted burglary" though police were yet to comment on it. No person has been arrested so far, a senior police official said. After Khan's medical procedure, his team said the actor has come out of the surgery and is out of danger.

# Prashant Kishor ends fast unto death after 14 days

Patna, Jan 16: Jan Suraaj Party founder Prashant Kishor Thursday withdrew his fast unto death after 14 days of protest over alleged irregularities in a competitive exam conducted by the Bihar Public Service Commission December 13 last year.

However, the former political strategist said his 'Satyagraha' would continue for the cause of civil service aspirants, and the youth of the state and also against the alleged 'authoritarian' attitude of the state government. "The matter, seeking the

cancellation of the BPSC's 70th Combined Competitive exam held December 13, is being heard by the Patna High Court today. It is a coincidence that I am calling off my fast unto death on a day when the matter is being heard before the court. We are quite hopeful that job aspirants will get justice from the Patna High Court. If they don't get justice, we will knock on the door of the Supreme Court," Kishor said.

Before withdrawing his fast unto death at the party's camp office here, Kishor took a dip in the Ganga river and offered puja. Kishor was offered fruit juice by his party workers as he withdrew from the hunger strike.

The party has set up its camp office at LCT Ghat on the bank of the Ganga river. "Now, my 'Satyagraha' will continue from



the Jan Suraaj party office here. We call it 'Bihar Satyagraha Ashram'. We will train at least 1 lakh students at this ashram till March 11," he said.

These trained students will create awareness among the people against the alleged injustice being faced by the socially weaker sections of the society and the youth, he claimed. "I condemn the baton charge and police action against the protest ing students in Bihar. The Jan Suraaj Party will file a criminal writ petition in the next two days against those bureaucrats who are behind the police action against the job aspirants. We will also go to the Human Rights Commission against the officials," Kishor said.

He also claimed, "Our 'Satyagraha' will also continue against the authoritarian attitude of the Nitish Kumar government, which has not said even a single word so far on students demands." Kishor also said the Bihar governor and the chief secretary met the protesting students, but "the CM never bothered to meet them".

#### GRAP 4 curbs lifted in Delhi-NCR

New Delhi: The Centre's panel on Delhi-NCR's air quality Thursday revoked curbs under stage 4 of the Graded Response Action Plan (GRAP) amid dip in pollution levels, according to an official order. The curbs were imposed Wednesday as calm winds, low temperatures and foggy conditions allowed accumulation of pollutants in the region, with the air quality index clocking 396 last evening. Stage 4 curbs include a ban on all construction activities, entry of non-essential polluting trucks into Delhi, and mandatory shifting of school classes, except for Classes X and XII, to hybrid mode. Non-essential diesel trucks are prohibited from entering Delhi, while Delhi-registered BS-IV and older diesel-run heavy goods vehicles are banned, except for essential services under Stage 4.

#### Court notice to Atishi, Sanjay Singh

New Delhi: A court here Thursday issued notice to Chief Minister Atishi and AAP MP Sanjay Singh on a criminal defamation complaint filed by former Congress MP Sandeep Dikshit. Additional Chief Judicial Magistrate Paras Dalal said the matter was at the stage of cognisance and as per law, Atishi and Singh were to be given the opportunity of being heard. The judge directed the AAP leaders to file a reply by January 27, when the court will further hear the matter. "Matter is at the stage of cognisance and in compliance of the first proviso to section 223 BNSS, the proposed accused persons are to be given the opportunity of being heard. Accordingly... let notice be issued to both proposed accused persons returnable for January 27, 2025," the judge said.

#### Coal scam: Justice Viswanathan recuses himself

New Delhi: Supreme Court judge Justice K V Viswanathan Thursday recused himself from hearing coal scam cases, paving way for a fresh three-judge bench to decide a crucial issue arising from previous orders that barred the high court from entertaining appeals. The apex court passed two orders in 2014 and 2017 restricting the accused from approaching the high court and had directed that appeals against trial court proceedings in the coal scam cases could only be filed in the top court. The intent behind the orders was to expedite trial processes by preventing delays and to stall the proceedings by the accused seeking relief in high courts. While taking up the pleas seeking modification of its earlier orders, a bench comprising Chief Justice Sanjiv Khanna and Justices Sanjay Kumar and Viswanathan, at the outset, said a fresh bench will be set up to decide the issue in the week commencing February 10.

## Nutritional support could prevent TB deaths, cases by 2035: Study

New Delhi, Jan 16: In India, providing nutritional support to half the households with individuals undergoing tuberculosis (TB) treatment could prevent roughly 4.5 per cent TB-related deaths and 2.2 per cent of disease episodes by 2035, a modelling study has found.

The study, published in The Lancet Global Health journal, estimated that more than 3.6 lakh deaths and over 8.8 lakh TB cases could be averted through such intervention. Typically, about 24 households would need to be treated of tuberculosis to prevent one death, while 10 would need to be treated to prevent one case, researchers, including those from the Indian Council of Medical Research (ICMR)-National

(NIRT), Chennai, estimated. The nutritional interven-

tion could have an additional cost of about \$1,349 million on the health system, with potential benefits of \$167 for every disability-adjusted life-year averted, they projected.

'Disability-adjusted life-year' is a metric that helps measure overall burden of disease. The researchers said that about a fifth of the world's tuberculosis incidence is attributable to undernutrition, with the ratio increasing to more than a third in India. A 2023 study, published in

The Lancet journal, by the same research team had enrolled household contacts of 2,800 patients with tuberculosis across 28 units of the National Tuberculosis Elimination Programme in four districts of Jharkhand. The patients re-

ceived food rations of 1,200 kilograms of protein per day with calories (52 grams of protein per micronutrients). day with micronutrients) for six months, with their household two-year follow up period, tucontacts receiving monthly berculosis incidence in a house-

Results showed that over a

support to household contacts of the infected. In this study, the researchers used the 2023 study's model to inform estimates of the impact and costs of nutritional support. Providing nutritional support is likely to have substantial health and economic benefits among the households willing to pay, even at the national level, they said. A higher fraction of the tuberculosis burden could be averted by focussing on states having high levels of undernutrition, further improving the value for money the authors added. A December 2024 study, pub

lished in the journal PLoS Medicine, estimated over 62 million cases of tuberculosis and eight million deaths in the two decades up to 2040, along with a Gross Domestic Product (GDP) loss of more than \$146 billion.

However, improving case detection rates and meeting the World Health Organization's End-TB target of 90 per cent could reduce disease burden by 75-90 per cent, and macroeconomic burden by \$ 120.2 billion. the study projected.

well countries are equipped to meet the evolving demands of the international job market by measuring four main points --Skills Fit, Academic Readiness, Future of Work, and Economic Transformation.

"In this new index, India places 25th overall when all four indicators are combined, and is recognised a future skills contender. Additionally, India excels in the Future of Work indicator, securing the world's second-highest score (99.1), trailing the US by less than a point as the overall



leader in the index," QS said in a statement. Prime Minister Narendra Modi lauded India's

Future Skills Index

"This is heartening to see! Over the last decade, our strengthening our youth by equipping them with skills that enable them to become self-reliant and create wealth. be built at the Satish Dhawan Space Centre at Sriharikota and will be capable of putting 30,000 tonne spacecraft in low earth orbit as against the existing capabilities of 8,000 tonnes as India eyes a larger pie in the global space economy. The Union Cabinet, at a meeting chaired by Prime Minister Narendra Modi, approved the setting up of the third launch pad at a cost of ₹3,985 crore in the next four years with maximum participation from the industry, Information and Broadcasting Minister Ashwini Vaishnaw said. Organisation (ISRO) is also developing the Next Generation Launch Vehicle (NGLV) which will be 91 m in height, taller than the 72-m tall Qutub Minar. It will also be able to support scaled up configurations of NGLV

#### China offers to invest \$3.7bn in SL oil refinery

Beijing, Jan 16: China has offered to invest \$3.7 billion in Sri Lanka, stated to be the biggest-ever foreign investment in the island nation, to build a state-of-the-art oil refinery as the two countries signed a new plan to upgrade BRI cooperation during Sri Lankan President Anura Kumara Dissanavake's state visit here.

Dissanayake met Chinese Premier Li Qiang and Chair man of the Standing Committee of the National People's Congress Zhao Leji Thursday and pitched for more Chinese investment in his address to

A day earlier, Dissanayake held talks with his Chinese counterpart Xi Jinping following which the two sides signed 15 agreements.

According to a press release by the Sri Lankan President's media division, his visit marked a significant milestone by securing the largest foreign direct investment to date of \$3.7 billion Chinese investment to build a state-of-the-art oil refinery at Hambantota.

"This significant achievement was formalised this morning with the signing of an agreement between Sri Lanka's Ministry of Energy and Sinopec, a

#### leading Chinese international petroleum corporation," it said. The refinery will have a capacity of two lakh barrels.

#### **Detained Yoon** refuses questioning, challenges arrest

#### Standoff in SA ends with 87 dead miners

Stilfontein, Jan 16: The death toll in a monthslong standoff between police and miners trapped while working illegally in an abandoned gold mine in South Africa has risen to at least 87, police said Thursday.

Authorities faced growing anger and a possible investigation over their initial refusal to help the miners and instead "smoke them out" by cutting off their food supplies. National police spokesper-

son Athlenda Mathe said that 78 bodies were retrieved in a court-ordered rescue operation, with 246 survivors also pulled out from deep underground since the operation began Monday. Mathe said nine other bodies

had been recovered before the rescue operation, without giving details Community groups launched

their own rescue attempts when authorities said last year they would not help the hundreds of miners because they were "criminals." The miners are suspected to

have died of starvation and dehydration, although no causes of death have been released

South African authorities have been fiercely criticised for cutting off food and supplies to the miners in the Buffelsfontein Gold Mine last year. That tactic to "smoke them out," as described by a prominent Cabinet minister, was condemned by one of South Africa's biggest trade unions. Police and the mine owners

were also accused of taking away ropes and dismantling a pulley system the miners used to enter the mine and send supplies down from the surface.

A court ordered authorities last year to allow food and water to be sent down to the miners, while another court ruling last week forced them to launch a rescue operation.

Trump wasted no time in asserting he was the moving force behind the deal, whose final details were still being ironed out, according to Israeli Prime Minister Benjamin Netanyahu's office.

"This EPIC ceasefire agreement could have only happened as a result of our Historic Victory in November, as it signaled to the entire World that my Administration would seek Peace and negotiate deals to ensure the safety of all Americans, and our Allies," Trump wrote on social media. "I am thrilled American and Israeli hostages will be returning home to be reunited with their families and loved ones.

Trump added that his incoming Mideast envoy, Steve Witkoff, would continue "to work closely with Israel and our Allies to make sure Gaza NEVER again becomes a terrorist safe

Biden stressed in a statement that a deal was reached under "the precise contours" of a plan that he set out in late in May.

"It is the result not only of the extreme pressure that Hamas has been under and the changed regional equation after a ceasefire in Lebanon and weakening of Iran — but also of dogged and painstaking American diplomacy," Biden said.

#### "My diplomacy never ceased in their efforts to get this done.'

Later in remarks at the White House. Biden said his administration negotiated the deal but that Trump's team will soon be charged with making sure it's implemented, a nod to Witkoff being a partner in the talks. "For the past few days, we

have been speaking as one team," Biden said. Nancy Okail, head of the US

based Center for International Policy, said acceptance of the deal in the face of Trump's insistence that a ceasefire be in place when he takes office next week "ironically shows how effective actual pressure can be in changing Israeli government behavior.'

Jonathan Panikoff, director of the Scowcroft Middle East Security Initiative at the Atlantic Council, said Biden deserves praise for continuing to push the talks despite repeated failures. But Trump's threats to Hamas and his efforts through Witkoff to "cajole" Netanyahu deserve credit as well, he said.

"The ironic reality is that at a time of heightened partisanship even over foreign policy, the deal represents how much more powerful and influential US foreign policy can be when it's bipartisan," he said. "Both the outgoing and incoming administration deserve credit for for this deal and it would've been far less likely to happen without both pushing for it."

New York, Jan 16: Disappointment, denial and confusion flooded US TikTok Wednesday upon hearing the news that Chinese owner ByteDance planned to shut off the app for its 170 million US users by Sunday, seemingly throwing in the towel on efforts to keep the popular video-sharing platform going.

Users who have amassed fol-



hoped for months that TikTok would find a way to avoid a US ban passed into law in 2023. But resignation and anger have begun to set in, with Jan 19 just a few days away.

### **UK's Starmer arrives in** Ukraine for security talks

Kyiv, Jan 16: British Prime Minister Keir Starmer arrived in Ukraine's capital Thursday with a pledge to help guarantee the country's security for a century, days before Donald Trump is sworn in as US president. The British government says Starmer and Ukrainian President Volodymyr Zelenskyy will sign a "100-Year Partnership" treaty in Kyiv covering areas including defence, science, energy and trade.

Starmer's unannounced visit is his first trip to Ukraine since he took office in July. He visited the country in 2023 when he was Opposition leader, and has twice held talks with Zelenskyy in London since becoming prime minister. On a gray and frosty morning, Starmer was greeted at Kyiv railway station by the UK ambassador to



Ukraine, Martin Harris, and Ukraine's envoy to London Valerii Zaluzhnyi. The UK, one of Ukraine's

About 225 million investors currently invest via systematic investment plans (SIP) but a maiority are from big cities. Introducing bite-sized SIPs would help take financial investments to smaller towns, which will give fund houses new markets to expand to. The regulator hopes to build

to deliver robust growth in 2025, and South Asia, particularly India, is also expected to maintain strong growth. The outlook for Europe remains gloomy, with 74 per cent of respondents predicting weak or very weak growth this year. The outlook for China also

remains weak, and growth is projected to slow gradually in the years ahead, the WEF said

#### **Economy to grow** at 6.4%, says FICCI

New Delhi, Jan 16: Industry body FICCI Thursday lowered India's growth projection for the current financial year to 6.4 per cent from 7 per cent es timated earlier.

According to FICCI's Economic Outlook Survey, the revised projection is in line with the broad expectations and reflect a notable slowdown visà-vis 8.2 per cent GDP growth recorded in 2023-24.

"...FICCI's Economic Outlook Survey projects an annual median GDP growth forecast of 6.4 per cent for 2024-25. The forecast in the current survey marks a moderation from 7.0 per cent estimate (for 2024-25) put out in the previous round conducted during the month of September

last year," it said. The survey was conducted in December 2024 and drew responses from leading economists representing industry, banking and financial services sector.

The participating economists observed global economy in 2025 to present a reasonable growth trajectory, with an underlying note of caution.

Sharing their perspective on the expected impact of US Presi-

dent Donald Trump's policies on the Indian economy, the economists indicated the possibility of short-term disruptions through channels like exports, foreign capital flows, and input costs for the US trading partners including India. The Union Budget for 2025-26, set to be presented February 1, arrives amidst global economic uncertainties and moderating domestic growth.

# EV onslaught in 2025 despite slowing global demand

New Delhi, Jan 16: Automakers operating in India plan to launch close to a dozen new electric car models this year, many in the premium market, with longer driving ranges and faster charging times, to attract buvers as demand for EVs slows down globally.

Electric cars will take centre stage at India's five-day auto show in New Delhi starting Friday with models from new Vietnamese entrant Vinfast shown alongside domestic brands Maruti Suzuki and Mahindra & Mahindra as well as global rivals BYD, Toyota and Hyundai.

India's EV market leaders Tata Motors and JSW-MG Motor, part-owned by China's tighter emission norms starting from 2027 are forcing a move to cleaner cars India's EV market is small,

with electric models making up about 2.5% of the 4.3 million cars sold in 2024 as high prices and a patchy charging network hold back buyers. The government wants to grow this to 30% by 2030.

Globally, electric car sales growth slowed to 13% in 2024 from a year ago but crossed 10 million units for the first time, according to data from research firm RhoMotion.

### **BCCI** unveils 10-point diktat

New Delhi, Jan 16: Mandatory domestic cricket, restriction on the presence of families and personal staff on tours and a bar on individual endorsements during series were among a slew of measures that the BCCI unveiled Thursday in a 10-point policy to promote "discipline and unity" in the embattled national cricket team.

Non-compliance would invite sanctions, including cuts in their retainer fee from central contracts and a bar on participating in the cash-rich Indian Premier League. The measures have been announced in the wake of the team's disastrous tour of Australia which was preceded by a series whitewash against New Zealand at home.

The Board has approved only a two-week window for families to stay with the players during overseas tours, besides imposing restrictions on personal staff, and commercial shoots.

The document also states that from now on, players won't be allowed to travel separately during a tour and would also be discouraged from leaving early in case a tour or a match ends early.

# Kalinga Lancers trounce Delhi SG Pipers

Rourkela, Jan 16: Dutchman Thiery Brinkman struck a brace as Vedanta Kalinga Lancers defeated Delhi SG Pipers 5-1 in a men's Hockey India League match here Thursday.

Brinkman scored two field goals in the 38th and 43 minutes, while Nicholas Bandurak (11th), Arthur van Doren (36th) and Gursahibjit Singh (45th) were the other goal getters for Kalinga Lancers.

Delhi SG Pipers' lone goal was scored by Corey Weyer in the 46th minute. Delhi SG Pipers are currently languishing at the bottom of the eight-team table with four points from seven games.

The win, however, propelled Kalinga Lancers to the third spot with 10 points from seven games.

Delhi SG Pipers started on the front foot and secured the first pen-



alty corner of the match in the fourth minute, only to be denied by Kalinga Lancers goalkeeper Krishan Baha-

While Delhi had the better share of possession in the first quarter, it was Kalinga Lancers who struck first in the 11th minute from a counter attack through Nicholas Bandurak's strike from a field effort.

Down by a goal, Dehi SG Pipers continued to attack and won a penalty corner soon but Gareth Furlong's flick was saved by an alert Pathak. Shamsher looked to score off a rebound but missed.

Kalinga Lancers doubled their lead in the 36th minute through Arthur Van Doren, who scored with a perfect deflection from a penalty corner past Delhi SG Pipers keeper Pawan.

Kalinga Lancers extended their lead two minutes later through Brinkman who stole the ball and sent it past into the net from a one-on-one situation with Pawan.

The Lancers scored their fifth goal two minutes later through Gursahibiit Singh, who finished the move with a simple tap-in.
