12 run over by train as passengers jump on tracks after fire rumour

Jalgaon, Jan 22: At least 12 passengers were killed Wednesday evening when they jumped from their Mumbai-bound train in panic due to a false fire alarm, only to be tragically run over by another train on the adjacent tracks here, officials said.

The tragedy unfolded when passengers onboard the 12533 Lucknow-Mumbai Pushpak Express, fearing a blaze when sparks flew from the train's wheels, hastily jumped onto the adjacent tracks and were run over by the oncoming Karnataka Express heading from Bangalore to Delhi, they said.

As many as 15 other passengers were injured in the accident, which took place between Maheji and Pardhade stations near Pachora town in North Maharashtra's Jalgaon district, when Pushpak Express halted after someone pulled the chain around 4.45pm, Central Railway officials said.

Chief Minister Devendra Fadnavis announced financial assistance of Rs 5 lakh each to the next of the kin of the passengers who died in the tragedy, while the Commissioner of Railway Safety, Central Circle, will probe the circumstances leading to the accident.

Tokyo, Jan 22: A solitary sunfish at an aquarium in southwestern Japan lost its appetite, began banging into the side of the fishtank and appeared unwell days after the facility closed last month for renovations. As a last-ditch measure to save the popular fish, its keepers hung their uniforms and set up human cutouts outside the tank.

The next morning, the sunfish ate for the first time in about a week and has been steadily recovering, said Moe Miyazawa, an aquarist at the Kaikyokan aquarium in Shimonoseki.

The large sunfish arrived at the aquarium in February 2024 from the southern coast of Kochi in the Pacific



Ocean. The sunfish, a member of the blowfish family known for its unique shape and big eyes, became one of the most popular attractions at the facility.



ODISHA CONSTITUTES 6TH STATE FINANCE COMMISSION

Bhubaneswar: The Odisha government Wednesday constituted the sixth State Finance Commission ahead of the visit of the 16th Finance Commission in the first week of February. A notification by the Finance department said retired IAS officer Arun Kumar Panda will be the chairman of the State Finance Commission. Professor Asit Ranjan Mohanty of XIMB, Professor Amaresh Samantray of the department of Economics, Pondicherry University, and Professor Bibhu Prasad Nayak of TISS will be its members, while Dr Satya Priya Rath, additional secretary, Finance department will be the member secretary. The chairman and other members of the commission including member secretary will remain in office for a period of six months, the notification said

Cabinet nod: Model school in each GP

Bhubaneswar, Jan 22: The state Cabinet, chaired by Chief Minister Mohan Charan Majhi, Wednesday approved upgradation of one government-run primary school in each of the 6,794 gram panchayats in the state to model school under Godabarish Mishra Adarsh Prathamik Vidyalaya (GMAPV) scheme.

Speaking to reporters after the Cabinet meet, Majhi said, "Government-run primary schools in 6,794 gram panchayats of Odisha will be upgraded to model schools under GMAPV scheme. The state government will spend Rs 11,939.41 crore towards upgradation of these schools over five years, from 2024-25 to 2028-29."

The estimated cost per school ranges between Rs 1 crore and Rs 4 crore.

Barang, Jan 22: An elephant calf that had fallen into a pit in Karanjia Forest Division and was rescued and later shifted to Nandankanan Zoological Park succumbed to its injuries in the wee hours of Wednesday.

The five-year-old elephant calf with severe spinal injuries was brought to the City zoo Jan-

uary 6 for treatment.

The injuries had left the calf's hind legs paralyzed, making it unable to stand or move properly, according to sources. Subsequently, the calf also suffered from paralysis. Upon arrival at Nandankanan, veterinarians and specialists conducted blood



tests and X-rays, which confirmed the paralysis.

As per expert recommendations, the calf was placed in a sling to relieve pressure on its limbs and aid recovery.

Despite feeding on grass, leaves, and banana plants, the elephant faced severe constipation, which required veterinarians to manually clear its bowels at regular intervals.

Several efforts made to rehabilitate the elephant proved futile. Health assessments conducted by Nandankanan Health Committee January 6 and 16 showed no signs of improvement in its condition.

Despite dedicated efforts of the veterinary team and experts, the elephant's health continued to deteriorate, eventually leading to its death late Tuesday night.



been exposed to some form of online sexual abuse or exploitation in the past year, according to a study published in 'The Lancet Child and Adolescent Health' journal Researchers, including from the University of Edinburgh in

UK, analysed 123 recent studies conducted in 57 countries to build a global picture.

To understand the prevalence and nature of online child sexual abuse and exploitation, the study identified four subtypes -- online sexual exploita-



tion (4.7 per cent global prevalence), sexual extortion (3.5 per cent), image-based sexual abuse and online solicitation. It was found that one in eight

children globally was affected

by image-based sexual abuse on the internet (12.6 per cent). Roughly the same number was found to be subjected to online solicitation (12.5 per cent) -- being persuaded into sexual activity or exposure.

"One in 12 children globally was subjected to at least one form of online sexual exploitation or abuse in the past year," the authors wrote.

However, in regions, including South Asia, where current evidence is either limited or non-existent, the team called for more research.

'East Asia, North Africa, Middle East and South Asia are lacking prevalence data; these regions constitute a large percentage of the global population of children so there is an urgent need for research at a national level in these regions," they wrote.

The findings pointed to the

need for increased legislation and primary prevention efforts to keep children safe.

Further, the researchers found no significant difference between the experiences of girls and boys with respect to online sexual victimisation from representative surveys, in contrast to previous evidence suggesting girls being more vulnerable than boys.

The authors proposed that changes in online environments may have increased victimisation rates for boys. They added that previous definitions of sexual exploitation involving contact do not hold true for online environments.

Sambalpur: Loss of greenery sparks concern Tepid response to bandh

Sambalpur, Jan 22: Even though the Forest department has been spending crores of rupees annually on conservation of greeneries, Sambalpur district has witnessed a steady decline in forest cover, raising concerns among nature lovers and environmentalists.

According to the India State of Forest Report (ISFR) 2023, released by the Union Minister for Forest and Environment Bhupender Yadav last month, Odisha has witnessed an increase by 152 sq km forest cover. However, Sambalpur district recorded a loss of 31.27 sq km jungles. Despite this decline, forests still account for 49.88 per cent of the district's total land area, said the report.

The ISFR, published biennially by the Forest Survey of India (FSI), reported that the district has a total forest area of 3,320.29 sq km out of 6,657 sq km surveyed. Of this, 536.47 sq km is classified as dense forest. A breakdown of the forest

divisions will reveal the truth. Out of 2,254 sq km surveyed in Sambalpur Sadar forest division, 745.87 sq km (33.09%) is forested area. However, the division has suffered a 12 per cent loss in forest area.

Out of 2,050 sq km surveyed in Redhakhole forest division, 1,402 sq km (68.39%) is forested area. Despite this relatively high coverage, the division lost 1.95 sq km forest area.



Bamra wildlife division, where 2,351 sq km were surveyed, has lost 18 sq km, as compared to the previous survey, and is now left with 1,172 sq km (49.84%) forest area. The decline in forest cover is

largely attributed to the raging wildfires as data shows that 2,248 forest fire incidents were reported in 2022-23, as against 692 incidents in 2023-24. Although the number of fires decreased, the damage caused to the district's forests remains bigger.

Regional Chief Conservator of Forests (RCCF) for Sambalpur Circle T Ashok Kumar acknowledged the decline in open forest areas. However, he highlighted that both dense and minor forests in the district have increased.

According to 2023 data, dense forests in the district have expanded by 492.67 sq km, as compared to 2021, while minor forests have grown by 1,514.70 sq km. In contrast, open forests continue to decline, partly due to government development activities and recurring forest fires.

"The exact reasons behind forest depletion are complex and require a detailed study, Kumar said, while stressing the importance of raising awareness and implementing timely measures to address the issue effectively.

The growing loss of forest cover calls for urgent intervention to protect the district's ecological balance and biodiversity.

State Highway 10 (Biju Expressway) was blocked by KS members, who staged a sit-in near Patrapalli crossing. As a result, buses from interior areas were largely off the roads. However, the police facilitated the movement of some vehicles to prevent congestion and minimize passenger inconvenience. The primary demand of the

KS is for swift action by the district administration to rescue the 90 girls who were allegedly trafficked to Tamil Nadu. KS general secretary Dilip Panda criticised the administration's indifferent approach, saying, "Over 90 girls have been taken to Tamil Nadu. Their parents want them back. Despite sit-in demonstrations and discussions with the District Collector, the administration has shown a casual attitude toward the plight of these parents."

Reports indicate that a private organisation had trained the girls in skills such as stitch-

ing and initially moved them to Cuttack before taking them to Tamil Nadu. Parents claim the girls have since reported being exploited and harassed.

Following the protests Sundargarh Collector Manoj Satyawan Mahajan engaged with the organisation responsible for the girls' relocation Mahajan reportedly urged the organisation's owner to take immediate action and repatri ate the girls. However, when he visited Tamil Nadu and at tempted to resolve the issue he faced threats and did not receive a satisfactory response from the organisation. The KS has vowed to continue its agi tation until concrete steps are taken to bring the girls back and ensure their safety.

Trap laid by poachers claims couple's lives PRESS TRUST OF INDIA Koraput, Jan 22: A man and

his wife lost their lives inside a forest in Koraput district after coming in contact with a live wire, suspected to have been laid by poachers targeting wild animals, police said Wednesday.

Balaram Galel and his wife Bala were running a roadside tea stall, and had gone to the forest in the Nandapur police station area Monday evening to get firewood, they said. When they did not return home, their family and neighbours started searching for them.

"They found the bodies in the forest entangled in live electric wires, apparently laid by poachers as animal traps," a police officer said.

"The bodies have been recovered and sent for post-mortem examinations. Efforts are underway to arrest those responsible for laying the wires," he said.

whe standard interpretation of the Russia-Ukraine war is that it is a "clash of cultures" pitting Western liberalism against traditional Russian authoritarianism. But this is deeply misleading. Far from being a traditionalist, Vladimir Putin is merely the latest in a series of murderous modernisers stretching from Ivan the Terrible and Peter the Great to Catherine the Great and Stalin.

When Stalin was asked to define Bolshevism in the late 1920s, he described it as a combination of Russian dedication to a Cause and American pragmatism. Once in power, he sought to imitate the American industrialist Henry Ford's achievements throughout the Soviet Union, brutally erasing all traces of Russian tradition through, most prominently, the violent collectivisation of agriculture

Stalin was also a great admirer of Peter the Great, who built a new capital for Russia on the Baltic Sea (St. Petersburg) to establish a direct link with Western Europe. Peter's reforms faced resistance from socalled Old Believers, Eastern Orthodox Christians whose liturgical and ritual practices predated the reforms carried out by Patriarch Nikon of Moscow in 1652-66. Many Old Believers ultimately chose death over compromising their faith. Between the seventeenth and nineteenth century, thousands died by self-immolation.

Things only really changed in Russia with the October Revolution;

and even then, the first Soviet government included several prominent figures with Old Believer backgrounds. The Bolsheviks correctly saw such sectarians as representatives of a long-running social protest against the czarist regime. The Old Believers had always distrusted the unity of church and state (which really meant the former's subordination to the latter), insisting that the religious community remain a self-organisation of common people.

Not surprisingly, state persecution of religious believers intensified under Stalin, and the Orthodox Church's subordination to the state continues to this day. Putin, indeed, has mobilised the Church for his own political ends. According to Patriarch Kirill of Moscow. Russians need not fear nuclear war, because Christians should welcome the end of the world. "We await the Lord Jesus Christ who will come in great glory, destroy Evil, and judge

all nations," he said late last year. Thus, what appears as a reactionary move – a return to the old orthodoxy – may in fact be a perverted expression of the rejection of the domination and exploitation that passes under the guise of "modernization" in the temporal world.

A very different, but illustrative, example of such resistance is Canudos, the nineteenth-century outlaw community deep in the Brazilian backlands of Bahia, which became a home to prostitutes, beggars, bandits, outcasts, and the poor under the leadership of the apocalyptic prophet Antônio Conselheiro. According to Eduardo Matarazzo Suplicy of the Workers' Party of Brazil: "This community developed a 'mutual, cooperative and solidary concept of work' ... a kind of socio-mystical, religious, assisting, community power inspired by the 'equalitarian fraternity of the primitive Christian communism.' in which there was no hunger. 'They all worked together. Nobody had anything. Everybody worked the soil, everybody labored. Harvested... Here's yours... Here's yours. Nobody got more nor less.' Conselheiro had read Thomas More, and his experiences were similar to those of utopian socialists Charles Fourier and Robert Owen. Canudos was razed by the Brazilian army, and Conselheiro was beheaded in 1897." (He had already died of illness.)

This refuge from money, property, taxes, and marriage did not disintegrate because of its internal tensions; it was destroyed by the armed forces of Brazil's "progressive" and secular government. Canudos was a place where the victims of historical progress had acquired a space of their own. Utopia actually existed for a brief moment, and that was too much for the modernisers. How else can one account for the slaughter of all inhabitants of Canudos, including women and children? The very memory of freedom had to be erased.

and humane schedules, leading to landmark movements such as the Haymarket Affair in Chicago in 1886. These protests laid the foundation for labour laws advocating the 8-hour workday and reasonable weekly working hours. In 1919, the International Labour Organization (ILO) enshrined the 8-hour workday into international labour standards, and it gradually became a norm in many countries. Similarly, the concept of weekly off for employees in India traces back to colonial times, influenced by the Factories Act of 1881. Initially limited to industrial workers, the act aimed to regulate working hours and included provisions for rest days. The Factories Act of 1948 formalised a weekly holiday for workers, mandating one day of rest for every six days of work promoting work-life balance and employee welfare.

Despite these hard-won rights. the modern era has witnessed renewed debates over working hours, with business leaders offering divergent views. Recent controversial statements by NR Narayana Murthy, founder of Infosys, advocating for 70-hour workweeks, and SN Subrahmanyan, Chairman of L&T, pushing for 90-hour weeks, have sparked nationwide discussions. These remarks, seen by many as regressive, undermine decades of progress and risk eroding work-life balance, a cornerstone of modern employment ethics. The debate around work-life balance is polarised, with influential leaders presenting contrasting views. On one side, Murthy dismisses the concept of

work-life balance, emphasising the need for hard work to drive economic growth. Subrahmanyan expressed regret over not making employees work on Sundays, reflecting a mindset focused solely on organisational productivity. On the other side, Anant Goenka of RPG Group champions a balanced approach, advocating for time allocated to family, health, and work. Sagar Adani from Adani Green Energy highlights "work-life harmony," a nuanced concept emphasising seamless integration rather than strict separation. Similarly, Torrent Power's Jinal Mehta supports a five-day workweek and flexible work-from-home options, and Nyrika Holkar from Godrei & Bovce emphasises creating engaging jobs to maintain employee satisfaction.

Working hours vary significantly across countries, reflecting differing economic structures, labour laws, and cultural norms. Developed nations such as Germany, Norway, and the Netherlands boast some of the shortest average working weeks, typically around 35-40 hours. Germany, for example, prioritises productivity over long hours, emphasizing quality over quantity. In contrast, developing economies like India, China, and Brazil often see extended workweeks exceeding 45-50 hours. Economic pressures and lack of stringent labour regulations contribute

to these longer hours, often at the cost of employee well-being. The disparity in working hours underscores the need for global standards that prioritise employee health and productivity while addressing the unique challenges of each economy.

Extended working hours and failure to achieve work-life balance have severe repercussions across sectors. According to the World Health Organization (WHO), overwork is linked to a 35% higher risk of stroke and a 17% higher risk of heart disease. In Japan, the phenomenon of "karoshi," or death by overwork, claims approximately 2,000 lives annually, with victims suffering from heart attacks, strokes, or suicide due to excessive hours. A 2022 study by the Pew Research Centre found that 42% of employees in the US who quit their jobs cited burnout as a primary reason. In India, similar trends are emerging, with voluntary retirements and resignations rising sharply across sectors. A 2023 report by the National Institute of Mental Health and Neurosciences revealed that 45% of corporate employees experience symptoms of burnout, with 23% reporting severe mental health issues. Additionally, a survey conducted by LinkedIn found that 63% of Indian professionals prioritise work-life balance when seek ing new jobs, underscoring its importance in retaining talent.

To address these challenges governments and corporations must act decisively. Establishing a uniform workweek of 40 hours across sectors, aligned with global best practices, would be a significant step forward. The government should mandate a maximum five-day workweek to standardise practices and enforce stringent regulations against overwork, ensuring employees are not coerced into extended hours. Flexible work policies, such as remote work and part-time options, should be encouraged to cater to diverse employee needs. Mental health support programmes, including counselling services and stress management workshops, should be made mandatory in workplaces. Furthermore, organisations that implement progressive work-life balance policies should be rewarded with tax benefits or public recognition, incentivising

others to follow suit. Today, as debates around extended workweeks resurface, it is essential to reaffirm the principles of work-life balance which is not just a moral imperative but a practical necessity for sustainable development. Balanced work environments enhance productivity, attract and retain talent, and promote mental health. Research conducted by Stanford University revealed that productivity per hour declines sharply when the workweek exceeds 50 hours, with virtually no productivity gains beyond 55 hours. Thus, governments and corporations must create environments where employees thrive without compromising their health and personal lives. The future of work must prioritise quality over quantity, ensuring that progress does not come at the cost of humanity. Achieving this balance is not just a need of the hour but a responsibility toward the workforce that drives the global economy.

While the economy is suffering from food inflation and economists seek a boost to consumption expenditure, lagging for months. Modi recently referred to a State Bank of India survey which reportedly showed urban-rural gap in the monthly per capita consumption expenditure (MCPE) having declined to 70% in 2023-24 from 84% in 2011-12. This reduction does not. in any way, show that rural incomes have increased, and consumption has shown an uptrend. On the other hand, it can be said that urban incomes may not have increased. Moreover, the real picture will come out if the average incomes of the lower segments of both urban and rural areas - say 40% of the total – are considered. This is necessary to reveal the distressing scenario in rural sector and plan accordingly and allocate funds realistically. The survey showed that MCPE in rural India increased

from Rs 1430 in 2011-12 to Rs 4122 in 2023-24 without taking into account the inflationary increase in these 10 years. Here too there's need to segregate the incomes of the economically weaker sections to find out whether their incomes have truly increased. There is no need to rejoice at the slight increase in MPCE for a country aspiring to reach a developed status. Even FMCG companies are talking about sales remaining stagnant for a few years. All this is obviously because incomes have not increased. Let us take the example of midday meal cooks, whose salaries have remained unchanged at Rs 1000 per month since fixed way back in 2009. Adjusted for inflation. the value of this amount comes to a mere Rs 540 per month. The actual money they get depends on how much the state government is willing to enhance. While Kerala pays the highest at Rs 12.000, in many others such as Delhi, Goa and some north-eastern states it remains Rs 1000. In the private sector, due to the critical job scenario, there is an insignificant annual increase in wages, which is more or less, or even lower if infla-

tion is considered. Even in the education sector, both in urban and rural areas, highly qualified teachers in private schools and colleges get 40% less than their counterparts in government educational institutions. A doctorate friend of this writer in Kolkata gets around Rs 40,000 in a private college after serving for over 12 years, which would have doubled had she served in a government college. It is pertinent to refer to the recently released job plan of Confederation of Indian Industry (CII) which suggested a seven-point agenda, including an integrated national employment policy, support to labour-intensive sectors and setting up an international mobility authority. This authority could work with the Ministry of Skill Development & Entrepreneurship to help develop various types of skills, not just technical. These may be worth considering in a situation where job creation is the crving need of the day. Also, the proposal of trade unions to increase the minimum EPFO pension to Rs 5000 per month needs to be seriously considered.

to consumption expenditure increase steadily. Thus, the obvious thrust in the forthcoming Budget should be on ensuring that incomes and wages of the unorganised sector are increased while budgetary grant for the MGNREGS is adequate to provide at least 100 days a year, if not more employment. Some economists have been talking of a similar scheme in the urban sector and the government may think of starting such a scheme for at least 60-70 days for the urban unemployed. Given that around 60% of India's total income has been going to the top 10-12% with the bottom 50% getting a little over 10%, this needs to change. In this scenario, the increase in standard deduction, currently pegged at Rs 75,000 per annum for salaried individuals and pensioners being envisaged may not help much. Also reducing the tax structure to help a section of the middle class may not witness consumption growth. The requirement for much-needed consumption boost is to ensure increasing wages and incomes of the rural populace and the lower segments of the population in cities. INFA

If today's "fundamentalists" sincerely believe that they have found their way to Truth, why do they feel so threatened by non-believers? After all, when a Buddhist encounters Western hedonists, he does not get worked up or feel the need to condemn them: he just shakes his head at their self-defeating search for happiness.

But pseudo-fundamentalists are obsessed with non-believers' sinful lives because the sins reflect their own temptations. Unlike the truly faithful, they envy, rather than pity, those who satisfy their appetites.

Whereas Tibetan monks regard Tibet as "the center of the world, the heart of civilization." European civilization is decidedly ex-centered. Our central longing is to recover some ultimate pillar of Wisdom, secret agalma, or spiritual treasure that we lost long ago. Colonisation was never only about imposing Western values on others; it was also a quest for lost spiritual purity. This story is as old as Western civilization itself: For the ancient Greeks, Egypt was the mythical storehouse of ancient wisdom. In our own societies, the difference between authentic fundamentalists and perverted fundamentalists is that the first (like the American Amish) get along with their neighbours, because they are concerned with their own world, not with what others are doing. Perverted fundamentalists, by contrast, are haunted by ambivalence, motivated by a simultaneous horror and envy of sinners – an unholv brew that pushes them toward acts of violence, be it terrorist bombings or brutal invasions.

Putin's regime has nothing in common with an authentic Russian spirituality that rejects European modernisation. His fantasised "Eurasia" is merely a term to legitimise his own misbegotten modernisation project. That is why we must not dismiss Russia as a deeply conservative and traditionalist country that is forever lost to modernity. After all, the Russian spirituality embodied by the Old Believers rejects authoritarian state power. To defeat the perverts now ruling in the Kremlin, it will have to be reawakened.

Kashmir chinar trees get digital protection

Srinagar, India, Jan 22: Authorities in Kashmir are geo-tagging thousands of 'Chinar' trees to create a comprehensive database for their management and help conserve them amid threats from rising urbanisation, road-widening projects and diseases.

The trees are a cultural and ecological symbol of the restive northern territory, which is claimed in full by India and Pakistan and ruled in part by both, but hundreds of them have been lost over the last few decades.

Under the geo-tagging process, QR codes are attached to each surveyed tree, recording information about 25 characteristics, including its geographical location, health, age, and growing patterns, enabling conservationists to track changes and address risk factors.

The public can also scan the code to access the details, Syed Tariq, the head of the project, told Reuters.

"We have geo-tagged nearly 29,000 trees, but we still have more small-sized trees that haven't been tagged... These will be

tagged in due course," Tariq said The Chinar trees take around 150 years to reach their full size of up to 30 metres (100 ft) in height with a girth of 10 to 15 metres (30 to 50 ft) at ground level.

The oldest Chinar in the region lies on the outskirts of the city of Srinagar and is around 650 years old.

"We are using a USG-based (ultrasonography-based) gadget capable of determining risk levels without human intervention. The gadget will assess risk factors, eliminating the need for manual evaluation," Tariq said. The portion of Kashmir un-

der India's control was roiled by violence for decades as militants fought security forces. but the conflict has eased in recent years, leading to a gradual rise in development projects and tourism.

Prime Minister Narendra Modi visited Kashmir last week to inaugurate a tunnel and, during the event, said that numerous road and rail connectivity projects in the region would be completed in the coming days.

Mumbai, Jan 22: The State Transport Authority (STA) in Maharashtra will meet after a long hiatus of 30 months Thursday and may approve the MSRTC's proposal to hike the passenger fare by 14 to 15 per cent, officials said.

The Maharashtra State Road Transport Corporation had sought the hike in fare under an automatic fare revision formula (AFRF) to mitigate the daily loss of ₹2 to 3 crore. This proposal was sent to STA for approval last year.

Buses operated by MSRTC travel across the length and breadth of Maharashtra with over 55 lakh passengers travelling daily. The 15,000-bus fleet being operated by MSRTC is considered the largest in India. An official said Wednesday that the STA, chaired by the state transport secretary, had approved a 17.17 per cent fare hike for MSRTC-operated buses under the AFRF in its last meeting in 2022, following which the existing fare structure came into force October 26 that year.

STA to meet after 30 months

The STA is mandated to conduct at least two meetings in a year under section 60 of the Maharashtra Motor Vehicles Rule 1989. However, it didn't meet even once since October 2021.

The then transport secretary Ashish Kumar Singh chaired the 275th meeting of STA October 27, 2021.

The incumbent Transport Secretary, who took charge

of the post February 26, 2024, didn't convene any meeting of STA. His predecessor too didn't call for meetings despite several pending proposals, transport department officials claimed.

Officials said matters like the issuance and renewal of licenses for renting motorcycles, and cab permits on inter-state routes are pending. Decisions regarding All India Tourist Vehicles (Authorisation and Permits) Rules 2021 and other issues are also awaiting discussions in the absence of meetings, officials added.

A retired transport department official told PTI that the transport secretary is supposed to convene a meeting of STA once every six months as it is a statutory body.

The STA was established by state governments to regulate and oversee the transport system within their jurisdictions. It plays a crucial role in ensuring the transport infrastructure adheres to legal, safety, and environmental standards.

The statutory body is also responsible for issuing permits for commercial vehicles, such as buses, taxis, and trucks, besides managing routes, schedules, and fare structures for public transport services.

Along with this, it ensures compliance with safety protocols for both vehicles and drivers to maintain a secure transportation network.



Three decades ago, the woman's 13-year-old son tragically died due to an electric shock after climbing a tamarind tree.

Overcome with grief and unable to cope up with the loss, the woman left her home in a distressed state and went missing, Thane Mental Hospital's superintendent

Dr Netaji Mulik said. The woman later reached Nashik, where she wandered in the Panchvati locality for years. Two years ago, the Nashik police found her in a deteriorated physical and mental condition.

After realising that she had a memory loss, they shifted her to the Thane Mental Hospital for care and treatment.



New Delhi, Jan 22: The CBI filed an appeal Wednesday before the Calcutta High Court, seeking death sentence for Sanjay Roy, who was sentenced to "life imprisonment until death" by a Sealdah court in the rapecum-murder case of an on-duty doctor at RG Kar Medical College and Hospital, officials said. The agency made the move

after receiving a legal advice that the brutal rape and murder of the 31-year-old trainee doctor comes under the "rarest of rare" category deserving capital punishment, they said.

Highly placed officials said the CBI was unanimous that the case deserves nothing but death penalty, seeing the manner in which the doctor was killed in her medical college. The CBI's plea seeking death penalty for Roy was turned down by the trial court, where Additional District and Sessions Judge Anirban Das said the crime did not fall under the "rarest of rare" category.

"The CBI prayed for the death penalty. The defence lawyer prayed that a jail term be given instead of the death penalty. This crime does not fall under the 'rarest of the rare' category," the judge said on Monday while sentencing Roy.

The trainee doctor was raped and killed in the early hours of August 9 in the seminar hall of RG Kar Medical College and Hospital when she had gone to have rest during her graveyard shift.

5 sentenced to death for gangrape-murder of girl

Korba, Jan 22: A court in Chhattisgarh has sentenced five men to death for the gangrape-murder of a 16-yearold girl and the killing of her two family members in 2021, holding that the crime has shocked the collective conscience of society.

The Fast Track Special Court in Korba district sentenced to death Santram Manjhwar (49), Abdul Jabbar (34), Anil Kumar Sarthi (24), Pardeshi Ram (39) and Anand Ram Panika (29) and handed a life sentence to the six accused, Umashanakar Yadav (26).

While delivering the judgement January 15, Additional Sessions Judge Mamta Bhojwani held that this inhuman and cruel act of the accused is extremely perverted, heinous, brutal and cowardly, said special public prosecutor Sunil Ku mar Mishra Wednesday. A copy of the order was made available Monday.

Those given the death penalty were convicted under sections 302 (murder), 376 (2)G (gangarape) and other sections of the Indian Penal Code (IPC) and provisions of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act and Protection of Children from Sexual Offences (POCSO) Act. In 2021, the teenage girl was allegedly gang-raped and bludgeoned with stones before she was dumped in a forest leading

to her death near Gadhuproda village under Lemru police station area of Korba district. According to police, the deceased man, a resident of Barpani village, had been working as a cattle grazer at the house of prime accused

Manjhwar since July 2020.

Cong accuses Kejriwal, AAP in ₹382cr scam

New Delhi, Jan 22: Congress leader Ajay Maken Wednesday alleged that the Aam Aadmi Party government committed a corruption of ₹382 crore in the healthcare sector.

I am not saying this, the CAG report is saying this,' Maken said.

While significant strides have been made in controlling communicable diseases, non-communicable dis-



eases (NCDs) now account for 74 per cent of global mortality and 66 per cent of deaths in India. Srivastava said.

"Stroke, often caused by conditions like diabetes and hypertension, is largely preventable," she said. The Indian Council of Medical Research (ICMR) has undertaken pivotal studies to establish stroke care pathways, specialised units, and mobile

stroke units. Moreover, the government is fully committed to addressing the growing burden of NCDs by implementing

a comprehensive hub-andspoke model for stroke care, ensuring optimised resource allocation and equitable access to specialized treatments and rehabilitation services nationwide, she said. "With nearly 500 stroke care units

Researchers, including those from the US' Ascension Health and All India Institute of Medical Sciences (AIIMS), Hyderabad, found that a total of 566 stroke centres equipped with the 'intravenous thrombolvsis' method of treatment (which breaks up blood clots) were spread across 26 states and union territories, the study had said. Of the 566, over 60 per cent (361) were found to be also equipped with endovascular therapy for stroke patients considered superior.

Former British PM Clement Attlee in a statement cited several reasons for the British leaving India, "the principal among them being the erosion of loyalty to the British crown among the Indian Army and Navy personnel as a result of Netaji's military activities."

Though his ideological differences with Mahatma Gandhi were well known, Bose's re spect for Gandhi's principles remained steadfast, and their contrasting paths highlighted his own distinct approach Netaji resigned from Congress in 1939 but his commitment to the cause of India's independence never wavered. For today's youth, this teaches us the importance of staving true to our ideals, even when the road ahead seems fraught with challenges.

Netaji recognised the importance of "Nari Shakti" by forming "Rani of Jhansi Regiment" within the INA, an all-women regiment that reinforced his belief in women's empower-

ment. These ideals are well reflected in Hon'ble PM's vision of a Bharat, where women play an integral role in shaping the country's future.

Celebrating Parakram Diwas has become an annual reminder of Netaji's undying legacy. Previous editions of the celebrations, marked by cultural events and exhibitions, have honoured his contributions, with Kolkata and Delhi as key venues, where his spirit of unity and patriotism reverberated through the streets.

The team headed by a director-rank officer in the Ministry of Home Affairs reached Rajouri district headquarters Sun day evening and was briefed by senior district, health and police officers. It is camping in Rajouri town. Senior epidemiologist and head of Community Medicines Department, GMC Rajouri, Shuja Qadri said al the investigations so far make it clear that the deaths in the village were not the result of any communicable disease.

Washington, Jan 22: Indian-American lawmakers have opposed the executive order by US President Donald Trump on changes in birthright citizenship. a move likely to hit not only illegal immigrants from around the world but also students and

In the opening hours of his second term as president Monday, Trump signed an order declaring that future children born to undocumented immigrants would no longer be treated as citizens. The order would extend even to the children of some mothers in the country legally but temporarily, such

as foreign students or tourists. Trump's executive order asserts that the children of such noncitizens are not "subject to the jurisdiction" of the United



States, and thus are not covered by the 14th Amendment's longstanding constitutional guarantee.

Indian-American Congress man Ro Khanna said changes in birthright citizenship as done through the executive order would impact newborn babies of not only illegal and undocumented immigrants but also

those staying in this country legally like on H-1B visas. The H-1B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise. Technology

companies depend on it to hire tens of thousands of employees each vear from countries like India and China.

'Plain and simple this is unconstitutional and cannot be done with the stroke of a pen. If enacted, it would make a mockery of our country's laws and the precedents set in the Constitution," she said. A coalition of immigration rights groups has challenged this in court and said that this is un-

constitutional. As per the executive order, the US would not give automatic citizenship to newborn babies after February 19, 2025, if one of the parents is not a US citizen or lawful permanent resident.

Also, attorneys general from 22 states sued President Trump in two federal district courts Tuesday to block the executive order that refuses to recognise the US-born children of unauthorised immigrants as citizens, the New York Times reported. Eighteen states and two cit-

ies, San Francisco and Washington, DC, challenged the order in the Federal District Court in Massachusetts, arguing that birthright citizenship under the 14th Amendment is "automatic" and that neither the president nor Congress has the constitutional authority to revise it.

Four other states filed a second lawsuit in the Western District of Washington. The states request immedi-

ate relief to prevent the President's Order from taking effect through both a Temporary Restraining Order and a Preliminary Injunction

Trump asks Putin to end war with Ukraine or face sanctions

S President Donald Trump U Wednesday warned Russian President Vladimir Putin to come to the negotiation table and "stop this ridiculous war" with Ukraine or face a high-lev el of sanctions and trade tariffs

"We can do it the easy way or the hard way - and the easy way is always better," Trump wrote in a post on his social media platform Truth Social.

The US president said he is not looking to hurt Russia and loves Russian people and had a "very good relationship" with Putin.

"We must never forget that Russia helped us win the Second World War, losing almost 60,000,000 lives in the process, he wrote. Trump said he is go ing to do Russia a "very big favour" and urged him to stop the war as "it's only going to get worse if we don't make a deal"

"I have no other choice but to put high levels of Taxes, Tariffs and Sanctions on anything being sold by Russia to the United States, and various other par ticipating countries," he wrote

Earlier, Trump Tuesday said he is ready to meet Putin any time, but at the same time warned that he would likely impose sance tions on Russia if the latter does not come to the negotiations table on the issue of Ukraine. "It sounds likely," Trump told reporters when asked if the US will impose additional sanctions on Russia if Putin doesn't come

to the negotiation table.

Houthis release crew of commercial vessel

> Dubai: Yemen's Houthi rebels said Wednesday they released the crew of the Galaxy Leader, a vehicle carrier seized in November 2023 at the start of their campaign in the Red Sea corridor. The rebels said they released the sailors after mediation by Oman. The crew of 25 included mariners from the Philippines, Bulgaria, Romania, Ukraine and Mexico. The Iran-backed Houthi rebels said they hijacked the ship over its connection to Israel. They then had a campaign targeting ships in international waters, which only stopped with the recent ceasefire in Israel's war on Hamas in the Gaza Strip.

ed Nations in Geneva confirmed Tuesday there had been no reports of looting or attacks on aid workers since the ceasefire took effect.

In recent weeks, Israeli airstrikes have targeted lower-ranking administrators in Gaza, in an apparent bid to break Hamas' grip on government. Israel had already eliminated Hamas' leadership, including political chief Ismail Haniyeh and the architects of the Oct 7 attack, Yahya Sinwar and Mohammed Deif.

Prince Harry hails 'monumental' legal win over Murdoch newspapers

Harry, 40, the younger son of King Charles, had been suing News **Group Newspapers** (NGN), publisher of The Sun and the now-defunct News of the World, at the **High Court in London,** alleging the papers had illegally obtained private information about him from 1996 till 2011

London, Jan 22: Prince Harry claimed a "monumental" victory over Rupert Murdoch's UK newspaper group Wednesday after the publisher settled his lawsuit, admitting unlawful actions at its Sun tabloid for the first time and paying substantial damages.

Harry, 40, the younger son of King Charles, had been suing News Group Newspapers (NGN), publisher of The Sun and the now-defunct News of the World, at the High Court in London, alleging the papers had illegally obtained private information about him from 1996 till 2011

NGN also admitted it had intruded into the private life of Harry's late mother, Princess Diana. A source familiar with the settlement said the damages involved an eight-figure sum.

"In a monumental victory today, News UK have admitted that The Sun, the flagship title for Rupert Murdoch's UK media empire, has indeed engaged in illegal practices," Harry and his co-claimant Tom Watson said in a statement.

'Today the lies are laid bare. Today, the cover-ups are exposed. And today proves that no one stands above the law. The



time for accountability has arrived," said the statement, read by their lawyer David Sherborne outside the High Court.

The trial to consider Harry's case, and a similar lawsuit from former senior British lawmaker Watson, had been due to start Tuesday but following last-gasp talks, the two sides reached a settlement, with NGN saying there had been wrongdoing at The Sun, something it had denied for years.

"NGN offers a full and unequivocal apology to the Duke of Sussex for the serious intrusion by The Sun between 1996 and 2011 into his private life, including incidents of unlawful activities carried out by private investigators working for The Sun," Sherborne told the court.

'NGN further apologises to the Duke for the impact on him of the extensive coverage and serious intrusion into his private life as well as the private

In a statement, an NGN spokesperson said its apology was for the unlawful actions of private investigators working for The Sun, not of its journalists.

"There are strong controls and processes in place at all our titles today to ensure this cannot happen now. There was no voicemail interception on The Sun," the spokesperson said, adding that the settlement marked the likely end of any lawsuits, and that future cases were liable to be thrown out.

NGN has paid out hundreds of millions of pounds to victims of phone-hacking and other unlawful information gathering by the News of the World, and set tled more than 1,300 lawsuits involving celebrities, politicians, well-known sports figures and ordinary people who were con nected to them or major events.

In their joint statement, Har ry and Watson said NGN had now paid out more than 1 bil lion pounds.

NGN previously always rejected any claims that there was wrongdoing at The Sun newspaper, or that any senior figures knew about it or tried to cover it up, as Harry's law suit alleges.

Trump's exit from global tax deal not to hit India: Experts

New Delhi, Jan 22: The decision of the Trump administration to withdraw from the OECD's global tax deal will not have any impact on India, but it will severely affect the progress made thus far in reaching an international consensus on global minimum tax, experts said.

Soon after taking charge, US President Donald Trump in a Presidential memorandum said that the "Global Tax Deal have no force or effect within the United States", thus nullifving the progress made so far by the Organisation for Economic Cooperation and Development (OECD) to bring 140 countries on the same platform to levy a minimum 15 per cent tax on profits of multina-

tional corporates. Nangia & Co LLP Managing

Partner Rakesh Nangia said the impact of the US pulling out of the global tax deal would have monumental impact on the global tax landscape, especially for countries/jurisdictions which have already adopted/ formulated rules in their domestic law for implementing Global anti-Base Erosion Model or GloBE rules (Pillar 2).

Around 50 jurisdictions have already adopted or made significant strides towards adoption of GloBE rules. These jurisdictions will have to now undertake a course correction to adjust to the new realities.

"India, on the other hand, have always adopted a 'wait and watch' policy on adoption of GloBE rules and has yet to introduce any substantial legislative change in this direction.' Nangia said.

Further, in Union Budget



2024, India also abolished the 2 per cent equalisation levy (which, being a unilateral action, was a bone of contention for the US)

"Thus, US pulling out of the global tax deal would not have much impact to India purely from a tax collection standpoint, however, this decision is going to severely impact the progress made thus far in reaching a international consensus and may potentially also force OECD to go back to the drawing board," Nangia said. In 2021 nearly 140 countries signed the OECD's global tax

deal. The two-pillar solution aimed to address "race to the bottom" approach of global tax competition and discourage cross-border tax avoidance by firms. Pillar 1 aimed to reallocate the residual profits of large multinationals from their home countries to jurisdictions where they generate revenue, and Pillar 2 establishes a 15 per cent global minimum corporate tax.

"Earlier remarks of Mr Trump and other Republican lawmakers left little to no doubt about US's position on the OECD's global tax deal - it was never a question of 'if' but a question of 'when!'," Nangia said.

Tax and consulting firm AKM Global, Head of Tax Markets, Yeeshu Sehgal said OECD's pillar 2 initiative sets a minimum tax rate of 15 per cent for every country that is signatory to it. This has caused a lot of concerns for the US because their current tax rules might conflict with this new global minimum tax.

One concern is that some US companies might end up paying tax twice on the same income Another issue is that the new rules might change how taxes are calculated, potentially increasing the burden on US companies with operations in other countries, he said.

The Champions Trophy will be held from February 19 and India will play its share of matches in Dubai after citing security concerns as the reason for refusing to travel to Pakistan.

"BCCI will follow every uniform-related ICC rule during Champions Trophy," Saikia told PTI. "Whatever the other teams will do regarding the logo and dress code, we are going to follow in true letter and spirit," he added.

However, Saikia said that whether national captain Rohit Sharma participates in the ICC's pre-tournament engagements, including a press conference and an official photo shoot in Lahore, is something that is still being discussed.

"Whether Rohit Sharma travels to Pakistan for ICC media engagements is some-



thing that's still not decided,' Saikia added.

There were some unconfirmed media reports that the BCCI had objected to the host nation's name being embossed on their jersey, which is an established practice for all ICC events, owing to the tense political ties between the two countries.

It is understood that there was never any doubt about following the logo guidelines and the BCCI did not raise concerns with the global body. When Pakistan came to In-

At least 17K security personnel to be deployed in Pakistan

Lahore: At least 17,000 security personnel would be deployed for the ICC Champions Trophy matches in Karachi, Lahore and Rawalpindi from February 19. "The Punjab government will deploy some 12,500 officers and other security personnel for the matches and for the teams," an official said. The official said that snipers and aerial monitoring will be carried out during the tournament with support from the Army if required.
