#### **Rural Odisha sees** maximum rise in consumer spending

New Delhi, Jan 30: The maximum increase in monthly per capita expenditure (MPCE) in rural areas was recorded in Odisha while Punjab topped the chart in urban areas during August 2023 to July 2024, a government survey stated.

There has been increase in average MPCE for all the 18 major states in rural and urban areas in 2023-24. In a statement, the statistics ministry said the maximum increase in average MPCE in the rural areas has been observed in Odisha (about 14 per cent from the level of 2022-23) while in urban areas, Punjab witnessed the maximum increase of around 13 per cent from the level of 2022-23.

The least increase in average MPCE has observed in Maharashtra (about 3 per cent) and Karnataka (about 5 per cent) in rural and urban areas, respectively. P3

#### Ration card e-KYC verification deadline extended to Feb 15

Bhubaneswar, Jan 30: The state government extended the deadline for e-KYC (know your customer) verification of ration cards to February 15, Food Supplies Minister Krushna Chandra Patra said Thursday.

Speaking to reporters, Patra said the e-KYC verification of ration cards was supposed to end January 31. "However, considering the requests of people, the government has decided to extend the deadline till February 15," he said. The government's e-KYC process requires Aadhaar-based biometric authentication for each family member through e-PoS machines Each beneficiary of the PDS will need to visit the nearest fair price shop for the purpose.

Earlier, the government had extended the deadline from December 31 to January 31. A total of 3.26 crore people are beneficiaries of the NFSA and 10.03 lakh people have been covered under the SFSS. More than 38 lakh of them have not completed their e-KYC verification

#### Trump's plan to abolish income tax

Washington, Jan 30: Pitching a monumental and potentially controversial proposal to his Republican allies, President Donald Trump is seemingly floating the idea of scrapping federal income taxes altogether. "We had no income tax. The

income tax came in...1913. As I said in my speech last week, instead of taxing our citizens to enrich foreign nations, we should be tariffing and taxing foreign nations to enrich our citizens," Trump said during his conference address in Doral.

"It's time for the US to return to the system that made us richer and more powerful than ever before," he said.

# **Kumbh tragedy** could rock Parl

New Delhi, Jan 30: Parliament's Budget Session is likely to get off to a stormy start Friday with Opposition parties demanding a discussion on the alleged mismanagement in the Maha Kumbh Mela in Prayagraj, where 30 pilgrims were killed in a stampede Wednesday.

The Opposition made its intentions clear at the all party meeting Thursday, on the eve of the Parliament session, by demanding a discussion on issues like Maha Kumbh tragedy and controversial UGC draft guidelines and raising complaints about the functioning of the Parliamentary panel on Waqf (Amendment) Bill.

The Budget Session will begin Friday with President Droupadi Murmu addressing both the Houses assembled together in the Lok Sabha. After the President's address. Finance Minister Nirmala Sitharaman will table the Economic Survey in the Lok Sabha and the Rajya Sabha separately. Sitharaman will present the Union Budget Saturday for the eighth consecutive time.

At the all party meeting, the Opposition accused the BJP-led government of politicising the Kumbh congregation and prevalence of VIP culture at the cost of the common man

The Opposition parties also alleged that the government is steam-rolling its agenda in Parliamentary panels and having disregard for procedure of finalising House business at the meetings of the Business Advisory Commit-tee (BAC). "We expressed our

concerns over the biased manner in the conduct of Parliament proceedings," Gaurav Gogoi, Deputy Leader of the Congress in the Lok Sabha, told reporters here.

A section of the Opposition leaders questioned the government over the publication of a parliamentary bulletin on the number of days allotted for discussion on the Motion of Thanks to the President's address, contending that this was the prerogative of the BAC.

"We have taken note of their concerns. The BAC will decide which issues will be taken up for discussion. We hope for a smooth and productive Budget Session. Cooperation from all parties is essential for a meaningful and constructive Parliamentary session." Parliamenta ry Affairs Minister Kiren Rijiju said. The government has listed 16 Bills, besides the financial business, for the Budget Session which will be held from January 31 to February 13 before breaking for recess to examine the Budget proposals. The session will reconvene March 10 and continue till April 4.

Asked about the Opposition's demand for a discussion on the stampede at the Maha Kumbh, Rijiju said the decision will be taken by the committee. "There are many important issues...the Kumbh was also mentioned," he said.

Meanwhile, Congress leader Pramod Tiwari said Opposition leaders have decided that the INDIA bloc will raise all issues together during the Budget Session. Emerging from the all-party meeting. Tiwari also slammed the 'politicisation' of the Kumbh, saying VIP movement during the event was creating difficulties for the common man.

**IUML** leader ET Mohammed Basheer said he raised the issue of the weakening of the law-making process in the country. "The JPC on Waqf was constituted to have discussion. But members were not given enough opportunity to speak." Basheer said.

#### **ODISHA CANCELS BUS SERVICE FOR KUMBH**

Bhubaneswar, Jan 30: The state government Thursday cancelled the special bus service for Maha Kumbh Mela till February 4, an official notice said.

"Due to unavoidable circumstances, the special bus service for Maha Kumbh Mela stands cancelled with immediate effect till February 4." the notice said.

It also said that further updates will be shared with the public on the official social media handles and website. Earlier, it was decided to operate special bus service to Maha Kumbh Mela till February 26.

The state government's decision to cancel the special bus service for Maha Kumbh Mela came a day after at least 30 people were killed in a pre-dawn stampede at the Sangam area of the Maha Kumbh Wednesday as millions of pilgrims jostled for space to take a holy dip on the occasion of one of the most auspicious days of Mauni Amavasya.

Chief Minister Mohan Charan Majhi had flagged off the special bus service for Maha Kumbh Mela from four locations of the state here January 12. The Transport and Commerce department regretted the inconvenience caused to passengers due to the cancellation of the special bus service. The Odisha State Road Transport Corporation (OS-RTC) will refund the money to people who had booked tickets for the visit to Maha Kumbh Mela, it said.

## Trump: No survivors in US plane-copter collision

Washington, Jan 30: A commercial American Eagle plane about to land at the Reagan National Airport collided with a US Army Black Hawk helicopter Wednesday night, in one of the worst aviation disasters in recent US history.

"Both aircraft crashed instantly and were immediately submerged into the icy waters of the Potomac. (A) real tragedy. The massive search and rescue mission was under way throughout the night, leveraging every asset at our disposal... The work has now shifted to a recovery mission. Sadly, there are no survivors," US President Donald Trump told reporters at a White House news conference.

The incident happened just before 9pm, he said. An American Airlines regional jet carrying 60 passengers and four crew collided with an Army Blackhawk helicopter carrying three military service members over the Potomac River in Washington, DC while on final approach to Reagan National Airport.

The American Eagle plane was coming from Wichita in Kansas.

Washington DC Fire Chief John Donnelly told reporters Thursday morning that the resque teams so far have recovered

27 bodies from the plane and one body from the helicopter.

Trump said there were nationals from other countries, including Russia, who are be-"We have a Russia contin-

gent, some very talented people, unfortunately, were on that plane, very, very, very sorry about that," he said, adding that the US is in touch with Russia to transfer these bodies to their near and dear ones.

"There were a couple of others. We're going to be announcing it in about an hour We have some very specific information. We're calling the countries. We've spoken to most of them, but there were some other countries represented. Trump said.

"We are one family and today we are all heartbroken we're all searching for answers and say that icy Potomac was a cold night cold water. We're all over come with the grief for many who have so tragically perished will no longer be with us together." he said.

#### Headmistress suspended as 15 students flee hostel

Rourkela, Jan 30: The headmistress of a primary school in Bonai sub-division of Sundargarh district has been suspended for negligence after 15 students fled the boys hostel January 28, officials said Thursday.

Officials said the Bonai BEO suspended the headmistress of Sihidiha Primary School, Draupadi Sahu, for negligence. The students. all boys aged 7-10, escaped around midnight following a punishment allegedly given to one of them by the warden. The boy, upset by the punishment, led the others to leave the hostel and return to their vil lage, Balan, they added.

Barkote police in Deogarh district, bordering Bonai, were notified and they quickly took the boys into safe custody. The following morning, Mahulpada police contacted Barkote police and brought the boys back.

#### Taranaki Maunga: NZ's mountain granted personhood colonised. It fulfils an agree-In 1840, Maori tribes and repand rights in NZ law.

Wellington, Jan 30: A mountain in New Zealand (NZ), considered an ancestor by Indigenous people, was recognised as a legal person Thursday after a new law granted it all the rights and responsibilities of a human being.

Mount Taranaki known as Taranaki Maunga, its Maori name – is the latest natural feature to be granted personhood in NZ, which has ruled that Whanganui river and Te Urewera, a stretch of sacred land, are people before. The pristine, snow-capped dormant volcano is the second highest on NZ's North Island at 2,518 metres and a popular spot for tourism, hiking and snow sports.

The legal recognition acknowledges the mountain's theft from the Maori of the Taranaki region after NZ was ment of redress from the country's government to indigenous people for harms perpetrated against the land since.

How can a mountain be a person?

The law passed Thursday gives Taranaki Maunga all the rights, powers, duties, responsibilities and liabilities of a person. Its legal personality has a name: Te Kahui Tupua, which the law views as a living and indivisible whole. It includes Taranaki and its surrounding peaks and land, incorporating all their physical and metaphysical elements. A newly-created entity will be the face and voice of the mountain, the law says, with four members from local Maori iwi, or tribes, and four members appointed by the country's Conservation Minister.

Why is this mountain special?

'The mountain has long been an honoured ancestor, a source of physical, cultural and spiritual sustenance and a final resting place," Paul Goldsmith, the lawmaker responsible for the settlements between the government and Maori tribes, told Parliament in a speech Thursday.

But colonisers of NZ in the 18th and 19th centuries took first the name of Taranaki and then the mountain itself. In 1770, British explorer Captain James Cook spotted the peak from his ship and named it Mount Egmont.

resentatives of the British Crown signed the Treaty of Waitangi -NZ's founding document — in which the Crown promised Maori would retain rights to their land and resources. But the Maori and English versions of the treaty differed — and Crown breaches of both began immediately.

In 1865, a vast swathe of Taranaki land, including the mountain, was confiscated to punish Maori for rebelling against the Crown. Over the next century hunting and sports groups had a say in the mountain's management — but Mao ri did not. "Traditional Maori practices associated with the mountain were banned while tourism was promoted," Goldsmith said. But a Maori protest movement of the 1970s and '80s has led to a surge of recognition for the Maori language, culture

How will the mountain use its rights?

Taranaki, our 'Today, maunga, our maunga tupuna, is released from the shackles, the shackles of injustice, of ignorance, of hate," said Debbie Ngarewa-Packer, a co-leader of the political party Te Pati Maori and a descendant of the Taranaki tribes, using a phrase that means ancestral mountain.

The mountain's legal rights are intended to uphold its health and wellbeing. They will be employed to stop forced sales, restore its traditional uses and allow conservation work to protect the native wildlife that flourishes there. Public access will remain.



# 'Bikashita Gaon, Bikashita Odisha' guidelines out

Bhubaneswar, Jan 30: The state government has issued guidelines for the recently announced scheme—'Bikashita Gaon Bikashita Odisha' (BGBO) for taking up various sustainable developmental projects for inclusive growth in rural areas.

The BJP government has announced the BGBO scheme replacing the 'Ama Odisha Nabin Odisha' (AONO) scheme launched by the previous BJD government. The government has made a budgetary provision of ₹1,000 crore under the scheme for the financial year

Panchayati Raj and Drinking Water department Secretary Girish SN has recently issued the guidelines to Collectors, which was shared with media Thursday.

As per the guidelines, the new scheme has the provision to take up various sustainable rural infrastructure developmental projects including roads, bridges, school buildings, civic amenities and

A maximum of 35 per cent of the total allotted funds can be utilised for road projects, while 40 per cent of the allocation will be earmarked for blocks that come under the Integrated Tribal Development Agency (ITDA), it said.

The incomplete projects under the AONO scheme in which a minimum 20 per cent expenditure has been incurred can also be taken up and will be completed under the new scheme, the secretary said. Gram Sabha will prepare a

need-based five-year perspec-



provision to take up various developmental projects including roads, bridges, school buildings, civic amenities and sports

A dedicated web-based MIS and mobile app will also be developed for real-time monitoring of projects

tive plan by February 14 and on the basis of which, an annual action plan for each financial year will be prepared by the blocks by February 18.

The project submitted by the Gram Panchayats will be scrutinised by a technical committee at block level and the Panchavat Samiti will recommend the scrutinised project list to the district collector for final approval before February 20.

A dedicated web-based MIS and mobile app will also be developed for real-time monitoring of projects, he said.

Commenting on the new scheme, senior BJD leader Badri Narayan Patra said, "There is no point in changing the name of the previous government's scheme and issuing other guidelines. The same work could have been taken

up under the previous scheme.

The BJP government is now seven months old. So, it should launch new schemes and programmes to move forward instead of blaming the previous one, he said

Congress MLA Nilamadhab Hikaka said both BJD and BJP are two sides of the same coin and they were running coalition governments for nine years (2000 to 2009). "Like the BJD, the BJP government is also hoodwinking the people of Odisha by making false promises," he alleged.

Reacting to the statements of Opposition leaders, BJP legislator Saroj Padhi said, "They have become flustered as the BJP government has been launching new schemes. So they are making such statements.

The previous BJD government was "deep in corruption" in the name of 5T (transformative initiative) and did nothing for the development of rural people, Padhi alleged

The father of the newborn is Julu, a male chimpanzee brought from Singapore Zoo May 16, 1994. Durga and Julu were first introduced for mating between May 26 and 29 this year, followed by another introduction from June 2 to 6. The blockade caused heavy traffic congestion, leaving numerous vehicles stranded on both sides of the road. Hindol Tehsildar Dilip Kumar Sethi, BDO Kalyan Saurabh SDPO Nalita Modi, Forest Ranger Gautam Pradhan, and Motanga police station In-Charge Jitendra Mallik reached the scene and convinced the protesters to withdraw the blockade. The girl's body was later sent for post-mortem, and an unnatural death case (1/25) was registered at Motanga police station.

Divisional Forest Officer Dhenkanal, Sumit (DFO), Kumar Kar said that the deceased's family would receive ₹6 lakh compensation as per norms. An initial 10 per cent payment would be made within 24 hours, while efforts are underway for electrification of the

village, he said. A total of 48 elephants are currently holed up in the affected region, and Forest officials have started efforts to drive them away.

New Delhi, Jan 30: Monthly per capita expenditure (MPCE) in rural areas of Odisha registered the maximum rise while Punjab topped the chart for urban areas during August 2023 to July 2024, a government survey stated.

There has been increase in average MPCE for all the 18 major states in rural and urban areas in 2023-24

In a statement, the statistics ministry said the maximum increase in average MPCE in the rural areas has been observed in Odisha (about 14% from the level of 2022-23) while in urban areas, Punjab witnessed the maximum increase of around 13 per cent from the level of

The least increase in average MPCE has observed in Maharashtra (about 3%) and Karnataka (about 5%) in rural and urban areas, respectively.

It stated that a wide variation in urban-rural difference in average MPCE is observed across the 18 major states in 2022-23 as well as in 2023-24.

Among these major states, there has been a decline in urban-rural gap in 11 states in 2023-24 from the level of 2022-23.

## Report reveals lapses in state's school education

Bhubaneswar, Jan 30: The Annual Status of Education Report (ASER), 2024 has exposed the lacunae in the state's elementary and primary education.

The report, published recently, has revealed that just 59.4 per cent fifth-grade students in state's schools can read textbooks meant for second graders, while the same can be performed by only 40 per cent third-graders.

While these figures bring to the fore the existing challenges, they also highlight a significant recovery from the pandemic period when the situation was even grimmer. In 2022, only 29.8 per cent of third-graders and 52.5 per cent fifth-graders were able to handle second-grade textbooks.

The ASER survey, released once in two years, by Pratham Foundation, highlights that only 32.6 per cent of fifth-grade stu-

# State's first automated testing station launched

The facility aims to enhance vehicle fitness assessments and road safety through advanced technology

Bhubaneswar, Jan 30: The Odisha government Thursday mated testing station (ATS) in Cuttack, marking a significant advancement in ensuring the transparency and efficiency of motor vehicle fitness testing.

This state-of-the-art facility, set up under the Cuttack Regional Transport Office (RTO), uses advanced machinery to assess the fitness of vehicles without any human intervention.

The newly-launched ATS system is aligned with the Central Motor Vehicle Rules, ensuring that it meets the standards for evaluating various vehicle categories, including two-wheelers, three-wheelers, light vehicles, medium vehicles, and heavy vehicles, both commercial and privately owned.

This system is designed to provide accurate, unbiased results and enhance road safety by eliminating unfit vehicles

Transport Commissioner Amitabh Thakur, who reviewed the operations of the ATS, expressed optimism about the role this technology will play in improving road safety across the state.

He emphasised that the system adheres to the high standards set by the Central government and will contribute to a safer transportation environment by ensuring that only roadworthy vehicles remain in circulation.

In line with the Central Motor Vehicle Rules, which mandate the implementation of ATS for vehicle fitness tests, the Odisha government has set its sights on expanding this initiative.

Plans are in place to establish 21 more ATS centers across various RTOs in the state, including in districts such as Boudh, Jharsuguda, Bargarh, Kendrapara, Sundargarh, Nayagarh, Nabarangpur, Ganjam, Sambalpur, Balasore, Koraput, Nuapada, Jagatsinghpur, Mayurbhanj Rourkela, Keonjhar, Angul, and Bhubaneswar RTO-2.

The introduction of the ATS system comes as part of the government's efforts to improve vehicle fitness certification, which has traditionally relied on manual inspections. With the recent amendments to the Central Motor Vehicles Act. ATS-based inspections have now become mandatory.

This automated approach is expected to ensure more accurate assessments and a more streamlined process for vehicle owners seeking fitness certificates and registration renewals.

The automated vehicle fitness tests are expected to reduce the risk of road accidents by ensuring that only roadworthy vehicles are allowed on public roads.

The Odisha government is hopeful that this new system will significantly contribute to road safety and help build a safer and more efficient transportation ecosystem in the state.

The meeting, held at the BMC headquarters. focused on identifying mosquito-prone areas and implementing control measures swiftly.

Minister Mahapatra directed officials to identify high-risk zones within seven days and take necessary mosquito control actions within the next two days. BMC Commissioner Rajesh Prabhakar Patil reported that the corporation's timely measures had led to a significant reduction in dengue cases this year. "While nearly 4.000 dengue cases were recorded Patil stated.

Currently, BMC operates 20 auto-mounted fogging machines, 30 small hand fog ging machines, and two trac tor-mounted machines, which are regularly used for mosquito fumigation across various wards. However, Minister Mahapatra emphasised the need for more resources, instruct ing officials to procure four additional tractor-mounted machines immediately.

The Minister also highlighted the shortage of manpower noting that fogging must be conducted simultaneously in all areas to prevent mosqui toes from migrating between zones. He recommended doubling the number of an ti-larvae workers to ensure effective control.

# BJD infighting intensifies in BeMC NIT-R develops innovative tech to treat industrial waste water

**Despite Naveen's** call for resolution, the discord has worsened as the civic body's **Mayor and 20** corporators meet **District Collector** seeking action

Berhampur, Jan 30: The internal rift among BJD corporators in the Berhampur Municipal Corporation (BeMC) has been widening despite repeated calls for unity from party supremo and former chief minister Naveen Patnaik

The discord was evident during Wednesday's corporation meeting, which was disrupted due to unruly behaviour of a faction, forcing an abrupt adjournment.

Meanwhile, in response, Be-MC Mayor Sanghamitra Dalai, Deputy Mayor E Vivek Reddy, and 20 corporators visited the District Collector at his residential office in Chhatrapur Thursday. They submitted a memorandum requesting strict legal action against corporators responsible for dis-



rupting the meeting.

According to the memorandum, during Wednesday's corporation meeting at the BeMC office, the corporator of Ward 26 allegedly used abusive language and misbehaved with the Commissioner and staff. Additionally, the corporator, along with a few others, locked the BeMC campus gate, preventing access for the general public. This disruption hindered operations of the municipal office.

Notably, the Commissioner had already written to the District Collector, the state Home and Urban Development department, and the Municipal Director, urging action against the Ward 26 corporator for misconduct. Mayor Dalai, Deputy Mayor Reddy, and 20 corporators reiterated their demand by submitting the memorandum during their meeting with the

Among BeMC's 36 BJD corporators, a majority reportedly align with former MLA Bikram Panda, while another faction is said to support Mayor Sanghamitra Dalai and district BJD President Ramesh Chandra Chyau Patnaik. The feud, ongoing for the past three months, stems from disagreement over organisational responsibilities within the Berhampur Assem-

bly constituency and is inten-

sifying with each passing day.

Following the disruptions in the corporation meeting, the party's district unit president Chyau Patnaik informed the former chief minister about the situation, urging action against those causing disorder. Notably, corporators from both factions had December 18 visited Naveen Nivas, where Patnaik had emphasised unity and organisational discipline. However, the continued infighting suggests his directives have been largely ignored.

Supporters of the mayor's faction question why Bikram Panda, who lost the last election as BJD's candidate from Gopalpur, continues to wield influence in Berhampur politics. Nevertheless, Panda reportedly retains the support of a majority of BJD corporators.

Former Union Minister and senior BJD leader Chandrasekhar Sahu remarked that ensuring smooth governance is the may or's responsibility, adding that she has failed to maintain control over the corporators.

Meanwhile, BJD Corporator Surendra Maharana warned that if the crisis escalates further, the present state government might consider dissolving the municipal corporation, necessitating immediate intervention from the party's top

Rourkela, Jan 30: Research ers at the National Institute of Technology (NIT), Rourkela have developed an innovative process for efficiently treating industrial waste water contaminated with persistent dyes such as Bismarck Brown R.

The research, supported by Science and Engineering Research Board of the Department of Science and Technolo gy, has been published in the prestigious Journal of Environmental Chemical Engineering and the team has been granted a patent for the developed tech

Led by Sujit Sen, Professor, Department of Chemical Engineering at NIT Rourkela, the research team includes Madhumita Manna, research graduate, NIT Rourkela and Binay Kanti Dutta, former professor, IIT Kharagpur.

According to Sen, waste water from industries like textiles and dve manufacturing often contains harmful dyes that are difficult to remove with traditional filtration methods.

"Dyes such as Bismarck Brown R are small enough to pass through microfiltration membranes, making them particularly challenging to treat. These dyes can cause signifi-

cant environmental and health issues due to their intense colour and potential carcinogenic properties.

"Conventional treatment methods, such as those relying on ultraviolet light, often struggle with large-scale applications, especially when separating dye particles from water," he said.

Sen explained that to address these challenges, the research team developed a cutting-edge treatment system that combines two advanced technolo-

"The first is a ceramic membrane coated with an industrial-waste derived Zeolite and Zinc Oxide nanocomposite. This photocatalyst can break down dye molecules when exposed to light."

"The second technology incorporates micro bubbles, generated via a simple air diffuser, to enhance mass transfer and improve the breakdown proflow membrane photoreactor was designed and tested using both simulated and real waste water from a local dyeing factory," he said.

Sen said, "Our hybrid system successfully achieved 95.4 per cent decolourisation of Bismarck Brown R and 94 per cent removal of chemical oxygen de mand (COD) in just 90 minutes. The nanocomposite performed well under visible light, making this approach suitable for practical wastewater treatment

applications."

There are a host of potential applications of this hybrid system, which is more efficient and cost effective in compari son to conventional oxidation methods. This technology could be applied across industries such as textile manufac turing, chemical industries steel, petrochemicals, and pharmaceuticals, where robust wastewater treatment is required. It can also be scaled up and integrated into existing wastewater treatment plants to improve the efficiency of treating dye-laden wastewater Furthermore, the system may prove effective for treating contaminants that are typi cally difficult to remove using conventional methods, such as those found in hospital and

pharmaceutical waste water.

### Youth sentenced to 10 years RI for raping minor girl

Kendrapara, Jan 30: A brick kiln labourer was sentenced to 10 years Rigorous Imprisonment (RI) Thursday along with a fine of ₹50,000 by the Ad-hoc Additional Session Judge (Fast Track Special Court) of Kendrapara for raping a 15-year-old

Public Prosecutor of Additional District Judge -cum-Special Judge (POCSO) Court Manoj Kumar Sahoo said the 22-year-old youth was convicted by the court for impregnating and making the victim an unwed mother.

The convict has been identified as Pradip Kissan of Kanchanpur village under Kesinga police station in Kalahandi district. According to Sahoo, Pradip, who was staying in a rented house near the victim's house, developed a relationship with the girl.

The accused had raped the minor girl several times and made her pregnant.

The victim's mother, after knowing the incident, lodged an FIR at Marshaghai police station in August 2023.

Marshaghai police had arrested the accused August 14, 2023. Later, the victim girl delivered a baby boy. To establish the identity of the biological father, police also made DNA profiling tests of the child, the unwed mother, and the accused.

While adjudging the under Section 376(3) of IPC and under Section 4 of POCSO Act, Ad-hoc Additional Session Judge (Fast Track Special Court) of Kendrapara, Tribikram Keshari Chinhara, convicted the youth and sentenced him to undergo 10 years RI and slapped a fine of ₹50.000 on him.

The judge ordered that the convict would be imprisoned for one more year if he failed to deposit the fine amount. The court also recommended to the government to provide a compensation of ₹4 lakh to the victim and ensure steps for proper rehabilitation of the child.

### Digital arrest: Teacher couple duped of ₹34.5L

Berhampur, Jan 30: A teacher couple from the Kukudakhandi police station area in Ganjam district was defrauded of ₹34.5 lakh through digital arrest by cybercriminals, police said Thursday.

The scam came to the light after the woman lodged a complaint at the Berhampur Cyber and Economic Offenses police station Wednesday.

According to the complaint, the woman's husband received an unknown call January 20. The caller, posing as a TRAI official, claimed that his SIM card would be deactivated within two hours. The victim's phone number is also linked with his Aadhaar card. The caller falsely accused him of involvement in a ₹2.38 crore money laundering case registered at the Kolaba police station in Maharashtra. The caller further alleged that an arrest warrant had also been issued against him.

When the teacher's wife got involved, the fraudsters connected with her via WhatsApp video calls from four different numbers. During these calls, they impersonated police officers and

a Supreme Court judge to convince the couple of the fabricated charges, ultimately coercing them into transferring the money.

Fearing consequences, the teacher transferred ₹30 lakh from her account at the Ankushpur branch of State Bank of India (SBI) to Bethel Mission School in Madhva Pradesh December 21. The next day, she made another transfer of ₹4.5 lakh via RTGS from the SBI's Bijipur branch in Berhampur to a different

Scammers had threatened that all the money in her bank account would be transferred to the Reserve Bank and that she would only get it back after an investigation. They also warned that both she and her husband would be arrested if she failed to deposit the money.

Even after making the transfers, the cyber fraudsters continued to call and intimidate the couple. Finally, the teacher approached the manager of the Ankushpur SBI branch to discuss the issue. Upon realising she had fallen victim to cyber fraud, she filed a complaint at the police station. Police registered a case (12/25) and launched an investigation.

### VIG GLARE ON ITDA OFFICIAL

Bhubaneswar/Rourkela, Jan 30: Vigilance department sleuths Thursday unearthed assets including a two-storey building, two flats, nine high-value flats and deposits worth ₹61 lakh allegedly belonging to a government official.

The anti-corruption officials raided the properties of the officer working at the Integrated Tribal Development Agency (ITDA) at Bonai in Sundargarh district for allegedly possessing assets disproportionate to his known sources of income, an official said.

The raids were conducted by seven teams in Bhubaneswar, Balasore, Jajpur and Bonai, the official added. The simultaneous raids were conducted after search warrants were issued by the Special Judge of Vigilance (Sundargarh). During the operation, the officials dis-

covered a two-storey building and two flats in Bhubaneswar, nine high-value plots in and around the Capital city and Puri, ₹4.5 lakh in cash, bank and insurance deposits of ₹61.42 lakh, and 150 grams of gold ornaments. A four-wheeler, four two-wheelers and household items worth ₹21.14 lakh were found in the possession of the ITDA official.

### Engg student among 4 held for 9 burglaries

Berhampur, Jan 30: Four people, including an engineering student, were arrested Thursday in connection with burglaries at nine places in Ganjam district, police said. Items worth over ₹10 lakh were seized from those arrested, they said.

Among these items were gold ornament, mobile phones, computers, colour printers, a water cooler, a water filter, a scooter, a digital weighing machine, and ₹1.40 lakh in cash, besides house-breaking equipment, they added.

The gold ornaments were recovered from a bank and a private finance company, where the accused had deposited them, police said. Those arrested were identified as

Silu Nayak (21), a fourth-year BTech student, Bikash Bisoyi (23), Kalia Behera (21) and Sarasa Kumar Nayak (32) of Borosingi, they said.

SP (Berhampur) Saravana Vivek M said a search was underway for other members of the gang who have been identified.

Preliminary investigations revealed that the gang was involved in at least nine burglaries -- six in the Gopalpur police station area, two

in Golanthara police station limits and one in the Chamakhandi police station area, he said. All the burglaries were committed

in the last five months, he added. "We suspect the gang might have

been involved in several other such cases in adjoining districts. We are verifying it," he said. The arrests were made during

the investigation of a burglary case registered in the Golanthara police station December 19. The gang robbed gold ornaments weighing 350 grams and over ₹45,000 in cash. among others, by breaking into a house, police said.

### Climate Displacement

very year,21.5 million people are forcibly displaced by floods, droughts, wildfires, and storms. This number is set to rise dramatically over the coming decades, with up to 1.2 billion people expected to be driven from their homes by 2050. The unfolding climate crisis is not just a humanitarian disaster but also a global health emergency.

Climate displacement poses both direct and indirect threats to public health. By disrupting care services, it deprives affected communities of access to doctors, hospitals, and pharmacies. Climate-induced migration also exacerbates poverty, overcrowding, and social instability. Food production is often severely affected, while unsanitary living conditions fuel the spread of infectious diseases.

As the climate crisis threatens to derail global efforts to achieve the United Nations Sustainable Development Goals, the health and well-being of hundreds of millions of people across the developing world are at risk. High-income countries are not immune: in the United States, 3.2 million adults were displaced or evacuated due to natural disasters in 2022 alone

Pharmaceutical companies must play a pivotal role in bolstering global health resilience. Their involvement is particularly critical in conflict zones at the forefront of the climate-displacement crisis, where life-saving medicines and vaccines

are often in short supply. While the pharmaceutical industry has made strides in reducing carbon dioxide emissions and adopting more sustainable practices, its efforts fall far short of mitigating climate-related disruptions to supply chains. These vulnerabilities were on full display in 2017, when Hurricane Maria devastated Puerto Rico's drug-manufacturing sector, which at the time accounted for nearly 10% of all drugs consumed

Some pharmaceutical companies, such as Novartis and Novo Nordisk, have launched targeted programmes to aid populations displaced by extreme weather events, while others have donated cash or supplies in response to natural disasters. The demand for these donations has risen with increasing climate and humanitarian needs. Hikma, a generic medicine manufacturer founded in Jordan, reported \$4 million in donations in 2020, and \$4.9 million in 2023, mostly serving the needs in the surrounding region.

No company has developed a comprehensive strategy to ensure that displaced communities have sustained access to health products. A more holistic approach is needed. Amid the ongoing climate-displacement crisis, pharmaceutical companies should adopt a four-pronged strategy to strengthen health-care systems.

For starters, they could help deliver medicines to vulnerable communities in remote areas by revamping their supply-chains, from building redundancy into

shipping networks to redesigning products to be more stable in hot climates where refrigeration may be unavailable. Moreover, they should include robust systems for the large-scale distribution of generic drugs, which are frequently the most effective tools for managing disease outbreaks.

Second, pharmaceutical companies must invest in research and development to create vaccines, diagnostics, and therapeutics targeting climate-sensitive diseases. Rising global temperatures are accelerating the spread of mosquito-borne illnesses such as dengue, malaria, and Zika, as well as waterborne diseases like cholera and shigella, putting displaced populations at even greater risk.

Yet, despite the need for innovation, the 2024 Access to Medicine Index – which ranks the efforts of pharmaceutical companies to improve access to essential drugs in developing countries - shows that the R&D pipeline for emerging pathogens and neglected tropical diseases is drying up. Compounding this problem is the lack of research into new antibiotics to combat the escalating threat of antimicrobial resistance,

exacerbated by extreme weather and poor sanitation. Third, pharmaceutical companies should forge long-term partnerships with humanitarian organisations focused on climate displacement. Public-private collaborations have also proven effective in strengthening health resilience. Since 2010, for example, leading vaccine manufacturers like GSK and Pfizer have supplied Gavi, the Vaccine Alliance, with billions of vaccine doses, protecting vulnerable populations in some of the world's most resource-constrained

Lastly, pharmaceutical companies must boost efforts to cut greenhouse-gas emissions across their value chains. While the climate impact of pharmaceuticals may get less attention than that of traditional manufacturing industries, the sector emits more CO per \$1 million of revenue than the automotive industry.

The active support and engagement of shareholders, employees, and other stakeholders is crucial. Investors, in particular, must encourage companies to align their business practices with global health and climate goals. This is not only an ethical choice but also one that promises significant long-term financial and reputational benefits.

Climate displacement is not a distant or hypothetical threat; it is a rapidly escalating health emergency. The pharmaceutical industry has a moral responsibility to act. To do so effectively, companies must get ahead of the curve and providevital, life-saving treatments to those on the frontlines of the climate crisis.

# WHO GETS WHAT

to get in this budget? People want straight and simple answers. It is not difficult to make aclose-to-accurate guess if one first addresses the other questions like: What is abudget? Who are its architects? Which segment of people - poor, rich, middle classes, employed, unemployed, farmers, gig workers -- is asking this?

First thing first. The budget is the government's estimated income and expenditure for the financial year - a financial statement. The higher the budget size, the higher would be allocations for the people's welfare. Unfortunately, the size of the union budget as a percent of the GDP has been shrinking over the years; it has come down from 17.43% of GDP in 2009-10 to 14.76% in 2024-25. The upcoming budget is not going to be different given the government's excess concern with fiscal consolidation and lower-than-expected GDP growth.

We can make a rough estimate of the size taking the expected GDP in 2025-26. The GDP was estimated at ₹326 lakh crore in 2024-25 budget: later it was brought down to ₹324 lakh crore with nominal growth 9.7% lower than the budget estimate of 10.5% growth. Presuming the estimate of ₹356 lakh crore nominal again with about 10% increase forecast and assuming that the budget size of some 14.5%, the budget size will be in the range of ₹51.62 lakh crore against the current year's ₹48.20 lakh crore, some 7% increase, not a big sum after adjusting the current inflation.

The reason for the shrinking budget size is in alignment with the economic policies of the budget architects. The present government's neo-liberal economic policies vehemently oppose the increasing fiscal deficit which means the focus will be on spending cuts and tax increases. The 2024-25 fiscal deficit was 4.9% of GDP. Finance Minister

Nirmala Sitharaman said her aim was to bring it down to 4.5%in 2025-26 budget and to keep on reducing it in successive budgets hereafter.

The same liberal economic policies that have a penchant for a low fiscal deficit that is low spending believe in the theory that economic growth is more important because they believe the growth trickles down benefits to the poor and middle classes. So, the approach is to help the industry and commerce rather than giving sops to the poor.

Based on income levels, the country has 134 million (9.7% of population) poor with less than \$2 a day income as per Pew Research Centre's compilation. Similarly, 1,162 million (84%) are in low-income category with earnings between \$2 and \$10 per day; 66 million (4.8%) middle-income group persons with \$10 to \$20 income: 16 million (1.2%) upper-middle-class persons with \$20 to \$50/ day and 2 million (0.1%) high-income individuals with above \$50 a day. Most people's expectations in India are understandable with poor (9.7%) and low-income (84%) categories accounting for 93.7% of the population.

Whatever the claims of growth and prosperity of the country the gap between rich and poor has been widening. The Gini coefficient of 0.410 in 2023 compared to 0.371 in 1955 as per a study of the People Research on India's Consumer Economy (PRICE), shows the present situation, worse than in the 1950s. Undoubtedly there has been growth but its fruits are not trickling down to the bottom but concentrating at the top whereby the number of billionaires and their wealth has been on the rise. Forbes billionaires' data show an increase in their number from just one in 1991 to 52 in 2011 and a further increase to 162 in 2022.

Unfortunately, the government's tax relief is also benefiting the rich and super-rich more than the ordinary. Not going into too many details some recent reputed media reportage showed ₹3 lakh crore worth of tax concessions garnered by the largest corporates since 2019 and the revenue foregone by the government since 2012-13 was ₹8 lakh crore.

A course correction is imminent with a practical approach as we do not expect any ideological shift from the government committed to neo-liberal economic policies. The tax relief to middle classes and low income is a big relief but not a big burden to the government since the revenue coming from the persons with incomes below ₹10 lakh is only 6.22% while those with above ₹50 lakh brought 76%.

Another ground to exclude this segment totally from the tax

fold is the falling consumption expenditure which is not even in the economic interest of the big because low consumption demand leads to lower sale volumes and profits.

Similarly, the middle classes expect no tax on the interest of their bank deposits since they are their poor sources of income. The government should rather encourage more deposits into the system and should learn how to use them productively instead of discouraging them with taxes on the interest earnings.

Naturally the rich want more sops. They want ease of doing business, simplified labour compliance, single window system, and transparency as listed in the CII's ten-point wish list.

As for others, the unemployed youth want employment and quality employment. Although some employment growth is shown what is conveniently forgotten is its quality. Most of the employment generated has been in the informal sector; more than 90% of employment in the country is in the informal sector.

Needless to add the woes of the farmers and their poor incomes. A high 92% of farm holdings are small and marginal. The monthly average of farmers' family income is ₹10,695. Of this, crop production provides ₹5,298 and the rest is coming as wage labour and from allied activities as per the NSS Survey 2019. Similarly, everyone knows about the neglect of health and education, their

poor quality and inadequacy. It may be concluded that the budget, poor in size due to excessive concern of limiting fiscal deficitto 4.5% of GDP, coupled with the government's commitment to neo-liberal economic policies cannot be a pro-poor budget in reality. So, the majority of the population, cannot expect any drastic changes in the tax regime or other concessions except some paltry benefits here and there.

health insurance is a shield that protects us and our families from financial instability during health emergencies. A good policy offers peace of mind at the time of hospitalization by taking care of our medical expenses. Of late, routine diseases like diabetes, obesity, respiratory problems, heart disease, are on the rise. This coupled with sedentary lifestyle, working environment, eating habits, gadget addiction and ecological imbalances make human lives fraught with increased incidence of ailments. With age, our overall health can decline and we might experience more frequent illnesses. Health insurance companies consider older individuals as higher-risk policyholders because they are more likely to need medical care. This perceived risk leads to higher premium costs.

Many people wonder, "can we get health insurance, if we are over 65," since most health care plans cap the entry age at 65. But today many insurance companies have special health insurance covers for the elderly, especially those above 65 because their health needs to be safeguarded too. While a 70-yearold individual may now have the opportunity to purchase health insurance for the first time, but they are likely to encounter stringent terms, exclusions and possibly high premiums.

To buy a new health insurance policy, senior citizens have to go for a full medical check-up. If they have pre-existing health conditions, the premium of the policies goes up. Senior citizens may also have a longer waiting period to claim the cost of treatment of certain medical conditions. The insurer has the right to reject a health insurance policy, if the underwriting process shows high risk, based on the results of the medical check-up. Usually, for senior citizens, premiums may increase every two to three years, based on the claims. As a rule, an insurer cannot contest any claim on the ground of non-disclosure or misrepresentation after the completion of 60 continuous months of coverage. In that case, if a senior citizen often claims insurance for surgeries or other expenses, the premium will sharply rise ev-

persons frequently visit doctors for check-ups, treatments and follow-ups become common. These OPD services lead to higher insurance premiums, as insurers anticipate more claims of OPD from older individuals.

As per IRDAI data, health insurers collected a total premium of ₹1.1 lakh crore during 2024 and settled claims totaling ₹83,493 crore making a profit of ₹26,507 crore. Still, insurance companies say health insurance is a loss-making business and every vear threaten not to renew the policies only to increase the premium amount year after year.

Considering the impact of medical inflation, which is around 15%, and the impact of these policy changes, the overall premiums may shoot upwards by 30% from coming year. Taking into account the advantage of group insurance plans offered by the employer, top-up health insurance plans offer cost-effective options for enhancing coverage by providing additional benefits at a lower premium than comprehensive plans. Family floater plans are a cost-effective option because they provide coverage

for multiple family members under a single policy.

Let us consider porting our insurance policy to another provider, if we find that our current insurer's premiums are too high. Transferring our coverage without losing benefits, is possible with many insurers and we might discover a more affordable plan with similar coverage elsewhere. Regularly reviewing our health insurance plan is important to identify unnecessary coverage or riders that can increase our premium.

It is important to explore government-sponsored health insurance schemes that offer subsidised or free coverage based on our location and income level. Recently the government has launched Pradhan Mantri Jan Arogya Yojana (PM-JAY) which aims at meeting the immediate hospitalisation needs of eligible beneficiary families in a cashless manner. Individuals can protect their financial well-being and secure their healthcare coverage by being proactive and making informed decisions.

### Launch web portal for live-in relationships: HC

Jaipur, Jan 30: A single-judge bench of the Rajasthan High Court has directed the state government to launch a web portal to register live-in relationships till the enactment of appropriate legislation.

Hearing a bunch of pleas filed by several live-in couples seeking protection, Justice Annop Kumar Dhand said that while such relationships may seem appealing, the problems likely to arise are many.

"Several couples are residing in live-in relationships and are facing threat and danger from their families and society for non-acceptance of their relationship status. Hence, they are approaching the courts by way of filing writ petitions under Article 226 of the Constitution, seeking protection under Article 21. As a result, courts are inundated with such petitions," the bench noted.

"The idea of live-in relationship may seem to be unique and appealing but in reality, the problems likely to arise are many and challenging. The status of a woman in such a relationship is not that of a wife and lacks social approval or sanctity," it said.

The bench noted that the live-in-relationship agreement



is liable to be registered by a competent authority or tribunal, which is required to be established by the government.

"Till the enactment of an appropriate legislation by the government, let a competent authority be established in each district to look into the matter of registering live-in relationships that will address and redress the grievances of such partners/couples who have entered into such a rela tionship and the children being born out therefrom. Let a website or web portal be launched in this regard for the redressal of the issue arising out of such

a relationship," the court said It directed that a copy of the order be sent to the chief secretary, principal secretary of the department of law and justice and the secretary of department of justice and social welfare, New Delhi to look into the matter and do the needful.

outside the court premises, bringing commercial activities to a standstill in Mawanda, Patan, Chala, Guhala, and Neem Ka Thana city.


The mining zone has also been completely shut down.

### JLF begins with need to bridge divide between arts, sciences

Jaipur, Jan 30: Technologies such as AI demand not just technical expertise but also understanding of human history and values without which any solutions proposed risk being shallow or even harmful, Nobel laureate Venki Ramakrishnan said Thursday while opening the Jaipur Literature Festival.

Literature and other parts of the humanities like history have a great part in helping

to break down these barriers. Scientists and science writers on their part can help communicate complex ideas to the general public while also being sensitive to their social consequences

The biggest celebration of literature started its 18th edition at Hotel Clarks Amer in the Pink City with the structural biologist proposing the need to bridge the divide between the arts and sciences.

As diverse streams of art, music, tradition, literature and sciences of India and the world flowed into a vast sea of listeners

across age, race, class and gender at the festival, Ramakrishnan pushed for greater empathy in his keynote address.

Quoting English novelist CP Snow's influential essay "The Two Cultures", he said science and mathematics have become 'seemingly unintelligible" and "almost magical" to those outside the anointed few.

"We live in an age dominated by technological advancements from artificial intelligence to gene editing to climate science. Many of these innovations have the potential to reshape human

existence in profound ways. But, as Snow warned in 1959, the general public often lack even basic scientific literacy,' Ramakrishnan said.

He added that even scientists can barely grasp these advances outside their "narrow" specialities.

At a time issues such as employment, food security, preparation for future pandemics and increasingly sophisticated weaponry gain centrestage, technologies like AI and genetic engineering carry tremendous promise as well as tremendous risks.

"All of these require more than just technical expertise, they demand empathy and understanding of human history, culture and values. Without that broader context the solutions we propose risk being shallow, shortsighted or even harmful," the 72-year-old noted. "Scientists alone cannot make decisions that affect us all."

According to him, there is need for the humanities, literature, philosophy, and history "to provide us with the framework to grapple with the moral ethical and social implications of the scientific inventions were make ing". In his view, instead of making people specialise too early, a broad curriculum that includes both sciences and humanities should be introduced to create

a "broadly literate" population "Such a population will at least have the basis to debate intelligently about the issues of the day and be less susceptible to being manipulated by demagogues and

misinformation," he said. JLF this year features a lineup of over 300 luminaries such as Nobel laureates, Booker Prize-winners, journalists, policvmakers, and acclaimed writ ers. 

### Yamuna poisoning claim row: Kejriwal slams CEC

New Delhi, Jan 30: AAP supremo Arvind Kejriwal Thursday accused Chief Election Commissioner Rajiv Kumar of engaging in politics by issuing him a notice over his claim that the Haryana government was "mixing poison" in the Yamuna.

Addressing a press conference, Kejriwal alleged that Kumar had "destroyed" the credibility of the Election Commission (EC) and was seeking a post-retirement position.

"No one has damaged the Election Commission the way Rajiv Kumar has done. If he wants, he can contest elections from any of the Delhi Assembly seats," the former Chief Minister said at the press conference.

"I will not let the people of Delhi drink poisonous water till I am alive. I know they will arrest me in two days but I am not afraid," he said without naming anyone. Kejriwal's remarks came shortly after the EC expressed dissatisfaction with his response to its notice, and gave him another opportunity to clarify his accusations against the Harvana government.

Targeting the CEC, the AAP supremo said, "If you want to do politics, contest elections. He is eveing a post-retirement job. No one has damaged the Election Commission as much as Rajiv Kumar has." "I will not let the people of Delhi drink poisonous water as long as I am alive. I know they will arrest me in two days, but I am not afraid," he added.

Taking a potshot at his polit-



ical rivals, Kejriwal alleged the Congress and BJP have teamed up and were putting the health of Delhi's people in jeopardy.

Echoing similar sentiments, senior AAP leader Manish Sisodia, in a post on X, said, "The Ya muna water which had touched 7 ppm ammonia, which is poisonous for the human body, was being sent by the BJP government of Haryana to the people of Delhi." "If the AAP raises its voice, you will file a case against it. I am willing to go to jail for the safety of the people of Delhi but will not compromise with the

lives of the people." "The BJP and Congress leaders, who are creating drama about becoming the leaders of the people of Delhi should try drinking this poisonous water mixed with 7 PPM ammonia We are sending bottles to your homes. Orink this water in front of the entire media; other

wise, apologise," Sisodia added Kejriwal responded to the EC's notice Wednesday, stating that raw water received from Haryana in recent days had been "highly contaminat ed and extremely poisonous' to human health. He warned that allowing such "toxic water' to be consumed would pose a severe health hazard and could lead to fatalities.

"Nobody is above the law in this country," it added. The counsel said his client and his father were jailed in connection with the cases lodged by

The counsel alleged the estranged wife gave a wrong declaration that no FIR was registered against her but she faced



two FIRs on the day she filled in ensuring that she loses a form at the time of joining the police service.

"You are more interested

her job," the bench said. The counsel said it was for the Home Ministry to take action if she had made any wrong declaration in her form.

"You are not interested in saving your life. You are interested in ensuring that her career goes. Ultimately, in the process of ruining her life, you will also ruin your life," said the court.

The bench observed it was "very clear" the man wasn't interested in settlement and said, "You are not interested in living your life happily. But you are only interested to ruin somebody else life. It is more than clear to us."

The bench noted it couldn't

force a settlement on the parties if they were unwilling and suggested they settled the disputes. The lawyers appearing for both the sides said the parties would sit together and try to find an amicable solution to the disputes. The bench posted the hearing after two weeks. One of the pleas filed by the

woman in the top court challenged the Allahabad High Court's June 2022 verdict The high court discharged the parents of the man in a criminal case lodged by the woman.

New Delhi, Jan 30: Ahead of the Union Budget, the Congress Thursday slammed the government's handling of the economy, asserting that there is a slowdown with "no jobs, raging inflation, stagnating wages and huge income inequality".

The Congress Thursday came out with a 'Real State of the Economy' report, compiled by AICC Research Department chairperson Professor M V Rajeev Gowda and his team, claiming the Modi government is marching India forward into the middle-income trap, which will make the country uncompetitive, underproductive and unequal.

The Opposition party also said that India's GDP growth for 2024-25, as per government data, is expected to be 6.4% but this rate of growth is not a cause for celebration as the country needs a sustained GDP growth of 8 per cent if it wants to encash its historic

demographic dividend. Addressing the press conference after releasing the 'Real State of the Economy 2025' report, senior Congress leader and former finance minister P Chidambaram said no matter how much the government may try to deny it, the economy is in a slowdown and it has fallen up to two per cent of the previous year's growth.

Asked whether the economy could go into recession, Chidambaram said the economy would not go into a recession even if there is no government in India and it will continue to grow at 4-5% because there are farmers, workers, and small industries that produce food grains and other things and

"The real question is how much more than 4-5% the government can grow the economy. This government's policies added about 1.5-2% to the inherent growth rate, but that's not sufficient. "We are indeed the fastest-growing economy in the world, but please remember this: Grow-



#### Sitharaman to table Economic Survey in Parliament today

New Delhi: Finance Minister Nirmala Sitharaman will table Economic Survey 2024-25 Friday, providing an official assessment of the performance of the economy in the ongoing financial year, and list out the challenges being faced by the nation. The Economic Survey, tabled in Parliament ahead of the Union Budget, also provides the roadmap for reforms and growth. The document is prepared by a team led by Chief Economic Adviser V Anantha Nageswaran.

added USD 787 billion to its GDP in that one year. Meanwhile, China grew last year at 4.91%, and it added \$895 billion to its GDP. We are growing at a faster rate but we add only \$256 billion to our GDP. So, we actually need to see the addition to the GDP and not compare the growth rates,'

Asserting that the economy is indeed facing significant Chidambaram challenges, said the high unemployment rates among youth and graduates, which are nearly 40% and 30%, respectively, are alarming.

"This is exacerbated by stagnant wages, which have remained unchanged for four to five years, making it difficult for people to make ends meet. Meanwhile, inflation is on the rise, with food, education, and healthcare inflation increasing by double digits,"

"There is a huge inequality gap, with 70% of the population living on a meagre ₹100-150 per day. The rich-poor divide is growing," Chidambaram said. "The economy is in a slowdown... that cannot be denied at all. However, much

that the economy is in a slowdown and this may be fallen up to two per cent of the previous year's growth."

Chidambaram said wages have stagnated for the last four to five years. "Inflation is raging, with food, education and healthcare inflation in double digits. Inflation has been raging for 2-3 years," the Congress leader said.

Chidambaram said many of the facts mentioned in the report released by the party are conveniently buried by the Union government.

The report titled 'What happened to growth?' said, "GDP growth in the 6% range is insufficient to create jobs for our growing youth population, especially when rapid technological change is disrupting the future of jobs.'

"It will keep India stuck in a state of high inequality, where two-thirds of our population remains dependent on free grains from the government, while the prime minister's favoured few accumulate wealth rapidly.

The Congress said such economic under-performance robs millions of the Constitution's promise of a more just.

"We have identified those who were behind the protest and instigated BPSC aspirants to gather near the commission's office and disrupted movement of traffic on Bailey Road. All protesters were removed by security personnel." he added.

Police have arrested four persons on charges of instigating protesters and detained 30 others who were involved in creating ruckus in the restricted area. "More people will be arrested on the basis of CCTV footage, which are being analysed", the Patna DM told PTI.

Out of the four arrested, one is Patna-based tutor Ramanshu Mishra. Police have filed two separate FIRs against 350 protesters at the Sachiwalaya and Kotwali police stations All four arrested, who are named in the FIRs, will be presented before the court Friday, the DM said.

"Majority of the protesters were brought from outside the state capital, and some of them came from other states as well," the DM claimed. He said out of the total 30 detained people, 26 are not residents of Patna.

# Top court allows HC to appoint ad-hoc judges

New Delhi, Jan 30: Considering a backlog of over 18 lakh criminal cases, the Supreme Court Thursday allowed the high courts to appoint ad-hoc judges, not exceeding the 10 per cent of the court's total sanctioned strength.

A special bench comprising Chief Justice Sanjiv Khanna and Justices B R Gavai and Surva Kant relaxed and kept in abevance certain conditions the top court had imposed in its April 20, 2021 judgment on appointment of ad-hoc judges in the high courts. The verdict, which was authored by former Chief Justice S A Bobde, directed retired high court judges to be appointed as ad-hoc ones for a period of two to three years to clear the backlog. While one condition said

the ad-hoc judges couldn't be appointed if a high court worked with 80 per cent of its sanctioned strength, the other said ad-hoc judges could sit separately on benches to deal with cases. Relaxing the conditions, CJI Khanna said, "Having regard to the situation, we are inclined to keep the observations from the conditions...of the order and judgement dated April 20, 2021 that recourse to the appointment of ad-hoc judges under Article 224A should not be made unless 80 per cent of the sanctioned strength is already either recommended or working," said the CJI.

The court said, "In other words, the requirement that vacancies should not be more than 20 per cent of the sanctioned strength for the time being shall be kept in abeyance." The bench said each high court should keep the

hoc judges and not exceed 10 per cent of the total sanctioned strength.

"The ad-hoc judges will sit in a bench presided over by a sitting judge of the high court and decide pending criminal appeals," said the apex court's order. The bench said it could partly modify the 2021 judgement to ensure ad-hoc judges were appointed to decide criminal appeals by division benches presided over by sitting high

## Cannabis in excess could damage working memory: Study

New Delhi, Jan 30: Heavy use of cannabis could affect a human's working memory, which is how the brain retains and uses just-learnt information to perform tasks, according to a new study.

Working memory helps a person follow instructions they've just been given or to mentally visualise and manipulate information, like solving

a math problem. Researchers, including those from the University of Colorado, US, analysed the effects of cannabis use in more than 1,000 young adults aged 22 to 36. MRI brain scans of the

participants were taken while they performed tasks that tested working memory, reward, emotion, among other cognitive

The study, published in The Journal of the American Medical Association (JAMA) Network Open, found that cannabis had a significant effect on brain function during working memory tasks, and a less significant one while performing other tasks.

"In this study of young adults, lifetime history of heavy cannabis use was associated with lower brain activation during a working memory task," the authors wrote.

"As cannabis use continues



to grow globally, studying its effects on human health has become increasingly important. By doing so, we can

provide a well-rounded understanding of both the benefits and risks of cannabis use, empowering people to make Researchers, including those from the University of Colorado, US, analysed the effects of cannabis use in more than 1,000 young adults aged

informed decisions and fully comprehend the potential consequences," first author Joshua Gowin, an assistant professor of radiology at the University of Colorado, said. While performing working memory tasks, heavy users of cannabis showed a reduced activity in brain regions involved in important cognitive functions, such as decision-making, memory, attention and emotional processing, the researchers said.

# Israel delays prisoner release

Cairo/Jerusalem, Jan 30: Hamas handed over three Israelis and five Thai hostages in Gaza Thursday, but Israel delayed the expected release of Palestinian prisoners after chaotic scenes at one of the handover points, where large crowds swarmed around the captives.

Arbel Yehud, 29, abducted from Kibbutz Nir Oz in the Hamas-led assault on Israel Oct 7, 2023, looked fearful and struggled to walk through a surging crowd as armed militants handed her to the Red Cross in a tense scene in the southern city of Khan Younis. Another Israeli hostage, Ga-

di Moses, 80, was also released along with five Thai nationals working on Israeli farms near Gaza when the militants burst through the border fence, the Israeli military said.

The mother of one of the Thais watched a livestream of the scene anxiously from her home in the northeastern Udon Thani province.

"Please, let my son walk out now, I want to see his face," Wiwwaro Sriaoun, 53, said as the footage on her phone showed a vehicle moving slowly through

Israeli Prime Minister Beniamin Netanyahu said the sight of their handover amid the swarming crowds was shocking and threatened death to anyone hurting hostages. He urged mediators to ensure the scene would not be repeated.

A total of 110 Palestinian prisoners were expected to be freed Thursday as part of the phased agreement that halted fighting in the shattered coastal territory earlier this month.

An Israeli official involved in the operation said buses carrying the detainees had been

### NASA's returned asteroid samples hold ingredients of life

The findings provide the strongest evidence vet that asteroids may have planted the seeds of life on Earth and that these ingredients were mingling with water almost right from the start

Cape Canaveral, Jan 30: Asteroid samples fetched by NA-SA hold not only the pristine building blocks for life but also the salty remains of an ancient water world, scientists reported Wednesday

The findings provide the strongest evidence yet that asteroids may have planted the seeds of life on Earth and that these ingredients were mingling with water almost right from the start.

"That's the kind of environment that could have been essential to the steps that lead from elements to life," said the Smithsonian Institution's Tim

McCoy, one of the lead study authors.

NASA's Osiris-Rex spacecraft returned 122 grams of dust and pebbles from the near-Earth asteroid Bennu, delivering the sample canister to the Utah desert in 2023 before swooping off after another space rock. It remains the biggest cosmic haul from beyond the moon. The two previous asteroid sample missions, by Japan, yielded considerably less material.

Small amounts of Bennu's precious black grains - leftovers from the solar system's formation 4.5 billion years ago — were doled out to the two separate research teams



whose studies appeared in the journals Nature and Nature Astronomy.

But it was more than enough to tease out the sodium-rich minerals and confirm the presence of amino acids, nitrogen in the form of ammonia and even parts of the genetic code.

Some if not all of the delicate salts found at Bennu — similar to what's in the dry lakebeds

of California's Mojave Desert and Africa's Sahara — would be stripped away if present in falling meteorites.

'This discovery was only possible by analysing samples that were collected directly from the asteroid then carefully preserved back on Earth," the Institute of Science Tokyo's

Yasuhito Sekine, who was not involved in the studies, said in an accompanying editorial.

Combining the ingredients of life with an environment of sodium-rich salt water, or brines, "that's really the pathway to life," said McCoy, the National Museum of Natural History's curator of meteorites. "These processes probably occurred much earlier and were much more widespread than we had thought before."

NASA's Daniel Glavin said one of the biggest surprises was the relatively high abundance of nitrogen, including ammonia. While all of the organic molecules found in the Bennu samples have been identified before in meteorites, Glavin said the ones from Bennu are valid — "real extraterrestrial organic material formed in space and not a result of contamination from Earth.

Bennu — a rubble pile just one-third of a mile (one-half of a kilometre) across — was originally part of a much larger asteroid that got clobbered by other space rocks. The lat est results suggest this parent body had an extensive under ground network of lakes or even oceans, and that the water evaporated away, leaving behind the salty clues.

Sixty labs around the world are analysing bits of Bennu as part of initial studies, said the University of Arizona's Dante Lauretta, the mission's chief scientist who took part in both studies.





Having fluffed their chances in the third T20I in Rajkot, the penultimate game of the fivematch series gives the hosts another opportunity to seal the series going into the final game in Mumbai, February 2. Suryakumar Yadav's men won the first two games in Kolkata and Chennai.

Samson, the maverick keeper-batter from Kerala, whose sympathetic and loyal fan base never fails to remind everyone of the limited chances he has got, started the T20I season with three hundreds against Bangladesh and South Africa prior to the ongoing series.

In the current rubber, he has had scores of 26, 5 and 3 and it is not these numbers that are concerning. In T20 cricket, if one factors in risk, there would always be lot of less profitable days at the office considering the kind of strokes batters play these days. But in case of Samson, what is of concern is his palpable discomfort against anything bowled above 145 clicks. Against Bangladesh at home,

he faced Taskin Ahmed, Tanzim Hasan Shakib while in South Africa Andile Simelane and Lutho Sipamla were among the bowlers.

These are not exactly intimidating fast bowlers and he rightfully took them to the cleaners. These are bowlers who fire in between 130 to 140 clicks and can be hit through the line on flat decks.

However, Jofra Archer and Mark Wood are different beasts, bowling between 145 kmph to 155 kmph and that pace is creating problems for Samson.

During all three games, the Kerala batter couldn't even get his bat down as deliveries would thud into Phil Salt's gloves. The hard lengths and steep bounce are creating a problem and even on batting shirt-fronts, it is not easy to hit through the line if one doesn't have proper technique or doesn't regularly face this

quality of fast bowling. Samson is one of head coach Gautam Gambhir's favourites and it is expected that he would be persisted with going into next year's T20 World Cup. But his technical issues need to be sorted out at the earliest by Gambhir, new batting coach Sitanshu Kotak and the himself.

The 2025 edition of the Champions Trophy, which is set to be played from February 19 to March 9, will be held across three venues in Pakistan and one in Dubai. India will, however, not travel to Pakistan for security reasons and will instead

play all their matches in Dubai. If they qualify for the final, the title clash will also be played in Dubai.

The inauguration ceremony would be held at the Huzoor Bagh in Lahore. The source though confirmed that PCB chairman Mohsin Naqvi had approved a scheduled list of events prior to the first match of the mega event at the National Stadium in Karachi

The PCB will officially open the renovated Gaddafi stadium February 7 in which Prime Minister Shahbaz Sharif has been invited as the chief guest.
