US cutting overseas aid contracts by over 90%

Washington, Feb 27: The Trump administration said it is eliminating more than 90 per cent of the US Agency for International Development's foreign aid contracts and USD 60 billion in overall US assistance around the world, putting numbers on its plans to eliminate the majority of US development and humanitarian help abroad.

The cuts detailed by the administration would leave few surviving USAID projects for advocates to try to save in what are ongoing court battles with the administration. The Trump administration outlined its plans in both an internal memo obtained by The Associated Press and filings in one of those federal lawsuits Wednesday. The Supreme Court intervened in that case late Wednesday and temporarily blocked a court order requiring the administration to release billions of dollars in foreign aid by midnight.

Wednesday's disclosures also give an idea of the scale of the administration's retreat from US aid and development assistance overseas, and from decades of US policy that foreign aid helps US interests by stabilising other countries and economies and building alliances. The memo said officials were "clearing significant waste stemming from decades of institutional drift.'

More changes are planned in how USAID and the State Department deliver foreign assistance, it said, "to use taxpayer dollars wisely to advance American interests.

President Donald Trump and ally Elon Musk have hit foreign aid harder and faster than almost any other target in their push to cut the size of the federal government. Both men say USAID projects advance a liberal agenda and are a waste of money.

Hindi mask, Sanskrit hidden face: Stalin

Tamil Nadu Chief Minister MK Stalin's vociferous opposition to alleged Hindi imposition on non-Hindi speaking states through the National Education Policy, 2020 took a curious turn Thursday when the DMK suprewill not allow the forcing of the language on it and vowed to protect Tamil and its culture. His contributions to Odia cinema earned him unparalleled respect. He remains the only Odia actor to have won the state government's Best Actor Award for three consecutive

years. He was also honored with Javadev Award in 1999.

Gene Hackman, wife found dead

Santa Fe, Feb 27: Oscar-winning actor Gene Hackman and his wife were found dead in their New Mexico home Wednesday, authorities said.

Foul play is not suspected, however authorities did not release any details of the circumstances of their deaths and said an investigation is ongoing.

Santa Fe County Sheriff's Office spokesperson Denise Avila said deputies responded to a request to do a welfare check at the home Wednesday around 1:45 pm local time and found Hackman, his wife Betsy Arakawa and a dog dead.

Hackman, 95, was a five-time Oscar nominee who starred in dozens of films and one of the industry's most respected and honoured performers. His two Oscar wins, for 'The French Connection' and 'Unforgiven',



were spaced out 21 years apart. News of his death comes just four days before this year's Academy Awards ceremony.

Hackman played a variety of roles, appearing in action movies, thrillers and even appearing in a comedic part in 'Young Frankenstein'.

Aside from appearances at awards shows, he was rarely seen in the Hollywood social circuit and retired in his mid-70s. An email sent to his publicist was not immediately returned early Thursday. P10

Things you can do to keep hackers at bay

ou must have read about former Disney employee Matthew Van Andel, whose world turned upside down when he downloaded an artificial intelligence (AI)-powered photo programme unaware that it was laced with hacking software. Now, you

must be wondering how to prevent this from happening to you. The Wall Street Journal lists out a few things you can do to make it harder for the hackers if they do slide into your digi-

tal life. Van had many usernames and passwords stored in a password manager. It can improve personal security as it eliminates the need to track passwords for dozens of online

accounts. However, the issue was Van did not have two-factor authentication (2FA) – a security sys tem that requires two distinct

forms of identification in order to access something - for the password manager itself.

Not having 2FA can make your life easier. However, make sure it's turned on.

It was shocking that after getting grip on Van's personal computer, the hacker dumped the contents of Van's password manager online. It made the attack worse as it allowed anyone who could see Van's logins and passwords to break into various accounts.

Many people might not realise that a lot of passwords they use frequently are already available online, stolen in data breaches. Password managers or some operating systems can flag when your passwords are exposed online and help create unique passwords that can then be stored.

Think twice when a website offers to 'remember you'.



According to the Federal Bureau of Investigation (FBI), hackers have ramped up the theft of 'session cookies'. A session cookie gets created

whenever users click 'remember me' while logging into a website. Often they are good for a fixed period, like a week or a month. But once a hacker

gets on your computer, they can use them to gain access to websites that require 2FA. Users should be very careful about using them on sensitive websites, FBI says.

Antivirus software like Microsoft's free Windows Defender is a superb product. However, it cannot protect you from everything. It did not discover that an AI plugin from GitHub that had positive reviews and seemed to work was actually malicious software (Trojan Horse).

Van tried out Bitdefender and it found the Trojan Horse immediately. If you're concerned, downloading some free antivirus software for a quick scan and a second opinion is not a bad idea. And if you are uncertain about the safety of a plug-in or some free software, ask yourself whether it's worth the risk. AGENCIES

Bhubaneswar, Feb 27: Union Health Minister Jagat Prakash Nadda who arrived here Thursday, will inaugurate the 9th National Summit on Good and Replicable Practices and Innovations in Public Healthcare System at Puri Friday

Chief Minister Mohan Charaj Majhi will be present at the inaugural function of the twoday event which will conclude March 1.

The event serves as a platform for states and Union Territories (UTs) to showcase their innovative practices and effective strategies aimed at enhancing public healthcare service delivery a press release issued by the I&PR department stated.

Additional chief secretaries/ principal secretaries, mission directors, senior state/UT nodal officials (NHM officials), and senior representatives from MoHFW, NHSRC, and RRC-NE will participate in the event, it added.

Cong to stage protest if power tariff is hiked

Bhubaneswar, Feb 27: The Congress Thursday threatened to stage protests across the state if power tariff is hiked from the upcoming financial year 2025-26.

Holding a press conference here, senior Congress leader and former minister Panchanan Kanungo said a hearing to hike power tariff is going on at Odisha Electricity Regulatory Commission

(OERC). Different power supply stakeholders have submitted their demands before the OERC to hike the power tariff and the commission is conducting public hearings on their pleas. So, there is an apprehension among the domestic consumers that the power tariff may be hiked

this time, he said. Kanungo claimed that the OERC has been engaged in bulk supply of electricity and power distribution companies have been demanding a hike in power tariff in the state.

"Prior to the 2024 Assembly election, the BJP had promised to provide 300 units of free power to the people of Odisha. However, instead of

providing free power, there is a proposal to hike power tariff by 12.42 paise per unit. So, we warn the government not to hike the power tariff,' the Congress leader said.

If the power tariff is enhanced by a single paise, the Congress party and its student, women and youth wings along with power consumers will launch state-wide agitations, he warned.

Youth Congress leader Yashir Nawaz, who was present at the press conference, said, "The Odisha government, in the state Assembly, informed that they have waived off electricity dues worth ₹4,097 crore to 14 industries in last 10 years. Similarly, electricity dues worth ₹1,096 crore have been pending against 23 industries." When such a huge amount

of electricity duty is pending against industrial units, on which basis, the power distribution companies have demanded for power tariff hike, he asked.

"Hence, we demand the government to reject the power tariff hike petitions of the power companies and implement the 300 free unit scheme immediately," the Congress leader said.

The new CCTV set up comprises 62 cameras which are connected to a dedicated control room. Oppn slams govt over temple mishaps

Bhubaneswar, Feb 27: Opposition BJD and Congress Thursday accused the BJP government of mismanaging major festivals at Srimandir in Puri and Lingaraj Temple in the Citv here.

A servitor fell from a height of 20 feet while carrying the 'Mahadeepa' (burning lamp) to the top of the 11th-century Lingaraj Temple as part of Maha Shivaratri rituals Wednesday. Three persons were injured in the accident.

In July last year, at least nine servitors of Srimandir were injured when the idol of Lord Balabhadra fell on them while it was being taken out from the chariot to a temple as part of Rath Yatra festival.

"The mishap at Lingaraj Temple during the lifting of 'Mahadeepa' is condemnable.

The state government has failed yet again, having already faltered during the Rath Yatra in Puri. There is still no report on how Lord Balabhadra's idol fell during the procession," BJD spokesperson Lenin Mohanty told reporters here.

He charged the state administration with remaining busy with VIPs only, rather than ensuring that festivals are conducted without mishaps.

Mohanty said the state government is vet to make its inquiry report public on how the idol of Lord Balabhadra fell.

Bhubaneswar Mayor and BJD leader Sulochana Das said the servitor's hand slipped while climbing due to oil on the stone wall of the Lingarai Temple. Earlier, sand used to be sprinkled on the stone to protect servitors from slipping due to oil, she said.

Newly appointed state Con-



gress president Bhakta Charan Das alleged the BJP government has twice hurt the religious sentiments of the people.

He asked the state government to issue a white paper on both the mishaps that hurt the sentiment of lakhs of devotees in the state and outside.

Das, who visited the injured servitor at Capital Hospital, claimed that the people were not satisfied with the government's management of the affairs in this regard.

The injured servitor iden-

tified as Jogendra Samartha was admitted to the hospital and Chief Minister Mohan Charan Majhi visited him there Wednesday night.

Senior BJP MLA Babu Singh said the Opposition leaders should refrain from indulging in politicising the matter.

He said the Bhubaneswar Mayor is also part of the admin istration and she was present at the shrine all day during Shivaratri festival, but did not rec tifv had there been any error.

The injured servitor's son Ashwini Samartha said there was no sand on the stone in the climbing area of the temple for which his father slipped and fell.

The ghee drops falling from the 'Mahadeepa' made the stone slippery, he said to reporters.

He said his father has been taking the 'Mahadeepa' to the temple top for the last 25 years and he is an expert in climbing the temple.

Nasal spray may help treat traumatic brain injury

New Delhi, Feb 27: A nasal spray being developed to target brain inflammation can also prove effective in treating traumatic brain injury (TBI) -- a leading cause of death and disability, according to a study. In a mice model, researchers from the Mass General Brigham in the US found that the spray could reduce damage to the central nervous system and behavioural deficits.

The research suggests a potential therapeutic approach for TBI and other acute forms of brain injury

Lead author Saef Izzy, neu-

rologist and head of the Immunology of Brain Injury Programme at Brigham and Women's Hospital (BWH), said that TBI includes cognitive decline and 'chronic inflammation is one of the key reasons'.

"Currently, there is no treatment to prevent the long-term effects of traumatic brain injury," Izzy added.

The team examined the monoclonal antibody Foralumab, developed by UK-based Tiziana, which has been tested in clinical trials for patients with multiple sclerosis, Alzheimer's disease, and other conditions. The team conducted multiple

experiments in mouse models



with moderate-to-severe TBI to explore the communication between regulatory cells induced by the nasal treatment and the microglial immune cells in the brain. They could identify how

these modulate the immune response, which led to "improved neurological outcomes, including less anxiety, cognitive decline, and improved motor skills," Izzy said. The results are published in the journal Nature Neuroscience.

The findings show that Foralumab may also work "in intracerebral haemorrhage and other stroke patients with brain injury", said the researchers.

'Our patients with traumatic brain injury still don't have an effective therapeutic to improve their outcomes, so this is a very promising and exciting time to move forward with something that's backed up with solid science and get it to patients' bedsides," said Izzy.

The next step in the research is to translate the findings from preclinical models to human patients, said the team.

20-yr RI to man for peddling narcotics

NIT Rourkela develops tech to **Brick kilns flout NGT regulations** enhance solar energy efficiency

Rourkela, Feb 27: A team of researchers from the National Institute of Technology (NIT) Rourkela has developed a technique to make solar power systems more efficient, affordable, and reliable.

Susovon Samanta, Associate Professor of Electrical Engineering, and team members Satabdi Bhattacharva, a PhD student, and Madhusmita Barik, a dual-degree student at NITR, have pioneered a lowcost technology that optimises the extraction of power from solar panels under changing weather conditions.

Supported by the Department of Science and Technology (DST) under the Clean Energy Research Initiative (CERI), the team has been granted a patent for their innovation (Patent Title: Method and System for Voltage Sensor-based Maximum Power Point Tracking for Photovoltaic System, Patent No. 543360, Application No. 202231039742).

Solar panels generate electricity from sunlight, but their output fluctuates throughout the day due to variations in temperature and sunlight intensity. To maximise energy production, solar systems employ a technique called Max-



imum Power Point Tracking (MPPT). This system adjusts the voltage and current based on sunlight and temperature changes to maintain peak efficiency. However, traditional MPPT methods can lead to energy waste and slow responses to changing weather conditions. To address these issues, the

team developed a voltage sensor-based MPPT method that eliminates the need for current sensors, reducing both system complexity and cost. Their approach uses a simple voltage sensor or resistor divider circuit to more accurately track the Maximum Power Point (MPP), resulting in improved tracking efficiency and enhanced energy harvesting.

"Our method minimises small power fluctuations that older techniques struggle with, ensuring stable and efficient power extraction. It also responds quickly to changes in sunlight and temperature, maintaining peak efficiency. Additionally, by using only a voltage sensor or a simple resistor divider circuit, it reduces system complexity and cost. Its adaptable design allows integration into a wide range of solar power setups, making it a versatile solution for various applications," Prof. Samanta said.

This innovation has significant potential for the renewable energy sector. It can be applied in solar-powered IoT devices, such as weather sensors and remote communication towers, where reliable energy output is essential. It can also be used in affordable consumer solar products like home lighting systems and portable solar chargers, where both cost and efficiency are critical. Additionally, it can support microgrid and off-grid energy solutions, providing stable power in remote or rural areas.

The team's research has been published in leading journals, including IEEE Transactions on Sustainable Energy and IEEE Transactions on Industrial Electronics.

Ignoring the directives of the National Green Tribunal (NGT), illegal brick kiln operators continue such activities with impunity, leading to rising temperatures in the area, thereby worsening public life. Highlighting these concerns, the Mangrove Forest Protection Organisation recently submitted a petition to the District Collector during a public administrative hearing, demanding action against the violations

Prabhu Prasad Mahapatra an official of the outfit, stated that riverbeds in the district have become prime targets of these businesses and illegal extraction of soil and sand is rampant. Existing environmental protection laws, including



the Forest and Environment Protection Act of 1986, as well as regulations from the Fire, Labour, and Revenue departments, have failed to curb illegal brick kiln operations.

Manufacturing and baking clay bricks without prior permission from the Odisha State Pollution Control Board (SP-CB) and the state government's Industries department are illegal. However, the continued operation of over a hundred brick kilns in the district has disrupted normal life

Environmental expert Ashok Kumar Swain pointed out that the heat, dust and fumes emanating from these kilns have led to hazardous environmental conditions, making life unbearable for local residents.

Akshav Behera from Bandhapada village under Derabish block said a formal complaint had been lodged at the District Collector's office regarding illegal mining. Certain individuals allegedly extracted soil from Tarajanga (Balidiapatna) pasture land to manufacture bricks, leaving the area unsuitable for grazing owing to craters of up to 3-4 feet depth. "Brick kiln owners extract

soil from pasture lands, uncultivated plots, riverbanks, and floodplains. The tehsil office has failed to take note of these activities, allowing the violations to continue unchecked,' alleged Subhendu Kumar Das, a resident of Kendrapara town. Debasish Jena from Indupur village said riverbanks across

the district have turned easy targets for illegal mining due to the high availability of sand and clay, rendering the landscapes severely degraded.

Brick kiln owners are reportedly employing labourers from Balasore, Bhadrak, Ke onihar. Medinipur in Kolkata and Chapra in Bihar for these operations. Cases of child la bour have also been observed in these kilns.

One brick kiln owner justi fied the operations citing increased demand for clay bricks in construction due to the shortage of fly ash brick factories. He suggested that if the brick factories were granted cottage industry status, those could generate employment opportunities for youths and address labour issues.

"Despite ban imposed by the SPCB and NGT, illegal brick kilns continue to function. According to the 1986 Pollu tion Control Act and the 2005 regulation banning sand mining within 500 metres of riv erbanks, these operations are prohibited," legal expert Bidhu Bhushan Mahapatra pointed out. He indicated plans to file a Public Interest Litigation (PIL)

Deogarh, Feb 27: Police have solved the murder case of a teenage boy at Tungamal village under Kundheigola police limits in Deogarh district with the investigations revealing that the crime was the fallout of a love triangle.

Two accused, identified as Sushil Munda from Chandrapur village under Naktideul police limits and Aman Nayak from Kuradapashi village under Kundheigola police limits, were arrested and produced in court Thursday. Police have also seized the victim's mobile phone and the rope used in the crime. The victim, 17-year-old Amit Munda, son of Bijay Munda from Tungamal, was reported to be missing by his family. After extensive searches, his body was discovered Wednesday inside the Tungamal forest. Preliminary investigations indicated that he was murdered and his body was hidden in the

Athagarh, Feb 27: A tusker was electrocuted late Wednesday night after coming in contact with live wires at Kuleilo Biribolua crusher under Sadar forest range and Athagarh forest division in Cuttack district.

According to Forest department officials, the dead animal is estimated to be 32-35 years old. The carcass was found about 500 metre away from the crusher unit. The unit was powered by an 11 KV line connected to the Athgarh-Khuntuni 33 KV supply line. Power supply to the crusher unit from the 11 KV line had been disconnected about four years ago but the wires had not been removed. The line had only been disconnected from the 33 KV supply line but remained intact.

Local residents had repeatedly urged the power distribution firm Tata Power and the Forest department to remove the live wires citing frequent elephant movement in the area. Howev



er, villagers alleged that their requests were ignored, leading to the fatal incident.

According to locals, overgrown wild shrubs and vines had become entangled with the 11 KV conductors drawn to the crusher unit. They alleged that the incident occurred when the

tusker was passing through the area late Wednesday night. When the animal attempted to pull the vine with its trunk, it inadvertently came in contact with the live conductor leading to electrocution. This happened as the conductors of the 33 KV

11 KV conductor, leading to the elephant's electrocution.

Residents have demanded immediate action to prevent similar incidents in the future. On being informed, senior

officials of Tata Power, along with DFO Yajnadatta Pati, Athagarh forest range officer Rabindra Nayak, and other Forest personnel arrived at the scene Thursday morning and conducted a probe. The carcass of the elephant was examined by veterinarians before it was buried in the forest.

RCCF Sudhanshu Shekhar Khara, DFO Yajnadatta Pati, Tata Power's Athagarh Executive Officer Jeetendra Patra and other officials also visited the site for an assessment.

Following a review meeting, Tata Power was directed to open the inactive conductors of the defunct power lines on priority basis by April 15. Khara stated that action will be taken against the officials found responsible once the investiga9 arrested for fishing inside Gahirmatha

All the arrested fishermen were later booked under Section 27, 29, and 31 of the Wild life (Protection) Act, 1972, and produced before the CJM court of Kendrapara, which remanded them into jail custody.

Building Institutions

ublic institutions worldwide are in crisis. Trust in them is declining, and US President Donald Trump's administration, working hand in glove with the world's richest man, Elon Musk, views them as enemies that need to be dismantled. In the face of funding cuts and geopolitical fragmentation, multilateral organizations look weaker than ever.

The attacks by Trump and Musk, who boasted about "feeding" US-AID "into the wood chipper" and preparing to abolish the Department of Education, may be ill-conceived and set to backfire. But they are reminding us that there is no good reason why public institutions have to be just as they were a half-century ago. Simply defending existing institutions looks ever less like an adequate response.

Few of humanity's biggest challenges - from shaping artificial intelligence and addressing mental health to managing energy transitions and industrial policy – are likely to be handled well without effective institutions. But today's ministries, agencies, commissions, public services, and regulators often look ill-suited to meet these new needs.

So, what should the alternatives look like? Governments have always depended on institutions to do their work – to enforce laws, educate children, collect taxes, or provide security - and they have

often invented new ones for new tasks, like reducing carbon dioxide emissions or fighting organized crime. Amid the funding cuts and attacks, reformers must focus on creating better expressions of the public interest, making the most of new tools and technologies to improve efficiency, and restoring public trust.

But the options for designing institutions today are very different from a generation ago. Global businesses like Alphabet, ByteDance, Amazon, and Alibaba have pioneered radically new business models and tapped into unprecedented economies of scale. A generation ago, few would have imagined that companies like Uber or Grab could provide a taxi service without owning any taxis

Meanwhile, civil society has also developed new models, such as Wikipedia, Ushahidi (data crowdsourcing), and Buurtzorg (home care), and there are many new forms of public-private

partnerships, as well as thousands of B-corps (like Natura in Brazil) guided by social and environmental principles.

There has also been some remarkable innovation within the public sector. Since its launch in 2009, India's Aadhaar program has provided biometric IDs to more than one billion people and helped vastly expand access to financial services. Over the past decade, Narendra Modi has been implementing his motto of "maximum governance and minimum government," while China created the world's first Cyberspace Administration in 2011, and its Government Guidance Funds have mobilized trillions of dollars for new technology since 2002.

But, in much of the world, public institutions have hardly changed. Most are still pyramid structures, as they were a century ago, and are too often opaque and unresponsive. When new institutions are created, they are typically designed by committees of relatively elderly politicians or civil servants and tend to be siloed, hierarchical, and inflexible.

Artificial intelligence shows starkly the gap between what's there and what's needed. It has been 20 years since AI started being widely used in some public services (including law enforcement and healthcare) and many private ones (such as credit scoring and search engines). But the world is only just starting to create institutions to govern it well - from procurement to maximize its value for public services to regulation to mitigate abuses, as well as multilateral institutions to pool global knowledge about the risks and opportunities associated with the technology.

In recent years, the list of high profile Congress functionaries exiting the grand old party is a rather lengthy one. A majority of them have left to join the BJP-led ruling alliance, a clear sign that the scent of power remains the ultimate magnet in politics. A few of them like Jyotiraditya Scindia, Jitin Prasada and Milind Deora for example had privileged access to the Congress' first family and yet chose to part ways. Other seniors like Himanta Biswa Sarma and Captain Amarinder Singh left after they found themselves on the wrong side of internal power politics.

Tharoor's case is a bit different. At the outset, he doesn't fit into the stereotypical Congress neta mould. Far from being an entitled dynast, a family friend of the Gandhis or someone who has wormed his way up the Congress ladder, the suave and articulate former UN diplomat turned MP represents a dying breed in Indian politics: a self-made meritorious individual whose career path combines the best of scholarship, hard work and skill.

When Tharoor first made the switch from UN bureaucracy to the hurly burly of electoral politics, there were

the usual sniggers, a belief that he was just another ambitious lateral entrant who would fall flat soon enough. His 'Stephanian' accent, unique vocabulary, personal life and loves were all seen to be unsuited to India's more conservative political milieu. No less than PM Modi had a rather unkind and wholly unwarranted jab at him when he derisively referred to Tharoor's late wife Sunanda as a '50 crore girlfriend'.

And yet, through all the storms in his private and political life, Tharoor has stuck it out as a four-time MP from Thiruvananthapuram, no mean achievement in a seat where the Left has a solid base and where the BJP has attempted to grow one. He may have punched above his weight at times - most notably when he threw his hat in the Congress president election ring in 2022 — but few can deny that he is one of the few English speaking 'outsiders' who has succeeded despite being stymied by an entrenched party system. As I detail in my book, 2024: The Election That Surprised India, Tharoor's bid for Congress presidency was fought on a completely non level playing field. That he still got over a 1000 votes in the contest suggests that his appeal within party ranks was greater than expected.

Part of Tharoor's problem is that he can't be slotted easily into any 'camp', a public intellectual who is perhaps far more comfortable in the

rarefied environs of a literature festival than in the cabals and coteries of Congress politics. Even when his name was propped up as part of the G23 — the grouping that was reportedly pushing for change in the Congress — it wasn't easy to see him spearheading a rebellion or coup in the Congress. Maybe his starkly individualistic style has meant that every time he supports a Modi government idea — be it on the economy or foreign policy — he is instantly viewed with suspicion by those within the Congress who claim to be waging a no holds barred 'war' against the Modi-BJP-RSS 'machine'. So deep are the anxieties and insecurities within a 'closed door' political system that there is an ever shrinking

trarian opinion. But a genuinely democratic party should never ossify into an echo chamber of sycophants. Sadly, that's the case with most of our political parties which is why Tharoor becomes a soft target for his critics within the Congress. Paradoxically, it is Tharoor's attempt to rise above the hyper-polarisation of a deeply divided polity that makes him such an attractive leader for the voter, if not the party. If the Congress has lost a large chunk of the urban middle class vote in particular in recent times it is because the party has got boxed into a narrow ideological construct where it finds it increasingly difficult to

to express even a mildly con-

appeal to a large fence-sitting populace who have no strong political loyalties. This group of voters is looking for a positive alternative for change, one revolving around a broadbased agenda of inclusivity and growth, not an opposition which is simply driven by a slough of negativism. As an avowed Nehruvian secularist who has repeatedly challenged the BJP's idea of Hindutva while also espousing a liberal outlook on economic issues, Tharoor's arguments offer an important ideological counterpoint to divisive saffronised politics as indeed he does to the left's sterile Stalinism.

Which is also why Tharoor might just be the right person to be projected as a Congress 'face' in Kerala, a state where winning the floating vote outside vocal cadre-based interests is crucial to electoral success. Kerala, in fact, is arguably the only state where the Congress might have a genuine shot at victory on its own in the next two year cycle of state elections. But as has been the case in so many other states, the Congress' capacity to score self-goals cannot be underestimated and having several CM candidates in a deeply factionalised state unit is a recipe for potential disaster. In the circumstances, is the Congress leadership ready to break with the status quo for once and take the 'risk' of elevating Tharoor as a possible Kerala chief minister? It may not be the worst choice a beleaguered party has made in recent times.

Post-script: At a recent dinner, a friend asked why I had never thought of entering politics. I referred to the case of Tharoor and chuckled, 'I guess some of us are far better off as talking heads in a TV studio and writing books on politics than actually being participants.' It is another matter that Tharoor and I went to the same school in south Mumbai: a truly cosmopolitan education may no longer be an asset in public life.

One reason for the delay was clever positioning by the industry. which discouraged governments from acting by framing AI as a fait accompli that should just be accepted. As Microsoft's chief economist, Michael Schwarz, put it in 2023: "We shouldn't regulate AI until we see some meaningful harm that is actually happening."

Such arguments are obviously favorable to private interests. But public institutions' duty is to the public. And as Daron Acemoglu, one of last year's Nobel laureate economists, and others have shown, it is institutions that determine why some countries prosper so much more than others.

Still, it is one thing to tout the successes of the Central Provident Fund and Temasek in Singapore, Brazil's Ministry of Social Development, the US Defense Advanced Research Projects Agency (DARPA). and the Development Bank of Southern Africa. It is quite another to devise equivalents for our current needs.

What will it take to create agile, flexible, and trustworthy institutions? What is the best design for making the most of AI, data, and collective intelligence (as the Intergovernmental Panel on Climate Change does for climate science)? Can we build on successes like Icarus, which mobilized satellite technology to build the "internet of animals" in an effort to help us track the state of animal populations on the planet?

These crucial questions are already a major focus within global bodies like the United Nations Development Programme. Its Istanbul Innovation Days conference in late March will feature innovators who are pioneering new methods to improve how institutions function.

These innovators are drawing as much from biology as from bureaucracy, thinking more in terms of mycelia (branching fungal networks) than pyramids. They are designing lighter mechanisms that can operate much faster during crises, and others that move more slowly and deliberately – like the establishment of a Future Generations Commissioner in Wales, which has inspired the creation of a similar post at the European Commission.

Work is underway to build new institutions to protect against misinformation and election interference; to mobilize capital for urban energy transitions; to empower indigenous communities; and to help young people navigate the labor market during a period of turmoil and uncertainty. UN Secretary-General António Guterres described the challenge well in 2023: "We cannot effectively address problems as they are if institutions don't reflect the world as it is. Instead of solving problems, they risk becoming part of the problem." Institutions are like buildings: we shape them, but they then subtly influence us and how we operate.We may be in an era of dismantling, disruption, and disorder. But history suggests that such circumstances eventually lead to rebuilding and reinvention. When that time comes, we will need to have already done the work of exploring better options. As the Brazilian sociologist and politician Roberto Mangabeira Unger observes, "the world remains restless under the yoke of a dictatorship of no alternatives." Fortunately, such restlessness can be fuel for imagination.

DEVELOPING COUNTRY LIKE INDIA, **INNOVATION** AND RESEARCH **ARE NOT JUST A SCIENTIFIC PURSUIT, BUT A VEHICLE FOR ECONOMIC** AWAKENING

ational Science Day marks the landmark discovery of Raman Effect by eminent physicist Sir CV Raman on 28 February, 1928 and his subsequent felicitation of the Nobel Prize as the first Asian in Physics. The theme for this year's celebration is 'Empowering Indian Youth for Global Leadership in Science and Innovation for a Developed India.

Over the years, India has made rapid strides in the Global Innovation Index (GII) rankings, rising from the 81st position in 2015 to 39th in 2024 among 133 economies. This leap in ranking reflects India's commitment to fostering a robust innovation ecosystem that is catalyzed by strong policies and a collaborative environment for startups and industries. In the 2024 edition of GII. while countries like Switzerland, Sweden, the US, Singapore, and the UK

dominated as the world's most innovative powers, India, along with China, Turkey, Vietnam, and the Philippines, has been recognised as one of the fastest-rising economies in terms of innovation over the past decade. Through its flagship initiatives like Start-Up India, Digital India. and Atal Innovation Mission, the government has strived to continuously foster entrepreneurship, research, and technological advancement.

The life of Raman has several important points to teach that would encourage the spirit of inquiry and innovation in our younger generation today. First, Raman published his first scientific paper "Unsymmetrical diffraction bands due to a rectangular aperture" in the British journal 'The Philosophical Magazine' in 1906 while he was just a graduate of only 18 years. Second, he

contradicted Lord Rayleigh, an established British physicist of that time, regarding the explanation for the blue colour of the sea which was believed to be due to the reflection of the blue sky. He proved that it was only due to the scattering of light rays by particles of water. This he concluded on the basis of an improvised experiment carried out with a Nicol prism from the deck of a steamship in the midst of the Mediterranean during his return vovage from Southampton to Bombay in 1921. It not only proved the Rayleigh explanation theoretically wrong, but represented a revolutionary idea from the Eastern world breaking the monopoly of the scientific supremacy of the West. Thirdly, Raman discovered his Raman Effect with the help of a Spectrometer that cost hardly five

hundred rupees at that time.

However, it is lamenting to note the state of poor research in India as is evident from the fact that the country has reportedly only 140 researchers per 1,000,000 population as compared to 4651 in the US.

For a developing country like India, innovation and research are not just a scientific pursuit, but a vehicle for economic awakening, societal transformation, inclusive growth and people's empowerment that leads to the ultimate goal of national development. Hence, building a right mindset and ecosystem for bolstering the research and innovation base in the country would truly establish us as world leaders in the field. Raman's life and work would always be the torch-bearer for us in achieving this goal!

Bangalore, Feb 27: Kempe gowda International Airport, Bangalore, operated by Bangalore International Airport Limited (BIAL) in partnership with Menzies Aviation, has launched India's largest Greenfield Domestic Cargo Terminal (DCT) in terms of designed capacity.

According to BIAL, this stateof-the-art 245,000-square-foot facility marks a significant milestone in BLR Airport's cargo handling capabilities. It offers enhanced infrastructure and streamlined processes to meet the growing demands of the domestic market.

This facility will play a key role in connecting industries, strengthening supply chains, and driving innovation toward a more sustainable future for domestic cargo and regional trade, positioning BLR Airport as a leader in cargo handling.

Spanning over seven acres, the DCT has a peak handling capacity of approximately 360.000 metric tons. with the potential to expand to 400,000 metric tons.

"With around 42 truck docks, more than 400 specially designed cargo bins, conveyors integrated with X-ray machines, approximately 30 Unit Load Device (ULD) build-up and breakdown stations, along with real-time data capture using 40 handheld terminals and self-service kiosks for agents. the facility will ensure seamless cargo movement while reducing turnaround times,' BIAL said in a statement.

Briefing the media, BIAL COO Satyaki Raghunath said, 'This is an initiative we conceptualised over the last two or three years. When we established this partnership, our goal was to prioritise domestic

The survey aims to monitor vulture populations in seven protected areas where these birds are known to exist.

According to a statement from the Principal Chief Conservator of Forests and Chief Wildlife Warden of Tamil Nadu, the census is being carried out with the participation of Forest department field staff, vulture experts, NGOs, students, and volunteers.

The highest concentrations were recorded in the Mudumalai and Sathyamangalam Tiger Reserves in Tamil Nadu.

The December 2023 survey identified the following vulture species: 217 critically endangered white-rumped vultures (Gyps bengalensis), 47 long-billed vultures (Gyps indicus), 50 Asian king vultures (Sarcogyps calvus), four endangered Egyptian vultures (Neophron percnopterus), and two near-threatened Himalayan griffon vultures (Gyps himalayensis).

The Nilgiri Biosphere Reserve is home to three main vulture species: white-rumped vultures, long-billed vultures, and Asian king vultures.

PUNE BUS RAPE

13 police teams to nab accused, ₹1L reward

Mumbai, Feb 27: Pune police Thursday announced a reward of ₹1 lakh for information leading to the arrest of a history-sheeter who allegedly raped a 26-year-old woman inside an MSRTC bus at the Swargate bus station here, officials said.

Amid the frantic efforts to crack the case, Shiv Sena (UBT) leader Sanjay Raut drew parallels between the crime and the 2012 Delhi Nirbhaya gang rape and targeted district guardian minister Ajit Pawar over law and order.

As many as 13 police teams are working to nab the accused, Dattatray Ramdas Gade (37) who has been on the run since the incident which took place on a Maharashtra State Road Transport Corporation (MS-RTC) bus early Tuesday morning, a police official said.

A reward of ₹1 lakh will be given to the person providing information about his whereabouts, Pune police commissioner Amitesh Kumar told PTI. Another police official said that information about Gade can be provided at numbers 020-24442769 or 9881670659. The informer's name will be kept

secret, he added. Gade has half a dozen cases of theft, robbery and chain-snatching registered against him in Pune and adjoining Ahilyanagar district, and was out on bail since 2019 in one of the offences. Swargate in Pune city is one of the largest bus depots of the Maharashtra State Road Transport Corporation (MSRTC).

According to the survivor woman, as she was waiting for a bus for Phaltan in Satara district at one of the platforms around 5.45 am Tuesday, a man approached and engaged her in conversation, calling her 'didi'

(sister), and said the bus for Satara had arrived at another platform.

He took her to an empty 'Shiv Shahi' AC bus parked elsewhere on the sprawling station premises. As the lights inside the bus were not on, she hesitated to get in at first, but the man convinced her that it was the right vehicle. He then followed her inside and raped her before fleeing, the woman, who works in the medical field,

told police. Transport Maharashtra Minister Pratap Sarnaik announced to dispose of all the scrapped buses and other vehicles parked in MSRTC depots before April 15, 2025.

Addressing a press conference at Mantralaya after taking a review of security concerning buses of MSRTC and its premises in the wake of the Swargate rape case, Sarnaik also said that around 15,000 buses, including hired ones, will be

fitted with GPS, panic buttons, and CCTV cameras.

Sarnaik also demanded the appointment of an IPS officer for the vacant post of security and vigilance officer in MS-RTC. He said that presently MSRTC has around 2,700 security guards, which are appointed through various security boards, but their number is very low, and hence 15-20 more female security guards will be increased in the corporation.

The shocking incident in the heart of Pune caused uproar, with the opposition lambasting the BJP-led Maharashtra government over women's safety.

Shiv Sena (UBT) leader Sanjay Raut compared the crime to the 2012 Delhi gang rape and targeted district guardian minister Aiit Pawar over the law and order situation. The Rajya Sabha MP said crime against women had increased drastically in Maharashtra.

26/11 TERROR ATTACK Court summons trial records from Mumbai

New Delhi, Feb 27: A Delhi court has sought the trial records of 26/11 terror attack from a Mumbai court ahead of the expected extradition of the crime's alleged mastermind Tahawwur Hussain Rana to India from the US.

MP Chief Justice Suresh Kumar Kait and Justice Vivek Jain had directed that the state government undertake "first trial run of 10 metric ton by taking all protocols into consideration" February 27.

During the hearing, the MP government said it may take three-four days to dispose of the first consignment of 10 tonnes of waste.

The study, which analysed data from over 6,600 newborns, found that the overall incidence of sepsis ranged from 0.6 to 10

per cent across the hospitals. The incidence was higher among newborns referred from other hospitals than in those born at the same facility. The findings, published

in The Lancet Global Health journal, underscore the need to strengthen infection prevention

and control measures while implementing programmes that ensure a judicious use of antibiotics, researchers said. Researchers, including those from the All India Institute of Medical Sciences, New Delhi and Raipur, said that data of sepsis in newborns from district hospitals in low- and middle-income countries is scarce. Sepsis occurs when one's

immune system produces an extreme response to an infection, thereby damaging tissues and organs. It can lead to multi-organ failure and can be potentially life-threatening. Antibiotic resistance, in which infection-causing germs become immune to the drugs designed to kill them, is a major chal-



lenge to managing sepsis. More than 39 million are projected to die due to antibiotic-resistant infections during the next 25 years with most of them estimated to occur in

Plastic use in idli preparation banned in K'taka hotels

Bangalore, Feb 27: Karnataka Health Minister Dinesh Gundu Rao Thursday announced a ban on the use of plastic in idli preparation after samples tested positive for carcinogenic elements due to the use of polythene sheets.

He said the Karnataka Food Safety Department found that 52 hotels were using polythene sheets to prepare idlis. According to him, polythene, especially thin sheets, is carcinogenic, and the government will not allow such practices in the hotel industry.

"The Food Safety Department collected idli samples from 251 places across Karna-



taka. Earlier, cloth was used for cooking idlis, but we received information that hotels have recently started using plastic. So, our officers conducted inquiries at various locations,"

Rao told reporters.

Out of 251 hotels, 52 were found using plastic, the minister said, adding, "Hoteliers should never have done this because plastic is carcinogen-

Taiwan condemns China for conducting shooting drills off its coast

Taipei, Feb 27: Taiwan Thursday condemned China's military exercises after Beijing designated an area to conduct shooting drills off the self-governed island's southwest coast.

China considers the island a renegade province to be taken by force if necessary and in recent years has increased military activity around Taiwan's waters and airspace.

"China is the biggest troublemaker for regional peace and stability, and the sole and greatest threat to peace and stability in the Taiwan Strait and the Indo-Pacific region,' Taiwan's Foreign Ministry said

in its statement. In Beijing, Chinese Defence Ministry spokesperson Wu Qian accused Taiwan of playing up what he called routine activity of China's military, officially called the People's Liberation Army. "The comments made by the relevant authorities of Taiwan on the routine exercise and training activities of the PLA are purely hype-ups," he said at a monthly news conference. Taiwan's Defence Ministry said in a 24-hour period it detected 45 aircraft, 14 navy vessels and one ship from the Chinese military operating around Taiwan, of which 34 had crossed into its waters and airspace. Taiwan said that it "responded accordingly" without elaborating. This comes after Taiwan said four Chinese coast guard boats entered into its waters near Kinmen island earlier this week, and that Taiwan dispatched its own boats to drive them away.

graphic crises South Korea's statistics agency said Wednesday that 2,38,300 habies were born last year, an increase of 8,300 from a year earlier. It said the country's fertility rate — the average number of babies born to each woman in their reproductive years — was 0.75 in 2024, up from 0.72 in 2023.

It's the first time that the yearly number of births has increased since 2015.

"It's fair to say this is a considerably meaningful rebound," Choi Yoon Kyung, an expert at the Korea Institute of Child Care and Education, said. "We still have to see figures in the next few years to find whether it was a temporarv rebound or it was driven by structural changes.

Park Hyun Jung, a senior official at the Statistics Korea, said that her agency assessed the increase in births was partly attributable to an increase in marriages among couples who delayed weddings during the

New Delhi, Feb 27: India's private consumption has almost doubled to \$2.1 trillion in 2024 from \$1 trillion in 2013. growing at 7.2 per cent CAGR, faster than the US, China and Germany, according to a report.

House price index rises 3.1% in Q3

Mumbai. Feb 27: All-India House Price Index (HPI) increased 3.1 per cent in the third quarter of 2024-25 as compared to 4.3 per cent growth in the preceding three months and 3.8 per cent growth in the yearago period, according to data released by the Reserve Bank of India (RBI).

The RBI released its quarterly house price index for the December quarter of 2024-25 Thursday, based on transaction-level data received from the registration authorities in 10 major cities.



The RBI said the annual HPI growth varied widely across the cities - ranging from a high growth of 8.1 per cent (Kolkata) to 0.1 per cent (Kanpur).

On a sequential (q-o-q) basis all-India HPI increased by 0.4 per cent in Q3:2024-25.

America First? Not when it comes to stock markets worldwide

The US stock market has risen in 2025 and isn't far from its all-time high set last week. But it's climbed less than stock indexes in Mexico City, Paris and Hong Kong.

The difference in performance has been so stark than an index of stocks from 22 of 23 developed economies around the world, excluding the United States, has trounced the S&P

500: a 7.5 per cent rise through Monday versus 1.7 per cent for Wall Street's benchmark.

The split in performance has many causes, and if it continues, it would mark a sharp reversal following years of US exceptionalism. The US stock market has been the clear winner for so long among global markets in large part because the US economy's growth has been so much stronger and more stable than nearly anywhere else.

But the steep divide means many other stock markets now don't look as pricey as Wall Street, where critics say prices for many stocks rose too quickly relative to their companies admittedly booming profits. And the Big Tech stocks that have accounted for more and more of the US stock market as they kept soaring look particularly expensive to some. Morgan Stanley strategist

Michael Wilson said many of



his clients in recent weeks have been asking if they should be focusing more outside the United States. That includes tech stocks from China, where an upstart called DeepSeek rocked the artificial-intelligence industry by saying it had developed a large language model that could compete with big US rivals but at a much lower cost.

Central banks in other countries also seem much more willing to cut interest rates, a move that often tends to boost stock prices there. The European Central Bank eased rates in January, for example. Bhubaneswar, Feb 27: With their playoff hopes hanging by a thread, Odisha FC will aim for maximum points when they take on Mohammedan SC in the Indian Super League here Friday.

The Juggernauts have struggled in recent weeks, registering just one win in their last five outings (W1, D2, L2) as they have slipped to seventh place with 29 points from 22 matches -- three points adrift of sixth-placed Mumbai City FC (32), who have played one game fewer.

Odisha also face stiff competition from East Bengal FC (27 points from 22 matches) and Kerala Blasters FC (24 points from 21 matches) in their bid to secure a top-six finish.

To stay in contention, Sergio Lobera's side will be also hoping for favorable results from Mumbai City FC and NorthEast United FC in the coming rounds.

Odisha FC are unbeaten in their last three home games (W1, D2) in the ISL. A victory on Friday would mark their first consecutive home wins since their four-match winning streak between February and April 2024. Odisha failed to score in their

last ISL outing, a 0-1 loss to Mohun Bagan. They will be eager to avoid back-to-back goalless matches for the first time since early 2023.

With 41 goals this season -- the second-highest in the league --Odisha FC's attack will be looking to fire once again.

Isak Vanlalruatfela, who has three goals, four assists, will be one of their key players as they would also look forward to Diego Mauricio who has nine goals and six assists, boasting 95 touches inside the opposition

box this season. "As a team, we want to believe until the end, keep fighting, and hopefully qualify for the playoffs. We also want to make our fans happy and put a smile on their faces," said Lobera, Odisha FC coach. Rooted to the bottom of the table, debutants Mohammedan

SC have endured a torrid run, losing all of their last five games. Another defeat would mark Mohammedan SC's longest losing run in ISL history and they would be keen to avoid that. With just 11 points from 21

matches, their chances of survival look bleak. However, their two wins this season -- against Chennaiyin FC and Bengaluru FC -- have both come on the road, offering them a glimmer of hope as they take

McCann. who was in Bhubaneswar from February 6-12, has been working for nearly eight years with the German U21 and Senior squads.

Experienced India forward Mandeep Singh said McCann paid special attention to the minute details that go into scoring field goals.

"I particularly enjoyed the basics inside the 'D', shot on target two-feet from the goal," said Mandeep, who played a key role upfront, scoring some fine field goals, including a breathtaking goal against Ireland in India's 3-1 win.

"He also taught us new things specific to strikers' lead and relead within the circle and how to deflect from the nine-yard mark near the D with two-touch to the goal were some of the interesting aspects he made us work on.

New Delhi, Feb 27: Asia Cup. which will serve as a preparatory event for the 2026 T20 World Cup, is likely to be held in September this year at a neutral venue though the hosting rights

are with India The last Asia Cup was held in the ODI format ahead of the 2023 50-over World Cup in India. "The tournament will be held in September. India has the hosting rights but it will be played in UAE or Sri Lanka," said a source in the Asian Cricket Council. The highlight of the event will be the India-Pakistan contest and if they reach the final. both teams could play each other as many as three times. India, Pakistan, Sri Lanka, Bangladesh, Afghanistan, UAE, Oman and Hong Kong will be the eight participating teams. Though BCCI has the hosting rights, it could go for a neutral venue with Pakistan unlikely to travel to India given what transpired in the ongoing Champions Trophy. India are playing all their Champions Trophy games in Dubai thought the hosts are Pakistan, where Rohit Sharma's team has not travelled due to security concerns.

Pakistan's campaign ends on winless note

Rawalpindi, Feb 27: Pakistan's campaign in the Champions Trophy ended on a winless note after their match against Bangladesh was called off without a ball being bowled due to incessant rain here Thursday.

The match was effectively a dead-rubber, with both teams already out of contention after failing to secure a win in their two previous matches. Pakistan. hosting an ICC tournament for the first time in 29 years, had hoped for a strong finish but ended their disastrous campaign without a victory.

Sports Minister launches course to develop more home-grown coaches

New Delhi, Feb 27: Sports Minister Mansukh Mandaviya Thursday launched a special capacity building course in collaboration with Netaji Subhas National Institute of Sports, Patiala for current and former elite sports persons in an effort to help India produce more home-grown coaches and officials.

The course has been designed and developed for athletes who are currently employed and serving in various central government or autonomous departments, organisations under central government or Public Sector Undertakings (PSUs). The eligibility criteria for

this course are participation

or medal winner in Olympics. World Championships, Asian Games, Commonwealth Games. The medal winners of Youth Olympics, Junior World Championship, World University Games, senior National Championship and National Games can enroll for the course.

The educational qualification required is minimum graduation or equivalent degree from any recognized university in India.

The course consists of four certification levels - foundation, pre-intermediate, intermediate and advanced certificate.

'We are suffering from a crisis of coaches, referees and trainers, so to bridge that I am starting a special capacity building course and give them a six week course. If they pass this course, some will become coaches, some will become referees, and they can be utilized in different sport-related work," Mandaviya said in a meeting with reporters
