'The Ranveer Show' to resume with riders

New Delhi, March 3: The Supreme Court Monday allowed podcaster Ranveer Allahbadia to air his 'The Ranveer Show subject to maintaining 'moral ity and decency' and an undertaking that it was suitable for

A bench of Justices Surya Kant and N Kotiswar Singh took note of Allahbadia's submission that the podcast was his only source of livelihood and around 280 people employed by him were dependent on the show.

The bench also extended the interim protection from arrest granted to Allahbadia till further orders, while asking him to join investigation in Guwahati.

Solicitor general Tushar Mehta, appearing for the Centre and states like Maharashtra, Assam and Odisha, said the comments made on the contentious YouTube show 'India's Got Latent' was not only vulgar but perverse and urged the court not to modify the condition of not airing any

SC: Vision no bar for justice Biju goes; Panchayati


that would go a long way in the empowerment of differently-abled in the country, the Supreme Court Monday ruled that visual impairment is in no way an impediment for the discharge of justice. Hearing a batch of petitions, including a letter petition filed by a visually-impaired candidate's mother in 2024, challenging a clause in the Madhya Pradesh Judicial Services (Recruitment and Service Conditions) Rules that prevented visually-impaired candidates from seeking appointment in the state judicial services, the top court ruled no candidate can be denied such opportunity solely on account of disability. The court said no one should face any discrimination in the pursuit of judicial service recruitments, and the State must provide them affirmative action to ensure an inclusive framework. Nevertheless, the order will herald a new chapter in the annals of the iustice system in the country which has long served without prejudice or bias of any kind, aptly represented by the statue of Goddess of Justice

New Delhi, March 3: The Supreme Court Monday held that visually-impaired persons cannot be denied opportunity of employment in judicial services, as it struck down provisions of the Madhya Pradesh Judicial Service Rules that excluded them.

The top court said, "It is high time that we view the right against disability-based discrimination, as recognised in the RPwD Act (Rights of Persons with Disabilities Act) 2016, of the same stature as a fundamental right, thereby ensuring that no candidate is denied consideration solely on account of their disability.'

A bench of justices JB Pardiwala and R Mahadevan delivered the significant judgement on petitions, including a suo motu case, over non-grant of quota to visually-impaired and low vision candidates in judicial services in a few states.

In the 122-page judgement, Justice Mahadevan held, "Visually impaired candidates cannot be said to be 'not suitable' for judicial service and they are eligible to participate in selection for posts in judicial service."



The verdict said the amendment made in Rule 6A of Madhya Pradesh Judicial Service (Recruitment and Conditions of Service) Rules, 1994, "falls foul of the Constitution, and is hence, struck down to the extent that it does not include visually impaired persons who are educationally qualified for the post to apply'

It also said that the provision to Rule 7 relating to additional requirements violated the equality doctrine and the principle of reasonable accommodation, and struck down its application to differently-abled persons who have requisite qualifications for applying to judicial posts.

"The overall analysis would

demonstrate that a rights-based approach necessitates that PwDs must not face any discrimination in their pursuit of judicial service opportunities, and instead, there must be affirmative action on behalf of the state to provide an inclusive framework," the bench said.

It referred to the principle of reasonable accommodation. as enshrined in international conventions, established jurisprudence, and the RPwD Act and said accommodations be provided to them as a prereg uisite to assess their eligibility.

"Any indirect discrimination that results in the exclusion of PwDs, whether through rigid cut-offs or procedural barriers, must be interfered with in order to uphold substantive equality," it said. It said relaxation can be resorted to in assessing the suitability of candidates when enough PwD are not available after selection in their respective category.

The bench directed the authorities to proceed with the selection process for appointment of judicial officers in the light of the decision and complete the same, as expeditiously as possible, preferably, within a period of three months.

Bhubaneswar, March 3: The state government Monday decided to celebrate Panchayati Raj Diwas April 24, instead of March 5 – the birthday of former chief minister Biju Patnajk - earlier.

The decision was taken to align the celebration of the day with National Panchayati Raj Diwas which is observed April 24. The government, through a notification issued by GA & PG department, said March 5 will be marked as a special day to honour Biju Babu which won't be a public holiday.

March 5 was being celebrated as Panchayati Raj Diwas in Odisha since 1990s. However, April 24 is celebrated as National Panchayati Raj Diwas during which Panchayat representatives of various states are felicitated. Moreover, April 24 will also

be observed as Lok Seva Diwas. Meanwhile, Biju Janata Dal (BJD) demanded that the state government should observe the

Panchavati Rai Diwas March 5. The birth anniversary of the legendary leader has been observed as Panchayati Raj Diwas every year in the state. Speaking to mediapersons

here Monday, senior BJD leader Debi Prasad Mishra said, "It is unfortunate that the state government delinked Biju Patnaik from the Panchayati Raj system. It was Biju Patnaik who strengthened the Panchayati Raj movement in the country and made 30 per cent reservation for women in the three-tier Panchayati Raj sys tem."All previous governments in the state have celebrated it March 5 since the 90's. But it is a matter of great sorrow that no preparations or decisions have been taken by the present Mo han Charan Majhi government even as only two days are left for the 109th birth anniversary of Biju Patnaik, the senior BJD leader said. Nagapattinam (Tamil Nadu), March 3: Tamil Nadu Chief Minister MK Stalin Monday favoured young people having children immediately following marriage and said a higher population appeared to be the criterion to get more MPs.

Addressing a wedding, Stalin, also the DMK president, said years ago, newlyweds were advised to not have children immediately following

However, the same thing must not be advised now and also there was no need for that. It is because a situation has now arisen, according to which only a higher population would ensure more MPs as the delimitation exercise would be on the basis of population, Stalin said.

Tamil Nadu paid attention to population control and succeeded and that was the reason for the state's plight today, he added. "I will not tell you to not have children hastily, have children immediately; but give them beautiful Tamil names,' he said, directly appealing to the bride and bridegroom.

The Tamil Nadu Chief Minister had October 21, 2024 said that the Lok Sabha delimitation exercise may make people to think about raising "16 children," alluding to a Tamil saying on 16 kinds of wealth.

Last year, Andhra Pradesh Chief Minister N Chandrababu Naidu had urged people of his state to have more children. He had also spoken of new policies to encourage people to have more children.

Los Angeles, March 3: 'Anora', the story of a New York sex worker who gets a chance at a new life when she marries a wealthy Russian client on a whim, won five Academy Awards Sunday, including the coveted best picture Oscar. In addition to best picture, Sean Baker won for best director, original screenplay and editing to tie the record for most Oscars won by an individual in one year with Walt Disney who won for four different films in 1954. The movie's 25-yearold star, Mikey Madison, was named best actress.

Baker's tale of an erotic dancer who elopes with the son of a Russian oligarch – unusually explicit for a best-picture winner - was made for just USD 6 million.

But Oscar voters, eschewing blockbuster contenders like 'Wicked' and 'Dune: Part Two', instead added 'Anora' to a string of recent indie best picture winners, including 'Everything Everywhere All at Once', 'CODA' and 'Nomadland'.

For a film industry that's been transformed by streaming and humbled by economic turmoil. Baker and 'Anora' epitomised a kind of cinematic purity. On the campaign trail,



Baker called for the return to the 90-day exclusive theatrical release.

"Where did we fall in love with the movies? At the movie theater," Baker said Sunday. "Filmmakers, keep making films for the big screen.'

In personally winning four Oscars Sunday, Baker tied the mark held by Walt Disney, who won for four different films in 1954. That Baker and Disney share the record is ironic; his 'The Florida Project" took place in a Florida low-budget motel in the shadow of Disne-

"Long live independent film!" shouted Baker from the Dolby Theatre stage.

Twenty-two years after winning best actor for 'The Pianist', Adrien Brody won the same Oscar again for his performance as another Holocaust survivor in Brady Corbet's 'The Brutalist'.

chayati Raj Diwas March 5.

Brody's win came over Timothée Chalamet ('A Complete Unknown'), who had the chance of becoming the youngest best actor ever, a record owned by Brody - just short of 30 when he won for 'The Pianist'.

"I'm here once again to represent the lingering traumas and the repercussions of war and systematic oppression and of antisemitism and racism and othering," said Brody. "I pray for a healthier and happier and more inclusive world. If the past can teach us anything it's to not let hate go unchecked.'





MAJHI CALLS CONG 'SINKING PARTY'

Bhubaneswar, March 3: Calling the Opposition Congress a "sinking party," Chief Minister Mohan Charan Maihi Monday said his government would soon publish a white paper on the alleged rise in atrocities against women in the state.

Majhi made this remark in response to an agitation by Congress supporters, led by its newly elected OPCC president Bhakta Charan Das, March 1. The Opposition party had alleged that crimes against women in Odisha had risen since the BJP came to power eight months ago.

"Let the Congress target the government. Congress is a sinking party, and it is doing so (agitation) in order to come to the limelight. It is making baseless allegations. The state government will soon bring a white paper on the issue (women atrocities)," Majhi told reporters on the sidelines of the CM's

Grievance Hearing session. Majhi, who also holds the Home portfolio, claimed that the number of cases involving women had drastically decreased compared to the previous government.

"Our government has been taking quick action against accused persons and sending them to jail. The court will consider cases and sentence punishment for the accused," the CM said

He added that as an Opposition party, Congress should raise such issues in the Assembly, such as during the question hour, zero hour, or as an adjournment motion.

"Let there be discussions. Our government is fully prepared to discuss the issues. We are not the government which runs away from the Assembly; it is the people's government,' Majhi emphasised.

However, Congress leaders were not immediately available to comment on Maihi's gress workers and leaders had staged an agitation near the CM's residence in the City to protest crimes against women in the state.

'Over 1,600 cases of crimes against women, including 54 gang-rapes, were registered in the last eight months. Children are getting pregnant in staterun schools. What is happening in the land of Lord Jagannath?" OPCC president Bhakta Charan Das had told reporters while attacking the BJP.

The Congress, which has already constituted a fact-finding team to investigate the violence against women, said, "Schoolgirls in Malkangiri, Jajpur, and Keonjhar districts have gotten pregnant while staying in state-run hostels. How is this possible?" While Das said Majhi, as

the Home minister, could not escape responsibility, his colleague and senior Congress leader Meenakshi Bahinipati alleged that the victims of crimes against women were primarily tribal.

Bhubaneswar, March 3: A 16-month-old boy from the City became Odisha's youngest organ donor, giving new lease of life to two patients, an AIIMS-Bhubaneswar official said Monday.

Janmesh Lenka was admitted to the paediatric department of AIIMS-Bhubaneswar February

12 after inhaling a foreign object, causing a blockage in his airway and leading to difficulty in breathing. Despite immediate CPR and relentless efforts of the intensive care team, he was declared 'brain dead' March 1, hospital sources said.

AIIMS-Bhubaneswar authorities counselled the grieving parents about organ donation to which they consented.

Thereafter, multidisciplinary team of surgeons and transplant coordinators facilitated the retrieval and transplantation pro-

retrieved and transplanted en bloc into a single adolescent patient at AIIMS-Bhubaneswar. According to AIIMS-Bhubaneswar, it is a medical milestone as Janmesh became the youngest organ donor in Odisha. "Additionally, this is the second instance of en bloc kidney transplantation in Odisha,' they said.





JAGATSINGHPUR HERITAGE WALKS

Heritage enthusiasts explore state's architectural marvels

Bhubaneswar/Jagatsinghpur, March 3: As part of the second Jagatsinghpur Heritage Walks (JHW), a group of 30 heritage enthusiasts Sunday visited the Trilochaneswar Temple in Kundeswar and the Ajaikapada Bhairava Temple in Sathalapura, exploring architectural and spiritual heritage.

The Trilochaneswar Temple, believed to predate the iconic Lingaraj Temple, stands as a testament to Odisha's rich architectural legacy. This ancient settlement, once comprising 12 villages, formed Kundinagar (Kundinagra), with Lord Trilochaneswar Deva as its presiding deity and Maa Harachandi as its protector goddess

Dating back to the eighth century, the temple was constructed by Keshari dynasty King Biswanbara in the Rekha Deula architectural style. The Jagamohana (assembly hall) was later added between the 10th and 11th centuries in the Pidha Deula style of Kalingan architecture. The complex features three smaller shrines, a Rosaghara (temple kitchen), and a small museum housing 8th-century idols. Despite its historical significance, visitors were dismayed by the lack of proper signboards or markers at the site. even after the Archaeological Survey of India (ASI) under-

took renovations in 1972. Guided by chief priest Subash Padhi, the group explored

the temple premises and proceeded to Maa Harachandi Temple, where they were welcomed by priests and villagers who offered water and Prasad.

Their next stop was Rukuna Ghat on the banks of the Alaka River, a tributary of the Mahanadi, known for its connections to Puranic legends of Lord Krishna and Devi Rukmini. However, visitors were concerned about the deteriorating state of this once-sacred water body.

The group then visited Siddheswar Temple, where they were welcomed by priests and introduced to the temple's history. A highlight of their visit was learning about ancient cooling techniques used to preserve the mahadeep (sacred oil lamp). At the nearby Saptamatruka Temple, they were informed about the 2019 theft of two precious idols during Mahasangam celebrations near Rukmini Ghat, with no progress made in their recovery.

The final stop was the Ajaikapada Bhairava Temple in Sathalapura, dedicated to Ekapada Bhairava. Archaeological evi dence suggests the temple was originally built in the early 10th century by the Somavamsi Keshari Kings. Over centuries the structure suffered damage from floods and invasions by non-Hindu rulers. The current Pidha Deula structure was re constructed in the 20th century preserving the original sanc tum sanctorum, which houses a Bhairava idol and a Shivalinga

Situated six kilometres from Alanahat in Sathalapa da, Jagatsinghpur, the temple is one of only two Ekapada Bhairava temples in Odisha, the other being in Jajpur district. It is officially listed as a monument by the ASI, reinforcing its historical and cultural significance.

Woman murders hubby, surrenders before police

Jajpur, March 3: The police Monday arrested a 30-year-old woman for allegedly killing her husband and burying his body in the backyard of their house in Jajpur district, an officer said.

The accused, identified as Dumari Munda of Dubikhal village surrendered at the Sukinda police station, confessing that she had hit him with a wooden plank leading to his death, February 27 night,

Police exhumed the body from the back of their house and sent it for post-mortem examination Monday

"We have arrested the accused and are investigating the case to get more details about the circumstances leading to the incident," said Sukinda police station IIC Bilwamanagal Sethy.

"The accused has confessed that she killed her husband alone. She claimed that she was fed up with her husband's drinking habit. He would come home drunk and beat her up frequently," he said. A court remanded Dumari to judicial custody for 14 days.

With the latest arrests, around 330 such fishermen have been apprehended and 30 sea-worthy vessels seized since November 1 last year, the Forest officials said.

2 labourers crushed to death as slab caves in

Aska, March 3: Two casual labourers were crushed to death after a newly constructed chajja slab of an under-construction house caved in on them at Karpura Nuagaon village under Aska police limits in Ganjam district, Monday.

The deceased were identified as Niranjan Mohanty (38) of Bhetanai village under Kotinada police limits near Aska and Khadala Sethy (62) of Gothanda village near Kulada in Bhanjanagar. The mishap occurred when the two labourers were removing the centring of the newly built chajja. They were crushed under rubble after the newly built chajja along with the centring caved in on them.

They were rescued in critical condition and rushed to the sub-divisional hospital at Aska where doctors pronounced them "brought dead", said SD-PO Santosh Kumar Jena.

Police have sent the bodies for post-mortem and started an inquiry into the incident, after a case was registered, the officer added. The two were engaged as labourers under a contractor, who has been detained.

NHRC seeks ATR on plight of Juang tribal community

Keonihar, March 3: The National Human Rights Commission (NHRC) has taken cognizance of a complaint and sought an Action Taken Report (ATR) from the District Magistrate-cum-Collector of Keonihar. regarding alleged human rights violations affecting the Juang Particularly Vulnerable Tribal Group (PVTG). The commission has directed officials to submit the report within four weeks.

The NHRC issued the order Friday after reviewing a petition filed by human rights activist and lawyer Radhakanta Tripathy. The petition alleges that negligence and apathy on part of state's ST & SC Develop ment, Minorities & Backward Classes Welfare department and the Keonjhar district administration have resulted in severe hardships for the Juang PVTG community, including lack of all-weather roads, healthcare, and education.

Tripathy further alleged that many villages lack basic infra-



structure, forcing residents to transport patients on makeshift cots. Despite Keonjhar district having one of the highest allocations from the District Mineral Foundation (DMF) funds, authorities have failed to address these pressing needs, he claimed. The petition highlighted the

plight of Juang tribesmen living in 114 villages without basic amenities. The Juangs are one of the 13 PVTGs among the 62 tribal communities found in Odisha, who primarily reside in and around the Gonasika Hill area of Banspal block in Keonjhar district. Citing a specific case, Trip-

athy reported that due to inadequate healthcare facilities, 35-year-old Sunia Juanga, his wife Rashmi, 30, and their 6-month-old daughter, Nani, three surviving children are now orphaned. The petition alleged that health services are virtually nonexistent, with the nearest primary health centre located 15 km away and the block headquarters at about 40 km distance. A few Juang fam ilies benefit from the state-spon sored Biju Swasthya Kalyan Yojana (BSKY) or the National Health Card, the complaint

Additionally, the petition contended that there is no official database tracking minor orphans or child marriages within the Juang community It accused state authorities of negligence and inaction, raising serious human rights

The petition further alleged that due to administrative failure. Juang orphans are left without access to even basic necessities. It cited govern ment inaction, corruption, and systemic neglect as contributing to the deprivation and suffering of the PVTG Juang community

Tusker dies after fight with another

Dhenkanal, March 3: A 30-year-old wild tusker was found dead in Kamakhyanagar forest area of Dhenkanal district Monday morning, Forest department officials reported. The carcass of the elephant, which had migrated from Joranda about five days ago, was discovered near Jamuihara village in the western part of Dhenkanal forest division.

The cause of death is believed to be injuries sustained in a violent confrontation with another tusker Sunday night. Ac-



cording to a forest official, the clash, which occurred near a pond in Jamujhara village,

rendered the tusker severely injured. The fight was so fierce that it caused panic among lo-

cals, with the thunderous trumpet of the elephants echoing throughout the area. Villagers immediately alerted the Forest department, but officials were unable to intervene in time.

Forest officials conducted a post-mortem on the carcass, and samples were sent to the Odisha University of Agriculture and Technology (OUAT) in Bhubaneswar for further analysis.

Local villagers and officials expressed frustration with the Forest department's lackadaisical attitude and delayed response.

Hamas Fooled Israel

he just published report of the top-level investigation by Israel Defence Forces (IDF) into the Israeli military's failure to gauge the impending lethal attack by Hamas on 7 October, 2023 reveals the military intelligence was so complacent about its false assessment of Hamas that it did not act even when unusual movements had been seen in Gaza the night before catastrophe struck Israel. Some 5,000 Hamas-led terrorists from the Gaza Strip burst into southern Israel carrying out a murderous rampage of unprecedented intensity and scale. The IDF probes have come out with evidence that the force struggled to mount a response with bases closest to the border overun and the chain of command broken amid the chaos. The attack claimed the lives of some 1,200 people in Israel, with another 251 people kidnapped and much of the area devastated. Most victims were civilians.

The material released by the IDF shows Hamas' invasion was possible because of the colossal failure for years of the Israeli forces to properly keep track of Hamas' preparations and analyse whatever credible information its intelligence wing collected. The Israeli military establishment deluded itself into the belief that Hamas did not have the nerve nor the intent to launch a ground offensive against Israel. At the most it could fire rockets which Israel's sophisticated system of interception could easily neutralize. This was the assessment of the IDF that was far removed from reality.

What is even worse and scandalous for Israel is that the Israeli army was "defeated" for several hours at the hands of Hamas during the invasion. The chaos and confusion catastrophically slowed the fightback on the day.

The probes at the General Staff level are focused on four main topics. The IDF believed, prior to the 7 October onslaught, that the Hamas in Gaza did not pose a significant threat to Israel, it was uninterested in a large-scale war and any cross-border threat would be thwarted by Israel's high-tech border fence. The investigation highlighted a widening gap between the IDF's perceptions of Hamas and what the terror group was doing in reality. As part of its investigation, the IDF has now determined that Hamas had decided in April 2022 to launch such an attack. By September 2022, the terror group was at 85 per cent readiness and it decided in May 2023 to launch the assault on 7 October. This investigation also found that the IDF's conduct, decision-making, and intelligence assessments on the night between 6 and 7 October were based on the result of years of false assessments about Hamas. As a result, intelligence officials at all levels failed to provide a warning for what would come.

Interestingly, even though the IDF probe has provided stark details of the holes in the famed intelligence service of Israel, there is not a word on the political establishment, especially Prime Minister Benjamin Netanyahu and his Far-Right allies. While the latter were busy with their political goal of virtual ethnic cleansing to displace millions of Palestinians from their homes in Gaza and destroy their houses and infrastructure, they failed to oversee the work of their defence forces and intelligence apparatus. According to one school of opinion, Netanyahu was opposed to any cease-fire because he feared this would give an opportunity to his adversaries to raise the issue of his government's intelligence failure and demand his resignation. It was to save his chair and his political future that he wanted the war with Hamas to drag on.

This raises the question why the probe report is made public now. The answer is the ruling establishment of Israel now feels safe as global and regional attention has shifted from the Hamas attack to US President Donald Trump's plan to rebuild Gaza forcing the Palestinians to leave their homes effectively, never to return. This seems to be the most opportune time to disclose the failure of the Israeli military and the government to anticipate Hamas' invasion without attracting much public criticism.

Israel's deadly intelligence and system's failure should be a dire warning for India. Encircled by enemies on all sides since the failure of relations in the neighbourhood has collapsed, India is constantly prone to any kind of attack. Dependence on imported hardware for intelligence gathering and warfare added with a lethargic and unwilling manpower, India has many hurdles to overcome that it has consistently been neglecting for decades. This should be a wake up call for the Indian political leadership.

Trump has a way with words. America's federal income tax department is called Internal Revenue Service. Trump says he will build an External Revenue Service. It is an appealing concept. Instead of burdening US taxpayers he proposes to tax outsiders. He says America is one of the most open consumer markets in the world, with access given to all exporting countries. But those exporting countries often have high tariff walls protecting their domestic markets. He says that is unfair to America's exporters. Hence, he has proposed to raise import tariffs to match the exporting country's tariffs. It's a tit for tat strategy, which he claims will raise much revenue for America, and punish those who keep their domestic markets protected. Never mind that the WTO rules do not allow America to selectively differentiate import tariffs for the same product from different origins. This is called the MFN rule. Never mind that raising import tariffs will hurt the American consumer, since it will raise prices and hence inflation. Trump counters that by saying he will cut income tax, which is not feasible given the

Never mind that the reason developing countries like India were allowed to have higher import tariffs than countries like the US was to compensate their domestic industries for domestic handicaps like high cost of power, infrastructure, credit and lower labour productivity. This was all a part of the grand design of the WTO to get all on board. India and many other developing countries have enjoyed a special and differential treatment for good reason, in the WTO. And yet Trump's threat of reciprocal punitive tariffs has an appeal to the American voter and consumer. It is also true that a country like India, boasting of

huge size of the fiscal deficit.

being the fifth largest economy in the world, cannot hide behind high protective tariff walls. High import tariffs do no good to foster competition, nor to Indian consumers who are denied free imports nor to inefficient industries who thrive in a protective environment.

The Trump tariff proposal gives India an opportunity to overhaul and reduce its import tariffs, at least on those items which are of interest to the USA. Such a mutual agreement on tariffs will surely fall afoul of WTO's MFN rule. But under Trump's presidency WTO is getting a short shrift anyway, and India must calibrate how much it wants to stick to strengthening the multilateral WTO. As such India's pursuit of several Free Trade Agreements (FTAs) anyway reveals a declining confidence in the WTO.

The Trump negotiation is a great opportunity to push tariff reform since it will be net beneficial to our export prospects and competitiveness. As such general tariff levels have gone up since 2015 and have drifted up 4 or 5% and are for non-agricultural goods, on average around 15%. Further, the proportion of those tariff lines which have MFN rates above 15% has risen to one fourth of all lines. This upward drift was justified for Make in India and later as sectoral support for the Production Linked Incentive scheme. But the time has come to slash these rates back to what they were before 2015 and progressively move toward a level on par with our peers in ASEAN countries. The Trump threat gives India an alibit to do this much needed reform. Just as 1991 reforms were pushed through as part of conditionalities of a loan from IMF, this tariff reform too could use an "external" justification.

The US is India's largest trading partner, and this fiscal the exports to America between April and December have grown at 5.6% to reach a level of \$60 billion. A substantial contribution is the export of smartphones which will clock \$30 billion, including exports to other countries. India has roughly a \$45-billion trade surplus with the US which includes software services export as well. The simple average tariff that India charges on imports, as per WTO data is 17%, whereas the US is at 3.3%. But on a bilateral basis these numbers are likely to be different. Not simple average, but a weighted average tariff difference between the two countries is likely to be about 7 or 8% excluding agricultural products. A hike in import tariff on India's exports will hurt steel, aluminium, pharmaceuticals and electronics. But in pharma, as also smartphones, polished diamonds and petro products, the import component is large. So

er. India has agreed to increase crude oil purchase from the US which will be factored into the negotiations. By giving duty free or moderate duty access to Harley Davidson motorcycles or Bourbon whiskey, the loss to India's economy is negligible. But jeopardising India's access to the software services export market of the US is a big risk. Even in this context, the big services exporters out of India to the US are American companies like EY, Accenture, IBM, Google, Microsoft and Genpact. The proliferation of Global Capability Centres run by major American corporations in India is a tribute to the confidence in Indian talent. That trend needs to be nurtured and enhanced, and if that requires a concession by reducing import tariffs, so be it.

India could also tap into the huge untapped potential of export of agriculture products including agro-processing. At \$50 billion, India's exports are barely 1.5% of global exports in agricultural and related products. India is the world's largest producer of milk, has the highest population of cattle, is among the top two or three producers of fruits and vegetables, and has one of the longest coastlines. How well does that translate into export of milk products, cheese, confectionary, meat, poultry, fisheries, fruit juices, nutraceuticals, organic foods? There is no use in hiding behind the excuse of "protecting the small farmer" for putting large export and import barriers in agricultural trade. The US can be a big exporting opportunity for this

Why nature needs its own ID

uring my 35-year career in environmental conservation. I have come to realize that today's planetary crisis is driven not just by destruction and neglect but also by something more profound: our economic systems' blindness to nature's value. As governments chase GDP growth and companies seek to maximize profits. they fail to account for the vast ecosystems that sustain our economies, societies, and personal well-being. We manage what we measure, and because ecosystem services don't appear on balance sheets, they are effectively invisible, even as the implications - exploitation of natural resources, habitat destruction, and pollution of our air, land, water, and ocean - stare us in the face.

ocean – stare us in the face.

The consequences of remaining on our current path are well-documented. The World Bank warns that the collapse of just a few critical ecosystem services, such as wild pollination and marine fisheries, could shrink global GDP by \$2.7 trillion annually by 2030. How can we make nature more visible and integral to our decision-making? The Taskforce on Nature-related Financial Disclo-

sures represents an important first step. By providing financial institutions and corporations with the tools to assess their dependence and impact on natural ecosystems, the initiative encourages and enables them to shift financial flows toward nature-positive investments.

nature-positive investments.
Quantifying these relationships is no easy feat. But digital nature IDs offer a promising solution. Much like personal IDs enable citizens to exercise their rights, receive government benefits, access banking services, and take legal action, a digital nature ID could help establish essential environmental metrics to account for the ecosystems supporting human development.

A person without an ID risks invisibility in modern society. The same is true for nature. Assigning secure IDs to natural ecosystems could shield them from unchecked exploitation. For example, a forested watershed could have an ID storing information about its geographical characteristics, biodiversity, and ecosystem services, along with the measurable benefits it provides to local communities and even distant populations downstream. By

quantifying these benefits, we could make it harder for businesses or individuals to disregard or harm nature. No longer invisible, nature's value would be profiled, legally recognized, and far more difficult to exploit.

With the rapid development of mobile technologies, a digital nature ID can integrate digital tagging, remote sensing, and sensor data for real-time monitoring of natural ecosystems. AI could further enhance these systems, making environmental data more accessible and actionable. Imagine a geo-tagged data parcel, overlaid with key ecological features and environmental health indicators, offering a holistic, living snapshot of a specific ecosystem.

By integrating administrative, environmental, and geographic data, digital nature IDs could pave the way for scaling results-based payment schemes, providing fair compensation to those who protect carbon-absorbing rainforests, mangroves, and other vital ecosystems. They could also enhance the traceability of raw materials in agricultural supply chains and empower land-rights holders by improving access to biodi-

versity credits, green bonds, and loans tied to sustainable stewardship. Moreover, such a system could bolster legal protections for indigenous and local communities by incorporating clear, location-specific records.

But development of a digital nature ID must be a whole-of-society effort, underpinned by the principles of inclusion and collaboration. Its design should reflect the concerns of all stakeholders, so that it serves as a public good that drives nature-positive action at scale. Above all, it must uphold the rights, welfare, and value systems of indigenous peoples and local communities, ensuring that they retain control over data related to their lands,

resources, and way of life.
At scale, a digital nature ID could become a transformative tool for accounting for the value of our planet's natural resources and contributions to humanity. By recognizing and quantifying the ways nature enables our societies and economies to survive and thrive, we can usher in a new era of accountability.

Sasan (Gujarat), March 3: Prime Minister Narendra Modi Monday announced the Asiatic lion population estimation exercise in May and unveiled conservation plans for tigers, gharials and a critically endangered bird, while pushing for using AI to combat forest fires and human-animal

He made a slew of announcements while chairing the seventh meeting of the National Board for Wildlife (NBWL), in his capacity as ex-officio chairperson, at Sasan in Gujarat's Junagadh district.

At the meeting, which coincided with World Wildlife Day, the PM virtually laid the foundation stone of a National Referral Centre for Wildlife at Junagadh. Modi announced a scheme focused on the conservation of tigers, and a centre of excellence for the effective management of human-wild-

The PM released the first-ever riverine dolphin estimation report in the country, which pegged the number of the aquatic mammals at 6,327.

Soon after completing his lion safari at the Gir National Park, Modi headed for the NBWL meeting, which ended by Union Minister of Environment, Forest and Climate Change Bhupender Yadav and other members of the board.

At the meet, the PM announced the initiation of a new conservation project on gharials, and a National Great **Indian Bustard Conservation** (CMS), said the release.

proposed National Referral Centre for Wildlife will function as a hub for coordination and governance of various aspects related to wildlife health and disease management, it said.

Population estimation of Asiatic Lions is carried out once every five years and the last such exercise was conducted in 2020. At the meeting, Modi announced the initiation of the 16th cycle of lion estimation exercise in May this year, it said.

The PM also announced that a Centre of Excellence will **PM released** be set up at the first-ever the Wildlife riverine dolphin Institute of India (WII) estimation report in the

campus in country, which pegged SACON (Salim Ali Centre for Ornithology and Natural History) at Coimbatore in Tam-

> il Nadu for effective management of human-wildlife conflicts.

The centre will support states and Union Territories in equipping rapid response teams with advanced technology, gadgets for tracking and forewarning, prescribe surveillance and intrusion detection systems in human-wildlife conflict hotspots, and build capacity of field practitioners and community to execute conflict mitigation measures, said the release.

Modi stressed on the usage

of remote sensing and geospatial mapping and Artificial Intelligence (AI) and Machine Learning (ML) to combat issues like forest fires and human-animal conflicts, it said.

He suggested engagement of the WII with the Bhaskaracharya National Institute for Space Applications and Geo-informatics (BISAG-N) to address the challenge of human-wildlife conflict, the release said.

With the Asiatic lions having now made the Barda wildlife sanctuary in Gujarat their home through natural dispersal, the PM announced that their conservation will be supported through prey augmentation and other habitat improvement efforts.

Underscoring the importance of eco-tourism as a means for development and conservation of wildlife habitats, he emphasised that there should be ease of travelling and connectivity for wildlife tourism, said the release.

The NBWL reviewed various initiatives undertaken by the government in wildlife conservation, highlighting achievements in the creation of new protected areas and species-specific flagship programs such as Project Tiger, Project Elephant, Project Snow Leopard, among others.

The PM asked the board and Environment Ministry to gather traditional knowledge and manuscripts of various regions of India with respect to conservation and management of forests and wildlife for research and development, stated the release.

Kolkata, March 3: A Bangladeshi delegation of the Joint River Commission (JRC) arrived in West Bengal Monday and visited the Ganges at Farakka regarding the Ganga Water Treaty, which is due for renewal in 2026, an official said.

One of the functions of the Farakka Barrage in West Bengal's Murshidabad district is regulation of water to Bangla desh as per the Indo-Bangladesh Treaty, 1996, on sharing of the Ganga Water.

The 86th meeting of the joint committee, as per the provisions of the Treaty, and the technical meeting under the India-Bangladesh Joint Rivers Commission Framework are scheduled to be held in Kolkata March 6 and 7.

"The Bangladeshi delegation of the Joint River Commission (JRC) reached Kolkata this morning and immediately left for the joint observation site on the Ganges at Farakka. The Commission will be in Farakka until March 5," an official of the West Bengal Irrigation & Waterways Department told PTI.

The delegation will then re-

turn to Kolkata for the two-day meeting, the official said.

According to state government officials, the Joint River Commission which includes members from the governments of India, Bangladesh and West Bengal, meets once a year to discuss issues regarding the cross-boundary river.

According to the Ministry of Jal Shakti, India and Bangladesh share 54 rivers.

The Joint Rivers Commission of India and Bangladesh was constituted in 1972 as a bilateral mechanism to address issues of mutual interest on common, border, and transboundary rivers.

The Ganga Water Treaty was signed December 12, 1996, by the then Indian Prime Minister HD Deve Gowda and his Bangladeshi counterpart Sheikh Hasina. During Sheikh Hasina's last visit to India in June – weeks before her regime was toppled in August 2024 the two sides announced that technical teams would meet for

West Bengal Chief Minister

Mamata Banerjee is expected to play an important role in the efforts to renew the Ganges water-sharing treaty. This comes even as she continues to oppose the Teesta River water-sharing agreement, despite both India and Bangladesh agreeing on its draft in 2011.

Last year, Banerjee wrote a letter to Prime Minister Narendra Modi, claiming that the push to renew the Ganga Waters Treaty was "unilater al" and that the West Bengal government had not been consulted.

However, officials from the Union government had clar ified that an internal committee formed by the Ministry of Jal Shakti in July 2023 had included representatives from both the Bihar and West Bengal governments — the two states through which the Ganges flows before reaching Bangladesh.

West Bengal nominated its representative to this internal committee in August 2023 and participated in three of the committee's four meetings.



Additional Sessions Judge Pankaj Arora was hearing a case against five men against whom the Sonia Vihar police station had registered a case under the penal provisions of murder, kidnapping and destruction of evidence. The prosecution alleged that the accused persons abducted and killed the victim, Kamal Singh, by inflicting iron rod blows and fist blows on him

UP woman on death row in UAE executed

New Delhi, March 3: Uttar Pradesh resident Shahzadi Khan, 33, who was on death row in Abu Dhabi for allegedly murdering the four-month-old son of her employer, had already been executed, the Ministry of External Affairs told the Delhi High Court Monday.

Shahzadi Khan was handed over to the Abu Dhabi police February 10, 2023, and she was sentenced to death July 31, 2023. She was lodged in the Al Wathba jail. On being informed about the development, Justice Sachin Datta termed it "very unfortunate"

"It is over. She was executed February 15. Her last rites will be held March 5," Additional Solicitor General Chetan Sharma told the court and stressed that the government had tried its best to assist her. The submission was made during the hearing of the petition filed by the 33-year-old woman's father seeking to know her well-being.

The Ministry of External Affairs, meanwhile, said Monday that the Indian Embassy provided all possible legal assistance to Shahzadi, including sending mercy petitions and pardon requests to the Government of the UAE.

Shahzadi was convicted on charges of murder of an infant and sentenced to death in the UAE. The highest court of the UAE, the Court of Cassation, upheld the sentence, it said The UAE authorities intimated to the Embassy February 28, 2025, that the sentence of Shahzadi has been carried out in accordance with local laws. The family of Shahzadi has been informed of the matter, the MEA said. Her father Shabbir Khan, a resident of Uttar Pradesh's Banda, had said there was "profound uncertainty" regarding his daughter's situation and his repeated applications to



the Ministry of External Affairs for clarification were fruitless.

The plea further alleged that Shahzadi was inadequately represented before the local courts in the case over the alleged murder of her employer's four-month-old child and she was pressured into confessing, leading to the imposition of the death penalty on her. During the hearing, the petitioner's counsel said his limited prayer was to know whether his daughter was alive or she had been hanged.

He said February 14, Shahzadi had called the family from the prison saying that she would be executed in a day or two and this would be her last call. Since then, they were unaware of her well-being, he said. The Centre's counsel told the court that the Embassy officials and the petitioner were in touch and arrangements were being made so that the family could attend their daughter's last rites in Abu Dhabi.

"We did our best. We hired a law firm there to represent her in court. But the laws there deal with the murder of an infant very severely," he submitted. The petition said, "On February 14, 2025, the petitioner's daughter telephoned him from detention, informing him that she had been relocated within the facility and that, prior to her potential execution, her final wish was to speak with her

Shabbir Khan said the last time he spoke to his daughter was February . 14, just a day before she was hanged. Asked whether the government had assured any support, he said, "No, we received no help whatsoever," adding that the family had reached out to politicians and even film personalities . but to no avail

"The petitioner, with considerable effort, submitted an application dated February 21. 2025 to the Ministry of External Affairs, seeking to ascertain the current legal status of his daughter and confirm whether she remains alive or has been executed," it added.

The plea said the woman travelled to Abu Dhabi in December 2021 after obtaining a legal visa. In August 2022, her employer gave birth to a son for whom Shahzadi was employed as a caregiver. On December 7, 2022, the infant received routine vaccinations and tragically passed away that evening, it said. It claimed that the infant's parents refused consent for a post-mortem and also signed an agreement to waive further investigation into the death.

'Friend' strangled Cong worker with charger

Chandigarh, March 3: Haryana Police Monday arrested a 'friend" of Congress worker Himani Narwal for allegedly strangling her with a wired mobile charger after a fight at her home in Rohtak and later dumping her body in a suitcase.

Himani's body was found stuffed in a suitcase in Rohtak Saturday, leading to the formation of a special investigation team (SIT) to probe the murder. Speaking to reporters in Rohtak, Additional DGP K K Rao said the accused. Sachin, hails from Jhajjar district, where he runs a mobile phone shop, and was arrested in Delhi.

Rao said it was a murder with few clues. "When the body was found, we set up eight teams, including an SIT. Our priority was to identify the victim when her body was found. When the family identified her, the police conducted swift investigations to trace out the accused.

"For the past one-and-half vears, the accused was in contact with the woman through social media and also used to visit her home. "The woman used to live alone in Vijay Nagar. On February 27, the accused visited her home, and they had a heated argument. Rao said. The officer said the fight between the two broke out over money. According to police, Sachin, a married man with no political connections. strangled Himani with a wired mobile phone charger, killing her on the spot. Sachin was produced before a court in Rohtak on Monday and was sent to a three-day police remand.

"There was a monetary is sue between the two, but what it was, all this has to be verified first. We cannot say this was the reason (for the murder). "The accused has said there was a fight between the two, and during an exchange of words, he strangled her,"

He got down near Sampla bus stand to waylay the investigation, Rao said. Once the auto-rickshaw left, he dumped the suitcase and left. The officer said the auto-rickshaw driver had no inkling that the passenger was carrying a body in the suitcase. Some Congress members said Himani was a dedicated party worker and also took part in the Rahul Gandhi-led Bharat Jodo Yatra.

Jharkhand tables ₹1.45L-cr Budget

Ranchi, March 3: The Jharkhand government Monday presented a ₹1.45 lakh-crore Budget for 2025-26, allocating a whopping ₹62,844 crore for social welfare programmes aimed at helping the poor, women and other vulnerable groups. For its popular Jharkhand

Mukhyamantri Maiya Samman Yojana that aims to enhance financial security and well-being of women in the age bracket of 18-50 years, it allocat ed ₹13,363 crore. Additionally ₹5,000 crore has been made towards providing free electricity. Presenting the maiden budget of the Hemant Soren-led government after it retained power following a resounding victory in Assembly elections last year, Finance Minister Radhakrishna Kishore said the state's economy is expected to grow at a rate of 7.5 per cent in 2025-26 fiscal.

"I lay on the table of the House a budget of ₹1.45 lakhcrore for the 2025-26 financial year March 3 that coincides with the birth anniversary of great industrialist Jamsetji Nusserwanji Tata, who believed that economic indepen dence is the base of political independence...This budget will pave way for overall development of the state," the finance minister said in the Assembly.

Amid reports flagging issuance of identical voter card numbers to electors in two different states, the EC Sunday said it would rectify the issue and also update its technology-driven platform. The poll authority asserted that while the elector photo identity card (EP IC) numbers of some of the voters "may be identical", the other details, including demographic details, Assembly constituency and polling booth, are different.

First-ever survey finds over 6,300 river dolphins in India

New Delhi, March 3: The first population estimation of riverine dolphins in India has revealed the presence of 6,327 dolphins in the Ganga, Brahmaputra and Indus River systems, according to a government report published Monday.

The Ganges River dolphin, known for its unique features, is found in the Ganga-Brahmaputra-Meghna river system and its tributaries across India, Bangladesh, Nepal, and Bhutan. A small population of

the Indus river dolphin, a close

relative of the Ganges river

dolphin, is found in the Indus River system in India.

As part of "Project Dolphin", a comprehensive survey was conducted for the first time to estimate the population of river dolphins across eight states -- Uttar Pradesh, Bihar, Jharkhand, Rajasthan, Madhya Pradesh, West Bengal, Assam and Puniab.

It is one of the world's largest freshwater surveys, covering the entire range of the Ganges river dolphin in the Ganga and Brahmaputra, as well as the Indus river dolphin in the Beas river, according to the report "Population Status of River

Dolphin in India"

The survey estimated 6,327 Ganges river dolphins (range: 5,977-6,688) and three Indus river dolphins. The findings sug-

The notice has been issued by a special director of the federal agency after the completion of an investigation and before the initiation of adjudication proceedings under the said law. A Paytm spokesperson said the company was working to resolve the matter in accordance with applicable laws and regulatory processes.

The show cause notice has been issued to Paytm's flagship company One 97 Communication limited (OCL), its managing director and other Paytm subsidiaries such as Little Internet Pvt Ltd and Nearbuy India Pvt Ltd for "contraventions" of the provisions of the FEMA to the tune of around ₹611 crore, the ED



said in a statement.

Investigations found that OCL made foreign investments in Singapore and "did not" file necessary reporting to the Reserve Bank of India (RBI) for the creation of an overseas stepdown subsidiary, it said. The company had "also received foreign direct investment (FDI) from overseas investors without following proper pricing guidelines stipulated by the

RBI", it alleged. The ED said OCL's subsidiary company in India -- Little Internet Pvt Ltd-- received FDI from overseas investors "without following" the pricing guidelines stipulated by the RBI. The other subsidiary -- Nearbuy India Pvt Ltd -- "did not" report the FDI received by the company within the time frame prescribed by the RBI, it said.

In a regulatory filing made on Saturday (March 1), Paytm said it received a notice from the ED for alleged violation of certain FEMA rules by the company and its two subsidiaries-- Little Internet and Nearbuy -- with respect to certain investment transactions.

Later, Paytm clarified that the alleged breach pertains to the period when the two companies were not its subsidiaries. It acquired the two companies in 2017.

According to the breakup shared by the company, OCL transactions amounting to over ₹245 crore, LIPL's about ₹345 crore, and NIPL's about ₹21 crore have been listed in the alleged breach. "The alleged contraventions relate to certain investment transactions relating to OCL, LIPL and NIPL", it stated.

In a statement, a Paytm spokesperson said, "We are working towards resolving the matter in accordance with applicable laws and regulatory processes. We remain committed to strengthening processes in adherence and upholding the highest standards of compliance and governance". The company's shares plunged more than 4 per cent following the reports of the ED notice.

With the arch-lamps having been momentarily switched off and the booming 21- gun salute of the 'media' artillery subsiding, there are many mundane tasks crying for attention. The state of school education is one of them.

According to the data released by the Ministry of Education, the enrolment of students has dropped by over a crore in 2023-24. In 2018-19 the total enrolment of students in school was 26.02 crore which increased in 2019-20 by 1.6 per cent and crossed 26.45 crore. A total of 24.8 crore students enrolled in the academic year 2023-24, the Unified District Information System for Education Plus (UDISE) report of the ministry stated.

The states which saw the highest drop in enrolments were Bihar, Uttar Pradesh and Maharashtra, In 2018-19 Bihar had an enrolment of over 2.49

crore students which dropped to over 2.13 crore (a fall of 35.65 lakh students). Uttar Pradesh had an enrolment of 4.44 crore students in 2018-19 which fell to 4.16 crore(a fall of 28.26 lakh students). In the case of Maharashtra which had 2.13 crore students the fall over the same period was to 2.13 crore-less by 18.55 lakh students.

A day before the budget 2025-26 February 2,2025, the union finance minister Nirmala Sitharaman tabled the Economic Survey 2024-25 in Parliament, which stated that India's school education

system serves 24.8 crore students across 14.72 lakh schools with 98 lakh teachers (UDISE+ 2023-24). Government schools make up 69 per cent of the total, enrolling 50 per cent of students and employing 51 per cent of teachers, while private schools account for 22.5 per cent enrolling 32.6 per cent of students and employing 38 per cent of teachers.

This year's education sector allocation has been pitched for a 6 per cent of Gross Domestic Product (GDP) allocation of ₹1,28,650 .05 crore marking a 6.65 per cent increase over the previous year. "The allocation for school education is ₹ 78,572 crore which is the highest ever for the department." "There has been an

overall increase of ₹5,074 crores (7 per cent) in the budget allocation for the department of School Education and Literacy in 2025-26 as compared to the previous year", union education minister Dharmendra Pradhan has stated for the record

"Window dressing is all fine, but the situation on the ground mirrors an altogether different story", says Dr Manish Doshi of the Congress. The ministry of education which released reports of school education in 2022-23 and 2023-24 together December 30, 2024, well behind schedule, paints a grim picture. The report attributes no reason for the fall but the inference is that the weeding of bogus students and the correction of outdated records, thanks to the installation of a new digital database system has led to it. Sources in the know aver that the fall has been over two consecutive academic years while the

so-called correction of records have been going on for long. The Prime Minister's own home state of Gujarat mirrors the decline avidly.

According to the recently released Social Economic Review of Gujarat 2024-25 the total number of primary schools have declined by 1000 in the last five years, the highest decline being recorded in those run by local bodies-from 31,337 in 2019-20 to 30,626 in 2023-24. Similarly in the case of primary schools, their numbers in the state have fallen from 45,315 in 2019-20 to 44,288 in 2023-24. So has the enrollment from 86.14 lakh to 78.47 lakh. There is a noticeable decline in the number of sanctioned seats from 1.85 lakh in 2020-21 to 1.22 lakh in 202-25. Similarly in diploma courses the number of students have declined from 1.87 lakh in 2020-21 to 1.17 lakh in 2024-25.

There is more troubling news for Gujarat. Prime Minister Narendra Modi's model state trails the likes of Manipur, Himachal Pradesh and Haryana, by a mile in education. This fact is revealed by the sustainable development report-2024 of the Niti Aayog. Kerala tops with 82, followed by Haryana and Himachal Pradesh 77 each with Gujarat getting just 58 which is less than West Bengal.

Jharkhand and Rajasthan. All this despite the fact that from the time when Modi helmed the state, Guiarat had been running a programme called "Shaala Prayeshotsay" wherein the might of the bureaucracy and the elected wing of the government fan out all over the state to enroll

students in school. Gujarat stands at 17.9 per cent as compared to Kerala with a mere 5.5 per cent, and Haryana at 5.9 per cent. As of December 2023, a total of 1606 government-run primary schools in the state had only one teacher. In 2019, 36 per cent of the 7.29 lakh students who appeared in the Class X board examinations failed in their mother tongue Gujarati in Gujarat. There has been improvement ever since. Last year the failure rate in Gujarati was only 9 per cent of 5.9 lakh students. Thank God for small mercies!



Top court upholds Khaleda's acquitta

A three-member Appellate Division bench headed by Justice Md Ashfaqul Islam passed the order, dismissing the plea filed by the state and the Anti-Corruption Commission challenging the High Court verdict that acquitted Zia and others, the state-run BSS news agency reported. Zia, 79, was convicted in the Zia Charitable Trust corruption case in 2018 by a Dhaka court. The court sentenced her to seven years imprisonment and fined her Taka 1 million.

France floats one-month truce

London/Paris, March 3: Britain said Monday there were several possible proposals on the table for a possible Ukraine ceasefire, after France floated a proposal for a month-long initial truce that could pave the way for peace talks

"There are clearly a number of options on the table," Prime Minister Keir Starmer's spokesman said. "I'm just not getting into a running commentary on the options.

European countries, led by Britain and France, are looking at options for a peace proposal including Ukraine after last week's Oval Office rupture between US President Donald Trump and Ukrainian President Volodymyr Zelenskiy.

Starmer hosted a summit of European leaders in London Sunday and said European leaders had agreed to draw up a Ukraine peace plan to present to the United States.

In an interview given on his way to the summit, French

President Emmanuel Macron raised the possibility of a onemonth ceasefire, although so far there has been no public

endorsement from other allies.

"Such a truce on air, sea and energy infrastructure would allow us to determine whether Russian President Vladimir Putin is acting in good faith when he commits to a truce," French Foreign Minister Jean-Noel Barrot said Monday of Macron's proposal.

"And that's when real peace negotiations could start."

Zelenskiy, asked if he was aware of the plan for a monthlong truce mentioned by Macron, told reporters in London. "I'm aware of everything."

France, Britain and potentially other European countries have offered to send troops to Ukraine in the event of a ceasefire, but say they would want support in some form from the US, a proposal referred to as a

2 dead after car drives into crowd in German city

Mannheim, Germany, March 3: A car drove into a crowd in the western German city of Mannheim Monday, killing at least two people and seriously injuring several others, local media reported, overshadowing carnival celebrations in the re gion where police had been on alert for attacks.

Police detained the car's driver and later said he had acted alone, with no broader threat seen for the public.

The suspect is a 40-year-old German man from the neigh bouring state of Rhineland-Pa latinate, broadcaster SWR reported, citing the state interior minister of Baden-Wuert-

temberg, Thomas Strobl. The ministry did not immediately reply to an emailed re-

quest for comment. People were seen lying on the ground at the scene and at least two were being resuscitated, a witness told Reuters.

It was unclear whether the driver acted deliberately or if there was any connection to Germany's carnival celebra tions, which culminated on Rose Monday with a number of parades, although not in Mannheim, which held its main event Sunday.

Police declined to comment on the suspect's identity, saying this was a focus of their investi gation. Security has been a key concern in Germany following a string of violent attacks in recent weeks, including deadly car rammings in Magdeburg in December and in Munich last month, as well as a stabbing in Mannheim in May 2024.

The ancient tradition practised by farming communities to usher in spring was eventually incorporated into the Christian calendar. Monday marks the end of carnival and the start of Lent, a period of dietary restrictions and increased religious observance before Easter, which this year falls April 20.

Distomo is known to Greeks as a symbol of wartime hardship. In June 1944, occupying Nazi forces slaughtered 230 civilian villagers, including more than 50 children in reprisals for attacks by resistance fighters.

An austerely-styled World War II mausoleum overlooks

"After the massacre, we managed to keep the tradition alive. It's to awaken the spring." Distomo Mayor Ioannis Stathas said. "This is a tradition that is many centuries old, a pre-Christian tradition, and it has been carried from generation to generation.

This year's Bell People, many of them schoolchildren, held up flares and olive-wood staffs as they entered the village, trailed by giggling children and their parents dressed up as dinosaurs, police officers and other carnival costumes.

Revelers were handed plastic cups filled with wine and portions of bean soup, as children danced to a mix of Greek folk music, Western chart hits and K-pop.

New Delhi, March 3: India's manufacturing sector growth fell to a 14-month low in February amid softer increase in new orders and production, a monthly survey said Monday.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index (PMI) registered 56.3 in February, down from 57.7 in January. but remained firmly within the 'expansionary' territory.

In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction.

"Although output growth slowed to the weakest level since December 2023, overall momentum in India's manufacturing sector remained broadly positive in February," said Pranjul Bhandari, Chief India Economist at HSBC.

Although softer than January's near 14-year high, the pace of expansion was sharp, the survey said, adding that new export orders rose strongly in February, as manufacturers continued to capitalise on robust global demand for their goods, the survey said.

Moreover, favourable domestic and international demand prompted firms to increase

purchasing activity and hire extra workers.

"Business expectations also remained very strong, with nearly one-third of survey participants foreseeing greater output volumes in the year ahead," Bhandari said

On the job front, manufacturers continued to expand their workforce numbers in February. The rate of job creation was the second-best in the series' history, behind only that recorded in January.

"One-in ten firms signalled greater recruitment activity, while 1 per cent of companies shed jobs," the survey said.

According to the survey, February witnessed the slowest rise in cost burdens in a year, but demand buoyancy kept charge inflation at an elevated level.

The HSBC India Manufac-

turing PMI is compiled by S&P Global from responses to questionnaires sent to purchasing managers in a panel of around 400 manufacturers.

On the domestic macroeconomic front, the Indian economy grew by 6.2 per cent in the December quarter, recovering sequentially from seven-quarter lows, but the expansion came in lower than last year.

For the full 2024-25 fiscal (April 2024 to March 2025), the government now pegs GDP growth at 6.5 per cent, marginally higher than its initial estimate of 6.4 per cent but below the revised growth rate of 9.2 per cent for 2023-24.

The growth in the current fiscal and less than 7 per cent expected in the next will keep India as the fastest-expanding major economy.

New Delhi, March 3: Gold prices rose by ₹200 to ₹87,900 per 10 grams in the national capital Monday amid fresh buying by jewellers and retailers and a weak rupee, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity had closed at ₹87,700 per 10 grams Friday.

Gold of 99.5 per cent purity advanced by ₹200 to ₹87,500 per 10 grams. It had settled at ₹87,300 per 10 grams in the previous market close.

Additionally, silver prices also went up by ₹100 to ₹96,500 per kg. In futures trade on the MCX, gold contracts for April delivery jumped ₹698 to ₹84,917 per 10 grams.

"Gold remained positive after last week's 1.60 per cent profit booking. The fresh upside comes as global uncertainty persists, with tensions between US and Ukraine leaders over deal negotiations," Jateen Trivedi, VP Research Analyst -Commodity and Currency, LKP Securities.

Further, Trivedi stated that ongoing tariff concerns and dollar volatility continue to support gold as a safe-haven asset. However, any positive developments in Russia-Ukraine relations or global trade tariffs could pressure prices.

Also, silver futures for May contracts surged by ₹1,193 or 1.26 per cent to ₹95,521 per kg on the Multi Commodity Exchange (MCX).

FDI drops 5.6% to \$10.9bn

New Delhi, March 3: Foreign direct investment in India dipped by 5.6 per cent year-onyear to USD 10.9 billion in October-December quarter of this fiscal due to global economic uncertainties, according to the government data.

FDI inflows during October-December 2023-24 stood at USD 11.55 billion.

According to the Department for Promotion of Industry and Internal Trade (DPIIT) data. in the July-September quarter of the current fiscal, the inflows were up by about 43 per cent year-on-year to USD 13.6 billion and had increased 47.8 per cent annually to USD 16.17 billion in the preceding April-June quarter.

Cumulatively, during the April-December 2024-25, the inflows registered a growth of 27 per cent to USD 40.67 billion as against USD 32 billion in the same period of 2023-24. Total FDI, which includes

equity inflows, reinvested earnings and other capital, grew by 21.3 per cent to USD 62.48 billion during the first nine months of this fiscal from USD 51.5 billion in April-December 2023-24. During the April-December

2024-25, FDI equity inflows rose from major countries, including Singapore (USD 12 billion against USD 7.44 billion), the US (USD 3.73 billion against USD 2.83 billion), the Netherlands (USD 4 billion against USD 2.27 billion), the UAE (USD 4.14 billion against USD



2.43 billion), Cayman Islands (USD 296 million against USD 215 million) and Cyprus (USD 1.18 billion against USD 796 million).

The last time India triumphed against Australia in the knockout stage of an ICC event was way back in 2011 World Cup quarterfinal.

India lost to Australia in the semifinals of the 2015 ODI World Cup and in the title clash of the 2023 ODI World Cup before succumbing to them in the World Test Championship final in 2023. This Indian side will realistically hope to rewrite that largely melancholic script over the last 14 years and the primary reason for that optimism is the presence of some top of the line spinners in their ranks.

Mumbai spinner Shivalkar dies

Mumbai: Legendary Mumbai spinner Padmakar Shivalkar died here Monday due to age-related issues. He was 84. Considered one of the best spinners to have never played for India, Shivalkar featured in a total of 124 First-Class matches and claimed 589 wickets at 19.69 between 1961-62 to 1987-88. The left-arm spinner made his debut at the age of 22 in Ranii Trophy and continued playing until he was 48 and took 361 wickets in India's premier domestic competition including eleven 10-wicket hauls.

FIFA lifts ban on PFF post constitutional changes

Lahore: FIFA, the world governing body of football, has lifted the suspension on the Pakistan Football Federation (PFF) after the necessary constitutional changes were made to ensure smooth governance of the sport in the country. FIFA had imposed the suspension on the PFF February 5 due to the failure of Congress members to amend the constitution as required by the global body.

Blatter arrived at a Swiss court Monday for his fresh trial on fraud, forgery and misappropriation charges, appearing frail one week before his 89th birthday. Blatter arrived 10 minutes after his co-defendant Michel Platini, the former UEFA president and FIFA vice president. Blatter and Platini are facing a second trial nearly three years after they were acquitted by three federal judges. The charges relate to a Blatter-approved FIFA payment of 2 million Swiss francs (now USD2.21 million) to Platini. When federal prosecutors published their initial indictment in November 2021, they said the payment "damaged FIFA's assets and unlawfully enriched Platini."

Khelo India Winter Games 2025 to commence from March 9

Srinagar, March 3: The second leg of the 5th edition of the Khelo India Winter Games (KIWG), which postponed due to insufficient snowfall, will now be held from March 9 to 12 as Jammu and Kashmir's Gulmarg received the appreciable snowfall. The second leg of the 2025

Khelo India Winter Games, featuring four snow sports Ski Mountaineering, Alpine Skiing, Snowboard & amp; Nordic Skiing, was initially scheduled to be staged in Gulmarg from February 22 to 25, but the authorities announced postponement of the event due to scant snowfall on the ski slopes of Gulmarg.

The Ski resort has received good snowfall during the last seven days, and even Monday five to eight inches of fresh snowfall accumulated on the ground while it was still snowing at Gulmarg.

Officials Monday said that the



event will now start March 9 and conclude March 12. "More than 300 athletes from all over the country will compete in events like alpine skiing, Nordic skiing, ski mountaineering, snowboarding and ice hockey. Arrangements for 5th Khelo India winter games 2025 have already been finalised, officials said.

The first leg of KIWG 2025 was held in Leh from January 23 to 27, featuring ice sports such as ice hockey and ice skating at Ladakh NDS Stadium and Guphuk Pond & amp; LSRC Army Rink.

The initiative is meant to promote winter sports in India by offering athletes a competitive platform in one of the country's premier snow desti-



Rivalry to rekindle in upcoming derby clash

In-form Atletico Madrid looks to end its Champions League slump against city rival Real Madrid

Madrid, March 3: The Madrid derby takes center stage in the round of 16 of the Champions League, with Atletico Madrid in a commanding position to try to finally get the best of rival Real Madrid in the European competition.

Madrid, the record 15-time European champion, has been a thorn for Atletico in the Champions League over the years, beating the city rival in two finals and eliminating it from the competition the other two times they faced off in the knockout rounds.

But this Atletico arrives for Tuesday's first leg at the Santiago Bernabeu Stadium playing some



of its best soccer since coach Diego Simeone took over more than a decade ago, and showing the confidence that it can take on the longtime rival head-on.

The round of 16 will begin this week to cap the inaugural season of a new Champions League format that featured a league phase and a playoff

Atletico Madrid enters the match against Madrid in good form and enjoying one of its best seasons under Simeone. The team is ahead of its rival in the Spanish league standings, and is only one point behind leader Barcelona

Atletico hasn't lost any of its matches this season against either Madrid or Barcelona. In the Spanish league, it beat the Catalan club 2-1 in Barcelona and drew 1-1 in both games it played against Madrid. Atletico hasn't lost to Madrid in four consecutive matches, having eliminated the city rival in the round of 16 of the Copa del Rev last season.

Cricket will open up new Olympic markets: Coe

New Delhi, March 3: Hailing cricket's inclusion in the 2028 Los Angeles Games, International Olympic Committee (IOC) president's post frontrunner Sebastian Coe savs the move will open up new markets, which will be critical for the growth of the Olympic movement.

Cricket returned to the Olympics in the T20 format for the first time after the 1900 edition, as it was named among the five additional sports for the 2028 LA Games. The decision was taken in 2023. Coe, who is currently the head of World Athletics. stressed that cricket's support
