## Subhadra crosses 1 crore milestone

Bhubaneswar, March 6: The state government Thursday disbursed ₹5,000 each to 2.30 lakh beneficiaries under Subhadra Yojana in the fifth phase of the first instalment, crossing the one crore milestone.

Deputy Chief Minister Pravati Parida, who holds the Women and Child Development portfolio, disbursed the amount to beneficiaries through DBT.

"Since its launch by Prime Minister Narendra Modi September 17 last year, the state government has disbursed financial assistance under the scheme in five phases, benefiting over one crore women," Parida added.

She also highlighted the state government's **Deputy CM** aim of creat-Pravati ing at least five **Parida** 'lakhpati didis announces in every village as part of bonus for its vision for a Anganwadi 'Viksit Odisha' workers To further help women assistants

powered, the government will assist the beneficiaries to enhance their skills and provide them market linkage to sell their products, she assured. Parida appealed to all beneficiaries of the scheme to light a lamp (diya) March 7 evening for the welfare of their families and their societies.

Additionally, she announced that the state government has decided to release 10 months of pending salaries for women workers under the Mission Shakti department, including Bank Mitras, Krishi Mitras and Prani Mitras.

Furthermore, the government will provide a bonus of ₹1,500 to each Anganwadi worker and ₹500 to each Anganwadi assistant in recognition of their dedication to reaching one crore women under the scheme, she said. In its election manifesto, the BJP had promised to provide ₹50,000 to one crore women in the state. "Now, that promise

## **Justice Harish Tandon** new HC Chief Justice

Bhubaneswar, March 6: The Supreme Court Collegium has recommended the appointment of Justice Harish Tandon as the Chief Justice of Orissa High Court, official sources said Thursday. Justice Tandon has been serving as a judge of Cal cutta HC since April 13, 2010.

The recommendation was made following the retirement of Chief Justice Chakradhari Sharan

Singh January 19, 2025 Justice Arindam Sinha is currently serving the acting Chief Justice of Orissa HC.

Justice Tandon ranks at sev en in the All-India Seniority of High Court Judges, including Chief Justices, the Collegium said in its statement.

"He has acquired extensive experience in dispensing justice. He is considered to be a competent judge and possesses a high level of integrity and conduct required of a person holding high judicial office," it said.

# **Trump's last warning**

Issuing his 'last warning' to Hamas, US President Donald *Trump threatened the militant* group to release all the hostages in Gaza immediately, or 'it is OVER for you.' Trump's warning came just a few hours after US confirmed that it was negotiating directly with Hamas about hostages and Gaza ceasefire, a move that goes against its tradition of not talking to groups it considers terrorist organisations. Taking to Truth Social, the US President said he would send Israel 'everything it needs to finish the job'. Trump's latest salvo at Hamas is interpreted as a culmination of the US' preparation for a full-scale attack against the terror outfit which started after it made Israel call a ceasefire with the warring militants

Washington, March 6: US President Donald Trump issued what he called a 'last warning' to Hamas to release all remaining hostages held in Gaza, directing a sharply worded message after the White House confirmed that he had recently dispatched an envoy for unprecedented direct talks with the militant group.

In a statement on his Truth Social platform soon after meeting at the White House with eight former hostages. Trump added that he was 'sending Israel everything it needs to finish the job.

"Release all of the Hostages now, not later, and immediately return all of the dead bodies of the people you murdered, or it is OVER for you," Trump said. "Only sick and twisted people keep bodies, and you are sick and twisted!" The pointed language from Trump came after the White House said Wednesday that US officials have engaged in 'ongoing talks and discussions' with Hamas officials, stepping away from a long-held US policy of not directly engaging with the militant group. Confirmation of the talks in

the Qatari capital of Doha came as the Israel-Hamas ceasefire remains in the balance. It's the first known direct engagement between US and Hamas since the State Department designated the group a foreign terrorist organisation in 1997. White House press secretary Karoline Leavitt declined to provide detail on the substance of talks, but said President Donald Trump has authorised his envoys to 'talk to anyone.

Egyptian and Qatari intermediaries have served as mediators with Hamas for US and Israel since the group launched its October 7, 2023 attack on Israel that sparked the war.

"Look, dialogue and talking to people around the world to do what's in the best interest of the American people is something that the president ... believes is a good-faith effort to do what's right for the American people," she said.

Leavitt added that Israel has been consulted about the direct engagement with Hamas officials, and noted that there are 'American lives at stake.' Israeli PM Benjamin Ne-

tanyahu's office offered a terse acknowledgement of the US-Hamas talks. "Israel has expressed to US its position regarding direct talks with Hamas," the PM's office said. Israeli officials say about 24

living hostages — including Edan Alexander, an American citizen — as well as the bodies of at least 35 others are believed to still be held in Gaza.

Adam Boehler, Trump's nominee to be special envoy for hostage affairs, led the direct talks with Hamas. Boehler, founder and CEO of Rubicon Founders, a healthcare investment firm, was a lead negotiator on the Abraham Accords team during Trump's first term that strove to win broader recognition of Israel in the Arab world.

The talks, which took place last month, focused mainly on the release of American hostages, and a potential end of the war without Hamas in power in Gaza, according to a Hamas official who was not authorized to comment publicly and spoke on condition of anonymity.

# CM residence welcomes occupant after 25 years

Bhubaneswar, March 6: After remaining vacant for nearly 25 years, the official residence of Odisha Chief Minister in the state capital welcomed a new occupant as Mohan Charan Majhi formally moved in Thursday.

Majhi, along with his family. performed the 'Gruha Pravesh' ceremony at 10:47am, following a puja conducted by 11 priests from Puri.

"The Chief Minister entered the official residence along with two cows, according to Hindu rituals of Gruha Pravesh," said Pandit Bishnu Charan Panda. one of the officiating priests. The two cows - Nandi and Nandini - were worshiped during the ceremony and will continue to reside on the premises.

Maihi had previously been staying at a government quarters on Mahatma Gandhi Marg.

## London: Bid to breach Jaishankar's security

London/New Delhi, March A pro-Khalistani protester attempted to breach the security perimeter outside Chatham House in London as External Affairs Minister (EAM) S Jaishankar left the think-tank, drawing condemnation from India over the provocative activities of this 'small group of separatists and extremists'.

The small group chanting pro-Khalistan slogans and waving separatist flags was barricaded and monitored by a significant police presence outside the venue Wednesday night, with officers rushing to restrain the man as he ran past the barricade in an attempt to block the path of the minister's car pulling at an Indian flag. He was swiftly taken aside by Metropolitan Police officers and no arrests have been reported so far. The Ministry of External Affairs (MEA) in New Delhi condemned the incident of the 'security breach' and called on the UK government to 'live up

pletely unacceptable'. "We strongly condemn the incident that took place outside Chatham House yesterday (Wednesday) during the EAM's visit to the UK," a Foreign, Commonwealth and Development Office spokesperson said.

A Met Police spokesperson added. "As the Minister left the event, a protester ran in front of his stationary car waving a flag. He was quickly intercepted by officers and moved out of the way. He did not get close to the Minister who was able to leave the area without further incident. There were no arrests.'

## **Police recruitment** exam put on hold

Bhubaneswar, March 6: The state government Thursday put on hold the written examina tion for recruitment to Group-B posts in the police department due to 'unavoidable circumstances', an official statement

said. The exam, conducted by the Odisha Police Recruitment Board (OPRB), was scheduled to be held March 8-9 at different centres across Odisha, it

In January, the OPRB had issued advertisements for recruitment for 933 vacancies in the police department 609 sub-inspector posts, 253 sub-inspector (armed) posts 47 station officer (fire service) posts and 24 assistant jailor positions.

Several aspirants, however, had raised objections over the conduct of two written examinations for Assistant Ag riculture Officer (AAO) and Group-B posts in the police department March 9.

The aspirants had demanded postponement of at least one test.

# At 108, world's oldest female barber has no plans to retire anytime soon

Tokyo, March 6: Meet the world's oldest female barber: She is 108 but the slender, white-haired Japanese woman has no plans to retire anytime

Shitsui Hakoishi says the formal recognition by the Guinness World Records this week brought her much joy - other than her satisfied customers, that is.

She was presented with an official certificate from the international franchise Wednesday. Guinness World Records has a separate category for male barbers but the man who was certified at age 107 in 2018, Anthony Mancinelli of the United States, has died in the meantime, leaving Hakoishi as the only holder of the record.

Her career has spanned nine decades and she says she owes it all to her customers.

"I could come this far only because of my customers,' Hakoishi told a televised news conference Wednesday at a gymnasium in her hometown of Nakagawa in the Tochigi prefecture, northeast of Tokyo. "I'm overwhelmed and filled with joy." Born November 10, 1916 to a family of farmers in Nakagawa, Hakoishi decided to become a barber at age 14 and moved to Tokyo, where she honed her craft first as an apprentice.



She got her barber's license at 20 and opened a salon together with her husband. They had two children before he was killed in the Japan-China war that broke out in 1937

Hakoishi lost her salon in the deadly March 10, 1945 US firebombing of Tokyo. Before that, she and her children were evacuated elsewhere in the Tochigi prefecture, according to the Guinness website.

It took her eight more years before she opened a salon again, calling it Rihatsu Hakoishi, in her hometown of Nakagawa. Rihatsu is Japanese for barber. She says she isn't ready to

put away her scissors "I am turning 109 this year,

so I will keep going until I reach 110," she said and smiled confidently.





# Vig glare on STA **Dy Commissioner**

Bhubaneswar, March 6: The state Vigilance claimed to have unearthed a massive amount of movable and immovable properties linked to senior state Transport department official during searches at his residence at Maitri Vihar here, Thursday.

A Vigilance official said the disproportionate assets recovered from the residence of Pradeep Kumar Mohanty, posted as a Deputy Commissioner in the State Transport Authority (STA) include Rs 15 lakh cash, about 1 kg gold, a fleet of vehicles and documents of several properties in and around the Capital City.

Giving details, the official said the properties include four multi-storied buildings, 11 plots, a 14-acre farmhouse which are registered in Mohanty's name. The movable properties include three gold biscuits (yet to be weighed), 700 gm gold ornaments, three four-wheelers, and a motorcycle. The official said the seized vehicles are expensive sports utility vehicles (SUVs). All the

recovered include Rs 15 lakh cash, about 1 kg gold, a fleet of vehicles and documents of several properties in and around the Capital City

The officer said the STA official's bank accounts, postal, and insurance deposits are presently being scrutinised for further information.

# CS directs all-out drives to curb illegal mining

Bhubaneswar, March 6: Chief Secretary Manoj Ahuja Thursday directed all district officials to undertake massive enforcement drives to curb all illegal mining of minor minerals and their transportation in their respective localities.

During a meeting with Collectors/District Magistrates, and Superintendents of Police (SPs) in virtual mode, Ahuja instructed the district functionaries to conduct raids at sand and stone quarries, check illegal mining at the source and book cases as per law against

Simultaneously, strict action is to be taken against illegal transport of minerals and transport without E- Transit Pass. "Wherever it is established prima facie that a vehicle is involved in illegal transport of mineral, it shall be seized forthwith as per law," Ahuja said.

The strategy for enforcement drive shall be decided jointly by the Collector and SP. Sub-divisional level teams and tehhsil-level teams consisting of revenue, mining, police and other officials shall undertake enforcement activities, he directed.

Collectors have also been instructed to undertake survey of new sources of sand and black stone. Each district has been asked to identify new sources equalling to 150 per cent of their current sources. District survey reports for these new sources shall be prepared by August, and the sources are targeted to be auctioned by October this year. Sources said the aim of the move is to increase number of sairat sources, which will not only ease the availability of minor minerals, but also make the prices reasonable, apart from checking illegal mining.

## Delhi woman dupes City man of ₹87 lakh, arrested

Bhubaneswar, March 6: The state Crime Branch Thursday arrested a woman from South Delhi on charges of swindling Rs 87 lakh from a resident here by luring him into high returns on investments through online trading. The accused, Vandana Bawa, was found to be involved in two other cyber fraud cases in Kerala and Gujarat, according to CB officials.

Additional Superintendent of Police (ASP) Ritesh Mohapatra said the complainant, a resident of Salisahree Vihar, lodged a complaint February

2, 2024, alleging that a stranger had added him into a WhatsApp Group "101 Stock Discussion Group". The group admin, identifying herself as a market expert, shared tips about picking stocks, initial public offerings (IPOs) and other tricks on the group. This made the complainant to cling on to the group.

"Vandana then shared fake pictures of account statements of members showing high re-

turns on their investments following which the complainant invested Rs 87 lakh in phases and on different dates. However, the complainant realised that he had been duped when the fraudster removed him from the group and went incommunicado," the ASP said.

He said a Saket court has granted permission for the transit remand of Vandana. She has been booked under Sections 419, 420, 465, 467, 468, 471, 120 (B) of IPC, along with Section 66 (C) and (D) of Information Technology Act. The sleuths produced her before a local court Thursday.



## Clearing AIBE needed for practice experience: HC

ORISSA HIGH COURT DISQUALIFIES LAWYER'S NOMINATION AS 'TREASURER' IN KHURDA DISTRICT BAR ELECTION

Khurda, March 6: The practice experience of an advocate enrolled with the state bar council cannot be taken into account unless and until he qualifies the All-India Bar Examination (AIBE) conducted by the Bar Council of India (BCI), the Orissa High Court said.

While disqualifying an advocate from holding the post of 'treasurer' of a district bar association for lack of practice experience after qualifying AI-BE, the single bench of Dr Justice Sanjeeb Kumar Panigrahi referred to the All India Bar Examination Rules, 2010 and observed," a perusal of the above rule clearly demonstrates that the All India Bar Examination is mandatory for all law students graduating from the year 2009-10 onwards. Passing



this examination is a critical requirement, directly linked to maintaining the standard of individuals seeking to obtain a license to practice law as a profession.

The said advocate had filed his nomination for the post of 'treasurer' in the annual district bar election in Khurda for the term of 2024-25. The petitioner, advocate Biswakesh Mohapatra, lodged a complaint with the Election Officer of the Khordha District Bar Association. alleging that the advocate was ineligible to contest the election due to having only three years of practice experience since he had cleared AIBE only in 2021.

However, the Election Officer dismissed the complaint on the ground that the advocate had been included as a valid voter in the voter list issued by the Odisha State Bar Council (OS-BC). Accordingly, his nomination was accepted.

Thereafter, the petitioner approached the OSBC which constituted a central election committee to investigate the matter. Upon deliberation, the committee concluded that the opposite party (advocate) who had cleared AIBE only in March 2021 could only be considered a practicing advocate from that date onwards, and not before.

Then, the OBSC directed the Election Officer of the Khordha District Bar Association to verify whether the eligibility criteria for the treasurer's post requires a minimum of ten vears of regular practice. In the event such a ten-year requirement was proved, the Election Officer was instructed to take the requisite steps to invalidate the nomination as the advocate did not meet the stipulated eligibility criteria. However, the Election Officer failed to comply with the order.

This made the petitioner file a writ petition in the Orissa High Court seeking that the respondent be treated as a 'non-practicing advocate' from the date of his enrolment to March 2021 - the date of passing AIBE - and he be disqualified under Rule 25 of the Khordha District Bar Association Rules, 1957.

After perusal of the above rule, Justice Panigrahi made clear that clearing AIBE is mandatory for all law students graduating from the year 2009-10 onwards for being eligible to practice the profession of law.

Consequently, the Election Officer was directed to comply with the direction of the election committee and take necessary steps to invalidate the nomination filed by respondent as he did not meet the requisite eligibility criteria.

## NHRC team begins probe into KIIT row

Bhubaneswar, March 6: A team of National Human Rights Commission (NHRC) Thursday began its inquiry into the death of a 20-year-old Nepalese girl student at KIIT University and the subsequent alleged attacks on the students of the Himalayan nation by the staff of the private institute.

Led by Joginder Singh, Registrar (Law), the inquiry team reached the airport and proceeded straight to KIIT University under Infocity Police Station here.

"We will follow the commission's order and work accordingly." Singh told reporters.

Prakriti Lamsal, a third-year Computer Science student at KIIT, was found dead in a hostel room of the university on the evening of February 16. It was alleged that she died by suicide.

The commission has asked the team to submit findings by March 10. Acting upon a complaint lodged by Ashutosh B, a resident of the city, and a letter from Nepal's rights panel, the NHRC had formed a team of officers from the investigation and law divisions to conduct an on-spot inquiry into the student's death at KIIT University, Bhubaneswar, and submit a report by March 10.

"Considering the seriousness of the matter, the commission directs its Registrar (Law) to proceed with an inquiry in KIIT University along with a team consisting of two officers from the investigation division, one not below the rank of SSP, and one officer from law division," the NHRC order stated.

The complainant has claimed that Lamsal, a Nepalese student at KIIT University, had faced harassment by an engineering student at the institute, follow-

ing which she died by suicide. The victim had brought the harassment issue before KIIT's

The Nepalese students were allegedly served eviction notices, driven out of their hostel rooms and dropped at a railway station.

These students were allegedly asked to return to their country without making any return arrangements.

# **SC** sets 6-month deadline for civil execution pleas

New Delhi, March 6: The Supreme Court Thursday asked all high courts to direct civil courts in their jurisdiction to decide the execution petitions within six months, failing which presiding officers would be held liable.

A bench of Justices JB Pardiwala and Pankaj Mithal also ordered high courts to gather data from district courts regarding pending execution petitions. The bench expressed concern that many such petitions, filed to enforce civil decrees, remain unresolved for three to four

"If execution petitions are delayed for years, it defeats the purpose of the decree," Justice Pardiwala remarked.

The ruling stemmed from a long-pending civil dispute from Tamil Nadu dating back to 1980. The court directed all high courts to collect data on pending execution petitions and issue administrative orders or circulars to ensure their disposal within six months. High courts must also forward the collected data to the Supreme Court registry

The Supreme Court noted that similar directions had been issued in 2021 and 2022. mandating completion of execution proceedings within six months, yet they were not implemented. It criticized the

excessive delays by executing courts in enforcing decrees.

The case before the bench involved a land sale agreement dated June 30, 1980, by Tamil Nadu resident Avvavoo Udayar. A dispute arose over the land's title, prompting Udayar to file a civil suit for specific performance in 1986. Despite securing a favorable decree, the defendants did not execute the sale deed, leading to prolonged litigation.

In 2004, the decree-holder filed a petition seeking en forcement of the decree, but it was dismissed. A revision petition in 2006 allowed the enforcement, yet the sale deed remained unexecuted. Another order for possession was passed in 2008 but was not carried out.

The Supreme Court ruled that the high court had committed a "serious error" in its handling of the case. It emphasized that the decree-holders must receive the property's vacant and peaceful possession within two months, using police assistance if required.

This directive aims to expedite justice and prevent undue delays in enforcing civil court

## Banks urged to boost credit in key sectors

Bhubaneswar: The 178th State Level Bankers' Committee (SLBC) meeting, co-chaired by Development Commis-Anu Garg and UCO Bank executive director VN Kamble, was held Thursday to discuss credit expansion strategies. Garg emphasised the need to achieve 100 per cent of the Annual Credit Plan (ACP) target of ₹2.11 lakh crore for FY 2024-25. She urged banks to prioritise credit flow in housing, education, and export sectors while addressing region al disparities in financial access, particularly for women, SC/ST communities, and weaker sections. Stressing the importance of PM-SVANidhi, a scheme regularly reviewed by the Prime Minister, Garg called for increased fi-nancing efforts. Additionally, she sough banking support for the newly-launched Financial Assistance to Cold Storage scheme, aimed at strengthening storage infrastructure, reducing post-harvest losses, and preventing distress sales by farmers. Banks were also encouraged to enhance credit flow to improve Odisha's Credit-to-GSDP ratio. The ACP target for FY 2025-26 has been set at ₹2.52 lakh crore, as per NABARD projections. Kamble commended banks for achieve ing 68.95 per cent of the ACP target by December 31 and full coverage under social security schemes like PMJJBY, PMSBY, and PMJDY. However, he raised concerns over slow implementation of PM Vishwakarma, declining SHG loan applications, and registration challenges in the housing sector. RBI regional director SP Mohanty pointed out high retail and food inflation in Odisha, the state's lower credit growth compared to the national average, and RBI's initiatives to promote financial literacy and cybersecurity.

# Parkinson's cases may surpass 2.5 crore by 2050

## **Rising aging** population fuels surge in neurological disorders worldwide

he global burden of Parkinson's disease is expected to rise significantly in the coming decades, with over 2.5 crore people projected to be living with the neurodegenerative disorder by 2050. According to a new study conducted by researchers at Capital Medical University, China, the estimated increase marks a staggering 112 per cent surge from 2021, primarily driven by an ageing population.

The findings, published in The

British Medical Journal, highlight that East Asia is expected to witness the highest number of cases, surpassing 1 crore, while South Asia is projected to have the second-largest share, with around 68 lakh cases

The study underscores the urgent need for increased research, healthcare infrastructure, and policy measures to address the growing prevalence of the disease.

Parkinson's disease is a progressive neurodegenerative disorder that gradually impairs movement, balance, and coordination. It can also affect speech, memory, and behaviour. Common symptoms include involuntary tremors, muscle stiffness, slow movement, and



difficulty with coordination.

The disease is caused by the loss of dopamine-producing neurons in the brain, but its exact triggers remain unclear.

The study analysed data from the Global Burden of Disease Study 2021 to estimate the prevalence of Parkinson's disease

between 2022 and 2050 across 195 countries and territories. Researchers found that population ageing is the primary factor behind the rise in cases, accounting for nearly 90 per cent of the projected increase.

While East and South Asia will have the highest number

of cases, the study predicts that Western Sub-Saharan Africa will experience the most dramatic rise, with an almost 300 per cent increase in Parkinson's prevalence. This sharp spike highlights the need for global healthcare systems to prepare for a higher demand for treatment and support services.

Another key finding of the study is the changing gender ratio among Parkinson's patients. The male-to-female ratio, which stood at 1.46 in 2021, is expected to rise to 1.64 by 2050, suggesting that men may be increasingly at risk of developing the condition compared to women.

The researchers emphasised that increasing physical activity and adopting healthier lifestyles could help reduce future Parkinson's cases. Additionally, they called for intensified efforts in medical research, par ticularly in the development of novel drugs, gene engineering techniques, and cell replace ment therapies.

These advancements, they noted, could modify the dis ease's progression and significantly improve the quality of life for those affected.

The study's findings serve as a crucial call to action for gov ernments, healthcare providers, and researchers worldwide to invest in better diagnostic methods, effective treatments, and improved support systems for individuals living with Parkinson's disease.

al thousand years old. Located around 100 km from Hirakud Dam, Bhimamandali holds immense archaeological value, he added. As one of the oldest rock art sites in the state. Bhimamandali features intricate paintings and engravings of deer, elephants, animal footprints and honeycomb patterns, offering a rare glimpse into early human settlements, he said.

He said the site is believed to be linked to the Pandavas from the Mahabharata and is named after Bhima, making it a mustgo destination for tourists.

Pradhan added that Bhimamandali attracts a diverse range of visitors, including history enthusiasts, nature lovers, pilgrims and adventure seekers.

However, he expressed concern over the site's deteriorating condition. Due to a lack of maintenance, much of the rock art has become indecipherable.

Historians, heritage conservationists and local communities have been demanding that Bhimamandali be declared a protected monument by the ASI to ensure its preservation and conservation, he added. Pradhan also wrote about the importance of Debrigarh Wildlife Sanctuary located between Hirakud Dam and its adjoining reservoir.

He said the sanctuary is home to a wide variety of wildlife and contains artifacts and tools dating back to the Middle and Upper Paleolithic Ages.

Given its immense tourism potential, Pradhan urged that Debrigarh Wildlife Sanctuary be included in the Swadesh Darshan scheme of the Union Ministry of Tourism.

Chief Wildlife Warden Prem Kumar Jha, in a post on X, said, "Olive Ridley 'arribada' has commenced at Gahirmatha, the world's largest rookery, following a record-breaking 6.37 lakh mass nesting at Rushikulva. 'Arribada' is a Spanish term for the mass nesting.

Jha said this is a significant milestone in Odisha's ongoing marine conservation efforts.

In another post, he said, "Gahirmatha witnessed the arrival of over 78,000 Olive Ridley turtles for mass nesting last night. As the world's largest rookery, it remains a critical site for their conservation. Odisha continues its dedicated efforts to protect these marine wonders.

An official of Rajnagar Forest (Mangrove) Division said it was heartening to note that the turtles have arrived on their annual sojourn to lay eggs at the tranquil Nasi-II beach of Gahirmatha Marine Sanctuary.

## Four injured in explosion while making crackers

Jajpur, March 6: At least four persons, including two minor boys, sustained serious injuries in an explosion at an illegal cracker manufacturing unit in Jajpur district Thursday, police said.

The incident took place at Jalpur village under Jajpur Town police station limits.

The injured persons were making crackers when the explosion occurred, police added. All the iniured were rushed to Maharaja Jajati Keshari Medical College and Hospital in Jajpur.

The impact of the blast was so powerful that the roof and wall of the pucca house, where the illegal firecrackers were being manufactured, were severely damaged, police added.

The matter is under investigation and the reason will be ascertained after the probe, a police official said.

## Heroin seized; 3 peddlers arrested



Rourkela: Rourkela police have made significant progress in their ongoing battle against drug trafficking, with the arrest of three individuals on drug-related charges Thursday. The arrested drug peddlers were identified as Sofik alias Kamran Khan, 36; Chuddu alias Saif Ali, 28; and Baaban alias MD Arif, 36. All three are residents of Nalla Road area. Police seized 16.58 gram heroin, one motorcycle, three mobile phones, and cash amounting to ₹10,700 from their possession. The arrests were made after the Plant Site police station received reliable information about the trio. A police

## 3 sentenced to life for murder

Bolangir: A court in Bolangir Thursday sentenced three men to life imprisonment after convicting them in the 2022 murder case of Sudhir Behera in Sadaipali under Bolangir Sadar police station limits. Additional Sessions Judge (First Class) Himanshu Shekhar Singh found the accused-Sanjeev Mugri, Bishal Suna and Shiba Nag-guilty and imposed a fine of ₹10,000 on each. In case of failure to pay the fine, they will serve an additional year in prison. According to the case diary, Behera had gone to Sadaipali with friends to witness Rath Yatra July 2, 2022, when the accused attacked him with iron rods over past enmity. Family members rushed a critically injured Behera to Bhima Bhoi Medical College and Hospital, and later shifted him to VIMSAR Hospital in Burla, where he died during treatment. Bolangir Sadar police arrested the three men and presented them in court. The judge delivered the verdict after hearing statements of 22 witnesses, said Additional Public Prosecutor Pradeep Kumar Padhi.

## 17 boats gutted as fire breaks out at Paradip fishing harbour

Paradip, March 6: A fire broke out at the Nehru Bangla Fishing Harbour in Paradip Thursday, police said.





## Get rich before getting old

he effects of falling birth rates and rising life expectancy are increasingly evident in advanced economies like Germany, Italy, and Japan. Labour markets are tightening, worker shortages are worsening, and families are struggling to find care for aging parents. In some areas, declining student numbers are forcing schools to shut down.

South Korea offers a stark example. In 2023, as the country's total fertility rate plummeted to just 0.7 children per woman of childbearing age over a lifetime, sales of dog strollers surpassed those of baby strollers. But population aging is not limited to advanced economies. Within

a generation or two, many emerging economies will likely face the same demographic problems plaguing their developed-country counterparts – without the financial resources needed to cushion the blow. In a new McKinsey Global Institute (MGI) report, we divide these

demographic shifts into three distinct waves. The first wave has already swept advanced economies, as well as Eastern Europe and China, where working-age populations peaked around 2010, followed by steady declines. As a result, per capita GDP growth in those economies is projected to slow by 0.4 percentage points annually on average, or as much as 0.8 percentage points in some countries, by 2050. While around 30 per cent of the labour income is currently used to fund pensioners' consumption, this figure could increase to close to 50 per cent by mid-century.

The second demographic wave will hit emerging economies over the next decade, as working-age populations peak everywhere except Sub-Saharan Africa, where it is projected to peak when the third wave arrives in the second half of the century. These economies have a narrowing window of opportunity before their demographic dividend diminishes and the financial burden of supporting an aging population

rises sharply In nearly half of the 89 emerging economies outside Sub-Saharan Africa, fertility rates have already fallen below the replacement level of 2.1 births per woman, leading to a rapid decline in the ratio of working-age individuals (typically defined as 15-64) to those who are 65 or older. China, an emerging economy with the demographic profile of a developed one, currently has 4.8 working-age people per retiree not far from the United States ratio of 3.6. By 2050, China's ratio of working-age people to pensioners is projected to fall to 1.9, below

France (2.0) and the US (2.6). Demographic transitions are unfolding at a slightly slower pace Whereas Thailand's ratio of work-

in other emerging economies. ers to pensioners is projected to fall to 3.9 - the current average in first-wave countries – within five years, Brazil will reach that level in 16 years and India in 33. In all three cases, however, GDP per

capita in emerging economies remains significantly lower than that of high-income countries. In purchasing-power-parity terms, Thailand's GDP per capita is just 37 per cent of the average in advanced economies, Brazil's is 34 per cent, and India's is 16 per cent

These shifts present emerging economies with a daunting challenge: they must get rich before they get old. Over the past 25 years, favourable demographic trends have led to an average annual increase of 0.7 percentage points in India's per capita GDP and 0.5 percentage points in Latin America's. But India's demographic dividend is now projected to drop to 0.2 percentage points of annual GDP growth over the next quarter-century, while Latin America's is expected to vanish.

So, what can emerging economies do? For starters, they must boost productivity. GDP per capita is determined mainly by the size of the workforce relative to the total population and the productivity of individual workers. Productivity in emerging economies lags far behind that of wealthier counterparts, averaging \$13 per hour worked – or \$18 when excluding Sub-Saharan Africa – compared to \$60 per hour

Given the right investments, emerging economies have an opportunity to create a "flywheel" effect, whereby investment fuels productivity gains. This, in turn, would attract more investment, create meaningful employment opportunities, boost purchasing power, and enable companies to increase productivity even further.

Beyond productivity gains, emerging economies can mitigate the impact of demographic shifts by increasing labour-force participation, particularly among women. In the median emerging economy, the labour-force participation rate of women aged 20-49 hovers around 60 per cent, compared to 80 per cent in advanced economies.

To navigate demographic shifts effectively, governments and businesses in emerging economies must learn from the experiences and strategies of developed countries. Two key lessons stand out.

First, emerging economies must ensure that young people are positioned to compete globally. In addition to improving their education systems, they must boost other investments in human capital and

With global consumption and talent increasingly shifting toward the developing world, emerging economies have an opportunity to cultivate the next generation of superstar companies. As MGI research has shown, developing economies that outperform their peers often have large, competitive firms to thank for it. But building such businesses requires a supportive ecosystem, including strong institutions, reliable physical and digital infrastructure, robust intellectual-property protections, and access to investment and partnerships.

In many emerging economies, old-age support systems are still largely informal and family-based. By improving financial inclusion and creating incentives for private savings and wealth accumulation, emerging markets could build systems that support aging populations without undermining economic resilience.

Emerging economies can also avoid some of the fiscal challenges facing their developed-country counterparts by investing in the health and well-being of their young and middle-aged populations. To ensure that workers remain active and productive well into old age, policymakers should seek to promote routine exercise, expand access to healthy food, and provide high-quality health care, especially

Most importantly, policymakers must keep in mind that demographic change does not hit like a tsunami; it happens gradually, like a tide. While its predictability is an advantage, its slow pace makes it easy to overlook until the consequences become unavoidable. Emerging economies still have time, but the water is already around their ankles.

# RECALIBRATING FOREIGN POLICY


Donald Trump to the White House for the second time has caused a tectonic change in global geopolitical order. All countries have to adjust their policies to cope with this dramatic change. India is no ex-

America can still move and shake things in the world. Remember, World War-II came to an end only after the US intervened in favour of the Allied Powers. The Cold War lasted so long because of American posturing against Russia. And the USSR's expansion into Eastern Europe was checked by the US. Israel survives against the combined might of Arab countries only on account of America's sustained support.

Europe, another big power, is basking in its past glory which is also fast fading. The European Union, the supranational entity, is not united as the USA. They are trying to regroup under the sudden blast inflicted by Trump. One only hopes that they succeed as the EU is a good experiment in integration.

China has emerged as a big power and is using its economic heft to acquire political and security dominance. Beijing is batting for carving out its own sphere of influence. Russia, under Putin is desperately trying to revive its old influence in the world. It is trying to undo the disintegration carried out under Gorbachev. Little did he realise his twin strategy of glasnost and perestroika would open up a Pandora's Box leading to falling apart of the Union.

Where does India stand in this changed scenario? Prime Minister Narendra Modi who was perceived as close to Trump must also be rethinking about his frenemies. He campaigned for Trump in 2020, breaking protocols. But Trump's spat with Zelenskyy bordering on plain abuse of each other would have shak-

en many leaders. Trump is currently advised by apolitical individuals. Take Elon Musk for example. Musk is the head of Department of Government Efficiency (DOGE). Did people watch how Musk met Modi in a bilateral interaction? Modi was accompanied by the National Security Advisor, the Foreign Minister and the Indian Ambassador to the US, and Musk's side was occupied by children from some foster care and their nannies. It is hard to interpret what it actually signified.

All heads of government may be rereading the chilling lines of Henry Kissinger: "It may be dangerous to be an enemy of America, but to be a friend of America is fatal." Who would realise it more than Zelenskyy? India is at the fence, has not fully become an American friend.

Given such geo-political zeitgeist, what could the South Block, that churns strategies, be thinking! It would be worth the while of observers and analysts to draw their inferences. I will do mine. The first thought that comes to mind is "wait and watch," which is a part of our culture and a policy imperative. Indians are not known for reacting impulsively. Good enough. But there is also a saying that "an early bird catches the worm." Those who take initiative, influence

the outcome.

If we go along with the wait and watch, allow the diplomatic storm to subside, India can navigate its path. After all, it may be a storm in the tea cup. Trump cannot thrive in chaos. He does not like market disruption--inflation or the stock market crashing. He will then pull back. Trump is flexible though unpredictable. So, it will be business as usual. The Ukraine war will end. Russia will agree to pull out with some concessions. If Ukraine undertakes not to join NATO, Putin may breathe in peace. Russia may be delinked somewhat from China, That will be good for India.

If all the above does not happen, what will be New Delhi's initiatives? The only viable and possible alternative is to push for a multipolar world. This has been the passion of India's Foreign Minister. Such a world order will provide the strategic autonomy to India and many other countries.

So far, I have argued against the possibility of a multi-polar world. It is not evidenced by history. It sounds utopian. But there is no harm trying it. Nothing is improbable in human lives or those of nations. Who has thought two Germanies will be one, Soviet Union will collapse, or China may fall apart? In science, roSo go for a multipolar world to escape the whims and caprices of one individual who runs the biggest power of the world. In any case, if this world order is going to be reality, and India genuinely wants it, New Delhi has to go overdrive on this.

Europe is jilted with the US New Delhi should talk to Europeans seriously. If they do not want a repeat of vocal thrashing and crash insults from the American Vice President, they have to pull up their socks. European leaders have reiterated their pledge of support to Zelenskyy. That pledge should soon translate into action. If Europe is making these utterances to put pressure on Trump to secure a better deal for Ukraine, it may not work. Trump may not yield easily to pressure.

President of European Commission Ursula von der Leven was in India recently. She talked to the Indian leadership about soon completing discussion and sign the FTA. This has gone on forever, almost 12 years. If that is the efficiency of the EU in clinching agreements, God help the EU. They could be more decisive by cutting out the bureaucracy. India is good with the Global South. New Delhi can carry them along. It is the middle powers that India needs to

carry confidence with. I am certainly not convinced that a multipolar world will ever emerge. It is for the countries to choose their place in geopolitical binary. Who will lead either side in a binary will change over decades. But that will be the world order. The middle powers can certainly influence the leaderships in binaries.

India should not hedge between two powers or axes. It can play an active role. For now, it has the space to build a multipolar world. All the best.

## Global pursuit of women's empowerment

extreme challenge while most opportunity of our times. We cannot have a free and equal society until everyone is free and equal, until women enjoy the same rights as men. According to the UN, "gender equality and the empowerment of women and girls is not just a goal in itself, but a key to sustainable development, economic growth, and peace and security." Research has shown that society gets better for everyone when women's rights are upheld and taken seriously. More specifically, the Charter of the United Nations (Articles 8 and 101) stipulates that there shall be no restrictions on the eligibility of men and women to participate in every capacity and under conditions of equality in its principal and subsidiary organs. The year 2025 is a pivotal

moment in the global pursuit of gender equality and women's empowerment, as it marks the 30th anniversary of the Beijing Declaration and Platform for Action. Adopted at the Fourth World Conference on Women

governments, the Beijing Declaration and Platform for Action remains the most progressive and widely endorsed blueprint for women's rights worldwide.

But gender equality remains elusive across the globe. Across the world many women and girls still face discrimination, violence and atrocities on the basis of gender. Gender inequality leads to many problems which disproportionately affect women and girls, such as domestic and sexual violence, lower pay, lack of access to education, and inadequate healthcare and lack of control over sexual and reproductive rights.

According to a report on gender justice and women's rights by Oxfam, nearly two thirds of the world's 78.1 crore illiterate adults are women, a proportion that has remained unchanged for two decades. 153 countries have laws which discriminate against women economically, including 18 countries where husbands can legally prevent their wives from working.

According to a new report by UN Women, the home, once a safe haven for women, has bemost dangerous places for them. This report highlights the global epidemic of femicide, emphasising that the vast majority of these terrible fatalities occur within the home.

Gender inequality is so pervasive in India that in UNDP's Gender Inequality Index (GII) 2022 released in March 2024, India is placed behind 107 countries (ranks 108) out of 193. Similarly in the Global Gender Gap Index 2024 of the World Economic Forum (WEF) India's position has declined two places from 127th last year to 129th.

As of 2024, 68.5% of global gender gap closed while 31.5% of the gap remains unaddressed across all 146 countries indexed this year. It will take 134 years to achieve full parity if the current rate of progress is maintained. By contrast, India has closed 64.15 of its gender gap in 2024, which means 33.9% the gap remains unaddressed.

The glass ceiling is a metaphor for the invisible barrier that prevents women from advancing in their careers and labour force participation. According to ILO, the global (LFPR) for women was 48.7% in 2023. This is much lower than the 73% rate for men, resulting in a gap of more than 24 percentage points. In India, latest Periodic Labour Force Survey (PLFS) 2023, the stands at 60.1%, with a breakdown of 78.8% for males and 41.7% for females, indicating a significant gender gap. There is some improvement in female labour participation in India due to increase in self-employed women.

The International Women's Day serves as a powerful reminder of the progress made towards gender equality and highlights the work that still needs to be done. The day's theme this year is: "For all women and girls: Rights. Equality. Empowerment." This theme calls for actions that can unlock equal rights, power and opportunities for all and a feminist future where no one is left behind. Central to this vision is empowering the next generation—youth, particularly young women and adolescent girls—as catalysts for lasting change.

Sir, President Trump won a second term by promising working-class Americans higher wages and a stronger economy. Yet his escalating trade war — particularly with Mexico, Canada, and China — is at odds with those promises. Tariffs are essentially taxes paid by American consumers and businesses, and Trump's newest rounds of tariffs could amount to a \$150 billion annual tax increase. The uncertainty around trade policy has already rattled markets with the Dow Jones Industrial Average down 3.4% since Trump took office, wiping out the gains from the post-election economic optimism. The latest tariffs are hitting America's closest trading partners. Trump imposed 25% tariffs on Canadian and Mexican imports, affecting everything from cars to agricultural products. He also raised tariffs on \$200 billion worth of Chinese goods, pushing rates from 10% to 20% and threatening to go even higher. These moves will raise prices for American consumers on essentials like fruits, vegetables, beer, and electronics. Retail giants like Target and Best Buy have already warned that tariffs will lead to higher prices, while farmers and manufacturers brace for rising input costs. Energy prices are also caught in the crossfire. Trump lowered tariffs on Canadian energy to 10%, implicitly acknowledging the risk to US consumers, but even that reduced rate will drive up heating bills in the Midwest and Northeast, where households rely on Canadian natural gas and electricity. Trump's tariff war reflects ideology trumping economic common sense — and unless he changes course. the very workers and farmers he vowed to protect will bear the brunt of his policies.



# **Condemn activities** of extremists: India

New Delhi, March 6: India on Thursday served a demarche to the British charge d'affaires lodging a strong protest over a breach in security for External Affairs Minister S Jaishankar in London as a pro-Khalistani protester attempted to break barricades and tried to stop his motorcade while some others were shouting anti-India

In a firm reaction, New Delhi condemned the incident and said it expects the host government to fully live up to their diplomatic obligations in such case. It also deplored the "misuse of democratic freedoms" by the "small group of separatist" elements. People familiar with the mat-

ter said the charge d'affaires at the British High Commission was called to the Ministry of External Affairs (MEA) and was served a demarche.

The incident happened as Jaishankar was leaving the Chatham House after concluding an interactive session at the institute, home to Royal Institute of International Affairs, Wednesday evening.

The external affairs minister was in London as in the first leg of his six-day visit to the UK and Ireland from Tuesday that is aimed at exploring ways to further boost bilateral cooperation.

"We have seen the footage of a breach of security during the visit of the external affairs

The British foreign ministry also condemned the incident and said attempts to disrupt public events were unacceptable. Videos posted on social media showed a small group of pro-Khalistan protesters holding yellow flags were shouting slogans against India and Jaishankar on the opposite side of the road from Chatham House.

As Jaishankar was about to leave the institute, a tall man was seen attempting to break the police cordon and run towards Jaishankar's motorcade. The tall and bearded man

even tried to block the minister's motorcade by standing in front of it and tore an Indian flag. The man was swiftly taken away by Metropolitan Police officers.

It was not the first such incident of breach of security by pro-Khalistan elements.

In March, 2023, certain pro-Khalistan elements pulled down the Indian flag at the Indian high commission in London, triggering strong reaction from India.

Following the incident, India summoned the senior-most British diplomat in Delhi and demanded an explanation over complete "absence of security" at the mission.

India has been asking the UK to take action against pro-Khalistani elements operating from British soil.

## No fresh FIR against Udhayanidhi sans our nod, says apex court

New Delhi, March 6: The Supreme Court Thursday ordered no fresh FIR should be filed against Tamil Nadu Deputy Chief Minister M Udhavanidhi Stalin without its nod over his contentious "eradicate Sanatan Dharma" remarks in 2023.

Observing several complaints couldn't be filed on a single issue, a bench comprising Chief Justice Sanjiv Khanna and Justice Sanjay Kumar also extended an interim order on his exemption from personal appearance in courts hearing the existing FIRs. The bench was hearing Stalin's plea for clubbing the FIRs and transferring the complaints to one place for future proceedings.

It issued notices to the states where the fresh FIRs were lodged on his plea filed in the pending matter. "Liberty is granted to newly-added respondents (states) to file a response within 15 days from the date of service, and rejoinder if any be filed after 15 days. The interim order to continue and will equally apply to the cases mentioned in the amended writ petition. We direct no further cases be registered without the permission of this court," the bench's order said.

Senior advocate Abhishek Singhyi, appearing for Stalin. said the FIRs were registered in Patna, Jammu, Bangalore aside from Maharashtra and argued all cases could be transferred to a place where the alleged incident took place -- Tamil Nadu.



Singhvi said a fresh case was registered against Stalin in Bihar and a plea for amendment was filed seeking to implead the complainants there in the pending petition.

He referred to the apex court decisions in the case of TV anchor Arnab Goswami, Alt News co-founder Mohammad Zubair and politician Nupur Sharma and said cases arising out of one incident couldn't be allowed to continue in different places.

"In Nupur Sharma, the words are supposed to be much more offensive, this court transferred in all other cases to the first place where the FIR was first registered. That is the solution in this case," Singhvi said.

Solicitor general Tushar Mehta, appearing for Maharashtra, referred to the present case and said it was a "Sanatan Dharma Eradication Conference" where the deputy CM said Sanatana Dharma had to be eradicated like malaria, corona, dengue, etc.

"Kindly appreciate that if a chief minister of another state says similar things about a particular religion, say Islam, should be eradicated, it wouldn't be tolerated," the law officer said.

The court quashed the proceedings and FIR registered against Patil in August 2019 with the Daulatabad police in Chhatrapati Sambhaiinagar district under provisions of the Indian Penal Code and the



Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act.

complainant had claimed that Patil hurled abuses at him for his own post and defamed Dr. Ambedkar in the process. However, the

did not amount to disrespect towards Dr. Ambedkar and instead, Patil questioned the complainant's use of Ambedkar's name while not adhering to his teachings, also pointing out that contemporary attitudes have diminished respect for the leader's legacy.

The court further noted that Patil's comments were a reaction to a provocative post made by the complainant.



# ED conducts raids 'India witnesses surge in fake medicines' in money laundering case against SDPI

New Delhi, March 6: The Enforcement Directorate conducted nationwide searches Thursday as part of a money laundering investigation against the SDPI, the political outfit of the banned Popular Front of India (PFI), official sources said. The searches come after the

federal probe agency arrested Social Democratic Party of India (SDPI) national president MK Faizy March 3 at the Delhi airport. He is currently in ED custody. The searches were carried out at two locations in Delhi, including the SDPI headquarters in Nizamuddin West, Thiruvananthapuram and Malappuram in Kerala, Nandyal in Andhra Pradesh, Pakur in Jharkhand, Thane in Maharashtra, Bangalore, Chennai, Kolkata, Lucknow and Jaipur, the sources said. The ED had claimed, after the arrest of fiftyfive-year-old Faizy, that there was an "organic" relationship between the two outfits and that the PFI was carrying out its criminal activities through the political party (SDPI).

The PFI was banned by the Union government in September 2022, calling it an unlawful association and accusing it of indulging in terrorist activities. Multi-agency searches by

the ED, NIA and various state police organisations preceded

The SDPI was founded in 2009 and is also registered as a political party with the Election Commission of India. The ED told the court, while seeking Faizy's remand earlier this week, that PFI and SDPI were "organically" linked and that SDPI was nothing but the "political front" of PFI and was "funded and controlled" by the

It claimed that it had evidence to state that there was a "deep-rooted" nexus between the two organisations, as there was "overlapping" membership of their cadres, involvement of PFI office bearers in the founding of SDPI, and the utilization of each other's assets.

"SDPI is a front organisation of PFI through which PFI has been carrying out its anti-national and criminal activities, even while overtly taking a stand that PFI is a social welfare organisation," the ED had alleged. However, the SDPI denies such a link and calls itself an independent outfit. According to officials in the

investigative agencies, the organisation has a "strong" influence in various pockets of Kerala, Karnataka and some other southern states.

"Counterfeit and substandard drugs were always available in the market, but their share never exceeded 10 per cent of the total amount of medicines that is retailed. Of late, that figure

has risen sharply, to nearly 15 per cent of the total medicines available in the market. That's a hike of nearly 50 per cent and poses significant threat to public health and safety, said Sankha Roy Chowdhury, spokesperson and former president of Bengal Chemists and Druggists Association (BCDA), the state chapter of the All India Organisation of Chemists and Druggists (AIOCD).

The BCDA, arguably the country's oldest traders' organisation founded in 1921, currently has membership strength of over 40,000 drug retailers and wholesalers across Bengal, office bearers claimed.

The organisation blamed the increasing attraction among consumers as well as among drug wholesalers and retailers for hefty price discounts on medicines as the primary cause for sharp influx of adulterated medicines in the

"The government has set a cap on profit margins, 10 per cent for wholesalers and 16-20 per cent for retailers, on MRF of scheduled drugs. Anyone offering higher discounts than that should be treated with utmost suspicion. There is, however, little awareness among ordinary consumers who are easily attracted towards hefty discounts and the medicine shops are also falling for the fake drug trap to tide past the ever-increasing and uneven market competition, said Prithwi Bose, general secretary, BDCA. Officials maintained that the spike in distribution of fake medicines has been observed since the introduction of GST in July, 2017.

Calling the flourishing busi ness of injecting substandard medicines to unsuspecting patients tantamount to "committing murder", the official pointed fingers at the alleged "inadequacies" of The Drugs and Cosmetics Act, 1940, which regulates import, manufacture, distribution and sale of drugs in this country for the violations with impunity.

Officials also blamed the "slackness" in government vigilance to deter the inflow of drugs in the retail market, which fails to meet quality control standards.

Dr Narayan Banerjee, a med icine specialist, while stating that the high inflow of spurious drugs in local markets would have far-reaching adverse repercussions on public health. blamed the sharp increase in the price of life saving drugs in the country in recent times for people's allurement towards low-priced alternatives.

## 5 convicted of plotting to coup in Germany

Berlin: A German court Thursday convicted five people of plotting to overthrow the government in a far-right coup and kidnap the former health minister. The Koblenz Higher Regional Court sentenced the four ringleaders to prison sentences between five years and nine months to eight years. A fifth defendant received a sentence of two vears and 10 months. German news agency dpa reported. The defendants, four men aged 46 to 58 and a 77-yearold woman, were accused of founding or being a member of a terrorist organisation called "United Patriots" and of preparing a highly treasonous enterprise against the German government.

## Albania shuts down

TikTok for year Tirana: The Albanian Cabinet decided on Thursday to shut down TikTok for 12 months, blaming the video-sharing platform for inciting violence and bullying, especially among children. Education Minister Ogerta Manastirliu said they are in contact with TikTok on installing filters like parental control and the inclusion of the Albanian language in the application. Authorities had conducted 1,300 meetings with some 65,000 parents who "recommended and were in favour of the shut down or limiting the TikTok platform,' the minister said. The Cabinet initiated the move last year after a teen stabbed another teenager to death in November after a quarrel that started on TikTok.

# **EU rallies behind Zelenskyy**

## EU leaders pledge defence surge, support Zelenskyy after US aid freeze

Brussels, March 6: European leaders Thursday said they would stand by Ukraine and spend more on defence in a world upended by Donald Trump's reversal of US policies.

"Europe must take up this challenge, this arms race. And it must win it," Polish Prime Minister Donald Tusk said as he arrived at the summit in Brussels. "Europe as a whole is truly

capable of winning any military, financial, economic confrontation with Russia - we are simply stronger," Tusk said.

Many EU leaders hailed the European Commission's proposals this week to give them fiscal flexibility on defence spending, and to jointly borrow up to 150 billion euros (\$160 billion) to lend to EU governments to spend on their militaries.

"We are here to defend Ukraine," the chairman of the meeting Antonio Costa said as he and European Commission Chief Ursula von der Leyen, both smiling broadly, warmly welcomed Ukrainian President Volodymyr Zelenskyy, in sharp contrast with the clash between Trump and Zelenskyy in the Oval Office last week.

But decades of reliance on US protection, divergences on funding and on how France's nuclear deterrence could be used for Europe showed how difficult it would be for the EU



to fill the void left by Washington after it froze military aid to Ukraine

Washington provided more than 40% of military aid to Ukraine last year, according to NATO, some of which Europe could not easily replace. Some leaders still held out hope, in public at least, that Washington could be coaxed back into the fold.

"We must ensure, with cool and wise heads, that US support is also guaranteed in the coming months and years, because Ukraine is also dependent on their support for its defence,' Germany's outgoing Chancellor Olaf Scholz said.

## SK fighter jets accidentally drop bombs, injuring eight

Seoul, March 6: Two South Korean fighter jets accidentally dropped eight bombs on a civilian area during a joint live-fire exercise with the US military Thursday, injuring eight people, officials said. The MK-82 bombs released

by the KF-16 fighter jets fell outside a firing range, the air force said in a statement. It apologised and expressed hopes for a speedy recovery of the injured and said it would offer compensation and take other necessary steps.

The air force said the fighter jets were taking part in the oneday firing drill with the US military in Pocheon, a city close to the heavily armed border with North Korea.

The air force also said a committee would investigate the accident and examine the scale of the damage inflicted.

An unidentified air force official told local reporters that a pilot of one of the KF-16s had entered wrong coordinates for a bombing site. An unidentified Defence Ministry official told reporters that further investigation was needed to determine why the second KF-16 also dropped bombs on a civil-



In a televised briefing, Pocheon Mayor Paek Young Hyeun called the bombings "awful" and urged the military to halt drills in the city until it formulates reliable steps that can prevent a recurrence. He said that Pocheon, a city of 140,000 people, provides three major firing ranges for the South Korean and US militaries.

Park Seong-sook, a 70-yearold eyewitness who was not hurt in the bombing, said she thought "a war has broken out." "It was such a loud sound," she said, adding that it left her trembling with fear.

The military said later Thursday it has decided to suspend all live-fire drills across South Korea.

The accident came just before the South Korean and US militaries announced they will begin large-scale annual military drills next Monday.

## **Trump delays tariffs** on most goods from Mexico for a month

Washington, March 6: President Donald Trump said Thursday that he has postponed 25 per cent tariffs on most goods from Mexico for a month after a conversation with that country's president.

Trump's announcement comes after his Commerce Secretary, Howard Lutnick, said tariffs on both Canada and Mexico would "likely" be delaved.

This is the second one-month postponement Trump has announced since first unveiling the import taxes in early February. The reprieve would apply to goods that are compliant with the trade agreement Trump negotiated with Canada and Mexico in his first term.

"We are working hard, together, on the Border, both in terms of stopping Illegal Aliens from entering the United States and, likewise, stopping Fentanyl," Trump said on Truth Social.

Trump's on-again, off-again tariffs threats have roiled financial markets, lowered consumer confidence, and enveloped many businesses in an uncertain atmosphere that could delay hiring and investment.

## US killing someone by firing squad for 1ST time in 15 years

The firing squad, a method of execution with a long and complex history in the **United States, is set** to be used for the first time in 15 years in **South Carolina** 

he firing squad, a method of execution with a long and complex history in the United States, is set to be used for the first time in 15 vears in South Carolina, Brad Sigmon, convicted of murdering his ex-girlfriend's parents in 2001, will face a firing squad Friday, a method he chose over the electric chair and lethal iniection.

The history of firing squads in the US dates back to colonial times, when it was used as a punishment for mutiny. In 1608, captain George Kendall. was executed by firing squad in Jamestown, Virginia, for suspected mutiny and conspiracy with Spain. This marked the first recorded execution by shooting in America. During the Civil War, firing

squads were used by both sides to execute deserters and create a "public spectacle" to maintain discipline. According to the Associated Press, Mark Smith, a history professor at the University of South Carolina, firing squads were designed to shock and intimidate, with the added element of uncertainty, as one of the executioners would often be given a blank cartridge.

In the late 19th and early 20th centuries, Utah became the primary state to use firing squads, with at least 40 executions carried out by this method. One no-



table case was the execution of labour activist and songwriter Joe Hill in 1915. Hill, who maintained his innocence until the end, was shot by a firing squad in Utah State Prison.

However, the use of firing

squads declined as lethal in jection became the preferred method of execution in the 1980s. Lethal injection was initially seen as a more humane alternative, but it has since been plagued by botched executions

In the late 19th and early

and difficulties in obtaining the required drugs.

In recent years, however, some states have reconsidered firing squads as an alternative to lethal injection. According to Deborah Denno, a criminologist at Fordham School of Law, firing squads have been relatively reliable, with only two reported cases of botched executions. Denno has argued that firing squads may be a more humane alternative to lethal injection. as they are typically quicker and less prone to error. In South Carolina, Sigmon's

decision to choose the firing squad over other methods has sparked debate. His attorney, Gerald "Bo" King, stated that Sigmon chose the firing squad because the alternatives seemed worse. The execution will be carried out by volunteer officers, with Sigmon bound to a chair and a target placed over his heart. As the US continues to grapple with the ethics and practicalities of capital punishment, the use of firing squads raises complex questions about the nature of justice and the value of human life.

Recovering from early losses, the 30-share BSE Sensex jumped 609.86 points or 0.83 per cent to settle at 74,340.09, marking its second straight day of gains. During the day, it surged 660.57 points or 0.89 per cent to hit a high of 74,390.80.

The broader Nifty of NSE advanced 207.40 points or 0.93 per cent to

close at 22,544.70. In the session, the 50-share barometer jumped 219.15 points or 0.98 per cent to hit an intraday high of 22,556.45.

From the Sensex pack, Asian Paints, NTPC, Reliance Industries, Tata Steel, Bajaj Finserv, Hindustan Unilever, Sun Pharmaceuticals, Adani Ports & SEZ, Axis Bank, Tata Consultancy Services, Titan and Bajaj Finance were the major gainers. Tech Mahindra, Kotak Mahindra Bank, Zomato, Tata Mo-

**Zomato, Swiggy, Zepto face heat** from local retailers

New Delhi, March 6: Indian consumer products distributors have filed an antitrust case against big fast-delivery businesses of Zomato, Swiggy and Zepto, calling for an investigation into alleged deep discounting practices, legal papers show. India's e-commerce sector

has faced intense scruting over how products are priced online. An antitrust investigation last year found Amazon and Walmart's Flipkart favour select sellers and resorted to "predatory pricing" which hurts smaller retailers. The companies have denied the allegations.

Quick commerce, in which companies deliver consumer products within 10 minutes from neighbourhood warehouses, is popular with customers but has upset smaller retailers as shoppers use apps to order everything from milk to pulses. Bernstein estimates India's quick commerce sector will reach \$35 billion in 2030, from \$200 million in 2021.

The All India Consumer Products Distributors Federation (AICPDF), in a case filing with the Competition Commission of India, has asked for an investigation into many business practices of Zomato's Blinkit, Swiggy's instamart, and Zepto, including how discounts are doled out.

"An alarming trend of predatory pricing and deep discounting practices by Q-commerce platforms resulted in unfair pricing models," said the group's filing, which is not public but was reviewed by

The filing could increase headaches for Zomato and Swiggy. A separate CCI in vestigation last year found their food delivery businesses breached competition laws. The case is ongoing.

Zepto is preparing for an IPO after raising funds at a valuation of \$5 billion last year. The watchdog will review

the case filing and can order its investigation unit to look at the matter closely. This can take several months and may require companies to explain their businesses. It can dismiss the case if it finds no merit in it.

AICPDF has 400,000 distributors as members, who supply products of brands such as Nestle, Unilever and Tata to 13 million retail shops across India.

## India bought ₹1.5tn worth of Russian oil since Ukraine war

**Russia continues to be India's top oil source**

New Delhi, March 6: India, the world's third largest oil consuming and importing nation, spent 112.5 billion euro (about ₹1.5 lakh crore) on buying crude oil from Russia since the start of the Ukraine war, a European think tank said Thursday.

The Centre for Research on Energy and Clean Air (CREA) released a report on payments to Russia for fossil fuels since February 24, 2022. "According to our estimates, since the beginning of the war, Russia earned EUR 835 billion in revenue from fossil fuel exports," it said.

China was the biggest buyer of Russian fossil fuel at EUR 235 billion (made up of EUR 170 billion for oil, EUR 34.3 billion for coal and EUR 30.5 billion for gas). India, according to CREA,

bought fossil fuels worth EUR 205.84 billion from Russia from the beginning of the war until March 2, 2025. This comprised EUR 112.5 billion (\$121.59 billion) for purchase of crude oil, which is refined into fuels like petrol and diesel at refineries, and EUR 13.25 billion for coal. India, which is more than 85

per cent dependent on imports to meet its crude oil needs, spent \$232.7 billion on crude imports in 2022-23 (April 2022 to March 2023) and \$234.3 billion in 2023-24.

India, which has traditionally sourced its oil from the Middle East, began importing a large volume of oil from Russia soon after the invasion of Ukraine in February 2022. This is primarily because Russian oil was available at a significant discount to other international benchmarks due to Western sanctions and

This led to India's imports of Russian oil seeing a dramatic rise, growing from less than 1 per cent of its total crude oil imports to a staggering 40 per

two years, ship tracking data showed, as refiners in the country sought alternative supplies following tighter US sanctions on Russian producers and tankers. The US exported about 357,000 barrels per day (bpd) of crude to India, the world's third-biggest oil importer and consumer, in February, ship tracking data from Kpler showed. That compared with exports of about 221,000 bpd last year. India said last month its energy purchases from the U.S. could go up to \$25 billion in the near future from \$15 billion last year. "Indian refiners are trying to diversify their crude supplies, especially lightsweet barrels," said Rohit Rathod, a senior analyst with ship tracking firm Vortexa. "Sanctions on Russian vessels that came in recently only pushed Indian buyers to lool elsewhere," he added. About 80% of the crude exported to India was light sweet West Texas Intermediate-Midland crude, according to the data.

Lahore, March 6: New Zealand batting mainstay Kane Williamson reckons India have "real clarity" on how they want to operate in Dubai, having played all their Champions Trophy games at the same venue but his team will also be reasonably well-prepared for the tournament finale due to its limited past familiarity with conditions.

Williamson did not specifically say that India had an advantage of playing at one venue, choosing to compare it to New Zealand's understanding of conditions in Lahore, where they beat South Africa Wednesday to set up a final clash against the Rohit Sharma-led side in Dubai Sunday.

New Zealand had played two games in Lahore during the preceding tri-series involving Pakistan and South Africa.

"I suppose having played there on a number of occasions; there's real clarity in how they want to operate," said Williamson when asked if India go into the final with an advantage of knowing the conditions.

"A little bit like our opportunity here, having played a number of times at this venue as well and I think that's part and parcel in cricket," he added.

Having scored a hundred in the semifinal. Williamson is high on confidence and looking forward to the final. "It is what it is (India play all games in Dubai). Our focus is the next match, the location of that match, the opposition, they're all factors. Obviously, we played India once there," he said.

"The conditions are different, so it's important that we try and take away some of those positives and be nice and clear in how we're trying to operate come two or three-days' time in the final," he said referring to New Zealand's loss to India in the group stage. Both Williamson and Rachin Ravindra struck hundreds to fashion New Zealand's emphatic win.

Williamson called Ravindra, who has score two hundreds in three games, a special talent.

# Have consistent selection policy: Ministry tells NSFs



New Delhi, March 6: In a bid to ensure accountability and consistency, the sports ministry has made it mandatory for national federations to standardise their selection policies, notify athletes of trials at least 15 days in advance and institute a grievance redressal system to bring down litigation caused by feelings of injustice.

The instructions on selection matters come after sports minister Mansukh Mandaviya made it clear to the national federations that he wants them to avoid legal showdowns with athletes as has been seen in wrestling, shooting and some winter sports events in recent times

The circular, which is in PTI's possession, has been sent to the Indian Olympic Association, the Sports Authority of India (SAI) and the National Sports Federations (NSFs).

The new directives make it mandatory for NSFs to upload selection policies on their respective websites and amend them only if there is a threemonth window before a competition. It has also been made compulsory to videograph selection trials.

'Video recordings of the selection trials shall be forwarded to SAI along with the duly signed minutes of selection committee, while sending proposals for financial assistance." it stated in the five-page document which also makes it mandatory for NSFs to inform the ministry before every trial.

The ministry has asked NSFs to publicise the selection criteria for showpieces such as the Olympics, Paralympics, Asian Games, Para Asian Games and Commonwealth Games at least two years in advance.

This has been a long-standing demand in a sport like shooting where renowned pistol coach Jaspal Rana saying that policies which are not standardised negatively impact athletes.

Inclusion of athletes, coach es, support staff and officials in the long list of these mega-events cannot be done without intimating the Ministry and "giving the rationale and basis for names proposed".

"Details of long list will be submitted to Ministry/SAI at least 30 days before the last date for making entries in the long list."

For other international events where it being a part of the national camp would be a pre-requisite for athletes the ministry has directed that the NSFs notify them of the requirements at least three months before the commence ment of training.

In case an athlete still feels hard-done by the system, the NSFs have been directed to create a Grievance Redressal Committee or Appeal Committee to decide within seven days of a complaint. "...(the committee) shall invariably include Sportspersons of Outstanding Merit who must have retired from active sports for at least four years," it has directed.

"No member of Selection Committee shall be part of the Grievance redressal

Committee. Such proceed ings will be summary in nature following principles of natural justice. If the NSF has formed a Dispute Resolution Commission (DRC), then second appeal shall be made before the DRC.

## TT stalwart Sharath Emma struggled to breathe after seeing "fixated" man announces retirement

Chennai March 6: Indian table tennis legend A Sharath Kamal will hang up his racket and the iconic bandana later this month, having stayed at the top of his game for more than 22 years and resisting the temptation of lasting another Olympic cycle at the ripe old age of 42.

In his own words, life has come full circle for one of India's finest athletes who will say goodbye to professional table tennis in front of his friends and family in Chennai, where the WTT (World Table Tennis) Star Contender and his swansong will be staged from March

Sharath's contribution to the game goes beyond the staggering numbers, including seven gold medals at the Commonwealth Games, two path-breaking bronze medals at the Asian



Games and five appearances at the Summer Olympics.

Paris last year was easily the highlight for him as an Olympian, having received the honour of carrying India's flag at the opening ceremony.

The results did not go his way in the French capital but considering his fitness and ranking (he remains India's highest ranked player at no 42), Sharath decided to carry on for another season and take it from there. Another Commonwealth Games and Asian Games are on the horizon but Sharath has

Indian Wells, March 6: Emma Raducanu says she "couldn't see the ball through tears" and struggled to breathe after spotting a man who was "fixated" on her during a match.

The British tennis player and 2021 U.S. Open winner was left distressed during a match at last month's Dubai Championships by the presence of the man in the stand.

The man, who had already approached Raducanu earlier in the tournament, was ejected from the arena after she spoke to the chair umpire during a second-round match against Karolina Muchova. He was later detained by Dubai police and signed a document pledging to "maintain distance" from Raducanu. The WTA said he had "exhibited fixated behavior."

"I was obviously very distraught." Raducanu told British reporters at the BNP Paribas Open in Indian Wells, her first tournament since the incident.



Raducanu regrouped to play on after the man was removed from the arena but lost 7-6 6-4.

"It was a very emotional time," added Raducanu. "After the match I did break down in

tears, but not necessarily because I lost.

Raducanu told the BBC that the incident "could have been dealt with better" but that security improvements have now been made.

"I'm always now very aware and not necessarily doing things on my own any more. I'm always with someone and always being watched," Raducanu told the BBC

## At 40, football icon Chhetri comes out of international retirement

New Delhi, March 6: Indian football icon Sunil Chhetri has decided to come out of his international retirement to help the national team in the FIFA friendly assignment scheduled this month, the sport's apex body in the country said Thursday.

Chhetri returns to the team, which he led for more than a decade, aged 40.

"Sunil Chhetri is back. The captain, leader, legend will return to the Indian national team for the FIFA International Window in March," the All India Football Federation (AIFF) wrote on its official 'X' handle.

Chhetri, who made his international debut in 2005 and left the scene as India's all-time top scorer and most-capped player, has been included in coach Manolo Marquez's list of 26 players for the March FIFA

international window.

The move comes less than a vear after he announced his retirement after a glorious career, leaving a huge void that is yet to be filled.

Having played at the top level until he was 39 years of age and ending his career as one of the game's leading scorers with 94 international goals, Chhetri's departure had made headlines with FIFA, world football's global governing body, leading the outpouring of tributes for the talisman.

FIFA had earlier in 2022 released a documentary on the long-serving Indian captain.

Titled 'Captain Fantastic', it had three parts - kick off, midgame and extra time.

Chhetri is the fourth-highest goalscorer in men's football, after Cristiano Ronaldo, Lionel Messi and Ali Daei.

Chhetri had called it a day after the FIFA World Cup qual-



ifying match against Kuwait in Kolkata June 6 last year. The Blue Tigers will play a

for the opening match of the AFC Asian Cup Saudi Arabia 2027 Qualifiers Final Round against Bangladesh March 25. Marquez said, "The qualification for the Asian Cup is very crucial for us. Given the importance of the tournament and the matches ahead. I discussed with Sunil Chhetri about making a comeback to strengthen the national team. He agreed, and so we have included him in the squad.'

Since his retirement, he had continued playing for Bengaluru FC in the Indian Super League. He has so far scored 12 goals from 23 matches this season to become its highest Indian goal-scorer.

Shillong's Jawaharlal Nehru Stadium will host the Indian senior men's team's two matches that they will play during the FIFA international window this month.

India have been placed in a qualifying group alongside Bangladesh, Hong Kong, and Singapore for the Asian Cup. In the tournament's previous edition, India had a disappointing

run, failing to progress past the group stage after losing all their matches.
