British woman raped in Delhi **Stalin drops** New Delhi, March 13: A

British woman was allegedly raped and molested by two men at a hotel in Delhi's Mahipalpur, police said Thursday. Police have arrested both men and informed the British High Commission about the incident that happened March 11.

The woman travelled to India a month ago and stayed in Maharashtra. She came to Delhi March 11 to meet Kailash, 24, whom she met on Instagram recently, they said. She had booked a room new National Education Poliat a hotel and had drinks with Kailash, who allegedly raped her. Later, a 27-year-old hotel housekeeper touched her inappropriately, they added.

Tamil Nadu Chief Minister MK Stalin's populist attempt to carve out Dravidian identity on the face of what he termed 'an imposing Centre' took a fresh turn Thursday when the southern state replaced the Indian Rupee symbol (₹) with Tamil letter (^(t)) in its logo for the Budget 2025-26, which will be tabled Friday. Chennai, March 13: Intensifying the language tussle with

the Centre, the Tamil Nadu government Thursday replaced the Indian Rupee symbol with a Tamil letter in its logo for the Budget 2025-26, in an unprecedented move signalling its unrelenting stance against the three-language formula under the National Education Policy (NEP).

The move comes amidst a political firestorm over the issue after the Tamil Nadu government rejected the NEP with CM MK Stalin accusing the Centre of trying to impose Hindi on the state under it and claimed that NEP was a 'saffron policy' aimed at promoting and developing Hindi and not the nation.

The logo for the Budget, released by the government over 'Hindi imposition' via the Thursday, carried 'Ru', the first letter of the Tamil word 'Rubaai', which denotes the Indian currency in the vernacular language. TN Finance Minister Thangam Thennarasu is scheduled to

table the Budget Friday. The logo also had the caption 'everything for all', in-

dicating the ruling DMK's assurance of an inclusive governance model. The symbol change trig-

gered a political slugfest, with BJP leaders attacking the DMK, and the ruling 2024 LOGO



rule barred such a depiction. DMK MLA Ezhilan Naganathan justified the move and said there was nothing wrong with using the mother tongue.

Slamming the Stalin government's move, BJP TN chief K Annamalai asked the CM how stupid he could be to do it.

"The DMK Government's State Budget for 2025-26 replaces the Rupee Symbol designed by a Tamilian, which was adopted by the whole of Bharat and incorporated into our Currency. party members asking if any Thiru Udhay Kumar, who

designed the symbol, is the son of a former DMK MLA. How stupid can you become, Thiru @mkstalin?" he said in a social media post. Responding to Annamalai's

criticism, DMK spokesperson Saravanan Annadurai said no law opposed or stopped using 'Ru' in Tamil. "Then why such anger," Annadurai asked in a post on X.

Senior BJP leader and former state unit chief Tamilisai Soundararajan also attacked the DMK. "We feel very sorry for the attitude of the TN CM and the TN government," she said.

According to a government portal, the rupee symbol is an amalgam of Devanagari 'Ra' and the Roman Capital 'R' with two parallel horizontal stripes running at the top representing the national flag and also the 'equal to' sign.

The Indian Rupee sign was adopted by the Government of India on 15th July, 2010." it said.

The course will be offered at eight of the 16 TTIs or BEd colleges while the remaining eight will implement the programme in near future, he said.

The eight institutes inked pacts with the nearest government degree colleges to implement the Integrated Teacher Education Programme (ITEP). The agreements were signed in the presence of the minister here.

"Our goal is to strengthen the foundation and infrastructure of the colleges and to provide quality education to the students. ITEP will allow students to complete their BEd within four years after Class XII," Suraj said. Earlier, students had to complete a three-year undergraduate degree and then a two-year BEd programme, requiring a total of five years.

"However, with ITEP, students can directly enrol in the integrated programme and complete the course in four years. This initiative aligns with the NEP, 2020 and aims to strengthen the education system in the state," he said.







Bhang Journeys' Hindi version launched in City

BHUBANESWAR: The Hindi edition of Bhang Journeys, titled Ras Bhang, was launched here by Walking Bookfairs and Rajkamal Prakashan, Thursday. Authored by Walking Bookfairs co-founder Akshaya Bahibala, the Hindi version was translated by Vyalok Pathak. Orissa POST and Dharitri Editor Tathagata Satpathy graced the event as the chief speaker.

"The goal of releasing the Hindi edition is to reach a broader audience, given the vast number of Hindi-speaking people in India," remarked Bahibala. He also hinted at the possibility of an Odia translation in the future.





Illegal gun making Din in House over Polavaram unit busted in Cuttack

Cuttack, March 13: Sleuths from the Special Task Force (STF) of Bhubaneswar-Cuttack Commissionerate Police and Kolkata Police busted an illegal firearms manufacturing unit running from a thatched housethat resembled a cowshed- in a village on the outskirts of Cuttack, Thursday.

An STF official said that four persons, including the owner of the house, were taken into custody following the joint raid at the unit located in Dhulishwar village under 42 Mouza police station in the morning hours. Thirty Mausers, several gun-making equipment and labeling machines were seized from the spot, the official added.

Significantly, though the illegal unit ran not far away from the local 42 Mouza police station. and the owner of the house was previously associated with 'Mo Police' initiative, no one got a whiff of the large-scale operation until the Kolkata police obtained the intelligence while investigating a murder case in West Bengal.

The arrested accused were identified as Sarat Behera, own-

er of the house, Shamsher Alam and Mohammad Abid Hussain of Munger district in Bihar, and Mohammad Azam from West Bengal. According to the official, the three suspects from outside states had been residing at Behera's residence since early 2024 under false pretense. Equipment, including labeling machines, was transported into the premises via Sidua river embankment. The illegal gun making unit was secretly manufacturing Mausers and country-made firearms, which were then smuggled to states like West Bengal, Bihar, and Jharkhand under the cover of darkness

During interrogation, the accused learnt to have confessed to their involvement in illegal arms distribution. However, Behera claimed he had no knowledge of the factory's operations. He stated that the three accused had

hired his premises in January 2024. Though they promised to provide identification documents later, they are yet to do so. The police, however, are skeptical of his claims, as to how such a largescale operation could take place without his knowledge.

Locals revealed that the factory was well-hidden within bamboo groves and mango orchards near Sidua embankment. The suspects reportedly staved indoors during the day and operated the facility at night.

The official said the Kolkata police gathered information about the illegal unit while investigating a recent murder case where a Mauser linked to 42 Mouza area was used. Accordingly, they shared the intelligence with their Odisha counterpart and collaborated in the raid. The custody of the accused will be transferred to Kolkata police following their transit remand from a local court, he added.

Moreover, Behera's previous association with 42 Mouza 'Mo Police' initiative has further raised suspicion about his role in the operation, which is likely to be unraveled during further investigations

Bhubaneswar, March 13: The state Assembly was adjourned multiple times Thursday due to a din created by Opposition BJD over the controversial Polavaram Dam project in neighbouring Andhra Pradesh.

Congress MLAs boycotted the proceedings of the House for the second consecutive day, demanding withdrawal of the suspension order on senior member Taraprasad Bahinipati.

An all-party meeting convened by Speaker Surama Padhy to end the Congress boycott also failed to yield any result. Bahinipati was suspended Tuesday for seven days for "misconduct and unruly behaviour".

As soon as the House assembled for Question Hour, BJD members rushed to the well and staged a protest after their notice for a discussion on Polavaram issue was rejected by the Speaker.

They shouted anti-BJP slogans and accused the saffron party of sacrificing the interest

8 places record 40⁰ C

Bhubaneswar: Eight places in the state recorded a maximum temperature of 40 degrees Celsius or more Thursday, with Jharsuguda sizzling at the highest 41.4 degrees Celsius. the Met department said. Boudh followed Jharsuguda at 40.8 degrees Celsius, while Bolangir was next at 40.4 degrees Celsius, as per the evening bulletin issued by the Bhubaneswar centre of India Meteorological Department's (IMD). Hirakud, Titilagarh and Bhadrak towns recorded a maximum temperature of 40.1 degrees Celsius each. Besides, Baripada and Sambalpur registered the maximum temperature of 40 degrees Celsius each, it said. Forecasting heatwave, the weather office has issued 'yellow' warning (be aware) for the districts of Kalahandi, Bolangir, Jharsuguda, Sundargarh, Angul, Boudh, Sambalpur, Mayurbhanj, Keonjhar, and Subarnapur for Friday. Heatwave conditions are expected to continue for another three days, the Met centre said. The IMD advised people to avoid heat exposure and wear lightweight, light-coloured, loose, cotton clothes, and to cover their heads with a cloth, hat or umbrella during the peak daytime

Road mishaps claim 17,348 lives in 3 yrs

Bhubaneswar: As many 17,348 people have been killed and 31,441 others injured in road accidents in the state in the last three years, state Transport Minister Bibhuti Bhusan Jena informed the Assembly Thursday. In a written reply to a question from Biju Janata Dal (BJD) legislator Prasanta Behera, the minister submitted the detailed road accident data. As per the statistics furnished by Jena, a total of 36,030 road accidents took place in Odisha in 2022, 2023 and 2024 in which, 17,348 people were killed and 31,441 individuals injured. The number of road accidents, casualties and injured persons increased in each passing year over the last three years. While 5,467 people were killed in road accidents in 2022, the death figure increased to 5,739 in 2023 and 6,142 in 2024. Similarly, the number of people injured in road accidents also increased from 10,302 in 2022 to 10,369 in 2023 and 10,770 in 2024. The minister informed that 11,663 road accidents were reported in the state in 2022, which marginally increased to 11,992 in 2023 and further to 12,375 in 2024. In another reply in the House, the minister said that 484 road accidents took place in the state in January, 2025, when the state was observing National Road Safety Month with an investment of `1.89 crore. During the month, 505 people died and 472 got injured in road accidents.

1,859 SNAKEBITE DEATHS IN 2 YRS

Odisha reported 1,859 snakebite deaths in two years – 2023-24 and 2024-25, Revenue and Disaster Management (R&DM) Minister Suresh Pujari informed the Assembly Thursday. While snakebite claimed 1,150 lives in 2023-24, 709 people died following snakebites in 2024-25, Puja said. They also demanded formation of a House Committee to inquire into the crimes against women and formulation of a stringent law to deal with cases of violence against women. The outfit came down heavily on the BJP, accusing its MLAs of attacking Opposition party members in the House. "If an MLA is not safe inside the House, how can the government ensure the security of 4.5 crore people in the

state?" it questioned. The protesters demanded action against Parliamentary Affairs Minister Mukesh Mahaling and senior BJP MLA Jaynarayan Mishra for an "attack" on Bahinipati in Assembly Tuesday.

Bahinipati, a senior Congress MLA from Jeypore, was suspended from the House for seven days by Speaker Surama Padhy following a scuffle between the Congress and BJP members in the well of the House Tuesday.

Bahinipati was accused of unruly behaviour in the House while demanding a statement from CM Mohan Charan Majhi, who is also in charge of Home department, on "rising" violence against women across the state.

Bhubaneswar, March 13: The Crime Branch of Odisha Police Thursday arrested Biju Yuva Janata Dal state vice-president Soumya Shankar Chakra, alias Raja Chakra, in connection with an alleged multi-crore mining and transport scam. The Orissa High Court Wednesday rejected Chakra's

plea seeking interim protection from arrest. Additional DGP, CID, Crime

Branch Vinaytosh Mishra said Chakra was interrogated and asked to clarify his role in the scam and then he was arrested. The Economic Offence Wing of the Crime Branch had earli

er in February 2025 registered a case based on a complaint of alleged irregularity in the functioning of Gandhamardan Loading (GML) Agency and a transporting cooperative society limited and misappropriation of funds of the cooperative society in the mineral-rich Keonjhar district.

"In the course of the investigation, it was found that the loading agency had earned around ₹185 crore from 2017-18 to March 24. The investigation also revealed that the coopera-

tive society president and secretary, namely Manas Barik and Utkal Das, with the help of some other local influential persons had defrauded huge sums," the ADGP said, adding that though ₹34 crore was taken in the name of peripheral development, but no work was done.

Similarly, ₹9.1 crore was taken away and paid to a petrol pump, which had not supplied any fuel to GML, rather, it was supplying fuel to the vehicles of one Soumya Shankar Chakra, whose payment was being done by GML, an official note said.

The investigation also revealed that about ₹33 crore were distributed to local villagers who are supposed to be members of cooperative society. "It was further found that around ₹74 crore have been shown as loading charges and labour pavments. The corresponding muster roll and vouchers indicate a huge mismatch. It has been decided to get the period audited after which detailed defalcation would be known.

It is to further inform that the society has not conducted audit since 2012 and 2013," an official statement of the crime branch said.

It also said that though Chakra was not associated with the society on paper, he was dictating terms through his henchmen Sadashiv Samal, Sudhansu Shekhar Naik and Samir Jena. "So far, the CB has seized 42

vehicles belonging to Raja Chakra, the statement said, adding that based on financial investigation, several bank accounts have been frozen," it said.



Bike theft gang busted; 4 held

Kendrapara, March 13: Residents of Charigharia village. located inside the Bhitarkanika National Park in Kendrapara district, are reportedly planning to intensify their agitation for adequate resettlement as their decade-old struggle over the same has yielded no results

so far. At present, over 70 households in the village, which falls under Rajnagar Forest Division, are living in a perpetual state of anxiety as they



have been slapped with repeated eviction notices from the Forest department, while the district administration has started preparations for their eviction without making any resettlement arrangements, reports said.

Future indefinite, present

They demand their rehabilitation in line with relocation of Satabhaya villagers in Rajnagar block to Bagapatia. Relocation of Satabhava residents was necessitated due to coastal

erosion. "We have been fighting for relocation to Bagapatia for over a decade now. However, a recent eviction notice has heightened our concerns," Santosh Kumar Sarkar, a resident of Charigharia village. Sarkar claimed that their ancestors had been

living in the area long before Bhitarkanika was declared a national park. In the aftermath of 1971 cyclone, four families settled down in the area, giving rise to the name 'Charigharia Sahi'. At present, the number of

households has grown to over

70. The Central government declared Bhitarkanika a wildlife sanctuary in 1975, and upgraded it to a national park in 1998. According to villager Reshmi

Das, life in Charigharia has become increasingly dangerous. 'The Forest department has dug canals near the village which have become breeding grounds for crocodiles. Villagers and livestock frequently fall victim to crocodile and other wildlife attacks," Das said.

She said despite living in a forest area, strict restrictions imposed by the Forest department have hindered their traditional livelihood activities, such as firewood collection.

While many villagers are willing to relocate, they expressed frustration over the administration's alleged lack of urgency in facilitating the process.

Sukumar Das, another villager, stated that the villagers are ready to shift immediately if the government included them in the resettlement plan and provided land and financial assistance in Bagapatia. He said the villagers have staged repeated protests and hunger strikes over the demand for fair resettlement.

Meanwhile, tehsildar Amiya Kumar Swain said that the process of relocating Charigharia residents to Bagapatia is under consideration. "A total of 148 families have been identified for relocation," he said. Swain claimed that 'some individuals' are trying to claim multiple plots under the resettlement scheme.



In a 1st, Odisha exports green papaya to London, Dublin

Dhenkanal, March 13: After mangoes, the demand for Dhenkanal's green papaya is growing internationally. The fruit's unique taste and health benefits have sparked interest among consumers abroad.

A total of one tonne green papava, cultivated by 14 women farmers from the Saptasajya Agro Producer Company under Sadar block of Dhenkanal district, was exported to London last week. Similarly, green papaya harvested from Ghatipiri area of Odapada block was shipped to Dublin in Ireland, through the Madan Mohan Cooperative Society. This marks the first time that green papaya from Dhenkanal has been exported outside India.

Most of these women farmers belong to tribal communities.

The Agricultural and Processed Food Products Export Development Authority (APEDA) facilitated the export process, aiming to provide significant economic benefits to local farmers.

Previously, mangoes grown in Dhenkanal had been exported to Dubai. With rising demand for fruits like green papaya and mangoes grown in the region, there is a crucial need for cold storage facilities. Meanwhile, farmers have

urged authorities to operationalise the abandoned mango hub and the fruit and vegetable preservation centre located along the national highway in Gobindpur under Sadar block.

Dhenkanal Deputy Director of Horticulture, Gitashree Padhi, stated that green papaya from the district has been exported to London and Ireland for the first time through Saptasajya Agro Producer Company and the Madan Mohan Cooperative Society, with support from APEDA. She emphasised that such initiatives would encourage farmers and strengthen their economic standing.

Choices We Make

nice ancient times, thinkers have asked whether we freely choose what we do or if our actions are determined by forces beyond our control. That debate has been given new impetus by scientific discoveries that have advanced our understanding of the causes of our behaviour. Robert Sapolsky, a Stanford University neuroscientist and recent guest on the podcast "Lives Well Lived," which I co-host with the Polish philosopher Katarzyna de Lazari-Radek, is one of these science-based determinists.

In his book Determined: A Science of Life Without Free Will, Sapolsky argues that free will is an illusion. Consider Joe, who decides that he should eat a healthy diet. He meets a friend at a café, and the friend orders a particularly tempting slice of cake, and urges Joe to order one, too. But Joe resists. He may think he exercised his free will and deserves some credit. No, Sapolsky would say: he was able to choose not to order the cake because of his genes, or perhaps because of the way he was brought up – in any case, because of factors over which he had no control.

Because our actions are determined, Sapolsky says, we are not morally responsible for them, and do not deserve praise or blame for what we do. He deplores the fact that that all over the world, in everyday life, from courtrooms to classrooms, at award ceremonies and in eulogies, we cling, with "ferocious tenacity" to our belief in free will.

What's wrong with this argument is not the claim that everything has a cause, nor the belief that everything in the universe, including

our behaviour, is determined. We can grant that if someone knew everything there is to know about our genes and our environment, they could predict our behaviour The flaw in Sapolsky's argument, and that of many others before him, is that he fails to recognise the distinction between behaviour that results from a choice we make, and behaviour that does not.

Consider George and Mary. George develops a grudge against his neighbour, who often ignores him when they pass each other on the street. George knows that every morning the unfriendly neighbour goes to a nearby station to catch a train to work, and George decides that this creates an opportunity to get rid of him.

George follows his neighbour to the platform, waiting for an opportunity to push him in front of the train as it arrives. For several days, the neighbour stands too far back from the edge, and George cannot carry out his plan. But he persists, until one day the neighbour stands close enough to the edge for George to give him a hard push. The neighbour falls in front of the train and is killed.

Mary takes the same train to work. One morning she is rushing to catch it as it pulls in, and doesn't notice that someone has left a bag on the platform. She trips


over it, falling into the back of her neighbour, who is standing near the edge of the platform. He falls in front of the train and is killed.

It is reasonable to say that George freely chose to kill his neighbour and is morally responsible for that person's death. It is not reasonable to say that about Mary.

Would it be better if we did not think that George should be held responsible, blamed, and punished, for the death of his neighbour? Or if we somehow thought that George and Mary were equally responsible for the deaths of their neighbours?

Surely not. People everywhere make such distinctions. Sapolsky himself even notes that some animals do it. He describes a study showing that monkeys and chimpanzees respond differently to a person who is unable to give them food, as compared with someone who could give them food, but doesn't. They prefer to be close to the former.

Sapolsky's response to this is: "Heck, even chimps believe in free will." But the study doesn't show that chimps believe in the kind of free will that is incompatible with the truth of determinism. If they believe in free will at all, it is a kind that is compatible with our actions being determined, just as the difference in our responses to George and Mary are compatible with their behaviour being determined. When it comes to crime, Sapolsky rejects retributive theories of punishment, and believes that we should seek to reduce the social iniquities that make it more likely that some people will engage in anti-social behaviour. I share those attitudes. Punishment, in my view, should aim at preventing crime, rather than punishing people for their wickedness. Determinism may be true, but that does not alter the fact that people make choices, and need to be held responsible for the choices they make.

sters, the rest of the country seemed relieved that their pol itics was somehow less coarse. A quarter of a century later, it is apparent that the rot is no longer confined to a few states. Viral videos last week showed how in a village in Beed district of Maharashtra, the accused beat up a sarpanch with rods, tortured him, even urinating on his body before killing him. The horrific murder was captured on camera, almost as if the accused felt emboldened enough to show off their clout to the gazing audience. No surprise that the prime accused in a case that has shocked Maharashtra is a key aide of state minister. Dhananjay Munde. The murder took place in early December. The videos have only surfaced now, the public outcry eventually

forcing the minister to resign. A belated resignation however cannot mask the reality of just how politics has become a criminal enterprise in many parts of India. The accused in this case were reportedly running an extortion racket, demanding money from a Mumbai-based wind energy company that had invested in the region. When the courageous sarpanch tried to intervene and stop the extortion bid, he was 'eliminated'. Could the accused have acted with such impunity unless they had the patronage of the minister? Was the minister controlling them or was the gang operating as an autonomous outfit?

Let's set the context. Beed is one of the most backward re-

gions in Maharashtra and the country. A drought-prone belt of Marathwada, Beed provides approximately 70% of farm labour to the more prosperous sugar heartland of southern Maharashtra. Limited sources of income have thrown up a vicious cycle of debt and poverty from which Beed has been unable to extricate itself. Crime then becomes a lucrative option for many unemployed youth: a senior journalist from neighbouring Aurangabad tells me that Beed has witnessed many such brazen 'political' murders in the last few years.

For the last three decades, Beed's politics has been controlled by the Munde family. The family fiefdom was built by Gopinath Munde, an ambitious BJP leader with strong links to the RSS. The rugged son-ofthe-soil Munde belonged to the Vanjari community, a populous OBC grouping that was in direct competition with the more politically influential Marathas. Brother-in-law to the more urbane Pramod Mahajan, another stalwart BJP leader from Maharashtra, Munde gradually established himself as the party's mass OBC face, eventually becoming Maharashtra's deputy CM in 1995 in a BJP-Shiv Sena coalition government. He was appointed a Union minister in the first Modi government in 2014, only to die in a tragic car accident barely weeks after moving to Delhi. The BJP leader's

sudden death triggered a turf battle: his nephew Dhananjay Munde versus his daughter Pankaja. The 49-year-old nephew was once a BJP Yuva Morcha state president who resigned from the party in 2013, joined the NCP and took on his cousin Pankaja from the family bastion of Parli in Beed. Where he had begun his career in his uncle's shadow, he now found refuge in Sharad Pawar's embrace. Controversies swirled around him, including a rape complaint in 2021. With characteristic swagger, Munde claimed that he was in a relationship with the complainant's sister and had two children from her. The rape charge did not stick and Munde adroitly switched sides with Ajit Pawar in 2023 to become part of the Mahayuti government. This time, the heinous murder charge has forced Munde to resign: the prime accused in the sarpanch murder Valmik Karad has managed the minister's constituency for years and the duo reportedly share common busi-

ness interests. In a sense, Munde's case typifies the shifting nature of Maharashtra's politics. Where once the state prided itself on its reformist zeal, its politics is now defined by a totally immoral 'power at all costs' ecosystem. Cash, crime and corruption under the veil of caste and communal identity politics have created a toxic mix, one where there is total ideological

bankruptcy and only a desire for self-aggrandisement. Where Gopinath Munde came through the Sangh Parivar womb and remained committed to the party, his nephew, like many contemporary Maharashtra politicians, has benefitted from the opportunistic politics of splits and defections that has wrecked the state's party system. Is it any surprise then that those associated with Dhananjay actually thought that they could get away with a murder on camera? After all, when political compromise and depravity is the name of the game. who will draw the red lines of acceptable behaviour?

Which is why the 'Maha-crime' in Beed must become another wakeup call that Maharashtra and indeed the country so desperately needs. A 'Magnetic Maharashtra' or a 'Viksit Bharat' can hardly be built on the edifice of lumpenised politics. Sadly, the media cheerleaders are so carried away with well-spun slogans that the grime that lies beneath the glitter of a '5 trillion economy' is barely noticeable. Like Beed, there are many other corners of India where local mafia and their political bosses still call the shots. Which is why instead of


holding fancy investment summits in five star hotels, maybe our governments should first hold law and order meetings in every district headquarters where an unambiguous message is delivered that there will be zero tolerance for law-breakers, irrespective of their political influence.

Post-script: On a morning walk along Mumbai's Marine Drive, I met a retired IAS officer who said he wasn't surprised with what had transpired in Beed. "The chickens have come home to roost. Earlier, politicians flirted with criminals, now the criminals have simply taken over politics!'

Global institutions that were introduced to play the role of Big Brother are increasingly becoming irrelevant due to political instability worldwide. The sovereign identity of countries is compromised due to pressure from powerful countries, putting the whole world's harmonious coexistence in question. The ongoing geopolitical conflicts in Ukraine, the Middle East. Bangladesh. Taiwan, Israel, and other regions have put the world in a fragile and fractured diplomatic situation. Multilateral or bilateral treaties are becoming weak, making the international peace climate volatile. So-called leading countries, such as the US, Chi-

However, the question is whether our leaders really want it or whether it is just an optic of peace-building or showcasing of power, overlooking the true ambition of peace-building in mind.

According to the legends, she ate nothing, her only nourishment being the food of the spirit, for she was transported by angels seven times a day into heaven where she heard, with her bodily ears, the delightful harmonies of the celestial choirs.

The SpaDeX mission was launched December 30 last year when the Indian Space Research Organisation (ISRO) placed in orbit two satellites --SDX01 and SDX02 -- to demonstrate the docking experiment in space.

After several attempts, the space agency successfully docked the two satellites Januarv 16



Later in a statement, ISRO said that after the undocking, it has planned further experiments with satellites.

"The SPADEX satellites were successfully docked 16 January 2025. ISRO has now accomplished the pivotal operation of undocking of SPA-DEX satellites in the very first attempt on 13th March, 2025 at 09:20 Hrs (ISD)," ISRO said in a statement.

The undocking of the satellites took place in 460 km

circular orbit with 45-degree inclination, the space agency explained.

It added that the satellites are now orbiting independently and their health is normal.

With this, ISRO has now successfully demonstrated all the capabilities required for rendezvous, docking and undocking operations in a circular orbit.

ISRO said the in-orbit performance of the docked satellites was extensively analysed and

an immediate opportunity was found to be feasible from March 10 2025 till March 25 2025 The entire operations were monitored through ground stations located at Bangalore, Lucknow and Mauritius.

"Having accomplished this major mile stone of undocking, further experiments with satellites are planned in the coming days," ISRO said.

According to the space agency, exhaustive ground simulations and analysis were the cornerstone of achieving the undocking in the first attempt itself. Various tests replicating on-orbit conditions were meticulously planned and carried out in preparation for the earliest opportunity for undocking operations.

ISRO said it has now successfully demonstrated space docking technology using two small satellites and termed it as a cost-effective experiment.

Agents paid ₹4-5K for trafficking Bangladeshi girls into India: ED

Bureau (ACB) of the Delhi government, the complainants alleged that there was a scam worth over ₹2,000 crore in the construction of classrooms and school buildings in Delhi. The work was done at a highly inflated cost by the Delhi government. The alleged scam involves the construction of

The ACB report said the total expenditure incurred for constructing the classrooms and school buildings was around ₹2,892.65 crore. They were allegedly constructed at the rate of ₹8.800 per square feet, whereas it was common knowledge that the average construction cost (even for a builder of flats) was around ₹1,500 per square feet. The total cost for constructing a classroom and school building, according to the tender awarded, was allegedly around ₹24.86 lakh per room, whereas such rooms are easily constructed in Delhi at around ₹5 lakh per room, it said. The prices were increased almost five times to defraud the taxpayer by siphoning off money from the public exchequer in the garb of construction cost, the report said.

New Delhi, March 13: A sum of ₹4,000-5,000 per person was being paid by Hyderabad-based flesh trade operators to agents based along the India-Bangladesh inter national border in West Bengal for trafficking Bangladeshi girls into the country, according to an ED investigation.

The money laundering probe stems from a Telangana Police FIR, a case re-registered by the National Investigation Agency (NIA), against a flesh trade and prostitution racket being run by two brothels located on the outskirts of the city. The En forcement Directorate said in a statement Thursday that it has provisionally attached assets worth ₹1.90 lakh as part of this investigation and this includes funds kept in "Paytm wallets and bank accounts" as well as an immovable property of a man named Ruhul Amin Dhali, one of the "most prominent" agents involved in the illegal trafficking of Bangladeshi girls into India. The accused, according to the ED, were running brothels at various places in and around Hy derabad and they also sent the victim girls to other brothels and agents, on a commission basis. They used "fake and forged" Indian identity documents and opened several bank accounts and online wallets for their illegal activities, the federal probe agency said.

New Delhi, March 13: Voicing concern over poor utilisation of funds, a parliamentary panel has said the Department of Water Resource, River Development and Ganga Rejuvenation, utilised only around 58 per cent of the revised allocation of ₹21,640.88 crore for 2024-25 by the end of December 2024.

The panel urged the Jal Shakti Ministry to strengthen monitoring and implementation mechanisms. In its report tabled in Parliament, the Standing Committee on Water Resources said nearly 40 per cent of the allocated funds remained unspent and highlighted delays in fund disbursal and project execution

The ministry has attributed the low spending to the fact that



Over 11,300 habitations in 96 districts hit by water contamination

A parliamentary panel has raised concerns over water contamination issue in the ountry, highlighting that 11,348 habitations in 96 districts across seven states have not been provided with short-term measures for pollutants such as iron, nitrate, and heavy metals. In its report tabled in Parliament on Tuesday, the Standing Committee on Water Resources has urged the Centre to take swift action to ensure safe drinking water in these vulnerable regions. The report further revealed that uranium contamination remains a pressing issue in Punjab, where 32 habitations across nine districts are affected. Despite interim measures in 22 of these areas, 10 habitations still await any mitigation efforts, it said. The committee has called for urgent and long-term interventions to safeguard public health. "The Committee notes that all arsenic and fluoride affected habitations have been covered by community water purification plants as an interim measure. However, they (panel) further observe that there are 11.348 quality affected habitations (iron, salinity, nitrate, and heavy metals) spread over 96 districts of seven states where short-term measures have not been provided," the report said.

When a train was halted for Holi and Haj pilgrims

New Delhi, March 13: It was Holi of 1999, the very day Haj for refusing Holi colours

pilgrims were to take a train from Uttar Pradesh's communally sensitive town of Mau to Delhi. The situation was fraught - till the administration imposed prohibitory orders to temporarily stop the train so the pilgrims in white didn't come face to face with the drenched in colour revellers.

Twenty-six years later, it is another Holi and another coincidence. The festival falls on a Friday during Ramzan and

the administration in various states, particularly in Sambhal in Uttar Pradesh, is on its toes to ensure 'jumma' prayers and Holi pass off peacefully.

That spring of 1999 and the predicament of the authorities in Mau has been recalled in detail in former Uttar Pradesh director general of police (DGP) OP Singh's book "Through My Eyes: Sketches from a Cop's Notebook"

The authorities in Mau served the prohibitory order on loco pilot (train driver) after the Railways refused a request from the authorities to delay the afternoon train by a few hours till Holi festivities end, he writes.

"It was the first time in India's history that an order under section 144 of the Criminal Procedure Code (CrPC), a law typically used to prohibit unlawful assemblies and prevent disturbances, was invoked not to control a mob, but to stop a moving train,' the former state police chief says in the chapter titled



"The Train under 144 CrPC". The former DGP says that Mau, a region known for its rich yet delicate communal fabric, had found itself at the heart of an unprecedented administrative decision in 1999.

"A seemingly routine train schedule had the potential to disrupt peace, but an extraordinary step ensured that harmony prevailed."

That particular year, he recounts, Holi coincided with the

departure of a sizable population of Haj pilgrims who were scheduled to board a train from Mau to Delhi, their first stop before flying to Mecca.

'The train was scheduled to arrive at noon, exactly when Holi celebrations would be at their peak. Streets would be filled with revelers throwing coloured powders and water, the air thick with the scent of festive sweets and burning pyres of Holika

Dahan from the previous night," the officer writes.

The Muslim pilgrims, the chapter says, dressed in white clothes and symbolizing purity and devotion, would have had no way of passing through without being inadvertently caught in the revelry and the district administration foresaw the problem.

Sensing that any "unintentional provocation" may "ignite tempers" in the district that had a history of communal skirmishes, the authorities sought the help of the Railway authorities "with a simple request: delay the train by a few hours"

The country's largest public transporter refused, stating that train schedules could not be altered for local events, no matter how sensitive the situation was and that "operational punctuality" was foremost for the Railways.

"Faced with an inflexible railway system and the looming risk of communal discord, the district administration took a bold and unprecedented step.' "The prohibitory order was

served directly to the train driver, legally preventing the train from proceeding beyond a designated railway station in a neighboring district," the former DGP says.

Police and other government authorities were deployed alongside the train that, as per Singh, remained "stationary for a few hours", not due to technical failure or scheduling delays, but by the sheer force of law.'

The Holi celebrations "died down slowly" and the pilgrims boarded the train without disturbance, their white robes unstained, their hearts set on their spiritual voyage, he writes.

While the decision to delay the train was "extraordinary and controversial, it demon strated a profound understanding of ground realities an acknowledgment that sometimes, rules must bend to uphold peace and coexistence", Singh says.



Armenia, Azerbaijan agree to end nearly 40 years of conflict

Tbilisi, March 13: Armenian and Azerbaijani officials said Thursday that they had agreed the text of a peace agreement to end nearly four decades of conflict between the South Caucasus countries, a sudden breakthrough in a fitful and often bitter peace process.

The two post-Soviet countries have fought a series of wars since the late 1980s when Nagorno-Karabakh, a region in Azerbaijan that had a mostly ethnic-Armenian population at the time, broke away from Azerbaijan with support from

Armenia Armenia's Foreign Ministry said in a statement Thursday that a draft peace agreement with Azerbaijan had been finalised from its side.

"The peace agreement is ready for signing. The Republic of Armenia is ready to start consultations with the Republic of Azerbaijan on the date and place of signing the agreement. In its statement, Azerbaijan's Foreign Ministry said: "We note with satisfaction that the negotiations on the text of the draft Agreement on Peace and the Establishment of Interstate Relations between Azerbaijan and Armenia have been concluded.' However, the timeline for

signing the deal is uncertain as Azerbaijan has said a prerequisite for its signature is a change to Armenia's constitution, which it says makes implicit claims to its territory.

Armenia denies such claims, but Prime Minister Nikol Pashinvan has said repeatedly in recent months that the country's founding document needs to be replaced and has called for a referendum to do so. No date has been set.

Russia's TASS state news agency cited Pashinyan as telling journalists Thursday that the agreement would prevent personnel from third countries deploying along the Ar-

menia-Azerbaijan border. That provision would likely cover a European Union civilian monitoring mission that Baku has criticised, as well as Russian border guards who police parts of Armenia's frontiers.

The outbreak of hostilities in the late 1980s prompted mass expulsions of hundreds of thousands of mostly Muslim Azeris from Armenia and Armenians. who are majority Christian, from Azerbaijan.

London, March 13: British Prime Minister Keir Starmer Thursday declared a war on red tape and bureaucracy, announcing the abolition of an "arms-length body" that manages the taxpayer-funded National Health Service (NHE) among some efficiency measures in his mission to "reshape" government.

In a major policy speech during a visit to Hull in northern England, Starmer said the NHS England will be phased out to bring the country's health service entirely under "democratic control" of the



government. NHS England is a quango, which stands for quasi autonomous non-governmental organisation, and stands to lose around 10,000 roles as the organisation is scrapped.



Tata began construction of

the new factory, which will also assemble vehicles other than EVs, in September. The plant is slated to produce over 250,000 cars a year when it reaches full capacity in about 5-7 years.

The shelved plans called for JLR to manufacture more than 70,000 electric cars there and Tata's EV unit to build 25.000. the sources said.

Tata said in a statement to Reuters that the production timelines and choice of models to be built at the new factory in the state of Tamil Nadu will be aligned with Tata and JLR's broader strategy and market requirements.

Tata, the biggest seller in India's nascent EV market, faces growing pressure from rivals like JSW MG Motor and Mahindra and Mahindra which have launched new, feature-rich models with longer driving ranges.

Tesla is also finalising plans to launch EVs in India, which is the world's third-largest car market with 4 million vehicles sold annually. EV sales currently account for about 2% of total car sales.

Tata's EV unit had planned to firm up orders with some suppliers by the end of January but is now making changes to its designs as the economics of its plan are not working without JLR, sources said

Tata in January pushed back the launch of its Avinya EV to 2026-2027 from an earlier plan for this year. It was not immediately clear if the current situation will cause further delays.

New Delhi, Mar 13: Threetime Paralympic champion long jumper Vanessa Low of Australia lived up to her top billing as she easily clinched gold in T61-64 class while India's Paris Games medallist Preethi Pal bagged a bronze in T35-38 class 200m race on the concluding day of the World Para Athletics Grand Prix here Thursday.

India finished on top of the medal tally with a total haul of 134 -- 45 gold, 40 silver, and 49 bronze. Around 150 Indians had competed in the Grand Prix while around 100 were from other 19 countries.

Vanessa, one of the few top stars taking part in the threeday event. cleared a distance of 4.96m in her third attempt, to stand on the top of the podium.

Zhanna Fekolina, a Neutral Paralympic Athlete, and India's Bhavani Munniyandi took home the silver and bronze respectively with efforts of 4.13m and 3.51m at the Jawaharlal Nehru Stadium here.

T61-64 classification is for those athletes who are competing with prosthesis affected by limb deficiency and leg length difference.

"I am happy with my performance. It's fun moments here in India. I will be coming back here for the World Para Athletics Championships (in September)," Vanessa said after the event. She also said she will take part in the 2026 edition of the event.

India has signed a four-year contract with the World Para Athletics to host the Grand Prix annually till 2028. Meanwhile, the 24-year-old Preethi, who had earlier secured a silver

PCB revises match fees after flak Wolff says he's not looking to sign Verstappen

Karachi, March 13: The Pakistan Cricket Board (PCB) Thursday increased the players' match fee for the National T20 Championship after its decision to enforce a pay cut faced severe backlash.

The PCB had earlier reduced the match fees to Rs 10,000 and Rs 5,000 for players and reserves, forcing its chairman Mohsin Naqvi to issue orders to review the decision.

Finding itself in a corner after widespread criticism, PCB has now increased the match fees of players to Rs 40,000 and reserves to Rs 20,000.

Pakistan's domestic cricket schedule and structure has



been under discussion this season after the board abruptly stopped the National Under-19 Championship after just one day's play. The decision to reduce the

match fees was earlier taken on the orders of Naqvi after complaints of selection of over-age players and other issues.

Interestingly, the National junior event, which is seen as the best platform for new talent, has

still not been held this season. There have also been reports of the domestic department cutting facilities for players in domestic cricket like termination of contracts and lowering hotel and travelling standards.

PCB sources claim that the expense cuts have been executed because of the increased domestic cricket events this season which were earlier not included in the budget.

replacement for its then-outgoing star Lewis Hamilton, Silver Arrows' team boss Wolff says extending Russell's contract beyond 2025 is the priority.

"I think we've said it pretty clearly last year, and (Verstappen) said the same, we need to concentrate on our driver line-up, we need to do (the best with) that we have," Wolff said



Thursday in Melbourne.

"I don't flirt outside if I'm in a good relationship, and that is true for this year, too. So, at the moment that is not on any, let's say, radar and I don't plan to shift my concentration away from these guys and make sure that George has a contract (extension) pretty soon and we agree on the final things.

Plenty of decisions to come-Wolff's future driver lineup came into focus this week af ter McLaren extended its deal with Australian Oscar Piastri which puts him out of reach during the sport's next big expected grid shuffle in 2027.

"We have had a chat (with Russell) a few weeks ago about what the right timing would be to liaise, and I'm — naively or not — someone that sticks to what he says," Wolff said.

"These three (including re serve driver Valtteri Bottas) are the combination that want to go forward with Mercedes, and I have no reasons to doubt that. We're going to find some time, I guess, before the summer.'
