Wildfire claims woman's life

Kamakhyanagar: A woman was burnt alive while trying to put out a raging forest fire at Gobari village on the fringes of a forest under Kankadahada block and Mahabirod police limits in Dhenkanal district Monday. The deceased was identified as Budhuni Mohanta. According to sources, the fire broke out in a nearby forest for unknown reasons and quickly spread to the surrounding areas. As the flames approached her house, Budhuni tried to douse the inferno by climbing onto a canal embankment and using water from her home and a stick. However, she lost her footing and fell into the raging fire. Cops from Mahabirod police station reached the spot and began a probe.

2,603 villages lack mobile connectivity

Bhubaneswar: A total of 2,603 villages in 167 blocks of Odisha do not have any mobile network, while 10 panchayats lack broadband connectivity, **Electronics & Information** Technology Minister Mukesh Mahaling informed the Assembly Monday. He said 375 villages in Kandhamal district have no mobile network, followed by Rayagada (274), Gajapati (241), Koraput (223), Malkangiri (216), Kalahandi (203) and Nayagarh (184). Blue dragons swarm Puri coast RATAN KUMAR PRADHAN, OP among locals, climatologists tiful but potentially painful have attributed it to a fall-

Bhubaneswar, March 17: Its bright blue underbelly on a slippery silvery-gray back is quite inviting. But looks can be deceptive. Any attempt to touch the blue dragon, a tiny insect-like sea slug seen crowding the beaches at Puri, Astaranga and Konark these days, may leave the curious onlooker with an unpleasant experience. Because, its sting can cause a host of emergencies - from nausea, pain, vomiting, acute allergic contact dermatitis to post-inflammatory hyperpigmentation.

Though the phenomenon of a large number of these deep sea residents sweeping to the coasts in Puri district has generated curiosity dia YuWaah Advocate 2022-24

This year too summer marked their arrival in Puri coast. This is due to rising ocean temperatures which is harming marine life."

He said the phenomenon is a matter of serious concern. "Climate change is disrupting the ocean's balance, which is critical for humans since most of Earth







CM: Over 20K people missing in 9 months

Bhubaneswar, March 17: As many as 20,060 missing person cases were registered across the state between June 2024 and February 2025, Chief Minister Mohan Charan Majhi informed the Assembly Monday.

In a written reply to a query by Congress MLA Sofia Firdous, Majhi, who holds the Home portfolio, said of the total cases, 7,048 people were traced, while 13,012 remain untraced.

The BJP came to power in the state June 12, 2024

Informing the reasons for the delay in resolving the pending cases, Majhi cited several challenges. He said missing reports are often delayed by relatives due to social stigma, ignorance

Many people leave the state for work without informing their families, leading to false missing reports, he added.

"A significant number of cases involve minor girls eloping, where they evade police notice due to fear of criminal prosecution against their partners. In several cases, families and informants hesitate to disclose

complete information to police, leading to delays in investigations," he added.

The CM said while the Minis try of Women and Child Development had launched the Misreunite missing children with their families, its effectiveness is hindered by the failure of Child Welfare Committees (CWCs) and Child Care Institutions (CCIs) to upload relevant data.

The Chief Minister stressed the need to integrate facial recognition software into the portal, which could help in identifying and reuniting children with their parents.

He added that steps were being taken to fill vacancies in the Integrated Anti-Human Trafficking Unit (IAHTU), Special Juvenile Police Unit (SJPU), and police stations to improve response times in missing person cases. The CM said the government has also proposed financial allocations to enhance rescue operations.

"A total of ₹ 3.24 crore has been set aside to strengthen SJPUs by hiring vehicles with drivers for transporting rescued children back to their families.

been allocated for Investigative Units on Crimes Against Women (IUCAW) in 29 districts for similar purposes," he said.

The government has proposed providing ₹19.47 crore to Mahila (women) and Sishu (children) desks of all 649 police stations to cover food and other expenses related to the rescue of the missing women and children.

"Each desk will receive ₹25,000 per month to cover expenses such as food and other necessities for rescued women and children," he added.

In a separate written reply, Majhi said 1,35,074 cases were registered across various police stations over the last eight months, with the highest number of cases recorded in Ganjam district. He assured that the law and order situation remains under control and reaffirmed the government's commitment to maintaining peace

"Whenever any law and order situation arises, police immediately intervene and take necessary action against the accused as per law." Maihi added.



CLIMATE CHANGE MITIGATION

Local involvement crucial for success: Satpathy

Bhubaneswar, March 17: Local involvement is crucial for long-term success of both environmental and community welfare, said Adyasha Satpathy, Chief Executive of Dharitri and Orissa POST.

Attending a panel session at a conference on 'Learnings for Climate Change Mitigation and Adaptation from Tribal Communities' at the Regional Museum of Natural History here Monday, Satpathy said many conservation efforts often fail as they don't involve local communities. She cited the example eco-friendly approach of beekeeping by tribals - which not only helps them generate income but also keeps elephants at bay by utilizing the giants' natural fears to reduce human-elephant conflicts and support local communities by deterring el-

ephants from crop raids. At the panel discussion titled 'addressing the challenges of balancing growth goals with conservation needs using tips from indigenous peoples practices', Satpathy also pointed out the issue of inconsistent policy implementation due to changing officers, and urged the youth to stay connected with their communities.

Addressing the conference, Padma Shri Jamuna Tudu of Jharkhand, also known as the Lady Tarzan of India, shared her perspective on the sacred relationship between humans and nature, and urged everyone to protect forests. She likened trees and jungles to deities, asserting that they provide life, peace, and fulfillment if cared for genuinely. In his address, Australian

Consul General in Kolkata and the chief guest on the occasion, Hugh Boylen, expressed pride in being associated with the project, recognizing indigenous communities as a valuable source of biodiversity knowledge that could significantly contribute to addressing climate change. The event was organized by FORCE Trust as part of the Australian Aid-supported project, "Voices of the Earth - Youth and Indigenous Wisdom in Climate Action."

Conditional bail for Hanshita, Anil

Cuttack, March 17: The Orissa High Court Monday granted conditional bail to Hanshita Abhilipsa and her husband Anil Mohanty, who were arrested in connection with a case of impersonation of government officials and cheating.

Justice RK Pattanaik allowed their release upon furnishing bail bonds of ₹50,000 each with one solvent surety of the like amount. The court, while granting bail, noted that a prima facie case was made against the duo for impersonating influential government officials.

The case was initiated following an intimation from the Kalinga Institute of Social Sciences (KISS), which raised suspicion over the couple's claims during a visit. Investigation revealed that Hanshita had 'morphed' photographs with top bureaucrats to establish false credentials.

Hanshita was also found to have a 'past criminal record' and allegedly concealed her identity while obtaining a passport.

Mortal remains of Ramakanta Rath consigned to flames

Bhubaneswar, March 17: The mortal remains of renowned Odia poet and former bureaucrat Ramakanta Rath were consigned to flames at Swargadwar in Puri

Rath's son Pinaki lit the funeral pyre after the Odisha Police accorded full state honours to the poet, who was a recipient of Padma Bhushan. Earlier in the day, Chief Minis-

ter Mohan Charan Majhi visited Rath's residence in the City and paid floral tributes to the poet. Rath breathed his last Sunday. He was 90.

Majhi, who returned to the state capital from a visit to Delhi Sunday night, reached Rath's residence in the City Monday morning and offered floral tributes. Deputy Chief Minister Pravati Parida and Culture Minister Suryabanshi Suraj also paid tributes to Rath.

"The state has lost a great son of the soil. Poet Ramakanta Rath was a frontline writer of modern



Odia literature. He was also an able administrator and took the responsibilities as chief secretary from 1990 to 1992," Majhi said, adding that Rath's 'Sri Radha' poetry would remain a classic in Odia literature.

In his condolence message, Leader of Opposition and BJD president Naveen Patnaik said, 'I am saddened to learn about the demise of the renowned poet and literary figure Ramakanta Rath. He has made a valuable contribution to enriching modern Odia literature. He will remain immortal in the hearts of readers for his unique style of writing. At this time. 

proposal to establish a ₹306.50-crore data centre in Khurda, which is expected to provide jobs to 90 people, also got the approval. Sapigen Biologix Private Limited will

set up a ₹854.32 crore vaccine manufacturing unit at Odisha Biotech Park in Khurda, while ARCL Organics Limited will establish a ₹500-crore specialty chemicals manufacturing unit in Jagatsinghpur. Both the facilities are expected to provide jobs to a total of 1.575 individuals. Healthcare crisis at Bargarh DHH Another drainage pipe

A 50-bed critical care centre inaugurated virtually by Prime Minister Narendra Modi last October remains non-functional, triggering public dissatisfaction

Bargarh, March 17: Healthcare services at the newly constructed Bargarh District Headquarters Hospital (DHH), relocated to Khedapali (Tukurla), about 4 kilometre away from the town, has been severely hit on account of acute shortage of doctors and lack of essential chemicals for various pathological tests.

As a result, despite promises of modern and improved medical facilities, patients at the hospital are struggling to access even basic healthcare services, reports said.

According to reports, a major concern at the hospital is the acute shortage of doctors and healthcare personnel, including the absence of an Orthopaedic specialist. Essential diagnostic tests such as blood and urine examinations are hindered by a lack of essential chemicals, forcing patients to seek these services at private clinics at inflated prices, increasing their financial burden. Similarly, services like



ultrasound, dialysis, and X-rays are either unavailable or inconsistent, leaving patients in distress, reports added.

Additionally, sources said, a 50-bed critical care centre inaugurated virtually by Prime Minister Narendra Modi last October remains non-functional, triggering public dissatis-

The DHH was previously located in the town, but a few years ago it was moved to Khedapali along the Bargarh-Bhatli road where a new seven-storeyed hospital building was constructed. At that time, medical equipment from the old hospital were transferred to the new facility, and authorities assured residents that the relocation would result in improved healthcare services. However, the transition

has only led to new challenges.

Both the old and new hospitals now suffer from staff shortage. Patients arriving at the old hospital are referred to the new facility, only to be redirected again to VIMSAR in Burla due to the unavailability of essential services. This cycle of patient displacement has become a daily occurrence, leading to unnecessary hardships and, in some cases, fatalities, "Many are forced to turn to private hospitals, incurring significant

expenses," sources added. Although the new DHH is equipped with infrastructure such as lifts, only one of the seven available lifts is operational. It is also alleged that the hospital has a mortuary, but its freezer has remained non-functional for a long time, causing bodies to decompose, leading to complaints of foul odour.

The ultrasound department has a single technician, and when he takes leave, services come to a halt. Recently, a pregnant woman brought in by the Padampur police for an ultrasound examination had to be turned away as the facility was closed, sources said.

Power supply issues further complicate hospital operations. Frequent electricity outages and a non-functional generator have forced doctors to conduct treatments using torchlights. Diagnostic procedures such as ultrasound and X-rays come to a standstill during prolonged power cuts.

Despite the presence of a 100-bed cancer hospital and a 50-bed critical care unit within the premises, both facilities remain underutilised due to similar issues

Local intelligentsia Vikash Agrawal noted that the hospital serves not only Bargarh but also neighbouring districts like Bolangir, Subarnapur and even parts of Chhattisgarh, He expressed disappointment that despite the ongoing issues, no concrete measure has been initiated to resolve them, allowing private hospitals to capitalise on the situation at the expense of poor patients.

Joda, March 17: Yet another large drainage pipe fell from Odisha's longest flyover in Joda town of Keonjhar district Saturday afternoon. Fortunately, owing to reduced traffic during the Holi holiday, no one was injured and a major accident was averted.

This is not the first time that such an incident has occurred. Previously, a pipe had fallen from the flyover injuring a passer-by. The repeated structural failures arising from the substandard construction of the flyover have sparked growing dissatisfaction among the local

Eyewitness Manas Das said the pipe fell with a loud noise at around 1pm. Over the past year, the flyover has experienced multiple structural failures, including falling pipes, large cement chunks breaking off, exposed iron rods, and visible

Despite these issues, neither the district administration and Odisha Bridge & Construction Corporation (OBCC), nor the consultancy agency Chevrox Constructions Pvt Ltd has taken any serious corrective measures. Instead, only superficial repairs have been carried out, raising concerns about the structure's

nymity, claimed that high-qual-

long-term stability.

Local BJP leader Ranjit Mahakur has demanded an investigation into the alleged construction flaws and irregularities. Youth activists Jagannath Panigrahi, Sameer Das, Ramesh Chandra Mohapatra, and Kamakshya Patra also voiced concerns, attributing the failures to low-quality pipes and faulty clamps that cannot withstand vibrations.

Additionally, the flyover has developed cracks, and large cement chunks continue to fall putting commuters at risk. A consultancy agency official, speaking on condition of anoity materials were initially ap proved by OBCC.

However, after approval, an official of the agency had allegedly replaced them with substandard materials with out further inspection, leading to repeated failures.

Earlier, a drainage pipe fell from Pillar No. 55, hitting motorcyclist Badri Narayan Kar as he was on his way to a bank February 16, 2025.

Experts are calling for an investigation by a high-level committee to uncover potential financial mismanagement in the flyover's construction.

Kabisuryanagar, March 17: S Lakshmi Sethi, chairperson of Kabisurvanagar Notified Area Council (NAC) in Ganjam district, lost her position following a no-confidence motion held Monday. Prior to the vote Monday, she submitted her resignation letter to the NAC's executive officer. However, since the resignation had not been officially accepted, the vote proceeded under the directive of the District Collector, with Chhatrapur Sub-Collector Subashis Baral overseeing the process.

Earlier in the day, 16 councilors gathered at the residence of former vice chairperson Kumud Sahu for a meeting before heading to the Maa Mahamaya temple. There they pledged to work collectively for the development of the NAC after lighting a lamp before the deity. Later, they proceeded to the NAC office and all 16 councilors voted in favor of the no-confidence motion, leading to Sethi's removal from office. According to the sub-collector, a total of 16 councilors participated in the voting process, while one councilor each from BJP and BJD remained absent. Meanwhile, Sethi cited mental stress, disappointment, and distress as reasons for her resignation.



Panic as Royal Bengal Tiger spotted in Madhapur forest

Boudh, March 17: A Royal Bengal Tiger has reportedly been roaming in the Madhapur forest range of Harabhanga block in Boudh district since Sunday, sparking fear and panic among local residents.

According to reports, an earthmover machine was excavating a pond near Petini Taila forest close to Baring village Sunday evening, when the tiger was first spotted. The terrified operator of the machine managed to capture a distant photograph of the tiger and shared it on social media. As the image went viral, fear spread among the local community.

However, the Madhapur forest range and Mahanadi wildlife range authorities had earlier reported zero tiger population in the region during a recent wildlife census. The unexpected sighting of the tiger has now raised serious questions about

the accuracy of the census data provided by the Forest department.

Meanwhile, reports suggest that forest fires in different parts of the Madhapur range may be forcing wild animals to stray towards human settlements. Notably, the carcass of a tiger had been found near the Kuchuda-Lengerpaju road in the protected Podhahola forest under the same range September 25, 2024.

When questioned about the recent sighting, Madhapur Ranger Ashish Kumar Digal denied the development dismissing the excavator operator's claims. However, with photographic evidence circulating online, his statement contradicts public reports.

Wildlife experts and local intelligentsia are now demanding a high-level investigation to verify the presence of the Royal Bengal Tiger and ensure transparency in future wildlife censuses

Economic Pain

vive years ago, the world economy was hit hard by the CoVID-19 pandemic which brought life in almost all countries to a grinding halt. After reeling under its impact for about two years, most economies recovered to a great extent. However, in case of India, the economic recovery was K-shaped, a situation characterised by stagnant consumer spending for the vast majority and rising wealth for a select few. It is definitely worrying that this pattern of growth has only intensified over the last few quarters.

The middle class, once a formidable force in the Indian economy, has been nearly wiped out by virtue of the double whammy of stagnant wages and spiralling inflation. The declining sales of two-wheelers and entry-level cars underscore the financial struggles faced by millions of families in the country. The household savings rate in India is already at a five-decade low. At the same time, there has been a significant increase in household debt which has grown from 36.6 per cent of the gross domestic product (GDP) in June 2021 to 41 per cent in March 2024, according to the recent Financial Stability Report (2024) of the Reserve Bank of India (RBI). Not only that, the proportion of loans used for consumption purpose has risen over the years implying that households are primarily borrowing for consumption rather than for acquiring assets like homes or vehicles or

Similarly, India has experienced an unprecedented increase in loans secured by gold jewellery, reflecting the financial struggles faced by many households. The combination of slowing economic growth and surging gold prices over the past year has led to a remarkable 68 per cent rise in gold loans during the first nine months of the current fiscal year, compared to just 12.7 per cent in the same period last year, according to data from the RBI. The affinity for gold among Indians is well-known, with a substantial portion of savings typically invested in jewellery. As economic hardships intensified throughout 2024, many families turned to pledging their jewellery to obtain loans. Additionally, what makes gold loans more attractive is their relatively easier processing as compared to other unsecured loans such as personal loans.

Lured by a remarkable surge in the benchmark stock indices, Sensex and Nifty, which more than doubled since the onset of CoVID-19 until the September quarter of last year, nearly 10 crore new investors began trading stocks and derivatives between 2020 and 2024. By end December 2024, the ownership of retail investors, who form the bulk of the small investors, and high-net-worth individuals (HNIs) in all listed companies on the National Stock Exchange (NSE) reached a historic high of 18.2 per cent, exceeding that of foreign portfolio investors (FPIs) for the first time since 2006. Adding to the pain of these crores of investors, India has now been experiencing its longest equity market slump in nearly thirty years, resulting in a loss of a whopping \$1 trillion in market capitalization. This market decline is already impacting consumer spending and also poses a risk of further slowing of the economy which is projected to grow at its slowest pace in four years during the current financial year, primarily due to weak urban consumer demand. Consumer spending, which constitutes half of India's GDP, is already being affected by stagnant income growth and high inflation.

The economic hardships that majority of Indians feel right now needs to be addressed at the earliest. However, prospects for that exercise appear bleak as the government at the Centre has other priorities, while the Opposition parties are busy raking up many trivial issues.

This leaves the ordinary citizen to fend for himself.

SUMMER TIME STORIES

ndia is getting hot as the summer season takes hold. But the hot weather, this year arriving earlier and feeling hotter, comes with a chill in the economy. Can an early summer thaw the consumption chill? Will the former salvage the latter? Many economists hold out the hope that FMCG will sell more fizzy sodas and squashes, more cleansing lotions and deodorants. Air-conditioners, coolers and fans will soon be in demand. The consumption story will pick up pace. This is a reasonable expectation from the frame of the modern economy.

But isn't it possible to change the frame? We have just passed the day, 11 March, when in the year 1930, Mahatma Gandhi and his 79 chosen satyagrahis left the Sabarmati Ashram at 6am for the famous Dandi March to break the Salt Law. The description of that historic day, recorded in many documents, did not mention any unusual heat or rise in temperature. Since then, research data show that the annual mean temperature of Gujarat as a whole has increased. The rise in minimum temperature during the winter season was found to be higher than the rise in maximum temperature in the summer season, according to a paper (Ray, Mohanty, and Chincholikar) published in 2009 by the Ahmedabad Meteorological department. Another paper (Dash, Jenamani, Kalsi and Panda) published by Springer recorded evidence of climate change in 20th century India, including an increase in extreme temperature events. Dandi is seeing a high of 35 degrees Celsius this year in March. Straight to the point of the

tion story, on 22 December 1916, Gandhiji addressed a gathering of economists in Allahabad. His lecture was titled "Does Economic Progress Clash with Real Progress?" Gandhiji said in the lecture. "Western nations today are groaning under the heel of the monster-God of materialism. Their moral growth has become stunted. They measure their progress in dollars. American wealth has become the standard ... I have heard many of our countrymen say that we will gain American wealth but avoid its methods. I venture to suggest that such an attempt if it were made is foredoomed to failure" (Collected Works of Mahatma Gandhi Volume 13, pp 310-17).

The doomsday prediction by Gandhiji may or may not have come true but adverse climate change is being felt sharply. One can argue that in the summer months (March-July) there is usually an increase in demand for some consumables such as cold drinks and ice-creams. Since 2016 alone, FMCG revenues have more than tripled. But the feeling of an economy stalled and citizens in distress is distinct. The hope that the higher variation seen in normal conditions (heat waves or extreme cold), the better for our economy is a position that is materially true in the short haul but also places Gandhi's thoughts in their clear light. We now must depend on fluctuations in weather to help us push the economy, which of course is in part a cause of the fluctuations in the first place!

Are we not trapped in this vicious cycle? All this will of course lead to a steep hike in energy use, most of which is fossil fuel based. Carbon and other greenhouse gas emissions will increase. It will attract more public and private investments in technology and machines to produce low-carbon goods and services. Artificial Intelligence and super automation will tolerate fewer people at work to lower costs and be competitive. People without work will offer great scope to the State to dole out welfare schemes and social security.

The result: more towns and cities will be added to high and dangerously high air pollution levels for which mitigation efforts will further enhance the production of goods and services that will add to the GDP. More prosperity will lead to

the demand for a rise in fossil fuel-driven motorised vehicles on roads. A sedentary life will give rise to lifestyle diseases like diabetes, hypertension, cardiovascular and cardio-respiratory problems. More professional gymnasiums and more coaches will arrive on the scene alongside general and super speciality hospitals. More technical and specialised educational courses to deal with these problems will be introduced in universities charging fancy fees. This is 'development" and modernity in full drive.

Not surprisingly, Gandhiji called it the "monster-god of materialism." Gandhiji did not give a religious sermon, but he did bring in religiosity by speaking about the moral value of regulating human beings' lifestyles with limited material advancement. The core of the problem lies somewhere else. More than a 100 years ago, Gandhiji was trying to show us that the path is unworkable. He wrote: "In a well-ordered society, the securing of one's livelihood should be and is found to be the easiest thing in the world. Indeed, the test of orderliness in a country is not the number of millionaires it has, but the absence of star-

vation among its masses." The threat to us from climate change is real. Human wisdom reflected in the SDGs or similar goals calls for a halt to unbridled consumption and GDP growth. The economists who see great GDP growth potentials in adverse climate conditions have turned into votaries of the monster-god of material progress. Gandhi reminds us of this simple truth.

ince their inception in late-nineteenth-century Europe, social protection programmes have been financed primarily through payroll contributions by workers and employers. These schemes maintain people's standard of living when old age, illness, child-rearing, or unemployment affect their capacity to earn an income.

The recent confluence of global crises – from the COVID-19 pandemic and the skyrocketing cost of living to the climate emergency and wars in Europe, the Middle East, and Africa – has highlighted the catastrophic risks of inadequate social protection. To address these vulnerabilities and curb rampant inequality, governments must work to bring everyone under the umbrella of comprehensive social protection systems.

But just when such systems are needed more than ever, global trends that could erode their very foundation are emerging. The move from productive to financialised capitalism, the rise of digital technologies, automation, and artificial intelligence, together with demographic change, will alter how social protection is funded, who can access it, and under what terms. Ensuring its long-term resilience requires innovative solutions.

Historically, labour was essential for production and the creation of wealth. But today, the most valuable companies increasingly leverage finance and technology more than human work. At the same time, wages have stagnated and no longer grow in line with productivity. Because social-insurance contributions depend on wages, labour-intensive firms now shoulder a larger financing burden, which lets some of the most profitable companies and those contributing less to employment creation off the hook.

Moreover, demographic shifts such as aging populations and declining birth rates increase the contributions required from workers and their employers, raising affordability constraints for employers seeking to expand their workforce. And with the rise of outsourcing and complex, far-flung value chains, combined with persistently high levels of informal and self-employment, firms benefit from the efforts of workers whom they do not directly employ, and thus contribute less

to financing social insurance. According to international labour standards on social security, workers should not pay more than half of social insurance's total cost, with the remainder borne by employers. As the balance of power and profit shifts away from labour and toward capital, this core principle is under threat.

To address these challenges, countries could raise additional revenue by increasing taxes on corporate profits. Global efforts to establish a minimum corporate tax and harmonise rates are already underway. But this is unlikely to be sufficient. Social protection programmes compete with government outlays for health care, education, sanitation, and other priorities, and financing them requires long-term planning, which is at odds with short-term political spending cycles.

Moreover, flat-rate, tax-funded benefits alone can hardly curb downward social mobility or prevent the impoverishment of the middle class during crises. Nor are they sufficient to sustain aggregate demand and serve as a macroeconomic stabiliser during economic downturns. Both objectives of social protection are arguably as important as poverty reduction.

In addition to expanding tax

financing to ensure a universal minimum of protection, it may be time to rethink the composition and structure of contributions to social insurance systems. Instead of being determined solely by wages (and thus labour stock), employers contributions to these systems could be determined partly by their capital intensity. This could be calculated as a portion of a firm's profits, sales, or investment in labour-replacing technologies – for example, a levy on robotisation, automation, or artificial intelligence could be earmarked for social insurance.

It would not be the first time that policymakers have devised innovative mechanisms to fund social-insurance programmes through levies on capital. In Portugal, contractors pay social contributions for the self-employed workers whose services they benefit from. Workers in India's and Indonesia's construction sectors, regardless of their contractual status, are insured for workplace-related injury, illness, and death through a charge paid by the main contractor based on the project's total value. Several countries are ensuring social-insurance coverage for platform work through levies on the digital platforms' turnover or digital transactions.

Social protection has long adapted to the changing nature of work and economic activity. Only by adapting can social protection realise its core principles - solidarity, collective financing by capital and labour, redistribution, and risk sharing - for years to come.

Sir, This refers to "Baloch militants attack paramilitary convoy; five killed," **OrissaPOST**, March 17. Terrorism, nurtured by the Pakistani deep state for decades, is coming back to bite it with devastating effect. The killing of three Frontier Corps personnel on Sunday and recent brazen hijacking of a train in the restive Balochistan province killing 24 passengers are the latest in a series of terror attacks across the country and highlight the growing unrest. The irony is that Pakistan, which used terrorism as an instrument of state policy for decades, is at its receiving end now. Despite being Pakistan's largest province, Balochistan remains its most marginalised and neglected region in the throes of a separatist movement. Home to roughly 15 million people, this arid, resource-rich region has long suffered economic exploitation and state repression. Baloch insurgent groups, particularly the BLA, have waged a decades-long battle for autonomy, accusing Islamabad of plundering the province's vast mineral wealth while leaving its people in abject poverty. The situation has reached a boiling point, with BLA militants targeting security forces, infrastructure and Chinese investments linked to the China-Pakistan Economic Corridor. With terror networks expanding and state authority eroding, Pakistan's security challenges are reaching a breaking point. N Sadhasiva Reddy, BANGALORE

March 17: Hundreds of ASHA workers, who have been staging a protest for over a month pressing various demands, Monday intensified their agitation by laying a siege to the state's Secretariat here.

A section of Accredited Social Health Activist (ASHA) workers has been protesting here for the last 36 days seeking post-retirement benefits and a hike in their honorarium.

As they are yet to get any assurance from the authorities on their demands, the agitators today laid a siege to the Secretariat by blocking its various gates, in the heart of the city.

After gathering at the protest venue, they moved towards the state's administrative hub, squatted on the road and raised

Security was intensified in and around the Secretariat and over 800 police personnel were deployed to prevent the protesters from entering Secretariat.

One of the protesting ASHA workers, who came from neighbouring Kollam district, said they won't end ongoing agitation untill the state government accepts their demands.

"How can we take our lives forward with this meagre income.

I am a widow and has two children and an elderly mother to look after. I cannot live anymore with this poor honorarium at a time when prices of essential commodities are skyrocketing, she told the media. Meanwhile, the ruling LDF

Monday continued to criticise the ASHA workers over their agitation and said those who are leading the protest have some hidden agenda.

"They should have staged a protest against the union gov-

ernment...not against the state government," senior CPI(M) leader and LDF convenor TP Ramakrishnan said here.

He also claimed that the LDF and the CPI(M) have always stood to protect the interests of the ASHA workers and that would continue.

The LDF government has claimed that it has not received any cash grant from the They should central govern-

> ment under National the Health Mission (NHM) for 2023-24 for payment towards various centre-sponsored schemes, including for ASHA

The central government has, however, rejected the state's claims and contended that it has given what was due. but the utilisation certificate has not come from Kerala.

It said that once the certificate comes, the requisite amounts would be given to the ASHA workers and the state.

Union Health Minister JP Nadda had also announced in the Parliament that the Mission Steering Group of the NHM has decided to raise the incentives of ASHA workers

Cheetah Gamini, 4 cubs released into Kuno wild

Sheopur, March 17: Cheetah Gamini and her four cubs were released into the wild at Kuno National Park (KNP) in Madhya Pradesh Monday, offering tourists a unique opportunity to spot the big cats during sa-

The release raised the number of cheetahs in the wild to 17, while nine felines are staying

Gamini, the South African female cheetah, and her four cubs (two male and two females, aged 12 months) have been successfully released in the Khajuri forest area of the KNP in Sheopur district, Additional Principal Chief Conservator of Forests Uttam Kumar Sharma said.

Madhya Pradesh Chief Minister Mohan Yadav hailed the development as an "important day" in the cheetah project and wildlife conservation.

Yadav said the translocation of cheetahs from South Africa to Madhya Pradesh is an important project not only for India but also for Asia in terms of biodiversity.

the KNP region would encourage tourism activities, generate employment, and strengthen the overall economy of the Chambal region.

The selection of Kuno (Sheopur) for this inter-continental project is good fortune for the state, he said in a message to

He hailed the dedication and hard work of the state forest department for the successful implementation of the cheetah

"Gamini and all the four cubs are healthy. This forest area is part of the Ahera tourism zone," Principal Chief Conservator of Forests Uttam Kumar Sharma stated in a release.

As per the forest department's assessment, the presence of cheetahs in the tourism zone will offer tourists an opportunity to spot the felines during safari rides.

"After the release of Gamini

and her four cubs, there are now 17 cheetahs (including 1) cubs born on Indian soil) in the wild in the Kuno National Park. All cheetahs are healthy and doing fine in the wild." the release stated.

According to officials, Gami ni gave birth to six cubs in her first litter March 10, 2024. Two of the cubs, however, died in subsequent months.

On February 21 this year Cheetah Jwala and her four wild in KNP.

Prime Minister Narendra Modi initiated the cheetah translocation project with the historic release of eight chee tahs -- five females and three males -- brought from Namibia to KNP September 17, 2022.

This marked the first-ever intercontinental translocation of big cats.

In February 2023, 12 addition al cheetahs were translocated from South Africa to the KNP

The total number of cheetahs in the KNP now stands at 26, in cluding 14 cubs born on Indian soil. The ambitious project is part of India's efforts to restore the cheetah population and enhance wildlife conservation and tourism in the region.

The resolution, passed in its recently concluded executive council meeting, aimed at embracing a term that reflects the nation's rich heritage. The decision was unanimously ap proved by all members of the council, Prof Vijayakumar CG, vice chancellor of the university told IANS over the phone.

He had chaired the meeting. From now onwards, 'Bharat' will be prominently used across various platforms, including the university's website, student materials, and even the official calendar. The universi ty will use the 'Bharat' word as much as possible in its official

With this decision, the university has become a pioneer in the state, to adopt 'Bharat in official documentation During the discussions, Exec utive Council member Gauray Dhakad proposed prioritising

Responding to a query from CPI(M) MLA V Joy regarding the Cancer Grid system in the Assembly, George stated that as part of the Nava Kerala Action Plan-2 Aardram Mission. activities are being carried out in the state with 10 main objectives in mind.

trol and prevention. The Cancer Grid is a network prepared by the Health Department in all districts to coordinate cancer patients, disease treatment systems, diagnostic labs and cancer treatment centres, George added.

The Cancer Grid system

works by connecting the three cancer centres in the state, cancer treatment units in medical colleges, and cancer care units in the Health Department with health institutions ranging from family health centres to district hospitals.

On February 4, 2025, the chief minister inaugurated the popular cancer prevention campaign 'Arogyam Anandam- Akattam Arbudham', and launched the Cancer Grid, she stated.

George further said the 'Karunya Sparsham – Zero Profit Anti-Cancer Drugs' scheme, which provides costly cancer medicines at company prices through select Karunya pharmacies across the state, is progressing successfully.

Under this initiative, med-

icines worth ₹2.5 crore were distributed in just five months, with cancer drugs made available at discounts of up to 88 per cent compared to market rates. ensuring zero profit, she added.

In the first phase, dedicated counters were set up in all 14 districts, and steps are being taken to expand the service further. George said.

The allocation for cancer drugs supplied through government hospitals has doubled in recent years. In 2024-25 alone, ₹27.43 crore worth of cancer drugs were distributed through Kerala Medical Services Corporation Ltd (KMS-CL) to medical colleges, district general hospitals, and other cancer treatment centres, she claimed.

The petition cited the pres idential order of February 28, 2020, which allowed delimitation in the four northeastern states, along with the Union Territory of Jammu and Kash-

It alleged selective denial of delimitation in these states. claiming a violation of the fundamental right to equality under Article 14 of the Constitution.

The plea highlighted that despite decades of elections being conducted peacefully in these states, no delimitation took place since the amendment of the Delimitation Act in 2002.

The lack of action left the northeastern states at a disadvantage compared to the rest of the country, it added.

RG Kar case: SC asks victim's parents to approach Calcutta HC

New Delhi: The Supreme Court Monday allowed the parents of the RG Kar Medical College rape and murder victim to pursue before the Calcutta High Court their plea for a further court-monitored CBI probe into the gruesome incident. A bench headed by Chief Justice Sanjiv Khanna took note of the submissions of senior advocate Karuna Nundy, appearing for the parents, that a further probe was needed to ascertain the alleged role of some other persons. "Without making comments, we dispose of the application (of the parents) observing that the applicants have the liberty to pursue the proceedings before the high court," the bench said.

SC seeks Centre's reply on PIL against CAG appointment process

New Delhi: The Supreme Court Monday asked the Centre's reply on a PIL for declaring as unconstitutional, the process of appointment of the Comptroller and Auditor General of India "solely by the executive and the Prime Minister and said we should trust our institutions. A bench of Justices Surva Kant and N Kotiswar Singh issued the notice on a PIL filed by NGO Centre for Public Interest Litigation and tagged it with a pending case on the issue. The bench said Article 148 of the Constitution provides for the appointment of CAG aside from the safeguards from any influence. "Ultimately, we have to trust our institutions. Article 148 also provides protection, similar to one which is provided to the judges of the Supreme Court," the bench said.

Nitish Katara murder: SC issues contempt notice to Delhi govt

SECURITY TIGHTENED AT AURANGZEB TOMB

Fadnavis assures protection, minister recalls Babri demolition

Mumbai, March 17: The security was beefed up around the tomb of Mughal emperor Aurangzeb in Chhatrapati Sambhajinagar district of Maharashtra amid threat by right-wing groups for its removal, with police mandating the visitor registration and asking tourists to provide identity documents.

Police have set up multiple security posts along the route from the entrance of Khultabad town to the site of the tomb, following the submission of a memorandum by the Vishwa Hindu Parishad (VHP) to Chief Minister Devendra Fadnavis asking for the removal of the grave.

The memorandum highlighted Aurangzeb's controversial history, particularly his conflicts with the Marathas, and termed his tomb as the symbol of "pain and slavery" to justify its removal.

The VHP cited Aurangzeb's role in the execution of Chhatrapati Sambhaji Maharaj, the son of Maratha warrior king Shivaji Maharaj, as well as his alleged destruction of temples in Kashi, Mathura, and Somnath.

The VHP held similar protests in Nagpur and suburban areas of Mumbai.

In response to these threats, Chhatrapati Sambhajinagar police increased security presence, mandated visitor registration, requiring tourists to



provide identity documents, and sign a visitors' register.

An official said a State Reserve Police Force (SRPF) company of 50 policemen, 30 personnel from local police, and 20 Home Guard jawans, have been deployed at various points and the grave site.

Tourists visiting the tomb will have to write their names in a visitors register kept with a team of Home Guards and have to furnish identity documents, he said. A State Reserve Police Force

(SRPF) company, along with local police and Home Guards, are stationed at various points around the tomb.

Fadnavis, while speaking about the controversy, said that while the government is

obligated to protect the tomb as a protected historical site, it will not tolerate any attempts to glorify Aurangzeb's legacy.

"However, I assure you, if any attempt is made to glorify his legacy through 'mahima mandan' (glorification), it will not succeed," Fadnavis said during a Chhatrapati Shivaji Maharaj birth anniversary

He said that only Chhatrapati Shivaji Maharaj's legacy deserves glorification.

His statement followed controversial remarks by state Cabinet minister Nitesh Rane, who suggested a "Babri Mas jid-type" action, calling on Hindutva outfits to do their duty while the government fulfils its responsibilities.

Orry, 7 others booked Rajnath flags concerns for drinking at Vaishno over SFJ's activities in US

New Delhi, March 17: Defence Minister Rajnath Singh Monday conveyed to US Director of National Intelligence Tulsi Gabbard India's concerns over activities of Khalistani separatist group Sikhs for Justice (SFJ) on American soil and urged her to declare it as a designated terrorist entity, sources said.

In an over 30-minute meeting at his office in the Raisina Hills, Singh also apprised Gabbard about SFJ's alleged links with Pakistani spy agency Inter-Services Intelligence (ISI) as well as its "collaboration" with Babbar Khalsa militant group, and pressed for action against it. they said.

Singh flagged concerns over the SFJ, headed by Gurpatwant Singh Pannun, targeting various Hindu religious structures in the US and said such activities must be stopped, the sources said.

The SFJ is a banned organisation in India. Pannun is want-



ed by Indian probe agencies on various terror charges.

Separately, External Affairs Minister S Jaishankar also met Gabbard.

In their talks, Singh and Gabbard explored ways to boost India-US collaboration in niche defence technologies, information sharing and integration of defence industrial supply chains.

The two leaders also reviewed bilateral strategic cooperation in the maritime domain, according to an official

The US director of national intelligence arrived in the national capital early Sunday on a two-and-a-half-day trip in the first high-level visit to India by a top official of the Donald Trump administration.

The analysis of food insecurity underscores the urgency of diversifying India's agricultural production and modernizing its value chain to combat malnutrition towards truly sustainable development. The examination of environmental transition identifies a set of priority actions to address India's triple crisis of water, air and forest degradation.

According to Marie- Pirre de Bailliencourt, managing director of the Institut, in early 2025 the analysis



has been extended to two additional challenges that will shape India's trajectory. The first examines the ambitions of the "Make in India" initiative in the light of the persistent weaknesses in the country's manufacturing sector. The second examines economic policy disparities among Indian states and their implications.

It is pertinent to note that India is as large as the European Union (EU) and, with its federal structure, has as many states as EU has Member States. Each state of the Indian Union has its own language and the Hindi belt states are the only part of the country to share a common idiom.

The report also notes the sharp contrast between the Hindi speaking North and the South. This division also lingers in a sharp political divide: while the ruling party governs many states in the north, it holds no power in the South. Going beyond the North-South dichotomy, the west also figures, in view of the key role of two of its states. Maharashtra and Gujarat. Thus it is that the study attempts

to show how three states from three different regions illustrate three development strategies-with clear implications for potential foreign partners.

The study notes that even if the Narendra Modi government has promoted centralization since it came to power in 2014, the states still have considerable margin to implement their own policies in infrastructure(roads, ports etc), education (at primary and secondary level at least), health and all sectors of the economy including agriculture and industry. Among the Hindi belt states, Bihar is known as the poorest although its situation is not terribly different from other north Indian states including Madhya Pradesh and Uttar Pradesh-which with 250 million inhabitants is the largest state in India with Bihar coming next with 130 million. Bihar's development is hindered by a very rigid caste system, a low rate of literacy and lack of infrastructure. As a result the state cannot create enough jobs for its population and so Biharis tend to migrate more than Indians from any other state. "Bihar represents a case of persistent underdevelopment", the study notes.

In contrast, Gujarat, in the west, is the richest case in the country in terms of per capita wealth. Like its neighbor Maharashtra, this prosperity is largely due to its achievement in the field of industry. However this

success has tended to find expression in the development of infrastructure (roads, ports and energy-all of which are highly capital intensive domains) rather than investments in human resources, as is evident from the rather low level of education) As a result, inequalities in the state are not decreasing and Gujarat has not been in a position to promote the IT sector for which India is still known as a model abroad." The trajectory of Guiarat-which Narendra Modi presented as a "model" when he helmed the state between 2001 and 2014-represents a case of highly capital-intensive infrastructure-based industrialization", the study observes. Tamil Nadu has also developed a

very robust industrial sector, but it has relied more on small and medium enterprises (SMEs) and has invested heavily in human resources. "Not only are the inequalities limited but the level of education is also well above average. This success is also seen as a model and its societal dimension is also emphasized. The state has capitalized on the egalitarian ethos of the Dravidians, the low caste locals who emancipated themselves from the Brahminical elite in the 20th century, arguing that they were the sons of the soil whereas the upper caste were Aryan invaders. Balochistan: 5 hurt in grenade attack

Karachi: Five people including four children were injured Monday in a grenade attack on the residence of a Station House Officer (SHO) in Pakistan's Balcohistan, as insurgents continued terror attacks in the restive province. The attack took place at the house of SHO Qadir Sheikh in Khuzdar, according to authorities. Khuzdar Senior Superintendent of Police (SSP) Javed Zehri told the media that unknown assailants threw a hand grenade at the residence of the Hub City SHO, injuring his father as well as his brother's four children, "The father has been moved to Karachi for treatment while the children have been given treatment," he said, adding that the incident was being investigated. There have been a series of terror attacks in different parts of the province since militants from the banned separatist outfit Baloch Liberation Army (BLA) ambushed Jaffar Express carrying 440 passengers last week.

Ukraine's new chief of general staff

Kyiv: Ukraine President Volodymyr Zelenskyy appointed Andrii Hnatov as the new chief of the general staff of Ukraine's armed forces, as the country looks to restructure and strengthen its military while its engaged in combat in Russia's Kursk region and facing increasing pressure in Donetsk. Hnatov replaced Anatoliy Barhylevych, who held the position since February 2024. The appointment was announced by the general staff via its Telegram channel Sunday. "We are systematically transforming the Armed Forces of Ukraine to enhance their combat effectiveness," Defense Minister Rustem Umerov said. Barhylevych will now serve as the general inspector of Ukraine's Defense Ministry. Umerov emphasized that Barhylevych would "remain part of the team," overseeing military standards and strengthening discipline in the army.

Migrant shipwreck leaves seven dead

Nicosia: State-run television in Cyprus reported Monday that seven bodies have been recovered and two people had been rescued after a boat carrying migrants sank off the south coast of the island. Officials from the Joint Rescue Coordination Center confirmed that a rescue effort was ongoing, involving a military helicopter and rescue vessels and a drone, but could not officially comment on casualties, citing the early stage of the operation. The agency confirmed that it was still searching for people believed to be missing.

Trump, Putin talks today

Washington, March 17: US President Donald Trump will speak with Russian President Vladimir Putin Tuesday as efforts continue to end the war in Ukraine, a move that could represent a possible pivot point in the conflict and an opportunity for Trump to continue reorienting American foreign

Trump disclosed the upcoming conversation to reporters while flying from Florida to Washington on Air Force One Sunday evening, while the Kremlin confirmed Putin's participation Monday

"We will see if we have something to announce maybe by Tuesday. I will be speaking to President Putin Tuesday. Trump said. "A lot of work's been done over the weekend. We want to see if we can bring that war to an end."

Kremlin spokesman Dmitry Peskov Monday morning confirmed the plans for the two leaders to speak Tuesday, but refused to give details, saying that "we never get ahead of events" and "the contents of conversations between two presidents are not subject to any prior discussion."

European allies are wary of Trump's affinity for Putin and his hardline stance toward Ukrainian President Volodymyr Zelenskyy, who faced sharp criticism when he visited the Oval Office a little more than two weeks ago.

Although Russia failed in its initial goal to topple Ukraine with its invasion three years



ago, it still controls large swaths of the country.

Beijing, March 17: China Monday appreciated Prime Minister Narendra Modi's 'positive' remarks on the Sino-Indian ties favouring dialogue over discord and said that a cooperative "dance between the elephant and dragon" contributing to mutual success is the only choice for both sides.

China noted Prime Minister Modi's recent positive statement on China-India relations and appreciated it, Foreign Ministry spokesperson Mao Ning told a media briefing here while responding to a question on the prime minister's remarks in conversation with American podcaster Lex Fridman. Mao said the successful meet-

ing between Prime Minister Modi and Chinese President Xi Jinping in Kazan, Russia, in October provided strategic guidance for the improvement and development of bilateral

Both sides have earnestly followed through on the important common understandings, strengthened exchanges and achieved positive outcomes

"Let me stress that in the 2000 plus years' history of interactions, the two countries have maintained friendly exchanges" and both the coun tries learned from each other contributing to civilisational achievements and human prog ress, she said.

As the two largest develop ing countries, China and India have shared the task of accel erating their development and revitalisation and understand and support each other's successes, she said. This serves the fundamental

interests of over 2.8 billion people, meets the common aspiration of regional countries, and follows the historical trend of the Global South growing stronger and conducive to world peace, she said.

The two countries should be partners that contribute to each other's success and a "coopera tive pas de deux", a ballet between dragon and elephant, is the "only choice for both sides, she said, reiterating the recent comments by Foreign Minister Wang Yi on the development of bilateral ties.



Carney meets European allies amid Trump tensions

Paris, March 17: New Canadian Prime Minister Mark Carney met with French President Emmanuel Macron Monday, seeking support from one of Canada's oldest allies as US President Donald Trump continues to attack Canada's sovereignty and economy.

This is Carney's first official foreign trip since he was sworn in March 14. He will next land in London where he will sit down with UK Prime Minister Keir Starmer and King Charles III, the head of state in Canada.

Why Paris and London? Carnev has deliberately chosen the two European capital cities that shaped Canada's early existence. During his swearing-in ceremony, he noted the country was built on the bedrock of three peoples. French. English and Indigenous, and said Canada is fundamentally different from America and will "never, ever, in any way shape or form, be part of the United States.'

"I want to ensure that France, and the whole of Europe, works enthusiastically with Canada, the most European of non-European coun-

tries, and at the same time resolutely North American, determined, like you, to maintain the most positive relations possible with the United States," Carney said Monday, standing next to Macron. Macron and Carnev appeared

in front of reporters before the talks but did not take questions, a sign the French president might not want to upset Trump by siding with Canada. Macron said tariffs only

bring inflation but did not address Trump's attacks on

"We both believe that fair trade which respects international rules is a good thing for the prosperity of everyone and is certainly more effective than tariffs, which create inflation and damage supply chains and our economic integration," Macron said.

Since Trump came to office, he has imposed whopping tariffs on Canadian steel and aluminum and repeatedly commented on turning Canada into the 51st state, infuriating Canadians and sparking a call to boycott US products across the country. He is threatening to impose tariffs on all Canadian products on April 2.

Rights groups seek answers on deportation despite court order

Washington, March 17: Civil rights groups Monday sought 'immediate clarification' from the Trump administration about weekend flights deporting alleged Venezuelan gang members from the US despite a judge's or der, saying the US government may have violated the court.

In a filing overnight, the American Civil Liberties Union and others called on the US District Court in Washington to compel President Donald Trump's administration to provide information on whether any flight took off after the judge's written or oral orders were issued as well as other details about the flight's timing

"Whether or not the planes had cleared US territory, the US retained custody at least until the planes landed and the individuals were turned over to foreign governments," the AC LU and Democracy Forward Foundation wrote.

Over the weekend, the Trump administration said it had deported more than 200 Venezuelans, saying in an extraordinary statement that a judge did not have the authority to block its actions.

As Tesla tanks, Musk's hand-picked board chair is doing just fine

Sydney, March 17: Billionaire entrepreneur Elon Musk is drawing political flak as he champions right-wing causes in Europe and leads President Donald Trump's slashing of the US federal workforce. The controversy is pummeling sales at Tesla, the electric-vehicle giant Musk runs. Its stock has plunged - down 15% on March 10 alone - and investors are yelping in pain.

Sixteen time zones away, the woman who ostensibly supervises CEO Musk is faring well: Robyn Denholm, hand-picked by Musk to run Tesla's board, is the best-paid chair at any public company in the US.

The Australian businesswoman has been so richly compensated as Tesla chair that a shareholder lawsuit recently forced her to return part of her



fortune. In a separate and ongoing case, a Delaware judge criticized Denholm for okaying a payout for Musk that, if approved by a higher court, would set a record for CEO compensation: \$56 billion.

Relatively unknown when

she assumed the chair in 2018, the 61-year-old former accountant has since become recognized as the chief defender of the hotly contested pay package. Denholm's effort to ensure the payout included a court appearance in which she

described her own pay from Tesla as "life changing."

Her Tesla compensation since she first joined the board in 2014 has totaled about \$682 million in cash and stock, based on recent market prices, according to a Reuters analysis of regulatory filings and research done at the request of the news organization by Equilar, a California-based compensation and governance specialist.

The figure, which varies with market fluctuations, has grown rapidly because of the surge in the value of Tesla stock during her time as chair. It is the highest compensation for any director at the biggest public U.S. companies, the analysis shows, and is exponentially more than the \$3 million a year Denholm has said she previously earned

as a telecoms executive. Despite the recent fall in Tesla's shares, Denholm already has banked a fortune: To date, she has cashed in about \$532 million worth of Tesla shares, according to Equilar, which analyzed dozens of regulatory filings regarding her compensation and stock sales over her time on the board. Some of those sales came as recently as early March, before the stock's decline accelerated last week.

With her wealth has come criticism of her compensation – and pointed questions about whether the windfall is compromising her oversight of Tesla and the billionaire who enriched her.

In a ruling last year, the Delaware judge who rejected Musk's compensation package suggested that Denholm's lucrative board pay has hindered her ability to perform her duties, "Ordinary, market-rate compensation

does not compromise a director's independence," wrote the judge, Chancellor Kathaleen McCor mick of the Delaware Court of Chancery. "Outsized director

compensation can.' Denholm declined to be interviewed for this story. In a statement, a spokesperson for Denholm said her pay is fair and in line with the gains other Tesla shareholders have reaped because of the stock's growth

over the years. "Tesla's Director Compensation program is 100% aligned with shareholder interests," the statement read. "She only gets paid if the shareholders get paid.'

Tesla and Musk didn't respond to requests for comment for this report. The billionaire CEO and the Tesla board have argued their high compensation is fair because the company's stock has outperformed corporate America.



Exports shrink; trade deficit narrows sharply

The change in trade trend was due to volatility in petroleum prices and global uncertainties

New Delhi, March 17: India's exports declined for the fourth month in a row in February to \$36.91 billion due to volatility in petroleum prices and global uncertainties, even as the country's trade deficit narrowed sharply.

The country's exports stood at \$41.41 billion in the same month a year ago

The trade deficit in February narrowed to \$14.05 billion as the country's imports reduced to \$50.96 billion in February, as against \$60.92 billion a year ago, data released by the commerce ministry showed.

Asked about the trade deficit, estimated at its lowest level since August 2021, an official said, "These are quick estimates. We are looking into the details of (the) fall in imports.'

Factors, including the highbase effect in February 2024 and change in petroleum prices and precious metals, may be behind the \$10-billion fall in imports from February 2024 to February 2025, the official said.

Aditi Nayar, Chief Economist and Head - Research & Outreach, ICRA Ltd, said, "India's merchandise trade deficit compressed to a 42-month low \$14.1 billion in February 2025 from \$19.5 billion in February 2024, largely explained by a compression in imports of

crude oil, gold and silver. A portion of the YoY decline in merchandise exports can be attributed to the base year effect related to the leap month".

She said the trade deficit was also significantly lower than the average of over \$23 billion during the first 10 months of FY25. Cumulatively, during April-February this fiscal year, the merchandise and services exports rose 6.24 per cent to \$750.53 billion as against \$706.43 billion for the same period last fiscal year.

Banks write off NPAs worth ₹16.35L-cr

New Delhi, March 17: Banks have written off non-performing assets (NPAs) or bad loans worth about ₹16.35 lakh crore in last 10 financial years, Parliament was informed Monday.

Highest amount of ₹2.36.265 crore was written off during financial year 2018-19 while NPAs worth ₹58,786 crore were written off in 2014-15, the lowest in the last 10 years.

During 2023-24, banks wrote off bad loans of ₹1,70,270 crore, lower than ₹2,16,324 crore done

in the previous financial year. Banks write off non-performing assets (NPAs), in-

cluding those in respect of which full provisioning has been made on completion of four years, as per the Reserve Bank of India (RBI) guidelines and policy approved by banks' boards, Finance Minister Nirmala Sitharaman said in a reply in the Lok Sabha, Such write-offs do not result in waiver of liabilities of borrowers and therefore, it does not benefit the borrower, she said.

Banks continue pursuing their recovery actions initiated against borrowers under the various recovery mechanism available to them, such as filing of a suit in civil courts or

in Debts Recovery Tribunals, action under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, filing of cases in the National Company Law Tribunal under the Insolvency and Bankruptcy Code, etc. she said.

As per RBI data, as De cember 31, 2024, scheduled commercial banks had 29 unique borrower companies, which have been classified as NPAs and each of them have outstanding of ₹1,000 crore and above, she said, adding aggregate outstanding in these accounts

Wholesale price inflation inches up to 2.38%

The marginal increase in WPI was witnessed after three consecutive months of decline

New Delhi, March 17: Wholesale price inflation marginally rose to 2.38 per cent in February due to expensive manufactured food items like vegetables oil and beverages, government data released Monday showed.

The Wholesale Price Index (WPI) based inflation was 2.31 per cent in January. It was 0.2 per cent in February 2024.

The marginal increase in WPI was witnessed after three consecutive months of decline. The month-over-month change in WPI for the month of February stood at 0.06 per cent as compared to January.

Positive rate of inflation in February, 2025 is primarily due to the increase in prices of manufacture of food products, food articles, other manufacturing, non-food articles and manufacture of textiles, etc, according to the statement issued by the Ministry of Commerce & In-

dustry. As per the data, inflation in manufactured food products

However, prices of vegetables cooled with potato prices dropping to 27.54 per cent from 74.28 per cent during the month. Besides, prices of milk moderated at 1.58 per cent from 5.40 per cent in the previous month. Fruits and onion prices were

still ruling high with 20 per cent and 48.05 per cent inflation respectively.

The fuel and power category witnessed a deflation of 0.71 per cent in February, against a deflation of 2.78 per cent in the previous month.

Retail inflation data released Wednesday showed that Con-

sumer Price Index (CPI) based inflation eased to a 7-month low of 3.61 per cent in February on easing prices of food items.

According to ICRA Senior Economist Rahul Agrawal, the downward pressure on the headline print on account of the dip in food inflation was offset by the narrowing deflation in the fuel and power segment. and an uptick in the core (nonfood manufacturing) WPI inflation to a 24-month high of 1.3

Overall, ICRA expects the WPI inflation to average at 2.5-3 per cent in the financial year 2025-26, he added.



New Delhi, March 17: The state of cricketing affairs in Pakistan was already in disarray. with the men's national team results on international cricket. And now, the losses that the Pakistan Cricket Board (PCB) incurred by hosting the ICC Champions Trophy, have reportedly burnt a big hole in the board's pocket. The PCB is said to have incurred a mind-boggling loss of USD 85 million (INR 869 crore) by hosting the Champions Trophy, a tournament in which they played just one game at home.

Pakistan suffered a defeat in their opening Group A match of the Champions Trophy against New Zealand in Lahore before travelling to Dubai where they faced India. Their third and final group match against Bangladesh was washed out without a ball being bowled. Due to the defeats against New Zealand and India, Pakistan were knocked out of the tournament, hence ending the campaign with just one home game.

As per a report in the Telegraph India, Pakistan had spent about PKR 18 billion (about \$58 million) to upgrade their three Champions Trophy venues -Rawalpindi, Lahore, and Karachi. The cost of upgradation turned out to be 50 percent more than the anticipated budget

Later, the Pakistan Cricket Board also reportedly spent USD 40 million on event preparations. In return, however, their earnings were literally in pennies. PCB is said to have only received USD 6 million in



return as part of the hosting fee. When it comes to ticket sales and sponsorships, the earnings were negligible.

The report, hence concluded that the PCB suffered a loss of about USD 85 million by hosting the ICC Champions Trophy. The aftereffects of such a loss were seen some of the board's subsequent plans.

The management decided to reduce the match fees for the national T20 championship by 90 per cent while reducing the reserve player payments by 87.5 percent.

As per Pakistan's Dawn, "The PCB had recently reduced match fees from ₹40,000

to ₹10,000 without any official announcement...however PCB chairman Mohsin Nagyi intervened, rejecting the decision and directing the board's domestic cricket department to reassess the matter.'

Even 5-star accommodations for players were swapped with economy hotels.

The Indian shuttlers have a formidable record at the Swiss Open. Past champions include Sindhu, K Srikanth, Prannoy,

This will be the first encounter between Lakshya and Prannoy, who were a part of the 2022 Thomas Cup-winning team, since the Paris Olympics.

London, March 17: Lando Norris heads to the second round of the Formula 1 season in China with a lead over champion Max Verstappen after winning a thrilling race in Australia.

Ahead of Sunday's race in Shanghai, here are five takeaways from the season-opening Australian Grand Prix:

Without the rain and the safety car, the Australian Grand Prix might not have been much of a contest. The two McLarens of Norris and Oscar Piastri quickly built a lead of more than 15 seconds to Verstappen in third early in the race. The McLarens were also three-tenths of a second faster than anyone else in qualifying. So much for preseason predictions that this year could be exceptionally close between multiple teams.



Norris acknowledged McLaren are favorites but warned the team shouldn't get complacent. "If you start thinking things are good and groovy, that's when you get caught," he said. "We will have races where we struggle."

Lewis Hamilton briefly led on his Ferrari debut. Unfortunately for the seven-time champion, a strategy blunder meant Ferrari left Hamilton and his new teammate Charles Leclerc on dry tires in increasingly heavy

rain. "Missed a big opportunity," Hamilton told Ferrari over the radio. Hamilton finished 10th, two places behind Leclerc.

Hamilton and Ferrari may need to work on their communication. After more than a de cade working with Peter "Bono" Bonnington at Mercedes Hamilton was frustrated at regular radio updates from his new engineer Riccardo Adami "Leave me to it, please," he said repeatedly.
