3 KILLED, AS MANY HURT IN GROUP CLASH

Dharakote, March 18: Three people were killed, and three others sustained critical injuries in a violent clash between two groups over alleged sorcery and witchcraft practices at Kharipalli village under the Baharpur panchayat in this block of Ganjam district, Tuesday.

The deceased were identified as Khadala Behera, 65, his son Ratnakar Behera, 40, who died on the spot. Another victim, Ramesh Behera, 45, of the other group succumbed to his injuries while undergoing treatment at a local hospital.

The injured persons were -Arun Behera, 30, Bikhari Behera, 18, and Jaga Dehera, 18. The three first were admitted to a local health centre before being shifted to the MKCG Medical College and Hospital in Berhampur for advanced care. According to reports, the dis-

pute between the two groups stemmed from accusations of sorcery and had been ongoing for five years.

The situation escalated Tuesday evening when members of both groups encountered each other near a village pond. A verbal altercation quickly turned violent, resulting in a deadly confrontation.

Curfew in Nagpur over Aurangzeb tomb row

Nagpur, March 18: More than 50 persons have been taken into custody and curfew imposed in parts of Nagpur, a day after protests against Aurangzeb's tomb triggered violence in the city, which Maharashtra Chief Minister Devendra Fadnavis claimed was premeditated.

Speaking in the legislative assembly Tuesday, Fadnavis said the Vicky Kaushal-starrer film Chhaava, based on the life of Chhatrapati Sambhaji Maharaj, reignited people's emotions against the Mughal emperor and brought before them the true history of the Maratha king. Five FIRs have been registered in connection with the violence, Nagpur police commissioner Ravinder Kumar Singal said Tuesday.

Violence erupted in central Nagpur's Chitnis Park in Mahal area Monday around 7.30 pm, with stones hurled at police amid rumours that the holy book of a community was burnt during an agitation by a right-wing body for the removal of Mughal emperor Aurangzeb's tomb in Chhatrapati Sambhajinagar district, officials said.

As many as 34 police personnel were reportedly injured in the violence.

PRICE COLLUSION

New Delhi, March 18: The Competition Commission of India(CCI) has raided the offices of many global advertising giants, including GroupM, Dentsu and Interpublic Group, and a broadcasters' industry group over alleged price collusion, people with direct knowledge told Reuters on Tuesday. Officers of the Indian antitrust body searched around 10 locations after it initiated a case against the agencies and top broadcasters over allegedly fixing ad rates and discounts, said one of the sources. The raids were being carried out in Mumbai. New Delhi and Gurugram, the first source said. Three other sources with direct knowledge confirmed the names of the entities being raided. The raids come as the ad landscape in India is seeing major shifts following the \$8.5 billion merger between Walt Disney and Reliance's India media assets, which Jefferies analysts say will have a 40% share of the ad market in TV and streaming segments. They also follow Omnicom Group 's \$13.25 billion all-stock deal in December to buy rival Interpublic Group, creating the world's largest ad agency.

Spokespersons for ad giant GroupM, owned by Britain's WPP, U.S.-based Interpublic's IPG Mediabrands unit, and Japan's Dentsu did not respond to requests for comment.

A bench comprising justices Abhay S Oka and Ujjal Bhuyan Monday said a democratic country must not function like a police state, where law enforcement agencies exercise arbitrary powers to detain individuals without genuine necessity.

It observed that two decades ago, bail pleas in smaller cases rarely reached the high courts, let alone the top court

"It is shocking that the Supreme Court is adjudicating bail pleas in cases that should be disposed of at the trial court level. The system is being burIt has repeatedly urged trial courts and high courts to adopt a more liberal stance in granting bail, particularly in cases involving minor infractions.

The apex court had previous ly expressed its anguish over what it termed 'intellectual dishonesty' by lower courts in denying bail, despite multiple directives emphasising the importance of protecting individual liberty when custodial detention is not required.

During the hearing, the bench granted bail to an accused who had been in custody for over two years in a cheating case. The accused's bail plea was rejected by both the trial court and the Gujarat High Court, despite the investigation being completed and a chargesheet filed.

"It is unfortunate that bail matters in cases triable by magistrates are being brought before the Supreme Court. We are sorry to say that people are not getting bail when they should," Justice Oka said.

Over 400 killed in Israeli strikes

Deir Al-Balah: Israel launched a wave of airstrikes across the Gaza Strip early Tuesday, saying it was hitting Hamas targets in its heaviest assault in the territory since a ceasefire took effect in January. The strikes have killed more than 400 people and wounded over 500, according to Gaza's Health Ministry, which says more than half of the dead are women and children. Prime Minister Benjamin Netanyahu said he ordered the strikes because of a lack of progress in talks to extend the ceasefire. Officials said the operation was open-ended and was expected to expand. The White House said it had been consulted and voiced support for Israel's actions. Hamas warned that Israel's new airstrikes breached their ceasefire and put the fate of hostages in jeopardy. 




The CB, which has conducted

the probe into the murder case during the BJD regime, has submitted the charge-sheet in a trial court at Jharsuguda against Gopal Krishna Das, the prime accused in the case. The investigating agency had examined several witnesses. The investigation, however,

overlooked crucial angles like whether some other people were involved or the persons behind the murder case. Many people do not believe that only Gopal is the masterminded and he executed the crime, a senior lawyer said.

Sources said a two-member CB team of ASP Vijay Mallick and DSP Diptimayee Mallick visited Das's residence at Sarbahal in Jharsuguda and recorded the statements. They have so far recorded the statements of Deepali Das and Bishal Das, the daughter and son of the then Cabinet minister.

Naba Kishore Das, then Health minister, was shot at by a policeman at Brajarajnagar in Jharsuguda district January 29, 2023. Later in the day, he was declared dead at a private hospital in Bhubaneswar.

during a discussion on the admissibility of an adjournment motion moved by the Congress on rising crimes against women in the state.

He claimed that conviction rates have started improving after remaining very low during the BJD government.

'Wait for five years, you will see that criminals are nowhere in Odisha," he said, adding that the state government has started recruiting more personnel in the police force and developing

the required infrastructure. Initiating the discussion Congress MLA Ashok Das alleged the government was in slumber, with 54 cases of gangrape being reported in only eight months.

This apart, more than 1,600 cases related to crimes against women have been registered in different police stations, he claimed.

Congress MLA Sofia Firdous said that this government has the habit of shifting responsibilities and blaming the previous regime for all wrong things.

"If the state government is so worried about the safety of the women in Odisha, it should announce a House Committee



to probe all such cases that took place since June last year," she said, demanding justice for the five-year-old girl who was allegedly raped and murdered in Angul last week.

Opposition Chief Whip Pramila Mallik of the BJD alleged that criminals were getting political protection, which was encouraging them to repeat their offences.

BJD MLA Goutam Buddha Das alleged, "The morale of the police is down and that of the criminals is up because the state government did not take any action against the son of the former Governor, who physically assaulted a government employee in July last year. Bhubaneswar, March 18: The route of proposed metro train service in the Capital City will be extended to make it a viable project, Housing and Urban Development Minister Krushna Chandra Mahapatra said here Tuesday.

The previous BJD government had planned to take up the phase-I metro project of the 26-km-long stretch between Biju Patnaik International Airport (BPIA) in Bhubaneswar to Trisulia in Cuttack at an investment of Rs 6,225 crore.

Speaking to mediapersons here, Mahapatra said, "I want to make it clear that our gov-

ernment wants to execute the metro project. We are neither against the project nor going to scrap it," he said.

The metro train service was proposed from Bhubaneswar airport to Trisulia near Cuttack. But what will someone do visiting Trisulia?, he asked.

"So, we have formed an expert committee to study and recommend a proper route to make the metro project viable," Mahapatra said. He said that a revised detailed project report (DPR) will be prepared soon to expand the project till Cuttack city and other areas.

It was also planned to construct an elevated corridor on he said.

Bhubaneswar, March 18: Wing Commander (Retd) BS Singh Deo, a towering figure in Indian and global aviation, was felicitated with the prestigious 'Lifetime Achievement Award' by Vertical Aviation International (VAI), the world's leading professional society for helicopters and drones, March 10. The award ceremony, held in Dallas, USA, celebrated his extraordinary 56-year long career marked by unparalleled contributions to helicopter operations, flight safety, and aviation innovation across military

and civilian domains. Singh Deo's journey in aviation began in his childhood, crafting and flying aeromodels in Dhenkanal and Cuttack. This early passion took flight when he joined Indian Air Force (IAF) in 1968. Graduating from IAF Helicopter Training School, he earned the Best Pilot Trophy and the Chief of the Air Staff Medal, setting the tone for a career defined by excellence. His service in the 1971 Indo-Pak War, alongside accolades as a Flying Instructor and Production Test Pilot, solidified his reputation as a prodigious talent. As an Air Force Examiner, he played a pivotal role in standardising helicopter pilot training for the IAF and Indian Army

After retiring from IAF, Singh Deo transitioned to civil aviation, taking on leadership roles at Pawan Hans Ltd., where he operationalised 21 Westland-30 helicopters and introduced Instrument Flight Rules (IFR) operations in India. by aviation. Later, at Malaysian Helicopter Services, he flew offshore missions in the South China Sea while championing safety initiatives.

With over 8,200 flight hours across five airplane types and 14 helicopter types,

Singh Deo's versatility shines through his roles in Helicopter Emergency Medical Services (HEMS), Humanitarian Assistance and Disaster Relief (HADR), VIP flights, and flight testing. His dedication earned him the 'Vayu Sena

Medal' from the President of India.

In 1997, Singh Deo joined Bell Helicopter as head of operations for India and five South Asian countries, a role he held for 21 years. John L Garrison, president & CEO of Bell Helicopter, praised him, saying, "Purpose, Passion, and Integrity. This is what makes him a pioneer in the industry. Yes, he brought Bell's vision to India." 

Odisha's rivers at risk: Citizens demand urgent action

With Odisha's cultural and ecological heritage at stake, activists, community leaders and experts unite to demand urgent river conservation measures

Bhubaneswar, March 18: Odisha's rivers, once the lifelines of civilisations, are now on the brink of ecological collapse due to rampant pollution, encroachments, and unchecked human activities.

Addressing this grave concern. the eighth edition of the Odisha Manaska Circle, held at Saheed Nagar Tuesday, brought together environmentalists, researchers, and community leaders to discuss the urgent need to revive the state's dying rivers and their deep-rooted cultural

significance. The session, themed "Dying Rivers, Dying Traditions: Can We Save Odisha's Socio-Cultural Identity without Saving Its

Rivers?", focused on the alarming deterioration of rivers like Mahanadi, Baitarani, Prachi, and Gangua, as well as vital water bodies such as Chilika and Anshupa lakes.

Special emphasis was given to Gangua, a river historically known as Gandhavati, which once played a crucial role in sustaining life and culture in Odisha. Today, however, Gangua has turned into a filthy drain, carrying sewage and industrial waste instead of fresh water.

Convener of Mahanadi Bachao Andolan (MBA) and environmental activist Sudarsan Das spoke at length about the alarming depletion of Odisha's rivers. Fresh from his

campaign to save the Rushiku-

The impact of climate change and human-induced activities. including deforestation and excessive sand mining, was also widely discussed. A consensus emerged—saving Odisha's rivers is not just an environmental concern but a cultural necessity.

As a way forward, the gathering proposed the formation of a dedicated pressure group to advocate for river restoration, starting with Gangua. Additionally, they urged the government to launch a 'River Mission'-modeled after existing water conservation programs-to systematically revive and protect the state's rivers. A proposal was also made

to publish an Odisha River Catalogue, documenting the current status and threats to each river, ensuring greater accountability.

The movement is already gaining momentum, with envi ronmental organisations such as Mahanadi Bachao Andolan and the Odisha Environmental Society taking their concerns to Chief Minister Mohan Charan Majhi.

Their advocacy, focused on pollution levels in Gangua Daya, Mahanadi, and Chilika is expected to play a crucial role in shaping future policies aimed at safeguarding Odisha's water bodies and, by extension, its cultural identity.

Dharakote, March 18: Three people were killed, while an equal number of others sustained critical injuries, when a violent clash broke out between two groups over alleged sorcery and witchcraft practice at Kharipalli village under the Baharpur panchayat in Dharakote block of Ganjam district Tuesday.

The deceased were identified as Khadala Behera, 65, his son Ratnakar Behera, 40both died on the spot. Another victim, Ramesh Behera, 45, of the rival group succumbed to his injuries while receiving treatment at the Dharakote hospital, police said.

The injured, identified as Arun Behera, 30, Bikhari Behera, 18, and Jaga Dehera, 18, were initially admitted to the Dharakote hospital before being shifted to the MKCG Med-



ical College and Hospital in Berhampur for advanced care. According to reports, the

dispute between the two groups stemmed from accusations of sorcery which has been going on since the past five years. Matters reached a flash point Tuesday evening when members of both the groups encountered each other near a village pond. A verbal altercation quickly turned violent, resulting in a deadly confrontation.

Following the incident, Sub-Divisional Police Officer Santosh Kumar Jena, along with officers from Badagada, Sheregada, and Dharakote police stations, rushed to the spot to maintain order and launch an investigation.

Notably, the police had previously intervened to halt the alleged practice of sorcery in the village and provided temporary protection to the families of Khadala Behera and Banabasa Behera for a month. However, despite the temporary breather, tensions between the two groups continued to simmer.

In a separate incident two months ago, unidentified miscreants set fire to two motorcycles and three bicycles in Kharipalli, further intensifying the animosity, sources said.

Authorities are continuing their investigation to determine the cause of the latest violence and ensure peace in the village, Dharakote police station IIC Chandrika Swain said.

2 minors arrested for gangrape of 12-yr old

Umerkote, March 18: Police arrested two minor boys on charge of sedating a 12-year old girl and gangraping her under this police limits in Nabarangpur district late Monday night.

The accused minors were questioned in this connection after their arrest. The survivor and the accused minors were taken for a medical examination to Umerkote health centre Tuesday. Later, the accused minors were produced before the Juvenile Justice Board which remanded them to a probation home.

According to police, the incident occurred when the minor girl was playing near her house in the afternoon hours on Holi (March 15, Saturday). The two accused allegedly trailed her and called her to a nearby ground. There they sedated her and gangraped her despite her resistance, police said.

The shocked girl remained mum that night, before narrating her ordeal to her mother the next day. Her mother then lodged a complaint at the Umerkote police station while the accused fled from the village.

Bhograi, March 18: With the fate of the long-pending Jaleswar-Digha broad gauge rail route still hanging in balance, people living along the Odisha-West Bengal border appear skeptical about the proposed Jaleswar-Chandaneswar new rail route ever becoming a reality.

According to reports, despite receiving approval 14 years ago with an estimated cost of ₹352.65 crore, work on the 41km Jaleswar-Digha railway project is yet to begin. In that backdrop, discussions on the new Jaleswar-Chandaneswar rail route have evoked lukewarm response from the border residents in both the states.

The skepticism stems from the ground that in the interim Budget, Union Railway Minister Ashwini Vaishnaw had announced allocations of ₹10.599 crore for Odisha, and ₹13,955 crore for West Bengal. However, there was no clarity on the specific funds allocated for these two railway projects. According to sources, both Odisha and West Bengal

governments are focused on boosting tourism, boosting exports, and regional development. The construction of Subarnarekha-Choumukh ports in Subarnarekha estuary under



Baliapal block of Balasore district, and at Tajpur under Ramnagar block in West Bengal is expected to drive economic growth. As a result, both the rail routes are seen as critical infrastructure for these initiatives.

Border residents believe the railway projects will improve connectivity with northern and southern states while facilitating cost-effective transportation of local produce such as betel leaves, paddy, coconut, groundnuts, and marine fish to other states.

The Jaleswar-Digha railway project was first proposed to the Central Railway Board by the then Odisha government in tion of ₹65 lakh was approved in

1994-95 fiscal to meet the needs of border residents. During the tenure of United Progressive Alliance (UPA) government in Centre, former minister Srikant Jena presented the railway project in the Parliament. In 2005, former minister and

MLA late Ananta Das launched efforts for realisation of the project. As a result, the state Assembly's standing committee met the then railway minister Mamata Banerjee in the UPA government to push for the project's swift implementation.

A Detailed Project Report (DPR) was prepared by October

2009-10. Later, a budget of ₹150 crore was sanctioned for the project in 2010-11.

Land acquisition in Jaleswar and Bhograi blocks for 34-km stretch of the 41-km railway line from Jaleswar in Odisha to Digha in West Bengal is in final stage while land in the remaining 7-km stretch in West Bengal has not yet been acquired, the railway minister informed. Due to this delay, the fate of the railway project has been pushed into uncertainty, reports said.

In March 2023, Railway Minister Ashwini Vaishnaw visited Bhograi block in Balasore district and offered prayers at the Chandaneswar temple. During his visit, he pledged to connect the 34-km Jaleswar-Chandaneswar route with a new railway line. Following this announcement. Balasore MP Pratap Chandra Sarangi recently confirmed that the South Eastern Railway Board has initiated a techno-economic feasibility survey for the railway project. While this news revived hopes among locals in Odisha. it left West Bengal residents concerned regarding its impact.

In the meantime, a fresh political controversy has erupted after Balasore MP announced **Tribals protest bauxite** mining in Koraput

KORAPUT: Thousands of tribal residents protested Tuesday in Koraput district against a proposed bauxite mining project in Nageswari Reserve Forest. Under the Community Forest Resource Management Commit-tees banner, people from 13 gram sabhas in Nandapur block opposed the project, citing environmental and livelihood threats. They submitted a memorandum to Nandapur tehsildar Prabhati Jhodia, urging President Droupadi Murmu to intervene, alleging violations of the Forest Rights Act (FRA), PESA Act, and Fifth Schedule rules. "The lease violates FRA which requires gram sabha consent. We were neither consulted nor did we approve it," it read. A public hearing was held March 6. "The memoran-dum will be sent to the state government," Jhodia said

22.76 gm brown sugar seized in Boudh; 3 held



Boudh, March 18: The police in Boudh confiscated 22.67 gm brown sugar and arrested three persons in connection with the peddling of the narcotics during a raid at a hideout in the district.

Addressing a press conference at the district police headquarters Tuesday, Superintendent of Police (SP) Rahul Goel said the drug seizure and arrests were made Monday. He identified the arrestees as Prabhakar Parida alias Pintu, 20, from Bagicha Sahi, Shibananda Gahir alias Shiba, 20, from Podapoda and Pritam Dehuri alias Bhalu, 21, from Irrigation Colony of the town.

He said apart from the narcotics, officers seized ₹15,920 cash, three mobile phones, a wristwatch, a motorcycle, a bus ticket, and other items from the accused persons. The estimated street value of the confiscated drugs is approximately ₹2.2 lakh

Giving details about the drug

bust. Goel said it followed on the receipt of a tip-off about narcotics trafficking near Ramjangi Nala, between Raithani Bypass and Butupali Road. "Acting on the information, a police team conducted a raid at around 4:04 pm Monday which resulted in the arrest of the trio and recovery of the contraband, and other articles," Goel added.

Preliminary probe has revealed that the accused procured the narcotics from a place in Jaleswar of Balasore district, not far from the Odisha-West Bengal border.

Goel said a case (number 159/25) has been registered at Boudh police station against the accused who were produced before a court for remand. Boudh police Station Officer Ranjit Kumar Muni was present at the press conference.

Nevertheless, this is for the first time that brown sugar has been seized in Boudh, sparking discussion among residents about the arrival of synthetic drugs in the quaint township.

Girl dies, cousin critically injured in wall collapse POST NEWS NETWORK

Hatadihi/Chhenapadi. March 18: An eight-year-old girl was killed while her five-year-old cousin was critically injured when portion of a mud wall collapsed and fell on the kids at Badarampas village under Hatadihi block in Keonjhar district, Tuesday morning.

The deceased has been identified as Snehalata Sahu, 8, niece of Maheshwar Sahu. Her cousin and Maheshwar's son, Saiprasad, 5, is currently undergoing treatment at the Anandapur Sub-Divisional Hospital.

According to sources, Snehalata had been living with her maternal family following her father's death. She was preparing to leave for school to appear in an examination while Saiprasad was sitting near her. At around 6:30 am, while she was taking breakfast, a section of the mud wall collapsed on the children.

Family members and neighbours rushed to rescue the children and took them to the hospital, where doctors declared Snehalata dead on arrival. The Nandipada police arrived at the hospital, took the body for post-mortem. A case of unnatural death (Case No. 2/25) has been registered, Inspector Rabindra Patra informed.

Anandapur MLA Abhimanyu Sethi and Badarampas Sarpanch Rabindra Kumar Jena expressed their condolences over the demise of the child. Meanwhile, the village sarpanch is actively coordinating efforts to secure immediate government assistance for both families.

ICC's Prestige

t a time when the strength and credibility of the International Criminal Court (ICC) is under question, the arrest of former President of the Philippines Rodrigo Duterte on a warrant issued by the ICC is a proof that the international body is needed to bring high profile politicians who have committed crimes against humanity, to book. It also becomes clear that the ICC can become effective only when there is political will in the ruling dispensation of a nation executing its arrest warrant. For, though the ICC had made a tight case for Duterte through its painstaking efforts, the arrest, as in many other cases, would not have taken place had the government of Philippines not shown the resolve to hand him over for trial and flown to The Hague for the purpose. The warrant was executed by the government headed by President Ferdinand Marcos Jr., and the decision appears to be a fallout of his serious differences with Vice-President Sara Duterte, Rodrigo Duterte's daughter who is now facing impeachment proceedings.

While the recent developments may appear swift, the case against Duterte has been meticulously constructed over seven years. In 2018, the ICC initiated a preliminary inquiry into allegations of crimes against humanity committed by Duterte. This led to a full criminal investigation in 2021. To save himself, Duterte withdrew the Philippines from the ICC believing that through that action he would be able to keep himself out of the purview of the court.

His arrest has a highly symbolic value for the embattled court because it has been able to demonstrate that it can continue its work and fulfil its mandate while it is under significant pressure from various directions. An evidence of such pressure is the aggressive economic sanctions US President Donald Trump has imposed on the ICC and travel bans on its staff, while the chief prosecutor, Karim Khan, is himself facing an investigation into allegations of sexual misconduct, which he obviously denies.

Khan, despite issuing high-profile arrest warrants against Benjamin Netanyahu, Vladimir Putin, and the Taliban's supreme leader, Hibatullah Akhundzada, has not yet tasted success in securing their arrests. There is pressure on Khan to deliver and the Duterte case may help. However, this process began under his predecessor and there is a team of people which has been putting its best efforts for years. As such the case is not his personal victory.

For the victims of Duterte's actions, this is a defining moment. The former president's brazen admissions of various crimes in his so-called war against drugs created the impression that he was untouchable - but now, he is in The Hague, awaiting trial. This also helps make the court appear effective enough though it has to rely on respective countries where the perpetrators reside for arresting them and setting in motion the trial process. It is a good sign that within days of securing the arrest warrant it acted effectively and quickly. Duterte's arrest should serve as a warning to other leaders. They need to comprehend that their fortunes can change and they too could find themselves being flown to The Hague. However, it proves, as the Duterte case shows, that justice hinges only on the political will of a ruling party leader seizing an opportunity to take down a rival.

The remarkable development in the Philippines makes it clear that arrest warrants for figures such as Putin or Netanyahu may testify to the court's resolve, but they also lay bare its limitations and impotence since there is no chance of either leader being detained in the near future. Still, Duterte's arrest is a rare moment for the court to heave a sigh of relief and get legitimacy of its work to make perpetrators of crimes against humanity accountable. This is no mean achievement in the present day and time.

RISKS OF GREENHUSHING

s the world becomes increasingly unstable, with the security that many people took for granted called into question, climate change, once viewed as the defining challenge of our time, has been sidelined by geopolitics, which has brought issues such as rearmament and the race for AI supremacy to the fore. But rising seas, protracted heatwaves, and devastating storms are not just risks; they are realities. The threat posed by climate change is obviously growing, but many corporations and even climate innovators have gone silent.

The rise of "greenhushing" when companies downplay environmental goals for financial or political reasons - reflects not just changing communications strategies, but rising tensions between competing priorities. Amid new geopolitical conflicts and economic pressures, some argue that sustainability has become an unaffordable luxury. But one should not assume a trade-off between sustainability and security. On the contrary, if we frame climate change, security risks, and economic needs as competing priorities, we risk losing on all fronts.

immediately to change course. The era of "peace dividends' and low interest rates is behind us. The task now is to adapt to an era of capital scarcity and geopolitical fragmentation. We can no longer ask whether climate action is important, but how it can be integrated into a rapidly changing global landscape. That means abandoning outdated approaches and forging a cohesive strategy that combines security, innovation,

and sustainability. In today's political climate, many will see greenhushing as a reasonable strategy. Like US corporate managers' back-pedaling on DEI and other issues that have been consumed by the culture war, keeping a low profile on environmental matters might seem pragmatic. But, by creating the illusion that sustainability is less urgent or feasible than it really is, greenhushing carries significant risks.

For starters, de-emphasizing sustainability threatens to slow green innovation just when it is needed most. Greenhushing could erode consumer trust and sap momentum in industries that have already started to build a carbon-neu tral future. In time, this will prove far costlier – both economically and environmentally – than any risks associated with remaining committed to mitigation and adaptation.

Worse, there could be a "lemming" effect across industries. If everyone assumes that sustainability is being abandoned, then everyone will abandon sustainability. The peer pressure that has been driving private-sector progress on this issue will vanish.

Despite these hurdles, there is still hope. The shift toward a more sustainable economy has begun, even in the United States. While the pace of progress may slow, the direction of travel need not change. In adjusting to new realities, the ultimate goal

should be to stay the course. Sustainability is a strategic imperative. Many companies - large and small, across everv continent - already recognise this, and have developed business models that combine profitability and environmental responsibility. Their success shows that adapting to this new era does not mean abandoning long-term goals. Instead, it means identifying new sources of value, investing in eco-efficient infrastructure, and aligning sustainability measures with cost-savings and resilience.

But public-private cooperation is also essential. Markets alone cannot deliver when priorities are constantly and abruptly shifting (say, from sustainability to AI to defence). Governments must step in to help stabilise expectations, and they can do so through public-private initiatives that tie sustainability to national security. For example, publicly

supported investments in clear energy and resilient supply chains can reduce reliance on fossil fuels, which in turn will strengthen economic resilience and diminish the importance of geopolitical competition.

While a coordinated, global approach would be ideal, regional, local, and sector-specific initiatives are probably more likely to succeed in today's fragmented political landscape. The key is to align financial incentives with sustainability goals to ensure that climate action is not sidelined in favour of short-term gains.

The collective project that all countries embarked on ten years ago - with the Sustainable Development Goals and the Paris climate agreement must remain our North Star, even if pragmatism demands strategic tacking along the way. This is no time for cynicism or despair. Any blame that should be assigned would be best directed toward those who are cynically exploiting the situation to reap short-term gains. Any company making a good-faith effort to recalibrate its strategy deserves support.

We must remain pragmatic yet resolute. We had a chance to act when times were easier, but that window has closed. Rising temperatures, extreme weather events, and biodiversity loss are not distant threats; they are here, and they are compounding geopolitical tensions. Greenhushing may feel like a convenient response to today's challenges. but it is not a sustainable one. Silence will not save us.

We need the opposite of greenhushing: bold, united action that weaves climate priorities into our economic and geopolitical strategies. Business leaders who do not speak up now will later regret it.

Recruiter: "How much flying experience do you have? We require a minimum of five years to be a pilot for South Asian Airlines." Applicant: "I have seven

years of flying experience so far.'

Recruiter: "Excellent. Can vou tell what vou've flown?" Applicant: "Mostly drones. None of them have crashed. Very smooth landing every time.

Recruiter: "Very good. We will keep your application on file, just in case we cannot find someone who has flown ... you know ... an actual plane."

Hiring unqualified people for certain positions can jeopardize public health and safety. But it nevertheless happens US president has appointed several unqualified people to cabinet positions, most notably Robert F. Kennedy Jr., an anti-vaccine activist, as Secretary of Health and Human Services.

Jobseekers are inclined to exaggerate their qualifications, hoping they will not only land good jobs but manage to hang onto them, perhaps by learning on the job. That's what an Indian woman named Smitha Johny apparently attempted to do when she applied to be a radiographer in Britain. According to news reports, Johny claimed to have 23 years of experience as a radiographer (also known as a radiology technician) in India, but her health experience consisted almost entirely of being a hospital receptionist. But it's easy to get "radiographer" and "receptionist" mixed up. Both are 12-letter words beginning with 'R.'

Johny was hired to work at North Downs Hospital in Ca-

apparent that her radiography skills were seriously lacking. According to a report in the Daily Mail, a colleague was assigned to help her, but that didn't seem to be enough.

Johny's manager, Fernando Pinto (no relation to Freida), told a tribunal last week that he noticed her following incorrect procedures with patients and gave her a performance review after three months on the iob. She told him she had used a CT scanner in India, but not an x-ray machine. Testing her knowledge, Pinto pretended to be a patient and asked her to take a hip x-ray. Instead, she pointed the machine at his leg. Pinto determined that she

was clueless about the x-ray machine; she could not perform even a basic foot x-ray. She also had trouble with basic anatomy. When he asked her to point to a particular bone in her wrist, she pointed to the wrong one.

Researchers Akshay Singhal, M Kavya and Sanjeev K Jha, from the Indian Institute of Science Education and Research, Bhopal, proposed an analytical framework for developing a 'CAVI' score, or 'combined avalanche vulnerability index'. "The CAVI shows that all the

They added, "The most vulnerable district in Uttarakhand is Chamoli.

Earlier this month, an avaanche hit a Border Roads Organisation camp in the village of Mana, located in Chamoli, killing eight workers.

The team also assessed each of the 11 district's avalanche risk based on exposure, sensitivity and adaptive capacity. Meteorological factors, such

as rainfall, snow depth and temperature, contribute towards a district's 'exposure' to avalanches, while slope and population are among those affecting 'sensitivity', the authors explained.

Sambhal goes human-mode for sehri calls, azaan

Sambhal (UP), March 18: It is 3 am and the only figure visible in Sambhal city's darklit bylanes is a lonesome man, walking down lazily with a kaftan loosely draped around his neck and a green 'saafa' covering his head.

Ever since the beginning of Ramzan, Mohammad Suhail has been giving a wake-up call to the 'rozedaars' (people observing fast during Ramzan) to begin their 'sehri' (the meal before the fast).

With a drum hanging around his neck, Suhail shouts, "Uth jao bhaiyo, sehri kaa time ho chuka hai..." He repeats his message twice and then beats



the drum.

Muslims have been forced to return to the rather primitive practice due to the Uttar Pradesh government's banning loudspeakers at religious places in 2022. "Now, it is 3 am. It is the time for sehri. Loudspeakers

are not allowed, so people who are sleeping are unable to get up. For them, I beat the drum, so that the 'rozedaars' can wake up, and perform their 'sehri' and then observe the fast," Suhail told PTI Videos.

Suhail is not alone made to

strain his vocal cords. With the loudspeakers gone, muezzins too are now giving 'azaan' - a call for prayer - shouting from the mosques' rooftops.

Several loudspeakers, appar ently taken off mosques, lay be fore policemen when PTI visit ed a local police station.

An Imam was fined Rs 2 lakh for allegedly using a loudspeak er for azaan beyond the permissible decibel limits December 13 last year.

Sambhal shot to front-page headlines after riots broke out there last November following a survey of the Mughal-era Shahi Jama Masjid. Four people were killed and several, including police personnel, were injured in the clashes.

That both Hindus and Muslims participated in the back to back events Sunday evening at the Shiv Vatika park in front of the Baba Avdheshwar Nath Temple in Avadhpuram Colony makes it even more special.

In fact, the name Shiv Vatika was given by a Muslim resident of the locality and the community also contributed to the construction of the temple, said Rajesh Tiwari, president of the Avadhpuram Welfare Society.

"In today's era, organising a roza-iftaar in Shiv Vatika may surprise many people but we all have to remember that Avadhpuram has been living the Ganga Jamuna tehzeeb of Avadh and



will continue to do so in future,' added Arif Ali Siddiqui, secretary of the society. According to residents of the area, the Shiv temple and the park in front of it have been constructed with their own resources.



They also demanded the inclusion of the stampede deaths in the statement. Members of the Congress, TMC and other Opposition parties then stormed the Well, raising slogans, while Samajwadi Party members staged a walkout in protest.

Parliamentary sources said the opposition parties demanded a discussion on the Maha kumbh so that their members could share their views on the subject. They had demanded a discussion on the Mahakumbh at a meeting of the Business Advisory Committee of the House. As many as 30 pilgrims were killed and 60 injured in a stampede at the Mahakumbh January 29.

The original FIR named 17 accused under Sections 302 (murder), 307 (attempt to mur der), and 396 (dacoity with mur der), among others offences of the IPC. Of the total accused, 14 persons died during the pendency of trial whereas one was declared an absconder.

New Delhi, March18: India Tuesday slammed Pakistan for "spreading lies" on Kashmir and said that the country which continues to actively promote cross-border terrorism should "vacate" the Indian territory held under its illegal and forcible occupation.

"We note that Pakistan has once again made some comments about the Indian Union Territory of Jammu and Kashmir. The world knows that the real issue is Pakistan's active promotion and sponsorship of cross-border terrorism. In fact, this is the biggest roadblock to peace and security in the region. Instead of spreading lies. Pakistan should vacate Indian territory under its illegal and forcible occupation," Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal said in a statement

The MEA spokesperson was reacting in response to media queries regarding comments made by the Pakistan Foreign Office Monday in which Islamabad had labelled the recent remarks made by Prime Minister Narendra Modi on the issue of terror activities in the neighbouring country



"misleading and one-sided". In a wide-ranging interview with the US-based podcaster Lex Fridman, PM Modi said that Pakistan has become the epicentre of terror, causing immense suffering not just to India, but to the entire world.

"Wherever terror strikes in the world, the trail somehow leads to Pakistan. Let's take the September 11 attacks, for example. The main mastermind behind it, Osama bin Laden, where did he eventually emerge from? He had taken refuge in Pakistan. The world has recognised that in a way terrorism and the terrorist mindset are deeply rooted in Pakistan. Today, it stands as an epicentre of terror, not just for India but for the world," PM Modi pointed out.

Prime Minister Modi had also asked Islamabad to abandon its path of self-sponsored terrorism for the larger good of its people.

He said that the people of Pakistan deserve a future free from violence and fear and wished that the country learns from its mistakes and chooses the correct path.

"We repeatedly asked them what good could come from this path. We have urged them to abandon the path of state-sponsored terrorism for good. What do you hope to gain by surrendering your nation to lawless forces..." he said. Sharing insights on his efforts to broker peace with Pakistan. PM Modi told Fridman about India's sincere efforts to establish peace and recalled his visit to Lahore and inviting the Pakistani counterpart to his swearing-in ceremony though the 'noble attempts were met with hostility'.

"When I became PM, I specially invited Pakistan to my swearing-in ceremony so that we could turn over a new leaf. Yet, every noble attempt at fostering peace was met with hostility and betrayal. We sincerely hope that wisdom prevails upon them and they choose the path of peace," he said in a statement.

Meanwhile, conveying his concern over cross-border terrorism, Defence Minister Rajnath Singh Tuesday urged his counterpart from the Netherlands, Ruben Berkelmans to ensure that Dutch companies do not provide weapons, platforms or technology to Pakistan, sources said.

After the meeting, Singh in a post on X said they looked forward to "further deepen and elevate" the bilateral defence partnership.

New Delhi, March 18: Opposition MPs Tuesday blamed the BJP-led Maharashtra government for the Nagpur violence, while Union minister Ramdas Athawale said the movie 'Chhaava' stoked people's sentiments against 17th century Mughal king Aurangzeb.

Curfew has been imposed in several areas of Nagpur city after a protest against Aurangzeb's tomb Monday triggered violence during which several houses and vehicles were vandalised. "Demands are being raised about Aurangzeb's grave, a movement is going on. The grave has been there for 500 years, but after watching the Chhaava movie, the way he murdered Sambhaji Maharaj, that has made people angry," Athawale told reporters

outside Parliament. "That is why protests are happening. We appeal to the protesters that they should agitate peacefully. There should be no violence," he added. Aam Aadmi Party (AAP) MP Sanjay Singh said the violence in Nagpur was part of a planned conspiracy

"BJP had been trying to spread hatred in Nagpur and the whole of Maharashtra for a long time. As long as the BJP is there, there cannot be peace in India. Ahead of Holi, they tried to disrupt peace in Uttar Pradesh, what is the reason behind it? It is so that people can't talk about the crashing share market, economic disparity is at its highest in hundred years, there is unemployment," he said. "Ye chilla rahe hai Aurangzeb, Aurangzeb, janta kah

rahi hai kat gayi jeb...(They are shouting Aurangzeb, people are saying their pockets are being picked)," he said.

Congress leader Karti Chidambaram said it was unfortunate that in 21st-century India, people are agitating over the history of the 17th and 18th centuries. "It is most unfortunate this kind of violence has broken, the state and Union government must take steps to quell it. I am baffled why this violence happened," he told the media outside Parliament Azad Samai Party MP Chandra Shekhar said the government was trying to distract attention from issues of unemployment and poverty.

"Riots, whether in Nagpur, Manipur, or Uttar Pradesh, are not good. There should be strict action against those who are behind the violence, whether they are BJP leaders or Congress leaders..." Chan-dra Shekhar said. "Centre should demand an explanation from the state government, which is fuelling this communal polarisation.

The world is talking about going to space, we want to go two feet under the ground, how is that going to help us become a developed country? Everyone knows which party's agenda this is..." he told the media out side Parliament.

TMC MP Sagarika Ghose said the confrontation in Nagpur exposed the Centre's 'Viksit Bharat' slogan as hollow. "At a time when the focus should be on employment, farmer suicide. rising prices, what is BJP doing? It is creating yet another weapon of mass distraction," she said.

Christian Michel not convicted, can't get remission, says Tihar

Bangalore, March 18: The Enforcement Directorate conducted searches in Bangalore Tuesday as part of an alleged foreign exchange violation case against US billionaire George Soros-founded 'private funding agency' OSF and its investment arm EDF, official sources said. Eight premises of some of

the beneficiaries of Open Society Foundations (OSF) and Economic Development Fund

(EDF), including those linked to some international human rights bodies, and a company named Aspada Investments Pvt. Ltd. were searched under the Foreign Exchange Management Act (FEMA), the sources said.

The Enforcement Directorate (ED) sources called Aspada Investments as the investment adviser or fund manager of Soros EDF (SEDF) in India and as a "wholly-owned subsidiary" of a Mauritius entity. The SEDF is the "impact investment arm

of the Open Society Foundations (OSF)", the sources said. The investigation pertains

ED searches Soros' funding agency

to alleged foreign direct investment (FDI) being sourced by the two Soros entities and the utilisation of these funds by certain beneficiaries in alleged contravention of FEMA guidelines.

The ED sources said the initial probe found that OSF was put under the "prior reference category" by the Ministry of Home Affairs (MHA) in 2016,

thereby "restricting" it from giving "unrgulated" donations to NGOs in India.

In order to "bypass" this restriction, OSF had subsidiaries in India and brought in funds in the form of FDI and consultancy fees, and these funds have been used to fund activities of the NGOs which is a FEMA "contravention", they said. The agency, the sources said, is "examining" the end use of other FDI funds brought in by Soros EDF and OSF.

In a tragic incident earlier Sunday, a 43-year-old worker died and two others were injured while cleaning a sewer in southeast Delhi's New Friends Colony. The victim, Panth Lal Chandra, was working on a Delhi Jal Board (DJB) sewer around 5.45 pm Sunday when the accident occurred, police said in a statement earlier.

Yogendra Jha, secretary of the NGO Centre for Social Security Action and Research (CSSAR), called for strict action against those hiring labourers for manual scavenging. "Manual scavenging is banned in



India, yet people continue to do this work without proper protective equipment, risking their lives just to support their families," he said. Jha said the government departments often outsource sanitation work to contractors, who, in turn, employ daily wage workers for sewer cleaning.

"The government must establish a dedicated committee to monitor such incidents and take necessary action to prevent further loss of life," he added. Centre for Holistic Development (CHD) Executive Director Sunil Kumar Aledia stressed the need for better enforcement of the ban.

"There are machines available for cleaning sewers, yet workers are still being sent into manholes to cut costs. Constant monitoring is essential because manual scavenging continues in the open despite the law," he said in a statement.

Manual scavenging is banned and mandates rehabilitation for those engaged in the practice, according to the Prohibition of Employment as Manual Scavengers and Their Rehabilitation Act, 2013. Emergency response teams, including the fire brigade and local police, pulled out the three workers from a manhole in an unconscious state Sunday. Chandra was declared dead at the hospital.

The police have registered a case under Section 105 of the Bharatiya Nyaya Sanhita (BNS) and Sections 7 and 9 of the Manual Scavenging Act. There was no immediate response from the Delhi Jal Board regarding the incident.

According to a Rajya Sabha data, approximately 377 people died in various states and Union Territories between 2019 and 2023 due to hazardous cleaning of sewers and septic tanks. A report by the Press Information Bureau states that around 22 manual scavengers lost their lives in Delhi between 2019 and 2022.

In hospitals strained by 15 months of bombardment, piles of bodies in white plastic sheets smeared with blood were stacked up as casualties were brought in. The health ministry said many of the dead were children, and 562 people were injured.

Macron speeds up **Rafale warplane orders**



Luxeuil-Les-Bains, France, March 18: President Emman uel Macron said France would order additional Rafale warplanes in the coming years and invest nearly 1.5 billion euros (\$1.6 billion) into one of its air bases to equip its squadrons with the latest nuclear missile technology.

Jolted by Russia's invasion of Ukraine and US President Donald Trump's more confrontational stance towards traditional Western allies, European countries are hiking defence spending and seeking to reduce dependence on the United States.

Macron, who has initiated a doubling of the French defence budget over the course of his two mandates, has recently set an even higher target, saying the country should increase defence spending to 3-3.5% of economic output from the current 2%.

He has also offered to extend the protection of France's nu clear weapons, the so-called nuclear umbrella, to other Eu ropean countries.

"I will announce in the com ing weeks new investments to go further than what was done over the past seven years," he told soldiers at one of the country's historical air bases in Luxeuil, eastern France.

German parliament approves Merz's historic spending surge

Berlin, March 18: Germanv's parliament approved plans for a massive spending surge Tuesday, throwing off decades of fiscal conservatism in hopes of reviving economic growth and scaling up military spending for a new era of European collective defence.

The approval in the Bundestag hands conservative leader Friedrich Merz a huge boost, giving the chancellor-in-waiting a windfall of hundreds of billions of euros to ramp up investment after two years of contraction in Europe's largest economy. Germany and other European nations have been under pressure to shore up their defences in the face of hostile Russia and shifts in US policy under President Donald Trump, which European leaders fear could leave the continent exposed. Merz's conservatives and Social Democrats (SPD), who are in talks to form a centrist coalition after last month's election, want to create a 500 billion euro (\$546 billion) fund for infrastructure and to ease constitutionally enshrined borrowing rules to allow higher spending on defence.

It is too early to predict the consequences. Netanyahu, Israel's longest-serving prime minister, is a proven master at smoothing over disagreements in his coalitions. An ultra-nationalist group that quit the government over the ceasefire in Gaza in January announced on Tuesday it was returning.

The European Commission proposed earlier this month to borrow up to 150 billion euros (\$163.67 billion) to lend to EU governments under a rearmament plan. For approval, the proposal requires a qualified majority, or the backing of at least 15 of the EU's 27 countries, representing at least 65% of the bloc's population. Hungary alone cannot block the plan.

China conducts air, sea drills near Taiwan







Besides, lower crude oil prices in the international markets and a weak dollar against major currencies overseas also bolstered sentiment, traders said. Rising for the second day on the trot, the 30-share BSE Sensex jumped 1,131.31 points or 1.53 per cent to settle at 75,301.26. During the day, it soared 1,215.81 points or 1.63

per cent to 75,385.76. As many as 2,815 stocks advanced while 1,221 declined and 123 remained unchanged on the BSE

The NSE Nifty surged 325.55 points or 1.45 per cent to 22.834.30. "Buoyancy across global eq-

uities boosted the confidence of local investors, which translated into value buying across the sectors. As markets were in a bearish mode over the past few weeks and valuations had become a bit attractive, inves-

tors seized opportunity in the beaten-down sectors. But the recovery would be difficult to hold on due to global challenges and fears of slowing domestic growth due to Trump's threat to impose tariffs on key economies including India, Prashanth Tapse, Senior VP (Research), Mehta Equities Ltd, said.

In the Sensex pack, Zomato emerged as the biggest gainer with over 7 per cent jump, followed by ICICI Bank, Mahindra & Mahindra, Tata Motors, Larsen & Toubro, Asian Paints, Ti tan, Kotak Mahindra Bank and

State Bank of India were among the gainers. In contrast, Bajaj Finserv, Bharti Airtel, Tech Mahindra and Reliance Industries were

the laggards. Shares of Bajaj Finserv declined over 1 per cent after the financial services firm signed share purchase agreements to acquire a 26 per cent stake owned by Allianz SE of Germanv in its insurance businesses Bajaj Allianz General Insurance Company and Bajaj Allianz Life Insurance Company.

Kia India to hike vehicle prices New Delhi: Kia India Tuesday

However, due to the rising costs of commodities and input materials, the automaker will be increasing up to 3 per cent price across all models. effective from April 1, he added. Mumbai, March 18: Life insurance behemoth LIC is confident of buying a stake in a health insurer in the next two weeks, its chief executive Siddhartha Mohanty said Tuesday.

Without identifying the company it will be buying a stake in, Mohanty said the state-owned company is in final stage of talks and hoped that a deal gets announced before March 31.

"It is a natural choice for LIC to be in health insurance, discussion is going on at final stage," he told reporters on the sidelines of the GCA25 event here.

Mohanty said LIC will not buy a controlling stake of 51 per cent or more in the target company and the exact quan-



tum of the stake buy depends on factors like the decision of LIC board and valuations.

At present, life insurance companies are not allowed to offer health covers which include covering up hospitalization and other expenses for the insured. There was a suggestion for a composite licence for insurers, but no announcement was made in this regard in the Union Budget.

As per some media reports, LIC is said to be eyeing a stake in ManipalCigna in a deal

pegged at ₹4,000 crore. In a regulatory filing issued later, the Corporation said it is in advanced talks to pick up a substantial stake in a "stand alone" health insurer and no binding agreements have been signed so far.

'The execution and ultimate consummation of the deal is subject to various factors, including approval of the Board, regulatory approvals and other approvals, if any, before executing any binding agreements. There can be no guarantee or assurance of the execution/ consummation of the potential deal," it said.

Meanwhile, the managing director and chief executive of the largest life insurer said there has been a "slowdown" in the growth of life insurance. particularly in terms of penetration lately

The slowdown has happened even as there has been a focus on enhancing the principles of insurance facilitation and moving towards a principle-based regulatory framework, he said. adding that this "dual reality' calls for a "comprehensive review" of LIC's approach.

He said actuaries will play an important role in addressing such challenges by providing objective and data-driven insights into emerging risks, developing innovative solutions to address the challenges of a changing world, ensuring the financial stability and sustainability of insurance companies.

In the third quarter of FY25, LIC reported a 9 per cent decline in its net premium income at ₹1.06 lakh crore, even though the standalone net profit increased 17 per cent to ₹11,056 crore.

The yellow metal of 99.5 per cent purity advanced by ₹450 to hit a lifetime high of ₹90.800 per 10 grams against the previous close of ₹90,350 per 10 grams. "Gold extended gains Tuesday and touched a fresh record high in the international market as well as the domestic market. The precious metal remains an attractive option for safe-haven flows due to uncertainties sur-



rounding US President Donald Trump's policies, fears of a US recession, and geopolitical uncer tainty," Saumil Gandhi, Senior Analyst of Commodities at HDFC Securities, said.

Meanwhile, gold futures jumped by ₹649 or 0.73 per cent to establish a fresh peak of ₹88,672 in the afternoon trade on the Multi Commodity Exchange.

On the global front, spot gold increased to hit a fresh high of USD 3,028.49 per ounce. Similarly, Comex gold futures quoted higher to hit a record peak of USD 3,037.26 per ounce.

Alphabet to buy Wiz for \$32bn in its biggest deal to boost cloud security

Majority of Indians long-term investors'

New Delhi: Majority of Indians are long-term investors as only 2 per cent actively trade in derivatives out of the 110 million market participants, National Stock Exchange (NSE) MD and CEO Ashish kumar Chauhan has said. This suggests the growing culture of disciplined, sustainable investment in the country. "Out of 110 million market participants, only 2 per cent actively trade in derivatives. The majority are committed to long-term investing," he stated. At a recent panel discussion in Singapore, he dispelled the notion that India's stock market is driven primarily by speculative trading.

San Francisco, March 18: Alphabet said Tuesday it would buy Wiz for about \$32 billion in its biggest deal as the Google parent doubles down on cybersecurity to sharpen its edge in the cloud-computing

race against Amazon.com and Microsoft. The all-cash buyout comes after Wiz rejected a \$23 billion bid from Alphabet last year

due to concerns about antitrust approvals and its aim to focus on an initial public offering

Acquiring Wiz will help Google bolster its cloud business with AI-powered cybersecurity solutions that com-

panies use to remove critical risks, helping it compete better in an industry benefiting from the rise of generative AI services like ChatGPT.

"Cloud is more important than ever, and attackers are not slowing down. They are already using the most innovative technologies to move faster," said Wiz CEO and co-founder Assaf Rappaport, who had called Google's previous offer 'humbling'

While a tough regulatory climate in 2024 had hampered such large-scale deals, Wall Street is optimistic that a shift in antitrust policies under US President Donald Trump could reignite dealmaking momentum.

One of the fastest-growing software startups, Wiz was valued at \$12 billion in a funding round last May. It works with cloud providers such as Amazon Web Services, Microsoft's Azure as well as Google Cloud and counts Morgan Stanley, BMW and luxury powerhouse LVMH among its customers.

After the deal closes, Wiz will join Google Cloud business which generated more than \$40 billion in revenue in 2024 and has outpaced growth in the search business in the recent years.

Wiz's products will continue to be available across all other major cloud services. Alphabet expects the deal to close in 2026, subject to regulatory

approvals.

DA Davidson analyst Gil Luria said the higher price is based on another year of exponential growth for Wiz.

"For Google to be able to compete with Microsoft Azure for enterprise customers, it needs to be able to offer a deeper suite of services, including security software," he said.

This is the not the first time Google has struck a big deal for a cybersecurity company. In 2022, it bought Mandiant for \$5.4 billion, outbidding Microsoft in a high-stakes contest.

Interest in the cybersecurity industry has been rising since last year's global CrowdStrike outage roiled operations across industries, prompting

companies to spend more on safeguarding their online do mains.

Google had \$23.47 billion in cash and cash equivalents as of Dec. 31, implying it might have to seek financing for the deal.

The company, which has kept aside \$75 billion in capital expenditure for 2025 mostly for AI investments, said Tuesday its capital allocation plans remain unchanged.

Shares of Google were down nearly 3% in early trading amid broader market weak ness. They had risen about 35% last year, but have lost 13% this year on investor worries over its hefty AI spending against the backdrop of Chi na's lower-cost DeepSeek.




