





### **Centre approves** Sujata Karthikeyan's retirement plea

Bhubaneswar, March 29: Senior Odisha cadre IAS officer Sujata R Karthikeyan, wife of BJD president Naveen Patnaik's former close aide VK Pandian, has been granted permission to take voluntary retirement from government service, official sources said Saturday.

The approval to her request for voluntary retirement was informed to Chief Secretary Manoj Ahuja by Under Secretary in the Ministry of Personnel, Public Grievance and Pensions, Bhupinder Pal Singh through a letter.

Sujata, a 2000-batch officer, was the special secretary in Finance department. She had applied for voluntary retirement owing to personal reasons. In May 2024, the Election Commission had ordered her transfer to a department where she would not deal with the public following allegations of misuse of her office. She was then on a six-month leave after BJD lost the elections in 2024. She was granted Child Care Leave till November 26 last year, but her application for extension was rejected by the state's BJP government.

New York/Washington, March 29: US President Donald Trump has described PM Narendra Modi as a 'very smart man' and his 'great friend' while emphasising that tariff talks between the US and India would 'work out very well'.

The remarks assume significance as they came the same day Foreign Secretary Vikram

Misri spoke with US Deputy Secretary of State Christopher Landau to discuss bilateral trade, including the reduction of barriers to achieve a balanced trade relationship.

"PM Modi was here just recently and we have always been very good friends," the US president said in the White House Friday. The remarks came days before Trump's reciprocal tariffs on the US' trade partners kick in April 2. **P7** 

# 18 Naxals killed in twin encounters

government's goal of eradicating Naxalism before March 31, 2026, security forces Saturday eliminated 18 Left Wing Extremists (LWEs), including 11 women, during encounters in Chhattisgarh's Sukma and Bijapur districts. Four security personnel are said to have received injuries in the gunfights which have become a norm in the jungles of the mineral-rich state, of late. The encounters came 10 days after 30 members of the banned CPI (Maoist) were eliminated in two separate encounters in Bijapur and Kanker districts. With Saturday's encounter, a total of 134 Naxals have been gunned down in the state so far this year, while 219 of them had been neutralised last year. However, the veracity of such 'encounters' have time and again come under a cloud. One such encounter in May last year where 12 Maoists were killed, generated unprecedented controversy after villagers staged protests terming it as cold-blooded mass murder of innocent tribals

The encounters occurred on the eve of Prime Minister Narendra Modi's scheduled visit to Chhattisgarh.

Four jawans were injured as security teams inflicted major damage on Naxals, killing 17 cadres, including a high-ranking Maoist, identified as Kuhdami Jagdish, carrying a reward of Rs 25 lakh on his head, in Sukma, police said.

He was wanted in more than a dozen deadly Naxal incidents, including the 2013 Jhiram Valley attack that left several Congress leaders dead. Another encounter was

reported from the neighbouring Bijapur district where one Naxal was killed, a police officer said.

Among the four injured security personnel, three be-Guard (DRG), a unit of the includes Sukma

state police, while the fourth is from the Central Reserve Police Force (CRPF), they said.

Union Home Minister Amit Shah hailed the Sukma encounter, saying those carrying weapons and resorting to violence cannot bring change but peace and development can.

"Another strike on Naxalism! Our security agencies have neutralised 16 Naxalites and recovered a massive cache of automatic weapons in an operation in Sukma. he wrote on 'X'.

## MYANMAR QUAKE TOLL CROSSES 1,600

Bangkok, March 29: Myanmar's ruling military said Saturday on state television that the confirmed death toll from a devastating 7.7 magnitude earthquake rose to 1,644, as more serving as the Commission- bodies were pulled from the er-cum-Secretary of Mission rubble of the scores of build-Shakti department. The new total is a sharp rise compared to the 1,002 total announced just hours earlier, underlining the difficulty of confirming casualties over a widespread region and the likelihood that the numbers will continue to grow from Friday's quake.

IMPHAL: An earthquake of 3.8 magnitude hit Manipur's Noney district Saturday, officials said. There was no immediate report of any loss of life or damage to property, they said. The earthguake took place at 2.31 pm. and the location was in Noney district of the northeastern state. the National Center for Seismology said. The depth of the quake eastern states fall in the high frequently hit the region.

# **Assembly clears Appropriation** Bill 2025 as BJD stages walkout

Bhubaneswar, March 29: Amid a walkout by the opposition BJD and in the absence of suspended Congress MLAs, the Assembly Saturday passed the Appropriation Bill, 2025, allowing the state government to spend ₹2.90 lakh crore from its consolidated fund during the financial year 2025-26

This was the first full budget of the BJP government, which was presented by Chief Minister Mohan Charan Majhi in the House February 17.

"No money can be withdrawn from the consolidated fund of Odisha except under appropriation made by the law passed in accordance with the provision of the Constitution,' Majhi said, adding that two aspects are taken into consideration, one is the size of the budget, and the second is the fiscal discipline.

The budget for the financial year 2025-26 is based on these two criteria, he said

"If we look at the size of the



budget, it is ₹2.90 lakh crore, which is about 10 per cent more than that of the 2024-25 fiscal. Out of this total estimate, the proposed programme expenditure is ₹1.70 lakh crore, which is 59 per cent of the total budget estimate," Majhi said.

He said the capital expenditure estimate of ₹65,012 crore in the current budget is 6.1 per cent of the Gross State Domestic Product (GSDP), the "highest" among all the major states in the country.

"A few days ago, I was watching an interview with the chief minister of Telangana, he was saying the financial condition not even able to spend ₹500 crore per month on capital expenditure. It is better not to talk about the financial condition of Karnataka and Himachal Pradesh." he said. However. the chief minister said that Odisha is able to spend more than ₹5,000 crore per month on capital expenditure and has also made provisions for this.

Stating that one of the key indicators of the budget is the fiscal deficit, Majhi said for the financial year 2025 26, this deficit is only ₹34,200 crore, which is limited to 3.21 per cent of the GSDP. "This is a very healthy economy. This financial management of our government is the best in the country and our government has not deviated from this goal even a little," he said.

He said this budget is based on four pillars - livelihood, infrastructure development, women empowerment and social security. These four pillars will lead to a new, strong and prosperous Odisha, he said.

### **Exotic wildlife** seized at BPIA

Bhubaneswar, March 29: Customs officials Saturday seized exotic wildlife, includ ing king snakes, monitor lizards and turtles, at Biju Patnaik International Airport (BPIA) here.

The seized wildlife concealed in chocolate boxes were being smuggled from Thai capital Bangkok to Chennai, Injeet Kumar Mohanty, a Customs official engaged at the airport, said.

Acting on a tip-off, the luggage of a person hailing from Chennai was searched and the seizures were made, he said, adding the passenger was detained and he was being ques-

against women are increasing at an alarming rate in Odisha. You will not find any single district where such horrific crimes are not happening, the memorandum stated. In the chief minister's home

district Keonjhar, a Class VI student was found pregnant in Champua area and a Class IX pupil also became pregnant at an ashram school in Telkoi.

Cases of rape and murder were being reported in Jaleswar, Dhenkanal, Malkangiri, Talcher, Rourkela, Bolangir, Kandhamal, Mayurbhanj and in every part of Odisha they alleged.

Noting that the state government has admitted in the Assembly that 20,000 women and children had gone missing in the last nine months, the Con gress stated that 1,600 cases of serious crimes against women have been registered in different police stations of the state in the last eight months.

"Sixty-one cases of rape gang rape and murder have been reported in the last eight months. Every hour, four women or girls go missing in the state and every day, eight women are raped, gang-raped and murdered," the Congress

memorandum stated. Stating that the Congress has been seeking a House Com mittee to probe the crimes and has been raising the issue both inside and outside the Assem bly, the party said the chief minister has neither made any remark nor formed the panel

## Drugs young bankers use to survive the summer

These days, drugs are more a **⊥** tool to optimize performance on the job. Especially for entry-level bankers at the analyst and associate level—who work long, tedious hours and fiercely compete for higher-level jobs with big pay days-prescriptions for stimulants such as Adderall and other ADHD drugs have become commonplace.

Jonah Frey, who worked as an investment banker in healthcare for Wells Fargo in San Francisco, said one colleague would sometimes snort lines of crushed up Adderall pills from his desk in the bullpen—the common area where junior bankers sit and work together. "Nobody blinked an eye," he said

Others use nicotine pouches such as Zyn to excess, or consume energy drinks. One banker who worked in Houston between 2017 and 2019 described his colleagues drinking "Monsterbombs"—an extra-strength five-hour Energy shot dropped into a glass filled with Monster Energy, chugged in one go. The caffeine payload was the equivalent of nearly five cups of coffee at once.

The feeling that the jobs can't be done without stimulants comes as Wall Street is under fire for pushing junior bankers to take on dangerous workloads.

A Wall Street Journal investigation in August about Bank of America's treatment of young bankers put a spotlight on long hours that violate its policies and cause health problems. One junior banker died in May after putting in over 100 hours a week for about a month to finish work on a \$2 billion acquisition. After the article's publication, Bank of America and the wider industry said they would crack down on

overwork. Morgan Stanley, for example, now asks junior bankers to report their hours and will intervene in some cases to make sure they don't go over 80 hours a week. Still, interviews with more than 50 current and former investment bankers at over a dozen banks about how they cope with long hours and high-pressure jobs made clear that the use of stimulants is openly discussed and visible in workplaces.

Most banks mentioned in this article either declined to comment or didn't respond to requests for comment.

Broadly speaking, banks said they were focused on improving working conditions for employees. Some said they viewed these examples as isolated cases and said employees made their own health decisions regarding prescription medication.

## **Religious Freedom**

ach year, the United States Commission on International Religious Freedom (USCIRF) names those nations whose governments engage in or tolerate "particularly severe" violations of religious freedoms, especially of minorities. It calls such nations Countries of Particular Concern (CPC) and asks the US State Department to sanction individuals and institutions in these nations.

This year, these are Afghanistan, Burma, China, Cuba, Eritrea, India, Iran, Nicaragua, Nigeria, North Korea, Pakistan, Russia, Saudi Arabia, Tajikistan, Turkmenistan, and Vietnam.

India first came on the list in 2020 and has been on it each year since. In the 2020 report, USCIRF said that "India took a sharp downward turn in 2019. The national government used its strengthened parliamentary majority to institute national-level policies violating religious freedom across India, especially for Muslims." It said the Modi government's prejudice against India's Muslims was showing through India's actions on citizenship laws, cow slaughter, Kashmir, and conversions. The report noted the Ayodhya ruling and the conduct of the Uttar Pradesh Chief Minister Yogi Adityanath. It recommended to then-US President Donald Trump that he designate India as a Country of Particular Concern "for engaging in and tolerating systematic, ongoing, and egregious religious freedom violations, as defined by the International Religious Freedom Act." It

sought sanctions against India. The response from our Ministry of External Affairs (MEA) was as follows: "We reject the observations on India in the US-CIRF Annual Report. Its biased and tendentious comments against India are not new. But on this occasion, its misrepresentation has reached new levels. It has not been able to carry its own Commissioners in this endeavor. We regard it as an organization of particular concern and will treat it accordingly." India did not respond to a single accusation or deny any of the facts

The reference to "carry its own Commissioners" is about dissenting notes from two of the commissioners, Gary Bauer and Tenzin Doriee, who agreed with the other seven commissioners that the situation in India was problematic but did not want it to be designated a CPC.

The next year, 2021, the report noted India's "disinformation and hateful rhetoric — including from government officials — often targeted religious minorities continuing familiar patterns" during the COVID-19 pandemic.

This time there were no dissents, and from here on, each of the four years under President Biden, there have been none. In 2021, the government of India did not respond. This has been the pattern since, and sometimes India has hit out and at other

In the 2025 report, released on March 25, the USCIRF said, among other things, that the Trump administration should "impose targeted sanctions on individuals and entities, such as Vikash Yadav and RAW, for their culpability in severe violations of religious freedom by freezing their assets and/or barring their entry into the United States.'

Within hours, our MEA put out a statement that called the report 'biased and politically motivated" and attempting to "misrepresent isolated incidents and cast aspersions on India's vibrant multicultural society reflect a deliberate agenda rather than a genuine concern for religious freedom." It said that "In fact, it is the USCIRF that should be designated as an entity of concern."

One wishes that the Indian government does designate USCIRF formally and sanctions it because it is true that it is not free from bias. The USCIRF refers to itself as a "bipartisan" body, meaning both Republicans and Democrats are represented on it and it advises the US State Department. But it is partisan in other ways. USCIRF reports make no reference to the genocide in Gaza and the apartheid practiced by Israel on Palestinians, including Christians, because that is inconvenient for the US government.

It would have been better for India to have responded to the specific allegations. But in our part of the world, who says something is as important and perhaps even more important than what is being said. We should have responded specifically, particularly because it may not necessarily be true that the people saying it are biased or politically motivated against us. This is how the 2021 USCIRF report on India ended:

Individual views of Commissioner Johnnie Moore:

I love India. I have floated early in the morning down the Ganges in Varanasi, walked every alley in Old Delhi, stood in awe of the architecture in Agra, sipped tea next to the Dalai Lama's temple in Dharamsala, circled the shrine in Ajmer, and looked in awe at the Golden Temple. All along the way, I have met Christian brothers and sisters who serve the poor selflessly, often in difficult circumstances.

Of all the countries in the world, India should not be a country of particular concern. It is the world's largest democracy and it is governed by a pristine constitution. It is diversity personified, and its religious life has been its greatest historic blessing.

Yet. India does seem to be at a crossroads. Its democracy—still young and freewheeling—is creating through the ballot box difficult challenges for itself. The answer, of course, is for India's institutions to draw upon their rich history to protect their values. India must always resist allowing political and inter-communal conflict to be exacerbated by religious tensions. India's government and people have everything to gain and absolutely nothing to lose from preserving social harmony and protecting the rights of everyone. India can. India must.

# **NAVIGATING TRUMPIAN CHAOS**

S President Donald Trump's repeated threats to impose reciprocal tariffs on goods from nearly every country have set off alarm bells around the world. Trump's tariffs are likely to accelerate the ongoing fragmentation of the global economy. And, as is often the case, developing economies will bear the brunt of the fallout.

The developing world now faces a series of interconnected threats: imported inflation, driven by tariff-related costs, could trigger a global recession, lowering commodity export prices and fueling business uncertainty, which in turn would reduce foreign direct investment. To protect themselves, developing countries must find ways to navigate today's Trumpian chaos while still responding to their rapidly growing youth populations' demand for decent jobs and economic opportunities.

Achieving this requires striking a delicate balance between maintaining open markets and preserving economic sovereignty-broadly defined as a country's ability to make independent policy decisions affecting its economy. That is easier said than done.

Most developing economies in Africa, Latin America, and South and Central Asia are heavily reliant on extractive industries and cash-crop exports—sectors often dominated by multinational corporations, primarily Western ones, which are often perceived as predatory, extracting resources from developing economies while giving little in return. Despite repeated international efforts to rein in tax evasion and abusive practices, such violations remain widespread.

Few companies illustrate this better than the commodity giant Glencore. In 2023, the company was ordered to pay a

\$700 million fine after admitting to a years-long scheme to bribe officials in multiple countries. Glencore has also faced allegations of massive tax evasion, bullying governments, and fomenting violence against protesters

Glencore's behavior underscores the longstanding power imbalance between developing-country governments and multinationals. But the dynamic is beginning to shift as more governments assert their economic sovereignty and demand a fairer share of the value created by foreign investment.

Rebalancing these relationships must start with transparent contracts and stronger institutional capacity, enabling developing countries to negotiate better terms, boost tax revenue, and invest in social programs and infrastructure. Given that extractive industries are capital-intensive, well-designed policies on local content can help create positive spillovers and boost job creation. To this end, some governments require multinationals to process raw materials domestically. Botswana, for example, has leveraged its 15% stake in De Beers—the world's biggest diamond company-to increase the share of rough diamonds that are cut domestically.

Some critics may argue that developing economies should simply give up on open markets, thereby eliminating the influence of multinational corporations. But while multinationals are certainly part of the problem, they can also be part of the solution. Severing ties with them would amount to adopting an autarkic model of economic development, which would impede technological spillovers to the broader economy and restrict access to global markets and financing. Even China, despite its size and rapid growth, has never attempted such a move.

That is not to say that some adjustments won't be required. It is now widely accepted that small and medium-size enterprises (SMEs) drive job creation in developing countries, but the reality is far more complex. In most, labor markets are bifurcated: on one side are state-owned and private companies, including multinationals; on the other, informal, low-productivity

SMEs that struggle to pay living wages. And the few SMEs that manage to scale up tend to concentrate talent, financing, and access to international

A more effective approach would be to adopt a hybrid industrial policy that combines temporary subsidies for SMEs-with unambiguous sunset clauses-and competitive pressures that reward performance and limit waste. Perhaps more importantly, multinational corporations should be welcomed, but with strong incentives to facilitate technology sharing and localize production in ways that create high-quality jobs.

China offers a useful model.

After joining the World Trade Organization in 2001, the country facilitated technology transfers by effectively forcing foreign corporations to enter joint ventures with Chinese firms. What made this possible was both the appeal of China's low-cost labor and the promise of access to its vast and rapidly growing domestic market. By contrast, other Asian countries like Bangladesh and Vietnam have made enormous efforts to attract multinational corporations but have struggled to localize production and expertise.

The broader lesson is that in a fragmenting world economy, multilateral organizations must do more to support the provision of public goods in developing countries. As the push for economic sovereignty gains momentum, multinational corporations must heed developing economies' demand for a fairer share of the gains from global economic growth and ensure that the benefits of open markets are

## There's no alternative to peace



**THE EARTH HAS ENOUGH RESOURCES FOR EVERYONE TO LIVE IN PEACE AND PROSPERITY IF MANAGED** COOPERATIVELY

he world is in dire need of peace and security, as violent conflicts and wars have disrupted global stability and made life insecure. The Gaza and Ukraine wars highlight the failure of world leaders to prevent such conflicts. In January 2025, American President Donald Trump took a controversial but bold initiative to stop the war in Ukraine, demonstrating a determination to end the conflict.

In international theory, the absence of war does not guarantee peace. Durable peace requires the creation of appropriate social, economic, and political structures. The international community must engage in building these structures, as existing organizations like the United Nations have failed to generate momentum for peace or prevent conflicts.

The Raisina Dialogue 2025. a significant international forum, included a session on peace, but it failed to produce substantial outcomes. The dialogue was marred by wrangling from European countries and their opposition to

the Trump administration. India, as the world's largest democracy without a history of intervention or aggression, is well-positioned to initiate a global peace-building process This initiative could be part of a new world order emerging from the current geopolitical Historically, the West was

defined as America plus Europe, but this definition is changing. The American Vice-President has advocated for withdrawing from Europe, reflecting a shift in US foreign policy. This new world order may introduce new power dynamics and issues, but peace will remain a priority. India's spiritual philos-

ophy. Vasudhaiya Kutumbakam, which emphasizes the oneness of humanity, can guide the creation of a peace manifesto for a unified world. This concept, rooted in ancient Indian thought. promotes a universal welfare system backed by common security. Modern thinkers like Swami Vivekananda have elaborated on these ideas, advocating for global unity and peace.

Today's world is both divided and shrinking, with communication technology reducing distances and increasing inter-dependence. However, international relations are often managed in a confrontational mode, which needs to be replaced by a solidarity mode to achieve peace.

Historically, the League of Nations and the United Nations have failed to prevent wars due to the dichotomy between their objectives and the actions of their member states. For example, Hitler's aggressive policies led to World War II under the League of Nations, and current conflicts like China's expansionist policies and Russia's actions in Ukraine highlight the UN's limitations.

The current world order is flawed, based on confrontation and competition. Instead, structures of equality, freedom, and solidarity are needed. The earth has enough resources for everyone to live in peace and prosperity if managed cooperatively. National and universal welfare state systems, along with a common security system for national

defence, can achieve this.

Scandinavian countries known for their peaceful and contented societies, offer models for universal welfare systems. These countries are at the top of the list for having peaceful and contented societies in the world. A world survey has repeatedly rated Finland as the happiest country in the world. Their systems provide cradle-to-grave care, ensuring social security for all citizens. A common security system would reduce defence expenditures, allowing countries to invest more in welfare

and development. The idea of a peace manifesto, inspired by India's spiritual philosophy and supported by practical models, is proposed for discussion. This manifesto aims to promote universal peace and security, recognizing that while there may be no alternative to war, there is no alternative to peace. The hope is that this initiative will lead to a more unified and peaceful world.

# **Andhra govt conducts** e-KYC in Kotia village

Pottangi, March 29: There is no let-up in intrusion by neighbouring Andhra Pradesh in the disputed Kotia panchayat of Koraput district as government officials from Andhra an e-KYC drive Saturday at Neredibalsa, a border village under Kotia panchayat of Pottangi block in Koraput district.

### Blasting at illegal stone quarry kills 15-foot python

Panchalingeswar, March 29: The death of a 15-foot long py thon during illegal blasting at a stone quarry has sparked wide spread discussion in the region

According to reliable sources. an illegal stone quarry under the Hatikhulia beat of Kuldiha range, located in Phase-4, carried out blasting of stones with gela tin explosives last Friday. The powerful explosion severely injured the python, which was later found trapped under the debris

In an alleged attempt to cov er up the incident, stone mafia operatives reportedly moved the injured snake about 500 metre away to the boundary of Baulagadia near Phase-5. They allegedly crushed its head with stones there before informing the Forest department.

However, concerns have been raised regarding the inaction of local Forest officials. Despite being informed, Hatikhulia Forester Jayanta Pradhan and oth er beat officers were yet to visit the site, raising suspicion over their response to the incident.

The tragedy highlights a larger issue—the rampant illegal stone quarrying and smuggling in the Debagiri hills, which threaten the region's wildlife. Residents have urged the Balasore dis trict collector to take strict ac tion against illegal stone quar ries and ensure protection of the region's wildlife.

# Discontent over substandard work under Mukhya Mantri Sadak Yojana

Keonjhar, March 29: Residents have expressed dissatisfaction over the poor quality of construction on the Haldiatangiri-Kholapa road near Keonjhar town, accusing the district administration of negligence. The road, a key connectivity project in Sadar block, is being built under the Mukhya Mantri Sadak Yojana by the Rural Development department.

According to sources, the construction is estimated to cost more than Rs 3 crore. While a contractor was initially awarded the project through a tender, he failed to carry out the work. Instead of taking legal action, the department allegedly handed the project over to another contractor with just a notice and an undertaking. Local residents questioned

the department's accountability questioning the absence of action against the original contractor. They argued that both the government and the public suffered due to the negligence,



transferred to another contractor without transparency.

Complaints have been lodged with the Rural Development department, citing substandard materials and improper construction methods. Locals reported the use of low-grade murrum and soil with inadequate rolling. Additionally, culverts and road sections are being built without diversions, causing inconvenience.

Mahanta criticised the delay in the project's completion. Although work has now resumed. the absence of the departmental engineer has affected its quality. Residents also expressed

frustration over the absence of an information board at the construction site, leaving them unaware of key project details. Junior Engineer Smruti Ranjan Behera stated that after receiving complaints, he visited the site and reprimanded the contractor. He confirmed that a notice had been issued to the previous contractor, and the project was now in the hands of a new contractor.

# **India sends NDRF** team to Myanmar

New Delhi, March 29: As Myanmar reels from death and destruction caused by a massive earthquake, India mounted a multi-agency relief mission on Saturday, delivering 15 tonnes of essential materials and dispatching more aid by air and sea, along with rescue teams, to the neighbouring country.

In a reflection of New Delhi's strong commitment to extend help, Prime Minister Narendra Modi spoke with Myanmar's Senior General Min Aung Hlaing and said India stands in solidarity with the people of that country.

India, which named its relief mission for Myanmar as "Operation Brahma", became the first country to bring rescue personnel to the capital city of Nay-Pyi-Taw to help local authorities, according to officials. Hours after New Delhi delivered 15 tonnes of essential relief materials to Yangon in a military transport aircraft, two C130J planes of the Indian Air Force (IAF) landed in Nay-Pyi-Taw, carrying a total of 80 National Disaster Response Force (NDRF) personnel and some more aid

Two more C17 military aircraft of the IAF, carrying 60 para-field ambulances, will land in Myanmar shortly, the officials said. India deployed the NDRF abroad on two previous occasions -- during the 2015 Nepal earthquake and the 2023 Turkiye quake. The total aid sent by air sorties and naval ships amounts to 137 tonnes, sources said, adding that more supplies will be sent in accordance with the requirement. "Conveyed our deep condolences at the loss of lives in the devastating earthquake. As a close friend and neighbour, India stands in solidarity with the people of Myanmar in this difficult hour," the prime minister said on X after his phone conversation with the senior military general. "Disas-

In the morning, India delivered 15 tonnes of relief materials to the Myanmarese city of Yangon after a C130J military aircraft of the IAF transported the consign-

ments to the Myanmarese city. The supplies included tents, sleeping bags, blankets, readyto-eat meals, water purifiers. solar lamps, generator sets and essential medicines, the officials said. "#OperationBrahma gets underway. First tranche of humanitarian aid from India has reached the Yangon Airport in Myanmar," Jaishankar said.

# Centre slams 'X' for calling 'Sahyog' censorship tool

Bangalore, March 29: The Centre has strongly objected to social media platform X's characterisation of the 'Sahyog' portal as a "censorship" tool, calling the claim both "unfortunate" and "condemnable."

In a detailed response submitted before the Karnataka High Court, the Centre countered the claims made by X Corp in its petition challenging India's information-blocking framework. The government asserted that the petitioner had misinterpreted the provisions of the Information Technology (IT) Act, particularly Sections

69A and 79(3)(b). X Corp has argued that Section 79(3)(b) does not authorise the government to issue content-blocking orders in a manner that bypasses the safeguards outlined in Section 69A, its corresponding blocking rules, and the Supreme Court's ruling in the Shreya Singhal case.

In a detailed response submitted before the Karnataka High Court, the Centre countered the claims made by X Corp in its petition challenging India's information-blocking

The government asserted that the petitioner had misinterpreted the provisions of the Information Technology (IT) Act, particularly

However, the government contended that Section 69A explicitly allows the Centre to issue blocking orders under specific conditions and provides multiple safeguards for online

content restriction. It stated that this section differs significantly from Section 79(3)(b), which only requires intermediaries to fulfill their due diligence obligations upon receiving notices from authorised agencies, "The Section 79 framework does not authorise 'blocking orders.' Instead, it merely notifies intermediaries of their responsibilities. If they fail to comply, they risk losing safe harbor protections and facing action under Rule 7 of the IT Rules, 2021," the government

It further argued that Section 69A empowers the government to block access to information with legal consequences for non-compliance, whereas Section 79 determines the conditions under which intermediaries can claim safe harbour protection. According to the government, X Corp had in-correctly equated the "blocking orders" issued under Section 69A with the "notices" issued under Section 79(3)(b), despite the Supreme Court previously distinguishing between the two in the Shreya Singhal case.

Addressing concerns raised by X, the government defended the Sahyog portal, describing it as a facilitative mechanism designed to streamline coordination between intermediaries and law enforcement agencies.

The Centre asserted that the portal provides a structured platform to ensure swift action against unlawful online content and benefits both intermediaries and investigative authorities. The government also pointed out that X, being a foreign commercial entity, has no inherent right to host or defend third-party content on its platform. It emphasised that in an earlier case brought by Twitter, the Karnataka HC had explicitly ruled that Articles 19 and 21 of the Indian Constitution do not apply to the company.



Srinagar, March 29: The Jammu and Kashmir government is establishing an early warning system to enhance preparedness for any sudden breach of glacial lakes due to the climate change-induced rapid melting in the Himalayas, officials said here.

They said there is an "imminent risk of sudden breach" of Glacial Lakes in the high-altitude regions, particularly in the Himalayas, and the government has adopted a proactive approach for mitigation and risk reduction to address the

growing threat "The government of J&K has



adopted a focused, holistic and a proactive approach which include comprehensive understanding of risk landscape and the development of robust mitigation and risk reduction

strategies," an official said. In this connection, the government has constituted the FGMC or Focused 'Glacial Lake Outburst Flood' (GLOF) Monitoring Committee which has conducted expeditions to various such lakes to enhance understanding and prepared-

ness against potential hazards.

Geographical field expeditions

were conducted to the two glacier lakes -- Sheshnag and Sonsar enroute the Holy Amarnath Cave in the Himalayas, the officials said.

After the expeditions, a detailed report was shared with the FGMC highlighting the major findings and future possibilities for deliberations. they said. Also, a specialised team carried out expeditions and undertook a comprehensive study of three other critical glacial lakes in the Kishtwar district, including Mundiksar Lake, Hangu Lake and

an unnamed lake, they added. The officials said the expeditions provided valuable data on the conditions of the lakes, surrounding environmental factors, and potential risks of a breach, or technically, Glacial

Lake Outburst Floods (GLOF).

Another expedition was carried out to the Gangabal Lake, in central Kashmir's Ganderbal district -- a high-altitude glacial lake located in the northwestern Himalayas, they said.

The expedition examined the physical and geological characteristics of Gangabal Lake, and a particular focus was given to assessing the local geomorphology, the stability of the natural dam containing the lake, and the conditions of the glaciers feeding it, the officials said.

The investigation provided critical insights into the GLOF hazard potential of Gangabal Lake and contributed to broader efforts to enhance climate resilience in the region, they said. Field expeditions for the rest of the categorised lakes are scheduled to be carried out in the coming months, the officials

### CBI court acquits ex-HC judge Nirmal Yadav after 17 years

# India, US decide to hold sectoral talks Protest in Jaipur over

New Delhi, March 29: India and the US have decided to hold sectoral talks under the proposed bilateral trade agreement (BTA) in the coming weeks, the commerce ministry said Saturday. It was decided after the four-

day negotiations of senior officers from India and the US. These negotiations ended Saturday here. "Sectoral expert-level engagements under the BTA will start virtually in the coming weeks and pave the path for an early negotiating round in person," the ministry said. In order to realise the shared objective of promoting growth that ensures fairness, national security and job creation, both sides have through four days of discussions here broadly come to an understanding on the next steps towards a mutually beneficial, multi-sector BTA, with the goal to finalise its first tranche by fall 2025, it said. During these discussions, the

two sides held a productive exchange of views on deepening bilateral cooperation in priority areas, including increasing market access, reducing tariff and non-tariff barriers and deepening supply chain integration in a mutually beneficial manner, it added. A team of US officials, headed by Assistant US Trade Representative for South and Central Asia Brendan Lynch, was here for the

The meeting follows the visit of Commerce and Industries Minister Piyush Goyal to Washington from March 4-6 during which he met his US Trade Representative Jamieson Greer and Commerce Secretary Howard Lutnick and subsequent video conferences between the two sides.

"The successful conclusion of the discussions reflects progress in efforts to expand India-US bilateral trade and investment relations to promote prosperity, security and inno-

vation in both the countries," the ministry said. These steps are designed to unlock new opportunities for businesses. drive bilateral economic integration, and reinforce the economic partnership between the two trading partners.

"India and the US expressed satisfaction with the outcomes of the meeting and reaffirmed their dedication to ongoing collaboration. Both sides look forward to building on this milestone in the coming months to finalise the BTA, ensuring it aligns with the shared goals of prosperity, resilience, and mutual benefit," it added.

US President Donald Trump Friday described Prime Minister Narendra Modi as a "very smart man" and a "great friend of mine" while emphasising that tariff talks would "work out very well between India and our country". The remarks assume significance since Trump has repeatedly criticised the alleged high tariffs charged by India and other countries on American goods. He has announced plans to impose reciprocal tariffs on its key trading partners, including India,

"India is one of the highest tariffing nations in the world. It's brutal, it's brutal. They're very smart. He (Modi) is a very smart man and a great friend of mine. We had very good talks. I think it's going to work out very well between India and

our country," Trump said.

India and the US are aiming to conclude the first phase of the agreement by the fall of 2025 (September-October). They have also set a target to more than double bilateral trade to USD 500 billion by 2030 from the current over USD 190 billion.

While the US has demanded duty concessions in sectors like certain industrial goods, automobiles, wines, petrochemical products, dairy, agriculture items such as apples, tree nuts, and alfalfa hay; India may look at duty cuts for labour-intensive sectors like textiles. Indian industry and exporters have asked the government to protect them against the USA's reciprocal tariffs. They have sought exemption from those tariffs as it would hurt them severely as the US is India's largest trading partner.

The US is pushing India to negotiate a large and grand bilateral trade agreement while seeking to open the agriculture sector for American businesses. According to experts, India is unlikely to include dairy and agriculture in trade negotiations as it is a politically sensitive sector.

The US agri exports to India was USD 1.6 billion in 2024. Key exports include almonds (in shell - USD 868 million); pistachios (USD 121 million), apples (USD 21 million), ethanol (ethyl alcohol USD 266 million). In June 2023, India announced



# 'Unacceptable that kids need to wear masks to play outside'

New Delhi, March 29: Supreme Court Judge Justice Vikram Nath Saturday laid stress on the need to regulate emissions and invest in cleaner technologies to combat pollution, saying it was unacceptable for children to grow up in an environment where they needed masks to play in the open.

Justice Nath also said there was a need to explore solutions which struck a balance between economic growth and environmental wellbeing and that government policies must focus on green technologies. He was speaking during the inaugural session of the National Conference on Environment - 2025 at Vigyan Bhawan. President Droupadi Murmu was the chief guest at the event. "The capital city of India regularly experiences high levels of pollution. I believe we can all agree that

it is not acceptable for our chil-

dren to grow up in an environ-

ment where they need masks to play outside or worry about respiratory ailments at a young age," Justice Nath said.

"This is an urgent call for action, a signal that we must come together to regulate emissions, invest in cleaner technologies and think of sustainable transport options that allow economic progress without compromising the air we breathe," he said. He flagged water pollution as another key concern, saying many sacred and pristine rivers had been burdened with untreated waste.

'When I see these riversides, I feel a mix of nostalgia and concern ... Nostalgia for how vibrant and pure these waters once were and concern for our inability to preserve them in their natural glory. Treating industrial effluent, enhancing sewage infrastructure and encouraging local communities to maintain cleanliness along riverbanks are essential steps, Justice Nath said.

# Desperate bid to rescue survivors Curfew lifted in

Bangkok, March 29: In the hours after a massive earthquake flattened buildings in Myanmar's Mandalay Friday, survivors scrambled through the debris using their bare hands in desperate attempts to save those still trapped. Without heavy machinery to assist them and with authorities absent, a resident and rescue workers in the Southeast Asian country's second-largest city told Reuters that they were struggling to pull out survivors crying out for help.

Myanmar has been in crisis since 2021, when the military seized power from an elected government, brutally crushing protests and sparking an unprecedented armed uprising.

Humanitarian agencies say Friday's quake, which measured 7.7 magnitude and has killed more than 1,000 people, has come at a vulnerable moment for the country, after four years of military rule and civil war that has crippled infrastructure and displaced millions.

A spokesperson for Myanmar's junta did not respond to requests for comment.

The foreign minister of the National Unity Government. the parallel civilian government that oversees some pro-democracy forces, told Reuters by phone it would deploy anti-junta troops to help with disaster efforts.

India saw massive 3,580 pc growth in solar power capacity in last decade

Ahmedabad, March 29: There has been an unprecedented increase in solar power capacity in the country -- from 2.82 GW in 2014 to 104 GW today -showing a significant increase of 3.580 per cent in the last 10 years, Union Minister of New and Renewable Energy, Pralhad Joshi, said Saturday.

By 2030, the production of solar modules will skyrocket and reach 150 GW and the capacity for solar cells will increase to 100 GW, with wafer production reaching 40 GW, said the Union Minister while inaugurating a state-of-the-art 5.4 GW solar cell gigafactory/manufacturing facility of Warree Energy at Chikhali in Gujarat.

"This magnificent facility embodies the spirit of India and stands in the form of India's growing expertise in the global renewable energy scenario. The plant will not only cater to local needs but also position India as a major exporter of advanced solar technologies," said Joshi.

The minister said that the emphasis on module production has also increased and its capacity has increased from 2 GW in 2014 to 80 GW today.

"In 2014, the production of solar cells and wafers did not exist, but today, India has 25 GW of cells and 2 GW of Wafers produces. To give a further boost to this, the government has issued guidelines stating that all solar PV modules used in projects will have to get their solar cells from ALM list-II starting from June 1, 2026," Joshi explained.

He further said that under the leadership of Prime Minister Narendra Modi, India co-founded the International Solar Alliance (ISA) to accelerate the global development of solar energy.

At present, more than 100 countries have committed to a greener future through the ISA.

## New UPI guidelines from April 1 Centre sends another

According to the new norms, the UPI ID linked to the inactive mobile number will become inactive

New Delhi, March 29: The National Payments Corporation of India (NPCI) recently issued new guidelines on numeric UPI ID solution with the aim of enhancing customer experience for UPI number-based payments. These new guidelines will be effective from April 1.

It will be mandatory for UPI member banks, UPI apps and third-party providers to follow these new guidelines.

According to the new norms, the UPI ID linked to the inactive mobile number will become inactive. That is, if the mobile number registered with the bank of a UPI user is inactive for a long time, then the UPI ID of the user will also be unlinked, and the person will not be able to use the UPI service.

In such a situation, every person using the UPI service will need to ensure that the mobile number registered with his bank is active.

UPI service can be used without any problem only if the bank records are kept updated with the correct mobile num-



ber. There may be problems with the UPI service associated with inactive or reassigned mobile numbers.

According to the new rules of the Department of Telecom (DoT), a mobile number can be assigned to a new user after 90 days of disconnection. If a customer's mobile number is not being used for calls, messages or data, then such numbers are deactivated by telecom providers. These numbers are called recycled or churned numbers.

Under the new guidelines. the user's bank-verified mobile number will act as the user's UPI identifier.

On the other hand, banks and

UPI applications will also need to update their mobile number records every week so that mistakes caused by recycled or modified numbers can be

avoided. Applications will need to seek permission from users before assigning numeric UPI IDs. Users must actively opt in for this feature as the default setting is opted out.

In case there is some delay in the NPCI verification, UPI applications may temporarily resolve numeric UPI ID issues internally. These issues will need to be documented and reported to NPCI on a monthly basis for monitoring purposes.

**SALES** The show-cause notice, dated March 21, seeks details about Ola scooters of various models sold and registered last month, as per reports.

The Bhavish Aggarwal-led electric vehicle (EV) maker has been asked to respond to whether Ola scooters sold in February are on the road without registrations; whether Ola scooters were delivered to customers without number plates: and whether Ola scooters are being sold from stores without trade certificates.

It was not clear yet if the EV maker had responded to the ministry's letter within the seven-day deadline.

Ola Electric claimed to have sold 25,000 scooters in February but only 8,652 of them were reg-

istered due to renegotiation of contracts with vendors that handled vehicle registrations.

The vendors, Rosmerta Group, subsequently filed insolvency petitions against the company over unpaid dues of up to ₹25 crore.

Ola Electric said it has "amicably settled all outstanding dues between its wholly owned subsidiary, Ola Electric Technologies Private Limited, and the Rosmerta Group" and the Rosmerta Group has filed the memo for withdrawal of the petitions filed before the National Company Law Tribunal (NCLT), Bengaluru

### **NCLAT upholds CCI** ruling against Google. penalty cut by a fifth

New Delhi, March 28: In a setback for Google, appellate tribunal NCLAT Friday upheld fair trade regulator CCI's finding that the company's app store billing policy was unfair

and restrictive for developers. It, however, slashed the penal ty to almost a fifth to ₹216 crore from ₹936.44 crore imposed by the Competition Commission of

India (CCI). In a 104-page order, the NCLAT said Google "has abused

its dominant position and has violated Section". However, it also said there was no violation by the tech major on charging 15 to 30 per cent service fee from apps depending on various parameters. A two-member bench com-

prising Chairperson Justice Ashok Bhushan and Technical Member Barun Mitra said Goo gle "has abused its dominant position and has violated Section" however, in some sections, vio lation was "not proved, but penalty was still leviable on proof of violation".

"The penalty imposed on Google is modified as per the computation contained in paragraph 105 of this order. Thus, the penalty imposed on Google for relevant turnover of last three preceding year of ₹936.44 crores is modified to the amount of ₹216.69 crore (USD 2,98,89,312.39)," said the NCLAT

As Google has already "deposited 10 per cent of the penalty in the present Appeal, rest of the amount of penalty shall be deposited by the Appellant within 30 days from today", said NCLAT.

Earlier October 25, 2022, the CCI had slapped a penalty of ₹936.44 crore on Google for abusing its dominant position with respect to its Play Store policies

### AIFF draft constitution proposes radical tweaks

New Delhi, March 29: The draft constitution of the All India Football Federation (AIFF) has proposed several radical changes, including the provision for inclusion of at least five former national players in the 14-member Executive Committee and removal of the office bearers through a no-confidence motion.

The draft constitution, prepared by retired Justice L Nageswara Rao has been submitted to the Supreme Court. An SC bench comprising Justices PS Narasimha and Joymalya Bagchi March 25 commenced final hearing on pleas related to the finalisation of the AIFF Constitution. The matter is likely to be taken up by the bench for further arguments and final disposal April 2.

The draft constitution says that the current elected members of the Executive Committee (after polls in September 2022), "shall stay in power and serve their permitted full term(s) of four years, subsequent to which fresh elections shall he conducted in the manner prescribed in this amended Constitution." But according to officials tracking the development, election can be called before the end of the term of the current office bearers -- which is September 2026 -- if the SC gives nod to the new constitution and the AIFF adopts it quickly.

Chennai, March 29: Indian Table Tennis legend Achanta Sharath Kamal hung his boots following his face-off against Snehit Suravajjula in the Men's Singles Round of 16 at WTT Star Contender Chennai 2025.

The 3-0 defeat against his compatriot meant this was Sharath's final official match. The five-time Olympian and India's most celebrated paddler, Sharath, had announced his retirement from table tennis ahead of the start of the tournament.

At 42 years old, Sharath, who is a record 10-time national champion, is currently India's top-ranked men's singles player, placed 92nd in the latest

WTT ranking list. Sharath has won 13 Commonwealth Games medals (including seven gold) and two Asian Games bronze medals, five Olympic Games appearances, and two ITTF Pro Tour titles under his twodecade-long career.

He won his first national title in 2003 and his maiden international medal at the 2004 Commonwealth Table Tennis Championships. His career graph reached a new high when he qualified for the 2004 Athens Olympics. In 2004, Sharath was conferred the Arjuna Award and won five national titles in a row. A historic singles gold medal at the 2006 Commonwealth Games in Melbourne and another gold in the men's team event capped

a successful year.

New Delhi, March 29: The Indian boxers are regaining momentum after months of inactivity but if the Boxing Federation of India's (BFI) election deadlock continues, the uncertainty around the formation of new body could adversely impact progress of the country's pugilists. President Ajay Singh, seek-

ing a third term, has announced a series of age-group tournaments and assured that national camps will also resume soon, along with a revamped coaching setup. But if a new president takes over post-elections, there is no guarantee if the new EC will keep the current system.

Singh stated, "We will fulfil our responsibility, a new team is free to take their calls later.' However, potential disruptions could harm the boxers' preparation and affect consistency.

India's boxers are yet to compete in an international tournament in this Olympic cycle. With the Commonwealth Games and Asian Games scheduled for next year, they are still adjusting to new world governing body's weight categories. Further delays could hurt them.

Singh has promised to recruit new coaches and review the controversial selection Indian boxing has been

without a High-Performance Director since Bernard Dunne stepped down in March last year. The BFI invited applications for a foreign coach in August, but no appointment has been made.

Foreign coach Dmitry Dmitruk and chief coach CA Kuttappa are also absent from the men's team which is currently in Brazil for the first World Cup. The president has also intro-

duced a new selection process

for national camps. Previously, the top four finishers at the Nationals secured camp spots. Under the new system, a pool of eight boxers will be formed based on performances across three tournaments, from which four national campers in each weight class will be selected.

But if Singh loses the election, these plans risk being

overturned, further disrupting the boxers' training and development.

Factionalism, its fallout

The BFI's internal power struggle has already cost athletes valuable time. The ongoing factionalism led to repeated postponements of the women's Nationals.

Days before the Nationals,

Singh suspended Secretary General Hemanta Kalita and Treasurer Digvijay Singh after an investigation led by former

Delhi High Court Judge Sudhir

Kumar Jain found them guilty

of "financial irregularities." Two rival factions have emerged in the run up to the elections, one being led by Singh. On the other side are Kalita, Digvijay, and Vice President Rajesh Bhandari, who support former sports minister Anurag Thakur's presidential bid.

As a result state units that aligned with the opposing faction, including Assam, Madhya Pradesh, West Bengal, Himachal Pradesh, Chhattisgarh, and Odisha, boycotted the women's Nationals, depriving their boxers of crucial competition.

Election controversy

Like several other National Sports Federation (NSF) elections in recent times, the BFI elections have been marred by legal disputes and procedural

The Returning Officer has paused the electoral proceedings until greater clarity emerges

The Delhi Amateur Boxing Association (DABA) and the Himachal Pradesh Boxing Association challenged the exclusion of their representatives, which stemmed from a March 7 order by Singh that only elected mem bers in state bodies could participate in the electoral process

The Delhi and Himachal High Courts stayed the disqualifications and ruled in favour of the state units.

The Himachal court had also directed the BFI to extend the date of nominations to enable his candidature. The BFI has filled appeals against both judgments.

Singh has support from some senior members, but shifting loyalties and withdrawals make the outcome uncertain until polling day.
