

SHORT TAKES HC halts work on forest near UoH

Hyderabad: Students of the University of Hyderabad (UoH) Wednesday continued protests against the state government's plans to develop the 400acre land parcel bordering the varsity land, even as the **Telangana High Court directed** the Congress dispensation to halt all the works in this regard until April 3. Meanwhile, the Union **Environment Ministry wrote** to the Telangana government, seeking a factual report on the state's "illegal clearing of vegetation on 400 acres of **P9** forest land" near the UoH.

Parl passes new **Immigration Bill**

New Delhi: Parliament approved a Bill to regulate immigration, entry and stay of foreigners in India, with the Rajya Sabha giving its nod Wednesday. The Immigration and Foreigners Bill, 2025 was passed in Lok Sabha March 27, 2025. The Rajya Sabha passed the Bill by voice vote Wednesday. Replying to the discussion on the Bill, Minister of State for Home Affairs Nityanand Rai attacked the previous Congress government and the TMC dispensation in West Bengal for aiding illegal immigrants enter the country and facilitating their stay by including their names in voters' list and ration cards. Washington, April 2: In a feat of determination, New Jersey Democratic Sen. Cory Booker held the Senate floor with a marathon speech that lasted all night and into Tuesday evening, setting a historic mark to show Democrats' resistance to President Donald Trump's sweeping actions.

Booker took to the Senate floor Monday evening, saying he would remain there as long as he was "physically able."

It wasn't until more than 25 hours later that the 55-year-old senator, a former football tight end, finished speaking and walked off the set floor. It set the record for the years longest continuous ago Senate floor speech in the chamber's history, though Booker





"Under the scheme, the Central government provides a subsidy of ₹78,000, while the state government offers ₹60,000 for the installation of solar plants up to 3 KW on rooftops," he added. He added that by leverag-

ing this scheme, consumers can generate nearly 300 units of solar power per month. The state government has

allocated a budget of ₹1,800 crore for the implementation of the scheme over three financial years, from 2024-25 to 2026-27, Singh Deo informed. So far, a total of 97,128 people have applied to bene-

fit from the PM Surya Ghar: Muft Bijli Yojana, with solar projects already installed on the rooftops of 3,124 households.

Singh Deo further emphasised that the adoption of solar power under this scheme will help mitigate load shedding and address the power crisis in the state.

Accord 2nd language status to Kosali: BJD AGENCIES

Bhubaneswar, April 2: Oppo sition BJD Wednesday urged the state government to accord second language status to Sam balpuri, popularly known as Kosali, and push for its inclusion in the Eighth Schedule of the Constitution.

The demand was made by BJD's deputy leader in the Assembly, Prasanna Acharya during Zero Hour. He claimed that over 1.5 crore people of the state's 4.5 crore population speak Kosali in about 11 of the 30 districts.

"This further strengthens the case for its official recognition, Acharya added, citing the con tributions of renowned personalities such as Satvanaravan Bohidar and Haldar Nag.

Bohidar, he said, was the au thor of 'Koshali Bhasakosh', a dictionary and grammar book in Kosali, while Nag is a Padma Shri awardee recognised for his folk songs

Acharya also pointed to the widespread popularity of Kosa li songs such as 'Rangabati and 'Chi Chi Chi Re Nani Chi' which have gained recognition bevond Odisha, as well as the global popularity of Sambalpur handloom sarees.



BJD to oppose Ghibli trend: Experts Waqf Bill: Patra warn of privacy risks PRESS TRUST OF INDIA

Bhubaneswar, April 2: As the Parliament begins a debate on the Waqf (Amendment) Bill, Odisha's Opposition party Biju Janata Dal (BJD) Wednesday said it will oppose the contentious legislation.

The party said it had made some suggestions to be incorporated into the Bill which were rejected. The BJD, which has seven members in the Raiva Sabha. will oppose the Bill, BJD's Rajya Sabha MP and national spokesperson Sasmit Patra told PTI.

The regional party, headed by former chief minister Naveen Patnaik, however, has no member in the Lok Sabha. Stating that BJD Rajya Sabha member Muzibulla Khan will speak on behalf of the party in Parliament during the debate on the matter, Patra said the party is not satisfied with the Bill.

The Centre has amended certain points in the Bill after the JPC, he said. The BJD leader said the Bill grants sweeping powers to the state government in determining the status of Waqf land, which could lead to undue interference.

Patra also claimed that the absence of legal and institutional support for Waqf bodies exposes them to bureaucratic delays and mismanagement.

Bhubaneswar, April 2: At a time when social media users are caught up in the frenzy of Ghibli-style AI image, cyber security experts have warned of privacy and data risks associated with the new image generator.

The viral trend is all about converting images with an anime-inspired touch with the help of ChatGPT's latest Artificial intelligence (AI) image maker. The feature is also available to ChatGPT users, including ChatGPT Plus, Team, and Pro. However, this has shot off several questions like is it safe to share personal data/photos on an AI platform? Does it pose any risk to our privacy which we are unaware of?

Cyber experts have raised concern over the issue as Open AI is getting free and easy access to the user's personal or private images: worse, when a user allows access to his mobile phone. Cyber security expert Lingaraj Sethi

said, "The 'Ghibli-style' trend has a major drawback. When we upload an image to convert it into a Ghibli-style picture, the AI Company stores it in its database. As crores of people are following the same practice, the AI companies are capturing the data to use them for data analytics.³

He also said the AI companies will later conduct data mining. "Access to huge amount of data will help the AI firms to learn and work more proficiently. Besides, there is no assurance from these companies as to what will they do with the large number of photos the users share in the AI platforms," he added.

'Chances are there that users might be the victims of 'identity theft' if the cyber fraudsters get hands on these data. They might use the images to create 'deepfake content'. India has maximum number of social media users and it is one of the most favourable places in the world to test any application and capture data. Through the process of analytics, the AI companies can predict the interest of the youth and get their hands on countries secrets.' Sethi added.

He advised people not to trust any AI tool or blindly upload any data on these platforms. "We need to be responsible for our own security and privacy. A small mistake can harm our privacy and even our life," he concluded.

Dip in Indravati water level raises concern

Bhawanipatna, April 2: Indravati Hydroelectric Project, also known as the lifeline of Kalahandi district, is witnessing a significant decline in its water-holding capacity, thanks to sediment accumulation due to inadequate desiltation drives.

The hydel project has long been a boon for the residents of Kalahandi district, supplying water for both kharif and rabi crops cultivation while also generating electricity for the surrounding region. However, years of inadequate silt removal in the reservoir have led to sediment accumulation, reducing the reservoir's water-holding capacity. This decline in water level has raised concern over potential disruptions to power generation and irrigation.

Sources said works for Indravati Hydroelectric Project started in 1978 and the project became fully functional by 2001. It features four turbines capable of generating 600-megawatt electricity. Its left and right main canals, and a lift irrigation system provide water to 1,28,012 hectares of farmland across eight blocks in Kalahandi.

fields, strengthening the backbone of local farmers. Additionally, the 600-megawatt power generation plays a crucial role in meeting the state's energy

needs However, the project now faces a crisis. While the reservoir's maximum water level stands at 642 metres and the minimum at 625 metres, the levels have steadily declined over the years. Farmers in the district are becoming increasingly concerned, while officials continue to attribute it solely to fluctuating rainfall, deflecting

their responsibilities for structural shortcomings. Without timely and permanent solutions, the project, which has been instrumental in Kalahandi's agricultural and economic growth, may face an existential threat.

On the other hand, due to deforestation at the upper reaches


of the reservoir and lack of necessary protective barriers, silt, mud, soil, and rocks flow into the reservoir along with rainwater every year. Instead of going for a permanent solution, authorities are wasting a huge sum of money on silt removal. According to sources, be-

tween 2022 and 2024, ₹24 crore was spent on silt removal in only a few metres of the reservoir. Given that the reservoir has a water storage capacity of 2.300 cubic metre and covers an area of 2,639 sq km, it is difficult to estimate how much silt has

accumulated. Currently, irrigation for rabi crops is being carried out in limited areas through the left and right canals, requiring 65 cubic metre water per day. Meanwhile, 195 to 210 megawatt electricity is being generated daily.

However, no one has provided an answer as to when the Water Resources department will identify the causes of declining water levels or when a protective barrier will be built to prevent silt accumulation.

When contacted, chief engineer, Construction, Jagannath Pani of Upper Indravati Project at Mukhiguda stated that authorities are deeply concerned over the issue, and efforts are on to take appropriate measures.

Sunapur-Gopalpur 4-lane marine drive on cards

Chhatrapur, April 2: A four-lane marine drive will soon be constructed along the coastal stretch of Sunapur-Gopalpur in Ganjam district, a detailed project report (DPR) of which is being prepared, officials said.

The proposed marine drive is expected to boost the district's economy by enhancing trade, commerce, and business infrastructure. Additionally, it will attract investments, promote tourism, create employment opportunities, and support the growth of local enterprises and industries.

The road will also play a crucial role in disaster management by providing a safe evacuation route for coastal residents during natural calamities like cvclones and floods. With this new connectivity, the distance between Berhampur

and Puri will be reduced by around 60 km, said sources.

Ganjam district administration and the southern circle of Roads and Buildings (R&B) department have initiated the DPR preparation. A consultancy firm has been chosen in this regard through a tender. The firm will oversee the DPR preparation, apart from providing assistance in land acquisition, monitoring, forest clearance, environmental clearance, and coastal regulation clearance. It will also constitute a specialised team comprising engineers and subject matter experts.

Significantly, Sunapur and Gopalpur are located along the coastline, making the marine drive a strategic addition. Moreover, plans are under consideration to extend the proposed coastal highway from Gopalpur to Digha via Sunapur.

Berhampur MP Pradeep Panigrahi has submitted a letter to the Prime Minister and Chief Minister, urging their support in this connection.

Panigrahi expressed optimism that the construction of the marine drive will commence soon. "The road is set to attract a significant number of tourists to the region," he said.

Agentic AI

I "agents" are coming, whether we are ready or not. While there is much uncertainty about when AI models will be able to interact autonomously with digital platforms, other AI tools, and even humans, there can be little doubt that this development will be transformative – for better or worse. Yet despite all the commentary (and hype) around agentic AI, many big questions remain unaddressed, the biggest being which type of AI agent the tech industry is seeking to develop?

Different models will have vastly different implications. With an "AI as adviser" approach, AI agents would offer individually calibrated recommendations to human decision-makers, leaving humans always in the driver's seat. But with an "autonomous AI" model, agents will take the wheel on behalf of humans. That is a distinction with profound and far-reaching implications.

Humans make hundreds of decisions every day, some of which have major consequences for their careers, livelihoods, or happiness. Many of these decisions are based on imperfect or incomplete information, determined more by emotions, intuitions, instincts, or impulses. As David Hume famously put it, "Reason is and ought only to be the slave of the passions." Humans may make most decisions without systematic reasoning or due attention to the full implications, but as Hume rec-

ognised with the "ought" part of his statement, this isn't all bad. It is what makes us human. Passion reflects purpose, and it may also play a key role in how we cope with a complex world.

With AI advisers that provide customised, reliable, context-relevant, useful information, many important decisions can be improved. but human motives will remain dominant. But what's so bad about autonomous AIs making decisions on our behalf? Couldn't they improve decision-making even further, save time, and prevent errors?

There are several problems with this perspective. First, human agency is critical for human learning and flourishing. The very act of making decisions and contemplating outcomes - even if the inputs and advice come from nonhuman agents - affirms our own sense of agency and purpose. Much of what humans do is not about computation or collecting inputs to decide on an optimal course of action; rather, it is about discovery - an experience that will become increasingly rare if all decisions are delegated to an AI agent.

Moreover, if the tech industry mainly pursues autonomous AI agents, the likelihood of automating more human jobs will increase substantially. Yet if AI becomes primarily a means of accelerating automation, any hope of widely shared prosperity will be dashed.

Most importantly, there is a fundamental difference between AI agents acting on behalf of humans and humans acting for themselves. Many settings in which humans interact have both cooperative and conflictual elements. Consider the case of one company providing an input to another. If this input is sufficiently valuable to the buyer, a trade between the two companies is mutually beneficial (and typically also benefits society).

But for there to be any exchange, the price of the input must be determined through an inherently conflictual process. The higher the price, the more the seller will benefit relative to the buyer. The outcome of such bargaining is often determined by a combination of norms (such as about fairness), institutions (such as contracts that will impose costs if violated), and market forces (such as whether the seller has the option of selling to somebody else). But imagine that the buyer has a reputation for being completely uncompromising – for refusing to accept anything but the lowest feasible price. If there are no other buyers, the seller may be forced to accept the low-ball offer.

Fortunately, in our day-to-day transactions, such uncompromising stances are rare, partly because it pays not to have a bad reputation and, more importantly, because most humans have neither the nerve nor the aspiration to act in such aggressive ways. But now imagine that the buyer has an autonomous AI agent that does not care about human niceties and possesses nonhuman steely nerves. The AI can be trained always to adopt this uncompromising stance, and the counterparty will have no hope of coaxing it toward a more mutually beneficial outcome. By contrast, in an AI-as-adviser world, the model might still recommend an uncompromising position, but the human would ultimately decide whether to go down that path. In the near term, then, autonomous agentic AIs may usher in a more unequal world, where only some companies or individuals have access to highly capable, credibly hard-nosed AI models. But even if everyone eventually acquired the same tools, that would not be any better. Our entire society would be subjected to "war-of-attrition" games in which AI agents push every conflictual situation to the brink of breakdown.

troller and Auditor General of India in November 2024, in nearly 60% of urban local bodies elections have been delayed. In a recent PIL filed in the

Supreme Court by ISHAD, a citizens' organisation, about 85,000 of the 1.5 lakh local bodies across 17 states have not held elections. This is too widespread and looks like a deliberate pattern. As per a study by Janagraha, the elections to the city council were delayed in Bangalore by 62 months, in Chennai by 84 months and in Kolkata by 15 months. On top of this, even after elections, there is an egregious delay in the formation of elected councils, mayors or chairpersons of standing committees. On an average, there was a delay of 11 months across major cities. During these long periods the governance is in the hands of the state government and local governments are powerless and people are representative less. In Maharashtra, all major civic bodies have been without representatives for more than

three years. This is ostensibly due to the case in Supreme Court regarding OBC reservations. But the legal logjam has meant that the true democratic functioning of local government is denied to the people of Maharashtra. Similar is the fate of the people in other states facing delays in local elections.

The inordinate delay in conducting local body elections is anti-constitutional. It is a severe blot on our democracy. It leads to several undesirable developments, even called a "disease of dysfunctional democracy" as articulated recently by Bhim Raskar, a civil society leader from Maharashtra. Firstly, it encourages "administrator raj" rather than people's rule. As such the marginalised sections feel intimidated in approaching the administration for their grievances and would rather approach a local representative. But thanks to delayed elections, we have a representative less functioning so-called democracy. Secondly, governments run by administrators appointed by the state government machinery are more likely to be captured by the gentry. So, they tend to be less responsive to grassroots concerns. Thirdly, the local bodies tend to degenerate into "service centres" or 'sewa kendras" delivering various schemes and missions, that originated in the state capital or in Delhi. Thus, the element of local decision making is robbed, and they become executors of welfare schemes. This phenomenon is seen even when elections are held on time. The gram panchayat has become a conduit for large funds flow, including for example, the employment guarantee scheme, tap water mission or affordable housing scheme. This means that the local government is not majorly a decision making and deliberative body, especially in the absence of elected representatives.

Another important casualty is the role of social audits. The impact of a scheme is verified only with people's participation and

independent evaluation. In the absence of local governments who can appoint such independent audits, the administration machinery ignores the aspect of measuring implementation score cards. The "administration raj" also increasingly becomes risk averse to trying out experiments at the local level, to deal with local realities. This means there is less learning and blockage of useful feedback mechanism. The lack of locally elected representatives also means that civil society and NGOs are kept away by the administration run local government. Such NGOs are not always nosy busy bodies but are often partners to locally elected governments, in improving governance, making it more accountable and effective. But administrators and bureaucrats usually have a distrust of such civil society organisations and would rather keep them away.

How can you have representative less local self-governments? That is a contradiction in terms. The empowering of people at the grassroots level requires regular and timely elections to all local bodies, fulfilling all conditions as stated in the landmark constitutional amendments, including one third reservation for women. Not only is the delay in elections experienced across many states a serious disease, but there are also other troubling trends too. Such as encouraging unopposed elected bodies with cash awards from the state government. As if getting a panchayat in place is like bagging a commercial deal. Among other well-known disorders in local body elections, is that of the female elected representative simply being a rubber stamp and proxy for male power wielders. Thus, it is clear that we have a long way to go to implement in letter and true spirit, genuine decentralisation and the strengthening of local democracy. This at the very least is holding elections in a time-bound manner without any delay. Else running thousands of local governments by remote control, and by unelected administrators is against the people and the Constitution.

Mundakkai, Chooralmala remain ghost towns

Once a bustling hub of tourist activity, this beautiful valley in Meppadi, Wayanad, is now devoid of residents or visiting tourists

Wayanad (Kerala), April 2: Suhara Joseph, 56, was taking a respite from the scorching heat under the shade of a shop in Chooralmala in Wayanad district, blankly looking across the Bailey bridge at the rubble where her house once stood.

She had just returned from the spot where her home had been completely wiped away, with not even a trace left, as huge boulders swept it away July 30 last year in the worst landslide Kerala has ever witnessed.

She reluctantly returned to the shade, as she was alone and afraid of fainting in the scorching sun.

"I am least concerned about the house and the properties we lost, but I can't get over the fact that the people who were so close to us are all gone," Suhara told PTI, choking with emotion as tears rolled down her cheeks.

Suhara survived because she was at a hospital for her husband's treatment. All the neighbours who had visited them at the hospital the previous night perished.

Eight months after the disaster, the Mundakkai and Chooralmala regions resemble a ghost town, with an eerie silence surrounding them.

"I am just going to see the place where my uncle and aunt lived. We have lost everyone--friends, family. This

the rubble silence is unbearable," said Faisal, who often visits the di-

d saster site, still unable to fathom the quietness of the place, is as he told PTI. For many like Faisal, who often visit the places where their loved ones once lived, it is a journey to connect with their past, their memories, and often a homage to those who lost their lives in the landslides.

"Many of them still remain buried deep somewhere here. This place is like a tomb for our relatives, and visitors may not respect it," Faisal said with deep sorrow, fully aware that there would be a barrage of visitors to the site if it were opened for tourism.

The local people had given a memorandum to the Chief

Minister Pinarayi Vijayan, requesting him not to open the place for tourist.

HIMACHAL PRADESH

In the three wards of Meppadi Panchayat--Punchirimattam, Mundakkai, and Chooralmala--there are no residents left. Even the houses that remained intact after narrowly escaping nature's fury remain closed.

In the partially damaged houses, all that can be found are broken household items, books, and other belongings--once woven so closely with the vibrant life that thrived here--now standing as sorrowful reminders of what happened in the early morning hours of July 30.

The flood marks on these houses remain intact, a stark reminder of how furious the nature's assault was on these hapless people. In most of the remaining areas, only iron bars and pieces of concrete serve as evidence that houses once stood there, sheltering the families.

"I have been working on a farm here for over a decade. Every morning, I used to take the road we lost to the landslides. I knew everyone here, and now there is no one. Now, when I ride along the other road to the farm, memories constantly replay in my mind--it is very difficult," said an estate worker in Mundakkai.

Thiruvananthapuram, April 2: The Kerala Women and Child Development Department is organising a training programme to create awareness about the POSH Act among those working in the film industry.

The Prevention of Sexual Harassment at the Workplace (POSH) Act is a central legislation enacted in 2023 to address the issues of sexual harassment being faced by women in the workplace.

State Health Minister Veena George will launch the awareness programme being implemented with the support of the state-run Gender Park, April 3 here, an official statement said Tuesday.

As many as 60 people from various sectors of the film industry will take part in the initial phase of the awareness event, in which Chief Secretary Sarada Muraleedharan would be the chief guest.

Stressing the significance of the programme, the Department in the statement said that this is a time when women are entering the workforce in greater numbers.

equality and equal rights for men and women, it said.

To achieve this objective and to make workplaces safe and secure for women, the state gov-

ernment has already initiated various activities through the Department. It also initiated steps to bring the film industry under the purview of the POSH Act.

In January 2023, a portal was launched to coordinate and monitor activities under the POSH Act to prevent sexual harassment against women in workplace.

Steps have also been taken to set up internal committees, as prescribed by the POSH Act in all institutions with more than 10 employees in 95 government departments in the state, it further said.

The safety of women in workplaces has been given greater importance by the state government and the upcoming programme is part of that, the statement added. Shimla, April 2: Consumers in

the state capital and surrounding areas will have to shell out more for water consumption, as Shimla Jal Prabandhan Nigam Limited (SJPNL) has hiked the tariff by ten per cent.

The revised rates will be applicable to all consumer categories, including domestic, commercial and religious institutions.

As per the notification issued by the government, the tariff would be different for consumers within the Shimla Municipal Corporation (SMC) area and outside the SMC area, officials said Wednesday.

The revised water charges will be ₹21.23 per kilo litre on 0-20 KL slab, ₹36.61 per KL on 20-30 slab and ₹69.89 for consumption above 30 Kl for consumers within the municipal limits. The minimum maintenance charges have been raised to ₹121 per month while the faulty meter rate would be ₹488.48 per month.

The tariff for consumers outside the SMC area would be ₹48.31 for consumption up to 20Kl, followed by ₹73.21 for 20-30 Kl slab and ₹102.49 for above 30 kilo litres while the minimum maintenance charge for domestic water connections outside the limits of the Shimla MC will be ₹242 per month. The faulty meter rate would be ₹1,948.58 per month.

The charges per kilo litre for water supply connections for establishments like hotels and restaurants within and outside the SMC limits will be ₹116.93 for consumption up to 20 Kl, ₹155.88 for 30-75 Kl and ₹214.34 for consumption above 75 Kl.

Further, ₹242 per month will be charged in case of plugged connections and ₹8,557.67 per month for faulty meters.

Shimla, April 2: The Himachal Pradesh Horticultural Produce Marketing and Processing Corporation (HP-MC) is planning to build a controlled atmosphere (CA) store with geothermal technology in collaboration with an Iceland company, horticulture minister Jagat Singh Negi said Tuesday.

He said the pilot project would start in Tapri in Kinnaur district soon. Talking to reporters after the 217th meeting of the Board of Directors of HPMC, Negi said this would be the first such

_____ store in the state.

Geothermal cooling utilises Earth's relatively constant below-surface temperatures to cool buildings. The heat from indoors of the building will be transferred to the cooler ground and back in a closed loop system. Negi said the HPMC has already established a fruit and vegetable dryer, which has started working on a small scale -- 500 kg per day -- and

the results were good. He said use of geothermal technology could be an eye opener; it could be used to generate electricity and keep homes centrally heated in



the coming times.

Citing that the corporation has attained the highest ever production of 2,000 tonnes of apple concentrate, the minister said he hoped it would earn the highest-ever profit of up to ₹5 crore this financial year.

He said the HPMC apple juice is in demand since it contains no added sugar. The corporation has also started manufacturing of apple cider, vinegar and wines, which are now being sold in several metros, including Delhi and Jaipur.

The minister said the HP-MC land lying idle would be utilised to earn revenue. Around ₹100 crore is expected upfront, with an annual rent revenue of ₹2 crore.

He said the Board of Directors has decided to give the controlled atmosphere stores and the grading packing centres in the state to private people through a tender process.

Negi said HPMC has been working for the gardeners and farmers of Himachal Pradesh for a long time. Apart from this, it also holds the responsibility of procurement of apples under the Market Intervention Scheme.

Hyderabad, April 2: Students of the University of Hyderabad (UoH) Wednesday continued protests against the state government's plans to develop the 400-acre land parcel bordering the varsity land, even as the Telangana High Court directed the Congress dispensation to halt all the works in this regard until April 3.

Meanwhile, the Union Environment Ministry wrote to the Telangana government, seeking a factual report on the state's "illegal clearing of vegetation on 400 acres of forest land" near the University of Hyderabad in the biodiversity-rich Kancha Gachibowli area. The ministry also directed the additional chief secretary (forests), Telangana, to take legal action under forest and wildlife laws as applicable.

"The ministry has come to know about the illegal felling and removal of vegetation in Kancha Gachibowli Village, Ranga Reddy district of Telangana by the Telangana State Industrial Infrastructure Corporation (TGIIC).

"There have also been various news reports in the print and social media in this regard alleging damage to the wildlife found in the said land, its lakes and the unique rock formations in the area," the ministry said in a letter Wedneday.

A protest rally by students and University of Hyderabad Teachers Association (UHTA) was stopped by the police earlier in the day.

The UHTA led a rally from Ambedkar auditorium to East



Campus (the site of 400 acres of the disputed land) in solidarity with the agitating students. The procession was stopped by the police and some of the protesting students were "lathicharged" by the police, UHTA said in a statement.

However, a police official denied the claims and said, "They were prevented from taking out the rally." The procession then moved towards the University main gate of the campus.

The University of Hyderabad Students' Union (UoHSU) and other unions and parties aligned with it have launched an indefinite protest and announced a boycott of classes from April 1, demanding withdrawal of police personnel from the campus and removal of earth-moving machinery from the land. The student groups and environmental activists have voiced Opposition to the proposal to undertake development work at the site. citing ecological conservation con-

cerns. The student groups protests intensified March 31 with

the government maintaining that the land parcel belonged to it and not the varsity. However, the UoH Registrar contradicted the government's claim that the boundary of the land in question was finalised.

The Telangana High Court Wednesday directed the state government to suspend all work on the 400-acre land parcel adjacent to the UoH, for a day. A bench comprising Acting Chief Justice Sujoy Paul and Justice Renuka Yara was hearing a batch of PILs seeking a directive from the court to stop the uprooting of trees and land clearing at the Kancha Gachibowli site.

Reacting to the HC's direction, UoHSU in a social media post described it as one step towards victory of the students to claim this land as theirs.

The petitioners also challenged the state government's decision to allot the land to the Telangana Industrial Infrastructure Corporation (TGIIC), claiming it violated the Forest Conservation Act

Man gets 2-year jail term for threat call to harm PM, Adityanath PRESS TRUST OF INDIA

Mumbai, April 2: A Mumbai court has sentenced a man to two years in jail for making a threat call to police and claiming underworld don Dawood Ibrahim was offering him money to kill PM Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath, noting showing sympathy to the accused was not justified.

In a verdict delivered on March 29 in the 2023 case, First Class Judicial Magistrate (Esplanade Court) Hemant Joshi dismissed the defence's argument that the accused, Kamran Khan, was mentally unstable.

The magistrate noted no evidence was produced by the accused to support his claim on mental health.

The court found Khan guilty of offences under sections 505(2) (statements creating or promoting enmity, hatred or ill-will be tween classes) and 506(2) (criminal intimidation) of the Indian Penal Code (IPC) Besides handing him two years imprisonment. the court has imposed a fine of ₹10,000 on him. As per the prosecution, the accused made a call to the Mumbai police's main control room in November 2023, wherein he threatened that he would blow up the state-run J J Hospital. The accused further said "There is a threat to Modi's life, Dawood Ibrahim is giving ₹5 crore, he has asked (him) to eliminate Modi," the complainant in the case told the court.

The person also stated that men of Ibrahim, designated as a global terrorist, were offering ₹1 crore to him to blow up UP Chief Minister Aditvanath with a bomb, the court was told. As per police, the accused made the call to the control room when he was at J J Hospital in central Mumbai and his med ical check-up by doctors was getting delayed due to a long queue of patients.

Pak Army violates ceasefire along LoC

Jammu, April 2: Pakistani troops violated the ceasefire by resorting to unprovoked firing after a mine exploded along the Line of Control (LoC) in Poonch district of Jammu and Kashmir, a defence spokesman said Wednesday.

He said the Indian army responded "effectively" to the ceasefire violation and continues to dominate the LoC where the situation is under control. Official sources said the violation took place at 1.10 pm Tuesday. While the Indian Army made no mention of any casualty on the Pakistan side, the sources said five enemy soldiers were injured in the explosion and the subsequent firing between the two sides. "On 01 Apr 2025, a mine blast occurred in Krishna Ghati Sector while the Pakistan Army was patrolling along the LoC. This was followed by unprovoked firing and ceasefire violation by Pakistan Army, Jammu-based defence PRO Lt Col Suneel Bartwal said.

"Own troops responded effectively. The Indian Army continues to dominate the LoC The situation is under control.' he said. The earlier statement had mentioned that "a mine blast occurred in Krishna Gha ti Sector due to Pakistan Army intrusion across LoC"

On February 21, India and Pakistan military held a flag meeting along the LoC in Poonch district in an effort to de-escalate tension after sev eral incidents of cross-border firing and an IED attack. The brigade-commander level flag meeting, lasting 75 minutes had taken place in the Chakkan-Da-Bagh crossing point area with both sides highlighting the need to maintain peace along the borders. The ceasefire violations along the borders of Jammu and Kashmir have been rare since the two countries renewed an agreement February 25, 2021 However, several incidents were reported on the LoC in Poonch-Rajouri sector in Febru ary. Two Indian Army personnel including a captain, were killed and another injured in an Improvised Explosive Device (IED) attack carried out by suspected terrorists in the Akhnoor sector of the Jammu region February 11. Two army personnel were also injured in separate incidents of small arms firing from across the LoC in Rajouri and Poonch districts, while two more army personnel were injured in separate landmine explosions in Poonch in February.

Vote bank being created by intimidating minorities: Shah in LS

As a result, 123 properties in Delhi's Lutyens zone were handed over to the Wakf just 25 days before the elections," he said. "The Narendra Modi govern ment runs on a very clear principle that we will not bring any law for vote bank because law is for justice and welfare of people," he said, adding, "Everyone has the right to fol low their religion, but conver sion cannot be done for greed, temptation and fear. He stressed that it has be come a fashion to create fear among the people of the mi nority community. "It is the resolve of the Modi government that no citizen of this country, irrespective of his religion, will be harmed, Shah said. He said vote bank is being created by intimidating minorities and confusion is being spread in the country by creating an atmosphere of fear among the minorities. There was no provision earlier to include any non-Muslim person among those who run religious institutions, nor is the NDA government going to do so, he said.

'Even a criminal enjoys safeguards to protect dignity'

THE SUPREME COURT'S OBSERVATIONS CAME AFTER A MAN ALLEGED HE WAS HELD BY HARYANA POLICE IN VIOLATION OF THE LAW ON ARREST ASIDE FROM BEING SUBJECTED TO PHYSICAL ABUSE DURING HIS DETENTION AND INSIDE THE POLICE STATION

New Delhi, April 2: Observing even a criminal enjoyed certain protections, the Supreme Court has directed the director generals of police (DGP) of all the states and UTs to strictly adhere to all safeguards available to persons in custody.

A bench comprising Justices Ahsanuddin Amanullah and Prashant Kumar Mishra called the police a very vital part of the state machinery, having a direct bearing on the safety and security of the society at large and individuals in particular. "The need, therefore, for maintaining the confidence of individuals and society-at-large in the police is paramount," it added.

The court referred to a checklist shown by the counsel for Haryana under Section 41(1)(b)



(ii) of the Code of Criminal Procedure, 1973. "Perusal of the same prima facie does not inspire confidence. Rather, it appears that only as a formality, the same has been submitted. We express our strong reservations with regard to filling-up of the checklist in a mechanical manner," the bench's March 26 order said.

The top court's observations came after a man alleged he was held by Harvana Police in violation of the law on arrest aside from being subjected to physical abuse during his detention and inside the police station. In support of such argument, the petitioner's counsel referred to an e-mail sent by his brother at around 11.24 am on the same day to the superintendent of police concerned over his brother's alleged arrest.

The counsel alleged physical torture in the police station was only after the e-mail was sent to the higher officials "as a knee jerk reaction" and an FIR was lodged two hours later at around 1.30 pm. The top court observed there appeared to be "evident high-handedness" on the part of the police.

"Even if a person may be a 'criminal', the law requires that he be treated in accordance therewith. Even a 'criminal', under the law of our land. enjoys certain safeguards in order to ensure protection of his

person and dignity. In this case, the petitioner, when picked up by the police, was at best an accused," the court said. "It is possible to state that a common man can be expected to exceed his limits (whereafter appropriate action in law shall ensue), but not the police," the bench said. The apex court cautioned the police officers concerned to be careful in future.

"The director general is also directed to ensure that such type of occurrences do not recur and there should be zero-tolerance on behalf of the senior officer(s) with regard to any alleged transgression of authority by any subordinate officer(s)," it added. The court was "confident" that the DGP was "appropriately sensitised" and the "transgressions of the nature alleged" would not happen again.

Niamey (Niger): Niger's military junta has freed dozens of former government officials and military officers detained after a coup in 2023 as part of what military authorities have described as efforts to reform the country. The officials were released from prisons with immediate effect "in accordance with recommendations from the national reform conference, according to a statement read on state television late Tuesday, referring to a recent conference that also set out how the country may transition to democratic rule. Israel to seize parts of Gaza REUTERS

Jerusalem, April 2: Israel announced a major expansion of military operations in Gaza Wednesday, saying large areas of the enclave would be seized and added to its security zones, accompanied by large-scale evacuations of the population.

In a statement, Defence Minister Israel Katz said evacuations would take place from areas where there was fighting, while urging Gazans to eliminate Hamas and return Israeli hostages as the only way to end the war.

He said the operation would clear out militants and infrastructure "and seize large areas that will be added to the security zones of the State of Israel"

The Israeli military had already issued evacuation warnings to Gazans living in some southern districts and Palestinian radio reported that the area around Rafah was almost completely empty following the evacuation orders.

Gaza's Health Ministry said 53 people were killed in Israeli strikes Wednesday, with 19 people including children killed in a strike at a UN clinic being used to house displaced people.

Israel's military said it had struck a building previously used as a clinic that it said was serving as a Hamas command and control centre to plan attacks, and that the military had used surveillance to mitigate the risk to civilians. Hamas denied using the building and called the Israeli accusation it



Gold trades flat

New Delhi: Gold price stayed flat at its all-time high level of Rs 94,150 per 10 grams in the national capital Wednesday amid concerns over imposition of reciprocal tariffs by the US, according to the All India Sarafa Association. On Tuesday, the precious metal of 99.9 per cent purity surged by Rs 2,000, the steepest in nearly two months, to hit a fresh peak of Rs 94,150 per 10 grams. Gold of 99.5 per cent purity also traded flat at its lifetime peak of Rs 93,700 per 10 grams. Traders said gold prices remained flat ahead of the US President Donald Trump's anticipated announcement of imposing reciprocal tariffs on various countries, including India, which have a trade deficit with America. New Delhi, April 2: Goods from sectors, including agriculture, precious stones, chemicals, pharma, medical devices, electricals, and machinery may get impacted if the US will go ahead with imposing reciprocal tariffs on Indian products, according to experts.

They said that these sectors could face additional customs duties from the Trump administration because of the high tariff differential or gap, which is the difference between the import duties imposed by the US and India on a product.

At the broad sector level, the potential tariff gaps between India and the US vary across the sectors. The gap is 8.6 per cent for chemicals and pharmaceuticals; 5.6 per cent for plastics; 1.4 per cent for textiles and clothing; 13.3 per cent for diamonds, gold, and jewellery; 2.5 per cent for iron, steel, and base metals; 5.3 per cent for machinery and computers: 7.2 per cent for electronics; and 23.1 per cent for automobiles

Dairy products, with exports worth \$181.49 million, could be 'severely" affected by a 38.23 per cent differential, "making ghee, butter, and milk powder costlier and reducing their market share in the US," GTRI Founder Ajay Srivastava said.

The other products which can be affected include edible oils (\$199.75 million exports and 10.67 duty gap); alcohol, wines, and spirits (\$19.2 million exports and 122.10 per cent tariff differential): live animals and animal products (\$10.3 million exports and 27.75 per cent gap).

Srivastava said that tobacco and cigarettes, whose exports are valued at \$94.62 million in 2024, may remain unaffected, as the US already imposes 201.15 per cent tariffs, creating a negative tariff differential (-168.15 per cent).

In the industrial goods segment, sectors could be impacted by American duties, including pharmaceuticals, jewellery, and electronics.

The pharmaceutical sector, India's largest industrial export, worth \$12.72 billion in 2024, faces a 10.90 per cent tariff differential, increasing costs for generic medicines and specialty drugs.

Diamonds, gold, and silver, with \$11.88 billion in exports, may see a 13.32 per cent tariff hike, raising jewellery prices and reducing competitiveness. Similarly, electrical, telecom, and electronics exports worth \$14.39 billion face a 7.24

per cent tariff

Can you brief us about your early life and your entry into automobile industry?

The car market in India is on a roll. Are you also witnessing the surge in sales in Odisha market? Car industry in Odisha is in

People are now choosing electric vehicles, cars with ADAS safety feature, infotainment options and more selection of vi-

New Delhi: India's Unified Payments Interface (UPI) continues to dominate the digital payments landscape, with transaction volumes surging 42 per cent year-onyear (YoY) to reach 93.23 billion in the second half of 2024, a recent report has shown. The 'India Digital Payments report for 2H 2024 report by Worldline showed that three UPI platforms are dominant in terms of volume and value: PhonePe, Google Pay, and Paytm. In terms of transaction volume, in December 2024, the three apps accounted for 93 per cent of all transactions. In terms of transaction value, they accounted for 92 per cent in December 2024.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index (PMI) was at 58.1 in March, up from 56.3 in February, indicating a substantial improvement in the health of the sector that was above its long-run average.

In PMI parlance, a print above 50 means expansion, while a score below 50 denotes contraction

Manufacturing sector growth in India recovered the ground lost in February, largely driven by a stronger contribution from its largest sub-component: the New Orders Index.

"March saw total sales expand to the greatest extent since July 2024, with companies remarking on positive customer interest, favourable demand conditions and successful marketing initiatives," the survey noted.

Accordingly, firms scaled up production volumes at the end of the 2024/25 fiscal year. The rate of expansion was sharp. above its historical average and the strongest in eight months. Although new export orders continued to increase strongly

in March, the pace of growth retreated to a three-month low. Panellists cited gains from Asia. Europe and the Middle East in terms of international sales.

"Although international orders slightly slowed, overall demand momentum remained robust, and the new orders index recorded an eight-month high of 61.5. Strong demand prompted firms to tap into their inventories, causing the fastest drop in finished goods stocks in over three years," said Pranjul Bhandari, Chief India Economist at HSBC, said.

Buoyant demand led companies to tap into their inventories to meet increased client appetite, resulting in the most rapid decline in finished goods stocks since January 2022.

The survey participants underpinned upbeat forecasts for output levels in the coming 12 months on favourable demand conditions better customer relations and projects pending approval.

"Going ahead, business expectations remained fairly optimistic, with around 30 per cent of survey participants foreseeing greater output volumes in the year ahead, compared to less than 2 per cent that anticipate a contraction," Bhandari said.

The HSBC India Manufacturing PMI is compiled by S&P Global from responses to ques tionnaires sent to purchasing managers in a panel of around 400 manufacturers.


