A bench comprising Chief Justice of India (CJI) Sanjiv Khanna and Justice Sanjay Kumar upheld a Calcutta High Court verdict of April 22, 2024, annulling the appointments and said the tainted candidates should refund their 'salaries/payments received'.

"This is a case wherein the entire selection process has been vitiated and tainted beyond resolution. Manipulations and frauds on a large scale, coupled with the attempted cover-up, have dented the selection process beyond repair and partial redemption. The credibility and legitimacy of the selection are denuded," said the CJI. The CJI, however, said candidates who are already employed need not be asked to refund or restitute any payments made to them. It also made a relaxation for a

differently-abled employee on humanitarian grounds, saying she would remain in the job. The bench fixed pleas, including the one filed by the West Bengal govern ment challenging the HC direction for a CBI probe, for hearing April 4.

On February 10, the SC reserved its judgement on a batch of petitions in the matter. Citing irregularities, the HC had invalidated the appointment of 25,753 teaching and non-teaching staff in schools in West Bengal.

On May 7 last year, the SC stayed the HC's order over the appointments made by the state's SSC. The case stemmed from the irregularities in the 2016 recruitment process conducted by the WB's SSC in which 23 lakh candidates appeared for 24,640 posts and 25,753 appointment letters were issued.

Meanwhile, West Bengal CM Mamata Banerjee said, "While I've the highest re spect for the judiciary and judges, I cannot accept the judgment from a humanitarian point of view." She however, emphasised that her government would abide by the SC's decision while exploring all legal options. **P9**





Smita called out showbiz for objectifying women

Mumbai: Late actress Smita Patil, known for portraying strong and independent women, once criticised Bollywood for objectifying women and conditioning audiences to accept such portravals. In an old Doordarshan interview, she highlighted how commercial Bollywood films often depicted women as foolish, perpetually suffering, or half-naked due to formulaic storytelling.

Addressing a controversial poster from her film Chakra, in which she was shown bathing, Smita stated that she had no control over its release and would have prevented it if possible. She condemned the industry's double standards, stating, "You can't show a hero naked—nothing is going to happen then. But if a woman is shown naked, they think it will attract 100 more viewers. The Indian audience has been conditioned to believe that if a film has sex and half-naked bodies, they must watch it. This is a completely wrong attitude. If a film genuinely conveys something heartfelt, it will work. Just having such posters doesn't make a film successful.'

When asked whether filmmakers assume that audiences prefer content that objectifies women. Smita acknowledged that while some films thrive on such portrayals, audiences




are not foolish. "If there is no storyline, the audience will reject it. Our family structure is strong, and people enjoy emotional films. If the wrong content is repeatedly shown, viewers will grow accustomed to it. But filmmakers and ac tors have the power to change



'6% women trafficking cases solved in Odisha'

Bhubaneswar, April 3:

While Odisha registered 582 cases of women trafficking from 2018-22 among the highest in the country—the state police managed to file closure reports in just 37 cases (6%), said Minister of State (MoS) in the Ministry of Women and Child Development, Savitri Thakur. She was replying to a question raised by AAP MP Ashok Kumar Mittal in the Rajya Sabha, Wednesday.


She said Odisha recorded 75 women trafficking cases in 2018, which went up to 147 in 2019, before de-

to 136 in 2021, and fell to 126 in 2022. Significantly, the trial in 16 cases culminated during 2018-22, while for two years (2018 and 2019) none of the cases could be decided, she added.

Highlighting the poor policing system in Odisha, Thakur said the state police managed to file chargesheet in just 386 cases (out of 582 cases) after a lapse of three years. "In the pre-Covid19 period - 2018 and 2019- Odisha Police filed chargesheets in 89 per cent of the cases. However, it declined after 2020 when hardly in 50 per cent cases chargesheets were filed",

4 held for abducting, assaulting man Bhubaneswar: Chandaka police Thursday arrested four miscreants for allegedly

assaulting a man by confining him in a room as the latter tipped off the cops about their sand smuggling in the area. The accused had also been booked by Jatni and Chandaka police earlier. The police also seized three trucks and a four-wheeler involved in abduction of the man. The incident took place around 6am Wednesday, when the four miscreants abducted Swagat Sethi and kept him in Asima's house in Chandaka area where the men had assaulted him. Swagat's wife informed the Chandaka police who traced the men's location to a secluded area, and rescued Swagat. The miscreants were booked under Sections 126 (2), 296, 115 (2), and a host of others under BNS.



₹1,536cr BDA Budget gets nod

Bhubaneswar, April 3: An estimated Budget of ₹1,536.08 crore has been approved for the Bhubaneswar Development Authority (BDA) for the 2025-26 financial year.

The approval was made during the 150th Authority Meeting of BDA Thursday under the chairmanship of Housing & Urban Development and Public Enterprises Minister Krushna Chandra Mahapatra, who also serves as BDA Chairman. During the meeting, the Budget estimate for FY 2025-26 and the revised estimate for 2024-25 were presented.

Moreover, in a significant move toward urban expansion, the BDA approved the inclusion of 143 new revenue villages within its jurisdiction. Currently, BDA oversees four urban local bodies - Bhubaneswar Municipal Corporation (BMC), the municipalities of Khurda and Jatni, and the Pipli Notified Area Council (NAC) - along with nearby gram pan-

An official said the expansion aims to promote systematic urban growth, enhance infrastructure, and address the challenges of rapid urbanisation.

Since its establishment in 1983 with 116 revenue villages, BDA has expanded multiple times, notably in 2002, 2003, and 2011. "The latest expansion aligns with the City's strategic urban planning efforts and major infrastructure projects aimed at improving regional connectivity," the official added. With the addition of these new villages, the total number of villages under BDA's jurisdiction will rise to 712 from the present 569. "Following approval, the proposal will now be forwarded to the state government for consideration under Section 3 of the ODA Act, 1982," the official said.

Additionally, the Authority approved a proposal for land monetisation to generate revenue for BDA. Several land patches have been identified for auction for the purpose. The BDA has also decided to launch a multi-storied housing project at Chandrasekharpur.

Moreover, housing and plotted development schemes will be undertak-

en at Jagasara and Sanapalla in Khurda. The Authority has also approved the development of Bhubaneswar Town Centre through Engineering, Procurement, and Construction (EPC) mode to enhance parking facilities and commercial utilisation. Another proposal to redevelop BDA City Centre, commonly known as Nicco Park, has been approved.

It also approved issuance of a Request for Proposal (RFP) to select an agency for planning and design of Town Planning Schemes 05, 06, and 07. Currently, BDA is implementing Town Planning Schemes 1, 2, 3, and 4 in revenue villages under Bhubaneswar Development Planning Area (BDPA), including Sahajpur, Naragoda, Sijuput, Paikarapur, Tamando, Bijipur, Nuagaon and Shyamsundarpur.

The BDA has also decided to develop 24 Comprehensive Development Plan (CDP) roads across the city, a proposal that was presented during the Authority meeting.

CAG REPORT

₹864.45cr minor mineral revenue lost during 2015-22

Bhubaneswar, April 3: The state government has lost revenue of ₹864.45 crore from minor mineral sources during financial years 2015-16 to 2021-22, the Comptroller and Auditor General (CAG) of India said in its latest report.

In its audit report on collection of revenue from minor minerals, the CAG said the government failed to collect ₹864.45 crore towards the District Mineral Fund (DMF) and Environment Management Fund (EMF) on royalty from minor minerals supplied by contractors and used in public projects without valid transit passes amounting to ₹4,624.58 crore. The authorities in charge of public projects deducted royalty amounting to ₹4,624.58 crore from the bills of contractors or project executants due to non-production of valid transit passes and purchase receipts in support of procurement from authorised sources.

A total of ₹885.70 crore towards DMF and EMF on rovalty was to be realised in the state, during 2016-22.

House passes 2 key Bills

Two crucial Bills - Odisha Universities (Amendment) Bill, 2024 and Odisha State Highways Authority Bill, 2025 - were passed in the Assembly following an overnight debate in which BJD members actively took part, but Congress MLAs gave it a miss.



314 blocks April 15, a day after Ambedkar Jayanti," he added. Similar protests are scheduled to be held in district headquarters April 21.

"Padavatras, meetings, and collector office gherao will be organised at the district level

on that day," Das said In addition to addressing the issue of missing women and children, the district-level protests will also raise concerns over local issues such as drinking water shortages,

mining scams, and farmers grievances, according to Das.

RAGGING HORROR

Class VI student beaten with iron rods by seniors

Baripada/Udala, April 3: A disturbing case of ragging has surfaced at SSD School at Basipitha, under Khunta police station in Mayurbhanj district. A Class VI student was allegedly beaten with an iron rod, slashed with a blade, and salt applied to the wounds by his seniors before being locked in a room. The matter came to the fore after the child's guardian filed a police complaint.

Khunta police have registered a case (107/25) and launched an investigation. The victim, identified as Dipankar Behera, resides in Bhugudakata under Bhanjpur police station limits in Baripada.

The SSD School in Basipitha is a residential high school run by the department of Welfare for Scheduled Castes, Scheduled Tribes, Minorities, and Backward Classes. Out of 425 students enrolled, 404 live at the hostel.

Reports indicated that school authorities had repeatedly cautioned students about their misconduct. Incidents of alcohol consumption within the hostel had been reported earlier. At around 10:30pm February 14, four students were allegedly found drinking alcohol beneath the school's solar panels.

Dipankar reportedly photographed the incident with his mobile phone and returned to his room. The next day, he informed the school authorities about it. Principal Deeptikant



Jena investigated and confiscated empty liquor bottles along with more than 100 mobile phones.

However, the following day, when Dipankar was going to washroom before school, several students allegedly beat him mercilessly with iron rods. They also cut his hands with blades, applied salt to the wounds, and locked him in a room, threatening further harm if he reported the incident.

Fearing attacks, Dipankar returned home March 25 after completing his annual exams. After he narrated his ordeal, his parents lodged a complaint at Khunta police station.

The principal acknowledged the school's difficulties, citing a lack of staff to prevent alcohol smuggling onto the premises.

Some hostel students had reportedly marched to meet the District Collector, protesting against alleged injustices February 25. Khunta Police Station Officer-in-Charge Panchanan Mohanty said, "This is an old incident. We have discussed the matter with the principal, and an investigation is ongoing."

Telugu over Odia: Linguistic shift in border areas KOTIA AADHAAR CARDS CARRY

Pottangi/Nandapur, April 3: Though the state government has been emphasising on the protection of Odia language in border villages, alarming deviations have been observed. A recent incident in Koraput district's Kotia region, a bone of contention between Odisha and neighbouring Andhra Pradesh, has raised concerns about the state of Odia language in the border areas.

During the Odisha Day celebrations in Pottangi block Tuesday, an elderly woman's Aadhaar card was found to contain various details written in Telugu instead of Odia. The woman was identified as Khara Jhipai, 70, of Arjubalsa village in Kotia panchayat. The discovery has raised questions as to why an Odisha-issued Aadhaar card would prioritise Telugu over the state's official language.

Additionally, the woman's date of birth on the card was found to be incorrect. Though she is approximately 70 years old, her Aadhaar card lists her age as 45. Such errors have led to many border residents being deprived of Odisha government benefits under various welfare schemes, while neighbouring Andhra Pradesh has reportedly taken advantage of the situation.

The issue highlights con-



cerns over the protection of Odia language in border areas. When asked why she had brought her Aadhaar card to the event, the elderly woman stated that she had been instructed to do so after being denied an old-age pension. She also confirmed that she was not receiving any pension

When contacted, Sudhir Sahu, Block Social Security Officer (BSSO) of the Persons with

in Pottangi, stated that the elderly individual's Aadhaar card does not appear online. However, he noted that many marginalised villagers in the concerned panchavat have reportedly edited their Aadhaar details to claim benefits from two different states, which could lead to complications and risks for them.

Block Development Officer (BDO) Ramakrusna Nayak acknowledged the issue, stating it had come to his notice. He

further said that he informed the district administration about the matter. "Discussions are underway to resolve Aadhaar-related discrepancies independently and bring them to the attention of the Union government," he added.

ORDER DWELLERS DISTANCING

MSELVES FROM ODIA

Meanwhile, residents of Nandapur, Lamtaput, Pottangi, Bandhugaon, and Narayanpatana blocks of Koraput are gradually shifting from Odia to Telugu as their primary language. While indigenous communities such as the Kui, Paraja, Bhumia, Bhatra, and Gadaba tribes still converse in their native dialects, educational institutions in the region continue to follow an Odia-language curriculum.

Residents in Panthlung, Bilaput, Golur, Paraja Badapada, Kularsing, Chatua, Khinbara, and Nandaka panchayats depend heavily on Andhra for trade, healthcare, education, and livelihood. This economic reliance has contributed to a linguistic shift, with many residents choosing to speak and write in Telugu, distancing themselves from Odia.

Language experts and educationists warn that this trend could threaten the future of Odia in the region. Intellectuals have urged the government to take necessary measures to protect the language.

Sources said eight pancha-

ing 70 per cent population from Kui, Paraja and Gadaba tribes, are located near the Andhra Pradesh border. They receive their education in Odia language from schools established in these villages by the state government.

However, the residents cross the border and travel to weekly markets in Andhra Pradesh to sell their agricul tural produce and purchase essential goods. They also rely on Andhra for weddings, education, and healthcare services. While there, they often use Telugu instead of Odia, both in conversation and writing, sometimes opting for English as well.

When contacted, Nandapur Block Development Officer Durga Prasad Dora and Block Education Officer Bhabani Nandan Pattnaik said the state's Culture and Educa tion departments are aware of the issue. With support from block and district administra tions, various initiatives have been launched to safeguard Odia language.

As part of these efforts the district education department has appointed 364 multilingual education (MLE) teachers specialising in languages of Kui, Paraja Gadaba, Bhumia, and Bhatra tribes. Around 53 Paraja-lan guage teachers are currently engaged in Nandapur block alone, Pattnaik stated.

308 turtles seized; 2 held

MV 79, April 3: Forest personnel seized 308 turtles and arrested two persons on charge of smuggling the animals near the Motu border under Kalimela block in Malkangiri district, early Wednesday morning. The accused were identified as Suraj Mallik and Shaktipada Gain.

Acting on inputs about turtle smuggling, a team led by MV-79 ranger Rashmiranjan Swain, along with forester Muralidhar Anugulia and Motu forest personnel conducted a checking at Motu.

Around 4am, officials spotted a pickup van and two motorcycles entering Odisha from neighbouring Andhra Pradesh. During verification,

the officials discovered the turtles. Preliminary investigation suggests the turtles were being transported from Kakinada in Andhra to Kalimela block.

The seized vehicles were taken to the MV-79 forest office, where authorities seized 308 turtles from the vehicles. The Forest department registered a case in connection with the incident and produced the two suspects in court Thursday.

Wanted criminal injured in encounter

Talcher, April 3: A notorious criminal, Sushant Kumar Nayak alias Jhamu, 40, from Ramadia village under Nisha police limits in Angul district, was apprehended and injured in a police encounter late Wednesday night. Nayak, who is wanted in several criminal cases across Angul. Dhenkanal, Jajpur, and Deogarh districts, had previously fired at police officers during a market raid January 22, and fled. Acting on a tip-off, Talcher po-

lice led by Inspector-in-Charge Digbijay Biswal and supported by the Angul district special squad raided the Talabeda forest

where Nayak and his associate, Prafulla Nayak, were hiding. When asked to surrender, Nayak fired two rounds at the police, but no injuries were reported.

In retaliation, Sub-Inspector AS Jena of the special squad fired a warning shot. However, Nayak continued firing, forcing the police to shoot him in the left leg. Prafulla Nayak, who attacked police with a sickle, was also subdued.

Sushant Nayak was first taken to Talcher Sub-Divisional Hospital and then shifted to Angul DHH. He was later referred to SCB Medical College and Hospital in Cuttack for advanced treatment.

Baripada, April 3: Conservationists are raising concerns over violations of wildlife protection laws in Mayurbhani district after a 12-foot king cobra was rescued and released without following proper protocols. The snake was found in the house of a resident in Baidakuli village, located near the Similipal Wildlife Sanctuary. The frightened family informed Forest officials but, instead of dispatching a trained snake handler, two untrained forest personnel captured and released the snake into the wild. Furthermore, videos of the

snake recorded by locals went viral on social media later.

12-ft king cobra rescued sans protocols, released

Wildlife protection guidelines stipulate that endangered species like the king cobra, listed under Schedule-I of the Wildlife Protection Act, 1972 require special handling. Rescued animals should be monitored and kept in a safe location before their release, which should be done away from populated areas to avoid conflict. Additionally, filming and sharing rescue footage on social media is prohibited, but locals violated this rule by making the video of the rescue viral. Baripada Divisional Forest

Officer A Uma Mahesh acknowledged the incident but

stated that delays in obtaining permission from the Chief Wildlife Warden led to the use of untrained staff. Critics argue that the Forest department's reliance on untrained personnel highlights a lack of preparedness in

handling endangered species. Although the snake appeared healthy and was released into the forest, critics argue that the forest department's rescue team is inactive despite having a rescue vehicle worth Rs 45 lakh. According to animal rights activist Bibhudatta Das, this negligence reflects poorly on the department's preparedness and commitment to wildlife protection.

Israel's Blind Spot

njoying a perfectly brewed cappuccino and a crisp croissant on a pleasant street in Tel Aviv, it is hard to imagine that people are being bombed, shelled, and strafed about 43 miles (69 kilometers) away in Gaza (not to mention the constant violence on the West Bank less than 40 miles away). When life seems so civilized on the surface, it is easy to forget about the suffering of others.

This is not to say that Israelis are oblivious to the war. They can see it on their television screens all the time, including images of devastated cities in Gaza and animated discussions about the latest news. Anger about the war, and Benjamin Netanyahu's efforts to prolong it, as well as his attempts to undermine the judiciary and other institutions of Israel's democracy, is palpable everywhere, especially in Tel Aviv, a mostly secular and liberal city.

There are daily demonstrations against the war, and against Netanyahu's firings of public officials who stand in the way of his autocratic impulses. People denounce the prime minister and the extremists in his cabinet as fascists and war criminals, and argue about who is the greater influence on the other, Trump or Netanyahu. A former fighter pilot in the Israeli Defense Force told me he would not serve again in a war he found unacceptable. Another person said he might leave Israel if his son were called up. I spoke to a writer who despaired that

among Israelis, as well as Arabs and Jews. Many anti-war protesters and pro-democracy activists feel isolated from the outside world. Cultural boycotts are cutting the international ties of Israeli arts institutions and universities. Israeli liberals feel that they are being squeezed between hostile forces at home, not least their own government and its radical nationalist supporters, and people abroad who condemn all Israelis

One can sympathize with such feelings of being misunderstood or even abandoned. Guilt by association is never fair. A good reason to oppose cultural boycotts is that they harm and alienate the very people who should be allies in opposing dictatorship and

for the horrors inflicted on the Palestinians.

There is, however, a glaring void in all the anti-war and pro-democracy demonstrations in Israel: hardly anyone mentions the Palestinians. There are banners everywhere demanding that the government "bring the hostages home." People on the left and the right of Israeli politics wear yellow ribbons. Amateur art installations outside the excellent Tel Aviv Museum of Art movingly express the anguish Israelis feel about the hostages, many of whom have already died in Gaza's stifling tunnels.

People on television talk shows deplore the continuation of a war that might cause all remaining Israeli hostages to die. But even though pictures of shattered buildings and streets in Gaza are shown, there are no images of Palestinian civilians being killed, maimed, driven from their homes, and starved. Haaretz still reports on these atrocities, but the readers of this fine liberal

newspaper constitute only about 4% of the Israeli population. For the rest, it is all too easy to pretend that the suffering of Palestinians is none of their concern. Or, worse, many Israelis regard even raising the issue as being in bad taste, as though any mention of it were just an encouragement to anti-Semites. I heard about an anti-war demonstration in Jerusalem where the microphone was taken away from a protester who began to discuss the Palestinian victims.

In Jerusalem, I met a middle-aged person, fiercely anti-Netanyahu and anti-war, who speaks Arabic and has started a worthy charity organization for the poor. When I asked whether her charity benefited Arabs, too, she sighed, and said she wished it were possible. Then she explained that the Palestinians said they wanted peace, but all of them supported the murders and abductions of more than 1,200 Israelis on 7 October, 2023. What happened on that day reminded her of the Nazi Holocaust. How could one possibly have friendly relations with such people?

This view cannot simply be dismissed as bigotry or racism. Her view is widely shared in Israel. There are many good reasons to be critical of Israeli oppression of Palestinians and indifference to their suffering. But it is foolish to underestimate the shock of 7 October. Suddenly being subjected to the kind of savage brutality from which Jews in Israel thought they finally would be safe revived memories of centuries of persecution, murder, and humiliation.

This would have been the case even if Netanyahu had been a less cynical leader, bent on continuing a war to maintain his government of extremists. Out of government, he will be tried and possibly convicted of fraud and corruption. He is not the first Israeli prime minister to use the long narrative of Jewish victimhood, culminating in the Holocaust, for political ends. David Ben-Gurion already did that in 1961, when Adolf Eichmann, the Nazi bureaucrat of mass murder, was put on trial in Jerusalem. But Netanyahu has done more than all his predecessors to promote the idea that the Palestinians, and Hamas in particular, are an existential threat to the Jews and that only he can protect them from a second Holocaust.

The 7 October attack made the last claim appear hollow, which is one reason for Netanyahu's plummeting popularity. But most Israelis share his view of an existential threat. In a struggle for survival, there is no room for compassion toward the enemy. That is why well-meaning people can be vehemently opposed to an illiberal, self-serving leader, while succumbing to the fears he has stoked.

the Government of India passed a bill along with the Finance Bill 2025, introducing a controversial provision that has sparked outrage among pensioners and legal experts alike. This legislation seeks to classify pensioners who retired in the past as a separate category, effectively denying them benefits that may be granted to those retiring after the bill's enactment. The move has been widely criticized as an attempt to bypass the landmark Supreme Court judgement that upholds the constitutional right to equality for all pensioners. At the heart of the issue is

the government's assertion that pensioners of the same class can be divided based on an artificial cut-off date. According to this perspective, those who retired earlier should not be entitled to benefits granted to future retirees. This argument stands in stark contrast to the principles laid down by the Supreme Court, which had previously ruled that the government cannot arbitrarily divide pensioners of the same class. The attempt to introduce such a significant change within the Finance Bill, rather than as a separate piece of legislation, raises concerns about the government's intentions. Many see this as a deliberate effort to push the bill through without due debate, especially given that it was passed despite strong opposition.

The Constitution guarantees equality before the law under Article 14. This fundamental right ensures that no individual or group is subjected to arbitrary discrimination by the state. The Supreme Court, in

its landmark ruling in Union of India vs. DS Nakara (1982), explicitly held that pensioners form a homogeneous class and cannot be treated differently based on arbitrary dates of retirement. The Court's decision reinforced that pension is not a mere bounty but a right, and any unjust distinction between pensioners violates the principles of equality and fairness.

By introducing an artificial distinction between past and future pensioners, the government is effectively contradicting this well-established legal precedent. The imposition of cut-off dates to deny benefits to older pensioners is not only discriminatory but also unconstitutional. The principle of pension parity ensures that those who have retired earlier receive the same benefits as those retiring later, provided they belong to the same service category. The government's move seeks to undo this principle, setting a dangerous precedent for future policies.

The implications of this bill are far-reaching. If implemented, it would mean that pensioners who retired before a specified date would be denied enhancements in pension amounts, medical benefits, and other allowances that may be granted to newer retirees. This would create significant disparities, making older pensioners vulnerable to financial difficulties and limiting their access to essential benefits. Many retired government employees depend solely on their pensions for their livelihood and any attempt to curtail their entitlements could have severe consequences on their

quality of life. Beyond its legal and financial implications, this move also raises ethical concerns. Pensioners are individuals who have devoted decades of their lives to government service. Denying them rightful benefits simply because they retired earlier is not just unfair but also morally indefensible. The government has a responsibility to treat all pensioners with dignity and respect. Instead of discriminating based on retirement dates, it should work towards ensuring that all retirees receive adequate financial support, especially as they grow older and their healthcare

The passage of this bill has rightly triggered strong opposition from pensioners' associations, legal experts, and political parties. Many have condemned the government's attempt to push the bill through the Finance Bill without open discussion. The move has also led to calls for legal intervention, with experts suggesting that the matter may soon be challenged in the Supreme Court. Given the clear constitutional violations, there is a strong case for striking down the provision and reaffirming the rights of pensioners.

It is imperative that the government reconsiders its position on this issue. Pensioners are not a burden on the state but individuals who have contributed to the country's development. Denying them rightful benefits undermines not only their rights but also the broader principles of justice and equality.

The government must uphold the Supreme Court's ruling and ensure that pensioners, regardless of their retirement date, receive equal treatment. The constitutional guarantee of equality cannot be compromised for administrative convenience or financial considerations. It is the duty of lawmakers, civil society, and legal institutions to stand against such discriminatory policies and protect the rights of pensioners. Any deviation from this fundamental principle would not only violate the Constitution but also erode public trust in the government's commitment to iustice and fairness.

Delimitation: Why's the south worried?

elimitation of parliamentary seats due in 2026 has evoked controversy with Opposition leaders, particularly the southern states, expressing serious concern and warning it will be a 'test for democracy'. If the delimitation is solely based on population, it is expected to violate federal fairness. This has forced the southern states to challenge the proposed delimitation with the formation of the Joint Action Committee (JAC) for 'Fair Delimitation', comprising CMs and heads of political parties from Tamil Nadu, Kerala, Karnataka, Telangana, Odisha and Punjab. It has passed a resolution calling for a 25-year extension of the freeze on Lok Sabha constituencies based on the 1971 pop-

ulation census. The JAC initiated by Tamil Nadu CM MK Stalin presented a joint representation to Prime Minister Modi by a core committee of MPs. The CMs and party chiefs are determined to challenge the Centre's delimitation plan, expressing concerns about transparency and states being penalised for successfully implementing population control measures. The JAC wants the Centre to enact Constitutional amendments to stop penalising states

that implemented population control programmes.

Another point that needs to be addressed is that while an MP can effectively represent around 3 million people in India, in the UK it is 0.1 million and closer home in Bangladesh it's 0.56 million. This is not to say that richer states should be rewarded with more seats. Nor is it necessary to tie representation to achievement of key development indicators, incentivising governments to improve their performance.

Reports indicate that Samajwadi Party and JMM have lent support to Tamil Nadu on the issue. However, the RJD has backed the proposed delimitation exercise

It is well known that the southern states stand to lose the most if the delimitation exercise is carried out on the basis of population alone. According to one estimate, Gujarat, Bihar, MP, UP and Rajasthan would have 367 seats, constituting 47% of parliamentary representation while the five southern states would have a mere 164 seats. Reduced representation could erode their say on national policy and government formation.

Though Union Home Minister Amit Shah has stated recently that no state will face

it doesn't appear to be a fact. If seats are to be allocated in proportion to the present population, UP, which now has 80 seats may send more than 130 members to a 790-strong House while Tamil Nadu will get only 43, an increase of just four seats. Indeed, states like UP. Bihar and Maharashtra would benefit, while the southern ones would see a drastic decline in their number of seats, obviously a punishment for successfully implementing family planning. It is understood that the pro-

reduction in Lok Sabha seats,

posed Delimitation Commission will be the final authority to decide the basis of the exercise. The Commission will be formed only after the population census is over and that members would go around the country to elicit states' views.

Delving into the past, the government thought it necessary not to disincentive the small family norm and delimitation of Parliament seats on basis of population was frozen for 25 years in 1976 and again for another 25 years by the Vajpayee government. The big question now is whether the BJP government wants to force delimitation in order to expand and consolidate the party's advantage in the

At 1.45 billion, the country's population continues to be above the carrying capacity of our ecosystem. In fact, the Centre has an important role to play in helping northern states, and even eastern states, in this regard. And those states that have shown success in controlling population cannot, in any way, be penalised by reducing their number of seats and thereby curtailing their powers in the national decision-making and governance process.

Obviously, an amicable solution needs to be formulated. One such solution would be to set the 2011 population as the new norm for both central resource transfers and for delimitation and freeze it at that level for the next 25 years. The delimitation could be gradual with 20 or 25% adjustment

every five years starting 2031. It is worth remembering the American political philosopher, Alexis de Tocqueville who argued that the equalising spirit of democracy exerted a prodigious influence over the whole course of society and the country, including public opinion, laws and the habits of the governed and this should not be curbed, in any way.

Altering Gandhian identity

Sir, Tushar Gandhi, the great-grandson of Mahatma Gandhi, has filed a petition in the Supreme Court challenging the Gujarat High Court's 2022 decision, which upheld the state government's ₹1,200-crore redevelopment project for the Sabarmati Ashram. In his petition, Tushar Gandhi has stated that the redevelopment project will destroy the simplicity and original ethos of the ashram, turning it into a modernised, state-controlled monument. The petition also argues that proposed structures like museums, amphitheaters, and food courts have absolutely no connection to Gandhian principles and that they would significantly alter the ashram's identity and character. Tushar Gandhi has further stated in the petition that the current plan will also displace residents of Harijan families and bypass Gandhian trusts that have historically overseen the precinct. It is bewildering on what basis the Gujarat High Court has given weight to oral submissions and affidavits of the state government without examining the ground realities or the legal implications of changing the governance structure of the Sabarmati Ashram.

Chennai, April 3: Tamil Nadu Chief Minister MK Stalin Thursday urged Prime Minister Narendra Modi to take immediate steps for retrieving the Katchatheevu island from Sri Lanka to ensure permanent protection of the traditional fishing rights of the state's fishermen in the Palk Bay area.

Writing to Modi. Stalin cited the Assembly resolution passed April 2, 2025 seeking retrieval of Katchatheevu island from Sri Lanka, and underscored that the origin of the problem was the Indo-Sri Lankan treaty (Katchatheevu Agreement) of the year 1974. The government of Tamil Nadu has been steadfast in opposing the Katchatheevu agreement right from the beginning. The Members of Parliament from Tamil Nadu had strongly opposed the ceding of Katchatheevu to Sri Lanka in Parliament in 1974.

After the signing of the Katchatheevu agreement by the union government on 28.06.1974 without the consent of the state government, the then Chief Minister M Karunanidhi immediately convened an all-party meeting at the Secretariat on the very next day 29.06.1974 and passed a resolution condemning it and wrote a letter to the then Prime Minister Indira Gandhi on the same day.

Subsequently, the Tamil Nadu legislative Assembly passed a resolution 21.08.1974 strongly opposing the decision of union government on the issue of Katchatheevu.

The Tamil Nadu legislative Assembly had passed resolutions 03.10.1991, 03.05.2013 and 05.12.2014 reiterating the consistent demand of retrieving the Katchatheevu Island to protect the traditional fishing rights of the state's fishermen.

The CM said, "The frequent apprehensions of our fishermen and seizure of their boats in large numbers have put the lives of coastal community in a state of permanent anxiety

and distress. The livelihood of the fishermen has also become uncertain due to the arrests and seizures. I have personally brought this issue to your notice for immediate intervention, during our first meeting 17.06.2021 after my assumption of office as Chief Minister and also reiterated our earlier requests for a permanent solution of this issue in our subsequent meetings as well. Since 2021, I have also written many letters to the Minister for External Af-

"Our fishermen are being sentenced to maximum imprisonment and are being levied hefty fines. Besides this their boats are confiscated and put to auction. All these aggressive measures of Sri Lanka have pushed our fishermen to the brink of extreme poverty and reaffirms our repeated demand for retrieval of Katchatheevu, which is the only way to find a permanent solution to this problem."

In this regard, the Tamil Nadu legislative Assembly unanimously passed a resolution 02.04.2025, urging the union government to immediately review the Indo-Sri Lankan Agreement and take all steps to retrieve Katchatheevu island and also to urge the Prime Minister to hold talks with the Sri Lankan government to get "all our imprisoned fishermen released along with their boats on a goodwill basis," during his upcoming official visit to Sri Lanka.

Stalin said, "I request your good office to take immediate steps to review the Indo-Sri Lankan Agreement at the earliest so that the Katchatheevu Island is retrieved and the traditional fishing rights of our fishermen are permanently protected.'

New Delhi, April 3: Delhi Assembly is targeting to set up 500 kVA capacity solar panels in 100 days to save a monthly electricity bill of Rs 15 lakh, Speaker Vijender Gupta said Thursday.

Addressing a press conference a day after the conclusion of the budget session, Gupta said that the Assembly will promote solar energy to send a message to the people to adopt it and ensure zero bills against electricity consumption.

He said the Assembly has also targeted to go paperless before the monsoon session under the National e-Vidhan Application (NeVA) project. A media desk will be set up and equipped with 25 computers, an internet connection, and printers.

Gupta said that in the 40 days of the formation of the new government in Delhi, two sessions were held and properly concluded.

The seven-day budget session was conducted for a record 27.56 hours. Gupta said that the budget tabled March 25 was discussed for 7.13 minutes by 36 members, including those from Opposition AAP.

The only calling attention motion accepted in the session was from the Opposition, he

said. The motion was moved to discuss power cuts.

"It's, however, surprising that despite being on the Assembly premises, they did not attend the discussion on their motion. I want to ask the Opposition why (they) did not attend the discussion while lying that they were stopped from speaking on the issue of power cuts," the Speaker said.

He said the Opposition will have to answer about this in the next session. Gupta asserted that "politically motivated" disruptions by the Opposition were "sternly" dealt with as the last option during the budget

In a first, one day of the session was fixed for private members resolutions. A record 78 matters were raised under the special mention rule, the Speak er said.

Eight reports of the Comp troller and Auditor General (CAG) on the performance of the previous Delhi government were also tabled in the House but the Opposition did not take part in the discussions, he said

Resolution under Rule 107 was also passed in the session, disposing of over 300 matters taken up by committees of the previous Assembly that were carried forward to the newly constituted eighth Assembly, he said. Celebration of the Hin du New Year for the first time in the Assembly was yet anoth er achievement, he asserted.

FREE BUS TRAVEL FOR WOMEN

Delhi women to get

New Delhi, April 3: The Delhi government's free bus ride scheme for women will only be available to those living in Delhi, with the transport department launching an exercise to introduce a 'lifetime' smart card for availing the benefits, officials said Thursday. The BJP government in Delhi

will soon launch the registration process for women willing to obtain the smart card for free travel in public buses, they said. The move comes days after

Chief Minister Rekha Gupta in the Assembly alleged corruption in the existing 'pink ticket' system under the previous Aam Aadmi Party (AAP) government.

"We are committed to providing this service to women... Corruption will not be tolerated. We will introduce digital travel cards for women, putting an end to the 'pink corruption' tied to physical tickets," Gup-



ta said. "The card will allow

women to travel freely on public buses anytime, eliminating corruption linked to ticketing, she added, emphasising that the ticketing system will be fully digitised to enhance efficiency. She also said that the entire

system would be modernised, and the flawed existing schemes would be revamped to ensure transparency and efficiency.

"Our goal is to make Delhi's public transport more accessible, reliable and globally recognised." Gupta said during the Budget Session of the Assemefforts to make public transports more inclusive and efficient, particularly for women.

The pink ticket scheme, launched by the AAP on the occasion of Bhai Dooj in 2019, offers free travel to women on Delhi Transport Corporation (DTC) buses.

Women receive single-jour ney passes in the form of pink tickets, with Delhi government covering the cost -- priced at Rs 10 per ticket -- and compensating the bus companies based on the total number of tickets

Participation in the scheme is voluntary, leading to a rise in the number of women using public transport in the national

The BJP, which formed the government in Delhi after more than 26 years following its landslide victory in the February 5 Assembly polls, is expected to begin work on the smart card initiative within the next two to three weeks.

Under this scheme, after identifying the "poorest of the poor" families within the Below Poverty Line (BPL) category, the government allows them to purchase up to 35 kilograms of rice and wheat at highly subsidized rates -- Rs 3 per kilogram for rice and Rs 2 per kilogram for wheat.

Ayushman Bharat scheme, launched by the Central government as recommended by the National Health Policy 2017, was not implemented in the national capital.

The scheme includes Ayushman Arogya Mandir, critical care blocks, integrated diagnostic facilities, PMJAY and the National Digital Health Mission.

The BJP, which formed its government in Delhi after more than 26 years, approved the scheme in its first cabinet meeting -- right after Chief Minister Rekha Gupta and her six ministers took the oath of office February 20.

The Delhi government has with this move increased the healthcare budget by 48 per cent for the financial year 2025 26, compared to the previous year's allocation by the AAP regime.

The current administration has allocated Rs 12,893 crore for the health sector -- an increase of Rs 4,208 crore from the Rs 8,685 crore budgeted by the AAP in FY 2024-25.

A significant portion of the funds will be directed towards implementing central health schemes, including Ayushman Bharat, which was a key BJP poll promise during the elections.

The scheme will receive Rs 2,144 crore, expanding insurance coverage for Delhi residents to Rs 10 lakh, with Rs 7 lakh being borne by the city government.

New Delhi: Delhi Police Thursday organised a drug destruction event as part of its ongoing campaign against narcotics and destroyed 1,643 kg of seized drugs worth ₹2,622 crore in the international market, an official said. The event held at Biotic Waste Solutions Pvt. Ltd. on GT Karnal Road was attended by Lieutenant Governor Vina Kumar Saxena and Police Commissioner Sanjay Arora, he added. Large quantities of narcotics, including 529 kg of cannabis, 27 kg of charas, 11 kg of heroin, 517 kg of cocaine and small er quantities of MDMA, ketamine and ephedrine, were disposed of during the event. "Set in motion the destruc tion of 1,643 kg's of seized drugs and narcotics valued at about ₹2,622 crore in the international market, in anothe major step towards Drug Free Delhi by 2027," the lieutenant governor said on X. The cocaine destroyed was part of a total recovery of 1,289 kg from a multi-state drug bust following the registration of a case Cell October 2, 2024.

TREE FELLING

SC says no activity till further orders

New Delhi, April 3: The Supreme Court Thursday asked the Telangana government to explain the 'compelling urgency' for clearing a large tree cover on a land parcel next to University of Hyderabad, and stayed any future activity till further orders

A bench of Justices BR Gavai and Augustine George Masih, which took suo motu cognisance of the state's tree felling drive in Kancha Gachibowli Forest, called it a 'very serious' matter. It said the interim report placed before it by the registrar (judicial) of the Telangana High Court depicted an 'alarming picture' as a huge number of trees were being felled aside from the deployment of huge machineries.

"We direct that until further orders, no activities of any sorts, except the protection of the trees already existing, shall be undertaken by the state," the bench said. The state Chief Secretary was ordered to answer several of its questions, including, the 'compelling urgency' in clearing the green cover for developmental activities from

a purported forest area The SC cautioned if it found lapses on the part of the state, it would take action against the Chief Secretary. "He will go to temporary prison constructed at the same spot near the lake,'

the bench said, "If Chief Secretary wants to enjoy the state hospitality, one can't help it."

The Chief Secretary was directed to explain whether the state had obtained the environmental impact assessment certificate for the development The bench asked whether for

felling the trees, requisite permission from the forest authority or any other local statutes was obtained. In case the state authorities

were found in the violation of any of its directions in true letter and spirit, the onus would fall on the state's chief secretary, it added.

The court enquired about the status of the felled trees.

A central empowered committee was directed to visit the place in question and submit its report prior to April 16, when the matter would be heard again. The committee was formed in 2002 after a top court order for monitoring and ensuring compliance of the directions of the apex court on preservation of forests and wildlife. The apex court referred to its March 4 order in a separate matter in which it had directed the states and union territories to constitute within a month an expert committee for preparing a consolidated record of lands, including forest like areas, unclassed and community forest lands.

Parl panel flags delays in MGNREGA payments

The Standing Committee on Rural Development and Panchayati Raj, in its eighth report on MGNREGA that was tabled in Parliament Thursday, highlighted that delays in wage payments continue to be a significant issue, affecting lakhs of rural workers dependent on the scheme for livelihood

New Delhi, April 3: A parliamentary panel has raised concerns over delays in wage payments under the Mahatma Gandhi National Rural Employment Guarantee Act (MGN-REGA) and called for urgent reforms in the National Social Assistance Programme (NSAP) to ensure better support for vulnerable sections of society.

The report urged the government to address systemic

bottlenecks, improve fund allocation, and ensure timely payments. Additionally, the panel expressed concerns over the declining budgetary allocation for MGNREGA and the increasing demand for jobs under the scheme. It recommended revising the wage structure to match inflation and strengthening grievance redressal mechanisms to protect workers' rights.

The report also pointed out issues such as the lack of

proper job card issuance, the need for better social audits, and the importance of including more women beneficiaries in MGNREGA employment. Furthermore, it emphasized that material shortages and administrative delays at the state level must be addressed to ensure seamless implementation of the scheme.

In its ninth report 'Impact

of National Social Assistance Programme on the Poor and Destitute in the Villages', which provides financial assistance to senior citizens, widows, and persons with disabilities, the committee flagged inadequacies in pension amounts. The report observed that current pension rates under the scheme remain insufficient to meet basic needs, urging the government to revise the amounts in line with rising living costs.

It also stressed the need for a simplified application process and better integration of NSAP with other social security schemes to enhance outreach. The panel further recommended an increase in central contributions to NSAP, saying that the financial burden should not be disproportionately placed on state governments.

It also suggested greater transparency in fund disbursement and improved tracking mechanisms to prevent delays in pension payments. The report emphasised the need to expand the coverage of NSAP, ensuring that all eligible beneficiaries receive assistance without bureaucratic hurdles. Moreover, it called for a periodic reassessment of pension amounts to reflect inflation trends and ensure sustainable social security support.

Another report analyzed broader welfare program inefficiencies, highlighting gaps in the implementation of direct benefit transfers (DBT). The panel noted that DBT-related delays hinder access to essen tial social benefits, particularly in rural areas where banking infrastructure remains weak It called for improved coordina tion between financial institutions and government agencies to ensure smooth transactions The report also stressed the


need to strengthen awareness campaigns so that eligible beneficiaries are informed about their entitlements. The panel urged the government to launch community outreach programs, especially in remote regions, to educate citizens on accessing welfare schemes.



SC refuses to relax ban on firecrackers in Delhi-NCR

New Delhi, April 3: The Supreme Court Thursday refused to relax the ban imposed on the manufacture, storage and sale on firecrackers in Delhi-NCR noting that air pollution levels remained alarming for a con-

A bench of Justices Abhay S Oka and Ujjal Bhuyan said a large section of the population worked on streets and was the worst affected by pollution. Not everybody can afford an air purifier at their residence or place of work to fight pollution, the bench said.

orders passed "Several by this court during last six months bring on the record the horrible situation with which prevailed in Delhi due to very high levels of air pollution... Right to health is an essential part of Article 21 of the constitution so is the Right to live in a pollution free atmosphere," the court said.

Unless the court was satisfied that the pollution due to the "socalled" green crackers was bare minimum, there was no question of reconsidering the previous orders, it added. The bench said restricting the ban on firecrackers in the Delhi-NCR region just around Diwali would be meaningless, as it could be purchased and stored in advance. The top court said the orders passed from time to time would indicate that the directions and ban on the use of firecrackers was warranted by an "extraordinary situation" created in Delhi.

Senior Advocate Aparajita Singh, who is amicus curiae in the case, informed the bench that all four NCR states had banned firecrackers, but online sale remained an issue in some states like Uttar Pradesh and Rajasthan. The apex court also raised the issue of noise pollution caused by bursting of firecrackers. The top court was hearing a batch of petitions filed by firecracker manufactures seeking relaxation of ban and permission to sell green crackers.

"Our lawvers will review this matter. If the BJP wants to send me to jail for supporting them, they can. Catch me if you want to." she declared.

residence in New Delhi, she questioned why such cases are treated differently when money is found at a judge's home. "I have heard and read reports of huge cash being recovered from a judge's residence. If you recover money from a sitting judge's home, he is only transferred. Then why were these candidates not transferred? The first judge (ex judge of Calcutta High court Abhiiit Gangopadhyay) to give this order is now a BJP MP," she said. She alleged that the verdict was "influenced by a conspiracy between the

Govt tables Waqf Bill in Rajya Sabha

Chennai, April 3: Union Minority Affairs Minister Kiren Rijiju Thursday tabled the Waqf (Amendment) Bill, 2025 in the Rajya Sabha, asserting that the proposed legislation is not against Muslims or intended to hurt their religious feelings, but seeks to improve the functioning of Waqf properties, address the complexities, ensure transparency and introduce technology-driven management.

The Lok Sabha passed the Bill with a 288-232 vote in the wee hours of Thursday after nearly 12 hours of debate.

Tabling the Bill in the Upper House, which was examined and redrafted by a Joint Parliamentary Committee (JPC), Rijiju said the proposed legislation has nothing to do with religion, but deals only with properties.

The Bill aims to include all the Muslims sects in the Waqf board, Rijiju said.

The minister informed the

House that there were 4.9 lakl Wagf properties in 2004, which have now increased to 8.72 lakh. Seeking the Opposition's

support to pass the Bill, Rijiju said it aims to accomplish the unfulfilled tasks of the previous governments. He also said that Waqf owns

the largest chunk of properties in the country, leaving aside those owned by defence and railways. Brushing aside the charges made by the Opposition, Rijiju said, "The Bill is not against Muslims... We don't want to hurt anyone's religious sentiments. The Waqf board is set up only to oversee, and not manage, Waqf properties. "The government has introduced the Bill with a good intention, and thus renamed it as 'UMEED'. No one should have any problem with the name. he added. The government pro poses to rename the Waqf Bill as Unified Waqf Management Empowerment, Efficiency and

Showdown between J&K L-G, Abdullah govt looms over transfers

Srinagar, April 3: A showdown is looming between Jammu and Kashmir Lt Governor Manoi Sinha and the nearly six-month-old government over the transfer of bureaucrats and other issues, prompting Chief Minister Omar Abdullah to convene Friday an urgent meeting of MLAs belonging to the ruling National Conference and supporting parties.

The agenda for the meeting to which legislators of the alliance partner Congress have also been invited, remained a subject of speculation as Abdullah and NC spokespersons remained tight lipped.

But the meeting is expected to discuss reported interference by Raj Bhavan in administrative matters which fall in the domain of the elected government.

The controversial transfer of 48 bureaucrats belonging to the Jammu and Kashmir Ad-

ministrative Service (JKAS) by the LG two days ago led to the latest flashpoint between the Raj Bhavan and the Abdullah government which regards the transfers as violative of the legal and administrative framework under Jammu and Kashmir Reorganisation Act.

Sources in the know said the chief minister has written to Sinha asking him to review the unilateral decision, pointing out that the transfers and postings of officers outside the All India Services cadre was the exclusive prerogative of the elected government.

Such orders undermine the functioning and authority of the elected government, Abdullah asserted in the letter. Abdullah is said to have taken up the matter with Union Home Minister Amit Shah complaining that a series of actions by the LG, including the transfers, eroded the authority of his government.

The LG's approach was a serious challenge in functioning



of the elected government, he is said to have stated.

Though the Abdullah government had been facing difficulties with the Raj Bhavan over several administrative issues, Sinha's Tuesday order to transfer and post 48 JKAS officers led to a face-off between the two power centres in the Union territory.

The chief minister also called for the expedited finalisation of the Transaction of Business

Rules, which were approved by the Cabinet on March 6, saying that the delay in issuing these rules is contributing to the current administrative friction.

Abdullah has also directed Chief Secretary Atal Dulloo to ensure that no transfer or posting orders for non-All India Services officers are issued without his prior approval.

He has specifically asked the chief secretary to keep the transfer orders of the 48 JKAS

officers in abeyance.

In the meantime, Friday's meeting is expected to convey the same feelings to the LG as well as the Centre.

The announcement of the meeting was made by NC Chief Whip Mubarak Gul on Thursday, who stressed on its significance, requesting all members to prioritise attendance.

Political analysts argue that the LG's recent transfers signify an attempt to gain an overarching control of the bureaucratic structure, particularly at a time when the elected government is awaiting approval from the Union Home Ministry for its proposed governance rules.

"Until we receive statehood, it is essential to establish business rules for clarity," Chief Minister Abdullah had said during a response to the LG's Assembly address, noting that the Cabinet had finalised the governance rules in a meeting on March 6 and submitted them for the LG's approval.

Abdullah has previously expressed his discontent with the dual governance model in the Union Territory, labelling it as a "recipe for disaster".

In a show of solidarity, the Congress party also criticised Sinha's decision on Thursday, saying that the LG should have awaited approval of the business rules before proceeding with officer transfers

Gulam Ahmed Mir, the Congress's national general secretary and leader of the Congress Legislative Party (CLP) in the J&K Assembly said that the LG should have exercised more patience, asserting that such actions could undermine confidence in the administration.

The current business rules stipulate that the chief min ister has dominion over the transfers of local JKAS officers while the LG retains authority over senior officers (IAS), Mir said, adding "taking such a step was not advisable".



Washington/Ottawa, April 3: President Donald Trump's sweeping tariffs on US imports sparked threats of retaliation Thursday, as companies and governments rushed to count the costs from an escalating trade war that threatens to shake up global alliances.

The penalties announced Wednesday unleashed turbulence across world markets and drew condemnation from other leaders facing the end of an era of trade liberalization that has shaped the global order for decades.

Trump said he would impose a 10% baseline tariff on all imports to the United States and higher targeted duties on some of the country's biggest trading partners, hammering goods from Italian coffee and Japanese whisky to sportswear made in Asia. Automaker Stellantis said it would temporarily lay off US workers and close plants in Canada and Mexico.

Canadian Prime Minister Mark Carney said the United States had abandoned its historic role as a champion of international economic cooperation.

"The global economy is fundamentally different today than it was yesterday," he said as he announced a limited set of countermeasures.

Elsewhere, China vowed retaliation for Trump's 54% tariffs on imports from the world's No 2 economy, as did the European Union, which faces a 20% duty. French President Emmanuel Macron called for European countries to suspend invest-

China urges US to immediately lift tariffs, vows retaliation

Beijing: China Thursday urged the United States to immediately cancel its latest tariffs and vowed countermeasures to safeguard its own interests, after President Donald Trump declared sweeping levies on US trading partners around the world. The US move disregards the balance of interests reached in multilateral trade negotiations over the years and the fact that it has long benefited greatly from international trade, China's Commerce Ministry said in a statement. "China firmly opposes this and will take countermeasures to safeguard its own rights and interests," the ministry said, as the world's largest economies look set to spiral deeper into a trade war that stands to upend global supply chains Trump Wednesday announced China would be hit with a 34% tariff. on top of the 20% he previously imposed earlier this year, bringing the total new levies to 54% and close to the 60% figure he had threatened while on the campaign trail.

Substantial implications for global trade: WTO DG

New Delhi: WTO Thursday said the measures announced by the United States will have substantial implications for world trade and economic growth prospects, and could lead to an overall contraction of around 1 per cent in global merchandise trade volumes this year. The statement by Director-General of the the World Trade Organization (WTO) Ngozi Okonjo-Iweala follows US decision to impose tariffs on nearly 60 countries. In a statement, Director-General of the the World Trade Organisation (WTO) Ngozi Okonjo-Iweala said the WTO Secretariat is closely monitoring and analysing measures announced by the United States April 2. "Many members have reached out to us and we are actively engaging with them in response to their questions about the potential impact on their economies and the global trading system," she said, adding that the recent announcements will have substantial implications for global trade and economic growth prospects. "While the situation is rapidly evolving, our initial estimates suggest that these measures, coupled with those introduced since the beginning of the year, could lead to an overall contraction of around 1 per cent in global merchandise trade volumes this year, representing a downward revision of nearly four percentage points from previous projections," she said.

A day after declaring their intention to capture large swathes of the crowded enclave, Israeli forces pushed into the city on Gaza's southern edge which had served as a last refuge for people fleeing other areas for much of the war.

Rafah "is gone, it is being wiped out," a father of seven among the hundreds of thousands who had fled from Rafah to neighbouring Khan Younis, told Reuters.

The assault to capture Rafah is a major escalation in the war, which Israel restarted last month after effectively abandoning a ceasefire in place since January. Netanyahu applauded Hungary for its the International Criminal Court as he visited Budapest Thursday, a rare trip abroad in defiance of an ICC arrest warrant. Netanyahu, invited by Hun gary's right-wing Prime Minister Viktor Orban, faces the ICC arrest warrant over allegations of war crimes in Gaza as Israel has expanded its military operation in the Palestinian enclave. Hungary has rejected the idea of arresting the Israeli prime minister and has called the warrant "brazen" In an announcement timed with Netan gary would withdraw completely from the ICC, an organisation set up more than two decades ago to prosecute those accused of war crimes, crimes against humanity, and genocide.

Israel has not spelled out its longterm aims for the security zone its troops are now seizing. Prime Minister Benjamin Netanayahu said troops were taking an area he called the "Morag Axis", a reference to an abandoned former Israeli settlement between Rafah and Khan Younis.

Gazans who had returned to homes in the ruins during the ceasefire have now been ordered to flee communities on the northern and southern edges of the strip.

Protesters clash with police in Haiti over gang violence

Port-Au-Prince, April 3: Thousands of Haitians took to the streets in Port-au-Prince Wednesday to express their anger against armed gangs that control nearly all of the capital and surrounding areas and the government's failure to hold them off.

Violent armed groups have united behind a coalition known as Viv Ansanm and forced over 1 million people from their homes, which has contributed to a freezing of the economy and fueled mass hunger. They are also accused of extortion, mass rapes and killings.

The transitional government. a rotating body of presidential council members appointed nearly a year ago, alongside a long undermanned and underfunded UN-backed security mission, have done little to hold off the gangs' advances

"Do you see what is happening?" protestor Joseph Mackendy told Reuters at the demonstration. "Today, Haitian people will fight to be free already. We are free. Those men today cannot frighten me.

Residents filled the streets of Port-au-Prince carrying ban-



ners and palm fronds, while some carried machetes and firearms. The protest began peacefully but gunfire erupted later in the day, causing a panic that caused crowds to flee.

We, the residents of the Solino neighborhood, we want to return home, and we will go home," added Julien David, another protester. Many critics alleged the government's poor performance against the gangs' advances is tied to state corruption and even collusion with the armed men and their financial backers.

The government rejects these accusations, but Haitian authorities have a long history of ingrained corruption, and its judicial system has been paralyzed amid the violence.

The protest comes days after a mass jailbreak in the central town of Mirebalais. Separately Wednesday, Haiti was among the countries slapped with 10% tariffs by the United States.

Myanmar's military head visits Thailand in rare overseas trip

Bangkok, April 3: The head of Myanmar's military government arrived in Thailand Thursday for a regional summit, making a rare international trip as his country recovers from a devastating earthquake that killed thousands.

Senior General Min Aung Hlaing has been shunned by much of the West for overthrowing the democratically elected government of Aung Saan Suu Kyi and subsequent brutal repression. He has not been allowed to participate in meetings of another regional organisation, the Association of Southeast Asian Nations (ASEAN), since the army seized power in February 2021 and began violently suppressing opposition.

He is one of several regional leaders visiting Bangkok for a three-day summit of nations in the Bay of Bengal region.



SpaceX rocket cargo project puts Pacific seabirds in jeopardy

Washington, April 3: A project proposed by Elon Musk's SpaceX and the US Air Force to test hypersonic rocket cargo deliveries from a remote Pacific atoll could harm the many seabirds that nest at the wildlife refuge, according to biologists and experts who have spent more than a decade working to protect them.

It would not be the first time that SpaceX's activities have affected protected birds. A SpaceX launch of its Starship rocket in Boca Chica, Texas, last year involved a blast that destroyed nests and eggs of plover shorebirds, landing the billionaire Musk's company in legal trouble and leading him to remark jokingly that he would refrain from eating omelets for

a week to compensate. The Air Force announced in March that it has selected

Johnston Atoll, a US territory in the central Pacific Ocean located nearly 800 miles (1,300 km) southwest of the state of Hawaii, as the site to test the Rocket Cargo Vanguard program it is developing with SpaceX. The project involves test

landing rocket re-entry vehicles designed to deliver up to 100 tons of cargo to anywhere on Earth within about 90 minutes. It would be a breakthrough for military logistics by making it easier to move supplies quickly into distant locations. According to biologists and

experts who have worked on the one-square-mile (2.6 square km) atoll - designated as a US National Wildlife Refuge and part of the Pacific Remote Islands Marine National Monument - the project could be too much for the island's 14 species of tropical birds to withstand. Roughly a million seabirds

Johnston Atoll, closed to the public, is administered by the Air Force and managed by Fish and Wildlife Service. The island was used for nuclear testing from the late 1950s to 1962, and to stockpile chemical munitions including Agent Orange from 1972 to 1975.

The Air Force completed a clean-up of the atoll in 2004 and it has served as a haven for nesting seabirds and migrating shore birds since. Visits by people to the island have been highly controlled to avoid disturbing the birds.

Dabur sees drop in **March qtr profit**

New Delhi: Home-grown FMCG major Dabur expects its revenue to decline in March quarter impacted by slowdown in urban markets and contraction of 150-175 basis points in operating profit margin due to inflation. Dabur expects its consolidated revenue to be "flattish" during O4 FY25, the company said in its latest quarter updates filed on Wednesday late evening. Following this undate, shares of Dabur India tumbled Thursday morning to its 52-week low at ₹458.25. Though it revived later to ₹464.55, it was still 6.25 per cent lower from the previous close. Its key international markets, including the MENA region, Egypt, and Bangladesh, performance, leading to robust double-digit growth. Dabur gets nearly one-fourth revenue from international business.

BoB reports 12.8% loan growth in Q4

New Delhi: State-owned Bank of Baroda (BoB) Thursday said it has posted a credit growth of 12.8 per cent to ₹12.3 lakh crore for the March quarter. Total advances were ₹10.9 lakh crore at the end of March 2024, BoB said in a regulatory filing. The lender reported 10.25 per cent rise in total deposits to ₹14.7 lakh crore as against ₹13.35 lakh crore at the end of the fourth quarter of the previous financial year. Total business of the bank rose 11.4 per cent to ₹27.03 lakh crore as compared to ₹24.25 lakh crore at Marchend 2024. Meanwhile, another public sector lender Bank of India reported a 13.59 per cent loan growth to ₹6.65 lakh crore at the end of fourth quarter of FY25 as against ₹5.85 lakh crore in the same period a year ago.

New Delhi, April 3: India's export sectors such as shrimp, carpet, medical devices and gold jewellery will face the impact of the 27 per cent additional import duties announced by the US Wednesday, an official said

However, export segments like electronics, textiles, and pharma will get an edge over its competitor countries in the US.

On April 2, US President Donald Trump announced a major new tariff policy designed to reduce the US trade deficit and boost domestic manufacturing. The announcement includes

a universal 10 per cent tariff on all imported goods, effective April 5. It will be replaced by 27 per cent duty on April 9. Over 60 countries are affected by the measures announced by America. The US is the largest market of domestic shrimp industry.

Shrimp will now become significantly less competitive in the US market due to the higher tariffs.

America already has anti-dumping and countervailing duties on Indian shrimp. Out of India's total shrimp ex-

ports, the country ships 40 per cent to America. Ecuador and Indonesia are major competitors of the domestic exporters in the US market.

The export of frozen shrimps during 2023-24 was 7,16,004 tonnes. The US imported 2,97,571 tonnes last fiscal year, followed by China (1,48,483 tonnes), the European Union (89,697 tonnes), and Japan (35,906 tonnes).

The US continued to be the major importer of Indian seafood in value terms, with an import worth \$2.55 billion, accounting for a share of 34.53 per cent.

Frozen shrimp continued to be the principal item exported to the US, with a share of 91.90 oer cent. Exports of black tiger shrimp to the US increased 35.37

In 2023-2024, India exported gems and jewellery worth \$32.85 billion globally, with the US accounting for 30.28 per cent (\$10 billion). In 2024, India exported diamonds, gold. and silver worth \$11.88 billion in exports. It has a tariff differential of 13.32 per cent.



Gold climbs ₹200 to hit record high of ₹94,350

New Delhi, April 3: Gold prices climbed ₹200 to hit a fresh peak of ₹94,350 per 10 grams in the national capital Thursday amid persistent buying by jewellers and stockists, according to the All India Sarafa Association.

The precious metal of 99.9 per cent purity had stayed flat at ₹94,150 per 10 grams Wednes-Rising for the fifth straight

day, gold of 99.5 per cent purity rose ₹200 to establish a lifetime high of ₹93,900 per 10 grams.

However, silver prices plunged ₹1,000 to ₹1,00,500 per kg from Wednesday's closing level of ₹1,01,500 per kg.

Meanwhile, gold futures for June delivery on the MCX. climbed ₹695 to hit a record high of ₹91,423 per 10 grams. Later, it pared all its gains, trading lower by ₹848 at ₹89,880 per 10 grams.

"Gold saw an initial rally in the morning session driven by the impact of reciprocal tariffs but soon faced profit-booking as prices had largely factored in the tariff effects," Jateen Trivedi, VP Research Analyst of Commodity and Currency at LKP Securities, said.

In the international markets, spot gold dipped \$43.39, or 1.38 per cent, to \$3,089.64 per ounce. On Wednesday, it had hit a fresh peak of \$3,167.71 per ounce after US President Donald Trump unleashed tariff barrage on over 60 countries.

"Gold soared to a new record high of \$3,167 per ounce as risk aversion heightened following President Trump's tariff decision," Saumil Gandhi, Senior Analyst -- Commodities at HD-FC Securities, said.

AFI's new directive

New Delhi: Athletics Federation of India (AFI) has made it mandatory for athletes to compete in at least one regional competition or country-wide one-day event like the Grand Prix to be eligible for participation in the Federation Cup. the first national championship of the season 2025. This is being done to ensure that athletes come prepared or show consistency as the Indian team for the Asian Championships to be held in Korea from May 27-31 will be picked on the basis of performance at the Federation Cup, which will be organised in Kochi, Kerala from April 21-24. However, the athletes who are sent abroad by AFI for training, like double Olympic medallist javelin thrower Neeraj Chopra, wiii be exempted from this regulation. "To participate in this competition (Federation Cup), athletes must achieve the qualification entry standards in events directly organised by the AFI in the year 2025," the AFI said

The Division A will be the highest one as the teams in it will fight for the championship title. Division B will have teams competing for promotion to Division A next season while in Division C, the teams will fight for a spot in Division B for the next edition.

The Division B and C matches are scheduled to begin April 4 while the Division A matches will commence April 8.

Division A has the top-12 teams in India, including defending champions Odisha and runners-up Haryana, based on their overall performances in the tournament over the years.

Each team will play every opponent once in their respective pools.

Real Madrid mint record \$154mn from Champions League win

The Spanish club topped prize money table last season

Geneva, April 3: Champions League winner Real Madrid topped the prize money list last season by getting almost 139 million euros (\$154 million), UEFA said Thursday, finally confirming the payments.

Madrid's money came from a total competition prize fund of more than 2 billion euros (\$2.22 billion) that rises by 25% this season in the new and expanded format with more teams and more games.

UEFA's formula to pay clubs

included Madrid getting more than 36 million euros (\$40 million) as the top-ranked club preseason, but just 14 million euros (\$15.5 million) as a share of income from broadcast rights

Paris Saint-Germain was the second biggest earner — despite being eliminated in the semifinals — with 122.4 million (\$135.7 million). That included 34 million euros (\$37.7 million) from TV money with the French rights deal shared with Lens as the only two French teams in the group stage.

Borussia Dortmund, the beaten finalist, just edged Bayern Munich with both getting more than 120 million euros (\$133 million). German broadcast money was shared among



four teams.

In the second-tier Europa League, beaten finalist Bayer Leverkusen got the highest payment of 41.2 million euros (\$45.7 million). Title winner Atalanta got almost 34 million euros (\$37.7 million).

Liverpool, which was beaten by Atalanta in the quarterfi-

nals, earned less than 27 million euros (\$30 million) from UEFA. Manchester City earned 110.5

million euros (\$122.5 million) from reaching the Champions League quarterfinals as the defending champion. An extra 4.5 million euros (\$5 million) was earned playing in the season-opening Super Cup against Sevilla, winner of the 2023 Europa League.

Barcelona got just 98 million euros (\$108.6 million) for reaching the Champions League quarterfinals in another financially challenging year for the club, which has had issues
