IB chief's tenure extended again

New Delhi: Counter-terrorism expert Tapan Kumar Deka was Tuesday given an additional one-year term till June 2026 as the chief of the Intelligence Bureau (IB), the second such extension for him. This comes amid the evolving security situation in the wake of India's strike May 7 on terror infrastructure in Pakistan and Pakistan-Occupied-Kashmir in retaliation against last month's Pahalgam terrorist attack, Deka, 62, a 1988-batch Indian Police Service (IPS) officer of the Himachal Pradesh cadre, was in June 2022 appointed as the IB chief for two years. His term was extended by one year in June last year.

Munir promoted to Field Marshal rank

Islamabad: Pakistan government Tuesday decided to promote Army Chief General Asim Munir to the rank of Field Marshal for his role in the recent conflict with India, making him the second top military officer in the country's history to be elevated to the position. The decision to promote Gen Munir was taken at a cabinet meeting chaired by Prime Minister Shehbaz Sharif, according to an official statement. Munir is the first army general since General Ayub Khan to be elevated to the highest military rank in Pakistan. General Khan was conferred the rank of Field Marshal in 1959.

No fresh Covid case in state

Bhubaneswar, May 20: Amid reports of the death of two Covid-infected patients in Maharashtra, the state Health department Tuesday said no fresh coronavirus case was reported in Odisha.

State Public Health Director Nilakantha Mishra said if anyone is found to be positive for the Covid infection, the sample of such a patient would be sent for genome sequencing to ascertain the variant of the virus

"Till now, we have not detect ed any fresh Covid case. If we find such a patient, the sample will be sent for genome sequencing to determine its variant," he said. Health authorities in India are keeping an eye on reports of a rise in Covid-19 cases in Singapore and Hong Kong, even as official sources Monday assert ed that the current coronavirus situation in the country was under control.

"However, people, especially those having co-morbidity, have to remain careful and take stan dard precautionary measures, Mishra advised. Civic-run KEM Hospital Monday clarified that the deaths of two patients at the medical facility in Mumbai were due to co-morbidities and not linked to Covid-19, as it advised people not to panic.

CHSE Class XII exam results today

Bhubaneswar: The Council of Higher Secondary Education (CHSE), Odisha, will announce the Plus II (Class XII) examination results at 4 pm Wednesday. Results for Arts, Science, **Commerce and Vocational streams** will be declared simultaneously, according to an official statement issued Tuesday. Students can check their results through the official websites. Principals of higher secondary schools will be able to access the tabulation registers from SAMS e-Space an hour after the results are

More power to ministers SC: Assign officers for

Ahead of the celebrations of its first anniversary, the Mohan Charan Majhi-led BJP government in the state has restructured the Cabinet meeting protocols, giving more powers to ministers and significantly curtailing powers of secretaries in the respective departments. Experts say the move has signalled the end of bureaucratic supremacy in governance which the state had witnessed during the over two-decades rule by the BJD dispensation wherein secretaries took centre stage in policy decisions. The corridors of power had then shifted from the Cabinet to a cabal of favoured bureaucrats, infamously referred to as the 3rd floor. By restoring the mandate and powers of the people's representatives, the Majhi government has not only aimed at upholding the norms of democracy, but also made the ministers more responsible and responsive.

Bhubaneswar, May 20: In a significant move, the Odisha government has curbed the powers of senior bureaucrats, particularly secretaries, in the functioning of Cabinet meetings. As per the new rules,

secretaries will no longer be allowed to sit in the Cabinet room during meetings. Only ministers will be permitted to present proposals related to their respective departments.

The government has also introduced a structured timeline for Cabinet proceedings. Accordingly, the meeting date must be finalised five days in advance, with the agenda finalised three days earlier. Relevant files are to reach the concerned ministers at least two days prior to the meeting. A directive outlining these new protocols has been issued to all departmental secretaries by the Parliamentary Affairs depart-

It has been clearly stated that no proposal can be placed before the Cabinet without the Chief Minister's prior approval. In previous administrations, ministers often received Cabinet agendas at the last minute and were unaware of the proposals under discussion. This lack of transparency had become a norm. The new rules seek to reverse that pattern by reducing bureaucratic dominance over the Cabinet process.

As per the guidelines, ministers must now present the



proposals themselves. Secretaries will remain in an adjacent room during meetings, and may be called in only if necessary. The responsibility of executing Cabinet decisions promptly lies solely with the ministers. Furthermore, if the agenda is not submitted by 5pm, three working days prior to the meeting, it will not be considered. If that third day falls on a holiday, the agenda must be submitted a day

If inputs are required from a secretary regarding any proposal, they can provide their opinion beforehand. Otherwise, their presence in the Cabinet room is not required.

Revenue Minister Suresh Pujari welcomed the move. stating that Cabinet decorum and protocol were often violated during the previous regime. "Only the minister concerned should present the departmental issue being discussed. The role of political leadership in a democracy must be honoured,' he said.

BJD legislator Kalikesh Singh Deo criticised the move, accusing the government of focusing more on public relations than on actual governance. "Let the government stop marketing itself and start working for the people," he said.

It may be noted that during the previous BJD government. ministers often did not have access to the agenda even after Cabinet meetings began. Departmental secretaries would handle the entire process. A former minister, speaking on condition of anonymity, recalled how Cabinet meetings would conclude within the time it took to finish a cup of tea. "Barely five minutes were given for discussion on any agenda item," the former minister said.

The abrupt shift in procedure has sparked widespread political discussion in state circles, with many questioning the timing and intent behind the changes.

protection of women

New Delhi, May 20: The Supreme Court Tuesday directed all the states and Union Territories (UTs) to identify officers in the Department of Women and Child Development at the district and taluka levels and designate them as protection officers. A protection officer is an appointed individual tasked with ensuring the safety and well-being of victims of domestic violence.

A bench of Justices BV Nagarathna and Satish Chandra Sharma directed the chief secretaries of the states, UTs and the secretaries of the Women and Child/Social Welfare departments to coordinate and ensure the designation of officers as protection officers under the Domestic Violence Act.

"They shall also take steps to discharge their duties under Section 11 by giving wide publicity through media to promote awareness about the provisions of the Act, ensure effective coordination of services under the Act, and implement its provisions," it said. The bench directed for the exercise to be completed within six weeks from today in areas where protection officers weren't designated.

"The states shall ensure the availability of service providers, help groups, and shelter homes for distressed women.



The respondent states shall also identify shelter homes for this purpose," the top court added.

Underlining the right under the Legal Services Authorities Act, the bench ordered the mem ber secretary of National Legal Services Authority to instruct all member secretaries of the state legal services authorities to spread awareness among wom en about their right to free legal aid and advice under the Domes tic Violence Act. They shall also give adequate publicity to these provisions, the bench said.

"Needless to say, if any woman approaches for legal aid or advice, it shall be provided expeditiously, as the Act guaran tees every woman the right to free legal assistance," it noted

The top court's direction came on a plea filed by NGO 'We the Women of India' seeking to fill massive gaps in infrastructure under Protection of Women from Domestic Violence Act across the country for providing effective legal aid to women survivors of abuse at matrimonial homes and creating shelter homes for them post lodging of complaints against husbands and in-laws

Philanthropy: Ambani couple, Premji in Time's 100 list

New York, May 20: Billionaire industrialist Mukesh Ambani and Nita Ambani, former Wipro chairman Azim Premji and Zerodha co-founder Nikhil Kamath have been named Tuesday by Time magazine in its inaugural list of the 100 most influential people in philanthropy.

The TIME100 Most Influential People in Philanthropy 2025 list "tells the stories of how generous donors and leaders of foundations and non-profits are directing funding into the communities that need it most," according to the publication.

The list includes Mukesh and Nita Ambani who, Time said, gifted Rs 407 crore (about USD 48 million) in 2024, "placing them among the country's biggest donors." Noting that Mukesh and



Nita Ambani are "empowering millions", the Time profile said the billionaire philanthropist couple's "charitable initiatives are as varied and wide-ranging as the business empire that earned them an estimated USD 110 billion fortune.

It listed the initiatives taken by Mukesh and Nita Ambani and added that Nita Ambani, founder and chair of the Relinesswoman in her own right, leads a number of the foundation's programmes.

On tech magnate Premji, Time said that today, he is better known as one of India's most generous philanthropists, directing his wealth to systematically improving India's public education system.

Premji was the first Indian

to sign the Giving Pledge and in 2013 endowed the foundation he launched nearly 25 years ago with over USD 29 billion in shares from his company, Wipro.

In addition to disbursing traditional grants—USD 109 million went to 940 organisations focused on education, health, and other areas in 2023-2024the foundation works directly with teachers and rural child care workers via 59 field offices and 263 teacher learning centres throughout India, on educational programmes that have so far helped over 8 mil-

lion children, Time said. In August, the foundation also committed around USD 175 million to expand school meal coverage for more than 5 million children—all collectively reflecting Premji's philosophy, influenced by Mahatma Gandhi,

to regard "holding one's wealth in trusteeship, to be used for the betterment of society.'

The list also includes co-founder of Zerodha Nikhil Kamath, who in 2023 at age 36 became the youngest Indian to sign the Giving Pledge. "By then, he had already donated millions to environmental and educational projects—and started his own offshoot initiative. the Young India Philanthropic Pledge (YIPP), which asks Indians under age 45 with fortunes over USD 100 million to commit to giving away at least 25 per cent of their wealth," Time said.

The list also includes legendary footballer David Beckham, billionaire philanthropist Warren Buffet, American philanthropist Melinda French Gates and Prince William and Catherine, Princess of Wales.

MONSOON LIKELY TO HIT **KERALA IN 4-5 DAYS: IMD**

New Delhi, May 20: The southwest monsoon is likely to reach Kerala in the next fourfive days, much earlier than the usual date of June 1, the India Meteorological Department (IMD) said Tuesday.

The weather department had earlier forecast that the monsoon would onset over Kerala by May 27.

If the monsoon arrives in Kerala as expected, it will be the earliest onset over the Indian mainland since 2009, when it began May 23, according to IMD data.

"Conditions are likely to become favourable for monsoon onset over Kerala during next 4-5 days," the IMD said in an update Tuesday afternoon.

Normally, the southwest monsoon makes its onset over Kerala by June 1 and covers the entire country by July 8. It starts retreating from northwest India around September 17 and withdraws completely by October 15.

FIVE GET LIFE IMPRISONMENT FOR MURDER



Bhubaneswar, May 20: A local court here Tuesday awarded life imprisonment to five persons for murdering a man over old enmity between two families.

Sushant Nayak, a housekeeping staffer of the Central Horticultural Experiment Station (CHES), was hacked to death at a slum in Unit III area under Capital police station limits in the early hours of May 24, 2023, according to the prosecution.

The five convicts had chased Sushant while he was returning home and attacked him, leading

to his death. The verdict was delivered by Judge Bandana Kar of the Ad-

ditional District Judge Court-2, Bhubaneswar. The court also imposed a fine of Rs 25,000 on each of the five

convicts -- Sujit Nayak, Subash Nayak, Ajit Nayak, Bishal Nayak and Tikili Nayak. In case of non-payment, they

will have to serve an additional one year jail term, said Additional Public Prosecutor Salila Kumar Pradhan. The verdict was delivered

after the court examined 18 witnesses, 16 exhibits, and 39 documents, he said.

State govt extends UG course admission deadline till June 1

Bhubaneswar, May 20: The Odisha government Tuesday extended the online admission deadline for undergraduate (UG) courses in state-run colleges to June 1.

The decision was taken as the state Council of Higher Secondary Education (CHSE) is yet to declare the results of the Class XII final examinations. Also, the state government recently decided to provide 11.25 per cent reservation to SEBC students in undergraduate cours-

es, and eligible candidates are yet to get their certificates, officials said.

"The timeline for e-Admission into all (Plus III) Degree Higher Educational Institutions, including Self-Financing Colleges and Sanskrit Colleges of the state under SAMS, has been extended to 1st June 2025, the Higher Education (HE) department posted on X.

The earlier deadline was May 20. The HE department advised applicants in the Socially and Educationally Backward Classes (SEBC) category to obtain a

valid caste certificate from the competent authority and keep it ready for admission.

Earlier in the day, School and Mass Education (S&ME) Minister Nityananda Gond said the results of the Class XII final examinations will be announced in two days.

"We will also ensure that the students do not face any problem in admission into the degree courses," the S&ME Minister said.

A total of 3.91 lakh students had appeared for the examinations conducted by the CHSE.

t a time when India resonates with pride following the successful execution of Operation Sindoor, a precise military campaign launched in response to the terrorist attack in Pahalgam April 22, there is a feeling that the mission has enhanced the dignity of 'sindoor' - the traditional red mark worn by married Hindu women. The Pahalgam attack claimed the lives of 25 Indians and one Nepali citizen. As a powerful retaliation, Indian Armed Forces launched a series of coordinated strikes on Pakistani terror camps on the night of May 6, delivering a strong message against terrorism. Patriotic fervour swept the country as citizens rallied to salute the armed forces. But beyond the strategic and military

Polavaram row: BJD urges CM to fight for tribal rights

Bhubaneswar, May 20: Opposition BJD Tuesday called upon Chief Minister Mohan Charan Majhi to prove his tribal identity and save the life and livelihood of the tribals in Malkangiri, who are facing inundation due to the Polavaram project of neighbouring Andhra Pradesh.

Addressing a press conference here, senior BJD leader Debi Prasad Mishra voiced concern over the 'continued violations and unilateral progress' of the Polavaram project by the Andhra Pradesh government, allegedly with the active support of the Centre. The Polavaram project, situated on the Godavari river, is a multi-purpose project intended for irrigation, power generation, water supply, and river diversion.

It has become a controversial project with neighbouring states Odisha, Telangana and Chhattisgarh opposing it, fearing the submergence of land and villages.

The matter is currently pending with the Supreme Court, with petitions filed by Odisha, Chhattisgarh, and Telangana. The Central government has declared Polavaram a national project and sanctioned funds in this financial year's

Budget. The BJD leader asserted that Odisha's interests, particularly those of tribal communities in Malkangiri, must not be compromised.

"As we have a CM from the tribal community, he should come forward and save the life and livelihood of the tribals of Malkangiri district," Mishra said.

"Prime Minister Narendra Modi has called a meeting May 28 to review the Polavaram project, but neither the Odisha CM nor ministers appear to be aware of it. This raises doubts about Odisha's representation and whether the state's interests will be defended effectively, he claimed. Majhi Monday said that he has no idea about Modi's proposed meeting with the CMs of the states involved.

Mishra said that the Polavaram project, originally approved with a discharge capacity of 36 lakh cusecs in 2006, was later unilaterally revised to 56 lakh cusecs, a clear violation of the Godavari Water Dispute Tribunal recommendations.

This revision, done without the consent of Odisha or other riparian states, raises serious concerns about potential submergence and displacement in Odisha, the BJD leader said.

Odisha faces rising heat risk across districts

Khurda, including Bhubaneswar, ranks among India's most heat-vulnerable districts in new national assessment

New Delhi/Bhubaneswar, May 20: A new report released by the Council on Energy, Environment and Water (CEEW) has raised serious concerns about Odisha's vulnerability

According to the report, "How Extreme Heat is Impacting India: Assessing District-level Heat Risk," none of the districts in Odisha fall under the low or very low-risk categories. This places the entire state in the high heat risk bracket, underscoring the need for urgent climate-resilient

planning and infrastructure. Khurda district, which includes Capital city, has been identified as facing very high heat risk, while 13 other districts, including Cuttack, Balasore, Ganjam, Mayurbhanj, and Bargarh, are marked as high risk. Another 16 districts, such as Nuapada, Sundargarh, Kandhamal, Sambalpur, and

Kendrapara, are under moderate risk of extreme heat ex-

posure.

Despite being in a danger zone, Odisha performs better than many other high-risk regions, the report noted. The state's higher green cover and robust water infrastructureincluding lakes, rivers, and ponds—have played a key role in strengthening the resilience of communities to cope with soaring temperatures.

The report offers India's first comprehensive district-level


heat risk assessment, covering 734 districts using 35 indicators spanning climate trends, socio-economic vulnerability, and adaptive capacity. It reveals that 57 per cent of Indian districts, representing 76 per cent of the national population, are now exposed to high or very high heat risk.

Three alarming national trends are highlighted: a rise in very warm nights, an increase in humidity, and greater heat exposure in urban and economic hubs, including

Bhubaneswar. Warmer nights particularly threaten public health by preventing the body from recovering from daytime heat stress. Over the last decade, about 70 per cent of districts have seen at least five additional very warm nights

CEEW CEO Arunabha Ghosh remarked, "Heat stress is a present reality, not a future threat. Odisha's approach in integrating health and climate data into its planning can serve as a model for other states."

The report urges state gov ernments to revise Heat Action Plans (HAPs) to include night-time heat, humidity stress, and local risk factors. With heatwaves now recog nized under the State Disaster Mitigation Fund, states like Odisha have an opportunity to access targeted funds to build long-term heat resilience through cooling infrastructure, community awareness. and tailored action plans.

Sanitation workers stage protest

Bhubaneswar, May 20: Members of the Bhubaneswar Municipal Corporation (BMC) Workers Union, affiliated with the Centre of Indian Trade Unions (CITU), staged a protest Tuesday outside the BMC office, pressing for a hike in salaries and fulfillment of a long-standing charter of de-

mands. Carrying placards and banners, the sanitation workers raised slogans against the civic body, highlighting their vears of service without adequate pay or job security.

The protesters, who serve in roles such as sweepers, drivers, loaders, grass cutters, trolley operators, and drain cleaners, alleged that despite working for the past 10 to 20 years, they have been denied regular employment and are not paid in accordance with the Minimum Wages Act. They demanded equal pay for equal work and recognition of their skills and experience.

Their key demands include a monthly salary of ₹26,000, regularisation of employment, paid weekly holidays, earned and casual leave benefits, and other statutory entitlements.

Consultancy agency gets extension despite chinks



Keonjhar/Hatadihi, May 20: The District Mineral Foundation (DMF) Trust Board in Keonjhar district has not held a meeting since December 2022. During this period, several allegations have surfaced regarding misappropriation and misuse of crores of rupees in grants. However, no report has yet been submitted by the government officials concerned.

Amid these allegations, another controversy has emerged about continued favouritism towards a particular consultancy agency despite multiple irregularities. The contract period for the firm was extended 20 days after its expiry even though serious allegations of irregularities remain unresolved.

According to reports, the firm Ernst and Yong LLP was appointed as the project management unit (PMU) for a period of three years through an agreement signed April 7, 2022. However, this agreement was never approved in a trust board meeting, and no corresponding allocation was made. The contract was valued at approximately ₹17

crore and ended April 6, 2025.

However, no step was taken to appoint a new agency before the expiry of the contract. Instead, during an executive committee meeting held March 29, 2025, the contract of the firm was extended for three months till July 6, 2025. This finds mention in the meeting proceedings.

The DMF CEO informed the agency of the extension after a 20-day delay. However, as per Rule 6 of the Odisha DMF Rules, 2015, the executive committee does not have the authority to extend contract periods.

Moreover, no such executive committee meeting appears to have taken place as no video recording is available, and the meeting proceedings were reportedly signed by committee members without any deliberation. The meeting proceedings were written whimsically and the members were asked to sign on it.

Additionally, the issue regis-

ter was left blank and backdated, while the extension letter was handed over to the firm retroactively, raising serious questions about undue favouritism. The reasons behind this preferential treatment remain

Written complaints have been filed with the Chief Minister, the Chief Secretary, the General Administration and Public Grievances department (GAPG), Planning and Convergence department, as well as with the District Collector, seeking an investigation and necessary action.

Following the complaint, the GA&PG department has asked the district administration and the Chief Secretary's office has asked the Planning and Convergence department for a detailed report on the issue.

Sources also indicated that in 2019 and 2020 the same consultancy agency's salary and staff count were increased through executive committee resolutions, which are currently under review for violations of protocol. The repeated extension of benefits to the same agency has raised eyebrows.

Additional Secretary of Planning and Convergence department and convenor of the DMF state-level committee PK Mahakud confirmed that a detailed report has been sought following the complaints. "A thorough inquiry is underway, and necessary action will be taken based on findings," he said.

According to report, the survey aimed at assessing anaemia prevalence among the unmarried youths to reduce complications during childbirth and lower infant mortality rates has revealed that 894 unmarried young men and women are suffering from the blood related disorder.

Swadhin Rath, in charge of the CHC, emphasised that if either partner in a marriage is anaemic, it could have adverse

QUINTUPLE MURDER IN SUNDARGARH

NHRC seeks report from DM, SP

Kendrapara, May 20: National Human Rights Commission (NHRC) has sought an action-taken report (ATR) from Sundargarh District Magistrate and Superintendent of Police regarding the brutal murder of five members of a nomadic family.

The incident occurred on the night of October 29, 2024, in the district, where five members of a nomadic family were killed, and five others were allegedly kidnapped.

Acting on a petition filed by civil rights advocate Radhakanta Tripathy, the apex rights panel issued the order Monday. Tripathy alleged that the victims, part of a group of approximately 20 family members residing in tents in Karamdihi village, were attacked while they were asleep. The family, seasonal visitors selling plastic mats, was reportedly targeted due to an illicit relationship involving one of the injured individuals. The kidnapped persons reman's second wife and four children. The incident, according to

portedly include the injured

the complaint, underscores the systemic marginalisation of Denotified and Nomadic Tribes (DNTs) and calls out the alleged inaction of both the Odisha government and Central authorities, framing it as a violation of human rights.

Tripathy urged the NHRC to conduct a thorough investigation, gather updated data, implement targeted policies, and ensure justice and protection of the

rights of the DNT community. "The allegations, prima facie, indicate serious violations of the human rights of the victims," observed the NHRC Bench, chaired by Priyank Kanoongo. The commission has taken cognizance of the matter under Section 12 of the Protection of Human Rights Act, 1993.

The Registry has been directed to issue notices to Sundargarh District Magistrate and SP, instructing them to investigate the allegations and submit

Investors abduct stock trader, held

Bhubaneswar: A group of investors allegedly abducted a share market trader from Cuttack after he failed to repay them their money, police said Tuesday. The stock trader, identified as Soumya Ranjan Behera, 31, was rescued from Kendrapara town Monday after a 12-hour-long operation. All seven kidnappers have been arrested, they said. Police Commissioner S Dev Datta Singh said Soumva was actively involved in share trading between 2019 and 2022, and had set up an office at Kharvelnagar in the Capital city. Lured by the promises of high returns in a short period, a large number of people had invested their money in the markets through him, Singh said. "However, due to a sudden and severe downturn in the market, Soumya incurred massive losses and was unable to repay the investors," the police commissioner said. No fraud has been detected so far in his business, he added. Those arrested belong to Kendrapara district, Singh said, adding that a car and four motorcycles were seized from them

Newborn rescued from Deogarh forest

Deogarh, May 20: A newborn boy was rescued from a forest near Kasada village under Jamankira police limits in this district Monday morning.

According to reports, Sunita Navak of the village heard the cries of a baby while collecting kendu leaves in the forest. She began a search and discovered the baby boy before bringing him home.

Later, she handed over the infant to her sister, Susmita Nayak, a resident of Mahulduma village under Kansara panchayat in Reamal police limits. Susmita, an issueless woman, expressed her strong desire to adopt the baby and started caring for him. However, Tuesday morning, a local informed the Childline officials on 1098 following which a

team from Child Protection Unit under the direction of Deogarh district child protection officer (DCPO) Romeo Mohapatra, visited Mahulduma and took custody of the child.

The rescue team enquired about the incident and shifted the baby to Debagarh District Headquarters Hospital (DHH) infant, weighing 1.7kg, is being treated at special newborn care unit (SNCU) of the DHH where his condition is stable.

The DCPO said the baby will be handed over to Child Welfare Committee (CWC) as soon as his health condition improves. "If someone comes forward with valid documents to claim the child, custody will be transferred accordingly. Otherwise, the process for legal adoption of the child will begin, as per departmental protocols.

Meanwhile, unable to bear the pain of being separated from the infant, Susmita reportedly fainted at the hospital multiple times. She continued to express her wish to adopt the baby officially.

Super Sunday Polls

t is not without reason that Sunday, 18 May, was regarded as an electoral "Super Sunday" when millions of voters across three European countries - Romania, Poland and Portugal decided the fortunes of candidates belonging to liberal, pro-European Union on the one hand and Far-Right, pro-Donald Trump parties on the other, vying with one another for their respective country's top posts.

There were widespread fears that the Far-Right would gain, particularly in Romania and Poland. But, after the ballots were counted it became clear that the Centrists held their ground in the two EU and NATO member nations bordering the war-ravaged Ukraine. This has come as a boost to the West and the EU must have heaved a deep sigh of relief that europesceptic parties have been kept at bay, at least for now. Portugal's Centre-Right governing party also secured a parliamentary win, but it had to concede record gains to the Far-Right.

However, the signs are ominous for liberal forces since despite the Centrist parties' eventual victories, Far-Right populist forces continue to grow in all the three countries. This is the latest in a string of Far-Right surges in Europe. Last summer, EU elections saw a clear shift to the Right in the European Parliament, shaking up governments across the 27-member bloc. The mainstream political parties had to

Romania's presidential election concluded with a clear victory for Centrist candidate Nicusor Dan, who secured 54 per cent of the vote against nationalist rival George Simion's 46 per cent. The closely watched contest recorded the highest voter turnout in 25 years as it has serious geopolitical implications for the EU. The election results show a dramatic comeback for Dan, the 55-year-old mayor of Bucharest, who trailed in the early stages but surged ahead in the final days of the ballot. Dan, a former mathematician, pledged to fight against corruption and rally behind the EU and NATO.

On the other hand, Simion, a Trump admirer, ran a campaign rooted in euroscepticism and nationalist rhetoric, pledging to stop military aid to Ukraine and overturn the ruling establishment in a style similar to Trump. His early lead raised fears among liberal segments of the population, but as results came in, it became clear that voters had opted for Dan's vision of a Centrist Romania. The elections were held after a previous vote in December had been annulled due to alleged Russian interference. Most Romanians feared that a win for the Far-Right Simion would mean Russian control of their country, while a victory for Dan would turn the country towards the EU and NATO They did not want their country to suffer the plight of Ukraine invaded by Russia. The high turnout reflected the people's mood rejecting the rising Right-wing populism and reinforcing Romania's Western orientation in the midst of regional instability. No wonder among the first to congratulate Dan were Ukraine's President Volodomyr Zelenskyy and European Commission President Ursula von der Leyen.

In Poland, Rafal Trzaskowski, a deputy leader of Prime Minister Donald Tusk's centrist Civic Platform (PO) party, won 31.1 per cent of the vote against the conservative Law and Justice (PiS) party's Karol Nawrocki's vote share of 29.1 per cent. It was a virtual referendum on Tusk's government. But, the fight is still on as the elections are poised for a second round. Social issues figured prominently during the campaign trail, with Nawrocki portraying himself as a guardian of conservative values, while Trzaskowski drew support from voters for his pledges to back abortion and LGBTQ rights. A Trzaskowski victory in the second round could enable Tusk's government to implement an agenda that includes rolling back judicial changes introduced by PiS that critics say have undermined the independence of the courts.

In Portugal, the parliamentary election saw the ruling Centre-Right Democratic Alliance (AD), led by Prime Minister Luis Montenegro, take 89 seats in the 230-seat parliament, well short of 116 needed for a majority. The party garnered 32.7 per cent of the vote. The Socialist Party (PS) and the Far-Right Chega finished in second place, both securing 58 seats. The Socialists suffered significant losses compared with the previous elections. With the results of several seats yet to be called, Chega might emerge as the main Opposition party. Chega, which ran on an anti-immigration platform, won a record 22.6 per cent of the vote, an impressive rise from the 1.3 per cent it had got in its debut election in 2019.

Even though the Far-Right parties in the three countries have failed to cause any major setback to the mainstream parties, the latter need to convince the electorate without any delay that their brand of politics is capable of tackling the ongoing cost of living crisis and the issue of migration. Otherwise, it is only a matter of time that the Far-Right could occupy the centre-stage of European politics.

srael's government decided last week to expand its military offensive against Hamas – an effort that, it notes, may include "seizing" Gaza. It is a brutal plan, devised in full awareness of its certain results, including the loss of the Israeli hostages who remain in Hamas's tunnels, the deepening of the humanitarian catastrophe faced by two million defenseless Palestinian civilians, and the erasure rather than resolution - of the Israeli-Palestinian conflict. But there is one thing Prime Minister Binyamin Netanyahu did not anticipate: the fracturing of his relationship with US President Donald Trump.

With his choice to drag an exhausted Israeli people and military into the indefinite occupation of Gaza, Netanyahu is sacrificing vital Israeli strategic interests, including the Israeli-Saudi normalization that seemed highly likely just a few years ago, as part of a grand US strategy for the Middle East. That is just fine with Netanyahu, who ultimately cares about only one thing: ensuring his government's survival.

Netanyahu long viewed Trump as the US president of his dreams, who would eliminate any daylight remaining between Israel and the United States, thereby strengthening Netanyahu's hold on power. But for all his unpredictability, Trump has remained steadfast about ending the era of US military entanglements in the Middle East. And nobody - not even a close ally – can make Trump do something he does not want to do.

Trump will do nothing to stop Israel from pursuing its forever war in Gaza, as long as it does not compromise American interests. (As a true friend of Israel, former President Joe Biden might have tried to save the country from itself.) But nor will Trump allow the US to be dragged into the effort.

Trump has also split with Netanyahu on Iran. Netanyahu persuaded Trump to withdraw in 2018 from the Joint Comprehensive Plan of Action, the nuclear deal that Iran, the US, and other world powers had concluded three

years earlier. But as soon as Trump abandoned the JCPOA, Iran's race to the bomb was back on, and upon returning to the White House, he was faced with a US adversary that is rapidly approaching nuclear-power status. Netanyahu awaited the green light, which he believed was imminent. from the US to attack Iran's nuclear installations. Instead, Trump initiated negotiations with the Islamic Republic.

For Trump, striking a quick deal he can tout as a great victory always matters more than the agreement's substance. But he is surely feeling pressure to secure better terms than his political foil, former President Barack Obama, did in 2015. To that end, Trump is happy to wield the Israeli military threat as leverage in talks - the prospect of a US military offensive against Iran is less credible - but he will not tie his political fate to the worldview of Netanyahu and his theocratic-fascist allies.

And then there is Trump's handling of the Houthis, Iran's proxy in Yemen. Despite Israel's success in eroding the ring of Iranian proxies that surround it, the Houthis have

proved indomitable, repeatedly launching ballistic missiles at Israel. Early this month, one such Iran-supplied missile struck Israel's main airport, spurring most international airlines to suspend flights.

The US was firmly on Israel's side in confronting the Houthis, even carrying out its own airstrikes on Houthilinked sites in Yemen in response to the group's attempts to disrupt traffic in the Red Sea. Then the Trump administration abruptly announced a ceasefire agreement: the Houthis would stop attacking ships in the Red Sea, in exchange for an end to US strikes. Israeli officials were "completely shocked."

Last week, Trump undertook a grand tour of the Middle East, but Israel was not on his itinerary. This trip was focused on trade and investment - and, as usual, moneymaking opportunities for himself, his family, and his friends. Deals were signed guaranteeing what the White House says is "over two trillion" dollars of Saudi, Qatari, and Emirati investment in the US and purchases of advanced American

agree to help Saudi Arabia develop the commercial nuclear-energy program that it has long coveted (and that could serve as the first step toward developing nuclear weapons).

Until now, Israel's enduring understanding with previous American administrations was "no surprises" on matters of national security, and an ironclad commitment by the US to ensure Israel's military superiority in the region. Trump's moves in Iran and his arms deals with Gulf states mark a dramatic departure from this status quo. Israel was not consulted, and it is inconceivable that Israel's military edge could be maintained if such massive arms deals materialize. Israel had long been the central pillar of US foreign policy in the Middle East. Now it is Saudi Crown Prince Mohammed bin Salman. All the "credit" for this historic shift goes to Netanyahu.

Under the Biden administration, such deals were supposed to be linked to a grand strategic plan that included the normalization of Saudi-Israeli relations and the establishment of a NATO-like alliance in the Middle East, centered on an Israel committed to some form of Palestinian statehood. Such a deal could win broad support in the US Congress and open the way for a defense treaty with Saudi Arabia.

Such a grand deal would, however, almost certainly cost Netanyahu the support of the most extreme elements of his coalition. Since that is not an option for Netanyahu, Trump is moving on without him. There is too much money in the Gulf for Trump to concern himself with Israel's domestic politics.

Neither Trump nor the Gulf monarchs and emirs want wars, not even with Iran. Leaders in the Middle East, including the former al-Qaeda commander and Syria's president, Ahmed al-Sharaa, whom Trump met on this trip, want economic development, not conflict. They, too, have no patience for an Israeli prime minister who sees only threats where they see opportunities.

Mumbai, May 20: The Maharashtra government Tuesday announced a new housing policy, which includes a comprehensive programme ranging from slum rehabilitation to redevelopment, with an investment of ₹70,000 crore besides focusing on low-income groups and affordability.

Talking to reporters after a cabinet meeting where the policy was approved, Chief Minister Devendra Fadnavis said the policy focuses on housing for the common man with the motto "My Home -- My Right". He stressed the policy prior-

itises senior citizens, working women, students, industrial workers, journalists, persons with disabilities, and ex-ser-The policy comprises a com-

slum rehabilitation to redevelopment, with an investment of ₹70.000 crore. The chief minister said af-

Fadnavis emphasised that the new policy takes into account the housing needs of urban and rural areas.

Deputy Chief Minister Eknath Shinde, who holds the housing portfolio, described the new policy as "revolutionary" and added it aims to provide affordable homes and give a major boost to the state's economy.

Speaking to reporters, Shinde said the path to affordable housing for common citizens and economically weaker sections in Maharashtra has been cleared through the policy.

The policy will transform ur-

ban development and the housing sector in the state. Flow of large-scale investments in the key sector will significantly boost Maharashtra's goal of becoming a \$1 trillion economy by 2032, the housing minister

The State Housing Policy 2025 with the slogan "My Home - My Right" will prove decisive in providing affordable, sustainable, inclusive residences for all sections of society, especially the economically weaker and low-income groups, he said.

The state government has set a target of building 35 lakh homes by 2030 for these groups, with specific provisions designed to meet the unique needs of every segment.

A centralized state housing information portal will be developed using artificial intelligence. It will coordinate data on housing demand and supply, geo-tagging of housing units, fund distribution, district-wise land banks, and integration with platforms like MahaRERA, MahaBhulekh, and PM Gati Shakti, Shinde

Recognizing the trend of rapid urbanization, all metropolitan region development authorities, not just corporations with populations over 10 lakh, have been instructed to implement inclusive housing

A dedicated self-redevelopment cell has been proposed to guide housing societies through planning, funding, developer selection, and execution. An initial fund of ₹2,000 crore will be allocated.

The policy emphasizes on transparency, real-time monitoring, and accountability through IT-based systems. ensuring tracking of beneficiaries, project progress, and fund management.

It aims to promote cluster redevelopment as a strategic approach. For slum rehabilitation schemes that haven't progressed, new developers will be selected under the policy through a transparent bidding process.

Shinde emphasised that delays will be avoided, and malpractices will be completely

Mumbai-Ahmedabad bullet train project completed

Mumbai, May 20: With the launch of a 40 metre-long girder near Surat in Gujarat, 300 km of viaducts for the Mumbai-Ahmedabad bullet train project has been completed, the National High Speed Rail Corporation (NHSRCL) said

According to the NHSRCL, of the 300 km of the superstructure, 257.4 km is constructed through the Full Span Launching Method (FSLM), including 14 river bridges, 37.8 km through Span by Span (SBS), 0.9 km of steel bridges (10 spans ranging from 60 to 130 m in 7 bridges), 1.2 km PSC bridges (20 spans ranging from 40 to 80 metres in 5 bridges) and 2.7 km

in station building. Besides the viaducts, 383 km of pier work, 401 km of foundation and 326 km of girder casting has been completed for the 508-km bullet train project, the agency said

FSLM has significantly accelerated construction, as full-span girder erection is up to 10 times faster than conventional segmental methods, NHSRCL said.

Each full-span box girder weighs 970 metric tonnes, and segmental girders are used selectively in locations where full-span installation is not

To facilitate construction, 27 dedicated casting yards were established along the corridor. Steel bridges are fabricated in seven workshops spread across



the country, three in Gujarat, one each in Uttar Pradesh, Tamil Nadu, Maharashtra, and West Bengal, the NHSRCL said.

The agency said more than 3 lakh noise barriers have been installed along the viaducts to mitigate noise during operations. Track works over viaducts have also started, and around 157 track km of RC (reinforced concrete) track bed construction has been achieved so far in Gujarat.

It further said that thematic Bullet Train stations are also rapidly taking shape. These stations will be integrated with rail and road-based transport systems to provide seamless travel to passengers and will be equipped with state-of-theart passenger amenities.

'The project has supported the use of indigenously

designed and manufactured equipment such as straddle carriers, launching gantries, bridge gantries, and girder transporters for construction," NHSRCL stated, adding that this marks a first for Indian infrastructure, showcasing India's growing capabilities in high-speed rail technology with the support from the Japanese government.

The total cost of the Mumbai-Ahmedabad High-Speed Rail Corridor project is pegged at ₹1.08 lakh crore, and as per the shareholding pattern, the Government of India is to pay ₹10.000 crore to the NHSRCL while the two states involved Gujarat and Maharashtra, are to pay ₹5,000 crore each.

The rest is to be paid by Japan through a loan at 0.1 per cent interest

followed the April 22 Pahalgam terror attack, the SP said. Sawan said while Jyoti did not have direct access to any information related to the military operations, she was directly in touch with Pakistani intelligence operatives (PIOs).

"This is modern warfare that is not just fought on the borders. We came across a new modus operandi wherein PIOs were trying to recruit some social media influencers," the SP said.

Sawan also said Jyoti went to Kashmir before the Pahalgam attack and visited Pakistan before that, and police are trying to establish the "links" between

Jyoti, whose YouTube channel at present has 3.87 lakh subscribers, came in contact with Ehsan-ur-Rahim alias Danish at the Pakistan High Commission in 2023, when she went there seeking a visa to visit the neighbouring country.

India expelled Ehsan for allegedly indulging in espionage May 13.

Police investigation has revealed that Guzala (31). whom Punjab Police arrested on charges of spying for Pakistan from Malerkotla district, came in contact with Ehsan in February

She met him at the Pakistan High Commission while seeking a visa to visit the neigh bouring country, police said.

Police arrested Guzala and Yameen Mohamad, both residents of Malerkotla, May 11 for their alleged role in leaking sensitive information and photographs of Army cantonment areas and air bases to Pakistan's intelligence agency.

The accused reportedly received payments through the online mode in exchange for sharing classified information, police said.

New Delhi, May 20: The Sufresh law graduates from appearing in entry level judicial services examination, fixing a minimum three-year law prac-

The top court also increased from 10 to 25 per cent the quota reserved for Limited Departmental Competitive Examination (LDCE) for promotion to higher judicial service or the cadre of district judge. A bench comprising Chief

Justice BR Gavai and Justices Augustine George Masih and K Vinod Chandran analysed the procedures related to filling of vacancies in higher judicial services and said raising the LDCE quota would have "no adverse impact on the administration of justice'

While 25 per cent posts in higher judiciary are filled by direct recruitment from the bar, 50 per cent of the total posts are filled by promotion on the basis of principle of merit-cum-se-

In the LDCE, the merit is the only criteria and judicial officers can become ADJs by clearing this irrespective of their experience or the seniority.

SC to hear Ashoka prof's arrest plea May 21

New Delhi, May 20: The Supreme Court would likely hear Wednesday a plea of Ashoka University's faculty Ali Khan Mahmudabad against his arrest for his social media posts over Operation Sindoor.

The top court's causelist shows a bench comprising Justices Surya Kant and N Kotiswar will be hearing the matter. Senior advocate Kapil Sibal, appearing for the associate professor, mentioned the case for urgent hearing before

a bench headed by Chief Justice BR Gavai May 19.

Mahmudabad was arrested May 18 after two FIRs were lodged under stringent charges, including endangering sovereignty and integrity, for his social media posts over Operation Sindoor.

He was produced before a local court in Sonipat May 18 and was remanded in police custody for two days in a case registered on a complaint from the Haryana State Commission for Women (HSCW) filed a day before.

The Sonipat court remanded

him to judicial custody till May 27 after the completion of his police custody Tuesday.

The HSCW recently sent a notice to him questioning the remarks, though Mahmudabad maintained they were "misunderstood" and underscored his fundamental right to freedom of speech. Haryana Police said the two FIRs were lodged at the Rai Police Station in Sonipat -- one based on a complaint from the chairperson of Haryana State Commission for Women, Renu Bhatia, and the other on the complaint of a village sarpanch.

Srinagar, May 20: PDP chief Mehbooba Mufti Tuesday appealed to the government to declare areas affected by shelling from across the border in Jammu and Kashmir as "war-impacted zones" and give the status of martyr to those who lost lives in the skirmishes.

ernment of India give the status of martyrs to all the people who lost their lives in this. This will give them respect as they were innocent, and their families will also get some benefits. Jobs should also be provided to the next of kin of the deceased,' she added.

Mehbooba noted that the shelling has left a trail of destruction in several areas like Poonch, Uri, Tangdhar and some parts of Kupwara.

It has devastated families. destroyed houses, and other properties. Some people still haven't got even tents to live in, and are living under open sky, she said. The PDP president claimed

banks were refusing to provide insurance to those whose shops have been damaged. "The government should

intervene in this. Also, those

who have taken housing loans and their houses have been de stroyed, their loans should be waived off," she said.

There are some areas like the area near the Brigade headquarter in Tangdhar where some nearby shops have suf fered damage, but no one form the government has reached upto them, she added.

On the demands of building individual bunkers for people living in the affected areas, she said it does not feel right to de mand such things in the 21st century in the first place when people should be demanding better schools and universities.

The Centre should think if it wants to keep the people think ing about war all the time, she said. War is not a solution and those advocating war, should come and live with their fami lies in the border areas, she said



Strong grounds needed for interim relief: SC

Over 100 petitioners have moved the top court against the amendments, contending that they infringed upon the rights of Muslims

New Delhi, May 20: The Supreme Court Tuesday began hearing a batch of petitions challenging the constitutional validity of the Waqf (Amendment) Act, 2025, stating that any request for interim relief must be supported by a "strong and glaring" case due to the presumption of constitutionality attached to laws passed by Parliament.

A bench comprising Chief Justice DY Chandrachud and Justice Augustine George Masih made this observation as senior advocate Kapil Sibal led arguments against the amended law, calling it a "complete departure from historical legal and constitutional principles" and an attempt to "capture waqf properties through a non-judicial process"

The bench focused initially on three key issues: the power to denotify properties declared as waqf by courts, by usage, or by deed; the composition of waqf boards; and the provision that allows authorities to treat wagf properties as government land during inquiries by collectors.

Solicitor General Tushar Mehta, representing the Centre,

sought to limit the scope of the hearing to these three issues, but this was opposed by Sibal and fellow senior advocate Abhishek Manu Singhvi. They argued that the entire statute represented a systematic effort to expropriate waqf properties, and piecemeal consideration would be inappropriate.

Sibal argued the 2025 law enables the government to bypass judicial oversight and allows executive officers to strip properties of their wagf status, in violation of Islamic legal principles that state "once a waqf, always a waqf." He said the law's new provision under Section 3C empowers an officer to initiate an inquiry into whether a property is government land, during which the property is no longer considered waqf-allowing authorities to assume control without court intervention.

He also objected to changes in the composition of Central and State Waqf Boards, claiming they now allow a majority of non-Muslim members. Referring to Section 23, Sibal said even the CEO of a want board can be a non-Muslim. "This is an attempt to dilute community control," he said, adding

that management of religious endowments must remain within the faith

Highlighting Section 3D, Sibal pointed out that properties declared as protected monuments under preservation laws would lose their waqf status. He contended this violates Articles 14, 25, and 26 of the Constitution, as it restricts religious practice and undermines equality.

Sibal also raised concern about the practicality of proving waqf status for historical properties where written deeds may not exist. He said wagf by user was recognized even without documentation in older laws, but now mutawallis (custodians) could face jail if they fail to provide records.

Senior advocate Rajeev Dhavan called the amendments an "attack on secularism and cultural autonomy," arguing that the law does not follow the doctrine of proportionality. Singhvi criticized the provision that only Muslims practicing for five years can create waqfs, calling it arbitrary and unique

Udhagamandalam (Tamil Nadu), May 20: Veteran scientist and former Chairman of the Atomic Energy Commission, MR Srinivasan, who played a key role in the country's indigenous nuclear energy programme, died here Tuesday, his family said.

He was 95 and is survived by wife and daughter.

"We are deeply saddened to announce the passing of Dr M R Srinivasan, former Chairman of the Atomic Energy Commission and Secretary, Department of Atomic Energy (DAE)," the family said in a statement.

It said Srinivasan joined the DAE in September 1955 and began his distinguished career working alongside Dr Homi Bhabha on the construction of the country's first nuclear re-



search reactor, Apsara, which achieved criticality a year lat-

In 1959, he was appointed as the Principal Project Engineer for the construction of India's first atomic power station. "His leadership continued to shape the nation's nuclear program when, in 1967, he took charge as Chief Project Engineer of the Madras Atomic Power Station (MAPS)," the statement said.

He held several key positions of national importance, such as the Director of the Power Projects Engineering Division, DAE, and Chairman of the Nuclear Power Board. "In these roles, he oversaw the planning, execution, and operation of all nuclear power projects across

'In 1987, he was appointed Chairman of the Atomic Energy Commission and Secretary of the Department of Atomic Energy. That same year, he became the Founder-Chairman of the Nuclear Power Corporation of India Limited (NPCIL). Under his leadership, 18 nuclear power units were developedseven of which were operational, seven under construction, and four in the planning stage,' the statement added.

In recognition of his outstanding contributions to India's nuclear energy program, Dr Srinivasan was awarded the Padma Vibhushan, one of the nation's highest civilian honors.

Mir Jafar," Malviya, the BJP's IT department head, wrote on X, posting another meme showing the Congress leader asking Indian Army from behind a wall. "How many aircraft we lost" while standing on the back of Pakistan Defence Minister Khawaja Asif who prods him to "ask loudly". "It is not surprising that Rahul Gandhi is speaking the language of Pakistan and its benefactors. He hasn't congratulated the Prime Minister on the flawless Operation Sindoor, which unmistakably showcases India's dominance.'

"Instead, he repeatedly asks 'how many jets we lost' - a question that has already been addressed in the DGMO briefings. Curiously, he hasn't once inquired about how many Pakistani jets were shot down during the conflict, or how many were destroyed while parked in their hangars when Indian forces pounded Pakistani air bases, Malviya said in his post.

The Congress hit back with party leader Pawan Khera post ing a meme apparently showing Jaishankar making a call to Pakistan with Prime Minister Modi by his side. "Jaishankar is the new age Jaichand?" 

Indian dies after **summiting Lhotse**

Kathmandu: An Indian climber died after summiting Mt Lhotse, the world's fourth highest mountain in the Himalayas, according to a media report. Rakesh Bishnoi from Rajasthan breathed his last at Yellow Band near Camp IV after returning from the summit point on Lhotse Monday, The Himalayan Times newspaper reported. Bishnoi climbed Mt Lhotse after abandoning his Mt Everest bid Sunday, the paper quoted Nepalese climbing guides as saying. They said that he died near Yellow Band on descent. Efforts were underway to recover his body, the paper said. At 8,516 metres above sea level, Lhotse is the fourth-highest mountain on Earth, after Mount Everest, K2, and Kangchenjunga. Mount Lhotse is located in the Himalayas, straddling the border between Nepal and the Tibet Autonomous Region.

Drone strike kills 4 children in Pak

Peshawar: A suspected drone strike killed four children and wounded five others in Pakistan's restive northwest. prompting thousands of residents to stage a protest by placing the children's bodies on a main road to demand justice, local elders said Tuesday. It was unclear who was behind Monday's attack in Mir Ali, which has been a stronghold of Pakistani Talihan, and there was no comment from the army about the incident. The civilian casualties came amid ongoing military operations against the Pakistani Taliban, which have a strong presence in Mir Ali, a city in the Khyber Pakhtunkhwa province. The Pakistani Taliban, known as Tehreeke-Taliban Pakistan, are a separate insurgent group from the Afghan Taliban, and they often target troops in

UK sanctions Israel, suspends trade talks Kyiv's allies hit Russia

London, May 20: The British government says it is suspending free trade negotiations with Israel and has levelled new sanctions targeting West Bank settlements as it criticises Israel's military actions in Gaza.

Tuesday's actions came a day after the UK, France and Canada condemned Israel's handling of the war in Gaza and its actions in the occupied West Bank.

Foreign Secretary David Lammy said the UK's existing trade agreement is in effect but the government can't continue discussions with an Israeli government pursuing what he called egregious policies in the West Bank and Gaza. Lammy said the persistent

demanded action.

'The Israeli government has a responsibility to intervene and halt these aggressive actions," Lammy said. "Their consistent failure to act is putting Palestinian communities and the two-state solution in peril."

The announcement came after British Prime Minister Keir Starmer ramped up his criticism of Israel on Tuesday, saying the level of suffering by children in Gaza was "utterly intolerable" and repeated his

call for a ceasefire.

"I want to put on record today that we're horrified by the escalation from Israel," Starmer told the UK's Parliament.

His brief remarks followed a scathing joint condemnation he issued Monday with French President Emmanuel Macron and Canadian Prime Minister Mark Carney that marked one of the most significant criticisms by close allies of Israel's handling of the war in Gaza and its actions in the West Bank.

to take "concrete actions" if the government of Israeli Prime Minister Benjamin Netanyahu did not cease its renewed military offensive and significantly lift restrictions on humanitarian aid. Netanyahu said the statement was "a huge prize' for Hamas Starmer repeated the trio's

Kyiv, May 20: Kyiv's European allies slapped new sanctions on Tuesday Moscow, a day after a phone call between US President Donald Trump and Russian President Vladimir Putin failed to produce a breakthrough on ending the 3-year-old war in Ukraine.

"We have made clear again and again that we simply expect one thing from Russia now: namely, a ceasefire, unconditional and immediate," German Foreign Minister Johann Wadephul said in announcing the sanctions.

'We welcome the fact that Ukraine is still prepared to do this. We note with disappointment that Russia has not yet taken this decisive step, and we will have to react to this."

Diplomatic efforts have seen little progress in halting the fighting, including Monday's phone call between Trump and Putin, and Friday's direct talks between Russian and Ukrainian delegations in Istanbul. In the phone call, Putin promised Trump that Russia is 'ready to work with" Ukraine on a "memorandum" outlining the framework for "a possible



future peace treaty'

"It appears that Putin has devised a way to offer Trump an interim, tangible outcome from Washington's peace efforts without making any real concessions," said Tatiana Stanovaya, a senior fellow at the Carnegie Russia Eurasia Centre, in a post on X.

Ukrainian President Volodymyr Zelenskyy said on his Telegram channel that "it is obvious that Russia is trying to buy time to continue the war and occupation. We are working with partners to put pressure on the Russians to behave differently.'

The new European Union sanc tions targeted almost 200 ships from Russia's "shadow fleet" illicitly transporting oil to skirt Western restrictions. It also imposed asset freezes and travel bans on several officials as well as on a number of Russian companies.

Laura Loomer swipes at Trump from heart of MAGA

Washington, May 20: Laura Loomer once had to chain herself to a building to get attention. Not any longer.

A far-right activist who has $\,$ jockeyed her way up from online agitator to self-appointed presidential adviser, Loomer has long been one of President Donald Trump's most fervent supporters. She has recently found herself at odds with the White House, however, clashing with the administration over both policy and personnel choices that she views as counter to the MAGA movement.

In the past few weeks, Loomer has criticized the new pope, mounted a campaign against Trump's pick for surgeon general, Casey Means, blasted his attorney general, Pam Bondi, and noisily objected to Trump's diplomatic efforts during his

Middle East trip. If Loomer were just another online rabble-rouser, the friction likely would not matter. But with 1.6 million followers on X and her own weekly programme that draws thousands of viewers,

Loomer can claim she speaks for the MAGA faithful and, in turn, influence how they view the performance of the president and his administration. Loomer has said it's her job to keep Trump on track. She has flitted in and out of the president's inner circle and has claimed to be responsible for the firings of National Security Adviser Mike Waltz and other aides.

"What makes her more dangerous than other people is that she clearly seems to have Trump's ear," said Peter Montgomery, who tracks conservative movements for the liberal advocacy group People For the American Way. Loomer did not respond to requests for comment for this story, but made clear how she views her role during her online video show earlier this month.

"I'm not working for President Trump. I'm not getting paid by President Trump I'm not in the Trump White House," Loomer said during her show. "I wasn't even on the Trump campaign. And yet, I feel like every single day, it's a full-time job just to make sure the president is protected and that he's receiving the information he needs to receive.

Loomer met last month with Trump at the White House, after which Trump immediately fired several national security officials Loomer claimed were disloyal. Trump later denied that Loomer was the reason.

Musk to cut back on political spending

Washington, May 20: Elon Musk, the richest person in the world and a key financial supporter of President Donald Trump, said Tuesday that he'll be spending less on political campaigns.

"I'm going to do a lot less in the future," Musk said. Asked why, he responded that "I think I've done enough.'

Musk spent at least USD 250 million supporting Trump in the presidential campaign. and even held some of his own campaign rallies. He also got in volved in a Wisconsin Supreme Court race this year, although his preferred candidate lost.

Wellington, May 20: The haka, a chanting dance of challenge, is sacred to New Zealand's Maori people but it's become a beloved cultural institution among New Zealanders of all races. Spine-tingling performances at sports events, funerals and graduations often go viral online, a non-partisan point of pride for the country abroad.

But one haka performed in protest in New Zealand's Parliament by three legislators last November has provoked fierce division among lawmakers about whether it was an act of peaceful dissent, or disruptive and even intimidating to their opponents.

A vote to approve unprecedented, lengthy bans from Parliament for the Maori party

lawmakers who enacted the protest was unexpectedly suspended Tuesday. Debate will resume in June, when it threatens to gridlock the legislative agenda until politicians from all parties reach consensus on what the punishment should be. Hundreds of protesters

against the sanctions waited outside Parliament's front doors in New Zealand's capital. Wellington, Tuesday to greet the Maori party lawmakers with a haka when they emerged.

The haka was once viewed as a war dance, but that understanding has changed in New Zealand as it has been embraced in a range of celebratory, sombre and ceremonial settings. It's an expression of Maori identity and while sacred, it can be performed by people of any race who are educated by Maori in



the words, movements and cultural protocols.

Emotional haka have generated news headlines in the past year when performed by soldiers farewelling a New Zealander who died fighting in Ukraine, and in Paris by athletes from New Zealand's Olympic team. While the best-known haka is "ka mate," the chant often performed by the All Blacks rugby team before games, there are many variants.

Last November's protest wasn't the first time a haka has rung out in Parliament. Performances regularly follow the passage of laws important to Maori.

But some lawmakers decried this one for two reasons: because the legislators from Te Pati Maori, the Maori Party, left their seats and strode across the floor toward government politicians while performing it, and because it disrupted the vote on a proposed law.

When asked how the Maori party would vote on a bill they said would dismantle Indigenous rights, Hana-Rawhiti Maipi-Clarke – New Zealand's youngest parliamentarian, at 22 – tore up a copy of the law and began the haka, joined by two of her colleagues.

The law, an attempt to rewrite New Zealand's founding treaty between Maori tribal leaders and the British crown, was widely unpopular and has since been defeated. But for six months, a committee of the lawmakers' peers have fought furiously about how - or whether - their protest of it should be punished.

Usually there's agreement among parliamentarians about penalties for errant behaviour. But this episode polarized the committee considering the lawmakers' actions.

Its report recommended Maipi-Clarke, who the committee said showed contrition in a letter, be suspended for seven days and her colleagues for 21 days. That's the harshest penalty ever assigned to New Zealand lawmakers; the previous record was three days

Parliament Speaker Gerry Brownlee this month sched uled a rare, unlimited debate in Parliament until all parties could find consensus on the penalty, citing the severity of the proposed bans. But min utes after the debate began Tuesday, it was adjourned at the government's behest after they allowed the Maori party lawmakers to stay until after Thursday's budget was delivered.

Key infra sectors' growth slows

New Delhi, May 20: The output of eight key infrastructure sectors slowed down to an eight-month low of 0.5 per cent in April due to contraction in the production of crude oil, refinery products and fertiliser.

According to official data released Tuesday. Sectors like coal, crude oil, refinery products, natural gas, steel, cement, electricity and fertiliser expanded by 6.9 per cent in April 2024.

In March this year, output of these sectors grew by 4.6 per cent. During the month under review, production of crude oil, refinery products and fertiliser recorded a negative growth.

The previous low growth rate was recorded in August 2024, when these sectors expanded by (-) 1.5 per cent. The growth rate in the production of coal, natural gas, steel, and electric ity moderated to 3.5 per cent, 0.4 per cent, 3 per cent, and one per cent, respectively, in April 2025

However, cement production rose by 6.7 per cent in April this year as against 0.2 per cent in the same month last year. Commenting on the data, Aditi Nayar, Chief Economist, ICRA Ltd, said the performance of the core sector "deteriorated significantly" in April.

"Based on the tepid rise in the core sector and the performance of the other available high frequency indicators, ICRA expects the IIP (index of industrial production) growth to moderate sharply to about 1 per cent in April," she said.

The eight core sectors contribute 40.27 per cent to the IIP, which measures overall industrial growth.

HONDA TO SKIP EV ROUTE

Tokyo, May 20: Honda said Tuesday electric vehicle sales were slowing in US, prompting the Japanese automaker to scrap its previous goal for EVs to be 30 per cent of its global vehicle sales by 2030.

Instead of the initial plan to invest 10 trillion Yen (USD 69 billion) in an electrification strategy through the fiscal year ending in 2031, Honda is reducing that investment by 3 trillion Yen (USD 21 billion) to 7 trillion Yen (USD 48 billion).

Honda Motor Co Chief Executive Toshihiro Mibe called the decisions a switch in the planned course, while stressing the long-term shift toward electrification remained unchanged, just pushed back in

Mibe didn't mention US President Donald Trump. But Trump's policies on tariffs, as well as his lack of enthusiasm for electric vehicles, have Japanese automakers scrambling to adapt.

"The environment surrounding the automobile industry is changing day by day. Uncertainty in the business environment is increasing, due particularly to the slowdown in the expansion of the EV market due to several factors, including changes in environmental regulations," Honda said in a statement.

cated for the adoption of fair, transparent, and consistent guidelines for assessing carbon intensity, energy classification, and mutual recognition of taxonomies and certifications.

Underscoring energy security as vital for socio-economic development, they highlighted the importance of market stability resilient infrastructure, diversified energy sources, and critical minerals for clean technologies.

In his address, Lal underscored the vital role of fossil fuels in the global energy mix especially for developing countries -- and urged greater cooperation to promote their cleaner and efficient use through technologies such as coal gasification, carbon capture and storage, and green chemical innovations.

BRICS energy ministers reaffirmed their commitment to strengthening energy security and advancing UN Sustainable Development Goal 7 (SDG 7), focusing on universal electricity access, clean cooking, and tackling energy poverty.

US tariff fickleness poses credit risk for debt issuers

New Delhi, May 20: Moody's Ratings Tuesday said the uncertainties around US tariffs have negative credit consequences for debt issuers across emerging markets, including companies, governments and banks.

"The on-again, off-again US tariffs and difficulty predicting US trade policy have negative credit consequences for debt issuers across emerging markets," Moody's said.

Besides, geopolitics is an additional stress for emerging markets, including the flare-up of tensions between India and Pakistan. Exporters are most directly

exposed to US tariff changes,

but most debt issuers face indirect effects, Moody's said, adding tariffs will reach a much bigger and varied group of debt issuers indirectly through slowing economic growth and, for many, commodity price declines, currency depreciation and investor risk aversion.

'The raft of tariffs the US administration has announced, altered and paused this year has negative credit consequences for debt issuers across emerging markets, including companies, governments and banks, Moody's said.

Companies that rely on exports to US are most exposed. But the wider effects of tariffs and trade uncertainty on con-

sumer, business and financial activity will affect most emerging market entities, even as tariff deals emerge, it added.

In early April, US adminis-

tration announced and then paused for 90 days the implementation of sweeping, country-specific tariffs on trading partners. It maintained a base

EUROPA LEAGUE FINAL: MANCHESTER UNITED VS TOTTENHAM

ALL OR NOTHING

Bilbao, May 20: It's all or nothing when Manchester United and Tottenham meet in the Europa League final Wednesday. For the winner of the all-En-

glish showdown in Bilbao there is the mother of all get-out-ofiail-free cards with entry to the Champions League.

For the loser, the abyss of no European soccer next year, the indignity of so many unwanted records broken, and uncertainty hanging over the futures of those who have presided over such a spectacular fall.

That's what's on the line at Estadio de San Mamés when two English soccer giants get one last shot at salvaging the

Long gone are the days when United dominated the Premier League and challenged the summit of European soccer on a regular basis. But even after 12 years without winning the English title, this season has represented a new low.

United is 16th out of 20 in the standings after a club-record 18 defeats in a single campaign since the Premier League began in 1992. It is also certain to register its worst-ever points total in the era, as well as its

lowest finish. "We know this season has been nowhere near good enough for this club and for our standards," United defender Harry Maguire says.

Tottenham is one place below United having lost 21 times in the league — also a club record in the modern era.

Spurs — Champions League runner-up in 2019 — are aiming for a first trophy since the 2008 English League Cup.

Champions League lifeline

It is rare that such a major final has so much riding on it beyond the trophy itself.

Neither team has looked capable of challenging for a top five position in the Premier League, which would secure Champions League qualification. But in a season when both teams occupy the last safe spots before relegation, they have a mind-boggling lifeline to the Champions League via the Europa League.

The Champions League offers the prestige of playing beside teams like Real Madrid and Barcelona, draws prospective signings, and comes with huge financial rewards.

Real Madrid earned almost \$154 million from winning the competition for a record-extending 15th time last season. Total prize money has increased from \$2 billion last season to \$2.7 billion in this expanded season.

United, in particular, could do with some of that money at a time of job losses and cuts under new co-owner Jim Ratcliffe, while coach Ruben Amorim hopes to rebuild his squad in the offseason.

"We are supposed to be in the Champions League. Europa League here is not enough and you have that feeling here," Amorim says.

"The best way to help us get in the top in a few years is the Champions League — it's not (winning) the cup (Europa League).

Trophy drought

While a return to the Champions League is also enticing for Tottenham, the chance to end its trophy barren run may be even more appealing.

Not even top class managers like Mauricio Pochettino, Jose Mourinho or Antonio Conte ended Spurs' wait for major silverware. It could be destiny that Ange Postecoglou is the man to end the drought, having boldly predicted early in the season that he always wins a trophy in his second year.

That was true at previous clubs Brisbane Roar, Yokoha-

HIL to start January 5

Noida, May 20: The 2026 edition of the Hockey India League (HIL) will begin from January 5, the national federation's secretary general Bhola Nath Singh said here Tuesday.

The HIL, which was revived after a gap of seven years, was last held from December 28 to February 1 this year.

"The HIL window is fixed and the men's HIL will continue to be an eight-team competition but the women's HIL will be of six teams from four from next year. The venues are yet not decided but we are in consultation with all stakeholders and soon we will have an update," Singh said after a Memorandum of Understanding (MoU) was signed between HI and Amity University Online

Singh also refuted reports that some national and foreign players haven't got their dues from franchises for their services in the last HIL.

"We will follow the guidelines of HIL, if a franchise wants to keep the same setup, they are free to do that. There is also a guideline that a franchise can keep their top 12 players and release rest for auction, then they will go into auction list. All dues of players are cleared, it's a false news,"

As per the MoU singed on Tuesday, hockey players of the country will get academic scholarships from Amity University to pursue any professional or undergraduate course. "The hockey players who want to study and build a career beyond the game can now do that because it's an online course. They can do the course from anywhere, while during national camp, or from abroad. It's a facility that Amity University has provided them," Singh said. For international players 100 per cent scholarships, for state and reginal players, there is 50 per cent, and for upcoming players 30 per cent.

Carlsen forced into draw against 143,000 players

Berlin, May 20: Norwegian chess grandmaster Magnus Carlsen was forced into a draw Monday by more than 143,000 people worldwide playing against him in a single, record-setting game.

Billed as "Magnus Carlsen vs. The World," the online match began April 4 on Chess. com, the world's largest chess website, and was the first-ever online freestyle game to feature a world champion.

The mega-match ended after Team World checked Carlsen's king a third time, a stunning outcome after Chess.com had predicted Carlsen would win by a wide margin.

Team World voted on each move and each side had 24 hours to make their play. Carlsen played the white pieces.

The world won on move 32 after checking Carlsen's king three times in the corner of the board where it could not escape. The rule is called 'threefold repetition' meaning all of the pieces on the board are in the exact same position three times to prompt a draw.

Carlsen, 34, became the world's top-ranked player in 2010 aged 19 and has won five World Championships. He achieved the highest-ever chess rating of 2882 in 2014 and has remained the undisputed world number one for more than a decade.

"Overall, the world' has played very, very sound chess from the start. Maybe not going for most enterprising options, but kind of keeping it more in vein with normal chess which isn't always the best strategy, but it worked out well this time," Carlsen said in a statement Friday as Monday's

draw seemed imminent. Last year, Indian grandmaster Viswanathan Anand won his "vs. The World" match against nearly 70,000 players on Chess.com.

Adriyan opens account with silver

New Delhi, May 20: Adriyan Karmakar opened India's account in the International Shooting Sport Federation (ISSF) Junior World Cup in Suhl, Germany, with a silver on debut in the 50m rifle prone men junior event at the hallowed International Shooting Sport Centre ranges Tuesday.

The 20-year-old junior 3P national champion shot 626.7 after 60 shots to miss out on gold, won by Sweden's Jesper Johansson, by just 0.3. Griffin Lake (USA) won bronze with 624.6.

Adriyan, who has represented India juniors in the world championships before but never in a World Cup, shot confidently and was one of the earliest to finish. His effort was also a junior national record in the event. Among other Indians in the fray, 15-year-old Rohit Kanyan finished in 12th place with a score of 620.2, while Vedant Nitin Waghmare shot 614.4 to finish in 35th place.



India, which finished on top of two of the three ISSF junior events last year, has fielded the largest contingent of 57 shooters, who will be accompanied by 21 officials, including coaches and support staff.

Dhillon Olympian Raiza (skeet) and mixed team trap bronze medallist in the recently concluded Nicosia Shotgun World Cup, Sabeera Harris, will be among the most prominent names in the strong Indian side. Others include Naamya Kapoor, who was a junior world champion at 13, reigning

New Delhi, May 20: Sub Inspector (SI) Geeta Samota has become the first CISF personnel to conquer the world's tallest peak Mount Everest in the 56-year-long history of the force, a spokesperson said Tuesday.

She summited the 8,849m tall

mountain Monday. "Geeta stood on the 'roof of the world', a triumphant moment symbolising not just a personal victory, but the incredible resilience and strength fostered within the CISF and the Indian nation," the spokes-

person said in a statement. The 35-year-old subordinate officer joined the paramilitary force in 2011 and is currently posted at the Udaipur airport unit of the Central Industrial

Security Force (CISF) The mountaineer hails from

the Chak village in Rajasthan's Sikar district and had initially started as hockey player in her local college. Her upbringing was traditional in a house that had five daughters including her.

An injury led her to move away from hockey and upon joining the force she found CISF did not had a mountaineering team then and she saw an sporting and adventure opportunity here, the spokesperson said.

Samota went on to undertake specialised training in mountaineering and in 2019 she became the first woman from any Central Armed Police Force (CAPF) to scale Mount Satopanth (7.075m) in Uttarakhand and Mount Lobuche (6,119m) in Nepal, he said.

In early 2021, the CAPF contingent for a Mount Everest expedition of which Geeta was part, was unfortunately called off due to technical reasons

She then set an ambitious goal-- the 'Seven Summits' challenge, which involves climbing the highest peak on each of the seven continents.

Between 2021-2022, she summited four of these formidable peaks: Mount Kosciuszko (2,228m) in Australia, Mount Elbrus (5,642m) in Russia, Mount Kilimanjaro (5,895m) in Tanzania and Mount Aconcagua (6,961m) in Argentina.

The CISF official achieved

this feat in a 'remarkable' span of just six months and 27 days. making her the fastest Indian woman to do so, he said.

Samota, the spokesperson said, also became the first and fastest woman to climb five peaks in Ladakh's Rupshu re gion in just three days, including three peaks over 6,000m and two over 5,000m.

"Her extraordinary journey and successful summit, shine as a bea con of inspiration for the youth of India and stand as a moment of immense pride for the entire CAPFs fraternity," he said.
