Cash row: SC nixes plea seeking FIR

New Delhi: The Supreme Court Wednesday refused to hear a plea seeking an FIR against high court judge Yashwant Varma in connection with the discovery of cash from this official residence in the capital. A bench comprising Justices Abhay S Oka and Ujjal Bhuyan said a press release issued by the top court May 8 records that the Chief Justice of India forwarded the report of the in-house enquiry committee along with the judge's response to President and Prime Minister

Top court rap, relief for Mahmudabad

New Delhi: The Supreme Court Wednesday granted interim bail to Ashoka University professor Ali Khan Mahmudabad, arrested for his contentious social media posts on Operation Sindoor, but refused to stay the investigation against him. A bench of Justices Surva Kant and N Kotisar Singh directed the Haryana director general of police to constitute a threemember special investigation team (SIT) headed by an inspector general (IG) rank officer also including a superintendent (SP) rank woman officer within 24 hours to investigate the case. The top court said the interim bail was granted to the petitioner to facilitate further investigation and directed Mahmudabad to surrender his passport.

12-yr-old raped by 5 minors in school

Moradabad (UP): A 12-year-old girl was allegedly raped inside a school building here by five minor boys, who have all been detained by the police, an official said Wednesday. Both the survivor and the perpetrators belonged to a Dalit community and lived in the same locality in Moradabad district, the official said. The accused -- aged between 12 and 15 years and students of Classes VII to IX-- lured the girl to the school building near her house, drugged her with an intoxicant in a cold drink, and committed the crime. After the assault, the accused allegedly recorded her video and threatened to upload it on social media if she spoke out, the official said.

26 more Maoists killed

Top leader Basavaraju,

Narayanpur (Chhattisgarh), May 21: Topmost leader and the backbone of the Naxal movement. Nambala Keshav Rao alias Basavaraju, and 26 other dreaded Maoists were killed by security forces in a fierce encounter in the dense forests of Abhujmad in Bastar region of Chhattisgarh Wednesday.

Hailing the operation, Prime Minister Narendra Modi said he was proud of the security forces for the "remarkable success", while Union Home Minister Amit Shah termed it a "landmark achievement" in the battle to eliminate Naxalism.

Police said the gunfight took place in dense forests of Abhujmad on the tri-junction of Naravanpur-Bijapur-Dantewada districts.

The operation was launched two days back following intelligence inputs about the presence of Central Committee and Politburo members of the CPI (Maoists) as well as senior Maad Division cadres and PL-GA (Peoples' Liberation Guerrilla Army) members.

So far, bodies of 27 Naxalites and a large number of weapons have been recovered from the spot. A member of the District Reserve Guard (DRG), a unit of Chhattisgarh Police, was also killed in the action while some others sustained injuries, police said.



said this was for the first time in three decades of India's battle against Naxalism that a general secretary-ranked leader has been neutralised by the security forces.

Applauding the "brave security forces and agencies for this major breakthrough", the Home Minister said he was glad to share that after the completion of Operation Black Forest 54 Naxalites have been arrested and 84 others have surrendered in Chhattisgarh, Telangana and Maharashtra. "The Modi government is resolved to eliminate Naxalism before the 31st of March 2026," he said.

Basavaraju was in his early 70s, officials said. Hailing from undivided Andhra Pradesh Basavaraju was the brain behind several major attacks on security forces in Chhattisgarh. He was associated with the banned movement since the 1970s and elevated to the top post in CPI (Maoist) seven years ago.

AFGHAN JOINS CHINA, PAK TO **EXPAND CPEC**

Beijing/Islamabad, May 21: The China-Pakistan Economic Corridor (CPEC) is set to be expanded to Afghanistan with the foreign ministers of the three countries agreeing on it as part of broader efforts to boost "trilateral" cooperation.

The announcement on expansion of CPEC was made following a meeting among Chinese Foreign Minister Wang Yi, his Pakistani counterpart Ishaq Dar and Afghanistan's Acting Foreign Minister Amir Khan Muttagi in Beijing, according to a Pakistani readout.

India has been severely critical of the CPEC as it passthrough Pakistan-occupied-Kashmir. New Delhi is also opposed to China's Belt and Road Initiative (BRI) as the project includes the CPEC

The trilateral meeting took place days after the interim Taliban government recently warmed up to India. The meet ing between the foreign ministers of the three countries was held also in the backdrop of Is lamabad's persistent criticism of the interim Taliban govern ment for failing to crackdown on militant groups operating from Afghan soil waging a war against Pakistan.

The Chinese Foreign Ministry spokesperson Mao Ning in her media briefing in Beijing termed as "unofficial" the meet ing between Chinese Foreign Minister Wang Yi, Pakistan's Deputy Prime MinisterForeign Minister Ishaq Dar, and Acting Foreign Minister of Afghani stan Amir Khan Muttagi.

The three countries for a long time had a trilateral foreign ministers' mechanism which has not been convened for some time amid growing differences be tween Islamabad and Kabul over forcible repatriation of thousands of Afghan refugees by Pakistan The trilateral meeting was held on the concluding day of Dar's three day visit to Beijing, the first high-level interaction after India launched Operation Sindoor.

Students' union polls after 7 yrs

Bhubaneswar, May 21: The state government is planning to hold elections to students' unions in colleges and universities this year, after a gap of seven vears.

Speaking to reporters here, Higher Education Minister Suryabanshi Suraj said, "Chief Minister Mohan Charan Majhi had earlier promised that students' union elections would be held this year."

Efforts are being made to commence the academic session for undergraduate and postgraduate courses by July 15 so that the first semester is completed on time before Dussehra holidays, and students' studies are not hampered during the elections, he said.

The previous BJD government had stopped holding college elections since 2018 due to various reasons, including violence on campuses and the Covid-19 pandemic. The BJP, in its 2024 election manifesto, had promised to resume the students' elections after coming to power.

Bhubaneswar, May 21: Girls once again performed better than boys in the Class XII (Plus II) board examinations in Odisha, the results of which were declared Wednesday.

About 82.77 per cent of students cleared the examinations conducted by the Council of Higher Secondary Education (CHSE), School and Mass Education Minister Nityananda Gond said.

About 3.93 lakh students had filled the forms for the Annual Higher Secondary Examination 2025, and out of them, 3.82 lakh appeared, he said.

Nilgais take over Asia's largest auto-test track dent of Ralamandal sanctuary

Indore, May 21: Asia's largest auto-testing facility, the National Automotive Test Tracks (NA-TRAX) at Pithampur near here, has found itself sharing space with an unexpected herd - over a hundred nilgais. As sleek test vehicles zip past at speeds of 300 km per hour, these gentle antelope have turned the sprawling campus into an unintended wildlife refuge.

With safety concerns mounting, authorities have intensified their efforts to rescue the nilgais. NATRAX is known as Asia's largest auto-testing facility, but officials fear that there could be accidents due to the presence of animals on its 3.000 acre campus.

Yohan Katara, superinten-

in Indore, said Wednesday that in the last five days they have released about 50 nilgais, rescued from the campus, in the Gandhi Sagar Wildlife Sanctuary, a habitat of leopards. NATRAX which belongs to

the Union Ministry of Heavy Industries is used to test the strength and performance of automobiles and automobile components before they are launched in the market.

The Gandhi Sagar sanctuary, incidentally, is the new home of cheetahs.

'Prabhas' and 'Pavak', two cheetahs from Kuno national park, were released into Gandhi Sagar sanctuary April 20.

The sanctuary is spread over Neemuch and Mandsaur districts, around 300 km away



from NATRAX.

"It is estimated that there are another 90 nilgais on NATRAX campus. Our campaign to rescue them and release them in their natural habitat will continue." Katara said.

NATRAX was formally in-

augurated January 28, 2018, but nilgais had made it their home before a fence was put up around its grounds.

With the availability of food and water, their number kept increasing year after year, Katara said

Manish Jaiswal, director of NATRAX, said, "No accident has happened due to a nilgai on our campus so far, but the risk is clearly there.

"Vehicles of national and international brands are often driven here at speeds of 200-300 km per hour during testing. We are lucky that no vehicle has collided with a nilgai so far,"

In the last two years, more than 80 nilgais were safely rescued and shifted to their natural habitats, the official said.

Banu Mushtaq wins Int'l Booker for 'Heart Lamp'

London/Bangalore, May 21: Kannada writer, lawyer, and activist Banu Mushtaq and translator Deepa Bhasthi Wednesday scripted history by winning the International Booker Prize for 'Heart Lamp',

the first Kannada title and the first-ever collection of short stories to be awarded the GBP 50,000 prize.

'This moment feels like a thousand fireflies lighting up a single sky brief, brilliant, and utterly collective," said Mushtaq, standing next to Bhasthi, after receiving the prestigious literary award at London's Tate Modern.

Mushtaq's collection of 12 short stories, translated from the Kannada 'Hridaya Deepa' into English by Bhasthi, chronicles the everyday lives of women in patriarchal communities in southern India -- the reproductive rights that are often exploited, the dynamics of lives

where the power reins are held by men and the oppression of an orthodox society that seldom tolerates women's autonomy.

In a moving acceptance speech, Mushtaq said that it is an affirmation, "We as individuals and as a global community can thrive when we embrace diversity, celebrate our differences and uplift one another."





Visit remote areas to assess situation: CM to secretaries

Bhubaneswar, May 21: Chief Minister Mohan Charan Majhi Wednesday directed department secretaries to visit remote areas in 14 districts of the state where PM Janman Yojana is being implemented and assess the situation there.

The CM gave the directive while reviewing the progress of implementation of PM Janman Yojana in Odisha, at Lok Seva Bhawan here.

"Visit every remote area in 14 districts where the scheme is being implemented and assess the situation there," Majhi said.

The CM also directed the district Collectors and the department officers working at the district-level to visit every identified village and public settlement and assess the situation there and submit a report.

Notably, the scheme covers 55 blocks, 1,751 villages/public settlements, 289 village panchavats and two municipal areas in 14 districts of Odisha, while a total of 3,14,514 people from 68,605 families will benefit from this noble initiative.

The meeting informed that by the end of 2026, the target

has been set to construct 45,408 houses, about 210 kilometres of roads, supply tap water to 1,646 villages, connect mobile towers in 351 areas, build hostels for students in 405 areas, and build 74 multipurpose centres.

The CM advised the officials to complete all the work within the set deadline.

It was informed in the meeting that all the 1,055 habitations have been provided with mobile medical units and 100 per cent success has been achieved in this regard. The CM expressed satisfaction over this.

Majhi directed all the secretaries to complete the works of water supply, electricity supply and mobile connection, especially for the tribals living in the PVTG areas, as soon as possible. "The Chief Secretary and other secretaries should visit the unconnected or remote areas and give instructions on how to complete the work there within the stipulated time," the CM said.

Bhubaneswar, May 21: Opposition BJD Wednesday staged a demonstration outside the Raj Bhayan here demanding 27 per cent reservation for students belonging to Socially and Economically Backward Classes (SEBCs) in the state.

A BJD delegation, which included MPs. MLAs and senior leaders, besides students, met Governor Hari Babu Kambhampati and submitted a memorandum seeking his intervention to protect the constitutional rights of the OBCs, who are referred to as SEBCs in Odisha.

The agitators staged the protest rally after the state's BJP government last week announced 11.25 per cent reservation for students in the SEBC category in higher education, excluding medical, engineering and technical courses. Both BJD and the Congress

are opposing the state government's decision and demanding 27 per cent quota, instead of 11.25 per cent reservation for the SEBC students in higher education, and inclusion of medical, engineering and technical

The ruling BJP Tuesday stated that 11.25 per cent quota will be extended to SEBC students in medical and engineering courses as well. However, it is yet to be implemented by the

state government. In the memorandum, the

BJD sought the Governor's intervention and stated that the measure taken by the BJP government in Odisha was inadequate.

"Reservation has not been extended to medical and engineering colleges in the state. Furthermore, we would like to highlight that while the Scheduled Tribes (STs) and Scheduled Castes (SCs) constitute 22.5 per cent and 16.25 per cent of the state's population respectively, the current reservation in technical, medical,

and engineering colleges stands at only 12 per cent for STs and 8 per cent for SCs -- totalling merely 20 per cent," the BJD memorandum pointed out.

"This falls significantly short of the 38.75 per cent combined reservation that should be allocated in proportion to their population," it said.

The regional party pointed out that the Central government and several other states have already implemented 27 per cent reservation for OBCs across educational institutions, including in technical and professional education.

₹3,500 social security pension from June

Bhubaneswar, May 21: The state government has decided to provide an enhanced pension of Rs 3,500 per month to beneficiaries aged 80 years and above and persons with more than 80 per cent disability from June this year, an official notification said.

As per the notification issued by the Social Security and Empowerment of Persons with Disabilities (SSEPD) department, the government has sanctioned the enhanced pension under its social welfare schemes.

All beneficiaries of the National Social Assistance Programme (NSAP) and Madhu Babu Pension Scheme (MBPS) will now receive an increased monthly pension of Rs 3,500 an official said, adding that the previous emolument was Rs 1,500 per month.

The SSEPD department has directed all district social se curity officers (DSSOs) to implement the enhanced pension from June based on the list of eligible beneficiaries provided by the sub-collectors. The DS-SOs have also been asked to sanction the revised pension amounts and forward the nec essary orders to the department for further action. This increase will be effective retrospectively from January 2025, it added.

SEC defers rural bypolls

Bhubaneswar, May 21: A few hours after announcing dates, the State Election Commission (SEC) Wednesday deferred the bypolls to a few three-tier panchayat institutions from May 22 as the early onset of monsoon is expected in the region, an official said The panel had Tuesday

issued a notification for the by-elections for 1,043 vacant ward member seats. 43 sarpanchs, 40 panchayat samiti seats and five zilla parishad members. The polls were scheduled May 22 and June 25.

Keeping in view the early onset of monsoon, the notification for the byelections stands cancelled and the polls will be held after the rainy season is over, an SEC official told reporters here.

Immediately after the issuance of the notification, feedback from the district officials, the public and intending candidates for the byelections poured in, suggesting that there may be disruption in the poll process due to early monsoon and inconvenience to voters, the official said.

The SEC immediately sought a report from the regional centre of the India Meteorological Department (IMD) in Bhubaneswar.

Quoting the IMD report, the official said the southwest monsoon is likely to reach Kerala in the next three to four days, much earlier than the usual date of June 1.

The conditions for the onset of monsoon are likely to become favourable for some parts south and central Bay of Bengal, the official said.

Woman, daughter held over ₹123-crore chit fund scam

IE IS IN JAIL

Bhubaneswar, May 21: The Economic Offences Wing (EOW) of Odisha Police has arrested the wife and daughter of a chit fund firm director, who is already behind bars, in West Bengal in connection with a ponzi scam involving Rs 123 crore and around 34,000 investors from multiple states and Bangladesh.

Dwipika Bhanjo and Tandra Bhanjo, who were arrested in Paschim Medinipur of West Bengal, are the wife and daughter, respectively, of Tusar Bhanio, the director of Harit Krishi Nidhi Ltd. and M/s Transvision Dream Multi Trade Pvt. Ltd. According to the EOW, the

company collected over Rs 123 crore from investors across Odisha, West Bengal, Chhattisgarh, Assam, Tripura, Maharashtra, and even The two women have been booked un-

der Sections 420, 467, 468, 471, and 120B of the IPC, read with Sections 4, 5, and 6 of the PCMCS (Banning) Act, Section 6 of the OPID Act, and Section 66(D) of the Information Technology Act.

The accused were produced before the Court of CJM, Barasat, North 24 Parganas, Kolkata, May 20 and brought to Bhubaneswar on a three-day transit remand. They were presented before the Designated Court under the OPID Act in Cuttack Wednesday.

The case was registered based on a complaint of Manmohan Dora of Bhubaneswar May 28 last year. He alleged that Harit Krishi Nidhi Ltd. and M/s Transvision Dream Multi Trade Pvt. Ltd., and their director Tusar Bhanio induced him and thousands others to invest by promising high returns, including monthly interest of 11 per cent and additional commissions of 4-5 per cent for referring new investors.

Tusar was arrested in the case in June 2024 and since then, he is in jail. The company also promised fixed

monthly salaries - Rs 4,000 for a Rs 4 lakh investment, Rs 8,000 for Rs 8 lakh investment and so on. To lure investors. Tusar used social media, leaflets. brochures, and physical meetings as well. Investigations revealed that Tusar had earlier registered M/s Transvision Dream Multi Trade Pvt. Ltd. with the Registrar of Companies (ROC), Cuttack. In 2023, he incorporated Harit Krishi Nidhi Ltd. in West Bengal.

Though rules restricted operations in the state of incorporation, Tusar opened offices in other states such as Odisha, Chhattisgarh, and Assam - in violation of Nidhi company regulations

Moreover, chit fund activities, which are prohibited for Nidhi companies, were being run in RRESTED IN THE the form of a ponzi scheme. CASE IN JUNE 2024 Investors were promised ND SINCE THEN high monthly returns and substantial commissions for bringing in new members.


With the help of associates, Tusar collected over Rs 123 crore. After disbursing a few initial returns at 11 per cent per month, he allegedly absconded with the rest of the funds.

The money was reportedly diverted to various accounts, including those of his wife and daughter. Funds were even siphoned off to Bangladesh and China, according to EOW sources.

In Odisha, the company had offices in Balasore, Bhadrak, Bhubaneswar, and Rourkela. Investors were actively encouraged to bring in new members with the lure of attractive bonuses — a key characteristic of a ponzi scheme, which is strictly prohibited for Nidhi companies.

It was also discovered that the company invested the collected funds in forex trading by creating a pooled account, aiming to earn an additional 20 per cent return, a fact not disclosed to the investors.

EOW sources further revealed that Tusar used investors' money for luxury trips to Dubai and Bangkok as well.

Rourkela, May 21: Widespread irregularities were detected in labour welfare schemes in Sundargarh district, with allegations surfacing that certificates and benefits are being issued in the names of deceased persons.

According to sources, a glaring example has emerged from Balani in Lathikata block where Ruturai Navak. a labourer who died January 30, 2022, was issued a construction worker certificate October 8, 2024. Moreover, a fake death certificate dated December 5, 2024, was also issued in his

Another case involves Gopal Kisan from Garjan village who is alive but was falsely declared dead in a certificate dated December 14, 2019. Despite Gopal's actual death occurring in 2023, an application for death benefits was processed based on the earlier fraudulent certificate. A department official accepted the forged application without due verification January 13, 2025.

These irregularities have allegedly taken place right under the nose of department officers and in cahoots with matter has now reached the District Magistrate and is sub

The state's labour welfare schemes are intended to support poor working-class families with benefits including educational assistance, health support, and financial aid for social ceremonies. VILLAGES IN NIYAMGIRI

Rayagada, May 21: Despite being home to a number of tribal communities, Rayagada district has also some major industries like a paper mill as well as bauxite mining. However, people in this tribal-dominated district continue to struggle with basic mobile network connectivity. People in 19 villages in the remote Niyamgiri hill region are still unaware about basic mobile network services when internet facility still eludes them.

Members of Dongria Kondh community, an indigenous tribe residing in Niyamgiri Hills under Kalyansinghpur block, remain disconnected from even the most basic cellular networks when it is better not to talk about internet services. The area comprises two panchayats Sunakhandi and Parsali under which lie 36 Dongria Kondh settlements. Out of these, 19 villages have no mobile coverage.

Locals said they face severe problems during emergencies due to the absence of connectivity. Despite years of government schemes aimed at mainstreaming the Dongria Kondh, many remain on paper only, according to Niyamgiri Suraksha Samiti president Lada Sikaka.

While Sikapadar village in Sunakhendi panchayat is one of the few villages with limited access, 18 villages under Parsali panchayat-such as Bada Dengneli, Bemberi, Chatikana, Damaguda, Dangamati, Guma, Kalatipadar, Krushamohi, Lakhapadar, Lamba, Mayabali, Nishikhal, Pakeri, Patangapadar, Sanadengneli, Sarijhola, Tadamunhi, and Talua have no connectivity at all. Even in places with signal presence, internet services are reportedly non-functional.

With mobile number-Aadhaar card link becoming mandatory for availing benefits under government schemes, these villages are unable to complete essential documentation due to lack of mobile connectivity in the area. Many are also missing out on government welfare schemes, such as access to eggs and sattu provided at Anganwadi centers, due to the lack of a registered mobile number.

Absence of connectivity is proving to be dangerous during medical emergencies. Residents say pregnant women and sick persons often have to be carried long distances on slings or cots to access healthcare services because calling for ambulances or health workers is not possible for them due to absence of mobile con-

The digital divide has also disrupted children's education. With no mobile network or internet access. online learning remains out of reach for students in these villages.

District Collector Parul Patawari has said that under PM Janman scheme, steps will soon be taken to provide mobile network services to the 19 affected villages. Meanwhile, tribal communities and local activists continue to urge the state government and district administration to take immediate action to bridge the digital gap in the Niyamgiri region.

Undermining Soft Power

ower is the ability to get others to do what you want. That can be accomplished by coercion ("sticks"), payment ("carrots"), and attraction ("honey"). The first two methods are forms of hard power, whereas attraction is soft power. Soft power grows out of a country's culture, its political values, and its foreign policies. In the short term, hard power usually trumps soft power. But over the long term, soft power often prevails. Joseph Stalin once mockingly asked, 'How many divisions does the Pope have?" But the papacy continues today, while Stalin's Soviet Union is long gone.

When you are attractive, you can economise on carrots and sticks. If allies see you as benign and trustworthy, they are more likely to be open to persuasion and follow your lead. If they see you as an unreliable bully, they are more likely to drag their feet and reduce their interdependence when they can. Cold War Europe is a good example. A Norwegian historian described Europe as divided into a Soviet and an American empire. But there was a crucial difference: the American side was "an empire by invitation." That became clear when the Soviets had to deploy troops to Budapest in 1956, and to Prague in 1968. In contrast, NATO has not only

survived but voluntarily increased its membership.

A proper understanding of power must include both its hard and soft aspects. Machiavelli said it was better for a prince to be feared than to be loved. But it is best to be both. Because soft power is rarely sufficient by itself, and because its effects take longer to realise, political leaders are often tempted to resort to the hard power of coercion or payment. When wielded alone, however, hard power can involve higher costs than when it is combined with the soft power of attraction. The Berlin Wall did not succumb to an artillery barrage; it was felled by hammers and bulldozers wielded by people who had lost faith in Communism and were drawn to Western values

After World War II, the United States was by far the most powerful country, and it attempted to enshrine its values in what became known as "the liberal international order" – a framework comprising the United Nations, the Bretton Woods economic institutions, and other multilateral bodies. Of course, the US did not always live up to its liberal values, and Cold War bipolarity limited this order to only half the world's people. But the

postwar system would have looked very different if the Axis powers had won WWII and imposed their values.

While prior US presidents have violated aspects of the liberal order, Donald Trump is the first to reject the idea that soft power has any value in foreign policy. Among his first actions upon returning to office was to withdraw from the Paris climate agreement and the World Health Organization, despite the obvious threats that climate change and pandemics pose.

The effects of a US administration surrendering soft power are all too predictable. Coercing democratic allies like Denmark or Canada weakens trust in our alliances. Threatening Panama reawakens fears of imperialism throughout Latin America. Crippling the US Agency for International Development – created by President John F. Kennedy in 1961 - undercuts our reputation for benevolence. Silencing Voice of America is a gift to authoritarian rivals. Slapping tariffs on friends makes us appear unreliable. Trying to chill free speech at home undermines our credibility. This list could go on.

Trump has defined China as America's great challenge, and China itself has been investing in soft power since 2007, when then-Chinese President Hu Jintao told the Communist Party of China that the country needs to make itself more attractive to others. But China has long faced two major obstacles in this respect. First, it maintains territorial disputes with multiple neighbours. Second, the CPC insists on maintaining tight control over civil society. The costs of such policies have been confirmed by public opinion polls that ask people around the world which countries they find attractive. But one can only wonder what these surveys will show in future years if Trump keeps undercutting American soft power.

To be sure, American soft power has had its ups and downs over the years. The US was unpopular in many countries during the Vietnam and Iraq wars. But soft power derives from a country's society and culture as well as from government actions. Even during the Vietnam War, when crowds marched through streets around the world to protest US policies, they sang the American civil-rights anthem "We Shall Overcome." An open society that allows protest can be a soft-power asset. But will America's cultural soft power survive a downturn in the government's soft power over the next four years?

American democracy is likely to survive four years of Trump. The country has a resilient political culture and a federal constitution that encourages checks and balances. There is a reasonable chance that Democrats will regain control of the House of Representatives in the 2026 elections. Moreover, civil society remains strong, and the courts independent. Many organisations have launched lawsuits to challenge Trump's actions, and markets have signalled dissatisfaction with Trump's economic policies.

American soft power recovered after low points in the Vietnam and Iraq wars, as well as from a dip in Trump's first term. But once trust is lost, it is not easily restored. After the invasion of Ukraine, Russia lost most of what soft power it had, but China is striving to fill any gaps that Trump creates. The way Chinese President Xi Jinping tells it, the East is rising over the West. If Trump thinks he can compete with China while weakening trust among American allies, asserting imperial aspirations, destroying USAID, silencing Voice of America. challenging laws at home, and withdrawing from UN agencies, he is likely to fail. Restoring what he has destroyed will not be impossible, but it will be costly.

A FEDERAL DILEMMA

n a rare development. President Droupadi Murmu on 13 May, invoked Article 143(1) of the Constitution, seeking the Supreme Court's advisory opinion on a matter that touches the heart of federal governance: whether timelines can be imposed by judicial authority on the President and Governors while exercising their discretion over state legislation. The move follows the SC's landmark verdict on 8 April, 2025, in which it laid down, for the first time, a three-month deadline for the President to decide on any bill reserved for her consideration by a Governor. The verdict arose from a case filed by Tamil Nadu government, alleging delays by the Governor in assenting to state bills. and has since ignited a fierce debate over the separation of powers between the Executive

and Judiciary. Under Article 143(1), the President may refer to the SC any question of law or fact that is deemed to be of such public importance that obtaining the Court's opinion becomes expedient. Though the Court's opinion in such matters is not binding, it carries great moral and legal weight, especially since such references are heard by a fivejudge Constitution Bench. The President's current reference is only the thirteenth in Indian constitutional history and contains fourteen significant questions regarding the interpretation of Articles 200 and 201—both of which relate to how Governors and the President deal with bills passed by state legislatures.

Article 200 allows a Governor to assent to a bill, withhold assent, or reserve it for the President's consideration. When a bill is reserved, Article 201 empowers the President to either assent to it or withhold assent. Notably, neither article sets a specific timeline for action, thereby creating the legal vacuum that has led to the present controversy. In its April 8 judgment, a division bench of Justices JB Pardiwala and R Mahadevan held that a Governor must act based solely on the advice of the state's Council of Minis-

ters and cannot delay or reject a bill based on personal dissatisfaction, political expediency, or irrelevant considerations. The Court further ruled that the President must decide on a reserved bill within three months of its receipt.

President Murmu, however, has raised fundamental objections to this ruling. In her reference, she noted that both Article 200 and Article 201 are silent on any deadlines, and this constitutional silence, she argued, cannot be replaced by judicial prescription. She also questioned the SC's use of Article 142 to introduce the idea of 'deemed assent" for bills withheld by Governors, suggesting that this doctrine is alien to the constitutional scheme. The President expressed concern that such judicial intervention circumscribes the constitutional powers of both the President and Governors, altering the federal equilibrium.

The President's reference highlights broader concerns about the limits of judicial power under Article 142, which authorises the SC to pass any order necessary for doing "complete justice." While this provision has been used in the past to fill legal gaps and offer equitable remedies, critics argue that it cannot be used to legislate from the bench or encroach upon functions clearly assigned to the Executive by the Constitution.

At the core of the current de bate lies the tension between the need for accountability in governance and the need to respect constitutional roles.

The SC's intent was clearly to ensure that Governors and the President do not become bottlenecks in the democratic process. But in attempting to ensure action, it may have strayed into the domain of constitutional function that traditionally rests with the Executive. For instance, treating a bill as "deemed passed" if not acted upon within a certain timeframe changes the very nature of legislative procedure and challenges the notion of discretion that Articles 200 and 201 implicitly provide.

President Murmu's decision to raise this issue through Article 143(1), rather than seeking a review of the verdict, suggests a strategic and constitutionally respectful approach. Under the rules of the SC, review petitions are typically heard in chambers by the same judges who delivered the original verdict, with limited scope for open debate. A Presidential reference,

on the other hand, is a more transparent and deliberative process, involving public hearings by a Constitution Bench, which may accept or refuse to answer the questions posed.

That said, the SC is under no obligation to respond to the reference, and in the past. it has occasionally declined to provide answers where it found the matter to be political or speculative. However, given the importance of the issues raised—touching upon federalism, legislative autonomy. and judicial overreach—the Court may well consider this an appropriate opportunity to

clarify the boundaries of institutional competence.

Looking ahead, there is a need for systemic reforms to prevent such impasses. Parliament could consider amending Articles 200 and 201 to introduce a reasonable time limit say three to six months-for Governors and the President to act on bills. Such an amendment would harmonise judicial concerns about executive inaction with the constitutional need to preserve the discretionary role of the executive. The judiciary, in turn, must develop clearer jurisprudential limits for its powers under Article 142, especially when dealing with domains that are already governed by constitutional or

statutory provisions. Moreover, the establishment of standing legislative committees in state assemblies to monitor the progress of bills and identify undue delays could bring additional transparency and accountability. Similarly, a codified "Governor's Code of Conduct" could help curb the misuse of constitutional powers for political ends, ensuring that Governors remain neutral constitutional functionaries and not partisan actors

Ultimately, the present episode is a crucial reminder that India's constitutional design depends not merely on the written word, but on a shared respect for institutional roles. The President, Governors, and the Judiciary are all guardians of the Constitution, and their powers are designed to check and balance one another, not to clash. As India approaches the 75th anniversary of its Republic, this moment offers an opportunity to recalibrate those balances and reaffirm the founding vision of a cooperative federalism under a constitutional rule of law.

In choosing the path of constitutional dialogue rather than confrontation. President Murmu has set a dignified precedent. Now the SC must decide how to respond—not just in legal terms, but in a way that sustains the delicate harmony of India's constitutional democracy.

ot all tax payers are sure whether income tax return has to be filed even in cases where tax computation may be zero. The answer is simple. If your income exceeds the basic exemption limit, you must file income tax return. The basic exemption limit under the New Tax Regime (Default), for the financial year 2025-26 (Assessment Year 2026-27) is Rs 4 lakhs for all individual taxpayers, regardless of age (including Hindu Undivided Family). If your income exceeds Rs 4 lakh, you must file income tax return even if tax liability comes to nil after application of exemptions, deductions, and rebate.

A rebate of up to Rs 60,000under section 87A is available for resident individuals with taxable income up to Rs 12 lakh. With a standard deduction of Rs 75,000, the effective tax-free income threshold for salaried taxpayers is Rs 12.75 lakh. However, even if the tax liability comes to zero on account of rebate and deductions, an individual must file IT return if the income exceeds the basic exemption limit of Rs 4 lakh under the new tax regime.

The rebate under Section 87A up to Rs 60,000 is available only for resident individuals with taxable income up to Rs 1,20,0000. This rebate is not applicable to non-resident individuals. If you are a non-resident Indian, your taxable income beyond Rs 4 lakh will be subject to income tax, without the benefit of rebate under Section 87A.

Under the old tax regime, the basic exemption limits vary by age for resident individuals. It is Rs 2.5 lakh for individuals below 60 years, Rs 3 lakh for senior citizens (60 years to less than 80 years), and Rs 5 lakh for super senior citizens (80 years and above). Therefore, super senior citizens need not file income tax return if their income is up to Rs 5 lakhs. Under old tax regime also a rebate of up to Rs 12500 is available (vide Section 87A) for resident individuals with taxable income upto Rs 5 lakh, effectively making income up to Rs 5 lakh tax-free.

Income tax also has its lexicon of ambiguous jargons. Many taxpavers have confusion about the precise difference between 'exemption' and 'deduction'. However, 'exemption' and 'deduction' are two distinct concepts that help reduce a taxpaver's tax liability, but they work differently. Whereas exemption applies to certain incomes like HRA, gratuity, Leave Travel Allowance (mostly under Section 10); deductions are eligible amounts of investments and expenses (mostly under Chapter VI-A) deducted from total income. Exemptions are applied to specific sources of income or allowances. Deductions require proactive investments or expenses. In other words, exemptions reduce income

subject to tax and deductions are amounts subtracted from taxable income.

In the context of exemptions, deductions, and rebates, it is reiterated that when your total income exceeds the basic exemption limit (which is at present Rs 4 lakh under new tax regime), you must file relevant return of income even though due to the exemptions you may not have taxable income. Even after having taxable income, you might circumvent income tax liability through deductions (under Chapter VI-A) and rebates (un-

der Section 87A). The new tax regime is the default option as per the Finance Act 2024, but taxpayers can opt for old tax regime while filing their income tax returns. Old tax regime suits those taxpayers who have substantial amounts of deductions to reduce tax liability.

Gandhinagar, May 21: The estimated population of Asiatic lions in Gujarat has increased to 891 from 674 five years ago as per the census conducted this month, officials

"Estimated population of Asiatic lions has increased to 891," Chief Minister Bhupendra Patel told reporters here.

As per the last census conducted in June 2020, the population of Asiatic lions, a subspecies only found in Gujarat's Gir area, was estimated at 674.

As per the latest count, there are estimated 196 males, 330 females, 140 sub-adults and 225 cubs, said the Gujarat forest department.

As the population of lions s increasing, their spread in Saurashtra region has also expanded. The big cats were earlier confined to the Gir National Park in Junagadh and Amreli districts, but now they have spread to 11 districts, an

counted in Gir National Park and Wildlife Sanctuary and 507 were found outside its limits. said Jaipal Singh, principal chief conservator of forest.

The areas outside Gir where lions were spotted included sanctuaries like Pania, Mitiyala, Girnar and Barda, Some animals were seen in non-forested areas and coastal areas too.

The highest number of lions recorded in a single pride was 17 in Bhavnagar district, official said.

The 16th Asiatic lion census, a four-day exercise, was conducted from May 10 to 13 in two phases, covering an area of 35,000 square kilome-

While the preliminary census was conducted on May 10 and 11, the final count was held on May 12 and 13 with the help of 3,000 volunteers, including regional, zonal and sub-zonal officers, enumerators, assistant enumerators and inspectors, said a forest department release.

The census was conducted through a more accurate method called 'direct beat verification', which provides 100 percent accuracy with almost zero margin of error due to statistical analysis and ease of implementation, said the release.

A lion census is conducted every five years by the state Forest Department.

Volunteers recorded details such as time of observation, direction of movement, sex, age, any other identifying marks on the body and GPS location among others.

Hi-tech tools like camera traps and high resolution cameras and radio-collars were used for the identification of lions, the release said.

The 11 districts where lions were spotted are Junagadh, Gir Somnath, Bhavnagar, Rajkot, Morbi, Surendranagar, Devbhoomi Dwarka, Jamnagar, Amreli, Porbandar and

Ahmedabad, May 21: The Ahmedabad administration has intensified its crackdown on the alleged illegal encroachments around Chandola Lake as the second phase of the demolition drive entered its second day Wednesdav.

The focus has now shifted to unauthorised religious structures, with Ali Masjid and Imam Hussain Masjid among those razed under heightened security arrangements. The drive, which began May 20, aims to clear over 2.5 lakh square me ters of encroached land.

The authorities had earlier cleared belongings from the structures before commencing demolition, which resumed early Wednesday morning.

As part of security precautions, roads leading to the Narol PWD office have been sealed off, and a significant police presence has been deployed in sensitive areas, including Hazrat



Shah-e-Alam Road.

Officials confirmed that nine mosques, both large and small, located near Chandola Lake, are scheduled for demolition. The area around Lalla Bihari Farm, home to Ali Masjid, was among the first targeted sites. The demolition of Siraj Masjid is also underway.

Chandola demolition drive targets

The move comes amid efforts by civic and police authorities to curb unauthorised constructions and alleged illegal activities, including settlements by undocumented foreign nationals.

Officials have cited the area as a hub for such encroachments and a breeding ground for unlawful activities. A high-level meeting chaired by the City Police Commissioner with senior officers from the Ahmedabad Municipal Corporation and law enforcement agencies preceded this operation.

Multiple Crime Branch teams

have been deployed to maintain law and order during the sensitive operation, which involves the removal of religious sites.

In the first phase of the oper ation, carried out earlier this year, around 1.5 lakh square meters of illegal structures were cleared. With religious structures now in focus, officials are taking precautions to prevent

any unrest. "We are ensuring that the process is handled lawfully and peacefully," a senior police of ficial said, adding that heavy deployment of police and crime branch personnel is in place to deter any potential backlash.

As the operation continues civic authorities reaffirm that the drive is part of a larger initiative to reclaim public land ensure security, and curb ille gal settlements, particularly in ecologically and socially sensitive zones like the Chandola

"We have decided to implement the 'Rahveer Yojana' to save the lives of people injured in road accidents. If a person takes the injured people in a road accident to a hospital or primary health centre, he will be given a reward of ₹25,000 by the government under this scheme," State Parliamentary Affairs Minister and cabinet spokesman, Kailash Vijayvargiya, told reporters. He said the government will instruct the police not to harass the people who rush the injured people to hospitals, in the name of inter-

Officials pointed out a provision in the 'Rahveer Yojana' of the Union Ministry of Road Transport and Highways wherein if a citizen admits person injured in a road accident to the hospital in 'golden-hour' (first one hour) and his life is saved, then he will be given a reward of ₹25.000, which was earlier ₹5.000.

Vijayvargiya said the state cabinet has decided to implement development works centred on the legacy of Adi Shankaracharya in Omkareshwar Jvotirlinga, A provision of ₹2.100 crore has been made.

Waqf Islamic concept but not essential to Islam: Centre to SC

New Delhi, May 21: The Centre Wednesday defended the Waqf (Amendment) Act, 2025 in the Supreme Court and said though waqf was an Islamic concept, it was not an essential part of Islam.

Arguing before Chief Justice BR Gavai and Justice Augustine George Masih, Solicitor General Tushar Mehta said, "Wagf is an Islamic concept. But it is not an essential part of $Is lam..\ Waqf\ is\ nothing\ but\ just$ charity in Islam." "Charity is recognised in every religion, and it cannot be regarded as an essential tenet of any religion," he said.

Earlier in the day, Mehta asserted nobody could claim right over public land by using waqf by user principle which was a statutory right and the law could take it away. "Waqf by user" refers to a concept where a property is recognised as waqf based on its long-term use for religious or charitable purposes, even without formal documentation.

Responding to the challenge against the validity of the 2025 law, Mehta argued the amended law dealt with the secular aspects of waqf and activities that were non-essential to Islam.

Mehta said the "waqf by user" concept did not permit "wholesale takeover of waqf properties" by the state as

Any stay of the provision on abolition of unregistered "waqf by user" properties would defeat the purpose of the law which has been enacted to remedy the mischief like usurpation of government land, Mehta added.

Mehta said, "There is a Supreme Court judgment which says the government can save the property if it belongs to the government and has been declared as wagf.'

Contesting the argument of government officers arbitrarily claiming land as government property from now on and override waaf status, he called it "misleading and false."

On the point of an officer above the rank of a district collector deciding the dispute on the claim over an alleged wagf property, he said officer wouldn't finally determine the property's ownership.

Mehta said the eviction or takeover of property could only occur after due process through the Waqf Tribunal proceedings (under Section 83) and subsequent appeals.

The possession would continue with the waqf until the issue was fully adjudicated, he said.

The SG cited the extensive deliberations of the Joint Parliamentary Committee, which

held 96 sittings, received 97 lakh representations, and incorporated feedback from 25 Wagf Boards and several state governments

The law officer also drew bench's attention to the "historic misuse" of waqf by user to claim ownership of public or private lands without documentation.

On the question whether the law infringed upon Articles 25 and 26 (freedom of religion and management of religious affairs) of the Constitution, he said though waqf was an Islamic concept, it did not constitute an essential religious practice. Unlike Hindu, Jain religious

trusts which deal with religious aspects, temples, priests and their management, waqf may include schools, colleges, etc., Mehta said.

Doctrine of essential religious practices, he added, as articulated by Dr B R Ambedkar must be satisfied before any constitutional protection under Article 25 can be claimed.

The Centre opposed the claim that the law enabled mass takeover of waqf prop-

Referring to case laws, he said the government could protect public lands even if erroneously entered as waqf, and that mere entry in the waqf register did not confer ownership.

Mehta said no affected parties moved the court and "it is nobody's case that Parliament does not have the competence

SC grants interim bail to Ashoka varsity professor

New Delhi, May 21: The Supreme Court Wednesday granted interim bail to Ashoka University professor Ali Khan Mahmudabad, arrested for his contentious social media posts on Operation Sindoor, but refused to stay the investigation against him.

A bench of Justices Surya Kant and N Kotisar Singh directed the Haryana director general of police to constitute a three-member special investigation team (SIT) headed by an inspector general (IG) rank officer also including a superintendent (SP) rank woman officer within 24 hours to investigate the case.

"Having regard to the contents of the two alleged offending posts uploaded on social media, which have led to the registration of two FIRs against the petitioner, we are satisfied that no case for staying the investigation is made out," the



bench said. The top court ordered, "However, to holistically understand the complexity of the phraseology employed and for proper appreciation of some of the expressions used in these two online posts, we direct the Director General of Police, Haryana to constitute an SIT comprising three directlv recruited IPS Officers, who do not belong to the States of Haryana or Delhi."

It said in the SIT the remaining members should be officers in the rank of Superintendent of Police and above and one of them will be a woman IPS of-

"We have also considered the prayer for bail made on behalf of the petitioner. With a view to facilitate the investigation, as noted above, we direct that the petitioner be released on interim bail, subject to his fur-

a learned person cannot lack a dictionary...he could have conveyed the very same feelings in a simple language without hurting others. He should have shown respect for the sentiments of others. He could have used a simple and neutral kind of language, respecting others, Justice Kant said.

The bench said though everybody had the right to freedom of expression, Mahmudabad's remarks seemed like "dog whistling", used in legal parlance.

The bench imposed certain conditions on Mahmudabad that he shall not write any online post, article or shall not make any oral speech related to either of the two online posts, which are subject-matter of the investigation.

The bench also restrained the professor from expressing any opinion in relation to the terrorist attack on Indian soil or the counter response given by the Indian armed forces.

TN moves SC against Centre over NEP row

India lost 18,200 ha of primary forest in 2024: GFW

New Delhi, May 21: India lost 18,200 hectares of primary forest in 2024 compared to 17,700 hectares in 2023, according to new data from Global Forest Watch (GFW), a global collaboration of over 100 organisations.

The GFW said the country lost 3,48,000 hectares of humid primary forest between 2002 and 2024 -- about 5.4 per cent of the country's total humid primary forest. This is 15 per cent of India's total tree cover loss

during the same period. Between 2019 and 2024, India lost 1,03,000 hectares (1.6 per cent) of humid primary forest, which is 14 per cent of its total

tree cover loss in those years.

The country lost 16,900 hectares of humid primary forest in 2022, 18,300 hectares in 2021, 17,000 hectares in 2020, and 14,500 hectares in 2019, the data showed.

The GFW defines primary forests as "mature natural humid tropical forests that have not been completely cleared and regrown in recent history".

These forests are identified using Landsat satellite images and special algorithms for each Since 2001, India has lost 2.31 million hectares of tree cover,

The GFW said the **country lost 3,48,000** hectares of humid primary forest between 2002 and 2024 -- about 5.4 per cent of the country's total humid primary forest

ghalaya 2,43,000 hectares.

During this period, 1.39 million hectares of tree cover was lost due to shifting cultivation. Another 6,20,000 hectares was lost to permanent agriculture. Logging caused the loss of

1,82,000 hectares while natural disturbances led to 35,100 hectares of loss. Settlements and infrastructure development caused 30,600 hectares of tree cover loss.

The GFW said its tree cover loss data is based on the best available satellite information. However, the data may change over time as algorithms improve. Therefore, it advises users not to directly compare older and newer data, especial ly before and after 2015.

According to the UN Food and Agriculture Organisation India had the second highest rate of deforestation in the world between 2015 and 2020. losing about 6,68,000 hectares of forest per year.



On May 13, India had expelled another Pakistani official for allegedly indulging in espionage. Following India's action, Pakistan had also expelled an Indian staffer posted at the Indian high commission in Islamabad. India's expulsion of two

As many as nine terror camps were hit inside Pakistan and Pakistan-occupied Kashmir by Indian forces to avenge the Pahalgam terror attack, which left at least 26 civilians dead.

India carried out precision strikes on nine terror infrastructures early May 7 in response to the April 22 Pahalgam terror attack. Following the Indian action, Pakistan attempted to attack Indian military bases May 8, 9 and 10.

IndiGo flight with 227 on board hits turbulence

Srinagar, May 21: A Srinagar-bound IndiGo flight from Delhi with more than 220 people, including TMC MPs, on board encountered sudden hailstorm Wednesday, prompting the pilot to report the "emergency" to air traffic control at Srinagar. The aircraft later landed safely here and has been grounded, officials said.

Videos of the moments of turbulence shared on social media showed panic-strick en passengers could be heard making religious supplications as the plane swayed. Some passengers claimed that the nose of the plane was damaged but there was no official word on it. 'IndiGo flight 6E2142 enroute Delhi to Srinagar experienced bad weather (hail storm), emergency reported by Pilot to ATC SXR (Srinagar)," an official of the Airport Authority of India said here. 'Aircraft on ground' (AOG) refers to a plane that is grounded and unable to fly due to technical issues. A Trinamool Congress (TMC) delegation, which included Derek O'Brien, Sagarika Ghose, Nadimul Haque, Mamata Thakur and Manas Bhuyan, was on board the plane. Ghose said.

"It was a near-death expe rience. I thought my life was over. People were screaming, praying and panicking. Hats off to the pilot who brought us through that. When we landed we saw the nose of the plane had blown up," Ghose said. "I was in the plane and heading back home from Srinagar...It was a near-death experience... the nose of the plane is damaged," Owais Magbool Hakeem (@owaismaqbool) posted on X.

ED asserts prima facie charges against Sonia, Rahul Gandhi



New Delhi, May 21: The ED has alleged that the proceeds of crime in the National Herald case against Congress' Sonia and Rahul Gandhi were obtained on "instructions of some senior party leaders" towards "protection, tickets to contest elections, and securing positions in the party"

The ED has filed its chargesheet against Congress leaders Sonia Gandhi, Rahul Gandhi and others under Sections 3 (money laundering) and 4 (punishment for money laundering) of Prevention of Money Laundering Act (PMLA).

ED alleged proceeds of crime amounting to ₹988 crore -- obtained through various channels -- in the case. Proceeds of crime include any property obtained or derived directly or indirectly as a result of criminal activity relating to a scheduled offence -- in this case the offence of money laundering. The central probe agency's

case accuses the Gandhis, late Congress leaders Motilal Vora and Oscar Fernandes aside from Dubey. Pitroda and a private company Young Indian of conspiracy and money laundering over the fraudulent takeover of properties valued over ₹2,000 crore belonging to the Associated Journals Limited (AJL).

The ED's chargesheet filed in a Delhi court said the payments received by Young Indian were not in the nature of donations but in the nature of accommo dation entries arranged as a part of the criminal conspiracy by the accused persons and in continuation of money laundering-related activities.

'The senior leaders of the Congress Party who were office bearers in Young Indian under the patronage of Gand hi family members namely So nia Gandhi and Rahul Gandhi, influenced various persons in cluding some Congress mem bers/leaders to arrange funds for Young Indian, in the guise of donations, in lieu of various favours promised to them and also in lieu of cash from AICC office," the ED said.

The ED Wednesday informed special judge Vishal Gogne that a "prima facie' case of money laundering was made against Gandhis and others in the matter.

Unnatural sex with wife not punishable under law: HC

New Delhi, May 21: Saying the law doesn't recognise the concept of marital rape, the Delhi High Court has quashed an order directing prosecution of a man for performing "unnatural" sex with his wife.

The court noted Section 377 of IPC penalising such acts won't apply in a marital relationship particularly when the allegation of consent was missing.

Justice Swarana Kanta Sharma was dealing with the man's plea against a trial court order which directed framing of Section 377 (punishment for unnatural offences) charge against him for allegedly performing oral sex with his wife.

The verdict said the law did not recognise the concept of marital rape.

"There is no basis to assume that a husband would not be protected from prosecution under Section 377 of IPC, in view of exception 2 to Section 375 of IPC since the law (amended Section 375 of IPC) now presumes implied consent for sexual intercourse as well as sexual acts, including anal or oral intercourse within a marital relationship," it said.

The court further said acts such as anal intercourse or oral sex were included within the ambit of offence of rape under the Section 375(a) of IPC and there was no basis to assume that the petitioner would not fall within the immunity granted to husbands under the "exception" to the offence of rape.

"In the context of a marital relationship, Section 377 of IPC cannot be applied to criminalise non-penile-vaginal intercourse between a husband and wife. Such an interpretation would be in line with the reasoning and observations of the Supreme Court in Navtei Singh Johar (case)," said the court in its May 13 order.

It came on record that the wife claimed the man was "impotent" and their marriage was the result of a conspiracy by him and his father to establish illicit relations and extort money from her family.

The man argued the mar riage was legally recognised and there was an implied pre sumption of consent for consensual sexual acts and its nature could not constitute an offence under Section 377.

The judge underlined an "inherent contradiction" in the statement of the wife who on the one hand alleged sexual incapacity of the man and levelled allega tions suggesting the performance of oral sex on the other.

Iran okays strategic pact with Russia

Dubai: Iran's parliament approved a 20-year strategic partnership Wednesday between Moscow and Tehran, state media reported. The agreement represents a deepening of bilateral ties including closer defence cooperation. Russian President Vladimir Putin and his Iranian counterpart Masoud Pezeshkian signed the strategic partnership document January 17. The Russian legislative branch approved the pact in April.

PIO Singaporean police officer charged

Singapore: An Indian-origin Singapore police officer was charged on Wednesday with forging police statements and documents related to cases he had investigated between 2021 and 2023. S Vikneshvaran Subramaniam, 35, was handed nine charges of forgery, reported Channel News Asia The charges relate to five criminal cases which were ongoing and two concluded cases which did not result in prosecution, the Singapore Police Force (SPF) said in a media release.

Japan's agriculture minister resigns

Tokvo: Japan's agriculture minister resigned Wednesday over his inappropriate remark about buying rice as the public struggles with record high prices of the country's traditional staple food. At a party seminar Sunday in Saga prefecture, Taku Eto said he "never had to buy rice" because his supporters always give him the grain as gifts. The gaffe was seen as insensitive to the rice situation and could be further trouble for Ishiba's already struggling minority government before a national election in July.

Indian nat'l pleads guilty in fraud case

Houston: An Indian national living in the United States has pleaded guilty to staging armed robberies at retail stores across several American states to help individuals fraudulently obtain US immigration benefits. Rambhai Patel, 37, a resident of New York, entered a guilty plea Tuesday before US District Judge Myong J Joun in Boston to one count of conspiracy to commit visa fraud. Sentencing has been scheduled for August 20. According to US federal prosecutors, Patel and a coconspirator carried out at least nine staged robberies at convenience stores and restaurants-five of them in Massachusettsbeginning in March 2023.

Trump finalises 'Golden Dome' missile defense plan

Washington, May 21: President Donald Trump has announced the concept he wants for his future Golden Dome missile defence program — a multilayered, \$175 billion system that for the first time will put US weapons in space.

Speaking Tuesday from the Oval Office, Trump said he expects the system will be "fully operational before the end of my term," which ends in 2029, and have the capability of intercepting missiles "even if they are launched from space."

It's likelier that the complex system may have some initial capability by that point, a US official familiar with the programme said.

Trump, seated next to a poster showing the continental US painted gold and with artistic depictions of missile interceptions, also announced that Gen. Michael Guetlein, who currently serves as the vice chief of space operations, will be responsible for overseeing Golden Dome's progress.

Golden Dome is envisioned to include ground- and space-based capabilities that are able to detect and stop missiles at all four major stages of a potential attack: detecting and destroying them before a launch, intercepting them in their earliest stage of flight, stopping them midcourse in the air, or halting them in the final minutes as they descend toward a target.

For the last several months, Pentagon planners have been developing options — which the US official described as medi-



'Golden Dome' may revive Russia-US arms talks: Kremlin

Moscow: The Kremlin indicated Wednesday that President Donald Trump's "Golden Dome" missile shield plans could force the resumption in the foreseeable future of contacts between Moscow and Washington about nuclear arms control. Asked about Trump's announcement that he had selected a design for the \$175-billion Golden Dome missile defense shield, Kremlin spokesman Dmitry Peskov said it was a sovereign matter for the United States. The so-called "Golden Dome", inspired by Israel's land-based Iron Dome defense shield, is an ambitious project aimed at blocking threats from China and Russia, which the United States views as its two biggest geopolitical competitors. Peskov, asked if Russia saw the project as a threat to Russia's nuclear parity with the United States, said that there was no detail about the US project and many nuances remained. "In the foreseeable future, the very course of events requires the resumption of contacts on issues of strategic stability," Peskov said.

Pak to extend closure of its airspace for Indian flights by another month

Islamabad, May 21: Pakistan has decided to extend the closure of its airspace for Indian flights by another month, a media report said Wednesday.

Pakistan banned its airspace for India last month after steps taken by New Delhi in the wake of the Pahalgam terrorist attack April 22.

The ban was imposed for a month until May 23, as under International Civil Aviation Organisation (ICAO) rules that airspace restrictions cannot be imposed for more than one month at a time.

Quoting sources, Geo News reported that the decision to extend the ban is expected to be announced Wednesday or Thursday, and a Notice to Airmen (Notam) will be issued.



The development comes amid heightened tensions between the two neighbours following India's precision strikes under 'Operation Sindoor' on terror infrastructure in Pakistan and Pakistan-occupied Kashmir May 7 in response to the April 22 Pahalgam terror attack that killed 26 people.

The Indian military has been maintaining that Pakistan pleaded for stopping the military actions after India hit eight military installations in Pakistan on early May 10 in response to Pakistan's attempts to target Indian military bases.

This is not the first time Pakistan has imposed such restrictions. Pakistan closed its airspace for Indian flights during the 1999 Kargil conflict and the 2019 Pulwama crisis.

Suicide bomber kills 5 on school bus in Balochistan

Quetta, Pakistan, May 21: At least three children were among five people killed when a suicide bomber struck an army school bus in Pakistan's restive Balochistan province, the military said Wednesday, in an attack that Pakistan blamed on Indian proxies.

At least 82 killed in Israeli strikes on Gaza

Deir al-Balah (Gaza), May 21: Israeli strikes continued to pound the Gaza Strip Wednesday, despite a surge in international anger at Israel's widening offensive.

The attacks killed at least 82 people, including several women and a week-old infant, according to the Gaza Health Ministry and area hospitals.

Israel began allowing dozens of humanitarian trucks into Gaza Tuesday, but the aid has not yet reached Palestinians in desperate need.

Jens Laerke, the spokesperson for the UN's humanitarian agency, said no trucks were picked up from the Gaza side of Kerem Shalom, the Israeli border crossing with southern Gaza.

UN spokesperson Stéphane Dujarric said Tuesday that although the aid had entered Gaza, aid workers were not able to bring it to distribution points, after the Israeli military forced them to reload the supplies onto separate trucks and workers ran out of time.

The Israeli defence body that oversees humanitarian aid to Gaza said trucks were entering Gaza Wednesday morning, but it was unclear if that aid would move deeper into Gaza for distribution.

The UN agency for Palestinian refugees, UNRWA, said its staff had waited several hours to collect aid from the border crossing in order to begin distribution but were unable to do so Tuesday. A few dozen Israeli activists opposed to Israel's decision to allow aid into Gaza while Hamas still holds Israeli hostages attempted to block trucks carrying supplies Wednesday morning, but were kept back by Israeli police.

Tigers, jaguars, elephants latest to flee Mexico cartel violence

Culiacan (Mexico), May 21: A pack of veterinarians clambered over hefty metal crates Tuesday morning, loading them one by one onto a fleet of semi-trucks. Among the cargo: tigers, monkeys, jaguars, elephants and lions – all fleeing the latest wave of cartel violence eclipsing the northern Mexican city of Culiacan.

For years, exotic pets of cartel members and circus animals have been living in a small animal refuge on the outskirts of Sinaloa's capital.

However, a bloody power struggle erupted last year between rival Sinaloa cartel factions, plunging the region into unprecedented violence and leaving the leaders of the Ostok Sanctuary reeling from armed attacks, constant death threats and a cutoff from essential supplies needed to keep their 700 animals alive.

The aid organisation is now leaving Culiacan and transporting the animals hours across the state in hopes that they'll escape the brunt of the violence. But fighting has grown so widespread in the region that many fear it will inevitably catch up.

"We've never seen violence this extreme," said Ernesto Zazueta, president of the Ostok Sanctuary. "We're worried for the animals that come here to have a better future."

Notice to Uber over 'Advance Tip' feature for faster service

New Delhi: Consumer protection watchdog CCPA has issued a notice to ride-hailing platform Uber for allegedly "forcing or nudging" users to pay advance tips for faster service. "The practice of 'Advance Tip' is deeply concerning,' Consumer Affairs Minister Pralhad Joshi

said in a social media post. "Forcing or nudging users to pay a tip in advance, for faster service is unethical

and exploitative. Such actions fall under unfair trade practices," the minister wrote. Joshi emphasised that tipping is meant as a token of appreciation, given after service completion, not as an entitlement beforehand. Taking cognizance of the issue, the minister directed the Central Consumer Protection Authority (CCPA) to investigate the matter. "Today CCPA has issued a notice to Uber in this regard, seeking explanation from the platform," he posted. "Fairness, transparency and accountability must be upheld in all customer interactions," Joshi added.

Marmoush let fly from around 30 yards (meters) to put City ahead in its 3-1 win against Bournemouth in the Premier League Tuesday.

The victory moved Pep Guardiola's team up to third in the standings and left Champions League qualification in its own hands heading into the last round of the season.

"It's really important. To be in the Champions League after what happened (this season) will be really nice," the City manager said.

De Bruyne was making his final home appearance for City before leaving the club as a free agent at the end of the season.

After a trophy-laden 10 years, the Belgium international was greeted with a huge banner declaring him "King Kev" and given a standing ovation when he was substituted off in the second half.

But it was Marmoush's goal after 14 minutes that lit up the match as his dipping shot clipped the post before crashing into the top corner. It was the type of goal that De

Bruyne would have been proud of in a career that has seen him score numerous spectacular strikes of his own. De Bruyne missed a glorious chance to cap his farewell with


