Koraput, June 4: At least six were provided ₹10,000 financial patients admitted at Saheed Laxman Naik Medical College assistance each from the district and Hospital (SLNMCH) here Red-Cross fund by the district administration in the presence died after they were allegedly of BDO Debashis Goud and administered wrong injections Tuesdav night. Five of them died within 90 minutes of taking the jabs Tuesday night while another succumbed in the early hours of Wednesday.

The deceased were identified as Bhagaban Paraja, 38, of Badap-indapadar village, Rukmini Pentia, 42, of Minaguda village, Jagannath Pujari, 29, of Dabuguda under Borigumma block, Shukra Majhi, 45, of Jagamguda under Semiliguda block, Phulmati Majhi of Koksara in Kalahandi district and Bati Khara of Machhra area in Koraput.

While Phulmati, Shukra and Rukmini had been admitted to the intensive care unit (ICU), Bati, Jagannath and Bhagaban were undergoing treatment in the general wards of the hospital. Their families alleged that they were administered injections, following which they died.

After reports surfaced, two separate investigations were ordered into alleged negligence in the hospital, officials said.

District Collector V Keerthi Vasan announced that a committee will be formed and the matter will be probed. SL-NMCH's superintendent Dr Susanta Kumar Sahu said that the state government has formed two DMET teams from Cuttack and Berhampur which

New Delhi, June 4: India's 16th Census with caste enumeration will be carried out in 2027 with the reference date of October 1, 2026 in snow-bound areas like Ladakh and of March

1, 2027 in the rest of the country. It has been decided to conduct Population Census-2027 in two phases along with the enumer-

ation of castes, the Union Home Ministry announced Wednesday. The Census is being carried out after a gap of 16 years as the last one was held in 2011. Over 30 lakh enumerators and their supervisors are likely to be

males and 586.46 million (48.46 per cent) were females.

'The reference date for Population Census - 2027 will be 00:00 hours of the first day of March 2027. For the Union Territory of Ladakh and the non-synchronous snow-bound areas of the UT of Jammu and Kashmir and states of Himachal Pradesh and Uttarakhand, the reference date will be 00.00 hours of the first day of October 2026," the ministry said in a statement.

The Home Ministry said the notification for the intent of conducting the Population Census with the reference dates will be published in the official gazette "tentatively on 16.06.2025, as per provision of section 3 of Census Act 1948".

Dhenkanal, June 4: Chief Minister Mohan Charan Majhi Wednesday launched development projects worth ₹308 crore in Dhenkanal dis trict.

During his day-long visit to the district, the Chief Minister inaugurated 12 projects worth ₹112 crore and laid the founda tion stone of 10 other projects worth ₹76 crore. He also partic ipated in the ground-breaking ceremony for Baji Rout Sports Complex worth ₹120 crore, an official statement issued by the CMO said.

On this occasion, Majhi also laid the foundation stone of four industrial projects worth over ₹50,000 crore, including ₹30,000-crore projects related to solar energy generation.

"Our goal is to make Dhen kanal district a solar energy-rich district. We will use solar energy as the main en ergy source not only for our state but also for the entire country," Majhi said adding that these projects will gen erate direct and indirect em ployment for 26,400 people.

Asserting that his govern ment was committed to meeting the aspirations of the people, Majhi said, "The new government has eight days left to complete one year in office. But, promises made to the people are being fulfilled quickly We will never break the trust of people.'

He said the Baji Rout Sports Complex will have a football field, synthetic athletic track, hockey training centre, indoor stadium, swimming pool, a hostel and other facilities.

Kyiv's daring drone strikes shake Kremlin's air power

OPERATION SPIDER'S WEB

In a stunning display of evolving war tactics, Ukraine's latest drone strikes on Russian airfields were both a strategic and symbolic blow to the Kremlin. The operation not only disrupted Russia's long-range bombing capabilities but also showcased Kyiv's ability to adapt under pressure, leveraging innovation and asymmetric warfare to strike far beyond the front lines. It signalled that despite troop shortages and limited resources. Ukraine can still impose serious costs on Moscow, shifting the psychological and operational dynamics of the war. The boldness and precision of the attacks echo earlier signature successes and mark a new phase in Ukraine's fight for control and credibility

kraine recently launched a bold and meticulously planned operation dubbed 'Spider's Web', one of its most daring drone strikes vet, hitting multiple Russian air bases across five regions. The strikes, which took place Sunday, mark a significant moment in Ukraine's evolution in asymmetric warfare, aimed at degrading Russia's strategic

bombing capabilities. According to The New York

Times, Ukrainian dronessome launched from trucks just miles away from key targetssuccessfully hit airfields in the Murmansk, Irkutsk, Ivanovo, Rvazan, and Amur regions. Verified footage showed drones striking the Olenya and Belaya air bases, damaging at least five aircraft, including four longrange Tu-95 bombers. Ukrainian officials claimed

117 drones were used, with 41 aircraft destroyed or dam-



aged—a figure Russia disputed. Still, even conservative Russian military bloggers estimated a dozen strategic bombers were hit, a major blow given Russia's limited ability to replace such aircraft.

Justin Bronk, an airpower expert at the Royal United Services Institute, said the operation could "significantly impact" Russia's capacity to launch regular cruise missile attacks. Ben Hodges, former commander of US Army Europe, called the operation a "real dent" in Russia's strike capability

This operation, reportedly overseen by President Volodymyr Zelenskyy and Ukraine's SBU intelligence chief Vasyl Malyuk, involved smuggling FPV drones deep into Russian territory. They were hidden in wooden crates with self-destruct mechanisms, transported on trucks near airfields, and then remotely launched to bypass traditional air defences.


Ukraine's strategy reflects a broader shift: targeting the 'archer' rather than intercepting the 'arrows'. With limited troops and international aid wavering, Ukraine is leveraging drone tech and innovation to keep Russia off balancemirroring past successes like the sinking of the Moskva and Black Sea drone raids.

Despite the tactical success, analysts warn the strike is unlikely to shift Russian President Vladimir Putin's political calculus. But as The Times notes, it sends a symbolic message: Ukraine can still strike at the

heart of Russia's war machine. Zelenskyy called it a move to force diplomacy: "Pressure is truly needed—pressure on Russia that should bring it back to reality." Yet the operation also raises risks of escalation and could test the resolve of Ukraine's Western allies. Still, experts like retired Australian Gen. Mick Ryan see it as a sign that "success in war favours those who learn and





Newlywed couple found hanging in Rayagada

Rayagada, June 4: A newly-married couple was found dead under mysterious circumstances in this district. The couple, who had tied nuptial knots seven months ago after a relationship, were found hanging from a tree late Tuesday night at Paikakupakhal under Maikanch panchayat of Kashipur block.

The deceased have been identified as Abhi Jhodia, 27, and his wife Amita Jhodia, 24, residents of Paikakupakhal. According to reports, the couple had been living separately from their families following

their marriage. Villagers spotted their bodies hanging from a tree near the village Wednesday morning, and immediately informed the Andirakanch police.

Police reached the scene recovered the bodies, and sent them to Kashipur community health centre (CHC) for post-mortem. The bodies were later handed over to the respective families. "A case (3/25) has been registered at Andirakanch police station, and an investigation is underway," said the police.

In written complaints to the police, both families confirmed that the two were in a relationship before getting married. However, the reason behind their reported suicide remains unclear. Locals have expressed concern and are demanding an impartial investigation, as suspicions of possible foul play have not been ruled out. Police said further clarity would emerge after a detailed inquiry.

Bhubaneswar, June 4: Reaffirming the state government's commitment to making land administration modern and people oriented, Chief Minister Mohan Charan Majhi Wednesday said no one in Odisha will

remain landless. Speaking at the State Revenue Officers' Conference and Workshop here, Majhi said, "No one in Odisha will remain landless. Even those

who own less than four decimals of land will be considered landless and will be provided with land by the government." Majhi highlighted the cru-

cial role of revenue officers in implementing this initiative effectively. Describing tehsildars as

the backbone of revenue administration, the Chief Minister urged them to listen to the grievances of the people and address them promptly. "Your office should not be a place of fear for the people —

it should be a place of trust,' Majhi said. He advised the revenue officers to reach out to the marginalised sections of society and ensure timely and fair services in villages. The Chief Minister also ex-

pressed concern over the encroachment of valuable government land and instructed officials to reclaim and protect such land.

"In the coming days, the government will introduce reforms across various revenue sectors to ensure swift resolution of sub mission-rejection cases and other land acquisition matters within set deadlines," Majhi said.

He emphasised the need for complete transparency in handling land acquisition cases. Addressing irregularities in the purchase and sale

of land by tribals and Sched uled Castes, the Chief Minister stressed that there should be no exceptions in addressing such disputes.

"If there is any lapse in this regard, the officer in question will be held accountable," he warned, adding that the government has a zero-tolerance policy towards such issues.

Four fall ill in ammonia gas leak at ice factory

Paradip, June 4: Four persons, including an elderly woman, fell ill following an ammonia gas leak incident at an ice factory in Paradip, according to reports.

All the afflicted persons were admitted to Biju Memorial Hospital and discharged after receiving treatment.

It took around three and half an hour for the state Fire and **Emergency Services personnel** to contain the gas leak, according to the officials.

"A swift and coordinated response by our personnel averted a major industrial mishap following an ammonia gas leak at the Paradip Ice Factory," a statement by the department said.

The fire brigade was informed regarding the incident at about 11:03am and a team from Kujang Fire Station, led by station officer Kartik Kumar Biswal, reached the site by 11:19am and immediately

began emergency containment operations, which continued until 2:05pm. Two ammonia cyl inders, each containing 60 kg, were found to be leaking. These were safely relocated from the premises. The ice factory had a total stock of eight cylinders (480 kg), but only the two leaking units were affected, an of ficial said.

As a precautionary measure, all factory personnel were promptly evacuated, and entry to the premises was strictly re stricted during the operation.

The fire team operated under chemical safety protocols using fire proximity suits, breathing apparatus sets, helmets, gum boots, and continuous water spray to dilute the concentration of ammonia and minimise exposure risk.

"Fortunately, there was no fire or explosion, and no human injuries or casualties," the of ficial said, adding that support was also extended by fire units from PPL and IFFCO.




Ex-jawan trains youth to join Indian Army

Berhampur, June 4: Simanchal Barik, a retired Indian Army jawan, has established Berhampur Physical Academy at Anantanagar here to train youths who aspire to join the armed forces. What began with just four unemployed youths has now grown into a thriving training centre. Today, the academy trains more than 500 aspirants, including over 80 girls from Odisha and other states.

Reports indicate that Simanchal comes from a poor family. His father Pitambar Barik had moved his family from neighbouring Gajapati district to the outskirts of Ganjam, eventually settling in Ramnagar near the railway station. Among his six children Simanchal is the fifth, whose early life was marked by poverty and struggle.

Despite financial woes, Pitambar enrolled Simanchal in Class I at the Government Municipal High School in Berhampur's Courtpeta area. Pitambar somehow could gift his son a single school uniform and a few books each year. When the uniform tore, it was stitched and reused. Ashamed of his worn clothes, Simanchal often hesitated to attend school.



Yet he harboured a dream to support his mother financially and make her happy. He frequently skipped classes to work and help her, gradually drifting away from school. Despite this, he managed to reach Class IX and even appeared Class X exam. Though unprepared, he passed, thanks to one of his friends who gave him a guidebook and encouraged him to memorise the lessons.

Later, motivated by another friend. Simanchal applied to join the Indian Army. It was January 15, 2001 when he ap-

peared for a recruitment test that included a 1,600-metre race. While others dropped out after three rounds, Simanchal completed all the four rounds. and cracked the test.

However, fate had something else in store as just days into the training his family received a phone call claiming Simanchal had been shot dead. Though the news turned out to be false eight days later, the initial shock snatched the life of his mother, who died of a cardiac attack. The loss devastated the family. Though tempted to Championship in Philippines in 2023, winning a silver and a bronze medal.

Then he established Berhampur Physical Academy at Anantanagar, 6th Lane in the Silk City, to train the Army aspirants. What began with just four unemployed youths has grown into a thriving training centre.

The academy has also become a hub for general fitness. Over 180 boys and 30 girls are enrolled for weight reduction and fitness training. The academy runs a YouTube channel 'Barik Command Fitness' offering online coaching and motivational content.

Significantly, no fee is charged for physical training. Only aspirants who opt for academic coaching to clear the written exams are required to pay ₹7,000 valid until selection. Hostel accommodation costs ₹4,500 per month, with a one-time admission fee of ₹1,000. Currently, five hostels in the city house the trainees

Several students from the academy have already been recruited into the armed forces. Simanchal said their mission to inspire and prepare youth for service in the Indian Army will continue in the years ahead.

Challenge & Opportunity

hen climate change is framed as a global problem requiring collective regulation of greenhouse-gas emissions, developing-country governments see little reason to prioritise the issue over others. After all, the rich, industrialised countries who contributed disproportionately to the problem are themselves backing away from decarbonisation and climate-finance commitments, while low-income countries bear the brunt of the costs of climate change. Decision-makers in developing countries understandably conclude it may be more rational to hunker down and focus on climate resilience rather than emissions reductions

But this is not the only way to frame the problem. While climate change undoubtedly poses a global collective-action problem, in practice climate outcomes are shaped by myriad decisions concerning development objectives such as industrial development, urbanisation, job creation, and local pollution management. Because late developers often have not entirely locked into energy systems, transport infrastructure, urbanisation plans, and energy consumption patterns, they have greater flexibility to steer investment and consumption choices toward lower-carbon and climate-resilient options.

In other words, the climate challenge can be framed as a choice among

alternative development pathways. In many cases, development choices are also climate choices, and in a world where being a low-carbon economy confers a competitive edge, the absence of structural lock-in could be turned into an advantage.

Pursuing a climate-as-development approach is not easy or foolproof: It requires considerable state capacity, strategy-setting capabilities, and full mobilisation of the necessary technologies and finance. Importantly, it does not negate concerns about climate equity. Developing countries may opt to pursue the climate-as-development opportunity, but rich countries that disproportionately caused the problem remain on the hook to support this transition. Yet, this perspective offers an alternative to the zero-sum framing of climate policy and a basis for nationally specific visions.

An important starting point is that elites internalise and support low-carbon development as a potential opportunity, with climate resilience as a necessary component. Climate objectives cannot trump development goals, but, equally, development innocent of climate considerations is no longer viable. To be politically feasible, any strategy must be rooted in the national context. Low-carbon development pathways are not easily replicable and need to be tailored to geography, local capacities, and other variables. And, as with any long-term structural change, a durable, widely shared national narrative is needed (South Korea's "green growth" in the 2010s is a useful example)

Shifting from narrative and vision to policy and implementation requires high levels of state capacity. Technical capabilities, along with the ability to identify climate-as-development opportunities and sources of climate vulnerability, are necessary, but by no means sufficient. In addition, as sociologist Peter Evans' analysis of East Asian industrial policy reminds us, the state must be simultaneously "embedded" to engage and support private-sector players, and maintain sufficient 'autonomy" to avoid capture.

In practice, this means building institutions that can set the strategy, coordinate across sectors and at different scales, and provide trusted platforms to mediate conflict, ideally enshrined in law. All too often, climate policymaking is entrusted to relatively weak or siloed environmental ministries that cannot organise or enforce an all-of-government approach. Moreover, because broad structural changes can introduce distributional concerns and leave some communities behind, deliberative bodies - such as South Africa's Presidential Climate Commission - can help to entrench low-carbon options by mediating social frictions and maintaining broad-based political buy-in. Another major challenge for developing and emerging economies facing high capital costs is mobilising adequate finance for capital-intensive low-carbon development. There are no easy answers here. According to BloombergNEF, global investment in the low-carbon energy transition in 2024 was only around one-third of the annual amount required through 2030, and there were wide disparities in spending. Developing countries have experienced few tangible gains from multilateral initiatives to scale up climate finance and reform the international financial architecture. Holding advanced economies to their financing commitments should remain a priority; but developing countries also need to mobilise more domestic finance and develop credible investment programmes to attract global capital. Recent efforts to create "country platforms" – government-led coordination mechanisms that articulate a vision and identify financing pathways to achieve it - suggest one way forward. In preparing to host this year's United Nations Climate Change Conference (COP30), Brazil is seeking to lead the way with a comprehensive multisectoral development programme to mobilise investment. Independent research suggests that Brazil has all the ingredients for a successful green industrial transformation: a strong resource base, a legacy of advanced manufacturing, and a large market. Such models are worth exploring elsewhere, provided that they reflect a national vision, not donor-driven objectives. One common criticism of nationally led, multi-objective development strategies is that the urgency of the climate crisis demands more direct action focused on emissions reduction, rather than on the indirect pathways suggested here. But this view ignores political reality. If climate action is seen to be at odds with other development objectives, it will lose. The only option is to devise strategies that can realise both sets of goals. The most effective climate policy over the long term might be one that shapes structural choices regarding urbanisation and industrialisation, rather than one that focuses narrowly on regulating emissions. With the scope for global cooperation receding in today's fraught geopolitical environment, these arguments should not be interpreted as a call for atomisation. On the contrary, developing national visions for low-carbon, resilient economies would benefit from mutual learning and enhanced coordination rooted in attention to local contexts. Moreover, deploying low-carbon technologies will require investment in stable value chains, which depends on political and economic predictability. Developing countries, in particular, will have to be strategic and nimble in finding a niche for themselves. And the provision of finance at the necessary scale will still depend on a threshold degree of global cooperation.



CARBON EMISSION DUE TO PLASTIC POLLUTION ALONE WILL AMOUNT TO 14 PER CENT

OF THE TOTAL GLOBAL EMISSIONS BY 2050

million tonnes mark by 2050 according to one estimate. Of the total world production, only 9 per cent is recycled and 12 per cent is incinerated and the rest is dumped in nature causing severe damage to our fragile environment. India produces 3.4 million tonnes of plastic waste in a year out of which only 30 per cent is recycled. India ranks as the fifth largest producer of plastic in the world.

The most alarming impact of plastic pollution is in the seas of the world. It is estimated that around 8.8 million tonnes of plastic waste are dumped into the sea every year. This is equivalent to the dumping of nearly one truckload of plastic garbage into the sea every minute. These plastic materials break into fine particles over the years called microplastic that enters into the marine food chain to

eventually make their way to animals like whales, dolphins, turtles and aquatic birds. It chokes their stomach greatly reducing their food ingestion ability ultimately leading to their death. It is estimated that nearly one lakh sea birds die each year as a result of

plastic pollution of the sea. Similarly, plastic pollution has also cast its footprints on land. Many animals eat away plastic items mistaking them as food that ultimately choke their food path and intestines. The microplastic materials also enter the bloodstream in humans which causes diseases like cancer and triggers hormonal imbalances leading to retarded growth and reduced cognitive ability. It is estimated that nearly one lakh land animals die every year as a result of plastic pollution. Plastic contamination also reduces soil fertility and affects

the water retention capability of the soil. Another devastating dimension of plastic usage is the proliferation of Single Use Plastic (SUP) items which has been greatly infused into today's busy urban lifestyle.

Since the production of plastic from its source of fossil fuels and its disposal techniques by incineration amount to the release of vast amounts of greenhouse gases into the atmosphere, plastic has greatly contributed to global warming and climate change over the years. It is estimated that the carbon emission due to plastic pollution alone will amount to 14 per cent of the total global emissions by 2050 leading to vast climatic catastrophe.

As a way out of this menacing problem, we should minimise the consumption of plastic products in our daily life. The use of SUP items should be completely banned from public life. Scientists should come up with the discovery of new biodegradable plastic materials which should also be cost-effective at the same time to promote their mass use. New innovative methods for disposal of plastic items without affecting nature should also be explored. Most plastic items should be recycled into new utility products rather than making them anew from raw materials again. Our mantra should be Reduce, Recycle and Reuse with a far-reaching goal of transition to a plastic-free society and eco-friendly lifestyle.

lastic is abundantly present everywhere, starting from the North Pole to the South Pole. It takes a variety of forms, from synthetic fishing nets to single-use items like water bottles and trash bags. If all plastic waste in the ocean were collected, it would fill 5 million shipping containers which can stretch 30,000 kilometres if placed end to end. And because plastic is not at all biodegradable, it simply breaks apart into smaller and smaller pieces over time, creating what's known as micro- or nanoplastics. Despite being tiny in size, microplastics and nanoplastics pose a massive threat to human health and the health of vital ecosystems. These microplastics act as little sponges and come with a lot of different chemicals that get absorbed, all these affect our health system and can cause endocrine alterations. When you look at the human health impacts of plastics, some of them have been linked to possibly being cancerous. They also infiltrate and contaminate every part of the planet, from everyday things like our clothing and laundry to remarkable places like the summit of Mount Everest or

If we can reduce production that would significantly help. And then hopefully, as behavioural change occurs, we then use alternatives, or we go back to what we used in the past. We need to identify which are the plastics that we still need, and we need to improve infrastructure to recy cle. We cannot rely solely on recycling to fix the problem. Not all plastics are made the same either. So, identifying what type of materials can be recycled and where is key. A variety of economic, social, and cultural reasons are part of why recycling isn't always ideal. In addition to government action, there is urgent need of efforts to raise advocacy and awareness. Individuals and communities must continue to use their voices to talk about the need to end plastic pollution and put their values into practice by supporting businesses striving to reduce single-use plastic products in their supply chains. Anyone can participate. Anyone can make a difference locally. Anyone can take their advocacy efforts to the next level.

REUSE REFERS TO THE TRANSFORMATION **OF THE 'THROWAWAY**

ECONOMY' INTO A 'REUSE SOCIETY'

And it's not just humans who are being negatively impacted; ocean ecosystems are harmed as well. Plastics have been shown to affect reproduction abilities in animals, which has serious implications not only for our food chain but also for communities that rely on those ecosystems for their livelihoods.

As a fast-growing source of greenhouse gas emissions, United Nations Environmental Programme (UNEP) estimates that plastic production, use, and disposal could account for 19 per cent of the total global carbon budget by 2040. Still, it is entirely possible to meet UNEP's ambitious goal of reducing plastic waste by 80 per cent in the next two decades. A systems change is needed to address the cause of plastic pollution. It combines reducing the most problem-

ucts deliver their function to society, e.g., substituting dry products for liquified ones so we do not need to transport water and the products can then be packed in simpler materials. Reuse refers to the transformation of the 'throwaway economy' into a 'reuse society' where reusing products and refilling them makes more economic sense than throwing them away. Reorient and diversify refers to shifting the market towards sustainable alternatives, which will require a shift in the way products and packaging are produced. consumer demand, regulatory frameworks and costs. Finally ensuring that where plastics are produced, they are designed to be recyclable in the market where they are sold and that waste management and the recycling market become more viable ventures. Today, only nine per cent of plastics produced are mechanically recycled.

Crackdown on freedom

Sir, The Tiananmen Square crackdown of 4 June, 1989 stands as a defining moment in modern Chinese history, symbolising the tension between state authority and democratic aspirations. What began as a peaceful movement led by students, intellectuals, and workers seeking political reform, freedom of expression, and an end to corruption, soon escalated into a nationwide call for change. Initially met with passive tolerance, the Chinese government imposed martial law and deployed the People's Liberation Army to forcibly suppress the demonstrators. On the night of June 3-4, troops and tanks moved into central Beijing, opening fire on unarmed civilians. The death toll remains uncertain, with credible estimates ranging from several hundred to several thousand. The consequences of the crackdown were both immediate and enduring. Reform-minded leaders such as Zhao Ziyang were sidelined, while figures like Jiang Zemin emerged to consolidate a more conservative and authoritarian trajectory for the Communist Party. In the aftermath, the state initiated aggressive censorship policies, erasing references to the incident from educational curricula, media discourse, and digital platforms-a strategy that has rendered the event virtually unknown to younger generations within China. The image of the anonymous "Tank Man" remains an iconic symbol of individual defiance, even as Chinese authorities continue to censor its memory.

Reasi, June 4: A century-old dream of connecting the Kashmir Vallev by rail is finally turning into reality as Prime Minister Narendra Modi is set to flag off the first Vande Bharat train from Katra to Kashmir Friday. He will also inaugurate the Chenab bridge, the world's highest railway arch bridge, marking a historic milestone in

India's infrastructure development. The vision dates

back to March 1, 1892, when Maharaja Pratap Singh of the Dogra dynasty proposed a railway line to Kashmir. British

engineers were engaged to survey the treacherous terrain, and between 1898 and 1909, three detailed reports were submitted. The first, by DA Adam, suggested a narrow-gauge electric railway, but was rejected due to elevation challenges. The second, by WJ Weightman, proposed a route from Abbottabad along the Jhelum River, which was also declined. The third report, by engineer Wild Blood, recommending a route along the Chenab River through Reasi, was finally accepted.

Plans to power electric trains and establish power stations were explored but later



dropped. British engineer Col DE Bourel and geologist TD La Touche were then tasked with studying coal reserves to support rail operations. However, the death of Maharaja Pratap Singh in 1925 and the intensifving freedom movement led to the shelving of the project.

The idea was revived in 1983 when Prime Minister Indira Gandhi laid the foundation for the Jammu-Udhampur-Srinagar rail line, then estimated to cost 50 crore and expected to be completed in five years. But progress was slow—only 11 km of track was built in 13 years, costing 300 crore. In 1996 and 1997, PMs H D

Deve Gowda and I K Gujral laid foundation stones at Udhampur, Qazigund, and Baramulla for a broader Udhampur-Katra-Baramulla railway project. Construction officially began in 1997, but severe geographical and weather challenges caused repeated delays and escalated the cost to over

43.800 crore. Recognising its strategic and national significance, the Udhampur-Srinagar-Baramulla

Railway Line (USBRL) was declared a national project in 2002. So far. 209 km of the 272 km stretch has been commissioned in phases: Qazigund-Baramulla (2009), Banihal-Qazigund (2013), Udhampur-Katra (2014), and Banihal-Sangaldan (2023). The final link from Katra to Sangaldan was completed in February 2024

This engineering marvel includes 38 tunnels and 927 bridges, with the Chenab bridge as its crowning glory—standing 359 metres above the riverbed, 35 metres higher than the Eiffel

Eid animal sales slump in Kashmir after attack

Srinagar, June 4: Shadow of the Pahalgam terror attack loomed over Eid-ul-Azha shopping in different parts of Kashmir, including Srinagar, with sales of sacrificial animals remaining sluggish so far.

Most people here link the sluggish trade to the Pahalgam terror attack, which killed 26 people April 22, saying people now want to hold on to their cash.

The deadly terror attack with cross-border links triggered a military response by India, which targeted multiple terror hideouts in Pakistan and Pakistan-occupied Kashmir under **Operation Sindoor.**

'Only last month, India and Pakistan almost went to war. In such a scenario, people are avoiding spending unnecessarily, leading to lesser economic activities over the past one-anda-half months," Jamal Ahmad, a local businessman, said.

Livestock dealers from across Jammu and Kashmir have descended on Srinagar, the summer capital of the Union Territory, in the hope of selling the sacrificial animals even as they find fewer takers. "The business has been on the slower side ever since the outbreak of the Covid pandemic. However, the sales this year are simply the lowest," Mohammad Asim. a goat trader from Samba district, told PTI at the

coming to Srinagar with his flock for the past 15 years, said the business was never so bad

"With less than three days to go for Eid, we would usually be planning our trip back home Even last year, the sales were not very good but we still managed to sell more than half the livestock by this time," he said. Mohammad Akhtar, a Bak

erwal from Poonch, said he might have to take some of his animals back to his village if the sales do not improve.

"I have slashed the rates by ₹50 per kg in the hope of doing some business. Last year, I sold sheep for ₹380 per kg, but this year the customers are bargaining even at ₹350 per kg, Akhtar said.



Hathras satsang stampede: Next hearing June 13

Hathras (UP), June 4: A court in Hathras district Wednesday briefly heard arguments in connection with the July 2024 stampede during a satsang of preacher Surajpal that claimed 121 lives and scheduled the next hearing for June 13.

During the day's proceedings, Supreme Court lawyer AP Singh appeared on behalf of the accused event organisers and told the court that the incident was a "conspiracy" and that they would expose the truth through a petition.

The incident had taken place July 2 during the satsang of Surajpal alias Bhole Baba alias Narayan Sakar Hari in Bulgarhi village in the Sikandra Rao tehsil. "What happened July 2 was not an accident but a planned conspiracy. We will file a petition naming those responsible for triggering the chaos and spraying toxic substances that led to the deaths." Singh said. "All 11 accused in the case are currently out on bail," Singh told PTI. "Except for Sanju Yadav, all were present in court today. Arguments are currently ongoing on the framing of charges,' he added. According to Singh, there is evidence and facts supporting the claim that outsiders orchestrated the stampede for political gains after seeing the large gathering

Lucknow, June 4: His countdown to space, the final frontier, has begun. And Group Captain Shubhanshu Shukla's family and friends are anxiously ticking off the days before he lifts off on board SpaceX's Falcon-9 rocket that will propel him into history as the first Indian to step onto the International Space Station (ISS).

The 39-year-old Lucknow boy's much anticipated space voyage, scheduled June 10 from the Kennedy Space Centre in Florida, will also mark India's return to human spaceflight after Rakesh Sharma's 1984 odyssey.

"It's true that as our son stands on the brink of history and is set to represent India in NASA's AXIOM-4 mission to the ISS. It's an immensely proud moment not just for us

but for the country, and we are praying for the success of this space mission each day,' Shukla's Lucknow-based father Shambhu, a retired government employee, told PTI.

"He calls us up each day to check on our well-being and to make us feel comfortable before his space trip that holds its own significance for the country," he added.

The family hasn't seen him in a year and a half as he has been in intensive training.

According to his elder sister Suchi Mishra, there is so much talk of the space mission that don't mention it very much during their conversations. "We keep our conversation as normal as possible. We are eagerly waiting for the mission's success and for our brother to

be back home with us. She recalled that her brother would talk excitedly about

aircraft as a child and this is a dream come true.

"As a child he had once been to an air show, and he later told me how he was fascinated by the speed and sound of the air crafts. Then he had spoken of his dream to fly, but of course there was no telling at the time how quickly he would embrace

his dream.

"As an Indian and as his sister, it's definitely a very proud moment, for this space journey of my brother is carrying with them the hopes and blessings of a billion Indians," Suchi told PTI.

The 14-day space flight is being seen as preparatory to the Indian Space Research Organisation's (ISRO) own Gaganyaan human-spaceflight programme.

The City Montessori School (CMS), where Shukla studied right from the beginning to primary classes to class 12, is also agog with excitement. Ensuring that its students don't miss out, the management is making special arrangements to watch the action live.

More than 62,000 students from across all its branches will be watching to celebrate Shukla's journey from class-

rooms to space, said CMS manager Geeta Gandhi Kingdon.

"We are all behind Shubhanshu and praying for his success, as his journey also embodies our motto of 'Jai Jagat' one that will inspire each student to aim for the stars," Kingdon told PTI.

Nageshwar Prasad Shukla, Shukla's Maths teacher at CMS's Aliganj branch in Lucknow, is currently on the Char Dhaam Yatra pilgrimage in Uttarakhand and said he was praying for the success of the space mission of one of his brightest, most focused students.

"As a teacher, I am delighted at the way he has progressed through sheer hard work and is now set to embark on a space odyssey to the ISS that no Indian has ever undertaken before," Nageshwar told PTI over the phone.

ing to a new report The report by the Geneva-based Internal Displacement Monitoring Centre (IDMC) said disasters triggered 264.8 million internal displacements or forced movements across 210 countries and territories during this period.

Stampede triggered by fan chaos, official lapse



Bangalore, June 4: "I don't know what we did wrong...we had tickets," an exasperated RCB supporter wondered outside the Chinnaswamy stadium, watching what was meant to be a day of celebration become a day of mourning after 11 fans were killed in a mad scramble to attend the team's IPL victory party here.

Thirty three of the team's injured supporters had to be hospitalised after a chaotic day. "When one organises a victory celebration of this magnitude...safety and security measures need to be taken," BCCI secretary Devajit Saikia told PTI, taking note of the lack of preparedness to deal with the lakhs who crowded the streets, desperate to catch a glimpse of their favourite stars, including the enigmatic Virat kohli.

The tickets for the hastily-arranged engagement programme were sold in a jiffy, but the fans crowded all the gates 12, 13 (main gates) and 10 (club house entrance) with not enough security to control them. The number swelled to unexpected levels around 3.30pm and it forced the police and stadium security officials to close all the gates to prevent the ticket-less from squeezing in along with the ones who had valid tickets.

"We came to watch our stars. I bought tickets for the function but was not even able to enter the stadium. Police suddenly blocked all the roads and closed

At around 4.30 pm many more came from the nearby Cubbon Park metro station, worsening the situation and the police had to resort to mild use of force to disperse the huge gathering. At Gate No. 10, the situation was grimmer as women and children were shoved around forcefully, and even this reporter was pushed to a corner by a police official with a lathi who also hurled some swear words in local dialect.

Several ticket-holders had no choice but to make a retreat from the venue albeit thankful that they escaped unscathed

from what became a stampede. Even from a distance, it was disturbing to see women fainting and some others getting crushed under the feet of iostling fans. The fan engagement function lasted close to an hour and the team went back to the hotel around 6.30 pm but the fans still remained near the stadium creating further traffic block and chaos, before slowly moving away after a tragic day.

A list of major stampedes in India

Here is a list of some other tragedies that have taken place in the country in recent years:

Over 50 people have been killed in stampedes this year at temples, railway station and at the Maha Kumbh among others.

On February 15, a stampede broke out at New Delhi Railway Station's platform number 14 and 15. Eighteen people were killed and 15 injured, mostly pilgrims visiting Maha Kumbh in Prayagraj.

During the Maha Kumbh, a Stampede January 29 at the Sangam area as millions as pilgrims were jostling for space to take a holy dip on the auspicious occasion of Mauni Amavasya resulted in the death of 30 people and injuries to 60.



December 4, 2024: A 35-year-old woman died and a boy was injured at Sandhya Theatre in Hyderabad in a stampede where Allu Ariun's blockbuster 'Pushpa 2' was screened.

July 2, 2024: At least 121 people, including women and children, were killed after a stampede broke out at a 'satsang' (prayer meeting) organised by self-styled godman, Bhole Baba aka Narayan Saakar Hari, in Uttar Pradesh's Hathras.

March 31, 2023: At least 36 people died when the slab constructed on top of an ancient 'bawdi' or well collapsed during a 'havan' ceremony held on the occasion of Ram Navami at a temple in Indore city.

Australia backs India's fight against terrorism

New Delhi, June 4: Australia backs India's fight against terrorism and it considers ties with New Delhi crucial for Canberra's national interest, Australian Deputy Prime Minister Richard Marles said Wednesday.

During talks with Defence Minister Rajnath Singh, Marles welcomed the cessation of military actions between India and Pakistan, and described it as "an act of Indian leadership"

In the meeting, India and Australia agreed to expand their strategic cooperation for peace and stability in the Indo-Pacific. The Pahalgam terror attack and Pakistan's support to cross-border terrorism figured in the Singh-Marles talks.

In his remarks, Singh hailed Canberra's unequivocal support to New Delhi's resolute response to the Pahalgam attack. We acknowledge and welcome the stoppage in military activity. We see this as an act of Indian leadership," Marles said in his televised opening remarks.

On his part, Singh highlight ed India's right to respond in self-defence against Pakistan-backed terrorism and its actions following the dastardly attack were measured, non-escalatory and responsible. The Australian leader said Canber ra's relationship with New Del hi is of the "highest priority" and that it is profoundly significant to Australia's national

interest. The visit to New Delhi by Marles coincides with the fifth anniversary of the firming up of India Australia Comprehensive Strategic Partnership that facilitated deeper bilateral defence ties. Singh. and Marles who is also Australia's defence minister, agreed to intensify and diversify defence-industrial collaboration.

In a separate meeting with Prime Minister Narendra Modi, the Australian leader reit erated Canberra's support to India's fight against cross-border terrorism, according to an official statement. Modi congratulated Marles on the historic victory of the Australian Labor Party in the recent federal elections, it said.

9 killed as trailer overturns on van in Jhabua

Jhabua (MP), June 4: Nine persons, including five minors, were killed and two others injured after a cement-laden trailer truck overturned and crushed a van in Madhya Pradesh's Jhabua district in the wee hours of Wednesday, police said.

Prime Minister Narendra Modi and Chief Minister Mohan Yadav expressed grief over the incident and announced financial assistance for the victims' kin.

The trailer was crossing an under-construction rail overbridge through a temporary road near Sanjeli railway crossing when it overturned on the van, Jhabua Superintendent of Police (SP) Padmavilochan Shukla told PTI. Nine persons were killed and two others injured in the accident, he said. "Deeply anguished by the loss

of lives due to an accident in Jhabua, Madhya Pradesh. Condolences to those who have lost their loved ones. May the injured recover soon," said the Prime Minister's Office on X, quoting the PM. "An ex gratia of Rs 2 lakh from PMN-RF (Prime Minister's National Relief Fund) would be given to the next of kin of each deceased. The injured would be given Rs. 50.000." it said.

"No doubt, Article 19(1)(a) of the Constitution of India guarantees freedom of speech and expression, this freedom is subject to reasonable restrictions and it does not include the free dom to make statements which are defamatory to any person or defamatory to the Indian Army," the judge said in the detailed order released later.

The case stems from a com plaint filed by Udai Shanker Srivastava, a retired Director from the Border Roads Organisation (a position equivalent to a Colonel in the Indian Army)

Srivastava alleged that on December 16, 2022, during his 'Bharat Jodo Yatra' in Lucknow, Gandhi made disparaging comments about a face off between the Indian and Chinese armies in Arunacha Pradesh December 9, 2022. Srivastava contended that Gandhi's statement was "false and baseless" and made with "evil intention of demoralising the Indian Army and to damage the faith of the Indian population in the Indian Army.

He highlighted that the official statement from the Indian Army on December 12, 2022 confirmed that "PLA troops contacted the LAC in Tawang Sector which was contested by our troops in a firm and resolute manner. This faceoff led to minor injuries to a few personnel from both sides.'

'Most Delhiites want urgent steps to tackle air pollution'

New Delhi, June 4: Delhi residents want the government to prioritise immediate action to reduce air pollution by focusing on curbing stubble burning in neighbouring states, covering construction sites, and ensuring regular cleaning of roads. according to a new survey by online survey platform Local-Circles

According to the survey, 8 out of 10 residents support urgent measures to check stubble burning outside Delhi, which is one of the key triggers of poor air quality during the winter months. It also found that around 70 per cent of the respondents want stronger enforcement against open garbage burning.



The findings come at a time when the Delhi government has announced a 25-point action plan, 'Shuddh Hawa Sabka Adhikar - Pradushan Par Zordar Prahar', under the Air Pollution Mitigation Plan 2025 launched ahead of World Environment Day (June 5).

Out of over 11,700 residents who responded to the question on pollution measures, 70 per cent called for stronger coordination with the neighbouring states to curb stubble burning. The same percentage of re-

spondents also supported mandatory covering of construction sites and mechanised street cleaning during the critical October-December period, according to LocalCircles.

The survey highlighted that 67 per cent of the respondents wanted the authorities to strictly enforce the ban on waste and garbage burning.

Another 67 per cent respondents to another question wanted the use of dual-fuel kits in diesel generator sets across Delhi, while 33 per cent supported plans to reduce vehicle use on city roads by half during the peak pollution months, according to the survey.

The survey mentioned that despite the government's new plan, only one-third of the residents believe it is actively taking steps to bring pollution levels down significantly this year.

In another poll conducted by LocalCircles among over 14,700 people, 58 per cent said the government was not doing enough to curb air pollution, 33 per cent said steps were being taken, while 9 per cent respondents were unsure.



Chandigarh, June 4: A Punjab-based YouTuber alleged to be in close touch with influencer Jvoti Malhotra, who is in custody on charges of spying for Pakistan. has been arrested after a "terror-backed espionage network" linking him to Pakistani intelligence and army officials was unearthed, police said Wednesday. Puniab Director General of

Police Gaurav Yadav said Jasbir Singh alias Jaan Mahal (41) was allegedly spying for Pakistan's Inter-Services Intelligence (ISI). Singh, a resident of Mahlan village in Rupnagar, was running the YouTube channel "JaanMahal Video" with over 11 lakh subscribers, ostensibly posting travel and cooking vlogs, said police.

He was found to be associated with Pakistani Intelligence Operative (PIO) Shakir alias Jutt Randhawa, who was in contact with a recently-expelled Pakistan High Commission official on charges of spying and had met Pakistan Army officials during one of his three visits to the neighbouring country, Yadav said.

A Mohali court sent Singh to three-day police remand after he was produced before it. Singh also maintained close contact with Ehsan-ur-Rahim alias Danish, the expelled Pakistan High Commission official, said Yaday. Investigation found that Singh attended the Pakistan National Dav event in Delhi on Danish's invitation, where he met Pakistani Army officials and vloggers.

New Delhi, June 4: The Congress Wednesday alleged that the government has announced the start of the Monsoon session of Parliament 47 days before it is due in order to run away from the demand of the party and INDIA bloc for an immediate special session to discuss the Pahalgam attack and the Centre's failure to bring the terrorists to justice.

Parliamentary Affairs Minister Kiren Rijiju Wednesdav said the Monsoon session of Parliament will be held from July 21 to August 12. The Cabinet Committee

on Parliamentary Affairs, chaired by Defence Minister Rajnath Singh, has recommended the dates, he told reporters here. In a post on X, Congress general secretary. communications, Jairam Ra-

mesh, said normally the dates for a Parliament session are announced a few days in advance, but "never have the dates been declared 47 days before a session is due"

'No reason to delay Census

New Delhi: Soon after the Centre announced the Census schedule, the Congress Wednesday said there is no reason to delay the exercise for another 23 months and alleged that the Modi government does not meet deadlines. The 2027 Census with caste enumeration will be carried out with the reference date of October 1 2026 in snow-bound areas like Ladakh and of March 1, 2027 in the rest of the country, the Home Ministry announced Wednesday In a post on X, Congress general secretary (communications) Jairam Ramesh said, "There is really no reason to delay the Census that was due in 2021 for another twenty three months. The Modi Government is capable only of generating headlines, not meeting deadlines."

Illegal mining near Kaziranga intensified despite SC ban: CEC

New Delhi, June 4: The Central Empowered Committee (CEC) has told the Supreme Court that illegal mining has continued and intensified in Assam's Parkup Pahar area near the Kaziranga National Park, despite a 2019 top court order banning all mining and related activities in and around the park's eco-sensitive zone.

Kaziranga, a UNESCO World Heritage Site, is home to around 65 per cent of the endangered one-horned rhino population in the world. It forms part of an important wildlife corridor between the Brahmaputra floodplains and the Karbi Anglong hills.

Based on a complaint from an anonymous government employee in Assam and field-level verification, the CEC submitted a fresh report dated May 30 to the SC. saying that mining activities in the region have "continued and intensified" despite the apex court's ban ordered on April 4, 2019.

The complaint received from the government employee in December 2024 contained Google Earth imagery from 2018 to 2024 and site-specific data.

images reportedly The showed that mining, which had stopped following the SC's 2019 ban order, resumed and intensified after 2021. The CEO forwarded the complaint to the Assam forest and police departments, requesting a fac tual report.

The principal chief conservator of forests, Assam, submitted a detailed report February 5, outlining the actions taken including the suspension of mining leases. The report confirmed that stone mining was occurring close to the

A series of technical review meetings were held June 2 and 3 under the chairpersonship of Director General of Health Services (DGHS) Dr Sunita Sharma.

The meeting was held with representatives of Disaster Management Cell, Emergency Management Response (EMR) Cell. National Centre for Disease Control (NCDC), Indian Council of Medical Research

(ICMR), Integrated Disease Surveillance Programme (ID-SP) and central government hospitals in Delhi and with representatives from all states and Union territories to evaluate the current Covid situation and preparedness measures.

According to the sources, state and district surveillance units under IDSP are closely monitoring Influenza Like Illness (ILI) and Severe Acute Respiratory Illness (SARI).

"Testing is recommended for all admitted SARI cases and 5 per cent of ILI cases as per guidelines and positive SA-RI samples are sent for Whole Genome Sequencing through the ICMR VRDL network," an official source said. As of June

Islamabad, June 4: PPP chairman and former foreign minister Bilawal Bhutto-Zardari has said that cooperation between Pakistan and India's intelligence agencies could significantly reduce terrorism in South Asia.

The Pakistan Peoples Party (PPP) chairman, who is currently leading a high-powered delegation to the US as part of a global diplomatic push to seek support following its recent conflict with India, was speaking at a press conference at UN Headquarters Tuesday, the Dawn newspaper reported.

"I am completely confident that if ISI and RAW were ready to sit down and work together to fight these forces, we would see a significant decrease in terrorism in both India and Pakistan," Bhutto-Zardari was quoted as saying by the newspaper Wednesday.

He also urged the global community to remain engaged in South Asia, warning that the risk of conflict between nuclear-armed neighbours had grown, not diminished, after the recent ceasefire.

"With the intervention of the international community — and I would like to mention particularly the role played by the US President Donald Trump and his team led by Secretary of State Marco Rubio - we did manage to achieve a ceasefire between India and Pakistan. This is a welcome first step.

During the question-answer session, Egyptian-American journalist Ahmad Fathi, UN correspondent of American Television News (ATN), asked Bilawal about his comments on India's treatment of Muslims and reminded him that it was an Indian Muslim military officer who was briefing the media during the conflict. "Let me start with a statement you made today, saying that the recent terrorist attack in Kashmir is being used as a political tool to demonise Muslims in India. Sir, I have watched the briefings on both sides, and as far as I recall, there were Muslim Indian military officers who were conducting the briefing on the Indian side," Fathi said. He was about to ask his second question when Bilawal stopped him mid-sentence. The Pakistani leader then went on to criticise India and continued his usual rhetoric.

Doubled US tariffs on steel, aluminium kick in as deadline hits

Paris, June 4: Trade talks between the European Union and the United States are going in the right direction, the two sides' top trade negotiators said Wednesday, although the Europeans said the doubling of US metals tariffs did not help with the negotiations. The new tariffs on steel and aluminium imports kicked in Wednesday, the same day President Donald Trump's adminis tration wants trading partners to make "best offers" to avoid other punishing import levies from taking effect in early July. Meanwhile, in another sign of disruptions to global trade, concerns about the damage from China's restrictions on critical mineral exports deepened, with some European auto parts plants suspending output and German carmaker BMW warning that its supplier network was affected by shortages of rare earths. In terms of tariff talks, the 27-nation EU's trade negotiator Maros Sefcovic said his meeting with US Trade Representative Jamieson Greer in Paris early Wednesday was constructive. "We both concluded that we are advancing in the right di rection, at pace," Sefcovic told reporters after the meeting. Technical talks are ongoing in Washington, he said, and high-level contacts will follow. "What makes me optimistic is I see the progress ... the discussions are now very concrete," Sefcovic said. He stressed that he and Greer had agreed to restructure the focus of their trade talks, after hav ing been "approaching it from different angles.'



Vietnam scraps 2-child policy

HANOI: Vietnam abolished its long-standing two-child limit Tuesday to try and reverse declining birth rates and ease the pressures of an aging population. The National Assembly passed amendments scrapping rules that limit families to having one or two children, state

media Vietnam News Agency reported Wednesday. The rules were usually stricter for Communist Party members, who could miss out on promotions or bonuses if they had a third child. Vietnamese families are having fewer children than ever before. The birth rate in 2021 was 2.11 children per woman, just over the replacement rate required for a population to avoid shrinking over the long term. Since then, the birth rate has steadily declined: to 2.01 in 2022, 1.96 in 2023 and 1.91 in 2024. Vietnam isn't the only Asian country with low fertility. But, unlike Japan, South Korea or Singapore, it is still a developing economy.

A team from the Crime Investigation Bureau of Kathmandu Valley Police arrested the five Indians and 12 Nepalese after conducting a raid at their rented flats in Nakhu area of Lalitpur district.

India thanks Iran for rescuing its 3 nationals

Tehran: India Wednesday thanked Iran for safely rescuing its three nationals who went missing in the country last month, saying Tehran's support reflects the "true spirit of friendship" between the two nations. They were "freed in a police operation against the hostage takers in Varamin in south Tehran," the Tehranbased Tasnim news agency reported Tuesday.

Over 20 'mild' guakes rattle Karachi



KARACHI: Pakistan's biggest city has experienced at least 21 earthquakes of mild intensity over the last two days but experts were divided Wednesday over a potential major earthquake later in the week. The tremors in and around Karachi since Sunday night were classified as low to moderate in intensity and ranged from magnitude 2.1 to

3.6. The strongest tremor, measuring 3.6, was recorded Sunday night, which led to a wall of the Malir Jail in the city collapsing and around 216 prisoners escaping from the prison. Pakistan Meteorological Department (PMD) has advised the citizens to not panic as its officials claim the intensity of the quakes will reduce soon. "The earthquake tremors of mild intensity will continue for the next two to three days and the situation will improve as the intensity of the quakes will reduce," said PMD Director General Mahr Sahibzad Khan.

Bangkok, June 4: A hungry wild elephant caused havoc in a grocery store in Thailand Monday when he strolled in from a nearby national park and helped himself to food on the shelves.

Videos of the incident showed the huge male elephant, known as Plai Biang Lek, briefly stopping in front of the shop, located next to a main road near the Khao Yai National Park in northeastern Thailand, before ducking his whole body inside.

The elephant stopped in front of the shop's counter, calmly snatching and chomping snacks, and did not flinch as the national park workers



tried to shoo him away The elephant later backed out of the shop still holding a bag of snacks with his trunk. He left

little damage behind, except mud tracks on the floor and the ceiling of the shop In a video posted on social

media, Kamploy Kakaew, the shop owner, appeared amused as she described the moment the elephant rifled her shop. She said he ate about nine bags of sweet rice crackers, a sandwich and some dried bananas she had bought that morning.

Kamploy said the elephant left without hurting anyone after getting his snacks.

Danai Sookkanthachat, a volunteer park worker familiar with the elephant, said Plai Biang Lek, who is about 30 years old, is a familiar sight in the area and has been known to enter people's houses in search of food. This was the first time he had seen him going into a grocery store

"After he left the shop, he

went on to open a bedroom window of another house," he told The Associated Press.

Danai said wild elephants in the Khao Yai National Park area have been coming out of the woods to ransack people's kitchens for many years, but this year he has started seeing them going into more random places to find food.

There were an estimated 4,000 wild elephants in Thailand in 2024, according to the Department of National Parks, Wildlife and Plant Conservation. As farmers push into forests for agriculture, elephants have been forced to venture out of their shrinking habitats in search of food, leading to confrontations that can turn deadly.

"Indian non-financial companies are not directly affected by US import tariffs due to their focus on domestic consumption and low dependence on exports," a statement from Moody's said.

It further noted that government initiatives to boost private consumption, expand manufacturing capacity and increase infrastructure spending will help offset the weakening outlook for global demand.

Indian corporates will continue investing in new capacity to cater to the sustained growth in domestic consumption, and Moody's estimated that non-financial companies rated by it



will spend around \$50 billion annually in capital spending over the next two years. It said most companies will

spend from internal accruals, and the average portfolio leverage will continue to remain at 3 times the operating profit.

Moody's Ratings managing director Vikash Halan said India's manufacturing growth will be constrained by challenges such as inadequacy of skilled labor, evolving logistics infrastructure and complex land and labor laws.



"Whatever inquiry that needs to be done, the concerned authorities will do that. It was not a BCCI event. It is sad and tragic. The celebrations turned into a tragedy. Our heartfelt condo lences to the families who lost their loves ones," Dhumal told PTI.

French wild card Boisson stuns Mirra to reach semis

Paris. June 4: French wildcard entry Lois Boisson upset sixth-ranked Mirra Andreeva 7-6 (6), 6-3 Wednesday in front of a boisterous and largely partisan crowd at Roland-Garros to reach the semifinals of the French Open

Andreeva repeatedly showed her frustration with the crowd, as excited fans chanted "Lois, Lois" between points, waved Tricolor flags, shouted during play, and even applauded the Russian teenager's errors.

The 22-year-old Boisson became the first woman to reach the semifinals at her debut Grand Slam tournament since 1989, when Monica Seles and Jennifer Capriati both did it at the French Open.

She is also the youngest French semifinalist at a Grand Slam event since Amelie Maures-



mo at Wimbledon in 1999

The first set was marked by momentum swings and brilliant shot-making from both players. Boisson twice found herself down a break but fought back each time, using heavy spin and deep groundstrokes to

trouble her Russian opponent. Andreeva responded strongly at the start of the second set, racing to a 3-0 lead. But Boisson broke back with a thunderous backhand winner down the

CHAMPIONS LEAGUE FIASCO Football law on penalty kicks updated

Zurich, June 4: The laws of football on taking a penalty kick were clarified after Julián Álvarez's accidental double touch helped to eliminate Atletico Madrid from the Champions League.

The new interpretation will take effect in UEFA-organ-

ised games Wednesday when Germany plays Portugal in a Nations League semifinal in Munich, the European football body said Tuesday.

The update published by FIFA-backed rules panel IF-AB means the kind of penalty Átletico forward Álvarez had disallowed after scoring in a shootout against Real Madrid in March should now be re-

Álvarez slipped and kicked the ball against his standing left foot in the shootout in the Champions League round of 16.

After the looping ball beat Madrid goalkeeper Thibaut Courtois for an apparent score, the goal was ruled out by a video review and Atletico ultimately lost the shootout.

The laws of football relating to the penalty kick and penalty shootout were seen as correctly applied in Madrid though too vaguely worded. The incident was widely judged to have been unfair as Álvarez did not deliberately slip and take the double touch to gain an advantage.

"This situation is rare, and as it is not directly covered in Law 14, referees have understandably tended to penalize





the kicker," IFAB said in a statement.

"However, this part of Law touched another player.' 14 is primarily intended for situations where the penalty letter to football stakeholders that a penalty kick which is scored now after an accidental double touch should be retaken.

A double-touch penalty that is not scored will not be retaken. In a shootout, such a penalty "is recorded as missed," IF AB said, and during regulation time or extra time a free kick can be awarded to the defending team.

The clarified rule also will apply at the Club World Cup which starts June 14 in the United States. The 32-team lineup includes Atletico.

IFAB is comprised of FIFA plus the four British football federations. Rules can be changed with six of the eight votes which are distributed by four to FIFA and one each to the British.
