## The unseen side of Raaj Kumar

Mumbai: Before he became one of Bollywood's most enigmatic actors, Raaj Kumar led a very different life. In the late 1940s, he served as a Sub-Inspector with the Mumbai Police, stationed at Mahim Police Station. His cinematic journey began unexpectedly when filmmaker Sohrab Modi spotted him while on duty at Metro Cinema. Though Raaj Kumar initially declined Modi's film offer, destiny had other plans, and he eventually transitioned into acting, bringing his signature style to the silver screen.

Known for his magnetic voice and piercing screen presence, Raaj Kumar was also famous for his eccentricities and blunt nature. A widely shared anecdote recounts how he rejected Zanieer, the film that launched Amitabh Bachchan's stardom, supposedly because he didn't like the director's face or his choice of hair oil. Whether fact or folklore, his refusal signifi-

Raaj Kumar shared the screen with Dilip Kumar in Paigham (1959) and reunited with him three decades later in Saudagar (1991). Despite the hype around their pairing, it's well-documented that the two rarely spoke off-camera due to their strong personalities and differing approaches to work.

Deeply loyal, Raaj Kumar retained the same driver, tailor, hairstylist, and even his beloved cantly shaped the course of Bol-Plymouth car for over 40 years

A fan of horse riding and golf, he also had a curious fondness for polished shoes.

True to his private nature. even in death, he left instructions for a quiet farewell—his cremation was to be done swiftly at Shivaji Park electric crematorium without informing the film fraternity. July 3, 1996, Raaj Kumar passed away due to throat cancer, leaving behind a legacy as unforgettable as the man him-



### 4 dead, 18 injured in **Pune bridge collapse**

Pune, June 15: Four persons died and 18 were seriously injured after an old iron bridge on Indrayani river collapsed Sundav afternoon in Pune's Maval tehsil, officials said.

While two persons succumbed to injuries during treatment after being rescued, the bodies of two persons were recovered from underneath the collapsed portion of the bridge, officials said.


"While two bodies were recovered from beneath the structure, we suspect one person is trapped there. Efforts are underway to locate and rescue the person," Talegaon Dabhade police station Senior Inspector Pradeep Rayannawar said late evening.

The incident took place at 3:30pm in Kundamala area, which has been seeing heavy rains over the past few days, giving the river a steady flow, another official said. It was not raining when the bridge collapsed in the presence of at least 100 picnickers, he added.

"In the mishap, so far 38 people have been rescued of which 18 sustained serious injuries and they are currently under treatment in three different hospitals. During treatment, two people succumbed to injuries," a statement from the district administration informed.







#### Sonia Gandhi hospitalised

New Delhi: Congress Parliamentary Party chairperson Sonia Gandhi was admitted to Sir Ganga Ram Hospital here Sunday due to stomach-related problems. sources said. Gandhi.78, was admitted to the gastroenterology department around 9 pm. the hospital sources said. They said Gandhi's condition is stable and she is under the observation of a team of doctors. On June 9, the former Congress president underwent a medical check-up at Sir Ganga Ram Hospital. Two days before the check-up, she underwent some tests at Indira Gandhi Medical College Hospital in Shimla after she complained of high blood pressure.

## **Another Char Dham disaster**

**J**ust days after an Air India flight crash in Ahmedabad claimed 274 lives, a helicopter carrying pilgrims from Kedarnath crashed in Uttarakhand, killing all seven on board. This tragic incident highlights growing concerns over air safety standards in India, particularly on the Char Dham pilgrimage routes where helicopter crashes and emergency landings have become alarming ly frequent. On May 8, a chopper en route to Gangotri crashed in Uttarkashi, killing six. On May 12, a helicopter from Badrinath made an emergency landing due to poor visibility. Another crash-landing occurred near Kedarnath May 17 involving a heli ambulance. On June 7, a chopper made an emergency landing in Rudrapravag district due to technical issues. Opposition leaders and activists blame the government's lack of oversight, alleging that profit-driven private aviation firms are compromising safety for financial gain. These incidents underscore the urgent need for stricter regulation and better safety protocols on pilgrimage routes.

Rudraprayag (Uttarakhand), **June 15:** A helicopter carrying

pilgrims from the Kedarnath shrine crashed early Sunday in the forests of Gaurikund amid poor visibility, killing all seven people on board, the fifth helicopter accident on the Chardham Yatra route since the pilgrimage started April 30.

The Civil Aviation Ministry suspended the operations of the helicopter operator and issued a slew of safety directions after the tragedy, which came just days after one of the deadliest air disasters where an Air India flight to London crashed in Ahmedabad just after take-off, killing 274 people on board and on ground.

The seven people on board the Bell 407 helicopter, operated by private firm Aryan Aviation Pvt Ltd, included a two-year-old child and the pilot. They hailed from Maharashtra, Rajasthan, Uttarakhand and Uttar Pradesh.

The Civil Aviation Ministry said it has suspended the operations of Aryan Aviation for

the Char Dham Yatra and has directed the Directorate General of Civil Aviation (DGCA) to immediately post officers from airworthiness, safety and operations to actively oversee all helicopter activity in the Kedarnath Valley.

Preliminary indications suggest that the probable cause may be Controlled Flight into Terrain (CFIT), with the helicopter reportedly airborne despite poor visibility and extensive clouding at the valley entry area, the ministry said in a statement.

The exact cause will be determined through a detailed investigation by the Aircraft Accident Investigation Bureau (AAIB), it added. CFIT occurs when an airworthy aircraft under the complete control of the pilot is inadvertently flown into terrain, water or an obstacle.

Uttarakhand Chief Minister Pushkar Singh Dhami also ordered a high-level inquiry and suspension of helicopter operations on the Chardham Yatra route for two days. Rudraprayag District Disaster Management Officer Nandan Singh Rajwar said zero visibility caused by bad weather apparently led the helicopter to crash between Gaurikund and Trijuginarayan in Kedarghati and catch fire.

### Jajpur: 3 more diarrhoea deaths; toll rises to 16

Jajpur, June 15: Three more persons, including a woman, died of diarrhoea in Jajpur district Sunday, while the infection reportedly showed signs of decline.

The deceased were identified as Jatadhari Sahu, 75, of Kamalpur village under Dasarathpur block; Madanmohan Sahu, 62, of the Jajpur Municipality area and Jayanti Sahu, 50, of Khairabad village - also under the civic body area. With these three deaths, the toll from the infection has reportedly risen to 16.

However, Chief District Medical Officer (CDMO) Bijay Kumar Mishra refuted claims that the three deaths were caused by diarrhoea. "The deaths were due to other medical conditions, not diarrhoea," he maintained. Meanwhile, special teams from MKCG Medical College and Hospital in Berhampur and SCB Medical College and Hospital in Cuttack reached Jajpur Sunday. They collected 17 samples for cholera testing.

Earlier, 13 deaths had been attributed to diarrhoea in the district. The district Health department, however, officially confirmed only five.

#### **Take urgent steps: CM**

**Bhubaneswar:** Chief Minister

Mohan Charan Majhi Sunday directed the Health department to take urgent measures to prevent the spread of diarrhoea from Jajpur to neighbouring districts. According to a CMO statement, all health the affected districts have been placed on high alert.

State Health Minister Mukesh Mahaling visited the district Sunday, touring community health centers in Barchana, Dharmasala, Madhuban, Rasulpur, Jajpur Road and the Jajpur DHH. He interacted with patients, assessed treatment conditions, and directed officials to resolve issues related to contaminated water and food.

Later, the minister attended a review meeting with District Collector P Anyesha Reddy at the Collectorate conference hall. Also present were Jajpur MP Rabindra Narayan Behera, Korei MLA Akash Das Nayak, Dharmasala MLA Himanshu Sekhar Sahu, Barchana MLA Amar Navak, several district and Health officials, and members of a 14-member Central team.

### Man held for beating pregnant wife to death

Tihidi, June 15: A pregnant woman reportedly died after being brutally assaulted by her husband in Talapada village, under Tihidi police limits in Bhadrak district.

The deceased, Monalisa Jena, 26, succumbed to her injuries late Saturday night. Police have registered a case (211/25) and arrested her husband, Shan karshan Jena, Sunday.

Monalisa's father, Panchanan Jena in his complaint said his daughter was murdered over dowry. Panchanan alleged that Shankarshan, son of Tera Jena from the same village, had married Monalisa five years ago. At the time of the wedding dowry demands were met as per the groom's side's wishes However, they continued to demand more, and Monalisa was repeatedly tortured both physically and mentally by her husband and in-laws.

Panchanan said Saturday night he learned that Monalisa had been tied up and severely beaten by Shankarshan and others in the house. She was allegedly kicked on the stomach by her husband in an attempt to terminate her pregnancy. Monalisa was declared dead by doctors at Bhadrak DHH.

### Israeli strikes kill over 400 in Iran

Dubai, June 15: Israel unleashed airstrikes across Iran for a third day Sunday and threatened even greater force as some Iranian missiles evaded Israeli air defences to strike buildings in the heart of the country. Planned talks on Iran's nuclear programme, which could provide an off-ramp, were cancelled.

Israel's strikes have killed at least 406 people in Iran and wounded another 654, according to a human rights group that has long tracked the country, Washington-based Human Rights Activists. Iran's government has not offered overall casualty figures.

The region braced for a protracted conflict after Israel's surprise bombardment Friday of Iranian nuclear and military sites killed several top generals and nuclear scientists. Neither side showed any sign of backing down. Iran said Israel struck two oil refineries, raising the prospect of a broader assault on Iran's heavily sanctioned energy industry that could affect global markets. The Israeli military, in a social media post, warned Iranians to evacuate arms factories, signalling a further widening of the campaign.

Israel said 14 people have been killed since Friday and 390 wounded. Iran has fired over 270 missiles, 22 of which got through the country's sophisticated multi-tiered air defenses, according to Israeli figures. Israel's main international airport and airspace remained closed

for a third day.

Sun comes to aid of heat-stressed cheetah cubs in Kuno PRESS TRUST OF INDIA

New Delhi, June 15: A solar-powered water lift system has emerged as a lifeline for the cheetah cubs born in Kuno National Park this summer, helping them survive extremely hot and harsh conditions.

Temperatures soared to the high 40s across northwest and central India this June, putting immense pressure on water resources.

In May 2023, three cubs born to Namibian cheetah Jwala died due to extreme heat in the national park in Madhya Pradesh. Learning from that experi-

ence, authorities have installed

a solar-powered system to pump

water from the Kuno river and

transport it through an 8.6-kmlong pipeline to sprinklers and water saucers at more than 15 locations inside the park.

"Lifting water from Kuno river, taking it kilometres away, using sprinklers extensively to create green spaces, and improving water availability, especially for mother and newborn cubs in a planned way, have proved quite successful, according to video posted on X by Additional Principal Chief Conservator of Forests and Cheetah Project Director, Ut-

tam Kumar Sharma. "The importance of water is felt only in its absence and it is nowhere as pronounced as in Kuno during peak summer. Under the incessant pummelling of hot winds called 'loo' and tem-



peratures bordering 48 degrees Celsius, life becomes very difficult for wildlife, particularly the young ones," it said.

South African cheetah Veera gave birth to two cubs in February 2025, while another South

African cheetah, Nirva, gave birth to five cubs in April.

Two of Nirva's cubs died, but officials said the rest are doing well.

The officials said the cubs were experiencing such harsh conditions for the first time and both the mothers and their offspring were regularly using the water points, indicating the success of the initiative.

Launched in September 2022, 70 years after the species was declared extinct in the country, India's cheetah reintroduction project is among the most am bitious conservation efforts in recent history.

As part of the project, 20 Af rican cheetahs were brought to Kuno: eight from Namibia in September 2022 and 12 from South Africa in February 2023

Since then, 26 cheetah cubs have been born in India. Of

these, 17 survived. Eleven cubs are roaming free in the wild, while the others are

in enclosures at Kuno.

## **CM: Take urgent steps to** curb spread of diarrhoea

Bhubaneswar, June 15: Amidst an outbreak of diarrhoea in some areas of Jajpur and Keonjhar districts. Chief Minister Mohan Charan Maihi Sunday directed the Health department to take urgent measures to prevent its spread to neighbouring districts.

According to a statement from the Chief Minister's Office (CMO), all health facilities in the affected districts have been placed on high alert

"Neighbouring districts have also been advised to remain vigilant. Disinfection of drinking water sources has begun in Jajpur, alongside a temporary ban on street food sales and intensified food safety inspections," the statement added. Adequate supplies of medicines have been ensured and medical teams have been deployed to contain the outbreak, the CMO said.

Health Minister Mukesh Mahaling is monitoring the situation through regular meetings with medical officers and administrative officials.

A team from the Indian Council of Medical Research (ICMR) has also arrived in Odisha to assist the state government in controlling the outbreak.

Sixteen people have died so

Chandra Bal said. Out of 1,750 people diagnosed with diarrhoea in the district, 1.500 of them have recovered and about 250 are under treatment, officials said. "The situation is yet to be brought under control. When no new patients are admitted to hospitals, we will be able to control it," Director of Public Health Nilakantha Mishra said.

Adding to the worries, 11 diarrhoea patients also tested positive to cholera, Chief District Medical Officer (CDMO) Bijay Mishra said. A 14-member central team visited the district Sunday to assess the ground situation. The team visited some hospitals where diarrhoea patients have been admitted and held a meeting with the district administration.

Mahaling also visited various hospitals in Jajpur district and Anandapur hospital in Keonjhar district during the day and interacted with patients and doctors.

"It is a matter of concern for us that cholera has been detected in Jajpur. A team from SCB Medical College and Hospital in Cuttack has been deployed in the district. We are trying to bring the situation under control," he

Rural Water Supply and Sanitation (RWSS) teams are disinfecting drinking water sources in the district, while food inspectors and disease surveillance teams are also working to bring the situation under control, officials said.

ASHA and Anganwadi workers, and health workers have been supplied with halogen tablets and ORS packets for distribution among the people, they said. People have been advised to take precautionary measures. avoid having outside foods, and adhere to hygienic practices, they said. Diarrhoea cases have also been detected in parts of the Cuttack district, Astaranga area in Puri district and Bhuban NAC in Dhenkanal district, officials said. Over 50 people were diagnosed with diarrhoea in Gholapur village in Cuttack, and 20 people were affected in Puri's Astaranga.

Similarly, over 30 persons in Bhaban NAC have been affected with diarrhoea, they said.

In light of rising cases of diarrhoea, the Housing and Urban Development (H&UD) department has directed all III. Bs and district-level officials to initiate immediate preventive and response measures.

Department principal secretary Usha Padhee has called for enhanced vigilance and real-time monitoring to ensure the sanitisation and safety of all water sources, with particular attention to vulnerable urban pockets. Meanwhile, BJD president and Leader of Opposition Naveen Patnaik accused the state government of taking the cholera outbreak lightly.

He said cholera has taken a serious turn in the districts of Jaipur, Kendrapara, Bhadrak, Puri, Cuttack, and Keonjhar, and the outbreak appears to be spreading

## Non-servitors banned from climbing chariots

"The final list will be enforced strictly," the minister said.

Meanwhile, Director General of Police (DGP) Yogesh Bahadur Khurania held a meeting here to review the security measures for the Rath Yatra.







# Fishermen ready to return to Bay as fishing ban lifted

Mahakalapara, June 15: The annual marine fishing ban imposed at Gahirmatha Marine Sanctuary of Kendrapara district ended Sunday, paving the way for thousands of local fishermen to return to the Bay of Bengal and resume operations. The ban, which has been in

effect for seven months and a half from November 1, last year to June 15 this year, was imposed to protect mass nesting of Olive Ridley sea turtles during their breeding season. With the turtles having returned to their natural habitats, the restriction will be lifted, officials said.

Around 10,000 fishermen from Batighar, Kharinasi, Ramanagar, Petachhela, Jambu, Suniti, Tantiapal, and Bau-



lakani panchayats under the Mahakalapara block depend heavily on marine fishing for their livelihood. Many of them conducted traditional rituals of boat worship like 'Danga Manga Puja' before setting out to the sea with their boats and nets Saturday.

Gahirmatha, spanning over 1,435 sq km from the Mahanadi river mouth to the Dhamra river mouth, is India's first marine sanctuary. Though the seasonal fishing ban is lifted, permanent

restrictions remain in force within the sanctuary's core area, which stretches 20 km from the coast into the sea. Entry into this zone is prohibited year-round, and a buffer zone follows beyond the 20-km mark.

To enforce the restrictions, the Forest department has deployed 14 high-tech floating buovs to demarcate boundaries. Despite such measures, officials allege that some trawler owners continue to trespass into the protected zones to illegally catch high-value fish species,

evading forest patrols. Kapila Chandra Pradhan, range officer of the Gahirmatha Marine Sanctuary, warned that any unauthorised entry into the restricted areas after lifting of ban will be met with legal action.



## Mid East Great Again

or decades, current Israeli Prime Minister Benjamin Netanyahu has been warning about the "existential threat" that a nuclear-armed Iran poses to his country, asserting that military action is the only reliable means to counter it. Throughout the various terms in his long 17-year tenure as the prime minister, Netanyahu has considered, debated, and planned an all-out strike on Iran's nuclear facilities, but never executed until the early hours of 13 June, 2025 when Israel struck Iran's nuclear and military facilities which resulted in the deaths of several high-ranking generals and nuclear scientists. It is clear why Netanyahu has chosen to act now. His recent statements drew on the darkest moments of Jewish history to emphasize that Israel will never allow itself to be vulnerable to a "nuclear holocaust." His arch rival and former PM Yael Lapir has, on 15 June 2025, said that though he opposes Netanyahu on many issues, his recent decision to strike on Iran's nuclear facilities is totally justified and timely.

Additionally, the timing is influenced by the current strategic weakness of the Iranian regime. Tehran's influence in the region has historically depended on its allies and proxies, creating a "ring of fire" around its adversary, Israel. This network included the Assad regime in Syria, Hezbollah in Lebanon, Hamas in Gaza, and the Houthis in Yemen, However, with Assad no longer in power and Syria's new leader gaining favour with US President Donald Trump, Syria's focus has shifted from Tehran to Washington. Meanwhile, the Houthis have reached an agreement with the US, Hezbollah is struggling without a leader and still recovering from last year's Israeli attacks, and Hamas has suffered significant losses, with its leadership decimated and Gaza destroyed. Consequently, there has never been a more opportune time for Tel Aviv to take on its sworn

On the other hand, the extent of the attacks, the targets selected by Israel, and the statements from its politicians indicate that, in addition to severely crippling Tehran's nuclear weapons programme, there is another goal: the overthrow of the Islamic regime. In a video message shortly after Israeli fighter jets launched strikes on Iranian nuclear facilities and air defence systems, Netanyahu, addressing the Iranian people directly, said: "The Islamic regime, which has oppressed you for almost 50 years, threatens to destroy our country, the State of Israel." Israel's objective was to remove the nuclear and ballistic missile threat, he said, but added: "As we achieve our objective, we are also clearing the path for you to achieve your freedom. The regime does not know what hit them, or what will hit them. It has never been weaker. This is your opportunity to stand up and let your voices be heard.

It will be naive to think that Israel's actions were unilateral, as stated by US Secretary of State Marco Rubio or as claimed by Trump himself that the US had "no involvement in the attack on Iran. For, it is a well known fact that Israel is a proxy of the US in the Middle East and therefore any action that it takes in the region has America's clear approval. With the post-Assad Syria under its fold, a decimated Iran will only strengthen the US position in the region vis-a-vis Russia.

Iran, on its part, counts on allies like Russia and China, who are reluctant to see the country humiliated. However, neither of these countries is willing to engage in the present conflict, and Iran's proxies -- Hezbollah, Hamas, and the Houthis -- are badly beaten and forced to remain on the sidelines. As a result, Tehran could now be finding itself in a spot on how to respond to the situation.

Meanwhile, Trump, remaining true to his unpredictability, on 15 June, called for a truce between Israel and Iran. He posted on his Truth Social platform that "Iran and Israel should make a deal, and will make a deal, just like I got India and Pakistan to make, in that case by using TRADE with the United States to bring reason. cohesion and sanity into the talks with two excellent leaders who were able to quickly make a decision and STOP!" He went on to add: "Likewise, we will have PEACE, soon, between Israel and Iran! Many calls and meetings now taking place. I do a lot, and never get credit for anything, but that's OK, the PEOPLE understand. MAKE THE MIDDLE EAST GREAT AGAIN!"

If Trump succeeds in making a deal between the two warring countries like he did in the India-Pakistan scene, not just the Middle East, the world at large can heave a sigh of relief.

## THE AGE OF DRONES

kraine's 1 June assault on airbases across Russia has already ushered in a new conventional wisdom: the expensive, human-crewed weapons (tanks, planes, ships) that have long defined the world's "advanced" militaries have been rendered obsolete by inexpensive drones. But this view is incomplete, and perhaps dangerously misleading. Today's drone warfare offers sobering lessons that go far beyond the vulnerability of expensive legacy weapons; and the looming integration of AI into drone warfare will make the current situation look positively quaint.

Consider the lessons of the Ukraine war so far. First, the impact of drones goes far beyond legacy weapons. Drones have indeed rendered tanks and armored personnel carriers extremely vulnerable, so Russian ground assaults now frequently use troops on foot, motorcycles, or all-terrain vehicles. But this hasn't helped. because drones are terrifyingly effective against people as well. Casualties are as high as ever but now, drones inflict over 70% of casualties on both sides.

Drones are also effective against almost everything else. Ukraine has used drones to destroy Russian targets as varied as weapons factories, moving trains, ammunition stores, oil refineries, ships, and ports. It could be worse; in fact, Ukraine has shown great restraint, considering Russia's barbaric conduct. Two additional sobering lessons from Ukraine concern how drone warfare depends on its industrial base. First, speed and responsiveness are critical. Drone technology, weapons, and tactics now evolve at a blinding pace. A new drone will be useful for only 2-6 months. The other side develops countermeasures, requiring the development of new products, against which new countermeasures are developed, and so on.

At first, the drones used in Ukraine were crude weapons, radio-controlled by a pilot who needed to be nearby. As drones became more sophisticated and lethal, jamming was used to

block their radio signals, which led to frequency changes and then frequency hopping, which was then countered by multi-frequency jammers, which then engendered drones that attack jamming equipment. Then Russia developed drones controlled via fiber-optic cable - impervious to jamming. Ukraine tries to track the cable to its source and kill the pilots (with drones). Now Ukraine has fiber-optic drones, too. Guidance is ever more sophisticated, so that drones can evade radar by flying very low or using stealth technology. But drone detection and tracking systems have also advanced, employing networks of cellphones and microphones connected to audio analysis software, as well as using Lidar, radar, and cameras.

In this ferocious environment, falling even a month behind is fatal. Normal defense industry procedures are totally inadequate, and most US drones and drone producers have proved to be hopelessly slow, expensive, and unusable. In response, however, Ukraine's drone industry and military developed a revolutionary model of weapons research and development, production, and deployment, based on direct, continuous communication between frontline units and drone producers. Ukraine's military command and Ministry of Digital Transformation have even developed a points-based system that publishes continuously updated rankings of military units' performance based on verified drone kills. Here, Ukraine benefited from having a strong startup ecosystem, which supports a weapons industry (with hundreds of companies) capable of designing, producing, and fielding a new weapon in a matter of weeks. This year, Ukraine will produce more than four million drones, most of them models that did not exist even a year ago. Unfortunately, Russia has adapted as well, also relying heavily on private startups.

Ukraine evolved its own drone industry because the US and NATO had almost none of their own, much less one with the speed and flexibility required, and because China has gradually tightened supplies to Ukraine in favor of Russia, Some 80% of the electronics used in Russian drones are sourced from China. While Ukraine was initially highly dependent on China, it has reduced its reliance to perhaps 20%, most of that obtained covertly.

Yet US and European defense R&D and procurement remain slow and uncompetitive, which cripples their ability to defend against drones, as well as their ability to use them. Although few people realize it, the US and NATO now desperately need Ukraine for its drone expertise. Ukraine is now the only country that could possibly match Chinese and/or Russian technology and reaction time in a war. Without Ukraine, and without modernizing their own forces, NATO and the US would suffer horrific casualties in a war with Russia or China and might even lose.

Moreover, AI will change everything. Ukraine's 1 June

each controlled by a skilled operator, and reports suggest that something like half were defeated by Russian defenses – jamming, mainly – because the drones needed to be in radio communication with their controllers. Had they been autonomous, there could have been a thousand of them. And with AI, there is no need for pilot communication, and thus no effective jamming, greatly increasing drone range and lethality. Five years from now, it will be terrifyingly easy to launch preemptive strikes on conventional targets. AI also increases the lethality and precision of drones used against people. Chinese researchers have already demonstrated drone swarms navigating through a forest and then re-forming as a swarm after passing through. This is not just about warfare; it also works for terrorist attacks.

Stuart Russell, an AI specialist at the University of California. Berkeley, has long argued for an arms-control treaty to prevent the spread of small, mass produced, AI-controlled drone weapons. He even underwrote the production of a short film. Slaughterbots, which dramatizes the risks these drones could pose in the wrong hands. At a dinner years ago, he told me that it would soon be easy to target individuals using facial recognition or, say, everyone wearing a cross, a yarmulke, or any other religious or political symbol.

Since any meaningful treaty is unlikely in the current geopolitical environment, we must prepare for a world that probably will contain such weapons. But the Western defense establishment increasingly looks like the typical "legacy" company that has been caught off guard by technological disruption. In markets, legacy resistance can be costly, but the costs are purely monetary. In warfare, they can and will be deadly.

## Disruption in India's retail landscape



**OUICK COMMERCE PLATFORMS HAVE LAUNCHED A FORMIDABLE ASSAULT ON TRADITIONAL RETAIL BY** WEAPONISING **TWO CRITICAL ADVANTAGES: HYPER-SPEED AND FRICTIONLESS CONVENIENCE** 

rana stores, the small neighbourhood shops, have traditionally been the go-to source for groceries and daily essentials for millions of Indian households. They dominate India's retail landscape, contributing to over 85% of grocery sales. However, the swift emergence of quick commerce platforms is disrupting this ecosystem. putting significant pressure on thousands of local kirana stores. The All India Consumer Products Distributors Federation (AICPDF) reports that around 200.000 kirana stores closed in the past year, with 45% of closures in metro cities, 30% in Tier-1 cities, and 25% in Tier-2/3 cities.

Quick commerce platforms have launched a formidable assault on traditional retail by weaponising two critical advantages: hyper-speed and frictionless convenience. Their promise of delivering groceries and essentials in minutes appeals to busy urban consumers. Compounding this disruption is aggressive discounting, subsidized by venture capital funding, which has accelerated a seismic shift in spending habits away from conventional stores. This dual strategy of instant gratification and price arbitrage now threatens the very survival of neighbourhood retailers struggling to match these capital-fueled efficiencies.

While there is no single, official government census for them, the most widely cited and accepted estimates from various market research firms and industry bodies place the number of kirana stores in India between 12 to 15 million. The vast majority of these stores operate in the unorganised sector. Many are unregistered, family-run businesses, making it incredibly difficult to conduct a precise count. The number is also dynamic, with stores opening and closing continuously.

Quick commerce is disrupting kirana stores, particularto significant closures and reduced sales. However, despite the rapid growth of e-commerce and quick commerce, kirana stores still remain the primary shopping destination for the vast majority of Indian households due to their convenience, accessibility, and deep-rooted community trust. Of the total number, over 10 million of these stores are situated in Tier-2 and smaller cities, highlighting their deep penetration into the heart of the country. The cordial personal relationships with customers, the extension of credit and the intimate understanding of local needs and preferences are significant advantages for kirana stores. This social fabric of trust and familiarity has been the bedrock of their existence for generations. The human touch of kirana shops acts as a powerful defense system against quick commerce. The future of retail in India

will likely be a hybrid mod-

el where technology-driven convenience and traditional, relationship-based commerce coexist. However, to compete with the quick commerce, kiranas in the Tier 1 and Tier 2 cities have to adapt and integrate technology to counter the onslaught. Many of them are now accepting online payments, receiving orders online and streamlining their inventory management. Quick commerce's impact is largely urban, with minimal penetration in rural areas where kirana stores remain dominant due to limited digital infrastructure and consumer preference for local, credit-based shopping. The kiranas with their inherent strengths will not only survive but may also find new avenues for growth in this dynamic new era of Indian retail. The battle is on, but the final bell for the ubiquitous Indian kirana store has certainly not rung.

The Commission has given the former chief minister 15 days to respond, warning that failure to do so could lead to legal proceedings. Talking to PTI, Bihar SC Commission vice-chairman Devendra Kumar said a notice was issued to Lalu Prasad seeking an explanation over the alleged incident.

"The Commission has given Prasad 15 days to respond

and warned that failure to do so could result in action under the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act," he added. The controversy erupted after a video, purportedly recorded during Lalu Prasad's 78th birthday celebrations earlier this week, went viral.

In the clip, the ailing leader is seen seated on a couch with

his feet on a nearby sofa. A supporter then enters the room carrying a portrait of Dr. Ambedkar and places it near Prasad's feet before greeting him. The act drew sharp criticism from political opponents. On Saturday, the BJP accused the RJD chief of insulting the Dalit icon. Addressing a press conference,

Bihar Deputy Chief Minister, a former state BJP president, played the video, demanding accountability. On Sunday, saffron party workers staged a protest and burnt an effigy of Prasad at Income Tax Golumber here.

Responding to the notice, Tejashwi Yadav, leader of the opposition in Bihar Assembly and Lalu Prasad's son, dismissed th move as politically motivated "There have been so many cases of atrocities against Dalits that the Commission has ignored But since we oppose the BJP, we are being subjected to intimidatory tactics," he said.

He further mocked the Com mission's process, claiming that a copy of the notice had not yet been officially received. "The draft that's doing the rounds contains multiple grammatical errors. We've also learned that the letter has been withdrawn twice for corrections. We'll respond appropriately once the Commission finishes drafting and formally dis-

#### **Rules eased for buying scientific** equipment by R&D institutes

New Delhi: In the wake of demands from researchers, the government has enhanced financial limits for the procurement of scientific instruments and consumables by various scientific institutions, including those pursuing research in the defence sector, and also allowed them to look beyond the GeM portal for making such purchases. The existing financial rules mandated procurement of equipment of less than Rs 200 crore only through the government e-marketplace (GeM) portal and from local producers to encourage the domestic manufacturing sector. However, various scientists and researchers faced hindrances due to these rules as several high-end research equipment were not available on the GeM portal.

#### FIR against Union minister for 'throwing slipper at Sikh man'

Kolkata: An FIR has been lodged against Union minister Sukanta Majumdar at a police station in Kolkata alleging he threw a slipper at a Sikh man which hit his turban, the ruling Trinamool Congress claimed Sunday. BJP dismissed the allegation and said it was only a paper cutting used in a protest. The FIR, lodged at Kalighat police station in south Kolkata June 13, claimed that June 12, Majumdar, who is also the state BJP chief, had thrown a slipper in a public place at the crossing of Hazra Road and Harish Chatterjee Street, near Chief Minister Mamata Banerjee's residence.

#### **Influencer murder: Key accused** fled to UAE hours after crime

Chandigarh: Amritpal Singh Mehron, the alleged key accused in the murder case of Puniab-based social media influencer Kanchan Kumari alias 'Kamal Kaur Bhabhi', fled to the UAE hours after the incident, police said Sunday. Bhatinda Senior Superintendent of Police Amneet Kondal said police had already issued a lookout circular against Mehron, a resident of Moga. Mehron (30) is a self-styled Sikh radical leader. He is also accused of issuing threats to at least two other Punjab-based woman social media influencers. The police said they have also blocked some of his social media handles. On June 13, two accused -- Jaspreet Singh (32) of Moga and Nimratjit Singh (21) from Tarn Taran -- had been arrested in connection with the murder of Kanchan Kumari, who was found dead in an abandoned car in a parking lot in Bathinda.

# Segregating dreams from scrap

India's E-Waste (Management) Rules, 2022, was designed to tighten controls, making producers more responsible through extended producer responsibility. But the system still falls short

New Delhi, June 15: In the winding, congested alleyways of New Seelampur, a 500-foot stretch tucked deep inside east Delhi, life hums with the quiet rustle of wires, metal scraps,

Every household here seems tied to the business of e-waste - a world where old computers, phones, fridges, and their innards are torn down, stripped, sorted, and sold.

But the story is no longer what it once was. As India's e-waste policy

evolves and the gaze of enforcement agencies intensifies, the epicentre of one of the world's largest informal e-waste markets has quietly dispersed, not collapsed, but fragmented and slipped into the shadows.

The business hasn't ended, it has just moved -- to Loni, Muradabad, Meerut and smaller towns where it thrives away from the eyes of the regulators, the media, and digital

"The volumes have not really reduced. The business is still alive, but just not visible in Delhi anymore," says Vinod, programme officer at Toxics

Link, an environmental NGO. During a recent visit to the New Seelampur slum, PTI witnessed how this once-bustling hub has morphed into a quieter but deeply embedded

As the reporter walked through the slum's narrow lanes, nearly every doorway opened into a home where families were engaged in e-waste segregation.

In a dimly-lit 6x6 feet room, 50-year-old Saleema sat hunched over a knee-high mound of cables. Her fingers. bent with arthritis, sort wires from morning to night, guided only by a low-watt bulb dangling from the tin roof. For 10 kg of wires, she earns ₹50 -slightly more if she finds slivers of copper. A single mother

-- her alcoholic husband vanished into irrelevance years ago -- Saleema supports her three children. Her eldest son has been lodged in Tihar Jail for over a year on theft charges, still awaiting trial.

Next door, 19-year-old Shahheda sits outside her one-room home, her hands still hennaed from her wedding barely a month ago. Married into this community from Muradabad, she's no stranger to the trade. After making breakfast for her family, she joins her husband and in-laws, segregating

Nearby, Sajid Khan's familv of five is also neck-deep in dismantling old electronics. His daughter attends school in the morning and returns to help in the evening -- a pattern repeated in many homes here.

Twelve-vear-old Sharmila (name changed) wants to become a doctor - and not just any doctor, but one who treats her neighbours, many of whom suffer from chronic ailments linked to toxic exposure. "After school, I help my father," she says shyly, as

she picks apart an old mobile charger. Her father, who did not wish to be named, is saving every rupee in the hope of breaking the cycle. For ₹80, a technician will strip an old phone into saleable pieces. In the makeshift shanties, trad ers examine CRTs from old monitors, polishing the glass to resell in rural markets. Impure copper sells for ₹600 per kg; pure fetches up to ₹800.

Each house is a microcosm of labour -- families bent over wires, children washing dismantled parts, mothers selling components to traders who come knocking. Yet, the total daily income rarely crosses ₹500-Rs 1,000 per household.

"How laws are made is not very important but how implementation takes place is the key, and that is where the gap is between implementation and the role of the informal sector -- these are two serious gaps,' says Satish Sinha, associate director, Toxics Link, which works closely in the sector.

Only about 500,000 tonnes of e-waste were formally collected in 2021-22 -- out of more than 3 million tonnes generated.

The Chinese-made wire stripping machines have replaced some manual labour, but not all. The actual dismantling -- sorting, stripping, burning -- is still largely done by hand. The traders now operate via phone calls, with less **UTTARAKHAND CHOPPER CRASH** 

# Pilot, who served Army for 15 years, killed

Jaipur, June 15: Rajveer Singh Chauhan, the pilot of the helicopter that crashed in Uttarakhand early Sunday killing all seven on board, had served in the Indian Army for over 15 years and had vast experience of flying missions over different

Chauhan (37), a resident of Jaipur's Shastri Nagar, was working as a pilot with Arvan Aviation Private Ltd since October 2024. He was the captain of Bell 407 helicopter that crashed near Gaurikund in Uttarakhand Sunday morning. Besides him, six people were killed in the accident.

"I got information about the crash from his colleague," said Chauhan's father Govind Singh. Singh said that his daughter-in-law and Rajveer's wife is a Lieutenant Colonel in the Indian Army and they became parents four months ago. "His wife gave birth to twins four months ago," he said.

Having worked in the Indian Army, Chauhan had a vast experience of flying missions over different terrains, over seeing aerial operations and had been trained in different types of helicopters and their maintenance, according to his LinkedIn profile. As soon as the news about his death broke, Chauhan's relatives and friends started reaching his residence in Shastri Nagar to console the

Rajasthan Chief Minister Bhajanlal Sharma, former chief minister Ashok Gehlot and oth er leaders expressed sorrow over the demise of seven people.

'The news of the loss of life of a pilot from Rajasthan and oth er devotees due to a helicopter crash in Kedarnath is extreme ly sad. May Baba Kedar grant a place in his lotus feet to the de parted souls and give strength to the bereaved families to bear this blow," Sharma said. Gehlot said the "death of seven people including Jaipur resident pilot Rajveer Singh Chauhan, in the helicopter crash near Kedarnath is extremely sad".

"My deepest condolences are with the bereaved families in this difficult time," he said in a social media post.

## Khejri tree rampantly felled at solar sites

Known as the Pride of Rajasthan' and 'Kalp Vriksha' of the desert, khejri has long been struggling for survival due to root borer and fungal infections forcing it to dry up

Jodhpur, June 15: A symbol of survival in the harsh climate of Thar desert and tagged as state tree of Rajasthan, 'khejri'

(Prosopis Cineraria) is now fighting a battle for its survival, desperately looking for another Amrita Bishnoi, who laid

down her life for the protection of the tree in 1730 AD.

However, for past few years, it is faced with a man-made threat -- solar plants -- which has unleashed mass elimination of these trees

This threat stood substantiated when the district administration of Phalodi last year recovered 47 khejri trees buried at a solar plant site in Badi Sid under the Baap tehsil, a prominent site for solar plants.

Activists from different Bishnoi organisations, who staged a demonstration in Phalodi following the recovery against



the indiscriminate felling of the tree, claimed to have satellite images validating their claim that thousands of bighas of land have been cleared to accommodate solar plants in Jaisalmer, Phalodi, Jodhpur and Bikaner districts

Earlier this week, a similar demonstration was reported from Osian, a temple town and emerging solar plant site near Jodhpur, where about 150 khejri tress were cut along with other species such as rohida, the flower of which enjoys the status of state flower in Rajasthan.

Om Prakash Lol, organising secretary of the Bishnoi Tiger Force, an organisation comprising predominantly members from the Bishnoi community known for its pro-environment and wildlife stance, said that if no action is taken against the

"killers" of the tree, they will launch a fierce movement.

Such demonstrations and warnings have become common with the increasing acreage of solar plants in the region, but they have failed to bring a check on indiscriminate and unabated felling of the trees.

Last year, Jaymalsar village in Bikaner district witnessed a 34-day sit-in against the felling of kheiri trees, but it ended with an assurance of action that never came to be. The absence of a stringent

law to penalise the felling of khejri has acted as immunity to the owners of the land or the solar companies.

They are demanding that the fine be increased to ₹2 lakh per tree and a minimum punishment of there years be man-

Alleging connivance between the companies and the administration, Bhawad claimed they dry up the tree either by pouring acid in its roots or by burning its base.

To avoid any legal implication, the solar companies in most of the cases ask the farmers or the owners of the land they are taking on lease to set up plants to clear the land of entire vegetation before taking possession of the same in lure of money. Phalodi District Collector Harii Lal Atal said permission for clearing the land of any vegetation is given by the concerned tehsildar, who is also supposed to keep a watch on the activities.

Taking a serious note of the indiscriminate felling of khejri trees, the National Green Tribunal (NGT) had directed AMP Energy Green Four Pvt Ltd to plant 2,500 trees, 10 times of the trees uprooted from the allotted land measuring 3,200 bighas, besides slapping a cash penalty of

₹2 lakh in October 2022. In April last year, the high court also sought affidavits from the secretaries of revenue, forest and energy departments on illegal felling of trees and damage caused to environment and wildlife due to solar plants at seven villages in Bikaner district.

New Delhi, June 15: After prolonged spell of scorching temperatures for several days, people in the national capital received a gradual respite from heatwave conditions early Sunday, as several parts of the city experienced light rainfall thunderstorm and strong winds.

The India Meteorological Department (IMD) has predicted a severe thunderstorm and strong wind for the city, warning residents in Delhi and the National Capital Region (NCR) to stay

indoors. According to the IMD, "moderate to intense spell of rainfall with thunderstorms and lightning, and squally winds reaching speeds of 80-100 kmph" swept through the capital during the early Sunday hours. Two thundersqualls along

with hailstorm activity were recorded at Safdarjung between 0348 to 0350 hrs IST and 0358 to 0400 hrs IST. The first squall saw gusty

winds reaching 82 kmph, while the second saw a peak wind speed of 104 kmph, the IMD said. The weather department urged residents to take precautions. "Stay indoors and avoid trav-

el unless necessary." the IMD

advisory said, as flying debris

and low visibility posed risks

on the roads. The Safdarjung observatory, Delhi's official weather station, recorded a maximum temperature of 41.2 degrees Celsius Friday -- a dip of 2.7 degrees from Thursday, but still 1.3 degrees Celsius above normal. The minimum temperature remained high at

31.0 degrees Celsius, marking a

departure of 3 degrees Celsius

from the seasonal average. Hu-

midity levels oscillated between

51 per cent and 69 per cent, mak ing conditions hot and uncomfortable throughout the day.

According to IMD officials, the national capital is set to witness generally cloudy skies with very light to moderate rainfall, thunderstorms, dust storms, and lightning till June 19. Gusty winds are also expected during thunderstorms.

This comes after a red alert - a severe warning level - was issued for Delhi, as the capital experienced extreme heatwave conditions. Daytime temperatures climbed to between 41°C and 45°C, while the minimum temperature reached 31°C, marking a rise of four degrees above the seasonal average.

The weather department has predicted partly cloudy skies with a chance of a thunderstorm and rain early Sunday morning, potentially bringing some relief from the intense heat.

The IMD, in its extended range forecast, has said that the southwest monsoon is likely to advance over the remaining parts of central and eastern India, along with some areas in northwest India, between June 12 and 18. It is further expected to reach most parts of northwest India, including Delhi, between June 19 and 25. The normal date for the monsoon to arrive in Delhi is around June 30.

This year, it arrived in Kerala May 24 -- well ahead of the usual onset date of 1 June -- and reached Mumbai by May 26, which is 16 days earlier than normal.

According to IMD data, the monsoon reached Delhi June 28 last year, and on June 26 in 2023.

In previous years, it ar rived June 30 (2022), July 13 (2021), and June 25 (2020). After a nearly 10-day pause, the monsoon has picked up pace again, especially over south ern India. Since Wednesday, several parts of Kerala, Tamil Nadu, Karnataka, Konkan, and Maharashtra have been receiving heavy to very heavy rainfall. This renewed activity marks a strong push northwards, indicating rapid progress of the monsoon across the country.

The IMD has also said the second phase of the monsoon is expected to spread across eastern India, bringing rainfall to West Bengal, Odisha, Bihar, Jharkhand, and eastern Uttar Pradesh within the next week



Mathura, June 15: Three people, including two minor sisters, were killed when a multi-storey building collapsed during excavation work Sunday in the congested Kachchi Sadak area here, officials said.

from the debris. Rescuers are still searching for survivors, they said. District Magistrate (DM) Chandra Prakash Singh said the building was located on a mound. The rescue operation is underway to make sure that no one else is buried under the rubble.

He said Totaram (38) and two sisters -- Yashoda (6) and Kavya (3) -- were killed in the incident. The immediate priority is to complete the rescue work. Later, an investigation will be launched into the cause of the incident and the culprits will be punished, Singh said after inspecting the site.

Senior Superintendent of Police (SSP) Shlok Kumar said one person was earlier rescued from the rubble and taken to hospital. The person is currently under observation and is stable. "Some individuals unauthorisedly started digging near the multi-storey house (likely two or three storeys) using a JCB machine to vacate the plot for sale, and that is why this incident occurred." the SSP said.

"The rescue operation is underway. Teams from fire services, municipal corporation, civil defence and police are currently on the site. "Additionally, National Disaster Response Force and State Disaster Response Force teams have been called in to assist with the rescue efforts," Kumar said.

## **DNA tests identify 80** victims including Rupani

Ahmedabad, June 15: Three days after the tragic crash of Air India flight AI-171 in Ahmedabad. which has so far claimed 270 lives hospital authorities confirmed Sunday the identification of 80 victims through DNA matching, including that of former Gujarat Chief Minister Vijay Rupani.

Authorities have handed over 33 bodies to the victims families, officials said Sunday. Rupani was among the 242 passengers and crew members on board the London-bound Air India flight AI-171 that crashed Thursday. The Gujarat government has announced a state mourning for Rupani Monday. His funeral procession will be held in Rajkot in the evening.

The Boeing 787-8 Dreamliner crashed into a medical college complex moments after taking off from Sardar Vallabhbhai Patel International Airport at 1:39 PM Thursday. So far 29 people are reported to have died in the disaster on the ground which includes five MBBS students. Only one person from the aircraft miraculously survived.

"A total of 80 plane crash victims have been identified so far through DNA matching. Of these, the bodies of 33 victims have been handed over to their respective families," Additional Civil Superintendent Dr Rajnish Patel told reporters. The victims whose mortal remains were handed over were



#### High-level govt panel to meet today for 1st time

NEW DELHI: The first meeting of the high-level multi-disciplinary com-mittee set up by the government to look into the Ahmedabad plane crash will be held Monday here, sources said. The panel, chaired by the home secretary, is expected to submit its report in three months. The committee will have its first meeting Monday afternoon, the sources said. A separate investigation is also being carried out by the Aircraft Accident Investigation Bureau (AAIB), which is looking into the technical aspects of the crash.

Various Central and state government agencies, including the state police, are assisting the AAIB team at the crash site in Meghaninagar.

Sources said the first meeting of a high-level multi-disciplinary committee formed by the Centre will be held Monday in New Delhi. The committee, headed by Union Home Secretary Govind Mohan, is mandated to ascertain the "root cause" of the plane crash and assess any contributing factors, including mechan ical failure, human error, and regulatory compliances.

## Act beyond advisories, evacuate Indian students from Iran: Cong to MEA

New Delhi, June 15: The Congress Sunday claimed that more than 1,500 Indian students are left in a state of uncertainty in Iran and asked the Ministry of External Affairs to move beyond passive advisories to immediately establish a coordinated evacuation mechanism.

The Congress' assertion came after Indians in Iran were Sunday asked not to panic, exercise due caution and maintain contact with the Embassy of India in Tehran through its social media accounts in view of the current situation in the country following the launch of strikes by Israel.

Congress' media and publicity department head Pawan Khera alleged that while Indian students in Iran are calling for help, the government remains largely unresponsive, even as missiles rain from the sky.

"With flights suspended, airspace over Tehran closed, and internet access disrupted, more than 1500 Indian students are left in a state of precarity and uncertainty - with no information about evacuation or safe zones," Khera said in a post on X. The Indian Embassy has issued a generic advisory urging the students to "remain vigilant, avoid all unnecessary movements, follow the Embassy's Social Media accounts and observe safety protocols as advised by local authorities", he said.

"Meanwhile, students remain trapped in distress as the Indi-



an Embassy in Iran remain unresponsive: 'We are traumatized after last night's attack There has been no response from the Indian Embassy. Our families are panicking'," Khera said. He claimed this is not the first time Indian citizens have been left pleading for help during foreign crises. "Wheth er it was Sudan, Ukraine, or now Iran, Modi's government has turned evacuations into propaganda opportunities stepping in late, speaking too much and doing too little, too slowly, Khera alleged.

"The MEA must move beyond passive advisories and immediately establish a coordinated evacuation mechanism -- complete with emergency response teams, real-time communica tion channels and logistic support -- before the window for safe exit narrows any further, he said.

In an advisory, the Indian embassy in Iran asked all Indian nationals and Persons of Indian Origin to remain vigilant, avoid all unnecessary movements, follow the embassy's social media accounts and observe safety protocols as advised by local authorities.

The PMK was not founded to facilitate the formation of government by the DMK or the AIADMK, he said without explicitly naming the two Dravidian parties.

#### Girl critically injured as zipline belt breaks mid-air

NAGPUR: A teenage girl from Maharashtra's Nagpur suffered serious injuries earlier this week after falling from a zipline in Manali. According to reports, the zipline cable snapped mid-air while Trisha Bijwe was on it, causing her to fall several feet to the ground. According to news agency PTI, Trisha was vacationing with her family in Manali. She fell while riding a zipline after the rope connected to a harness she wore snapped. A video of the incident that surfaced on social media shows the girl falling on boulders below after the zipline rope connected to the harness snaps. The girl was rushed to a nearby hospital and later transferred to a specialised facility in the city for further treatment. Trisha suffered several fractures and underwent an operation a few days ago, he said.

#### **Heavy rains batter Kerala**

Thiruvananthapuram: Heavy rains continued to pound various parts of Kerala Sunday, leading to widespread disruptions including uprooted trees, rising river levels, and the opening of shutters at multiple dams. Mudslides in highranges, inundation of low-lying areas and intense sea erosion in the coastal belts were reported across the state. In light of heavy rains, authorities declared a holiday for educational institutions in Malappuram, Kannur, Kasaragod, Wayanad and Thrissur districts for Monday. Though no major casualties were reported anywhere, sporadic incidents of damage to houses and vehicles were recorded in various places across the state. In Malappuram's Kottakkal, a house located on a hilly terrain was damaged in a mudslide Saturday evening. However, the family inside escaped unharmed. Huge trees were uprooted, temporarily disrupting traffic in Sultan Bathery in Wayanad and at Chungam in southern Kottayam district.

#### **UP: Lightning strikes claim 9 lives**

Lucknow: Nine people died in separate lightning strike incidents in Uttar Pradesh's Prayagraj, Sambhal, Bijnor and Gorakhpur districts, officials said Sunday. In Prayagraj, four members of a family in Sonvarsha Hallabor village died after being struck by lightning, they said. Additional District Magistrate (Finance and Revenue) Vinita Singh said Virendra Vanyasi, his wife Paryati and their daughters Radha and Karishma were sleeping in their thatched house when the incident took place Saturday night. The age of the victims is yet to be ascertained, Singh said, adding the bodies have been sent for postmortem. In Sambhal, 18-year-old Ratneshkumari died, and two others were injured after being struck by lightning in Gunnaur tehsil.

Pahalgam (J&K), June 15: Nearly two months after the deadly terror attack here left 26 persons dead, the tourism trade in this south Kashmir resort is limping back to normalcy as locals and a "trickle" from Punjab have started visiting the valley of shepherds after the Eid holidays.

A significant number of Kashmiris from other parts of the valley made their way to Pahalgam on the third day of the Eid, much to the delight of people associated with the tourist trade in this resort, which is 100 kilometres from Srinagar.

Most of the local tourists were happy that Lieutenant Governor Manoj Sinha had decided to open the parks at Pahalgam, saying it would attract more people to the place.

"There is no better advertisement than word of mouth... The people from various parts of Kashmir started to visit soon after Eid, but the numbers did not increase much as they had no place to sit as all the parks were closed. We hope that it will change now as the LG on Saturday announced that the parks will be opened again," said Mohammad Ishaq, a hut owner.

Ishaq said that a few tourists from other states also returned to Pahalgam over the past 10 days. A hotelier, who wished not to be identified, said the Amarnath Yatra usually does not impact his business. The hotelier, however, added that a peaceful and successful yatra will immensely benefit the entire tourism sector of Kashmir as the pilgrims will be "our ambassadors to the rest of India".

"The well killing process is going on, and we have mobilised all necessary equipment for the same. The Crisis Management Team (CMT) is working on war-footing to control the leakage," an official told PTI. The well has not caught fire yet and no one is injured in the incident, while all emergency services have been pressed in the area, he added.

The blowout took place June 12 at well no. RDS 147 of rig no. SKP 135 of Rudrasagar oil field of ONGC at Barichuk of Bhatiapar, A private firm, SK Petro Services, was operating the well on behalf of

#### Modi lands in Cyprus

Nicosia: Prime Minister Narendra Modi arrived in Cyprus Sunday for a two-day visit during which he will hold talks with President Nikos Christodoulides to strengthen bilateral ties. In a special gesture, President Christodoulides welcomed PM Modi on his arrival at the airport. Modi is the first Indian prime minister to visit Cyprus in over two decades. "Landed in Cyprus. My gratitude to the President of Cyprus, Mr. Nikos Christodoulides for the special gesture of welcoming me at the airport. This visit will add significant momentum to India-Cyprus relations, especially in areas like trade, investment and more," Modi posted on X.

#### Saudi executes scribe

**Dubai:** A prominent Saudi journalist who was arrested in 2018 and convicted on terrorism and treason charges has been executed, the kingdom said. Activist groups maintain that the charges against him were trumped up. Turki Al-Jasser was put to death Saturday, according to the official Saudi Press Agency after the death penalty was upheld by the nation's top court. Authorities had raided Al-Jasser's home in 2018. arresting him and seizing his computer and phones.

#### China patrols in SCS

Beijing: China's military held joint sea and air patrols in the South China Sea Saturday, a spokesperson for the People's Liberation Army's Southern Theater Command said. Spokesperson Tian Junli said in a statement on Sunday that the Philippines has courted countries outside the region to organise "joint patrols" and "raised security risks" in the region. "The theater command forces remain on high alert, resolutely safeguarding China's national sovereignty and maritime rights," he said, adding that "all military activities that seek to stir up trouble in the South China Sea or create flashpoints are fully under control.'

#### Hot air balloon crashes

Istanbul: A hot air balloon crashed in central Turkiye Sunday, leaving its pilot dead and 19 Indonesian tourists injured, a local official said. State-run Anadolu Agency said another hot air balloon taking off from the same location of Ilhara Valley also made a hard landing early Sunday morning, and that 12 Indian tourists were slightly injured and taken to hospital.

# Israel, Iran conflict turns deadly

Israel launched **Operation Rising Lion** early Friday, targeting Iran's nuclear, missile and military infrastructure. Iran later launched retaliatory strikes on Israel, which has

Jerusalem, June 15: The death toll grew Sunday as Israel and Iran exchanged missile attacks for a third consecutive day, with Israel warning that worse is to come.

Israel targeted Iran's Defence Ministry headquarters in Tehran and sites it alleged were associated with Iran's nuclear programme, while Iranian missiles evaded Israeli air defences and slammed into buildings deep inside Israel.

Israel's strikes have killed at least 406 people in Iran and wounded another 654, according to a human rights group that has long tracked the country, Washington-based Human Rights Activists. Iran's government has not offered overall casualty figures.

The country's main international airport and airspace remained closed for a third day.

The region braced for a drawn-out conflict after Israel's strikes hit nuclear and military facilities, killing several senior generals and top nuclear scientists. President Donald Trump said the US had "nothing to do with the attack on Iran" and warned Tehran to expect "the full strength and might of the US Armed Forces" if it retaliates against the United States.

#### Iran's prez criticises US, Western nations

Iran's President Masoud

Pezeshkian criticised United States and some Western countries for supporting Israel's attacks on Iran.

He said that if Israeli attacks continue, Iran's responses "will be more decisive and severe.'

Pezeshkian said that Israel "is not capable of any action without the permission of the US" and that "what we are witnessing today is being done with the direct support of Washington.

In a report carried on state TV, Pezeshkian said that Iran has never sought war and conflict. "However, just as our armed forces, including the powerful army and Islamic Revolutionary Guard, have so far provided appropriate and firm responses, in case of continued hostile actions, the responses will be more decisive and severe.

#### 'Israel doesn't want regime change in Iran'

Israel's Foreign Minister Gideon Sa'ar said Sunday that the goal of its military campaign in Iran "is not a regime

"This is for the Iranian people to decide," Sa'ar said in an interview. He said the Israeli security Cabinet set the objective as eliminating Iran's nuclear program and minimising its ballistic missile threat.

"I believe what we are doing, as an ally for the US and for the Western civilization as a whole, is critical for stability in this part of the world," Sa'ar said, adding: "If we learn something from our history. when somebody says I'm going to eliminate the Jews,' take him at his word.'

Sa'ar said Iran was within six months of being able to build as many as nine nuclear bombs.

#### Iraqi militia warns US

The powerful Iran-linked Iraqi militia Kataib Hezbollah Sunday warned it will target US interests and bases in the region if Washington intervenes in the hostilities between Israel and Iran.

The group said in a statement that it is "closely monitoring the movements of the American enemy's military in the region" and "should the United States intervene in the war (between Israel and Iran), we will directly target its interests and bases spread throughout the region without hesitation.'

The statement was the first explicit and direct threat issued by an Iraqi militia to target US forces and interests in the region since the outbreak of the Iran-Israel conflict.

Iraqi militias have previously targeted US bases in Iraq and Syria, but have largely remained quiet since Israel launched a barrage of strikes on Iran and Tehran retaliated. Three drones launched at the Ain al Assad base housing US troops in western Iraq on Friday were shot down, and no group has claimed responsibility for the attack.

#### Iran, Israel should make deal just like I got India, Pak to make one: Trump

S President Donald Trump Sunday claimed that he could secure a deal between Iran and Israel just as he had done between other arch-rivals. as he repeated his claim that he stopped the war between India and Pakistan last month by "using trade". In a post on Truth Social, Trump also claimed that "many calls and meetings are now taking place" on the issue. "Iran and Israel should make a deal, and will make a deal, just like I got India and Pakistan to make, in that case by using TRADE with the United States to bring reason, cohesion, and sanity into the talks with two excellent leaders who were able to quickly make a decision and STOP!" Trump claimed. He said, "Likewise, we will have PEACE, soon, between Israel and Iran! Many calls and meetings now taking place. I do a lot, and never get credit for anything, but that's OK, the PEOPLE understand. MAKE THE MIDDLE EAST GREAT AGAIN!"

#### Trump vetoed Israeli plan to kill Khamenei

President Donald Trump vetoed a plan presented by Israel to the US to kill Iran's Supreme Leader Ayatollah Ali Khamenei, according to a US official familiar with the matter. The Israelis informed the Trump administration in recent days that it had developed a credible plan to kill Khamanei. After being briefed on the plan, the White House made clear to Israeli officials that Trump was opposed to the Israelis making the move, according to the official who was not authorised to comment on the sensitive matter and spoke on the condition of anonymity. The Trump administration is desperate to keep Israel's military operation aimed at decapitating Iran's nuclear programme from exploding into an even more expansive conflict and saw the plan to kill Khamene as a move that would enflame the conflict and potentially destabilise the region.

#### Trump admin weighs adding 36 countries to travel ban, memo says

Washington, June 15: US President Donald Trump's administration is considering sig nificantly expanding its trave restrictions by potentially ban ning citizens of 36 additional countries from entering the United States, according to an internal State Department cable seen by Reuters

Earlier this month, the Republican president signed a proclamation that banned the entry of citizens from 12 countries, saying the move was need ed to protect the United States against "foreign terrorists" and other national security threats

The directive was part of an immigration crackdown Trump launched this year at the start of his second term, which has included the deportation to E Salvador of hundreds of Vene zuelans suspected of being gang members, as well as efforts to deny enrollments of some foreign students from US univer sities and deport others.

The countries that could face a full or a partial ban if they do not address these concerns within the next 60 days are: Angola, Anti gua and Barbuda, Benin, Bhutan Burkina Faso, Cabo Verde, Cam bodia, Cameroon, Cote D'Ivoire Democratic Republic of Congo Djibouti, Dominica, Ethiopia, Egypt, Gabon, The Gambia, Gha na, Kyrgyzstan, Liberia, Malawi Mauritania, Niger, Nigeria, Saint Kitts and Nevis, Saint Lucia, Sao Tome and Principe, Senegal, South Sudan, Syria, Tanzania, Tonga, Tuvalu, Uganda, Vanuatu, Zambia, and Zimbabwe.

That would be a significant expansion of the ban that came into effect earlier this month The countries affected were Afghanistan, Myanmar, Chad Congo Republic, Equatoria Guinea, Eritrea, Haiti, Iran, Lib ya, Somalia, Sudan and Yemen

The entry of people from seven other countries - Burundi, Cuba, Laos, Sierra Leone, Togo, Turkmenistan and Venezuela - has also been partially restricted.

# India-origin man dies days after Oz police allegedly knelt on his neck

Melbourne, June 15: A 42-year-old Indian-origin man has died days after an Australian police officer allegedly knelt on his neck during an attempted arrest, a media report said Sunday.

Gaurav Kundi, 42, from Modbury North in Adelaide, died surrounded by his family Thursday after he was hospitalised for an "unrecoverable" brain injury, 7News Australia reported.

Police attempted to arrest Kundi on Payneham Rd at Royston Park, alleging that it witnessed an "altercation" between him and a woman.

The video footage of the incident showed Kundi being forced by police while he and



his wife, Amritpal Kaur, loudly protested.

"I've done nothing wrong," Kundi shouted while Kaur filmed and cried out that the police were acting unfairly.

Kundi was rushed to the hospital after his condition declined and he "became unresponsive" during the attempted arrest.

Police said Kundi violently resisted the arrest and was intoxicated. It said the couple was



allegedly arguing, and a passing patrol reportedly mistook the incident for domestic violence.

However, Kaur said his husband was simply drunk and loud, not violent.

Meanwhile, South Australian (SA) Police Commissioner Grant Stevens told ABC Radio Adelaide it would investigate the incident in addition to a probe by the internal investigation section detectives.

#### **Ex-French prez Sarkozy stripped of**



Paris: France's former President Nicolas Sarkozy has been stripped of his Legion of Honour medal after being convicted last year of corruption and influence peddling while he was the country's head of state, it was announced Sunday.

The decision was made via a decree released in the Journal Officiel that publishes the government's major legal information. It comes in line with the rules of the Legion of Honour. The conservative politician, who was president from 2007 to 2012, has been at the heart of a series of legal cases since leaving office. He was found guilty of corruption and influence peddling by both a Paris court in 2021 and an appeals court in 2023 for trying to bribe a magistrate in exchange for information about a legal case in which he was implicated. He was sentenced to wear an electronic monitoring bracelet for one year, a verdict upheld by France's highest court, the Court of Cassation, in December. Earlier this year, Sarkozy stood trial over allegations he received millions of dollars from Libya for his successful presidential campaign in 2007. He denies the claims. Prosecutors requested a seven-year prison sentence. The verdict is expected in September.

#### Russia hands over 1,200 war dead bodies to Ukraine

received the bodies of another 1,200 Ukrainian soldiers killed in the war with Russia, as part of agreements to exchange



both prisoners of war and the dead, Ukrainian officials said Sunday. In several exchanges so far this month, Ukraine has repatriated more than 4,800 bodies, Ukrainian officials said. This marks one of the largest returns of war dead since Russia launched its full-scale invasion of Ukraine in February 2022. Russian state news agencies TASS and RIA both reported the handover, saying Moscow had not received a single Russian corpse in return. It is the fourth in a series of handovers of soldiers' remains to take place in the past week, in accordance with an agreement reached between Russia and Ukraine at talks in Istanbul earlier this month. Kyiv and Moscow agreed to each hand over as many as 6,000 bodies and to exchange sick and heavily wounded prisoners of war and those aged under 25. Russia has so far reported only receiving a total of 27 Russian servicemen in return. Ukraine and Russia have conducted three exchanges of POWs so far, but have not disclosed exact numbers.

## After day of protests, Trump's military parade rolls through DC

**Largest outpouring of protests against** Trump since his return to power

Washington, June 15: President Donald Trump's longsought military parade rolled through the streets of downtown Washington Saturday, but the celebration of the US Army's 250th anniversary was marred by a day of violence and discord.

In the hours before the parade began, hundreds of thousands of Americans marched and rallied in streets in cities from New York to Chicago to Los Angeles, protesting Trump's actions while in office, in the largest such actions since his return to power in January.

Earlier in the day, a gunman assassinated a Democratic lawmaker and wounded another

Meanwhile, Israel and Iran exchanged further attacks early Sunday, stoking fears of a mushrooming conflict between the two nations.

All of it followed a week of tension in Los Angeles, where protests over federal immigration raids resulted in Trump calling in National Guard troops and US Marines to help keep the peace, over the objections of the state's Democratic Governor Gavin Newsom.

The parade, which fell on Trump's 79th birthday, kicked off earlier than expected with thunderstorms forecast in the Washington area. Tanks, armored personnel

down the parade route along storied Constitution Avenue, an unusual sight in the US where such displays of military might are rare.

Thousands of spectators

The demonstrations were largely peaceful, and marked the largest outpouring of opposition to Trump's presidency since he returned

to power in January. In Los Angeles, however, the situation remained tense. About an hour before a downtown curfew, police officers mounted on horses were aggressively pushing back demonstrators, using gas, flash bangs and other less lethal munitions, causing large groups to panic and flee.

Protesters were firing what police called commercial-grade fireworks against officers along with rocks and bottles

## **Iran-Israel** war may affect India exports

The escalating tensions between Iran and Israel are also sending shockwaves through global stock markets, with India's benchmark Sensex closing 573 points lower Friday

New Delhi, June 15: The Iran-Israel conflict has further increased global economic uncertainties, impacting world trade, including India's exports, as it is expected to drive up both air and sea freight rates, exporters say.

They said that India's exports to Europe and counters like Russia may get impacted due to this war. If the conflict continues for long, the movement of merchant ships through routes such as Strait of Hormuz between Iran and UAE, and Red Sea would be affected.

"The war will further hurt global trade. The situation was gradually improving but now again the trade will be impacted. Our exports to Europe and countries like Russia may get hurt. Freight rates and insurance are expected to increase,' Federation of Indian Export Organisations (FIEO) President S C Ralhan said.

Indian export consignments gradually started moving through the Red Sea route but now again it would get impacted, he said. The immediate fallout of the conflict that started on early Friday or June 13 will be freight and insurance charges going up after a period of calm as Red Sea routes were slowly coming back to normal, Mumbai-based exporter and Technocraft Industries Ltd Founder Chairman S K Saraf said. Cargo ships had gradually returned on Red Sea routes, saving those 15-20 days while moving to US and Europe from India and other parts of Asia.

"The merchant ships will again avoid the Red Sea which will lead to escalation of freight costs that will have to be borne by traders. If war would go beyond a week, it can push freight rates by about 50 per cent." he added

The present conflict that began with an attack on Israel on October 7, 2023 had brought cargo movement through Red Sea routes to a halt due to attacks by Houthi rebels on commercial shipping. After the US intervened with attacks on the rebels, the firing on commercial ships stopped.

'Everything depends on whether the conflict remains localised or expands to include other countries. Its impact will

be first felt in global crude oil prices." FIEO Director General Ajay Sahai said.

Apart from the Red Sea route, this time transit through Strait of Hormuz is another factor that is weighing on the world energy trade. The Strait of Hormuz, located between Oman and Iran, connects the Persian Gulf with the Gulf of Oman and the Arabian Sea. Around 21 per cent of global

petroleum liquids consumption passes through that route. China, India, Japan, and South Korea were the top destinations for crude oil moving through the Strait, Oman also uses this route to supply liquefied natural gas to India. Only Saudi Arabia and the United Arab Emirates (UAE) have operating pipelines that can circumvent the Strait of Hormuz.

Around 80 per cent of India's merchandise trade with Europe passes through the Red Sea and substantial trade with the US also takes this route. Both these geographies account for 34 per cent of the country's total exports.

India's exports to Israel have fallen sharply to \$2.1 billion in 2024-25 from \$4.5 billion in 2023-24. Imports from Israel came down to \$1.6 billion in the last fiscal from \$2.0 billion in 2023-24.

Similarly, exports to Iran of \$1.4 billion, which were at the same level in 2024-25 as in 2023-24. could also suffer. India's imports from Iran were at \$441 million in FY25 as against \$625 million in the previous year.

The conflict adds to the pressure world trade was under after the US President Donald Trump announced high tariffs. The government is expected to hold meetings with exporters in the coming days to discuss the recent developments.

Based on the tariff war impact, the World Trade Organisation (WTO) has already said that the global trade will contract 0.2 per cent in 2025 as against the earlier projection of 2.7 per cent expansion.

India's overall exports that had grown 6 per cent on year to \$825 billion in 2024-25 were expected to touch \$1 trillion by the end of this year, according to FIEO, and it could fall well short of this target due to geopolitical uncertainties.

## Iran-Israel conflict, likely to drive mkts

New Delhi, June 15: Stock investors will track the ongoing conflict between Iran and Israel, Brent crude oil prices, inflation data and US Fed interest rate decision for further cues this week, analysts said.

Tariff-related news would also dictate trends in the equity market, experts noted. Stock markets faced heightened volatility last week and ended in the red amid escalating geopolitical tensions, which sparked a risk-off sentiment. Investor sentiment was hit hard on surging oil prices as fears of supply disruptions resurfaced.

"Indian stock markets are likely to follow the global trend, following rising tension in the Middle East amid the Israel-Iran conflict, which could fuel further pessimism and prompt investors to flee riskier assets. Also, traders

## AIF investments up 32% to ₹5.38 lakh cr

New Delhi, June 15: India's affluent investors are increasingly turning to Alternative Investment Funds (AIFs) with investments in the space reaching ₹5.38 lakh crore by the end of the March 2025 quarter, a surge of 32 per cent from the vear earlier.

This increase is being driven by heightened market volatility and shifting global macroeconomic conditions, prompting the wealthy to seek more diversified and resilient portfolio options, according to investment advisory firm Multi-Act Trade and Investments

This trend marks a departure from the traditional equity-debt mix, as the country's affluent investors or High Net worth Individuals (HNIs) move into the AIFs space, which include private equity, hedge funds, real assets, private credit, and other non-traditional instruments that typically have low correlation with public markets.

The appeal of these alternatives is driven by their potential to offer higher returns as well as stability during periods of market stress

"As HNIs navigate persistent

volatility, global macroeconomic shifts, and a low-yield environment, the demand for diversified and resilient portfolios is on the rise," Multi-Act noted.

To support this view, Sebi data showed that cumulative investments in Indian AIFs surged 32 per cent year-on-year to ₹5.38 lakh crore in Q4 FY2025 from ₹4.07 lakh crore in Q4 FY2024. This suggests a clear shift in asset allocation strategy among HNIs and family offices

"Family office portfolios have a really long horizon, so their ability to participate in private investments is much higher than most other investors,' the firm added, highlighting a key advantage that allows these entities to engage in alternative assets. Multi-Act attributed this increase to a combination of factors such as the need for diversification, a hedge against inflation, and access to expert management.

AIFs have been divided into three categories I, II, and III - covering early-stage venture capital, private equity, private credit, infrastructure, and long-short hedge strategies -- each offering a unique mix of risk, return potential, and

The former Manchester United and England captain is now 'Sir David Beckham', a title befitting one of the most influential and celebrated footballers of all time. Widely regarded as one of the greatest midfielders in the



history of the game, Beckham enjoyed a stellar playing career that spanned across top clubs and continents. He represented footballing giants such as Manchester United, Real Madrid, AC Milan, Paris Saint-Ger-

main, and LA Galaxy, leaving his mark with world-class performances and a legacy of

At the international level, Beckham donned the England shirt 115 times between 1996

and 2009, scoring 17 goals, and captained his country in many memorable moments.

His club career is decorated with silverware. At Manchester United, Beckham was an integral part of Sir Alex Ferguson's golden era, playing 265 Premier League matches and scoring 62 goals. Beckham later moved to Real Madrid, where he made 116 appearances and netted 13 goals. His football journey then took him to the United States, and joined LA Galaxy, contributing 18 goals in 98 appearances.

Beckham also signed for AC Milan, making 29 appearances and scoring 2 goals, and ended his playing career at Paris Saint-Germain.

He has been a UNICEF Goodwill Ambassador since 2005.

Beckham was in India and watched India's semifinal clash against New Zealand in Mumbai on November 15 during the Men's Cricket World Cup. He interacted with cricket greats like Virat Kohli and Sachin Tendulkar.
