





She further mentioned that the mood of the scene then trickles from the director and is then picked up by the HODs and the actors.





Car fest fervour grips City

Bhubaneswar, June 26: As the world-famous Rath Yatra is set to begin in Puri Friday (June 27), The Capital city is buzzing with festive fervour. The City will burst into vibrant celebrations and joyous events across temples and institutions, embracing the sacred spirit of this grand festival.

One of the City's shining highlights is the ISKCON Temple in Nayapalli, where thousands of devotees

eagerly gather each year for the spec tacular chariot festival. This year, the festivities will shine even brighter with the Rath Yatra, Bahuda Yatra (July 5), and the dazzling Suna Besha (July 6). The chariot-pulling ceremony at ISKCON is a lively spectacle, drawing enthusiastic crowds who come to seek blessings from Lord Jagannath, Lord Balabhadra, and Devi Subhadra.

Bhubaneswar's renowned educational institutions, including KIIT University, Utkal University, and the Regional College of Management (RCM), are joining the celebrations with great zeal. Since 2007, the Jagannath Temple at RCM has grown into a vibrant hub for Rath Yatra, attracting over 40,000 devotees every year to witness the joyous procession of the deities.

But the festive spirit doesn't stop there. Across neighbourhoods like Patia, VSS Nagar, Sailashree Vihar, Kolathia, Jagamara, Vani Vihar, Bhimatangi, Dumduma, Baramunda, Laxmi Sagar, OUAT, and Old Town, communities come together to pull chariots and offer heartfelt prayers, filling the City with devotion and cheer.

This sacred celebration crosses borders too. Odias living in the USA, Australia, the UAE, and beyond are joyfully honouring Lord Jagannath's divine journey with community events, keeping the tradition alive worldwide.

Righagarh temple through lens of history

he centuries-old Sri Baladev-jew Temple in Righagarh under Ishwarpur panchayat in Rajnagar block of Kendrapara district holds immense historical significance.

Legend says this temple stands as a lasting tribute to King Balabhadra Bhanja of the Bhanja dynasty. Built in the late 14th century, when Righagarh was the capital of the Kanika estate, its royal palace also stood nearby. Initially commissioned during the reign of King Biswanath Bhania. the temple was completed under King Balabhadra Bhanja, who installed the deities himself.

In 1909, King Rajendra Narayan Bhanjadeo undertook a major restoration, giving the temple its present appearance. Since then, it has been preserved by the Kanika royal family's temple trust.

By the early 20th century, as King Rajendra Narayan Bhanjadeo moved the capital elsewhere, Righagarh fell into decline. The grand palace eventually crum-



bled into ruin. Yet, despite its rural surroundings, the temple remains a vivid reminder of the area's glorious past and a proud symbol of Kendrapara district's rich cultural heritage.

Interestingly, while the three main deities were crafted in traditional Srikhetra style, Lord Balabhadra's idol here is noticeably larger than Lord Jagannath's.

The temple's jagmohan was built in Rajasthani style, and at its Singhadwara, exquisite depictions of Vishnu's ten avatars from Jayadeva's Gita Govinda and the Navagrahas adorn the walls. Inside the sanctum, one can admire a brass image of Narasimha along-

side Radha-Krishna, four-armed Vishnu idols, rare palm-leaf manuscripts, and sacred shalagrams.

Despite this glorious heritage, neglect has taken its toll. Muddy paths and lack of devotees have even led to the cancellation of Rath Yatra for years. Due to the dense forests and marshes surrounding Righagarh, pulling a chariot was impossible for decades. Even 70 or 80 years ago, attempts failed. Hence, a temple chariot with intricate Rangoli was created inside the shrine so that rituals could continue.

Recently, local youth and cultural leaders like Professor Lalit Lenka and Devendra Raul, supported by Kanika royal Shivendranarayan Bhanjadeo and Queen Mrunalini Devi, have revived hopes of conducting a grand Rath Yatra now that roads to Righagarh are fully paved. Bhanjadeo acknowledged that, with collective effort, a full-scale chariot festival may soon become a reality.


Resource Diplomacy

esource competition has long underpinned international relations. But it seems to be taking center stage again, much like the nineteenth-century Scramble for Africa or Western grabs for Middle Eastern oil in the last century.

As demand rises for the critical minerals that power the industries of the future, many countries are rushing to gain an edge. The United States recently struck a high-profile minerals deal with Ukraine, which, for its part, wants to prevent a further hemorrhaging of US support for its war with Russia. US President Donald Trump has also talked of acquiring Greenland partly because of its potential mineral wealth, while his administration is negotiating deals with other mineral-rich countries, such as the Democratic Republic of the Congo.

Moreover, natural resources are increasingly being wielded as a foreign-policy weapon. In 2022, after Europe sanctioned Russia for its invasion of Ukraine, the Kremlin scaled back gas exports to the continent. And in the past few months, China has restricted exports of rare-earth elements as part of its trade war with the US, while India has suspended the Indus Water Treaty, a water-sharing agreement with Pakistan, following a terrorist attack on Hindu tourists in Kashmir. And the conflict between Israel and Iran has raised concerns among Israel's Western allies that Iran could disrupt shipments of oil and gas from the Persian Gulf.

Control of oil and gas flows has long shaped geopolitics, but critical minerals have lately taken on new importance because escalating geopolitical tensions are accelerating efforts to bolster defense capabilities and shifting the AI race into high gear, all while the global clean-energy transition continues apace. Constructing new missiles, data centers, and electricity grids requires enormous amounts of metals and minerals, such as copper, cobalt, lithium, and nickel. In an increasingly divided world where China dominates the refining and processing of many of these critical minerals, many countries understandably fear losing access to them.



For starters, resource diplomacy takes careful long-term planning. China's critical-mineral domination was not achieved overnight; it is the result of strategic foresight. Decades ago, the Chinese government adopted a forward-looking industrial policy and began investing in mining projects abroad and forging alliances with resource-rich countries. By

contrast, many Western governments, having only recently woke up to the dangers of dependency on other countries for critical minerals, have made little headway in securing their own supply chains for these raw materials, despite introducing multiple initiatives to

European governments were similarly shortsighted when they allowed themselves to become dependent on Russian gas in the years prior to the Ukraine war. As the continent learned in 2022, scrambling to diversify suppliers during or after a crisis can be highly costly and disruptive.

Moreover, countries must focus less on concluding impressive-sounding deals, and more on getting the boring details right. Understanding the technical and economic aspects of resource extraction and processing will determine whether these agreements achieve their long-term aims.

For example, mining executives have criticized the US-Ukraine resources deal for exaggerating the value of the country's critical minerals and the potential for attracting private investment to exploit them. Likewise, US officials may be overestimating the commercial viability of the minerals under Greenland's ice. In both cases, while Trump's manoeuvres have certainly garnered attention, they may do little to strengthen US mineral security.

Of course, countries should not exert too much control over others' resources, at least not without ensuring significant local benefits. Otherwise, they risk generating resentment and fuelling a backlash. In the 1960s and 70s, Western oil firms were booted out of much of the Middle East because host governments felt they were getting too little in return. Today. Western mining firms are being squeezed in some parts of Africa and Latin America, owing to similar local perceptions. While Chinese mining firms have gained ground in Africa by portraying themselves as more supportive of local development, they, too, are sometimes tarred with the same neo-colonialist brush. Securing resources without sowing suspicion is easier said than done.

Finally, resource-rich countries should recognize that weaponizing their exports may backfire: importers may shift away from the relevant commodity or retaliate in other ways. A striking historical example is the 1973 Arab oil embargo. While this delivered the intended shortterm result – inflicting economic pain on Western countries – it also impelled those countries to develop new oil fields outside the Arab world, such as in Alaska and the North Sea.

In the same vein, Russia's decision to cut gas flows to Europe caused initial pain, but ended up devastating a once-lucrative export market, which has now secured alternative energy supplies. And more countries are at risk of making the same mistake. India's suspension of the Indus Water Treaty has raised fears that China, Pakistan's ally, may weaponize the waterways under its control that flow to India. Likewise, in tightening global exports of its rare earths, China risks accelerating moves to open up rare-earth mining and processing facilities elsewhere in the world. When it comes to securing access to natural resources or using them as geopolitical tools, headline-grabbing moves rarely produce the desired outcome, especially over the long term. Instead, effective resource diplomacy requires sensitivity, expertise, foresight, and balance – qualities that, unfortunately, are not prevalent among today's political leaders.

GOVERNANCE AT IMF

were in the news. They are still in the news. One is the Hollywood blockbuster Mission: Impossible's Impossible Mission Force (IMF), and the other is the International Monetary Fund (IMF) or the Fund. During 'Operation Sindoor', India's tactical military strike against terrorist hideouts in Pakistan involved in the Pahalgam kill ings, the IMF approved a loan to Pakistan. That specific act by the IMF has been vehemently criticised by both the public and the government in India, with some even referring to it as the 'International Military Fund'. Is it arguably logical and reasonable to criticise the Leviathan of the world political economy, the IMF, one of the Western-led dominant multilateral institutions?

It's not uncommon to hear condemnation of the Bretton Woods Institutions, particularly from left-leaning civil societies and academics. Yet, it is quite unusual for senior members and ministers of a founding member country, i.e. India, to engage in a spree of severe scrutiny of the IMF. On 9 May, the IMF Executive Board approved a lending amount of \$1 billion to Pakistan under an earlier agreed (September 2024) longterm programme. Additionally, another \$1.4 billion was approved for Pakistan's efforts in economic resilience to climate vulnerabilities and natural disasters. Evidently, that was enough to ignite the Indian backlash during the height of a limited war with its arch-rival.

Was the approval of that loan to Pakistan—a country that has been relentlessly supporting terrorism against India—by the IMF board legitimate? The financial assistance provided by the IMF to Pakistan is valid. In fact, Pakistan, which became a member in 1950, has been receiving financial and technical aid from the IMF. like other borrowing member countries. In 2024, the IMF approved a 37-monthlong structural adjustment programme loan amounting to nearly \$7 billion. Some Indian leaders expect that the

IMF should impose strict conditionalities on Pakistan to discourage it from terrorist activities against India. Generally, IMF loans come with conditionalities that require borrowers to change their economic policies to create markets for Western economies.

The Bretton Woods institutions were established with the sole aim of rehabilitating and reconstructing war-rayaged Europe under the leadership of the Allied Powers, especially the US. Independent India neither participated nor became a founding member. Instead, it was India under British rule that participated in the Conference and became a so-called founding member in 1945. The Fund plays a crucial role in the balance of payments. In simple terms, the Fund provides financial assistance to debt-ridden countries like Pakistan in the interest of Western liberal capitalism.

How can India, in its wishful thinking, persuade the IMF or other multilateral institutions to put pressure on Pakistan? Former Foreign Secretary and National Security Advisor (2010-2014), Shivshankar Menon, recently said in an interview that Indian diplomacy must not aim towards preventing the IMF from funding Pakistan. Contrastingly, it is being claimed that the NDA government has been pursuing the tenets of complete diplomacy-Sama (conciliation), Dama (reward), Danda (punishment) and Bheda (dissension) - in protecting India's national interest. Directly, India has the option of a) abstaining from the

loan approval board meetings, or b) formally voting against the loan through its representation in the Board Meeting. Had India attempted these two permissible actions in the IMF?

Indeed, India abstained from formal voting while raising serious concerns about the possibility of Islamabad's misuse of debt financing funds for state-sponsored cross-border terrorism. However, India's formal concerns didn't prevent the IMF from approving the bailout package to Pakistan. More likely, India's position in the Russia-Ukraine war had a definite reflection in the approval of the bailout for Pakistan. Perhaps, European countries holding incredible economic clout and voting share found a suitable payback time for India's bromance with Moscow during

the ongoing war in Ukraine. Does India have enough influence on the IMF Board to change its course of action? Certainly not. India's decision to terminate and temporarily appoint its executive director to prevent Sri Lanka's nominee from becoming director is directly linked to the loan to Pakistan. However, India's influence on the IMF's decisions remains limited because of its voting share. As one of the 25 Executive Directors (EDs) representing 191 member countries at the IMF Board, India's voting share is only 2.63% of the total, while the US holds the largest and only double-digit share at 16.49%. Seven countries appoint their own EDs, while the remaining 18 EDs are chosen from 184 member countries. Western

and European nations, control nearly 44% of the total vote. Meanwhile, India represents a group of countries that includes Bangladesh, Bhutan, and Sri Lanka. With such disparities in decision-making, the IMF and the Bretton Woods institutions are among the least democratic organisations, unlike the UN General Assembly, where each country has one vote.

After a prolonged battle to

reform IMF's governance structure, a slight increase in the voting share, adopted in 2010, has not fully reflected the role and power of emerging markets, especially in G20 countries. Besides, IMF does not disclose the decision-making at the Board in public despite being the highest intergovernmental public institution. When the most crucial decisions (no matter if it's authoritarian or whimsical) are being coordinated, completed, communicated and coerced upon in social media, the transparency is not as exemplary as expected from a progressive public institution. Above all, the US elects its citizens as the President of the World Bank Group, while Europe decides its own for the Managing Director of the IMF.

Reforming multilateral institutions must not be confined to speeches and statements or select media interactions in the Western Hemisphere. Moreover, India's boasting of a trillion-dollar economy, or the 'Vishwa Guru', does not transform its claim into realpolitik. India must act with like-minded emerging economies to transform multilateral institutions to reflect fair representation. Whereas China, India's sole competitor for the coveted leadership role for the Global South, has successfully initiated multilateral intergovernmental institutions like the Asian Infrastructure Investment Bank and the International Organisation for Mediation to counter Western dominance. India must translate its foreign policy objectives into reality.

State of poverty: A reality check

otwithstanding the BJP-led NDA government claiming various achievements, a detailed analysis reveals that development has primarily benefited the upper echelons of society. The poorer sections have been overlooked, as evidenced by the declining standards of health and education nationwide, for which the states also bear some responsibility.

These observations have been somewhat substantiated by the World Bank. Though it has found that 171 million Indians had been pulled out of extreme poverty and this is quite encouraging, it has revised the poverty line upwards from \$2.15 per head per day to \$3 per head per day. When the poverty line is raised, more people are expected to be included as poor, not less.

However, if one examines some other metrics of development such as per capita income, the Human Development Index and the Global

Hunger Index, the country's rankings are 144, 130 and 105 respectively, which are poor. Moreover, while the World Bank report has talked about the number coming out of extreme poverty, it has not stated in what category they are now. Most, if not all, of those who may have come out of extreme poverty have to depend on the state for free rations & other forms of support.

One may refer here to the Congress booklet, '11 Saal, Jhoothe Vikaas Ke Vaade', (11 years, false development claims) which has quoted extensively from published data to nullify the government's claims. Citing the Global Hunger Index report, the Congress stated: "Malnutrition remains a national crisis. Stunting (low height for age) is at 35.5%, wasting (low weight for height) at 19.3% and underweight (low weight for age) at 32.1%." It referred to the World Bank report regarding Swaachh Bharat, which said: "Toilet usage dropped since 2018-19 by 20 points among SCs and 24 points among STs due to non-functional toilets, lack of water and poor maintenance."

Though GDP growth has remained steady, food inflation has increased rapidly, affecting the poor and marginalized sections. The most distressing factor, however, has been lack of iob creation as manufacturing did not expand while the government also failed to diversify exports and enter new markets.

The government must focus attention on the rural sector and make appropriate allocation for the rural employment programme, which is not being done. Moreover, the money that is being paid is far less than the minimum wages of the states. This should be looked into while such a programme for the urban poor, as argued by many economists, may need to be given a rethink.

Another important aspect that needs to be considered is the education sector which is in the Concurrent List and thus the Central government has a key responsibility in this sector, more so because the states are cash-starved. The formulation of Right to Education has little meaning if the learning outcomes do not improve.

Given the financial constraints faced by the governments and the fact that international agencies have suggested that the super-rich be taxed more, authorities should consider introducing at least some cess. Many countries, even rich economies, have wealth tax and inheritance tax but in India these do not exist. The government should take note of a quote of political scientist, Sheldon Wolin: "Ordinary men and women can recognize that their concerns are best protected and cultivated under a regime whose actions are governed by principles of commonality, equality and fairness." Thus, in all fairness the present dispensation must garner more resources for the welfare needs of the struggling masses.

Stop digging the past



Srimandir's spiritual glory shines at

he annual Snana Yatra, the sacred bathing ritual of Lord Jagannath, was • once held within the precincts of the Srimandir in Puri.

Lord Jagannath, revered as the presiding deity of Odias, embodies human-like activities. Each year, accompanied by His siblings, Lord Balabhadra and Devi Subhadra, He embarks on a journey to the Gundicha Temple on chariots and returns to the temple's sanctum after a nine-day sojourn. This vibrant festival, globally renowned as the Rath Yatra, has occasionally faced interruptions in its long

Typically held at the Snana Mandap in the temple's Ananda Bazaar on Jyestha Purnima, the ritual was instead performed on wooden throne near the Ratna Bedi, where Lord Jagannath's Nabajaubana Besha (youthful attire) is usually displayed. fered to Lord Jagannath at the Shree Jagannath Temple, one of the most essential yet lesser-known is the Darji Seba – the tailor's service. Renowned heritage scholar Surendra Kumar Mishra explains that this service is an indispensable component of temple rituals and has been meticulously preserved for generations.

The tailors serving in this capacity are collectively known as 'Darji Sevaks'. They operate under the leadership of a 'Sardar' (chief), who



organises and supervises their tasks, as recorded in Srimandir Record of Rights (RoR). These servitors work according to ancient service rolls (Bedhapatra), with only the Darji chief authorised to tie the ceremonial cloth known as 'Sadhi/Saree'. No other tailor may perform this specific duty. This is a hereditary service, tradi-

tionally passed down within families. Darji servitors are often associated with the Mahapatra surname. They start serving once they acquire the necessary skills and knowledge. Each Bedha (service group) has a defined structure and sequence, determining who works when and in what order. There are a total of 12 Bedhas dedicated to tailoring duties, ensuring yearround service in alignment with the temple calendar.

This system illustrates the scale and complexity of 'Darji' service. Tailors are integral to all 13 major annual rituals of the Lord. During the reign of Gajapati kings, 'Darji' servitors were officially recognised through royal decrees (Sanands). A royal order which is still with Deulakarana servitors of the temple shows that these designated tailors had the exclusive right to sew and sell the ceremonial flags (Bana) hoisted atop Srimandir's 'Nilachakra'. Some tailors even held property deeds (Kabala) from the Gajapati kings, earning them the name 'Kabaladar Darji'. These privileges allowed for the buying and selling of the tailoring rights a practice still remembered today. If a tailor could not perform his duties or lacked heirs, he was permitted to Puri's spiritual heritage, their thread sell his service entitlement to another qualified individual.

Top court issues guidelines for retention, disposal of records

The Supreme Court highlights a lacuna over the management of administrative records

New Delhi, June 26: The Supreme Court Thursday issued guidelines for retention and disposal of documents to create accountability and efficiency across all registry wings.

The top court highlighted a lacuna over the management of administrative records.

In a message, Chief Justice of India BR Gavai said over the years, the registry of the Supreme Court has witnessed a significant increase in the volume and diversity of administrative records generated across multiple branches. "While judicial records per-

taining to case proceedings are governed by explicit provisions contained in Order LVI of the Supreme Court Rules, 2013, and further elaborated in Chapter XXI of the Handbook on Practice and Office Procedure of the Supreme Court of India, 2017, a lacuna has persisted with respect to the management of administrative records," he said.

The CJI continued, "This disparity leads to inconsistent practices across branches, affecting archival clarity and efficiency. The 'Guidelines for



Retention and Destruction of Records 2025' aim to remedy this by promoting coherence, accountability, and efficiency in managing administrative records, including institutional decisions, policy implementations, inter-departmental correspondences, audits, and engagements with external stakeholders.'

CJI Gavai underscored the importance of properly managing these records for transparency and accountability and guidelines to establish a rational framework.

"Operational efficiency is enhanced by the systematic elimination of obsolete documents, easing storage burdens and improving record retrieval speed. The Guidelines ensure compliance with audit and statutory obligations by defining appropriate retention periods based on fiscal, legal. an administrative relevance. They are aligned with national public record management standards.'

The guidelines were stated to have borne out of detailed consultations among registrars and officials of the registry.

"I place on record my sincere appreciation for the efforts of Pradip Y. Ladekar, Registrar at the Supreme Court, who played the instrumental role in drafting these Guidelines. He was ably supported by his staff members throughout the process. I also appreciate Bharat Parashar, Secretary General, and SC Munghate, Officer on Special Duty (in the rank of Secretary General), for their leadership and guidance in steering the Registry through this important initiative," he said.

According to the issued guidelines, original submission notes or paper books bearing signatures of the chief justice of India and judges of the Supreme Court to be preserved permanently.

Further, policy files, office orders and circular files were to be preserved permanently.

US asks visa applicants to share social media usernames

New Delhi, June 26: Outlining each visa adjudication as a "national security decision", the US has asked applicants to share their social media usernames or handles of each platform they have used in the last five years.

The US Embassy in India shared the information in a brief statement issued Thursday, which also cautioned against "omitting" social media

visa denial and ineligibility for future visas" The statement which was

posted on X read, "Visa applicants are required to list all social media usernames or handles of every platform they have used from the last 5 years on the DS-160 visa application form. Applicants certify that the information in their visa application is true and correct before they

sign and submit."

The communication continued, "Omitting social media information could lead to visa denial and ineligibility for future visas." The US Embassy asked those applying for an F, M, or J non-immigrant visa to switch the privacy settings of their social media accounts to "public" to facilitate vetting, which it said was necessary to establish their identity and admissibility to the US under law.

Saffron flags featuring Lord Jagannath and banners reading 'Welcome to Jagannath Dham' lined the entire 180 km stretch of the national highway from Kolkata to the town.


While thousands of devotees have already reached Digha, devotional songs invoking Lord Jagannath were being played continuously over the public address system.

Shukla enters International Space Station

New Delhi: IAF test pilot Group Captain Shubhanshu Shukla Thursday became the first Indian to set foot on the International Space Station as he and three other astronauts entered the orbital laboratory to warm hugs and handshakes after the docking of their spacecraft at the end of a 28-hour journey around the earth. Scripting history with this feat, Shukla, 39, became the 634th astronaut to travel to space with the Indian Air Force's fighter pilot ending his brief remarks after entering the ISS with a "Jai Hind Jai Bharat" message. He is also the second Indiar space in 41 years and the first since Rakesh Sharma's eight-day sojourn in 1984. "With your love and blessings, I have reached the International Space Station It looks easy to stand here, but my head is a little heavy, facing some difficulty; but these are minor issues," he said in brief remarks in Hindi at the formal welcome ceremony at the ISS. "We will get used to it. This is the first step of this journey."

Responsibility of interim govt to protect Hindus: India on damage to temple in Dhaka

NEW DELHI: India Thursday denounced the reported destruction of a Durga temple in Dhaka and said it is the responsibility of Bangladesh's interim government to protect Hindus as well as religious institutions. External Affairs Ministry spokesperson Randhir Jaiswal also said India is prepared to engage with Bangladesh on "all matters" in an environment that is conducive for mutually beneficial dialogue. His remarks came in response to a question on possible renewal of Ganges water treaty with Bangladesh next year. Jaiswal was critical of Bangladeshi authorities for the reported destruction of the temple. "We understand that extremists were clamoring for demolishing the Durga temple in Khilkhet, Dhaka," he said. "The interim government, instead of providing security to the temple, projected the episode as illegal land use...and they allowed the destruction of the temple today," he said, "This has resulted in damage to the deity before it was shifted. We are dismayed that such incidents continue to recur in Bangladesh," he added.

DRUG ABUSE AND ILLICIT TRAFFICKING

Role of RPF under the NDPS Act

rune 26, observed as the International Day against Drug Abuse and Illicit Trafficking, highlights the urgent need to combat the global drug menace. India, facing growing challenges from rising narcotic consumption among youth, has empowered the Railway Protection Force (RPF) under the NDPS Act, 1985, since 2019 to prevent misuse of its vast railway network for drug trafficking.

Indian Railways, due to its extensive reach and high passenger volume, had become a key conduit for drug smuggling. The RPF, traditionally tasked with protecting railway property, now plays a pivotal role in narcotics control. In 2024, the



RPF conducted over 1700 operations, seizing contraband worth 227.5 crore and arresting 1,489 traffickers.

Major recoveries include 31.5 kg methamphetamine worth 150 crore in Madurai, 1.03 kg brown sugar in Nabadwip Dham, and over 24 kg of charas in various states. These operations reflect a shift towards intelligence-led policing and

strategic coordination with agencies like NCB, DRI, and state police.

Emerging smuggling corridors such as the Lumding-Arunachal and Odisha-Southern States routes indicate evolving trafficking trends. Common tactics include using general class coaches, night trains, and concealing drugs in luggage.

To combat these challenges, the RPF is enhancing capabilities through dog squads, advanced training, data analytics, and installation of large baggage scanners at key stations. However, issues like resource gaps, porous borders, and balancing surveillance with privacy remain. MANOJ YADAVA IPS

29 kids killed in school

Bangui: An explosion and the stampede that followed killed at least 29 schoolchildren and injured more than 250 at a high school in Central African Republic's capital city, authorities said Thursday. The explosion occurred Wednesday at the Barthelemy Boganda High School in Bangui when power was being restored to an electrical transformer within the school premises after it malfunctioned, according to the country's Ministry of National Education. Most of the victims - including 16 girls - died at the scene after the explosion resulted in a stampede while others were confirmed dead at the hospital, the Ministry of Health said in a statement. At least 260 were injured and being treated in various hospitals,

PIO woman assaulted

the ministry said.

Ottawa: A 23-year-old Indian woman was brutally attacked and robbed near her home in Winnipeg, the capital of the Canadian province of Manitoba, and a teenager has been arrested in connection with the incident, police said. The woman, identified by community members as Tanpreet Kaur, was walking back to her apartment in Winnipeg after finishing her evening shift late when she was ambushed by two strangers at the 1-99 block of Roslyn Road shortly after midnight June 23. Winnipeg police said in a statement on Wednesday that bystanders in the area stopped the attack after which suspects quickly fled after stabbing and robbing the victim of her property.

Toll from deluge rises

Johannesburg: The death toll from severe floods that inundated parts of South Africa's rural Eastern Cape province two weeks ago has risen to 101, with a 12-monthold baby the youngest fatality, authorities said Thursday. Two children are still missing. Heavy rain June 9 and 10 caused by a cold front resulted in floods that swept away victims and their houses, trapped others in their homes, damaged roads and other infrastructure and cut electricity supplies.

Curbs on cannabis sale

Bangkok: Thailand is further tightening control of cannabis by banning sales of the plant to those without prescriptions. Thailand became the first country in Asia to decriminalise cannabis in 2022, in a move that boosted Thailand's tourism and farming, and spawned thousands of shops. But the country has faced public backlash over allegations that under-regulation has made the drug available to children and

Khamenei talks tough

Iran's supreme leader warns against further American attacks in his first statement since ceasefire

Dubai, June 26: Iran's Supreme Leader Ayatollah Ali Khamenei said Thursday his country had delivered a "slap to America's face" with its strike on an American base in Qatar, and warned against any further US attacks in his first public comments since a ceasefire was declared with Israel after 12 days of war.

Khamenei spoke in a recorded video broadcast on Iranian state television, his first appearance since June 19 The 86-year-old looked and sounded more tired than he did only a week ago, speaking in a hoarse voice and occasionally stumbling over his words. The more-than 10 minute

speech by the supreme leader was filled with warnings and threats directed toward the United States and Israel.

He downplayed Sunday's US strikes on three Iranian nuclear sites using bunker-buster bombs and cruise missiles, saying that US President Donald Trump — who said the attack "completely and fully obliterated Iran's nuclear programme had "exaggerated" its impact. "They could not achieve any-

thing significant," he said. UN nuclear watchdog con-

firms damage to Iran sites The head of the UN nucle-

ar watchdog, International Atomic Energy Agency Director Rafael Grossi, reiterated Thursday that the damage done by Israeli and US strikes at Iranian nuclear facilities "is very, very, very considerable.

"I think annihilated is too much but it suffered enormous damage," Grossi told French broadcaster RFI.

Iran's Foreign Ministry spokesman, Esmail Baghaei, Wednesday also conceded that



'our nuclear installations have been badly damaged, that's for sure.

Khamenei has not been seen in public since taking shelter in a secret location after the outbreak of the war June 13 when Israel attacked Iranian nuclear facilities and targeted top military commanders and scientists.

Following Sunday's US attack on Iran's nuclear facilities, Trump was able to help negotiate a ceasefire that came into effect Tuesday

Khamenei claimed the US had only intervened in the war because "it felt that if it did not intervene, the Zionist regime would be utterly destroyed."

Life slowly returns to normal Majid Akhavan, spokesperson for the Ministry of Roads and Urban Development, said Iran had reopened the airspace for the eastern half of the country to domestic and international flights, including those transiting Iranian airspace.

Earlier this week, Tehran said 606 people had been killed in the conflict in Iran, with 5,332 people wounded. The Washington-based Human Rights Activists group released figures Wednesday suggesting Israeli strikes on Iran had killed at least 1,054 and wounded 4,476.

The group, which has provided detailed casualty figures from multiple rounds of unrest in Iran, said 417 of those killed were civilians and 318 were security forces.

At least 28 people were killed in Israel and more than 1.000 wounded, according to officials

During the 12-day war, Iran fired more than 550 missiles at Israel with a 90 per cent interception rate, according to new statistics released by Israeli authorities Thursday. Israel, meantime, hit more than 720 Iranian military infrastructure targets and eight nuclear-related sites. Israel said.

Trump has also asserted that American and Iranian officials will talk next week, giving rise to cautious hope for longer-term peace.

Iran has not acknowledged any such talks would take place, though US Mideast envoy Steve Witkoff has said there has been direct and indirect communication between the countries. A sixth round of US-Iran negotiations was scheduled for earlier this month in Oman but was cancelled after Israel attacked Iran June 13.

United Nations, June 26: India strongly rejected Pakistan's "unwarranted aspersions" over UN processes and attempts to deflect attention from atrocities committed against children in the country and rampant cross-border terrorism, asserting that the world has not forgotten the Pahalgam attacks.

"I am constrained to respond to the politically motivated remarks made by the delegate of Pakistan, one of the grave violators of the CAAC (Children and Armed Conflict) agenda," India's Permanent Representative to the UN Ambassador P Harish said.

In a statement at the UN Security Council open debate on 'Effective strategies to end and prevent grave violations against children' Wednesday. Harish said that Pakistan is casting unwarranted aspersions over UN processes and also smearing India at various discussions to pursue their nefarious agenda

"We reject this attempt by Pakistan to deflect attention from the atrocities committed against children in their country, as highlighted in the Sec-

Secretary General has "expressed concern at the rise in such grave violations reported including attacks against schools, particularly girls' schools, against health workers. and about the incidents in the border areas with Afghanistan where a series of killing and maiming of Afghan children was directly attributed to cross border shelling and air strikes by Pakistani armed forces!'

"To preach at this body after such behaviour is grossly hypocritical," Harish said.

He told the Council that the

world has not forgotten the "savage targeted attacks" by Pakistani and Pakistani-trained terrorists killing 26 tourists in India in Pahalgam, Jammu and Kashmir April 22.

He noted that the Security Council had issued a Press Statement April 25 that had underlined the need to hold perpetrators, organisers, financiers and sponsors of this reprehensible act accountable and bring them to justice.

"And yet, they try to preach to others," the Indian envoy said. The Secretary General's re-

port on Children and armed conflict noted that a total of 99 grave violations against 86 children (27 boys, 14 girls, 45 sex unknown) were reported in Pakistan. A total of 13 attacks on schools were reported and insecurity had a negative impact on health workers.

Nairobi: The number of Kenyans who died during Wednesday's nationwide protests over police brutality and bad governance has doubled to 16, according to the state-funded human rights commission. Property was also destroyed in the protests that attracted thousands of frustrated young Kenyans. At least two police stations were razed down by angry protesters. Kenyans demonstrated Wednesday in 23 of 47 counties across the country calling for an end to police brutality and better governance. Thousands chanted anti-government slogans, and the protests morphed to calls for President William Ruto to resign. Many protesters were enraged by the recent death of a blogger in custody and the shooting of a civilian during protests over the blogger's death.

Trump gets 'golden share' power in US Steel buyout

Harrisburg: President Donald Trump will control the so-called "golden share" that's part of the national security agreement under which he allowed Japan-based Nippon Steel to buy out iconic American steelmaker US Steel, according to disclosures with the US Securities and Exchange Commission. The provision gives the president the power to appoint a board member and have a say in company decisions that affect domestic steel production and competition with overseas producers. Under the provision, Trump — or someone he designates — controls that decision-making power while he is president. However, control over those powers reverts to the Treasury Department and the Commerce Department when anyone else is president, according to the filings. The White House responded in a statement that the share is "not granted to Trump specifically, but to whoever the president is" when asked why Trump will directly control the decision-making and why it goes to the Treasury and Commerce departments under future presidents.

RBI urges banks to pass on 50bps rate cut to customers

The Reserve Bank of India is encouraging banks to lower lending rates to ensure recent policy rate cuts are effectively passed on to borrowers. Financial conditions are favorable for this transmission, with banks already reducing rates following earlier cuts

Mumbai, June 26: Reserve Bank of India (RBI) bulletin / report has suggested that all banks should bring down their lending rates for speedy transmission of the policy rate, which was lowered by 50 basis points earlier this month.

An article published in the Reserve Bank's June Bulletin stressed that the financial conditions remained conducive to facilitating an efficient transmission of rate cuts.

Most of the banks have already passed on the rate cuts announced in February and April to their customers.

It may be mentioned here that several large banks, including SBI, Bank of Baroda. and HDFC Bank, have already passed on the benchmark lending rate-linked interest rate to borrowers by the same margin within days of the RBI cutting repo rate by a jumbo 50 bps on June 6.

Besides reducing the repo rate by 50 bps earlier



this month, the RBI had announced a reduction in the cash reserve ratio (CRR) by 100 bps to 3 per cent of net demand and time liabilities (NDTL) in a staggered manner during the latter half of the vear.

"Financial conditions remained conducive to facilitate an efficient transmission of rate cuts to the credit market," said an article on 'State of the Economy' in the Reserve Bank's June 2025 Bul-

The reduction in CRR would release primary liquidity of about Rs 2.5 lakh crore into the banking system by December 2025.

"Besides providing durable liquidity, it will reduce the cost of funds for banks, thereby facilitating monetary policy transmission to the credit market," the article added. The central bank, however, said that the views expressed in the Bulletin article are those of the authors and do not represent the views of the Reserve Bank of India.

The article noted that the 50-bps cut in the policy repo rate during February-April 2025 reflected in banks' repo-linked external benchmark-based lending rates (EBLRs) and marginal cost of funds-based lending rate (MCLR).

Consequently, the weighted average lending rate (WALR) on fresh and outstanding rupee loans of banks declined by 6 bps and 17 bps, respectively, during the period February-April 2025.

On the deposit side, the weighted average domestic term deposit rates (WADT-DRs) on fresh and outstanding deposits moderated by 27 bps and 1 bp, respectively, during the same period.

The 30-share BSE Sensex jumped 1,000.36 points or 1.21 per cent to settle at 83,755.87. During the day, it surged 1,056.58 points or 1.27 per cent to 83,812.09.

As many as 2,097 stocks advanced while 1,900 declined and 156 remained unchanged on the BSE. The 50-share NSE Nifty rallied 304.25 points or 1.21 per cent to 25,549.

From the Sensex constituents, Tata Steel, Bajaj Finance, Bharti Airtel, Adani Ports, Eternal, Bajaj Finserv, NTPC, HDFC Bank, Reliance Industries and Axis Bank were among the major gainers.

Shares of Reliance Industries climbed nearly 2 per cent Thursday, with its market valuation again breaching the coveted Rs 20 lakh crore marks. In contrast, Trent, State Bank of India, Tech Mahindra, Maruti and Mahindra & Mahindra were among the laggards.

The BSE midcap gauge climbed 0.56 per cent, and smallcap index went up by 0.12 per cent. Among BSE sectoral indices, metal jumped 2.28 per cent, oil & gas (1.88 per cent), energy (1.68 per cent), commodities (1.39 per cent), financial services (1.25 per cent), utilities (1.24 per cent) and power (1.13 per cent).





India register thrilling 2-wicket win over Eng at 'Home of Cricket'

London, June 26: India's Mixed Disability Team held its nerve and sealed a thrilling two-wicket win over England in the last over at Lord's in the third T20I of Mixed Disability Vitality seven-match IT20 series at the Lord's Cricket Ground.

The occasion was historic as it was the first-ever international Disability match at the 'Home of Cricket.' The date, venue and the result of the match all made for a tremendous coincidence- 42 years back, India, led by the legendary Kapil Dev, had clinched the 1983 World Cup on June 25 at Lord's in 1983.

"We dedicate our team's historic win to Kapil Dev sir's team's 1983 World Cup-winning team," said Ravi Chauhan, the general secretary of the Differently-Abled Cricket Council of India (DCCI).

June 25 is incidentally celebrated as the 'World Mixed Disability Day.'

SKY undergoes surgery

New Delhi: India's T20I captain Suryakumar Yadav has undergone a successful surgery for a sports hernia in his lower right abdomen in Munich, Germany. PTI had reported last week that Suryakumar was suffering from sports hernia in his right lower abdomen and will go under the knife if required. "Life Update: Underwent surgery for a sports hernia in the lower right abdomen. Grateful to share that after a smooth surgery, I'm already on the road to recovery. Can't wait to be back," the 34-year-old batter wrote on his social media handle Wednesday. A sports hernia is a soft tissue injury in the groin or lower abdomen, often involving muscles, tendons, or ligaments. India's next white-ball assignment is a tour of Bangladesh in August, which will have three ODIs and three T20Is.

Tanvi to lead India

New Delhi: The fast-rising Tanvi Sharma was Thursday named in India's 19-member squad for the Badminton Asian Junior Championships (team and individual) to be held in Solo. Indonesia from July 18 to 27. Tanvi won a gold in the Badminton Asia women's team championship. Junior world No 1 men's doubles pair of Bhargava Ram Arigela and Viswa Tei Gibburu will also be critical to India's chances in the event. The team competitions are scheduled from July 18-22 while the individual events will be held from July 23-27. The team event will be played in a relay format, with the first side to reach 110 points declared the winner. It will begin with a group stage, followed by knockout rounds, with the top two teams from each group advancing.

India-Oz match craze

Melbourne: India's white-ball tour of Australia is still four months away but Cricket Australia (CA) has already sold more than 90,000 tickets for eight matches with third ODI in Sydney and first Twenty20 in Canberra completely sold out. India will travel Down Under in October-November to compete in three ODIs -- starting October 19 in Perth -- and five T20 Internationals -- the last one in Brisbane November 8.

Archer returns to Eng

The star pacer last played in a Test more than

New Delhi, June 26: Fast bowler Jofra Archer returns to the England Test set-up for the first time since February 2021 after being named in the squad for the second Anderson-Tendulkar Trophy game against India, starting at Edghaston July 2

"The 30-year-old right-arm quick returns to the England Test set-up for the first time since February 2021 and will be looking to add to his 13 Test caps at Edgbaston next week," the ECB said in a statement.

England lead five-match series 1-0 after defeating India in the opening Test by five wickets at Leeds.

A recurrence of an elbow injury and a stress fracture in the back meant Archer was largely sidelined from playing Tests for England after February 2021. Archer turned out for Sussex in their recent County Championship game against Durham at Chester-Le-Street, marking his first red-ball appearance in four years, and returned with figures of 1-32 in 18 overs.

A thumb injury sustained while playing for Rajasthan Royals (RR) at the Indian Premier League (IPL) in early May further delayed Archer's return to first-class cricket and caused him to miss England's white-ball series against the West Indies.

With the 30-year-old pacer, whose last Test appearance came over four years ago against

India in Ahmedabad in 2021, now making a long-awaited return to the Test team, he will be looking to add to his 13 caps and 42 wickets at an average of 31.04, at Edgbaston next week.

It remains to be seen who, between Josh Tongue, who picked seven wickets in the first game, and Brydon Carse, with four scalps to his name, will drop out of the playing eleven to accommodate Archer. Sam Cook, Jamie Overton, and Jacob Bethell retain their places in the squad.

England are currently leading the Anderson-Tendulkar Trophy series 1-0, after sealing a thrilling five-wicket win with a successful chase of 371 at Headingley. Another win for them at Edgbaston will give them a chance to seal the fivematch series in the third game at Lord's, starting July 10.

Clean sweep by India

Historic moment as seeders secure hat-trick of gold medals in men's doubles, women's doubles and mixed doubles

Kuala Lumpur, June 26: In a remarkable achievement, India swept all the three titles -- men's, women's and mixed events -- in the second Asian Squash Doubles Championships after beating their respective rivals in the finals here Thursday. The top-seeded men's pair

of Abhay Singh and Velavan Senthilkumar lost the first set but made a comeback to beat their Pakistani opponents Noor Zaman and Nasir Iqbal 2-1 (9-11, 11-5, 11-5) in the summit clash that lasted 88 minutes. The Indian duo had reached

the final after beating Hong Kong pair of Chi Him Wong



and Ming Hong Tang in the semifinals.

In the women's doubles final, second seeds Joshana Chinappa and Anahat Singh also rallied from a set down to win 2-1 (8-11, 11-9, 11-10) against Malaysia's Ainaa Amani and Xin Ying Yee in a 35-minute final.

Joshna and Anahat had

made it to the summit clash after beating Hong Kong's Po Yui Kirstie Wong and Yee Lam Toby Tse.

The top-seeded mixed doubles pair of Abhay and Anahat made it a clean sweep of titles for India as they beat Malaysia's Rachel Arnold and Ameeshenraj Chandaran 2-0 (11-9, 11-7) in the 28-minute summit showdown.

In the process, Abhay and Anahat bagged their second title of the championships.

They had made it to the last-two stage after beating another local pair of Ainaa Amani and Syafiq Kamal in the semifinals.

Shoan betters national meet record, Karnataka finish first

Bhubaneswar, June 26: Shoan Ganguly bettered his national meet record in 400m medley on the fifth and final day of the Senior National Aquatic Championships with Karnataka finishing at the top with a haul of total 41 medals.

Karnataka's Ganguly clocked 4:24.64 to finish first in the 400m medley whereas Advait Page came in second with 4:26.90. followed by Aryan Nehra from Madhva Pradesh with a timing of 4:30.35. In women's 100m backstroke, Karnataka's Vihitha Loganathan bagged the gold medal with 1:05.18 followed by Bengal's Soubrity Mondal (1:05.19) and Odisha's Pratvasa Ray (1:05.64). SSCB's Likith Prema finished first in men's 100m breaststroke with 1:03.16, while Tamil Nadu pair of Danush Suresh (1:03.11) and MS Yadesh Babu (1:03.81) came in



second and third respectively.

In women's 100m breaststroke, RSPB's Harshitha Jayaram finished with 1:13.24 followed by Mannata Mishra (Odisha) and Saanvi Deshwal (Maharashtra), who both clocked 1:15.57.

On the final day of the 78th edition of the tournament, Karnataka recorded a total haul of 41 medals including 16 gold medals. 11 silver and 14 bronze.

ICC introduces stop clock in new WTC cycle

Dubai, June 26: The ICC has introduced stop clock in Test cricket to deal with slow over rates while allowing fielding teams to decide which batter should be on strike in case of a 'deliberate' short-run as part of the playing conditions for 2025-27 World Test Championship cycle.

The new rules have been implemented from the 2025-2027 World Test Championship which got underway with the first of the two Tests between Sri Lanka and Bangladesh in Galle.

According to the ICC Test Match Playing Conditions on the governing body's website, the use of the stop clock — like in limited-overs cricket — has been implemented to eradicate the issue of slow over-rate.

"The fielding side shall be ready to start each over within 60 seconds of the previous over being completed. An electronic clock will be displayed at the ground that counts up seconds from zero to 60," the ICC said.

The fielding side will thus be given two warnings and in case of a third infraction, the batting side will be awarded with five penalty runs.

These warnings will be reset to zero after the completion of 80 overs, the ICC said.

Meanwhile, ESPNcricinfo reported that the ICC no longer mandates the umpires to change the ball once they discover saliva on it. The ban on the use of saliva remains in force.

The website said fielding teams may deliberately apply saliva on the ball to force a ball-change but the current document available on playing conditions for men's Test cricket does not mention any such change.

The ICC also said in case

there are instances of referrals being made by both player and the on-field umpire, the process will be carried out in a chronological order, effectively as per the order of their occurrence.

The ICC instructed that in case of a second review of a decision adjudged 'out' by

an on-field umpire, the default decision for the subsequent mode of dismissal will remain 'out'. For ex-

ample, if a batter challenges an on-field call for caught-behind and is adjudged not out with the replays showing the

ball hit the pads, the TV umpire would subsequently turn to see if the batter was out leg-before.

In such a scenario, the default decision for this mode of dismissal will be 'out' and if the ball-tracking shows 'umpire's



In Greenland, 24-hour summer sun means its football season

Nuuk (Greenland), June 26: For most of the year, Greenland is covered in ice and snow and its locals retreat indoors. But for three short months beginning in June, everyone heads outside — day and night — to watch or play football, the island's favorite sport.

On an island of roughly 56,000 people, about 5,500 — nearly 10% of the population — are registered football players. So it was a crushing blow in early June when the Confederation of North, Central America and Caribbean Association Football, or CONCACAF, unanimously rejected the Greenlandic Football Association's application to become a member.

Some blamed politics for the decision in light of US President Donald Trump's repeated wish to take control of the strategic, mineral-rich island. CONCACAF is one of six conti-

nental federations under FIFA, soccer's world governing body that oversees the World Cup.

But Patrick Frederiksen

But Patrick Frederiksen, captain of the national team, thinks CONCACAF's rejection came down to money.

"We all know it's really expensive to travel to Greenland," he said. Earlier this month, the first direct flight from the US to Greenland by an American airline landed in the capital, Nuuk. The one-way ticket from Newark International Airport in New Jersey cost roughly \$1,200. The return flight from Nuuk had a \$1,300 to \$1,500 price tag. Other flights require a layover in Iceland or Copenhagen, Denmark.

Greenland, technically European territory, might have been expected to seek membership in UEFA. But the European federation only allows members from countries recognized as independent per sovereignty rules introduced

in 2007. CONCACAF has no such restrictions. Despite the recent headlines, the Arctic island's inhabitants are more concerned this summer with getting to the nearest field. They want to take advantage of the 24-hour sunlight even if the temperatures hover around 5 to 10 degrees Celsius (41 to 50

degrees Fahrenheit) in Nuuk.

Picturesque outdoor fields, featuring views of drifting icebergs and snow-capped mountain peaks even in late June, range from artificial turf to dirt to real grass, though older players remember dribbling across

"You should come watch a

game," said Oscar Scott Carl, coach of the B-67 club in Nuuk. "You can see how much people go into the game, how much cheering from the attenders."

"It's also a big part of creat-

ing unity in the country, having a sport to gather around and celebrate wins and being a part of something bigger than only football, to be honest," he added. The Kalaallit Arsaattartut Kattuffiat, Greenland's national football association, was founded in 1971 and regulates multiple men's and women's teams. Community projects are also important to the island's soccer culture and national team players serve as role models for local youth. Something to show

The national team of the Faeroe Islands, a semi-independent Danish territory in the North Atlantic, is a member of

the world

FIFA and UEFA, which over sees European soccer.

It's a sore spot for Greenlanders, especially after CON-CACAF's decision. The Faeroe Islands team joined the tournaments more than three decades ago, before there were requirements such as a stadium with tens of thousands of seats, among others.

among others.

Visit Greenland, the government's tourism agency, said that a national stadium has "long been on the wish list for many in Greenland." But with such a small population, an arena with a minimum of 40,000 seats — more than 70% of the island's inhabitants — "is sadly not in the pipeline," the agency wrote on its website.

Still, Jimmy Holm Jensen, chairman of Nuuk's B-67 club, wishes Greenland's teams could at least play in international soccer tournaments. Right now, they only can compete in friendly matches abroad.
