#### Ratna Bhandar: 600 stone slabs replaced

Puri, July 7: The Archaeological Survey of India (ASI) has completed the conservation and repair works of Ratna Bhandar (both inner and outer chambers) of Puri Srimandir, said Chief Administrator of Shree Jagannath Temple Administration (SJTA) Arabinda Padhee Monday, adding that 600 stone slabs were replaced with new ones

The SJTA chief shared the up dates on his official account, say ing, "Blessed to inform that the conservation and repair works of Ratna Bhandar (both Bhitara and Bahara) of Shree Mandira by ASI concluded today. All Mahaprabhu's blessings!

The restoration involved replacing around 600 stone slabs with new ones, meticulously replicating the traditional designs while ensuring enhanced structural safety. The ASI be gan work inside the temple vault in July 2024 when it was reopened after 46 years. The initial focus was on preparing an inventory of valuables and assessing the structure for necessary repairs.

Padhee explained that both the outer and inner sections were preserved with the applica tion of chemical coatings. Fourteen beams have been repaired and over 80 skilled craftsmen contributed their expertise to

# **Roll revision unites Oppn**

Amid growing chorus against the Election Commission's (EC) conduct of Special Intensive Revision (SIR) in Bihar, the Congress Monday said that the Opposition is united against the contentious move ahead of the Assembly elections in the eastern state. Maintaining that such a provision has no legal basis, nor does it find any mention in the rules, the party said the term doesn't even exist in electoral law. With the EC move being termed by many as 'mass-scale rigging and mischief, aimed at disenfranchising the vast number of voters', all eyes are now set on the Supreme Court, which has agreed to hear a batch of petitions challenging the exercise July 10

New Delhi, July 7: Joining nine other parties in challenging the special intensive revision of electoral rolls in Bihar before the Supreme Court, the Congress Monday said the entire Opposition is united on the issue and alleged that the exercise is aimed at disenfranchising the vast number of voters with its "mischievous methodology".



The Opposition party said it has full faith that the apex court will deliver justice, as it claimed that the revision exercise initiated by the Election Commission (EC) just ahead of Assembly elections in Bihar is causing chaos across villages and towns in the state by creating anxiety among crores of voters who fear their right to vote will be stolen.

Congress general secretary (Organisation) KC Venugopal said as a signatory on behalf of the Indian National Congress, along with various Opposition parties, he has approached the Supreme Court against the "blatantly unconstitutional SIR exercise" in Bihar.

"It has wreaked havoc across

villages and towns of Bihar, giving crores of voters anxiety about whether their right to vote will be stolen. This is mass-scale rigging and mischief being carried out by the ECI, under instructions from the ruling regime." Venugopal alleged in a post on X.

"We have faith that the Hon'ble Supreme Court will deliver justice," he said.

The party's in charge of the media and publicity department. Pawan Khera, said the Congress. said, "Today, the INC, along with nine political parties, came together to file a challenge to the flawed and destructive SIR being carried out by the ECI."

"The entire Opposition stands together to oppose an

exercise that is guaranteed to disenfranchise a vast number of voters due to its malicious and mischievous methodology. The Supreme Court has listed the matter for Thursday, July 10, 2025. Satyamev Jayate, Khera said in his post on X.

In a post in Hindi on X, Congress general secretary Randeep Surjewala said, "Democracy or BJP's vote suppression mechanism? Bihar is asking, the country is asking!'

He said Bihar's voter list was finalised in January 2025, and the EC itself acknowledged this. Revisions were made until June, and then, suddenly, it was discarded, he noted.

"Without any proof, without any discrepancies, 7 crore voters now have to prove their Indian citizenship again. Those whose names were added after 2003 are being viewed with suspicion. Citizens who have been voting for the past 20 years are now being asked for identification. residence, and citizenship documents," Surjewala said.

Meanwhile, the Supreme Court Monday agreed to hear July 10 a batch of petitions challenging the decision of the EC to undertake SIR in Bihar.

The deceased were identified as Dash Sabar, 70, from Usthapalli village and Prakash Raita, 37, of Bhismagiri area. At least six seriously ill persons



in the village are undergoing treatment at MKCG Medical College and Hospital here, another officer said. The exact cause of the outbreak is yet to be ascertained, said a medical officer of the block.

### Washington, July 7: A discov-

ery made by a NASA rover has offered a clue for the mystery as to why Mars is barren and uninhabitable, while life has always thrived here on our relatively similar planet Earth. A new research has revealed recently that while rivers once sporadically flowed on Mars, it was doomed to mostly be a desert planet.

Mars is thought to currently have all the necessary ingredients for life except for perhaps the most important one: liquid water, the research revealed.

However, the red surface is carved out by ancient rivers and lakes, showing that water once flowed on our nearest neighbour. There are currently

several rovers searching Mars for signs of life that could have existed back in those more habitable times, millions of years ago.

Earlier this year, NASA's Curiosity rover discovered a missing piece in this puzzle: rocks that are rich in carbonate minerals.

These carbonates - such as limestone on Earth - act as a sponge for carbon dioxide, pulling it in from the atmosphere and trapping it in rock. A new study, published in

the journal Nature, modelled exactly how the existence of these rocks could change our understanding of Mars's past. Lead study author Edwin

Kite, a planetary scientist at

the University of Chicago and a

member of the Curiosity team,

told AFP it appeared there were

anything to survive. It is still possible that there are pockets of liquid water deep underground on Mars we have not vet found. Kite said.

NASA's Perseverance Rov er, which landed on an ancient Martian delta in 2021, has also found signs of carbonates at the

Similarly, the Horticulture Service cadre has been increased from 403 to 470 posts. following the creation of 67 new positions. The expansion is expected to enhance technical support for horticulture farmers, and promote innovation in the sector. "Given horticulture's growing contribution to Odisha's agricultural economy, the move is seen as a significant step toward boosting productivity and sustainable practices," the CMO said.

"The restructuring of these services reflects the government's commitment to modernising agriculture and ensuring inclusive growth in rural areas," a senior official from the Department of Agriculture and Farmers' Empowerment said. Experts believe that the added capacity will translate into better outreach, training, and support for farmers, thereby improving overall agricultural performance in the state.

New Delhi, July 7: The Enforcement Directorate (ED) Monday said authorities in West Bengal and Odisha did not take any action against admission of ineligible candidates in certain private medical colleges under the NRI quota despite the MEA providing 'categorical' information of 'forgery'.

The federal probe agency said it has seized 'incriminating' evidence during searches in this case in the past.

A fixed deposit worth ₹6.42 crore of a private college in West Bengal has been provisionally attached, the ED said. It had earlier attached assets worth ₹12.33 crore of some colleges and individuals involved in these alleged irregularities.

Probe has found that the managements of certain private colleges -- offering MBBS, MD and MS courses -- in these states colluded with agents to create 'fake' papers for candidates, such as embassy documents of NRIs and family tree, the ED said.

"These private medical colleges were paying agents to prepare fake documents. The agents approached and obtained credentials of unrelated NRIs by paying money and used these to prepare fake documents and projected these NRIs as sponsors for students.

"In some cases, the agents and medical colleges used the same set of NRI sponsor documents for two to three different and unrelated candidates," the agency said.

According to the Phase I list announced by the DHSE, the selection rate this year stands at an impressive 92.75%, with 4,13,804 students selected out of 4,46,205 applicants.



Arts stream received the highest number of selections at 2,64,766, followed by Science with 1,17,089, Commerce with 20,552, Upashastri (Sanskrit) with 6.811, and Vocational with 4,586 students

The gender breakdown among selected candidates includes 1,96,268 males, 2,17,529 females, and 7 transgender stu-

### Heritage lovers explore Grameswar Mahadev shrine

Jagatsinghpur, July 7: The 6th edition of the Jagatsinghpur Heritage Walks (JHW) Sunday explored Grameswar Temple at Panchapalli village, in which around 40 participants from across the state participated.

The connotation of village Panchapalli represents five hamlets such as Gobindapur, Patana, Paniendula, Naradia and Tikarapara. Five village goddesses representing these hamlets always evoke a religious sanctity for the region.

Shree Grameswar Mahadev's abode, built on the bank of the Hansua river, has got its mention in the Vedic text, popularly known as 'Garga Peetha'. The history relating to the origin of Shree Grameswar Mahadev is interesting and eventual. As mythology and folklore narrate, the ruler of Bishunpur had constructed the temple basing on the account of a cow herder.

He found that the cow would regularly stop at certain point and ooze out milk. The cow herder reported this unusual incident to the king. The king in return ordered for excavation.

During the process of digging, there appeared a lingam of Lord Shiva. The king tried to fathom its root, but in vain. The lingam appeared in the midst of village (grama) for which the king named it as Grameswar Mahadev. After emergence of the Shi-

va lingam, the king constructed a permanent wooden and thatched house and engaged Brahmins from Kanyakubja for performing puja and observing JAGATSINGHPUR HERITAGE WALKS



the rituals of Lord Shiva.

Another story referring to the Puranic texts says Sage Garga, the son of Lord Brahma, in-

stalled this lingam to offer puja. After the demise of Sage Garga the lingam was buried under the earth and the cow was oozing her milk at that place. On the basis of Puranic reference, the place of Lord Shiva at Panchapalli is also called Garga Peetha. A small temple of Sage Garga located on the temple premises of Grameswar Mahadev stands as a testimony to it.

After the death of the king of Bishunpur, the landlords of the regions took the responsibility of worshiping Lord Shiva. Subsequently, the Endowment Commission, taking the responsibility of the management of the temple, formed a trust. In the passage of time, the old temple of wooden and thatched cover was removed, and a 71 feet high temple has been constructed by the trust with active support of locals.

The beautiful sculptures on the temple wall of Shree Grameswar Mahadev, and different festivals have been attracting devotees from Odisha and outside. Apart from Lord Shiva Lord Jagannath, Balabhadra and Subhadra are also worshiped here at the Nrusinghnath temple.

Heritage enthusiasts also visited a 100-year-old primary school that just celebrated its Centenary. They were welcomed by headmistress Lax mipriya Swain and retired headmaster Shuva Narayan Nayak. ### Earth's oldest rocks are over 4 billion years old

arth formed about 4.6 billion years ago during the Hadean Eon—a period named after the Greek god of the underworld, reflecting the planet's intense early heat. By around 4.35 billion years ago, Earth may have cooled enough for the first crust to form and possibly for life to begin.

But the earliest chapter of our planet's history remains largely mysterious. Rocks from the Hadean are extremely rare, leaving major gaps in our understanding of Earth's formation and early evolution. Our research team recent-

ly confirmed that the oldest known rocks on Earth are in northern Québec. Dating back more than four billion years, these rocks offer a rare glimpse into the planet's ancient begin-

Remnants of the Hadean The Hadean Eon lasted from Earth's formation around 4.6 billion years ago to about 4.03 billion years ago. The oldest terrestrial materials ever dated



are zircon crystals from Western Australia, some as old as 4.4 billion years. Though their original host rocks have eroded away, these tiny, durable minerals survived and have helped researchers piece together

clues about early Earth. Chemical analysis of these zircons suggests they formed in magmas derived from sedimentary rocks at the bottom of ancient oceans, indicating early crust formation and the presence of liquid water. Some

studies also hint that this first crust was mafic—rich in magnesium and iron.

Until recently, the existence of this Hadean crust had not been confirmed.

Ancient rocks in Québec In 2008, one of us-Jonathan O'Neil-proposed that the Nuvvuagittuq Greenstone Belt in northern Québec might contain rocks from the Hadean. Located in Nunavik, north of the 55th parallel, this region hosts ancient, metamorphosed volca-

nic rocks. The most common of these, known as the Ujaraaluk rocks, means "big old solid

rock" in Inuktitut. Initial analysis revealed variations in neodymium-142, an isotope produced only during the Hadean by the radioactive decay of samarium-146. This suggested an age of 4.3 billion years—an interpretation based on techniques previously used to date meteorites and lunar rocks. However, this conclusion sparked debate, with some studies dating local zircons to a younger, Archean age of

around 3.78 billion years. Confirming the Hadean Age In 2017, we returned to Nuvvuagittuq for a closer look. This time, we collected intrusive rocks called metagabbros, which cut through the older Uiaraaluk formation. Since the intrusions are younger than the rock they cut, dating them would help confirm the age of

the Ujaraaluk rocks. Led by master's student Chris Sole at the University of Ottawa, the project combined fieldwork and lab analysis, with support from undergraduate students and French geochronologist Jean-Louis Paquette. Using two independent samarium-neodymium dating methods, we determined the intrusive rocks are 4.16 billion years old—proving the Ujaraaluk rocks are even older.


A glimpse into Earth's begin

This places the Ujaraaluk rocks firmly in the Hadean Eon, making them the oldest preserved rocks on Earth.

Studying these ancient rocks offers a rare opportunity to understand the formation of the first continents and how Earth's environment began evolving toward habitability.

As some of the only surviving pieces of our planet's earliest crust, the rocks of the Nuvvuagittuq Greenstone Belt are helping to rewrite our understanding of Earth's deep past.

Tihidi/Khaira, July 7: Three farmers, including two siblings, were killed and another was rendered critical in separate incidents of lightning strike on farmlands Monday in Tihidi and Khaira areas of Bhadrak and Balasore districts, respectively.

In the first incident, two farmers identified as Madanmohan Moharana, 60, and his younger brother Hrudananda Moharana, 57, were struck by lightning at Chandisahi, Harasinghpur village under Pirhaat police limits and Tihidi block of Bhadrak district. Another injured farmer was identified as Giridhari Mahallick, 64, of nearby Barabatia village.

They were working on their farmland when lightning struck them during a thunderstorm and rendered them critical. Villagers and family

members rescued them and admitted them to Tihidi hospi tal, where doctors pronounced Madanmohan and Hrudananda dead. Giridhari was shifted to the Bhadrak District Headquar ters Hospital after doctors administered him primary treat

Tihidi police registered two separate cases of unnatural death and sent the bodies for

post-mortem. In the second incident, a 25-year-old farmer Chandra kanta Panda died after being struck by lightning Monday af ternoon while ploughing a field in Kurunta village under Khai ra block in Balasore district.

Sources said Panda was operating a tractor when a lightning strike rendered him unconscious. Family members rushed him to Simulia Commu nity Health Centre, but doctors declared him dead on arrival

### **Students eat MDM in rain** under cover of umbrellas

At a time when reports have surfaced on neighbouring Andhra government luring students of border villages to its schools through various facilities such as school buses, this incident from Nandapur block in Koraput has brought to the fore the sorry state of affairs in government-run schools.

Nandapur, July 7: With low pressure induced incessant rainfall continuing across Odisha for the past 16 days, students in Koraput district's Nandapur block have been forced to eat their mid-day meals under the cover of umbrellas out in the open, due to absence of proper dining halls in their schools

The matter came to the fore after around 140 girl students at the Marada Sevashram School in Hikimput panchayat under the block were seen having their mid-day meals holding umbrellas in front of their school, Monday.

Following this, members of the school management committee, including chairman Hari Dora, ward member Kamulu Lochan Dora, guardians Samara Bada Naik, Hari Dalapati, Dhanapati Karingia and Harishchandra Kirshani. voiced their dissatisfaction on the headmaster Udavnath Kirshani.

The headmaster cited a lack of infrastructure, including classrooms and a dining hall, as the reason behind the ordeal. He said he had already reported the matter through the block Welfare Extension Officer to higher district-level

The issue was also brought to the attention of block Welfare Extension Officer Nagen Tripathy, District Welfare Officer Sunil Kumar Tandi, and Assistant Block Education Officer (ABEO) Mumtaj Gomang.

Both the welfare officers acknowledged that Nandapur block has 18 Welfare department schools and 45 School and Mass Education (S&ME) department schools with hostels managed by the Welfare department. Over 4,500 students are continuing their education as boarders in these facilities.

### Three Maoists surrender before Kandhamal police

Phulbani, July 7: Three Maoists, including two women and a youth, surrendered before Kandhamal police, officials said Monday.

The surrendered cadres were identified as Made Beti alias Champa, Admo Madhavi alias Manju and Raju Dodi alias Aiav. All three are natives of Chhattisgarh.

Champa was a Divisional Committee Member (DC-M)-rank cadre in the BGN (Bansadhara-Ghumsur-Nagabali) division of CPI (Maoist) while Manju and Ajay were Area Committee Member (AC-M)-rank cadres in the (Kalahandi-Kandhamal-Boudh-Nayagarh) KKBN division of the outlawed organisation. Champa had joined the Maoist outfit in 2009, Manju in 2011, and Ajay in 2016. They were all active in parts of Kandhamal, Boudh and Kalahandi districts and were reportedly working to reactivate the Maoist corridor between Jharkhand and Chhattisgarh.

The surrender took place during a press briefing at the district police headquarters in Phulbani, Monday where Southern Range IG Niti Shek-

har identified the ultras. The IG said the three were linked to previous Maoist activities in the region. Their surrender comes in the wake of a recent encounter in Baliguda police limits, where two Maoists were killed during a gunfight with security forces.

Police believe sustained anti-Maoist operations have weakened the rebel network in Kandhamal. In the past month alone, the number of active Maoists in the region has dropped by 15. Currently, the number of Maoists in Kandhamal, Boudh, and Kalahandi is estimated to be between 50 and 60.

### Strawberries, turmeric, coffee to be processed in Daringbadi

MISSION SHAKTI DIRECTOR VISITS KANDHAMAL, STRESSES ON VALUE ADDITION

Daringbadi, July 7: In a significant push to boost women-led agri-enterprises and promote local produce, Mission Shakti Director Manika Priyadarshini visited Kandhamal district's Daringbadi block to assess ongoing efforts and chart a roadmap for value addition in key crops like strawberries, turmeric, and coffee through processing units.

Priyadarshini arrived at the PWD Inspection Bungalow in Daringbadi Saturday evening and was received by BDO Preetiranjan Rath. She visited local coffee plantations, the Mission Shakti-run Coffee Café, Hill View Park, and turmeric processing centres at Dandima and Sulumaha villages, Sunday. These centres are managed by Mission Shakti women's groups and play



a vital role in empowering tribal women in the region.

She noted that several women

in the block have successfully taken up strawberry farming, which offers good returns in a short span. However, due to the lack of processing infrastructure, their earnings are limited to the harvest season. She suggested that if facilities for making products like squash and jam were

created-either by the government or private entities-strawberries could provide year-round income. She instructed the BDO to explore steps in this direction.

Regarding the globally acclaimed Kandhamal turmeric, the director emphasised that steps would be taken to promote value addition and branding. She stated that turmeric will be processed, packaged, and sold with GI tag labelling to enhance marketability and farmer incomes.

The director also highlighted the need to process coffee locally. Currently, organically grown Daringbadi coffee is collected by TDCCOL (Tribal Development Cooperative Corporation of Odisha Ltd.), processed in Koraput, and sold under the Koraput brand. She said the state government is planning to set up a processing unit in Daringbadi itself, which will further strengthen the identity of Daringbadi coffee and provide better earnings to local growers. Plans are also in place to expand coffee cultivation to more areas.

During her visit, Priyadarshini had lunch at the Mission Shakti Café in Daringbadi and interacted with women members. discussing their initiatives and challenges.

### Bloodline

he coming together of the Thackeray cousins – Raj Thackeray, chief of the Maharashtra Navnirman Sena (MNS) and Shiv Sena (UBT) president Uddhav Thackeray - on 5 July, two decades after they had fallen out, could not have happened at a more opportune time. The BJP-Shiv Sena government had to eat dust over its bid to include Hindi as a third language in school curriculum. It had to abandon the scheme altogether. It is not only on the backfoot, but has given the MNS and Shiv Sena (UBT) a golden opportunity to bury their differences and close ranks to redraw the contours of Maharashtra politics. Maratha pride is a potent political weapon that the two cousins have been handed over afresh following what is widely perceived as the imposition of Hindi in Maharashtra after the southern states, especially Tamil Nadu, fumed recently over a similar move on it but in a different form, by the Centre. The rollback on the Hindi imposition by the BJP-led Mahayuti government has brought Raj and Uddhav together when both are facing an existential crisis following the Maha Vikas Aghadi's (MVA) debacle in the Assembly elections last year.

The MNS and Shiv Sena (UBT) seem to have got the right issue and weapon to go after the ruling dispensation capitalizing on the three-language formula in school curriculum. The government's kneejerk reaction and subsequent climbdown is being seen as an admission of a failed attempt to use Maharashtra to test the BJP-led NDA government's policy of promoting and imposing Hindi on non-Hindi states. The decision to scrap the government order on the three-language formula by the government of Maharashtra is being seen as an outcome of fear of antagonizing the Marathi population.

The most immediate and direct impact of the cousins' closeness appears to be for the Eknath Shinde camp as it has the potential to turn the Deputy CM's claim to the legacy of Shiv Sena founder Bal Thackeray hollow and challenges his standing among core Marathi voters. This is alarming for the ruling alliance in the coming municipal elections. With Bal Thackeray's son and nephew cementing their ties, Shinde runs the risk of being branded as an outsider and a traitor (gaddar). He is likely to face a major challenge on his turf – the urban pockets of Maharashtra, especially across the Mumbai Metropolitan Region (MMR). He is likely to find a united Marathi regionalist platform propped by the two cousins too tough to handle. Though the Thackeray cousins are yet to formally announce a united front, speculations about such an alliance getting momentum just ahead of the civic body polls, including in the high-stakes BrihanMumbai Municipal Corporation (BMC), are apparently worrying Shinde. Poor showing could lead to waning of his influence in the state and the government he is part of.

The BJP of course remains the most dominant political party in the state at the moment having won 132 of the state's 288 seats in the Assembly elections last year. It has a 26.77 per cent vote share, more than double that of the second-placed Congress, which has a vote share of 12.42 per cent. However, if the Thackeray cousins do succeed in forming an alliance, which appears likely, they would pose a serious challenge to this dominance of the BJP by consolidating the Marathi voter base. The coming civic body polls will be a litmus test for both the BJP and the two cousins. Even a slight shift of voters away from the BJP in cities such as Mumbai, Thane, Pune and Nashik could seriously affect the party, which has for long tried to wrest the BMC from the Shiv Sena. A poor showing in the civic polls could become really problematic for the BJP led state government in the long run.

The Thackerays have synchronised it well to come together as they have enough time to consolidate their base with the Assembly elections being far away. Their plan seems to be to first test the waters in the civic body polls and then build on the gains they may achieve. The Congress may find it difficult to reconcile itself with Raj Thackeray's strident anti-minority pitch, but everything depends on the acceptability of the show of unity between the MNS and Shiv Sena (UBT).

# INDIA'S ETHANOL DRIVE

ndia's sustained economic growth will not happen without parallel and steady increase in energy usage. That will increase at roughly the same rate as GDP growth for the next two decades. We need to increase electricity for households, factories and offices, and fuel for transportation. Three-fourth of India's electricity is produced from coal and the remaining is from renewable sources such as solar, wind, hydro, nuclear and biomass. The installed capacity of renewables has reached nearly 50% of the total, but production is at 25%. India has the third largest deposits of coal but still needs to import more than one-fifth of its requirement from foreign sources. That means an outgo of \$20 billion or more for importing coal.

For transportation, the import dependence is higher. Nearly 90% of the crude oil consumed is imported, clocking 242 million tonnes last year. Depending on international prices, say in a range of \$65 to \$85, it drains \$125 to \$150 billion from India's foreign exchange. At higher oil prices the forex burden is much higher. The good news is that the export of petrol and diesel is increasing faster than the import of crude oil. Last year, the total export was 65 million tonnes of petrol and diesel, with very good profit margins. In the next few years, India's domestic refining capacity will go up by 20% and reach above 310 million tonnes. This growth in refining capacity is faster than the domestic requirement growth, meaning more export earnings. The refining capacity expansion happens due to a combination of brownfield expansion and building new refineries. The refineries in the Western world are closing down, and thus there is an opportunity for India. A proposed new refinery in western Maharashtra would be a big boost

for production, employment and exports. Imagine a future where one fourth of the refining capacity of the country is used only for exports, which will actually reduce the total outgo of foreign exchange. Keep in mind that the world is also trying to move away from fossil fuels.

In order to reduce pressure on foreign exchange, and to reduce the carbon footprint, India embarked on an ambitious programme to blend ethanol with petrol and diesel. Ethanol was to be made from sugarcane i.e. molasses, or from grains such as maize and rice, or from dual feed. The progress since 2013 on ethanol blending is very impressive. It started with just 1.5% blending back in 2013. By this year the target of 20% has already been achieved. In terms of the growing volume it is a spectacular growth of nearly 30% per year, compounded over the past 12 years. This pace is far ahead of the growth of petrol and diesel consumption in India.

The ethanol blending programme (EBP) is benefited by special subsidies provided for the purchase of feedstock by ethanol producers, and the lower rate of GST paid by them. There are also interest subvention schemes, providing loans and lower interest rates to producers. India has become a global leader in ethanol production technology. EBP targets also mean that oil marketing companies have to compulsorily purchase ethanol upto a certain target. Presently of 1,810 crore litres of installed capacity, 816 crore litres is of sugarcane/molasses based, 136 crore litres of dual feed, and 858 crore litres are grain-based which include maize and rice.

At this stage, it is worth examining the EBP. It has four objectives, namely, to reduce import dependency on crude oil, to reduce the outgo of foreign exchange, to reduce carbon emissions and finally to provide a boost to agricultural output. At 20% blending already achieved, how successful has the EBF been in meeting these objectives? Firstly, as per a report from PIB, over past ten years till 2024, the total saving in crude oil import was about 18 million tonnes, which is just 0.8% of the total oil imported during that period. In terms of foreign exchange savings, it was about Rs 1.06 trillion, or roughly \$10 billion (using average exchange rate). But that is less than 0.5% of outgo saved over ten years. In terms of carbon dioxide emissions, in ten years the EBP has saved 54 million tonnes, which is also less than 1%. As far as agriculture is concerned, farmers

earned nearly Rs 1 trillion extra during these ten years and distilleries too earned another Rs 1 trillion. The percent increase in farm income for those sugarcane or maize farmers, is probably modest. EBP has provided an assured market for sugarcane, and hence the sugar sector, which is often plagued by excess production thanks to the MSP and assured price mechanism. Recently, the government has decided to divert 5 million tonnes of rice, which is about 9% of world exports, to ethanol production. It represents only 4% of India's production, and 10% of stocks sitting in government godowns.

One side effect of diverting grain like rice and maize to EBP is that it deprives the poultry feed sector which is suffering from scarcity and input cost escalation. India turned from net exporter to net importer of maize, thanks to EBP. It can also lead to food inflation, leading to instant and arbitrary bans on export of sugar and rice. Thanks to the high assured price for ethanol, distilleries often make more money converting rice to ethanol, rather than selling it as grain. Keep in mind that India provides free five kilos of wheat or rice to 810 million people. That operation too requires government procurement and distribution.

The excise and other tax burdens on oil marketing companies is more than 50% for petrol and diesel, but ethanol has a negligible tax burden. Can some of this be rationalised to make the fiscal burden fairer between petrol and ethanol? The bottom line is that at 20% blending, which is a great milestone, we need to take a comprehensive look at the EBP policy which has multiple objectives, inter-linked complicated incentives, and unintended side effects, on food security, food inflation and fiscal burden.

### Norwegian lessons to safeguard the future



**MANY OF TODAY'S CHALLENGES ATTEST TO THE DIRE CONSEQUENCES OF FAILING TO PLAN FOR THE FUTURE** 

ver the first four months of 2025, 56 Norwegian citizens convened to discuss how Norway's immense oil wealth can best serve current and future generations, both domestically and globally. Unlike traditional policymaking, where elected officials and experts call the shots, this so-called Future Panel - the second such assembly held in Norway - allowed ordinary citizens, selected through a representative process and equipped with the necessary knowledge, to craft recommendations through informed debate.

The Panel was established by seven civil-society organizations - WWF Norway, Save the Children Norway, Caritas Norway, Framtiden i våre hender (The Future in Our Hands), the Norwegian Children and Youth Council, and the think tank Langsikt-to conduct a fact-based public discussion about Norway's wealth. Its remit is to amplify the people's voice on this highly important topic before the general election in September. By embracing a more radical model of deliberative democracy that focuses on the long-term collective good rather than short-term political interests, Norway is setting a precedent for other countries. Perhaps more importantly, when presenting its recommendations to the Norwegian parliament on 13 May, the Future Panel formally demanded a legal framework - including a dedicated commissioner - to safeguard future generations. If enacted, it would demonstrate that grassroots advocacy can bring about a paradigm shift in governance.

I experienced the potential of this shift firsthand as the first Future Generations Commissioner for Wales, which passed the Well-being of Future Generations Act in 2015. The law requires public bodies to consider the long-term consequences of their decisions, ensuring that sustainability and intergenerational justice are embedded in policymaking.

Momentum for such legislation is growing globally. In September, the UNGA adopted a Declaration on Future Generations that encourages governments to institutionalize longterm thinking. Norway's opportunity to do so could prove particularly consequential because of the country's \$1.8 trillion sovereign oil fund. As climate change accelerates and economic uncertainty deepens, Norway must develop a new vision for financial stewardship that will help preserve planetary and societal well-being.

First and foremost, as one of the world's largest oil exporters. Norway must reckon with its fossil-fuel dependency. To be sure, the country has committed to ambitious climate targets. including net-zero emissions by 2050. But it continues to expand oil exploration, despite the global call for a managed decline in fossil-fuel production and the vulnerability of its pristine ecosystems – from the Arctic tundra to vast fjords – to environmental degradation. Norway also faces the challenge of moving to a post-oil economy amid the shift to renewables. To mitigate the cost of stranded assets, protect workers, and ensure a fair transition, the country will need to diversify carefully. A Norwegian future gener-

ations act based on the Welsh model would embed intergenerational responsibility into policy decisions, ensuring that the government seeks to balance social, economic, environmental, and cultural well-being for current and future generations. As part of that process, a future generations commissioner could act as an independent advocate, flagging measures that conflict with the law's aim and holding political leaders accountable for pursuing and achieving a balance between the short and long term.

Many of today's challenges attest to the dire consequences of failing to plan for the future. From climate change to demographic shifts, these often-in-

tersecting problems stem from shortsighted decision-making and a willful blindness to robust data and trends.

But long-term thinking is not only about preventing problems. It is also about working toward a better and more hopeful future. The Welsh model has given the government and public institutions a vision that seeks to transcend political cycles. Since becoming more future-oriented, policymakers have prioritized investing in public transport over building roads; focused on keeping people healthy, instead of just treating the ill; and even revived Welsh, a once endangered language.

Norway's Future Panel has spoken, and now the government is at a crossroads. Will it become a global leader in longterm policy planning, ensuring that its oil wealth benefits generations to come? Or will it make decisions based solely on short-term considerations, perpetuating crises that future citizens will have to fix? If its citizens' wishes are to be respected, Norway must assume the responsibility to help create a world that improves human well-being and equity.

#### Police torture

Most custodial deaths in India go unreported because the police pick and choose their targets based on their socioeconomic status. As the poor and the marginalised have no voice, such highhandedness of the police goes unnoticed. There are, on an average, as many as five custodial deaths per day happening in the country. Though India has signed the United Nations Convention Against Torture (CAT), absence of a uniform Central law has emboldened the perpetrators. Retributory and preventive justice to families through fast tracking of such cases is the need of the hour.

# Mandi's miracle baby TB death prediction model

11-month-old baby girl survives flash floods in Himachal, family swept away

Mandi, July 7: The catastrophic flash floods triggered by multiple back-to-back cloudbursts, tore through several villages of Himachal Pradesh's Mandi district, swallowing everything in

The youngest victim of the calamity is an 11-month-old baby girl, a family's lone survivor, who desperately awaits maternal warmth to feel safe and confident amid the devastation. A week after the mayhem, that is almost a regular feature in the mountainous state every monsoon largely owing to unplanned infrastructure development, rescuers have been on their toes and risking their lives to bring normalcy in the deluge-battered villages.

One of the villages is Talwara in Parwada panchayat that was hit by the deluge in the wee hours of July 1, that swept away the baby's parents and grandmother.

Locals say the child was sleeping alone in the house when the tragedy struck.

Her parents, father Ramesh and mother Radha, along with grandmother Purnu Devi went outside, leaving the sleeping child behind to divert the gushing waters, in which they were swept away.

In the morning, the persistent and heart-wrenching cries of the baby pierced the air and the villagers went in to check on her and contacted the local authorities after realizing what had happened to her.

Now, the video of Sub-Divisional Magistrate (SDM) Samritika Negi, holding the child in her arms has gone viral, touching the hearts of many.

The body of the child's father has been recovered, however, her mother and grandmother are still missing.

witnessed 23 flash floods, 19 cloudbursts and 16 landslides since the onset of monsoon on June 20, and 52 people have died in rain-related incidents in the state so far, officials said Monday. In the worst-hit Mandi district, search and rescue operations

have been intensified with drones and sniffer dogs being used to trace 28 people who went missing last week in the Thunag, Gohar and Karsog subdivisions, they said. On Monday, a landslide occurred in Sai Kharsi area of Bilaspur district and a large part of a mountain fell on a petrol pump. However, no casualty was reported. Eyewitnesses said that suddenly a huge amount of debris and rocks started coming down from the mountain and fell on the petrol pump. In Mandi, about 250 personnel from the National and State Disaster Response Forces, Army, and Indo-Tibetan Border Police, along with home guards and locals, are undertaking the search and rescue work. Besides, 20 teams are gathering information and distributing ration and medical kits in inaccessible areas, the officials said. According to official data, the state has reported 80 deaths since June 20, of which 52 are linked to rain-related incidents such as cloudbursts, flash floods and landslides. The rest 28 fatalities were associated with road accidents, the officials said.

# TN first state to implement

New Delhi, July 7: Tamil Nadu has become the first state in the country to implement a model which predicts the probability of deaths among adults with Tuberculosis and has integrated it with the existing state-wide application TB SeWA, which triages them at diagnosis.

The predictive model, developed by ICMR's National Institute of Epidemiology (NIE) that was launched last week, aims to reduce the average time from diagnosis to hospital admission for severely ill TB patients, thereby bringing down the mortality rate further, said Dr Asha Frederick, State TB Officer of Tamil Nadu.

The new feature has been added to Tamil Nadu's existing TB SeWA (Severe TB Web Application), which has been in use since 2022 under the state's differentiated care model initiative Tamil Nadu - Kasanoi Erappila Thittam (TN-KET), she told PTI.

Under TN-KET, healthcare workers screen a triage every newly diagnosed adult with TB for very severe undernutrition, respiratory distress or poor physical condition using five variables -- body mass index (BMI), pedal oedema (swelling of feet and ankles), respiratory rate, oxygen saturation, and the ability to stand without support.

Then, health staff feeds these variables into TB SeWA, which then tells whether a particular patient is severely ill or not. Under TN-KET, all severely ill (very severely undernourished or having respiratory distress or poor physical status) have to be prioritised for admission, Dr Frederick said.

Until now, TB SeWA flagged patients as 'severely ill' based on these variables, helping health staff prioritise them for inpatient care, Dr Manoj Murhekar, Director of NIE said.

"The new feature goes a step further - calculating and displaying predicted probability of death for adults with TB,' Dr Murhekar said.

This objective risk percentage aims to overcome any subjective inference regarding severity and guide frontline staff to act immediately and firmly for the hospital admission of severely ill adults with TB at the time of diagnosis, he said.

"How this feature addition is helpful is that the predicted probability of death varies widely between a 'severely ill' and 'not severely ill' patient. The predicted probability for a severely ill adult with TB death ranges from 10 per cent to as high as 50 per cent, depending on how many of the conditions are present.

sharply to just 1-4 per cent," explained Dr Hemant Shewade, a senior Scientist at NIE.

Data of last three years show that about 10-15 per cent of adults with TB in Tamil Nadu are found to be severely ill at diagnosis, he told PTI.

"This clear risk estimate wil help ensure that the sickest pa tients are admitted to hospitals without delay," Dr Shewade stated.

All 2,800 public health facili ties in Tamil Nadu --? from pri mary health centres to medical colleges --? currently use the TB SeWA application alongside a paper-based triage tool, said Dr Frederick. "Tamil Nadu is so far the only state in India to system atically record and use these five triage variables to guide patient management," she said.

According to a study by the NIE, after implementing TN KET for around three years now, the losses in the care cas cade have significantly reduced and around two-third districts have documented reduction in TB death rates.

The ICMR-NIE scientists emphasised that the initiative sets an important example for other states, where TB deaths, especially the early fatalities. remain a persistent challenge despite free diagnosis and

### EV charging operators in TN face higher power bills

*The tariff revision comes* at a time when the state is pushing for greater EV adoption and expanding the charging network

Chennai, July 7: Electric vehicle (EV) charging operators across Tamil Nadu are bracing for a steep rise in operational costs following a significant revision in power tariffs by the Tamil Nadu Electricity Regulatory Commission (TNERC), effective July 1.

The revised tariff structure has increased both energy charges and fixed monthly charges for EV charging stations, raising concerns among operators about the economic viability of public charging infrastructure in the state.

While TNERC has retained its time-of-day (ToD) tariff mod-



incentivise off-peak charging -- it has hiked electricity rates across all time slots.

Under the new structure, charging during solar hours (9 am to 4 pm) will cost Rs 6.50 per kWh: during peak hours (6 am - 9 am and 6 pm -10 pm), the rate rises to Rs 9.75 per kWh, up from Rs 9.45.

Night charging (10 pm-6 am) will cost Rs 8.10 per kWh, compared to Rs 7.85 earlier.

Operators are now urging the state government to review the policy framework and consider incentives or subsidies to keep the EV charging ecosystem viable.

Chennai, July 7: In a major step towards fostering social equity and unity among the youth, Tamil Nadu Chief Minister MK Stalin announced that all student hostels run by various government departments across the state will now be known as 'Social Justice Hos-

This move, the Chief Minister said, reflects the core principles of the Dravidian Model government and is aimed at creating a strong foundation for an egalitarian society.

"The renaming is not just symbolic but part of our broader effort to root out caste-based discrimination and foster a spirit of unity among the younger generation," he said.

The decision was taken based

on the recommendations of the Justice K Chandru Commission, a one-man panel set up by the state government to examine ways to eliminate caste markers in educational institutions.

The Commission had proposed removing caste-based names and symbols and recommended the introduction of a curriculum that encourages inclusive education. Acting on these recommendations, the government has decided to rename all 2,739 hostels catering to school and college students as 'Social Justice Hostels'.

These hostels currently house around 1,79,568 students from various communities, many of whom come from marginalised and economically disadvantaged backgrounds. "While we are transforming the names



It has suspended the hedge fund from accessing the market and impounded over ₹4,843 crore in gains.

The probe has found that Jane Street made a profit of ₹36,671 crore on a net basis during the probe period from January 2023 to May 2025.

According to police, they received a missing report about her June 26. Her husband told them that she had been missing since June 24 after a quarrel. He said that this had happened before, but she would return on

Meanwhile, the woman told the police that she was sitting at a nearby railway station when a person, claiming to have been sent by her husband, ap proached her.

'She said he took her with him and boarded an empty bogie of a stationary train where he raped her. Later, two other men joined him and raped her,' Shri Niwas, SHO of Quilla police station said. The woman, who appeared to

be traumatised, also stated that later on she was taken to Sonipat where the accused threw her on the tracks and she lost her leg when a train went over her. She was later admitted to a hospital and is undergoing treatment, Niwas said.

"We registered a Zero FIR for gangrape and forwarded it to the Panipat Government Railway Police (GRP) for further action," Niwas said over the phone.

Inspector Rajesh, SHO of the Government Railway Police here, said that they have received a zero FIR on Sunday evening and further investigation is underway.

Zero-FIR can be filed in any police station, irrespective of the place of incident/jurisdiction, and it can be later transferred to the appropriate police

### Chandrachud reveals why he overstayed in CJI residence

New Delhi, July 7: In the wake of the controversy over his stay at the official residence beyond permissible time, former Chief Justice of India D Y Chandrachud Monday cleared the air saying his luggage was packed and he along with his wife and children would soon move to a paid government accommodation.

Chandrachud, his wife Kalpana and daughters Priyanka and Mahi, both of whom are persons with disabilities, were living in the official CJI residence of 5, Krishna Menon Marg, New Delhi. "We have actually packed up our luggage. Our luggage is already completely packed up. Some of the luggage is already gone to the new house and some are kept here in the storeroom." Justice Chandrachud told PTI while elaborating on reasons for his overstay in the bungalow.

The 50th CJI, who superannuated from the office November 8, 2024, was responding to the Supreme Court administration's communication to the Centre to vacate the official bungalow due to the purported overstay. The former CJI lamented over the controversy and referred to the medical condition of his daughters who required a wheelchair-friendly home.

"I won't tell you how I feel, but you can imagine how I feel about it...one thing which I would like to mention is that we are the parents of two children, Priyanka and Mahi. They are special children and they have special needs. They have a condition called Nemaline



myopathy... And you know this is a very rare genetic disorder which affects the skeletal muscles.

He continued, "Even at home we maintain a high standard of hygiene, sanitation and we have a very specialised nurse who looks after them. So now it's a matter of maybe a couple of days, or not a couple of days but maybe a couple of weeks at the most. As soon as they tell me that the house is ready for occupation, I will be moving out.' Justice Chandrachud re called his elder daughter Priyanka being in the ICU for 44 days at PGI Chandigarh in 2021 and in January, 2022.

The former CJI pointed out his children's regular chest. respiratory and neurological therapies aside from pain and speech management.

He said one of the kids had difficulty in swallowing as a multi-disciplinary team looked after both his children on a daily basis.

Justice Chandrachud re ferred to former CJIs Justices U U Lalit and N V Ramana and other top court judges, saying they too were granted extension of time to stay in their official

Mumbai, July 7: Maharashtra has recorded over 12,000 child deaths between April last year and February 2025, averaging more than 37 fatalities per day, the state's Public Health and Family Welfare Minister Prakash Abitkar said Monday

The figure came up during the question hour when ten MLCs from the Opposition and treasury benches asked a question as to whether 12.438 children died in the state in 11 months.

They also highlighted the situation in Kolhapur district where 1,736 deaths of children, including 11 newborns, were reported. In a written response, Abitkar confirmed the numbers, acknowledging the traumatic loss of young lives throughout the state. However, the minister neither provided any age-wise breakup nor specified the causes behind the death of the children. The period from April 2024 to February 2025 mentioned by the minister comes

#### MMC nod to homoeopaths irks IMA Mumbai: The Maharashtra Medical Council (MMC) has issued a

notification permitting homoeopaths to prescribe modern medicines after completing a six-month course in pharmacology, drawing a sharp reaction from the Indian Medical Association, which claims it will dilute modern medical practices. Demanding a rollback of the permission, the IMA will submit memoranda to Chief Minister Devendra Fadnavis via the district collector and the tahsildar. If their concerns are not addressed, the association plans a 24-nou withdrawal of non-emergency health services July 11. The MMC notification, dated June 30, authorises the initiation of a Certificate Course in Modern Pharmacology (CCMP) for homoeopathy practitioners, enabling them to practice modern medicine. Following these amendments, the Medical Education and Drugs Department, Government of Maharashtra, August 13, 2014, approved to launch the certificate course in pharmacology for homoeopathy practitioners to practice in modern medicine. This development stems from a previous notification issued June 25, 2014, regarding amendments to the Maharashtra Homeopathic Practitioners Act and the Maharashtra Medical Council Act, 1965. Following these amendments, the Medical Education and Drugs Department, Government of Maharashtra, August 13, 2014, approved to launch the certificate course in pharmacology for

homoeopathy practitioners to practice in modern medicine.

### Planned C-section linked to higher child leukaemia risk: Study

New Delhi, July 7: Having a planned caesarean section during delivery could be related to an increased risk of leukaemia -- a blood cancer -- later in the child's life, compared with an emergency C-section, a study has found.

A C-section delivery of a child involves making a surgical cut in the mother's abdomen and uterus. The need for delivering via a C-section can be planned or arise as an emergency during labour.

Researchers at Karolinska Institutet said that exposure of a baby to vaginal bacteria in an emergency C-section -- which usually begins as a vaginal delivery -- could be why planned

C-sections carry an increased risk of certain diseases, com-

pared to emergency ones. "We don't want mothers to feel anxious about medically indicated C-sections. But when this result is combined with other study results showing that the risk of later asthma, allergies, or type 1 diabetes increases in children born by planned C-section, there is reason to discuss C-sections that are not medically indicated," lead author Christina-Evmorfia Kampitsi. researcher at Karolinska Institutet, said.

The study, published in The International Journal of Cancer, looked at nearly 25 lakh children born in Sweden during 1982-1989 and 1999-2015 from the Medical Birth Reg-

More than 3.75 lakh of these (15.5 per cent) were born by a C-section, of which 1,495 later developed leukaemia -- a can-

cer affecting blood and bone

Overall, children born by a C-section were seven per cent more likely to develop acute lymphoblastic leukaemia, compared to those born vaginally.

However, compared to an emergency C-section, birth via a planned C-section was associated with a 21 per cent higher risk of developing acute lymphoblastic leukaemia, the most common form of childhood leu A C-section delivery of a child involves making a surgical cut in the mother's abdomen and uterus

However, in planned C-sections -- usually performed before labour has started naturally -- the baby does not experience this stress and is not exposed to vaginal bacteria the team said.

The difference in exposure to vaginal bacteria and immunological factors thereof may help the increased risk of acute lymphoblastic leukaemia in a planned -- and not emergency -- C-section, the researchers added.

The findings help contribute towards understanding what causes acute lymphoblastic





### 'Drones to boost Indian industry to \$23bn by 2030'

# PM: BRICS must secure critical minerals supply

In his address at a session on multilateralism, financial matters and artificial intelligence, Modi also called for creation of global standards for use of AI to maintain transparency and prevent misuse

Rio de Janeiro, July 7: The BRICS nations must work together to make supply chains for critical minerals and technology secure and ensure that no country uses these resources for its own "selfish gain" or as a "weapon" against others, Prime Minister Narendra Modi said at the annual summit of the grouping.

In his address at a session on multilateralism, financial matters and artificial intelligence Sunday, Modi also called for creation of global standards for use of AI to maintain transparency and prevent misuse.

The prime minister's comments on critical minerals came amid concerns over China restrictions on the export of the vital resources as well as its non-transparent policy approach in the sector.

We need to work together to make supply chains for critical minerals and technology secure and reliable. It's important to ensure that no country uses these resources for its own selfish gain or as a weapon against others," Modi said.

Critical minerals such as lithium, nickel and graphite are considered vital for high-end technology products including electric vehicles (EVs), drones, and battery storage. China has been a dominant player in the critical minerals supply chain globally.

On artificial intelligence, Modi said it can greatly improve everyday life but on the other hand, it also raised concerns about risks, ethics, and bias.

The Prime Minister announced that India will organise the "AI Impact Summit" next year.

"We believe that resolving concerns and encouraging innovation should be given equal importance in AI governance. We must work together for responsible AI," Modi said.

"Global standards must be created that can verify the authenticity of digital content, so that we can identify the source of the content and maintain transparency and prevent misuse," he said.

The top leaders of BRICS held deliberations on a range of pressing challenges facing the globe at the summit in this seaside Brazilian city.

Chinese President Xi Jinping and his Russian counterpart Vladimir Putin skipped the summit. Iranian President Masoud Pezeshkian and Egypt's Abdel-Fattah el-Sissi also didn't attend the gathering.

The BRICS has emerged as an influential grouping as it brings together 11 major emerging economies of the world, representing around 49.5 per cent of the global population, around 40 per cent of the global GDP and around 26 per cent of the global trade. In his remarks, the prime minister also talked about efforts by BRICS to help the Global South.

"In the form of BRICS New Development Bank (NDB), we have offered a strong and credible alternative to support the

development aspirations of countries in the Global South," he said. At the same time, he said

the NDB must focus on demand-driven approaches, long-term financial sustainability, and healthy credit rat-Strengthening our internal systems will further enhance the credibility of our

Modi said the countries of the Global South have some special expectations and aspirations from BRICS and it should work together to fulfil them.

### Citizens can self-ennumerate for 1st time in upcoming Census

In the country's first digital Census, enumerators will collect the data of citizens using mobile applications on their Android and **Apple phones**

New Delhi, July 7: A special dedicated web portal will be launched for self-enumeration during the upcoming Census, which will be available for both phases of the national enumeration exercise, officials said

Monday. In the country's first digital

Census, enumerators will collect the data of citizens using mobile applications on their Android and Apple phones, they said.

It will also be the first time in the country that citizens will get a chance to self-enumerate through a dedicated web portal which will be available for both the phases of Census - Houselisting and Housing Census (HLO) and Population Enumeration. "Digital Census initiative is a

transformational step towards modernising the Census process. For the first time, technology will be used to collect data and send it electronically to the central server. This will result in early availability of Census data," an official said.

Very stringent data security measures would be kept in place to ensure data security at



the time of collection, transmission and storage.

HLO will start from April 1, 2026 followed by phase 2 starting on February 1, 2027 in which Population Enumeration (PE) will be conducted. Castes of household members will be enu-

Reference date for the Census 2027 will be 00:00 hrs of March 1, 2027 and 00:00 hrs of October 1, 2026 for Union Territories of Ladakh and Jammu and Kashmir and snowbound non-syn chronous areas of Himachal

Pradesh and Uttarakhand. It will be the 16th Census

since start of the exercise in the country and 8th after Independence, for which a gazette notification was issued on June 16.

The Registrar General of India has put in place a three-tier focused and need-based training for each phase--national trainer, master trainer and field trainer.

The field trainers will train around 34 lakh enumerators and supervisors for the massive exercise.

The RGI has told states and Union Territories to make any proposed changes in the boundaries of administrative units before December 31, when they will be considered final for the Census exercise.

In a letter to all states and Union Territories, Registrar

General and Census Commis sioner of India Mritunjay Kumar Narayan had said that for the Census, all villages and towns are divided into uni form enumeration blocks and for each block, an enumerator is assigned to avoid any miss or repetition during the population count. According to norms, the

Census can be conducted only three months after the freezing of boundary limits of adminis trative units such as districts, sub-districts, tehsils, talukas and police stations. Narayan had said that from

April 1, 2026, the Houselisting Operation, the appointment of supervisors and enumerators and the work division among them will be done, and on February 1, 2027, the Census of the population will begin.

#### Ukraine withdraws from mine ban treaty

#### B'desh tribunal to decide on charges against Hasina July 10

**Dhaka:** Bangladesh's International Crimes Tribunal Monday set July 10 to determine whether charges will be framed against ousted prime minister Sheikh Hasina and two of her top aides. Hasina, former home minister Asaduzzaman Khan Kamal, and former inspector general of police Chowdhury Abdullah Al-Mamun are accused in the case over alleged crimes against humanity committed during the July uprising last year. The International Crimes Tribunal-1 (ICT-1) set July 10 to decide whether charges will be framed against Hasina, Kamal, and Al-Mamun, The Daily Star newspaper reported. On that day, the three-member tribunal will hear the petitions filed by the defence counsels, who argued that the charges against their clients are baseless and should be dropped, it said. Hasina, Kamal, and Al-Mamun were charged with five counts of crimes against humanity June 1. The prosecution pressed formal charges against the deposed prime minister, the former home minister, and the former top cop for murder, attempted murder, torture, and use of lethal weapons, among others.

#### **Australian Erin Patterson** convicted of mushroom murders

Sydney: An Australian woman was Monday convicted of murdering three elderly relatives of her estranged husband with a meal laced with poisonous mushrooms, and attempting to murder a fourth, in a case that gripped the country. After a week of deliberation, the jury found Erin Patterson lured her mother-in-law Gail Patterson, father-in-law Donald Patterson and Gail's sister, Heather Wilkinson to lunch at her home and poisoned them with individual servings of Beef Wellington that contained death cap mushrooms. They also found the 50-year-old guilty of the attempted murder of Ian Wilkinson, Heather's husband, who survived the 2023 meal at Erin Patterson's home in Leongatha, a town of about 6,000 people some 135 km (84 miles) southeast of Melbourne. Patterson had pleaded not guilty to the four charges, saying the deaths were accidental. The mother of two will be sentenced at a later date and faces a maximum life sentence. She can appeal against the verdict.

New Delhi, July 7: The Securities and Exchange Board of India (SEBI) Monday proposed allowing asset management companies (AMCs) or their subsidiaries to offer additional services related to fund management, such as acting as Points of Presence (POP) for pension schemes and serving as global distributors for the funds they manage or advise. Presently, AMCs and their

subsidiaries are only allowed to provide services which are in the nature of management and advisory of pooled funds. On Points of Presence (POP)

for pension funds. SEBI proposed that subsidiaries of AMCs registered as pension fund managers may be allowed to offer POP services and receive compensation as permitted by PFRDA, according to its consultation paper.

However, AMCs should ensure that the interests of mutual fund investors are not affected.

Currently, AMC subsidiaries can act as POP for pension funds under the direct plan, but they are not allowed to receive any commission or fees directly or indirectly from investors or pension funds

On global distribution, SEBI suggested that AMCs can market and sell only direct plans of



nationally). AMCs may continue to do this through overseas subsidiaries. However, they cannot receive any commission or fees for distributing direct plans.

On distributing other non-MF schemes globally, AMCs may be allowed to distribute other than mutual fund schemes managed or advised by them outside India through their subsidiaries. This is subject to compliance with relevant regulations.

Also, SEBI has proposed relaxing the broad basing requirement and permitting AMCs to serve pooled nonbroad based funds. This is subject to strong governance and regulatory controls that would address any concerns related to conflicts of interest situations.

In case the broad basing re-

flicts are likely to arise such as differential fees for pooled non-broad based funds and diversion of resources, risk of contrary trade positions and front-running, risk of insider trading and inter business transfer of assets on unfavorable business terms for mutual funds investors.

To address the concern relating to diversion of resources, SEBI has "proposed that AMCs may be required to ensure that the resources dedicated to pooled non-broad based funds should be proportionate to the fee earned by AMC from such funds vis-a -vis fees from investors in mutual fund schemes".

Further, mutual fund investors should not made to bear the cost of servicing mandates for pooled non-broad based funds, it added. The regulator has sought public comments by July 28 on the proposals.

#### **SEBI to enhance** surveillance against derivatives manipulation

New Delhi, July 7: India's markets regulator is enhancing its surveillance to scrutinise manipulation in derivatives trading, its chairman said Monday, and days after it barred US firm Jane Street from the local markets after its investigation found the firm manipulated stock indexes.

'There may not be many more such cases," Chairman Tuhin Kanta Pandey said without elaborating.

India is the world's largest derivatives market, accounting for nearly 60 per cent of the 7.3 billion equity derivatives traded globally in April, according to the Futures Industry Association.

The surge in derivatives trading, which has also been driven by retail investors, has prompt ed the Securities and Exchange Board of India (SEBI) to limit the number of contract expiries and increase lot sizes to make such trades more expensive.

Friday, SEBI barred trading firm Jane Street from buying and selling securities in the Indian market and also seized \$567 million of its funds, citing manipulation of stock indexes.

The regulator alleged that the trading firm had bought large quantities of Bank Nifty constituents in the cash and futures markets to artificially support the index in morning trade, while simultaneously building large short positions in index options.

### Carrier to sue India over electronic waste rules

New Delhi, July 7: The Indian unit of US air conditioning giant Carrier has become the latest major firm to sue Prime Minister Narendra Modi's government over electronic waste rules that have hiked the fees manufacturers must pay to recyclers

South Korea's Samsung Electronics and LG Electronics as well as Japan's Daikin and Tata's Voltas have also brought suits, which are set to be heard by the High Court of Delhi Tuesday. All of the companies are seeking to have the rules quashed India is the third-biggest

generator of electronic waste behind China and US, but the government says only 43 per cent of the country's e-waste last year was recycled Modi's government in Sep-

tember fixed a floor price that electronics makers must pay recyclers, which manufacturers argue is roughly three to four times higher than what they paid earlier.

In a 380-page court filing dated June 3, which has not been disclosed publicly, Carrier said recyclers were willing to continue their work at the older prices and the government should not interfere in private dealings between companies and recyclers.

"The burden of the benefit being given to the recyclers

has been put on the producers which is unfair and arbitrary, said submissions by Carrier Airconditioning & Refrigeration which were reviewed by Reuters.

The submissions added that the rules will impose a "huge financial burden" on the company. However, both the parties have not commented on this. It has previously argued in court that the pricing rules are needed to ensure proper waste dis posal and were a "reasonable" intervention.

The new rules mandate a minimum payment of 22 rupees per kilogram to recycle consumer electronics. Such rates are still lower than levels in US where they are up to five times higher, according to research firm Redseer.

The association expressed concern over the implications of the Reserve Bank of India's reclassification of ID-BI Bank as a private sector bank. Speakers highlighted that this shift has already impacted lending under priority sector schemes like Kisan credit card (KCC)loans. and warned that further privatisation would jeopardise small loans under MUDRA, PMSVANIDHI, Stand-Up India, and unsecured education

loans for needy students.

AIIDBIOA underscored IDBI Bank's significant role in social banking, with over 18.72 lakh PMJDY accounts. 10.86 lakh PMSBY holders, and extensive participation in other government schemes. The bank operates 2,106 branches and has over 20,000 plus employees, including substantial representation from SC, ST, OBC, EWS, women, and differently-abled groups.

Despite earning net profits for five consecutive years — ₹7.515 crore in FY 2024-25 alone the proposed sale of IDBI Bank by the Centre and LIC (holding 45.48% and 49.24% respectively) threatens depositors and borrowers alike, the association warned.

AIIDBIOA urged the government to regain a 51 per cent stake to ensure IDBI's public sector status and advised RBI to classify the bank as a PSU for regulatory purposes.

#### Jindal gets nod for steel project

New Delhi, July 7: Jindal (India) Ltd Monday said the company has received a letter of approval from the Odisha government for its proposed greenfield project in the state to be set up with an investment of ₹3,600 crore.

The company plans to invest ₹15,000 crore in three phases in Odisha by 2030, it said in a statement. The company's facility will focus on manufacturing special coated steel products. The plant will feature coating facilities such as a Cold Rolling Mill (CRM) with a Continuous Galvanizing Line (CGL) and a Colour Coating Line (CCL) for steel sheets with multiple high potential downstream products having total annual capacity of 9.6 lakh MT. This phase will be commissioned by 2027. In parallel, its wholly-owned subsidiary Jindal India Steel Tech Limited (JISTL) will enhance the total capacity of the Odisha plant to 30 lakh MT per annum in the flat product division by 2030.

Jindal (India) Limited will also establish a steel pipe manufacturing facility that will have an estimated annual production capacity of 2 lakh MT per annum.

### Debt securitisation volume rises

Mumbai, July 7: Debt securitisation volumes have inched up to ₹49,000 crore during April-June 2025 as compared to ₹45,000 crore recorded in the year-ago period, a report said Monday.

The total number of originators in these securitisa tions, wherein a lender hands over future receivables on a single or a bunch of loans to a new entity usually on a discount, was around 90, Crisil Ratings said.

Issuances by non-banking financial companies (NBFCs), led by large players, posted a strong on-vear growth of 24 per cent, it said, adding this helped offset the lower origination volume by banks, the domestic rating agency said.

NBFC originations contributed to 92 per cent of the market in Q1FY26, compared to 74 per cent in FY25. The share of top-20 NBFC originators increased to 67 per cent in first quarter this fiscal compared to 56 per cent in the corresponding quarter of last fiscal.

'The top NBFCs have re mained steadfast in tapping the securitisation market as a strategy for resource profile diversification. On the other hand, originations by small



ly present in microfinance, unsecured personal loans and business loan segments has moderated as both the NBFCs and investors remain cautious in these segments." the agency's director Aparna Kirubakaran said. In the case of banks, where

a few large private sector lenders lead originations, the activity was low on steady improvement in the overall cred it-deposit ratio, it said.

From an asset class perspective, vehicle loans (including commercial vehicles and two-wheelers) held steady at 41 per cent, while mortgage-backed loans decreased to around 21 per cent from 25 per cent on year, it said, attributing the decline to lower volumes originated by a large private bank.

Lifting of regulatory curbs on a leading originator led to the share of gold-loan securitisation to surge to 11 per cent in Q1 from virtually negligible levels year-ago, it said.

The BSE smallcap gauge declined 0.33 per cent and midcap index dipped 0.15 per cent. Among BSE sectoral indices FMCG jumped the most by 1.50 per cent, followed by utilities (0.71 per cent), oil & gas (0.31 per cent), power (0.31 per cent). energy (0.28 per cent) and services (0.16 per cent).

In Asian markets, Japan's Nikkei 225 index and Hong Kong's Hang Seng settled low er while South Korea's Kosp and Shanghai's SSE Composite index ended higher. Euro pean markets were trading on a mixed note.

### Domestic automobile retail sales up 5% in June

New Delhi, July 7: Automobile retail sales in India rose around 5 per cent year-on-year in June with all vehicle segments, including passenger vehicles and two-wheelers, witnessing growth, Federation of Automotive Dealers Associations (FADA) said Monday.

Overall automobile registrations last month stood at 20,03,873 units, up 4.84 per cent as compared with 19,11,354 units in June 2024. Passenger vehicle (PV) retail sales rose 2 per cent year-on-year to 2,97,722 units last month as against 2,90,593 units in the year-ago period.

"Heavy rains and tight market liquidity weighed on footfall and conversion, even as elevated incentive schemes and fresh bookings lent selective support," FADA President CS Vi-

gneshwar said in a statement. Some dealers indicated that certain PV OEMs have introduced compulsory billing procedures such as automatic



ume targets; inventory consequently stands at around 55 days, he added.

PV sales rose 3 per cent yearon-year to 9,71,477 units. Similarly, two-wheeler registrations increased 5 per cent year-onyear to 47,99,948 units.

CV and three-wheeler retail sales rose 1 per cent and 12 per cent, respectively, in the April-June period. Tractor registrations rose 6 per cent year-onyear to 2,10,174 units in the first On business outlook in the

near term, FADA stated that above-normal monsoon forecast at over 106 per cent of the LPA in July, with regional variances should bolster rural demand even as heavy-to-veryheavy precipitation zones introduce logistical complexities. However, evolving geopoliti-

### Djoko storms into QFs

The Serbian overcomes a poor start to beat Alex de Minaur and reaches his career's 63rd Slam quarterfinal

London, July 7: Novak Djokovic overcame an uncharacteristically unsteady start to avoid what would have been his earliest exit at Wimbledon since 2016, coming through for a 1-6, 6-4, 6-4, 6-4 victory over 11th-seeded Alex de Minaur in the fourth round Monday.

With Roger Federer, an eight-time Wimbledon winner, sitting in the front row of the Royal Box, so little went right at the outset for the 38-year-old Djokovic on the grass below during a breezy afternoon with the temperature in the 60s Fahrenheit (teens Celsius), a week after matches were contested in record-breaking heat.

But Djokovic turned things around enough to grab the middle two sets and then really took control after trailing 4-1 in the fourth. He won the last five games and 14 of the final 15 points.

His bid for an eighth Wimbledon title and 25th Grand Slam singles trophy overall will continue



against No 22 Flavio Cobolli of Italy. Cobolli reached his first major quarterfinal with a 6-4, 6-4, 6-7 (4), 7-6 (3) victory over 2014 US Open champion and two-time major runner-up Marin Cilic.
