New Delhi: Former foreign secretary Harsh Vardhan Shringla, Special Public Prosecutor in the 26/11 Mumbai terror attacks case Ujjwal Nikam, Kerala BJP leader C Sadanandan Master and historian Meenakshi Jain have been nominated to the Rajya Sabha (RS). Bihar: Many Nepalese, Bangladeshis found

New Delhi: Field-level functionaries of the Election Commission (EC) have found 'a large number of people' from Nepal, Bangladesh and Myanmar during house-to-house visits made for the ongoing intensive review of voters' list in Bihar, officials said Sunday. They asserted that the names of illegal migrants will not be included in the final electoral roll to be published September 30, after proper enquiry of such people is conducted after August 1. Citing ground reports, EC officials said that during house-to-house visits 'a large number' of people from Nepal, Bangladesh and Myanmar have been found by booth-level-officers. The EC will eventually carry out a special intensive revision of electoral rolls across India to weed out foreign illegal migrants by checking their place of birth.

Political donations totalled ₹157 crore in 2024-25, up from ₹97 crore in the previous financial vear. While donations to the BJI soared, those to the Opposition Congress were cut to just ₹10 crore. The donations in fiscal year April 2024 to March 2025 (FY25) in cluded 'contributions to BJP of ₹97 crore (₹26 crore in fiscal year ended March 31, 2024), BJD of ₹25 crore (March 31, 2024: ₹15 crore), JMM of ₹20 crore (March 31, 2024; ₹5 crore) and AICC of ₹10 crore (March 31 2024: ₹49 crore)," according to the annual report for 2024-25.

Vedanta has been one of the biggest donors to political parties. In 2022-23, it had donated a total of ₹155 crore to political parties and ₹123 crore in FY22 (April 2021 to March 2022). Beneficiary-wise, the breakup was not provided for the previous donations. It had, through the now-scraped electoral bonds donated, ₹457 crore to political parties in the five years of their existence starting 2017.

'Plough justice' rocks Koraput

July 13: A couple in Peda Itiki village under Bargi panchayat of Narayanpatna block in the district was subjected to humiliating punishment for marrving within the same clan as a kangaroo court allegedly forced them to plough the village road with a wooden yoke tied to their backs, a report said.

The matter came to the light after a video of the incident went viral, days after a similar case in neighbouring Rayagada district made headlines. Sources said, the 18-year-old girl and the 21-year-old man were reportedly in a relationship for nearly five years. They are said to belong to the same clan and are considered cousins under tribal customs. They had eloped and got married,

defying societal norms and ageold community traditions.

Later, their families and relatives lured them back to the village promising their marriage. Upon their return, some village elders declared the marriage invalid due to their shared lineage and insisted that they must undergo a ritualistic punishment called 'Balada Danda' (plough justice) to absolve them of their so-called sin. They tied them a voke and made them to till the village road. The couple was later sprinkled with coconut mixed water as part of a 'purification' ritual. New York, July 13: For sale: A 54-pound (25-kilogramme) rock. Estimated auction price: \$2 million to \$4 million. Why so expensive? It's the largest piece of Mars ever found on Earth.

Sotheby's in New York will be auctioning what's known as NWA 16788 Wednesday as part of a natural history-themed sale that also includes a juvenile Ceratosaurus dinosaur skeleton that's more than 6 feet tall and nearly 11 feet long.

According to the auction house, the meteorite is believed to have been blown off the surface of Mars by a massive asteroid strike before travelling 140 million miles to Earth, where

it crashed into the Sahara. A meteorite hunter found it in Niger in November 2023, Sotheby's says

The red, brown and gray hunk is about 70% larger than the next largest piece of Mars found on Earth and represents nearly 7% of all the Martian material currently on this planet, Sotheby's says. It measures nearly 15 inches by 11 inches by 6 inches.

"This Martian meteorite is the largest piece of Mars we have ever found by a long shot," Cassandra Hatton, vice chairman for Science and Natural History at Sotheby's, said in an interview. "So it's more than double the size of what we previously thought was the largest piece of Mars.



It is also a rare find. There are only 400 Martian meteorites out of the more than 77,000 officially recognised meteorites found on Earth, Sotheby's says. Hatton said a small piece of ered during the Viking space probe that landed on Mars in 1976, she said.

The examination found that it is an 'olivine-microgabbroic shergottite,' a type of Martian rock formed from the slow cooling of Martian magma. It has a course-grained texture and contains the minerals pyrox ene and olivine, Sotheby's says

It also has a glassy surface likely due to the high heat that burned it when it fell through Earth's atmosphere, Hatton said. "So that was their first clue that this wasn't just some big rock on the ground," she said.

The meteorite previously was on exhibit at the Italian Space Agency in Rome. Sotheby's did not disclose the owner.

Dialysis starts; next 48 hours vital: AIIMS doctors

BHUBANESWAR: The health condition of the 20-year-old FM Autonomous College student, who tried to immolate herself over inaction in alleged sexual harassment meted out to her, remained critical, with doctors at AIIMS. Bhubaneswar starting her dialysis as part of the initiation of renal replacement therapy, a treating medical practitioner said. The second-year student of the integrated B Ed programme at the college in Balasore had Saturday set herself on fire, demanding action against a teacher who had allegedly sexually assaulted and mentally harassed her. Dialysis commenced following consultation with experts from AIIMS Delhi, said Sanjay Giri, Additional Professor and HoD, Department of Burn and Plastic Surgery at AIIMS Bhubaneswar. Giri said the hospital authorities have informed the patient's family about her health condition. She shows a high heartbeat rate at 180 per bpm (beats per minute) even under ventilator support, he said. "About 95 per cent of the victim's body has suffered severe burn injuries. Her kidneys and lungs are also affected. She is currently on critical care support," AIIMS Bhubaneswar Executive Director Ashutosh Biswas told reporters here Sunday. The woman was admitted to AIIMS Saturday and hospital authorities said that the next 48 hours are vital and the victim is not showing any sign of improvement. Stating that doctors of multiple departments were engaged in the treatment of the student, Biswas said that her entire stress. H5N1 OUTBREAK: GOVT CULLS OVER 6,700 BIRI

Bhubaneswar, July 13: A day after bird flu (H5N1) outbreak was confirmed in a poultry farm in Puri district, the state government has swung into action as it has culled over 6,700 birds as part of containment measures, a senior official said Sunday.

The state government resorted to mass culling of the birds after the National Institute of High Security Animal Diseases (NIHSAD), Bhopal, confirmed that samples collected from Bada Ankula in Delang block of the district tested positive for the H5N1 avian influenza virus, he added.

The official also said that more than 6,700 birds were culled Saturday and Sunday following standard operating procedure (SOP) lay down by the Union government.

Sarat Kumar Behera, chief district veterinary officer

(CDVO), Puri, informed that seven rapid response teams (RRTs) along with health teams have been deployed in the area where bird flu cases were detected.

"We have completely restricted the movement of live birds in and out of the infected zone," he said.

After completing culling within a 1-km radius of the village, samples from another five villages have been collected to

test for the virus, Behera said. Sources said the village had

witnessed unusual poultry deaths over the past week, but the outbreak was officially confirmed only after villagers raised concerns and officials collected samples July 9.

Meanwhile, Fisheries and Animal Resources Development Minister Gokulananda Mallik visited the bird flu infected area to take stock of containment measures taken to prevent further spread of the virus.

The Minister has said that immediately upon confirmation, the State Government initiated urgent containment and control measures to prevent further spread of the disease. Seven Rapid Response Teams (RRTs) were mobilized by F&ARD Department to undertake culling, disinfection,

sanitation, and surveillance activities in the infected zone. Compensation for the culled birds will be disbursed to the

affected poultry farmers as per the guidelines of Govt. of India within two days to ensure their livelihoods are protected. The Minister further said

that biosecurity measures have been enforced in a ten-kilometre surveillance zone around the epicentre.

Bhubaneswar/Jajpur, July 13: Four persons, including a woman, were killed due to lightning strikes in Jajpur, Jagatsinghpur, Sambalpur and Bhadrak districts Sunday, police said.

A 65-year-old farmer died in lightning in Balabhadrapur vil-

lage under the Jenapur Police Station limits in Jajpur district, a senior officer said.

The incident occurred when he was working in his agricultural fields, he said.

'Other farmers and labourers working there saw him lying in the field after the lightning strike. They took him to the Dharmasala Community

Health Centre, where a doctor declared him dead," the officer said. The body of the farmer was sent for post-mortem examinations, and a case of unnatural death was registered, he said, adding that the investigation is underway.

Another man died in a lightning strike while he was taking shelter under a tree in the Kuchinda area of Sambalpur district, police said.

Lightning struck a young woman when she visited a garden in Bhadrak district, another officer said.

A farmer died as lightning struck him when he was returning from an agricultural field in Kujang area in Jagatsinghpur district, he added.

Bhubaneswar, July 13: The India Meteorological Department (IMD) Sunday issued a heavy rainfall warning for several districts of Odisha as a low-pressure area is likely to form over the northwest Bay of Bengal (BoB) and adjoining coastal areas of West Bengal and Odisha within the next 24 hours. The system is expected to bring widespread rainfall, thunderstorms, lightning, and gusty winds across the state between July 13 and July 17.

According to IMD, an upper air cyclonic circulation over the north BoB, extending up to 5.8 km above sea level is likely to intensify, leading to the development of the low-pressure system. This weather disturbance, coupled with an active monsoon trough extending from northwest India to the northeast BoB, will enhance rainfall activity across the state.

The IMD has predicted heavy to very heavy rainfall accompanied by thunderstorms and lightning in the districts of Mayurbhanj, Keonjhar, Sundargarh. Sambalpur. Jharsuguda, and Bargarh. These regions are likely to experience wind speeds of 30-40 kmph, raising concerns over local flooding and disruptions.

Other districts such as Balasore, Bhadrak, Jajpur, Kendrapara, Angul, Dhenkanal, Cuttack, Nayagarh, Kalahandi, Koraput, and Rayagada are also expected to witness heavy rainfall and thunderstorms.

A Yellow warning (Be Aware) has been issued for multiple districts including Boudh, Subarnapur, Bolangir, Kandhamal, and Ganjam, indicating the likelihood of isolated heavy showers and lightning strikes.

Significant rainfall has already been recorded in parts of the state. Rampur (Kalahandi) received the highest with 7 cm, followed by Kantapada in Cuttack (6 cm), and Sharapada, Nayagarh, and Rasagovindapur receiving around 5 cm.

Authorities have urged people to stay indoors during thunderstorms, avoid water-logged and low-lying areas, and remain cautious of falling trees and electric poles due to gusty winds. Fishermen have been advised not to venture into the sea during this period due to rough conditions.

The state government is on alert and district administrations have been asked to keep disaster response teams ready in vulnerable areas.

to stop the breach of tradition,' he said. Asked if he would sug gest that the Odisha government consider copyrighting rituals related to the 12th-century shrine in Puri to stop recurrence of such incidents, the titular king said that the state administration has already started working on it.

"It has to be seen from a legal point of view. The state will take the opinions of experts and take appropriate steps,' Deb said.

The Gajapati Maharaja alleged that the term of previous members nominated by the Odisha government in the Shree Jagannath Temple Managing Committee, a statutory body, has expired September 2, 2024, and no new members have been appointed.

Unless these 10 members are nominated, the committee will not have a quorum to convene its meetings, he said and urged the government to name new members.

"Now that the Rath Yatra is over, we hope the government will make the nominations. It is necessary in the interest of the smooth and efficient management of the affairs of the Puri temple," Deb said.

Phase-III clinical trial results by October INDIA'S 1ST **DENGUE VACCINE**

New Delhi, July 13: Enrolment of about 10,500 participants in the phase III clinical trial of the indigenous one-shot Panacea Biotec developed dengue vaccine, DengiAll, is likely to be completed by October across 20 centres in India, according to Indian Council of Medical Research (ICMR) scientists.

So far, 8,000 participants in various centres at Pune, Chennai. Kolkata. Delhi and Bhubaneswar among others have received either the vaccine or a placebo as part of the trial sponsored by the ICMR and Panacea Biotec.

The trial is co-led by IC-MR-National Institute of Translational Virology and AIDS research in Pune, National Institute of Epidemiology (NIE), Chennai and National Institute of Virology, Pune.

Currently, there is no antivi-



ral treatment or licensed vac cine against dengue in India.

The results of the Phase-I and II trial has shown no safety concerns for the one-shot vaccine, NIE Director Dr Manoj Murhekar said.

The participants enrolled in the Phase-III trial will be followed up for two-years. This trial will evaluate the efficacy of this tetravalent dengue vaccine," Dr Murhekar said.

dou-The multi-centre, ble-blind, randomised, placebo-controlled phase-III trial was launched in August last year to evaluate the jab's efficacy, safety and, long-term immunogenicity. The first participant in this trial was vaccinated at the Pandit Bhagwat Dayal Sharma Post Graduate Institute of Medical Sciences (PGIMS), Rohtak last

vear The development of an effective vaccine is complex due to the need to achieve good efficacy for all four serotypes. The dengue virus has four serotypes, 1 to 4, with low cross-protection against each other, meaning individuals can experience repeated infections, Dr Murhekar said.

In India, all four serotypes of dengue virus are known to circulate or co-circulate in many regions

The Union Health Ministry in a statement earlier had said that the tetravalent dengue vaccine strain (TV003/TV005), originally developed by the National Institutes of Health (NIH), USA, has shown promising results in clinical trials in Brazil.

Panacea Biotec, one of three Indian companies to receive the strain, is at the most advanced stage of development. The company has worked extensively on these strains to develop a

full-fledged vaccine formulation and holds a process patent for this work.

Dengue is a major public health concern in India, ranking among the top 30 countries with the highest incidence of the disease.

The global incidence of dengue has been steadily increasing over the past two decades, with more than 129 countries reporting dengue viral disease by the end of 2023, according to the World Health Organisation (WHO)

In India, approximately 75-80 per cent of infections are asymptomatic, yet these individuals can still transmit the infection through the bite of Aedes mosquitoes.

Among the 20 to 25 per cent of cases where symptoms are clinically apparent, children are at a significantly higher risk of hospitalisation and mortality. In adults, the disease can escalate into severe conditions like dengue hemorrhagic fever and dengue shock syndrome.

According to the government data, around 12,043 dengue cas es were reported till March this year. In 2024, 2.3 lakh cases and 297 deaths had been recorded.

Despite instructions to use solar fencing only, a local farmer had allegedly linked the wire to the main electricity line to ward off elephants, leading to the fatal accident, Forest officials said.

A Special Task Force (STF) team from Bhubaneswar visited the site Sunday afternoon and launched an inquiry.

Reports indicate that elephants have been regularly straying into Tikilipada village over the past few days, damaging crops and properties. The incident occurred when a herd of nine elephants strayed into the village Saturday night. With the help of Forest staff and locals, the herd was driven back towards the jungle. While retreating through a scrubland near a paddy field, the female elephant came in contact with the live wire and was electrocuted at around

Press body submits memorandum to CM over scribe's murder

Malkangiri: The District Journalist Coor dination Committee Sunday submitted a memorandum to Malkangiri SP Binod Patil, addressed to Chief Minister Mohan Charan Majhi, demanding swift action in the brutal killing of web journalist CH Naresh. The journalists urged the government to arrest the culprits immediately, enact a Journalist Protection Act, and provide ₹10 crore in ex gratia to the victim's family. The memorandum came a day after Naresh, a web channel reporter, was hacked to death by five unidentified assailants in Muraliguda village under Motu police limits while on assignment. He had gone to the area with two colleagues for news coverage when the attackers, riding two motorcycles, launched a sudden assault with sharp weapons. While his companions managed to flee. Naresh was caught and brutally attacked, suffering deep wounds to both arms, which resulted in excessive blood loss. Locals rushed him to the Motu Community Health Centre. from where he was referred to the district headquarters hospital. He died en route. Naresh's murder has triggered shock and anger among the journalist fraternity in Malkangiri and beyond. Despite repeated calls over the years from media bodies for a law to protect working journalists, no such legislation has been enacted in Odisha.

Realtor held for ₹5-cr scam; 200 duped

Berhampur, July 13: Odisha Police has arrested a 43-yearold realtor in Ganjam district for allegedly duping over ₹5 crore from nearly 200 people under the pretext of allotting residential plots, officials said Sunday

The accused has been identified as Chetan Kumar Choudhury, son of a former president of the district Congress unit.

According to police, Chetan of Gosaninuagaon in Berhampur city allegedly collected monthly instalments from

buyers through his office staff since August 2019 with the assurance to allot plots to them in September 2021. However, when the investors began demanding their promised plots on the due date, Choudhury allegedly refused responsibility, claiming the receipts issued were fake and that he had no knowledge of the scheme. On Saturday, an investor lodged a police complaint against Choudhury.

Based on his complaint, a

criminal case was registered

against him under different

sections of BNS and an investi-

gation was launched. Another case was also pending against him in Bada Bazar police station here, they said. Preliminary investigation revealed that the accused swindled over ₹5 crore from around 200 people under the pretext of pro viding residential plots though a detailed monthly money in vestment scheme, Berhampur SP Saravana Vivek M said.

Students cross reservoir to attend school

Man dies, 35 hurt as bus overturns after collision

Jaleswar, July 13: A man was killed and 35 others were injured as a passenger bus overturned after being hit by a truck on the bypass road near Chalanti village under this police limits in Balasore district Sunday.

The deceased was identified as Malaya Mohanty, 45, of Kharida village in Bartana panchayat of Jaleswar block. Among the injured. 12 persons in critical condition have been admitted to the district headquarters hospital in Balasore

The mishap occurred when a bus named 'Geetanjali' with 50 passengers on board was on its way to Baripada from Bhograi via Jaleswar.

The bus was negotiating a diversion road when a West Bengal bound truck hit it from the rear. The bus overturned under the impact of the collision.

On being informed, locals rushed to the spot and rescued the injured passengers trapped inside the bus. Later, they rushed the injured passengers to GK Bhattar hospital in Jaleswar. There the doctors administered them primary treatment and rushed the 12 injured persons in ambulances to the district headquarters hospital in Balasore. However, Mohanty succumbed to his injuries near Rupsa.

The truck driver had fled the scene after the mishap but people caught him near the Laxmannath toll plaza and informed the police. Police seized the truck and took the driver in its custody. An investigation was launched while Jaleswar Municipality Chairman Pratap Pradhan visited the hospital and met the injured passengers undergoing treatment.

Sunabeda/Semiliguda, July 13: In the absence of a bridge, students from several villages under Charangul panchavat in Semiliguda block have been forced to risk their lives as they have to cross the Kolab reservoir by country boat daily in order to reach their school.

Children from six villages including Lenjiguda, Khalpadi and Gaudaguda, who study at Jagannath Vidyapeeth and TRW High School, have to cross the reservoir in unsafe country boats, a situation fraught with danger.

Years ago, the government had provided a motorised boat to ferry the students. But for the past three years, it has remained defunct. Not only is the boat out of service, but it also lacks an operator, the





students said.

This issue affects not just the students, but the entire local population. Residents of these villages rely on the boat for day-to-day needs, including travel to hospitals, banks and

tehsil office. While taking the road would require a detour of nearly 15 km, crossing the reservoir reduces the journey to just one kilometre.

Villagers allege that although a bridge was sanctioned by the previous government, the project has remained buried under bureaucratic red tape.

When contacted, Charangul panchavat sarpanch Phulmati Pujari confirmed that funds for the bridge had been approved and the Rural Development department had completed a survey. However, she admitted ignorance about the reason for the delay in construction. She also acknowledged that the motor of the government boat was non-functional and that the BDO had been informed.

Local MLA Ramachandra Kadam, when alerted to the children's risky commute, stated that all necessary arrangements for the bridge construction had been completed. He assured that tenders would be floated soon and construction work would begin by year-end.

RSP sets multiple production records

Gaur population on rise as Ghumusar forest turns safe haven

Bhanjanagar, July 13: The northern forest division of Ghumusar forest in Ganjam district has emerged as a secure habitat for wildlife, with officials observing a notable rise in the population of the rare Indian bison or gaur. Alongside gaurs, numbers of black panthers, elephants, and spotted deer have also shown an increase in recent years.

Locals have even reported sightings of a rare melanistic leopard, commonly referred to as 'black panther', in one of the forest ranges. The presence of this elusive species has generated considerable excitement.

Forest officials attribute this positive trend to in-

creased enforcement of forest laws, which has significantly reduced illegal tree felling. Since the implementation of the Pradhan Mantri Ujjwala Yojana (PMUY) scheme, the demand for firewood has sharply declined, contributing further to the preservation of forest cover. While isolated

issues of encroachment, timber theft and poaching persist in certain forest patches, the Ghumusar North division remains largely protected. Last year also saw a significant drop in forest fires-an outcome credited to heightened public awareness campaigns.

At present, over a hundred gaurs are believed to be roaming safely within the Malati reserve forest which forms



the core of this division. To support the growing population, the Forest department is constructing new water bodies and rehabilitating old

ponds. Grazing grounds are also being prepared. Watchtowers are being planned to monitor their movements more effectively.

Although no official gaur census has yet been conducted in the region, preparations are under way to carry out one in the near future. Notably, gaurs are a preferred prey for tigers. However, the absence of resident big cats in the area means the species faces minimal predatory pressure, allowing it to multiply relatively undisturbed. A few months ago, a transient tiger, believed to have entered from Maharashtra, killed and consumed two gaurs in an isolated incident.

Apart from Malati, gaur sightings have also been reported in Chandragiri and Ambajhari ranges of the Ghumusar division. Elsewhere in the state. gaur populations are found in the Mahanadi wildlife sanctu-

ary, Debrigarh sanctuary, and a few other forested areas.

When contacted, Divisional Forest Officer Himansu Sekhar Mohanty said that all neces sary steps are being taken to ensure the protection of wildlife, particularly rare species. "Dedicated measures are being implemented for their safety, he stated.

In a related development, Principal Chief Conservator of Forests (PCCF) Suresh Panth is on a five-day inspection tour of Ganjam, Kandhamal, and Boudh districts since Friday.

He reviewed various forestry operations under the Berham pur forest division and assessed works in the Ghumusar South and North divisions, including the Digapahandi range.

ECI & Aadhaar

any of the acts of omission and commission by the Election Commission of India (ECI) in the recent past have been under question for their perceived bias in favour of the ruling dispensation and against the Opposition. Its latest ongoing exercise of conducting Special Intensive Revision (SIR) of electoral rolls in Bihar further strengthens the suspicion especially in the light of certain observations of the Supreme Court hearing petitions challenging the SIR. The most alarming is the revelation that the ECI appears to be arrogating to itself, in the name of electoral roll revision, the task of determining citizenship which is supposedly the exclusive preserve of the Union Home Ministry. However, handing over this critical power to that ministry also is a dangerous proposition. The Home Ministry tried to undertake the job under controversial circumstances through the infamous National Register of Citizens (NRC).

While allowing ECI to continue the SIR in Bihar, the two-judge Bench of Justices Sudhanshu Dhulia and Joymalya Bagchi rightly flagged three key issues, one of which being EC's power to check the citizenship of voters. The other two issues are the importance of due process and procedure to be followed during the revision and the timing of the revision itself. The Bench pertinently said, "This issue goes to the very root of democracy and the right to vote." It acknowledged that the EC, as a constitutional body, has powers well beyond the Representation of People's Act, 1951 (RPA), but at the same time made it amply clear that the process would be subject to judicial intervention. There is no room for confusion over the remit of the Ministry of Home Affairs to determine whether an individual is a citizen, as the SIR has sought to create. The Bench said "citizenship is an issue to be determined not by the Election Commission of India, but by the Ministry of Home Affairs," when EC's counsel defended the Commission's decision to exclude Aadhaar as a valid document.

The EC argument that "the precondition for adult suffrage is citizenship" appears tortuous. The contention is fallacious since it is not empowered to find the answer to the question of one's citizenship. The Bench drove home the point with the observation that had it been so, the SIR should have started much earlier. The ECI decision to disenfranchise the person who is already there on the electoral roll in

2025, would compel such an individual to appeal against it and the time-consuming exercise would denv him his right to vote in the ensuing election. The decision to begin the exercise only a couple of months before the Bihar election makes it all the more suspect, to say the least. Justice Dhulia's comment is a slap in the face of the entire exercise: "If you ask for these documents immediately. even I will not be able to produce it now



look at the practicality, look at the timeline." The Supreme Court also, in its order, asked the EC to explain why Aadhaar, Electoral Photo Identity Card and ration card cannot be accepted as valid documents in the SIR process. This potentially increases the ambit of the 11-document list that has caused widespread panic and confusion on the ground.

The ECI has over the years earned international accolades for its commendable work in including millions of voters into electoral rolls widening the scope of democracy. The court has rightly observed that "the entire exercise of SIR is about identity only." none of the 11 documents currently listed are "telltale ones for citizenship" and that they are all meant to prove identity. It also rightly went on to question why Aadhaar, which is "considered basic for getting other documents," is excluded while documents prepared on the basis of Aadhaar, such as caste certificates, are accepted. This not only exposes the inherent inconsistency in the ECI's position, but also the intent behind the exercise, which is primarily aimed at excluding as many Moslem and Yadav voters from the voter list so as Bihar elections swing in favour of the ruling BJP and its allies.

Also, the ECI's objection to Aadhaar, prepared at the cost of hundreds of crores of rupees from the national exchequer, as merely proof of residence rather than citizenship betrays its failure to understand the practical realities of Bihar, as also the rest of the country. According to one set of data, while 87 per cent of Bihar's population has an Aadhaar, only 45-50 per cent are matriculates and close to just 2 per cent have passports that form part of the 11 documents listed by the ECL The ECI has indeed not covered itself with glory by enforcing SIR. Its reputation as an autonomous, independent Constitutional body is at stake. It needs to be seen to rise above political manipulations and guarantee the participation of every citizen in exercising franchise instead of disenfranchising bona fide citizens. Funny as it may sound, the idea of Aadhaar was born during the Congress government of UPA II. But as is usual with that party, it was not forcibly implemented. Then comes the Modi led BJP in 2014 and by 2017 Aadhaar was made absolutely the pivot for survival in India. The citizen was made to run and run to link everything, including the spiritual soul to Aadhaar. Commercial enterprises understood the benefits and demanded Aadhaar, that held all private data of citizens, for every little act. Again, as is usual in India, even the so-called impregnable Aadhaar has been twisted and groped by elements inimical to the ruling dispensation. Therefore, the ECI has been commanded to deny use of Aadhaar for right to vote. If this move by the ECI is successful then it is the death of Aadhaar.

FOCUS DIPLOMACY **PAVING THE THIRD WAY**

rime Minister Narendra Modi visited five countries en route to attend the 17th BRICS Summit in Rio de Janeiro. These visits broke many new grounds. The countries he visited - Ghana, Trinidad & Tobago, Argentina, Brazil and Namibia - were all former colonies of Britain, Spain, Germany and Portugal. Significantly, in the current geopolitical scenario, whilst America and China are flexing their military and economic muscles to gain influence world over, these countries have tried to remain independent of the

power blocs Strategically, Modi may be

offering a third way by inviting these countries to 'grow together' as partners and seek 'security through solidarity'. He said that the power and value of a country do not manifest only through military mind or market size but in promoting inclusivity, cooperation and trust. The reference is obvious, that is, to America and China. There is hardly any debate on India's commitment to the Global South. Modi's visit to these countries heavily reflected this. He himself asserted that India has been concerned about the conditions of exploitation and discrimination of Global South. New Delhi sought to create an equal world where Global South has a voice and space. Modi promised to give a 'new form' to BRICS under its leadership that is passed on from the current Chair, Brazil. Will he succeed in transforming BRICS as he did to G20? Remember, BRICS is largely controlled by Sino-Russian axis.

In the absence of Chinese and Russian Presidents, there was quite a bit of coherence evident in the deliberations and statements that came out of the Rio Summit. The members were unanimous in their reference to the wars in Gaza and Iran. The Indian delegation even managed to insert a paragraph on Pahalgam condemning the act of ter-

rorism. This was not possible in the recent SCO Conference. Yet, substantially restructuring BRICS is a tall order.

Modi's first stop was Port of Spain, capital of Trinidad & Tobago. This was after the last visit of an Indian Prime Minister in 1999. Indian labourers were taken to that country way back from 1845. The current President Christine Carla Kangaloo and the Prime Minister Kamla-Prasad Bissessar owe their ancestry to India. Modi, as usual, addressed the Indian Diaspora and said the story of the Diaspora is no longer that of struggles and suffering but now consists of success and value. An important MoU was signed on Indian Pharmacopia, meant to facilitate supply of generic medicines from India.

The next stop was Ghana. Modi's visit was first by an Indian Prime Minister in 30 years. Ghana is a strategic partner for India in West Africa as it is a member of African Union and ECOWAS - Economic Community of West African States comprising 15 countries. Four MoUs were signed during the visit in the areas of traditional medicine and Ayurveda, BIS -Bureau of Indian Standards and a Ghana counterpart for trade investment, a cultural exchange (2025-29) and a Joint Commission for Regular Interaction between officials of both countries. Gha-

na was one of the first countries to use UPI payments. New Delhi offers to develop Ghana as a vaccine hub of Africa.

India would focus on Ghana to reduce China's dominance in Africa. New Delhi has the second largest number of projects in Ghana (11), and Indian companies have invested up to \$2bn in 818 projects. Ghana has been active in international politics along with India from the days of Kwame Nkrumah and Jawahar Lal Nehru.

In Buenos Aires, the capital of Argentina, the third stop in Modi's itinerary, he was received by President Javier Milei. The discussions focused on common themes of his entire visit - pharmaceuticals, vaccines, digital technology, food security and critical minerals. Argentina is rich in shale gas and oil. Both countries agreed on critical minerals as India offered pharmaceuticals.

Modi then flew from Argentina to Rio (Brazil) for the BRICS Summit, the highlights of which have been mentioned here earlier. After the Summit, Modi made an official visit to the country. He was met by his counterpart, the formidable Left leader, President of Brazil, Luiz Inacio Lula da Silva popularly known as Lula. Modi acknowledged the contribution of Lula as the chief architect of India-Brazil strategic partnership. Both leaders agreed that India-Brazil cooperation is an important pillar of the world. Both countries are members of BRICS and IBSA. Six agreements were inked which covered renewable energy, terrorism, intellectual property, agriculture, protection of classified information and defence (on mutual trust).

The last port of call was Namibia. This was first for Prime Minister Modi and third ever by an Indian Prime Minister. Namibian President Netumbo Nandi-Ndaitwah conferred Modi with the highest civilian award of her country. India has stood by Namibia's struggle for liberation. Its forerunner South West African Peoples Organisation had diplomatic contact with India in 1986. India was one of the first countries to recognise Namibia as it got independence in 1990. Several MoUs were signed with Namibia including the Global Bi-fuel Alliance. Namibia also accepted to launch UPI digital payments.

All in all, this long trip of five countries was an exercise essentially in economic diplomacy. Modi said profoundly that relationship should be built through technology, trade and trust. In this tour, Modi articulated alternative economic mechanisms to the developed world of Global North. It is perfectly in order to promote economic diplomacy and build trade partnership. But, at the end of the day, the world order is defined by power, in its multiple dimensions. The countries in Global South are disunited despite common history and destiny. The big question is how to execute their aspiration in the current geopolitical complexity. Admittedly, economic diplomacy can be independent of other variables in global politics. However, this is doable and desirable as long as it lasts.

Abandoning the founding principles

n late June and early July 1776, the Second Continental Congress framed, debated, and adopted the Declaration of Independence. The document announced the creation of a new American republic and established its defining principles: a commitment to free trade, free immigration, and internationalism. The determination of President Donald Trump's administration to abandon these founding principles has become starkly apparent. By doing so, they risk surrendering the key to America's prosperity and geopolitical influence at a moment when the world has never appeared so unstable. The Committee of Five -John Adams, Thomas Jefferson, Benjamin Franklin, Robert Livingston, and Roger Sherman - who drafted the Declaration of Independence condemned King George III for "cutting off our trade with all parts of the world." Since George III's accession in 1760, the British imperial government had erected tariffs and non-tariff barriers on American trade with the French and Spanish colonies in the Caribbean and South America, depriving Americans of a vital outlet for their products and access to hard currency.

This led Jefferson, in 1774, to implore Britain not "to exclude us from going to other markets.' The following year, Franklin called on the monarchy "to give us the same privileges of trade as to the greater employment of our manufacturers. America's founders declared

people by signing into law the Act to Encourage Immigration.

No one truly committed to their independence from Britain the original meaning of Amernot because they wanted to turn ica's constitutional document can abandon the principles of free trade, free immigration or internationalism, as framed by Franklin and Jefferson, embraced by Adams and Lincoln, and presumably celebrated each year on the Fourth of July. But recent developments suggest that today's political leaders are doing just that. The Trump administration's flurry of tariffs and trade barriers, terrorization and deportation of immigrants, and increasing isolationism are more reminiscent of George III's policies than of those defended by America's founders. Over the past 249 years, the US was arguably at its greatest when it fervently pursued its founding mission to guarantee the free flow of people and goods, and to build international alliances opposed to tyrannical and autocratic governments. As the country approaches its semiquincentennial, one fears that it is also approaching its nadir.

The focus on freshwater pearl cultivation in Jharkhand leverages the state's natural water resources while providing a sustainable livelihood option that can be scaled from small backvard operations to larger commercial ventures

Ranchi, July 13: Jharkhand is rapidly emerging as India's freshwater pearl farming hub, with the state government and Centre implementing comprehensive training programmes and infrastructure development to transform this niche sector into a major livelihood opportunity for rural youth and farmers.

The transformation gained momentum when the Centre notified development of Hazaribagh as the first pearl farming cluster with ₹22 crore investment under the Pradhan Mantri Matsya Sampada Yojana (PMMSY) in collaboration with the Jharkhand govern ment.

What started as a pilot project in 2019-20 under the state plan has now evolved into a structured ecosystem focusing on skill development, with specialised training centres established across the state to teach farmers the intricate art of pearl cultivation.

Training takes root

The Purty Agrotech Training Centre, established in Ranchi in 2024 using corporate CSR funds, has emerged as the nerve centre of this training revolution. The facility has already trained over 132 farmers from across the state in advanced pearl culture techniques, with these trained farmers now cascading their knowledge to others in their respective districts, creating a multiplier effect.

"Training is the backbone of successful pearl farming. We are focusing on round pearl



culture as it fetches more returns compared to designer pearls," said Budhan Singh Purty, a mechanical engineer from NIT Jamshedpur who runs the training centre and has become one of the state's few surgical experts in round pearl cultivation.

The training programmes emphasise skilled surgical grafting techniques, use of specialised instruments, and careful post-surgical management -- critical factors that determine survival rates and quality of pearl production. This focus on technical expertise is crucial since culturing round pearls demands precision to ensure high survival rates and

quality production. Recognising the sector's potential, St Xavier's College, Ranchi, has introduced certificate courses in pearl farming ranging from six months

Hazaribagh is set to to one-and-a-half years, integrating academic research with practical field ex-

perience "Pearl farming is going to be a rising sector in Jharkhand and provide job opportunities to youth. The knowledge of science along with field experience will help develop enterprising skills," Professor Ritesh Kumar Shukla told PTI.

Compelling economics drive adoption

The state's emergence as a pearl farming hub is driven by compelling economics -- round pearls can be cultivated in backyard settings using cement tanks, buckets, or fish tanks, and yield profits of more than ten times the investment. The cultivation can be done in small spaces, making it accessible to small farmers and youth seeking alternative livelihoods. The economics are straightforward: it costs ₹35-50 to nurture one mussel for three years until plans

it produces a pearl, which then sells for up to ₹1,000, depending on quality. This means farmers can expect significant returns on relatively modest investments.

ground, Purty has developed indigenous surgical tools costing ₹3.600 to manufacture, compared to imported alternatives that cost up to ₹25.000. "As pear] farming expands in the state, there will be huge demand for surgical tools. There is scope to set up a unit to manufacture surgical tools," he said.

Purty has established supply chains with TRIFED, Tata Big-Basket, IndiaMART, and also supplies to Surat for export purposes, demonstrating the market potential for Jharkhand's pearl production.

Government support and future

State Fisheries Department Director HN Dwivedi emphasised the huge potential to promote natural pearl farming as a cottage industry in Jharkhand providing employment to youth.

Currently, NABCONS (NA-BARD Consultancy Services) is conducting gap analysis and soon the action plan to devel op Hazaribagh cluster will be ready," Dwivedi said.

The state has also proposed setting up a brood bank of Vietnamese mussel species Hyriop sis Cumingii and sought funds from the Centre under PMMSY

The National Fisheries Development Board (NFDB) has reported that 1.02 lakh pearls were produced from Hazaribagh district alone, indicating the sector's growing scale.

Science behind pearl production

Mussels, bivalve molluscs found in both freshwater and marine environments, play a central role in freshwater pearl production as living hosts that secrete nacre to form pearls over a three-year period. The process requires careful man agement and monitoring to ensure optimal conditions for pearl formation.

As this sector continues to expand, Jharkhand is positioning itself not just as a production hub but as a centre of excellence for pearl farming training and technology development, potentially transforming the economic landscape for rural communities across the state.

Bundi, July 13: In a significant move towards sustainable energy and self-reliance, the Health Department in Bundi, Rajasthan, has taken a major step by adopting solar power under the government's initiative to promote renewable energy across public departments.

In what is beneficial to the patients and staff a lot, a solar panel system of 4.5 kilowatts has been installed at the Bundi District General Hospital. This is aimed at reducing electricity consumption and significantly cutting down monthly electricity bills.

This significant move has come at a time when the hospital has been reeling under power outages for a long time. The outages have been causing operational disruptions in the hospital.

With the new solar power setup, the hospital is expected to enjoy uninterrupted power supply, ensuring a smoother experience for both patients and healthcare staff, say officials.

Lakshmi Narayan Meena, the in-charge of the General Hospital, expressed his satisfaction with the initiative. Talking to IANS, Meena said, "This solar panel will truly help us overcome the challenges

caused by frequent power cuts and it will also ease the burden of high electricity bills. All departments should adopt this system.

He further added that such steps by the state government would serve as a milestone for administrative offices and public institutions. One of the key benefits of this solar system is its capacity to generate surplus electricity. If the hospital pro duces more electricity than required, the excess power can be sold back to the electricity dis tribution company (DISCOM)

This would provide an additional source of income for the department, which can be utilised for minor operational expenses, offering further financial relief. He said that the surplus power can be given to the government, which can also benefit from it.

"There is no fault and other related issues in the supply of the power generated through solar panels, which is normally felt in a non-solar power system," he added.

He lauded this initiative. saving that there are lots of benefits from this. This tran sition to solar energy marks a significant step toward making the Bundi Health Department more self-reliant and environmentally responsible.

Tree plantation targets raise concerns in schools

Buried in plantation - targets, school teachers in Rajasthan say govt ordered drive 'impractical'

Jodhpur, July 13: Schools in Rajasthan face an unlikely challenge at the beginning of the new session: teachers and students are both tasked with ensuring that they meet daily and ultimately monthly targets of an aggressive government-ordered plantation drive.



A teacher from a senior secondary school in the city also questioned the order's "practicality", and asked where schools in urban areas will find enough places for such a plantation drive.

Media in-charge of Rajasthan Shikshak Sangh (Ajmer Division), Kalu Ram, asked whether



Under the Hariyalo Rajasthan Ek Ped Maa Ke Naam Mission. the state's education minister, Madan Dilawar, has directed the planting of 25 crore saplings between July 10 and August 10.

According to the order, every student up to upper primary classes has to plant 10 saplings per day, while students in the primary level have a target of 15 plants per day, and teachers have to plant 15 saplings per day.

"Does it sound practical by any means?" asked a principal of a senior secondary school in Jodhpur's suburban area.

"Plantation is the need of our time, but such a daunting target and pressure to achieve it does not make any sense and affects the routine work," she said, adding that most schools do not have a place for plantation at all.

This affects routine school work and affects admissions, given that it is harder to convince parents to send their children to school.

Besides, the schools have to upload the entire activity, from digging to planting the sapling, on an app provided to the teachers, according to the order.

Teachers are also concerned about finding a spot to dig a pit. arranging the plants, and then ensuring that the plants survive, the teachers are supposed to run the school and teach or be seen running around digging pits and planting trees. "Many important aspects have been overlooked in this drive, and in the absence of judicious planning, this entire exercise will miserably fall short of purpose," he added.

He further expressed concern that school staff will struggle to convince parents, many of whom are already disinterested in sending their children to government schools.

Environmentalist and plantation crusader Ram Niwas Budhnagar attributed the order to an attempt at self-praise and said the order was a "mockery" of environmental concern and "exploitation" of teachers. "This order is absolutely impractical and arbitrary, which would derail the school's routine function at this time," he said.

Budhnagar said the government could instead have chosen those who were already engaged in plantation work, given their expertise and access to resources.

Under the central government's Ek Ped Maa Ke Naam campaign, people plant trees in the name of their mothers — a symbolic gesture to honour their role in nurturing life while addressing the need for environmental preservation.

Srinagar, July 13: Prominent leaders, including from ruling and Opposition parties, were placed under "house arrest" in Srinagar Sunday to prevent them from visiting the martyrs' graveyard to pay tributes to the 22 people killed by the Dogra army in 1931, a move termed by Chief Minister Omar Abdullah as "blatantly undemocratic". The detentions, which were

not officially confirmed by police or the administration, were widely reported by leaders who posted videos and pictures showing their gates locked or blocked by security personnel to stop

them from going to the Naqshband Sahib Martyrs graveyard near Nowhatta in the old city.

The Srinagar district administration had denied permission to all applicants, including the ruling National Conference lead-

ers, to visit the graveyard. All roads leading to the area located in downtown were barricaded with a heavy presence of police personnel Sunday.

In a post on X, the Jammu and Kashmir chief minister likened the July 13, 1931 incident to the Jallianwala Bagh massacre, saying, "the people who laid down their lives did so against the British ... What a shame that true heroes who fought against British rule ... are today projected as villains."

Abdullah criticised the house detentions, and said "in a blatantly undemocratic move. homes have been locked from the outside, police and central forces deployed as jailers ... All to stop people from visiting a historically important graveyard.'

The National Conference leader said, "We may be denied the opportunity to visit their graves today, but we will not forget their sacrifices". Senior National Conference leader and advisor to the chief minister. Nasir Wani, termed the detentions as a "misuse" of power, specifically highlighting what he called a conflict between the "nominated system" of the central administration and the "elected government". This sentiment was echoed by others who saw the move as an attempt to undermine the authority of the newly elected government.

Srinagar Police had issued a public advisory and posted on its handle on X Saturday that the "District Administration Srinagar has denied permission to all applicants intending to proceed towards Khawaja



Bazar, Nowhatta 13th July 2025 (Sunday)". The district magistrate had also rejected the ruling National Conference's plea seeking permission for NC president Farooq Abdullah and other senior functionaries to visit the graveyard.

PDP President Mehbooba Mufti posted pictures of her main door locked and said, "When you lay siege to the Martyrs' Graveyard, lock people in their homes... it speaks volumes.

She argued that a genuine end to mistrust between Delhi and Kashmir would only happen when India accepts Kashmiri "martyrs" as their own. "The day you accept our heroes as your own just as Kashmiris have embraced yours, from Mahatma Gandhi to Bhagat Singh, that day, as Prime Minister Modi once said, the 'dil ki doori' (distance of hearts) will truly end,' she said in a post on X.

Deputy Chief Minister Surinder Chaudhary, who was in Jammu, said that his official residence in Kashmir was also locked by the administration. July 13 used to be a public holiday in Jammu and Kash mir before the reorganisation of the erstwhile state into two Union territories in August 2019. The administration dropped the day from the list of gazetted holidays in 2020.

On the day, mainstream po litical leaders used to visit the "martyrs' graveyard" to pay homage to the Kashmiris who fell to the bullets of the forces during a protest against the then Dogra ruler, Maharaja Hari Singh, in 1931.

Assembly Sunil Sharma dubbed the slain protesters as "traitors' and said the ruling party is trying to indulge in "provocative politics" and revive a separatist sentiment which was long buried following abrogation of Article 370 in 2019.

Panun Kashmir and All State Kashmiri Pandit Conference held separate programmes in Jammu to protest "communal attacks" faced by the community in 1931. Jammu and Kashmir Apni Party chief Altaf Bukhari said he has been confined to his home, with police reportedly locking his party's headquarters to prevent a planned prayer event. He described the actions as "clear and blatant examples of highhandedness and authoritarian behaviour."

CPM leader and MLA M Y Tarigami posted on X that his gate has been locked and he has been placed under house arrest and denied the right to pay homage to the July 13 martyrs.

Peoples Conference president Sajad Gani Lone also claimed that he has been stopped from leaving his residence.

Rural health officer shot dead in Patna

Patna: A 50-year-old rural health officer was shot dead in Patna's Pipra locality, officials said Sunday. The deceased has been identified as Surendra Kumar. The incident took place at Sheikhpura village Saturday night when Kumar was working in a field, they said. According to villagers, they heard gunshots from the field, and when they went there, the officer was found lying unconscious with bullet injuries, Sub-Divisional Police Officer (SDPO-2) Masaurhi, Kanhaiya Singh, told reporters, Kumar, reportedly associated with BJP, was taken to a nearby hospital where he succumbed to injuries during treatment, Singh said. The body has been sent for post-mortem examination, he said, adding, further probe is underway. The incident comes close on the heels of a spate of murders that have rocked the state capital in the last one week.

4 devotees killed as car rams into tractor-trolley

Kushinagar (UP): Four devotees, returning from Baba Dham and Thawen after offering prayers, were killed when the car they were in collided with a tractor-trolley in the Pateharwa Police Station area of the Kushinagar district, officials said Sunday. All the devotees in the car were residents of Siddharthnagar district, returning after visiting the Thawe Durga Temple located in Gopalganj, Bihar Sunday morning. The deceased were identified as Manoj Kumar (village head, Phulpur), Sujit Jaiswal (village development officer, Mithwal block), Ramkaran Gupta (kanungo, Shohratgarh) and Kailash Mani Tripathi (teacher, Nagar Palika Parishad Siddharthnagar), all residents of Siddharthnagar district. Two other individuals, Rajesh Sharma (the driver) and Sushant Sharma, also residents of Siddharthnagar, sustained injuries and are currently receiving treatment, the police said.

Second suspected Nipah death in Kerala

Palakkad (Kerala): A 57-year-old man from Palakkad district in Kerala, who died July 12, is suspected to have been infected with the Nipah virus, prompting the government to ramp up contact tracing and field-level surveillance in the area. The man had been undergoing treatment at a private hospital in this northern district. His samples were tested at Manier Medical College, where the result came back positive for Nipah. Health Minister Veena George said in a statement. She added that the government is awaiting confirmation from the National Institute of Virology in Pune. This is the second Nipah-related death reported in Kerala in recent days. A native of Malappuram had recently died from the infection, while another patient from Palakkad district remains hospitalised. In response to the fresh suspected case, the government has ramped up contact tracing and fieldlevel surveillance in the area. A list of 46 people who came into contact with the patient has been drawn up. CCTV footage and mobile tower location data have been used to help identify those on the contact list. A detailed route map of the patient's recent movements has been prepared, along with a family tree to trace close contacts.

He is then made to publicly apologise to a man and his sister, with whom he allegedly misbehaved earlier, as well as to the state for "insulting" it and its linguistic and cultural heritage.

New Delhi, July 13: Excessive salt consumption is fuelling a silent epidemic in India with people at increased risk of hypertension, stroke, heart disease, and kidney disorders, according to scientists from ICMR's National Institute of Epidemiology.

The scientists have initiated a community-led salt reduction study to address the issue and are focusing on low sodium salt substitutes.

While the World Health Organisation (WHO) recommends less than 5 grams of salt per person per day, studies show that urban Indians consume around 9.2 grams/ day, and even in rural areas it is around 5.6 grams/day - both higher than recommended.

One promising tool in this effort is low-sodium salt substitutes -- ?blends where part



of the sodium chloride is replaced with potassium or magnesium salts, Dr Sharan Murali, a senior scientist at National Institute of Epidemiology (NIE) and principal investigator of the study, said. "Lesser sodium consumption

helps reduce blood pressure and improves overall heart health. making low-sodium alternatives a meaningful switch, especially for those with hypertension," Dr Murali stated.

"Just switching to low-sodium salt can lower blood pressure by 7/4 mmHg on average'?a small change with a big impact," Dr Murali said. To tackle the issue of high salt consumption, the NIE has launched a three-year intervention project in Punjab and Telangana, supported by the Indian Council of Medical Research (ICMR).

The goal is to evaluate the effectiveness of structured salt reduction counselling, delivered by health workers at Health and Wellness Centres (HWCs), in reducing blood pressure and sodium intake among individuals with hypertension, senior scientist at NIE, Dr Ganesh Kumar, who is also a part of the study, said.

"We are currently in the first year of the project, focused on baseline assessments and field preparations," Dr Kumar said. 'Counselling materials are not yet finalised; rather, we aim to co-create the intervention package with the community health workers, drawing on their experiences and incorporating their suggestions. It's not just about delivering health education - ?it's about listening, understanding, and building together," Dr Murali said.

To ensure interventions are

grounded in reality, the NIE conducted a market survey across 300 retail outlets in Chennai to assess the availability and pricing of low-sodium salt (LSS)

They found that LSS was available in only 28 per cent of retail outlets. It was seen in 52 per cent of supermarkets, but a dismal 4 per cent in small grocery shops. The price of LSS averaged ₹5.6 per 100g, more than twice the price of normal iodised salt (Rs 2.7 per 100g).

To spark a public conversation around salt reduction, the NIE has also recently launched the #PinchForAChange campaign on Twitter and LinkedIn through ICMR-NIE. Using infographics, facts, and simple messages, the campaign aims to raise awareness about hidden salt sources, promote low-sodium alternatives, and empower individuals to make heart-healthy choices.

New Delhi, July 13: After 18 days of intense science experiments at the International Space Station, it is time for farewells and feasts for Shubhanshu Shukla and three other astronauts of the Axiom-4 mission who are set to begin their return journey to Earth Monday.

The Axiom 4 (Ax-4) crew— Commander Peggy Whitson, Pilot Shubhanshu "Shux" Shukla, and Mission Specialists Slawosz "Suave" Uznanski-Wisniewski and Tibor Kapu-are nearing the completion of their research and preparing to undock no earlier than at 7:05 am ET (4:35 pm IST) Monday.

'Arrival back to earth... splash down scheduled for 15th July at 3:00 PM IST," Science and Technology Minister Jitendra Singh said in a post on X. A formal farewell for the Axiom-4 crew is scheduled for Sunday evening, India time. As the Axiom-4 mission drew to a close, astronauts on board the ISS gathered for a feast with a diverse menu from the six nations they represent.



Currently, there are 11 astronauts on the ISS, seven of Expedition 73 and four of the Axiom-4 commercial mission. "One of the most unforgettable evenings I've experienced on this mission was sharing a meal with new friends, Ax-4, aboard the International @Space_Station,' US astronaut Jonny Kim said in a post on X last week. "We

swapped stories and marvelled at how people from diverse backgrounds and nations came together to represent humanity in space," he said.

For appetisers, the astronauts made rehydrated shrimp cocktails and crackers and the main course featured sayoury chicken and beef fajitas. The cosmonauts capped the night

with a delicious cake made from sweet bread, condensed milk, and walnuts. Kim said.

Shukla had got aam ras and carrot halwa for the feast, while Polish astronaut Slawosz had brought his native dish, pierogi with cabbage and mushrooms, to the ISS.

It has been a historic trip for Shukla, who became the first Indian to travel to the ISS and only the second to travel to space after Rakesh Sharma's pathbreaking spaceflight as part of the then Soviet Russia's mission to Salyut-7 space station in 1984.

So far, Shukla has spent 18 days in space, witnessing 16 sunrises and sunsets every day as the ISS travels at a speed of 28,000 km per hour in an orbit about 400 km above the Earth.

According to ISRO, post splashdown, Shukla will undergo a rehabilitation programme (about 7 days) under the supervision of a flight surgeon to adapt back to Earth's gravity.

ISRO paid approximately Rs 550 crore for Shukla's travel to the ISS, an experience that will help the space agency in the planning and execution of its human spaceflight programme, Gaganyaan, set to take to orbit in 2027.

Shukla and the three other astronauts are expected to board the spacecraft at 2.25 pm IST, wear their space suits and carry out the necessary tests before they begin their journey to the Earth.

The ISS is orbiting the Earth at a speed of 28,000 km per hour, and the Dragon space craft will initiate the autonomous undocking process to gradually slow down and re-enter the planet's atmosphere for a splashdown off the coast of California.

Israel says it will only end the war once Hamas surrenders, disarms and goes into exile, something it refuses to do. Hamas says it is willing to free all the remaining 50 hostages, less than half said to be alive, in exchange for an end to the war and the full

withdrawal of Israeli forces. Gaza's Health Ministry said Sunday that more than 58,000 people have been killed in the



war. The ministry doesn't differentiate between civilians and combatants in its count but says more than half of the dead are women and children. In the Oct 7, 2023, attack that sparked the war, Hamas-led militants killed some 1,200 people and abducted 251 in a raid

 on northern Israel.
Throughout the war in Gaza, violence has also surged in the Israeli-occupied West Bank,
where funerals were held Sunday for two Palestinians, including Palestinian-American Sayfollah Musallet, 20, who was killed in an attack by Israeli settlers, according to the Palestinian Health Ministry.

In central Gaza, officials at Al-Awda Hospital said it received 10 bodies after an Israeli strike on a water collection point in nearby Nuseirat. Among the dead were six children, the hospital said.

Ramadan Nassar, a witness who lives in the area, told The Associated Press that around 20 children and 14 adults were lined up Sunday morning to fill up water. When the strike occurred, everyone ran and some, including those who were severely injured, fell to the ground, he said.

He said Palestinians walk some 2 kilometres to fetch water from the area.

The Israeli military said it was targeting a militant but that a technical error made its munition fall "dozens of metres from the target." It said the incident was being examined.

Additionally, health officials said an Israeli strike hit a group of citizens walking in the street on Sunday afternoon, killing 11 people and injuring around 30 others in central Gaza City.

Dr Ahmed Qandil, who specialises in general surgery and laparoscopic, was among those killed, the Gaza Health Ministry said in a statement. One of the ministry's spokespeople, Zaher al-Wahidi, told the AP that Qandil was on his way to Al-Ahli Arab Baptist Hospital when the strike happened. All bodies and those wounded were taken to Al-Ahli hospital, according to al-Wahidi.

'Beautiful' or 'Ugly,' Trump's bill shapes battle for midterms

Washington, July 13: Debate over President Donald Trump's sweeping budget-and-policy package is over on Capitol Hill. Now the argument goes national.

From the Central Valley of California to Midwestern battlegrounds and suburban districts of the northeast, the new law already is shaping the 2026 midterm battle for control of the House of Representatives. The outcome will set the tone for Trump's final two years in the Oval Office.

Democrats need a net gain of three House seats to break the GOP's chokehold on Washington and reestablish a power centre to counter Trump. There's added pressure to flip the House given that midterm Senate contests are concentrated in Republican-leaning states, making it harder for Democrats to reclaim that chamber.

As Republicans see it, they've now delivered broad tax cuts, an unprecedented investment in immigration enforcement and new restraints on social safety net programmes.

Democrats see a law that rolls back health insurance access and raises costs for middle-class Americans while cutting taxes mostly for the rich, curtailing green energy initiatives and restricting some workers' organising rights.

"It represents the broken promise they made to the American people," said Rep Suzan DelBene, a Washington Democrat who chairs the party's House campaign arm. "We're going to continue to hold Republicans accountable for this vote." There are a historically low number of so-called crossover districts: Only 13 Democrats represent districts Trump carried in 2024, while just three Republicans serve districts Democratic presidential nominee

opened by retirements.

Kamala Harris carried. Both committees are busy recruiting challengers and open-seat candidates and more retirements could come, so the competitive map will evolve. Still, there are clusters of districts guaranteed to influence the national result.

California, despite its clear lean to Democrats statewide, has at least nine House districts expected to be up for grabs: three in the Central Valley and six in southern California. Six are held by Democrats, three by the GOP.

Pennsylvania features four districts that have been among the closest national House races for several consecutive cycles. They include a suburban Philadelphia seat represented by Rep Brian Fitzpatrick, one of just two House Republicans to vote against Trump's bill and one of the three GOP lawmakers from a district Harris won. Fitzpatrick cited the Medicaid cuts.

Iowa and Wisconsin, meanwhile, feature four contiguous GOP-held districts in farmheavy regions where voters could be swayed by fallout from Trump's tariffs.

Beyond bumper-sticker labels – Trump's preferred "Big Beautiful Bill" versus Democrats' "Big Ugly Bill" retort – the 900-page law is, in fact, an array of policies with varying impact.

Democrats hammer Medicaid and food assistance cuts, some timed to take full effect only after the 2026 midterms, along with Republicans' refusal to extend tax credits to some people who obtained health insurance through the Affordable Care Act.

Over 70 held at UK protests in support of Palestine Action

London, July 13: More than 70 people were arrested Saturday at protests in the UK against the Palestine Action group being proscribed a terrorist organisation by the British government following a breakin and vandalism at a Royal Air Force base.

In London, the Metropolitan Police said 42 people had been arrested by late afternoon. All but one of the arrests were for showing support for a proscribed organisation, which police have said includes chanting, wearing clothing or displaying articles such as flags, signs or logos. Another person was arrested for common assault.

A further 16 arrests were made in Manchester, according to Greater Manchester Police, while South Wales Police said 13 people were also held in Cardiff.

In London, it was the second straight week protesters gathered to support the pro-Palestinian activist group. Its outlawing has meant support for the organisation is deemed a criminal offense. Police arrested 29 people at a similar protest last weekend. Two groups gathered underneath both the statues of Mahatma Gandhi and Nelson Mandela, in Parliament Square. Signs with the wording "I oppose genocide, I support Palestine Action," were held aloft in silence as the protesters were surrounded by police officers

No details on where the plane was heading or how many people were on board were immediately disclosed.

In a statement on social media, the airport confirmed a "serious incident" involving what it termed a general aviation aircraft. Images posted on social me-

dia show a plume of fire and black smoke emanating from the crash site. The plane involved is said to be 12 metres (39 feet) long.

Witness John Johnson, who was at the airport with his family, said he saw a "big fireball" after the plane "crashed head first into the ground."

"It took off and about three or four seconds after taking off, it started to bank heavily to its left, and then within a few seconds of that happening, it more or less inverted and crashed just head-first into the ground," he said. "There was a big fireball." Johnson said that before the plane got into position for take-off, he and his family waved at the pilots and "they all waved back at us." After the crash, Johnson said the airport's fire service responded straight away, with two fire engines sent to the crash site, followed by local police, ambulance and fire services.

"We are working with all emergency services at the scene now and that work will be ongoing for several hours," Essex Police said. Hungary's 1000-yr-old library fighting beetle infestation

Pannonhalma, July 13: Tens of thousands of centuries-old books are being pulled from the shelves of a medieval abbey in Hungary in an effort to save them from a beetle infestation that could wipe out centuries of history.

The 1,000-year-old Pannonhalma Archabbey is a sprawling Benedictine monastery that is one of Hungary's oldest centres of learning and a UNESCO

World Heritage site. Restoration workers are removing about 100,000 handbound books from their shelves and carefully placing them in crates, the start of a disinfection process that aims to kill the tiny beetles burrowed into them.

The drugstore beetle, also known as the bread beetle, is often found among dried foodstuffs like grains, flour and spices. But they also are attracted to the gelatin and starch-based adhesives found in books.

They have been found in a section of the library housing around a quarter of the abbey's 400,000 volumes.

"This is an advanced insect infestation which has been detected in several parts of the library, so the entire collection is classified as infected and must be treated all at the same time," said Zsofia Edit Hajdu, the chief restorer on the project. "We've never encountered such a degree of infection before."

The beetle invasion was first detected during a routine library cleaning. Employees noticed unusual layers of dust on the shelves and then saw that holes had been burrowed into some of the book spines. Upon opening the volumes, burrow holes could be seen in the paper where the beetles chewed through.

The abbey at Pannonhalma was founded in 996, four years before the establishment of the



Hungarian Kingdom. Sitting upon a tall hill in northwestern Hungary, the abbey houses the country's oldest collection of books, as well as many of its earliest and most important written records.

For over 1,000 years, the abbey has been among the most prominent religious and cultural sites in Hungary and all of Central Europe, surviving centuries of wars and foreign incursions such as the Ottoman invasion and occupation of Hungary in the 16th century.

Ilona Ásványi, director of the Pannonhalma Archabbey library, said she is "humbled" by the historical and cultural treasures the collection holds whenever she enters.

"It is dizzying to think that there was a library here a thousand years ago, and that we are the keepers of the first book catalogue in Hungary," she said.

Among the library's most outstanding works are 19 codices, including a complete Bible from the 13th century. It also houses several hundred manuscripts predating the invention of the printing press in the mid-15th century and tens of thousands of books from the 16th century.

While the oldest and rarest prints and books are stored separately and have not been infected, Ásványi said any damage to the collection represents a blow to cultural, historical and religious heritage.

"When I see a book chewed up by a beetle or infected in any other way, I feel that no matter how many copies are published and how replaceable the book is, a piece of culture has been lost," she said.

To kill the beetles, the crates of books are being placed into tall, hermetically sealed plastic sacks from which all oxygen is removed. After six weeks in the pure nitrogen environment, the abbey hopes all the beetles will be destroyed.

Before being reshelved, each book will be individually inspected and vacuumed. Any book damaged by the pests will be set aside for later restoration work. The abbey, which hopes to reopen the library at the beginning of next year, believes the effects of climate change played a role in spurring the beetle infestation as average temperatures rise rapidly in Hungary.

Hajdu, the chief restorer, said higher temperatures have allowed the beetles to undergo several more development cycles annually than they could in cooler weather.

Industry officials said this would lead to differentiated compliance based on proximity to urban populations and the sulphur content of the coal used. The new framework has been finalised after extensive deliberations and multiple in-

Measurements across multiple cities showed sulphur oxide levels ranging between 3 and 20 micrograms per cubic meter. significantly below the NAAQS threshold of 80 micrograms per cubic meter. Officials said studies had also questioned the environmental and economic

efficacy of a universal FGD mandate in the Indian context.

Indian coal typically has a sulphur content of less than 0.5 per cent, and due to high stack heights and favourable meteorological conditions, dispersion of SO2 is efficient. The NIAS study warned that

retrofitting FGDs nationwide would add an estimated 69 million tonnes of CO₂ emissions between 2025 and 2030 due to increased limestone mining, transportation, and power consumption. Globally, carbon markets aim to incentivise generators that are reducing their carbon footprint and penalise those who are emitting carbon.

With the installation of FGD, India may be increasing its carbon footprint with a reduction in SO2 emission, which is not advisable as per the present ambient air quality levels, according to a report written by CSIR-NEERI with financial support from NITI Aayog.

Besides, SO and CO have different atmospheric lifetimes -SO has a short atmospheric lifetime of several hours to about 15 days, while CO persists for over 100 years

The financial burden of mandatory FGD retrofitting was previously estimated at over Rs 2.5 lakh crore, or Rs 1.2 crore per MW, with installation time lines of up to 45 days per unit.

Russian oil import

New Delhi, July 13: India's import of crude oil from Russia rose to an 11-month high in June as refiners topped up tanks amid the Israel-Iran war, analysts said.

India imported 2.08 million barrels per day (bpd) of Russian crude in June, the highest since July 2024, according to vessel tracking data from global commodity market analytics firm Kpler.

"While India's global imports of crude oil dropped by 6 per cent in June, Russian volumes saw an 8 per cent month-onmonth rise to their highest levels since July 2024," European think tank Centre for Research on Energy and Clean Air said. "More than half of these im-

ports from Russia were made by three refineries in India, which also export refined products to G7+ countries."

India imports more than 85 per cent of its requirement of crude oil, which is turned into fuels like petrol and diesel

in refineries. Traditionally the Middle East was the main source, but Russia has been the mainstay supplier for nearly three years now.

After much of the West shunned Russian crude following Moscow's invasion of Ukraine in February 2022 Russia began offering steer discounts to attract alterna tive buyers. Indian refiners seized the opportunity, turn ing Russia, once a marginal supplier, into India's largest source of crude oil, overtaking traditional suppliers from West Asia. Russia now accounts for as much as 40 per cent of India's oil imports.

In June, India imported approximately 8,93,000 bar rels per day (bpd) of crude from Iraq - its second-largest supplier - marking a 17.2 per cent month-on-month decline. Saudi Arabia followed with 5,81,000 bpd (largely unchanged from May), while imports from the UAE rose 6.5 per cent to 4,90,000 bpd.

The valuation of Life Insurance Corporation of India (LIC) di minished by Rs 11,954.25 crore to Rs 5,83,322.91 crore.

The mcap of HDFC Bank declined by Rs 4,370.71 crore to Rs 15.20.969.01 crore and State Bank of India went lower by Rs 2,989.75 crore to Rs 7,21,555.53 crore. However, the valuation of Hindustan Unilever Ltd jumped Rs 42,363.13 crore to Rs 5,92,120.49 crore. Shares of Hindustan Unilever Ltd (HUL) Friday surged nearly 5 per cent after the company announced that Priva Nair will become its first woman CEO and MD.

The mcap of Bajaj Finance climbed Rs 5,033.57 crore to Rs 5,80,010.68 crore.

Reliance Industries was the most valued firm, followed by HDFC Bank, TCS, Bharti Air tel, ICICI Bank, State Bank of India, Infosys, LIC, Bajaj Fi nance and Hindustan Unilever in that order.



Electronics, pharma sectors corner 70% of PLI disbursements

New Delhi, July 13: Largescale electronics manufacturing and pharmaceuticals cornered about 70 per cent of the total fiscal incentive disbursements in 2024-25 under the production-linked incentive (PLI) schemes, according to government data.

The scheme was introduced in 2021 to support domestic manufacturing across 14 sectors with an outlay of Rs 1.97 lakh crore.

In 2024-25, the government has disbursed a total of Rs 10.114 crore. PLI firms in the electronics sector received Rs 5,732 crore, while pharmaceutical drugs received Rs 2,328 crore, the data showed.

In 2023-24, the disbursals stood at Rs 9,721 crore. The figures highlight the country's growing strength in these segments amid efforts to boost manufacturing and value-added exports.

Besides these two, the other sectors that received these incentives in the last fiscal include bulk drugs (Rs 22 crore), Medical Devices (Rs 77 crore), Telecom (Rs 840 crore), Food Processing (Rs 448 crore), White Goods (Rs 210 crore), Automobiles (Rs 322 crore), Specialty Steel (Rs 48 crore), Textiles (Rs 40 crore) and Drones (Rs 35 crore).

The country's electronic goods shipment saw the highest export growth rate at 32.46 per cent, jumping from \$29.12 billion in 2023-24 to \$38.58 billion in the last fiscal year. It was \$23.6 billion in 2022-23 and \$15.7 billion in 2021-22.

Within this, computer hardware and peripherals, which form 3.8 per cent of the sector, saw 101 per cent growth, doubling from \$0.7 billion to \$1.4

The main destinations for electronic goods were UAE, US, Netherlands, UK, and Italy. According to the data, Indian drugs and pharmaceuticals are reaching over 200 countries now. These exports increased by about 10 per cent to \$30.5 billion in 2024-25
