The court, June 23, granted FM student dies; principal held

Bhubaneswar, July 14: The 20-year-old female student of FM (Autonomous) College, Balasore, who set herself ablaze following alleged sexual harassment by a professor and was undergoing treatment at AIIMS, Bhubaneswar, succumbed to 95 per cent burns she sustained in the incident, late Monday night.

This was informed by Chief Minister Mohan Charan Majhi through a post on X.

Assuring the victim's family of justice, the CM said that stringent action will be taken against all those involved in the incident. "I have personally issued directions in this regard to the officials concerned. The government stands firm with the victim's family in

Based on the panel's report, the police Monday arrested the college principal Dillip Ghose, who was suspended earlier.

Khan interim protection from coercive action till July 14. He had filed a complaint against another social media influencer Sharmistha Panoli for allegedly making communal remarks in a video. Offensive comments should not be made in response to similar posts, his lawyer informed the court. "The citizens must know the value of the fundamental right of freedom of speech and expression. The State can step in case of violations... Nobody wants the State to step in (sic)," Justice Nagarathna said.

SC for rules on freedom of speech

The judge continued, "All this divisive tendency on social media has to be curbed.'

The bench clarified it did not mean censorship.

"There should be fraternity among citizens," the bench said as it considered framing guidelines on freedom of speech and expression for citizens.

The bench extended the interim protection from arrest to Khan till the next hearing.

Meanwhile, hearing the an ticipatory bail petition filed by cartoonist Hemant Malviya, accused of sharing alleged objectionable cartoons of PM Narendra Modi and RSS workers on social media, the SC said the right to freedom of speech and expression is being "abused". Malviya was booked by Lasudiya police in Indore in May this year on a complaint filed by lawyer and RSS worker MORE P8 Vinay Joshi.

Woman set afire by in-laws

Khalikote/Berhampur, July 14: A woman from Kanheipur under Khallikote police limits in Ganjam district sustained severe burns after she was allegedly set ablaze by her in-laws over dowry demands in the wee hours of Monday.

The victim, Arati Das, suffered over 25 per cent burns and is being treat

doctors said her condition remains critical. Her father lodged a complaint at Khallikote police station alleging that her in-laws had tried to kill his daughter

over dowry demands. Arati had married Akash Parida of the same village,

following a relationship, two years ago. The couple has a daughter. Akash works in Dubai. However, Arati had allegedly been subjected to frequent harassment by her in-laws for dowry.

Sources said a heated argument broke out between Arati and her mother-in-law Sunday night. On Monday morn ing, she was allegedly doused with petrol and

hospital. Police visited the medical facility and started an investigation at the incident site.

However, no arrests have been made yet, as the in-laws have fled the house when the police arrived in the village.

Next 72 hours crucial: AIIMS docs depression: Prez asks docs

Father of 'sexual harassment' victim appeals all to pray for her recovery

Bhubaneswar, July 14: The condition of the 20-year-old college student, who set herself on fire for allegedly being denied justice over 'sexual harassment' by a teacher, remained critical for the third consecutive day Monday, hospital sources here said.

Briefing reporters on the latest health condition of the college student, AIIMS Bhubaneswar Superintendent Dr Dillip Parida said: "The patient is certainly critical, but stable. We are saying stable because her health condition has remained the same as it was during her admission to the hospital Saturday evening. However, there is no improvement in the health condition. The next 72 hours are very crucial."

Dr Parida said that there has been little urination after doing dialysis on the patient Sunday night. She had a fever Sunday night. "Though it (urination) is a positive sign, but we can't say that she has improved. She is still in critical condition."

The student's father, a resident of Balasore district, said: 'I could not recognise my daughter after seeing her at AIIMS. I could not stay with her for even a minute. Her entire body is bandaged. Doctors told me that dialysis had been done last night. The doctors are doing their best. As much as 95 per cent of her body is burnt."

The father appealed to all people of Odisha and urged them to pray to Lord Jagannath for the recovery of his daughter as the doctors have already informed him that there were no signs of improvement since her admission at AIIMS Bhubaneswar Saturday evening.

The second-year Integrated BEd student of Fakir Mohan (Autonomous) College in Balasore Saturday afternoon set herself on fire after being denied justice over a sexual harassment complaint lodged by her against her teacher. The student with severe burn injury was first admitted at the Balasore District Headquarters Hospital (DHH) and then shifted to AIIMS Bhubaneswar for ad-

GUV SEEKS REPORT FROM GOVT

Bhubaneswar: Governor Hari Babu Kambhampati Monday sought a report from the state government on the circumstances under which a 20-year-old woman college student resorted to self-immolation and steps taken to address the situation. Kambhampati's action came a day after Leader of Opposition in state Assembly Naveen Patnaik sought the governor's intervention into the matter that led to a second-year Integrated BEd student attempting self-immolation on the campus of Fakir Mohan (Autonomous) College in Balasore Saturday. Kambhampati in a post on X said: "Spoke to Higher Education Minister Shri Suryabanshi Suraj (@suryabanshibjp) regarding the unfortunate incident involving the girl student of FM (Autonomous) College, Balasore, who is currently undergoing treatment at AIIMS Bhubaneswar. I sought details about the circumstances that led to the incident and the steps being taken to address

the situation." The governor also said in the social media post that Higher Education Minister Suryabanshi Suraj has assured him that the matter is being taken seriously and that necessary measures have been initiated to provide support and ensure accountability. "I also spoke to the Director of AIIMS Bhubaneswar to get an update on the student's health. A team of specialists from AIIMS Delhi is assisting in her treatment," the governor said. Kambhampati also said: "I pray to Lord Jagannath for her swift recovery and inner strength, and sincerely hope she regains her health soon. The safety, mental well-being, and dignity of students must be protected at all times. I have urged the authorities to act with urgency, empathy, and responsibility to prevent such incidents in the future.

Parties hit streets, demand justice



Bhubaneswar: As the 20-yearold college student fights for her life in AIIMS Bhubaneswar, political tensions in the state reached a boiling point, with Opposition parties staging demonstrations and holding press conferences.

Alleging that women are not safe in BJP-ruled Odisha, both the Opposition BJD and Congress held multiple demonstrations in Bhubaneswar and Balasore. Mahila Congress state president Meenakshi Bahinipati, along with party MLA Sofia Firdous, held a press conference in Delhi to highlight the issue of women's safety at the national level.

In Odisha, Congress Legislature Party leader Rama Chandra Kadam along with former Union minister Srikant Jena and others held a press conference here demanding a judicial inquiry into the circumstances leading to the second-year Integrated BED woman student allegedly being denied justice and subsequently attempting suicide by setting herself on fire. "We have been raising the issue of women safety since a long time. See what is happening in the state. Girls are not safe on campus," Kadam said. A fact-finding team of the Congress rushed to Balasore and met students and other

stakeholders and inquired about the situation. The BJD also staged a demonstration near Fakir Mohan (Autonomous) College in Balasore and burnt effigies of chief minister, higher education minister

and Balasore MP. The agitators also demanded strict action against all the culprits. Meanwhile, Union Education Minister Dharmendra Pradhan visited AIIMS Bhu-

baneswar and met the parents and family members of the victim.

"At Balasore Fakir Mohan Autonomous College, a student involved in an incident is undergoing treatment at Bhubaneswar AIIMS Hospital. I met her parents and discussed her health condition with AIIMS authorities. I pray to the Almighty that she recovers quickly and returns home," Pradhan said in a X post.

CONG INSTIGATED STUDENT: BJP

Addressing a press Conference here, Odisha BJP vice-president Biranchi Narayan Tripathy alleged that there are evidence in social media indicating that student Congress activists instigated the 20-year-old student to attempt suicide. "While the Congress indulged in dirty politics, the BJP government in Odisha is dedicated to empowerment and welfare of women," Tripathy asserted.

On the demand of Opposition parties, Pradhan said, "For us, priority is the girl's health. We are not doing politics over such an unfortunate incident. Let them (Opposition) do politics. I have confidence on the state government that stringent action will be taken in this matter. Chief Minister Mohan Charan Majhi has himself visited hospital and met the parents of the girl." Pradhan expressed concern over the degradation of 'Guri-Sishya' tradition in a state like Odisha. Meanwhile, Deputy Chief Minister Pravati Parida came down heavily on Opposition leaders and accused them of politicising the matter. Stating that the state government has taken prompt and strict action, Parida said CM has visited AIIMS Bhubaneswar to enquire about the health of the victim.

Heavy rain to pound 19 districts: IMD

Bhubaneswar, July 14: As the low-pressure area over the Bay of Bengal intensified into a well-marked system, the India Meteorological Department (IMD) Monday forecast heavy rainfall in 19 of the 30 districts of the state. The IMD cautioned fishermen not to venture into the sea for the next 24 hours in north Bay of Bengal as under the influence of the well-marked low-pressure squally wind speed of 40-50 kmph gusting to 60 kmph likely to prevail along and off north Odisha. In its morning bulletin, the IMD said: "The low-pressure area over north Bay of Bengal and adjoining coastal areas of Bangladesh, West Bengal and north Odisha moved north northwestwards and lay as a well-marked low-pressure ar-

Hospital sources said that the patient's potassium levels had dropped dangerously low, for which essential vitamins and micronutrients are being administered to her.

'We are also closely monitoring her blood sugar levels. Her internal organs have been severely impacted. We are offering round-the-clock and the best treatment facilities to her," the doctor said.

Chief Minister Mohan Charan Majhi Sunday, after visiting the student at the hospital, had said, "The condition of the student is critical. She is being provided the treatment akin to that available in AIIMS. Delhi. A medical team is formed for her treatment. The government will consider airlifting the patient after her condition stabilises.' Leader of Opposition Naveen Patnaik also said: "I fervently pray to Lord Jagannatha for her swift recovery from the grievous burn injuries.

Student Congress activists lighted 'dipa' (lamp) at Sri Ram temple here praying for recovery of the girl, several organisations in Balasore district poured water at different Shiv Temples on the occasion of first Monday of Shravan month, praying for the recovery of the college student.

The Opposi-tion party also urged President Droupadi Murmu to meet the victim during her visit to Odisha and ensure justice. "The student is an office-bearer of ABVP, the student affiliate of the BJP-RSS. The Head of the Department (HoD), Sameer Kumar Sahu, was continuously pressuring this BEd student for sexual favours. The HoD was

threatening her that if she did not comply with his demands for sexual favours, she would face consequences," Mahila Congress president Alka Lamba claimed while addressing a press conference with Cuttack-Barabati MLA Sofia Firdous. Lamba pointed out that Congress president Mallikarjun Kharge had sent a delegation of MPs to meet the victim's family. "Our MPs have met the victim's family and prepared a report, which will be released soon. We are making every effort to ensure that the victim gets justice, but when Congress workers went to meet the victim yesterday, the BJP government and ABVP did not allow us to meet her," she said. Firdous said the party demands that Chief Minister Majhi should resign, taking responsibility for it. A three-member committee set up by the Odisha government has already started its inquiry into the incident.



"The Congress spokesperson who criticised the Odisha government in this case in Delhi today, is probably not aware of the the party's dark history regarding atrocities against women." Parida said.

Suffering in silence: Harassment on campuses often unreported

Female students react to FM college

self-immolation tragedy

Bhubaneswar: July 14: The self-immolation bid by a second-year BEd student of Fakir Mohan (Autonomous) College in Balasore has triggered a storm of protests, grief, and rage across Odisha's student and parent communities.

The alleged cause: persistent harassment by an assistant professor, and the administration's reported inaction despite prior complaints.

Female students, OrissaPOST spoke to alleged that many instances of harassment on campuses go unnoticed and unreported due to fear of reputation damage and inaction by authorities. Sources confirm that the victim had informed the principal earlier about in-

appropriate behavior from the assistant professor, but no substantial action was taken.

The students expressed deep sorrow and fear, calling the incident both traumatic and symptomatic of systemic failure in ensuring women's safety in educational institutions.

Anandita Mishra, a student at BJB College, said, "Self-immolation is not a decision anyone takes lightly. It is the gravest, most tragic step - one that a student reaches only when she is drowning in despair, feeling that every door around her

is shut. The door of her home, her in stitu-

tion, her friends. her society — all closed. When the weight of soci-

etal shame chokes her spirit, and when no one stands beside her, she sees no way out but to end her life.

She said though women face harassment on campuses every day, most cases go unnoticed and unreported. "Why is so? Because victims fear being blamed, shamed, and silenced, she said.

Calling for urgent action. Anandita said, "We need instant action teams - groups that ensure immediate and visible consequences for those who harass or assault women. There must be justice that is swift, serious, and uncompromising, so that fear shifts from the victim

Citing an example of the regular occurrence of such incidents on campuses, she said even at her own college a girl was beaten up by her ex-boy

friend inside a closed classroom. "He still remains active on campus. This is not just unacceptable — it's horrifying. Institutions must stop protecting abusers and start protecting students," she added.

Subhalaxmi Jayasingh, a student at Rama Devi Women's University, said it is extremely upsetting and tragic for any student to witness or hear about a case of self-immolation, like the one at FM University. "Such an incident is not just a personal tragedy — it is a

harsh indictment of our educational institutions and their



said the incident reflects a breakdown of the very system that is meant to nurture and protect women. "This is not normal. This is not acceptable, she said. Subhalaxmi called upon the

government to take the matter seriously and act with transparency and urgency. "We need an objective investigation that brings the truth to light — not just for this one case, but to protect all women who suffer in silence," she added.

Another student, Arpita Meher, insisted that colleges must face direct accountability for such incidents and take stricter action against the culprits

Sharmistha Mallick, a former student, criticised the nor malisation of harassment and eve-teasing on campuses "Everyone knows it happens. But it's always taken lightly. That's what enables these predators, she said.

Law min vows stern action against 'kangaroo courts'

Bhubaneswar, July 14: Expressing concern over the backto-back incidents of tribal couples being tied to yoke and publicly humiliated by villagers for 'violating' customs, Law Minister Prithiviraj Harichandan Monday said stringent legal action would be taken against those operating such 'kangaroo courts'

Terming the acts as 'immoral', Harichandan said, "We will not encourage hateful practices and kangaroo courts. The state government has already initiated legal action.'

He attributed such incidents to lack of awareness among people, especially in remote areas. The Law minister added that some influential people in rural

regions are indulging in these harmful practices, which negatively impact society.

"None will be spared for taking the law into their hands. Strict action will be taken against the perpetrators to ensure such kangaroo courts do not occur in the future," he asserted.

Harichandan was referring to two recent cases - one in Kanjamajodi village under Kalvansinghpur block of Ravagada district, and the other in Peda Itiki village under Bargi Gram Panchayat in Narayanpatna block of Koraput district.

In both incidents, tribal couples, who had married within the same clan, were subjected to degrading treatment by local community members.

In the Rayagada incident,

a tribal couple – a 32-year-old man and his father's cousin sister – was tied to a voke and forced to plough farm land by villagers for being in a relationship and getting married secretly' against their families' wishes.

A group of villagers, including women and minors, were seen witnessing the cruel punishment.

Similarly, in the Koraput incident, another couple, a 21-year-old youth and his cousin, 20, was seen tied to a yoke and being paraded through the streets for marrying within the same clan, which villagers considered a violation of tribal customs.

Videos of both incidents went viral on social media, prompting the Law minister to intervene and direct officials to take swift legal action against those responsible for organising the kangaroo courts and humiliating the couples

Despite the public outrage, some villagers have defended the actions, claiming they were carried out as part of customary tribal purification rituals. Meanwhile, Rayagada police have detained several villagers

based on video evidence and were questioning them. In the Koraput case, the local administration has also launched an investigation into the incident.

Bhubaneswar, July 14: The Opposition, including the Congress and several Left parties, will stage a mass protest July 18 in front of Lok Seva Bhawan, demanding justice in the self-immolation case involving a student of Fakir Mohan College. Balasore.

A joint meeting in this regard held at Congress Bhawan Monday saw participation from Odisha Congress president Bhakta Charan Das and leaders from the Communist Party of India (CPI), Communist Party of India (Marxist) [CPI(M)], Communist Party of India (Marxist–Le ninist) Liberation [CPI(ML)], All India Students' Federation (AISF), Nationalist Congress Party (NCP), Samajwadi Party (SP), and Rashtriya Janata Dal (RJD). The leaders pledged statewide protests against rising atrocities on women and institutional negligence.

They demanded the resignation of the Higher Education Minister Suryabanshi Suraj, the local MLA and MP, and immediate arrest of the college principal and the accused faculty member. Citing a series of recent violent and unethical incidents across the state, they termed it a reflection of systemic administrative failure.

Monday, several Left parties and the Navnirman Krushak Sangathan staged separate protests demanding justice for the victim, who is currently battling for her life at AIIMS-Bhubaneswar. The CPI(M) and the Socialist Unity Centre of India (Communist) held demonstra



Govt seeks compliance report on IC formation

Bhubaneswar: The Higher Education (HE) department Monday asked all public and private universities and degree colleges to submit compliance reports within 24 hours, ensuring constitution of internal committees (ICs) in their institutions under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.

The HE department's directive follows a shocking incident at FM Autonomous College in Balasore, where a second-year integrated B.Ed student attempted self-immolation Saturday, allegedly in protest against sexual harassment by assistant professor Samir Kumar Sahu of the Educational Studies department.

According to reports, the student resorted to the extreme act after allegedly receiving no support from either the college authorities or the internal committee following her complaints.

Both the assistant professor and the college principal have since been suspended and arrested by the police.

In a letter addressed to the registrar of public and private universities and principal of government and aided colleges, the deputy director of the HE department emphasised that the department had previously communicated the necessity of constituting ICs in all higher educational institutions.

"The institutions have now been directed to submit compliance reports within 24 hours, ensuring adherence to Section 4 of the Act," the department said.

Colleges have also been instructed to display the names and contact details of all IC members in prominent locations on campus and to upload this information on the HIMS portal.

Registrars and principals have been asked to immediately organise workshops to sensitize students and staff regarding the 2013 Act.

Hungry Vamsadhara gobbles up land, farmers' livelihoods

Not only do its unforgiving waters eat up riparian farmlands, but a meandering Vamsadhara has also turned into farmers' sorrow by redrawing borders between them and their livelihoods

Paralakhemundi, July 14: Large swathes of agricultural land in Gajapati district's Kashinagar block are being steadily consumed by the Vamsadhara owing to change in course of the river.

Despite the presence of three mega irrigation projects along the river intended to facilitate water supply to farmlands, farmers in the region are facing increasing losses.

Hundreds of acres of cultivable land have been consumed by the river, severely affecting the livelihoods of many farming households. Locals recall the devastating floods of 1980, during which the river had changed its course engulfing significant portions of farmlands along its banks. That trend continues till date, with the river steadily eroding its banks and swallowing farmlands.

The erosion is acute across several riparian panchayats and villages. These include Palasing, Khandaba, Sara, Badigaon, Purutiguda in Khandaba panchayat, Kidigaon and Kash inagar town as well as Gouri, Bhanna, Kitingi, Bathaba, Budura, and Idudi in Budura

Every year, the river eats away farmlands in these villages due to change in its course. The annual monsoon rains and recurring floods further exacerbate the erosion as the river eats away as much as 30-40 feet into the bank.

As a result, hundreds of acres of land have already been lost and crop production has significantly declined. Farmers say their land now exists only on official records not in reality. Things have come to such a pass

that many cultivators are left without any land to grow crops. Residents of riverside villages say the river's altered course and powerful current are the primary reasons for the loss of

farmlands. They are also concerned about embankments reportedly being constructed along the Andhra Pradesh side of the river, which they allege is diverting water flow towards river banks in Odisha side, worsening erosion.

Many farmers of Abhilama mouza in the border region of Kashinagar block allege that parts of their farmland now lie on the Andhra side due to the river's shifting path. The combined effect of natural erosion and disputed interventions across the border has sparked concern among farmers, threatening both their land and their livelihood.

In 2003, farmers under the leadership of late Paralakhemundi MLA Trinath Sahu began cultivating mangoes, cashew, and other fruit-bearing trees on their rightful land across the Andhra border. However, over the years, frequent elephant intrusions turned the area into a hotspot for wildlife movement, making it increasingly difficult for farmers to cross the river and cultivate their fields on the other side of the state border.

Locals and intellectuals in the town claim the land has gradually fallen under the unofficial control of neighbouring

Andhra Pradesh due to the lack of consistent monitoring. Despite repeated appeals to the state government to relocate the affected farmers or provide

alternative farmland and a permanent solution, no substantial step has been taken so far. Residents have urged the district administration to intervene and take concrete steps to

support the distressed farmers.

Barbil, July 14: The body of a 41-year-old woman, identified as Nirmala Sharma, wife of Neel Prasad Sharma. an assistant manager working with Rungta Mines, was recovered Monday morning from the company's colony quarters in Barbil area of

Keonihar district. Police sources said the body bore multiple injury marks, prompting suspicion of foul

play. Nirmala's husband has been detained for questioning as police continue their investigation, treating the case as a

Nirmala's body was transported by ambulance from the company quarters to the Barbil Community Health Centre (CHC), where doctors declared her dead. However, the presence of several injuries on the body led to suspicion of a possible murder.

Following the discovery, police registered a case of unnatural death and began a detailed inquiry. The deceased woman's body was sent for post-mortem to ascertain the exact cause of

Nirmala and Neel Sharma have two children. Their daughter is currently pursuing higher studies in Bhubaneswar, while their son studies in Class X at a private school in Barbil. Police said the couple's

members arrived in Barbil following the incident and post-mortem procedures had commenced at the time of reporting. Authorities have stated that further investigation will continue based on the post-mortem report and other

evidence gathered. While the exact cause of any possible conflict between the couple remains unclear, police suspect that Nirmala's death could have been the result of a brutal assault.

Student alleges mental harassment by lecturer

Chhendipada, July 14: In a heart-wrenching scene from Bhaliasar village under Nuagaon panchayat of Chhendip ada block in Angul district, a pregnant woman in labour was carried across a swollen river on a makeshift sling by her fam ilv after an ambulance failed to reach the village due to the ab sence of a motorable road.

The woman, Mami Pradhan wife of Rajendra Pradhan, began experiencing severe labour pain Monday. Her family called an ambulance, but no vehicle could reach the remote village, as the swollen Aaunli river stood as a major barrier on the way to the nearest health facility.

Bereft of any other option, the family placed her on a makeshift sling and carried her on their shoulders across the overflowing river. From there, she was transported in a vehicle to the Bagadia Primary Health Centre (PHC), where she was admitted for delivery.

The incident has once again highlighted the lack of basic infrastructure and emergency medical access in remote rural areas of the state.

With the state experiencing low-pressure triggered heavy rainfall, many rivers in various parts of the state are in spate. This has cut off connectivity be tween the villages and disrupt ed normal life of the villagers

Surgery was performed July 13 at the private clinic. However, his condition worsened during the procedure. The hospital staff then suggested referring him to a Bhubaneswar facility. Family members were denied access to him during this time. While being transported in an ambulance, a paramedic accompanying Balaram declared him dead.

Balaram's brother Jagannath Gouda later lodged a complaint with MKCG authorities, accusing Dr Pradhan of gross medical negligence and financial misconduct. Based on the complaint, a police case (352/25) was registered at Baidyanathpur police station.

Dr Pradhan is reportedly absconding and unreachable, with his phone switched off, according to police sources

MKCG Dean and Principal Dr Suchitra Dash assured a thorough investigation and strict action against those found guilty. "We are taking the matter seriously and will act based on the findings," she said. Ganjam SP Saravana Vivek M confirmed he has been briefed on the case. "Detailed inquiries will be conducted and necessary action will follow," he added.

Trump Targets BRICS

'S President Donald Trump is opening new theatres of his global tariff war. This appears to be a strategy he is determined to adopt even as his trade war is forcing some of the US-friendly countries to join hands with those with which they do not see eye to eye on many issues.

Trump betrays his increasing impatience by making the BRICS group of emerging major economies a new target of his tariff war. He has threatened members of the group, which include China and India, with 10 per cent tariffs on goods exported to the US in addition to heightened tariffs already on the horizon for some of them. As leaders of the group met for an annual summit in Rio de Janeiro recently, Trump thundered threatening on social media "any country aligning themselves with the Anti-American policies of BRICS" will face those duties with "no exceptions." He then followed it up with the assertion that he intended to break up the group.

In a sense, the new development demonstrates how the US under Trump is concerned by the fact that BRICS is growing from strength to strength expanding its membership to include Egypt, Ethiopia, Indonesia, Iran and the United Arab Emirates, while more countries are waiting in the wings for entry. It also puts the international spotlight on the group, which roughly serves as the Global South's answer to the US-led G7 advanced economies. It is also true that the BRICS member states are too politically and ideologically disparate to be effective. That gives rise to the question why Trump is so concerned about it. The answer seems to be his worry that BRICS may pose a grave threat to the dominance of the dollar in the world economy and the accumulation of wealth in the USA. What he said during his cabinet meeting soon after the BRICS session points to this direction: "BRICS was set up to hurt us, degenerate our dollar and take it off as the standard."

In fact, the ambitious goal of a "BRICS currency" had first been suggested by Brazil's President Luiz Inácio Lula da Silva in 2023, but the idea was shelved as it appeared to be too complex and practically impossible. While most other nations supported Brazil's idea, it was India that opposed the push for a unified currency simply due to political considerations and not economic. However, BRICS countries are keen on expanding trade in their national currencies, rather than relying on the US dollar. The aim is to reduce the dollar dependence of a significant chunk of the global economy. BRICS members account for more than a third of global GDP based on purchasing power parity. Interestingly, in a joint declaration released during their Brazil summit, the group of BRICS leaders endorsed ongoing discussions of a "cross-border payments initiative" between member countries. If such a system is developed, analysts suggest, it could potentially become an alternative to the SWIFT inter-bank network, using BRICS countries' currencies or their digital equivalents.

Bypassing SWIFT and a dollar-denominated trade system has obvious benefits for certain BRICS countries, such as Russia and Iran, as it could allow them to wriggle out of heavy Western sanctions. Other countries also see a benefit in not relying on the US dollar for trade. For example, China has long been aiming to make its renminbi an international currency and counter what it calls the US' "financial hegemony.'

There are conflicting interests in the BRICS group that make united economic actions a very difficult task. But, what appeared to be too complex even a few months back, now becomes feasible for the simple reason that Trump is resolved to reset the global economic order dismantling the previous system. His belligerence in asserting America's economic power is ironically bringing together other countries in the Global South so that they can work against the might of the US and precisely negating his intentions.

INDIA MUST RESIST

ndia is in the midst of negotiations for a trade deal with the United States under an environment of unpredictability laced with unabashed and overt arm-twisting that has become the signature call of that nation under the leadership of President Donald Trump. These are understandably difficult negotiations, and a lot is at stake given that the US remains one of the most significant trade partners of India, reflected in the trade numbers but also in deep ties seen through the lens of the large and vibrant Indian community in the US and the number of Indians who still flock to the US for work, tourism or to study. The US has extended the deadline for a trade deal from 9 July to 1 August under the threat of punitive tariffs of 26% if an agreement is not reached by then. The extension signals hope and optimism that a deal is possible and workable, but it equally signals that the US side is pushing hard to see if India will bend under pressure. Another explanation is that the extension in itself is a case of 'TACO', or 'Trump Always Chickens Out', given that blanket tariffs on the rest of the world as envisaged by the US are not sustainable. But this is less likely with the dominant mood in Washington being to push hard, unmindful of the consequences, and India not being in a very strong position to dictate terms. Further, the US has extracted significant concessions from others, including the UK, and would demand that India, too,

fall in line. Of course, the people of India would expect the country not to bend to anything unreasonable, even though making such demands has become the currency of the US. In this context, it is good to delink the success or failure of a trade deal with the performance or the influ-

Having a trade deal by granting undue concessions to the US can be far worse since it may open Indian markets in ways and to products and services that will have deep and long-lasting impacts on the nation. The risks are many, but they will take their toll long after the deal is signed, so this is the space to be more watchful. The latter will create dis-

pushing for what India will see as undue concessions. In this context, two hot button items that appear to have emerged are the US push for exports of GM crops and exports of cow milk to India. None of these are new demands. Both are red lines

that cannot be crossed and should not be crossed. They cannot be part of discussions if the Indian side makes it clear that no negotiations on these are possible. For example, India requires that dairy products used as food must be from animals that are not given blood meals or given feeds containing internal organs or tissues of ruminant or porcine origin. This is a perfectly fair and reasonable requirement cows and buffaloes used for milk production are herbivores and must not be given any animal products as food. Further, milk in the Indian

context is culturally sensitive given that it is used for religious offerings and in sweets for auspicious occasions. Which Indian would like milk that comes from a source that is fed organs or blood? Yet, the US position as articulated in the US '2025 National Trade Estimate Report on Foreign Trade Barriers (FTB)' is that Indian requirements "lack a discernible animal health or human health justification.'

This is one small part of a larger problem, one that the US wants to dump its excess produce which itself is achieved through intensive methods and a growing chemicalisation of the industry. Such a sectoral opening up will kill the Indian dairy sector. It will mix up imported US milk that contains recombinant bovine growth hormone (rBGH), which is approved in the US since 1993 to increase milk production in cows but is banned in the European Union and Canada. Milk and meat from these sources have higher levels of IGF-1, a growth hormone which at high levels is said to be linked to prostrate, breast, colorectal and other cancers though the linkage is not definitive, according to the American Cancer Society.

On GM crops, the Alliance for Sustainable and Holistic Agriculture or ASHA-Kisan Swaraj network which brings together farmers and agriculturists has written to the government appealing against any concessions to the US.

The US wants much more than this. Take the example of stent prices, which were capped in India when the regulators found that price inflation was as high as 2000%. Everyone made merry while patients suffered, till the caps came in. The US in the 2025 FTB report has argued that "price controls (on coronary stents and knee implants) have not been increased in line with inflation and do not differentiate on the basis of the cost of production or technological innovation, which dissuades U.S. companies from serving the market.'

The drift is clear. The US wants to extract if not extort. India must resist.

Patna, July 14: Back-to-back killings targeting businessmen, politicians, lawyers, teachers and ordinary citizens have raised serious concerns about Bihar's law and order, with police blaming the surge on the widespread availability of illegal firearms and ammunition.

Over the past 10 days, a string of killings — including those of businessman Gopal Khemka, BJP leader Surendra Kumar, a 60-year-old woman, a shopkeeper, a lawyer, and a teacher — has rocked the pollbound state.

According to the latest State Crime Records Bureau (SCRB) data, the state recorded 1,376 murders with an average of 229 each month between January and June, compared to 2,786 in all of 2024 and 2,863 in 2023.

Bihar has consistently ranked among the top-five states in terms of violent crimes, including those involving firearms, according to National Crime Records Bureau (NCRB) figures. The state has held second position in violent crime rate in 2017, 2018, 2020 and 2022, NCRB data said.

Talking to PTI, DGP Vinay Kumar, said, "Land disputes and property matters are the main reasons behind most of the killings. In such cases, role of police is limited and it starts after the crime takes place. Our force has achieved 100 per cent detection rate"

Aizawl, July 14: First conceptualised in September 1999, the Bairabi-Sairang railway line has finally brought Mizoram's capital Aizawl on the country's railway map after overcoming unprecedented challenges in terms of alignment, short working seasons and frequent landslides.

Officials said the dream which Railways saw in 1999 turned into a reality when it was commissioned in June this year by the Commissioner of Railway Safety

The 51.38-km long railway line will soon be inaugurated by Prime Minister Narendra Modi.

In 1999, when engineers learnt that a preliminary survey was not possible due to thick forest, poor visibility, and other local issues, it was agreed to conduct a reconnaissance survey, which involved a rough route assessment, according to documents.

"Under a Preliminary Engineering cum-Traffic Survey (PET) a detailed examination of the route is done. As a PET survey was found not feasible. the Board was requested to change it to Reconnaissance survey, which the Railway Board agreed on July 15, 2003, a senior railway official said.

INDIAN NURSE ON DEATH ROW IN YEMEN

Nothing much govt can do: Centre to SC

New Delhi, July 14: The Centre Monday informed the Supreme Court that it was doing whatever was "utmost possible" to save an Indian nurse facing execution July 16 for murder in Yemen, but "nothing much" could be done keeping in view the status of Yemen.

"There is a point up to which the Government of India can go and we have reached that point," attorney general R Venkataramani informed a bench of Justices Vikram Nath and Sandeep Mehta. The top law officer said the government was keen to save its citizens and was doing "utmost possible" in the matter.

"Having regard to the sensitivity and status of Yemen as a place, there is nothing much the Government of India can do," he said. He further referred to the Houthis in Yemen, saying it was not even diplomatically recognised.

Venkataramani said the government recently wrote to the public prosecutor of the area concerned to find out if the execution could be suspended for the time being.

"The Government of India is trying its best," Venkataramani said, "and has also engaged with some sheikhs who are very influential people there."

Priva, a nurse from Palakkad district of Kerala, was convicted of murdering her Yemeni business partner in 2017. She was sentenced to death in 2020, and her final appeal was rejected in 2023. She is currently imprisoned in a jail in Sana'a, the capital of Yemen.



On Monday, the counsel appearing for petitioner organisation 'Save Nimisha Priya -International Action Council³ which extends legal support to assist Priya, said it was a "very unfortunate situation".

He said mother of Priya was there in Yemen along with a social worker to negotiate with the family of the deceased for blood money. Venkataramani said, "Blood money is a private

Govt urges display of oil, sugar content in snacks at workplaces

New Delhi, July 14: The Union health ministry has urged all ministries, departments and autonomous bodies to display 'oil and sugar board" mentioning the sugar and oil content in snacks such as samosa, kachori. pizza, french fries and vadapav to promote healthy lifestyles and combat obesity and non-communicable diseases

It has also called for printing health messages on all official stationeries such as letterheads, envelopes, notepads, folders, etc and publications to reinforce daily reminders on fighting obesity

In the letter written June 21, Union Health Secretary Punya Salila Srivastava said that India is witnessing a sharp rise in obesity among both adults and children. As per NFHS-5 (2019-21) more than one in five adults in urban areas are over weight or obese. Prevalence of childhood obesity is impacted by poor dietary habits and reduced physical activity. As per the Lancet GBD 2021 obesity forecasting study published in 2025, the number of overweight and obese adults in India is projected to rise from 18 crore in 2021 to 44.9 crore by 2050, making it the country with the second-highest global burden, she said.

Obesity significantly raises the risk of non-communicable diseases such as diabetes, hy pertension, heart disease, and certain cancers. It also affects mental health, mobility, and quality of life, and imposes a heavy economic burden through increased healthcare care costs and productivity losses



I-T Department cracks down on fraudulent claims of deductions

New Delhi, July 14: The Income Tax Department Monday conducted a "large-scale" verification operation across 150 locations in the country as part of a tax evasion probe against individuals and entities facilitating fraudulent claims of deductions and exemptions in Income Tax Returns (ITRs)

Official sources told PTI that the department undertook searches and surveys at multiple office and house locations in various states during the operation that came about after analysing financial data received from third-party sources, ground-level intelligence, and advanced artificial intelligence tools.

These findings were further substantiated by recent search and seizure operations conducted by the department in Maharashtra, Tamil Nadu, Delhi, Guiarat, Punjab, and Madhva Pradesh, where evidence of fraudulent claims was found to have been used by various groups and entities, the Central Board of Direct Taxes (CBDT) said in a statement.

"Investigations have uncovered organised rackets operated by certain ITR preparers and intermediaries, who have been filing returns claiming fictitious deductions and exemptions.

The analysis, the Board said, reveals "rampant misuse" of deductions available under sections 10(13A) (exemption under house rent allowance). 80GGC (contribution made to political parties), 80E (deduction for interest on education loan), 80D (deductions related to medical insurance), 80EE (deduction for interest on home loan), 80EEB

Т (deduction for electric vehicle)

80G and 80GGA (contributions made to charitable or research organisations), and 80DDB (deduction for treatment of critical illness like cancer, etc.).

"Exemptions have been claimed without valid justification. Employees of MNCs, PSUs government bodies, academic institutions, and entrepreneurs are among those implicated. the policy-making body for the I-T Department said.

It was found that taxpayers are often lured into these fraud ulent schemes with promises of "inflated" refunds in return for a commission, the CBDT said.

The Board said the tax de partment follows the guiding principle of 'Trust Taxpayers First', and it has always em phasized voluntary compliance and it has carried out ex tensive outreach efforts over the last few years by sending SMS and email advisories, nudging suspected taxpayers to revise their returns and pay

the correct tax. The CBDT said that despite a fully e-enabled tax adminis tration system, ineffective communication remained a "significant" hurdle in assisting taxpayers as it was observed that such ITR preparers often create temporary email IDs solely for filing bulk returns, which are later abandoned, resulting in official notices going unread.

SC junks plea against extension of ban on SIMI

Global vaccine reserves helped prevent over 3L deaths: Study

New Delhi, July 14: Global stockpiles of vaccines under programmes supported by 'Gavi, the Vaccine Alliance,' helped prevent more than 5.8 million cases and 3,27,000 deaths from outbreaks in low- and middle-income countries since 2000, according to a new study

The alliance, established

in 2000, funds the roll-out and scale-up of new vaccines through routine healthcare systems and preventive campaigns.

The findings, published in the British Medical Journal (BMJ) Global Health, highlight life-saving impacts and economic benefits of nearly \$32 billion due to outbreak response immunisation programmes aimed at containing vaccine-preventable disease outbreaks. "For diseases with routine vaccination programs, maintaining high levels of population immunity

is vital for preventing large outbreaks," lead author Dominic Delport, a PhD candidate at Burnet Institute, an Australian-based medical research institute and NGO said.

"But when outbreaks do occur, a rapid vaccine response



typically provides the greatest protective impact for the population at risk -- and the faster the response, the greater the impact," Delport said.

The researchers added that with routine vaccination declining and also impacted by cuts to the US' foreign aid, the study

highlights the ongoing need for an insurance policy against major outbreaks of diseases like cholera, Ebola and measles. The study analysed 210 outbreaks across 49 low- and middle-income countries that occurred between 2000-2023 for five diseases -- cholera, Ebola, measles,

meningitis and yellow fever. Globally, routine vaccine coverage has been shown to falter, with a recent study published in The Lancet journal attributing this to persistent inequalities, challenges due to the COVID-19 pandemic, and a growth of vaccine misinformation and hesitancy -- factors which increase the risk of vaccine-preventable outbreaks, it said.

Low- and middle-income countries have been studied to bear the major brunt of these outbreaks.

Senior author Nick Scott, associate professor and head of modelling and biostatistics, Burnet Institute, said the global decline in routine vaccine coverage highlights the value of vaccine stockpiles as insurance against major outbreaks.

The authors wrote, "Across 210 outbreaks, ORI (outbreak response immunisation) programmes are estimated to have averted 5.81 million cases 327,000 deaths.'

The team also looked at the impact of outbreak response immunisation programmes in helping control large outbreaks in low- and middle before they became overly disruptive.

Larger outbreaks are linked with worse health and econom ic outcomes. often requiring more disruptive public health measures that involve trave interruptions and school and business closures.

"We found here that the presence of the (outbreak response immunisation) consistently resulted in smaller outbreaks (eg, reducing the percentage of measles outbreaks with more than 100,000 cases from 41 per cent to eight per cent)," the authors wrote.

New Delhi, July 14: Astronaut Shubhanshu Shukla, the Axiom-4 mission pilot. has showcased a zero-gravity experiment aboard the International Space Station (ISS) involving water to illustrate how microgravity transforms everyday physics.

The experiment, part of Axiom Space's outreach and scientific mission, highlighted the unique behaviour of water in space.

After an 18-day stay at the ISS, Shukla and three others -- commander Peggy Whitson and mission specialists Slawosz Uznanski-Wisniewski of Poland and Tibor Kapu of Hungary -- of the commercial Axiom-4 mission set off on a return journey to Earth Monday evening.

Using surface tension to their advantage, Shukla formed a floating water bubble. "I've become a water bender here in the station," he joked. Another astronaut, Whitson, further went



on to press a plastic bag gently into the sphere, demonstrating how surface tension behaves like a magnet in microgravity by clinging to the object and

distorting light like a lens. The astronauts also spoke about the opportunity not just to engage in science but also to communicate the wonder and beauty of Earth from space. "I try to savour every moment I get -- just sitting by the window and looking down. It's the most beautiful view I've seen," Shukla said onboard the ISS.

Whitson explained that the crew is nearing the end of their two-week mission, during which they've balanced rigorous scientific research with education and public engagement.

Their mission has also included outreach to students and STEM communities around the globe, including in India, Hungary, and Poland.

Asked about re-entering Earth's gravity, Whitson was frank: "From me having experienced it, I know first person -- it sucks. Gravity really does."

Shukla, on his maiden spaceflight, said he hopes to handle the descent better than his ascent, which involved some space motion sickness.

In the final leg of his space sojourn, Shukla turned into a farmer, taking photos of 'moong' and 'methi' seeds sprouting in petri dishes and inserting them into a storage freezer on the International Space Station (ISS) as part of a study on how microgravity influences germination and early plant development.

"I am so proud that ISRO has been able to collaborate with national institutions all over the country and come up with some fantastic research which I am doing on the station for all the scientists and researchers. It is exciting and a joy to do this," Shukla said in an interaction with Axiom Space Chief Scientist Lucie Low June 9.

The sprouts experiment is led bv two scientists -- Ravikumar Hosamani of the University of Agricultural Sciences, Dharwad and Sudheer Siddapureddy of the Indian Institute of Technology, Dharwad

Once returned to Earth, the seeds will be cultivated over several generations to examine changes in their genetics, microbial ecosystems and nutritional profiles, a statement from Axiom Space said.

In another experiment, Shukla deployed and stowed microalgae, which are being investigated for their potential to produce food, oxygen and even biofuels. Their resilience and versatility make them ideal for supporting human life on long-duration missions.

Shukla also captured images for the crop seeds experiment, where six varieties will be grown over multiple generations post-mission. The goal is to identify plants with desirable traits for genetic analysis for sustainable farming in space. Shukla said his research tasks on the space station spanned various domains and disciplines.

Rockhampton, Australia, July 14: Australia's army fired a truck-mounted long range rocket system that has become a priority for US allies in the Indo-Pacific for the first time Monday, alongside US and Singapore forces firing the same system in joint war games.

Armoured trucks with HI-MARS - High Mobility Artillery Rocket Systems that can reach 400 km (250 miles) - are in high demand in the Ukraine conflict and are also being acquired by US allies in the Indo-Pacific, including Australia, which is reshaping its forces to respond to China's military build-up.

On the first day of Australia's largest war games, "Talisman Sabre", the US, Australia, Japan, France, South Korea and Singapore held a live-fire exercise in northern Queensland involving US F-35B fighter jets and land-based long-range strike rockets and missiles. Up to 40,000 troops from 19

nations are taking part in Talisman Sabre, across thousands of kilometres from Australia's Indian Ocean territory of Christmas Island to the Coral Sea on



Australia's east coast. Australian Army Brigadier Nick Wilson, director general of the combined live-fire exercise, said it was the first time Australia, Singapore and the United States had fired HIMARS together, and the first firing by Australia on home soil.

"HIMARS will be utilised

in conjunction with a number of other weapon platforms to ensure we have a strategy of denial for security, peace and stability in the Indo-Pacific," he told reporters Monday.

The joint exercise at Shoalwater Bay in north Queensland was watched by Australian Governor General Sam Mostyn

Trump gives 50-day ultimatum to Russia Avoiding trade curbs vital for normalisation of ties, India tells China REUTERS

Beijing/New Delhi, July 14: India and China must resolve friction along their border, pull back troops and avoid "restrictive trade measures" to normalise their relationship, India's foreign minister told his Chinese counterpart in Beijing

Monday. External Affairs Minister S Jaishankar met Wang Yi in Beijing during his first trip to the country since 2020, when a deadly border clash between their troops led to a four-year military standoff and damaged ties until a thaw began in October, when they agreed to step back.

"Good progress" made by the countries in the past nine months for normalisation of relations is a result of the resolution of friction along their border. Jaishankar told Wang

India and China share a 3,800 km (2,400 miles) border that is poorly demarcated and has been disputed since the 1950s They fought a brief but brutal border war in 1962 and talks over the decades to settle the

A Civil Aviation Authority official said they are investigating the unusual incident. "A passenger boarding the wrong flight by mistake can happen, but we have never come across a case where a domestic passen ger ended up on an international flight," the official said.

According to Shahzain, he was returning to Karachi from Lahore on the night of July 7 after learning that his child had fallen ill. He arrived at the air port on time and presented his pre-booked boarding pass, and was then directed to the lounge and the departure gate.

"There were two AirSial aeroplanes on the tarmac, one headed to Karachi and the oth er to Jeddah. The staff, without checking properly, put me on the international flight, and I only realised this when, even after two hours of flying time we did not land," Shahzain said.

While the passenger landed in Jeddah, his luggage reached Karachi. At the Jeddah airport. Shahzain was questioned by immigration officials for hours before they realised that he landed there for no fault of his and directed the airline to put him on their next flight to

Karachi. However, the ordeal didn't end there, as the airline flew the passenger back to Lahore, informing him he would need to arrange his ticket to Karachi.

The engineer claims the airline staff accepted their mistake in putting him on the international flight from Lahore to Jeddah when he was supposed to fly from Lahore to Karachi. However, he is still awaiting

a formal response and apology from the private airline.

Italy's abortion taboos challenged by new law in Sicily

Catania, Italy, July 14: Monia, a Sicilian woman in her early forties, was overjoyed when she discovered in October 2022 she was expecting her first child. Her doctor, however, recommended a genetic test due to her age, and the result was one no parent wants to receive. The foetus had a genetic syn-

drome. Monia, who declined to give her surname, asked her gynaecologist what she could do. "Nothing. You don't want to terminate, do you?" the doctor

asked her, she said. He was a conscientious ob-

jector, Monia said, one of hundreds on the southern Italian island. More than 80% of gynaecologists in Sicily refuse to perform abortions for moral or religious reasons, according to the latest health ministry data, which dates to 2022, even

though the procedure has been a legal right for women in Italy since 1978.

To address that situation, in late May Sicily's regional council - run by a centre-right coalition - passed a law in a secret ballot requiring all public hospitals to create dedicated abortion wards and to hire staff willing to provide the service.

Under the national rules, abortion is permitted within the first 90 days of a pregnancy, or later if there are risks to the mother's health or foetal abnormalities. The latter circumstance applied to Monia, who went to the Sant'Antonio Abate hospital in the city of Trapani, in western Sicily, to terminate her pregnancy.

"All the gynaecologists were objectors," she said. "An obstetrician gave me a bed with only a mattress cover and said they would administer a pill every

three hours until I went into labour." She was told she would receive no further assistance. Her story is far from unique

At first, Monia's pills were ineffective, but after five days and a change of treatment she finally miscarried, attended to by a doctor and a midwife.

Hospital staff referred to her as "Article 6," she said, after the provision in the law that allows abortions beyond 90 days.

Abortions are only available in around half of Sicily's hospitals, health ministry data shows, a figure much lower than in central and northern Italy, where rates are around 70%. CATHOLIC INFLUENCE

Most other European Union countries allow health workers to refuse to perform abortions on ethical grounds, according to a 2022 study published in the Acta Biomedica journal. But the right is generally exercised far less commonly than in southern Italy.

One exception is deeply Catholic Poland, where abortion is only legal in cases of rape or in cest or when a woman's health or life is at risk. The Acta study said many Polish women have been forced to travel abroad to terminate their pregnancies.

Abortion has always been contentious in Italy, a Catholic country that hosts the Vatican Right-wing Prime Minister Gi orgia Meloni passed legislation last year to try to deter women from terminating pregnancies.

Pro-life groups have been al lowed into abortion advice clinics, in a move Meloni's party said was aimed at giving women an opportunity for reflection before making a final decision. Some Sicilian politicians who strongly oppose the new rules believe the region should instead bolster its healthcare and support facilities for pregnant women, who often feel abandoned and see no alternative to abortion.

India. New Zealand trade negotiations

New Delhi: India and New Zealand Monday started the second round of negotiations for the proposed free trade agreement, aimed at boosting two-way commerce and investments, an official said. These talks will end on July 25. After a gap of about ten years, the two countries on March 16 this year announced the resumption of negotiations for the trade pact. "The second round of negotiations started on July 14 here," the official said. India and New Zealand began negotiating the Comprehensive Economic Cooperation Agreement (CECA) in April 2010. However, after ten rounds of discussions. the talks stalled in February 2015. According to economic think tank Global Trade Research Initiative (GTRI), a major challenge in the renewed talks will be the disparity in tariff structures. New Zealand's average import tariff is only 2.3 per cent, with over half of its tariff lines already duty-free, meaning Indian

goods already have substantial access to its market. In

Retail inflation eases to over 6-year low of 2.1%

Wholesale price inflation turns negative after a gap of 19 months, declining

New Delhi, July 14: Retail inflation declined to over sixyear low of 2.1 per cent in June, nearing the RBI's comfort zone, on account of subdued prices of food items. including vegetables, driven by widespread monsoon.

The Consumer Price Index-based inflation was 2.82 per cent in May and 5.08 per cent in June 2024. Inflation is on a decline since November 2024.

Year-on-year inflation rate based on CPI for the month of June 2025 over June 2024 is 2.1 per cent, the National Statistics Office (NSO) said in a statement.

"There is a decline of 72 basis points in headline inflation of June 2025 in comparison to May 2025. It is the lowest yearon-year inflation after January 2019." it said

The previous low of 1.97 per cent was recorded in January 2019. The NSO said the significant decline in headline inflation and food inflation in June 2025 is mainly attributed to favourable base effect and decline in inflation of vegetables, pulses and products, meat and fish, cereals and products, sugar and confectionery, milk and

products and spices. The Reserve Bank, which has been tasked to ensure inflation remains at 4 per cent (with a margin of 2 per cent on either side), has cumulatively reduced the key short-term lending rate by 100 basis points since February in the wake of slowing

retail inflation. Meanwhile, the wholesale price inflation (WPI) turned negative after a gap of 19



months, declining 0.13 per cent in June as deflation widened in food articles and fuel, along with softening in manufactured

product costs. WPI-based inflation was 0.39 per cent in May. It was 3.43 per cent in June last year

"Negative rate of inflation in June, 2025 is primarily due to decrease in prices of food articles, mineral oils, manufacture of basic metals, crude petroleum & natural gas etc,' the industry ministry said in a

statement. As per WPI data, food articles saw a deflation of 3.75 per cent in June, as against a deflation of 1.56 per cent in May, with vegetables seeing a sharp drop. According to the NSO data

on CPI, the annual inflation in the food basket during June 2025 over June 2024 was (-) 1.06 per cent.

A sharp decline of 205 basis points is observed in food inflation in June 2025 in comparison to May 2025. The food inflation in June was also the lowest af-

ter January 2019. The inflation rural was lower than the national average at 1.72 per cent while it was higher in urban areas at 2.56 per cent. The lowest inflation was in Telangana (-0.93 per cent) and

the highest in Kerala (6.71 per cent). On all India basis, the annual inflation was negative in vegetables (-19 per cent), 'meat

and fish' (-1.62 per cent), 'pulses and products' (-11.76 per cent), and spices (-3.03 per cent).

Commenting on the CPI data, Aditi Nayar, Chief Economist, ICRA, said the cooling was entirely led by the food and beverages (F&B) segment, which witnessed a deflation of 0.2 per cent after a gap of 75 months, after printing at 1.5 per cent in the previous month.

The CPI inflation eased for the eighth consecutive month to a softer-than-expected 2.1 per cent in June 2025 from 2.8 per cent in May 2025, touching the lowest level since January 2019. We are not ruling out the possibility of a final 25 bps rate cut in the August 2025 meeting, carrving forward the front-loading seen in June 2025." Navar said.

Paras Jasrai, Associate Director at India Ratings and Research, said that notwithstanding the deflationary turn of food items, core inflation increased to 4.4 per cent in June 2025, the highest since September 2023.

"A closer look indicates that it was largely on account of an uptick in inflation of jewellery items. Inflation of gold increased to a 58-month high of 36 per cent (as geopolitical tensions flared up in the Middle-East), the inflation of silver and other ornaments was also at elevated levels of 17.8 per cent and 21.5 per cent, respectively, in June 2025," Jasrai said.

Jane Street deposits ₹4,843cr in escrow account

New Delhi, July 14: US-based hedge fund Jane Street, which allegedly made handsome gains through market manipulation. has deposited the mandated Rs 4,843.57 crore in an escrow account in favour of Sebi and requested it to lift certain restrictions.

The watchdog is examining the request, Sebi said in a state ment Monday.

In an interim order July 3, the regulator found Jane Street (JS) guilty of manipulating indices by taking bets in cash and futures & options markets simultaneously for making massive gains.

Sebi barred the hedge fund from accessing the market and impounded over Rs 4 843 crore in gains. The probe found that JS made a profit of Rs 36,671 crore on a net basis during the probe period from January 2023-May 2025.

In compliance with the interim order, a sum of Rs 4.843.57 crore has been credited to an escrow account with a lien marked in favour of Sebi, the regulator said.

"Jane Street has further requested Sebi that, following the creation of this escrow account in compliance with Sebi directions, certain conditional restrictions imposed under the interim order be lifted and that Sebi issue appropriate directions in this regard," the statement noted.

"This request is currently under examination by Sebi in accordance with the directions of the interim order." it added.

The regulator said it remains committed to following due pro cess and ensuring the integrity of the securities market.

India's vegetable oil imports flat in June

.

New Delhi: India's vegetable oil imports remained flat at 15.49 lakh tonnes in June compared to the same month last year, even as shipments of crude edible oils surged more than 25 per cent, industry body Solvent Extractors Association (SEA) said Monday. The rise in crude oil shipments came after the government reduced the Basic Customs Duty (BCD) on crude edible oils, including crude palm oil, crude soybean oil, and crude sunflower oil, to 10 per cent from 20 per cent, effective May 31. Total vegetable oils, comprising both edible and non-edible oils, stood at 15.50 lakh tonnes in June 2024. In the edible oil category, barring crude sunflower oils, imports of other crude edible oil variants rose 25.64 per cent to 11.51 lakh tonnes in June from 9.16 lakh tonnes a year earlier. However, crude sunflower oil shipments declined 53.58 per cent to 2.61 lakh tonnes in June from the year-ago period. According to SEA data, crude palm oil (CPO) imports rose 23.55 per cent to 7.88 lakh tonnes in June from 6.37 lakh tonnes a year earlier, while crude soybean oil imports increased 30.39 per cent to 3.59 lakh tonnes from 2.75 lakh tonnes. Crude Palm Kernel Oil (CPKO) imports rose 33.33 per cent to 4,000 tonnes in June from 3,000 tonnes in the year-ago period. Total imports of crude edible oils (CPO, CPKO, crude sunflower and crude soybean oils) stood at 11.51 lakh tonnes in June.

New Delhi, July 14: India has achieved 50 per cent non-fossil fuel-based power generation capacity of 242.8 GW out of the total 484.8 GW installed capacity, five years ahead of its 2030 target, Union New & Renewable Energy Minister Pralhad Joshi said Monday.

This assumes significance in view of India's commitment at international fora to increased non-fossil fuel-based power generation in the country.

India has set an ambitious target of having 500 GW of renewable energy-based electricity generation by 2030. 'Under the visionary lead-

Indian exports to US to be more competitive: NITI Aayog

New Delhi, July 14: Indian exports to the US will become more competitive following imposition of higher tariffs by the Trump administration on countries, including China, Canada, and Mexico, NITI Aayog said in a report Monday.

The Aayog in its third edition of 'Trade Watch Quarterly' said there will be significant opportunities for India in the US markets both in terms of the number of products and volume of the US market.

"India is expected to gain competitiveness in 22 out of the top 30 categories (HS 2 level), representing a market size of USD 2,285.2 billion," the Aayog said

It further explained that China, Canada, and Mexico are the leading exporters to the US in these categories, therefore

higher tariffs on these countries at 30 per cent, 35 per cent, and 25 per cent, respectively, will enhance India's competitiveness

The thematic focus of this quarter's edition is the evolving US trade and tariff structures and their implications for India's export competitiveness.

"India's relative tariff advantage vis-a-vis major competitors presents a strategic window to expand market share in the US market, especially in sectors such as pharmaceuticals, textiles, and electrical machinery, among others," the Aayog said, adding that the evolving global trade environment demands ag-

ile policymaking to capitalise on new trade alignments. The government think tank said India's competitiveness will remain unchanged in 6 out of 30 categories, amounting for 32.8 per cent exports to the US



and 26 per cent of the US total imports, amounting to USD 26.5 billion.

While for six product categories at HS 2 level, India faces a higher average tariff (between 1-3 per cent) which can be negotiated with the US, the Aayog said. "In 78 products, accounting for 52 per cent of India's exports and 26 per cent share

in total US imports, India is expected to gain competitiveness.

For 17 products (accounting for 28 per cent of India's export to the US) out of the top 100 products at the HS-4 level, the Aayog said India's competitiveness remains unchanged due to no change in tariff differential. The Aayog also pointed out that "India stands to gain in sectors with high tariff gaps vs China. Canada and Mexico -- minerals and fuels, apparel, electronics, plastics, furniture, and seafoods in a USD 1,265-billion market."

To support MSMEs and boost export competitiveness, it said the government could consider expanding production-linked incentive (PLI) schemes to include labour-intensive sectors such as leather, footwear, furniture, and handicrafts.

The Aayog also called for rationalising electricity tariffs by reducing cross-subsidisation for industrial users and promoting renewable energy adoption could help lower operational costs and enhance the global competitiveness of Indian manufacturers.

It suggested that building on the model of the India-?UK agreement, India should pur-

sue a services-oriented trade deal with the US, placing strong emphasis on key sectors such as information technology, fi nancial services, professional services, and education.

"The agreement should include robust provisions for dig ital trade, creating a framework for enhanced cross-border service delivery," the Aayog said.

Meanwhile, an Indian commerce ministry team has reached Washington for another round of talks on the proposed bilateral trade agreement (BTA), which will begin Monday.

The visit assumes significance as both sides have to iron out issues in sectors like agriculture and automobiles It is also important as the US has further postponed the imposition of additional tariffs on several countries, including India, until August 1.

India, who batted brilliantly in the first two Tests, could not stand the test of Archer and Co. on a spicy day five pitch.

The outcome was a foregone conclusion when Chris Woakes had Nitish Reddy caught behind at the stroke of lunch to leave India tottering.

However, Jadeja's steely effort created a glimmer of hope for India.

Starting the day at 58 for four and needing another 135 runs on a rapidly deteriorating surface with variable bounce, India needed their experienced batters to fire for their fourth success at the iconic ground since 1932 but it was not to be.

The loss of Rishabh Pant (9 off 12 balls), KL Rahul (39 off 58) and Washington Sundar (0 off 4) inside the first hour made the chase an improbable task for India.

Archer, making a Test comeback after more than four years, flaunted his X-factor status once again as he produced a beauty to send back a half-fit Pant back into the dressing room. There is an eight-day gap before the start of the fourth Test in Manchester from July 23.
