## **US** designates LeT proxy TRF as terror outfit

Washington/New Delhi, July 18: The US has designated The Resistance Front (TRF), a proxy of the Pakistan-based terror outfit Lashkar-e-Taiba (LeT), as a 'foreign terrorist organisation' over the Pahalgam terror attack, a move welcomed by India as a 'timely and important' step reflecting strong counter-terror cooperation between the two countries.

US Secretary of State Marco Rubio, announcing the punitive measure, said it was part of Washington's commitment to countering terrorism and enforcing President Trump's call for justice for the Pahalgam attack.

The TRF, an LeT 'front and proxy.' claimed responsibility for the Pahalgam attack which killed 26 civilians, he said, adding it was "the deadliest attack on civilians in India since the 2008 Mumbai attack conducted by the LeT.' **PAGE 10** 

### **EU** slaps sanctions on **Rosneft's India refinery**

New Delhi, July 18: The European Union Friday imposed sanctions on the Indian oil refinery of Russian energy giant Rosneft and lowered the oil price cap, as part of a new raft of measures against Russia over its war in Ukraine. The fresh sanctions package on Russia included new banking restrictions, and curbs on fuels made from Russian crude oil.

The lowered oil price cap - currently set at USD 60 per barrel means Russia will be forced to sell its crude at reduced rates to buyers like India As the second-largest purchaser of Russian oil, India stands to benefit from this move.

"For the first time, we're designating a flag registry and the biggest Rosneft refinery in India," EU foreign policy chief Kaja Kallas said in a post on X.

# No spi courts, all bail: SC Women safe till 5:30pm RAVENSHAW UNIVERSITY FLIP-FLOP

At a time when Indian courts are buckling under an unprecedented weight with the total number of pending cases across high courts and subordinate courts surging past the five crore-mark by the end of 2024, the Supreme Court has come down heavily on the Centre for its failure to set up special courts for NIA and other statutes. The top court observed that no effective measures have been taken by the government to conduct expeditious trials in matters being investigated under special laws such as UAPA. The apex court

licitor General (ASG) Rajkumar Bhaskar Thakre, appearing for the Centre and Maharashtra government, designating the existing courts as special courts amounted to "coercing" the high court to relabel them. 'We are satisfied that no

effective or visible steps have been taken to set up special courts for speedy trial in cases under NIA Act and other special statutes. It goes without saving that setting up of special courts would require creation of posts for superior judicial officers, staff, courtroom and basic amenities," the bench said. The bench said contrary to

its orders, an impression was created that designation of existing court as special court under the NIA Act would be sufficient compliance of the directives.

"We are outrightly rejecting this plea taken by the respondents (Centre and the Maharashtra government)," the bench said, proposing if the high court chief justice had agreed to it, the court would call for an explanation.

The bench said designating courts as special courts or entrusting exclusive trial under the NIA Act and other special statutes to the existing courts would be at the cost of undertrials and prisoners of old age, marginalised sections of society, languishing in jails.

The top court passed the order on the bail plea of Kailash Ramchandani, a Naxal sym-

'Last opportunity is granted to the Centre and the state government to take decision as per the observations made by the court," the bench said and posted the matter after four weeks.

Thakre earlier submitted that a special court was designated in Mumbai for NIA cases with the high court's approval. The statement irked the bench, which questioned the ASG about cases the judge was already hearing when the court

was designated as special NIA court.

"Why should it be done at the cost of other litigants? If you are bringing new statutes, you need to create adequate infrastructure and sanction posts in superior judicial services," the bench said.

The top court asked not for "commitment" but "action from the government.

## Man carries daughter's body in trolley for post-mortem

Balasore, July 18: A daily wage earner was forced to carry his daughter's body in a trolley rickshaw to the hospital for post-mortem due to lack of financial resources and official support.

Madhu Bindhani, a resident of Bindhani Sahi in Deula panchayat under Baliapal police station limits, transported his daughter's body in a trolley for nearly 6 km from his house to the Community Health Centre (CHC) for autopsy

According to Bindhani, his daughter had a history of psychiatric issues. Her body was found hanging from a tree in the village. Upon being informed, the local police arrived at the scene



and, after a preliminary inquiry, instructed Bindhani to take the body to the CHC for post-mortem. As he could not afford the cost of an ambulance, Bindhani said he had no choice but to use a trolley to carry his daughter's body.

The incident sparked widespread outrage among locals, who alleged that the police failed in their duty by not arranging proper transportation.

In a letter to all registrars and heads of all universities, government colleges, aided colleges and private colleges under the Higher Education department, the government directed that all must treat it as 'extremely urgent'.

#### **Congress to observe 'Shraddhanjali Divas'**

Bhubaneswar, July 18: The opposition Congress Friday announced that it will observe 'Shraddhanjali Divas' across the state July 24, marking the deceased FM College girl student's Ekadasah (11th day postdeath ritual).

Odisha Pradesh Congress Committee (OPCC) President Bhakta Charan Das made the announcement following meeting with party's public affairs committee here. Addressing a joint press meet along with leaders of seven other political parties. Das said that July 24, marking the 11th day since the victim's death, will be observed as 'Shraddhanjali Divas' across the state to pay tribute to the voung student and other women who have lost their lives due to atrocities and systemic failures

"Our women leaders will lead the observance. We appeal to all educational institutions, including colleges and universities, to observe a two-minute silence in memory of the victims and in demand for justice," Das said.

'We also request all mothers and sisters across Odisha to observe a one-minute silent praver at home on that day." he added. Reiterating the party's demands, Das called for the formation of a Women's Commission, a high-level judicial probe, and the resignation of the CM over the incident.

The party also decided to continue its stir till the government announced a court-monitored judicial probe into the incident, in which the woman student resorted to self-immolation and subsequently died after being denied justice in an alleged sexual harassment case.

The party has decided to hold demonstrations before three revenue divisional commissioner (RDC) offices in Cut tack, Sambalpur and Berhampur July 21 to exert pressure on the government to announce a judicial probe into the incident." BJD's senior vice-president Debi Prasad Mishra told reporters.

Covering their mouths with black badges and holding placards, BJD's women, student and

GI cancers rising among middle-aged adults

New Delhi, July 18: Gastrointestinal (GI) cancers are rising at alarming rates worldwide in adults younger than 50 years, according to two studies.

The first study, published in JAMA, showed that the surging cancer cases go beyond colorectal, and include gastric, oesophageal, and pancreatic.

"Colorectal cancer is the most common early-onset GI cancer worldwide, accounting for more than half of the cases. but it is not the only GI cancer that is rising in younger adults.

Unfortunately, pancreatic, gastric, and oesophageal cancers are also increasing in young people," said Dr Kimmie Ng. from Dana-Farber Cancer Institute in the US.

'The rising incidence of early-onset GI cancers is alarming and underscores the need for enhanced prevention strategies and early detection methods,' Ng added. The second study, published in the British Journal of Surgery, showed that the number of newly diagnosed cases of early-onset GI cancers rose by 14.8 per cent between 2010 and 2019.



The study showed that the count of early-onset GI cases is highest in the oldest group -- people aged 40 to 49 -- but the rise in rates is progressively

steeper in younger groups.

People born in 1990 are twice as likely to develop colon cancer and four times as likely to develop rectal cancer compared

**Common risk factors** associated with earlyonset gastrointestinal cancers include modifiable lifestyle factors and alcohol consumption

to those born in 1950, revealed the findings, also led by Ng.

The common risk factors associated with early-onset GI cancers include modifiable lifestyle factors such as obesity, poor diet, sedentary lifestyle, smoking, and alcohol consumption.

The study also emphasise the importance of genetic testing for all patients with early-onset GI cancers to assess familial risk of cancer and to guide treatment, and to increase early screening. 'Screening adherence is absolutely critical. Each missed

screening is a lost opportunity to detect cancer early when it is more treatable, or to prevent cancer altogether by identifying and removing precancerous polyps," said Dr Thejus Jayakrishnan, from Dana-Farber.

New Delhi, July 18: The Supreme Court has issued a stern warning to all states and Union Territories (UTs), including Odisha, over continued non-compliance with its directives regarding appointment of special teachers for Divyang (differently-abled) students in schools. The apex court has mandated that all states and UTs file compliance affidavits within three weeks, failing which top education officials will have to personally appear before the bench August 29, 2025, and explain why contempt proceedings should not be initiated against them.

In a hearing concerning a series of petitions on the education rights of Divyang students, the apex court expressed concern over the laxity shown by several state governments. The court reiterated its earlier order dated March 7, 2025. directing states and UTs to advertise recruitment for special teachers in two leading newspapers and on the respective Education department's website by March 28, 2025

Additionally, the apex court ordered the formation of a three-member screening committee, comprising State Disability Commissioner, Education Secretary, and an Indian

## Man gets life in prison for killing partner

Bhubaneswar, July 18: A court in Keonjhar Friday awarded life imprisonment to a man after holding him guilty of killing his transgender partner in the district in 2021.

Keonjhar Sessions Judge GC Behera also slapped a penalty of Rs 10,000 on the convict, identified as Sadasib Samal alias Tiku, 34, of Tentulipala village under Daitari police limits in Keonjhar, Public Prosecutor (PP) Pradip Kumar Das said.

According to the case details Sadasib 'married' Sandhyara ni Kinnar of Jajpur district in 2015. They used to stay in another village under Daitari police limits and worked as labourers.

"The duo picked up a quarrel over a trivial issue October 19, 2021. Soon, a mountain was made out of a molehill and Sadasib thrashed Sandhvarani with an iron rod. Sandhyarani suffered severe head injuries and succumbed to the injuries," the PP said. Later, police arrested Sadasib and the trial began. The court convicted Sadasib after examining statements of at least eight witnesses and other exhibits.

Bhubaneswar, July 18: A day after the arrest of an assistant professor for "sexual exploitation" of a female student Gangadhar Meher (GM) University in Sambalpur, the varsity authorities Friday issued an advisory to all its faculty members, asking them to treat the students as their brothers and sisters.

An assistant professor of the university was arrested Thursday for allegedly sexually exploiting a 20-year-old student of the varsity, police said. Following his arrest, the university suspended the assis tant professor.

Susant Kumar Das, in-charge Vice Chancellor (VC) of GM University, said he has advised all teachers to treat the students as their brothers and sisters. The

HoDs and faculty members have been asked to counsel the students at individual-level and directly report to him in case of any kind of harassment of any student. Das said. "The teachers have been asked to maintain professional, ethical and moral values at the highest level," he said.

The students of the university staged a protest inside the varsity campus in Sambalpur during the day and also submitted a memorandum to the VC demanding a proper inquiry to identify other faculty members who might have engaged in such unethical practice, a protesting student said.

Later in the evening, the VC convened a meeting of the internal complaint committee (ICC) of the university and issued necessary instructions to the members of the panel.

A dog's 'personality' guides its TV viewing habit: Study

New Delhi, July 18: Dogs may have 'personalities' which guide their television viewing habits – an anxious dog might respond more to cars or a doorbell sound, while an excitable one is more likely to follow on-screen objects, a study has found.

Researchers from Auburn University, US, also found that pet dogs may perceive two-dimensional objects on the TV screen in a manner similar to those in the three-dimensional environment.

The results, published in the journal Scientific Reports, help understand a pet dog's internal, perceptual experience and may inform interventions taken towards their welfare.

"In practice, engagement with television could provide dogs with an enriching, meaningful experience," the authors wrote.

About 650 dog owners responded to surveys after observing their dogs' TV viewing habits. Aspects such as whether an owner taught their dog to watch TV or not, hours in a week spent watching TV and average time a dog paid attention while watch-

Dogs' reactions to objects on-screen - animals, non-animals and how much they were followed - were assessed. Age range of the 453 dogs finally included in the analysis was two months to 16 years old.

Dogs were found to be more likely to react to animals on-

screen than to other stimuli, with about 45 per cent of the dogs (206) always responding to dog noises such as barking and howling.

The authors wrote, "Dogs who were more excitable were more likely to exhibit behaviours suggesting an expectation that the television stimulus exists in the 3D environment (i.e., follow behaviours).3

"Furthermore, dogs who displayed more fearful tendencies were more likely to respond to the non-animal stimuli (e.g., car, doorbell)," they wrote.

The researchers said that differences in dogs' temperament could inform owners' training methods in rectifying problem behaviours towards content on television.

# **Chromium levels in** Sukinda groundwater 14x above safe limit

Jajpur, July 18: Toxic levels of chromium have been found in groundwater of Sukinda mining area under Jajpur district, with concentrations up to 14 times higher than the permissible limit, a Central Ground Water Board (CGWB) report has confirmed. The investigation was conducted as per the orders of National Green Tribunal (NGT).

The CGWB collected 233 groundwater samples across the region. Of these, 37 and 28 samples taken before and after the monsoon, respectively, showed chromium levels much above the safe limit of 0.05 milligrams per litre. The highest concentration, 0.7313 mg/L, was found in a sample from Chingudipal.

The report validates complaints filed with the NGT, alleging that residents are suffering from kidney ailments and fatalities due to long-term exposure to contaminated water. The tribunal has now directed the Jaipur Collector to prepare and submit an action plan.

Despite nearly Rs 230 crore being spent on three piped water supply projects in Sukinda, many residents remain without access to clean and safe drinking water, prompting calls for permanent solutions.

Earlier, the State Environmental Impact Assessment Authority (SEIAA) had alerted the Odisha State Pollution Control Board (SPCB) about the

#### **Drunken man bites** cobra; hospitalised

BOLANGIR: In a bizarre incident that has become the talk of the town, a man allegedly bit and chewed on a live cobra under the influence of alcohol, leading to his hospitalisation in a critical condition at Bhima Bhoi Medical College episode took place Thursday in Tentulikhunti village under Tushura police limits. The man, identified as Debarchana Bhoi, was reportedly drunk when he bit the live snake. The findings were submitted in June following a directive in NGT case 73/2024/EZ A four-member team led by CGWB Regional Director BK Sahu, including scientists Mausumi Sahu, Bibhuti Bhusan Sahu and Sinos PK, conducted the study. Both hexavalent and triva-

lent chromium were detected in the groundwater samples. The report recommended supplying clean drinking water to every household, testing water from new bore wells before use, and installing and monitoring effluent treatment plants.

It also highlighted that mining companies have been drawing clean water from the Brahmani River and releasing toxic effluents into the Damsala stream, causing widespread contamination of rivers, ponds and groundwater.

The report identified elevated chromium levels in Damsala Nala and noted a rise in kidnev diseases in nearby areas. Villages affected include Kamarda, Masasahi, Hatisahi, Saruabil, Gurujang, Ostapal, Kuchidabanka, Kusumghut, Kalarangi and Ramsol in Sukinda block, and Krushnapur, Odisa, Barua, Mathakhokasa and Balijhati in Bhuban block of Dhenkanal district - affecting around 50,000 people.

Locals have demanded immediate action based on the CGWB report to address the crisis.

## 6 students hospitalised after vaccination; inquiry ordered

Daringbadi, July 18: Six students of a government-run primary school in Kandhamal district had to be hospitalised Friday as they took ill two days after getting vaccinated during a routine immunisation drive. The incident has triggered an official inquiry and sparked concern among parents.

The students-three boys and three girls-attend Patangi Government Primary School under Kirikuti panchayat in Daringbadi block. According to school sources, the children received DPT and TT vaccines Wednesday as part of a government health initiative.

While classes were under way Friday afternoon, the students reportedly developed symptoms including chest pain. headache, body ache, fever, and chills. However, they were not immediately attended to by the school authorities.

Instead, a local Anganwadi worker, Latika Pradhan, and



the children's guardians ar ranged an auto-rickshaw and admitted them to Simanbadi Hospital. The children were treated by Dr. Abinash Mallick and are reportedly in stable condition.

The lack of timely response from school officials drew sharp criticism from the students' families and the local community. Kandhamal District Education Officer Rajesh Swain has ordered a probe into the incident.

A team led by Additional Block Education Officer (ABEO) Gokulananda Nayak, along with officials Banamal Majhi and Cluster Resource Centre Coordinator (CRCC) Rakesh Kumar Sahu, visited

the school to investigate. They questioned Headmistress Sunama Pradhan regarding the chain of events and her response.

During the inquiry, the headmistress stated that she had delegated vaccination monitoring duties to two teachers-one of whom was present at the school while the other was on leave However, investigators found that the leave application had not been officially approved or signed by her, raising questions about administrative oversight

Health officials have said the cause of the students' illnesswhether related to the vaccines or any other factor-will be confirmed only after a detailed investigation.

where was a time when "superannuation" meant something. Now it's just the date you pencil in until the next extension arrives. Union Home Secretary Govind Mohan is the latest to join the Great Indian Extension Club. He was due to retire in September 2025. Not anymore. He's now staying on until August 2026. Or later.

It's all very smooth and above board. The Appointments Committee of the Cabinet signs off, the paperwork proceeds, and another top officer avoids the retirement ritual. Extensions have now become more routine than retirements. The Cabinet Secretary lives on an annual renewal plan. Ravi Sinha of RAW, sadly, wasn't so lucky. Parag Jain in RAW made it in time, thankfully.

Similarly, across states, it's become a proud tradition. In West Bengal, Chief Secretaries rarely retire. They just acquire more titles. Others? Not so fortunate.

This brings us to an uncomfortable question. What about all the highly capable officers waiting their turn? It's hard not to feel for them-the ones who played by the book, ticked all the boxes, and still didn't make it. Maybe they were too junior by a month. Or too distant from Delhi. Or just unlucky.

Meanwhile, the extended family of babus marches on. Retirement is for the lesser mortals.

#### Soft power of coaching

It was only a matter of time before the parallel universe of IAS coaching centres collided messily with the real world of judicial process. Dr Vi-

kas Divyakirti, the founder of Drishti IAS, has trained thousands to clear the world's most grueling civil services exam. Now he finds himself learning the hard way about due process. From the other side of the table.

An Ajmer court has taken cognizance of a defamation complaint against him for remarks allegedly disparaging the judiciary in a video. It is a classroom-style monologue comparing judges and babus. Perhaps his tone was flippant, but it proved to be a tripwire for legal action.

Most know Drishti as a civil services production factory. Its founder isn't merely a teacher; he's a philosopher-king for lakhs of hopefuls. Coaching gurus like him are unofficial institution-builders. They shape attitudes, internalize hierarchies, and, as this case shows, occasionally overstep

Divyakirti may not hold a post, but his cultural capital runs deep. His words carry further than some government circulars. And when vou're indirectly influencing the next generation of district collectors, it pays to measure your metaphors.

So, while the court decides the legal merits, the larger takeaway is clear: in the bureaucratic food chain, even the feeders must mind their diet. What's said in jest in a classroom can echo dangerously in a courtroom. When perception is policy, that's a lesson worth filing away.

#### One ticket, one spouse, no exceptions

There are few things in life more complex than Indian family trees, except, perhaps, government rules trying to keep up with them. Enter the Department of Personnel & Training (DoPT), which has just updated its Leave Travel Concession (LTC) guidelines with the kind of bureaucratic poetry only sarkari memos can deliver, a fresh July 4 circular clarifying who counts as "family" for LTC purposes. And tucked away in the officialese is a gem: "not more than one wife."

You read that right. While listing those excluded from LTC benefits-parents-in-law, grandchildren of estranged daughters, and even grandparents—the circular slips in a little marital limit. Lest we leap to conclusions, this isn't some bold new policy. It's a reiteration, a clarification, a tightening of screws in response to RTIs and complaints about who's eligible to tag along on sarkari-sponsored vacations. But the phrasing is classic bureaucracy-meets-blunt-truth.

It also inadvertently opens a window into the complex web of personal laws, family arrangements, and the Centre's cautious dance around them. India allows for plural marriage under certain religious laws. but the state? The state prefers its travel parties nuclear, thank you very much. Humour aside, this is part of a larger challenge: our rules often lag behind the reality of modern relationships. Live-in partners, single parents, blended families-none of them sit neatly inside Rule 4 of the CCS (LTC) Rules, 1988.

# **SAILING TARIFF TROUBLES**

he present geopo litical situation has generated a lot of discussion and has, no doubt, been a cause for serious concern among Indian industry, not to speak of exporters. **US** President Donald Trump recently said he will announce a 50 per cent tariff on imported copper, an effort to boost US production of a metal critical to electric vehicles, military hardware, power grid and many consumer goods.



and partly by consumers but more than that the sector may be gravely hit.

In 2024-25, India exported \$4.56 billion worth of iron, steel, and aluminium products to the US, with key categories, including \$587.5 million in iron and steel, \$3.1 billion in articles of iron or steel and \$860 million in aluminium and related articles. "These exports are now exposed to sharply higher US tariffs, threatening the profitability of Indian producers and exporters,"says founder of Global Trade Research Initiative (GTRI) Ajay Srivastava.

Meanwhile, Indian exports soared to a record \$825 billion in 2024-25, growing over 6 percent and sustaining around

5.8 percent Compound Annual Growth Rate (CAGR) over the past decade. This indeed is a commendable performance, and optimists believe the country may be able to maintain 5 to 6 per cent growth in goods, especially non-petroleum exports while services may grow even faster at 9 to 10 percent.

It is significant to mention that with the UAE service exports have almost doubled in the 4-5 years while with Australia, it has almost tripled. Experts believe that investments are coming to India in a big way and there are collaborations for technology as well. In the space sector, India's dominance is well known while in the maritime front. the country is recognised as a ship-building destination.

Meanwhile, Union Commerce Minister Piyush Goyal pointed out that there are plans to invest Rs 20 lakh crore in the next ten years and auto parts and sanitary ware are witnessing large investments as there is confidence in the competence of Indian companies. Undeniably, in such a situ-

ation where the geopolitical environment is far from conducive, India is moving ahead quite steadily. Some optimists pointed out that even if the US levies a 26 to 28 percent tariff on exports of Indian goods to the US, it will "not matter to India" and pointed out that the global view on the Indian market does not change even if the trade deal is rational and

not unjustified. The question that comes up here is obviously to diversify exports and set up manufacturing centres in foreign countries. It is understood that there are plans to set up pharmaceutical companies in some African countries which indeed is welcome. Another important aspect is to diversify the basket of goods that India exports. The country's technology is improving with each passing year and centres for imparting various advanced skills should be started. Experts believe with government support it would not be difficult to identify new products as also increase exports to existing markets.

Importantly, labour-inten-

exports, increasing technology adoption have positioned India as the third-largest manufacturer of sports goods in Asia. The government is quite industry-friendly and big business houses are getting all that they demand. It is also good to hear that the commerce minister is determined to increase exports in a big way with requisite technology and expertise. However, it needs to be pointed out that in areas such as critical minerals and magnets, where India is very much dependent on China. exploration work should be intensified. Finally, the key question

# Merger and privatisation of banks

ndia's banking underwent a major change on 19th Ju-L ly 1969 when the government nationalised 14 private banks, followed by six more in 1980. The Banking sector became priority sectors like

the year 1993. Again during 2001, Bank of Madurai was merged with ICICI Bank and followed by problem-ridden privately owned Global Trust Bank (GTB) merged with the public sector Oriental Bank

it the third-largest bank in the country. The merger of Syndicate Bank with Canara Bank created the fourth largest public sector bank. The merger of Andhra Bank and Corporation Bank with Union

has also expressed that the banking sector will continue to be recognized as a strategic sector on the issue of privatisation.

IDBI Bank, originally the Industrial Development Bank of India, which was established in 1964, later transformed into a commercial bank in 2004. Subsequently in 2019, LIC acquired 51% controlling stake, making it a subsidiary of LIC. Indian government and LIC are now planning to divest a 60.72% stake by September 2025 to categorise it as a private sector bank. PSBs after nationalization have historically played a crucial role in providing banking services to remote and backward communities. If PSBs are privatised, there is a risk that as private banks they may focus more on profitable urban areas, neglecting rural and underserved regions. Privatisation of banks in India is a tightrope walk, striking the right balance between efficiency, social responsibility and financial stability, which is essential.

The establishment of private banks in India gained momentum after economic liberalization in the 1990s. India embarked on its journey towards economic reforms of 1991 known as the 'New Economic Policy' or the LPG (Liberalisation, Privatisation, Globalisation) policy. During 1993, the Reserve Bank of India (RBI) issued guidelines for licensing new private sector banks, leading to the establishment of 10 new banks. These banks are Global Trust Bank, ICICI Bank, HDFC Bank, Axis Bank, Bank of Puniab. IndusInd Bank, Centurion Bank, IDBI Bank, Times Bank and Development Credit Bank. However, due to precarious state of liquidity, New Bank of India was taken over by Punjab National Bank (PNB) in

of Commerce (OBC) during 2004. The government issued a directive in June 2016 asking SBI to merge the Associate Banks. SBI merged all the seven subsidiaries with itself and Bharatiya Mahila Bank was also merged with State Bank of India by April 2017.

During 2019, PSB mergers took place, when Dena Bank and Vijava Bank were merged with Bank of Baroda, was effective from April 1 (2019). In another round of boosters for the economy, the then Finance Minister on 30th August (2019), announced amalgamation of 10 public sector banks into 4 big banks.

After the merger, State Bank of India continued to be the largest Bank in the country. Punjab National Bank. **Oriental Bank of Commerce** and United Bank of India joined together to form the second-largest state-run bank in the country. The merger of Dena Bank and Vijava Bank with Bank of Baroda, made

Bank of India created India's fifth largest PSB and Indian Bank became 7th largest after merger with Allahabad Bank.

The following six PSU banks - Bank of India (6th largest PSB), Central Bank of India, Indian Overseas Bank, UCO Bank, Bank of Maharashtra and Punjab and Sind Bank remained independent and continued to operate as before. The total number of public sector banks in the country has come down from

18 to 12. There have been no indications or announcements about further mergers of the remaining six banks. Alternatively, the talk of privatisation of public sector banks has been gaining momentum in the policy circles. The names of four banks-Central Bank of India, Bank of India, Bank of Maharashtra and Indian Overseas Bank, are going rounds as potential candidates that could be privatized. The Government

The northeastern state suffered losses to the tune of Rs 66.51 crore due to ASF outbreak till July 16 in 2025, the data showed. In 2024, the total losses amounted to around Rs 336.4 crore, Rs 334.14 crore in 2021 and Rs 210 crore in 2022.

The outbreak, which is now considered endemic, has affected 10,468 families since 2021, it said. A total of 51,301 pigs have been culled during the period.

## Lianpui menhirs declared 'monument of national importance'

This is the second megalith site in Mizoram to receive national recognition after 'Kawtchhuah Ropui' or Great Entranceway in Vangchhia village, which hosts over 170 engraved menhirs and is located about 20 km south of Lianpui village

Aizawl, July 18: Ancient carved memorial stones, also known as menhirs, found at a village in east Mizoram's Champhai district, have been officially declared a 'monument of national importance' by the Archaeological Survey of India (ASI), officials said Friday.

Lianpui village near the Myanmar border is home to the memorial stones, locally known as Lungphun Ropui. The village is situated 54 km southeast of Champhai town near the India-Myanmar border, and it is famous for its rich repository of ancient artefacts.

The formal notification declaring the Lianpui menhirs as a monument of national importance was issued by the Ministry of Culture July 14, following years of research and inspection, they said.

These antiquarian artefacts include 114 intricately carved



memorial stones, anthropic holes, petroglyphs, Y-shaped wooden posts and ancient pathways.

The upright memorial stones at Lianpui bear detailed carvings of human figures, birds, animals, mithun heads, gongs, lizards, and other cultural mointo eight alignments, with four oriented north-south and the other four east-west. they said. Lianpui village was named after Lusei chief Lianpuia, who reportedly established the vil-

lage in the 18th century CE. Mizoram's lone Rajya Sabha member K Vanlalvena, had informed the Parliament in March that the ASI, after a thorough inspection by experts, had found Lianpui village to possess significant archaeological heritage worthy of national importance.

According to officials, the process of declaring the site of national importance began in February 2021 with the publication of a preliminary notification in the Gazette of India. marking the commencement of a statutory procedure required under the Ancient Monuments and Archaeological Sites and Remains Act, 1958, for declaring protected monuments.

On July 7 this year, ASI Director (Monuments) AMV

Subramanyam visited Lianpui village and confirmed that final ste ps were underway to declare the megalith site of national importance.

With no objections filed, the Centre finalised the notification declaring Lungphun Ropui a monument of national importance and brought the site under national protection.

Meanwhile, residents of Lianpui village expressed happiness and thanked the Art and Culture minister C Lalsawivunga and K Vanlalvena for their efforts towards receiving the ASI's tag.

Art and culture department director Carol VLMS Dawngkimi also expressed happiness due to the national recognition and dedicated the achievement to the hard work of many individuals, particularly former convener of the Indian National Trust for Art and Cultural Heritagem (INTACH) Mizoram chapter P Rohmingthanga.

## **Mizoram Oil Tanker Drivers'** Association to halt service due to 'poor' road situation

Aizawl, July 18: Mizoram Oil Tanker Drivers' Association (MOTDA) said it will cease operations from Saturday due to the dilapidated condition of the national highway linking the state with Assam.

A statement issued by MOTDA on Friday said that the Sairang-Kawnpui stretch of the national highway is so "badly damaged that it is no longer safe for oil tankers to ply on it".

"The MOTDA decides not to ply on the national highway starting from July 19 till it is repaired for trucks to travel. We apologise to the public for any inconvenience that will be caused by the strike," the statement said.

NH-306 is the primary lifeline of Mizoram, as all supplies come through this national highway from outside the state It connects Mizoram's capital Aizawl with Silchar town. A portion of the national highway is called NH-6.

The Sairang-Kawnpui sector of NH-6, which was worst affected by the monsoon, was recently taken over by the National Highways and Infrastructure Development Corporation Limited (NHIDCL) from the state government.

NHIDCL executive director (P) Virender Kumar Jakhar told PTI that the repairing work of the stretch began July 10 and is ongoing.

He said that the repair work could not be expedited due to heavy traffic and rain.

# Govt: All parties on board to impeach Justice Varma

New Delhi, July 18: All political parties are on board on the move to impeach Justice Yashwant Varma, from whose residence here burnt wads of currency notes were found, the government said Friday, pav ing the way for a motion on this matter during the upcoming Monsoon session of Parliament. A fire incident at Justice Varma's Delhi residence in March

this year, when he was a judge of the Delhi High Court, had led to the discovery of sacks of halfburnt cash in the outhouse. Justice Varma was

subsequently repatriated to the Allahabad High Court but no judicial work was assigned to him. An in-house probe ordered by then Chief Justice of India Sanjiv Khanna has indicted the judge.

Whie Parliamentary Affairs Minister Kiren Rijiju said he was coordinating with leaders of different parties on the motion to ensure that a unified stand of the Parliament comes out, the Congress, the principal opposition party, has said all its MPs will support the motion against Justice Varma. Rijiju also said there should not be any politics over the impeachment move. The Monsoon session of Parliament is scheduled

to start from July 21. "I have spoken to all the senior leaders of different political parties. I will also get in touch with some of the single-MP parties because I do not want to leave out any member. So it becomes a unified stand of the Parliament of India," Rijiju told PTI Videos in an exclusive interview.

## SC refuses to stay trial court proceedings against Lalu Yadav

New Delhi, July 18: The Supreme Court Friday refused to stay the trial court proceedings against former Bihar chief minister and RJD supremo Lalu Prasad Yadav in the CBI's land-for-jobs case.

A bench of Justices M M Sundresh and N Kotiswar Singh asked the Delhi High Court to expedite hearing on his plea for quashing of the CBI FIR.

The top court also granted exemption from appearance to Yadav before trial court in the case noting his health condition.

"The appeal being against interim order we are not inclined to interfere except by observing that at the time of disposing the final matter the observation made in the impugned order will not stand in the way.

fact "Considering the and circumstances of the case, we are inclined to pass further order to the effect that he may not be personally present and therefore his appearance is dispensed with. We request the High Court to expedite the hearing," the bench said.

Senior advocate Kapil Sibal, appearing for the RJD supremo, sought a stay on proceedings saying there was no prior approval obtained by the CBI under Section 17A of the Pre vention of Corruption Act.

Additional Solicitor General S V Raju, appearing for the CBL countered it saying sanction was not required in the present case

Sibal sought the stay pointing out no prior approval with the CBI under Section 17A of the Prevention of Corruption Act (prior sanction before initiating investigation against public servant). On May 29, the Delhi High Court said there were no compelling reason to stay the proceedings.

## Curbs after clash: Maha Assembly bans visitors

Mumbai, July 18: A day after supporters of two MLAs clashed in the Maharashtra Vidhan Bhavan premises, assembly speaker Rahul Narwekar Friday said visitors will not be allowed in the legislature complex during the session, and only ministers, legislators, their personal secretaries and officials will get entry

Making this announcement in the Lower House of the state legislature, he also said that an ethics committee, empowered to disgualify members, will be formed within a week.

The incident occurred at 5.45 pm on the ground floor of the legislature building here, Narwekar said, adding that he has sought a report from the chief security officer of Vidhan Bhavan.

"Visitors will not be allowed inside the Vidhan Bhavan during the session. Only ministers, legislators, their officially-designated personal secretaries and government officials will be allowed during that period," he said.

Ministers will not be allowed to hold official meetings and meet visitors in the legislature complex during the session. They will have to conduct their official briefings and meetings in Mantralaya, the state secretariat, he said.

MLAs will be held accountable for the conduct of persons accompanying them, Narwekar added. Both Padalkar and Awhad expressed regret in the House over the scuffle between their supporters.

Speaker Narwekar said Nitin Deshmukh and Sarjerao (Rishikesh) Takle, associates of Awhad and Padalkar, respectively, who were involved in the scuffle and detained by the security personnel of the state legislature, will face breach of privilege of the House.

Deshmukh said he was a sup-

porter of Awhad, while Takle said he was a cousin of MLA his phone.

New Delhi, July 18: The declared incomes of registered unrecognised political parties witnessed a 223 per cent spike in 2022-23 and more than 73 per cent of these parties failed to publicly disclose their financial records, according to poll rights body the Association for Democratic Reforms (ADR) Its report analysed the status

of submission of annual reports of a total of 739 (26.74 per cent) registered unrecognised parties across 22 states in India, whose either audit or contribution

reports were available on the websites of respective state CEOs for the 2022-23 financial vear.

The maximum number of registered unrecognised parwhose statements are ties, available are in Uttar Pradesh, followed by Delhi and Bihar, given that these states have the highest number of registered unrecognised political parties.

States with zero reporting included Punjab (73 registered unrecognised parties), Uttarakhand (40) and Goa (12) are among the top three states where both audit and contri-



butions reports of none of the registered unrecognised parties are available on the official websites

Among the 739 registered unrecognised parties analysed in this report, both audit and contribution reports are available for 501 parties across 20 states. This is a mere 18.13 per cent of the total number of registered unrecognised parties

The top compliant states are

compared to the national average in terms of the availability of both reports of registered unrecognised parties in the public domain. Out of the top 10, five parties (50 per cent) are from Gujarat, indicating a concentration of unrecognized parties with high declared incomes in this state.

Gujarat parties collectively reported Rs 1158.115 crore in total income - over 70 per cent of the top 10 parties' income. The highest income was declared by Bharatiya National Janta Dal, Rs 576.458 crore. Donations above Rs 20,000 account for a large share of total donations - e.g. New India United Party shows 100 per cent of donations as large donations (Rs 407.45 crore).

Many of the top earners were formed after 2015, reflecting a trend of newer parties rapidly mobilizing funds. These include Satyawadi Rakshak Party (2022), Jan Man Party (2021) Jan Sewak Kranti Party (2021) and New India United Party (2018) the ADR said.

Bharatiya National Janata Dal declared the highest total income of Rs 957.4454 crore (31.76 per cent of total) between the FY 2019-20 to 2023-24. The party witnessed a major jump in FY 2021-22 and FY 2022-23 the report said.

Satyawadi Rakshak Party declared the second highest income of Rs 416.2337 crore with sharp growth in FY 2022 23 (Rs 85.6779) and a massive Rs 330.5558 crore in FY 2023-24.

Guiarat-based parties alone account for 73.22 per cent (Rs 1158.1154 crore) of the top 10 parties' declared income of Rs 1581.7517 crore. Some parties report no or very less income in earlier years, but then suddenly report large sums in one or two fiscal years.



Gujarat (30.53 per cent), Delhi (21.67 per cent) and Bihar (18.48 per cent) demonstrate relatively higher levels of compliance

# **INDIA bloc to hold** online meet today

New Delhi, July 18: INDIA bloc parties will hold an online meeting Saturday to reach a consensus on issues that they would raise to corner the government during Parliament's Monsoon Session and convey a message of unity, but AAP has distanced itself from the Opposition grouping.

The TMC, which was earlier said to be skipping the INDIA bloc meeting, however, said its national general secretary Abhishek Banerjee will attend the online meeting.

The meeting comes right before the Monsoon Session of Parliament, which starts Monday.

It will be held after a long gap since the INDIA bloc parties jointly deliberated the country's political situation.

Raipur, July 18: The Enforcement Directorate Friday arrested Chaitanya Baghel son of senior Congress leader and former Chhattisgarh chief minister Bhupesh Baghel, in an alleged liquor scamlinked money laundering case, official sources said.

According to Bhupesh Baghel, the action came on Chaitanya's birthday. The junior Ba ghel was later sent to five-day ED remand by a court. Chait anva was taken into custody by the ED under the Prevention of Money Laundering Act (PMLA) following fresh early morning raids conducted at his residence in Bhilai town of Durg district. The father-son duo reside at the same house.

Bhupesh Baghel alleged that central agencies were being misused to target Opposition leaders, but he trusted the judiciary and would cooperate with them. Congress MLAs boycotted the proceedings of the state Assembly for the day as a mark of protest against the arrest and accused the agency of trying to harass the Opposition.

A heavy posse of police personnel was seen outside the house of the Baghels, even as some party supporters gathered and protested the ED action. ED sources said Chaitanva was arrested under Section 19 of the anti-money laundering law as he was allegedly not cooperating during the searches that came about following receipt of fresh evidence in the case.

The alleged liquor scam in the central Indian state, according to the ED, was orchestrated between 2019 and 2022 when Chhattisgarh was governed by the Bhupesh Baghel-led Congress government. Assets worth about ₹205 crore of various accused have been attached by the ED as part of this investigation so far, ac cording to the agency.

#### PRESS TRUST OF INDIA 50 Schools in B'lore receive bomb threat New Delhi, July 18: More than

45 schools and three colleges in Delhi received bomb threats via emails Friday, triggering panic among the students and their parents. The threats, however, later turned out to be hoaxes. This was the fourth day this

week that schools and colleges in the national capital were targets of bomb threats. Although the threats turned out to be hoaxes, many panic-gripped parents chose not to send their children to school Friday.

"I did not send my son (to school) today. It is not that we are panicking, but after repeated incidents, it feels safer to wait things out," said Parmita Sharma, a parent whose child studies at Richmond School. Paschim Vihar. Many parents had to rush to schools, leaving their work mid-way, after receiving communication about the threat.

"Even if there is nothing, we cannot ignore the fear these messages cause. Parents can't focus on work, and the children feel tense too. It is an emotional rollercoaster." a father of a student of St Thomas Schools in Dwarka said. Police, along with bomb disposal and dog squads, and the fire department, rushed to the schools and colleges as these institutions started

receiving threats via email. The premises were evacuated and thoroughly searched, following which the threats were declared as hoaxes as nothing suspicious was found, an official said. Indraprastha (IP) College for Women, Hindu College and Shri Ram College of Commerce (SRCC) in North Delhi received bomb threats. Schools in multiple districts of Delhi also received bomb threats.

Ritam Mondal (21), a student of mechanical engineering, was found hanging in his room at Rajendra Prasad (RP) Hall hostel building, an institute official told PTI. The student, who hailed from Kolkata, had retired to his room after dinner Thursday night, and there was no abnormality in his behaviour, one of his hostel mates said. The IIT KGP official said that, as repeated knocks on his door did not evoke any response, in the morning, police at the outpost on the campus, accompanied by institute security quards, broke open the door and found him hanging. An FIR has been lodged by the institute, and all cooperation is being extended to the investigators.

#### SC nixes PIL against appointment of BPSC chairperson

New Delhi: The Supreme Court on Friday rejected a PIL challenging the appointment of Bihar Public Service Commission chairperson Parmar Ravi Manubhai after observing that an FIR against him was closed. The top court, however, was critical of PIL and asked the petitioner not to file such bereft of facts petitions. "If you are filing a PIL then you have to give your life to it. Please do not go behind this publicity business, it will ruin you... you should have read the facts properly," a bench comprising Justices P S Narasimha and Atul S Chandurkar said. After it was informed about an FIR against Manubhai, the bench asked, "What happened to the FIR?" "It was closed," the lawyer said. The bench, after hearing the counsel for the state government and the BPSC chairperson, held the PL ought to be rejected. The bench initially imposed a cost of ₹10,000 on petitioner Brajesh Singh. Paris: France, Britain and Germany told Iran Thursday that they would restore UN sanctions unless it reopened talks on its nuclear programme immediately and produced concrete results by the end of August. The foreign ministers of the so-called

E3, along with the European Union's foreign policy chief, held their first call with Iranian Foreign Minister Abbas Araqchi since Israel and the US attacked Iranian nuclear facilities a month ago.

Brussels, July 18: The European Union Friday agreed an 18th package of sanctions against Russia over its war in Ukraine, including measures aimed at dealing further blows to the Russian oil and energy industry

The EU will set a moving price cap on Russian crude at 15% below its average market price, EU diplomats said, aiming to improve on a largely ineffective \$60 cap that the Group of Seven major economies have tried to impose since December 2022.

"The EU just approved one of its strongest sanctions packages against Russia to date," EU foreign policy chief Kaja Kallas said on X.

"We will keep raising the



costs, so stopping the aggression becomes the only path forward for Moscow.

The Bangladesh Army in a statement, said it used force in self-defence during Wednesday's clashes in Go palganj after coming under attack from "a group of unruly people.'

The Inter-Services Public Relations (ISPR) statement said a group of people carried out "organised acts of violence" in Gopalganj Sadar centring on a public rally called as part of a political party's month-long programme.

"As the situation quickly es calated, both the Bangladesh Army and local police intervened and were able to bring the situation under control, the ISPR said.

The clashes in parts of Sweida province continued into Friday, according to residents of Sweida

# ChatGPT will soon shop online, make presentations

A growing number of tech companies, including **OpenAI** backer Microsoft Corp. and rival Anthropic, are focusing on agents, or AI software that can complete multistep tasks for users with minimal supervision

San Francisco, July 18: OpenAI is rolling out new options for chatbot ChatGPT to carry out a variety of increasingly complicated tasks on a user's behalf, part of its push to bring so-called AI agents to the mainstream, Bloomberg reported.

The ChatGPT agent is designed to streamline personal and professional projects, such

as planning a meal and ordering ingredients for it online, or creating a slideshow for a business meeting. The tool works through OpenAI's flagship chatbot and combines the capabilities of two AI services it rolled out earlier this year: Operator, which can browse, type and click on the internet much in the way a human would; and Deep Research, which is meant to handle time-consuming online research.

> The San Francisco-based company said the agent features will be available immediately to its paid Pro, Plus and Team subscribers, with plans to release it later this summer to other enterprise and education customers. Some of the details of the software were previously reported by the Information.

OpenAI Chief Executive Officer Sam Altman previously said agents will be "the next giant breakthrough" for AI. The hope is that such tools can save users time and thereby live up to the long-held promise that AI will make people more productive. For now, however, the software can still be frustrating and slow.

In a demonstration of the ChatGPT agent this week, Neel Ajjarapu, OpenAI's product manager for the software, gave the chatbot a detailed prompt: Browse Etsy for vintage-style lamps that are under a couple hundred dollars and available with free shipping, then put the best-looking items in his online shopping cart and provide a URL for each one.

OpenAI has also experimented with using the tool to make presentations and PowerPoints, Ajjarapu said, though he cautioned it's more for making "very early rough drafts" of presentations people can then refine. Microsoft, the company that makes PowerPoint, also offers AI tools to help professionals draft presentations.

Ajjarapu said the AI model that powers the tool uses a computer and web browser to complete assignments. It can also take in feedback from the user while a task is underway and alter its approach, he said. While users are accustomed to chatting in nearly real time with ChatGPT, it can take much longer - several minutes at least - for the chatbot to complete agent-like tasks.

AI agents present new safety and security risks, given the potential for AI to make mistakes or be misused by bad actors. The company said ChatGPT agent is meant to turn down some tasks, includ ing those related to finances or legal advice. There are also a number of actions the tool will seek permission for before car rying out, including making purchases, the company said For some tasks, such as write ing emails, the service will require a user to supervise it.

# **SEBI to review MF** categorisation norms

Markets regulator SEBIproposed to review the categorisation of mutual fund schemes in a bid to improve clarity and address the issue of overlap in portfolios of schemes

New Delhi, July 18: Markets regulator Security Exchange Board of India (SEBI) Friday proposed to review the categorisation of mutual fund schemes in a bid to improve clarity and address the issue of overlap in portfolios of schemes.

The proposal came after SE-BI noted a significant overlap of portfolios in some schemes and felt the necessity to introduce clear limits to the industry to avoid schemes with similar portfolios.

In its consultation paper, it suggested that mutual funds should be permitted to offer both Value and Contra funds. subject to the condition that no more than 50 per cent of the schemes' portfolios would overlap at any point in time.

The overlap condition should be monitored at the time of New Fund Offer (NFO) deployment and subsequently on a semi-annual basis using month-end portfolios. In case of a higher-than-per-

mitted overlap, the Asset Management Company (AMC) should rebalance the portfolios within 30 business days. An extension of up to an additional 30 business days may be obtained from the Investment Committee (IC) of the AMC, with the reasons for granting the additional days properly recorded and maintained.

"If the deviation persists beyond this period, investors of both the schemes shall be given an exit option without any exit load," SEBI proposed.

The regulator proposed that mutual funds should be permitted to invest the residual



portions of their portfolios in equity, debt (including money market instruments), gold and silver, Real Estate Investment Trusts (REITs), and Infrastructure Investment Trusts (InvITs) under the equity category

schemes. It also recommended changes in the nomenclature of debt schemes to enhance investor understanding. It proposed that the term 'Duration' be replaced with 'Term' for better clarity. Additionally, the 'Low Duration Fund' should be renamed as 'Ultra Short to Short Term Fund to better reflect the investment objective, and the name of each

debt scheme should indicate the fund's duration, such as Overnight Fund (1 Day) or Medium Term Fund (3 to 4 years). The regulator further pro-

posed that mutual funds should be allowed to launch sectoral debt funds, provided that no more than 60 per cent of the portfolio in a sectoral debt scheme overlaps with any other sectoral debt or debt category scheme.

This move should also ensure sufficient availability of investment-grade papers within the chosen sectors.

Moreover, mutual funds should be permitted to invest the residual portion of their debt category schemes in RE-ITs and InvITs, except for those with shorter durations, such as Overnight Fund, Liquid Fund, Ultra-Short Duration Fund, Low Duration Fund, and Money Market Fund, subject to regulatory limits applicable to this asset class.

In terms of arbitrage funds, SEBI suggested that such schemes should be allowed to take exposure in debt instruments only through government securities with a maturity of less than one year and in repos backed by government bonds. For equity savings schemes, the regulator proposed that net equity exposure and arbitrage exposure should be mandated between 15 per cent and 40 per cent.

With respect to hybrid category schemes, mutual funds should be allowed to invest the residual portion in REITs and InvITs, except in Dynamic Asset Allocation and Arbitrage Funds.

#### **Delhi HC reserves** order on Celebi's plea

New Delhi, July 18: The Delhi high court Friday reserved its order on a plea filed by Turkish-based Celebi company, namely Celebi Ground Handling India Private Limited, against Centre's decision to revoke its security clearance.

A different bench of the high court July 7 dismissed the pleas by Turkish-based firms -- Celebi Airport Services India Pvt Ltd and Celebi Delhi Cargo Termi nal Management India Pvt Ltd, challenging the revocation of their security clearance by aviation watchdog Bureau of Civil Aviation Safety (BCAS) May 15, saying there are compelling national security considerations involved

Justice Tejas Karia Friday reserved the order after companv's lawyer submitted that the petition was filed on July 4 after a coordinate bench reserved its judgement in a similar case involving the associated companies.

The counsel said Friday that the July 7 verdict directly applied to the present case as well, and urged the judge to pass a similar order. BCAS revoked the security clearance; days after Turkey backed Pakistan and condemned India's strikes on terror camps in the neighbouring country.

The court July 7 underlined the necessity to eliminate the possibility of espionage or dual use of logistics capabilities which would be highly detrimental to the security of the country, especially in the event of an external conflict.

## Informal Chinese sanctions hurting India's electronics sector

New Delhi, July 18: Informal trade restrictions imposed by China on capital equipment. critical minerals, and skilled technical personnel, can adversely impact India's electronics manufacturing ecosystem and constrain India's deeper integration into global value chains (GVCs), leading industry body India Cellular

India's electronics and mobile manufacturing sector has seen a remarkable growth over the past decade, driven by forward-looking policy interventions and private sector investments and the

shift of GVCs to India. At the forefront of this growth is smartphone manufacturing, which reached \$64 billion in production in FY25, with exports accounting for 38

per cent to \$24.1 billion. In turn, smartphone exports have propelled electronics from the seventh-largest export in FY20 to reach the third-largest export in FY25 reaching \$38.6 billion - only behind engineering goods and petroleum. "From ranking 167th among



India's exports in FY15, smartphones have now become the country's single largest export. This success is a direct outcome of the Production Linked Incentive (PLI) scheme launched in 2020, and aligns with the Government's vision of scaling electronics production to \$500 billion." the letter read.

China remains the dominant global source of high-precision tools and specialised machinery - an outcome of three decades of industrial clustering and deep GVC integration.

"For the electronics sector,

including smartphones, this has created a high dependency on China for capital equipment," the ICEA said in its letter. For over a year, China has been restricting the export of equipment to India across multiple sectors, including heavy-duty boring machines and solar equipment, now extending the restrictions over the last 8 months to electronics manufacturing, the industry body alleged.

"These disruptions are leading to operational inefficiencies, impacting scale and above all raising costs of production. since producing this equipment locally or in collaboration with Japan or Korea costs 3-4 times higher than Chinese imports,' the ICEA highlighted

Recent curbs by China on

rare earth materials are also risking input shortages for smartphone manufacturers operating in India.

Alternate sources are scarce and, where available, economically unviable, difficult to scale, or logistically inefficient, according to the ICEA.

There have also been travel restrictions and recall of Chinese technical teams working in India. "Over the last three months, China has taken two specific actions creating massive risks to India's supply chains in this space -- It has directed select companies that produce capex to wind up India operations and remove trained Indian professionals from their rolls, thus cutting off the technology transfer link that existed with China.

#### Adani group exits **AWL Agri Business**

NEW DELHI: Adani Group Friday exited AWL Agri Business (formerly known as Adani Wilmar) by selling its remaining 10.42 per cent stake in the company for ₹3,732 crore through open market transactions. according to the BSE data. Adani Commodities LLP (ACL), a subsidiary of Adani Enterprises, offloaded a total of 13,54,82,400 equity shares in 11 tranches on Friday, amounting to a 10.42 per cent stake in AWL Agri Business, as per the block deal data on the BSE. Shares of AWL Agri Business slipped 1.31 per cent to close at ₹274.60 apiece on the BSE. Thursday, billionaire Gautam Adani-promoted Adani Group said it has sold a 20 per cent stake in AWL Agri Business to Wilmar International Singapore for ₹7,150 crore, as part of its decision to exit the FMCG business and focus on the infrastructure vertical.

New Delhi, July 18: The Board of Control for Cricket in India (BCCI) generated a record revenue of Rs 9741 crore in the 2023-24 financial year, according to a report.

Indian Premier League (IPL), which was described as the golden goose of BC-CI in the report, contributed 59 per cent of the total revenue amounting to Rs 5761 crore.

"BCCI in 2007 discovered a golden goose - the IPL which is now a 100 per cent part of the BCCI. The tournament is the best and media rights are constantly going up. IPL also ensures that players from Ranji Trophy-level get a playing field. IPL will continue to churn out profitability as it growth further," said Lloyd Mathias, business strategist and independent director.

The BCCI earned Rs 361 crore from the media rights of non-IPL events which included the rights for series featuring the Indian cricket team. At the moment, Viacom18 holds the rights for the Indian cricket team matches while Disnev Star and Viacom18 have the IPL
