 $T^{hough\ Vice ext{-}President\ Jag-}$ deep Dhankhar cited health reasons behind his resignation, the abrupt move sent ripples through political circles, with some remarking that there was more to it than what meets the eye. Was he another Satyapal Malik, the former J&K Governor who turned hostile towards the ruling dispensation, in the making and the government got rid of him before it was too late? Lately, Dhankhar had started asserting himself and discussing issues with Opposition leaders to the discomfort of the government, it is believed. Accepting an Opposition-sponsored move to remove a judge was that last nail in the coffin, claimed a report. The shock resignation, sources indicate, has spared Dhankhar a government-backed no-confidence motion against him

New Delhi, July 22: President Droupadi Murmu Tuesday accepted the resignation of Vice President Jagdeep Dhankhar, who stepped down citing health concerns. However, his exit has triggered intense political speculation, with Opposition parties alleging that the move was prompted by pressure from the government.

Congress leader Sukhdeo Bhagat said, Dhankhar's resignation appeared "pre-scripted and the real story lies elsewhere," referring to reports suggesting the VP resigned shortly after receiving a phone call from unnamed officials.

The controversy comes amid simultaneous developments involving Justice Yashwant Varma, against whom large amounts of unaccounted cash were reportedly seized. The opposition had moved a proposal in the Rajya Sabha seeking Varma's removal. As Rajya Sabha Chairperson, Dhankhar had accepted the notice and instructed the secretary general to initiate appropriate procedures.

Sources indicate this step may have strained Dhankhar's relationship with



the government and the former was summoned for a discussion. He is believed to have strongly defended the constitutional authority of his office. The conversation reportedly escalated into a heated exchange.

Following this, discussions allegedly began within the ruling coalition regarding a possible no-confidence motion against him-Dhankhar's resignation came shortly after these developments, fueling speculation that it was a pre-emptive step to avoid political confrontation.

Meanwhile, Congress Tuesday claimed that there are 'far deeper reasons' for Dhankhar's resignation.

Party's general secretary incharge communications Jairam Ramesh said, "The VP has resigned. He has given health reasons for doing so. Those should be respected. But it is also a fact that there are far deeper reasons for his resignation."

The Congress saying that there is "far more to his totally unexpected resignation than meets the eye" also urged Prime Minister Narendra Modi to convince Dhankhar to change his mind. The AAP also demanded a

'clear explanation" from the government for the sudden resignation of former vice president, calling it a matter of "serious concern"

Addressing a press conference, Rajya Sabha member Sanjay Singh questioned the government's "silence" and the 'delayed response" from Prime Minister Narendra Modi.

While both the ruling party and the opposition sought Justice Verma's removal, the real contest is over who will claim the credit.

Washington, July 22: US Senator Lindsey Graham has warned that American President Donald Trump will impose steep tariffs on Moscow's trading partners --including India and China-- if they don't stop buying Russian oil amid Russia's war in Ukraine. The Republican lawmaker said the Trump administration was planning to impose a 100 per cent tariff on oil-related imports, fueling Russian President Vladimir Putin's campaign against Kyiv

Graham had earlier proposed a bill calling for 500 per cent tariffs on goods from countries continuing to trade with Russia, including India and China.

"Trump is going to impose tariffs on people that buy Russian oil - China, India, and Brazil... Here's what I would tell China. India and Brazil: If you keep buying cheap Russian oil to allow this war to continue, we're going to tear up the hell out of you, and we're going to crush your economy," Graham said during an interview with Fox News. "What you (India, China

and Brazil) are doing is blood money...He's (Putin) not going to stop until somebody makes him stop."

In a direct warning to Russia, Graham said, "The game has changed when it comes to you, President Putin. You have played President Trump at your own peril. You made a major league mistake, and your economy is going to continue to be crushed." Graham claimed that by "invading countries that do not belong to him", Putin was trying to recreate the former Soviet Union.

"Putin wants to take countries that are not his. In the mid-90s, Ukraine gave up 1,700 nuclear weapons with a prom ise that its sovereignty would be respected by Russia. Putin broke that promise," the Republican added. The fiery remarks seem to signal the Trump administration's growing frustration with Putin's disinterest in ending the war, which Trump once promised to end on the first day of his second term.

Students' startup delivers combat drones to Army

Hyderabad, July 22: Apollyon Dynamics, a defence-tech startup founded by two students of BITS Pilani, Hyderabad, an enterprise that began as a humble prototype assembly unit in a hostel room, has now started delivering indigenous combat drones and kamikazes to the Indian Army, just two months after launching operations, the founders said on Tuesday.

The startup co-founded by Jayant Khatri, a Mechanical Engineering student from Ajmer and Sourya Choudhury, an Electronics Engineering student from Kolkata, has delivered unmanned aerial vehicles (UAVs) to Indian Army units in Jam-



mu, Haryana's Chandimandir, West Bengal's Panagarh, and Arunachal Pradesh.

With a strategic goal to reduce India's dependence on foreign UAV technology, Apollyon's lineup includes multi-role aerial vehicles for long-range surveillance, tactical payload delivery, and high-precision kamikaze operations.

can fly at speeds exceeding 300 km per hour and deliver payloads up to 1 kg with high accuracy, making it one of the most effective systems of its kind.

"Designed for versatility in high-stakes environments, these drones are capable of executing a wide range of tactical operations from precision kamikaze strikes and covert nighttime surveillance to strategic payload deployment,' Jayant Khatri and Sourya Choudhury, told this agency.

The idea for Apollyon Dynamics was born in early April this year, driven by Jayant and Sourya's shared passion for robotics and unmanned aerial systems.



An advocate filed a PIL praying for the constitution of a high court-monitored special investigation team (SIT) to probe the incident. Currently, the Crime Branch of Odisha Police is probing the case.

During the hearing, the bench, also comprising Justice Manas Ranjan Pathak, expressed satisfaction with the investigation being carried out by the Crime Branch.

Earlier, Advocate General (AG) Pitambar Acharya submitted a status report before the bench, stating that the ongoing probe is being led by a senior IPS officer of the rank of inspector general, and assured the court that the state government is making every effort to ensure justice to the victim.

He said that the teacher concerned and the then-principal of the college were arrested.

The bench took exception to attempts by political parties and organisations to politicise the incident, giving bandh calls, road blockades, and picketing before government offices and hospitals, which have disrupted public life in violation of binding directions issued by the Supreme

The AG told the court that some of the political parties are politicising the issue and resorting to strikes undemocratically, violence, staging demonstrations inside hospitals like AIIMS-Bhubaneswar, paralysing the public transport system, which affected work at public offices.

The petitioner's advocate also informed the bench that he failed to reach court July 17. The court took suo motu cognisance of the mode of protest and issued notices to the BJD and the Congress, directing them to file responses in connection with the PIL within three weeks.

The bench observed that such bandh calls constitute a blatant violation of the Supreme Court's rulings, which prohibit obstruction of normal life under the guise of protest.

A total of 38 cases were closed following the hearings, while three others were disposed of after compliance and proof of compensation payment.

Additionally, compensation worth ₹1 crore remains pending under the Victim Compensation Scheme in 25 cases. The Odisha State Legal Services Authority assured the NHRC of



Following confirmation of the outbreak in Fasiguda, the Digapahandi block health administration has initiated emergency measures. A mobile medical team has been deployed in the village to conduct door-to-door visits, raise awareness and distribute preventive medication.

Meanwhile, personnel from the Rural Water Supply and Sanitation (RWSS) department have begun collecting water samples for testing. They have also taken up urgent repair and disinfection work on the village's tube wells.

Local representatives—including block vice chairperson Sukanti Pradhan, her representative Nakula Pradhan, sarpanch Gauri Bisovi and sarpanch representative Shibaram Pradhan—have joined in the response effort, conducting door-to-door awareness drives in coordination with health workers.

The Health department is monitoring the situation closely and has urged residents to take all necessary precautions.

Man arrested for rape bid on woman teacher

er in a private school. Police said the survivor sought Mishra's help in arranging an accommodation near the school and also to buy some goods. Mishra took him to Bada Bazaar where she purchased some goods and later took her to his aunt's house where he tried to rape her. Mishra assured to marry her when she resisted his advances, the SP added.

Keonjhar, July 22: The district administration here has issued termination letters for 29 employees who were drawing salaries with the funds available under the District Mineral Foundation (DMF) scheme.

The affected personnel in clude 22 junior project engineers (JPEs) and seven assistant project engineers (APEs), who were appointed across various blocks in the district.

Acting on the District Collector's directive, the Zilla Parishad office in Keonihar issued a letter (no. 4308; dt July 18, 2025) instructing the outsourcing agency to discontinue the services of these staffers.

This move follows a series of allegations and ongoing legal proceedings in the Orissa High Court regarding irregularities. fund misappropriation, and misuse of DMF grants in Keonjhar. Despite repeated complaints and the lapse of several months, the state-level committee had failed to submit its report to the court, prompting the petitioner to file a second petition in the court.

Sources allege that funds worth crores from the DMF fund were arbitrarily spent by



engaging employees in various departments, violating Section 11(A)(5) of the Odisha DMF Rules, 2015. Moreover, instead of directly transferring salary grants to the outsourcing agency, the funds were routed through the Project Director or CDO, Zilla Parishad of the District Rural Development Agency (DRDA), Keonjhar.

The state Chief Secretary had issued an order September 10, 2019 where in point no-5 (A) it was explicitly instructed that wages for project-specific outsourced personnel should be paid from the project contingency fund. However, the directive was bypassed, and large sums were spent directly from the DMF fund.

In this situation, the timeline for terminating those employees appointed in other departments remains uncertain. Furthermore, although various departments received DMF funds for contingency use many have failed to return the unspent amounts or provide clear account statements.

Concerns have also been raised about illegal appointments across departments, lack of income and expenditure records, and the absence of dedicated cashbooks for DMF linked activities. A serious al legation was made May 20, 2025 that different departments had opened multiple bank accounts under the DMF project title without authorisation.

Following a directive from the Union Ministry of Mines the State Planning and Convergence Department had sent a letter (no-8569/18, dt June 20, 2025) to the Keonihar Collector. requesting a detailed report on the issue.

Youth kills elderly mother for objecting to assault on wife

Pattamundai, July 22: In a shocking incident in Bishnupur village under Oupada panchayats and Pattamundai rural police limits, a youth allegedly beat his 70-year-old mother to death after she protested against his assault on his wife.

The accused, identified as Manoj Malik, reportedly attacked his wife Sasmita during a domestic altercation late Monday night. When his elderly mother, Shantilata Malik, intervened and objected to the violence, Manoj turned to-

wards her and hit her brutally. Shantilata died on the spot due to the assault. As Manoj attempted to flee, villagers apprehended him and informed the police. A team from Pattamundai Rural Police, led by IIC Dhiraj Lenka, arrived at the scene and took the accused



into custody.

Police registered a case (270/25) under Section 302 of the IPC and launched an investigation.

Sources said Manoi had married three months ago and had since been subjecting his wife and family to regular physical and mental abuse. The incident has triggered widespread outrage in the area, with villagers demanding strict punishment for the accused.

The case has shaken the local community, as the brutal act of matricide has left residents deeply disturbed.

Man held for causing wife's miscarriage

Tihidi: Police arrested a man here in edly causing the miscarriage of his wife following birth of two girl child instead of male progeny. The accused was identified as Sheikh Sahauddin, a resident of Balipal village in Achak anchayat under Tihidi police limits in Bhadrak district. He was arrested Monday, and produced in a court over a complaint by his wife. Samina Biwi alleging that he assaulted her with the intent to terminate her pregnancy. As per reports, Sahauddin married Samina in 2017. She hails from Mirzapur village under Bhatapada panchavat of the same district. The couple had a daughter soon after mar riage, and later, Samina gave birth to a second daughter, which reportedly displeased Sahauddin. Following this, he allegedly began harassing her for dowry and subjected her to repeated physical and mental abuse. Unable to bear the torture. Samina went back to her parental home. The incident occurred when she was alone at home July 4. Sahauddin allegedly visited his in-laws house and kicked Samina on the stomach on finding her alone in the house. Daringbadi, July 22: Awareness about environment conservation is growing among indigenous communities in the tribal-dominated reasons of Daringbadi in Kandhamal district as large patches of forests have been wiped out in several villages due to the effects of climate change. Realising the adverse im-

pacts of deforestation, tribal women across various panchayats have taken the lead in rejuvenating forest lands. Through an initiative involving the preparation and dispersal of seed balls-locally known as bihana mati pindula—they aim to restore degraded forest areas, including the barren method, mixing soil and compost with seeds. The balls are then dispersed across deforested areas, offering a simple yet effective technique for forest regeneration. According to the women involved, this method not only protects the seeds from harsh climatic conditions but also improves the chances of germination and survival.

Local voluntary organization Jagruti, while working under the state government's forest land rights initiative, is making the collaborative efforts with tribal women in reviving native tree species that are on the verge of disappearing. Seeds of such trees are being

Exit Mystery

major controversy has erupted after the sudden resignation of Vice President Jagdeep Dhankhar, tendered hours after he had attended the proceedings of the first day of the Monsoon Session of the Rajya Sabha, of which he was the Chairman, on 21 July. The government itself is to blame for this unseemly development. The official reason given out by Dhankhar himself for the resignation – his health problems - does not wash easily. Statements made by some RS members, who attended the session, suggest the Vice President did not show any signs of being so ill that he had to put in his papers immediately late in the evening. Coupled with this the fact that he still had two more years before his tenure was to come to an end gives enough room for speculation, as several Opposition parties are doing, that there is more than meets the eye. Of course, there is no definite and easy clue to what "more" could imply in this situation. He had recently said he would complete his tenure at the right time.

The government, which has a knack of springing surprises on the people before announcing something big, should have made a highly important matter such as the resignation or selection of the second highest constitutional head of the country transparent and convincing. The Vice President did have health issues that cropped up a few months back. Had his health deteriorated to the extent that he was unable to discharge the responsibilities any longer, the nation should have been informed before the decision for his exit from the office was announced unless a health emergency had occurred. There is no indication whatsoever that such a thing had happened. On the contrary, the Vice President appeared hale and hearty when he had conducted RS business earlier in the day. He even took up important issues such as the impeachment of High Court judge Justice Yashwant Varma from whose house wads of notes were discovered months ago. Only a few hours later the incredulous announcement was made that Dhankhar was stepping down, of all things, on account of failing health. On another note, any Vice President would be the greatest beneficiary if she or he needs health care as the national exchequer (or rather the tax payers of the country) would have been forced to pay for his best medical care that may be available anywhere in the world. After resignation, obviously, Dhankhar will now have to pay any medical expenses that he may incur from his own pocket. Significantly, two Union ministers had been conspicuous by their absence from an important meeting presided over by the RS Chairman earlier in the afternoon.

Unlike his predecessors, Dhankhar, in his three years in the office, became embroiled in several controversies for the statements he made inside and outside the Parliament. He took a stand diametrically opposite to that of the government on the farmers' protests, while he was over-enthusiastic about corruption in judiciary. He advised the government in a veiled manner against being audacious with people. But, he was more vocal than many of the Union Ministers on issues such as Sanatana Dharma and insertion of the words secularism and socialism in the Constitution.

In one of his first speeches as Vice President on judicial accountability in 2022, he called the Supreme Court's 2015 judgement striking down the National Judicial Appointments Commission (NJAC) Act a "glaring instance" of "severe compromise" of parliamentary sovereignty and disregard of the "mandate of the people." He urged then Chief Justice of India, DY Chandrachud, who was present at the programme, to find out a parallel in the world where "a Constitutional provision was undone." He wondered why even after the verdict, there was not even a murmur in the Parliament. He also had a running feud with the Opposition which tried unsuccessfully to impeach him. Of the greatest importance is Dhankhar's recent statement made on 10 July at JNU where he had said addressing a gathering, "I will retire at the right time - August 2027. Subject to divine intervention." Now, it seems the divine, in whatever form, has indeed intervened.

Before his tenure as Vice President he had been appointed West Bengal Governor and he had several face-offs with the Trinamool Congress (TMC) government. The latter accused him of turning the Raj Bhavan into an extension of the BJP's office and acting more as a BJP leader with animus against the Trinamool than as an impartial Governor.

Now with speculation about the reasons for his resignation being rife, bigger surprises may be in store for the country, given the government's track record and Dhankhar closeness to the RSS.

During the conference, Tarrio led a group back to the US Capitol, where they chanted, "Whose house? Our house!" He was later arrested for assaulting a protester. After his release, Tarrio traveled to the Principles First venue, where he verbally harassed Michael Fanone, the former Washington police officer who was severely injured while defending the Capitol during the insurrection.

As an anthropologist who studies political violence, I see these events as a sign that the United States is in serious trouble. In my 2021 book It Can Happen Here, I argued that bad actors are increasingly emboldened, heightening the risk of politically motivated violence. That threat became even more apparent on 14 June, when Trump supporter Vance Boelter shot two Minnesota state Democrats and their spouses, killing State House Speaker Emerita Melissa Hortman and her husband. Authorities later discovered a hit list with the names of 45 Democratic officials in Boelter's car.

sylvania's Democratic Governor Josh Shapiro by breaking into his residence and setting it on fire. There have also been other recent attacks, including some carried out by individuals on the political left.

Four key factors are driving this surge in political violence. First, despite branding himself as a "law and order" president, Trump has helped cultivate a culture of impunity. It's not just that he is a convicted felon whose three remaining criminal cases were dismissed or suspended after his re-election. Long before that, he famously proclaimed, "I could stand in the middle of Fifth Avenue and shoot somebody, and I wouldn't lose any voters."

On his first day back in office, Trump pardoned or commuted the sentences of more than 1,500 6 January insurrectionists, including Tarrio. He has continued issuing pardons to allies, with the Justice Department's pardon attorney, Ed Martin, posting on X, "No MAGA Left Behind." By politicising the presidential pardon, Trump has sent the dangerous message that partisan violence is acceptable.

The second factor is past acts of political violence, which heighten the risk of future violence. As I explained in It Can Happen Here, the US has a long history of political violence to draw on. But even recent events offer ample cause for alarm.

Trump bears much of the

blame. Before the 6 January insurrection, he attacked election integrity and explicitly directed the Proud Boys – and, by extension, other far-right extremists – to "stand by." Like other scholars at the time, I warned that the risk of violence in the US was especially high. While dramatic, neither the 7 October, 2020, arrest of militia members who plotted to kidnap Michigan Governor Gretchen Whitmer nor the 6 January Capitol attack came as a surprise.

As the 2024 election approached, the threat of violence once again escalated. Trump himself was nearly assassinated during a 13 July rally in Pennsylvania, threats against election workers surged, and many feared that a contested election would again lead to an insurrection – a concern that Trump's victory ultimately rendered moot.

Third, American society remains deeply divided. In my research on US political culture, I have seen this polarisation firsthand, as people on both the left and the right often demonise the other side as authoritarian, framing politics in apocalyptic us-versus-them terms.

The data underscore just how toxic and entrenched US polarisation has become. Nearly half of Americans view those on the opposite side of the political spectrum as "downright evil," while an even greater share of Democrats and Republicans describe

each other as "closed-minded, dishonest, and immoral." Roughly 80% of US adults worry about political violence, and 40% believe the country is headed toward civil war.

While both parties have contributed to this division, Trump remains the polariser-in-chief. He repeatedly stoked anger and resentment during his first term, and his 2024 campaign centered on promises of retribution and warnings about "criminal" immigrants and "woke" leftists – groups he continues to demonise.

Lastly, the risk of political violence tends to rise during tumultuous periods, especially when the legitimacy of elections is challenged or when democratic institutions are weakened. Both conditions were present in the lead-up to the 2021 insurrection, and they persist today.

Trump is now waging an aggressive campaign to consolidate executive power. Since returning to the White House, he has sought to undermine every check on presidential authority, including judicial independence, civil society, academic freedom, public-service neutrality, press freedom, and even basic civil liberties.

even basic civil liberties.

As a result, today's America is a tinderbox. When and where the next would-be assassin might strike is anyone's guess, but one thing is certain: the risk of political violence will spike ahead of the 2026 midterm elections and could reach crisis levels by the presidential election of 2028.

There's an easy way to mitigate this risk: Trump could choose to be a unifier rather than a divider. Polls show that most Americans want the political temperature brought down. Unfortunately, it is far more likely that Trump, who rose to power on a populist platform rooted in fear and grievance – much of it racially tinged –

much of it racially tinged – will continue to fan the flames of division, keeping the risk of political violence elevated.

It's okay to keep your shoes on

ANYONE WHO KEEPS A DOG INSIDE THEIR HOME IS SAYING TO THE WORLD, 'A LITTLE DIRT WON'T KILL ME' he Transportation Security Administration (TSA) in the US recently decided to allow people to keep their shoes on while going through airport security. In a related move, I have decided to allow people to keep their shoes on while entering my

Anyone entering my home may keep wearing their shoes if the following conditions are met: (1) the shoes look clean; (2) it is not raining heavily; and (3) my wife is not home.

It is not that my wife would necessarily object to someone entering our home without removing their shoes in the entryway. She has certainly made exceptions over the years. But I have not consulted her before deciding that the shoe-removal tradition we have followed puts an unnecessary burden on our guests. Older people have trouble bending down to put their shoes on when leaving our home, while youngsters have trouble tying their laces. It's

an extra five minutes of their lives that I'm hoping to return

The TSA, on the other hand, is concerned more about safety than convenience. The shoe removal rule was instituted in August 2006, when the TSA determined that shoes continued to pose a serious threat. About five years earlier, on 22 December, 2001, an American Airlines passenger named Richard Reid, flying from Paris to Miami, tried to detonate his shoes. He had filled them with 10 ounces of explosive material, as well as two large feet. Fortunately he had trouble lighting the fuse, and passengers and crew members pounced on him before he could blow up the plane. Reid. known as the "shoe bomber," is serving a life sentence in federal prison. (I do not know if the TSA has informed him that his name is no longer being cursed at security checkpoints.)

The shoe-removal rule was

in place for almost two decades and during that time, very few shoes were found to pose actual threats. The most serious incident reportedly occurred a few years ago at LaGuardia Airport in New York City when a passenger from Europe placed his shoes on the conveyor belt, causing two TSA officers to immediately faint from the odor. Smelling salts were needed to revive them. The passenger was arrested and sentenced to three hours on a Spirit Airlines flight. He was ordered to keep his shoes on.

The main reason for the rescinding of the shoe-removal rule is improved technology. The TSA now has the technology to detect explosives, contraband or anything else in your shoes while you are wearing them. If you need to sneak anything onto a plane, don't do it in your sneakers.

Thankfully, I do not have to worry about any explosives entering my home through shoes. But shoes can certainly carry a lot of dirt, which is why Donald Trump was once spotted speaking directly to Volodymyr Zelenskyy's shoes, asking, "Do you have any dirt on Joe Biden?"

Keeping dirt out of a home is one of the main reasons that the shoe-removal tradition is followed in India and other Asian countries. It was natural for my wife and I to do what is commonplace in our native land. But aside from the inconvenience to our guests, I wonder whether it makes sense to be concerned about dirt on a guest's shoes when our dog, Lulu, does not even wipe her feet before entering our home. She not only puts her feet on our carpet, she rolls around on it, as though it's her best friend with whom she wants to share whatever she carries in.

Anyone who keeps a dog inside their home is saying to the world, "A little dirt won't kill me."

Neither will a pair of shoes, as the TSA has concluded.


Pahalgam, July 22: Three months after the brutal terror attack in Pahalgam that left many tourists dead, the perpetrators are still at large, raising concerns over security lapses in the region and sparking growing calls for fixing ac-

While the National Investigation Agency (NIA) has made two arrests in connection with the April 22 incident, those nabbed are believed to be the ones who provided logistical support, while the actual terrorists responsible for the ghastly crime have evaded security agencies.

The security vacuum has prompted Lt Governor Manoj Sinha, who will complete his five-year term next month, to take full responsibility for what he acknowledged as a "security

This admission was appreciated by Chief Minister Omar Abdullah, who nonetheless called for accountability. "I appreciate the statement of the Lt Governor but an admission of failure must be followed by action," he had told PTI here recently. "Heads must roll when such a grave mistake leads to the loss of precious lives. The people of Kashmir deserve to know what went wrong and who will be held accountable," the chief minister had said.

Srinagar, July 22: Jammu and Kashmir Lieutenant Governor Manoj Sinha Tuesday launched a web portal to expedite the process of providing relief and compassionate appointment to the families of terror attack victims in the Union Territory.

Sinha said the portal, developed by the Home Department in collaboration with the National Informatics Centre (NIC), will act as a centralised platform to capture and maintain comprehensive district-wise data on terrorism-affected families and provide institutionalised support to them.

"The initiative will streamline and expedite the process of providing relief, compassionate appointments, and other forms of assistance to those who have suffered from terrorism in the UT," the LG said.

An official spokesperson said the details of any encroachbers are also being captured.

It will ensure that no legiti mate case is left unaddressed and timely support is extended to eligible families in terms of financial relief, ex-gratia com pensation and compassionate employment while ensuring elimination of any bogus or multiple claims, he said.

The LG is personally monitoring and overseeing the redressal of all cases across Jammu and Kashmir, the spokesperson added.

Toll-free helpline numbers have also been established at the offices of the divisional commissioners in both Jam mu (0191-2478995) and Kashmir (0194-2487777) divisions, to fa cilitate the registration of any overlooked or pending claims

the spokesman said. These helplines are being attended through dedicated control rooms as citizen interfaces for receiving grievances or queries related to pending government support to ter ror-affected families regarding compensation, ex-gratia relief and compassionate appoint ments, he said.

The helplines have been staffed with trained personnel and will be integrated with the centralised application to ensure that every claim is formally recorded and acted upon

To ensure regular oversight, coordination, and follow-up on the grievances and pending claims, special monitoring cells have been constituted in the offices of the chief secre tary and the director general

End of an era in Bengal's Naxalite politics

Kolkata, July 22: Azizul Haque — firebrand poet, political thinker and one of the last towering leaders of India's Naxalite uprising died here Monday, marking the end of a turbulent, bloodsoaked chapter in Bengal's radical Left history that once shook the nation in the 1960s

He was 83. Haque, who was born in Howrah in 1942, belonged to the generation of Naxal leaders who believed that 'bonduker nol-i, khomotar utsa' (Political power flows out of the barrel of the gun), a doctrine popularised by their ideological mentor, Charu Mazumdar, who made the Mao Zedong's slogan popular in India in the Sixties and

A poet, political thinker and once the head of the CPI(ML)'s second central committee, Haque had long been battling illness and was admitted to ICU after a fall at home that left him with a fractured hand.

He breathed his last at 2:28 PM, sources said. West Bengal Chief Minister Mamata Banerjee expressed deep condolences on X, describing Haque as a "fighter who never bowed down in his long political life".

"I express my condolences at the passing of veteran politician Azizul Haque. Azizul Haque was a fighter, a resolute leader. In his long political career, he never bowed his head. I extend my heartfelt condolences to his bereaved family and associates," she posted on X.

A close associate of Charu Mazumdar and Kanai Chatterjee, Haque was among the few leaders who kept the flame of the Naxalbari uprising alive long after it was crushed by the state.

He was expelled from the CPI(M) for endorsing Ma-

zumdar's radical line, later

co-founding the CPI(ML)'s Second Central Committee with Nishith Bhattacharya after the latter's death. faction tried to set up parallel

Notably, he supported the CPI(M)'s industrialisation drive in Singur in 2006, distancing himself from many of his former comrades who opposed land acquisition.

"Leftism is to walk against the current," he often said, and till the end, his pen remained active-contributing columns and essays to leading dailies and journals, always with a streak of rebellion.

Azizul Haque's death is not just the passing of a political veteran, it is the quiet extinguishing of one of the last flames of Bengal's revolutionary Left. For many, July 21, 2025, will be remembered as the day a radical conscience bid farewell.

New Delhi, July 22: The Election Commission of India has justified its ongoing Special Intensive Revision (SIR) of electoral rolls in Bihar saying it adds to the purity of the election by "weeding out ineligible persons" from the electoral rolls.

The affidavit filed by the poll panel in a plea challenging the June 24 order directing SIR of electoral roll pan-India starting from Bihar, said despite legal concerns Aadhaar, voter card and ration card were already being considered by the commission for the limited purpose of identity during the SIR-2025

"The SIR exercise adds to the purity of elections by weeding out ineligible persons from the electoral roll. The entitlement to vote flows from Article 326 read with Sections 16 and 19 of the RP Act 1950 and Section 62 of the RP Act 1951 which contains certain qualifications with respect to citizenship, age, and ordinary residency. An ineligible person has no right to vote, and thus, cannot claim a violation of Articles 19 and 21 in this regard," the ECI said in a detailed affidavit.

It referred to the July 17 order of the top court asking the ECI to consider Aadhaar, voter IDs and ration cards for the purpose of SIR-2025.

"In addition to the legal concerns already articulated hereinabove, these documents are, in fact, already being considered by the Commission for the limited purpose of identity, during the SIR process," it said. The ECI continued, "A bare

52 lakh voters untraceable: ECI

New Delhi: During house-to-house visit in the ongoing Special Intensive Revision (SIR) of electoral roll in Bihar, poll officials have so far found that more than 52 lakh voters were not present at their addresses and another 18 lakh have died. The Election Commission said Tuesday that 26 lakh electors have shifted to different constituencies, while another sever lakh have enrolled at two places. Poll officials in the state have shared detailed lists of the 21.36 lakh electors whose enumeration forms have not been received so far and also of the nearly 52.30 lakh who are reportedly deceased or permanently shifted or have enrolled at multiple places.

The poll panel said as on July 18, of the 7,89,69,844 existing electors in Bihar, enumeration forms from 7,11,72,660 electors, constituting 90.12 per cent, had already been collected.

The poll panel assured of making "all possible efforts" to include all those eligible in the electoral roll and as a special effort, political parties were

given the list of electors, whose enumeration forms had not been received, in order to trace them and get their enumeration forms through their BLAs.

NGO Association of Democratic Reforms and other petitioners, including leaders of various political parties and members of civil society, argued that the June 24 orders violates fundamental rights of citizens.

The ECI refuted the claims saying no discrimination could be alleged. Further, the poll panel said persons who featured in the 2003 electoral roll had already undergone scrutiny through the previous intensive revision and remained electors since then.

As a result, it said, they did not constitute the same class of persons whose names feature in the electoral roll of January 2025. The poll panel said any person unable to submit an eligibility document by July 26, could do it in the claims and objections period and there was no discriminatory treatment meted out to ordinary voters as compared to the distinguished persons such as members of judiciary and public representatives as their documents were being collected from home.

Amid 'rummy' video row, minister calls govt 'beggar'

Nashik, July 22: Maharashtra minister Manikrao Kokate, who has been accused of playing rummy on his phone in the legislature, Tuesday waded into another controversy as he termed the government a "beggar" while trying to clarify an earlier comment on farmers.

Chief Minister Devendra Fadnavis said it was inappropriate for ministers to speak in such a manner and asserted Maharashtra's economy was in good shape despite challenges.

Earlier this year, Nationalist Congress Party (NCP) leader Kokate, who handles the agriculture ministry, allegedly compared farmers to beggars, inviting severe criticism.

"Even a beggar does not take Re 1 in alms, but here we are giving crop insurance for Re 1. Even then, some people try to misuse it," he had said. Asked about his remark, Ko-

kate on Tuesday told reporters, "The government doesn't give Re 1 to farmers, it takes Re 1 from them. The government is a beggar." The minister, who represents the Sinnar constituency in Nashik district, said 5 lakh to 5.3 lakh bogus applications for the Re 1 crop insurance scheme had been received and he rejected them and implemented several corrective steps. The Re 1 crop insurance scheme, launched two years ago, was scrapped a few months back and replaced with the Prime Minister Crop Insurance Scheme.

Reacting to Kokate's re-



has made such a comment, it is inappropriate for ministers to speak in this manner. We have taken corrective measures in the crop insurance scheme as we saw insurance companies benefitting and not farmers."

Boeing delivers 3 Apache choppers to Indian Army

The company delivered the AH-64E Apaches choppers as part of a Rs 4,168 crore contract to supply six helicopters to the Indian Army. The AH-64 Apache is one of the world's most advanced multi-role combat helicopters and is flown by the US Army.

"The arrival of the first batch of Apache helicopters for the Indian Army is a significant step towards strengthening India's defence capabilities.

"These advanced helicopters will enhance the Army Aviation wing's operational effectiveness, specially in challenging terrains. A proud moment reflecting our commitment to modernising the Armed Forces," Singh said in a social media post. The Army described the delivery of the first batch of choppers as a "milestone moment" for the force.

In 2020, Boeing completed delivery of 22 E-model Apaches to the Indian Air Force and signed a contract to supply six AH-64Es for the Indian Army. In a major ruling delivered Monday, the Bombay High Court acquitted 12 accused, of whom five were on death sentence and seven others on life imprisonment, in the July 11, 2006, Mumbai blast case.

Delhi govt extends current EV policy till March 2026 ers to boost EV adoption, devel

New Delhi, July 22: Delhi government has extended the current Electric Vehicle (EV) Policy until March 31, 2026, as the draft of the new policy will undergo public consultation, which is expected to take time, Transport Minister Pankaj Singh said Tuesday.

Singh said the policy extension was among the matters listed for Tuesday's Cabinet meeting, and it has been decided to extend the same.

"The current Electric Vehicle (EV) Policy has been extended until March 31, 2026, or until a new policy is approved. whichever is earlier," Singh told PTI. The minister said the move aims to facilitate comprehensive consultations with all the relevant stakeholders. including citizens, industry experts, private organisations, and environmental groups.

Singh added that during this extended period, key provisions of the policy will be discussed, including strengthening the EV charging infrastructure, reviewing subsidies and waiv-

oping robust systems for safe e-waste and battery disposal and clearly defining the role of the public and private sectors in advancing the electric mobility ecosystem. Given Delhi's air pollution crisis, this participatory approach is seen as a crucial step towards framing a more effective, inclusive, and forward-looking EV policy that promotes clean and sustainable urban transport, Singh said adding that the government has also urged active public participation in the consultation process to collectively shape the future of electric mobility

in the capital. The current EV policy -- first introduced in 2020 during the previous Aam Aadmi Party rule lapsed in August 2023. It has since been extended multiple times.

The Cabinet had discussed the draft policy April 15 but deferred the approval of key proposals, including the phas ing out of CNG auto-rickshaws and fossil fuel-based two-wheel ers within two years. The draft policy envisions 100 per cent electric vehicle ado



MUMBAI: Nine of the eleven persons acquitted by the Bombay High Court in the 7/11 serial train blasts case have been released from various prisons in Maharashtra, while two others will continue to be behind bars as other cases are pending against them, officials said Tuesday. Nineteen years after seven train blasts here killed more than 180 persons, the high court Monday acquitted all the 12 accused, saying the prosecution utterly failed to prove the case and it was "hard to believe the accused committed the crime". The court allowed the appeals filed by the accused challenging their conviction and sentences imposed on them by a special court in 2015. Of the 12, five had been sentenced to death and seven to life imprisonment by the special court. One of the death row convicts died in 2021.

New Delhi, Jul 22: Indian cities are becoming increasingly more vulnerable to floods, heatwaves, and other climate-related risks and will require over 2.4 trillion US dollars in investments by 2050 to build resilient and low-carbon infrastructure. according to a World Bank report released Tuesday.

The report notes that Indian cities hold tremendous potential as centres of economic growth, with 70 per cent of new jobs coming from cities by 2030. "However, timely action is

needed for cities to deal with impacts from extreme weather events and avert billions of dollars in future losses," the report 'Towards Resilient and Prosperous Cities in India' states. The report, prepared in partnership with the Ministry of Housing and Urban Affairs, stated that "Annual economic losses from rain-related flooding are currently estimated at 4 billion dollars. These are projected to rise to five billion dollars by 2030 and between 14 and 30 billion dollars by 2070 if no remedial action is taken."

According to the report,

Between 1983 and 2016, exposure to dangerous heat levels increased by 71 percent in India's 10 largest cities, rising from 4.3 billion to 10.1 billion person-hours per year," the report added. The report raised concerns about heat-related deaths.

Heat mitigation alone could increase India's Gross Domestic Product by up to 0.4 per cent and save up to 130,000 lives annually by 2050, the report states

According to the report, the country's urban projected population will be around 1.1 billion by 2070. "More than 144 million new urban homes will be required, doubling the current housing stock," the report



'Racist' attack on **Indian in Ireland**

London: An Indian man in his 40s was hospitalised following what has been dubbed "mindless, racist violence" in a suburb of the Irish capital of Dublin, with the Indian Ambassador to Ireland calling for the perpetrators to be brought to justice. According to local reports, the victim had arrived in Ireland a few weeks ago when he was targeted in an assault at Parkhill Road in Tallaght Saturday evening. The Gardai, as the police are known in Ireland, have opened an investigation into the case. "Gardaí in Tallaght were alerted to an incident at Parkhill Road, Tallaght, Dublin 24 on the evening of Saturday 19th July, 2025, at approximately 6pm," the local police said in a statement. "Gardaí attended the scene and a male, aged in his 40s was taken to Tallaght University Hospital with injuries," the statement added.

Moscow: Russian lawmakers Tuesday approved a bill that punishes online searches for information that is deemed "extremist", the latest move by government authorities in their relentless crackdown on dissent. The bill passed by the lower house, the State Duma, moves to its all-butcertain endorsement in the upper house and then goes to President Vladimir Putin to be signed into law. The legislation punishes what it describes as "deliberately searching for and accessing extremist materials" online. First-time offenders face a fine of up to the equivalent of \$64. The official definition of extremist activity is extremely broad and includes opposition groups like the Anti-Corruption Foundation, created by the late opposition leader Alexei Navalny, and the "international LGBT movement". It's not clear how authorities will track

Peshawar: Two children were killed in a mortar explosion while on their way to a religious seminary in Pakistan's Khyber Pakhtunkhwa province Tuesday, as per local sources. The victims Arafat and Amir, both around six to seven years old, belonged to the Mehsud tribe in Raghza village, located in the jurisdiction of Gomal Bazaar Police Station in Tank district of northwest Pakistan. sources said. The victims were carrying tea for their teacher when the blast occurred. they added. The bodies of the victims were taken to the District Headquarters Hospital in Tank. Authorities have launched an operation to further investigate the incident.

Starvation deaths mount in Gaza

Cairo/Gaza July 22: A sixweek-old infant was among 15 people who have died of starvation in Gaza in the past 24 hours, local health officials said, with malnutrition now killing Palestinians faster than at any point in the 21-month

The infant died at a hospital ward in northern Gaza, the health officials said, naming him as Yousef al-Safadi. Three of the others were also children, including 13-year-old Abdulhamid al-Ghalban, who died in a hospital in the southern city of Khan Younis. The other two children were not named.

Palestinian health officials say at least 101 people have died of hunger during the conflict, including 80 children, with most of them in recent weeks.

Israel controls all aid supplies into the war-ravaged enclave, where most of the population has been displaced multiple times and faces acute shortages of basic necessities.

The head of the UN Palestinian refugee agency said Tuesday that its staff, as well as doctors and humanitarian workers, were fainting on duty in Gaza due to hunger and exhaustion.

"No one is spared: caretakers in Gaza are also in need of care. Doctors, nurses, journalists and humanitarians are hungry," UNRWA Commissioner General Philippe Lazzarini said in a statement.

There has been international condemnation of mass killings of civilians and dire shortages of aid in Gaza, but no action that has yet stopped the conflict, or significantly increased supplies.

European Commission President Ursula von der Leyen said on Tuesday that images of civilians killed during the

distribution of aid were "unbearable" and urged Israel to deliver on pledges to improve the situation, but did not say what action European countries would take.

Israel's military said that it "views the transfer of humanitarian aid into Gaza as a matter of utmost importance", and works to facilitate its entry in coordination with the international community.

It has denied accusations it is preventing aid from reaching Gaza and has accused Palestinian militant group Hamas of stealing food, an allegation Hamas denies

FOOD AND MEDICINE SHORT-AGES

"Hospitals are already overwhelmed by the number of casualties from gunfire. They can't provide much more help for hunger-related symptoms because of food and medicine shortages," said Khalil al-Degran, a spokesperson for the health ministry.

Degran said some 600,000 people were suffering from malnutrition, including at least 60,000 pregnant women. Symptoms among those going hungry include dehydration and anaemia, he said.

Baby formula in particular is in critically short supply, according to aid groups, doctors and residents

Israel says its assault on Gaza aims to destroy Hamas, which waged the deadliest attack in Israel's history on October 7, 2023, killing at least 1,200 Israelis including civilians, by

Israeli bombs and gunfire have killed nearly 60,000 people in Gaza since then, according to local health authorities.

Tank shelling killed another 16 people living in tents in Gaza City on Tuesday, as Israeli troops launched attacks across the strip, health officials said. The Israeli military said it wasn't aware of any incident, or artillery in the area at that

The health ministry said at least 72 Palestinians were killed by Israeli gunfire and military

Daily food gathering has become a deadly task for Gazans, with UNRWA estimating that more than 1,000 people have died while trying to receive food aid since May.

On Tuesday, men and boys lugged sacks of flour past destroyed buildings and tarpaulins in Gaza City, grabbing what food they could from aid warehouses.

'We haven't eaten for five days," said Mohammed Jundia. Famine is killing people."

Israeli military statistics showed on Tuesday that an average of 146 trucks of aid per day had entered Gaza over the course of the war. The United States has said a minimum of 600 trucks per day are needed to feed Gaza's population.

Twenty-five Western countries, which have backed Isra el's war against Hamas, issued a statement on Monday condemning Israel over the "inhuman killing" of civilians in Gaza, but there was no indication that further action would be taken against Israel.

European Union foreign policy chief Kaja Kallas said the Israeli military "must stop killing people at distribution points,' and that "all options" were on the table if Israel didn't expand humanitarian access, but did not say what those options included.

The EU remains divided over how hard a line to take. Germany refrained from signing the statement, which Israel dismissed as "disconnected from reality", saying Hamas was shooting civilians at aid distribution points. It provided no evidence for the claim.

Israel and Hamas are engaged in indirect talks in Doha aimed at reaching a 60-day truce and hostage deal, although there has been no sign of breakthrough.

Students protest as B'desh jet crash toll goes up to 31



Dhaka, July 22: Thousands of students Tuesday protested demanding 'accurate' information on casualties and compensation for the families of those killed when a Bangladesh Air Force training jet crashed into a school, as the death toll in the incident

rose to 31, including 25 children. The F-7 BGI aircraft, a training fighter jet manufactured in China, experienced a "mechanical fault" moments after takeoff and crashed into a two-storey building of Milestone School and College in Dhaka's Uttara area Monday, according to officials.

The death toll from the crash rose to 31, according to the Inter-Services Public Relations (ISPR) - the media wing of the military. The Chief Adviser's special adviser, Saidur Rahman, told reporters that 25 deceased were children and many of them under the age of 12, who succumbed to extensive burn injuries. The pilot and one teacher were among the dead.

Sharing the details, the ISPR said that 16 people died at the Combined Military Hospital, 10 at the National Institute of Burn and Plastic Surgery, two at Lubana General Hospital, and one each at Dhaka Medical College Hospital, Uttara Adhunik Medical College Hospital, and United Hospital.

It added that 165 of the injured are undergoing treatment at 10 hospitals in Dhaka. Authorities fear the toll could further rise as conditions of some of the in jured were critical.

Hundreds of students of Milestone School and College, as well as from nearby schools. protested, demanding the "accurate" disclosure of the informa tion about those killed, compensation for victims' families and the immediate discontinuation of outdated and unsafe training aircraft used by the Bangladesh Air Force.

Law Adviser Asif Nazrul, Education Adviser CR Abrar, and Chief Adviser's Press Secretary Shafiqul Alam visited the crash site, where agitating students confronted them and shout ed slogans in favour of their demands. The advisers took shelter inside one of the school buildings around 10:30 am.

Despite security vigils by army and paramilitary troops the students laid a siege to the building where the advisers took shelter. They alleged that the authorities were deliberate ly hiding the actual death toll.

Their demands include a complete list of the injured; a public apology for the assault on teachers by army personnel at the crash site, and reforms in Air Force training procedures to ensure safety.

US leaving UNESCO again, only 2 yrs after rejoining

Paris, July 22: The United States announced Tuesday it will again pull out of the UN's educational, scientific and cultural agency because it believes that its involvement is not in the country's national interest, and that the agency promotes anti-Israel speech. This decision comes only two years after the United States rejoined UNESCO after leaving in 2018. during US President Donald Trump's first administration.

State Department spokesperson Tammy Bruce said the withdrawal was linked to UN-ESCO's perceived agenda to "advance divisive social and cultural causes.

She added in a statement that UNESCO's decision "to admit the State of Palestine' as a Member State is highly problematic, contrary to US policy, and contributed to the proliferation of anti-Israel rhetoric within the organisation."

The decision, first reported by the New York Post, will take effect at the end of Decem-

This will be the third time that the United States has left UNESCO, which is based in Paris, and the second time during a Trump administration. It last rejoined the agency in 2023, under the Biden admin istration.

UNESCO's Director General Audrey Azoulay said she "deeply" regrets the US decision but insisted that it was expected, and that the agency "has prepared for it." She also denied accusations of anti-Israel bias.

"These claims ... contradict the reality of UNESCO's efforts, particularly in the field of Holocaust education and the fight

against antisemitism." she said. The Trump administration in 2017 announced that the US would withdraw from UNES-CO, citing anti-Israel bias. That decision took effect a year later. The US and Israel stopped financing UNESCO after it voted to include Palestine as a member state in 2011.

Tiny Pacific nation turns to ICJ as climate disasters mount

Port Vila (Vanuatu), July 22: When John Warmington first began diving the reefs outside his home in Vanuatu's Havannah Harbour a decade ago, the coral rose like a sunken forest — tall stands of staghorns branched into yellow antlers, plate corals layered like canopies, and clouds of darting fish wove through the labyrinth.

'We used to know every inch of that reef," he said. "It was like a friend."

Now, it's unrecognisable. After Cyclone Pam battered the reef in 2015, sediment from inland rivers smothered the coral beds. Crown-of-thorns starfish swept in and devoured the recovering polyps. Back-to-back cyclones in 2023 crushed what was left. Then, in December 2024. a 7.3 magnitude earthquake shook the seabed.

What remains is a coral graveyard — bleached rubble scattered across the seafloor, habitats collapsed, life vanished. "We've come out of the water in tears," said Warmington, who has logged thousands of dives on this single reef. "We just see heartbreak.

That heartbreak is becoming more common across this Pacific island nation, where intensifying cyclones, rising seas and saltwater intrusion are reshaping coastlines and threatening daily life. Since 1993, sea levels around Vanuatu's shores have risen by about 6 millimetres per vear — significantly faster than the global average — and in some areas, tectonic activity has doubled that rate.

On Wednesday, Vanuatu will get its day in the world's highest court. The International Court of Justice (ICJ) will issue an advisory opinion on what

legal obligations nations have to address climate change and what consequences they may face if they don't. The case, led by Vanuatu and backed by more than 130 countries, is seen as a potential turning point in international climate law.

"Seeing large, polluting countries just continue business as usual and not take the

climate crisis seriously can get really sad and disappointing,' said 16-vear-old climate active ist Vepaiamele Trief. "If they rule in our favour, that could change everything. The opinion won't be legally

binding, but could help shape future efforts to hold major emitters accountable and secure the funding and action small island nations need to adapt or survive.

It comes after decades of frustration for Pacific nations who've watched their homelands disappear. In Tuvalu, where the average elevation is just 2 metres, more than a third of the population has applied for a climate migration visa to Australia. By 2100, much of the country is projected to be under

In Nauru, the government has begun selling passports to wealthy foreigners — offering visa-free access to dozens of countries — in a bid to generate revenue for possible relocation efforts.

water at high tide.

For children in Vanuatu, climate change isn't a theory it's a classroom, or the lack of one. At Sainte Jeanne D'Arc school on Efate Island, elementary school teacher Noellina Tavi has spent two of the last three years teaching her students in tents - first after the 2023 cyclones and again following the 2024 earthquake.

With a shortage of emergency tents, her class was combined with another. Students fidget and lose focus. "It's too crowded," Tavi said. "We can't work peacefully."

When it rains, the tents turn cold and muddy. Tavi often sends students home so they don't get sick. Anytime a storm approaches, the tents must be dismantled, the furniture car ried to shelter and the children sent home. "That disrupts their education for a whole week, she said. In rural areas, ex treme weather hits something even more basic: food securi ty. On Nguna Island, farmer Kaltang Laban has watched cyclones wipe out the banana cassava and taro crops that feed his community.

Cabinet approves India-UK trade deal

India and UK are set to sign a free trade agreement. The agreement aims to boost trade between the two nations. The pact will remove taxes on some exports and imports. It also addresses issues like intellectual property rights

New Delhi. July 22: The cabinet Tuesday approved the free trade agreement between India and UK, which will be signed in London July 24, sources said. The pact, officially called as

comprehensive economic and trade agreement, will be signed during Prime Minister Narendra Modi's visit to London. Modi's four-day visit to Unit-

ed Kingdom and Maldives begins Wednesday. Commerce and Industry Minister Piyush Goyal will accompany the prime minister. The two countries an-

nounced the conclusion of the negotiations for the trade agreement May 6. The trade pact proposes to

remove taxes on the export of labour-intensive products such as leather, footwear and clothing, while making imports of whisky and cars from Britain cheaper, in a bid to double trade between the two economies to \$120 billion

The pact has chapters on issues including goods, services, innovation, government procurement, and intellectual property rights.

The text of the agreement is

generally signed by the com merce ministers from both countries. Once the free trade agreement is signed, it will require approval from the British Parliament before it can

The two countries have also concluded the negotiations for the Double Contribution Convention Agreement, or social security pact. It would help avoid double contribution to social security funds by Indian professionals working for a limited period in Britain.

However, the talks for the bilateral investment treaty (BIT) are still going on. The FTA comes into force after signing and ratification by both the countries.

In such trade agreements, two countries either eliminate or significantly reduce customs duties on maximum goods traded between them. They also ease norms for promoting trade in services and bilateral investments.

India's exports to UK rose by 12.6 per cent to \$14.5 billion, while imports grew by 2.3 per cent to \$8.6 billion in 2024-25.

The bilateral trade between India and UK increased to \$21.34 billion in 2023-24 from \$20.36 billion in 2022-23.

Resurgence of rate-cut wagers revives FDI in bonds

Mumbai, July 22: Foreign appetite for Indian government bonds is back, with inflows picking up steadily over the last month, as investors gauge fresh expectations of a rate cut by the Reserve Bank of India (RBI) as early as August.

The RBI cut rates by a larger-than-expected 50 basis points in June and changed the stance to "neutral", prompting investors to bet on a prolonged The RBI could implement a

modest 25 basis point cut in August if inflation remains subdued and growth concerns persist, said Singapore-based Manish Bhargava, CEO of Straits Investment Management, adding that bond yields are attractive at current levels.

Over the last one month, foreign investors have net bought 129 billion rupees (\$1.5 billion) of Indian bonds linked to glob al indexes after selling more than 330 billion rupees in the first two-and-a-half months of the financial year that started April 1, clearing house data showed. With recent high-frequen-

cy data disappointing and indicating the possibility of a further slowdown in growth, "there is potential for more support from the RBI further down the line," said London-based Giulia Pellegrini, lead portfolio manager, emerging market debt at AllianzGI. India's overall economic

SEBI flags cyber threats as key investor challenge PRESS TRUST OF INDIA and depositories -- along with

New Delhi, July22: With an increasing number of savers stepping into the capital markets, Security Excannge Board of India (SEBI) Whole-Time Member Ananth Narayan Tuesday highlighted that cyber threats, market volatility, and a trust deficit in the financial ecosystem could pose significant challenges to this growing investor trend. Over the years, the number

of unique investors in India's capital markets has risen sharply from 4.2 crore in March 2020 to 13 crore to date. Despite this remarkable growth, there remains considerable room for further expansion.

While acknowledging the rise of domestic investors, Narayan stressed the importance of addressing the challenges to sustain the momentum

Among these challenges, he noted that risks such as cyber risk and digital frauds are a serious concern. Fraudsters-often sophisticated and organized-- prey on unsuspecting investors, making cybersecurity a key area of focus.

Alongside this, investors



volatility, he said, emphasising that market movements are a given, and urged investors to align their portfolios with their individual risk appetites. 'We must understand and

internalise the meaning of volatility and risk better, just as we have better understood the concept of returns," he added.

Addressing an International Conference on Financial Planning, Narayan further stressed the importance of maintaining investor trust in the financial ecosystem. Trust, he pointed out, can be challenged by any episodes of "egregious governance failures or market ma nipulation".

In this regard, he acknowledged the vital role of first-line regulators -- such as exchanges Sebi and other stakeholders in upholding the integrity of the On investment strategy,

Narayan emphasised the need for diversification across asset classes. He observed that some small investors display a tendency to concentrate heavily in equities. To address this, SEBI is working to strengthen the debt and commodities markets to offer robust alternatives. He also highlighted the ne-

cessity of informed and responsible investing to ensure sustained capital formation. Registered and trained financial planners, he said, have a vital role in helping investors navigate these complexities.

The official also said SEBI is significantly scaling up its investor education and awareness initiatives. A nationwide survey covering over 90,000 households is underway to address two critical questions -- what will it take to bring more savers into the securities market, and how informed are existing and potential investors about risks, and what steps are necessary to promote responsible investing.

TPNODL upgrades transformers

Balasore, July 22: TP Northern Odisha Distribution Limited (TPNODL), a joint venture between Tata Power and the Government of Odisha, has undertaken major upgrades to its electricity infrastructure to ensure reliable and quality power supply across the region.

In the Ghatagaon area of Keonjhar district, a 100 KV transformer has been replaced with a 250 KV unit, while Vidyadharpur saw a 63 KV transformer upgraded to 100 KV. Similar efforts were made in Raghunathpur (Mayurbhanj district) and Akhuapada (Bhadrak district), where 100 KV transformers were upgraded to 250 KV.

In the Rairangpur division, the Kantabani and Uparabedha areas witnessed upgrades from 25 KV to 100 KV, and in Joda,



Keonihar, a 100 KV unit was also upgraded to 250 KV. These enhancements are meant to cater to the demands of a broader consumer base by ensuring electricity with greater voltage stability

Beyond boosting capacity, TPNODL is also prioritising safety by constructing boundary walls around previously unfenced transformers to prevent accidental contact, particularly in residential and high-traffic zones. These measures aim to enhance public safety and prevent accidents involving children and animals.



Manchester, July 22: An injury-plagued India is likely to go back to the Headingley template when it takes on a reinvigorated England in the fourth Test starting here Wednesday, hoping to end a winless record at the storied Old Trafford and draw level in what has been a compelling series so far.

Following the first Test in Leeds, India had found a settled line-up by fielding three all-rounders in the playing eleven including Nitish Reddy, who has now been ruled of the series due to a knee injury.

Pacer Akash Deep was also ruled out on the eve of the Test due to a groin injury, and captain Shubman Gill said uncapped fast bowler Anshul Kamboj is on the verge of making his debut.

With Ravindra Jadeja and Washington Sundar being the two spin bowling all-rounders, India had the cushion of batting till number eight but that may not be the case in Manchester, where the visitors are yet to win in nine attempts including four losses and five draws. England are leading 2-1 going into the penultimate game of the rubber.

Shardul Thakur, who played the series-opener, would be the direct replacement for Reddy in the playing eleven but he doesn't provide the same batting quality. If selected, he would ball too as Reddy had produced timely wickets in the third Test at Lord's.



Bangladesh clinch historic T201 series win over Pakistan

Dhaka: Bangladesh secured their maiden T20I series with a dramatic win over Pakistan. edging out the visitors by eight runs in a tense second match at a packed Sher-e-Bangla National Stadium in Dhaka Tuesday. The hosts, buoyed by a composed bowling display and a late batting charge, now hold an unassailable 2-0 lead in the three-match series. Defending 134, Bangladesh's pacers - Shoriful Islam, Mustafizur Rahman, and Tanzim Hasan Sakib - rose to the occasion with a disciplined bowling performance that rocked Pakistan's top order. The visitors crumbled to a shocking 15/5 - their lowest score after losing five wickets in a T20I within the first five overs.

Berlin: India is assured of a rare medal in tennis as Vaishnavi Adkar made it to the women's singles semifinals while most of her compatriots across disciplines failed to make a mark in the World University Games here Tuesday. The 20-year-old Vaishnavi beat home favourite Sina Herrmann 6-1 6-4 in a dominant display in the women's singles quarterfinals. She will face Eszter Meri of Slovakia in the semifinals on Thursday. She will become only the second Indian to win a medal in the World University Games, after Nandal Bal clinched a silver in men's singles in the 1979 edition in Mexico City.

Arjun, Vidit to headline Chennai **Grand Masters**

Chennai: Grandmasters Arjun Erigaisi, Vidit Gujrathi and Anish Giri will headline the third edition of Chennai Grand Masters, starting here August 6. India's most prestigious classical chess tournament will feature 20 players from across the Masters and Challengers categories. The latest edition will have a Rs one crore prize pool as competitors chase FIDE Circuit points, which are vital for qualifying for next year's Candidates Tournament.

The Wrestling Federation of India (WFI) had sought appointment July 10 but 12 days have passed and it is yet to hear a positive response from the embassy.



Explaining the visa procedure further, the website mentions that it may take more than 15 days to process the visa applications. "Applicants submitting

their visa application at a

Visa Application Centre in India other than the one in New Delhi, need to calculate 5 extra days to their minimum processing time as their visa application will first be dis patched to the GVCW New Delhi VAC for Greece, from where it will be forwarded to the Embassy of Greece - Consular Office in New Delhi the following day.
