## Mega-quake sends tsunami into Trump's 25% tariff for India coasts of Russia, Japan & Hawaii

Tokyo, July 30: One of the strongest earthquakes ever recorded struck off Russia's sparsely populated Far East early Wednesday, sending tsunami waves into Japan, Hawaii and the US West Coast. Several people were injured, but none gravely, and no major damage has been reported so far.

India's import of crude oil from Russia has risen from 0.2 per cent of total purchases before the Russia-Ukraine war to 35-40 per cent. New Delhi is the largest buyer of Russian oil after China.

#### Rupee at nadir, slides steepest in over 3 yrs

**Mumbai:** The rupee plunged 89 paise, logging its steepest singleday fall in over three years, and closed at an all-time low of 87.80 against the US dollar Wednes day after America announced a sweeping 25 per cent tariff on Indian imports in the absence of a trade deal ahead of the August 1 deadline. Forex traders said month-end dollar demand from importers and sustained foreign fund outflows also weighed on the local unit. At the end of Wednesday's trading session the local unit settled at a fresh all-time low of 87.80, down 89 paise over its previous closing price. This was rupee's steepes single-day fall since February 24. 2022 when it had lost 99 paise against the dollar.

Among India's major trade competitors, the US has imposed lower tariffs on Vietnam (20 per cent) and Malaysia (25 per cent), but higher on Bangladesh (35 per cent) and Thailand (36 per cent).

On April 2 this year, Trump announced high reciprocal tariffs on number of countries including India (26 per cent). The implementation of high tariffs was immediately suspended for 90 days till July 9 and later until August 1.





# Flood fury: CM extends free kitchen by 7 days

Bhubaneswar, July 30: Chief Minister Mohan Charan Majhi Wednesday announced extension of free kitchen facilities for flood-affected people in three districts and claimed that no lives were lost in the calamity.

Accompanied by Revenue and Disaster Management Minister Suresh Pujari, Higher Education Minister Suryabanshi Suraj, and Special Relief Commissioner (SRC) Deoranjan Kumar Singh, the CM conducted an aerial survey of submerged villages in Balasore, Bhadrak, Jajpur and Keonjhar districts.

The flood situation is completely under control, and directions have been given to start post-flood activities. Around 30,000 people of 81 villages under eight blocks of three districts -Balasore, Bhadrak and Jajpur – have been hit by the floods," the CM said.

Stating that 5,869 people from low-lying areas were evacuated, Majhi said free kitchens are currently providing two meals a day for 10,000 people.

"The free kitchen facility will be extended for seven more days from today," Majhi told reporters after his return from the aerial survey.

While 16 free kitchens have been opened in Balasore district, 10 are available in

# Govt to release Subhadra third instalment August 9

Bhubaneswar, July 30: The state government will release the third instalment of ₹5,000 financial assistance under Subhadra Yojana to over 1 crore women beneficiaries August 9 in Koraput district, Deputy Chief Minister Pravati Parida said here Wednesday.

Subhadra Yojana, an ambitious women welfare scheme of the BJP government, was launched by Prime Minister

Narendra Modi on his birthday September 17, 2024.

The scheme is designed to provide eligible women aged between 21 and 60 years with ₹50,000 over five years, from 2024-25 to 2028-29.

Each beneficiary will receive ₹10,000 annually in two instalments of ₹5,000 each — one on Rakhi Purnima and the other on International Women's Day (March 8).

This year, the Rakhi Purnima will be celebrated August 9.

This high patronage reflects strong demand among daily commuters, business travellers and tourists alike,' an official said. The enhanced capacity will

The policy will be grounded in the Odisha Hindu Religious Endowments (OHRE) Act of 1951, ensuring that reforms are legally sound and institutionally sustainable.

Minister Harichandan urged all officials to work in unison toward the vision set by the Chief Minister for the holistic upliftment of religious institutions in the state.

Key attendees included Law department Principal Secretary Manas Ranjan Barik, Endowment Commissioner Lalatendu Jena, Independent Secretary Pranab Kumar Patra, Additional Secretaries Shiba Prasad Mahapatra and Bhagaban Prasad Sahu, along with other senior officials from the Endowment Department.

Speaking as chief guest, Assembly Speaker Surama Padhy praised APV's potential to transform rural



"This is a bold, forward-thinking idea. Odisha is ready to explore its full potential," he said.

#### Man says nephew killed his daughter

Phulbani, July 30: The body of a Class V girl in Pionda area of Phulbani town in Kandhama district was found hanging at her residence, raising suspicion of a murder, allegedly by her paternal aunt's son, who was staying with the family.

Given the sensitive nature of the incident, Town police have launched a detailed investiga tion covering all possible an gles. A scientific team visited the scene Wednesday, to collect evidence and examine the cir cumstances. The accused has been sent to the Juvenile Justice Court, said the police.

Preliminary findings suggest that the girl did not die by suicide but was murdered. The victim was reportedly found hanging with a towel inside the house, but the surround ing situation indicates possible foul play. Police said the truth behind the incident will be un raveled only after receiving the post-mortem report.

According to reports, the girl was found hanging, with a towel tied around her neck, by her elder sister Tuesday evening when she returned from tuition The family members rushed her to Kandhamal district headquarters hospital, where doctors declared her dead.

Town police seized the body and registered a case. Based on the victim's father's statement, police are interrogating the complainant's nephew, a minor boy, who was staying with the family.

The complainant told reporters, "I have two daughters. After my sister's husband passed away, I brought her and her son to stay with us. However my nephew has been behav ing disrespectfully. The police will reveal more details after investigation."

### **Keonjhar DMF Trust Board reconstituted**

Keonjhar/Hatadihi, July **30:** The state government has reconstituted the trust board of Keonjhar District Mineral Foundation (DMF) after a gap of seven years. According to a notification (10611/24) issued by the Planning and Convergence department July 24, the board now comprises 31 members.

The Keonihar Collector will serve as the board's chairperson while the members include MP Ananta Navak. Rajya Sabha MPs Debashish Samantaray, Sujeet Kumar, MLAs Mohan Charan Majhi (the CM), Badri Narayan Patra, Akhil Chandra Nayak, Fakir Mohan Nayak, Abhimanyu Sethy, and Sanatan Mahakud, among others.

In a significant administrative move, the post of CEO of mained vacant since 2018, has finally been filled. IAS officer Reena Pradhan officially assumed charge as CEO Monday. Previously, the role was being handled by the chief development officer (CDO) of Keonjhar Zilla Parishad.

As per Odisha DMF rules of 2015 Schedule 4(4), the trust board is required to meet at least twice in a financial year. However, the last such meeting was held November 19, 2022, and the board had not been reconstituted since.

Concerns over alleged financial irregularities, misappropriation and mismanagement in the DMF funds had led to a case being filed in the Orissa High Court. Following this, the Planning and Convergence and the Steel and Mines departments directed the Collector to initiate the board's reconstitution.

# Jackfruit economy: Kandhamal leads the way

From raw cuts to diabetic-friendly powder, Odisha's tribal district turns jackfruit into a year-round business

Phulbani, July 30: Whether in a spicy curry or as crisp, golden chips, jackfruit has always been a seasonal delight. But that's about to change. Processed jackfruit productssuch as diced cuts, chips and powder—will now be available year-round, making it easier for households to enjoy the fruit without waiting for its natural

With the launch of packaged iackfruit cuts and chips, the hassle of chopping and cleaning has gone. Open a packet, cook, or fry, and enjoy the taste of jackfruit any time throughout

While Kandhamal is known for its turmeric and ginger, jackfruit is now emerging as a significant produce. Until recently, local farmers had not fully benefited from its commercial potential. Through the Odisha Jackfruit Mission, the district is now promoting value-added jackfruit products—such as chips, powder and curry-ready cuts—at a national level.

Considering the increasing demand, efforts are under way to scale up production commercially. This year, around 500 quintals of jackfruit will be processed. The initiative is being managed by KASAM (Kandhamal Apex Spices Association for Marketing).

Kandhamal district produces nearly 6 lakh tonne jackfruits and 9 lakh tonne mango annually. Most of this comes from wild trees in forest areas, while a smaller share is grown in orchards. However, due to the absence of cold storage and processing units, these fruits were underutilised. The government has now stepped in to

address this gap. Since last year, Odisha Jackfruit Mission has included Kandhamal, Kalahandi, Kora-

put and Dhenkanal districts under its umbrella. Backed by the State Horticulture department, a jackfruit processing unit has been set up on the premises of the Horticulture Training Institute at Kalinga in Kandhamal district. Built at a cost of Rs 2 crore, the facility includes a five-metric-tonne capacity cold

The processing unit can handle 500 kg jackfruit daily. The operations have been entrusted to KASAM, a leading local agricultural cooperative.

Trial production began last vear, and several products are now being rolled out. KASAM secretary Sanjit Kumar Pattnaik said the aim is to scale up production to meet commercial demand

Both raw and ripe jackfruits are being processed into various food products. Raw jackfruit is cut into pieces for cooking, while its core is dried and ground into a powder that is especially useful for people with diabetes.

Moreover, flour is also being produced from ripe jackfruit

However, the most popular product so far is jackfruit chips, made from semi-ripe fruit. Pattnaik noted that demand for these chips is outpacing that of potato, yam and raw bananas. The chips are being sent to markets across Odisha and beyond.

Jackfruit is sourced from across the district, and its processing is supported by Odisha Rural Development and Marketing Society (ORMAS). In addition to Phulbani, KASAM has authorised distributors in Bhubaneswar, Cuttack and Berhampur. The cooperative is also planning to expand production capacity and explore new



## New Trade Agenda

itigating the worst effects of climate change requires reconciling ambition and justice. But achieving both a just energy transition and ambitious global climate action depends on trade rules that foster equitable development. To facilitate the shift to low-carbon economies, developing countries must have reliable access to green technologies, investments, and international markets.

Regrettably, many of today's trade policies constrain developing countries' green ambitions. In particular, the securitisation of international trade – driven by the geopolitical interests of major powers and emerging blocs - threatens to disrupt global supply chains, limit access to emerging technologies, and reinforce existing power imbalances. If left unchecked, this trend risks undermining multilateral cooperation and regional integration efforts across the Global South.

The European Union's Carbon Border Adjustment Mechanism is a prime example. While the CBAM is intended to position the EU as a global leader on climate action, many developing countries - particularly in Africa – view it as a protectionist measure and question its alignment with the principles of the 2015 Paris climate agreement.

These concerns are well-founded. Research suggests that African countries could lose up to \$25 billion annually as a direct result of the CBAM, and that the proposed amendments may not always stand to benefit African exporters. Moreover, despite the establishment of the African Continental Free Trade Area (AfCFTA), the EU continues to pursue fragmented bilateral deals that undermine Africa's integration agenda and weaken the coherence of regional trade strategies.

Another example is the International Maritime Organisation's controversial plan to introduce a carbon emissions tax on shipping. Set to take effect in 2028, the tax falls far short of the more ambitious carbon levy developing economies had advocated, which could have supported low-carbon transitions, climate adaptation, and capacity-building in the world's most climate-vulnerable countries.

Investor-state dispute settlement mechanisms also present significant challenges to effective climate action. These provisions, embedded in international investment treaties, often limit African governments' ability to legislate in the public interest or implement trade and investment policies that support green industrialisation and sustainable development.

In recent years, international development practitioners have increasingly focused on the link between trade and climate policy. This signals a shift from a purely normative view of climate change to a SECURITISATION more pragmatic approach that recognises climate policy as a driver of econom- OF INTERNATIONAL

ic growth and investment. At the same time, global trade is undergoing a profound transformation as major trading powers prioritise geopolitical and economic self-interest over longstanding commitments to non-discrimination and multilateral cooperation, thereby weakening the World Trade Organisation. Against this backdrop, developed and

developing economies alike are deploying fiscal stimulus packages, subsidies, and protectionist trade measures to align their climate goals with domestic green industrial strategies, aiming to reshape the global economic order in their favour. The race to gain a competitive edge in green industries is partly driven by the dominant position China has established over the past decade through a combination of fiscal expansion, strategic subsidies, and control over critical minerals and key supply chains.

Adding to these tensions is US President Donald Trump's decision to with draw from the Paris climate agreement,

as he did during his first term. This move has further eroded global trust and undermined multilateral climate cooperation, casting doubt on the reliability of developed countries' commitments to the broader sustainable-development agenda.

Yet periods of geopolitical realignment can also create new opportunities. Even amid rising tensions and economic fragmentation, there are opportunities for African countries to advance fairer, climate-aligned trade rules. One of the most promising is increased regional integration.

Despite deep divisions within the G20. South Africa's presidency of the group this year could help advance trade policies that are better suited to managing climate risks and accelerating clean-energy transitions in the Global South. The upcoming Leaders' Summit in Johannesburg provides a platform to champion a more inclusive agenda that integrates risk management, economic diversification, and industrial development into a long-term vision of environmental justice.

Some low-income economies are particularly vulnerable to measures like the CBAM, which, in its current form, departs from the "common but differentiated responsibilities" principle that underpins the United Nations Framework Convention on Climate Change. Without careful design and implementation, it could exacerbate inequalities within Africa and jeopardize the continent's energy transition.

To prevent such an outcome, the CBAM must be implemented through a transparent, multilateral framework that acknowledges differences in countries' historical responsibility and capacity to respond. Redirecting CBAM revenues toward supporting green transitions in low-income economies, for example, would be a step in the right direction.

It is equally important to help countries that rely heavily on fossil fuels diversify their economies. This raises a fundamental question: How can trade policy be leveraged to foster climate-resilient development? The answer lies in recognising that diversification is not only central to long-term growth but also crucial to building resilience to both climate disasters and external shocks.

While global consensus on climate policies remains out of reach. regional trade agreements and coalitions offer a viable path forward. The AfCFTA, for example, could help us reimagine trade as a catalyst for inclusive development. By strengthening intra-African trade and economic resilience, it could help unlock new pathways to food sovereignty, climate adaptation, and long-term stability across the continent.

The world needs fresh thinking and more equitable relationships between the Global North and South. Although today's geopolitical landscape, marked by self-interest and weak leadership, is fraught with uncertainty, it also creates space to promote green, climate-conscious solutions that are largely absent from existing trade frameworks.

When the current turbulent period gives way to renewed cooperation, we must be ready to introduce a new climate-trade framework. Such an arrangement should support decarbonisation across industries while upholding the principles of justice and solidarity, ensuring that developing countries are actively supported on their path to a more sustainable future.

# EYE OPENING JUDGEMENT

even serial blasts ripped through Mumbai's suburban train network between 6.23 and 6.29 pm on 11 July, 2006, killing 187 people and injuring 824. The ghastly crime against a particularly soft target, the local trains that ferry more than six million ordinary people a day in India's financial centre along the city's north-south corridor, shook the nation. But a shocker of a different kind came last week, 19 years on, when a division bench of the Bombay High Court on 21 July ruled that the case in effect remains not solved and that the "true threat remains at large." The HC acquitted all 12 accused in the case, including five who had been awarded death penalty by the trial court, and recorded strong findings against the police for grossly mis-in-

vestigating the case. The division bench of Justices Anil Kilor and Shyam Chandak began the 667-page judgement with the following words, "Punishing the actual perpetrator of a crime is a concrete and essential step toward curbing criminal activities, upholding the rule of law, and ensuring the safety and security of citizens. But creating a false appearance of having solved a case by presenting that the accused have been brought to justice gives a misleading sense of resolution. This deceptive closure undermines public trust and falsely reassures society while, in reality, the true threat remains at large."

In effect, the Justices recorded that the culprits still roam free. We do not know who committed the crime. Some innocents were tortured and presented as killers, but the elaborate story did not

stand scrutiny.

The scathing remarks of the HC not only brought shame and ignominy for the investigating agencies but also raised important questions that go beyond the quality of investigations, or the capacity of the agencies and their leadership to get to the bottom of such a well-coordinated and heinous crime. While it is known that police systems are anything but perfect, that the niceties of the law and due process do get stretched, particularly in sensitive investigations, wholesale violations of the kind recorded by the HC make this case stand out as a new bottom for the State and its agencies.

The quite natural and obvious response of the State has been to move the Supreme Court in appeal. Solicitor General Tushar Mehta asked for a stay on the judgement to the extent that it would not serve as precedent before trial courts currently hearing other cases prosecuted under the Maharashtra Control of Organised Crime Act. In their order, Justices MM Sundresh and NK Singh of the SC noted that "there is no question of imprisoning" those already released after the acquittals. However, the judges ruled that "taking note of the submissions made by learned Solicitor General on the question of law, we are inclined to hold that the impugned judgment shall not be treated as a precedent in any other pending proceedings. Therefore, to that extent, there shall be a stay on the operation of the impugned judgment."

It'll be sometime before the SC weighs in on the matter. Meanwhile, there is ample material in the HC judgment to act as an eye opener; it must trigger some internal soul searching among the top brass of the administrative machinery and lead to some review of operations if there is to be any public confidence that terrorists will be brought to book. The case shows that outdated modes of investigation, including use of torture, do not help solve any crime but actually are used to push a preferred line of inquiry because the real culprits are out of reach.

The court found that con-

fessional statements did not reveal crucial aspects of the crime like: (1) in what containers the bombs were packed. (2) how were the bombs detonated, (3) what was the device used to trigger the bombs, (4) how the device got accurately activated, and most importantly, (5) who planted the bombs that exploded at Mahim and Bandra stations.

The larger picture that emerges is of a failing administration that is rapidly sliding down a very slippery slope in the absence of robust internal and external scrutiny, blind support in the name of fighting terrorism while the real terrorists go scot-free and a refusal to accept and correct mistakes. Worse, this is a secular fall. We cannot blame a particular party or government - all sail in the same boat and are a party to this collapse. Since the blasts, Maharashtra has had a total of 10 governments under various parties and dispensations, including two bouts of Central rule.

In the end, short cuts don't work. They don't serve the cause of justice. They are a disservice to the nation. This message must be sent down to the police force, right from the very top. It must be accompanied by strong action against those who violate due process. Just as some sections have raised a voice against the acquittals, there has to be a voice against those who messed up the investigation. We must work to find the real culprits and we must punish all those who violated norms and have brought us to this pass.

# Premonitions for banking sector

ndia's banking sector is facing a significant shift in household savings patterns, with Reserve Bank of India (RBI) Governor Sanjay Malhotra acknowledging that the share of savings flowing into banks has fallen from 43% to 35% over the last nine years. His predecessor Shaktikanta Das on 19 July, 2024, had flagged concerns on the widening gap between credit and deposit growth with household savings increasingly moving away from traditional deposits.

For decades, India has been a nation of savers. They stash away a significant portion of their earnings for future security, especially for emergencies at the expense of current consumption. But something seems to be amiss now. India is no longer a great savings economy.

The gross domestic saving (GDS) rate as a percentage of GDP at current market prices has declined from record high of 37.8% of GDP in 2007-08 to 32.2% in 2014-15 and further

The gross domestic saving that spurs investment and growth comprises public sec-

tor savings, corporate savings and household saving. The household savings -- comprising physical savings and net financial savings-- indicates the wellbeing of society. The household savings have declined from a peak of 25.10% in 2010-11 to 18.1% in 2023-24. The proportion of physical assets peaked at 12.9% of GDP in 2022-23, while net financial savings declined from a peak of 12.10% in 2009-10 to a 47-year low of 5.2% in 2022-23. It may decline further in 2023-24. In order to hedge against in-

flation and get higher returns. rich people, even middle-class people, are investing more in physical assets which are unproductive and inflationary. The households incur greater borrowing (or reduce net financial savings) solely to finance higher physical savings (investment). When net financial savings is declining as a proportion of GDP or gross national disposable income, all financial savings are tumbling

Household financial liabilities, which were 3.8% of GDP in 2021-22, increased to 5.9% in 2022-23 and further to 6.4% of GDP in 2023-24. While

gross household debt in India was 8% of GDP in 2010-11, it increased to 30.1% of GDP in 2017-18, and further to 42.9% of GDP at the end of June 2024. This has increased significantly after the demonetisation and GST implementation. When financial liabilities and household liabilities increase, people spend more on interest repayments leading to huge erosion in disposable income and net financial savings. When net financial savings decline, if people save more in equities, mutual funds, risky avenues for higher returns. bank deposits will automatically get pounded despite

security. As for the trend in constituents of financial savings in India, the share of public provident fund, pension funds. life insurance funds and mutual funds in the net financial savings of Indian households increased while the share of bank deposits and cash declined between 2020-21 and 2022-23, according to a report by AMFI and Crisil.

In March 2025, the finance ministry informed the Parliament that a shift in household deposits from banks to market-linked financial products in search of higher returns may expose the households to significant market risks and that they may face financial losses during market corrections or volatility due to inadequate assessment of risks and financial literacy.

Financial savings create the resources that the government uses to meet fiscal deficit, companies to establish and expand their industries, and people to buy houses, vehicles, etc. Financial savings form the foundation of investment and growth of the economy. Hence it is imperative to incentivise bank deposits by paying higher returns. Banks pay lower even negative real interest rates on deposits if inflation and tax on interest is considered. One of the reasons for paying lower interest is that banks want to compensate for the losses due to rising bank frauds and mammoth loan writes off. Hence, the government should provide more tax rebate on bank savings while exempting interest income

This marks the first evidence of Indus Valley presence in Rajasthan's deep desert, and is being seen as a vital link between known Harappan sites in northern Rajasthan and Gujarat. OF

The discovery was **INDUS** made at Raatadi Ri Dheri in the Jaisalmer district, a remote desert location nearly 60 km from Ramgarh tehsil and around 70 km from Sandhanawala in Pakistan, where Harappan remnants had previously been identified.

Archaeologists say the site adds an important dimension to the understanding of Harap pan rural networks, especially in resource-scarce desert zones that had been largely overlooked in Indus Valley studies. It also opens the possibility of more Harappan settlements buried under Rajasthan's shift-

A detailed research paper by Dr Kharkwal and Jagani has been submitted to an international peer-reviewed journal. If accepted, the site may gain global recognition as a keystone in Harappan studies.

# Kargil veteran's family harassed over nationality by Hindutva activists

Pune, July 30: The family members of a Kargil war veteran have alleged that a group of around 80 persons affiliated to a Hindutva outfit barged into their house in Pune and demanded a proof of their Indian citizenship, accusing them of being Bangladeshis.

The incident took place in Chandannagar area of the city Saturday midnight, they claimed, adding that some police personnel in plain clothes were also present at that time but they remained mute spectators.

Irshad Shaikh (48) said his elder brother Hakimuddin Shaikh, who currently resides in Uttar Pradesh's Pratapgarh, served in the Indian Army and took part in the Kargil war. He retired as a havildar from the Engineers Regiment in 2000.

'While my elder brother lives in Uttar Pradesh, I, along with my two brothers and their children, have been living in Pune's Chandannagar area for the last many decades," he said.

On Saturday midnight, around 80 people suddenly came to our house and began banging on the door. When we opened it, some of them barged in and started demanding Aadhaar cards of the family members. When we showed the documents, they termed them as fake and asked the women and children to produce Aadhaar cards, Shaikh alleged.

He said they tried to explain to the group that the family had been residing there for the last 60 years and that apart from his elder brother, two of his uncles had also served in the army. "But members of the group

were in no mood to listen. They hurled abuses and accused us of being Bangladeshis, I told them that if they want to investigate, they are welcome to do so, but barging into someone's house, hurling abuses and forcing children to show documents at midnight was not appropriate," he said.

Shaikh claimed that when the group of Hindutva activists began chanting 'Jai Shree Ram' and tried to force the family members to come to the police station, two individuals accompanying them identified themselves as policemen.



During the entire episode these two policemen in plain clothes stood by silently and did not do anything, he said.

He also alleged that when they reached the Chandannagar police station, the woman police inspector took their documents and asked them to

"After making us wait for two hours, the officer told us to visit again the next day and warned that if we fail to do so we would be declared Bangla deshi nationals," Shaikh said.

He added that they visited the police station again the next day. "We were asked not to make

an issue out of the incident and not to file any complaint. Police are now trying to pressure us and show that no one barged into our house," Shaikh, who works in the transport sector

If there were any discrepancies in the documents, the police would have taken a coercive action, he said.

"But since all our documents are genuine, they are now asking us to stay quiet,' he claimed, adding that he told the officers they could provide a proof of their Indian citizenship dating back to 400 years.

Several members of the family had served in the Indian army, Shaikh said.

"My uncle was injured in the 1971 war after a bomb explosion and was awarded for his valour. Another uncle fought alongside Abdul Hameed during the Indo-Pak War of 1965," he added.

Shaikh said they approached social activist Rahul Dambale, who helped them contact a senior police officer.

The officer assured action in the matter, but even after three to four days, no steps

have been taken, he alleged.

On July 16, the HC upheld the HPC's decision to relocate the jumbo to the Gujarat-based facility, citing an elephant's right to quality life must take precedence over humans' right to use it for religious purposes.

But the high court cited a June 2024 report about the el ephant's health, diet and nutrition, social environment, hygiene and cleanliness of shel ter, veterinary care and work schedule, and said they "appear to be absolutely dismal".

As per the report, the elephant suffered from "decubital ulcerated wounds" on its hip joints and a few other body

New Delhi, July 30: The Commissioner of Railway Safety has said that the accident of Mysuru-Darbhanga Bagmati Express at Kavaraipettai station in Southern Railway's Chennai Division October 11, 2024 was a result of sabotage as miscreants forcefully removed the components of track interlocking system.

The CRS of Southern Circle, A M Choudhary, said the probe has found that the collision between the Bagmati Express and a stabled freight train "happened not due to au tomatic/sudden failure of any equipment/assets but due to the forceful alteration in the designed position of LH (left hand) tongue rails by the mis creant(s)"

"Therefore, the accident is classified under the category 'sabotage'," the CRS said. Choudhary also praised the loco pilot of the Bagmati Express for his extraordinary presence of mind. "Loco pilot of train No 12578 had showed outstanding alertness and promptness in applying emergency brakes this reduced the speed of train and the consequent impact of the collision. His commendable action may be suitably recognized by the Railways," he said.

#### Kerala court clears two nuns. 3 others

Thrissur (Kerala), July 30: A court in Kerala has discharged five people -- two nuns from the state and three others from Jharkhand -- in a 2022 case al leging the trafficking of three underage girls for domestic work, ruling that there was no evidence of threats, coercion or exploitation.

In the July 26 order, the Court of I Additional Sessions Judge of Thrissur, K Kamanees, said that "the prosecution is not at all successful in proving a prima facie case" under Section 370 of the Indian Penal Code, which covers human trafficking. The order pointed out that there were no claims of "threats", "fraud", "deception' or "practices similar to slavery or servitude". The survivors al so stated that "no amount had been received" in exchange for their travel. "There is absolutely no recital that the girls had been transported using any threats. There is no case of committing any abduction or playing fraud/deception or by abuse or power. The main allegation is that there has been some form of coercion and that of inducement.

Under the Bihar Right To Public Service Act, people can apply online for a residence certificate, which is issued by the official concerned after due verification.

The special intensive revision of electoral rolls is said to have caused a spurt in applications for residence certificate, which is among 11 documents accepted by the Election Commission, a bone of contention before the Supreme Court, which has been of the view that more commonly available proofs of identity, like Aadhaar card and ration card, be also made admissible.



## Your conduct doesn't inspire confidence: SC to judge Varma

New Delhi, July 30: The Supreme Court Wednesday told Justice Yashwant Varma that his conduct did not inspire confidence and also defended the CJI's authority to act on any judicial misconduct saying he cannot be merely a "post office" but has certain duties to the nation.

It also asked Justice Varma, who is now a judge of the Allahabad High Court, why he chose to move the apex court after an in-house committee found him guilty of misconduct in the cash discovery row.

The top court was hearing Justice Varma's plea seeking invalidation of a report by an in-house inquiry panel which found him guilty of misconduct in the cash discovery matter. The report indicted the judge over the discovery of a huge cache of burnt cash from his official residence during his tenure as a Delhi High Court judge. The plea does not reveal Justice Varma's identity and is titled, "XXX v. The Union of India". Posing sharp questions to the judge, the top court asked Justice Varma why he appeared before the in-house inquiry committee and did not

It told Justice Varma that he should have come earlier to the apex court against the panel's report. A bench of Justices Dipankar Datta and A G Masih said the in-house process was put in place in 1999 and the chief justice of India (CJI) cannot be considered merely a post office. "The Chief Justice of India is not supposed to be a post office only. He has certain duties to the nation as the lead er of the judiciary. If material comes to him regarding mis conduct, he is only to inform the president and the Prime Minister. Nothing more."

The top court reserved its order on Justice Varma's petition challenging the in-house inqui ry procedure and the CJI's rec ommendation for his removal

As the hearing commenced, senior advocate Kapil Sibal, appearing for Justice Varma, referred to Articles 124 and 218 of the Constitution and said it lays down a complete procedure for the removal of a judge, and any parallel or extra-constitutional mechanism falls outside the framework of the Constitution

Article 124 deals with the appointment and removal of provisions to high court judges.

# Sudden braking on highway is negligence: SC

New Delhi, July 30: In a significant verdict, the Supreme Court has held that a car driver, who applies sudden brakes on a highway without any warning, can be held negligent in the event of a road accident.

A bench comprising Justices Suddhanshu Dhulia and Aravind Kumar Tuesday observed that a driver's abrupt halt in the middle of a highway, even if triggered by a personal emergency, cannot be justified if it endangers other road users.

"On a highway, high speed of vehicles is expected and if a driver intends to stop his vehicle, he has a responsibility to give a warning or signal to other vehicles moving behind on the road." Justice Dhulia. who wrote the judgement for the bench, said.



The verdict came on a plea of S Mohammed Hakim, an engineering student whose left leg had to be amputated after a road accident in Coimbatore

January 7, 2017. The incident occurred when Hakim's motorcycle collided

with the rear of a car that had

come to an unexpected stop. As a result, Hakim fell onto the road and was run over by a bus approaching from behind. The car driver had claimed that he applied brakes suddenly because his pregnant wife experienced a vomiting sensation.

# HUGE QUAKE ROCKS RUSSIA'S FAR EAST



The earthquake appeared to be the strongest recorded since the 9.0 magnitude earthquake off northeastern Japan in March 2011 that caused a massive tsunami and set off meltdowns at a nuclear power plant

Tokyo, July 30: A very powerful magnitude 8.8 earthquake off Russia's Far Eastern Kamchatka coast Wednesday triggered tsunami warnings as far away as French Polynesia and Chile, and was

followed by an eruption of the most ac-

tive volcano on the peninsula. The shallow quake damaged buildings and injured several people in the remote Russian region, while much of Japan's eastern seaboard - devastated by a 9.0 magnitude earthquake and tsunami in 2011 - was ordered to evacuate, as were parts of Hawaii.

By the evening, Japan, Hawaii and Russia had downgraded most tsunami warnings. But authorities in French Polynesia warned residents of several of the remote Marquesas Islands to move to higher ground and expect waves as high as 2.5 metres (8 feet).

Tsunami waves began hitting the Marquesas Wednesday but were forecast to be smaller than initially feared, local authorities said.

Some initial wave surges were re ported on Nuku Hiva, the largest of the Marquesas, about 1,400 km northeast of Tahiti, and between five to 10 additional waves were expected in the coming

hours, the high commission said

Russian scientists said the quake in Kamchatka was the most powerful to hit the region since 1952. The US Geological Survey said it was shallow, at a depth of 19.3 km (12 miles), and centred 119 km (74 miles) east-southeast of Petropavlovsk-Kamchatsky, a city of 165,000.

"It felt like the walls could collapse any moment. The shaking lasted continuously for at least three minutes," said Yaroslav, 25, in the city.

Kremlin spokesman Dmitry Peskov said there had been no casualties in Russia, crediting solid building construction and the smooth operation of alert systems.

In Severo-Kurilsk in the northern Kuril Islands, tsunami waves exceeded 3 metres. with the largest up to

5 metres, Russia's RIA news agency reported. A quake of magnitude 6.07 later struck the Kuril Islands that lie between Kamchatka and northern Japan, the German Research Center for Geosciences said. Tsunami waves partially flooded the

port and a fish processing plant in the town, sweeping vessels from moorings, regional officials and Russia's emergency ministry said. Verified drone footage showed the town's entire shoreline submerged, with taller buildings and some storage facilities surrounded by water.

The Klyuchevskoy volcano on Rus-

sia's Kamchatka Peninsula began erupting later, a geological monitoring service said. Located around 450 km (280 miles) north of the regional capital, Petropaylovsk-Kamchatsky, Klyuchevskoy is one of the highest volcanoes in the world.

"A descent of burning hot lava is observed on the western slope. Powerful

glow above the volcano. explosions," the Russian Academy of Sciences' United Geophysical Service said on Telegram.

#### **WAVES IN HAWAII, JAPAN**

Hawaii recorded waves of up to 1.7 metres while in Japan the largest recorded came to 1.3 metres, officials said.

Flights out of Honolulu airport resumed in the evening, the transportation department said. Waves of nearly half a metre were observed as far away as California, with smaller ones

reaching Canada's province of British Columbia. But a tsunami advisory was cancelled for coastal British Columbia as well as coastal areas of south Alaska. In French Polynesia, waves hit some

islands in the early morning hours. In other parts, wave heights were expected to remain below 30 cm, not requiring evacuation or sheltering.

While the Marquesas are high-rising volcanic islands, much of French Polynesia consists of low-lying atolls.

A contour shake map of magnitude 8.8 earthquake struck off Russia's Far Eastern Kamchatka Peninsula

Authorities in Ecuador's Galapagos Islands, some 970 km (600 miles) off South America's western coast, ordered precautionary evacuations to safe zones. Tsunami alarms sounded in coastal towns across Japan's Pacific coast and evacuation orders were issued for tens of thousands of people.

Workers evacuated the stricken Fukushima nuclear plant, where a meltdown following the 2011 tsunami caused a radioactive disaster, operator TEPCO said.

Chief Cabinet Secretary Yoshimasa Hayashi said no injuries or damage had been reported, and there were no irregularities at any nuclear plants.

Kamchatka and Russia's Far East sit on the Pacific Ring of Fire, a geologically active region that is prone to earthquakes and volcanic eruptions. The quake occurred on what is known as a "megathrust fault" where the denser Pacific Plate is sliding underneath the lighter North American Plate, according to scientists.

The Pacific Plate has been on the move, making the Kamchatka Peninsula off Russia's Far East coast especially vulnerable, and bigger aftershocks could not be ruled out, they said.

Video footage from the region's health ministry showed a team of medics in Petropavlovsk-Kamchatsky performing surgery as the quake shook their operating theatre. The medics used their hands to try to steady both the patient and their equipment, CCTV footage released by the Kamchatka region's health ministry showed.

## UN prepares aid to Sweida Thailand, Cambodia trade accusations

Damascus, July 30: The United Nations is preparing

to send a convoy of humanitarian aid to Syria's southern province of Sweida, three aid officials told Reuters, after days of bloodshed left hundreds dead and displaced an estimated 175,000 people.

The preparations began after Syria's foreign ministry granted UN aid agencies a green light to access Sweida directly, according to correspondence seen by Reuters, following three deliveries of UN aid to the province carried out by the Syrian Arab Red Crescent.

The new UN convoy will include food and other supplies, according to Marianne Ward, head of the UN's World Food Programme in Syria.

"We're organising a conent UN agencies' support, which we expect will be the beginning of blanket access" to vulnerable communities, Ward told Reuters.

# **Tariff plus penalty adds** uncertainty to exports

New Delhi, July 30: US President Donald Trump's announcement to impose a sweeping 25 per cent tariff plus penalty on India from August 1 will be a big blow to the country's exports and adds a fresh layer of uncertainty, exporters said Wednesday They said that in the absence

of clarity on the penalty's scope, Indian exporters and US importers are unable to accurately calculate landed costs or plan how to absorb the elevated tariff burden "The announcement by Trump...comes as a big blow for India. With US being one of the key export destinations, this will severely impact the sectors like gems and jewellery that are heavily dependent on exports and is one of the biggest contributors to the economy of the country," Kama Jewelry MD Colin Shah said.

The domestic gems and jewellerv industry of India has already been bearing the brunt of the prolonged geopolitical tensions between Russia-Ukraine and Middle East for almost over two years. "Going ahead, we expect trade activities to remain muted with US," he said.

US President Donald Trump Wednesday announced the imposition of a 25 per cent tariff on all goods coming from India starting August 1, plus an unspecified penalty for buying military equipment and crude

Sharing similar views, Federation of Indian Export Or-

General Aiay Sahai said US decision has added a fresh laver of uncertainty for businesses

"Exporters largely view this disruption as a temporary setback, anticipating that a comprehensive trade agreement will bring stability, correct asymmetries, and ultimately create new avenues for trade and recovery," Sahai said.

He added that this lack of predictability is disrupting supply chain planning and pricing de-

Mumbai-based exporter and founder chairman of Technocraft Industries India Sharad Kumar Saraf said that this announcement will create further uncertainty. "We need stability in these tariffs."

India's goods exports to US rose by 23.53 per cent to \$8.3 billion in June while imports dipped by 10.61 per cent to about \$4 billion during the month, according to the commerce ministry data.

During April-June, the country's exports to US increased by 22.18 per cent to \$25.51 billion. while imports rose 11.68 per cent to USD 12.86 billion, the

data showed. US was the largest trading partner of India in the April-June quarter of 2025-26

In 2024, India's main exports to US included drug formulations and biologicals (\$8.1 billion), telecom instruments (\$6.5) billion), precious and semi-precious stones (\$5.3 billion), petroleum products (\$4.1 billion), vehicle and auto components (\$2.8 billion), gold and other precious metal jewellery (\$3.2) billion), ready-made garments of cotton, including accessories (\$2.8 billion), and products of iron and steel (\$2.7 billion).

Imports included crude oil (\$4.5 billion), petroleum products (\$3.6 billion), coal, coke (\$3.4 billion), cut and polished diamonds (\$2.6 billion), electric machinery (\$1.4 billion), aircraft, spacecraft and parts (\$1.3 billion), and gold (\$1.3 billion).

### Rupee slides steepest in over three years

Mumbai, July 30: The rupee plunged 89 paise, logging its steepest single-day fall in over three years, and closed at an all-time low of 87.80 against US dollar Wednesday after America announced a sweeping 25 per cent tariff on Indian imports in the absence of a trade deal ahead of August 1 deadline.

Forex traders said month-end dollar demand from importers and sustained foreign fund outflows also weighed on the local unit. At the interbank foreign exchange, the domestic unit opened at 87.10 and touched an intra-day low of 87.05 against the greenback. At the end of Wednesday's

trading session, the local unit settled at a fresh all-time low of 87.80, down 89 paise over its previous closing price. This was rupee's steepest single-day fall since February 24, 2022 when it had lost 99 paise against the dollar. Tuesday, the rupee declined

to an over four-month low and closed 21 paise weaker at 86.91 against US dollar.

Anuj Choudhary, Research

Analyst at Mirae Asset Sharekhan, said, "We expect the rupee to slide further amid uncertainty over the trade dea between India and the US. Ris ing global oil prices and foreign outflows may also keep the ru pee under the leash.

## SEBI bans Gensol, Jaggi brothers

New Delhi, July 30: Security Exchange Board of India (SEBI) Wednesday upheld its interim order restraining Gensol Engineering and its former top executives Anmol Singh Jaggi and Puneet Singh Jaggi from the securities markets on concerns over fund diversion and corporate governance failures.

Additionally, the regulator said Jaggi brothers, also co-founders of EV ride-hailing firm BluSmart Mobikity, would continue to be debarred from holding the position of a director or key managerial personnel in Gensol.

The final order comes as the company undergoes insolvency proceedings under the supervision of a court-appointed professional.

The brothers have been accused by SEBI of siphoning off loan funds from their publicly-listed company Gensol for personal use, raising concerns over corporate governance and financial misconduct.

The order stated that the prima facie findings of misappropriation of funds and falsification of conduct letters to



CRAs -- initially highlighted in its April 2025 interim orderremain unrebutted by the company's promoters.

... prima facie findings regarding diversion mis-utilisation of funds of Gensol have not been successfully rebutted by Noticees. I also note that a detailed investigation into this matter is being carried out. Further, a forensic auditor has already been appointed to examine the books of accounts of Gensol and its related parties.

"The concrete findings of the investigation and the forensic auditor are yet to emerge. The

findings of the forensic audit will serve to corroborate the factual position and provide greater clarity on the matters under scrutiny," SEBI Whole Time Member Kamlesh C Varshney said in his order.

The board further said it finds no reason to lift or modify the restrictions imposed earlier and accordingly confirmed the directions of its interim order

However, it clarified that the directions concerning Gensol will remain subject to any further orders from the competent tribunal or court overseeing the insolvency process.

London, July 30: India's prospects of signing off the UK tour with some serious bragging rights brightened by a few notches on the eve of fifth Test with England's talismanic skipper Ben Stokes and pacer Jofra Archer rendered unavailable for the game starting Thursday.

Stokes, the inspirational skipper who pushed the limits of his body while bowling in the last two Tests was ruled out with a muscle tear on his right shoulder while comeback man Archer was rested after the workload of playing in back-to-back matches.

Pacer Brydon Carse and left-arm spinner Liam Dawson have also been rested.

Birmingham, July 30: India have refused to play against arch-rivals Pakistan in the semifinals of the World Championship of Legends here Thursday, citing the nation's stand against any bilateral sporting ties with the neighbouring country after the gruesome Pahalagam terror attack.

The Indian team which includes legends like Shikhar Dhawan, Irfan Pathan, Harbhajan Singh, Yuvraj Singh, Suresh Raina among others have already expressed their unwillingness to play against Pakistan following the terror attack and the subsequent 'Operation Sindoor' launched by India.

India took a similar stand like they did in the group-stage match against Pakistan earlier in the tournament.

In that game, several top former India cricketers had refused to play against Pakistan in the aftermath of Operation Sindoor. India were set to play Pa-

kistan in the semi-final of the tournament Thursday at the Edgbaston Cricket Ground.

Peshawar, July 30: German double Olympic biathlon champion Laura Dahlmeier has died after a mountaineering accident in Pakistan, her management and local authorities confirmed Wednesday.

The accident occurred around noon Monday, at an altitude of approximately 5,700 metres at Laila Peak,

the Alpine Club of Pakistan said Tuesday. Dahlmeier was climbing

with her mountaineering partner when she was struck by a sudden rockfall in the Hushe Valley, part of the northern Gilgit-Baltistan region. Poor weather conditions prevented a rescue helicopter from reaching the site

Two teams of expert climbers from Germany and the United States



deployed to search her confirmed that she had died, regional government spokesperson Faizullah Farag said.

"Laura Dahlmeier died on 28 July in a mountain ac cident on Laila Peak (6,069 metres) in Pakistan's Kara koram range," her manage ment said in a statement.

"A recovery operation was launched but ultimate ly called off on the evening of 29 July.'

Her representatives added that Dahlmeier most likely died instantly, while her mountaineering partner was unharmed.
