Odia mandatory on shop signboards

Bhubaneswar: The state government Wednesday made it mandatory for all shops and commercial establishments in urban areas to prominently display signboards in the Odia language. The direction was issued by Housing & Urban Development department Principal Secretary Usha Padhee for businesses under the jurisdiction of municipal corporations, municipalities, and notified area councils. It said that the order aligns with the state government's commitment to uphold the Odia language in public spaces and make signage more accessible to citizens, especially those unfamiliar with other languages or scripts.

CBSE: Strictly adhere to 75 pc attendance

New Delhi: The Central Board of Secondary Education (CBSE) has warned schools to strictly adhere to the 75 per cent attendance requirement for students appearing for board exams, according to officials. According to the CBSE Examination Bye Laws, a minimum of 75 per cent attendance is mandatory for students to be eligible to appear for the board examinations. The CBSE offers a 25 per cent relaxation only in cases of exigencies such as medical emergencies, participation in national or international sports events, and other serious reasons, if supported by the necessary documents or record.

Washington/New August 6: US President Donald Trump Wednesday slapped an additional 25 per cent tariff, raising it to 50 per cent, on goods coming from India as penalty for New Delhi's continued purchase of Russian oil, a move that is likely to hit sectors such as textiles, marine and leather exports hard.

The United States has imposed this additional tariff or penalty for Russian imports only on India while other buyers such as China and Turkey have so far escaped such measures. The 30 per cent tariff on China and 15 per cent on Turkey is lower than India's 50 per cent.

Reacting to the development, India said that these actions are unfair, unjustified and unreasonable. It is extremely unfortunate that the US should choose to impose additional tariffs on India, the External Affairs Ministry said in a statement, adding India will take all actions necessary to protect its national interests.



Trump signed an executive order - Addressing Threats to the US by the Government of the Russian Federation - imposing the additional tariff over and above the 25 per cent levy which comes into effect from August 7. After this order, the total tariff on Indian goods, barring a small exemption list, will be 50 per cent.

'The ad valorem duty imposed shall be in addition to any other duties, fees, taxes, exactions, and charges applicable to such imports," the order said.

While the initial duty becomes effective August 7, the additional levy will come into effect after 21 days or August 27. After the new levy, India will

Kendrapara, August 6: A female college student died after she allegedly immolated herself at her house in Kendrapara district Wednesday following her former boyfriend's threat to upload her intimate photographs on social media, police said.

The woman's father claimed that his daughter took the extreme step after police refused to accept their FIR around six months ago, and instead asked them to block the ex-boyfriend's phone number. Kendrapara SP Siddharth Kataria said he will personally probe the allegation.

This was the third incident of a woman dying of burn injuries in Odisha since July 12.

The fresh incident took place in Kathiapada village in Pattamundai (Rural) police station area Wednesday morning.

The father of the 19-year-old woman claimed she poured kerosene over herself and set herself ablaze when she was alone in their house. He said they opened the door of their house to find their daughter's charred body lying on the staircase.

She was an undergraduate student at Mohanpur College located near her village. Her former boyfriend was black mailing her, the woman's father alleged. "Had prompt action been taken, my daughter would not have died by suicide," he claimed.

Sailendra Palei, however, denied the allegation.

"I did not receive any FIR, and the woman's father had never come to our police station. I never suggested anyone to block any phone number," he claimed.

SP Kataria, who reached the spot, told reporters, "The woman's father claimed that she died by suicide. The matter will be investigated. I will also personally inquire into the fa

PM likely to visit **China this month** after 7-year gap

New Delhi, August 6: After a gap of over seven years. Prime Minister Narendra Modi is ex pected to travel to China later this month to attend the annual summit of the Shanghai Cooperation Organisation (SCO), people familiar with the matter said Wednesday.

According to the plan, Prime Minister Modi will embark on a visit to Japan around August 29 and after concluding the trip, he will travel to the northern Chinese city of Tianiin for the SCO summit to be held August 31-September 1. Modi's visit to China is be-

ing planned amid efforts by the two sides to repair their bilateral ties which came under severe strain following the deadly clashes between Indian and Chinese troops in Galwan Valley in June 2020.

There is no official confirmation yet on Modi's two-nation visit to Japan and China. The visit is likely to take place from

August 29 to September 1. Modi last visited China in June, 2018 to attend the SCO sum mit. Chinese President Xi Jinping visited India in October 2019 for

the second "informal summit". However, the relationship came under stress due to the eastern Ladakh border face-off and clashes at Galwan valley in

May-June, 2020.

New Delhi, August 6: In a groundbreaking move that signals a fundamental shift in management education, the Indian Institute of Management (IIM) Ranchi has announced the complete replacement of traditional hall-based mid-term examinations with AI-integrated business problem-solving projects across all courses.



According to officials, the initiative, termed WAI (Working with AI), represents a radical departure from conventional assessment methods and positions the institution at the forefront of pedagogical innovation.

"We recognised that the traditional model of isolated theoretical learning was becoming increasingly disconnected from the dynamic needs of modern business," said Deepak Srivas tava, Director, IIM Ranchi.

"Our students needed to de velop competencies that go beyond textbook knowledge - they need to work collaboratively with emerging technologies to solve complex business challenges," he added.

Srivastava explained that the WAI initiative reflects a sophisticated understanding of how artificial intelligence is reshaping the business landscape.

"Rather than viewing AI as a disruptive force to be managed

it as a fundamental component of business education. Students are now required to demonstrate their ability to work alongside AI systems to develop innovative solutions for real business problems," he said. This approach addresses

a critical gap in traditional management education, where students often graduate with theoretical knowledge but lack practical experience in human-AI collaboration - a skill increasingly essential in today's workplace. The initiative goes beyond simply learning about AI to actually working with AI as a collaborative partner in problem-solving processes, he said.







The Chief Minister also urged the Union Minister to increase the monthly lifting of rice by the Food Corporation of India (FCI) as it would help ensure its smooth and timely evacuation from state godowns. Emphasising the state's commitment to food security and farmer welfare, Majhi informed the Union Minister about the Odisha government's proactive steps like promotion of millets, expansion of storage infrastructure, and many policy measures aimed at strengthening the agri-food ecosystem.

"Highlighted the Odisha Government's proactive measures, including promotion of millets and expansion of storage infrastructure, aimed at strengthening food security and safeguarding farmers' interests," the Chief Minister said. The meeting assumes significance as Odisha prepares for a bumper paddy crop, and the state government looks to ensure adequate procurement and distribution mechanisms are in place ahead of the harvest season.

As per the official sources, currently, 27LMT of rice is sumption. But this year, a total of 93LMT of paddy has been produced in the state, including Kharif and Rabi paddy.

"Out of this, an average of 63LMT of rice will be produced, which is much more than the demand of the state. The state government had also earlier raised the issue regarding the slow pace of FCI's procurement process in Odis-

A bench comprising Chief Justice BR Gavai and Justices K Vinod Chandran and NV Anjaria took note of the submissions of advocate Gaurav Kumar Bansal while also asking the response of a central empowered committee.

Bansal sought quashing of the no-objection certificates (NOCs) granted by district Collectors of Angul, Nayagarh, Boudh and Cuttack for the construction and development activities in and around the tiger reserve.

His plea alleged unchecked expansion of tourism infrastructure and other proposed constructions in the ecologically-sensitive tiger reserve.

The petitioner also questioned the legality of directions issued by the district Collectors, pointing out the provisional NOCs were granted without iurisdiction and in violation of the Wildlife (Protection) Act, 1972, besides forest and envi-

ronmental laws. "The district Collector has issued such permissions for construction of an eco-tourism spot. How can this be permitted." Bansal asked.

The STR, spread across the districts of Angul, Cuttack, Nayagarh and Boudh in Odi-

sha, is a crucial habitat for tigers, elephants, and several endangered species

The National Tiger Conservation Authority (NTCA), the plea said, in April 2018 directed all states for mandatory delineation of eco-sensitive zones (ESZs) around tiger reserves.

There directions were stated to have clearly stipulated a demarcation of a minimum of a kilometre of ESZ encompassing a protected area, whenever it formed part of the buffer.

There are multiple large scale and systemic issues affecting the ecological and legal integrity of STR, which require independent attention and urgent consideration of this court,

In line with the NTCA's April 2018 direction, the petitioner said, the Odisha government recently submitted a draft proposal for declaration of ESZ around STR to the Ministry of Environment, Forest and Climate Change for final notification.

However, the said draft, if approved in its current form, will seriously compromise the ecological integrity and conservation dignity of the tiger reserve, it alleged.

The proposed tourism-centric development activities in and around the tiger reserve, including the construction of high-impact infrastructure and grant of arbitrary NOCs were said to be contrary to the precautionary principle and vi olate the statutory framework under the Wildlife (Protection) Act, 1972, the Forest (Conserva tion) Act. 1980, and the Environment (Protection) Act, 1986.

The zero-kilometre ESZ boundary proposed in parts of STR violates NTCA's 2018 directive, which mandates a minimum one km buffer from core tiger habitat wherever the buffer is absent or disjunct, the

plea added.

It claimed the issuance of no objection certificates by district Collectors and non-forest authorities for tourism infra structure within and around a notified tiger reserve constituted an unlawful usurpation of statutory powers reserved for designated authorities under the Wildlife (Protection) Act and violate the binding direc tives of the apex court.

The plea alleged the actions of state government and its agencies exhibited a deliberate pattern of undermining central environmental regulations through procedural shortcuts and executive overreach, including attempts to modify ESZ notifications to dilute their protective scope for commercial tourism purposes

It also sought a direction to the state to withdraw the draft ESZ proposal relating to STR.

NGT orders demolition of illegal Chilika jetty

Khurda, August 6: The National Green Tribunal (NGT) has directed Khurda Collector to immediately stop the unauthorised construction of a concrete jetty at Gadadwara of Chilika Lake by Vikash Eco Resort Private Limited. The environment watchdog has also ordered the Collector to ensure demolition of the illegal jetty and restoration of the site to its original condition.

Observing that the construction violated Coastal Regulation Zone (CRZ) norms and caused environmental damwaste into ecologically-sensitive Chilika Lake, the NGT has asked the district Collector to initiate criminal proceedings under the Environment Pro-

tection Act. Both Chilika Development Authority (CDA) and Vikash Eco Resort Private Limited have been asked to submit a de-

tailed report within four weeks. The illegal construction came to light after Maa Kalijai Motor Boat Workers' Union lodged complaints first with the local tehsildar and later with the

district Collector, opposing the

construction in the ecological-

With no response from authorities, the union filed a writ petition with the NGT, which took cognizance of the matter and delivered its order August 1.

For decades, the government had allowed traditional fisherfolk to operate in Chilika. Though the practice was halted in 2017, the fisherfolk who depend on boats for both fishing and tourism have long demanded a jetty for their livelihood. However, authorities have reportedly shown little interest. Despite the absence of official approval, Vikash Eco constructing a concrete jetty within the lake—an area falling under the CRZ as demarcated by the Forest and Environment department. The area is protected under CRZ notifications, and enforcement of these rules lies with the district-level CRZ monitoring committee, headed by the Collector.

However, despite multiple complaints and wide media coverage since April 24, the Collector's office failed to take any action against the illegal construction.

ADB to extend technical assistance for urban devpt

"We will open dedicated centres for breastfeeding in public places. In the railway stations, a lady attendant will be deployed at the breastfeeding centre so that lactating mothers can breastfeed their babies in a women-friendly atmosphere," Parida told mediapersons after gracing the state-level celebration of World Breastfeeding Week

2025 here. Parida, who is in charge of Women and Child Development department, said there is an emotional and physical bond between mother and



child. Breastfeeding brings the child closer to the mother's heart, she said.

She stressed the significant health benefits of breastfeeding, both for mothers and infants, including reduced risks

in women and improved mental well-being for both during the first six months of exclu-

sive breastfeeding.

Parida called upon all stakeholders to increase the rate of breastfeeding centres across Odisha and encouraged collective societal responsibility in promoting breastfeeding.

Mandatory for shops to display signboards in Odia

Bhubaneswar, August 6: The state government Wednesday made it mandatory for all shops and commercial establishments in urban areas to prominently display signboards in the Odia language.

The direction was issued by Housing and Urban Development (H&UD) department Principal Secretary Usha Padhee for businesses under the jurisdiction of municipal corporations, municipalities, and notified area councils.

It said that the order aligns with the state government's commitment to uphold the Odia language in public spaces and make signage more accessible to citizens, especially those unfamiliar with other languages or scripts.

The directive said that all shops and commercial establishments across the urban areas must ensure that the Odia script occupies at least 60 per cent of the total area of

their signboards. "This will help reinforce the visibility

and importance of the state's official language," it said. "To encourage adherence,

compliant establishments will be eligible for a five per cent discount on the renew al fee of their trade license, the order stated. Urban local bodies were instructed to verify compliance during trade license renewals and inspections, which must be complet ed by September 30 this year Non-compliant establishments will receive a formal notice and will be given 55 days to rectify the signage, it said.

A penalty of Rs 500 per day will be imposed on continued non-compliance beyond the grace period. Besides, all municipal corporations municipalities, and notified area councils were directed to conduct awareness drives to inform shopkeepers about the new norms and extend necessary support for implementation.

Trade unions oppose night shifts for women

Bhubaneswar, August 6: Central Trade Unions staged a protest Wednesday in front of the Labour Commissioner's office, strongly opposing the Odisha government's recent notification permitting women to work night shifts in shops and commercial establishments.

In a joint statement, representatives of major unions including INTUC, AITUC,

CITU, HMS, AICCTU, TUCC, and LPF — criticised the lack of consultation before the policy change. They accused the Labour and Employees State Insurance Department of bypassing trade unions in the decision-making process. thereby violating principles of tripartism and collective bargaining.

While the notification includes safety measures such as mandatory written consent, GPS-enabled transport,

and compliance with anti-harassment laws, unions argue that implementation remains questionable. Citing past incidents from other states, they warned the move could expose women to greater risks and exploitation, particularly in unorganised sectors like hospitality and BPOs.

The unions also voiced concerns over night shifts' impact on women's health and work-life balance, arguing that provisions like eight hours of rest between shifts may be inadequate. They demanded the notification's immediate suspension and called for thorough assessments with trade union involvement.

Reaffirming their commitment to women's employment rights, the unions urged a meeting with the Labour Commissioner to ensure future labour reforms are developed through democratic inclusive, dialogue.

Angul railway station 'Safe campuses need collective ownership'

Event on sensitisation programme marks the launch of the Nationwide Campaign for Safe Campuses in Higher Educational Institutions

Bhubaneswar, August 6: Building safe campuses requires not just robust mechanisms, but also collective ownership, ongoing sensitisation, and active engagement from all $stakeholders -- from \ students$ to university leadership and the surrounding community, said Dr Rajesh Tandon, UNE-SCO Co-Chair on Community-Based Research and Social Responsibility in Higher Education. While progressive laws are in place, their true impact is realised only when institutions and individuals internalise and act upon them, he emphasised.

Dr Tandon was speaking at a sensitisation programme on "Empowering Campus: Safety, Security and Inclusivity", organised by the Centre for Youth and Social Development (CYSD) in collaboration with the Martha Farrell Foundation (MFF), UNFPA, UNESCO, and PRIA. The event, held Wednesday, also marked the launch of the Nationwide Campaign for Safe Campuses in Higher Educational Institutions — an MFF initiative in partnership with the Association of Indian



Universities.

The event highlighted the urgent need to ensure students' physical, emotional, and psychological safety — particularly for women - as Odisha experiences significant social and demographic changes. "With over 2,500 colleges and nearly 12lakh post-secondary students, half of them women, Odisha has a unique opportunity to lead in building gender-just campuses," Dr. Tandon said.

He stressed that members of the academic community have both a moral and institutional duty to initiate change within their own campuses, then extend those efforts outward to

foster a broader culture of collective responsibility

Jagadananda, mentor and co-founder of CYSD, stressed that building safe and inclusive campuses requires more than awareness — it demands a shared understanding among stakeholders of the structural issues tied to gender justice. Aligning institutional goals with the lived realities of students and faculty, he noted, is key to turning dialogue into meaningful and

lasting action. Dr Nadeem Noor, state head of UNFPA Odisha, noted that the concept of safety and security has evolved beyond mere


physical protection to include mental, emotional, social, and digital well-being — a shift from its traditional focus on physical threats and law-andorder concerns.

The global and national shifts from demographic changes to technological advances, economic restructuring, and climate impacts — require campuses to adopt an inclusive, future-ready approach to safety, well-being, and gender justice, Dr Noor added.

Rukmani Panda, state head of Breakthrough, stressed the need to integrate gender justice into the curriculum. Pra mila Swain, state convener of NAWO, underscored the importance of challenging and transforming deeply entrenched gender norms, while Biraj Patnaik of PCI India highlighted that achieving gender justice requires systemic change.

The programme united faculty, students, gender focal points, civil society leaders, experts, and volunteers from 17 universities across the state to pledge collective action for fostering gender-sensitive cultures in higher education institutions

TWO SCHOOLS, ONE VILLAGE

Schools in Kotia panchayat host rival education systems



Pottangi, August 6: In an unusual situation highlighting the challenges in border regions, Dhulipadar village in Kotia panchayat under this block of Koraput district is home to two primary schools belonging to two different states, a report said. One of the schools is run by the state government and the other by neighbouring Andhra Pradesh.

Both schools are functioning simultaneously, imparting education to children in the village. While education is considered the cornerstone of social progress, the divided administrative control has left villagers uncertain about the direction of their children's future.

In Dhulipadar, the state government runs a primary school having facility for teaching from Class-I to Class-V. The school has 17 students on its roll and two teachers appointed to teach the children. Although a new school building has been constructed, it has not vet been handed over for use due to some pending construction works. As a result, the students continue to study in a makeshift and di-

Just a short distance away, Andhra Pradesh government operates a rival primary school. It has comparatively better infrastructure, including facilities for handwashing and classroom learning. The school currently has a strength of 24 students having classes from I to IV.

The coexistence of two different educational systems in one village underscores the lingering administrative conflict between Odisha and Andhra Pradesh over the disputed Kotia region. The impact is most evident in the classrooms—where young learners are caught between two states and two futures.

Subarnapur's natural-dyed sarees revive handloom heritage

Sonepur, August 6: The demand for naturally dyed cotton sarees from Subarnapur and Boudh districts is surging, driven by their eco-friendly appeal and durability. These sarees, crafted with organic

dyes, are gaining popularity in major cities like Cuttack, Bhubaneswar, Mumbai, Bangalore, Chennai, Delhi, and Kolkata, commanding prices range from ₹5,000 to ₹10,000 higher than their chemically dyed counter-

Derived from natural sources such as flowers, fruits, tree bark, and seeds, these dyes ensure sarees are skin-friendly, allergen-free, and long-lasting, retaining vibrancy for years. "These sarees don't cause skin issues and stay intact for a long time," said Prafulla Meher, a 63-yearold master weaver from Subarnapur's Gokarneswar Pada. "Their quality is driving market growth.

Subarnapur's handloom industry, renowned for its intricate Bandha art,



holds a prominent place in the global textile market. The shift to cheaper synthetic dves in the 1960s nearly erased the labour-intensive tradition of natural dyeing, which uses materials like harida, pomegranate, manjistha, turmeric, jaggery, iron, palash flowers, tea leaves, marigold flowers, aparajita, jamun tree bark. khair, jackfruit wood, henna, tulsi, jhapada seeds, and lac.

Meher, a national award-winning weaver, has been reviving this tradition since 1991. Born into a weaving family in Birmaharajpur of Subarnapur district, he joined Odisha's Handloom and Textile Department,

earning the National Merit Award in 1992. After his retirement, he established workshops in Subarnapur's Patabhadi and Boudh's Basudevpali, employing over 100 families and providing training to new weavers.

Meher has developed 65 distinct natural dve shades, creating eco-friendly. lightweight, and soft sarees that remain comfortable even in 45-degree Celsius heat. His acclaimed designs, including the "Ganit" (mathematics) and "Ashtanayika" sarees, have earned national and state recognition, with the latter receiving a Merit Award. Under his guidance, 19 Sonepur weavers have received prestigious awards. His sarees, priced between ₹20,000 and ₹80,000, reflect the meticulous dyeing and weaving process.

"Natural-dyed sarees eco-friendly, lightweight, and retain their color no matter how often they're washed," Meher said. With growing consumer interest in organic products, these sarees blend heritage with sustainability, meeting the demands of a discerning market.

Reports of extrajudicial killings and torture in custody have become

Buddhists, Christians, Hindus, tribal communities, and members of Islamic sects that Islamists consider heretical are being attacked with impunity. Women dressed "immodestly" face public shaming and assault. A culture of Taliban-style moral policing is rapidly taking root. The situation has gotten so bad that even the pro-regime Bangladesh Nationalist Party, long the Awami League's arch-rival, has decried the erosion of basic freedoms, the "madness that erupted in the name of religion," and the "terrifying violence" on the streets.

mocracy is not just in holding elections but in maintaining a dignified and constructive political discourse. The recent controversy involving US President Donald Trump's remark that the Indian economy is "dead," and the public endorsement of this statement by Leader of the Opposition Rahul Gandhi has caused discomfort among many intellectuals and citizens. While it is entirely legitimate to criticise the ruling government and its economic policies, equating a political critique with a sweeping condemnation of the entire nation is both irresponsible and detrimental to India's global image.

Criticism of the government is a fundamental part of democratic functioning. The Opposition has every right—and indeed the duty-to question economic mismanagement. policy failures, and governance lapses. But such criticism must be aimed at the ruling party or administration, not the country itself. A responsible leader, especially one who aspires to govern the nation, must make a clear distinction between condemning the government and maligning the country. When a foreign leader mocks our economy and an Indian leader echoes the remark without nuance or context, it appears as a betrayal of national interest. Patriotism does not mean silence on failures, but it demands loyalty to the truth and sensitivity to the country's dignity.

India's economy may be facing challenges, but it is far from dead. Despite global headwinds like the COVID-19 pandemic, geopolitical disruptions, and inflationary pressures, India remains the world's fifth-largest economy in terms of nominal GDP, with a GDP of \$3.73 trillion as of 2024, ahead of the UK and just behind Germany. The International Monetary Fund (IMF) projects India's GDP growth rate at 6.8% in 2025, making it the fastest-growing

major economy in the world. Even though this growth is not evenly distributed, and income inequality and rural distress persist, the economic fundamentals are not in collapse.

Yes, there are issues such as unemployment, a stressed agriculture sector, a widening fiscal deficit, and inflation affecting the common man. As per the Centre for Monitoring Indian Economy (CMIE), unemployment rate in India hovered around 7.5% in mid-2025, with youth unemployment in urban areas surpassing 20%. Consumer inflation, though moderated in recent months, still remains a concern, with food inflation in June 2025 recorded at over 8.2% vear-on-vear. The fiscal deficit of the central government for FY25 stood at 5.9% of GDP, with mounting interest payments constraining public investment. But these require collaborative national resolve, not theatrical blame game. Constructive criticism should always be accompanied by constructive solutions. And in a country like India, with its complexity and diversity, economic revival cannot be engineered by one party alone.

The role of the Opposition is not just to oppose, but to propose meaningful alternatives, expose governance flaws with evidence, and offer a credible vision for national growth.

It should come forward with shadow budgets, policy blueprints, and economic roadmaps. Parliament must be used as a forum for intelligent debate rather than a battleground of loud rhetoric. Leaders must offer their economic vision, suggest reforms, and support the government in national matters like defence, health, and educa-

tion where unity is vital A responsible Opposition can help shape fiscal prudence, question wasteful expenditure, and press for transparency. For instance, while the government claims significant infrastructure growth through schemes like PM Gati Shakti and Bharatmala, the Opposition must ask how these projects are being funded and whether they create inclusive growth. Similarly, while the Production-Linked Incentive (PLI) schemes in sectors like electronics and semiconductors are yielding results, the Opposition must demand better accountability and more domestic job creation from these capital-heavy investments.

However, the responsibility does not lie with the Opposition alone. The government must also foster a culture of openness and accountability. Every criticism must not be dismissed as anti-national. A self-assured government must treat dissent as a tool for improvement. Transparency

ment of policy shortcomings, and genuine federal cooperation with states—irrespective of their political colour—are crucial to restoring economic momentum and public trust.

The government must also recognise that headlines don't drive growth; structural reforms do. The banking sector, for instance, continues to suffer from high levels of non-performing assets (NPAs). As per the RBI's latest Financial Stability Report (June 2025), gross NPAs in banking sector stood at 4.3%, with public sector banks still bearing the highest burden. Reforms in labour laws, now consolidated into four Labour Codes, remain unevenly implemented across states. Agricultural reforms, too, remain half-hearted, particularly after the repeal of the three controversial farm laws without a structured alternative.

In terms of human capital development, India still spends less than 3% of its GDP on health and around 3.1% on education-far below OECD standards. A country with over 600 million people below the age of 30 cannot afford to under-invest in skill development and higher education if it aims to become a knowledge and manufacturing powerhouse. Vocational training, digital access, research innovation, and public health infrastructure need massive public-private coordination backed by political will.

This moment calls for political maturity across the board. Name-calling and blame-trading must give way to sincere dialogue and shared responsibility. In matters of the economy, national dignity should never be compromised for political gain. Leaders must remember that their words, especially when amplified on global platforms, have real-world consequences. Governments rise and fall. Parties win and lose. But India remains.

The rise and the fall of Indo-US ties

THE SO-CALLED BIPARTISAN SUPPORT FOR INDIA AS A STRATEGIC PARTNER IS A MYTH. IT IS **DRIVEN ENTIRELY BY AMERICAN ECONOMIC INTERESTS**

fter failing to bully China through unfair trade and tariff measures, the US led Donald Trump is now attempting to pressure India by imposing various measures aimed at weakening its economy. These actions also threaten India's independent foreign policy, as the US seeks to undermine India for refusing to fall in line with its imperialist strategies of global dominance that envision India as a junior partner. The history of India-US relations shows that the US has consistently acted against India's national interests. It has never been a truly committed friend of India-or of any other country, for that matter. Instead, it uses other nations as tools to sustain its declining hegemony in global affairs.

From the first decade of independent India to the present day, the US has continued to pursue Cold War-era imperialist politics in Asia, using terrorism and Pakistan as proxies to disrupt peace and progress in the region, while seeking to contain India's independent and non-aligned foreign policy. From the 1962 Sino-Indian

War to the formation of the QUAD, the US has repeatedly devised strategies to build alliances with India—primarily to counter China. The 123 US. India Civil Nuclear Agreement is structured in a way that primarily serves to revive the struggling nuclear industry in the US, offering India little in terms of meeting its clean energy needs. During the 1970s. 1980s, and 1990s American technological embargoes, trade restrictions, and other sanctions were aimed at pressuring India to open its markets on American terms. Over the decades, American leadership has consistently sought to woo Indian policymakers into granting greater access to American companies. However, such moves risk undermining India's industrial and agricultural productivity, weakening its economy, and jeopardising the country's food security.

India-US relations were relatively warmer during the presidencies of Bill Clinton, George W. Bush, Barack Obama and Joe Biden, who viewed India as a strategic partner—though cooperation remained conditional, with underlying tensions over India's independent foreign policy, its close ties with Russia, and differing approaches to the containment of China. The Trump administration is essentially continuing the legacy of the long-standing American approach toward India, imposing higher tariffs, introducing trade restrictions, and pursuing political realignments that aim to weaken India's progress. It would be naïve to believe otherwise regarding the direction of the American approach toward India and Indians. Therefore, India and its people must revive the spirit of their secular, anti-imperialist anti-colonial, and anti-capital ist politics to resist American hegemony and expose its nefarious strategies for the region and the world. India needs to expand its anti-imperialist struggle by building solidarities with countries across Asia, Africa, Latin America, and Eu rope. The end of imperialism and its capitalist hegemony would be beneficial for people worldwide, paving the way for democracy, peace and prosperity across the globe.

New Delhi, August 6: The death and destruction left behind by the flash floods in the Kheer Ganga river in Dharali resurrected painful memories for Geeta, a survivor of the 2013 Kedarnath disaster, who lost four family members in that tragedy, India's worst since

"The same thing happened in Kedarnath," she exclaimed as visuals played out on television at some house in New Delhi where she works as a domestic help.

The 2013 disaster was triggered by more than 300 mm of rain in 24 hours as an early intense monsoon surge interacted with a western disturbance. The extreme rainfall, combined with rapid snowmelt, breached the moraine dam of Chorabari Lake, unleashing massive



floods that killed around 5,700

Scarred by the tragedy, Geeta (now 45 years old) and her family migrated to Delhi to rebuild their lives. But each time it hits the Himalayan state, it revives those haunting memo-

Over the past 12 years, a series of disasters have underscored the fragility of the Himalayan terrain.

August 18, 2019, a cloudburst in Tikochi and Makudi villages in Uttarkashi's Arakot region triggered flash floods and landslides, killing at least 19 people and affecting 38 villages.

In February 2021, the collapse of a hanging glacier caused a debris flow in the Ronti Gad stream, a tributary of Rishiganga, sweeping away two hydropower projects in Chamoli. Eighty bodies were recovered, and 204 people went missing.

In August the last year, flash floods caused by a cloudburst in the Maldevta-Song-Baldi river system washed away large parts of the Maldevta town near Dehradun, affecting a 15

The Dharali disaster, experts say, shares features with the 2021 Chamoli tragedy.

"It is similar to Chamoli, and rainfall is just one factor. We need high-resolution satellite data or ground verification to know more," HNB Garhwal University Professor YP Sundriyal said.

The 2021 Chamoli disaster impacted an area spanning 20-22 km but did not affect the Alaknanda downstream, A

study published last month in the Journal of the Geological Society of India has confirmed a sharp rise in extreme rainfall and surface runoff events in Uttarakhand after 2010.

The research, led by Professor Sundriyal, shows that while 1998-2009 saw warming and low rainfall, the trend reversed post-2010, with central and western Uttarakhand witnessing more extreme precipitation events.

"Data from 1970 to 2021 shows a clear increase in extreme rainfall events after 2010," Sundriyal said. The state's geology compounds is risky. Steep slopes, young and fragile formations prone to erosion and tectonic faults such as the main central thrust make the terrain unstable. The orographic effect

air upwards, leading to intense localised rainfall, while unstable slopes magnify the risk of landslides and flash floods.

A November 2023 study published in the Natural Hazards iournal, analysing disaster data between 2020 and 2023, recorded 183 incidents in Uttarakhand during the monsoon months alone. Landslides accounted for 34.4 per cent of these, flash floods 26.5 per cent and cloudbursts 14 per cent.

The Centre for Science and Environment's Atlas on Weather Disasters shows that between January 2022 and March 2025, the 13 Himalayan states and Union territories reported extreme weather events on 822 days, claiming 2,863 lives. Experts say these natural factors are worsened by human activity. Unregulated road-building, deforestation and construction of tourism infrastructure and settlements on unstable slopes or riverbanks have increased the disaster risk

Environment activist Anoop Nautiyal said repeated tragedies in Kedarnath, Chamoli, Joshimath, Sirobagad, Kwarab, and Yamunotri have not altered Uttarakhand's development trajectory. "If anything, ecological degradation and haphazard development are accelerating due to flawed policies and projects, he claimed.

Climate campaigner Harjeet Singh described the Uttarkashi tragedy as "a deadly mix of global warming-fuelled monsoon extremes and unscientific, unsustainable construction in the name of development".

Organic farming gains traction in Himachal

Himachal Pradesh, August 6: With incentives like subsidies and assured minimum support price given by the state government to promote natural farming, around 37,000 farmers have adopted natural farming in the twin districts of Una and Hamirpur.

Over 20,000 farmers in Hamirpur district and 16,853 farmers in Una have adopted natural farming, officials said. Deputy Commissioner of Hamirpur Amarjeet Singh said around 96 quintals of wheat and 9 quintals of turmeric prepared through natural farming have been purchased in the district in the Rabi season, while 53 quintals of maize were purchased in the last Kharif season.

Project Director of Aatma Project, Hamirpur, Nitin Sharma said that to promote natural farming, farmers are given a subsidy of Rs 25,000 for the

purchase of indigenous cows

A subsidy of Ra 8,000 is given for paving the floor of the cowshed and setting up systems for collecting cow urine. Additionally, a subsidy of up to Rs 2,250 is available for preparing materials required for natural farming, such as

drums and other equipment. Shakuntala Devi and Sushma Devi of Gram Panchayat Amla had, who have adopted natural farming, have found new hope Not only has it significantly re duced their farming costs, but their crops are also fetching better prices, and their food is now free from harmful chemicals, Sharma added.

The ATMA Project Director Virender Bagga claims 41.66 metric tonnes of natural wheat and 11.15 metric tonnes of natural maize were purchased by farmers in Una district.

Chamoli, August 6: Women of Self-Help Group are not only running their livelihood by taking advantage of the public welfare schemes run by the government, but they have also improved their economic condition by earning good profits by making eco-friendly rakhis in Uttarakhand's Chamoli.

The initiative is a part Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), the Ministry of Rural Development's flagship programme aimed at reducing poverty by building strong institutions for the poor, especially women. These institutions are empowered to access financial services, market linkages, and diverse livelihood opportunities.

In Chamoli, this mission has taken a colourful turn. As Raksha Bandhan approaches, SHG members are crafting rakhis from pirul, bhojpatra, and vaijayanti seeds – materials rooted in the region's ecology and traditions. Alongside, they are preparing local delicacies like arasa and roti, attracting buyers keen on authentic. handmade products.

The response has been overwhelmingly positive. Local residents and visitors



are readily purchasing these unique items, praising both the craftsmanship and the initiative's eco-friendly ethos. For the women involved, the sales have meant more than just extra income – they have brought recognition, confidence, and a stronger voice in household and community decisions.

New Delhi, August 6: The Supreme Court on Wednesday asked the Election Commission to furnish by August 9 the details of around 65 lakh electors left out from the draft electoral rolls in poll-bound Bihar.

A bench of Justices Surya Kant, Ujjal Bhuyan and N Kotiswar Singh asked the counsel for the poll panel to furnish the details of deleted voters, the data which has been already shared with the political parties, and give a copy to the NGO, Association For Democratic Reforms.

The NGO, which has challenged the June 24 order of the Election Commission directing for Special Intensive Revision (SIR) of electoral rolls in Bihar, filed a fresh application seeking direction to the poll panel to publish the names of around 65 lakh deleted voters with the mention whether they are dead, permanently migrated or not considered for any other reason.

The bench told advocate Prashant Bhushan, appearing for the NGO, that the reason for deletion would come in subsequent time as it is now only a draft list.

However, Bhushan contended that some political parties have been given a list of deleted voters but they have not further clarified whether the said voter is dead or migrated.

The bench told the ECI's counsel, "We will see every voter likely to be affected and get the required information. You (ECI) file a reply by Saturday and let Mr Bhushan look at it and then we can see what is disclosed and what is not disclosed.

Bhushan alleged that 75 percent of voters, who have filled the enumeration form have not furnished any supporting documents mentioned in the list of 11 documents and their names were included on the recommendation of Booth Level Officer (BLO) of the poll panel.

The bench said it is commencing hearing on a batch of petitions challenging the June 24 order of the poll panel August 12 and the NGO can make these averments on that day.

Terming the Election Commission a constitutional authority deemed to act in accordance with law, the top court had said July 29 that it will step in immediately if there is "mass exclusion" in the SIR of electoral rolls in Bihar.

It had fixed a timeline for considering a batch of pleas challenging Election the Commission's SIR exercise in Bihar and said the hearing on the issue will be held August 12 and 13. Earlier, observing there

should be "en masse inclusion" instead of "en masse exclusion" in the ongoing SIR exercise of voters' list in poll-bound Bihar, the top court asked the Election Commission to continue accepting Aadhaar and voter ID documents.

Underscoring the "presumption of genuineness" of the two documents, the top court also refused to stay the publication of the draft electoral roll in Bihar.

NSA Doval travels to Russia for talks on crucial issues

New Delhi, August 6: National Security Advisor Ajit Doval has travelled to Russia to hold crucial talks on bilateral ener gy and defence ties and to pre pare ground for Russian Pres ident Vladimir Putin's visit to India later this year.

Doval's visit to Russia comes amid some strain in ties between India and the US over New Delhi's continuing procurement of Russian crude oil, notwithstanding Western sanctions on Moscow.

US President Donald Trump Wednesday issued an executive order slapping an additional 25 per cent tariff on Indian goods as a penalty for New Delhi's continued purchase of Russian oil

The additional duties raised the overall tariff on India to 50 per cent. Defending its purchase of Russian crude oil India has been maintaining that its energy procurement is driven by national interest and market dynamics.

People familiar with Doval's visit to Moscow said bilateral energy and defence ties as well as Western sanctions on Rus sian crude oil will figure in his talks with Russian officials.

Russia has emerged as India's top energy supplier since the West slapped sanctions on its crude oil after the invasion of Ukraine. The NSA is also expected to press Moscow to ensure early delivery of remaining two regiments of S-400 air defence systems to India.

The S-400 systems played a crucial role during the Oper ation Sindoor. India signed a \$5.43 billion deal with Russia in 2018 for five squadrons of the S-400 Triumf missile system, a state-of-the-art air defence plat form capable of engaging multi ple aerial threats at long ranges.

Comprehensive reset of foreign policy needed: Cong

New Delhi, August 6: After the imposition of an additional 25 per cent tariff on Indian goods entering the US, the Congress Wednesday called the action "unjust" and "economic blackmail" aimed at bullying India into an unfair trade deal, even as it hit out at Prime Minister Narendra Modi, saying his "personalized" and "headline-grabbing style of huglomacy" has been an "abysmal failure"

The Opposition party also sought a comprehensive reset of India's foreign policy and administration.

The Leader of Opposition in Lok Sabha, Rahul Gandhi, said, "(Donald) Trump's 50 per cent tariff is economic blackmail -- an attempt to bully India into an unfair trade deal.'

"PM Modi better not let his weakness override the interests of the Indian people," Gandhi said in a post on X.



Noting that US President Donald Trump has hit India "hard and unjustly", Congress general secretary (communications), Jairam Ramesh, called for a comprehensive reset of India's foreign policy and said Prime Minister Modi should shed his ego and take inspiration from Indira Gandhi in the manner she stood up to the US' 'bullying" in the 1970s.

"Now President Trump, while still claiming to be a friend of Mr Modi, has hit India hard and unjustly. While his tariff and penalty actions are simply unacceptable, the fact remains that they also

reflect the abysmal failure of Mr Modi's personalised and headline-grabbing style of huglomacy," Ramesh said in a post on X.

'India stood up to the bullying of the US in the 1970s especially under the prime ministership of Smt. Indira Gandhi. Instead of defaming, distorting, and denigrating her, Mr Modi should shed his ego -- if indeed that were possible -- and take inspiration from the manner in which she stood up to the USA. India's foreign policy and administration needs a comprehensive reset,'

Ramesh said. Recalling past events under the Modi government, the Congress leader said the prime minister went to the US and attended a 'Howdy Modi' event in Houston in September 2019.

"President Trump was also present and Mr Modi broke with all tradition and declared 'Ab ki Baar, Trump Sarkar','

New Delhi, August 6: Parliament Wednesday passed The Carriage of Goods by Sea Bill 2025, amid Opposition protests and sloganeering in the Rajya Sabha over the Special Inten-

sive Revision issue. The Bill seeks to repeal and replace pre-independence The Carriage of Goods by Sea Act, 1925, and simplify the language and structure, in an attempt to make the law more accessible to stakeholders, particularly Indian exporters, importers, and

shipping professionals. Moving the Bill, Shantanu Thakur, Minister of State for

Ministry of Ports, Shipping and Waterways, said the repeal of the pre-Constitution legislation and its replacement with a new legislation is "a part of the government's effort to rid ourselves of the vestige of colonial mindset, and to ensure ease of doing business through simple and rationalised law.

He said under Prime Minister Narendra Modi, the government has replaced more than 1,500 old laws. The debate on the Bill, which was passed by the Lok Sabha in March this year, was carried out amid protests by the Opposition on the SIR issue.

Several Opposition MPs who stood up to participate in the



debate on the Bill demanded a

discussion on SIR. Neeraj Dangi (Congress), P Sandosh Kumar (CPI), Haris Beeran (IUML), and V Sivadasan (CPI(M)), were among the opposition MPs who stood

up to speak, and demanded a discussion on SIR.

MPs from the treasury benches meanwhile slammed the Opposition for not being interested in the development of the country. The Bill was put to vote, and as the clause by clause consideration was being done, CPI(M) MP John Brittas moved an amendment, and insisted on division and voting.

Several other Opposition MPs backed the demand for division, however, as several MPs were not on their seats, the Bill was passed amid continuing protests and sloganeering through voice vote.

The new Bill retains all provisions of the 1925 Act, which establishes responsibilities, liabilities, rights, and immunities in case of goods carried from a port in India to another port in the country or any other in the world, and is in conformance

with the International Convention for the Unification of Certain Rules of Law relating to Bills of Lading of August 1924 (Hague Rules) and subsequent amendments to it.

While retaining the substantive legal framework, the Bill aligns it with contemporary drafting practices, reducing ambiguities and minimising the risk of potential litigation.

The bill empowers the government allowing India to swiftly adapt to evolving international maritime conventions It also ensures transparency and accountability by providing for parliamentary oversight of executive notifications.

Rescuers retrieve 2 bodies; NDRF at site

Four people are suspected to have been killed in the disaster that struck the ecologically fragile area Tuesday afternoon

Uttarakashi (Uttarakhand), August 6: As the sun set over the flood-ravaged Himalayan village of Dharali with 190 people rescued and two bodies recovered Wednesday, fears mounted for those still trapped under the massive river of sludge that buried scores of houses, trees and cars.

Four people are suspected to have been killed in the disaster that struck the ecologically fragile area Tuesday afternoon.

Two bodies were recovered Wednesday and 15 are missing, Disaster Management Secretary Vinod Kumar Suman said.


Two Chinook helicopters have reached Sahastradhara helipad in Dehradun in which 50 NDRF jawans are to be taken along with rescue equipment to ground zero. Five AN-32 helicopters of the IAF have also arrived at the helipad on the way to Dharali.

Tonnes of rubble lay on the site with the ITBP, Army and SDRF personnel rummaging through it for those trapped underneath amid continuing rain and road collapses.

Officials said the army's Ibex brigade which had helped in rescue operations in the Mana avalanche of February is preparing to take the help of ground penetrating radars and sniffer dogs to search the missing.

Two more NDRF teams are en route to Dharali but have been unable to get there because continuous landslides have blocked the Rishikesh-Uttarkashi highway

According to Mohsen Shahedi, NDRF deputy inspector general (DIG) operations, two NDRF teams are to be airlifted from Dehradun, but they can't



be moved as bad weather is preventing a successful sortie.

Earlier in the day, Prime Minister Narendra Modi spoke to Chief Minister Pushkar Singh Dhami to get an update on the situation and assured him of the Centre's assistance.

Modi also met MPs from Uttarakhand -- Anil Baluni, Mala Rajya Laxmi Shah, Trivendra Singh Rawat and Ajay Bhatt -- at the Parliament House and was briefed on the current situation and the ongoing rescue operations.

Dhami did an aerial survey of the affected areas and met the kin of the missing people in Dharali assuring them of all

Dharali is the main stopover on the way to Gangotri, from where the Ganga originates. and is home to several hotels and home stays.

The Gangotri national highway is blocked at various points with a joint team of more than 200 rescue personnel waiting in Bhatwari for the route to open. added an official at the district emergency operation centre in Uttarkashi. A bridge built over the Li-

maccha river at Gangnani on the Gangotri National Highway was swept away by the flash flood, leaving a team of rescue personnel stranded on the way to Dharali.

During the day, Dhami held a meeting with officials at the State Emergency Operation Centre here to review the rescue efforts. He surveyed the flooded ar-

ea in Dharali and Harsil from a helicopter, and later met the injured soldiers and relatives of those missing in the flood.

"The rescue work is apace. Teams from the army, ITBP, and SDRF have reached the spot ... A road has been blocked. The DM and an SP rank officer are on their way to the spot. It's a challenging situation as it is still raining there," he told PTI Videos.

Kolkata court grants police custody to law college rape accused

Kolkata, August 6: In what is being claimed as a first-ofits-kind order by a court in Kolkata, all four accused in the South Calcutta Law College rape case were remanded to po lice custody for an additional period of three days, 39 days after they were first arrested.

The prime accused in the

case, Monojit Mishra, an alumnus and a contractual employee of the college, and two of his suspected accomplices, Pramit Mukhopadhyay and Zaib Ahmed, both students. along with Pinaki Banerjee, security guard of the campus, were granted police custody till August 8 by Amit Sarkar, Additional Chief Judicial Magistrate of Alipore Court.

The order was passed Tuesday in the wake of all four accused having previously been remanded to police custody for 11 days, followed by their judi cial custody for another 28 days

"Under the provisions of Section 167 of the earlier CrPC Act, the prayer for police remand had to be made within the first 15 days of arrest. That provision has now changed un der the new Bharatiya Nagar ik Suraksha Sanhita (BNSS), which replaced the CrPC July 1, 2024. The BNSS now empowers the police to pray for re mand anytime within the first 60 days of arrest for heinous crimes like rape and murder,' Sourin Ghosal, the Kolkata Police Chief Public Prosecutor in Alipore Court, explained.

"The case was initially registered in Ranchi and was transferred to Chaibasa in 2021. We had filed a petition for exemption from personal appearance before the high court, and we are here as per the high court's direction," he added.

MP Sudha's chain snatcher nabbed

NEW DELHI: The Delhi Police Wednesday arrested a 24-year-old habitual offender for allegedly snatching a 30 gm gold chain from Congress MP R Sudha in the high-security Chanakyapuri area, an official said. Sudha, an MP from Tamil Nadu, was on her routine morning walk Monday when a scooter-borne man wearing a full-face helmet snatched her gold chain near Tamil Nadu Bhavan and sped away. The MP sustained minor injuries in the incident, police said. The accused, identified as Sohan Rawat alias Buggu, was arrested early Wednesday morning after multiple police teams tracked his movements using CCTV footage, local intelligence, and technical surveillance. "Rawat has been previously involved in 26 criminal cases, mostly related to theft and snatching. He was released from jail on bail June 27 after being arrested for vehicle theft in the Ambedkar Nagar area earlier this year," a senior police officer said. Multiple Delhi Police units, including the Anti Auto Theft Squad (AATS), Operation Units of South West and New Delhi districts, were involved in tracking and apprehending the accused, he said.

Police SSI hacked to death while attempting to resolve dispute

Tiruppur (Tamil Nadu): A Special Sub Inspector of Tamil Nadu police was hacked to death when he attempted to resolve a dispute between a man and the latter's son in Gudimangalam in the district. police said Wednesday, According to police, M Shanmugayel (57), working as a Special Sub Inspector at Gudimangalam police station in Tiruppur district, and Armed Reserve Police constable Azhaguraia. on patrol duty at around 11 pm August 5, rushed to a private farm upon receiving information about a drunken brawl between two persons. After arriving, the police tried to pacify the two, but the police official was attacked with a sickle and the constable chased away. Preliminary enquiry revealed that though Manigandan was suspected to have caused grievous injuries to the SSI. his brother Thangapandian and their father Moorthy were also involved in attacking the official and chasing away the constable, he said. While Shanmugavel died on the spot, the constable managed to escape a bid on his life.

Enforce 75% attendance for board exams: CBSE

New Delhi, August 6: The Central Board of Secondary Education (CBSE) has warned schools to strictly adhere to the 75 per cent attendance requirement for students appearing for board exams, according to

According to the CBSE Examination By Laws, a minimum of 75 per cent attendance is mandatory for students to be eligible to appear for the board examinations

The CBSE offers a 25 per cent relaxation only in cases of exigencies such as medical emergencies, participation in national or international sports events, and other serious reasons, if supported by the necessary documents or record.

"All students and parents must be made aware of the mandatory 75 pc attendance requirement criteria and the potential consequences of not meeting this criteria. Any student, if on leave due to a medi-



school with proper medical and other documents at the time of availing leave. Leave without a written request will be considered unauthorized absence from the school," CBSE Examination Controller Sanyam Bhardwaj said in a letter to schools. The board has directed that schools must regularly monitor and maintain correct attendance records. "Attendance registers should

be updated daily, signed by the

class teacher and the competent authority of the school and be readily available for inspection

"The Board may conduct surprise inspections to verify student attendance records During such inspections, if it is found that the records are incomplete or students have not been attending the school regularly, the school may face strict action, including disaffiliation. The students may be disqualified from appearing in the board exams," Bhardwai said.

Gaza, August 6: Weakened by hunger, many Gazans trek across a ruined landscape each day to haul all their drinking and washing water - a painful load that is still far below the levels needed to keep people

Even as global attention has turned to starvation in Gaza, where after 22 months of a devastating Israeli military campaign a global hunger monitor says a famine scenario is unfolding, the water crisis is just as severe according to aid groups.

Though some water comes from small desalination units run by aid agencies, most is drawn from wells in a brackish aquifer that has been further polluted by sewage and chemicals seeping through the rubble, spreading diarrhoea and hepatitis.

COGAT, the Israeli military agency responsible for coordinating aid in the Israeli-occupied Palestinian territories, says it operates two water pipelines into the Gaza Strip providing millions of litres of water a day.

Palestinian water officials say these have not been working re-

Israel stopped all water and electricity supply to Gaza early in the war but resumed some supply later though the pipeline network in the territory



has been badly damaged.

Most water and sanitation infrastructure has been destroyed and pumps from the aquifer often rely on electricity from small generators - for which fuel is rarely available.

COGAT said the Israeli military has allowed coordination with aid organisations to bring in equipment to maintain water infrastructure throughout the conflict.

Moaz Mukhaimar, aged 23 and a university student before the war, said he has to walk about a kilometre, queuing for two hours, to fetch water. He often goes three times a day, dragging it back to the family tent over bumpy ground on a small metal handcart.

The United Nations says the minimum emergency level of water consumption per person is 15 litres a day for drinking, cooking, cleaning and washing. Average daily consumption in Israel is around 247 litres a day according to Israeli rights group B'Tselem.

Bushra Khalidi, humanitarian policy lead for aid agency Oxfam in the Israeli-occupied Palestinian territories said the average consumption in Gaza now was 3-5 litres a day.

Oxfam said last week that preventable and treatable water-borne diseases "ripping through Gaza", with reported rates increasing by almost 150% over the past three months. Israel blames Hamas for the suffering in Gaza and says it provides adequate aid for the territory's 2.3 million

"Water scarcity is definitely increasing very much each day and people are basically rationing between either they want to use water for drinking or they want to use a lot for hygiene," said Danish Malik, a global water and sanitation official for the Norwegian Refugee Council.

Merely queuing for water and carrying it now accounts for hours each day for many Gazans, often involving jostling with others for a place in the queue. Scuffles have sometimes broken out, Gazans say.

Collecting water is often the job of children as their parents seek out food or other necessi-

"The children have lost their childhood and become carriers of plastic containers, running behind water vehicles or going far into remote areas to fill them for their families," said Munther Salem, water resources head at the Gaza Water and Environment Quality Authority.

With water so hard to get, many people living near the beach wash in the sea.

A new water pipeline funded by the United Arab Emirates is planned, to serve 600,000 people in southern Gaza from a desalination plant in Egypt. But it could take several more weeks to be connected. Much more is needed, aid

Trump in dark on Russian imports

New York, August 6: President Donald Trump has said that he doesn't know anything about the US imports of Russian uranium, fertilisers and chemicals.

Trump made the comments Tuesday while responding to a question on India's statement on American imports of these commodities. "I don't know anything about

it. I'd have to check, but we'll get back to you on that," Trump said, adding that he will soon decide on tariffs to be imposed on nations buying Russian energy. India Monday mounted an

unusually sharp counterattack on the US and the European Union for their "unjustified and unreasonable" targeting of New Delhi for its procurement of Russian crude oil.

Firmly rejecting the criticism, India pointed out the double standards in targeting it on the issue and said both the US and the EU are continuing their trade relations with Russia.

"Unlike our case, such trade is not even a vital national compulsion," the Ministry of External Affairs (MEA) said in a statement on Monday night.

The Europe-Russia trade includes not just energy, but also fertilisers, mining products, chemicals, iron and steel, and machinery and transport equip-

ment, the MEA said. "Where the US is concerned, it continues to import from Russia uranium hexafluoride for its nuclear industry, palladium for its EV industry, fertilisers as well as chemicals." it added.

"In this background, the targeting of India is unjustified and unreasonable," the MEA said. In response to another question that he has threatened to impose 100 per cent tariffs on all countries that purchase

Russian energy, including China, Trump said while he never said a percentage, "but we'll be doing quite a bit of that. We'll see what happens over the next fairly short period of time".

He said that the US has a "meeting with Russia" Wednesday, without giving further details on where and what the meeting will entail. "We're going to see what happens. We'll make that determination at that time.

Meanwhile, State Department Spokesperson Tammy Bruce said it will be up to President Trump on how to respond to "those nations that are facilitating this war on Ukraine".

She was asked about India's comment that New Delhi is not going to change its position on oil purchase from Russia.

I will not characterise or remark on another nation's comments about what they will or will not do...But I do know that, of course, President Trump understands the entire field, and he has made it very clear he doesn't like what's been

happening," she said. To another question on India and China indicating they fully intend to continue purchasing Russian oil irrespective of US sanctions, Bruce said Washing ton is now talking about secondary sanctions, sanctioning a country, company or others that might be doing business with a country that the US has sanctioned in this instance.

France's biggest wildfire of summer eclipsed size of Paris, still spreading

Paris: France's biggest wildfire this summer was spreading quickly Wednesday in a Mediterranean region near the Spanish border after leaving one person dead, authorities said. About 2.000 firefighters and several water bomber aircraft battled the blaze that broke out Tuesday afternoon in the village of Ribaute in the Aude region. a rural, wooded area that is home to wineries. The wildfire remained 'very active' Wednesday and weather conditions were unfavourable, the local administration said in a statement. One person died in their home. nine others were injured, including seven firefighters, and at least one person was missing, the statement said. The interior ministry said the fire had spread over 13,000 hectares (32,000 acres), an area larger than the French capital. Jacques Piraux, mayor of the village of Jonquières, said all residents have been evacuated. "It's a scene of sadness and desolation," he told broadcaster BFM TV after he visited Wednesday morning to assess the damage. "It looks like a lunar landscape, everything is burned. More than half or three-quarters of the village has burned down. It's hellish." Residents and tourists in nearby areas were requested to remain in their homes unless told to evacuate by firefighters. Two campsites were evacuated as a precaution.

Mumbai, August 6: The Reserve Bank of India (RBI) kept its policy interest rate unchanged Wednesday as it appeared to have taken a waitand-watch approach to assess the full unveiling of US President Donald Trump's trade policies as well as transmission of past rate cuts. The six-member rate-setting

panel, headed by RBI Governor Sanjay Malhotra, held the repurchase rate at 5.5 per cent in a unanimous vote and decided to continue with a 'neutral' stance. While on-track monsoon rains

and the approaching festival season are expected to provide buoyancy to the economy, global trade challenges continue to linger, Malhotra said, announcing the decision of the Monetary Policy Committee (MPC).

Trump last month slapped a 25 per cent duty on all Indian goods entering the US from August 7, and Tuesday threatened to substantially hike the tariff for New Delhi's continued purchase of Russian oil.

"Over the medium-term also, the Indian economy holds bright prospects in the changing world order, drawing on its inherent strength, robust fundamentals, and comfortable buffers," he said. "Opportunities are there for the taking, and we are making all efforts to create enabling conditions through a multi-pronged yet cohesive approach to policy making."

The pause follows a 100 basis point (bps) cut in interest rate over three bi-monthly MPC meetings in 2025. The full transmission of the front-loaded 50 bps rate cut effected in June is

RBI revises CLA for banks and NBFCs

Mumbai, August 6: The Reserve Bank Wednesday issued revised directions on co-lending arrangements (CLA) to provide specific regulatory clarity on the permissibility of such arrangements and address some of the prudential as well as conduct-related aspects.

Regulated entities (REs), including banks, NBFCs, and All-India Financial Institutions, can enter into a lending arrangement with other REs

for extension of credit to the borrowers, subject to compliance with the extant prudential regulations.

Exports to hit hard: Experts

New Delhi, August 6: Domestic export sectors such as leather, chemicals, footwear, gems and jewellery, textiles and shrimp will be severely impacted by the imposition of the 50 per cent tariff by US, say industry experts.

US President Donald Trump Wednesday slapped an additional 25 per cent tariff, raising the total duties to 50 per cent on goods coming from India, as a penalty for New Delhi's continued purchase of Russian oil.

The United States has imposed additional tariffs or penalty for Russian imports only on India while other buyers such as China and Turkey, have so far escaped such measures.

"The tariffs are expected to make Indian goods far costlier in US, with potential to cut US-bound exports by 40–50 per cent," think tank GTRI said.

After the new tariff, it said, organic chemicals' exports to US will attract additional 54 per cent duty. The other sectors which will attract high duties include carpets (52.9 per cent), apparel - knitted (63.9 per cent), apparel - woven (60.3 per cent), textiles, made ups (59 per cent), diamonds, gold and products (52.1 per cent), machinery and mechanical appliances (51.3 per cent), furniture, bedding, mattresses (52.3 per cent). The 25 per cent duty, an-

nounced July 31, will come into force from August 7 (9.30 The additional 25 per cent will be implemented by US

from August 27. These will be over and above the existing standard import duty in US. In 2024-25, the bilateral trade

between India and US stood at \$131.8 billion (\$86.5 billion exports and \$45.3 billion imports). The sectors, which would



New Delhi, August 6: The men's javelin event is set to be the top draw when the country hosts its maiden World Athletics Continental Tour bronze level competition in Bhubaneswar August 10 with two Indians and as many Sri Lankans expected to vie for top honours

Though two-time Olympic medallist Neeraj Chopra is missing from the competition, Sachin Yadav and Yashvir Singh will spearhead India's challenge while Sri Lankans Sumeda Ranasinghe and Rumesh Tharanga Pathirage will also fancy their chances.

The total prize fund of the one-day event is \$25,000.

Ranasinghe has already secured a direct spot in World Athletics Championships in September while Pathirage, Yadav and Singh are likely to make the showpiece through world ranking quota.

The 34-year-old Ranasinghe has the top season's best with his 85.78m effort in March, while Pathirage, who won bronze in the NC Classic last month, has 85.14m for his best of the year.

Meanwhile, Yadav, the Asian Championships silver winner, has 85.16m as his season's best while Singh's top mark of the year is 82.57m. Rohit Yadav and Vikrant Malik are the other

'This is the country's first Continental Tour event and we are hoping for a successful competition so that the world knows we can host this kind of events," Athletics Federation of India (AFI) President Bahadur Singh Sagoo said in a press conference.

Ministry has amended the RTI-related provision of the National Sports Governance Bill, placing only those bodies under its ambit which rely on government grants and assistance.

The bill was tabled in the Lok Sabha by Sports Minister Mansukh Mandaviya July 23 and its clause 15 (2) stated that "a recognised sports organisation shall be considered as a public authority under the Right to with respect to the exercise of its functions, duties and powers under this Act."

The RTI has been a thorny issue for the BCCI, which has steadfastly opposed coming under it as the Board is not dependent on government funds unlike a majority of other National Sports Federations (NSFs).

The amendment proposed in the bill effectively puts an end to that apprehension.
