Farmer ends life in Subarnapur district

Sonepur/Binika, August 12: A 42-year-old farmer from Choukamal village under Lachhipur police limits in Subarnapur district died late Monday night after allegedly consuming pesticide, police said Tuesday.

The deceased, identified as Surendra Biswal, cultivated paddy during the ongoing kharif season. According to police, it is unclear whether the act was triggered by mental distress or family disputes. Surendra was one of three sons of Chakaman Biswal, who owns about 4.5 acres of farmland. Due to their father's old age, the siblings managed the land together. Police said Surendra had a dispute with his elder brother, Jogindra, over division of ancestral property.

The three visited the police station Sunday, where IIC Bhojaraj Sahu mediated an amicable settlement. All three signed a written statement confirming the dispute had been resolved.

However, family members said Surendra consumed pesticide Monday after returning from the police station and died while undergoing treatment at VIMSAR, Burla. Further investigations were on.

Schoolgirl 'gangraped'

Kendrapara , August 12: A 15-year-old girl was allegedly raped by five people, including her uncle, at a village in this district, police said Tuesday.

While the victim's uncle was arrested, others were detained and are being interrogated, an officer said.

The Class X student lodged a complaint with the Rajnagar Police Station Monday, alleging that a relative had visited her August 9, and taken her to a deserted place where she was gang-raped, he said. The minor also alleged that four others, who were near the place, raped her, he said. "It seemed that the relative of the girl was the main accused," police said.

The accused threatened her with dire consequences if she revealed the incident to her family, the officer added.

Aadhaar no proof of citizenship: SC

New Delhi, August 12: The Supreme Court Tuesday backed the Election Commission of India's (ECI) stance that Aadhaar cannot be treated as conclusive proof of citizenship, stressing that it must be independently

A bench led by Justice Surya Kant made the observation during a hearing on petitions challenging the Special Summary Revision (SIR) of electoral rolls in Bihar. "The EC is correct in saying Aadhaar cannot be accepted as conclusive proof of citizenship. It has to be verified." Justice Kant told senior advocate Kapil Sibal, appearing for the petitioners.

The apex court also said the first question to decide was whether the ECI had the power to carry out the verification exercise. "If they don't have the power, everything ends. But if they have the power, there can't be a problem,' Justice Kant remarked.

Sibal argued that the poll



panel's process would lead to large-scale exclusion of voters, especially those unable to submit required forms. He claimed that even voters included in the 2003 electoral rolls were required to fill fresh forms, and failure to do so would lead to deletion of names, despite no change in residence. Sibal contended that despite residents holding Aadhaar, ration and EPIC cards, officials refused to accept the documents.

"Is it your argument that people who have no documents but are in Bihar and therefore he should be considered as a voter of the state. That can be allowed. He has to show or submit some documents (sic)," the bench said.

When Sibal said people were struggling to find birth certif icates and other documents of their parents, Justice Kant said, "It is a very sweeping statement that in Bihar nobody has the documents. If this happens in Bihar, then what will happen in other parts of the country?"

Meanwhile, the Bombay High Court Tuesday said a person does not become a citizen of India merely by possessing documents like Aadhaar card, PAN card or a voter ID. The court said this while refusing bail to a man, allegedly from Bangladesh, for entering India illegally. The man is accused of staying in India for more than a decade with forged and fabri-

cated documents. A bench of Justice Amit Borkar said provisions of the Citizenship Act lay down who can be a citizen of India and how citizenship can be acquired and documents such as the Aadhaar card, PAN card and voter ID are only meant for identification or availing services.

City to have ₹4,009cr chip plants

New Delhi, August 12: The Union Cabinet has approved four semiconductor projects, entailing a total investment of ₹4,594 crore, for Odisha, Punjab and Andhra Pradesh, including a ₹4,009 crore chip plants in Bhubaneswar, Information & Broadcasting Minister Ashwini Vaishnaw said Tuesday.

The proposals have been approved under the India Semiconductor Mission, which has an outlay of ₹76,000 crore to provide financial support for setting up chip manufacturing facilities in the country.

"Cabinet has approved four semiconductor plants that will be set up in Odisha, Punjab and Andhra Pradesh," Vaishnaw said. The minister said that a silicon carbide semiconductor plant will be set up in Bhu-

baneswar with an investment of ₹2,066 crore by SiCsem Pvt Ltd. "Silicon carbide is a very ro-

bust material and can sustain at high temperatures. Silicon carbide is used in our missiles, satellites, telecom towers, rockets, railway engines, etc," Vaishnaw said. The minister said that the plant will have a capacity to produce 9.6 crore chips per year.

The Cabinet also approved US chip major Intel-backed 3D Glass semiconductor manufacturing unit in Bhubaneswar with an investment of ₹1,943 crore. The plant will be set up by Heterogenous Integration Pack aging Solutions Pvt Ltd with an annual production capacity of 5 crore units. The minister said the project will be backed by US firm Lockheed Martin as well.

A chip packaging plant in Andhra Pradesh, to be set up by Advanced System in Package Technologies with an investment of ₹468 crore, was also approved by the Cabinet. The cabinet also cleared a semiconductor project of electronics component maker firm CDIL. The facility will be set up in Puniab with an investment of ₹117 crore, having an annual production capacity of 15.8 crore units

The minister said that due to various steps taken by the Prime Minister Narendra Mo di-led government, the electronics manufacturing sector has grown six times to ₹12 lakh crore in the last 11 years.

T'gana: 3 Odia workers killed

After lunch Monday, a group of workers including these three was returning to work when a vehicle hit them from behind, killing them on the spot. The workers left for Telangana 11 days ago.

SC relief for old vehicle owners

New Delhi, August 12: In a significant development, the Supreme Court Tuesday ordered authorities not to take coercive action against owners of diesel vehicles of over 10 years and petrol vehicles older than 15 years in Delhi-NCR. The top court was dealing with a plea seeking recall of its October 29, 2018 order upholding a National Green Tribunal's directive.

The apex court had directed transport departments of states in the NCR to ban diesel vehicles more than 10 years old and petrol vehicles more than 15 years old from plying in roads in terms of the NGT's order.

On Tuesday, a bench com-

prising Chief Justice BR Gavai and Justices K Vinod Chandran and NV Anjaria ordered no coercive action after Solicitor General Tushar Mehta, appearing for the Delhi government, made a prayer.


"Issue notice, returnable in four weeks. In the meantime, we direct that no coercive steps be taken against the owners on the ground that vehicles are 10 years old in respect of diesel vehicle and 15 years old in respect of petrol vehicles," the bench said.

During the hearing, Mehta said a vehicle used by the owner for commuting from home to court and vice-versa might run only 2,000 kilometres after 10 years but he would have to sell it due to the ban.

Washington, August 12: He promised her the moon — and meant it.

More than 23 years ago, NASA intern Thad Roberts hatched a daring plan to steal 17 pounds of moon rocks and a meteorite from Houston's Johnson Space Center - priceless samples from every Apollo mission, locked in a 600-pound safe and valued at \$21 million, quoting FBI, New York Post said.

Only 24 years old with a triple major in physics, geology and geophysics at the University of Utah, with a wife he was supporting back in Utah, and



financially struggling, Roberts thought his plan was foolproof.

The first step was finding a buyer. With help from friend Gordon McWhorter, Roberts

connected online with a potential Belgian purchaser willing to pay \$1,000 to \$5,000 per gram.

The buyer, however, grew suspicious and alerted the FBI, which instructed him to keep

talking while it investigated. Around this time, he met Tiffany Fowler, a 22-year-old NASA intern. Their friendship quickly became romantic, and after three weeks, they moved in together. They recruited another NASA intern, Shae Saur, and one night the trio used their NASA IDs to slip into the Johnson Space Center, making off with the entire safe. Back at the hotel, they cracked it open

with a power saw. On July 20, 2002 — the 33rd anniversary of the first moon landing—Roberts placed moon rocks beneath the bed covers, later claiming the couple had "sex on the moon".

Later, when the two met with the supposed buyers, they were instead greeted by undercover FBI agents. The moon rocks were recovered from their hotel room. When asked why he stole the moon rocks, Robert told the agency "We weren't going to take this money we were getting from it to go buy a yacht or lots of cars or a big house. We were gonna live just the small kind of lifestyle we were, but fund science that might change the world.'

In the end, Roberts, Fowler and Saur all pleaded guilty to conspiracy to commit theft and interstate transportation of stolen property.



Bhubaneswar, August 12: Chief Minister Mohan Charan Majhi Tuesday launched the Odisha Marine Biotechnology Research and Innovation Corridor (OMBRIC), a platform for young entrepreneurs to establish marine biotechnology startups rooted in local resources while meeting global standards, and said it will transform the state's blue economy and significantly contribute to India's economic growth.

On the occasion, a pact was signed between the Science and Technology department and the National Institute of Ocean Technology (NIOT), Ministry of Earth Sciences, for R&D col-Six higher education insti-

tutions, including IIT-Bhubaneswar, also signed MoUs with the Odisha government to provide R&D support for the initiative that aims to contribute to the field of environmental protection, science-based tourism. investment and employment of people in coastal areas.

"This unique platform will become a beacon of hope for the scientific community and innovation, not only for Odisha, but for the entire nation and the world.' the CM said, adding, "It will transform the state's blue economy and significantly contribute to the nation's economic growth."

Low pressure over Bay of Bengal likely to bring heavy rains: IMD

Bhubaneswar, August 12: A low-pressure area is likely to form over the west-central and adjoining northwest Bay of Bengal, bringing heavy rainfall across Odisha over the next few days, the India Meteorological Department (IMD) said Tuesday

According to the IMD bulletin, heavy to very heavy rainfall accompanied by thunderstorms and lightning is likely over several districts of Odisha from August 13 to 15 due to the formation of this system.

IMD sources said a trough currently extending from south Bihar to north Odisha, up to 1.5km above mean sea level.

In addition, an upper air cyclonic circulation is positioned over the central Bay of Bengal between 3.1km and

5.8km above mean sea level. Under its influence, the low-pressure area is expected to form August 13 and may

become more marked in the following 48 hours. The IMD has issued yellow and orange warnings for sev-

eral districts until August 17, forecasting heavy rain, thunderstorms, lightning, and gusty surface winds reaching speeds of 30-40kmph. Fishermen have been ad-

vised not to venture into the sea along and off the Odisha coast, as well as over the west-central and northwest Bay of Bengal, from August 13 to August 16.

The bulletin also warned of squally winds with speeds of 40-50kmph, gusting up to 60kmph, in these areas during this period. Sea conditions are expected to be rough to very rough.

Stating that Odisha is taking a 'hold and visionary step for-

"From gene discovery to bioactive molecules, from bioremediation to nutraceuticals, this initiative covers the entire pipeline of marine biotechnology innovation, culminating in job creation, environmental sustainability, and economic growth," he said.

The Chief Minister asserted that Odisha is no longer just a coastal state: it now seeks to be a coastal innovator.

"We are investing in nature-based solutions and harnessing our biodiversity not by exploiting it, but by preserving, understanding, and responsibly utilising it," he said.

Taking note of the strength of academic and research institutes of Odisha, the Chief Minister said the state has initiated an alliance of knowledge research, and innovation to identify threats to coasts with the help of biotechnology.

Science and Technology Minister Krushna Chandra Patra said that Odisha has huge potential in marine biotechnology and will make all efforts to explore this sector to promote growth.

OMBRIC is a blueprint for a prosperous future, he said.

Recognising the state's vast coastline, packed with unexplored rich marine bio-resources, Odisha Science and Technology department has conceptualised OMBRIC as a pioneering initiative aimed at transforming and positioning the state into a global leader in marine biotechnology and blue economy development in future, an official note said.

Based on their scientific expertise and regional relevance. the state government has roped in six premier institutes as hubs of OMBRIC.

These institutions will lead various components of the initiative with specific objectives aligned with their areas of expertise and the needs of the state, Chief Secretary Manoj Ahuja noted.

Review pending grievances of women, SPs told

Bhubaneswar, August 12: The Crime Against Women and Children Wing (CAW&CW) of Odisha Police Tuesday asked all superintendents of police (SPs) and Deputy Commissioners of Police (DCPs) to review pending and fresh grievances lodged by women and girls to prevent them from taking extreme steps such as suicide. Inspector General of Police

(IGP), CAW&CW, S Shyni has written a letter to all SPs, DCPs and Superintendents of Railway Police in this regard.

Shyni in her letter said, "Since the Balasore Fakir Mohan (Autonomous) College incident of self-immolation of a girl student, there has been a steady increase in the incidences of suicide by self-immolation and attempts." Studies and research have shown that reporting and portrayal of suicidal behaviour in the media have potentially negative influences and facilitate suicidal acts by people exposed to such stimuli, she said.

The IGP instructed the police officers to review pending grievances and fresh grievances of women and girls within the notice of the police and take proactive measures to prevent self-harm by women and girls.

She also advised them to undertake awareness campaigns and workshops to screen and map pre-existing vulnerabilities among the teenage group, which are a higher risk category, to be undertaken in schools, colleges and training institutes in coordination with departments concerned.

BJP govt failing to create trust in system: Naveen

Bhubaneswar, August 12: BJD supremo and Leader of the Opposition (LoP) in Assembly Naveen Patnaik Tuesday accused the state's BJP government of failing to create confidence in the system that led to four separate self-immolation deaths in Odisha in the last one month.

Patnaik's reaction came a day after a 13-year-old schoolgirl died after allegedly immolating herself in Bargarh district.

"Deeply saddened, shocked and anguished to know that another girl from Gaesilat, Bargarh has died after setting herself on fire. My condolences for the young girl and prayers are with the family members in the hour of grief. May God give the family members strength to bear this irreparable loss,' he said.

Patnaik, who served as CM for five terms, said, "It is deeply disturbing that there is a heartbreaking pattern in the way our girls are dousing themselves with inflammable to take their lives.

Four young girls have lost their lives in similar circumstances within a month. In each passing away of innocent lives lies a pain of a daughter of Odisha, which became so unbearable that she saw no other way out than to end her life, Patnaik said.

"These four deaths are not stray cases - there are many such girls who are dying in the

alleged gang-rape of a minor Dalit girl in Rajnagar area of Kendrapara district, accusing it of failing to ensure women safety in Odisha. Briefing media in the City, BJD MLA Dhruba Charan Sahoo and party spokespersor Lenin Mohanty said that the incident took place on the day of Rakhi Purnima when the victim went with her paternal uncle to buy an idol for Bhalukuni puja. Around five men allegedly took her to a secluded area, took turns to rape her, and video-recorded the shame. Mohanty said in the last one montl four girls have died in self-immolations. "And today, a woman from Bhubar with 50 per cent burn injuries was hospitalised. National media repeatedly highlight Odisha as unsafe for women, bringing shame to the state. Man sets himself on fire, rescued

Cops rescue couple with seven-yr-old daughter

Reports say the family is facing severe emotional and financial distress as their daughter battles a prolonged illness

Bhubaneswar, August 12: A couple from Boudh district threatened to self-immolate along with their seven-yearold daughter near Chief Minister Mohan Charan Majhi's residence at Lower PMG Road Tuesday but were rescued by police before any harm could occur, officials said.

The family hails from Tutusinga village in Boudh, and the man has been identified as Tirtha Mallick, father of the ailing child.

According to reports, the family is under severe emotional and financial distress due to their daughter's prolonged illness. Struggling to afford treatment, they approached the Chief Minister's residence and threatened self-immolation in front of the media to draw attention to their plight.

Police intervened promptly and rescued the couple and the child. No inflammable

materials were found in their possession.

"The trio was rescued and brought to the Chief Minister's grievance cell, where their concerns were heard," said Bhubaneswar DCP Jagmohan Meena.

Mallick stated, "We came here to seek help from CM Majhi for our daughter. If the government does not assist us, we will leave the child here and walk away. Despite

seven years of treatment, she shows no improvement. Yesterday, we borrowed money from villagers to travel here. We just want our daughter to get better.'

Earlier, the family had re ceived ₹40,000 from the Chief Minister's Relief Fund (CMRF) for treatment. Following the incident, they were referred to SCB Medical College and Hospital in Cuttack for further care.

This incident comes amid a worrying trend in the state, which has witnessed several cases of attempted self-immolation in the past month. In a recent tragic case, a 13-yearold girl from Bargarh district died Monday after attempting self-immolation.

Min Naik reviews rural drinking water projects

Bhubaneswar, August 12: To speed up rural water supply and guarantee pure drinking water in every household, Panchayati Raj & Drinking Water Minister Rabinarayan Naik Tuesday reviewed ongoing projects at a meeting in the conference hall of the State Rural Development and Panchayati Raj Institution. The minister conducted a detailed review of all ongoing drinking water projects across the state.

ing that 18 of the state's 207 rural drinking water projects have been completed, while work on the remaining projects is being expedited with regular monitoring. To ensure accountability, the minister directed officials to maintain constant supervision and ensure systematic execution.

Currently, more than 10,000 villages and 552 Gram Panchayats in the state have fully benefited from the 'Har Ghar Jal' (Water to Every Home) scheme. In Nuapada district, all villages have been covered under the 'Har Ghar Jal' scheme, mark ing a historic step towards en suring drinking water facilities in rural life. The government has taken swift steps to complete these projects as soon as possible.

According to the plan, 54 more projects are targeted to be completed by December 2025. The minister has instructed to finish all works within the stipulated time frame after review ing the status of these projects

To ensure safe drinking wa ter supply in the state, 5,27,570 hand pumps/sanitary wells 21,401 production wells, and 15,155 overhead tanks have been disinfected. Out of the previously approved 29,512 hand pumps, about 20,891 have been nearly completed. Great emphasis is being given to the accountability of these works.

The minister warned that strict action will be taken if the ongoing projects are not completed within the scheduled time. During the review meeting, department secretary SN Girish informed the minister about various details of the drinking water projects.

Meanwhile, in Bhubaneswar, the Regional Science Centre



Staff, infra shortage fuels **Sundargarh leprosy rise**

Rourkela, August 12: There is no letup in the rise of leprosy cases in Sundargarh district, with 707 new patients identified over the past 20 months.

Health officials attribute the increase to a shortage of manpower like healthcare professionals, including paramedical staff and physiotherapists, as well as inadequate infrastructure such as designated hospitals. Reports said that in between April and July alone, 81 additional cases were detected.

The highest number of cases has been reported from the Hemgir area, particularly among the elderly and children. The average prevalence

rate stands at 4.02 per cent. Despite the government spending crores of rupees annually to eradicate leprosy, the disease's growth in Sundargarh remains

a concern for all. According to sources, symptoms of leprosy typically appear five to six years after infection, making early diagnosis and surgical intervention challenging. The government is attempting to curb the spread through ASHA workers conducting tests at primary health centres and district headquarters hospitals, conducting awareness campaigns among the residents, and ensuring treatment facilities for the patients.

The government has also made appointments in the posts

of district leprosy officer (DLO), special physiotherapist and para-medical workers and officers for complete eradication of the

To boost eradication efforts, the government has appointed a district leprosy officer (DLO), a special physiotherapist, paramedical workers, and other officers. However, Sundargarh currently has only one physiotherapist for the entire district. Rourkela has six leprosy testing units but no physiotherapist has been appointed yet. Unless cases are severe, patients are not diagnosed, treated or tested at Rourkela Government Hospital (RGH).

Patients also face difficulties due to the shortage of paramedical staff and physiotherapists in all six hospitals in the city.

Residents say manpower and infrastructure must be strengthened to reduce the disease's prevalence.

When contacted Sundargarh DLO Mahendra Tanti said government instructions and regulations are being followed at the grassroots level to control the spread of the disease. He added that patients are being provided with medicines, rehabilitation facilities, government incentives, and awareness programmes are being held from villages to urban centers. Tanti expressed hope that the prevalence of leprosy

Bhadrak Plus III girl student found hanging in hostel bathroom

Bhadrak, August 12: An 18-year-old Plus III first-year arts student at Bhadrak Autonomous College was found dead Tuesday, hanging in the bathroom of a private hostel near Jagannathpur, within the Town police station jurisdiction, authorities said.

Mallick's father said she attended coaching classes Tuesday morning and spoke cheerfully with her mother before the incident. The family was notified of her death by suicide

Bhandaripokhari legislator Sanjib Mallick called the incident "tragic" and called for an impartial investigation. Police have registered an unnatural death case (56/25), and the investigation is ongoing.

ALLEGATIONS OF MISUSE SURFACE IN KEONJHAR DMF

Keonjhar/Hatadihi, August 12: Another instance of alleged irregularities and misuse of funds in Keonihar District Mineral Foundation (DMF) has come to light, with tenders reportedly being invited before projects were approved or sanctioned, a report said.

Former MLA Subarna Naik alleged that several works under the DMF have been executed without prior approval, and that a high-level probe could expose corruption among officials involved. Anandapur Civil Society secretary Bhagaban Mallick demanded recovery of misappropriated funds and strict action against those responsible.

According to DMF case record No-17/2024, the 10th trust board had approved a budget estimate of ₹12.89 crore for serial no-24 project. Case record No. 43/2024 shows that administrative approval was granted twice via DMF office order no-1039,



dated July 1, 2021, and order no-178, dated January 11, 2023. The project was later canceled and reapproved under DMF order no-184, dated January 12, 2023, with an administrative sanction of ₹96.21 crore.

Of this, ₹32.28 crore in three phases was sanctioned to the District Fisheries Officer (DFO) as the implementing agency. However, before the administrative approval and sanction, the District Fisher-

ies officer had invited tenders for the project September 13, 2022, and signed an agreement December 20, 2022. This has been mentioned in letter no-388, dated January 29. 2025.

Similarly, the 10th Trust Board had approved an estimated cost of ₹50 lakh for serial no-210 project. But DMF case record no-74/2024 shows that DMF office orders no-2391 and 2392 dated October 29, 2024.

sanctioned ₹12 crore through administrative approval for the project. The District Skill Development office, the implementing agency and the Employment Officer for the project, was sanctioned a grant of ₹3.60 crore. However, the agreement was signed on March 16, 2024, before the project's grant approval and For the 352nd project on

the 11th trust board's list, an estimated expenditure of Rs 32 crore had been approved. But as per DMF order no-3256, dated October 26, 2023, administrative approval was granted for ₹85.83 crore.

In one phase, the implementing agency, the Deputy Director of Horticulture, was sanctioned half of the grant, as recorded in DMF Case Record no-43/2024.

However, it was found that the grant sanction did not comply with the state chief secretary's 2019 directive to follow a 30:40:30 ratio.

Murder accused on run for 24 years arrested PRESS TRUST OF INDIA

Berhampur, August 12: Police arrested a 52-year-old man, who had been on the run for the last 24 vears after being accused in a murder case, an officer said Tuesday.

Acting on a tip-off, police apprehended the man, identified as Udaya Pradhan, from Chennai Monday, as part of 'Operation Garuda' launched by the Odisha Police to nab all fugitives.

Pradhan, along with his two brothers, allegedly hacked a man to death, identified as Kaibalya Pradhan, in Keranditola village in present-day Chamakhandi police station area in Ganjam district July 6, 2001 over a dispute.

Police had arrested Musha Pradhan, one of the brothers of Udaya Pradhan, the same day of the murder, while Udava and his elder brother Pancham absconded from the village.

"Police had earlier made several attempts to arrest Udaya Pradhan but he managed to evade arrests. However, after receiving reliable information, a police team rushed to Chennai and nabbed him," Ganjam Superintendent of Police Subhendu Patra said.

The accused was working in a construction firm in Chennai by identifying himself as Ganesh, said Sabyasachi Malla, inspec-

tor-in charge of Chamakhandi police station.

The two brothers - Udaya and Pancham - had initially fled to Bengaluru after the murder but after a dispute with the latter, Udaya had come to Chennai. Other members of his family, however, continued to stay in the village, Malla said.

Udaya's elder brother Pancham is still absconding and efforts are being made to nab him, he said.

Meanwhile, his younger brother Musha has been released from jail after completing his life sentence awarded by a local court for his involvement in the murder, police said.

Woman bedridden since birth denied full disability pension

Rayagada, August 12: For 20-vear-old Renuka Navak, life has been confined to a bed since birth. Suffering from cerebral palsy, she is entirely dependent on her mother for even the most basic needs. Despite holding a 90 percent disability certificate, she continues to receive only ₹1,200 a month in pension — far less than the ₹3,500 promised by the Odisha government to those with 80 percent or more disability.

Renuka's condition leaves her unable to sit or move unaided. Her head is disproportionately



large due to a brain disorder, and her limbs are severely underdeveloped and non-functional. She lives with her mother, Basanti Nayak, and younger brother in

a rented home in Rayagada's ru Nagar. Basanti works in several households to support the family while her husband works outside the district.

A 2013 disability certificate rated Renuka's impairment at 80 percent. After a government policy

change earlier this year, a new certificate issued March 26 upgraded her to 90 percent disabled. qualifying her for the higher pen-

sion. However, the increase has

yet to be implemented, and she has never received government aid for her treatment.

Moved by her plight, lawyer Gouri Patnaik, in whose home Basanti works, donated a modern bed brought from Visakhapatnam, Andhra Pradesh, on Sunday. Patnaik has urged the district administration and philanthropists to step in.

District Social Security Officer Shrikant Panigrahi said steps would be taken to ensure Renuka receives all benefits. But until then, her family's struggle — and the government's delay — remain painfully evident.

Tariff Tactic

he effects of US President Donald Trump's imposition of a 50 per cent tariff on Indian goods have started to be felt on the country's economy. Bad news has come from Tiruppur, the country's knitwear capital, Coimbatore and Karur in Tamil Nadu which collectively employ over 1.25 million workers and export ₹45,000 crore worth of garments annually. The helplessness and anxieties shown by the garments exporters, who are feeling the heat of the 50 per cent tariff, are a pointer to the shape of things to come. They have said orders are being paused, redirected, or lost entirely to competitors in Bangladesh, Pakistan, Vietnam, and Cambodia, all of whom have lower US tariffs ranging between 19 per cent and 36 per cent. Information reaching the exporters indicate they need to brace for an unprecedented situation as buyers are asking them to absorb the tariff hike before thinking of sending their products to US markets. The revised duties, including baseline and remedy-linked tariffs, now push effective rates for some knitted garments to even 64 per cent. This means the same products exported by the Asian rivals will be available in US markets at rates 35 per cent less than Indian garments. It is feared that there will be a virtual de facto trade embargo.

It is an irony that only a few weeks ago Indian exporters of garments were so optimistic about better profits helped by the India-UK Free Trade Agreement (FTA) and growing US interest in Indian goods. This led to many exporters in Tamil Nadu to invest in new machinery to meet the expected surge. That hope is now being replaced by abject despondency due to the retaliatory tariffs, especially with respect to China, which is now at 30 per cent and could see a further downward revision if Beijing manages to clinch a favourable deal with Washington. Indian exporters are crestfallen and clueless about how they can absorb the raised tariff with average margin of profits of 5 to 7 per cent. A nightmarish scenario is going to unfold. For, if exports contract 10-20 per cent due to loss of orders, it can threaten 100,000-200,000 textile and garment jobs collectively in the three hubs of Tiruppur, Karur and Coimbatore in the next few months.

The 50 per cent US tariff would hurt India's export industries and economy in other sectors such as gems and small businesses as well. The high tariffs are causing great worry because they put India's \$87 billion worth of exports to the US at risk and are a sign of worsening Indo-US relations. Leather, marine products, chemicals, and auto components face significant danger, with 55 per cent of India's US-bound exports at risk.

This is happening despite the US and India sharing a robust trade relationship, with bilateral trade reaching \$190 billion in 2024. India's top three exports to the US include pharmaceuticals (\$8.1 billion) telecom instruments (\$6.5 billion), precious stones (\$5.3 billion), while the US runs a \$45.7 billion trade deficit with India.

The tariffs threaten India's \$434 billion export with \$87 billion directed to the US, equivalent to 2.5 per cent of India's GDP. Industry estimates suggest a \$4-5 billion drop in engineering exports alone, while overall GDP growth could decline by 0.2-0.5 per cent, with forecasts revised from 6.5 per cent to as low as 6 per cent.

Indian foreign policy has hugely suffered in the past few years, with New Delhi left completely isolated and friendless. Relations with our neighbours have worsened and the Centre's Russia leanings and ongoing trade have put India in a wrong spot vis-à-vis the US. India has lost the narrative war in Operation Sindoor. Trump now wants to arm twist India over the purchase of oil from Russia to extract further concessions from New Delhi, especially in the farm and dairy sectors. The Indian government can hardly afford to antagonise farmers by letting American farm-based goods into Indian markets. However, time is running out for India. It must get an economic deal from the US with reasonable compromises reflecting pragmatism without being browbeaten into abject surrender. Now is not the time for optics but it's high time for mature diplomacy.

A NEW ECONOMICS OF WATER

gather in Cape Town for the African Water Investment Summit, there can be no equivocation: the world faces an unprecedented water crisis that demands a paradigm shift in how we value and govern our most precious resource. The scale of the challenge is staggering. Over half the world's food production now comes from areas experiencing declining freshwater supplies. Two-thirds of the global population faces water scarcity at least one month per year. More than 1,000 children under five die every day, on average, from water-related diseases. And if current trends continue, high-income countries could see their GDP shrink by 8% by 2050, while lower-income countries (many in Africa) face losses of 10-15%.

Yet this crisis also presents an extraordinary opportunity. As South Africa assumes the G20 presidency (for which I have been appointed special adviser to President Cyril Ramaphosa), it can champion a new economics of water that treats the hydrological cycle as a global common good, rather than as the source of a commodity to be hoarded or traded.

The economic case for action is compelling. The International High-Level Panel on Water Investments for Africa shows that every \$1 invested in climate-resilient water and sanitation delivers a return of \$7. With Africa requiring an additional \$30 billion annually to meet the Sustainable Development Goal (SDG) on water security and sustainable sanitation, the financing gap is significant; but it is surmountable with the right strategy. The Global Commission on the Economics of Water recently called for such a strategy. Treating water as a global common good and adopting mission-oriented approaches to transform the crisis into an opportunity requires that we recognise three critical facts. First, water connects us all-not just through visible rivers and lakes, but through atmospheric moisture flows that travel across continents. Second, the water crisis is inseparable from climate change and biodiversity loss, each of which accelerates

the others in a vicious cycle. And, third, water runs through every SDG, from food security and health to economic growth.

Yet too often, water investments follow the failed playbook of climate and development finance. There is a tendency to derisk private capital without ensuring public returns; to fund projects without strategic direction; and to treat water as a technical problem, rather than a systemic challenge. Such approaches risk creating water infrastructure that serves investors more than communities, exacerbates existing inequalities, and fails to address the interconnected nature of the water, climate, and biodiversity crises.

This interconnectedness demands a new economic framework that aims to shape markets proactively rather than simply fixing failures after the fact. We need to move from short-term cost-benefit thinking to long-term value creation, and that calls for mission-oriented investments that shape markets for the common good.

Missions require clear goals like ensuring that no child dies from unsafe water by 2030. Once goals are established, all financing can be aligned with them through cross-sectoral approaches spanning agriculture, energy, manufacturing, and digital infrastructure. Rather than picking sectors or technologies. the point is to find willing partners across all industries to tackle shared challenges. Such can also lead to economic diversification, creating new export opportunities and development pathways

Consider Bolivia's approach to lithium extraction. Rather than simply exporting raw materials, the country is developing strategies to avoid the traditional "resource curse" by building domestic battery-production capabilities and participating directly in the energy transition. In doing so, it is converting its resource wealth into innovation capacity, strengthening value chains, and creating new export markets for higher-value activities.

As matters stand, more than \$700 billion per year is channeled into water and agriculture subsidies that often incentivise overuse and pollution. By redirecting these resources toward water-efficient agriculture and ecosystem restoration, with clear conditions attached, we could transform the economics of water overnight. To that end, public development banks can provide patient capital for water infrastructure, while requiring private partners to reinvest

profits in watershed protection. Africa is uniquely positioned to lead this transformation. Its vast supply of groundwater remains largely untapped, with 255 million urban inhabitants living above known supplies. Combined with affordable solar power, these supplies present an opportunity to revolutionise agriculture. By focusing on efficiency and reuse, as well as on capacity building, data-sharing,

and monitoring and evaluation this relatively stable groundwater resource, accessed by solar-powered pumps, can be a decentralised alternative minimising the emissions, waste, and other environmental costs implied by larger infrastructure projects that disrupt natural waterflows. Through Just Water Partnerships - collaborative frameworks that pool such solar-groundwater projects for increased bankability while ensuring community ownership - international finance can be channeled toward water infrastructure that serves both national development goals and the global common good.

South Africa's G20 presidency – the first ever for an African country - offers a historic platform to advance this agenda globally. Just as Brazil has used its G20 leadership and role as host of the upcoming COP30 to drive climate action. South Africa can make water security central to the global economic agenda. With the 2026 UN Water Conference on the horizon, and with the international community recognizing that climate change cannot be tackled without also addressing the water crisis, the time is right for bold leadership. The African Water Investment Summit is not just another gathering, but should be a watershed. This is the moment when we should shift from treating water as a local resource to governing it as a global common good, moving from crisis management to proactive market shaping and from viewing mission-oriented investment as a cost to recognizing it as the foundation of sustainable growth.

Water security underpins Africa's aspirations for health. climate resilience, prosperity, and peace. With young Africans set to constitute 42% of global youth by 2030, investing in water is tantamount to investing in the world's future. The question isn't whether we can afford to act, but whether we can afford not to



'Bedroom Jihadis' become nuisance for security in JK

Srinagar, August 12: Security agencies in Jammu and Kashmir are grappling with a new and insidious threat in the form of "bedroom jihadis" -- people who manipulate social media from the safety of their homes to spread misinformation and incite communal discord, officials said.

This kind of enemy, far removed from the traditional armed terrorists, is at the heart of a sophisticated cross-border effort to destabilise the region,

An in-depth investigation has uncovered a network of social media handles, believed to be controlled by terror groups and their sympathisers in Pakistan, that have been actively intruding into local digital spaces, disseminating inflammatory content and propaganda with the clear objective of creating sectarian clashes and unrest in the Kashmir valley.

"After years of fighting armed terrorists, security agencies have been facing this hidden enemy in which these new-age jihadis use computers and smartphones to wage war from just about anywhere, spreading rumours and influencing youths," an official in the know of the developments said.

The trend emerged in 2017 but ended after an effective crackdown with curbs on the Internet post abrogation of the special status of the erstwhile Jammu and Kashmir in 2019.

After the successful completion of Assembly elections last year, the "bedroom jihadis" have surfaced again, possibly with an aim to destablise the elected government and create a sense of unrest, the officials said.

Security agencies have also uncovered a sophisticated and concerted effort by terror groups and their sympathisers operating from across the border to use social media platforms to incite sectarian clashes and destabilise the region.

The investigation, which has been underway for several weeks, involved scrutinising thousands of social media posts, comments and private messages and its analysis provided compelling evidence of a direct link between these malicious online activities and handlers located in Pakistan.

During Muharram days observed by the Shia community recently, there was tension between the two sects of the Muslim community over a post but effective handling by Srinagar police doused the fire before it could spread, the officials said.

Former Director General of Jammu and Kashmir Police Kuldeep Khoda says the successful identification and disruption of this cross-border social media plot highlight the evolving nature of threats

to security in Jammu and Kashmir.

"While traditional terror activities remain a concern, the digital battlefield is increasingly becoming a front where external forces seek to destabilise the region by exploiting local tensions, which should be nipped in the bud," he feels.

In the recent past, the virtual nature of this conflict was seen in a case where the personal details of Kashmiri Pandit migrants appointed under the Prime Minister's rehabilitation scheme were leaked on various social media platforms.

The malicious act, intended to create fear within the minority community, was swiftly countered by the Jammu and Kashmir Police and their investigation led to the arrest of a local youth who had been directed from across the border to carry out the act.

Officials coined the term "bedroom jihadis" to describe these people who operate in a virtual battleground where a "bloody war is fought, but with words".

However, this has a significant impact on young minds and the ease with which a rumour can spread poses a significant challenge, the officials said and explained, "Anyone, while sitting on his bed or sofa, can plant fake news in one of the thousand chat groups and the entire Union Territory can plunge into communal divide.

Jagan chaired liquor policy meeting

Amaravati, August 12: A chargesheet filed by the Andhra Pradesh police in connection with the alleged Rs 3,500-crore liquor scam in a court alleges former Chief Minister YS Jagan Mohan Reddy chaired a meeting held in July 2019 related to the new liquor policy under which the outlets would be run by the APSBCL, a government

The Special Investigation Team (SIT) probing the alleged liquor scam filed a 124-page supplementary chargesheet

The previous chargesheet filed last month mentioned former chief minister YS Jagan Mohan Reddy as one of the recipients of kickbacks averaging Rs 50-Rs 60 crore per month. The 305-page chargesheet, however, stopped short of naming Jagan as accused.

supplementary chargesheet alleged that the kickbacks were systematically laundered through low-profile individuals, such as office boys or employees

"During the discussions held in the meeting 29.07.2019 chaired by Chief Minister of Andhra Pradesh, matters relating to number of shops, hiring



structure, manpower transportation chargers, etc., have been finalised," the police said quoting a letter written by then Managing Director, APSBCL (Andhra Pradesh State Beverages Corporation Ltd).

Then police also alleged that Jagan also played a key role in the appointment of D Vasudeva Reddy an IRTS officer and accused No. 2 in the case, as Managing Director of APSBCL despite him being recommended for other posts by then Chief Secretary and other officials.

According to the chargesheet, former bureaucrat Rajat Bhar-

the Chief Minister's Office about the irregularities in the APSBCL. However, his warnings fell on deaf ears. Bhargava served as Special Chief Secretary for Excise when the alleged scam took place.

When contacted, former minister and senior YSRCP leader Ambati Rambabu told PTI that all the allegations made in the chargesheets are baseless and 'created" ones.

"During the course of investigation, it was revealed that the accused have systematically laundered the kickback amount with the help of low-profile in-

dividuals who were working as office boys or employees in the companies owned by the accused," officials said quoting the chargesheet.

"Such employees and individuals acted as couriers and mules for depositing illicit cash into a network of bank accounts linked to the syndicate," they

This pattern of cash layering and circulation demonstrates a deliberate attempt to conceal the origin of crime proceeds constituting a classic case of structured money laundering and concealment under the garb of petty deposits, they further said.

A portion of the liquor kickbacks was transferred to the employees and associates of the accused as salary, they further said adding it was also observed that several of such low-profile individuals were made to send the cash deposited into their account to other accused.

Several illegalities in modifying the Excise Policy in the year 2019 have been found during the course of investigation.

The hiring of the consultancy firm KPMG Advisory Services Pvt. Ltd. was intended to lend credibility to a flawed excise policy, the police said.

Andhra CRDA proposes projects for Amaravati

Amaravati, August 12: The Andhra Pradesh Capital Region Development Authority (CRDA) has proposed works worth Rs 81,317 crore for the greenfield capital city of Amaravati, with tenders already issued for projects valued at Rs 50,552 crore.

Chief Minister N Chandrababu Naidu reviewed the progress of Amaravati's construction at the Secretariat, in a meeting attended by Municipal Minister P. Narayana, senior officials, and contractors.

"CRDA has proposed works worth a total of Rs 81.317 crore for the construction of the capital city. Currently, it called tenders for projects worth Rs 50,552 crore," said an official press release.

Officials informed the CM that construction work has commenced on 74 projects, covering housing, public buildings, roads, ducts, flood control measures, and other infrastructure. The TDP supremo instructed officials to complete Amaravati construction work six months ahead of the schedule.

He reviewed the progress of infrastructure development in areas under the LPS (land pooling scheme) and the construction of residences for ministers, MLAs, officials, employees, and judges,

On returnable plots to farmers, Naidu called for measures which would neither inconvenience the peasants nor impact Amaravati's master plan.

Further, the CM instructed officials to expedite approvals to agencies intending to build their offices in the greenfield capital city, especially for institutions like BITS - Pilani. XLRI and others.

YSRCP demands cancellation of Pulivendula local body bypoll

Pulivendula (Andhra Pradesh), August 12: YS-RCP leader and Kadapa MP YS Avinash Reddy Tuesday demanded the cancellation of the Pulivendula ZPTC by-election, accusing Chief Minister N Chandrababu Naidu of causing widespread electoral malpractices, booth capturing and voter intimidation affecting fairness.

The Zilla Parishad Territorial Constituency (ZPTC) bypoll in Pulivendula began on a stormy note in Kadapa district as police have taken Avinash Reddy into custody Tuesday morning.

"Avinash Reddy demanded that the ongoing ZPTC by-elec-

tion in Pulivendula be cancelled and re-conducted under the supervision of central police forces," said a YSRCP press release quoting the MP.

Police placed a YSRCP leader and a TDP leader under house arrest. Avinash Reddy accused TDP and BJP MLAs of allegedly rigging of votes by bringing in party workers from other constituencies.

The Opposition party demanded re-polling in Pulivendula and Vontimitta under the watch of neutral central forces, ensuring transparency and protection of the people's mandate in both constituencies.

Mandal Parishad Territorial Constituency (MPTC) elections are being held in Ramakuppam

(Chittoor district), Karempudi (Palnadu district) and Vidavaluru (Nellore district) while ZPTC elections are underway in Pulivendula and Vontimitta

(YSR Kadapa district). The MP condemned the police action -- taking him into custody-- as atrocious. He alleged that it was done without notice or reason and claimed that hundreds of TDP supporters entered Pulivendula without facing any police action.

"Avinash Reddv's arrest in Pulivendula early this morning is an atrocious act by the police. This arrest was made without any prior notice or valid reason," said YSRCP in a press release.

Heavy rains lash Jammu region, schools shut

Authorities in Rajouri, Reasi and Poonch districts have ordered the closure of all schools in view of the adverse weather conditions

Jammu, August 12: Heavy rain lashed various districts of the Jammu region, triggering flash floods that damaged four structures and led to the closure of some inter-district

roads, officials said Tuesday. Authorities in Rajouri, Reasi and Poonch districts have ordered the closure of all schools in view of the adverse weather conditions.

Significant rainfall was recorded between 8.30 am Monday and 6.30 am Tuesday, meteorological department officials said. Reasi recorded the highest rainfall at 284 mm, followed by 204 mm in Katra, 166 mm in Udhampur, 199 mm in Kathua, 102 mm in Samba and 96 mm in Jammu. The rain triggered flash floods, landslides and mudslides in various places. No casualties have been reported, the officials said.

Portions of two houses on the banks of the Tawi river in the Beli Charana area were washed away by the flash floods, promoting police to warn people living along the river bank to not go near it.

Several temporary structures for housing animals were vacated in the Nikki Tawi area. Part of a school in the Surankote area of Poonch district was severely damaged after the flash floods struck during the intervening night of Monday and Tuesday, according to the officials.

The flash floods swept away a 200-ft-long shed adjacent to the school and a sports room, destroying all records and

sports items. There were no casualties in the incident, the officials said.

In Rajouri's Jaglanoo village, a cowshed collapsed, causing loss of livestock. The rain also caused multiple road blockages across the district, disrupting vehicular movement in several areas, they said.

The Kotranka-Khawas road has been closed at Kanja, while the Rajouri-Thanamandi-Surankote road remains cut-off following a landslide between DKG and Bufliyaz.

The Ghambir Mughlan-Thanamandi road is also blocked at several points, including Bhattian Morh and adjoining stretches, due to debris.

The Jammu-Srinagar high way also experienced traffic iams at Jagti as the road was inundated. The authorities also shut down the Udhampur-Samba road following landslides at several places, the officials said.

Five to six buffaloes, two cows were washed away in the flash floods in Kathua, they said.

The top court is hearing a batch of pleas against the Election Commission electoral roll revision exercise in Bihar. A bench of Justices Surva Kant and Joymalya Bagchi during the hearing remarked it "largely appears to be a case of trust deficit, nothing else" as it questioned the petitioners challenging the EC's June 24 decision of conducting the SIR on the ground that it would disenfranchise one crore voters.

"If out of 7.9 crore voters, 7.24 crore voters responded to the SIR, it demolishes theory of one crore voters missing or disenfranchised." the bench told senior advocate Kapil Sibal, appearing for petitioner and RJD leader Manoj Jha.

The top court also agreed with the EC decision to not accept Aadhaar and voter cards as conclusive proof of citizenship in the ongoing exercise and said it has to be supported by other documents.

Sibal contended that despite residents holding Aadhaar, ration and EPIC cards, officials refused to accept the documents. "Is it your argument that people who have no documents but are in Bihar and therefore he should be considered as a voter of the state. That can be allowed. He has to show or submit some documents (sic)," the bench said. When

The hearing would resume Wednesday. On July 29, terming the election commission a constitutional authority deemed to act in accordance with law, the top court said it will step in immediately if there is "mass exclusion" in the SIR of electoral rolls in Bihar.

GPR scanning helps identify 20 spots in **Dharali: Rescuers**

Uttarkashi, August 12: Rescuers Tuesday said they have identified 20 spots at a depth of 2.5-3 metres using Ground Penetrating Radars in the lower ar eas of the flood-ravaged Dharali where there is the possibility of people being trapped, officials said as search and rescue operations entered the seventh day

Heavy equipment is being used with great caution as the soil is marshy and sinking, while machines are strictly not being used at places where there could be life, they said.

A team of experts from the National Geophysical Research Institute (NGRI) is lending a helping hand in the search operation to trace the 66 people, including 24 Nepali labour ers, reported missing since the tragedy. According to the India Meteorological Department (IMD), there is moderate to high flash flood risk in a few watersheds and neighbourhoods of 11 of Uttarakhand's 13 districts, including Uttarkashi. over the next 24 hours.

The devastating flash flood August 5 virtually left almost half of Dharali village buried under mud and badly damaged an army camp in nearby Harsil.

"Through GPR scanning in the lower areas, 20 such spots have been found at a depth of two and a half to three me tres, where buildings or other similar structures have been detected.

"Light debris and then solid ground have been found below three metres which suggest there might be people trapped at that level," said an official of the National Disaster Response Force (NDRF), who is on ground zero.

Ground Penetrating Radars (GPRs) use radio waves to detect objects and structures up to a depth of 50 metres below the surface.

"Copy of this order should be circulated by Registry to Home Secretaries of all states

and UTs to ascertain whether any accused or convict has remained in jail beyond the period of sentence," the bench said

The order went on to issue di rections for release of such con victs if not wanted in other cases "A similar copy shall be send to member secretary National

Legal Service Authorities for onward transmission to all member Secretaries of state and UTs Legal Service Authorities for communi cation of District Legal Service Authorities in the states for the implementation of judgement,' it added.

The court said Yadav should have been released after he completed his sentence.

New Delhi, August 12: Enactment of the Bharatiya Nyaya Sanhita, repealing of outdated laws like triple talaq and sedition, and striking down of Section 377 will be part of the CBSE's Legal Studies curriculum from the 2026-27 academic session, according to officials.

The decision, approved by the Central Board of Secondary Education's (CBSE) Curriculum Committee and ratified by the Governing Body in June — will see senior secondary students study new laws that have replaced

colonial-era statutes, along with landmark judgments and doctrines that have reshaped India's legal framework.

"The legal studies textbooks for classes 11-12 were introduced over five years ago to build foundational legal literacy among senior secondary students. Since then, India's legal framework has undergone major reforms, including the repeal of key colonial-era areas and enactment of Bhara tiya Nyay Sanhita (BNS), Bharatiya Nagarik Suraksha Sanhita (BNSS) and Bharatiya Sakshva Adhinivam (BSA) in 2023-24, replacing IPC, CrPC and Indian Evidence Act, re-



spectively," the minutes of the meeting read.

According to CBSE officials, an expert committee will be formed and a content development agency may be engaged to ensure updated textbooks are ready for the next academic session.

"The textbooks will be designed according to modern, engaging pedagogy aligned

with the new National Education Policy (NEP)," a senior board official said.

First offered by the CBSE in class 11 in 2013 and class 12 in 2014, Legal Studies has evolved from a niche elective to a significant offering for students eyeing careers in law, public policy, or gover-

In April 2024, the Director-

ate of Education approved its rollout in 29 additional schools, urging principals to "complete all formalities asked by the CBSE"

It is reported that CBSE plans to form an expert committee and may engage a content development agency to prepare the revised textbooks.

These are expected to be ready ahead of the 2026-27 academic year. As reported by media sources, the updated material will aim to deliver a modern, student-focused approach to teaching legal concepts at the senior secondary

Legal Studies was introduced in Class XI in 2013 and in Class XII in 2014. In April 2024, the Directorate of Education approved its introduction in 29 additional schools. The subject has grown in relevance for students pursuing careers in law, public policy, or governance.

DGCA issues show-cause notice to IndiGo

Mumbai/New Delhi, August **12:** Aviation regulator DGCA has issued a show cause notice to IndiGo for alleged lapses in simulator training conducted for nearly 1,700 pilots, according to sources.

The sources Tuesday said the show cause notice was issued after scrutiny of records and replies received from the airline

IndiGo said it is in the process of reviewing the show cause notice.

The Directorate General of Civil Aviation (DGCA) found that Category C or critical air field training for around 1.700 pilots, including pilots in com mand and first officers, was conducted with non-qualified simulators, the sources said.

According to the sources, the regulator found that the simulators on which the nearly 1,700 pilots did their training were not qualified for operations at certain airports like Calicut, Leh, and Kathmandu.

Certain airports, like Calicut, which has a table top runway have additional requirements for flight operations.

"We confirm receipt of a show-cause notice issued by the DGCA pertaining to simulator training of some of our pilots. We are in process of reviewing the same and will respond to the regulator within the stipulated timeline," an IndiGo spokesperson said in a statement.



India, China likely to resume flight services

New Delhi, August 12: India and China are in an "advanced stage" of negotiations to resume direct flight services between the two countries soon, people familiar with the matter said Tuesday.

The development comes ahead of Prime Minister Narendra Modi's likely visit to the Chinese city of Tianjin later this month to attend the annual summit of the Shanghai Cooperation Organisation (SCO)

The move to resume the flight services between the two Asian giants also came amid some strain in India's ties with the US over President Donald Trump slapping a 50 per cent tariff on Indian goods.

New Delhi and Beijing are



moving forward in a "positive" trajectory to restart trade through four border transit points, the people cited above said.

The direct flight services between India and China were suspended in 2020 following the Covid-19 pandemic. The air connectivity remained suspended in view of the eastern Ladakh border row. The people cited above said the Indian and Chi nese negotiators are looking at firming up a new air services agreement to resume the flight

But if that is not materialised, then the two sides are set to resume the services using the existing air services

It is learnt that Air India has been sounded out about the possible resumption of flight services between India and China.

In the last few months, India and China have initiated a number of measures to repair the bilateral ties that had severely nosedived following the deadly clashes between the two militaries in June 2020.

Last month, India announced the resumption of issuance of tourist visas to Chinese nation-

New Delhi: The environment ministry's advisory committee has recommended 'in-principle' approval to a Telangana government proposal for de-notification of 1,501.88 hectares of reserve forest land to relocate five villages from the core area of the Amrabad Tiger Reserve in Nagarkurnool district. The state government has said the relocation is voluntary and aims to consolidate wildlife habitat, reduce human-wildlife conflict and improve ecosystem protection. A total of 1,54,977 trees of 27 species will be felled for the exercise, according to the proposal. According to the agenda note considered by the committee in its meeting July 30, the proposal sought diversion of forest land in compartments 465, 466, 467, 468, 469, 470, 471, 472 and 473 of the Bacharam Reserved Forest of Achampet Division for relocation of Kollampenta, Thatigundal Penta, Sarlapally, Kudichinthala Bailu and Vatvarlapally villages from the core area of the reserve.

Plane crashes into parked aircraft

Kalispell (US): A small plane landing Monday at a Montana airport crashed into parked aircraft, triggering a large fire but causing no serious injuries. authorities said. The singleengine plane carrying four people was attempting to land at about 2 pm at the Kalispell City Airport, according to Kalispell Police Chief Jordan Venezio and the Federal Aviation Administration, A preliminary investigation showed the pilot lost control. crashing onto the runway before the plane struck several parked aircraft, igniting fires on multiple planes. Kalispell police said. The fire spread to a grassy area before it was extinguished, Venezio said.

SK court orders

Seoul: A South Korean court Tuesday ordered the arrest of the wife of jailed former President Yoon Suk Yeol as investigators seek to charge her over various suspected crimes, including bribery, stock manipulation and meddling in the selection of a candidate. In granting a special prosecutor's request for an arrest warrant near midnight, the Seoul Central District Court said Kim Keon Hee poses a risk of destroying evidence. The investigation into Kim is one of three special prosecutor probes launched under Seoul's new liberal government targeting the presidency of Yoon, a conservative who was removed from office in April and rearrested last month over his brief imposition of martial

Explosion at US Steel plant leaves 2 dead

Clairton (Pennsylvania): An explosion at a US Steel plant near Pittsburgh left two dead and sent at least 10 to hospitals Monday and heavily damaged the sprawling facility, officials said. One worker was pulled from the wreckage hours after the explosion sent black smoke spiraling into the midday sky in the Mon Valley, a region of the state synonymous with steel for more than a century. **Allegheny County Emergency** Services said a fire at the plant started around 10.51 am. Authorities later said a second person had died. The explosion, followed by several smaller blasts, could be felt in the nearby community and prompted county officials to warn residents to stay away from the scene so emergency workers could respond.

Russia makes sudden advance in Ukraine

Moscow/Brussels, August 12: Small bands of Russian soldiers thrust deeper into eastern Ukraine Tuesday ahead of a summit this week between Russian President Vladimir Putin and US President Donald Trump, which European Union states fear could end in peace terms imposed on an unlawfully shrunken Ukraine. In one of the most extensive

incursions so far this year, Russian troops advanced near the coal-mining town of Dobropillia, part of Putin's campaign to take full control of Ukraine's Donetsk region. Ukraine's military dispatched reserve troops, saying they were in difficult combat against small groups of advancing Russian soldiers.

Trump has said any peace deal would involve "some swapping of territories to the betterment of both" Russia and Ukraine, which has up to now depended on the US as its main arms supplier.

Virtually all the territory in question is Ukrainian, alarming President Volodymyr Zelenskiy and his European allies.

Zelenskiv and most of his European counterparts have said a lasting peace cannot be secured without Ukraine's voice in the negotiations, and must comply with international law and Ukraine's sovereignty and territorial integrity.

They plan to call Trump Wednesday to sway him ahead of his summit in Alaska Friday with Putin, and they have praised the US president's peace efforts, if not every idea he has floated for getting there.

"An imitated rather than genuine peace will not hold for long and will only encourage Russia to seize even more territory," Zelenskiy said in a statement Tuesday after a phone call with Turkish Presi-

dent Tayyip Erdogan, who has hosted previous talks between Ukrainian and Russian leaders.

RUSSIA ADVANCES IN EASTERN UKRAINE

Ukraine faces a shortage of soldiers after Russia invaded more than three years ago, easing the path for the latest Russian advances.

"This breakthrough is like a gift to Putin and Trump during the negotiations," said Sergei Markov, a former Kremlin adviser, suggesting it could increase pressure on Ukraine to yield territory under any deal.

EUROPEANS LINK UKRAINE TO THEIR OWN SECURITY

European leaders have said Ukraine must be capable of defending itself if peace and security is to be guaranteed on the continent, and that they are ready to contribute further.

"Ukraine cannot lose this war and nobody has the right to pressure Ukraine into making territorial or other concessions. or making decisions that smack of capitulation," Polish Prime Minister Donald Tusk said at a government meeting, "I hope we can convince President Trump about the European position." Zelenskiy has said he and European leaders "all support President Trump's determination.'

Hungarian Prime Minister Viktor Orban, Putin's principal ally in Europe, was the only leader not to join the EU's statement of unity, and mocked his counterparts.

"The fact that the EU was left on the sidelines is sad enough as it is," he said. "The only thing that could make things worse is if we started providing instructions from the bench.'

Trump had been recently hardening his stance towards Russia, agreeing to send more US weapons to Ukraine and threatening hefty trade tariffs on buvers of Russian oil in an ultimatum that has now lapsed.

Even so, the prospect of Trump hosting Putin on US soil for the first US-Russia summit since 2021 has revived fears that he might put narrow US interests ahead of the security of European allies or broader

S Korea's Lee, Trump plan August 25 summit on defence, trade

Seoul, August 12: South Korean President Lee Jae Myung and US President Donald Trump will hold their first summit meeting August 25 in Washington to discuss strengthening the countries' alliance and economic security partnership, Lee's office said Tuesday.

Lee, who was elected president in a snap election in June, has made it a top priority to help his export-dependent country navigate the dramatic changes in the global trading environment triggered by Trump's tariff policies.

"The two leaders will discuss ways to develop the US-South Korea alliance into a comprehensive strategic alliance of the future in response to the changing international security and economic environment," presidential spokesperson Kang Yu-jung told a briefing.

Based on the tariff deal reached last month, the two leaders will advance partnership in the manufacturing sector, including in semiconductors, batteries and shipbuilding, as well as critical minerals and technology, Kang said.

A White House official also confirmed the meeting. Trump announced July 30 that the countries had reached a trade deal that would subject South Korean goods to 15% import duties, lowering the tariff he had initially set against one of America's top trading partners.

In return, Trump has said that South Korea will announce investment plans at the upcoming summit and that Seoul had committed to making \$350 billion of investments to be "selected" by him.

South Korean officials have offered differing details, however, and topics left unresolved by the deal - which has yet to be committed to writing - provide scope for more disputes

Israel has since said it will launch a new offensive and seize control of Gaza City, which it captured shortly after the war's outbreak in October 2023 before pulling out.

Israeli Prime Minister Benjamin Netanyahu's plan to expand military control over Gaza, expected to be launched in October, has increased a global outcry over the widespread devastation, displacement and hunger afflicting Gaza's 2.2 million people. It has also stirred criticism in Israel, with the military chief of staff warning it could endanger surviving hostages and prove a death trap for Israeli soldiers. It has also raised fears of further displacement and hardship among the estimated one million Palestinians in the Gaza City region.

Foreign ministers of 24 countries including Britain, Canada, Australia, France and Japan, said Tuesday the humanitarian crisis in Gaza had reached "unimaginable levels' and urged Israel to allow unre stricted aid into the enclave.

However, the gaps between the sides appear to remain wide on key issues, including the extent of any Israeli military withdrawal and demands for Hamas to disarm.



US, China extend tariff truce by 90 days

Washington/Beijing, August 12: The United States and China have extended a tariff truce for another 90 days, staying off triple-digit duties on each other's goods as US retailers get ready to ramp up inventories ahead of the critical end-of-year holiday season.

US President Donald Trump announced on his Truth Social platform Monday that he had signed an executive order suspending the imposition of higher tariffs until 12:01 am November 10, with all other elements of the truce to remain in place. China's Commerce Ministry issued a parallel pause on extra tariffs early Tuesday, also postponing for 90 days the addition of US firms it had targeted in April to trade and investment

"The United States continues to have discussions with the PRC to address the lack of trade reciprocity in our economic relationship and our resulting national and economic security concerns," Trump's executive order stated, using the acronym for the People's Republic of China.

Bangkok, August 12: A Thai soldier was injured by a land mine near the Cambodian border Tuesday, the Thai army said, days after the Southeast Asian neighbours agreed to a ceasefire following last month's deadly five-day conflict.

The soldier's left ankle was severely injured when he stepped on the mine while patrolling along a routine border route about 1 km (half a mile) from Ta Moan Thom temple in Thailand's Surin province, the army said in a statement.

The soldier is being treated in hospital, it said.

The incident is clear evidence that Cambodia has violated the ceasefire as well as international agreements like the Ottawa Convention against landmines, Thai army spokesman Major-General Winthai Suvaree said in the statement.

Cambodia continues to covertly plant landmines, while the Thai army has consistently adhered to peaceful approaches and has not been the initiating party, the statement said.

"Should circumstances become compelling, it may be necessary to exercise the right of self-defence under international law principles to resolve situations that cause Thailand to continuously lose personnel due to violations of ceasefire

agreements and sovereignty encroachments by Cambodian military forces," the army said.

Cambodia rejected the Thai charges. "Cambodia, as a proud and responsible State Party to the Ottawa Convention, maintains an absolute and uncompromising position: we have never used, produced, or deployed new landmines under any circumstances, and we strictly and fully honour our obligations under international law," the defence ministry spokesperson said in a post on social media.

It was the fourth time in a few weeks that Thai soldiers have been injured by mines during patrols along the border. Three soldiers were injured by a landmine in an area between Thailand's Sisaket and Cambo dia's Preah Vihear provinces Saturday.

Two earlier incidents led to the downgrading of diplomatic relations and triggered the clashes. Bangkok has accused Cambodia of planting landmin es on the Thai side of the disputed border that injured soldiers

July 16 and July 23. Thailand and Cambodia have bickered for decades over un demarcated points along their 817-km (508-mile) land border, with ownership of the ancient Hindu temples Ta Moan Thom and the 11th-century Preah Vi hear central to the disputes.

Myanmar security forces involved in systematic torture: UN

Geneva, August 12: United Nations investigators said Tuesday they have found evidence of systematic torture by Myanmar security forces and identified some of the most senior perpetrators.

The Independent Investigative Mechanism for Myanmar (IIMM), formed in 2018 to analyse evidence of serious violations of international law, said victims were subject to beatings, electric shocks, gang rape, strangulation and other forms of torture like the removal of fingernails with pliers.

"We have uncovered significant evidence, including eyewitness testimony, showing systematic torture in Myanmar detention facilities," Nicholas

Koumjian, head of the IIMM. said in a statement accompanying the 16-page report.

The torture sometimes resulted in death, the report said. Children, who are often unlawfully detained as proxies for their missing parents, were among those tortured, it said.

A spokesperson for Myanmar's military-backed government did not immediately respond to requests for comment. The military-backed government has not responded to over two dozen requests by the UN team for information about the alleged crimes and requests to access the country, the UN report said.

Retail inflation hits 8-year low



New Delhi, August 12: India's retail inflation in July eased below two per cent for the first time in eight years, on the back of falling prices of food items including vegetables and pulses, hurting some farmers, but will have limited impact on the central bank's policy decision.

Annual retail inflation slowed to 1.55 per cent in July as compared to 2.10 per cent in June.

The figure was the lowest since June 2017, according to a government statement, and below the Reserve Bank of India's tolerance band of two to six per cent. RBI mandated to not let inflation fall below or above the range for more than three quarters. "These inflation numbers are

Food prices have been the main driver for the drastic fall in inflation for the last eight months. Prices in July fell 1.76 per cent compared to a revised fall of 1.01 per cent in June.

Vegetable prices fell 20.69 per cent compared with a 19 per cent year-on-year fall in June, while prices of pulses dropped 13.76 per cent compared to a 12 per cent decline in the previous month. Farm cost inflation has risen while food prices are entering deflationary territory, Citibank's chief India economist Samiran Chakraborty said, citing this as a key reason that Citi's rural consumption index has peaked.

Net direct tax mop-up falls nearly 4%

New Delhi, August 12: Net direct tax collection dipped 3.95 per cent to ₹6.64 lakh crore so far this fiscal, mainly on account of higher refunds, according to government data released Tuesday.

Direct tax includes taxes on income paid by companies, individuals, professionals, and other entities.

As per the data released by the Central Board of Direct Taxes (CBDT), refunds issued so far this fiscal jumped 10 per cent to 1.35 lakh crore between April 1 and August 11. Net corporate tax collection

rose 3 per cent to about 2.29 lakh crore, while non-corporate tax (which includes individuals, Hindu Undivided Families (HUFs) and firms) mop up

dipped 7.45 per cent to 4.12 lakh between April 1-August 11, a

Securities Transaction Tax (STT) mop-up was 22,362 crore between April 1 and August 11. Total net collections stood

at about 6.64 lakh crore, a 3.95 per cent fall over 6.91 lakh crore collected in the same period last fiscal (2024-25). Gross collections (before re-

funds) stood at ₹7.99 lakh crore

1.87 per cent dip over ₹8.14 lakh crore in the year-ago period.

Price Waterhouse & Co LLP Partner Hitesh Sawhney said the decline in the net collections is mainly due to the higher volume of refunds issued, especially for the corporate tax.

ICRA Chief Economist Aditi Nayar said the direct tax collections seem to have been

dampened by high refunds of corporation tax collections and a later deadline for personal income tax return filings.

"The available data on tax collections suggests that the GoI's personal income tax and corporation tax collections are required to record a high double-digit growth in the re maining part of FY2026, to meet their respective FY2026 targets While this may seem challenging, the growth rates in net PIT and CT collections are likely to improve as the year progress es and the base normalises, Nayar said.

In the current fiscal (2025-26) the government has projected direct tax collection at ₹25.20 lakh crore, up 12.7 per cent year-on-year. The government aims to collect ₹78,000 crore from STT in FY26.

New Delhi, August 12: Inflow in Gold Exchange Traded Funds (ETFs) declined 40 per cent month-on-month to 1.256 crore in July, weighed down by concerns over high gold prices. particularly with ongoing news around tariffs.

Despite this drop, July's numbers mark the third consecutive month of positive flows.

According to data from the Association of Mutual Funds in India (Amfi), Gold ETFs attracted a net inflow of 1,256 crore in July, moderation from 2,081 crore registered in June.

This came following a net inflow of 292 crore in May. Before this, the category witnessed a net outflow of 6 crore in April and 77 crore in March. With this, Gold ETFs have garnered cumulative inflows of over 9,277 crore in this year (January-July). This indicates product growing role as a strategic allocation in portfolios, both for wealth preservation and as a counterbalance to risk assets.

The inflow led to an expansion in the category's assets under management, rising 4.4 per cent to 67.634 crore in July from 64,777 crore in the preceding month.

FinMin notifies corrigendum to Income Tax Bill interest

New Delhi, August 12: The finance ministry Tuesday notified a corrigendum to the Income Tax Bill with regard to interest to be charged on short payment of advance tax by a taxpayer. The corrigendum, which pro-

vides for 3 per cent interest on short payment of advance tax. aligns the clause with the existing provisions in the Income Tax Act, 1961. Taxpayers having a tax li-

ability of 10,000 or more have to pay advance tax in 4 instalments -- June 15, September 15, December 15 and March 15. Nangia Andersen LLP, Partner, Sandeep Jhunjhunwala

said that as per the corrigendum to Clause 425 of the Income-tax (No 2) Bill, 2025, the interest provision for shortfall in advance tax payment has now been aligned with that under the Income-tax Act, 1961. "If there is a shortfall in re-

mittance of advance tax even for a day beyond the statutory quarterly due date, interest is charged for a minimum of 3 months." Junihunwala said.

New Delhi, August 12: A consortium led by Bengaluru-based PixxelSpace has won the bid to build and operate India's first fully-indigenous commercial Earth Observation (EO) satellite constellation, the Indian National Space Promotion and Authorisation Centre (IN-SPACe) said Tuesday. The PixxelSpace-led consor-

tium, comprising Piersight Space, Satsure Analytics India and Dhruva Space, will launch a constellation of 12 EO satellites equipped with panchromatic, multispectral, hyperspectral and microwave SAR sensors over the next five years. The consortium will invest more than 1,200 crore over the next five years.

The Pixxel-led team edged out consortia led by Astra Microwave Products Limited and GalaxEye Space to win the bid to build the constellation under the Earth Observation satellite

constellation will feature a mix of sub-metre very-high-resolution, wideswath multispectral, Synthetic Aperture Radar (SAR) and hyperspectral satellites, enabling applications such as precision agriculture, water-quality monitoring, land-use mapping, environmental compliance, disaster

coming of age of India's private space industry in the space sector. It demonstrates the capability and confidence of Indian companies to lead large-scale, technologically-advanced and commercially-viable space missions that serve both national and global markets," Pawan Goenka, Chairman, IN-SPACe, said.

High GST on scrap, e-waste hurting India's circular economy

India's waste management sector is dominated by informal operators, who handle up

New Delhi, August 12: The steep GST of 18 per cent levied on several crucial waste categories has become an obstacle in the sustainable management of solid waste in India and is also leading to revenue losses of around 65,000 crore, according to a new study published Tues-

The study by think tank Centre for Science and Environment (CSE) finds that small dealers who collect scrap cannot afford an 18 per cent GST, so they keep their transactions cash-based and untaxed.

This not only deprives the government of revenue but also distorts the market, as compliant businesses struggle to compete with tax-evading informal operators. In fact, the informal sector

dominance results in an estimated 65,000 crore in annual GST losses due to unrecorded transactions. Without interventions, this loss is projected to escalate to 86,700 crore by 2035. "While India is rooting for

recycling of waste and promotion of a circular economy, the existing GST regime could be dumping all that effort into the proverbial 'waste bin'. For one, the regime does not differentiate between virgin and recycled materials, taxing them equally, which places recycled products at a severe cost disadvantage



despite their lower environmental impacts," said Nivit K Yadav, programme director, industrial pollution unit, CSE

This flies in the face of the National Steel Policy, which aims for 40 per cent of India's steel production to come from scrap by 2030. The 18 per cent GST on ferrous scrap makes it economically unviable for

small dealers to operate formally. A reduced rate would align the fiscal policy with the coun-

try's circular economy objectives, said Subhrajit Goswami, programme manager at CSE. Similarly, plastic waste, electronic waste and various industrial by-products are subjected

to an 18 per cent GST, creating

a significant cost burden that

pushes operators toward informal, cash-based transactions.

Speaking at the report release, Pranshu Singhal of NGO Karo Sambhav concurred: "No one actually looks at waste as a resource. They wake up only when both natural resources and waste are taxed at the same rates for them.'

India's waste management sector is dominated by informal operators, who handle up to 90 per cent of certain waste streams like e-waste and metal scrap. Millions of informal workers handle hazardous waste like batteries and e-waste without safety gear or fair wages. The CSE said formalising their work with social security, better pricing and access to healthcare is not just an economic necessity, it is a moral obligation.

The study recommends lowering the GST rates on critical waste streams, such as metal 18 per cent to 12 per cent in the short term, with a further reduction to 5 per cent. This would encourage and incentivise compliance while maintaining revenue neutrality.

Even a 50 per cent reduction in informal sector participation combined with a 12 per cent GST rate, could generate 62,384 crore in net revenue by 2035. The report proposes integrating informal workers into government schemes and providing them access to subsidised loans, health care and pensions. To strengthen Extended Pro-

ducer Responsibility (EPR) compliance, the report suggests linking GST benefits to verified recycling. Producers who meet EPR targets through formal channels could receive tax rebates, creating a self-reinforcing cycle of compliance and transparency.

NATIONAL SPORTS BILL

New Delhi, August 12: The National Sports Governance Bill was Tuesday passed by the Parliament with Rajya Sabha giving its nod a mere 24 hours after Lok Sabha, marking a historic first for India's sports administration that is now set to be regulated by a national board and have its own dispute resolution mechanism

The National Anti-Doping (Amendment) Bill, which reinforces NADA's autonomy as required by the World Anti-Doping Agency, was also passed by the Parliament. The two bills now await presidential assent to be notified as acts.

Soon after Minister of Youth Affairs and Sports Mansukh Mandaviya moved the bills for consideration and passage in the Upper House at 3pm, there were vociferous opposition protests over revision of electoral rolls in Bihar.

The opposition eventually staged a walkout led by Leader of Opposition and Congress President Mallikariun Kharge. who demanded a discussion on the revision of electoral rolls in Bihar. "In 20 countries, there is sports law. I request the Rajya Sabha to make India the 21st

country with a sports law," Mandaviya said in his address which was followed by a discussion that lasted over two hours.

During the discussion, BJD MP Subhashish Khuntia raised

concerns about the centralisation of sports governance due to the bill. He also felt that the bill did not have clarity on district and block level development of

DIFFERENCES WITH SPORTS CODE

"The bill should empower, not control," he said.

Mandaviya responded by saying that the government is only seeking to be a facilitator.

"In this bill, we are bringing transparency, not control, not interference. Government doesn't want to control. We are being the supporters and providers of a structure," he asserted. Former All India Football Federation President and NCP leader Praful Patel and Indian Olympic Association President PT Usha, who is a nominated member, were among the prominent voices who lauded the bill.

"This bill will usher in transparency, accountability, and gender parity. It will empower athletes and build confidence among sponsors and federations. It is about justice and fair-play," said Usha.

Mandaviva has described it as "the single biggest reform in sports since independence.'

Age Cap: While the Sports Code capped the age of administrators at 70, the new bill allows an office-bearer to complete his/her tenure if they were less than 70 at the time of filing nominations. A further relaxation of another five years has been made for contesting elections if the international statutes and byelaws allow for it in the concerned

Tenure: The Sports Code allowed three terms with a cooling off period after two terms for the President and two terms for Treasurer and Secretary. The sports bill allows office-bearers (President, Secretary General and Treasurer) to serve three consecutive terms of a maximum of 12 years and remain eligible for election to the Executive Committee after a cooling off period.

Executive Committee: The sports code had no provision for mandatory women's representation in the committee whose strength was capped at 15. The new bill mandates that at least four members of the EC must be women along with two sportspersons of outstanding merit.

Regulatory Body: The sports code had no provisions for a regulatory body to oversee NSFs, leaving the power to recognise or derecognise in the hands of the sports ministry. But the sports governance bill outlines the creation of a National Sports Board which will fulfil this role.

The National Sports Tribunal, which will adjudicate sporting disputes, the National Sports Election Panel to oversee polls in NSFs and the Ethics Commission were not a part of the Sports Code. All these bodies will have a significant role to play once the bill becomes an act.

RTI: All recognised sports organisations, which are dependent on government funding and support, will be covered under the Right to Information Act. 2005 "with respect to the exercise of its functions, duties and powers." This ensures that the BCCI, which is not relying on ministry funding, will readily come under the hill's amhit. It will have to register itself as an NSF with the NSB as cricket is set to debut as an Olympic sport in the 2028 Games in the T20 format.

Govt's discretionary powers: Any sports organisation wanting to use the word "India" or "Indian" or "National" or any national insignia or symbols will have to obtain a No Objection Certificate from the central government. The central government, if it considers "necessary" and expedient in the public interest, will have also have the power to "relax" any of the provisions mentioned in the bill. In addition, the government can also give such directions to the National Sports Board or any other person or entity for the "efficient administration" of the provisions of this bill.

Dubai, August 12: The epic double hundred in a winning cause at Edgbaston will forever be etched in the memory of Indian skipper Shubman Gill, who was Tuesday named ICC's 'Player Of The Month' for scoring 754 runs in the recently-concluded five-Test series against England.

Gill, who was inspirational both as a batter and skipper, led from the front with four hundreds as a young Indian team without Virat Kohli and Rohit Sharma drew 2-2 against England.

The Indian skipper, who won the award ahead of his England counterpart Ben Stokes and South Africa all-rounder Wiaan Mulder, said he was hoping to continue his good form in the season ahead.

"It feels great to be named the ICC Player of the Month for Julv. This time it holds a lot more significance since it has come for my performances during my first Test series as captain. The double ton in Birmingham is obviously something I will

cherish forever and will be one of the highlights of my tour to England," Gill was quoted as saying in an ICC media release.

"The Test series against England was a learning experience for me as captain and we had some outstanding performances from both sides, which I am sure players from both sides will remember for a long time."

The 25-year-old skipper is hopeful that he can continue his good form in the upcoming series.

"I would like to thank the jury for selecting me for this award and my teammates who have been with me during the course of this exciting series. I look forward to continuing my form in the season ahead and bring more laurels for the country.

Gill became the first male player to win the 'Player of the Month' award four times after a stupendous run in England saw him score 567 runs (out of 754 runs) at an average of 94.50 in the three Tests played in July.

His previous ICC Player of the Month awards were in January 2023, September 2023 and February 2025.

The highlight for Gill during this period was his aggregate of 430 runs in the second Test in Birmingham, the second high est ever in a Test match.

His scores of 269 and 161 in that Test helped India level the series 1-1. He also chipped in with a useful 103 in the second innings of the fourth Test in Manchester that helped draw the match and keep the series

Apart from Gill, England batter Sophia Dunkley was adjudged women's 'Players of the Month'. England batter Dunkley edged her team-mate Sophie

Ecclestone and Ireland captain Gaby Lewis for the honour, showing a fine run during this period in ODIs as well as T20Is. She played in all seven

matches at home against India across the two formats, aggregating 270 runs in three ODIs and four T20Is.

Dunkley was England's lead ing scorer in the T20I series and smashed a superb 92-ball 83 in the first ODI in Southampton.

Gukesh was outplayed by Aronian in a complex opening-round battle but rebounded strongly, producing a resounding victory against Oparin before crushing Liem to end the day with four points out of a possible six Monday.

With each rapid win worth two points, Aronian took the early lead by winning all three games on the opening day. Fresh from his triumph in the recently concluded Freestyle Chess tournament in Las Vegas, the American GM beat key rivals Nodirbek Abdusattorov of Uzbekistan and Maxime Vachier-Lagrave of France to maintain a perfect score.

Aronian sits on six points, followed closely by compatriot

Fabiano Caruana on five after two wins and a draw. Gukesh shares the third place with another American, Wesley So, while Vachier-Lagrave and Leinier Dominguez Perez are tied for fifth with three points each.

Liem and Oparin are next on two points, Nodirbek has one, and Sam Shankland is last after losing all his games.

For Gukesh, the first round was a heartbreak as he went

down in extreme complexities arising from a Caro Kann defense game.

However, he recovered quickly, defeating Oparin in style. The finale was picturesque out of a Sicilian Rossolimo as the Indian sacrificed his queen to checkmate the Russian turned American.
