### India alerts Pak about potential flood in Tawi

New Delhi, August 25: India has informed Pakistan about a flood alert in the Tawi river on humanitarian grounds, even as the Indus Waters Treaty (IWT) continues to remain in abeyance in the aftermath of the Pahalgam terror attack, sources said.

It is the first known official contact between India and Pakistan since a four-day conflict between the two sides in May.

The communication was made to the Ministry of External Affairs, which then reached out to Islamabad, sources in the Jal Shakti Ministry said.

"While India used to exchange data with Pakistan before the suspension of the treaty, this move was made purely on humanitarian grounds," a source said.

The Tawi river originates in the Himalayas and passes through the Jammu division before assembling in the Chenab in Pakistan. India's decision to suspend the decades-old treaty came after terrorists with cross-border links killed 26 people, mostly tourists, in Jammu and Kashmir's Pahalgam April 22.

Brokered by the World Bank, the Indus Waters Treaty governed the use of the Indus river and its tributaries between India and Pakistan since 1960. Earlier, Pakistani news out-

let The News reported that India has contacted Pakistan to share information about possible flooding. Citing official sources, the paper said that India alerted Pakistan about a possible major flood in the Tawi river in Jammu. The Indian High Commission in Islamabad conveyed the alert on Sunday, it added.

Pakistani authorities issued warnings based on the information provided by India, it added.

The flood alert from India comes as Pakistan witnesses one of its deadliest monsoon rains, with a death toll of 800.

Jajpur/Bhograi/Bhadrak, August 25: Floods in two major rivers have left over 1.67 lakh people marooned in Jajpur, Balasore and Bhadrak districts Monday, reports said, adding that one person

drowned in Jajpur. In Jajpur district, a 70-ft-long breach occurred around 4am Monday on the right embankment of Kani river, a distributary of Baitarani, near Bangal abadi in Kasapa panchayat of Dasharathpur block. More than 100 houses near the breach were submerged up to window level, forcing hundreds to flee to embankments and flood shelters.

The breach flooded parts of Mallikapur and Kasapa panchayats, directly affecting nearly 50,000 people. Informed, District Collector Ambar Kumar Kar, ADM Sibananda Swain, and BDO Akash Pattnayak rushed to the spot. Officials said rescue operations were carried out on a war footing to evacuate ma rooned villagers. A 70-year-old man died af

ter being swept away by the floodwaters of Baitarani river in Jajpur district Sunday. A 23-day-old infant was among those rescued from rising waters Monday.

# Odisha IT Policy 2025 PM Modi's degree 'personal info' gets Cabinet approval

Bhubaneswar, August 25: In a decisive step towards strengthening Odisha's digital and industrial infrastructure, the 24th Cabinet meeting chaired by Chief Minister Mohan Charan Majhi approved several key proposals Monday, including the Odisha IT Policy 2025. The meeting was held at the Conference Hall of Lok Seva Bhawan.

Briefing the media after the meeting, Chief Secretary Manoi Ahuja stated that the Cabinet approved four key proposals from three departments. These include two major policy frameworks from the Electronics and Information Technology (E&IT) department, personnel appointments by the General Administration & Public Grievance department, and administrative arrangements for the upcoming Monsoon session of the state Assembly

Odisha IT Policy 2025 aims to create a robust digital ecosystem by embracing cutting-edge technologies such as Artificial



Intelligence, Cloud Computing. Data Analytics, Blockchain, and 5G. The policy sets an ambitious target of generating one million direct and indirect employment opportunities in the IT and IT-enabled services (ITES) sector. It also envisions the development of new infrastructure including IT Parks, Special Economic Zones (SEZs), and Co-Working Spaces, while promoting research and development and encouraging partnerships with startups and academic institutions.

To attract investments and nurture the state's digital economy, the policy offers a broad range of business-friendly incentives such as capital subsidies, rental assistance, utility charge exemptions, SGST reimburse-

ments, and support for marketing and patent registration.

In another key decision, the Cabinet approved the Odisha Electronics Component Manufacturing Policy 2025, a move aligned with the 'Make in India' initiative. The policy proposes substantial incentives for largescale investments, including a 50 per cent capital subsidy for initial projects, turnover-based benefits, and a ten-year exemption from electricity duty. Special concessions will be extended to mega projects involving investments over ₹500 crore or those

creating more than 1,000 jobs. The Cabinet also cleared the appointment of three new members to the Odisha Public Service Commission (OPSC). The appointees include Udava Naravan Das. retired IAS officer and former Director of Census Operations; Mihir Prasad Mishra, retired Principal of SCS (Autonomous) College, Puri: and Manoi Kumar Mohanty, retired IAS officer and former Additional Secretary in the General Administration & Public Grievance department.

### Seaplane services to restart by Oct: Naidu

Bhubaneswar, August 25: The Civil Aviation Ministry will restart seaplane operations on at least two routes in India by October, Union Minister Ram Mohan Naidu said here Monday.

Addressing the Eastern Region Civil Aviation Ministers' Conference, Naidu said, "Seaplane operation was there once, but it was limited to a single route. The government has simplified the guidelines to operate seaplanes, and we hope that by October, we will have two seaplanes in the country operating either on the Andaman & Nicobar, Kerala, or Andhra Pradesh network.

He added that the service could also be extended to Odisha's Chilika Lake and the entire eastern coast.

The service can be started on any water body where you have more than five feet depth and 200 metres of landing space,

Bikaner, August 25: In a striking blend of history and cinema, the Indian Air Force's iconic MiG-21 fighter jets thundered across the skies one last time at the Nal Air Force Station in Bikaner, even as cameras rolled to capture the jet's swan song for Sanjay Leela Bhansali's upcoming film Love And War. Vanity vans lined up on the tarmac, film crews buzzed with anticipation, and the moment was surreal – a historic farewell doubling as a cinematic milestone.

The film, starring Ranbir Kapoor, Alia Bhatt, and Vicky Kaushal, is rumoured to be a love triangle set against a wartime backdrop. The Russian-origin MiG-21, long hailed as a "rocket with wings," will feature prominently - both as a cinematic symbol and a real-life war hero making its final bow.

These final sorties August 18 and 19 mark the beginning of the end for the IAF's supersonic workhorse that has dominated the Indian skies for over six decades. Air Chief Marshal AP Singh led the farewell with solo flights, calling the aircraft "agile, manoeuvrable, and un-

forgettable." His connection with the jet dates back to 1985 when he first flew the Type-77 variant in Tezpur. "The MiG-21 was built to intercept and it served that







# Pilot training for tribal girls soon

Bhubaneswar, August 25: The state government will soon launch a cadet pilot programme to train tribal girls to become pilots, Chief Minister Mohan Charan Majhi said while addressing the Eastern Region Ministers' Conference on Civil Aviation here, Monday.

The cadet pilot programme would start under the state's flagship initiative B-MAAN (Building and Management of Aviation Assets and Network), he said.

According to officials, comprehensive theoretical and practical pilot training will be provided free to about 10 to 15 tribal girls per year for five years.

The CM said that a worldclass international airport is being built in Puri, and it will be a spiritual and cultural gateway for crores of devotees of Lord Jagannath from all over the world.

During his hospital stay, several prominent leaders, including Odisha ministers and Opposition leaders, had visited Patnaik.

### Patna-Puri spl train to tackle festive rush

Bhubaneswar, August 25: To cater to the festive rush during the upcoming Puja season, Indian Railways has announced introduction of Weekly Puja Special Train service connecting Patna and Puri. The move aims to manage the expected surge in passenger traffic and provide improved travel facilities.

According to an official release, the special train (03230/03229 Patna–Puri–Patna) will depart from Patna every Thursday from August 28 to December 25, 2025, while in return direction it will operate on Fridays from August 29 to December 26, 2025.

The train will include one Second AC coach, two Third AC coaches, nine Sleeper Class coaches, six Second Class seating coaches, two Luggage-cum-Second Class coaches, equipped with differently-abled-friendly facilities.

The special train will halt at major stations including Bakhtiyarpur, Barh, Mokameh, Kiul, Jhajha, Jasidih, Madhupur, Chittaranjan, Asansol, Durgapur, Barddhaman, Dankuni, Andul, Kharagpur, Balasore, Bhadrak, Jajpur Road, Cuttack, Bhubaneswar, Khurda Road, and Sakhigopal in both directions.

Indian Railways expects this service to provide much-needed relief to travelers heading to the coastal temple town of Puri and other destinations during the festive season.

# State govt to implement livelihood schemes to curb distress migration

Bhubaneswar, August 25: The state government has decided to implement effective livelihood schemes like Odisha PVTG Livelihood Model and the Chief Minister's Tribal Livelihood Mission to curb the migration of workers from Odisha, official sources said Monday.

The decision was taken at the third meeting of the High-Level Task Force on Distress Migration held here under the chairmanship of Deputy CM and Agriculture and Farmers' Empowerment Minister KV Singh Deo. The state government had earlier engaged The Nudge Foundation to conduct a study on the causes of migration and suggest possible solutions.

Based on the survey report.

Based on the survey report, the task force resolved to expand livelihood opportunities and skill training for migrant workers. Currently, various welfare schemes such as MGN-REGS, Subhadra, input support to farmers, CM's Agriculture Enterprise scheme, Kamdhenu, goat farming, and plantation programmes are being implemented across the state.

The government has decided to ensure 100 per cent coverage of these schemes in migration-prone districts and blocks. For this purpose, satu-

ration drives will be conducted, and department officers and secretaries will verify the full coverage of beneficiaries.

Official sources said migra-

tion has already reduced to some extent following the implementation of input support to farmers during the kharif and rabi seasons. In addition, departments including Labour, Rural Devel-

opment, Panchayati Raj and Drinking Water, Fisheries and Livestock Development, and Agriculture have discussed strategies to further check distress migration.

These include more irrigation support through chan-

These include more irrigation support through channels and canals, an additional 200 wage days for unskilled workers under state-supported MGNREGS, Gram Uday, development of Model Gram Panchayats, and promotion of contract farming—aimed at generating income equivalent to what workers would otherwise earn by migrating.

A committee will soon be formed to monitor outcomes at the household level, curb distress migration, and crack down on labour sardars. This committee will function in mission mode in coordination with enforcement officials, police, railway authorities, and district administrations.

# Cop takes bribe from scrap dealer, arrested

Bhubaneswar, August 25: Vigilance sleuths Sunday apprehended sub-inspector (SI) Jagga Bariha of Bijepur Police Station in Bargarh district while demanding and accepting a bribe of Rs 7,000 from a scrap dealer.

According to Vigilance sources, the SI had demanded Rs 10,000 from the complainant for allowing him to run his scrap business smoothly and for not lodging any case against him.

When the complainant expressed his inability to pay the full amount, Bariha reduced the demand to Rs 7,000 and threatened to take stern action if the bribe was not paid.

Left with no option, the scrap dealer reported the matter to the Vigilance authorities.

Acting on the complaint, Vigilance officers laid a trap and caught Bariha red-handed while accepting Rs 7,000. The bribe money was recovered from his possession and

Following the trap, simultaneous searches were conducted at three locations linked to Bariha to investigate disproportionate assets.

Sambalpur Vigilance has registered a case against the accused SI under Section 7 of the Prevention of Corruption (Amendment) Act, 2018. Further investigation is underway, sourc-

### Man gets life term for niece's rape, murder

Bhubaneswar/Berhampur, August 25: A POCSO court in Berhampur Monday awarded life imprisonment to a man after holding him guilty of rape and murder of his five-yearold niece in Ganjam district in April this year.

The court awarded Kalia Nahak alias Sanda Kalia, 27, rigorous life imprisonment under Section 6 of the POCSO Act. He was also convicted under Sections 103(1), 238(a), and 137(2) of the BNS.

The court directed the District Legal Services Authority (DLSA) to provide Rs 5 lakh as compensation to the victim's family. The girl's mother said she trusted the judiciary but a death sentence would have brought peace to her daughter's soul.

According to the prosecution, the minor girl was playing outside the home at Kholingi vil-



lage under Pattapur police limits in Ganjam April 25 evening when Nahak kidnapped her. He later raped the child, killed her and dumped the body at an under-construction Anganwadi building.

Following the complaint, police launched an investigation and arrested the accused.

The matter was initially treated as a blind case, but scientific evidence and investigation, led by inspector Dipti Ranjan Behera under the supervision of the Ganjam Superin-

tendent of Police, established the involvement of the accused, the prosecution said.

The chargesheet was filed within 50 days, and 20 prosecution witnesses were examined in a record timeframe. The trial concluded with conviction within four months.

The proceedings were monitored by the Inspector General (Southern Range) and the Inspector General (CAW), while close coordination between the prosecution and police secured the conviction.

### Fertilizer crunch hits farmers in Ganjam

Bhubaneswar: Farmers in Ganjam district are facing an acute shortage of phosphate fertilizers during the Kharif paddy season. With agricultural cooperative societies running out of stock, dealers are reportedly hoarding and selling fertilizers at double the official price, sparking widespread resentment among the farmers. In Beguniapada block, farmers alleged that urea is being sold at Rs 700 per bag in black market. "Due to non-availability of the fertilizer at societies, dealers are exploiting farmers by charging double the price," claimed farmer leader Johan Swain. In Chhatrapur block, urea is being sold at Rs 520 per bag, farmer leaders Narendra Padhiari, Mohan Behera, Kuna Das, and Jay Lenka alleged. Farmers in Khallikote block also complained about rampant black marketing of fertilizers due to scarcity. They demanded immediate government intervention to check irregularities and ensure timely supply. Every year, farmers encounter similar fertilizer shortages. Members of Rushikulya Rayat Mahasabha, led by Simanchal Nahak, urged the Agriculture department to promote organic farming and use of farmyard manure. "If farmers are encouraged to use more organic manure, dependence on chemical fertilizers will reduce and soil fertility will also improve," Nahak said.

From triage to fire safety, the six-day training empowers healthcare leaders to ensure continuity of care during crises

Bhubaneswar, August 25: Hospitals are the lifeline during disasters, and strengthening their preparedness and continuity plans is vital to ensure critical care reaches people when it is needed most, said AIIMS-Bhubaneswar executive director Ashutosh Biswas here Monday.

The remarks were made at the inauguration of a six-day Capacity Building Training on Hospital Preparedness for Health Emergencies, organised by AIIMS-Bhubaneswar in collaboration with the Disaster Management Cell, Ministry of Health & Family Welfare (MoHFW), Government of

"This event is a step towards building disaster-resilient healthcare systems in the country," said Biswas.

The programme aims to equip hospitals to respond effectively during disasters ment Act, triaging, logistics while ensuring uninterrupted communication, fire safety healthcare services. Senior healthcare professionals from Odisha, Meghalaya, West Bengal, and Assam are taking part, including consultants, district medical officers, medical superintendents, senior medical officers, hospital administrators, and managers

The inauguration ceremony was graced by medical superintendent Dilip Kumar Parida, DDA Lt Col Abhijit Sarkar, and nodal officer Jayanta Kumar

The training covered a comprehensive set of modules, including: hospital disaster management principles, hospital emergency incident response systems, the Disaster Managemock drills, psychosocial care hospital evacuation, continuity of services, and return to nor malcy. ### 'Pandian retires from politics, not from Naveen'

Bhubaneswar, August 25: The Biju Janata Dal (BJD) Monday said that bureaucrat-turned-politician VK Pandian might have announced his retirement from politics, but not from former chief minister Naveen Patnaik.

The BJD made this announcement at a press conference addressed by party's spokespersons Lenin Mohanty and Tambunath Panda.

"The people of Odisha know very well that VK Pandian has announced his retirement from active politics, not from former chief minister Naveen Patnaik. Therefore, there should be no dirty politics about Pandian,' Mohanty told reporters here.

The BJD's clarification in regard to Pandian came hours after BJP MLA Saroj Padhi made some adverse remarks against the former IAS officer.

Padhi, earlier in the day, had accused Pandian of eveing the BJD's fund, the amount of which would be nearly ₹1,000 crore. "Pandian remains glued



to Patnaik only for party fund. Therefore, he sidelined many BJD leaders who were once close to Patnaik. His real motive is no longer hidden," Padhi alleged.

The BJP MLA's statement sparked a political controversy.

The BJP leaders, including Padhi, are utterly frustrated after knowing that the government has failed to meet the aspirations of the people. BJD will continue to win the upcoming rural polls in 2027 and the general elections in 2019. Patnaik will again become chief

minister," Mohanty claimed. Referring to Patnaik and Pandian's relationship, the BJD in a statement said, "We do not need to give clarification to the people of the BJP who are close to Patnaik. They are just afraid of Patnaik and fear of losing the next elections.

The regional outfit claimed that the BJD is a successful political party and its president, Naveen Patnaik, is the most popular leader in the state. Two days ago, BJD leader

and opposition Chief Whip in the Assembly, Pramila Mallik, had also said, "It is another matter whom Patnaik will choose to assist him. It is his personal matter, and there should be no politics over this.'

However, issues relating to Pandian are being discussed in the political circles in the state since August 20, when Patnaik was admitted to a private hospital. Pandian and his wife Sujata Karthikeyan were found at the hospital, and the party also released two videos of him.

The first video, released on August 20, showed that Patnaik, while being discharged from the hospital, came out holding Pandian's hand.

The second video, which was released within 24 hours. showed that Pandian was very much present when Patnaik's elder brother, Prem Patnaik. was being briefed by the doc tors on the treatment and health of the Leader of Opposi tion in the Assembly.

Pandian was also seen July 12 at Naveen Niwas when Patnaik returned from his spine surgery in Mumbai.

The bureaucrat-turned-pol itician had announced his 'sanyas' from active politics June 9, 2024, after he was held responsible by a section of people for the regional party's defeat in Lok Sabha and state Assembly elections.

Pandian had opted for vol untary retirement from civil service in October 2023 and officially joined the BJD next

Before the 2024 elections, though Pandian did not take any official post in the party. he was a star campaigner for the BJD and covered all the 147 Assembly segments in the state



"He said he couldn't even move his eyelashes. Then he remembered the victory breath. Now, he uses it constantly. He believes this practice not only saved his life but also enabled him to protect four others in his unit," Natalia recounted.

Since 2022, the Art of Living has reached more than 8,000 people - soldiers, displaced civilians, and children from occupied territories — through its programmes. Volunteers often risk their lives to bring healing where it is needed most. "It is an honour and a deep inspiration to support those who need it most right now," said one instructor.

block has 240 AWCs under the state Women and Child Development (W&CD) department, of which 201 operate from their own buildings. However, 78 of these centres suffer roof leakage during rains. Another 39 centres lack their own buildings and continue having classes in schools, community

The centres are tasked with providing preschool education, nutrition and healthcare for children, adolescent girls and pregnant women. Despite the disruption, food and health services are continuing.

Khemunduguda six, Raisingh 18, and Chatua has four. Children, adolescent girls, Anganwadi workers, and assistants are unable to remain inside and run for cover when it starts raining. Block development officer (BDO) Durgaprasad Dora and assistant executive engineer Jhashaketan Behera said funds were recently sanctioned for the construction of buildings at four AWCs in Darengba, Gulpandi, Khadaput and Dumuriguda.

They added that more than 60 AWCs will receive grants of ₹45,000 each from the W&CD department for repairs. The block and panchayat offices have also decided to support renovation of additional centres. Officials said all pending works will be completed soon. A cross-section of people in the region urged authorities to expedite development of AWCs, which serve as the first step toward children's

Ganjam, August 25: Police have unearthed a bizarre case of land fraud in which a deceased man was shown as alive and his land sold using forged documents. Three people have been arrested and produced in court following preliminary investigations. The arrested are: Manoj

Kumar Gouda, 30, of Kumar begpalli in Chhatrapur; Dillip Mali, 51, of Kalajamuna; and Dandapani Behera, 78 of Nimakhanda Bandha Sahi in Berhampur. Police seized fake Aadhaar cards and bank passbooks from them.

According to police, one of the arrested posed as the fake landowner while the other two acted as brokers. Sub-inspector Aniruddha Swain said the accused fraudulently sold the land belonging to a deceased man by passing him

Records showed that real Dandapani Behera, a resident of Haladia Padar, had died in 2004. He owned 2.642 acre land under Malada panchayat Since most of his family members lived outside the state permanently, the land was left neglected. Taking advantage, the accused conspired to forge ownership documents and sell the property.

The fraud came to the fore when Dandapani's son, Manas Behera, discovered discrepancies while veri-



mutation. He lodged a written complaint at Ganjam police station August 20. A case (270/2025) was registered, and an investigation started under the supervision of station in-charge Shradhanjali

Police said in 2024 the accused used a forged Aadhaar card to impersonate the deceased Dandapani, showing him as a 78-year-old, and sold the land to a local man D Bikash.

The registration was completed at Ganjam sub-registrar office September 1, 2024. The land, valued at far higher, was sold cheaply.

The total deal was worth ₹15 lakh, of which ₹1.5 lakh was shown as paid to the fake Dandapani, while ₹13.5 lakh was shared between the two brokers. The accused have confessed to the fraud, police said.

### **Koraput: Suspected food** poisoning claims 4 lives

Koraput, August 25: Four persons, including a fouryear-old boy and two elderly people, have died during the last four days due to suspected food poisoning, sparking panic at Odapara village under Dasmantpur block in Koraput district. Three others are un dergoing treatment at Saheed Laxman Nayak Medical College and Hospital (SLNMCH) according to reports.

Officials said the first casualty was reported Thursday when 42-year-old Manindra Gouda died during treatment at SL NMCH. A day later, four-year old Rajesh Gouda passed away while 60-year-old Naina Gouda succumbed, followed by death of Khagapati Gouda, 60, Sun day. All four had been admitted to SLNMCH with complaints of vomiting and uneasiness.

"The sudden deaths have sparked fear among the villag ers," said sarpanch Maheswar Gadba. A medical team from Koraput visited the remote vil lage Sunday and collected water samples for laboratory testing.

Chief district medical and public health officer Rabi Narayan Mishra said no new cases were reported Sunday and the situation is under control.

"The deaths are suspected to be linked to food poisoning as the affected persons had at tended a community feast. How ever, water samples have been collected for confirmation,' Mishra said.

The district administration has chlorinated all drinking water sources and deployed a mobile health unit.

# Floods hit three districts; 1 dead

Jaipur/Bhograi/Bhadrak.

August 25: Floods in two major rivers have left over 1.67 lakh people marooned in Jajpur, Balasore and Bhadrak districts Monday, reports said, adding that one person drowned in Jajpur.

In Jajpur district, a 70-ft-long breach occurred around 4am Monday on the right embankment of Kani River, a distributary of Baitarani, near Bangalabadi in Kasapa panchayat of Dasharathpur block, More than 100 houses near the breach were submerged up to window level, forcing hundreds to flee to embankments and flood shelters.

The breach flooded parts of Mallikapur and Kasapa panchayats, directly affecting nearly 50,000 people. Informed, District Collector Ambar Kumar Kar, ADM Sibananda Swain, and BDO Akash Pattnavak rushed to the spot. Officials said rescue operations were carried out on a war footing to evacuate marooned villagers.



after being swept away by the floodwaters of Baitarani river in Jaipur district Sunday. The victim, identified as Bhagabat Majhi of Tarei Sahi in Khatikata, was swept away by the strong current. Fire service personnel and an ODRAF team rescued him from the river, but doctors at the DHH declared him dead on arrival.

By afternoon, floodwaters had spread across 50 villages in 10 panchayats, inundating farmlands. Dasharathpur. Fire Services and ODRAF teams from Cuttack reached the site and began rescue operations. A 23-day-old infant was among those rescued from rising waters.

The swelling flood waters of Kani river have submerged much of Dasharathpur block. By evening, the Baitarani was flowing nearly 10 feet above the danger mark.

Meanwhile, the Water Resources department said it is closely monitoring the flood

Judge Pratima Patra also imposed a fine of ₹60,000 on each convict. In default of payment, they would undergo an additional jail term of two years and six months. The convicts were identified as Samay Murmu, 33, and Motu Murmu, 33, both residents of Chadada under Udala police limits. According to case records, the minor girl had gone to a nearby playground when the duo raped her finding her alone. They later threatened to kill her if she disclosed the incident to anyone. However, the victim confided in her aunt, following which a village meeting was convened. As no resolution was reached, the family lodged a written complaint at Udala police station April 12. Police registered case (125/21) and began an investigation. Both accused were arrested and underwent medical examination.

### Algorithm to safeguard microgrids from cyberattacks

Rourkela, August 25: A multi-institutional team led by National Institute of Technology (NIT) Rourkela has developed an algorithm to bolster cyber resilience and stability in microgrids, the localised power systems that play a crucial role in global energy transition. The research spearheaded by Pravat

Kumar Ray, professor and head of the Department of Electrical Engineering at NIT Rourkela, introduces a Modified Improved Whale Optimisation (MIWO) algorithm. The method draws inspiration from the hunting strategies of humpback whales, which use bubble-net feeding by circling fish and releasing bubbles to trap them.

Microgrids integrate renewable sources such as solar and wind power with storage and traditional generators. While vital to clean energy adoption, these systems rely heavily on digital communication networks, leaving them vulnerable to cyber threats such as false data injection and time-delay attacks.

To counter these risks, the team developed a Modified Improved Whale Optimisation-based Fractional Order PID (MIWO-FOPID) controller. This system ensures robust secondary frequency regulation during cyberattacks and fluctuations in energy storage systems. Fractional Order PID is an advanced form of the classic proportional-integral-derivative controller that allows more precise tuning for complex systems, while MIWO enhances optimisation by improving accuracy, speed, and the ability to avoid errors when searching for solutions.

"In modern microgrids, communica-

tion networks act as the primary medium for information exchange among different components, thereby increasing their vulnerability to cyberattacks," Ray said. "These include time-delay attacks, where information from sensors or controllers is intentionally delayed, and false data injection, where attackers manipulate system data to mislead control actions. potentially causing instability. To address these challenges, the proposed algorithm incorporates multiple advanced enhancements, including an adaptive strategy with dynamically tuned control parameters and a multi-phase exploitation

The MIWO-FOPID controller minimises frequency deviations by optimising the cost function under scenarios including time-delay attacks, false data injection. random attacks, energy storage system status manipulation, and malware intrusions. Both computer simulations and real-world hardware experiments confirmed that the approach ensures resilient microgrid frequency control and maintains system stability under hostile conditions.

The research findings were published in IEEE Transactions on Consumer Electronics in a paper co-authored by Ray; Ramesh Chandra Khamari, research scholar at NIT Rourkela; Manoj Kumar Senapati of the Government College of Engineering, Keonjhar; and Sanjeevikumar Padmanaban of University of South-Eastern Norway. This breakthrough enhances the safety and reliability of modern power systems, enabling microgrids to maintain stable operations even under cyberattacks.

### Hindi-Chini Bhai Bhai

his is a good moment for fruitful and significant interactions between India and China at the highest level when Prime Minister Narendra Modi met China's top diplomat and the country's foreign minister Wang Yi recently in New Delhi. Modi hailed the 'steady progress' made in improving the bilateral relationship after years-long standoff between the two nuclear-armed Asian powers. This has happened at a time when the two nations navigate a shifting global economy upended by US President Donald Trump's tariffs. Modi also noted "respect for each other's interests and sensitiveness" in a statement on social media after meeting Wang.

Significantly, China's Ministry of Foreign Affairs reciprocated the Indian PM's diplomatic comment with the remark that said the two countries have entered a "steady development track" and they should "trust and support" each other.

The rebuilding of India-China ties coincides with friction between New Delhi and Washington after Trump imposed steep tariffs on India for continuing to buy Russian oil, which the US says is fuelling Moscow's war machine. India is learning the hard way about the risks of doing business with the US, trusting it too much and flirting with Trump as Modi did, bending over backward to placate him, throwing to the wind diplomatic conventions. This current phase is also showing how India is badly equipped politically to deal with global trade and business demands. The US entered into partnership with India for its strategic interest using India as a counterbalance against China's influence in Asia. This was the main reason for making India part of the Quad security alliance comprising the US, Australia and Japan. India failed to hold a steady stand and lost out in strategic partnerships due to clouded political thinking.

To the US' glee, relations between India and China soured after the deadly clash in 2020 between troops in the Galwan region. This affected trade, diplomacy and air travel, as both India and China deployed tens of thousands of security forces in border areas. However, some progress has been made since then. In fact, Wang visited India this time to meet Modi with the aim of easing border tensions and strengthening ties. Last year, India and China agreed to a pact on border patrols and withdrew additional forces along some border areas. Both countries continue to fortify their border by building roads and rail networks. In recent months, the countries have increased official visits and discussed easing some trade restrictions, movement of citizens and visas for business people. In June, Beijing allowed pilgrims from India to visit holy sites in Tibet. Both sides are working to restore direct flights.

Last week, India's Foreign Ministry spokesman Randhir Jaiswal said India and China were in discussions to restart trade through three points along their 3,488 km (2,167 mile) border. Settling the boundary issue between the two countries requires compromise at the highest political level.

Wang also met External Affairs Minister S Jaishankar and National Security Adviser Ajit Doval over the countries' disputed border in the Himalayan mountains. The MEA said Wang's meeting with Doval discussed "deescalation, delimitation and boundary affairs." The conciliatory and friendly gesture made by Wang speaks volumes for the new thinking in China to mend relations with India to the advantage of both the countries which are at the receiving end of Trump's tariff war. India, of course, suffers far more than China. Wang said the setbacks the two countries had experienced in the past few years were not in the interest of their people. Sounding positive over the cooperation between the two countries in view of the economic hostility of the US, Wang said it was gratifying for China to "see the stability that is now restored in the borders."

Given the chequered history of Indo-China relations, it is premature to judge China's motive to extend the olive branch to India, especially after the recent Operation Sindoor had revealed how Pakistan could rebuff India's offensive with the help of Chinese military hardware and intelligence. At the same time it is of urgent necessity for India's foreign policy to be tailored in such a way that it does not embrace too tightly a powerful and unpredictable ally such as the US thereby closing doors to other powerful nations.

There is every possibility that China may take advantage of the current frosty relations between India and the USA to advance its own economic, military and territorial aspirations. But that does not mean India should put most of its eggs in one basket as it did in the case of the US. It needs to be circumspect about China's statement of backing India for Trump's skewed tariff policy vis-à-vis India, even while closing ranks with China for taking on the US tariff aggression.

# **ROBOTIC WARFARE IS HERE**

ussia's war against Ukraine has become a full-scale technological conflict, where 70-80 per cent of casualties are now caused by unmanned aerial drones. After three and a half years, the war has become a nonstop cat-andmouse game, where every new weapon system offers only a brief two- or three-month advantage before the other side develops countermeasures.

That means the age of robotic warfare is here. We are witnessing its first stage in Ukraine's skies, on the ground, and at sea. The fastest military-tech development in the world is happening in Ukrainian garages, basements, and factories, where hundreds of small teams are building new-model drones and interceptors.

Many have been working nonstop since February 2022, without weekends or vacations. As soon as a new product is ready, it is deployed to the front line. Soldiers test it the next day, and within 24 hours, combat feedback is sent to developers, starting a new cycle. Some defense-tech teams even hand deliver their products to combat zones and work directly with soldiers on integration and iteration.

But Russia's war machine is also operating at full speed, with many factories running around the clock. A clear sign of how quickly Russia can scale up effective weapon systems came on July 9, when it launched 728 Shahed drones in a single day. By the end of the month, more than 6,200 Shaheds had been deployed - 14 times more than in July 2024, and 16 per cent more than in June. To address this threat, at least two Ukrainian defense companies have developed AI-powered interceptor drones that use machine learning to identify and destroy Shaheds.

But the fight is evolving quickly. The Shaheds, too, are getting smarter. When Ukraine deployed machine guns for air defense, Shaheds responded by flying above three kilometers (1.9 miles) - well out of range. Then, in late July, Russia launched a jet-powered Shahed that can fly up to 700 kilometers per hour, faster than most known interceptors. Moreover, some Shaheds are now equipped with thermal imaging, advanced processors, and even autonomous swarm coordination. They appear to sense when they are being hunted, swerving and dodging to escape their pursuer.

Such is the nature of the first-ever robot-on-robot war. The conflict is being waged by two autonomous systems, each trying to outsmart the other in real time. Similar breakthroughs are happening on the ground. FPV (first-person view) drones with optical cable connections (meaning their signal cannot be jammed) can now strike targets up to 30 kilometers from the frontline—

making any movement in that zone extremely dangerous. Both sides have begun using "sleeping drones" that wait on the ground for hours until a target appears.

As a result, unmanned ground vehicles are now being deployed at scale – mostly for logistics, resupply, evacuation, mining, and even attacks. For now, Ukraine appears to be ahead in this area. In July, its 3rd Assault Brigade carried out a historic fully autonomous operation, combining FPV drones and ground robots to force Russian troops to surrender in Kharkiv Oblast without any Ukrainian soldiers participating directly in the assault.

One of Ukraine's biggest successes has been the use of maritime drones to push Russian ships out of the Black Sea. These units, too, have been upgraded over time. On December 31, 2024, a Ukrainian Magura V5 sea drone armed with a surface-to-air missile destroyed a Russian Mi-8 helicopter over the Black Sea. Never before had an unmanned surface vehicle shot down a manned aircraft. And now, some maritime drones are be-

ing used as launch platforms or communication relays for smaller drones, expanding both range and capability.

These are not isolated cases. They confirm that we have entered a new era of warfare, in which autonomous systems are central to battlefield success. Ukraine's top drone units operate like high-performance tech startups, each with its own recruitment, training, funding, and team culture. One advanced brigade includes more than 70 data architects analysing live intelligence around the clock. These units build rapid learning loops, adapting to battlefield changes faster than traditional military units.

The most successful new player in the Ukrainian conflict is former Google CEO Eric Schmidt's defense company Swift Beat, which plans to deliver hundreds of thousands of drones this year. The company has developed one of the most effective Shahed-interceptor drones, and is developing systems capable of intercepting cruise and ballistic missiles. But, remarkably, many of the new technologies are being developed not by large defense contractors, but by thousands of volunteers and civil society.

These kinds of innovations help to explain how Ukraine has managed to hold off a military superpower for so long. NATO and its allies urgently need to study and bolster their support for Ukraine. Robotic warfare is here, and Ukraine is writing the field manual.



### Banning, balancing & betting

ndia's digital revolution has always been a story of ambition outpacing regulation. From e-commerce to fintech, industries have flourished first and faced scrutiny later. Now it is online gaming's turn in the spotlight. What was once dismissed as a frivolous hobby has swelled into a multi-billion-dollar force, embedding itself in the daily lives of nearly 600 million Indians. But the thrill of play has collided with the pain of addiction, debt, and despair, leaving the government with little choice but to intervene. The Promotion and Regulation of Online Gaming Bill, 2025, is not just a piece of legislation but India's attempt to wrestle order out of chaos in one of its fastest-growing digital frontiers.

The industry's numbers are seductive: 400 companies, two lakh jobs, \$3 billion in FDI, and Rs 20,000 crore in annual GST contributions. These are not small stakes. Gaming has been celebrated as both a cultural phenomenon and an economic engine. Yet its darker side has become impossible to ignore. Families have watched teenagers drain digital wallets.

salaried workers gamble away paychecks, and headlines now routinely carry the grim news of suicides tied to online gam-

bling losses. The government's response is sweeping. The Bill bans all online money games, regardless of whether they are based on skill or chance. Fantasy sports, poker, and rummy once booming businesses are treated no differently than slot machines. The penalties are severe: fines up to Rs 1 crore and five years in prison, doubling for repeat offenders. Financial institutions are barred from facilitating transactions and advertisements that promote money games are outlawed. The message is blunt: online gambling has no place in India's digital economy.

But the Bill is not merely a hammer; it is also a chisel. It seeks to carve out a legitimate space for e-sports and non-monetary games, granting them official recognition and institutional support. A National e-Sports Authority will be tasked with ensuring fair play, enforcing compliance, and helping integrate e-sports into state policies. Educational and social games are actively

encouraged, with government backing to promote learning and skill development through play. This dual approach crushing real-money games while nurturing e-sports signals that the government does not reject gaming itself, only its most corrosive incarnation.

Critics, however, argue the cure may be worse than the disease. Industry bodies warn that a blanket ban ignores the legal protections afforded to skill-based games in several jurisdictions. By passing the Bill, the government is not only destroying a job-creating sector but also pushing players towards offshore platforms, accessed via VPNs. Tax revenues could dry up, investments could evaporate and thousands of livelihoods could be jeopardized. In trying to protect citizens, the government may inadvertently drive them into even more dangerous, unregulated spaces.

Yet defenders of the Bill see it as a necessary correction. The industry has enjoyed years of unchecked growth while the social costs mounted. If the short-term price is disruption, they argue, the long-term reward is a safer

and more responsible digital ecosystem.

The truth, as always, lies

in the execution. A blunt ban may satisfy public anger but risks creating a black market. Overregulation could strangle innovation, while underregulation could leave citizens vulnerable. What India needs is not just a law but a living framework, one that adapts to technological change, consults stakeholders and refines its definitions over time. Without this flexibility, the Bill risks being remembered not as a landmark reform but as a lost opportunity.

India's online gaming Bill is, in many ways, a gamble in itself. It bets that by outlawing one half of the industry and uplifting the other, the government can protect citizens while still reaping economic rewards. Whether this gamble pays off will depend less on what is written in the Bill and more on how it is enforced. For now, the dice are cast.

### Balanced approach Sir, The Supreme Court's updated order on stray dogs takes a

more balanced approach to a contentious topic. The court chose compassion tempered with pragmatism, reversing its earlier ruling demanding the permanent removal of all stray dogs from streets. The Supreme Court's earlier order directing the authorities in Delhi, Gurgaon, Noida and the rest of the National Capital Region to remove all the stray dogs to specially-made shelters in eight weeks sounded impractical and financially untenable but it sought to address a very serious issue from the point of view of the most vulnerable segment of the human population in the light of the right to life guaranteed under Article 21 of the Constitution. It is noteworthy that dogs have been with humans in every civilization. In the past, the Supreme Court and various High Courts have repeatedly affirmed the territorial rights of community dogs, holding that removal or relocation is unlawful. Again mass confinement will violate Article 51A(g) of the Constitution, which enjoins citizens, and by extension the State, to

show compassion to all living creatures.

# Delhi Metro raises fares after 8 years



Despite the latest increase, the DMRC maintained that its fares remain among the lowest worldwide

New Delhi, August 25: Grappling with financial stress due to COVID losses, loan repayments and upkeep costs, the Delhi Metro Rail Corporation (DMRC) on Monday revised passenger fares after a gap of nearly eight years. The hike ranges from ₹1 to ₹4 depending on the distance travelled, officials said.

In the financial year 2023-24, the DMRC incurred a loss before tax of ₹1,781.69 crore. In the following year, 2024-25, the losses are projected to be around ₹1,598 crore, as per a DMRC official.

"The latest fare increase is minimal and will only provide limited relief. The additional revenue, however, will help the DMRC sustain its operational standards by ensuring timely maintenance of trains and infrastructure, much of which is now ageing," the official added. According to the new struc-

ture, the minimum fare has increased from ₹10 to ₹11 for journeys of up to 2 km, while the maximum fare for trips beyond 32 km has risen from ₹60 to ₹64. For the 12–21 km slab, fares now stand at ₹43, compared to ₹40 previously, and for the 21–32 km slab, the fare has been increased to ₹54 from ₹50.

The new rates apply on Sundays and national holidays as well. On these days, a journey beyond 32 km will now cost ₹54 instead of ₹50, while travel in the 12–21 km range has been revised from ₹30 to ₹32, the DMRC said in a statement.

A similar revision, with an increase of up to ₹5, has also been introduced on the Airport Express Line, it stated.

### How Naidu turned ₹7K into ₹6,755cr dairy empire

Andhra Pradesh CM Chandrababu Naidu emerges as richest CM with assets worth ₹936cr

New Delhi, August 25: The latest report by the Association for Democratic Reforms (ADR), which pegs the collective assets of India's Chief Ministers at over ₹1,600 crore, places Andhra Pradesh Chief Minister N Chandrababu Naidu at the very top with a declared wealth of ₹931 crore.

While the findings spotlight the disparities in the financial backgrounds of political leaders, Naidu's case is distinct in that his wealth is tied to a business enterprise he founded three decades ago, Heritage Foods Ltd, rather than inherited assets or opaque sources.

Across the country, other Chief Ministers also feature prominently in ADR's wealth analysis. Arunachal Pradesh Chief Minister Pema Khandu is second on the list with assets of ₹163 crore, followed by Odisha's Naveen Patnaik with TIPLE

₹63 cror

Kerala Chief Minister Pinarayi Vijayan declared the lowest assets at just ₹40 lakh, while Delhi Chief Minister Arvind Kejriwal reported ₹3 crore. With most Chief Ministers now counted as crorepatis, with only two exceptions, the report highlights the broad divergence in wealth among India's political leadership.

Naidu founded Heritage Foods Ltd in 1992, when India's dairy sector was opening up to private investment under economic reforms. Starting with a paid-up capital of just ₹7,000, the company went public in 1994 with an IPO over-

subscribed 54 times, raising ₹6.5 crore.

Over three decades, Heritage has grown into a pan-India brand with a presence in 17 states and partnerships with nearly 3 lakh dairy farmers. The company's turnover milestones-from ₹100 crore by FY2000 to ₹4,000 crore by FY2025-reflect its sustained expansion. The Nara family, which retains a 41.3 per cent stake, has seen Heritage's mar-

heavals. A four-time Chief Minister of Andhra Pradesh, he has alternated between power and opposition, steering his party through turbulent phases such as the bifurcation of the state in 2014, electoral setbacks in 2004 and 2019, and a return to office in 2024.

Parallel to his political career, Naidu has consistently projected himself as a tech-forward leader, branding Hyderabad as "Cyberabad" during his tenure in undivided Andhra Pradesh, and more recently emphasising the importance of artificial intelligence, high-tech manufacturing, and quantum computing for Andhra Pradesh's growth.

It was under his wife, Nara Bhuvaneswari, who took charge of Heritage in 1994 when Naidu entered gov ernment, the company has expanded steadily, maintain ing a reputation for ethical growth and farmer-centric operations without state concessions or preferential contracts. Its net worth rose from ₹9.99 crore in 1994 to ₹972 crore in 2025, making it a rare example of a political leaders declared wealth being linked to a transparent, publicly list ed enterprise.

### Andhra announces ₹1L for 55 SC NEET toppers

Amravati, August 25: Andhra Pradesh Chief Minister N Chandrababu Naidu Monday announced a cash incentive of ₹1 lakh for each of the 55 students from the state's Scheduled Caste (SC) and Scheduled Tribe (ST) residential schools who have secured seats in prestigious institutions like the IITs, NITs, and for MBBS through the National Eligibility cum Entrance Test (NEET) exam.

The announcement was made at a special felicitation event at the Secretariat in Amaravati, where the students met the Chief Minister and shared their success stories. The state government has reiterated its focus on empowering students from underprivileged backgrounds and providing them with the necessary resources to compete at the national level.

The state's residential school system provides free quality education to students from marginalised communities. The students received specialized coaching at Dr BR Ambedkar IIT-NEET coaching centres located in Chinnatekur, Kuntamukkala, and Adivi Thakkellapadu.

The results are particularly impressive given the competitive nature of these national-level entrance exams. Out of 176 students who were trained for JEE (Mains and Advanced), 129 qualified. From the 180 students who received coaching for NEET, 143 qualified. From this pool of successful candidates, 12 secured seats in IITs, 30 in NITs, and 13 got MBBS seats through NEET.

This cohort of high-achievers includes 20 girls, highlighting the program's success in promoting female education. An additional 14 students are also likely to secure BDS seats, with 19 gaining admission to GFTIs and Central Universities.

Kurnool, August 25: The early rains in the Rayalaseema region of Andhra Pradesh have turned into a season of fortune seeking for farmers and villagers in Kurnool and Anantapur districts, where hunting for precious stones, including Diamonds, has intensified alongside kharif cultivation.

Rain-washed lands in Jonnagiri, Tuggali, and Peravali mandals, long known for diamond discoveries, are drawing crowds of villagers, traders, and outsiders eager to test their luck this season.

"Even if you pick a stone,

the may turn your fortunes," Bharat Palod, an entrepreneur from Mahabubnagar district in Telangana, told PTI, adding that stories of ordinary farmers turning millionaires and billionaires fuel widespread interest in the region.

Palod said the precious stone hunting has changed his life. "I found my first piece in 2018 and this year I sold one for ₹8 lakh", he said.

Deepika Dusakanti, a social worker, recalled how she previously sold a diamond for ₹5 lakh to fund education of underprivileged children.



"This year's discovery worth ₹10 lakh will again go for students' benefit," she mentioned.

Naman, an archaeology student, said, "I came to study Telugu history. I found stones that will both fund my studies and serve research purposes," he told PTI.

A farmer from Chittoor, Godavariamma, said she travelled to Jonnalagiri after watching videos of diamond discoveries. "Though I came late, I will continue searching. If I find one, it will support my family's needs," she said. Kurnool DIG Koya Praveen said folklore about diamonds in Kurnool and Anantapur districts persists.

"People migrate for work, return during the monsoon, and harvest diamonds. No crimes have been reported despite high sums involved," Praveen told PTI.

He said that villagers claim the lands as their own and sometimes resist outsiders entering, yet 'no major disputes or criminal incidents' have been reported so far. This season, reports of multiple high-value diamonds have renewed excitement.

Venkateshwara Reddy, a farm worker in Peravali village, reportedly sold a diamond for ₹15 lakh to a local trader.

P Bajranglal, owner of the land in Anantapur district, said he owns over 40 acres where villagers search for diamonds, as many have found precious stones, and he has no objections. He mentioned that his family even provides water and food for people who come in

"If these diamonds bring happiness to others' lives, I fully support it," he said.

With each monsoon, these districts once again transform into a hub of diamond seekers chasing hidden fortunes.

### Delhi on track to become EV capital

New Delhi, August 25: Delhi is set to cement its place as the country's Electric Vehicle (EV) capital with 7,000 to 8,000 new electric buses on its roads by February 2026, Transport Minister Pankai Singh said Monday.

At present, the city has 3,400 electric buses, up from 400 when Singh took charge. The fleet is expected to grow to 6,000 by the end of this year, he said.

"Based on route rationalisation, Delhi requires 7,000 to 8,000 buses. We believe we will reach that target by February," the minister said while addressing the India Clean Transportation Summit 2025 at the India International Centre here. The expansion also includes the city's Devi buses, aimed at strengthening last-mile connectivity. Singh added that Delhi's new EV Policy 2.0, likely to be unveiled by February, will focus heavily on charging

A bench of Justices Surya Kant and Joymalya Bagchi said the degree of repentance should be higher than the degree of offending and made it clear that the court would consider imposing a penalty on the influencers for offending disabled persons by social media influencers, at a later stage

New Delhi, August 25: Commercial and prohibited speeches are not covered under the fundamental right, the Supreme Court Monday said as it asked five social media influencers, including "India's Got Latent" host Samay Raina, to display their unconditional apology in their podcasts or shows for ridiculing persons with disabilities and rare genetic disorders.

"It is like purging contempt," Justice Kant said while asking the influencers to apprise the court on how much penalty they were willing to pay, which in turn can be utilised in the treatment of people suffering from rare genetic disorders like spinal muscular atrophy (SMA).

The five influencers are accused of making fun of the disabled and those suffering from SMA and visual impairment.

Except Sonali Thakkar alias Sonali Aditya Desai, four influencers including Raina were present in the courtroom.

Justice Bagchi said the influencers should be more cautious while creating humour related to different communities es-

pecially when it pertains to

'apartheid in the society"

'Much of this media block is used like feeding your own ego. It feeds on yourself and when you become too big and have so many followers... It's not only freedom of speech here. It is purely commerce... infact, there are various kinds of speeches and in the Amish Devgan case this court has classified various kinds of speeches like commercial speech and prohibited speech. This overlap of commercial and prohibited speeches is where you have no fundamental rights (sic)," Justice Bagchi said.

The bench allowed the intervention of the Ministry of Information and Broadcasting and asked Attorney General R Venkataramani to come up with guidelines to regulate the contents on social media while taking into account the views of all stakeholders.

Venkataramani said the

government was in process of formulating the guidelines but ruled out any "gag order".

Justice Kant agreed and said that was the reason behind the suggesting in the last hearing that draft guidelines will be shared in public domain for the views of all stakeholders.

"There should be some accountability. Today it is disabled people but tomorrow it can be women, children and senior citizens," Justice Kant

Justice Bagchi weighed in, "Humour is definitely well taken as humour is a part of life. We laugh at ourselves but when you start laughing at others then we should have a sense of sensibility. It's not only disability but we are a country of varied communities...

Senior advocate Aprajita Singh, appearing for NGO Cure SMA Foundation of India, which has sought action against the influencers for their utterances against the disabled, said a better sense prevailed among the influencers, who tendered an unconditional

She said the issue was not of the influencers alone and the Information Technology Rules and the Cinematograph Act mandate that persons with disabilities cannot be

While Justice Kant said there should be penal action under the rules which should be proportionate to the harm caused to the dignity of people, Singh suggested influencers to spread awareness on the rare genetic disorder and disabilities through their shows.

The bench told the attorney general that the proposed guidelines for social media regulations should not be a kneeierk reaction to one incident but based on broad based parameters incorporating views of all stakeholders.



New Delhi: The Supreme Court collegium Monday recommended to the Centre, the names of Bombay High Court Chief Justice Alok Aradhe and Patna High Court Chief Justice Vipul Manubhai Pancholi for elevation as top court judges. Justice Pancholi, upon becoming a top court judge, would be in line to become the Chief Justice of India (CJI) in October 2031 after Justice Joymalya Bagchi's retirement October 2, 2031. Subject to Centre's clearance, he would assume CJI's office on October 3, 2031 and retire May 27, 2033.

New Delhi, August 25: Article 32 of the Constitution empowers the court to reopen sentencing in cases of capital punishment on grounds of breach of procedural safeguards, the Supreme Court said Monday while agreeing to hear again a

death row convict's plea.

Vasant Sampat Dupare, who belongs to Nagpur, was convicted of raping and killing a four-year-old in April 2008. He lured her with chocolates and crushed her head with stones to avoid identification of the body

A bench of Justices Vikram Nath, Sanjay Karol and Sandeep Mehta allowed the convict's plea filed under Article 32 noting that there had been a breach of procedural safeguards.

It also cited the 2022 Manoj Vs Madhya Pradesh judgement in which the top court issued several guidelines and mandated the trial courts to collect the accused's psychiatric and psychological evaluation report

before awarding death.

"We hold that Article 32 of the Constitution empowers this court in cases related to capital punishment to reopen the sentencing stage where the accused has been condemned

to death penalty without ensuring that the guidelines mandated in the Manoj vs Madhya Pradesh was followed," the bench said.

"This corrective power is invoked precisely to compel

rigorous application of the safeguards laid down in Manoj judgment in such cases, thereby ensuring that the condemned person is not deprived of the fundamental rights to equal treatment, individualised sentencing and fair procedure that Articles 14 and 21 of the Constitution secure to every person," the bench said.

The top court also said the exceptional scope of Article 32 cannot be permitted to become a routine pathway for reopening concluded matters.

"Reopening will be reserved for only those cases where there is a clear, specific breach of the new procedural safeguards, as these breaches are so serious that if left



# All 4 accused held in Noida dowry killing

In Sirsa village, where the incident occurred August 21, residents in the victim's neighbourhood shared chilling accounts of the behaviour of the accused and the chain of events that led to the killing of 26-year-old Nik-

Among the accused, fatherin-law Satveer Bhati (55) and brother-in-law Rohit Bhati (28) were taken into custody near Sirsa Toll Chauraha following a tip-off and manual intelligence inputs, officials said. They had been absconding since the incident that has sparked outrage across the region occurred.

Nikki's husband, Vipin Bhati, was arrested Saturday and later shot in the leg during an alleged attempt to escape police custody Sunday. His mother, Daya (55), was also arrested

"All the named accused in the FIR registered at Kasna Police Station have been arrested by Greater Noida Police in the murder case of a woman who was burnt by her husband and in-laws. Investigation is on and facts are being collected." Additional DCP Sudhir Kumar said.

Disturbing videos of the assault, recorded by Nikki's elder sister Kanchan who is married to Vipin's brother Rohit, had circulated widely on social media. One clip purportedly showed Nikki being dragged by her hair, while another showed her engulfed in flames.

### 10 killed, 41 injured as truck hits tractor-trolley

Bulandshahr (UP), August 25: Ten people were killed and 41 injured when a truck rammed into a tractor-trolley carrying pilgrims in Uttar Pradesh's Bulandshahr district in the early hours of Monday police said.

"The tractor-trolley was carrying 61 people, who were travelling from the Rafatpur village in the Kasganj district to Jaharpeer in Rajasthan for a pilgrimage," he said.

The police officer said the victims were rushed to hospitals. "Eight people died, while 43 of them are undergoing treat ment. Three of the injured are on ventilator support," Singh added. Later, two more victims. identified as Lekhraj (40) and Umashankar (60), succumbed to injuries during treatment at hospitals, taking the toll in the incident to 10, police said.

The Police said 10 passengers escaped with minor injuries.

### ED arrests MLA in school jobs scam

New Delhi: The Finance Ministry Monday introduced a one-time one-way switch facility from the newly introduced Unified Pension Scheme (UPS) to the National Pension System (NPS). From April 1, 2025, the government has introduced UPS as an option under the National Pension System (NPS) for central government employees. UPS will provide assured payouts to the employees. Around 31,555 central government employees have opted for the Unified Pension Scheme (UPS) till July 20, and the last date to enrol under the scheme is September 30. In an office memorandum, the Finance Ministry said it has been decided that a one-time, one-way switch facility from UPS to NPS will be made available to all Central Government employees who have opted for UPS.

Beijing, August 25: India's successful test of the Integrated Air Defence Weapon System (IADWS), especially the high-power laser-based Directed Energy Weapon (DEW), drew praise from a Chinese military expert who said it should be considered a "significant advancement"

The IADWS is a multi-layered air defence system consisting of indigenous quick reaction surface-to-air missiles (QRSAM), very short-range air defence system (VSHORADS) missiles and a high-power laser-based directed-energy weapons (DEW) system.

The indigenous air defence

system was flight-tested off the coast of Odisha Saturday.

The IADWS, especially the DEW, which is possessed by a few countries like the US, Russia, China, the UK, Germany and Israel, drew the attention of Chinese experts. The Indian IADWS is an air

defence system designed to counter low and mid-altitude targets such as drones, cruise missiles, helicopters and low-flying aircraft, with a limited strike range, Wang Ya'nan, chief editor of Beijing-based Aerospace Knowledge magazine, told China's state-run Global Times. The key to such an inte-

grated air defence system lies in having a highly effective



information system capable of distributing target data to corresponding weapon com-

ponents, or the system would merely consist of separate air defence weapons operating in-

dependently, he said. 'Among the three layers of

the IADWS, the vehicle-based air defence missile QRSAM and the man-portable air defence system VSHORADS are not technologically novel, but the laser system should indeed be considered a significant advancement," Wang said.

"There are only a few countries in the world that have deployed combat-ready laser systems," Wang said, pointing to China's LW-30 vehicle-based laser defence weapon system, dubbed a killer of UAVs.

It has characteristics of light speed engagement, silent attack, continuous operation. flexible and accurate, and a high cost-effectiveness ratio, The Chinese experts' com-

ments were regarded as significant, considering the People's Liberation Army, which is heavily investing in modern weapons for its use, also provides a significant amount of weapons to Pakistan. According to a recent report

by Stockholm International Peace Research Institute (SI PRI), China supplied over 81 per cent of Pakistan's military hardware, which the Pakistan military sought to use against India in the recent Operation Sindoor conflict.

The flight tests of the new air defence system came more than three months after Operation Sindoor.

#### Typhoon Kajiki **batters Vietnam**

Cua Lo: Typhoon Kajiki brought torrential rains to Vietnam's north central coast Monday, felling trees and flooding homes, despite wind speeds tapering off from earlier in the day. As of 0900 GMT. Kaiiki was on the coast of Nghe An and Ha Tinh provinces, with wind speed easing to 118-133 kph from as strong as 166 kph, according to the country's weather agency. State media reports said power in several areas in Ha Tinh province had been cut off, roofs were blown out and floating fishing farms were washed away. Vietnam had earlier shut airports, closed schools, and begun mass evacuations as it prepared for the most powerful storm so far this year. The Vietnamese government said earlier Monday about 30,000 people had been evacuated from coastal areas. More than 16.500 soldiers and 107.000 paramilitary personnel had neen mohilised to help with the evacuation and stand by for search and rescue.

### Torrential rains kill 17 in Pak

Peshawar: At least 17 people including three children were killed and 50 others injured in northwest Pakistan in the last 24 hours as torrential rains and windstorms battered parts of Khyber Pakhtunkhwa province, officials said Monday. The deaths come as Pakistan reels from earlier monsoon spells between June 26 and August 20, which left more than 788 dead and 1,018 injured as of Saturday. Khyber Pakhtunkhwa was the worst-hit province. Heavy rains accompanied by strong winds hit Dera Ismail Khan district and adjoining areas early Sunday, leaving thirteen people dead and over 50 hurt in various incidents, mainly roof collapses.

### 5 journalists killed by Israeli strikes on Gaza

Deir al-Balah, August 25: Israel struck Nasser hospital in the south of the Gaza Strip Monday, killing at least 20 people, including five journalists who worked for Reuters, the Associated Press. Al Jazeera and others

Cameraman Hussam al-Masri, a Reuters contractor, was killed near a live broadcasting position operated by Reuters on an upper floor just below the roof of the hospital in Khan Younis in an initial strike, according to Palestinian health officials.

Officials at the hospital and witnesses said Israel then struck the site a second time, killing other journalists, as well as rescue workers and medics, who had rushed to the scene to

The IDF "regrets any harm to uninvolved individuals and does not target journalists as such. The IDF acts to mitigate harm to uninvolved individuals as much as possible while maintaining the safety of IDF troops," it said.

A Reuters spokesperson said in a statement, "We are devastated to learn that cameraman Hussam al-Masri, a contractor for Reuters, was killed this morning in Israeli strikes on Nasser hospital in Khan Younis in Gaza. Moaz Abu Taha, a freelance journalist whose work had been occasionally published by Reuters, was also killed, and photographer Hatem Khaled, a Reuters contractor, was wounded.'

"We are urgently seeking more information and have asked authorities in Gaza and Israel to help us get urgent medical assistance for Hatem," the spokesperson added.

The AP said it was "shocked and saddened" to learn of the deaths of Abu Dagga and other journalists, adding that Abu Dagga had often based herself at the hospital for coverage, which recently included stories on starving and malnourished

The Palestinian Journalists Syndicate condemned Israel for the strikes, saying it represented "an open war against free media, with the aim of terrorising journalists and preventing them from fulfilling their professional duty of exposing its crimes to the world".

More than 240 Palestinian iournalists have been killed by Israeli fire in Gaza since the war started October 7, 2023, according to the Palestinian Journalists Syndicate.

### **National Guard begins** carrying firearms in DC



Washington DC, August 25: US National Guard troops patrolling the streets of Washington DC as part of what President Donald Trump said was his crackdown on crime will begin carrying weapons Sunday night, two officials

### Trump blasts South Korea

### Bangladesh runs out of resources for Rohingya refugees

Cox's Bazar, Bangladesh, August 25: Bangladesh has no scope to allocate more resources for its 1.3 million Rohingya refugees, Chief Adviser Muhammad Yunus said Monday, urging the international community to find a sustainable solution to the crisis.

Children make up half the 1.3 million Rohingya refugees now living in Bangladesh, most of whom fled a brutal 2017 military crackdown in Buddhist-majoritv Myanmar that UN investigators called a "textbook example of ethnic cleansing".

Hosting the refugees has put a huge strain on Bangladesh, in areas from its economy and environment to governance, said Nobel peace laureate Yunus,

the South Asian nation's de-facto prime minister.

### Oil firms' Q1 results

Mumbai: State-owned fuel retailers Indian Oil Corporation (IOC), Bharat Petroleum Corporation Limited (BPCL) and Hindustan Petroleum Corporation Limited (HPCL) has reported strong profits in the April-June guarter of the current financial year (Q1 FY26), thanks to higher petrol and diesel margins. The three companies total earned a profit of ₹16,184 crore in the first guarter of FY26, more than two-and-a-half times higher than the same period previous year, as per their regulatory filings. Among the three. BPCI topped the list with a profit of ₹6.124 crore, overtaking IOC which reported ₹5,689 crore, even though IOC is nearly twice its size. HPCL posted a net profit of ₹4,371 crore during the quarter. In comparison, IOC earned \$2.15 per barrel and HPCL \$3.08. BPCL's refineries also operated at a higher efficiency, running at 118 per cent of their installed capacity. against 107 per cent for IOC and 109 per cent for HPCL. Its fuel sales per pump also outpaced rivals, averaging 153 kilolitres per month, compared to IOC's 130 kl.

### India, UN WFP ink pact

New Delhi: India Monday agreed to supply fortified rice to the UN World Food Programme (WFP) to aid the food and nutritional requirements of the most vulnerable populations in crisis-hit zones globally. A letter of intent (LoI) was signed between India's Food Ministry and WFP here, underscoring the strength of global partnerships. The initiative signifies the culmination of discussions at the February 2025 Executive Board side event in Rome, where representatives from the Indian government and WFP explored ways to collaborate. By sourcing rice from India, WFP will utilise the resources of an agricultural surplus nation to deliver life-saving aid and make tangible progress against hunger. The WFP's **Deputy Executive Director had** lauded India's contribution to the fight against hunger, as the world faces rising food insecurity amid constrained humanitarian funding. New Delhi, August 25: Fitch Ratings Monday retained India's sovereign credit rating at 'BBB-' with a stable outlook on robust growth and external finances. The proposed 50 per cent US tariffs on India pose a moderate downside risk to its 6.5 per cent GDP growth forecast for the current fiscal, the agency said.

"India's economic outlook remains strong relative to peers, even as momentum has moderated in the past two years, Fitch said, adding the ratings are supported by its robust growth and solid external finances. 'BBB-' is the lowest invest-

ment grade rating and comes within a fortnight of another global rating agency S&P upgrading India's credit rating



S&P's first upgrade for India in over 18 years

Another global rating agen cy Morning DBRS, had, in May this year, upped India's rating to 'BBB', citing structural reforms. Fitch's forecast of GDP growth at 6.5 per cent in the fiscal year ending March 2026 (FY26) is unchanged from FY25, and well above the 'BBB' median of 2.5 per cent.

It estimates India's medium-term growth potential at 6.4 per cent, led by strong public capex, a private investment pick up and favourable demo-

"Proposed goods and services tax (GST) reforms, if adopted, would support consumption, offsetting some of these growth risks." Fitch added.

The Centre has proposed to the Group of Ministers on GST rate rationalisation a 2-tier rate structure of 5 and 18 per cent for 'merit' and 'standard' goods and services, and a 40 per cent rate for 5-7 goods. The proposal entails doing away with the current 12 and 28 per cent tax

"The government's deregula tion agenda and GST reforms should support incremental growth. Passage of other significant reforms, especially on land and labour laws, seems politically difficult. Still, some state governments are likely to advance such reforms. India has signed several bilateral trade agreements, but trade barriers remain relatively high," Fitch said.

The rating agency said a strengthening record on delivering growth with macro stability and improving fiscal credibility should drive a steady improvement in India's structural metrics, including GDP per capita, and increase the likelihood that debt can trend modestly downward in the medium term.

Fitch, however, flagged fiscal metrics as a credit weakness. given the high deficits and debt compared to 'BBB' peers. "Lagging structural metrics, including governance indicators and GDP per capita, also constrain the rating," the agency said.

New Delhi, August 25: State Bank of India (SBI), the country's largest lender, has requested the Reserve Bank of India (RBI) to allow banks to fund acquisitions, its Chairperson Challa Sreenivasulu Setty said Monday.

Currently, Indian banks are not allowed to lend money for mergers and acquisitions.

Because of this rule, companies usually turn to non-banking financial institutions or raise funds through bonds when they plan to buy other businesses

Speaking at the FIBAC event organised by FICCI AND IBA, Setty said SBI has asked the RBI to consider allowing acquisition financing, at least for large listed companies to

New Delhi, August 25: Fantasy sports company Dream11 is no longer the title sponsor of the Indian cricket team and the Board has initiated the process to find a replacement, which is unlikely to be finalised in time

for next month's Asia Cup. As reported by the PTI Sunday, Dream11 won't be continuing as Indian cricket team's title sponsors, starting from the men's Asia Cup, after the government banned real monev gaming under the recently-passed 'Promotion and Reg-

ulation of Online Gaming' act. BCCI secretary Devajit Saikia confirmed that the deal with Dream11 has ended and BCCI is putting the process in motion to get new title sponsor

for various national teams.

"Our stand is very clear. With government regulations in place, the BCCI cannot continue its sponsorship relationship with Dream11 or any such other gaming company. Under the new restrictions, there is no scope and we are facing a road-

block with Dream11," Saikia told PTI Monday.

"So we cannot continue with them and therefore trying to find some alternatives, and that process is now ongoing. The vacant position of the sponsor is something that we are trying to fill and till now nothing has been completed. Once something happens we will let you know with a media
