Man dies in custody; cop torture alleged

Cuttack, Sept 22: Raising se rious questions about safety and security at police stations under the twin city Commissionerate Police, a 39-year-old man, arrested on charges of vehicle theft, died reportedly by suicide on the premises of Choudwar police station in Cuttack district late Sunday night, after being unable to withstand custodial torture by the men

The deceased was identified as Rasananda Nayak of Shankarpur village in Dhenkanal district. Police had brought him to the station for questioning in connection with a vehicle theft case. Since the main lockup was under repair, Nayak was kept at the police barracks, about 200 metres from Choudwar police

According to sources, Nayak went to answer nature's call and allegedly hanged himself from a tree using his belt on the campus. Policemen at the barracks rushed an unconscious Nayak to Sriram Chandra Bhanja Medical College and Hospital (SCBMCH) in Cuttack where doctors declared him dead.

While some police personnel maintained that no such incident of torture had occurred, Navak's wife and brother alleged that he took the extreme

step after being unable to bear the "third-degree" torture in custody. They alleged that three policemen physically assaulted Nayak with plastic pipes. The cops threatened Nayak to implicate his wife in false ganja peddling case. Unable to tolerate the torture, Nayak hanged himself, the family alleged.

Choudwar police, however, rubbished the allegations and said that Nayak died due to some pre-existing illness.

A senior police officer, requesting anonymity, said, "Nayak had a pre-existing illness (fits) and collapsed suddenly before being taken to the hospital.'

Meanwhile, attempts to contact Choudwar police station inspector-in-charge (IIC) Biswaranjan Sahu failed. Zone-1 Assistant Commissioner of Police (ACP)

Choudwar IIC among three suspended

s per a direction of Chief A Minister Mohan Charan Majhi, Biswaranjan Sahu, ACP, in charge of Choudwar police station, has been suspended in connection with the death of Nayak in custody. SI Niranjan Goda and OAPF constable Kamal Lochan Majhi were also placed under suspension for dereliction of duty.

Arun Kumar Swain and Additional Deputy Commissioner of Police Amarendra Panda have launched an inquiry.

While police said the actual reason behind Nayak's death will be ascertained after the postmortem, locals demanded an impartial investigation into the incident.



Bhubaneswar: A low-pressure area formed over the Bay of Bengal Monday is likely to trigger heavy rain in several parts of Odisha, the IMD said. Under the influence of an upper air cyclonic circulation, a low-pressure area is formed over northeast Bay of Bengal in the morning, it said, adding that another low-pressure area is likely over east-central and adjoining north Bay of Bengal around September 25. Both the weather systems are likely to trigger heavy rain in Odisha till September 28. On Monday (from 8:30am to 5:30pm), heavy rainfall was recorded at Koraput (80.8mm), Sambalpur (39.2mm), Titlagarh (39mm), Bhadrak (37mm), Bolangir (24mm), and Boudh (20mm).

CM: Over 37K cases of crimes against women in 14 months

Bhubaneswar, Sept 22: As many as 37,611 cases of crimes against women were registered in the state in 14 months, between June 2024 and July this year, Chief Minister Mohan Charan Majhi told the Assembly Monday.

Responding to a query of Congress MLA Sofia Firdous, the CM said 2,933 cases of rape, 9,181 molestation, 1,278 sexual harassment, 2,161 public disrobing of women, 8,227 kidnapping/abduction of women, 5,464 dowry-related torture and 6,134 non-dowry torture were reported in Odisha during those 14 months.

702 cases of Similarly, eve-teasing, 174 attempt to rape, 334 refusal to marry after physical intimacy, 447 stalking, three acid attack, three acid attack bid, 127 trafficking of women, 264 dowry homicide and 44 dowry suicide were also registered in different police stations across the state during the period, Majhi said. "In connection with these cases of crimes against women, 5,979 people, including 225 women, have been arrested.'

Noting that preventive measures were taken to improve the safety and security of women in the state, the CM said all sensitive cases against women, such as rape, POCSO and acid attacks, are being monitored and supervised by superintendent of police (SP) or additional

Bhubaneswar, Sept 22: Tension gripped Capital Hospital here Monday when the mem bers of Smart City Online Auto & Taxi Association and locals fought a pitched battle with the hospital's security personnel following the death of a 13-month-old boy allegedly due to 'wrong medicines'. The melee resulted in injuries to several protesters, according to reports.

The deceased was identified as Ayushman Sahu, son of Asish Kumar Sahu, an auto-rickshaw driver, and Ranjita Sahu of Salia Sahi.

The child was brought to the hospital by the parents after he fell ill Sunday, said reports, adding that doctors prescribed some medicines and discharged him. However, Ayushman's condition deteriorated around 3am following which his parents rushed him to the hospital again.

"The attending doctor gave our son some medicines, which caused reactions," said Asish.

'The doctor first advised us to conduct X-ray before prescribing medicines. We requested for a bed, which they denied. My child died after the lady doctor gave him wrong medicines. We want justice and arrest of the doctor," said Ranjita.

Soon after the death, several

The parents then took the child downstairs and administered medicine. We sus pect the parents might have given water from outside and they reached us when the child's condition deteriorated. After the child's death, they gheraoed our staffers," she added.

Director of Health Services Amarendra Mohanty said "The child was suffering from cold and cough and the doctors had prescribed for X-ray. The prescription shows no sign of wrong medicine. After autopsy the reason behind the child's death will be ascertained."

boost consumption

Bhubaneswar, Sept 22: Chief Minister Mohan Charan Majhi Monday said the GST reforms will boost consumption of 'swadeshi' goods and services, resulting in a resilient and stronger economy.

The GST Council, comprising the Centre and states, had decided to reduce tax rates on goods and services from September 22 - the first day of Navratri.

"Today, 22nd September 2025, is getting etched in history as an iconic date as Bharat rolls out the Next-Generation GST reforms under the visionary leadership of Hon'ble Prime Minister Shri Narendra Modi Ji," the CM said in a post on X.

The upgraded GST slabs bring about a welcome change in the way people produce and consume, he said.

"Easier compliances and reduced GST on MSMEs will encourage manufacturers and producers to build for India, to Make in India. The reduction in GST will ultimately boost consumption of 'swadeshi' goods and services, resulting towards a resilient and stronger economy built on the bedrock of an 'Aatmanirbhar Bharat'," Majhi asserted.

"These Next-Gen GST reforms tie the Hon'ble Prime Minister's vision of 'Aatmanirbhar Bharat' and Make in India together and form a more cohesive action plan towards Viksit Bharat 2047'," he said.

The GST reforms embody the government's commitment to inclusive growth and ease of living for all, the CM said.

Meanwhile, addressing a press conference here, state BJP president Manmohan Samal said the new GST rates will



immensely benefit Odisha and its people.

'The rolling out of the new GST regime is not only a gift for the people of India on the occasion of Navratri, but it also gives a new sense of self-confidence to the public," Samal

Meanwhile, the Odisha Pradesh Congress Committee (OPCC) slammed the Centre's decision to observe the implementation of GST reforms as 'GST Bachat Utsay'

Briefing media at Congress Bhawan here, party spokesperson Prashant Satpathy said demonetisation in 2016 and the flawed GST in 2017 crippled the economy, forcing 63 lakh small and medium enterprises to shut down. He pointed to worsening inequality, with just 21 billionaires now holding more wealth than 80 crore Indians, while 50 per cent of the poor own only 3 per cent. Citing government data, Satpathy said debt per farmer rose from ₹74,121 in 2021 to ₹91,231 in 2024, with 75 per cent of Odisha's farmers burdened by loans. Youth unemployment has also surged, with nearly half of people aged 20–24 jobless, he added.

"After looting ₹55 lakh crore in GST over eight years, the government is now talking of savings. This is ridiculous," he said.

Bhubaneswar, Sept 22: Hundreds of aspirants for State Selection Board (SSB) lecturer posts staged a protest at Lower PMG Monday, expressing frustration over the prolonged delay in the recruitment process.

The candidates claim the recruitment drive has been mired in legal proceedings for over a year, with repeated court adjournments extending the uncertainty. Despite multiple appeals, no clear timeline for the examinations has been provided. "Our patience has run out. We will not allow the future of educated youths to be jeopardized any longer," the aspirants warned.

They noted that the next hearing is scheduled for October 9 and demanded that the state government secure a final judgment on that day. They also urged authorities to announce

the examination schedule immediately, calling for the tests to be conducted in December

According to the aspirants thousands of postgraduates across the state remain unem ployed due to the unresolved case. They warned that if their demands are not addressed, they will escalate their agitation in the coming days.

Aspirant Hari Sankar said "In March 2024, 786 SSC lecturer posts were announced, attracting around 85,000 appli cants. The exam was delayed and although the SSC chair man assured it would be held by November-December, the court later quashed the ad vertisement. Despite filing a case and repeated follow-ups, we have only been given post poned dates for over a year. We demand the exams be conduct ed soon, or we may resort to a hunger strike."

Four held for cabbie's kidnap, suicide

Bhubaneswar, Sept 22: The police have arrested four people for their alleged involvement in abduction and suicide of a taxi driver whose body was found on the outskirts of Bhubaneswar last week.

The deceased was identified as Bidyadhar Sahoo (35) of Khurda district's Aranga village. His body was found near Ju-

jhagada village on Pitapalli-Baranga road under Chandaka police station limits Saturday.

According to police, the accused persons along with some others had kidnapped Sahoo after he allegedly cheated them of lakhs of rupees on the promise of providing jobs. They demanded a ransom of ₹1.5 crore from the wife of Sahoo.

Some others, including a woman, were allegedly involved in the job fraud case, the police said.

'Sahoo had allegedly taken educational certificates and some money from the accused persons in the promise of giving them jobs. September 15, the accused persons forcefully took Sahoo to Jajpur and asked him to return their money and documents." Bhubaneswar-Cuttack Police Commissioner S Dev Datta Singh

said here Monday.

Subsequently, he allegedly died by suicide in the house in Jajpur September 19, where he was held captive by the abductors. The accused persons later disposed of his body and abandoned his taxi near Chandaka, he said.

25-ft croc in Gobari river sparks panic

Mahakalapara, Sept 22: Panic has gripped villagers in Kendrapara district after a giant crocodile, estimated to be more than 25 feet long, was sighted at Gobari Mouth-1, the interjunction of Baulakani, Jambu and KB Dandua panchayats near the Mahakalapara Tini Muhani ferry ghat.

Locals said the crocodile has been swimming close to ferryboats, particularly during crossings, and has attacked goats, sheep, ducks and cattle along the riverbanks. Many villagers, who depend on fishing and crabbing in the Gobari river for their livelihood, have now stopped entering into the water out of fear. Residents also reported that crocodiles—both small and large—are commonly seen in Gobari river passing through nearby areas, including Pathanpeta, Jambu, Bena Kandha, Milan Moda, Tarapada, Radia, Baodhi, Babar,

Itakandia, Ekalpur Ghat, Mali Ancha Ghat, Bijayanagar Ghat, Deulapada, Chandia Palli, Orat Ghat and Jalkana.

The Forest department had earlier installed wire fencing along several ghats and bathing spots, but villagers said the structures were of poor quality and have been damaged at many locations. They demanded stronger protective measures from the authorities.

Meanwhile, three crocodiles have reportedly entered

the Jambu-Marshaghai main canal, creating fresh alarm among residents. "The reptiles are frequently sighted near our village canal," said villagers Mani Biswas, Dilip Mandal and Krupasindhu Haldar of Skulgheri village.

When contacted, Mahakalapara Range Officer Shantanu Kumar Dalai said the Forest department has been carrying out awareness campaigns to caution riverside residents against entering the waters.

Fresh landslide at **Kalinga Ghat hits**

restoration work

Berhampur, Sept 22: Restoration work at Kalinga Ghat. a stretch of NH-157 connecting Ganjam and Kandhamal districts, was hit due to a fresh landslide Monday, an official

The stretch was badly damaged after massive landslides September 16. While several huge rocks

rolled down the hills due to fresh rainfall, other rocks were hanging precariously. National Highways Authority of India (NHAI) Chief Construction Engineer Bankim Chandra Panda, who was on the spot to oversee the repair work, said.

The situation is terrible now and work has been stalled, he said.

Even though we deployed heavy equipment for repair to restore traffic movement temporarily, work can't progress now, he said, adding the fresh landslide was a setback for the restoration.

He said NHAI could not give any probable date for completion of the stretch in view of heavy rain.

If rain continues for some more days, the temporary construction of the highway will be further delayed, he added.

Pak-Saudi Pact

hat has been unofficial for years is now official. Saudi Arabia's landmark mutual defence pact with Pakistan signed on 17 September could come with double benefits for Pakistan. It will greatly strengthen Islamabad and help it play a major role in the geopolitical strategies planned by every other country in the Middle East, especially in the backdrop of recent tensions. India's military action under Operation Sindoor might have acted as a trigger for Pakistan while Israel's attack at Doha in Qatar on Hamas leaders might have acted similarly on the Saudis.

The Strategic Mutual Defence Agreement, signed in Riyadh during Pakistan Prime Minister Shehbaz Sharif's recent visit, cements ties between the two countries in such a manner that both countries will treat an attack on one as an attack on both. Reports also indicate the pact extends to Pakistan's nuclear capabilities, allowing them to be considered part of Saudi Arabia's arsenal in case of an emergency. This implies that out of the 56 or so Islamic nations across the world, all those who sign this kind of a defence agreement with Pakistan will also benefit from a nuclear deterrent in this indirect manner.

Pakistan has emerged stronger with the pact seemingly instilling new confidence in the country's military establishment. It gets new partners, while its principal ally remains China which provides to it military support in addition to intelligence inputs. This further implies that those Islamic nations that ink a pact with Pakistan will get Chinese defence technology and intelligence as a bonus package.

The new pact comes at an opportune moment for Pakistan as its relations have improved much with the US since President Donald Trump assumed charge for the second time. It is no secret that Saudi Arabia has been supporting Pakistan's nuclear programme for many years by providing the much needed funds. It was understood that Saudi Arabia would use Pakistan's nuclear capabilities should the need arise. The new pact formalises that understanding. The fact that they are now openly declaring a collective security pact is a very significant financial achievement for a cash strapped nation like Pakistan.

The deal marks a shift in Riyadh's security calculus. It appears Saudi Arabia is now trying to expand its alliances so that it has to depend less exclusively on the US for security purposes. Israel's recent attack on Qatar, a US ally, seems to have jolted Saudi Arabia's confidence in relying on US support. It must have alarmed Riyadh that the US did not make any noise, not to speak of censuring Israel, for invading Qatar's airspace to launch a missile attack. This has apparently cast doubts about US security guarantees to the Gulf monarchies. With Israel's war in Gaza, Iran-backed Houthis flexing their military muscle and America adopting an ambivalent attitude to friendly Arab countries when it comes to supporting the Israeli offensive, Saudi Arabia seems to find in Pakistan its best bait as a security provider.

With this sudden development India finds itself in an unenviable position, especially, as it has been bragging of its successful Middle East policies with top leaders, including Prime Minister Narendra Modi, making frequent visits to the Arab countries in recent times. For Pakistan the pact offers strategic deterrence against India in future military confrontation, especially in response to cross border terrorism. India in its recent campaign post-Pahalgam massacre has made a virtue of its "surgical strikes" at terrorist networks inside Pakistan and declared it would repeat such strikes whenever there are non-state actors organising terror attacks in India. As per the stipulations of the pact, Saudi Arabia will construe any Indian forays into Pakistani territories as an attack on itself as well.

The Indian foreign affairs establishment is studying the implications of the pact, both its strategic and economic aspects. India is the second largest trade partner of Saudi Arabia whereas Saudi Arabia is the fifth largest trading partner of India. Also, Saudi Arabia is the third largest crude oil supplier to India. The question is whether Saudi Arabia will give more importance to its economic ties with India than its defence commitment to Pakistan under the pact should such a choice become inevitable. In a sense Saudi Arabia will have to make a balance between Pakistan providing it comfort in the defence area and India giving economic benefits including a very substantial community working in the country.

There is also the question of whether the Saudi-Pak defence pact would impact India's relationship with other Moslem countries in the Arab world such as Oman, UAE and Qatar. It could be that these countries may not look at India with the communal lens or from the perspective of India-Pakistan conflict. The Mumbai terror attack in 2008 launched by operatives from Pakistan was condemned by many of the Arab countries. India can only hope that religion or solidarity of the Arab world with Pakistan on the basis of their common Islamic faith would not influence its relations with India.

INDIA'S SOARING TRADE DEFICIT

ndia has been living with chronic trade deficits for nearly half a century. The last time the country recorded an overall annual trade surplus was in 1976–77 that was only the second time in its history, the first being in 1972-73. Since then, the red ink has flowed year after year. India has consistently imported far more than it has exported, with China leading the pack of deficit partners, followed by Russia, Saudi Arabia, the UAE, and Indonesia. The inability to build an export-oriented manufacturing base while allowing low-tech imports to flood the market has locked India into a cycle of rising deficits and shrinking competitiveness.

For decades, successive governments have offered the same explanation: petroleum imports. India is indeed 85-90% dependent on imported crude, and last year's petroleum bill stood at around \$180 billion. But the argument is misleading. Petroleum is only part of the problem. Once petroleum exports are netted out, the effective share of crude and products in the total import bill falls marginally around 10 to 14%. The real issue is the explosion of non-petroleum imports—ranging from electronics and chemicals to plastics, fertilizers, and even mundane household items like cotton swabs and kitchenware. These are products that India could manufacture at home, yet they are imported in bulk, often rebranded and sold at premium prices.

In 2024–25, India's imports climbed to \$720.24 billion from \$678.21 billion a year earlier, while exports fell to \$437.42 billion. This pushed the trade deficit to \$282.83 billion, among the highest ever. Petroleum product exports, once a buffer, dropped 13.7% in value despite higher volumes, even as non-petroleum imports surged unchecked—highlighting policy lapses and frail domestic

capacity.

India's manufacturing base remains shallow, fragmented. and dependent on imports for critical inputs. Consider electronics. India imported electronic goods worth over \$80 billion in 2024, making it one of the largest items in the import basket. Most domestic electronics manufacturing remains limited to assembly, with high dependence on imported components like semiconductors, displays, and microchips. The same pattern holds true in chemicals, pharmaceuticals (especially active ingredients), and machinery.

Contrast this with China. In the early 1950s, its economy was smaller than India's, and it too ran trade deficits. But Beijing quickly shifted gears in the post-Mao era. It adopted performance-driven policies: building infrastructure at lightning speed, boosting industrial capacity, creating jobs, and relentlessly pushing exports. The result is a global manufacturing powerhouse that now runs surpluses year after year. From toys and textiles to power equipment and telecom gear, Chinese goods dominate Indian markets. The situation has become so unbalanced that many Indian companies depend on Chinese inputs to remain competitivefurther entrenching the deficit.

India's global exports share remains 1.8%, ranking 17th worldwide. By comparison, China commands more than 14% of world exports. Even smaller economies like Vietnam and Malaysia now surpass India in certain segments. Vietnam, once devastated by war, has transformed itself into a manufacturing and export hub for electronics, textiles, and machinery. In 2023, its exports crossed \$350 billion—nearly matching India's despite a population 15 times smaller.

The US remains India's largest export destination, absorbing a wide range of goods from pharmaceuticals and IT services to gems and textiles. But the ground is shifting. Since August 2025, Washington has imposed 50% tariffs on a range of Indian goods. In response, New Delhi has scrambled to put together a ₹25,000-crore export support plan under its "Export Promotion Mission." Spread over six years, the initiative promises cheaper credit, insurance support, and incentives for diversification into new markets beyond the US. Yet the scale of support pales in comparison to what competitors offer. Vietnam, for instance, has provided tax holidays, cheap land, and infrastructure support to exporters, while Mexico has leveraged its proximity to the US with trade

agreements and logistics ad vantages.

In a hyper-competitive export market dominated by China and fast-emerging players such as Vietnam, Indonesia, Malaysia, and Mexico, India risks being squeezed from all sides. To escape the trade trap, India must rethink its economic strategy on several fronts. First, it must curb non-essential imports through smart tariffs, quality controls, and domestic substitution. There is no reason India should import billions worth of low-tech items that can be made locally.

Second, it must build real capacity in high-value manufacturing—electronics, semiconductors (small beginning made), pharmaceuticals, and green technologies. Third, India has to reduce overdependence on the US and the EU. Fourth, it has to promote manufacturing by cutting costs on logistics, power, and smoothen-

ing regulatory systems.
Finally, India must recognise that remittances, IT services, and petroleum re-exports are no substitute for a strong goods export base. These revenue streams have cushioned the current account but cannot drive long-term prosperity.

The stakes are high. Chronic trade deficits are not just a number on a balance sheet; they represent lost jobs, lost industries, and lost opportunities. Unless India breaks out of this cycle, it risks remaining a perennial net importer—its growth hobbled, its currency under pressure, and its economic sovereignty weakened.

In 1976–77, India briefly tasted the power of a trade surplus. Nearly 50 years later, that moment is still a dream. If India is to reclaim it, the country needs more than slogans—it needs a decisive, sustained push for industrial strength and export dynamism. Otherwise, the trade trap will keep snapping shut, year after year.

the University of California, San Diego called Last Gift offers terminally ill patients the opportunity to help create more effective treatments. Their special circumstances transform the usual risk-benefit calculus of joining a clinical study of an untested drug. Researchers can ask them to consider consenting to being research participants in ways that they would not ask healthier people with long life expectancies, and terminally ill patients may choose to give that consent when others would be less likely to do so.

The leading United States research agencies, the Food and Drug Administration and the National Institutes of Health. have recently issued strong statements about moving away from testing drugs on animals. The results from such tests, they now acknowledge, do not translate well into findings relevant to humans. Terminally ill patients can offer their own bodies to contribute to this growing effort to make drug testing more human-relevant, generating data on how people, rather than beagles or mice, respond to new

treatments, while also reducing the suffering currently inflicted

Before launching Last Gift, researchers at UCSD surveyed nearly 500 people about end-of-life medical research. More than half said they would be willing to give up four weeks of their life to participate in research even if they had only six months to live.

Over a third said that if they had a terminal illness, they would agree to being exposed to pathogens, such as streptococcus bacteria, hepatitis C virus, and malaria, to help develop new treatments and vaccines. A desire to "give back" was also expressed by individuals receiving hospice care. For many, the idea of contributing to science brought a deeper sense of meaning to their lives.

Currently, the Last Gift programme is focused on understanding where HIV hides. Participants in this study are infected with HIV as well as being terminally ill. They don't just donate their bodies for research to be conducted after their death; they also participate in invasive procedures while still alive, including biopsies, spinal taps,

and blood draws.
Davey Smith, the lead inves-

tigator for the Last Gift study at UCSD, says, "It is incredible how much our study participants want to give of their time, energy, and literal body to science. They are pushing hard for us to do more, faster. For the next phase of the programme. Smith and colleagues are developing ethically and scientifically sound approaches to testing treatments and vaccines in Last Gift participants. Smith understands the great advantage that testing drugs in humans has over testing drugs in nonhuman animals: "Our physiology is just different," he says, "Thousands of drugs found promising in an-

The research does not need to be in an area related to the participant's illness. For example, a person with advanced cancer might volunteer for a trial of a vaccine for an infectious viral disease. The trial will involve deliberate exposure to the virus, to test whether the vaccine offers protection.

imals have failed in humans."

It isn't difficult to imagine a programme that offers people with limited life expectancy a choice of ongoing research projects that they can participate in, thus leaving it up to participants to decide which diseases or medical conditions matter most to them. Offering that choice restores agency to people near the end of life and actively integrates them into a broader human effort to improve human health.

One doesn't have to be a researcher to make an important difference to medical research. Many patients could contribute to the development of safer drugs for curing human diseases while helping to reduce the use of animals in research. Productive medical research partnerships with the dying can save human lives, and at the same time add meaning to the last days of terminally ill patients. Initiatives like Last Gift have the potential to benefit all sentient beings - humans and animals.



Gold surges ₹2,200 to hit fresh high Sensex, Nifty plummet

New Delhi, Sept 22: Gold prices surged Rs 2,200 to hit a fresh peak of Rs 1,16,200 per 10 grams in the national capital on Monday buoyed by strong global cues as investors awaited key commentary from US Fed officials for policy direction.

According to the All India Sarafa Association, the precious metal of 99.9 per cent purity had closed at Rs 1,14,000 per 10 grams Friday. In the local bullion market,

gold of 99.5 per cent purity rallied Rs 2,150 to hit a record high of Rs 1,15,650 per 10 grams (inclusive of all taxes). It had settled at Rs 1,13,500 per 10 grams in the previous market session.

"Both gold and silver traded at record levels in the domestic markets, tracking the bullish trend in international markets.

"A dovish signal from the US Federal Reserve (Fed) suggests that two additional rate cuts are likely by the end of this year, which could limit gains in the US dollar and Treasury yields while bolstering precious metal prices," Saumil Gandhi, Senior

Analyst - Commodities at HDFC Securities, said.

In addition, a strong inflow into exchange-traded funds as well as continued interest from central bank has also contributed to the rise in bullion prices, Gandhi added.

The precious metal prices have added Rs 37,250 per 10 grams or 47.18 per cent in the current calendar year, climbing from Rs 78,950 per 10 grams on December 31, 2024.

Meanwhile, silver prices skyrocketed by Rs 4,380 to hit an all-time high of Rs 1,36,380 per kilogram (inclusive of all taxes) Monday. The white metal had ended at Rs 1,32,000 per kg Friday, as per the Association.

From the Sensex firms, Tech Mahindra, Tata Consultancy Service, Infosys, HCL Tech, Tata Motors, Trent, Reliance Industries and Larsen & Toubro were among the major laggards. However, Eternal, Bajaj Finance, Adani Ports and UltraTech Cement were among the gainers. President Trump Friday signed a proclamation raising the fee on the visas used by companies to hire workers, including from India, to live and work in the US.

The H1B visa fee of \$1,00,000 would be applicable only to new applicants, a White House offi-

New Delhi, Sept 22: As lower GST rates take effect Monday, sales of air-conditioners, TV sets surged dramatically with buvers rushing to grab cheaper deals offered by retailers at the beginning of the Navratra festival.

Neighbourhood kirana stores also witnessed a modest rise in sales of daily essentials as well as food items.

The new two-slab GST (goods and services tax) structure of 5 per cent and 18 per cent has replaced the earlier four-rate duty regime following GST Council's sweeping reform aimed at boosting consumption across the country. This led to price cuts of most

of the common-use items ranging from foods, toiletries and cosmetics to white goods such as TV and air-conditioners from Monday, which also coincides with the beginning of the nine-day annual Navratra festival. Dealers of home appliance

Costly H1B likely to spark offshore, local talent moves

New Delhi, Sept 22: The magnitude of the new H1B visa application fee for fresh petitions - math of which works out to \$500 million in case of 5,000 filings - may nudge IT companies to expand offshore delivery or increase local hiring, according to Motilal Oswal Financial Services.

The \$100,000 fee will start to impact from FY27 onwards, when new petitions are filed. The visa applications for FY26 are already locked in.

"If an IT company were to apply for 5,000 H1Bs in FY27, the annual fee alone would amount to \$500 million (5,000x\$100,000). Given the magnitude of this fee, it is likely that Indian IT companies will avoid new H1B filings altogether, opting instead to expand offshore delivery or increase local hiring," it said.



If new H1Bs "vanish", on-site revenues will decline, but so do on-site costs. This shift could improve op-

erating margins, as offshore work tends to be structurally more profitable. The net effect on earnings per share could be neutral in the medium term, although topline growth could be slower, according to it.

On the evolving risk, it said the fee hike order is likely to be challenged in US courts and may not survive in its current form. Over the last decade, Indian

IT vendors have reduced their reliance on H1B visas. "With localisation drives in

the US and higher local hiring, only about 20 per cent of employees are currently based on-site. Of this, 20-30 per cent are on H1B visas, implying that H1B holders represent just 3-5 per cent of the active workforce for a typical vendor," it noted. For IT vendors, localisation

and subcontracting are already baked into their delivery models, making them relatively better placed to adjust. On Monday, Nasscom said

that US clarification that the H1B visa fee hike will not affect current visa holders and will apply as a one-time fee only to fresh petitions, helped address the immediate ambiguity surrounding eligibility and timelines. It alleviates concerns on business continuity and uncertainty for H1B holders that were outside the US, as per the association.

Further, it pointed out that Indian and India-centric companies operating in the US have significantly reduced their dependencies on H1B visas and are increasing local hirings, and added, given this "we anticipate only a marginal impact for the sector"

"Moreover, with the fee being applicable from 2026 onward, it gives companies time to further step up skilling programmes in US and enhance local hiring,' the apex industry body said. The industry is spending

over \$1 billion on local upskilling and hiring in the US and the number of local hires has increased tremendously.



New Delhi: In a coordinated crackdowns against narcotics and organised crime, the Delhi Police has arrested 120 drug peddlers and recovered a substantial quantity of narcotics along with Rs 21 lakh cash under "Operation Kavach 10.0", an official said Monday. The 24-hour operation, carried out ahead of the festive season, was launched September 20. "It covered over 2,000 locations across all 15 districts of the national capital, with 1,140 police teams, including units of the Crime Branch and Special Cell, participating simultaneously,' Special Commissioner of Police (Crime Branch) Devesh Chandra Srivastva in a statement said.

Migrant workers hurl stones at police

New Delhi, Sept 22: The Centre Monday decided to extend the ban imposed on the National Socialist Council of Nagaland (Khaplang) [NSCN (K)] along with all its factions, wings and front organisations for five more years due to its involvement in activities prejudicial to the sovereignty and integrity of India.

The ban will be effective from September 28 for a period of five years, a Ministry of Home Affairs (MHA) notification said.

The central government is of the opinion that the NSCN (K) has declared its aim to create a sovereign Nagaland incorporating the Naga inhabited areas of the Indo-Myanmar region by secession from the Indian Union and aligned itself with other unlawful associations like the United Liberation Front of Asom (Independent) [ULFA (I)], People's Revolutionary Party of Kangleipak (PREPAK) and People's Liberation Army (PLA), it said. Narayanpur, Sept 22: Two top Maoist leaders carrying a bounty of Rs 40 lakh each in Chhattisgarh were killed in an encounter with security personnel in the state's Narayanpur district Monday, police

The two have been identified Raju Dada alias Katta Ramachandra Reddy (63) and Kosa Dada alias Kadari Satyanarayana Reddy (67), both Central Committee members of the outlawed Communist Party of India (Maoists), they said. The operation garnered praise from Union Home Minister Amit Shah who called it a "major victory" for security forces.

Chief Minister Vishnu Deo Sai hailed it as a decisive achievement in Chhattisgarh's fight against Naxalism.

The gun battle broke out this morning in the forest of Abhuimaad, adjoining Maharashtra, when security forces were out on a search operation based on inputs about the movement of senior cadres in the region, Narayanpur Superintendent of Police Robinson Guria said.

"Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), (hereinafter referred to as the said Act), the central government hereby declares the National Socialist Council of Nagaland (Khaplang) [NSCN (K)] along with all its factions, wings and front organisations as an unlawful association," the notification said.

The home ministry said several activities have been noted involved between September 28, 2020 and April 30, 2025. These include registration of 71 cases against its cadres with 56 chargesheets filed and 35 cadres prosecuted, involvement of its cadres in 51 other criminal activities, arrest of 85 cadres and surrender by 69 cadres and recovery of 69 arms, 52 magazines, 931 live rounds, 10 grenades, 150 detonators, three explosives gel tubes, 200 grams trinitrotoluene one-and-a-half kilogramme improvised explosive device (IED) and 800 grams of other explosives.

During this period, 13 underground cadres were killed in action by police or security forces.

The state governments of Nagaland, Manipur and Arunachal Pradesh have also recommended the declaration of NSCN (K) as an unlawful association under the Unlawful Activities (Prevention) Act (UAPA).

"And whereas, the central government is of the opinion that the aforesaid activities of NSCN (K) are detrimental to the sovereignty and integrity of India and if these are not immediately curbed and controlled, the NSCN (K) may further regroup and rearm itself, expand its cadres, procure sophisticated weapons, cause loss of lives of civilians and security forces and thereby accelerate its anti-national activities. And whereas, the central government is of the opinion that for the reasons aforesaid, the NSCN (K) together with its factions, wings and front organisations, is an unlawful association," the notification said.

'Caste census' begins in Karnataka

Bangalore: The Social and Educational Survey, popularly known as the 'caste census' in Karnataka, commenced Monday, with enumerators going door-to-door to collect data. While the survey is underway in most parts of the state, officials indicated a potential delay of one or two days in the Greater Bengaluru area, where five corporations have been newly formed due to training and necessary preparations. The survey by the Karnataka State Commission for Backward Classes will see as many as 1.75 lakh enumerators, mostly government school teachers, covering around 7 crore people in approximately 2 crore households across the state.

SC posts bail pleas of Khalid, Imam for Oct 27

New Delhi: The Supreme Court Monday sought Delhi Police's response on Meeran Haider in the UAPA case related to the alleged conspiracy behind the February 2020 riots in Delhi. A bench of Justices Aravind Kumar and N V Anjaria issued notice and posted the matter for October 27. As the hearing commenced, Justice Kumar clarified that the matter could not be taken up for hearing September 19 as Justice Manmohan, who was sitting with him on the bench, wanted to recuse as he was an associate in the chambers of senior advocate Kapil Sibal at one point in time.

Afghan boy lands in Delhi by hiding in plane

New Delhi: A 13-year-old Afghan boy's "curiosity" brought him to Delhi from Afghanistan after he somehow managed to get inside the landing gear compartment of an aircraft that took off from Kabul, official sources said Monday. The incident was reported around 11 am on Sunday when KAM airlines flight number RQ-4401 reached the Indira Gandhi International (IGI) Airport after a 2-hour journey. The teenager was, however, repatriated to Afghanistan Sunday itself, on the same flight, sources said. The airline authorities reported to the airport security control room about a 13-year-old boy who was found roaming near the flight after it touched down, they said. The boy, a native of Kunduz city, was apprehended by the airline personnel and handed over to the Central Industrial Security Force personnel, who brought him to Terminal 3 of the airport for questioning.

Rahul, Kharge to attend CWC meeting in Patna tomorrow

The Congress leader alleged that the ruling BJP at the Centre was involved in "vote theft" and Prime Minister Narendra Modi was "like a student who does not study hard, but takes recourse to unfair means for doing well in examinations".

Asserting that Bihar, where Gandhi recently took out an over 1,300-km Voter Adhikar Yatra, had become "the centre of national politics", Allavaru said. "We are fighting the second war of Independence in the state, a reason why the CWC meeting is being held here."

In reply to another query, he said talks on seat-sharing are being held on a positive note in the INDIA bloc.

"We will soon come out with a viable formula. On the other hand, we find the BJP-led NDA in disarray," the Congress leader said.

Asked whether RJD leader Teiashwi Yadav will be named as the chief ministerial candidate of the INDIA bloc with a stamp of approval from the Congress, Allavaru said, "At an appropriate time, all alliance partners will sit together and decide".

PM unveils ₹5,100cr projects in Arunachal

Itanagar, Sept 22: Prime Minister Narendra Modi Monday alleged that the Congress has an "inherent habit" of abandoning any development work that is difficult, and this caused significant harm to the Northeast.

He made the statement after unveiling development works worth over Rs 5,100 crore in Arunachal Pradesh, among which were two mega hydropower projects.

Criticising the Congress, he claimed that it overlooked Arunachal Pradesh in terms of development, as the state has only two Lok Sabha seats.

The PM said he knew that the Northeast couldn't be developed from Delhi, and so, he sent ministers and officers more frequently to the region, and himself came here more

than 70 times.

"One inherent habit of the Congress is that they never take up development work which is difficult to do; they abandon it. This habit of Congress caused significant harm to Arunachal Pradesh and the entire Northeast. In the hilly and forested areas, where development work was challenging, Congress would declare the regions backward and simply forget them," he claimed.

Modi said areas once considered impossible for building roads now have modern

The Sela tunnel, which was once unthinkable, is now a proud identity of Arunachal The Hollongi airport has a new terminal and has flights connecting directly to Delhi, he said.

The PM said all these connectivity projects eased travelling and helped farmers send their produce to big markets. "When I was given the op-

portunity to serve the nation in 2014, I resolved to free the country from the mindset of Congress. Our guiding principle is not the number of votes or seats in any state, but 'nation first'," he said. "Modi worships those

New Delhi, Sept 22: The NHRC has issued notice to the Ministry of Information and Broadcasting and Mumbai police commissioner in the wake of a complaint alleging that web series 'Ba***ds of Bollywood' on an OTT platform, showed a popular actor using banned e-cigarette on screen, "without any warning or disclaimer", according to

alleged that this particular scene was "streamed openly", which misled or negatively influenced young viewers by allegedly promoting use of such banned substances, it says.

There was no immediate reaction from the ministry or overthe-top platform Netflix.

The National Human Rights Commission has said that authorities be directed to get the allegations levelled in the complaint, be inquired into, and an "action taken report" be submitted within two weeks for perusal of the Commission.

pressed concerns that such "irresponsible content promotes illegal activities, disrespects law enforcement, and harms public health and morality' The complainant sought the

intervention of the NHRC and "requested strict legal action against the actors, producers, and Netflix" for allegedly violating Indian laws and "spreading harmful content", the proceedings says. The allegations made in the complaint prima facie seem to be serious violations of the laws, the NHRC said.

A bench of the NHRC, presided by its member, Priyank Kanoongo, has taken cognisance under Sections 12 of the Protection of Human Rights Act, 1993, the proceedings says.

"Furthermore, this incident is in clear violation of Sections 4 read with Section 7 of the Prohibition of Electronic Cigarettes Act, 2019. It is pertinent to mention here that Section 4 prohibits the storage, use, and promotion of e-cigarettes in any form, and Section 7 penalises individuals and companies that advertise or promote such banned products," it adds.

The registry has been directed to issue a notice to the secretary of the Ministry of In formation and Broadcasting, to "take appropriate action and immediately prohibit such content which may wrongly influence the young generations".

The notice is also marked to commissioner of police of Mumbai, regarding "initiation of investigation into the identity and operations of manufacturers and importers of electronic cig arettes, and for taking appropri ate legal action including lodg ing of an FIR as per laid down procedures against actor Ranbin Kapoor and other individuals companies including the pro ducers/production company OTT platform Netflix, involved in the advertisement, depiction or promotion of the same in contravention of the Prohibition of Electronic Cigarettes Act, 2019 and other applicable criminal laws," it says.

A group of friends went to a party at a bar, where an argument over splitting the bill led to an altercation, according to preliminary investigation.

Building collapse in **Indore: 7 rescued**

Indore: A three-storeyed building collapsed amid rains in Indore in Madhya Pradesh Monday night, following which seven persons were rescued while a few others are feared trapped under the debris, officials at the site said. The incident took place in Ranipura area, they added. 'Initial information suggests the building is 8-10 years old. A portion of the structure fell onto an adjacent building. Around 10-12 persons were said to be trapped under the debris.

Man gets life term for murdering lover

Thiruvananthapuram: A court here Monday sentenced a Kollam native to life imprisonment for strangling his lover to death at a city lodge in 2022. Additional **District Sessions Court** Judge Siju Shaikh sentenced Praveen to life imprisonment and a fine of Rs one lakh for the murder of Gayathri (27), who hailed from the Kattakkada area. The crime took place March 5, 2022. Police said that, though there were no eyewitnesses, circumstantial and digital evidence helped secure a

conviction in the case.

Selective release of report irks SC

New Delhi, Sept 22: The Supreme Court Monday termed as "unfortunate and irresponsible" the selective publication of a preliminary report on the June 12 Air India crash which outlined lapses on the part of pilots and paved way for a "media narrative".

A bench of Justices Surya Kant and N Kotiswar Singh, which issued notices to the Centre and the Directorate General of Civil Aviation (DGCA) on the aspect of an independent, fair and expeditious probe of the crash, said an element of privacy and dignity of families of victims was also involved.

It took note of certain aspects of the Aircraft Accident Investigation Bureau (AAIB) preliminary report issued July 12 and said "piecemeal and selective" publication of the findings which led to building of a media narrative was "unfortunate and irresponsible"

"There should be complete confidentiality of reports of this nature till the inquiry is complete. There is an element of privacy and dignity of the victims involved. That's why we should wait for the final report," the bench observed.

Advocate Prashant Bhushan, appearing for the NGO 'Safety Matters Foundation', earlier said one line of the preliminary report which blamed the pilots for the crash led to building of a narrative in the media across "Unless people know what

was the cause of the accident, they are in danger as no preventive steps can be taken till then. It's been over 100 days since the crash and we still don't know the reason," Bhushan said.

He alleged in the probe panel constituted after the crash, three of the five-members were from the aviation regulator and there could be an issue of conflict of interest.

"There are three interested parties-manufacturer of aircraft, airline and the DG-CA and involvement of any member of these three parties will be a conflict of interest. How can officers of the very organisation whose role is likely to be examined be part of the committee probing the incident," Bhushan said.

He said revealing information from the flight data recorder of the airplane would "clear the air" over the cause

The bench said while the demand for free, fair and independent inquiry was understandable, the demand for information from the flight data recorder was "questionable".

While cautioning that releas ing a particular information might be exploited by rival airlines, the bench suggested such information should not be released prematurely.

"We should not release the information piecemeal and maintain utmost confidentiality till the regular inquiry is taken to its logical conclusion. Then only we can say what was the actual reason," Justice Kant said.

Bhushan referred to a podcast, which claimed of having examined all aspects of the incident, and said it concluded that it was not a case of pilot's

Media reporting from one isolated line from the preliminary report has actually distorted the larger picture," he submitted and added the probe panel could be headed by a judicial person.

When bench felt an independent inquiry by domain experts was a better option, Bhushan said a retired judge could head the panel to oversee the inqui-

The top court said such inqui ries should happen promptly to quell rumours and speculations and avoid selective leakage of information to media, social media and other forms of me-

Bhushan reiterated about the flight data recorder, but the bench pointed out the possibili ty of several "parallel theories" if information was released.

Bhushan said theories would anyway come even after the final report and there was no way to prevent it.

The plea has been filed by an aviation safety NGO led by Captain Amit Singh, alleging that the official probe violates citizens' fundamental rights to life, equality and access to truthful information.

The plea says the AAIB issued its preliminary report on July 12, attributing the accident to "fuel cutoff switches" being moved from "run" to "cutoff" effectively suggesting a pilot error. It alleged that the report withheld critical information, including the full Digital Flight Data Recorder output, complete Cockpit Voice Recorder transcripts with time stamps and Electronic Aircraft Fault Recording data.

New Delhi, Sept 22: Prime Minister Narendra Modi on Monday said the next generation GST reforms will boost savings and directly benefit every section of society, as he asserted that it is imperative to walk on the path of self-reliance to achieve the collective goal of Viksit Bharat by 2047.

In an open letter to Indians which he posted on X, Modi said that from September 22, next generation GST reforms have begun to make their presence felt, marking the start of a 'GST Bachat Utsay' or 'GST Sayings Festival' across the country.

"This year, the festive season brings an added reason to rejoice. These reforms will boost savings and directly benefit every section of society, be it farmers, women, youth, poor, middle class, traders or MS-MEs. They will encourage greater growth and investments and accelerate the progress of every state and region, the prime minister said.

An important feature of the next generation GST reforms is that there will mainly be two slabs of 5 per cent and 18 per cent, he said. "Daily essentials such as

food, medicines, soap, toothpaste, insurance and many more items will now either be tax-free or fall in the lowest 5% tax slab. Goods that were earlier taxed at 12% have almost entirely shifted to 5%. It is greatly heartening to see various shop keepers and traders putting up then and now boards which in dicate taxes pre-reforms and post-reforms," Modi said in his letter to the people.

In the last few years, 25 crore people have risen above pover ty and formed an aspirational neo-middle class, he said.

"Further, we have also strengthened the hands of our middle class with the massive income tax cuts, which ensure zero tax up to the annual income of Rs 12 lakh. If we combine the income tax cuts and the Next Generation GST reforms, they add up to savings of nearly Rs 2.5 lakh crore for the people," he said.

Your household expenses will reduce and it will be easier to fulfil aspirations such as building a home, purchasing a vehicle, purchasing appliances, eating out or planning a family vacation," the prime minister said. 2nd autopsy of Zubeen's body today: Assam CM

Guwahati, Sept 22: A second postmortem of singer Zubeen Garg's body will be conducted Tuesday morning at the Gauhati Medical College Hospital (GMCH) following demands from certain sections of Assam people, Chief Minister Himanta Biswa Sarma said Monday.

The first autopsy was conducted in Singapore where Garg died by drowning September 19. His last rites will be performed on the outskirts of Guwahati Tuesday with full state honours

Sarma said that after the post-mortem examination at GMCH, his journey to the cremation ground will begin at 9.30 am, two hours after the earlier-announced time.

'It (second postmortem) is not a demand from the public but from certain fringe elements and we have decided to conduct it with his wife's consent," the chief minister said at a press conference here. 'We do not want to create any controversy over Zubeen, so this decision was taken,' he said.

The CM said that he personally was not interested in 'cutting up his body' as he is a 'die-hard Zubeen fan but when a section, even if they are in a minority, demands it, my personal wish does not matter. This is democracy'.

After the Singapore doctors had conducted the postmortem, 'I don't think it was necessary for another postmortem as they have more technical expertise but there should not be any scope for any section to indulge in any kind of politics over Zubeen,' Sarma said.

The postmortem will be conducted by a team of doctors from GMCH and AIIMS, Guwahati. 'It will take around two hours in the morning and so his final journey will begin at 9.30 am instead of the earlier scheduled time of 7.30 am,' the

New York, Sept 22: External Affairs Minister S Jaishankar Monday met US Secretary of State Marco Rubio for bilater al discussions, as the high-level 80th session of the UN General Assembly (UNGA) kicks in.

The meeting at Lotte New York Palace is the first face-toface interaction between them following President Donald Trump's imposition of an additional 25 per cent tariff on India for Delhi's purchases of Russian oil, taking the total levies imposed on India to 50 per cent.

They had last met in July in Washington DC for the Quad Foreign Ministers' Meeting. Their meeting takes place on the same day India and the US will hold discussions to achieve an early conclusion of a trade agreement.

A delegation led by Union Commerce and Industries Minister Piyush Goyal will meet with the US side on Monday in the city. "The delegation plans to take forward the discussions with a view to achieving early conclusion of a mutually beneficial Trade Agreement," the Ministry of Commerce and In dustry had said in a statement

The statement added that during the last visit of officials from the office of the US Trade Representative to India on September 16, positive discussions were held on various aspects of the trade deal, and it was decided to intensify efforts in this regard.

The bench added, "Suppose a judge is hearing a criminal appeal, then we don't expect him to decide 50 cases in a day and deciding one criminal appeal in a day is itself a very big achievement. But in a bail matter, if a judge says I will decide only one bail matter in

a day, that is something which requires introspection.

The top court, as a result, stressed on "performance evaluation" but underlined the question of parameters and guidelines guiding the process.

"Our intention is not to act as a school principal and there should be broad guidelines so

that judges should know what is the task before them and on how much task they must deliver. There is a legitimate expectation of the public at large from the judiciary," the bench added. The observations came on criminal appeals, where some life and death row convicts have knocked at the door alleging that the Jharkhand high court has not delivered verdicts on their criminal appeals despite reserving verdicts for years. However, the high court later delivered the verdicts in their case and acquitted many of the convicts Advocate Fauzia Shakil, who

appeared in the case, said a chart on the status of judgment delivery by various high courts and highlighted that some high courts have not given the data in a prescribed format.

The bench, asked her to file high court data where cases were reserved; date of pronouncements and date of uploading verdicts within two weeks. Senior advocate Ajit Sinha was asked to assist in the matter. Justice Kant pointed out that

4.3 magnitude quake **jolts San Francisco**

Berkeley: An earthquake with a magnitude of 4.3 rocked the San Francisco Bay Area early Monday, waking up many people, with more 24,000 saying they felt it, according to the United States Geological Survey. The earthquake was just east-southeast of Berkeley, the survey said. It happened shortly before 3 am PDT. People posted online that they felt their homes shake. A few stores in Berkeley had minor damage, like a broken window or some merchandise falling off shelves. Bay Area Rapid Transit posted on X that trains were running at reduced speeds as it completes safety track inspections. It told commuters to expect delays of up to 20 minutes system wide.

Egypt pardons activist Alaa Abd el-Fattah

Cairo: Egypt's President Abdel Fattah al-Sisi pardoned high-profile Egyptian-British activist, Alaa Abd el-Fattah, after a lengthy imprisonment and repeated hunger strikes that prompted international pleas for his release. Al Oahera news said Monday. Abd el-Fattah, 43, became Egypt's most prominent political prisoner after spending much of his adult life in and out of detention due to his activism, and a rare symbol of opposition to a far-reaching crackdown under Sisi. Despite many local and international campaigns calling for his release, most notably during the COP27 climate summit that Egypt hosted in 2022, that possibility only became tangible when Sisi ordered the relevant authorities in September to study his possible pardon.

Ecuador prison riot leaves 14 dead

Quito: A prison riot caused by gang fighting in southern Ecuador Monday left 14 people dead and another 14 wounded, according to a local police chief. Prisoners in port town Machala, south of Guayaquil, faced off with authorities, killing a guard and kidnapping officers, police chief William Calle told TV network Ecuavisa. "From the inside they were shooting, throwing bombs, grenades," Calle said. Some prisoners escaped, and 13 have been recaptured so far, he added. After about 40 minutes, authorities were able to retake control of the prison, according to Calle. Ecuador has been plagued by prison riots in recent years, with hundreds of inmates killed. The government of President Daniel Noboa, who has vowed to crack down on crime, attributes the clashes to gangs vying for territory and control.

Putin offers Trump a one-year extension to nuclear arms pact



Moscow, Sept 22: Russian President Vladimir Putin offered his US counterpart Donald Trump a nuclear arms control deal Monday that would extend the last treaty limiting both countries' nuclear weapons by one year while Moscow and Washington discuss what

Russia and the United States have by far the biggest nuclear arsenals in the world. The last remaining treaty between them that limits the numbers of these weapons is due to expire February 5 next year.

The New START treaty covers strategic nuclear weapons those designed by each side to hit the enemy's centres of military, economic and political power - and caps the number of deployed warheads at 1,550 on each side. Both are likely to breach that limit if the treaty is not extended or replaced.

PUTIN UNDER PRESSURE TO END UKRAINE WAR

Putin, who said his proposal was in the interests of global non-proliferation and could help spur dialogue with Washington about arms control, has been under pressure from Trump to agree to end the war in Ukraine. something Moscow says is part of a slew of security issues that have raised East-West tensions to their most dangerous level since the Cold War.

The offer, made at a time when Ukraine is trying to persuade Trump to impose harsher sanctions on Russia, was made public by Putin at a meeting of his Security Council.

Russia to complete deliveries of S-400 missile systems to India in 2026

Under the \$5.43 billion deal signed with India in 2018, Russia will complete deliveries of the S-400 Triumph air defence systems next year, according to a media report Monday. "Russia will complete the contract to supply India with five S-400 Triumph air defence systems in 2026. Four of these systems have been delivered to date, and the fifth will be delivered next year," a defence source was quoted as saying by the state-run TASS news agency. According to earlier media reports, the \$5.43 billion deal (Rs 40,000 crore) was formally signed October 5, 2018, ignoring the threat of US sanctions. In March 2021, US Secretary of Defence Lloyd Austin discussed India's planned purchase of Russia's S-400 air missile system and warned that the purchase of S-400 could trigger CAATSA sanctions. So far, the US has not invoked the Countering America's Adversaries through Sanctions Act signed by President Donald Trump in his first term as the S-400 deal has not been formally completed

"Russia is prepared to continue adhering to the central numerical limits under the New START Treaty for one year after 5 February 2026," said the Russian president.

"Subsequently, based on an analysis of the situation, we will make a decision on whether to maintain these voluntary self-imposed restrictions. We believe that this measure will only be viable if the United States acts in a similar manner and does not take steps that undermine or violate the existing balance of deterrence capabilities." The proposal appears to be a unilateral change of policy by Moscow which has until now insisted it would only engage with Washington on such matters if overall ties - hampered by stark differences over the war in Ukraine - improved.

TALKS ON OVERHAULING TREA-TY YET TO START

With just over four months to go before the New START runs out, differences over the Ukraine mean Russia and the United States have not started talks on renewing or overhauling the treaty though Trump has spoken of his desire to do a new nuclear arms control deal, albeit with China as well.

Beijing has rejected the idea that it should be included too. Putin said Russia would be monitoring US nuclear arms and defence activity, paying particular attention to Wash ington's plans to beef up its missile defences and ideas to deploy missile interceptors in space.

British Indian charity, biz, entrepreneurial efforts awarded in UK

Sour reaction from tech over Trump visa policy



New York/Bangalore, Sept 22: US President Donald Trump's new visa fees for foreign workers drew widespread condemnation from technology executives, entrepreneurs and investors across social media. with just a few outliers, as many saw it as a major blow to a sector that contributed millions to his re-election campaign.

Technology executives and investors said the new fees could add millions of dollars in costs for companies and disproportionately hurt startups, which may not be able to afford visas as part of their strategy.

In a confusing set of announcements beginning late Friday, Trump and other White House officials said they would charge firms \$100,000 apiece for H1B worker temporary employment visas, used by many tech majors, including Amazon.com, Microsoft and Meta Platforms.

Many criticized the move and the chaotic roll-out that required the White House to clarify the hefty fees would be charged just once, not annually, and they would not apply to existing holders including those who happened to be overseas at the time of the announcement.

Most executives at the tech giants, many of whom have forged close relationships with the Trump White House since

Karki expands Nepal's interim cabinet

Kathmandu: Nepal's newly-appointed Prime Minister Sushila Karki Monday inducted four new ministers into her interim cabinet, raising its strength to eight. President Ramchandra Paudel administered the oath of office to former Justice Anil Kumar Sinha. National Innovation Centre founder Mahabir Pun. journalist Jagdish Kharel and expert Madan Pariyar at a ceremony held at the presidential office, Sheetal Niwas. With the inclusion of four new ministers, the strength of the Karki-led Council of Ministers has reached eight. The Prime Minister has kept several important portfolios with her. Sinha is the Minister for Industry, Commerce and Supplies, while Kharel is the Minister for Communication and Information Technology. Pariyar is the Minister for Agriculture and Livestock Development, while Pun is the Minister for Education and Science and Technology.

NK's Kim says he is open to talks if US drops denuclearisation demand

Seoul: North Korea's Kim Jong Un said there was no reason to avoid talks with the US if Washington stopped insisting his country give up nuclear weapons, but he would never abandon the nuclear arsenal to end sanctions, state media reported Monday. "Personally, I still have fond memories of US President (Donald) Trump. KCNA reported the North Korean leader saying in a speech at the Supreme People's Assembly Sunday. The two leaders met three times during Trump's first presidency. Kim's comments come as the new liberal governmen Seoul urges Trump to take the lead in reopening dialogue with Kim, six years after all peace talks with Pyongyang collapsed over sanctions and nuclear dismantlement. "If the United States drops the absurd obsession with denuclearising us and accepts reality, and wants genuine peaceful coexistence, there is no reason for us not to sit down with the United States." Kim was guoted as saving.

Japan's ruling party opens leadership race to choose Ishiba's successor

Tokyo: Outgoing Japanese Prime Minister Shigeru Ishiba's ruling party opened official campaigning Monday to find his replacement who can restore political stability and voter support for the beleaguered Liberal Democrats. Five candidates are vying for the Liberal Democratic Party's top job ahead of a highly unpredictable vote in early October. The race has a slogan, "Change, LDP." The winner must act quickly to address rising prices if the party is to have any chance of winning back support following devastating losses to both the LDP and its junior partner Komeito in the past year that deprived their coalition of a majority in either house of parliament. Its new leader is still likely to be prime minister because the LDP remains the No. 1 party, while opposition groups are too splintered to form a coalition. Whoever becomes the LDP leader must also gain cooperation from main opposition parties or risk facing constant no-confidence motions and a cycle of shortlived leadership. The Oct 4 vote is not open to the general public. It is limited to 295 LDP parliamentarians and 1 million dues-paying grassroots party members. That's less than 1 per cent of Japan's eligible voters.

Pak strikes kill 24 citizens

Peshawar, Sept 22: At least 24 people, including women and children, were killed and several others injured Monday when explosive materials stored at a compound owned by the Pakistani Taliban exploded in northwest Pakistan, police said.

The residents, however, claimed that air strikes hit the compound in Tirah Valley's Matur Dara area in Khyber district of Khyber Pakhtunkhwa province, bordering Afghanistan.

No official statement has been issued by the government regarding the tragedy.

Pakistan Tehreek-e-Insaf party's provincial branch claimed that the "jet bombing" in the Tirah Valley destroyed five houses. It said that 20 bodies have been recovered from the rubble.

The local administration denied the claims about aerial strikes by the Pakistani fighter jets on the compound, saying the explosives used in bomb making exploded, causing the death of 24 people, including 14 militants.

At least 10 civilians, includ-



ing women and children, were killed, along with 14 militants in the explosion, Station House Officer, Tirah police Station, Zafar Khan said.

The compound had been home to a large number of local militant leaders and operatives, including dozens of Afghan fighters. It was regarded as a hub for the production of improvised explosive devices (IEDs) and sniper training. The locals have announced the closure of Bara Bazaar, demanding accountability and protection. Protesters accused government authorities of failing to ensure the safety of citizens and called upon elected

representatives to play an active role in addressing the communi ty's grievances

Mohammad Iqbal Khan Afridi, Member of the National Assembly from Khyber, expressed grief in a video message, saving women and children were among those killed in the "shelling by jets." He urged residents to protest the killings, adding that "the killing of civilians has become routine.

Meanwhile, the Human Rights Commission of Pakistan (HRCP) expressed concern over civilian casualties in alleged "aerial bombings" in the Tirah Valley and called for an immediate inquiry.

Russia revives Soviet-era tactics to quash dissent: UN expert

Geneva, Sept 22: Russia is reviving Soviet-era tactics such as forced psychiatric treatment to silence dissenters and anti-war voices in an increasingly repressive environment, a UN expert said Monday.

Rights groups say President Vladimir Putin's government has lurched further into authoritarianism since the fullscale invasion of Ukraine more than three years ago, but Moscow denies that and accuses the West of a smear campaign.

A report this month by Mariana Katzarova, the UN's special rapporteur on rights in Russia, found that state-sponsored repression is escalating and becoming systematic via national security laws and other measures.

"Punitive psychiatry has returned as a tool against anti-war voices," Katzarova told reporters in Geneva.

The Russian diplomatic mission in Geneva pointed Reuters to a September 8 statement by its foreign minister saying that Moscow does not recognise her mandate and calling her work illegitimate. Moscow has previously called criticism of its rights record unfounded.

Since the invasion of Ukraine, it has passed stronger laws to punish dissenters and perceived traitors.

Torture, criminal prosecution and coercive psychiatry were among measures being used, Katzarova said, with the latter documented in an average 23 cases annually since 2022, compared to five per



year from 2015-2021. "It's the old Soviet tool of getting dissidents, in this case, anti-war activists, also journalists, she said.

the country. Katzarova said laws on foreign agents and spreading fake news were being harnessed "massively" to suppress dissent and critics, by portraying jour-

nalists, political opponents and anti-war activists as enemies of the state. Just over 20,000 people have

been arrested for expressing an anti-war position since the full scale Ukraine invasion began, according to Russian rights group OVD-Info.

GST 2.0: Odisha auto industry hopes to ride the tide



he recent GST rate reduction is set to benefit primarily small and mid-segment vehicles like hatchbacks, compact SUVs, and entry-level sedans—segments where buyers are most price-sensitive. These categories are expected to see a significant demand boost due to noticeable price drops. While the new rates apply only to vehicles invoiced after the implementation date, dealers with older stock may face margin pressure. To manage this, they often rely on OEM support or run promotions. Government clarity on input tax credits will be a key to a smooth

transition. The announcement has added positive momentum to the ongoing festive season, with increased footfalls, enquiries, and a strong rise in bookings—especially in the compact segment. Sales are projected to grow in double digits compared to last year. For consumers, the GST cut brings both lower prices and a more transparent tax structure, enhancing affordability and buyer confidence across the auto market.



ollowing the recent GST reduction, demand 1 en notably across the automobile sector, particularly in mass-market segments like hatchbacks and compact SUVs, which attract price-sensitive buvers. Premium vehicles with engine capacities above 1500cc, especially mid-size sedans and SUVs, are also experiencing renewed interest due to price corrections. The GST cut lowers the ex-showroom price, improving affordability and boosting consumer sentiment. However,

since the revised GST rates apply only prospectively, dealers holding older stock may face margin pressure. To manage this, they might partially pass on benefits to customers or bear losses to clear inventory. OEMs may need to provide limited support during this transition to protect dealer profitability. The GST cut has encouraged hesitant buyers to make purchase decisions during this key sales period. Customers across all segments benefit from the reduced GST, either through improved affordability or substantial savings in premium models. However, the actual impact depends on how effectively OEMs and dealers transmit the tax benefits. Overall, the market response is positive.



he implementation of GST 2.0. effective September 22, 2025, has significantly reduced the tax on small petrol cars (engine ≤ 1,200cc, length < 4m) from 28 per cent to 18 per cent and eliminated the additional Cess. This move has led to substantial price cuts across entry-level models, with Maruti Suzuki reducing prices by ₹46,000 to ₹1.3 lakh on models like the Spresso, Alto K10, Celerio, WagonR, and Swift. The price reduction, coupled with the festive season, has boosted consumer sentiment and driven strong growth

in vehicle sales and bookings compared to last year. However, while consumers benefit, dealers face challenges. Those holding pre-GST 2.0 inventory purchased at higher tax rates risk losses exceeding ₹2,500 crore due to the lack of a refund mechanism for the discontinued Cess. The Federation of Automobile Dealers Associations (FADA) has sought government relief on this issue. The government has mandated that all unsold inventory reflect new prices within 15 days, with penalties for non-compliance. Manufacturers are assisting by reducing wholesale billing to manage transition risks. Overall, GST 2.0 is expected to drive demand in the automotive sector, benefiting consumers and manufacturers though short-term financial stress persists for dealers without compensation for tax paid on older stock.



he Government's revised GST rates are a positive move for the automobile sector, especially during a period of slow sales growth. While overall car registrations in August saw minimal increases (1 per cent nationally, 6 per cent in Odisha), festive demand is promising, with many customers delaying purchases until the new GST rates take effect. Small cars are expected to benefit the most from the rate cuts, while luxury cars, despite a GST hike from 28 per cent to 40 per cent, will still see a net price benefit

of up to 8% due to the removal of the 20% cess. However, dealers are facing losses on existing inventory taxed under the old cess regime, and the government has denied compensation, despite FADA's efforts. Overall, market sentiment is optimistic, and the industry is expected to grow by 15 to 20 per cent under the new GST structure (GST 2.0).




he small car industry is set for notable growth following recent price cuts and GST revisions. Starting prices for small cars have been reduced to ₹3.5 lakhs, making them more affordable. The new GST structure, effective from Sept 22, applies an 18 per cent tax on vehicles with engine capacity up to 1200cc and length not exceeding 4 meters. Cars exceeding either criterion will attract a higher 40 per cent GST. This clear price differentiation is expected to influence consumer

choices, encouraging buyers to select vehicles better suited to their actual needs rather than opting for larger engines due to minimal price differences before. The policy benefits consumers directly and is likely to boost demand for compact vehicles. OEMs have responded by slashing prices across their product lines and continuing attractive offers, further stimulating market interest. Positive buyer sentiment is evident through strong booking numbers and increased showroom visits. However, dealers with high input tax credits from previous cess rates may face short-term financial pressure. Despite this, the overall market outlook remains optimistic. The alignment of policy changes with market response is expected to lead to a surge in sales for small cars, reflecting a favorable shift in consumer behavior and industry dynamics.

In a landmark move towards simplifying the tax structure and easing the financial burden on citizens, the Government of India announced the new generation tax reforms. Under this, the government has reduced the Goods and Service Tax (GST) rates on two and four wheelers from 28 per cent to 18 per cent. This move is expected to make automobiles more affordable for middle-class families, thereby boosting the auto sector. In conversation with OrissaPOST, eminent automobile dealers across Odisha have shared their views on the recent GST update



recent 10 per cent GST reduction on small cars—those under 4,000 mm in length with engines up to 1,200 cc—has led to significant price cuts across popular Maruti Suzuki models like the Alto K10, S-Presso, Celerio, WagonR, Swift, Brezza, and Dzire. In addition to the tax cut, Maruti Suzuki has further lowered prices on select models, resulting in total reductions ranging from 8.6 per cent to 24 per cent across variants. This double impact has made entry-level and compact cars far more affordable, with prices now comparable to 2019 levels but with more features, such as six airbags and enhanced comfort options. However, dealers are facing losses on older inventory purchased before the GST change due to lack of clarity on cess





(100-125cc) and small cars, where affordability is key. Premium bikes and SUVs will also benefit, though their demand is less price-sensitive. The GST cut is effective immediately, and older stock purchased at higher rates is expected to be sold gradually without major concern. A major issue is the lapse of cess, which could lead to significant dealer losses unless manufacturers or the government offer support. Dealers may need to absorb some of the cost to stay competitive. Despite this, the festive season outlook is strong. Bookings are up 15-20 per cent for two-wheelers and 10 per cent for cars, as the tax cut has encouraged buyers to finalize delayed purchases. With on-road prices and EMIs coming down, overall affordability has improved. All



manufacturers are passing on the GST benefit to customers, making this one of the most significant price advantages seen so far.



New Delhi, Sept 22: Grandmaster Divya Deshmukh, the reigning FIDE Women's World Cup champion, has been awarded a wild card for the upcoming FIDE World Cup 2025, scheduled to take place in Goa from October 31 to November 27

The 19-year-old Nagpur-born GM was added to the field following the last-minute withdrawal of a participant, with former women's world champions Ju Wenjun and Hou Yifan having earlier declined their invitations. The move ensures India's brightest young talent a place in one of the most prestigious events on the global chess calendar.

Divya, who has made rapid strides in the past two years, most recently tested herself in the open section of the FIDE Grand Swiss 2025, where she secured two victories and six draws across 11 rounds. Though her final score was modest, the event highlighted her fighting spirit against elite opposition.

Her wild card entry adds further intrigue to the Indian challenge at the 11th edition of the World Cup, where a record 21 players from the country will compete. The contingent will be spearheaded by reign ing world champion D Gukesh,



Colombo, Sept 22: India maintained their stranglehold over arch-foes Pakistan across sports as the country's football team notched a 3-2 victory in a highly-charged SAFF U17 Championship match here Monday in which losing team member Muhammad Abdullah's controversial celebration attracted attention.

Abdullah's controversial celebrations came only a day after Pakistan cricketers Haris Rauf and Sahibzada Farham made provocative gestures during their Asia Cup Super 4s match against India in Dubai on Sunday.

India won the Asia Cup game by six wickets, before their younger footballing counterparts got the better of Pakistan at the Racecourse InLanka capital.
