Modi enters 25th yr as head of a govt

New Delhi, Oct 7: Prime Minister Narendra Modi Tuesday began his 25th year as the head of a government, asserting that improving the lives of people and contributing to the progress of this great nation have been his constant endeavour.

He noted in a series of posts on X that he had taken oath on this day in 2001 as Gujarat's chief minister for the first time and emphasised on the changes first his home state and then the country witnessed on his watch.

"Thanks to the continuous blessings of my fellow Indians, I am entering my 25th year of serving as the head of a Government. My gratitude to the people of India," Modi said.

He added, "Through all these vears, it has been my constant endeavour to improve the lives of our people and contribute to the progress of this great nation that has nurtured us all."

Modi said India, which was marred by "the worst form of corruption, cronyism and policy paralysis" during the UPA government, is now home to one of the largest healthcare and social security schemes in the world.

Curfew lifted

Cuttack, Oct 7: Normalcy returned to the city, which was affected by violence during immersion of Durga idols last week, as the Odisha government withdrew curfew and restored internet services Tuesday, a senior official said.

There was no report of any untoward incident in the last three days. While the prohibitory order was imposed for 36 hours from 10 PM of October 5 till 10 AM on October 7, internet services had been suspended for 48 hours in two phases from 7 PM of Sunday.

The measures had been taken in the wake of the violence and arson in Cuttack that originated during Goddess Durga idol immersion procession in the intervening night of Friday and Saturday. The city witnessed another spell of violence on Sunday evening forcing the administration to impose restrictions like curfew and internet suspension, said Commissioner of Police, S Dev Datta Singh.

There was also no report of violence in any part of the city, even during the 12-hour bandh call given by Vishwa Hindu Par-

ishad (VHP) Monday, he said. Nine people have so far been arrested in connection with th violence on Sunday evening.

"The prohibitory order was imposed in 13 of the 20 police station areas of Cuttack city on Sunday after protestors attacked the security personnel leaving 25 people including 8 policemen injured," the police


commissioner said. He said a total of 31 people including 10 police personnel were injured in the clashes Saturday and Sunday and many shops were gutted or damaged

The Commissioner of Police said that internet service was suspended to prevent "anti-social elements" from misusing the facility to spread rumors and disturb communal harmony.

Though curfew is not further extended and internet service restored, the government has decided to maintain tight security in the city for a few more days.

He said that 50 platoons (1,500 personnel) of police, along with eight companies of central armed force, including Rapid Action Force (RAF) personnel are deployed to maintain law and order situation. Singh said the officials are also keeping a close watch on social media which is found to be misused to spread rumour and hate among the communities.

3 get Nobel for works on quantum physics

Stockholm, Oct 7: US-based scientists John Clarke, Michel Devoret and John Martinis won the 2025 Nobel Prize in Physics for "experiments that revealed quantum physics in action", paving the way for the development of the next generation of digital technologies.

"My feelings are that I'm completely stunned. Of course it had never occurred to me in any way that this might be the basis of a Nobel Prize," Clarke told the Nobel press conference by telephone Tuesday.

Quantum mechanical behaviours are well studied at the level of the incredibly small atoms and sub-atomic particles - but are often seen as bizarre and unintuitive compared with classical physics and its far larger scale.

The Nobel winners carried out experiments in the mid-1980s with an electronic circuit

built of superconductors and demonstrated that quantum mechanics could also influence everyday objects under certain conditions.

"It is wonderful to be able to celebrate the way that century-old quantum mechanics continually offers new surprises. It is also enormously useful, as quantum mechanics is the foundation of all digital technology," Olle Eriksson, chair of the Nobel Committee for Physics, said.

Quantum technology is already ubiquitous, with transistors in computer microchips an

everyday example. "This year's Nobel Prize in Physics has provided opportunities for developing the next generation of quantum technology, including quantum cryptography, quantum computers, and quantum sensors," the Royal Swedish Academy of Sciences, which awards the prize, said in a statement.

New Delhi, Oct 7: The Supreme Court Tuesday asked the Election Commission to provide it with the details of 3.66 lakh excluded voters from the final electoral roll prepared after Bihar's Special Intensive Revision (SIR) exercise.

The Election Commission informed the apex court that most of the names added are of new voters and that no complaint or appeal has been filed till now by any excluded voter.

A bench of Justices Surya Kant and Joymalya Bagchi said the poll panel will submit whatever information it gets

on excluded voters by Thursday (October 9), when it will conduct further hearing on the pleas challenging the SIR exercise.

The top court said everyone has the draft electoral roll and the final list has also been published on September 30, so the required data can be furnished through a comparative analysis.

Justice Bagchi told senior advocate Rakesh Dwivedi, appearing for the poll panel, that court orders have resulted in more transparency and access to the electoral process

"You'd agree with us that the degree of transparency and access has improved in the electoral process. It appears from the data that there was a 65 lakh deletion in the draft list which

you published, and we said whoever is dead or moved is alright, but if you are deleting someone, please follow Rule 21 and the SOP.

'We also said that whoever is deleted, please put up their data in your electoral offices. Now the final list appears to be an appreciation of numbers and there is confusion in the general democratic process what is the identity of the add-ons, are they of deleted names or new names," Justice Bagchi said.

"No complaint or appeal filed till now by any excluded voters," Dwivedi said.

In September 30, the EC, while publishing the final electoral list of the poll-bound Bihar, said that the total number of electors has come down by nearly 47 lakh to 7.42 crore in the final electoral roll from 7.89 crore before the SIR of the voter list carried out by the Election Commission

The final figure has, howev-

er, increased by 17.87 lakh from 7.24 crore electors named in the draft list issued on August 1, which had removed 65 lakh voters from the original list on various accounts, including deaths, migration and duplication of voters.

At the outset, advocate Prashant Bhushan, appearing for Rashtriya Janta Dal, and senior advocate Abhishek M Singhvi, appearing for opposition leaders challenging the poll panel decision to conduct the SIR, alleged that excluded voters were not given any notice or reasons for their deletion.

"Nobody knows whether the addition of names was from the 65 lakh excluded voters from the draft roll or whether new voters were added which reduced the number of excluded voters in the final list," Singhvi said.

Bhushan alleged that the poll panel has not been following the required rules and, instead of cleaning the electoral roll, the SIR has compounded the problem.

In a post on X, Patnaik said, 'At a time when the state should be celebrating the festive season with joy, an atmosphere of fear prevails. People are beginning to feel insecure.

Referring to the murder of senior advocate and BJP leader Pitabas Panda in Ganjam, Patnaik said, "The brutal killing of a senior lawyer in front of his house is extremely shocking and tragic." He also extended his condolences to the bereaved family.

The BJD supremo also expressed concern over other recent developments, including a rape case in Rourkela, the horrifying incident aboard a bus in Kanas, the night restrictions in Balasore, and the recent violent clashes in Cuttack, calling them 'deeply worrying'.

Poor road conditions trouble Johal residents

KIMS docs save 2.7-year-old girl with rare TACE procedure

Bhubaneswar, Oct 7: In a first for Odisha, doctors at Kalinga Institute of Medical Sciences (KIMS) successfully performen a complex Transarterial Chemoembolisation (TACE) procedure on a 2.7-year-old girl with hepatoblastoma, a rare liver tumor that had spread to her lungs.

According to KIMS sources, the procedure required the coordinated efforts of 15 doctors across seven departments, marking it as one of the most challenging multidisciplinary interventions ever at the hospital. The young patient, now fully recovered, can be seen playing joyfully with her friends in the hospital corridors—a testament to her courage, resilience, and the dedication of the medical team

The girl was brought to KIMS after months of worsening abdominal pain, swelling, and loss of appetite, despite multiple consultations across the state. Detailed investigations revealed hepatoblastoma with lung metastasis. Under the care of Paediatric Hemato-Oncologist Palash Das, she was immediately started on chemotherapy. While her condition improved, the liver tumor remained too large for surgical removal.

At this critical stage, Interventional Radiologist Swati Das

recommended TACE, a procedure in which chemotherapy

recommended TACE, a procedure in which chemotherapy is delivered directly into the blood vessel supplying the tumor. The treatment proved highly effective, causing the tumor to shrink sufficiently to allow for surgical removal.

Subsequently, an extended liver resection (non-anatomical) was performed by Vedavyas Mohapatra (Surgical Gastroenterology) and Varsha M Totadri (Paediatric Surgery), under the guidance of PK Jena, (HOD of Paediatric Surgery), with crucial support from the anesthesia team. Post-operative care was managed by the Pediatric ICU team and Paediatric Gastroenterologist Jiten Sahoo.

This milestone procedure marked the first time such a complex intervention was performed on a child so young in Odisha and positioned KIMS among a select group of hospitals in India capable of providing this rare treatment. KIIT and KISS founder Achyuta Samanta congratulated the medical team for their path-breaking work and wished the young patient a long and healthy life.

Similarly, another resident, Kailash Chandra Lenka, said the road construction work began in 2023 and was expected to be completed soon. However, the work came to a halt after the elections, leaving residents to suffer due to the worsening road condition. "We urge the BMC to address the issue at the

earliest," he added.

Meanwhile, Ward No. 4 Corporator Sukumar Sahoo said,
"Initially, I had received the tender for the road construction, but the work was halted due to certain issues. Later, the locals and the BMC took up the matter on their own."

When contacted, BMC Commissioner Chanchal Rana said, "The road has been included in the action plan under a relevant scheme this year."

Telegraph to AI: Real hidden environmental cost

rom the telegraph to artificial intelligence, communication technologies have always carried hidden environmental and human costs. When people send a message in a group chat or interact with an AI chatbot, they rarely think about the massive infrastructure and resources behind these systems.

While metaphors like "the cloud" or "AI" suggest something intangible, these technologies are deeply material, powered by data centres, undersea cables, and complex networks that consume enormous amounts of energy and water.

Historically, the pattern is not new. The first global communication system, the telegraph, enabled near real-time contact between continents, but it came at a steep human and environmental cost. Submarine telegraph cables were insulated with gutta-percha, a rubber-like latex harvested from tropical trees by colonial labourers. Entire forests were felled to grow plantations, and Indigenous communities were exploited to meet the global demand.

In Australia, the construction of the Overland Telegraph Line connecting Adelaide to Darwin required vast amounts



of water to power batteries and sustain human operators and animals at repeater stations. This led to environmental degradation, forced displacement of First Nations peoples, and even loss of life — effects that remain part of the region's legacy today.

The telegraph was widely celebrated as a symbol of progress and technological innovation, yet its construction was embedded in a colonial extractive logic.

European powers colonised territories not only to gain land but to extract resources for technological and industrial use. The narrative of technological progress often masked these social and environmental costs.

Modern communication sys-

tems and AI reflect striking parallels. Today, nearly 99 per cent of global internet traffic travels through undersea fibre-optic cables, retracing many routes of now-obsolete telegraph lines. AI systems rely on massive data centres that produce heat, consume electricity, and require large volumes of water for cooling.

By 2027, AI operations may require between 4.2 and 6.6 billion cubic metres of water annually — equivalent to Denmark's yearly consumption. Manufacturing specialised AI processors also drives deforestation, mining, and toxic waste production.


Just as historical accounts framed the telegraph as miraculous while ignoring its material and human costs, AI is often celebrated as revolutionary without acknowledging the resources, energy, and labour that underpin it. As AI scholar Kate Crawford notes, artificial intelligence is "embodied and material, made from natural resources, fuel, human labour, infrastructures, logistics, histories, and classifications." The same was true of the telegraph.

The lesson from history is clear. Telegraph companies and imperial networks accepted human and environmental exploitation as the cost of technological progress. Today's tech giants are following a similar trajectory, racing to release ever more powerful AI models while obscuring their environmental impact. Governments and regulators must act decisively: enforcing ethical standards, mandating transparent disclosure of energy and environmental usage, and supporting low-impact innovation.

From the "Victorian internet" to modern AI, communication systems have always traded environmental and human well-being for technological advancement. Recognising and addressing these hidden costs is essential to building a more sustainable, responsible technological future.

Housemaid raped in Rourkela; 1 held

Rourkela, Oct 7: A woman was allegedly raped near the railway tracks under Raghunathpali police station Monday evening. Police have arrested one person and detained other two in connection with the incident.

The rape of the housemaid in Raghunathpali area is yet another disturbing reminder of how safety of women is at stake in the Steel City.

The arrested has been identified as Kahnucharan Jena, 32, of Koelbank area. He was produced in court Tuesday evening after he underwent a medical examination. The two other suspects are being interrogated, police said.

According to reports, the ncident occurred around 9pm Monday when the woman, a housemaid from Panposh area, was returning home after work. Police said Jena. who was known to the woman, lured her near the railway track near Khariabahal slum, where he allegedly raped her. Two other men reportedly attempted to assault her as well, but the woman managed to escape and



went straight to Raghunathpali police station, where she lodged a complaint around 2:45am Tuesday.

Acting swiftly on the complaint filed by the rape survivor, Rourkela Police have arrested one person and detained two others in this connection, according to reports. Based on her statement, police registered a case (564/25) and launched an investigation.

"The survivor's medical examination was conducted and statement has been recorded before the court Tuesday morning," said Rashmiranjan Mahapatra, SDPO, Panposh, who confirmed the arrest. "Two others have been detained for questioning. Appropriate action will be taken against the other two if their involvement is established." The investigation is in progress.

Cancer hospital in Bargarh to operate in PPP mode

Bargarh, Oct 7: The long-shuttered cancer hospital in Bargarh is set to resume operations in public private partnership (PPP) mode, local MLA Ashwini Kumar Sarangi announced

Speaking at a health camp for anaemia and cancer screening organised by the Agragami Yubak Sangha, Sarangi said the state government has decided to operate the Bargarh Cancer Hospital in collaboration with a private institution under the PPP mode.

A team from a Hyderabad-based organisation visited the facility Sunday, held a 45-minute discussion with the MLA, and later inspected the hospital premises. "If an agreement is reached between the state government and the

organisation as per the pre-

scribed guidelines, the hospital is expected to become fully operational within four to six months," Sarangi said.

Sarangi stated that he, along with representatives from the Forum for Cancer Hospital at Bargarh and Fighters Group, had recently met Chief Minister Mohan Charan Majhi and the health minister to press for the hospital's activation. Following their meeting, a high-level discussion was held with departmental officials, during which the CM reportedly expressed

strong interest in making the hospital functional.

According to Sarangi, 120 beds and sufficient medicines have already been supplied to Bargarh Cancer Hospital. He further stated that the forum had requested a direct supply of essential drugs to the Bargarh facility instead of routing them through Acharya Harihar Cancer Institute in Cuttack. The health minister has since approved this request.

Speaking at the camp, Sarangi also urged people to remain health-conscious to avoid preventable diseases.

Bargarh district has seen a worrying rise in the number of cancer patients and deaths, leading to growing concern among residents. The district has increasingly been described as a "cancer hub" in public discussions.

Denied phone, girl dies by suicide

41-yr-old Anganwadi helper retires due to clerical error

Nandapur, Oct 7: A 41-year-old Anganwadi helper in Nandapur block was mistakenly declared 60 years old and forced into retirement reportedly due to a clerical error in official records. The Koraput district administration has now ordered a correction of the mistake with immediate effect.

Ratnamani Burudi, an Anganwadi helper at Arlabput Anganwadi Centre under Kulabir panchayat in Nandapur block, discovered the error when she received notice of her retirement. Although her age is recorded as 41 in her school certificate, Aadhaar card, and voter ID, official records at Nandapur Child Development Office listed her as being 60 years old.

During the public hearing held in Nandapur Monday, Burudi submitted a written complaint along with supporting documents to acting Koraput Collector (ADM) Tapan Kumar Nayak. She explained that she was appointed as an Anganwadi helper in 2010 at the age of 26, but her date of birth was incorrectly entered as 1964 instead of

1984 by an office employee. The error went unnoticed for years.

"When the office informed me that I had reached the retirement age of 60, I was shocked. I still have 19 years of service left," Burudi said, requesting

Upon reviewing the complaint, Nayak questioned Child Development Project Officer (CDPO) Minati Bala Pattnaik and directed her to resolve the issue promptly. Pattnaik confirmed that the error, made 16 years ago, would be rectified as per the new departmental rules.

According to the revised procedure, a committee headed by the sub-collector and comprising the District Child Protection Officer (DCPO). Social Welfare Officer, and the concerned CDPO as convener will handle such cases. The committee will review Burudi's service book and correct the discrepancy at the earliest.

Spice farms add new flavour to Koraput tourism

Nandapur, Oct 7: Koraput district, long known as a tourism hub for its natural beauty. is now drawing visitors to its farmlands, where spice cultivation is taking root alongside coffee and linseed. Tourists are showing growing interest in ginger, turmeric, black pepper, cinnamon, cardamom, bay leaf, mustard and chillie, often buying produce directly and learning about farming methods, yields and income.

Many visitors, however, have voiced concern over the lack of incentives and market access for farmers. They urged that cultivators receive technical knowledge and proper support so that agriculture and tourism can be linked to benefit the district's economy.

Agriculture scientists, including Parshuram Sial, Upendra Kumar Saha, Mihir Kumar Jena and Sauray Gupta, said Koraput has the potential to become a research and training hub



for organic spice cultivation Farmers, they added, could gain from better markets and targeted incentives. According to Sudam Biswal, deputy director of Horticulture, farmers in 14 blocks are cultivating spices on thousands of hectares: 1.550 hectares under black pepper,

61 hectares under cardamom. 4,223 hectares under ginger, 3,373 hectares under turmeric, 35.5 hectares under cinnamon, two hectares under bay leaf and 4,533 hectares under chillie.

Annual production figures include 115.5 tonne black pepper, 0.4 tonne cardamom, 58,119

tonne ginger, 9,020 tonne turmeric, 2.15 tonne cinnamon, two tonne bay leaf and 3.503 tonne chillies. This year, Nandapur block alone reported 120 hectares of black pepper cultivation, three hectares of cardamom, 875 hectares of ginger, 866 hectares of turmeric, one hectare of cinnamon, 597 hectares of chillie and 87 hectares of mustard. Other blocks including Lamtaput, Semiliguda, Potangi, Laxmipur, Narayanpatna, Koraput, Bandhugaon, Baipariguda, Borigumma, Jeypore, Kotpad, Kundura and Dasmantpur also recorded

substantial spice cultivation. Farmers said they are pursuing spice cultivation with limited technical knowledge and minimal incentives. Tourists visiting nearby destinations

incentives and markets, and of-

ten purchasing produce. Researchers and cultivators argue that adding spice farms to the tourism map, alongside Koraput's established coffee and millet farms, would encourage farmers, promote the crops and strengthen the district's economy. The farms could also

provide a living laboratory for researchers.

District tourism officer Ta lina Pradhan said she would consult with Koraput Collector, the Agriculture and Horticulture departments and the Odisha Tourism Development Corporation to showcase spice farming. She added that efforts would be made to include farms and cultivation zones on the state tourism map.

Military Rhetoric

t is prudent for officials in high positions to speak with care and caution, for their words carry the weight of their position and responsibilities and can make or break any situation. Any loose talk on their part can have far-reaching consequences. This is especially true for high-ranking diplomatic and military officials as their statements are taken into account by leaders in other countries as official statements from the government, no matter if they are

During a visit to troops stationed in Rajasthan on 4 October, Indian Army Chief General Upendra Dwivedi issued a stark warning to Pakistan, declaring that India would no longer exercise restraint if Islamabad continued to support terrorism. "India is fully prepared this time... We will go a step further, and Pakistan will have to consider whether it wants to remain on the world map."

Separately, Air Chief Marshal AP Singh stated that Indian airstrikes during Operation Sindoor destroyed or damaged at least a dozen Pakistani aircraft, including US-supplied F-16 jets. He dismissed Pakistani claims of Indian losses as "fanciful stories.

On the same day, Defence Minister Rajnath Singh, speaking at an event in Hyderabad, reinforced India's readiness to act decisively across borders if national security is threatened. Singh also warned Pakistan against any misadventure in the Sir Creek sector, a disputed 96-km tidal estuary between Gujarat's Rann of Kutch and southern Pakistan. He stated that any such move would invite a "decisive response" strong enough to change both "history and geography."

In response, Pakistan's Defence Minister Khawaja Asif described these remarks as "delusional, provocative, and jingoistic," and issued his own threats. Asif warned that India would be "buried under the wreckage of its warplanes" if it provoked Pakistan further. "These statements from Indian political and military leadership are a failed attempt to restore their tarnished reputation," Asif said. 'After a decisive defeat, with a score of 0-6, if they try again, the outcome will be even worse." Though Asif did not clarify the "0-6" reference, it appears to refer to unverified Pakistani claims of having downed six Indian fighter jets during Operation Sindoor—claims for which Islamabad has offered no evidence.

It is important to note that such rhetoric by senior military officials risks blurring the lines between military professionalism and political positioning. It is inappropriate and dangerous for serving military leaders to make such aggressive public pronouncements which can push the country to yet another military escalation. Ever since the ceasefire between India and Pakistan was reached after four days of military confrontation, high-ranking Indian military officials have often made such public statements. When General Dwivedi says that "India is fully prepared this time" it also sends across a message that the nation's military was unprepared for the confrontation in Mav

This kind of heated exchange between the two nations' military and political leaders will only worsen animosity between the two nuclear-armed neighbours. India-Pakistan relations have sharply deteriorated following the Pahalgam terror attack of 22 April when 26 innocent tourists were massacred by Pakistan-sponsored terrorists. In response, New Delhi took several diplomatic steps, including suspending the Indus Waters Treaty that had till then survived three wars. India has also made it clear that any future dialogue with Pakistan will centre solely on the return of Pakistan-occupied Kashmir (PoK) to India. It may be noted that India seemed to have lost the narrative war in convincing world leaders of Pakistan's complicit role in the terror attacks. Meanwhile, Pakistan has received funds in billions of dollars from the International Monetary Fund and signed a military deal with Saudi Arabia called the Strategic Mutual Defence Agreement whereby it will now get all backing from the Saudi nation in the eventuality of a war. With further plans to form a military alliance among various Moslem nations, Pakistan seems focused on strengthening diplomatic relations and forming strategic military partnerships.

India needs to focus on its foreign relations and building diplomatic friendships at the global stage. India's relations with the US have soured in recent times, especially after Operation Sindoor, and India repeatedly refuting US President Donald Trump's claims of being the peacemaker and averting a war between the two nuclear

India and Pakistan have fought three major wars and numerous skirmishes since 1947. Any further escalation in rhetoric, particularly from top officials, risks destabilizing the fragile ceasefire and regional peace, something both nations can ill afford at this stage.

ernment services shutting down for lack of funding, the blame game in Washington is intensifying, and journalists are playing their own game of trying to predict the political winner. But given that Democrats are confronting dilemmas that all opposition parties face when battling aspiring or practicing autocrats, a more fruitful exercise is to consider the lessons of two decades of what political scientists are calling a global "democratic recession." This recent history makes clear that some strategies for dealing with would-be autocrats work much better than others.

One of the Democrats' biggest problems is that they are very unpopular, even with their own base. Their supporters feel, justifiably, that party leaders are constantly sending mixed messages. They call President Donald Trump and his henchmen fascists one day, and the next they behave as if they were operating in a chummier, bipartisan time when Congress could cobble together solutions to practical problems. Most people take their cues from elites whom they trust, whether party leaders, trade unionists, or opinion journalists. If those elites do not communicate clearly. well-meaning citizens will struggle to mobilize even in the face of an obvious threat.

During politically normal times, opposition parties are supposed to develop policy alternatives and use parliamentary procedures to hold governments accountable. A classic example is the rhetorical dueling that takes place during Prime Minister's Questions in the UK. But these are not normal times in the US. Trump, like all aspiring autocrats, is changing institutions to make it less likely that he will lose power in the future, as well as intimidating civil society, harassing political adversaries, and inciting hatred against certain segments of society.

Such conduct does not mere-

ly "erode norms." We are confronting what scholars have called "autocratic legalism": the use of duly enacted laws to undermine constitutional systems and, in particular, to concentrate power. In fact, the situation may even be worse than that. In his second term, Trump no longer bothers maintaining a façade of legality, and simply engages in illegal conduct openly. Even when courts rule against his administration, it usually has already created facts on the ground, signaling its intention to disregard constraints.

In theory, how opposition parties should respond to autocratic legalism or outright lawlessness is straightforward: play "tit-for-tat." Transgressions from one side must be answered with a matching transgression. As game theory teaches, that is the only way to get back to normal with repeated play. Ideally, the opposition party, in the process, will also explain to the public that it is pursuing such a strategy because a core democratic principle, not just a policy disagreement, is at stake

But the problem, in practice, is that a governing party bent on autocracy can escalate. Not only has it already proven willing to break the rules, but it also has more power with which to do so. One could see this clearly with Democratic Senate Minority Leader Chuck Schumer's attempt to slow the confirmations of Trump's nominees. In response, Republican Majority Leader John Thune simply went for "the nuclear option," changing the rules so that whole batches of nominees could be waved through with a simple majority.

Another problem is that politicians beholden to an aspiring autocrat are unlikely to negotiate in good faith, or even to tell the truth to the public. Republicans, for example, are simply lying about the Democrats wanting to give health care to undocumented immigrants. And since aspiring autocrats systematically work to capture media organizations, the space for making the opposition's case steadily shrinks. Trumpaligned businessmen already control Fox News and now CBS (long seen as the closest a US outlet would come to the BBC).

Still, as Saul Alinsky, the father of community organizing, once put it: "You do what you can with what you have." A government shutdown concentrates the mind and provides a focal point for sending the right message about an autocratizing government. As important as the Democrats' arguments about health care are, the stronger justification for accepting a shutdown is that Trump will not respect any compromise they might negotiate. After all, he has already forced congressional Republicans to rescind spending to which they had previously approved.

Democrats therefore can make this an argument

has a Republican-controlled government shut down, but Republican-controlled Congress is simply handing power to Trump and letting him get away with the plainly illegal impoundment of funds approved by the legislature. This is not about this or that policy; it is about a chief executive governing according to his whims, with impunity and obvious disregard for the US Constitution. The argument is not difficult to make, nor would it be difficult for the public to understand.

In the same vein, as the political scientist Norman Ornstein has proposed, Democrats could create focal points if they started holding floor debates about impeaching Trump cabinet secretaries who have behaved in a particularly egregious manner. While such efforts have zero chance of succeeding, the point is that the Speaker of the House cannot prevent them, and Democrats can use the proceedings both to create a record of misdeeds and to educate receptive parts of the public about the harm these figures are causing.

In the end, aspiring autocrats also face a challenge. They must portray the opposition either as posing a mortal danger to the country (polarization helps here) or as irrelevant, even pitiful (hence Trump's recent dismissal of Democrats: "Don't even bother dealing with them"). By going back and forth between these extremes, Republicans, too, are sending mixed messages.

A well-crafted strategy around the shutdown and impeachments would show that the Democrats can take the initiative and defend their actions in the name of democratic principles. This is the moment for them to demonstrate that they can master the art of opposition.

If you happen to suffer a Sentara Health, a regional heart attack while driv-L ing your car, don't crash into just any building. Make sure you crash into a cardiologist's office. That could be the difference between returning to your loved ones and never seeing them again.

Trust me, you are far more likely to survive your heart attack if you do what Jeff Geraci, a 64-vear-old financial planner in Virginia Beach, US, recentlv did.

The health emergency happened after a routine trip to a fitness club, where Geraci had lifted weights and used a rowing machine and treadmill. When he got to his car. he didn't feel good and sat for a little while before deciding to drive home. During the drive, he suffered a heart attack and veered off the road, crossing multiple lanes. Fortunately, he didn't hit any other cars, but instead crashed into a sign near the office of Dr. Deepak Talreja, the chief of cardiology for

healthcare network. Talreja heard the crash and ran out to help Geraci, while calling 911, the emergency line.

Imagine Geraci's good luck. Of all the places to crash, he crashed near the chief of cardiology. With my luck, if I suffered a heart attack, I'd crash near a funeral home. The funeral director would run out to offer his services.

Dr Talreja couldn't assess Geraci's condition immediately because the airbags had deployed. When he finally did, he realized that the heart attack was severe. How severe? Geraci was virtually dead.

"You weren't breathing, and you didn't have a pulse SCD, sudden cardiac death," Dr Talreja said, speaking to Geraci during a news feature on a local TV station, WTVR. "And what that means is the heart just isn't doing the job, and so it's a form of death. But fortunately, we got things restarted very quickly, and so God was watching out...'

Was it God or was it luck? of a heart attack... one sister Geraci certainly believes that God ensured that his heart-attack crash wasn't fatal. "It's such a testimony of God's greatness, of all the things that had to happen to keep me alive," he told WTVR. "It's a miracle. God was there, and thank God Dr. Talreja was

Dr Talreja isn't always

at his medical practice, of course. Sometimes he's at two local hospitals, and other times, he's at home. It would have taken a longer drive to crash into his home. By then, it might have been too late, as Dr Talreia noted: "So if he'd gone eight minutes or so without CPR and without blood flow, then we can probably resuscitate the heart for another 10 minutes or so, but the brain doesn't recover, and so [he] wouldn't be with us today.

Geraci has a family history of heart attacks. That's why he made it a point to exercise regularly. "My mother died has heart issues," he said. "I've been an athlete since I was 14 years old. I work out all the time. I ran marathons, [I thought] it's not going to happen to me.

He couldn't prevent the heart attack, but he did somehow manage to prevent death, whether by divine intervention or otherwise. "I got an opportunity to come back, so there's got to be a reason," he said. "And every morning, I pray and think about, if I'm here, I need to be doing more than I was doing... Try to be a better person every day. Try to make everybody smile every day.'

Getting everybody to smile is a nice goal, but what he really needs to do is persuade Dr Talreja to put a large sign outside his office: "Having a heart attack? Please crash here.'

Geraci should also produce a map showing the homes and offices of all the cardiologists in the area. After all, why leave things to chance?

Call for caution

Sir, The death of 14 children in Madhya Pradesh and Rajasthan due to the consumption of Coldrif cough syrup has caused widespread concern across the country. To prevent such tragedies in the future, every family should develop the habit of using medicines strictly under medical advice. Vigilance protects lives — negligence can cost them.

WINTER IS COMING, SO IS SMOG

Air inside Delhi homes as harmful as outdoors: Study

Long term exposure to high fungal and bacterial concentrations make indoor air in several parts of Delhi almost as harmful as the smog outside

New Delhi, Oct 7: As Delhi braces for winters and likely another spell of the late fall smog, a study has found that the air inside city homes are filled with fungal spores 12 times higher than the WHO safety limit, causing skin allergies, respiratory issues as well as anxiety among residents.

The study by Delhi University's Satyawati College, Jamia Millia Islamia and US's South Dakota State University, has also revealed that the bacterial levels were recorded to be 10 fold higher than the World Health Organization (WHO) safety limits.

Long term exposure to high fungal and bacterial concentrations make indoor air in several parts of Delhi almost as harmful as the smog outside, noted the study published in Frontiers in Public Health.

The study also noted that most fungal particles were smaller than 2.5 microns, small enough to penetrate deep into the lungs and cause lasting respiratory damage.

It observed a clear seasonal pattern. Fungal levels rose steadily from winter and reached their highest concentration at around 6.050 CFU per cubic metre in fall between September and November -- the period just before Delhi's smog

Bacterial levels increased

from winter to summer, peaking in August, before declining in fall, it said.

About 33 per cent of residents reported frequent headaches, 23 per cent complained of burning or irritated eyes, 22 per cent experienced persistent coughing and breathlessness, and 18 per cent suffered from sneezing and allergic rhinitis, also known as hay fever. Around 15 per cent reported skin irritation and itching, the researchers noted.

"Children and young adults emerged as the most vulnerable groups. The study found that about 28 per cent of children under 12 years and 25 per cent of young adults aged 18 to 30 reported breathing difficulties. coughing, or allergy-related symptoms," they added.

The authors noted that developing lungs, higher activity levels, and longer indoor exposure made children particularly susceptible. Women also reported higher rates of eye and skin irritation, accounting for nearly 60 per cent of all dermatological and eye complaints, likely because they spent longer periods indoors, they added

The study, titled "Microbial Indoor Air Quality Assessment and Health Correlations in Densely Populated Urban Areas of Delhi, India", found that fungal and bacterial concentrations inside homes in densely populated parts of the national capital were several times higher than safe standards set by the WHO, based on a year-



long survey of households in North Delhi.

Researchers collected air samples from 336 houses across the slum clusters of Ashok Vihar and Azadpur, representing low-income, overcrowded neighbourhoods with poor ventilation and visible dampness.

The survey covered all four seasons to track how microbial levels changed throughout the

The findings revealed that fungal concentrations ranged between 1,330 and 6,050 colony-forming units (CFU) per cubic metre, while WHO recommends a limit of 500 CFU per cubic metre, meaning that homes recorded up to twelve times higher fungal levels than what is considered safe.

Bacterial concentrations varied from 730 to 5,300 CFU per temperature, which create ideal conditions for fungal growth and persistence indoors.

The most common airborne microbes identified were Aspergillus, Penicillium, Cladosporium, Staphylococcus, Streptococcus, and Micrococcus. Among them, Aspergillus and Cladosporium were dominant fungi known to trigger asthma, allergies, and chronic lung infections, they said.

While microbial counts were highest during the late monsoon and fall, health complaints among residents were most frequent in winter and fall, suggesting that prolonged indoor exposure in poorly ventilated conditions worsened health outcomes. A health questionnaire was

administered to 509 residents of the sampled homes, using a structured survey approved by the Indian Council of Medical Research (ICMR). The results

The researchers attributed Delhi's poor indoor air to a combination of overcrowding, inadequate ventilation, high humidity, and infiltration of outdoor smog. Many households showed visible mold growth and damp walls, while sunlight exposure was minimal.

Meteorological and outdoor pollution factors also played a crucial role.

The study noted that as humidity levels rose above 60 to 70 per cent, fungal and bacterial counts increased sharply.

The researchers warned that the health risks associated with indoor fungi extend beyond allergies and asthma. Species such as Aspergillus and Penicillium produce mycotoxins, chemical compounds that can cause headaches, fatigue, and immune suppression after pro-

Chennai, Oct 7: Tamil Nadu is now home to an estimated 3,170 wild elephants, an increase of 3,063, said R S Raja Kannapan, State Minister for Forests and Khadi. Tuesday. Kannapan was releasing the

Third Synchronised Elephant Population Estimation (2025) report as part of the Wildlife Week celebrations at the Secretariat.

"This steady growth in Tamil Nadu's elephant population reflects the state's commitment to science-based wildlife management and community-driven conservation." said the minister.

Highlighting the importance of evidence-based and collaborative conservation, Supriya Sahu, Additional Chief Secretary to the Government, Environment, Climate Change and Forests Department, said the state is focusing on habitat restoration, removal of invasive species, improvement of fodder and water availability. and use of technology to monitor movements.

"Elephants are an integral



part of our forests and our cultural identity. The steady increase in their population is a strong indicator that our policies are working," she added.

According to her, the state has declared the Agasthyamalai Elephant Reserve, notified the Thanthai Perivar and Cauvery South Wildlife Sanctuaries, and expanded protection across more than 2.8 lakh hectares of elephant habitat under Tamil Nadu's Elephant Conservation Schemes.

The synchronised estimation was conducted from May 23 to 25 in coordination with Karna-

taka to ensure consistent data across shared elephant landscapes, said a press release issued by the Forest Department.

In Tamil Nadu, the survey covered 26 forest divisions, including tiger reserves, wildlife sanctuaries, territorial forest divisions, and a national park. it added.

In the latest survey, Mudumalai Tiger Reserve recorded the highest density at 1.35 per km² (estimated 325 elephants), followed by Gudalur Forest Division and Anamalai Tiger Reserve, according to the press release.

5 BUSES BROKE DOWN EVERY HOUR ANNUALLY IN DELHI: OFFICIAL DATA

NEW DELHI: Over 112 DTC buses broke down on average every day in Delhi over pots of the public transporter, according to data obtained through an RTI guery over a span of two years between 2023 and 2024 -- an average of nearly five bus es breaking down every hour and every day for two years. Between January and July this year, 21,123 complaints of buses breaking down on roads were received by the DTC control room, the data showed. According to details divulged through the RTI, 8,598 buses operated by various depots falling under the North region broke down this year. The Rohini Depot 4 under the North region recorded 1,008 cases of hus breakdowns this year between January and July, declining from 1,824 in 2023 and 1,249 in 2024 during the same time period. The Rohini Sector 37 depot showed a surge in numbers. Between January 1 and July 28 this year, 3,014 bus breakdowns were recorded. The figures in 2023 and 2024 between January 4 and July 28 stood at 686 and 1.007 respectively.

Vandalur zoo to go fully carbon-neutral: Tamil Nadu

Chennai, Oct 7: The Tamil Nadu government Tuesday said efforts were underway to achieve complete carbon neutrality at the Vandalur zoo here, in order to make it the first-of-its-kind in the country's zoo network.

Popularly known as Vandalur zoo, the Arignar Anna Zoological Park already meets 80 per cent of its power requirements through solar energy.

"Efforts are underway to achieve complete carbon neutrality, making it a first-of-itskind in the country's zoo network," the government said.

A decision to this effect was made at a meeting of the Zoo Authority of Tamil Nadu, chaired by Chief Minister MK Stalin at the Secretariat here

It was decided to allocate Rs 35 crore for the comprehensive development of four zoos across the state.

The meeting also resolved to advance Tamil Nadu's vision of sustainable, inclusive, and carbon-neutral zoos where conservation, climate consciousness. and community connect come

Carbon neutrality is the state of balancing carbon dioxide and other greenhouse gases emitted into the atmosphere by achieving net-zero carbon emissions.

The chief minister, who presided over the 22nd Governing Board Meeting of the Tamil Nadu Zoo Authority, reviewed ongoing initiatives and new proposals to strengthen infrastructure, enhance animal welfare, and improve visitor experience.

"Over the last four years, Tamil Nadu's zoos have witnessed a quiet but remarkable transformation, embracing accessibility, digital innovation, and climate resilience," a press release said.

The Vandalur zoo, equipped



plant, will soon see the revamping of the birds' aviary and the nocturnal animal house. It will have enhanced accessibility with ramps, anti-skid tiles, and improved facilities for differently-abled visitors.

"Over 90 per cent digital ticketing adoption through UPI, online, and WhatsApp

Delhi govt preschools outshine private peers in overall quality: Study

New Delhi, Oct 7: In contrast to popular belief, preschools in Delhi run by the government have outperformed their private counterparts in most of the six components including physical infrastructure, WASH practices, child-friendly environment. curriculum implementation, classroom process and safety, according to a study by Jamia Millia Islamia.

When all six parameters were combined, the government preschools performed best overall, with more than half rated "good". The private preschools followed closely, while Anganwadis mostly remained in the "average" category, with one rated "poor", the 2025 study said.

Researchers from Jamia's Department of Education studied 45 preschools across the capital, 15 each from the government, private and Anganwadi setups in 2023.

The findings of the study, named 'A quantitative study on quality of physical infrastructure, WASH practices, preschool education and safety in Anganwadi centers, government preschools and private preschools in Delhi'. were published in Discover Education (2025).

According to the study, preschools were assessed on six components -- physical infrastructure; water, sanitation and hygiene (WASH) practices; child-friendly environment, curriculum implementation classroom process and safety.

The researchers used the Anganwadi Assessment Scale, a standard tool for evaluating early childhood programmes and the scores obtained were subsequently split into three categories - "poor", "average' and "good".

As far as physical infrastructure is concerned, the study found that 13 of the 15 government preschools had "good" infrastructure, com pared to eight private schools and four Anganwadi centres Ten Anganwadis were rated "average" and one "poor".

The paper attributed this gap largely to the fact that most An ganwadis function from rented or standalone buildings with limited indoor and outdoor space, ventilation and facilities

sources, it read. When it came to WASH, none of the government preschools achieved a "good" score. All 15

were rated "average", the study highlighted.

15 killed as landslide hits bus in Himachal

Shimla, Oct 7: At least 15 passengers were killed when a private bus was struck by a massive landslide in Himachal Pradesh's Bilaspur district Tuesday evening, officials said. The accident took place in

Bhalughat area in Jhandutta assembly segment around 6:30 pm, they said, adding the bus carrying 25-30 passengers was on its way from Marotan to Ghumarwin. Several people are be-

lieved to be trapped under the debris while three have been rescued, the officials said. Prime Minister Narendra Modi announced an ex-gratia of ₹2 lakh from Prime Minister's National Relief Fund (PMNRF) to the next of kin of each deceased while the injured would be given ₹50.000.

"Saddened by the loss of lives due to a mishap in Bilaspur, Himachal Pradesh. My thoughts are with the affected people and their families during this difficult time. Praying for the speedy recovery of the injured,' Modi wrote on X.

Intermittent rains have been lashing the area since Monday. So far 15 people including the driver and the conductor of the bus have died while three rescued alive were sent to hospital. BJP MLA from Jhandutta J R Katwal, who was on the spot, told PTI over the phone.

Police and district administration officials are at the spot and rescue operations are going on in full swing, said Bilaspur Superintendent of Police Sandeep Dhawal, maintaining that 15 bodies have been recovered from the rubble.

Whole mountain came crashing down on the bus, said an eyewitness engaged in the rescue operations.



Union health minister J P

Nadda, Chief Minister Sukhvinder Singh Sukhu and Deputy CM Mukesh Agnihotri have expressed grief over the accident. CM Sukhu directed the officials to expedite the rescue operations, an official statement said.

President Droupadi Murmu condoled the loss of lives and prayed for the speedy recovery of those injured. "The news of the deaths of several people in a bus accident caused by a landslide in Bilaspur, Himachal Pradesh, is extremely tragic. I express my condolences to the families who have lost their loved ones and pray for the speedy recovery of those who have been injured,' Murmu said in a post on X in Hindi. Meanwhile, Union Home Minister Amit Shah expressed "deep sadness' over the bus accident. In a post on X in Hindi, Congress president Kharge said the tragic bus accident in Bilaspur district, which resulted in the death of several people, is deeply saddening and unfortunate. "The state government is continuing its rescue operation on a war footing. The chief minister is personally overseeing the relief and rescue efforts, and the government is providing all possible assistance to the victims," Kharge said.

The hospital visit came hours after the Lok Sabha Secretariat sought a factual note within three days from the Union Home Ministry on the attack. Parliament officials said the Secretariat has written to the Ministry of Home Affairs to obtain a "factual note" from the West Bengal government within three days. Television visuals showed Banerjee entering the hospital and speaking softly to the injured parliamentarian and his family. "Do you have diabetes? Are you taking insulin and medicines regularly?" she was heard asking Murmu. before consulting doctors and assuring that the government would extend all necessary help.

"If you need any assistance or further treatment elsewhere. please let me know," Banerjee told the family. However, she did not meet Siliguri MLA Sankar Ghosh, who was also injured in the attack and shares a frosty relationship with the chief minister following repeated assembly clashes. While the BJP welcomed Banerjee's visit as a "political courtesy', it questioned the "inaction" of the police.

Murmu, who is in the ICU

with a fractured bone below his eve, is stable but under close monitoring, and doctors said he may need surgery. The assault on Murmu and Ghosh came amid torrential rains that triggered deadly floods and landslides across north Bengal. 

No dirty business or manipulation: Govt

New Delhi, Oct 7: Civil Aviation Minister K Rammohan Naidu Tuesday said there is "no manipulation or dirty business" happening in the investigation into the Air India plane crash that killed 260 people June 12.

His assertion comes against the backdrop of concerns expressed in certain quarters about the Aircraft Accident Investigation Bureau (AAIB) probe into the fatal crash. Naidu said evervone has to

wait for the final AAIB's final probe report to know what exactly happened. "There is no manipulation, or

there is no dirty business, happening in the investigation. It is a very clean and very thorough process that we are doing according to the rules...," he said. The minister also said it

will take some time for the final AAIB report into the crash and added, "We don't want to pressure them into coming up with some history report". He was speaking on the side-

lines of a book launch function in the national capital. In one of the worst aircraft

accidents in India, a total of 260 people, including 241 passengers, died after Air India's Boeing 787-8 aircraft operating flight AI171 to London Gatwick crashed soon after take off from Ahmedabad June 12.

AAIB, in its preliminary report released July 12, had said the fuel supply to both engines of the plane was cut off within a gap of one second, causing confusion in the cockpit soon after takeoff.

"In the cockpit voice recording, one of the pilots is heard asking the other why did he cut

off. The other pilot responded that he did not do so," it had said. On September 22, the Federation of Indian Pilots (FIP) urged the government to order a judicial probe into the Air India Dreamliner crash, alleging that the ongoing investigation is "compromised" and should be halted.

FIP represents around 5,500 pilots. On August 29, Pushkarai Sabharwal, father of Captain Sumeet Sabharwal, who was one of the pilots of the ill-fated Air India Dreamliner, demanded a 'formal investigation' by the central government.

In a letter to the civil aviation secretary and AAIB Director General, 91-year-old Pushkaraj said that selective leaks about the accident have led to speculation that Sumeet (56) was under tremendous psychological pressure and, therefore, was contemplating committing

"These innuendos have very adversely affected my health and mental setup, and the reputation of Captain Sumeet Sabharwal. They tarnish Captain Sabharwal's reputation, which is a fundamental right guaranteed to a citizen of India under Article 21 of the Constitution of India." he had said in the letter.

Pushkaraj has demanded that the central government order a formal enquiry into the accident under Rule 12 of the Aircraft (Investigation of Accidents and Incidents) Rules, 2017. The Supreme Court, September 22, termed as "unfortunate and irresponsible" the selective publication of a preliminary report on the June 12 Air India crash, which outlined lapses on the part of pilots and paved the way for a "media narrative".

Gift under Mohammedan law valid without proof: SC

New Delhi, Oct 7: The Supreme Court Tuesday said a gift (hiba) under Mohammedan Law does not require a written document to be valid. The court said there are three

essential conditions for an oral gift -- a clear manifestation of the wish to give on the part of the donor, an acceptance of the gift by the donee and the taking of possession of the subject-matter of the gift by the donee, either actually or constructively.

A bench of Justices Ahsanuddin Amanullah and S V N Bhatti said an oral gift that fulfils the three essential requisites is complete and irrevocable.

"A gift under Mohammedan Law does not require a written document to be valid. The mere fact that a gift is reduced

to writing does not change its nature or character. A written document recording the gift does not become a formal instrument of gift," the bench said. The court said delivery of possession is a critical and necessary element for a valid gift.

There was no word from Indian officials on the matter. Official sources said the Indian embassy in Kyiv was ascertaining the veracity of the report. Hamas talks deal, but conditions persist

Sharm El-Sheikh, Egypt, Oct 7: Hamas said Tuesday it wants to reach a deal to end the war in Gaza based on US President Trump's plan but still has a set of demands, a statement signalling that indirect talks with Israel in Egypt could be difficult and lengthy.

Senior Hamas official Fawzi Barhoum set out Hamas's position on the second anniversary of the Palestinian militant group's attack on Israel that triggered the Gaza war, and one day after the indirect negotiations began in Sharm el-Sheikh.

The talks appear the most promising yet for ending a war that has killed tens of thousands of Palestinians and devastated Gaza since the October 7, 2023 attack on Israel, in which 1,200 people were killed and 251 were taken back to Gaza as hostages.

But officials on all sides urged caution over the prospects for a rapid agreement, as Israelis remembered the bloodiest single day for Jews since the Holocaust and Gazans voiced hope for an end to the suffering brought by two years of war.

"The (Hamas) movement's delegation participating in the current negotiations in Egypt is working to overcome all obstacles to reaching an agreement that meets the aspirations of

The protests reflect a shift in global sentiment, with sympathy that initially flowed to Israel after the October 7 attacks now increasingly directed towards Palestinians, leaving Israel more isolated on the world stage. Organisers of pro-Palestinian protests say they are intended to spotlight the humanitarian crisis in Gaza and advocate for Palestinian rights. But politicians in several countries said scheduling such protests on the 'Terrible timing, shockingly insensitive," Chris Minns, the premier of the Australian state of New South Wales, told radio station 2GB of a planned protest in Sydney. srael has repeatedly denied permission to transfer incubators from an evacuated hospital in North Gaza, a UN children's agency official said Tuesday, adding to strain on overcrowded hospitals further south where newborn babies are now sharing oxygen masks. Two years of war between Israel and Hamas has increased stress and malnourishment among pregnant mothers, leading to a rise in premature and underweight babies who the World Health Organization says now account for a fifth of all Gaza newborns. Over the past month an Israeli assault on Gaza City in northern Gaza has shut hospitals in that area, worsening overcrowding in hospitals that remain open in the south. James Elder, UNICEF spokesperson, described mothers and babies

lining the corridor floors of Nasser Hospital in southern Gaza, and said that premature babies were being forced to share oxygen masks and beds. Meanwhile, vital equipment is stranded in hospitals that have been shut in the north. "We've been trying to recover incubators from a hospital that was evacuated in the north, and we've had four missions denied simply to get those incubators," he told Reuters by video link from Gaza, referring to supplies now stuck at the damaged Al-Rantissi Children's Hospital in Gaza City.

FIR registered against deposed PM Oli, home minister

Kathmandu: Nepal's youth-led Gen-Z group, which organised antigovernment protests last month, Tuesday registered an FIR against deposed prime minister KP Sharma Oli and then home minister Ramesh Lekhak, seeking their criminal accountability for the deaths during the demonstrations. The Kathmandu District Police Circle Spokesperson, Superintendent of Police Pawan Bhattarai, confirmed that the FIR was registered at the Kathmandu District Police Office, Bhadrakali, against UML chairman Oli and Nepali Congress leader Lekhak. He said that since a probe commission to investigate the matter has already been constituted, the police have forwarded the FIR to the high-level Judicial Investigation Commission headed by Justice Gauri Bahadur Karki. "The FIR registered by the Gen-Z youths with the police will establish their (Oli and Lekhak's) criminal accountability and pave the way for investigation of the crime committed 8 and 9 September," said senior advocate Dinesh Tripathi. "The serious crime committed by the state agents should not go unpunished, and impunity must be ended," he added. Nineteen protesters were killed during the police firing September 8, the first day of the Gen-Z protests. In total, 76 people were killed during the two-day protests September 8 and 9.

Macron pressed to end political 'mess'

Paris, Oct 7: France's President Emmanuel Macron faced growing pressure Tuesday to resign or hold a snap parliamentary election to end political chaos that has forced the resignation of five prime ministers in less than two years.

Bhangura, Bangladesh, Oct 7: In flood-prone regions of Bangladesh, solar-powered "floating schools" ensure children do not miss class when rising waters cut off roads and villages. One of them is 10-year-old

Each morning, he waits on the edge of his flooded village in Bhangura, western Bangladesh, for the solar-powered classroom that sails right to

his doorstep. His home lies deep in Chalan Beel, a sprawling 26-square-kilometre (10 sq miles) wetland where seasonal floods often cut off roads and submerge entire villages.

But for Islam and hundreds of other children, education floats. The initiative, launched in 2002 by architect Mohammed Rezwan using \$500 of his scholarship money, has grown into a nationwide model run by the non-profit Shidhulai Swanirvar Sangstha (SSS). Now, more



than 100 boats serve as schools, In Chalan Beel, around two libraries, and clinics. The project has educated over 22,000 lages six days a week. students and won a UNESCO The school boats are made of Confucius Prize for Literacy

local timber and are equipped

with benches, blackboards, and bookshelves. Solar panels power lights and computers.

"Right now, we have 2,240 pupils enrolled in 26 boat schools, said Madhusudan Karmaker, a senior manager at SSS. "Over 22,500 students have graduated so far, and during severe floods. these boats also double as shelters for displaced families."

Other NGOs have adopted similar models for their work in the country's wetland areas.

Classes are run in three shifts a day, lasting about three hours each. Teachers navigate narrow waterways to collect students, conduct lessons in Bengali, maths, and general knowledge.

"We never had the chance to study," said parent Sufia Khatun, waiting on the riverbank for her son Islam to return. "But this boat lets my children dream of a better future.

Teacher Sakhina Khatun who has been with SSS for over a decade, said similar floating school initiatives have since inspired projects in countries like Nigeria, Cambodia, and the Philippines. "These schools never close - not even during floods," she said. "That's what makes them special.

Founder Rezwan, a World Fellow at Yale University, said, "I haven't had many things during my life and these children don't have much either. But giving them access to schooling healthcare and seeing that rep licated around the world - that gives me motivation.'

paise to settle at 88.74 against the US dollar. Investors moved cautiously after the US Senate once again rejected both Democratic and Republican proposals to fund the government, prolonging the government shutdown into its sixth day, traders said.

Jateen Trivedi, VP Research Analyst - Commodity and Currency, LKP Securities, said the rupee witnessed limited volatility as FII selling eased and crude prices remained soft.

RBI proposes changes in credit risk norms for banks

Mumbai, Oct 7: The Reserve Bank Tuesday proposed to replace the incurred-loss-based provisioning framework with an expected credit loss (ECL) based provisioning to further strengthen credit risk management practices and promote greater comparability across financial institutions.

The proposed guidelines are expected to enhance credit risk management practices and promote better comparability of reported financials across institutions.

The draft RBI (Scheduled Commercial Banks & All India Financial Institutions - Asset Classification, Provisioning and Income Recognition) Directions, 2025' also aims to align regulatory norms with internationally accepted regulatory and accounting standards.

The introduction of staging criteria for asset classification under the ECL approach, while retaining the extant norms for non-performing asset (NPA) classification, is one key element of the proposed framework.

Alignment of the income rec-

ognition norms based on the Effective Interest Rate (EIR) method and broad principles on model risk management for implementing ECL models are other objectives behind changing the extant regulations.

The RBI said that while the proposed directions are estimated to result in an additional one-time provision ing, the overall impact on the minimum regulatory capital requirements of banks is ex pected to be minimal, with all banks continuing to meet the requirements comfortably. The proposed five-year glide

path will further facilitate the transition in a non-disruptive manner. Under the ECL norms banks would be required to clas sify financial assets (primarily loans, including irrevocable loan commitments, and investments classified as held-to-maturity or available-for-sale) into one of the three categories -- Stage 1 Stage 2, and Stage 3, depending upon the assessed credit losses on them at the time of initial recognition as well as on each subsequent reporting date and make necessary provisions.

St. Louis (USA), Oct 7: Former world champions Viswanathan Anand and Garry Kasparov will reignite their once fierce rivalry after 30 years when they face off in the Clutch Chess: The Legends tournament here from

The 12-game Chess 960 match will carry a total prize pool of USD 144000 and will be held in the upgraded St Louis Chess

Having played a Classical World Championship match in 1995 on the 107th floor of the the World Trade Centre in New York, the two legends of the game will battle it out again in the famous rapid and blitz format that was recently christened Freestyle Chess. Kasparov dominated that

match against Anand and won the 20-games contest 10.5-7.5. After retiring in 2004 Kasparov has played only in exhibitions or blitz events while Anand is semi-retired and plays occasionally in higher events.

While Kasparov runs a world-wide training programme under his name, Anand has limited himself to Republike

mentoring the young generation of Indian players and has been the inspiration behind WACA – Westbridge Anand Chess Academy - that has already produced one world champion in D Gukesh.

The format here is interesting and the stakes will go up each day. There will be four games everyday in the threeday contest with two rapid and two blitz games. While there will be four points at stake on the first day, on the second day it will double as each win will be worth two points and on the third day, each game will fetch three points for a win.

The winner will take home USD 70000 (approximately Rs 62 lakh) while USD 50000 (approximately Rs 44 lakh) is reserved for the one ending on the losing side of this match.

Indian batters also struggled to get runs as the visitors were reduced to 41 for 3 in the seventh over with prodigy Vaibhay Survayanshi dismissed for 20 off the bowling of Charles Lachmund.

Suryavanshi, who had struck a rapid 113 off just 86 balls in India's innings and 58-run win in the first match, hit two fours and a six from the 14 balls he faced this time.


The T20Is here have generally seen high scores, as both India men and Delhi Capitals (in the IPL) were able to chase down 200-plus targets.
