PM lays stones for two fishery projects in state

Bhubaneswar, Oct 11: Prime Minister Narendra Modi Saturday virtually laid the foundation stones for two fishery projects worth around ₹160 crore in Odisha.

He laid the foundation stones for the fishery projects while launching the ₹24,000-crore Pradhan Mantri Dhan Dhaanya Krishi Yojana and a ₹11,440-crore Mission for Aatmanirbharta in Pulses in Delhi. The fishery projects included a ₹100-crore integrated aqua park at Basantapur in Sambalpur district and a ₹59.13-crore fish market at Pandara in Bhubaneswar. Chief Minister Mohan

Charan Maihi, his deputy K V Singh Deo and others joined the event virtually from a state-level function on OUAT premises here.

Maihi said the fish market project in Bhubaneswar is another important initiative under the Pradhan Mantri Matsya Sampada Yojana. "Of the ₹59.13 crore, ₹30 crore will be given by the Centre and remaining amount by the state," the CM said.

The project will be implemented in collaboration with the state government's Fisheries and Animal Resources Department and the Bhubaneswar Municipal Corporation, and it will directly benefit 143 traders and generate indirect employment for more than 2,000 people, he said.

The CM said that the integrated aqua park at Hirakud, which will be built over 95.47 acres of government land, will further develop modern fish farming. Of the ₹100 crore investment to be made in the project, the central government will contribute ₹60 crore while the remaining ₹40 crore will be spent by the state govern-

Afghan FM's 'male only' presser triggers row

New Delhi, Oct 11: The Opposition and media bodies Saturday termed the absence of female journalists from a press conference of visiting Afghan Foreign Minister Amir Khan Muttaqi 'unacceptable' and an 'insult to women.'

The Editors Guild of India and the Indian Women Press Corps termed the act as highly discriminatory, which cannot be justified on grounds of diplomatic privilege under the Vienna Convention.

Congress leader Rahul Gandhi launched a scathing attack on Modi, saying by allowing 'exclusion' of women scribes from a public forum, the prime minister is telling every woman in India that he is 'too weak to stand up for them.' In a post on X, Gandhi said, "Mr Modi, when you allow the exclusion of women journalists from a public forum, you are telling every woman in India that you are too weak to stand up for them.

In our country, women have the right to equal participation in every space. Your silence in the face of such discrimination exposes the emptiness of your slogans on Nari Shakti."

Congress general secretary Priyanka Gandhi Vadra said if the PM's recognition of women's rights isn't just convenient posturing from one election to the other, how has this "insult to some of India's most competent women been allowed in our country."

The press conference addressed by Muttaqi Friday saw participation restricted to a handful of reporters, while women journalists were con spicuous by their absence.

It is learnt that the decision on inviting journalists to the media interaction was taker by Taliban officials accompa nying the foreign minister.







Bhubaneswar, Oct 11: Odisha will soon emerge as a frontrunner in country's blue revolution, with the construction of eastern India's first integrated aqua park at Hirakud in Sambalpur district, Chief Minister Mohan Charan Majhi said Saturday.

Prime Minister Narendra Modi virtually laid the foundation stone for the integrated aqua park at Basantpur in Sambalpur and a modern wholesale fish market at Pandara in Bhubaneswar under the Pradhan Mantri Matsya Sampada Yojana while launching the

he integrated aqua park, to be developed over 95.47 acres of government land in Sambalpur at a cost of ₹100 crore, is expected to be completed by January 2027

he wholesale fish market, to be set up in Bhubaneswar's Pandara at an estimated cost of ₹59.13 crore, is slated for completion by

Prime Minister Dhan-Dhaanya Krishi Yojana (PMDDKY) and Mission for Aatmanirbharta in Pulses in Delhi. Addressing the state-level launch ceremony of the PMDDKY and the Mission for Aatmanirbharta in Pulses at OUAT here, Majhi said the new initiatives would empower farmers and promote self-reliance.

The PMDDKY was launched in 100 districts across India, including Kandhamal, Malkangiri, Sundargarh, and Nuapada in Odisha. Over the next six years, the scheme will involve an annual expenditure of ₹24,000 crore, benefiting 1.7 crore farmers nationwide. The integrated agua park, to be developed over

95.47 acres of government land at a cost of ₹100 crore, is expected to be completed by January 2027. It will transform Sambalpur into a centre of excellence in modern aquaculture, Majhi said.

Of the ₹100 crore, the Union government will contribute ₹60 crore, while the remaining ₹40 crore will be spent by the state government.

Majhi said agriculture and allied sectors remain the primary livelihood source for over 60 per cent of Odisha's population and nearly 50 per cent nationally.

The state government, he added, has introduced major policy reforms in these sectors, with ₹37,838 crore allocated for agricultural development in the 2025–26 Budget.

Under the Samruddha Krushak Yojana, farmers are assured of ₹3,100 per quintal as a combined benefit of Minimum Support Price (MSP) and input

Majhi expressed confidence that the PMDDKY would strengthen the rural economy, boost farmers' income, and promote inclusive agricultural growth.

The wholesale fish market at Pandara, to be set up at an estimated cost of ₹59.13 crore, will be jointly implemented by the Fisheries and Animal Resources Development department and the Bhubaneswar Municipal Corporation (BMC).

Of the total cost, ₹30 crore will come from the Union government and ₹29.13 crore from the state government. The market will directly benefit 143 traders, create over 2,000 indirect jobs, and cater to the fish demand of Bhubaneswar and Cuttack. It is slated for completion by Novem-

Deputy Chief Minister Kanak Vardhan Singh Deo, who is also the Agriculture and Farmers Empowerment Minister, said while India is already self-sufficient in rice, the focus must now shift towards self-reliance in pulses and oilseeds, along with promoting the blue economy to enhance farmers' income. With the death of Nuapada BJD MLA Rajendra Dholakia September 8, BJD's tally in the state Assembly dropped from 51 to 50. The outcome of the upcoming by-election to seat was supposed to decide whether the party could regain its earlier strength. However, Rajendra Dholakia's son, Jay Dholakia, joined the BJP Saturday, fuelling speculation that the BJD may no longer be intending to retain its previous numbers.

Leader of the Opposition and BJD supremo, Naveen Patnaik, who had been in New Delhi since September 7, returned to Bhubaneswar Friday. Jay, who was also in the national capital around the same time. joined the BJP soon after his return. The timing has triggered talk of a possible understanding between the BJD and the BJP's Central leadership. A senior political observer, speaking on condition of anonymity, claimed that "some form of understanding has already been reached between the two At present, the BJP has 78

MLAs, along with three Independents who are aligned with it, taking its effective strength to 81. The BJD's count has fallen to 50 following Dholakia's death. The Congress holds 14 seats, while the CPI(M) has one. Based on the current numbers, a candidate requires 30 votes to win a Rajya Sabha seat. This arithmetic gives the

BJP two seats comfortably, while one seat is almost certain for the BJD. The fight for the fourth seat, however, now leans in the BJP's favour with 21 votes as against the BJD's 20. Initially, the BJD had

planned to field Jay as its candidate for the Nuapada by-election, banking on sympathy votes. However, his joining the BJP has upended that strategy. What seemed certain until Thursday turned uncertain the very next day, coinciding with Patnaik's return from Delhi.

Had the Nuapada seat remained with the BJD until the Rajya Sabha polls, the party would likely have needed the

backing of the Congress and CPI(M) to claim the fourth seat. But given the BJD's neutral stance during the Congress no-confidence motion against the state government in the Assembly and its abstention in the recent Vice Presidential election-moves seen as indirectly favouring the BJP-political observers believe the BJE is unlikely to take Congress help to claim the fourth seat.

The scenario might have been different had Rajendra Dholakia still been alive, as the numbers would have forced the BJD into a tougher contest The party's earlier gestures of goodwill toward the BJP-such as supporting Union Minister Ashwini Vaishnaw's Rajya Sabha election twice despite having the numbers to field its own candidate-appear to be continuing.

In the coming Rajya Sabha polls, the BJD seems poised either to cede the fourth seat to the BJP or to refrain from contesting it aggressively. Sourc es indicate that a new political understanding may have been brokered through a corporate figure, reportedly being consid ered as the BJD's nominee. If true, it could mark yet another chapter in the quiet coopera tion between the two parties.

Srimandir sky now a 'Red Zone'

Bhubaneswar/Puri, Oct 11: In a significant development, the Directorate General of Civil Aviation (DGCA) has marked Srimandir and its periphery on its flight map as a 'Red Zone', prohibiting aircrafts like drones from flying in the area, particularly above the 12th

Puri Superintendent of Police Prateek Singh said Saturday that the DG-CA move came after repeated sightings of unauthorised drone flights over the temple. Singh said the 'Red Zone' status will remain effective for three years – till September 25, 2028. "The restriction will apply to unmanned aircraft such as drones, which can pose a significant security challenge," he said.

Odisha Police had approached the DGCA and acting on its request, the authority appointed nodal officers to survey Puri. "Following their recommendation, the DGCA issued a notification September 25 this year, declaring Srimandir and its surrounding areas as a 'Red Zone'," Singh said.

With the 'Red Zone' status, strict legal action will be taken against any unauthorised drone operations or aerial activities near the temple complex.

The move aims to bolster aerial surveillance and safeguard the historic shrine, which attracts millions of devotees from across the world every year.

In recent months, several incidents of drones flying close to the temple have

'Lawyers, judges must ensure justice for all'

New Delhi, Oct 11: Chief Justice of India BR Gavai Saturday said lawyers and judges have a responsibility of strengthening the justice system and they must ensure that the legal discourse does not remain confined to metropolises, but is accessible to even those living in the country's remotest corners.

Speaking at the LAWASIA Conference at Hanoi in Vietnam on the topic of "Role of Lawyers and Courts in Promoting Diversity and Inclusion", the CJI said it is crucial that the principles judges articulate in their judgments are reflected in the administrative policies of the court.

"I can share that when I assumed office as the CJI in May. one of my top priorities was to ensure that affirmative action in the recruitment of administrative positions within the court was implemented not just in letter, but in spirit. I directed that marginalised communities receive their due share in all administrative appointments and that these policies be applied consistently and transparently," Justice Gavai said.

He said the dream of equality, nurtured by Gautam Buddha. Mahatma Gandhi and BR Ambedkar was enshrined in the Constitution of India in 1950 and it turned the tide of destiny for millions who were historically marginalised and denied their basic rights. "For me, born into a low-caste family, it meant that I was not born untouchable. The Constitution recognised my dignity as equal to that of every other citizen, offering not just protection, but



the promise of opportunity, freedom and social recognition," he said

The CJI said lawyers should not be reluctant in hiring women because of assumptions about maternity leave, time constraints or perceived 'commitment issues'.

"Such biases are unfair and counterproductive. Lawyers have a duty to ensure that the principles they advocate in court and in public life are reflected in their own workplaces and professional conduct," he

Referring to various Supreme Court verdicts, including the permanent commission judgment, where women officers were allowed permanent commission in defence forces, Justice Gavai said the judiciary has played a crucial role in ensuring that the law protects and promotes equality, rather than perpetuating historical disadvantages.

"I also believe that lawyers and judges share additional common goals in strengthening the justice system. We must ensure that the legal system and legal discourse do not remain confined to metropolitan cities, but are accessible to every citimotest corners of the country.

"Inclusion is achieved only when the common person can understand, relate to and feel connected with the legal processes, the exchanges between a lawyer and a judge, the judgments delivered and the mechanisms of justice itself," he said.

The CJI said in his role as the executive chairperson of the National Legal Services Authority (NALSA), which is mandated to ensure that no one is left without legal aid, he made it a priority to direct his team to reach the farthest and most underserved regions of the country.

'The goal was clear -- no individual should be deprived of their legal rights and every person must have access to necessary legal representation, guidance and support," he said at the conference of LAWASIA, which is headed by senior advocate Shyam Divan.

Justice Gavai said lawyers often have a more direct access to the public than judges, as the latter are expected to maintain a degree of aloofness, and this proximity gives lawyers a unique opportunity and responsibility to engage with the

"Their role is not confined to only the courtroom. It extends to the broader community, where they can raise awareness about rights, legal processes and the principles of justice. By doing so, lawyers serve as vital bridges between the law and the people, ensuring that justice is not only delivered but also understood, accessible and meaningful to all members of the society," he said.

Evicting citizens from a public tribunal hearing violates Articles 19(1)(a) and 21 of the Constitution, which guarantee the right to information, freedom of expression and access to fair judicial proceedings, the activists said. The organisation has filed a formal complaint before the tribunal chairperson seeking redressal.



POST NEWS NETWORK Nilagiri, Oct 11: At a time when a series of elephant deaths have raised concern in Kuldiha Wildlife Sanctuary, another pachyderm estimated to be over 20 years old was found dead in a nearby pond Friday night. The cause of death is yet to be determined.

The carcass was discovered in a pond near Ambajhar village in the Panchalingeshwar forest range under Kuldiha sub-division. About 85 elephants reside in and around the sanctuary. Forest staff first noticed the dead elephant and informed high-

including Divisional Forest Officer (DFO) Prafulla Kumar Mallik, ACF Tatini Sethi, Kuldiha Range Officer Subrata Kumar Behera, Panchalingeshwar Forest Officer Hrushikesh Pradhan, and a veterinary doctor, visited the site to conduct a preliminary investigation Saturday morning. Later, a high-level committee from the Forest department arrived to ascertain the cause of death and an autopsy was carried out on the carcass.

Forest officials said the final post-mortem report will reveal the cause of death. "Once the report is received, we will be able to confirm the exact cause," the DFO said.



Stalled Promise

hirty five years ago, India chose to go down two paths, on both of which it remains. The first path was to move to a new form of economics. This was informally named liberalisation and involved opening India to foreign capital, dismantling the license raj, and ending public sector monopolies.

Though this was unstated, the goal of liberalisation was to follow the path of Asian nations like Japan, Taiwan and South Korea and industrialise India. Another nation was attempting this at the same time as us, and that is China. On the cusp of liberalisation, whose date we mark as 24 July 1991 (when finance minister Manmohan Singh presented his budget) India and China were at the same stage of economic development. The World Bank says both nations had a per person GDP of \$334 in 1991.

It is said China had a bit of a lead because their process of opening up came just after Mao Tse Tung died, a decade or so before India. But China was coming from a very dark place with no private sector at all and a society that was wounded by the cultural revolution, hammered still by such cruelty as the one-child policy. So it is fair to say that in 1991 we were actually even.

What has happened since on this road is a story that can be understood when summarised by decade. By

the end of the 1990s, China's per person GDP was twice India's.

The Atal Behari Vajpayee years that opened the next decade gave us the promise of 'India Shining'. But by the end of the 2000s, China was ahead by three times. In the Manmohan Singh era, China was up four times. In Modi's New India, up by five

Till the time of the global financial crisis of 2008, publications that tracked the global economy, such as The Economist, the Wall Street Journal and the Financial Times used to run features speculating that India was on the path to joining Japan, South Korea and China. That ended by the time of the Covid pandemic. It was conceded that India was not doing and could not do what the Asian tigers had done, and was consigned to grow at more or less the same pace as its sisters, Bangladesh and, to a lesser extent, Pakistan.

The reasons for this were likely several, but the primary one was the inability of the state, meaning the apparatus of government, to effectively develop and implement policy. Today, India's per person GDP is \$2696, more comparable to Bangladesh (\$2593) and Pakistan (\$1484) than it is to China (\$13,303).

This is the reason why the majority of Indians are thought by the government itself to be in need of food support and why jobs and gross inequality are the real problem behind the fables of development.

Though it is clear that it is not working as intended. India remains on the same economic path. The second path India chose to go down in 1990 also it remains on. This was to move away from pluralism and secularism and towards whatever Utopia was promised by the BJP's ideology, which it called Hindutya in its manifesto of 1996.

The party's successful campaign against the Babri Masjid and the pogroms that followed, moved India away comprehensively in a new direction. The party formed in 1951 did not have a chief minister of its own, without a coalition, till 1990. Its national vote share was in the single digits for all these decades before doubling under LK Advani after Babri to around 18% and then doubling again under Narendra Modi to 36%

Unlike the first path of development, the acceleration down this second path has been quite rapid. Under Vajpayee, the BJP was not as full-throated in its expression of anti-minority politics as it is today. This was because some felt Vajpayee was soft, though it is true that he was dependent on allies and therefore forced to be hesitant. The events of 2002 changed that. The BJP found its new leader, who personified both the directions. Coming from a state that had benefited most from the reforms of 1991, he claimed its relative progress was because of him. And the pogrom of 2002, and Vajpayee's inability to get him removed, established him as the primary figure of the future, something that he was able to fulfil. He promised progress down both the paths chosen by India in 1990, but was able to lead it on only one. Today, India is not compared to China and the government has given up on comparisons, along with the rest of the world. Instead, we have found comfort in internal persecution, fighting the Pakistani army and the Bangladeshi refugee along the way. The electoral success of the BJP after 1990 has meant that this road will be difficult to leave, since these policies are rewarded.

For younger readers 1990 will seem a very long time ago, but for many of us it is recent memory. We can look at those decades and see what transpired, and why. The next decades will be similar: hesitant and slow travel on the road to becoming a wealthy and equal society and a rapid, confident march further into the Hindutva utopia.

tense political polarization, there are still moments when a bipartisan consensus can emerge around important ethical issues. One such moment is happening now. Last April the United States Food and Drug Administration released its "Roadmap to Reducing Animal Testing in Preclinical Safety Studies." The FDA said that it was taking "a groundbreaking step" that would advance public health and limit wasteful expenditure by replacing animal testing with "more effective, human-relevant methods."

Such a step would, of course, reduce the suffering of millions of nonhuman animals used for tests. Echoing what opponents of the use of animals in drug testing have long been saying, the FDA referred to a growing scientific recognition that animals do not provide adequate models of human health and disease. The Roadmap also noted that more than 90% of drugs that appear safe and effective in animals do not receive FDA approval for use in humans because they are not safe and effective in humans.

Two weeks after the FDA announcement, the US National Institutes of Health (NIH), the world's largest funder of biomedical research added its support for the shift away from animals, announcing a new commitment: to give higher priority to "human-based research technologies" and to reduce the use of animals in the research that it funds. NIH Director Jay Bhattacharya said that integrating data science and technology would "fundamentally reimagine the way research is conducted," and by doing so, speed up innovation and improve the outcomes obtained from healthcare.

In July, the FDA and NIH

jointly hosted a high-level workshop on reducing animal testing, where papers on new research methods were presented. The event's breaking news was the NIH's announcement to stop issuing new grants for research that

relies solely on animal testing. Senior FDA officials reported that their interactions with hundreds of pharmaceutical and biotech CEOs during a nationwide listening tour had revealed that industry is already using the new, human-centered approach "because it works and because it's highly predictive." The pharmaceutical and biotech companies were nevertheless still using animals for testing, that the FDA wanted animal data.

Industry representatives reported that they found this troubling, owing to ethical concerns about conducting costly experiments that caused animals to suffer while providing data useful only to satisfy a bureaucratic requirement for bringing their products to market. The FDA commissioner noted that the new methods could accelerate the provision of beneficial treatments to the

public, reduce research and development costs, and eventually lower drug prices, while being "more humane and ethical for animals."

This shift is cause for celebration, but it is tragic that it has taken so long. Fifty years ago, one of us wrote in Animal Liberation that alternatives to the use of animals "exist already and others would develop more rapidly, if the energy and resources now applied to experiment on animals were redirected into the search for alternatives." That did not happen. Since the 1938 Federal Food, Drug, and Cosmetic Act, the United States had required animal testing for predicting human outcomes for all drug, therapy, cosmetic, and food safety reviews and approvals.

For more than 80 years, industrial suppliers profited from breeding and selling billions of animals for research purposes. (The shareprice of the largest of these companies, Charles River Labora tories, fell 28% after the FDA announced its intention to reduce animal use.) Public funds were wasted on tests that caused immense harm to animals while failing to predict how humans would respond. Patients suffered and died because they were given drugs that worked on nonhuman animals, but not on them.

The first step toward changing the paradigm was taken in 2022, when overwhelming, bipartisan majorities in both the House of Representatives and the Senate approved the FDA Modernization Act 2.0, making it legal for the FDA to certify substances as safe based on testing without animals. Some of these methods have existed for a long time, while others are novel. In 2024, the NIH established a nearly \$400 million innovation program to develop, over the next ten years, new methodologies that promise to transform the way we understand biological processes and disease states.

Charles River Laboratories, after seeing its stock price plummet, decided that it didn't want to risk going the way of Kodak. The company announced its support for the FDA's focus on alternatives and stated that it intended to

be a leader in the transition. Animal testing will not stop overnight. Nevertheless, weare hopeful that over the next ten years, we will see a profound change in protecting human safety and developingcures for the diseases that afflict us, without inflicting suffering on animals.

REAL LAW ENFORCEMENT AGENCIES DO NOT CONDUCT ARRESTS OVER **VIDEO CALLS OR DEMAND IMMEDIATE PAYMENTS TO AVOID LEGAL ACTION**

n the fast growing digital world, cyber scams have become increasingly sophisticated, with one of the most alarming threats being digital arrest. Digital arrest scams are among the most manipulative forms of cybercrime, public face today. Digital arrest is one of the most dangerous cyber fraud trends today, not just because of the money people loose, but because of the deep psychological trauma it leaves behind.

Usually, a victim receive an unsolicited call or video call from someone posing as police officers, customs officials, or other government agency representatives and threaten with arrest, seized bank accounts, or passport cancellation. Victims are mostly accused of a serious offence, like money laundering, cybercrime, or illegal international transfers. Victim is shown forged FIR copies. police IDs, or legal notices. Sometimes, deep fake videos or fake emails are used to add authenticity and say "We have orders to arrest you immediately unless you cooperate.

Victims are often directed to switch to video calls via platforms like Whatsapp to make the interaction appear more legitimate. Scammers also create a convincing "police station" at the backdrop to gain trust of the victim. Victims are forced to stay on the video call and they are told not to consult anyone, or else the police will come to their door. Let us remember that, there

is no provision for digital arrest under Indian criminal law. Real law enforcement or government agencies do not conduct arrests over video calls or demand immediate payments to avoid legal action. Such incidents are to be reported to the Cyber Crime cell through the national helpline 1930 or the www. CyberCrime.gov.in portal. We can hang up the call and contact the legitimate authorities directly (e.g., your bank, police) using official numbers to verify any claims. Fear of social stigma and reputational harm keeps many from reporting these crimes, enabling scammers to continue their operations unhindered. It's very difficult to catch those

criminals. Hence, the number of cyber crimes is increasing day-by-day across the globe.

Several instances have occurred wherein people receive phone calls that appear to be from their bank. Always remember that information like password, PIN, TIN, etc., are strictly confidential and are not known even to employees/service personnel of the bank. Do not provide your bank account details to emails offering a job or claiming that you have won a lottery. Avoid opening attachment of emails from unknown senders. Avoid accessing Internet banking accounts from cyber cafes or shared PCs. Keep your system up to date.

In response to the growing menace of cybercrime, the Indian government has ramped up efforts to combat digital fraud. The helpline number 1930 receives an average of 1,600 to 1,800 calls daily, a significant rise from the previous year. Financial Cyber Fraud Reporting System was launched in 2021. This platform has successfully saved over ₹3431 Crore across 9.94 lakh complaints

by allowing immediate reporting of financial frauds. The number of registered cybercrime complaints has seen a steady increase from 2022 to 2025. According to the Indian Cyber Crime Coordination Centre (I4C), in 2024, over 92,323 cases of digital arrest scams were reported in India. The total financial loss from these scams was estimated at ₹2.140.99 crore.

The government has also implemented awareness campaigns through SMS, social media, Cyber Dost, Sanchar Sathi portal and even digital displays in public spaces like metro stations and airports, promoting cyber safety and security. Please stay alert and spread the word - 'legitimate authorities will never ask for payments or sensitive details over the phone or online'. Trust your instincts, verify any claims, and report suspicious activities. The next time you or someone, you know gets a call claiming 'immediate arrest.' remember - digital arrest is a scam, not a law.

New Delhi, Oct 11: This Diwali, as the potters of Delhi's Kumhar Colony work late into the night shaping and painting diyas, the vounger members of the community are adding an unexpected tool to the craft artificial intelligence (AI).

What began as curiosity has become a quiet experiment in creativity, blending centuries-old traditions with the imagination of the

The prices of the diyas (earthen lamps) here range from one rupee to thousands, depending on their size and other details. The in bulk to local markets, while intricately-painted or customised lamps fetch higher prices from buvers seeking something unique.

This year, a few families have seen a new kind of creativity among their younger members, who are experimenting with AI for colour and pattern ideas.

"We just use it to see which colours look nice together," said Yash, 19, a college student who helps his family after classes.

"Sometimes it comes up

with very odd ideas, but sometimes it gives really good ones. We do not copv everything it says, we use our own touch, but it helps us think differently," Yash said. For younger potters, technology is a small but useful tool, especially when preparing for large orders and in search of fresh ideas

"It is not like we let it decide everything. We just ask for ideas. The final design still comes from our hands," Yash said.

older artisans though, this new approach feels unfamiliar and unnecessary. Banwari Lal, 62, who has been making divas since childhood, said he prefers to rely on traditional methods passed down through generations.

"Our families have been doing this since Shiva and Parvati were married," he said. "We learnt by watching our fathers and grandfathers. Now, these children learn from their phones. I do not know what they keep doing online all day, but if it helps them, maybe that is how things are now," Lal added.

Sitting nearby, Raghunath, 58, who has worked with clay his whole life. said technology cannot replace skill or intuition.

"The diya listens to your hands, not to a machine," he said, adding, "Clay has its own life. You have to feel it to know when it is ready. No computer can teach that." Still, some artisans believe that the younger generation's curiosity may bring long-term benefits to the craft.

Dheeraj, 54, who runs a small workshop in the colony, said AI has not made a big difference yet but can help attract more customers. "Right now, it is just something new they are playing with, but maybe in the future, it will help us reach new buyers. People like seeing different designs," he said.

Dheeraj believes that blending traditional skills with modern ideas can help the community survive in an increasingly-competitive market. "There are so many ready-made, machine-made items in stores now. If we want to keep our handmade work alive, new ideas like this might help," he added.

This Diwali season has brought its own difficulties. The unexpected early-October rain has damaged a large portion of the potters' ready stock.

"We have lost around 20 per cent of our diyas," Dheeraj said. "We had kept them out to dry and did not expect any rain. It came suddenly and by morning, many of the diyas had gone soft. Once that happens, you cannot sell those. We had to throw away all the trays. The losses have been hard to recover from, especially with the festival so close.

"We earn most of our income in this one month.' said Banwari. "When the diyas get spoiled, we have to start again from the scratch. But there is no choice. We work till late at night to make up for it," he said. Even with the setbacks, the lanes of Kumhar Colony are busy and bright. Rows of diyas line the narrow pathways, glistening in the fading sunlight. The rhythmic sound of clay wheels fills the air as the smell of drying earth mixes with paint and varnish. Children run between houses carrying trays of freshly-painted lamps, while elders sit nearby, shaping new ones for the next batch.

Watching his younger helpers at work, Banwari smiled faintly.

"Maybe, times are changing," he said. "We used to learn by looking at our elders. Now they learn by looking at screens. But if their hands stay in the clay, our tradition will survive.'

DARJEELING TEA PLANTERS TO SEEK GOVT SUPPORT

Kolkata, Oct 11: Darjeeling tea planters hit by the recent landslides triggered by incessant rain in north Bengal are planning to seek the state government's assistance for restoration of infrastructure and communication within the estates so that gardens can function smoothly and future production is not hampered, stakeholders said Friday.

At least 30-35 tea gardens in the hills have been affected with reports of loss of plantation areas, deaths of workers, and damage to houses of labourers, they said.

The Darjeeling Tea Association (DTA), at a meeting Thursday, decided to seek the state government's support for restoration of infrastructure and communication within the gardens, as heavy rains severely damaged internal roads in the



estates and washed away tea bushes, industry veteran and Chamong Tea chair-

"We have decided to make a representation to the state government for assistance for restoration of infrastructure, such as roads, drinking water and electricity, so that the gardens can function smoothly," Darjeeling Tea Association principal adviser Sandip Mukherjee said.

For Darjeeling tea planters, the autumn crop, which is around 15-20 per cent of the annual producman Ashok Lohia said. tion in the hills, has been affected due to the wide-

> spread devastation. Last year, production of the aromatic tea fell below

6 million kg. "Around 200-250 hectares of tea bushes have been affected in the gardens, resulting in financial stress to planters," Mukherjee said.

Firecracker ban proposal dates back to 1961

New Delhi, Oct 11: The han on firecrackers in Delhi is not a new issue. As far back in 1961, concerns over pollution caused by crackers prompted a proposal for a ban, though the government of India did not approve it, according to official records preserved by the Delhi Archives Department.

The proposal, dating back to January 1961, orig inated from the Deputy Ganj Committee -- one of the industrial market associations in Sadar Bazar, Delhi -- which wrote to the chief commissioner of Delhi, complaining about "noise pollution" caused by large-scale use of fireworks during festivals and other celebrations.

The letter was later forwarded from the office of the chief commissioner, who was the executive head of the national capital functioning under the government of India, to the Ministry of Works, Housing and Supply for



its consideration, records accessed by PTI showed.

More than six decades later, the debate over ban on firecrackers continues.

The Supreme Court Friday said a complete ban on bursting of firecrackers in Delhi-NCR is "neither practical nor ideal", as such restrictions are often violated, so a balancing of equities

is needed.

The observation, which hinted at relaxation of the ban, was made by a bench comprising Chief Justice B R Gavai and Justice K Vinod Chandran, which reserved its order on a batch of pleas seeking permission to manufacture and sell "green" firecrackers in Delhi-NCR.

In 1961, Delhi's popula-

tion was just around 26 lakh -- a fraction of the over two crore residents the city has now. Yet, noise pollution caused by firecrackers was a matter of public concern even then.

The Deputy Ganj Committee, in its letter, said the deafening noise from some high-decibel crackers was causing distress

ularly those with heart ailments.

"During the course of fireworks display, it appears as if a complete warfare is going on out side, the association wrote, adding that the authorities seemed "im mune to the situation". The committee also

suggested several measures to control the problem, including a complete ban on high-decibel crackers, prohibition of fireworks after 10 pm, strict licensing for manufacturing and sale of fireworks, and heavy penalties for violations.

These recommendations were also part of the records maintained by the Delhi Archive department.

Responding to the proposal, the secretary to the government of India in the Ministry of Works, Housing and Supply wrote to the chief commissioner of Delhi, saying "a total ban was not considered necessary".

Delhi to boost creative sector, generate jobs

New Delhi, Oct 11: The Delhi government is working on formulating a policy to promote the animation, visual effects, gaming and comics sector, with an aim to boost the city's creative economy and generate employment for youth, officials said Saturday.

The plan, the officials said, is to finalise a draft of the policy by December and put it in public domain for feedback, and subsequently, the policy will come up before the Delhi cabinet for approval.

Earlier this month, the Delhi government's tourism department partnered with streaming platform Netflix for holding a screening of animated series 'Kurukshetra'. The government plans more such initiatives in the future to boost the sector in



the national capital. At the event, Delhi Tour-

ism minister Kapil Mishra said the government is working to position the city as a Global Content Hub in the AVCG (Animation, Visual Effects. Comics and Gaming) sector, guided by Prime Minister Narendra Modi's vision of 'Vikas bhi, Virasat bhi' (development along with heritage).

The government, according to the officials, is studying policies adopted

by states such as Maharashtra to prepare a comprehensive roadmap suited to Delhi's ecosystem.

In September, the Maharashtra cabinet cleared the new Animation, Visual Effects, Gaming, Comics and Extended Reality (AVGC-XR) Policy 2025 with a roadmap till 2050, projecting the industry to create two lakh jobs and attract Rs 50,000 crore investment over the

next 20 years. Under the policy, dedi-

cated AVGC-XR parks will be developed with worldclass infrastructure and special hubs will come up in various parts of the city, including Mumbai, Navi Mumbai, Pune, Satara and Nagpur.

Last year, the Union Cabinet had approved a proposal to set up the National Centre of Excellence (NCoE) for Animation, Visual Effects, Gaming, Comics and Extended Reality (AVGC-XR) on lines of the IITs and IIMs to anchor the animation ecosystem in the country.

The centre, which will come up in Mumbai, will also have regional centres in other cities.

"We plan to establish one of the regional centres under the NCoE here in Delhi. The government will approach the Centre at an opportune time," the official said.



New Delhi, Oct 11: The US "values" its relationship with India, US Ambassador-designate Sergio Gor said Saturday after holding talks with Prime Minister Narendra Modi that focused on cooperation in areas of defence, trade and critical minerals.

Gor landed in New Delhi this morning on a six-day visit that came amid continuing strains in the bilateral relations over Washington's imposition of 50 per cent tariffs on Indian exports and a host of other measures taken by the Trump administration that hit Indian interests. The Ambassador-designate held talks with External Affairs Minister S Jaishankar, National Security Advisor Ajit Doval and Foreign Secretary Vikram Misri before meeting

PM Modi.

In a post on "X", Modi said he was "glad" to receive Gor.

"I'm confident that his tenure will further strengthen the India-US Comprehensive Global Strategic Partnership," prime minister said.

Gor said his meeting with Modi focused on defence, trade, technology and critical minerals, adding President Donald Trump considers Modi as a great leader and personal friend. "We had a great series of meetings including with Foreign Secretary Misri, with external affairs minister Jaishankar and National Security Advisor Doval," Got told PTI and two other media outlets.

"We just finished an incredible meeting with Prime Minister Modi where we discussed bilateral issues including defence, trade and technology," he said



"We also discussed the importance of critical minerals and our nations," Gor added.

"President Trump considers Modi a great and personal friend. In fact, just before I left for New Delhi, they had an incredible phone call. That is something that will continue over the weeks and months ahead," Gor said.

The US ambassador-designate said he was confident that the India-US relationship would continue to grow. "It's an honour to serve as President Donald Trump's ambassador to India and I look forward to this very important relationship. And (it will) continue to grow and deep en," he said. Gor, accompanied by Deputy Secretary for Management and Resources Michael J Rigas, is visiting New Delhi days after his appointment as the US envoy to India was confirmed by the Senate. Following his meeting with Gor, Jaishankar said the discussions focused on the India-US relationship

and its global significance.

Meanwhile, Kumar's family objected to shifting the body of the IPS officer from the Government Multi-Speciality Hospital in Sector 16 here to the Post Graduate Institute of Medical Education and Research (PGIMER) Saturday, "without their knowledge".

Unless justice is delivered to the family and action is taken in the matter, post-mortem and cremation will not be allowed. said Kumar, who is a member of a 31-member committee formed by the outfit to ensure that the family's demands and concerns are addressed by authorities.

Another representative of the committee told reporters here that DGP Haryana Kapur and outgoing Rohtak SP Narendra Bijarniya should be terminated from service and arrested.

Prominent leaders who met



Fishermen protest over arrest by SL Navy

Rameswaram (Tamil Nadu): Fishermen hailing from the district Saturday observed a token strike condemning the arrest of 47 fishermen and seizure of boats by the Sri Lankan Navy. The development comes in the wake of the Tamil Nadu government seeking the intervention of the Centre for the release of the fishermen. "Yes, they observed a token strike near the Harbour," an official of Rameswaram Town Police Station told PTI. Chief Minister MK Stalin, October 9, urged External Affairs Minister S Jaishankar to expeditiously secure the release of 47 fishermen apprehended by the Navy of the Island Nation. As of October 9, a total of 242 fishing boats and 74 fishermen from Tamil Nadu remain in Sri Lankan custody, the chief minister had said in the letter.

Greens urge Maha to save flamingo lake

Thane: Environmental groups have urged Maharashtra Chief Minister Devendra Fadnavis not to entertain city planner CIDCO's proposal to revoke the conservation reserve status of the DPS flamingo lake, a crucial habitat for migratory birds in Navi Mumbai. NatConnect Foundation appealed to the government to save the flamingo abode and protect the city's fragile biodiversity from being destroyed in the name of development. The Foundation claimed that CIDCO, at its board of directors meeting April 30, passed a resolution authorising its managing director to take up the issue with the government and has since expedited its efforts to get the lake "de-reserved."

Girl child vulnerable in digital era: CJI Gavai

Emphasising the need for specialised training, the CJI said institutions, policy frameworks and enforcement authorities must, therefore, be attuned to the realities of the times

New Delhi, Oct 11: Chief Justice of India (CJI) BR Gavai Saturday flagged the vulnerability of a girl child in the digital era due to online harassment, cyberbullying and digital stalking as well as the misuse of personal data and deepfake imagery, and called for the enactment of specialised statutes and training of law enforcers and decision makers.

The CJI voiced his concern while speaking at the national annual stakeholders consultation on "Safeguarding the Girl Child: Towards a Safer and Enabling Environment for Her in India", organised under the aegis of the Juvenile Justice Committee (JJC) of the Supreme Court, in association with UNICEF. India.

He said despite constitutional and legal guarantees, many girls across the country continue to be tragically denied their fundamental rights and even basic necessities for survival and this vulnerability exposes them to disproportionately high risks of sexual abuse, exploitation and harmful practices, such as female genital mutilation, malnutrition, sex-se-



lective abortions, trafficking and child marriage against their will.

'To secure her safety is not merely to protect her body, but to free her spirit. To create a society where she can hold her head high in dignity and where her aspirations are nourished by education and equality.... We must confront and overcome the deep-rooted patriarchal customs that continue to denv girls their rightful place," the CJI said.

Recalling Rabindranath Tagore's poem, "Where the Mind is Without Fear", Justice Gavai said it captures the very essence of what is sought to be achieved in safeguarding the girl child.

"That vision remains incomplete so long as any girl in our country lives in fear -- fear of violence, of discrimination, or of being denied the chance to learn and to dream," he said, adding that only when every girl child grows in an environment of freedom and respect can it be said with conviction that the country has awakened into that "heaven of freedom" of which

Tagore so beautifully spoke. Calling for a deeper examination of the social, economic and cultural barriers that continue to impede girls' lives, the CJI, in the presence of Union Minister for Women and Child Development Annpurna Devi and Cynthia McCaffrey, the country representative for UNICEF-India, said the threats faced by young girls are no longer confined to physical spaces, they extend into the vast and often unregulated digital world.

"Furthermore, in today's technological era, where innovation defines progress, it is important to recognise that technology, though empowering, also brings new vulnerabilities, especially for the girl child," he said, adding, "From online harassment, cyberbullying and digital stalking to the misuse of personal data and deepfake imagery, the challenges have evolved in both scale and sophistication.

Emphasising the need for specialised training, the CJI said institutions, policy frameworks and enforcement authorities must, therefore, be attuned to the realities of the times.

"Training programmes for police officers, educators health professionals and local administrators should consequently incorporate a sensitive approach, equipping them to respond with empathy, nuance and contextual understanding, he said.

Oppn parties mull sending delegation to Ladakh

New Delhi, Oct 11: Opposition parties are deliberating on sending a delegation to Ladakh, where violence during a protest last month for statehood and tribal status under the Sixth Schedule of the Constitution left four people dead and several injured.

Sources in several Opposition parties confirmed that there have been informal discussions regarding sending a group of leaders to the Union Territory towards the end of October, Parties like the Congress, the CPI(M), the Aam Aadmi Party, the Samajwadi Party, and the Jharkhand Mukti Morcha have held talks on the proposal, they said.

An AAP leader acknowledged that deliberations have been held, but asserted that no final decision has been taken yet. Sources in the CPI(M) and the Samajwadi Party also confirmed that the proposal is under consideration. A senior opposition leader said the matter is being discussed "seriously".

Leh was rocked by widespread violence September 24 during an agitation spearheaded by LAB and Kargil Democratic Alliance (KDA) for statehood and extension of Sixth Schedule safeguards

Opposition leaders have been vocal in condemning the deaths during the protest and the subsequent arrest of climate activist Sonam Wangchuk under the stringent National Security Act (NSA).

They have also supported the demand of the Apex Body Leh and the Kargil Democratic Alliance for a judicial enquiry into the firing incident.

The home ministry has accused Wangchuk, who was leading a hunger strike in Leh at the time, of "instigating" the protesters. Wangchuk called off his hunger strike after the incidents of violence. He was detained under the NSA September 26.

NDA, INDIA work on seat-sharing

PK launches campaign from Tejashwi's seat

Patna, Oct 11: The Jan Suraaj Party continued to steal a march, ahead of Assembly polls, over the ruling NDA and the main Opposition INDIA bloc, with its founder Prashant Kishor Saturday launching election campaign from Raghopur, the home turf of RJD leader Tejashwi Yadav.

Senior BJP's leaders of the state, including president Dilip Jaiswal and former provincial chiefs Samrat Choudhary and Mangal Pandey, were camping in Delhi, holding meetings with top leaders as well as alliance partners.

Jaiswal told reporters in the national capital, "It is unfortunate that the social media is replete with imaginary seat-sharing figures. Our ally Upendra Kushwaha has come out with an anguished tweet. Let all be informed that talks are still on and an announcement is likely by tomorrow".

Kushwaha, a Rajva Sabha MP who heads the Rashtriya Lok Morcha, had responded to reports in a section of the media that his party has been asked to settle for a single-digit share of seats of the 243-strong Assembly.

The reports also suggest that the JD(U), headed by Chief Minister Nitish Kumar, and the BJP, will contest almost an equal number of seats, in the range of 101-102, while about 30 will be given

to Union minister Chirag Paswan's Lok Janshakti Party (Ram Vilas)

Another NDA partner Jitan Ram Manjhi, who has been pressing for "at least 15 seats' for his Hindustani Awam Morcha, is said to have been asked to settle for seven or eight.

Jaiswal was also asked whether the "announcement" would be made in Delhi itself or in Patna. He replied, "We will dis

cuss with our allies. Many leaders are away in their constituencies. We will decide on the venue once we get an idea where most of the leaders, whose presence will be required, could be easily available" Late in the evening, JD(U)

working president Sanjay Kumar Jha, who spent the day here re-inducting a former party MP and, thereafter, holding deliberations with the chief minister, left for Delhi.

"Following standard operating procedures, the aircraft landed safely in Chennai and will resume operations only after necessary checks and clearances," the statement added.

UK, US, NATO jets fly near Russian border

London: Britain said Saturday that two Royal Air Force aircraft flew a 12-hour mission earlier this week alongside US and NATO forces to patrol the border of Russia, amid a series of recent Russian drone and aircraft incursions into NATO airspace. "This was a substantial joint mission with our U.S. and NATO allies.' defence minister John Healey said. "Not only does this provide valuable intelligence to boost the operational awareness of our Armed Forces, but sends a powerful message of NATO unity to (Russian President Vladimir) Putin and our adversaries," Healey added. An RC-135 Rivet Joint electronic surveillance aircraft and a P-8A Poseidon maritime patrol plane flew from the Arctic region past Belarus and Ukraine Thursday, supported by a US Air Force KC-135 refuelling aircraft.

At least 60 killed in attack on Sudan

Cairo: Drone and artillery strikes by the paramilitary Rapid Support Forces on a shelter in the Sudanese city of Al Fashir killed at least 60 people Friday night and Saturday morning, according to local activists. Al-Fashir is under siege by the RSF as it struggles to wrest control of the army's last stronghold in the Darfur region. The siege has spread hunger and disease in the city and relentless drone and artillery strikes have hit displacement shelters, mosques, and hospitals and clinics. "Bodies remain under the rubble, and others were burned alive inside the shelter caravans, children, women, and elderly killed in cold blood, the al-Fashir Resistance Committees said in a statement earlier on Saturday.

Unrest continues in Pak; police kill 11

Lahore: Radical Islamist party Tehreek-e-Labbaik Pakistan (TLP) Saturday claimed that police shot dead 11 of its supporters as they attempted to march towards Islamabad to stage a demonstration outside the US embassy against Israel's military actions in Gaza. Authorities in Punjab, however, said that at least 40 policemen were injured in clashes with the TLP that began two days ago amid the group's call for anti-Israel demonstrations. A senior police officer told PTI that violent confrontations broke out on Saturday when 10,000 to 15,000 TLP workers, who had camped overnight at Azadi Chowk in Lahore, resumed their march towards Islamabad in the morning.

US PRESIDENT THREATENS TECH EXPORT LIMITS, NEW 100% TARIFF ON CHINESE IMPORTS STARTING NOV 1 OR SOONER

Washington, Oct 11: President Donald Trump said Friday that he's placing an additional 100 per cent tax on Chinese imports starting on Nov 1 or sooner, potentially escalating tariff rates close to levels that in April fanned fears of a steep recession and financial market chaos

The president said he is imposing these new tariffs because of export controls placed on rare earths by China.

Trump said on Truth Social that "starting November 1st, 2025 (or sooner, depending on any further actions or changes taken by China), the United States of America will impose a Tariff of 100% on China, over and above any Tariff that they are currently paying."

Trump said Friday that "there seems to be no reason" to meet with Chinese leader Xi Jinping as part of an upcoming trip to South Korea and threatened additional tariffs after China restricted exports of rare earths needed for American industry. The Republican president

suggested that he was looking at a "massive increase" of import taxes on Chinese products in response to Xi's moves. It's possible that this could amount to either posturing by the United States for eventual negotiations or a retaliatory step that could foster new fears about the stability of the global economy.

"One of the Policies that we are calculating at this moment is a massive increase of Tariffs on Chinese products coming into the United States of America," Trump posted on his

Truth Social platform. "There are many other countermeasures that are, likewise, under serious consideration.'

The United States and China have been jostling for advantage in trade talks, after the import taxes announced earlier this year triggered a trade war between the world's two largest economies. Both nations agreed to ratchet down tariffs after negotiations in Switzerland and the United Kingdom, yet tensions remain as China has continued to re-

strict America's access to the difficult-to-mine rare earths needed for a wide array of US technologies.

Trump did not formally cancel the meeting with Xi, so much as indicating that it might not happen as part of a trip at the end of the month in Asia. The trip was scheduled to include a stop in Malaysia, which is hosting the Association of Southeast Asian Nations summit; a stop in Japan; and a visit to South Korea, where he was slated to meet with Xi ahead of the Asia-Pacific Economic Cooperation summit.

Trump's threat shattered a monthslong calm on Wall Street, and the S&P 500 tumbled 2.7 per cent on worries about the rising tensions

between the world's largest economies. It was the market's worst day since April.

CHINA'S NEW RESTRICTIONS

On Thursday, the Chinese government restricted access to the rare earths ahead of the scheduled Trump-Xi meeting. Beijing would require foreign companies to get special approval for shipping the metallic elements abroad. It also announced permitting requirements on exports of technologies used in the mining, smelting and recycling of rare earths, adding that any export requests for products used in military goods would be rejected.

Trump said that China is "becoming very hostile" and that it's holding the world "captive" by restricting access to the metals and magnets used in electronics. computer chips, lasers, jet en gines and other technologies.

"I have not spoken to President Xi because there was no reason to do so," Trump posted. "This was a real surprise, not only to me, but to all the Leaders of the Free World.

Sun Yun, director of the China program at the Stimson Center, said Beijing reacted to US sanctions of Chi-

nese companies this week and the upcoming port fees targeting China-related vessels but said there's room for de-escalation to keep the leaders' meeting alive. "It is a disproportional reaction,' Sun said. "Beijing feels that de-escalation will have to be mutual as well. There is room for maneuver, especially on the implementation.

The US president said the move on rare earths was "especially inappropriate" given the announcement of a ceasefire between Israel and Hamas in Gaza so that the remaining hostages from Hamas' Oct 7, 2023, attack can be released. He raised the possibility without evidence that China was trying to steal the moment from him for his role in the ceasefire, saying on social media, "I wonder if that timing was coincidental?

There is already a backlog of export license applications from Beijing's previous round of export controls on rare earth elements, and the latest announcements "add further complexity to the global supply chain of rare earth elements," the European Union Chamber of Commerce in China said in a statement.

The outbreak of a tariff-fueled trade war between the US and China initially caused the world economy to shudder over the possibility of global commerce collapsing. Trump imposed tariffs totalling 145 per cent on Chinese goods, with China responding with import taxes of 125 per cent on American products.

Israel strikes south Lebanon

Beirut, Oct 11: Israel carried out intense airstrikes on southern Lebanon early Saturday, killing one person, wounding seven and briefly cutting a highway that links Beirut with parts of south Lebanon, the Health Ministry said.

The pre-dawn airstrikes on the village of Msayleh struck a place that sold heavy machinery, destroying a large number of vehicles. A vehicle carrying vege tables that happened to be pass ing by at the time of the strikes was hit, killing one person and wounding another, according to Hezhollah's Al-Manar TV

The Health Ministry later said that the one slain was a Syrian citizen, while the wounded were a Syrian national and six Lebanese, including two women. The Israeli military said it struck a place where machinery was stored to be used to rebuild infrastructure for the militant Hez bollah group. Since the 14-month Israel-Hezbollah war ended in late November with a US-brokered ceasefire. Israel has carried out almost daily airstrikes killing dozens of people. Israel accuses Hezbollah of trying to rebuild its capabilities after the group suffered heavy losses during the war.

Earlier this month, the UN human rights chief, Volker Turk, called for renewed ef forts to bring a permanent end to hostilities in Lebanon following the war. He said that until the end of September, they have verified 103 civilians killed in Lebanon since the ceasefire.

US govt shutdown triggers mass layoffs

Firings of federal workers begin as White House seeks to pressure Democrats in government shutdown

Washington, Oct 11: President Donald Trump Friday blamed Democrats for his decision to lav off thousands of workers across the US government as he followed through on his threat to cut the federal workforce during the government shutdown.

Job cuts were under way at the Treasury Department, the US health agency, the Internal Revenue Service and the departments of education, commerce, and Homeland Security's cybersecurity division, spokespeople said, but the total extent of the layoffs was not immediately clear. Roughly 300,000 federal civilian workers had already been set to leave their jobs this year due to a downsizing campaign initiated earlier this year by Trump.

"They started this thing," Trump told reporters during an event in the Oval Office, calling the job cuts "Democrat-oriented." Trump's Republicans hold majorities in both chambers of Congress, but need Democratic votes in the US Senate to pass any measure that would fund the government.

Democrats are holding out for an extension of health-insurance subsidies, arguing health costs will increase dramatically for many of the 24 million Americans who get their coverage through the Affordable Care Act.

Trump has repeatedly threatened to fire federal workers during the shutdown standoff, in its 10th day Friday, and has suggested his administration will aim primarily at parts of the government championed by Democrats.

Trump has also ordered the freezing of at least \$28 billion in infrastructure funds for New York, California and Illinois - all

home to sizable populations of Democratic voters and critics of

the administration. The Justice Department said in a court filing more than 4,200 federal employees had gotten layoff notices at seven agencies, including more than 1,400 at the Treasury Department and at least 1,100 at the Department of Health and Human Services.

DEMOCRATS SAY THEY WON'T RELENT

Democrats said they will not cave to Trump's pressure tactics. "Until Republicans get serious, they own this - every job lost, every family hurt, everv service gutted is because of their decisions," Senate Democratic Leader Chuck Schumer said. Labor unions representing federal workers have sued to stop the layoffs, saying they would be illegal during a shutdown.

The administration said in a Friday court filing that the unions' request should be denied because they lack the legal right to sue over federal personnel decisions. A federal judge is due to hear the case October 15.

The government is required by law to give workers 60 days' notice ahead of any layoffs, though that can be shortened to 30 days.

B'desh court to indict pregnant Indian woman

Dhaka, Oct 11: A court in Bangladesh is set to indict a pregnant Indian woman and three others on charges of entering the country illegally, a move that could pave the way for their repatriation months after they were reportedly pushed in by Indian law enforcement agencies suspecting them of being Bangladeshi nationals, officials said

'Senior judicial magistrate Ashraful Haque has set October 23 for the hearing on charge framing against Sonali Khatun and the three others, alongside two infants. They have been languishing in jail for the past four months," Chief Public Prosecutor (northwestern) Chapai Nawabganj M Abdul Wadud

Wadud said if they plead guilty to the charges during the hearing, it would pave the way for their repatriation. He added that they are "likely to" plead guilty.



France's re-appointed PM Lecornu calls for calm

Paris: France's newly re-appointed prime minister acknowledged Saturday that there weren't a lot of candidates for his job — and that he might not last long in the post given the country's deep political divides. Sebastien Lecornu, renamed by President Emmanuel Macron late Friday after a week of political chaos, called for calm and for the support of political parties to produce a budget for the European Union's No 2 economy before looming deadlines. His appointment is seen as Macron's last chance to reinvigorate his second term, which runs until 2027. His centrist camp lacks a majority in the National Assembly



and he is facing increasing criticism even within its ranks. But rivals from far right to far left slammed Macron's decision to rename Lecornu. France's fourth prime minister in barely a year. France is struggling with mounting economic challenges and ballooning debt, and the political crisis is aggravating its troubles and raising alarm across the European Union. "I don't think there were a lot of candidates." Lecornu told reporters Saturday during a visit to a police station in the Paris suburb of L'Hay-les-Roses. Lecornu, who resigned Monday after just a month on the job, said he agreed to come back because of the urgent need to find financial solutions for France. Over the past year, Macron's successive minority governments have collapsed in quick succession, leaving France mired in political paralysis as it faces a debt crisis that has worried markets and EU partners, and a growing poverty rate.

Peru wakes up to seventh prez in less than a decade

Lima (Peru): Peruvians woke up to their seventh president in less than a decade Friday, as 38-year-old José Jerí took the reins of the shaken nation after Congress ousted widely loathed President Dina Boluarte in a lightning overnight impeachment. The young lawyer with scarce political experi ence, who just became president of the Congress in July, said shortly after bein sworn in early Friday that he would see reconciliation," tackle Peru's runaway crime and ensure "neutrality" in elections when Peruvians elect a new presi



dent in April. Lawmakers had set up a debate and impeachment trial late Thursday in the 130-member unicameral Congress after voting to accept four requests for a vote to remove Boluarte from office over what they said was her government's inability to stem crime. They requested that Boluarte come before them shortly before midnight to defend herself. but when she did not appear they immediately voted to oust her. In short order, 124 lawmakers voted just past midnight to impeach Boluarte. There were no votes against the effort, the ninth attempt to remove her. The shocking turn of events came just hours after a man opened fire at a concert in the capital, injuring five and inflaming anger over crime roiling the country.

Markets recorded fourth largest fund raise via IPO

New Delhi, Oct 11: Indian markets recorded the fourth largest fund raise via the initial public offering (IPO) route in CY 2025, accumulating ₹1.26.096 crore (\$14.2 billion), according to Bernstein, a joint venture between AllianceBernstein and Societe Generale. AllianceBernstein and So-

ciete Generale is widely recognised as a premier global equity research and brokerage firm, with a trading platform that spans Europe, US, Asia, and the West Asia. US led with ₹4,69,752 crore

(\$52.9 billion), followed by Hong Kong ₹2,07,792 crore (\$23.4 billion) and China ₹1,43,856 crore (\$16.2 billion).

In rupee terms, 74 companies have raised ₹85,241 crore (\$9.6 billion) from primary markets in CY25, excluding three major IPOs, WeWork India, Tata Capital, and LG Electronics India. which together aim to raise nearly ₹30,000 crore (\$3.38 billion), Bernstein said. "The primary market mop-

up in CY25 marks the third highest in the past five years, behind ₹1,59,784 crore (\$17.99 billion) via 91 offers in 2024 and ₹1,18,723 crore (\$13.37 billion) via 63 offers in 2021," it said.

Bernstein noted that this activity is significant as for eign institutional investors (FIIs) have withdrawn nearly ₹1,59,840 crore (\$18 billion) fron India's secondary markets this year while investing ₹44,400 crore (\$5 billion) in primary markets, reflecting a clear dis tinction between primary and secondary market behaviour.

Moreover, analysis of 161 companies listed since January 2024 shows that IPO invest ments have generally outper formed broad market indices beating Nifty returns in five of the last seven quarters, with 61 per cent, outperforming Nifty in the past six months.

Average listing gains stood at 22 per cent, with over 53 per cent delivering double-digit returns. Highlighting the sec toral trends, Bernstein said that 28 IPOs came from con sumer tech, green energy and digital industries. On the other hand, smaller IPOs performed particularly well, with sub-Rs 178 crore (\$20 million).

Indian exporters likely to gain from US-China trade clash

India silver ETFs trade at steep premium amid festive demand

New Delhi, Oct 11: India's silver exchange traded funds (ETFs) are trading at steep premiums over international benchmarks amidst surging festive demand and constrained physical global supply, a report said Saturday

Investment inflows into silver products hit record levels globally in H1 2025, adding about 95 million ounces - exceeding the total inflows of the entire previous year, the report from Axis Mutual Fund said.

That shortage has flowed through to ETFs, which are trading at premiums of about 5–12 per cent over converted LBMA prices inclusive of customs and GST, Axis MF said.


"IMPaCT has been in continuous pursuit to recognise and inspire excellence in sports, besides contributing to the gen-

St Louis (USA), Oct 11: Thirtv years to the day, history was repeated as Garry Kasparov defeated Viswanathan Anand in the 10th game of the Clutch Chess Legends contest to win the match with two games to

It was in 1995 October 10 that Anand took a draw in the 18th game to concede the 20-games Classical World Championship match against Kasparov 7.5-10.5 on the 107th floor of the World Trade Centre in New York.

As per rules, the last two games under blitz time control were still played and Anand pulled back two victories albeit a little too late in the day. The scoreline eventually read 13-11 with Kasparov winning \$78,000, while Anand took home \$66,000

in the \$1,44,000 contest. Leading the match by five points. Kasparov knew that Anand still had a chance to win



the match as the final day had as many as 12 points at stake with each victory worth three

Anand started the day with a hard-fought draw and then seized the initiative early in the second game. However, Kasparov kept himself in contention and a wrong trade by Anand cost the Indian ace dearly as he lost in the queen-and-minorpiece endgame.

Kasparov had already sealed the match with two blitz games still remaining and it was Anand's turn to bounce back as he came back with all guns blazing to win both games.

Kasparov said he was not expecting to win this match but was pleased with the buzz

Speaking about the match and his play, Kasparov, 62, noted, "I think I was more resilient than he (Anand) expected," pointing out that he'd done surprisingly well when both players were low on time.

He also felt that Anand might have had some "psychological discomfort".

Kasparov explained, "His score against me historically is bad, and I think it's somehow probably the ghosts of the past visited him during the games.

National Junior Athletics: Bronze for Odisha's Alokika

Simran faces medals loss after guide Saifi fails doping test

New Delhi, Oct 11: World Para-Athletics Championship's gold-winning sprinter Simran Sharma is likely to lose her medals after her guide Umar Saifi was handed a provisional suspension by the National Anti-Doping Agency (NADA) for failing a dope test

Saifi, who has been the visually impaired Simran's guide for over seven months, has tested positive for Drostanolone, a banned anabolic steroid that helps increase muscle mass. and strength. He won a 200m gold at the Delhi State Open September 7 where this dope test was likely conducted.

Saifi's name appears in the updated list of provisionally suspended athletes issued by NADA Friday. He can appeal against the finding and seek a 'B' sample test. It is not clear why his name did not appear on the NADA website before the World Championships which took place from September 27 to October 5.

Besides the 100m T12 gold, Simran also won a silver medal in the 200m race of the showpiece that was held in India for the first time. The 100m gold was her second suc-



cessive top finish in the world championship.

As per, the International Paralympic Committee rules, Simran could lose her medals if Saifi fails to prove his innocence. 'Yes, there is a big chance of Simran and India losing both medals. The guide is also considered an athlete and part of the event. The guide also gets a medal and certificate though only the medal of the athlete is counted," Indian Para Athletics
