Winter session of Majhi woos tribals, calls BJD 'sinking boat' Parl from Dec 1-19

New Delhi, Nov 8: The Winter session of Parliament will be held from December 1 to 19. Union Parliamentary Affairs Minister Kiren Rijiju announced Saturday, in what the Opposition has described as an unusually delayed and truncated session.

The three-week session will have 15 sittings in all and is expected to be stormy as it comes in the midst of the Election Commission's Special Intensive Revision (SIR) of electoral rolls in 12 states and Union territories, an exercise against which several Opposition parties have raised objections.

The Monsoon session of Parliament also saw vociferous protests by several Opposition parties over the SIR in Bihar that led to daily disruptions in Parliament.

'The Hon'ble President of India Smt. Droupadi Murmu ji has approved the proposal of the Government sion of Parliament from 1st December 2025 to 19th December 2025 (subject to exigencies of Parliamentary business)," Rijiju said on X.

Looking forward to a constructive and meaningful Session that strengthens our democracy and serves the aspirations of the people, he said.

Pakistan to create new post of Chief of Defence Forces

Islamabad, Nov 8: Pakistan Saturday brought in a Constitutional amendment to create a new post of Chief of Defence Forces to ensure greater coordination and unified command among the three services. The 27th Constitutional Amendment bill presented in parliament proposes changes to Article 243 of the Constitution. which deals with the armed forces among other issues.

Under the amendment bill. the President will appoint the Army Chief and the Chief of Defence Force on the advice of the Prime Minister. The Chief of Army Staff, who will also be the Chief of Defence Forces, will appoint the head of the National Strategic Command in consultation with the Prime Minister.

Nuapada, Nov 8: Chief Minister Mohan Charan Majhi, during his campaign for the Nuapada bypoll, Saturday wooed tribal voters. targeted opposition BJD president Naveen Patnaik and called the former CM's party a "sinking boat".

Tribals constitute over 35 per cent of Nuapada's over 2.53 lakh voters.

Majhi went to Sunabeda Wildlife Sanctuary, offered prayer before their presiding deity Goddess Suna Dei, had lunch with a tribal family and said he could understand the plights of people living in hills. 'As a tribal, I can under-

stand their problems. The tribal families, even after 78 years of Independence, are deprived of basic facilities like drinking water, electricity and roads in their villages. I will ensure all



such facilities," Majhi told a gathering. Claiming that he is the first chief minister of Odisha who visited the tribals in Sunabeda Wildlife Sanctuary, Majhi blamed Patnaik for their plight.

"What has Naveen Babu done for you during his 24 years of governance? He does not understand your

language. Tribals cannot speak in Hindi or English,' Majhi said. The CM assured the people that Sunabeda will witness development with establishment of a college and upgradation of the existing government hospi-

After visiting Sunabeda area, Majhi led a four-hour long roadshow from Khariar Road to Nuapada from 4pm to give a push to the BJP's campaign before it ends Sunday. Addressing a public meeting at Nuapada, he claimed that the BJD has no future in Odisha's politics.

Will you vote for a party which is a sinking boat? The leaders of BJD have been quitting the party one by one including Jay Dholakia. The leaders in BJD do not get due respect, because of which they are quitting the party," Majhi said.

Jay Dholakia, son of BJD MLA Rajendra Dholakia whose death necessitated this bypoll, was tipped to be the candidate of the regional outfit. He, however, joined the BJP, leaving the BJD red-faced

Majhi described the BJP candidate as the "suputra" (good son) of Rajendra Dholakia. Earlier, BJD women leaders had dubbed Jay as the "kuputra" (bad son) of the deceased MLA and accused him of getting sold to BJD. To buttress his allegation

that opposition party leaders do not get respect from the party, the CM claimed that Snehangini Chhuria, the BJD nominee, was not found during Patnaik's roadshow Friday.

Jajpur woman dies after family planning surgery

Jajpur, Nov 8: Tension prevailed at a government-run hospital in Jajpur district Saturday after family members of a deceased woman accused the doctor and staff of the health facility of a faulty sterilisation surgery leading to her death.

The incident took place at Madhuban under Kuakhia police limits in the district.

The agitators staged a demonstration in front of the entrance of the Community Health Centre with the body, demanding stern action against the doctor who conducted the surgery on the 30-year-old woman and an ASHA who brought her to the CHC for a family planning operation.

Mamata Malik, a resident of Kandasara village in the district, was brought to Madhuban CHC where a doctor gery on her Friday afternoon

The condition of the woman became serious after the surgery, and the doctor asked her husband to shift the pa tient to SCB Medical College and Hospital in Cuttack.

She, however, died or the way to the hospital in Cuttack in an ambulance Friday night. Following her death, family members and villagers protested in front of the hospital gate Saturday with the body.

"Our ASHA didi brought my wife to Madhuban CHC for a family planning operation. An inexperienced doctor of the CHC conducted a faulty surgery which led to her death. We want stern action against the doctor and the ASHA didi," said Ashwani husband of the deceased.

Cuttack, Nov 8: At least three persons, including a minor boy, were killed and three others seriously injured when the balconv of an old apartment building collapsed and fell on an adjacent house here Saturday, police said.

Fire Service personnel rescued all six persons and took them to SCB Medical College and Hospital, where doctors declared three of them dead, police said.

Cuttack-Barabati MLA Sofia Firdous, who visited the spot and met the family members of the victims, said, "There are several unsafe buildings in the city, and those should be immediately sealed and repaired."

The administration must inquire into the circumstances that led to the death of three persons, she said.

2 women defy norms to marry in Sundarbans temple; village rallies behind them

Kultali (WB), Nov 8: In a quiet hamlet deep inside Sundarbans, where mangrove forests guard a maze of rivers and traditions run long and deep, two young women stood before a village temple and chose each other for life.

Professional dancers Riya Sardar and Rakhi Naskar, both in their early twenties, tied the knot at the Paler Chak temple in Jalaberia in Kultali block, November 4 in a ceremony that drew hundreds of villagers who ululated, blew conch shells



and blessed the couple.

In a country where same sex marriages have no legal sanction and the issue still pending before the Supreme Court, the wedding was a quiet rebellion rooted more in affection than activism. It unfolded in a socially conservative part of the Sundarbans, where such public assertions are unusual. Yet on that afternoon,

the temple courtyard shimmered with colour and curiosity as Riya, dressed as the bride, and Rakhi, wearing a groom's crown, exchanged garlands (mala badal) and took sacred vows. A priest conducted all rituals. Villagers watched, some surprised, many silently

"We have taken vows to become life partners," Riva. from Rameshwarpur in Mandirbazar, told reporters. Rakhi, who hails from

Bakultala police station area, said, "We are adults. We can decide our lives. Why should gender matter while choosing a life partner?" Riya said she lost her par-

ents at a young age and was raised by her aunt Kavita Koyal, who was stunned at first but did not oppose her decision. She studied up to high school and works as a dancer.

Rakhi, who studied up to Class IX and performs in a local dance troupe, said, "Despite pressure from my farming family, I decided to marry only the person I truly love."

Mumbai: Nawazuddin Siddiqui, celebrated for his raw and powerful performances, recently opened up about one of the darkest phases of his life — the years before 2012, when he battled rejection, despair, and suicidal thoughts. 



Man held in City for ₹55 lakh land fraud

Bhubaneswar: A man was arrested in the City for allegedly cheating another person of ₹55 lakh in a land deal. The accused has been identified as 38-year old Rakesh Ranjan Beura, a resident of Bhubaneswar. According to police reports. Rakesh introduced himself as a land broker and lured the complainant into purchasing about 23.65 acres of land in the Daruthenga and Jhujugada areas on the outskirts of Bhubaneswar. Trusting his assurances, the complainant entered into an agreement on October 11, 2025, and paid ₹55 lakh to Rakesh for facilitating the deal. However, even after a considerable time, Rakesh failed to hand over the land documents or deliver possession of the property. The complainant later discovered that he was negotiating the sale of the same parcel of land with another developer. Following the complaint, police launched an investigation, arrested Rakesh, and forwarded him to court. Further investigation revealed that he had been involved in similar fraudulent activities earlier, with a previous case already registered against him at Badagada Police Station. Laxmisagar Police has booked him under Sections 319(2), 318(4), 336(3), and 340(1) of the Bharatiya Nyaya Sanhita (BNS).

Chit fund: ED seizes ₹84L, car in Berhampur

New Delhi, Nov 8: The Enforcement Directorate (ED) has seized unaccounted cash totalling ₹84.20 lakh and a luxury car during searches at four premises in Odisha's Berhampur in connection with a ₹69-crore chit fund scam, an official said Saturday.

ED, Bhubaneswar conducted search operation Thursday at four premises under the provisions of Prevention of Money Laundering Act (PMLA), 2002 as part of an ongoing money laundering investigation against the Green India Infra Projects Limited and its related entities

The ED case is related to an FIR (RC.11/S/2014) registered June 4, 2014 against the Green India Infra Projects Limited and its promoters in connection with multi crore rupees chit fund scam.

It was alleged that various group companies had collected the money from hundreds of gullible investors and ulti-



mately cheated them

The said amounts were collected under the guise of huge returns or to provide flats in 'Green Paradise Project'. However, the company neither returned the invested amount, nor gave any flats to the in-

On being asked to refund the money paid to the alleged company by the investors, the MD of the company refused to refund the amount paid by them as advance and threatened them. Thus, the depositors have been cheated by the said company to the tune of ₹69 crore, the ED said.

During investigation, it was found that the accused persons had laundered the proceeds of crime and invested the same in the various immovable properties and other assets, the state-



Pitabas murder: Kin alleges death threats

Berhampur: The family of slain lawyer and RIP leader Pitabas Panda has alleged receiving death threats and pressure to withdraw the murder case Panda's wife, Susmita Panda, made the revelation during a presser at her residence Saturday. She alleged that a few days back, the accused persons' associates had made threatening phone calls twice to Panda's son and brother, hurling abuses and warning them to withdraw the case. "They threatened to kill me and my son if we don't withdraw the case " Susmita said, adding that the family is living in fear. She said the matter has been reported to senior police officials and a written complaint has been filed at Baidyanathpur police station. Susmita added that after her husband's death. their family friend Bikram Panda had visited them, promising protection. But later, police arrested him for his alleged involvement in my husband's murder, which shocked us deeply," she said. Expressing concern for her family's safety, Susmita urged the court not to grant bail to any of the accused. Pitabas's elder brother, Prakash Panda, and younger brother, Purnachandra Panda, were also present at the press conference. Police have registered a case based on their complaint, said Berhampur SDPO Priyasranjan Chhotray, adding that security has been provided to the family. Notably, lawyer Pitabas Panda

INDEPENDENT VOICES CAN **SHAPE NARRATIVES: EXPERT**

Nuapada, Nov 8: In every election, beyond the banners of major political parties, there stand individuals who contest not for ideology or symbols, but for conviction. Independent candidates — often dismissed as long shots — quietly play an influential role in shaping democratic outcomes across India

In constituencies like Nuapada, their presence is nothing new. Late Rajendra Dholakia, a towering figure in the region's political landscape, began his journey as an independent candidate and went on to win his first election in 2004 without the backing of any party. His victory was a testament to personal credibil-

ity and grassroots connection — proof that genuine public trust can outweigh party machinery. After joining BJD, he won thrice from the constituency, leaving behind a legacy of accessibility and public service that still resonates in the

This time, as Nuapada votes in a crucial byelection November 11, the poll paper tells its own story — 14 candidates, including eight independents, are in the fray. Their participation

underscores growing public disillusionment with traditional party politics and a desire for more grounded, people-centric leadership. Among them is Hemant Tandi, an advocate who decided to contest after decades of observing political stagnation. 'For the last 35 years, I have seen people and their parties come and go without doing anything. Farmers don't get help, water scarcity continues, and tivated me to fight this election for my right and for the people's right," Tandi said. He added sharply, "If you stay in power for long, you become corrupt and that's what has happened.

doing nothing." While many independents are contesting to bring change, some have taken a different path.

Bhakta Bandhu Dharua, a noted tribal leader known for his work with kendu leaf workers recently announced his mora support for BJP candidate Jay Dholakia. Dharua made the dec laration in the presence of BJP Odisha in-charge Vijaypal Singh Tomar and senior leader Lata Usendi, expressing his belief that his community's interests align with Dholakia's agenda.

However, not all independents agree with such alignments Ashraya Mahananda, another independent candidate in the fray, voiced his disappointment

"This doesn't help our cause People like us are fighting honestly to raise real issues, but when some in dependents star aligning with par ties, it creates a bad image for genuine candidates,'

he said. Mahananda believes that de velopment has largely benefited politicians, not the public. "Development is happening for the benefit of politicians, not for people. But there are still good peo-

battle," he added. Confident in his independence, Mahananda said, "As an educated and independent candidate, you can do a lot on your own - you don' need a party to serve the people. Earlier, Mahananda had also contested from Birmaharajpur and Rairakhol. Political analyst Naba Kishore Pujari said such independent voices, even when they don't secure victory, can shape narratives and influence vote margins, forcing major parties to address local concerns like irrigation, jobs, and healthcare. Beyond numbers their presence embodies the spirit of representation — a re minder that democracy belongs

Countering criticism of being an 'outsider', Chhuria retorted, "This is my uncle's home. How can I be an outsider here?" She credited Naveen's leadership for Nuapada's development, citing welfare schemes such as Biju Swasthya Kalyan Yojana and Anwesha, which have benefitted rural and tribal populations.

"Under our government, Maoist threats have been eliminated, and peace returned to Nuapada," she added.

Chhuria also accused the BJP-led government in the Centre of neglecting farmers. alleging urea shortages and halted scholarships. "Farmers and students are suffering under BJP's rule," she claimed.

On the other end of the triangle stands Ghasiram Maihi. a 62-year-old tribal leader with over four decades of grassroots activism. Majhi has contested for the Nuapada seat multiple times — three times for Congress and once as an indepen-

dent candidate in 2024, when he secured over 50,000 votes and finished second.

"I am more confident than ever this time," Majhi told Orissa POST. "I am more local than both other candidates and have the backing of tribals, OBCs, and minorities," he said.

State Congress leaders, including Bhakta Charan Das and Suresh Routray, and several MLAs from Chhattisgarh have campaigned for Majhi. AICC General Secretary Sachin Pilot will campaign for the party's Nuapada candidate Sunday.

While the bypoll carries state-wide implications, local concerns remain central to voter sentiment. Migration and unemployment continue to haunt Nuapada's rural belts, with thousands of families moving seasonally to other states in search of work. All major parties have promised job creation and better imple-

mentation of MGNREGA. Infrastructure and development gaps are also in focus. The government has announced projects worth over

Rs 1,100 crore. However, Opposition parties have dubbed it as 'poll-timed promises'. Villagers cite erratic electricity and poor healthcare infrastructure as everyday challenges.

Agriculture and irrigation are pressing concerns. Erratic rainfall, limited canal coverage, and dependence on borewells have made farming uncertain. Farmers seek assured irrigation and better market access for their produce.

Political analyst Kishore Pujari describes the byelection as a high-stakes triangular contest and Odisha's first major electoral test since BJP's 2024 Assembly victory.

"With 14 candidates in the fray, three frontrunners emerge - BJP's Jay Dholakia, BJD's Snehangini Chhuria, and Congress's Ghasiram Majhi. While campaigning has been intense, marked by roadshows and personal accusations, substantive issues like irrigation, healthcare, and migration have largely taken a backseat," Pujari noted.

On the candidates, he said, "Jay combines youth with sympathy votes after his father's demise, but his lack of political experience could be a liability. Chhuria brings experience and the emotional connect of the BJD supremo, yet her outsider tag could limit appeal. Maihi is a grassroots tribal leader with a clean image, but Congress' weak structure makes him a long shot."

Asked who has the upper hand, Pujari observed, "BJP holds an edge in certain blocks and may secure sympathy votes. But BJD's massive rallies and loyal party workers make it a close contest. Congress may influence tribal votes, creating the possibility

Nuapada, located in Odisha's western frontier adjoining Chhattisgarh, was once part of the Maoist-affected 'Red Corridor'. In the early 2000s and 2010s. several parts of the district witnessed Maoist activity that disrupted road construction, forest development, and electioneering.

Over the years, increased policing, local cooperation, and state welfare outreach helped neutralise the threat. Today, Nuapada is largely peaceful, but the legacy of those years still shapes local consciousness, with voters valuing sta bility and development. Both BJD and BJP have sought to take credit for the restoration of peace, while Congress points to the need for inclusive growth.

Nuapada's social fabric adds another layer of complexity to the contest. Situated along the Odisha-Chhattisgarh border, the constituency has a significant Hindi-speaking population, many of whom migrated from neighbouring Chhattisgarh and Madhya Pradesh. Their voting preferences often sway between parties, making them an influential bloc in a constituency with over 2.5 lakh voters.

Alongside the 40 per cent tribal electorate, OBC communities—particularly Yadays and Hindi-speaking traders and farmers hold the key to victory. Issues like irrigation, forest rights, farmer distress, and employment dominate voter concerns.

Boy brutally assaulted by Bhadrak police

Tihidi, Nov 8: In yet another incident of police brutality, a minor boy from Narendrapur village under Pirahat police limits in Bhadrak district was beaten up by men in khaki at the police station,

his parents alleged Friday. The matter came to the fore after the boy's father. Sarat Majhi, lodged a complaint with the Odisha Human Rights Commission (OHRC), demanding justice and disciplinary action against the accused officers Friday. Police officials not only beat up his son but also asked him to open his pant and shirt.

In the complaint, Sarat alleged that the incident stemmed from a mobile phone theft case registered October 27, in which a local woman had named his 14-year-old son, Deeptikant, as a suspect. The following day, Sarat filed a counter-complaint.

However, police reportedly called Sarat over phone and asked him arrive with his son at the police station for questioning by 8 pm, November 2. IIC Rojalin Behera questioned both parties regarding the boy denied involvement, a sub-inspector allegedly dragged him outside and brutally assaulted him. Another staffer reportedly hit the boy on the chest with a pipe and verbally abused him. The family claimed the boy was also threatened to remove his shirt and pants during the assault for which he had to unbutton his shirt. However, IIC Behera denied the allegations, stating that the minor boy and his father were only called for questioning regarding the theft case and that

The first amendment of the United States constitution reads as

'Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances'.

The language seems slightly archaic because it was written in 1789, but is clear enough for us to understand that freedom of speech cannot be curtailed. It can however be restricted, for example when related to threats of violence or pornography.

In 2010, the US Supreme Court eliminated restrictions on the funding of elections, interpreting this as a First Amendment free speech right. Corporations and wealthy individuals were free to influence elections, by creating political action committees that spend money on advertising. This was the outcome of the famous Citizens United case, which fatally damaged US democracy because both their major political parties are now permanently influenced by corporate interests. If the reason you won your seat is your donors, then it is likely that your actions in office will also be influenced by them. This seems to have become inescapable in US politics. However, there is another way of doing politics, and though its formula

is simple, its execution is very hard. To attempt something that carries a high failure rate takes a certain sort of determination and outlook. To succeed in it is truly remarkable. An example of this comes to us from the recent New York election for mayor. There were two different approaches to contesting from the two major candidates. The first approach is the one preferred by both major political parties and their candidates, which is to win by raising more money than the opponent. This money is then deployed chiefly on messaging: advertising on television and mailers to overwhelm the voter with positive impressions about the candidate paying for the ad and negative ones about the opponent.

The more ads one can put out the greater the chance of success. A report from 2018 headlined 'How money affects elections' found that more than 90% of the time, the candidate who raised and spent more than their rival won their race for a seat in Congress (their version of the Lok Sabha).

One major candidate in New York, Andrew Cuomo, took this approach and raised more than five times the money his opponent had.

The second approach, the reason this piece is being written, is to convince voters not through advertising but through personal conversations. This is effective but does not seem to be scalable. It seems especially absurd to attempt in a general election where the voters number in the millions. The scale has to be staggering and the number of people required to do this would surely cost more than advertising. And it would be difficult for these people to open conversations with strangers. because many at home would either not answer the door or ask the person to leave, or not stop on the street when hailed. Even if they chose to speak then it would

not be easy to convince them to vote for the

candidate. After all this, the success rate is likely worse than 1 in 10. Meaning that for every person that is convinced into voting for the candidate, another 10 slam the door or say they will support the other side or just walk on.

How would one keep these workers motivated enough to keep attempting this and not just stay at home or in a cafe and pretend that they had been knocking on doors or stopping strangers on the street? These are the reasons this approach is not preferred and why candidates choose to just raise more money.

It can only succeed under certain conditions: First, that the message is compelling to a large number of potential voters. Second, that the workers are highly motivated and not put off by the high rate of failure. The motivation of the workers here is not money but the cause. It is similar to propagation and proselytising. Third, that there is some mechanism that monitors the engagement and sees it through to voting day. Meaning to repeatedly stay in touch with people once contact is made.

This was the approach used by Zohran Mamdani, the Indian-origin socialist who won and will be New York's mayor. Those who say he is inexperienced and knows little about leadership do not understand that to motivate people to throw themselves into something that has a high rate of failure, and then succeed at it, is the highest expression of leadership. An army of over 1 lakh volunteers trained and led by 700 senior volunteers worked for Zohran. These were mostly young people but also many middle aged and old who gave hours, for many months, doing physical work for their cause.

More than \$40 million was spent by corporates backing Andrew Cuomo to paint Zohran as a terrorist. They lost to the volunteers who were paid nothing.

This win will be studied for a long time because it reduces to bare essence the two approaches to winning elections and shows the limits

It's ironic that while an elaborate Maritime Security Week was organized by the defence forces in Mumbai in the context of GOI's declaration of 2026 as the Year of India-ASEAN Maritime Cooperation, the PM's absence from the most consequential event was lost sight of. Instead, Modi in his virtual address to the 22nd India-ASEAN Summit reaffirmed support for ASEAN centrality and Indo-Pacific cooperation. Even though India had announced the Quadrilateral summit to take place this year in India, the matter was not raised at all though all the Quad leaders were there.

The US-ASEAN summit saw several ASEAN States get Trump-imposed tariffs reduced while there was promise from the ASEAN side for export of rare earth minerals and elements besides market access to agriculture, technology and pharmaceuticals.

It may be noted that while Malaysia supplies 13% of the global demand for critical minerals, China possesses 69%. China used its advantage in this area in agreeing to a one-vear freeze on its ban imposed a month ago on such exports to the US in lieu of Trump softening its tariffs on China to 47%, lower than India and Brazil, while committing to bring down its Fentanyl exports to the US and giving market access to US soyabeans.

In the US-China Summit in Busan, South Korea, Trump gloated about a historic win in his tariff war with China while the latter took asobering posture in standing firm in its strategy to hedge America. This was construed as yet another comedown for Trump (after the Alaska fiasco) in which the US was seen as the weaker side in handling the other two global powers on Ukraine and tariffs. In contrast, the Regional Comprehensive Economic Partnership (RCEP), the largest free trade agreement of the world signed in Nov 2020, held its first Summit where China's primacy in the ASEAN bloc was reaffirmed. India had stepped back from signing the RCEP due to domestic considerations at that time which was perceived as a serious setback to India's efforts towards regional connectivity and multilateralism. It may be noted that China is ASEAN's largest trading partner with bilateral tradeworth \$ 771 billion in 2024 while India's bilateral trade with the group stands at \$106.9 billion for the same period (as the 6th largest trading partner).

Tired of Trump's regular boasts of having been instrumental in stopping the India-Pakistan conflict in May this year and his continuous sermonizing to India to stop buving oil fromRussia, Modi may have decided to avoid meeting the mercurial US President. Besides, unsure of positioning itself in the Great Power matrix and with Putin visiting India later this year for a bilateral summit, it may not have gone down well with the PM's image to be again seen shortchanged by Trump.

As per reports India has reduced imports of Russian oil and in this the recent assertion of Trump would have

amounted to further pressure on India even at the cost of the latter's national interests and geo-strategic options. The game of leveraging its strategic autonomy for hard bargaining with Washington has brought India to a crossroads. Delhi's approach of pleasing all sides and shifting partnerships to gain specific leverage and locational advantages may have gone this far and no farther. At the end of the day India's further alienation in the Global South needs to be critically assessed and its claim for leadership closely viewed notwithstanding the attendant threats that belittle such claims.

India's civilizational links with South East Asia have been forged in history, culture and trade alliances, and that requires careful nurturing. The centrality of AEAN forIndia has to be thus evaluated in the crucible of those long-standing linkages and be broadly reflective of India's global standing. Forging partnerships in the region and beyond is of critical importance with or without the claim of asserting superiority which has to be silently nurtured and worked through with abiding values. As late PM Dr Manmohan Singh in an essay written for the "Raethinking India" series titled India's tryst with the World presciently states, "We should be conscious of the fact that as partnerships gain in importance, India may have to accept greater constraint on the exercise of its strategic autonomy. I would therefore hope that our focus remains on building up our own capabilities for which accelerated growth is indispensable"

Meanwhile, this month elections are being held in Bihar, and next year will witness elections in West Bengal. Assam, Kerala and Tamil Nadu along with Pondicherry.

Though elections theoretically may be a part of the democratic process, it is only money power and muscle power that wins elections. This is very much true in the case of Bihar and West Bengal and some other states, mostly in the north.

Addressing these challenges requires a collective effort from citizens, political parties, and the government. By not promoting transparency, enforcing accountability, and fostering a culture of ethical politics is unfortunate and goes against the very tenets of democratic principles. There is a need to ensure that the voice of every citizen is heard, untainted by undue influences.

Doctor slams poor GLACIER Arunachal begins climate study

Itanagar, Nov 8: The fourth Khangri glacier expedition, a major scientific mission to study the response of Himalayan glaciers to climate change, commenced, Saturday in the Mago Chu basin under the towering Gorichen Mountain in Arunachal Pradesh's Tawang district, an official said.

The week-long expedition, to be continued till November 15, is jointly organised by the Centre for Earth Sciences & Himalayan Studies (CE-SHS) and the National Centre for Polar & Ocean Research (NCPOR), he said.

Led by scientist Dr Parmanand Sharma, one of India's leading glaciologists, the expedition brings together a multidisciplinary team of scientists and engineers from CESHS,



NCPOR, Nagaland University, and North East Regional Institute of Science and Technology (NERIST), CESHS director Tana Tage said. Despite the vast glaciated expanse of the Arunachal Himalayas, scientists point out that very few glaciers in the region have been studied in detail, making it one of the least explored 'white spots' of the Indian cryosphere.

While the state is home to 161 glaciers covering nearly 223 square kilometres across four

major basins - Manas, Subansiri, Kameng, and Dibang-none has undergone long-term fieldbased monitoring to assess their mass balance or glacial

dynamics, the official said. The expedition's primary ob jective is to conduct systematic studies on glacier mass balance and movement to understand their differential responses to

the changing climate, he said. Researchers will also examine the evolution of glacial lakes in the region and assess the potential risks of Glacial Lake Outburst Floods (GLOFs), which pose serious threats to downstream communities and infrastructure.

These glaciated basins are of critical hydrological importance as they form the headwaters of the Brahmaputra river system, a lifeline for millions across the northeastern region. Scientists believe that insights from this expedition will play a key role in understanding the intricate linkages between climate, cryosphere, and hydrology in the Eastern Himalavas, Tage said.

By shedding light on one of the least understood glacial systems in the Indian Himalayas, the expedition is expected to make a significant contribution to the study of climate change impacts and to the long-term water security of the region, he added.

As the mental condition of the woman deteriorated, her father lodged a complaint, following which the police registered a case and launched an investigation.

Police said the sorcerer Shivadas (54), the woman's partner Akhil Das (26) and his father Das (54) were ar-

rested in this regard, Friday. As per the complaint, the partner's mother had brought the sorcerer and made arrangements for the black magic, alleging that the woman's body was possessed by the evil spirits of her de-

ceased relatives. "The process started by 11 am on the day and lasted till night. I fell unconscious at the end," the woman told



the media, Saturday.

She alleged that, amidst the ritual, she was given alcohol, forced to smoke beedi, made to consume "sacred ash", and subjected to other forms of physical torture, in-

cluding burn injuries. The sorcerer, the prime accused in the case, who had gone into hiding after switching off his phone following the incident, was arrested from the Muthoor area in Thiruvalla, police said.

The partner's mother, a co-accused in the case, is currently absconding, they added. The arrested were remanded by a court later, police added.

call regarding the blaze at 10.56 pm, following which multiple fire tenders and firefighting robots were rushed to the spot.

Police cordoned off the area and additional fire tenders were kent on standby to prevent the fire from spreading further.

The fire was brought under control by early morning, a DFS official said. Munna died in the fire while Rajesh was injured in the incident.

CM Gupta said the Delhi government is providing all possible help to the affected families.

"Arrangements for food and drinking water have been made for the affected people. Temporary shelter sites are being established, while the permanent relief centre at Rithala community centre is operational," the chief minister posted.

Delhi's 80-year-struggle to deal in 'humane' ways

New Delhi, Nov 8: The dilemma on humane ways to deal with stray animals in Delhi is not a recent one, with the city's British administrators having to deal with the same issue. Even then, they debated ways to deal with the problem, with some officials suggesting "most painless" ways to kill the ani-

Fast forward eight decades, and the country's top court is grappling with the same issue. It took note of the "alarming rise" in dog bite incidents within institutional areas and directed the forthwith relocation of stray canines to designated

shelters after due sterilisation

and vaccination Friday.

Records from 1946-47 preserved in the Delhi Archives reveal that even then, officials discussed "humane" ways to control the stray dog population.

In a letter dated April 11, 1946, the chief commissioner of Delhi wrote to the deputy commissioner expressing his objection to the use of strychnine poison for killing stray dogs, calling it "inhumane" He described poisoning as the

"most objectionable" and "by no manner or means of a painless death", noting that the animals suffered for nearly 20 minutes before dying. He requested the authorities to adopt "some painless method", suggesting the use of chloroform or electrocution instead.

This debate between what is a "compassionate" way to deal with the problem and what would be regarded as "cruel" exacerbates Delhi's administrators to this day.

While the apex court's approach to sterilisation and relocation may seem a "humane" approach in dealing with the problem, animal rights activists have strongly opposed it, calling the move "cruel" and "detached from reality"

The question of how to balance public safety with compassion for animals remains relevant even today.



NDCs are national climate plans under the Paris Agree ment that set targets to cut emissions and adapt to climate change, guiding global efforts to limit warming to 1.5 degrees

Countries are required to submit their third round of NDCs, referred to as "NDCs 3.0", for the 2031-2035 period this year.



James Watson, DNA pioneer, passes away

Washington: James D Watson, whose co-discovery of the twisted-ladder structure of DNA in 1953 helped light the long fuse on a revolution in medicine, crime-fighting, genealogy and ethics, has died, according to his former research lab. He was 97. The Chicago-born Watson was just 24 turned him into a hallowed figure in the world of science for decades. But near the end of his life, he faced condemnation and professional censure for offensive remarks, including saying Black people are less intelligent than white people. Watson shared a 1962 Nobel Prize with Francis Crick and Maurice Wilkins for discovering that deoxyribonucleic acid, or DNA, is a double helix, consisting of two strands that coil around each other to create what resembles a long, gently twisting ladder. That realization was a break through. It instantly suggested how hereditary information is stored and how cells duplicate their DNA when they divide. The duplication begins with the two strands of DNA pulling

Afrikaners (People who are descended from Dutch settlers, and also French and German immigrants) are being killed and slaughtered, and their land and farms are being illegally confiscated," Trump said in a post on Truth Social on Friday.

"No US Government Official will attend as long as these Human Rights abuses continue. I look forward to hosting the 2026 G20 in Miami, Florida!" he

In February this year, just weeks after being sworn in as US President for a second term, Trump issued an order condemning South Africa's "shock-

ing disregard" of its citizens rights by enacting legislation that enabled the South African government to seize ethnic minority Afrikaners' agricultural property without compensation. In the wake of this, Trump

had said that the US shall not provide aid or assistance to South Africa and shall promote the resettlement of Afrikaner refugees escaping government-sponsored race-based discrimination, including racially discriminatory property confiscation. In his remarks at a busi-

ness forum in Miami, Florida, Wednesday, Trump said, "I am not going. We have a G20 meeting in South Africa. South Africa shouldn't even be in the Gs anvmore because what's happened there is bad. I'm not going. I told them I'm not going. I'm not going to represent our country there. It shouldn't be there."

The US will take over the Presidency of the G20 from South Africa and head the grouping from December 1, 2025, through November 30, 2026. Trump has previously said that he will host the G20 leaders for the 2026 summit at his golf club near Miami.





Centre notifies new deep-sea fishing rules

New Delhi, Nov 8: In a significant move to unlock the potential of India's vast manotified new rules for deep-sea fishing in the country's Exclusive Economic Zone (EEZ), with a focus on empowering fishermen, cooperatives and smallscale fishers, while banning foreign vessels from operating in Indian waters. The rules, notified, November

4, fulfil the Budget 2025-26 announcements and are expected to open new avenues for India's marine fisheries sector, particularly in tapping high-value tuna resources that have remained largely underutilised despite neighbouring countries harvesting them in the Indian Ocean region, the fishery ministry said in a statement.

The new framework prioritises Fishermen Cooperative Societies and Fish Farmer Producer Organisations (FFPOs) for undertaking deep-sea fishing operations using technological ly advanced vessels.

A key innovation is the introduction of the mother-and-child vessel concept, which allows mid-sea transhipment under Reserve Bank of India (RBI) regulations, particularly beneficial for the Andaman & Nicobar and Lakshadweep Islands, which ac-

To protect the marine ecosystem, the rules ban harmful fishing practices such as LED light fishing, pair trawling and bull trawling.

count for 49 per cent of India's

Minimum legal sizes for fish species will be prescribed, and Fisheries Management Plans will be developed in consultation with stakeholders, including state governments.

Under the new rules, mechanised and large-sized motorised vessels will require an Access Pass, which can be obtained free of cost through the online ReALCRaft portal.

Traditional and small-scale fishers operating motorised or non-motorised crafts are exempted. The digital system is designed to be time-bound, allowing boat owners to apply with minimal documentation and track applications in real time without visiting any office.

Currently, around 2.38 lakh fishing vessels across 13 coastal states and Union Territories are registered on the portal. While about 1.72 lakh smaller vessels are exempt, some 64,187 mechanised fishing vessels will be required to obtain Access Passes for EEZ operations.

Crucially, foreign fishing vessels are not allowed to get access pass under any arrangements, to safeguard the interests of

The ReALCRaft portal is being integrated with the Marine Products Export Development Authority (MPEDA) and the Export Inspection Council (EIC) for issuing Fish Catch and Health Certificates, key requirements for exporting seafood to premium international markets. This integrated digital system ensures end-to-end traceability, sanitary compliance and eco-labelling, enhancing the global competitiveness of Indian marine products.

The rules also bring regulatory reforms recognising fish resources from the Indian EEZ beyond the contiguous zone as 'Indian origin' under revenue and customs norms, so that they are not treated as 'imports while landing at Indian ports.

The government will provide comprehensive support through training programmes, international exposure visits and capacity-building initiatives across the value chain, including processing, value addition, marketing, branding and exports. Access to credit will be facilitated under flagship schemes such as the Pradhan Mantri Matsya Sampada Yojana (PMMSY) and the Fisheries and Aquaculture Infrastructure Development Fund (FIDF).

To ensure safety and security, the rules mandate the use of transponders for deep-sea fishing vessels and QR-coded Aadhaar Card/Fishers ID Card for identification.

The ReALCraft application has been integrated with the Nabhmitra Application used by fishermen for safe navigation. which will also help marine enforcement agencies, including the Indian Coast Guard and Navy, strengthen coastal security.

India's 11,099 km coastline and EEZ of over 23 lakh square kilometres provide livelihood to more than 50 lakh people in the fishing community.

SEBI warns investors about unregulated digital gold

Mumbai, Nov 8: The Securities and Exchange Board of India (SEBI) has issued a warning to investors regard ing "digital gold" or e-gold products available online, stating that all such offerings operate outside the securities regulatory framework and hold significant risks for investors

This situation may expose buyers to considerable coun terparty and operational risks, as these products are neither classified as securities nor regulated as commodity de-

"It has come to the notice of SEBI that some digital/ online platforms are offering investors to invest in 'Digita' Gold/E-Gold Products'. Digi tal Gold is being marketed as an alternative for investment in physical gold," the market regulator said in a statement.

SEBI informed that such dig ital gold products are different from SEBI regulated gold prodfied as securities nor regulated as commodity derivatives.

They operate entirely outside the purview of SEBI. Such digital gold products may entail significant risks for investors and may expose investors to counterparty and operational risks, the statement said. SEBI clarified that none of

the investor protection mechanisms under securities market purview shall be available for investments in such digital gold or E-Gold products. Various online platforms

and iewellers are promoting digital gold with minimal investment options, starting at ₹10 or ₹100. They are also highlighting features like anytime buy/sell and the ability to redeem for physical jewellery. SEBI emphasised that in-

vestment in gold can be made through regulated channels, exchange-traded including commodity derivatives, gold exchange-traded funds from mutual funds, and electronic gold receipts that can be tradinvestments are facilitated by SEBI-registered intermediaries and are subject to the regulator's framework.

India's gold exchange-traded funds saw \$850 million in net inflows in October, taking the total to a record \$3.05 billion. the highest-ever for a single year, according to the World Gold Council data.

Moody's rating changes OLA outlook

Mumbai. Nov 8: Moody's Ratings has downgraded ANI Technologies Pvt Ltd, the parent company of ride-hailing firm Ola, from 'B3' to 'Caa1 and changed the outlook to negative.

The downgrade is attributed to weakening financial perfor an increased risk of violating loan covenants. The global credit rating agency reported a decline in operating cash flows and an increase in refinancing risks due to slower revenue growth and ongoing losses. "Moody's Ratings (Moody's

has downgraded ANI Technol ogies Pvt Ltd's (Ola) corporate family rating (CFR) and the rating on the guaranteed senior secured term loan borrowed by OLA Netherlands BV, to Caa1 from B3. The loan is guaranteed by Ola," the release said. Moody's reported that ongo-

ing operational challenges led to a higher-than-expected cash burn in the six months ending September 30, 2025, decreasing cash reserves from \$90 million in March 2025 and limiting headroom under the term-loan covenant. "A covenant breach constitutes an event of default and accelerates repayment of Ola's \$65 million loan due De cember 2026. Ola must maintain cash equal to 40 per cent of the outstanding loan, at least \$26 million, to comply with the covenant," the release added.

Intense competition in India's ride-hailing sector will result in continued cash burn over the next 12 months. As such, the company will have to rely or external funding sources to re finance its upcoming loan ma turity, the ratings agency said

The ratings firm has deemed Ola's liquidity weak, indicating that available cash may fall substantially short of covering upcoming debt maturities and capital spending needs through December 2026. Moody's said that Ola is considering options such as a potential initial pub lic offering and selling its 3.64 percent at approximately \$90

psychological harm, according US-based OpenAI released the GPT-40 model in May 2024, when it became the default

model for all users. In August, OpenAI launched GPT-5 as the successor to GPT-40, but "these lawsuits partic-

ularly concern the 40 model, which had known issues with being overly sycophantic or excessively agreeable, even when users expressed harmful intentions," according to a report in TechCrunch.

The report said that while four of the lawsuits address ChatGPT's alleged role in family members' suicides, three claim that ChatGPT reinforced harmful delusions that in some cases resulted in inpatient psychiatric care.

According to the report. the lawsuits also claim that OpenAI rushed safety test-



ing to beat Google's Gemini to market.

OpenAI was yet to comment on the report.

Recent legal filings allege that ChatGPT can encourage suicidal people to act on their plans and inspire dangerous delusions.

"OpenAI recently released data stating that over one million people talk to ChatGPT about suicide weekly," the report mentioned.

In a recent blog post, OpenAI said that it worked with more than 170 mental health experts to help ChatGPT more reliably recognise signs of distress, respond with care, and guide people toward real-world support-reducing responses that fall short of our desired behaviour by 65-80 per cent. "We believe ChatGPT can

provide a supportive space for people to process what they're feeling, and guide them to reach out to friends, family, or a mental health professional when appropriate," it noted. "Going forward, in addition

to our longstanding baseline safety metrics for suicide and self-harm, we are adding emotional reliance and non-suicid al mental health emergencies to our standard set of baseline safety testing for future model releases," OpenAI added.

Brisbane, Nov 8: India raced to 52 for no loss in 4.5 overs before rain forced their fifth and final T20I against Australia to be washed out at The Gabba in Brisbane on Saturday. With persistent rain and lightning forcing the game's abandonment. India clinched the five-match series 2-1.

The result marks India's fifth consecutive T20I series win over Australia, and also shows their dominance over their opponents in the shortest format. Openers Abhishek Sharma (23 not out) and Shubman Gill (29 not out) gave India a brisk start before the skies opened up and eventually didn't give any room for a restart – the second such instance of a no result in the series.

Before rain halted the proceedings, left-handed opener Abhishek Sharma survived early chances to be unbeaten on 23 while Shubman Gill hit glorious boundaries to be 29 not out.

After India were inserted into batting first, Abhishek was dropped twice in the powerplay first by Glenn Maxwell at longoff off Ben Dwarshuis, and then by Dwarshuis himself on the boundary after he miscued a pull against Nathan Ellis.

Despite the nervy start, Abhishek capitalised on the reprieves to hit two glorious boundaries and reached the 1000-run milestone in T20Is in just his 28th innings since making his debut in July 2024.

While Abhishek rode his luck. Gill looked assured at the other end by hitting six boundaries to

The left-handed batter shattered the previous global record, which belonged to Australia's Tim David. When it comes to overall balls faced in T20Is, David now stands 6th in the list, having faced 614 balls to reach 1000 runs in T20Is, but this record consists of matches played for both Singapore and Australia. The Indian women's team of Elavenil, Meghana Sajjanar and Shreya Agrawal won the bronze with an aggregate of 1893.3, while China (1901.7) and South Korea (1899.9) took the gold and silver respectively.

In the qualification round whose scores are considered for team medals, Valarivan shot 633.4, while Meghana and Shreya scored 631.2 and 628.7

The AIFF had floated the Request for Proposals on October 16 for a 15-year contract to monetise the league's commercial rights. The submission deadline was November 7, with bids scheduled


