New Delhi, Dec 4: Prime Minister Narendra Modi Thursday warmly welcomed Russian President Vladimir Putin as he kick-started a nearly 27-hour visit to India to further shore up an eight-decade bilateral partnership that remained in firm footing notwithstanding fractious geopolitical upheavals.

IN DELHI

In reflection of the importance India attached to the Russian leader's first visit to India in four years, Modi received him at New Delhi's Palam airport with a hug amid a group of artistes performing traditional dances

From the airport, the two leaders travelled to Modi's official residence in his car, nearly three months after the PM rode with Putin in the Russian leader's vehicle in Chinese city of Tianjin during the Shanghai Cooperation Organisation summit.

"Delighted to welcome my friend, President Putin to India. Looking forward to our interactions later this evening and tomorrow. India-Russia friendship is a time tested one that has greatly benefited our people," the PM said on social media.

₹1 CRORE FOR DHANU JATRA

Bhubaneswar, Dec 4: The state government Thursday sanctioned ₹1 crore for Bargarh's Dhanu Jatra, during which the town transforms into an open-air theatre with the life of Lord Krishna being enacted over 11 days.

The decision was taken at a meeting chaired by Odia Language, Literature and Culture Minister Suryabanshi Suraj.

The festival is scheduled to be held from December 24 to January 3. It was also decided at the meeting to provide an honorarium of ₹10,000 each to nearly 200 artistes participating in the festival, Suraj said.

The Directorate of Odisha Pa ribar will arrange live screening of the festival across the country, he said. It was also decided to build Dhanu Jatra-themed welcome gates at major entry points of the town. Special tourist buses from Bhubaneswar and Puri to Bargarh will be operated during the festival, he added.

He said a dedicated website will also be created to provide information about the festival, including event videos, major landmarks, hotels, parking areas and venue details

Mockery of system: SC on tardy acid attack case trial

New Delhi, Dec 4: Expressing deep shock after learning from an acid attack survivor that her case has been pending before a trial court in Delhi since 2009, the Supreme Court Thursday termed the situation a 'national shame' and remarked that such offences ought to be tried in spe cial courts. Stating that the slow pace of trials in acid attack cases amounts to a 'mockery of the system', the apex court directed High Courts to submit details of all such pending cases across the country within four weeks.

Mooting the idea of setting up special courts for expeditious disposal of acid attack cases, the SC also asked the Centre to consider amending the law through legislation or even an ordinance so that the survivors are formally included within the definition of persons with disabilities under the Rights of Persons with Disabilities Act to avail welfare schemes.

A bench comprising Chief Justice of India (CJI) Surya Kant and Justice Joymalya

Bagchi also issued notices to the Centre and the Department of Empowerment of Persons with Disabilities on a PIL filed by acid attack survivor Shaheen Malik that the victims be categorised as persons with disabilities to ensure access to welfare schemes.

General (SG) Solicitor Tushar Mehta assured the court that the issue would be taken up with 'due seriousness' by the government.

The SC termed as 'national shame' the prolonged delay of 16 years in Malik's own case, which has been pending since 2009 before a Rohini court here.

personally, said that she was attacked in 2009, yet the trial has still not concluded. "Mere saath 2009 mein attack hua tha. abhi tak trial chal raha hai' (I was attacked in 2009; the trial is still going on)," she said.

Expressing surprise over the delay of over 16 years, the CJI said, "The offence is of 2009 and the trial is not completed! If the National Capital cannot respond to these challenges, then who will deal with them? It is a shame on the system! This is a national shame.

The CJI asked Malik to file an application in the PIL itself explaining why the matter has not been concluded, assuring her that the court may even take suo motu cognisance. The CJI said trial in her case must be held on a day-to-day basis.

"Issue notice. Learned SG has also expressed concern about the causes raised in the instant petition. We also direct the Registrar Generals of all High Courts to furnish the details of pending trials in the cases of acid attack victims in their respective jurisdiction," the SC ordered.

The CJI said that the aspect of pendency of cases and covering acid attack victims within the definition of persons with disabilities will be taken up after four weeks.

The bench, however, said that it will take up next week the issue of the delay in the trial in Malik's case at a Rohini court.

During the hearing, Malik highlighted the plight of victims who are forced to ingest acid, often surviving with artificial feeding tubes and severe disabilities.

The CJI expressed shock and said he had heard about the incidents of acid-throwing but had never come across cases where victims were forced to consume acid.

The CJI remarked, "These offences ought to be tried in special courts, given the gravity and the impact on survivors.

'This (tardy trials in acid attack cases) is a mockery of the system. There should be no sympathy for such persons (accused)," he said.

Chaos as 550 IndiGo flights cancelled

Mumbai/New Delhi, Dec 4: The country's

largest airline IndiGo Thursday cancelled more than 550 domestic and international flights, and services were delayed at various airports as operational disruptions continued for the third straight day, impacting travel plans of hundreds of passengers.

On a day when the Ministry of Civil Aviation and DGCA held a meeting with senior Indi-Go officials to take stock of the situation as well as the mitigation plans, the airline's CEO. Pieter Elbers, told the staff that normalising operations and bringing back punctuality will not be an 'easy target'.

The airline, which generally operates around 2.300 flights daily and presents its punctuality as a hallmark, recorded an on time performance of 19.7 per cent Wednesday, a steep fall from 35 per cent reported Tuesday.

Grappling with significant flight disruptions due to a multitude of factors, including cabin crew woes and technology issues, the airline has adjusted its schedules which means that pre-

planned ser vice cancellations are being carried out as part of normalising operations.

Sources told PTI that more than 550 flights were cancelled at different airports, including 172 flights at the Delhi airport. Thursday. There were at least 118 flight cancellations at the Mumbai airport, 100 at Banga-

lore, 75 at Hyderabad, 35 at Kol-

kata, 26 at Chennai, and 11 at Goa. Flight cancellations were reported at other airports also. "IndiGo has been experienc ing a sharp rise in cancellations. reaching approximately 170-200 flights per day, which is substantially higher than normal," the

DGCA said following reported chaos at airports. Civil Aviation Minister K Rammohan Naidu held a high-level review meeting to assess the sit uation of significant flight disruptions and expressed his displeasure at the way IndiGo handled

the new FDTL norms implementation despite having ample time. Meanwhile IndiGo told DGCA that operations are expected to be fully stabilised by February 10, 2026, and sought temporary relaxations in flight duty norms.

Why did hundreds of Porsches in Russia suddenly shut down?

magine waking up on a Monday morning, coffee in hand (they drink that in Russia, right?), ready to fire up your beloved Porsche — only to discover it has transformed into a very expensive lawn ornament.

Back then, everyone

worried about us. Now they

don't even check the rate

That's exactly what happened to hundreds of Russian Porsche owners this week, and the automotive world is buzzing with theories.

December 1 marked an unusual day in Russian automotive history. Across the vast expanse from Moscow to Krasnodar, Porsche owners found themselves in an oddly specific predicament: their cars simply refused to cooperate. We're not talking about a dead battery or a temperamental starter motor. These vehicles went full rebellion — engines locked up and alarms disabled.

One particularly unlucky driver in St. Petersburg had his Porsche die right after picking up

his takeout order, according to Daily Mail. "I picked up my order, got back in, and that was it - the car wouldn't start," he said, adding, "I spent two days trying to understand what happened."

The prime suspect appears to be Porsche's own Vehicle Tracking System (VTS) yes, the very feature designed to protect these cars. Every Porsche sold in Russia since 2013 came equipped

with this VTS. which communicates satellites to track the vehicle's location. It's like a high

tech security blanket. When VTS loses its satellite connection, it doesn't just shrug and wait for better reception. It takes the nuclear option: activating the engine immobilizer and turning your six-figure sports car into a paperweight.

According to Yulia Trushkova from Rolf Group's service division, every model and engine type is affected. Naturally, when hundreds of luxury cars simultaneously brick themselves, people start asking questions. And in Russia right now, those questions tend toward the dramatic. One dealer representative floated the possibility of deliberate interference, though they were quick to admit there's zero evidence backing that theory. Up next on Ancient Aliens..

Porsche's Russian division has gone radio silent on the matter,



nv's German headquarters isn't exactly rushing to issue statements. This has only made the ordeal feel even more suspicious.

Meanwhile, owners are stuck with cars that look pristine but won't budge. In the absence of official solutions, Porsche owners have turned to shade-tree engineering. Some have yanked alarm system connectors entirely. Others report success after disconnecting the battery for 10 hours or more — apparently these cars need a really long nap to reconsider their life choices.

Service centres across Russia are now flooded with identical cases: mechanically sound vehicles that simply refuse to start. Imagine being a mechanic faced with a parade of perfectly healthy patients who've all fallen into the same mysterious coma.

It's worth noting that Porsche stopped shipping new cars to Russia after the Ukraine invasion, but plenty of their vehicles remain on Russian roads. The incident raises uncomfortable questions about the vulnerability of modern connected cars. When your vehicle's security

system can remotely disable it intentionally or not — you're essentially driving a computer on wheels that might decide to take an unscheduled vacation. For now, stranded Porsche owners are left waiting for answers that may never come. Is this a massive technical glitch? A satellite malfunction? Something more deliberate? Your guess is as good as theirs.

One thing's certain: somewhere in Stuttgart, a team of engineers is having a very bad week. And across Russia, hundreds of Porsche enthusiasts are learning a hard lesson about the double-edged sword of modern automotive technology.



State will get its rights over Mahanadi waters soon: CM

Bhubaneswar, Dec 4: Chief Minister Mohan Charan Majhi Thursday said Odisha will soon get its rights over Mahanadi River waters through a legal and amicable solution to the dispute with neighbouring Chhattisgarh.

Majhi made the assertion while replying to a written question from Congress member Taraprasad Bahinipati in the Assembly.

"Mahanadi is considered the lifeline of Odisha, and the state government, since the last oneand-a-half years, is striving to resolve the water-sharing dispute through legal as well as amicable negotiations. Odisha will get its rights very soon,' the CM said.

The dispute over sharing Mahanadi waters between Odisha and Chhattisgarh has continued for over a decade after the latter allegedly constructed several barrages and dams on the upstream of the river, blocking the free flow of water downstream.

The dispute finally led to the formation of Mahanadi Water Disputes Tribunal in 2018. How-

ment has started an initiative to resolve the issue through amicable negotiation between the two BJP-ruled states.


"Majhi and his Chhattisgarh counterpart Vishnu Deo Sai have informally talked regarding the Mahanadi water dispute. The matter has also been discussed at the Eastern Zonal Conference chaired by Union Home Minister Amit Shah," Parliamentary Affairs Minister Mukesh Mahaling informed the House on behalf of the CM, while replying to questions.

Mahaling said that following informal talks between the two chief ministers, the chief secretaries of the two states held a meeting in New Delhi August 30 this year and discussed how to resolve the issue. Another review between the chief secretaries was held November 10.

The minister said both states are discussing the volume of water to be released to Odisha during the non-monsoon season so that the Hirakud reservoir could be managed properly according to the Curve Rule.

Stating that the joint technical committee (JTC)

BJD, Congress ruckus causes adjournments PNN & AGENCIES

Bhubaneswar, Dec 4: The Odisha Assembly Thursday saw repeated adjournments after BJD and Congress members protested alleged "objectionable" by BJP MLA Santosh Khatua.

Soon after Khatua made ber 5 as part of the ongoing BJD and Congress legis-

lators rushed to the well of the House demanding an apology. They also urged the Speaker to expunge the remarks from the official records, which was later done. The agitating members also raised anti-BJP slogans, leading to eight adjournments.

Later, opposition members staged a silent demonstration near the Gandhi statue. Normalcy was restored after Mahaling clarified in the House that the state government denounced the

Khatua's statement.

Earlier in the day, the House was adjourned for a brief period after Congress MLAs held protests in the Odisha assembly over reservation issues. As soon as the House assembled for the Question Hour, Congress members assembled near the well and raised slogans against the BJP government in the state, alleging that democracy has been murdered. They also protested the denial of permission for presenting a resolution by the party on making provision of reservation for SC, ST and OBCs as per the rate of population

Similarly a concession agreement has been signed for setting up a captive jetty for the JSW Utkal Steel Limited's proposed Integrated Steel Plant at Jhatadhari Muhan in Jagatsinghpur district. Odisha has a lone major port in Paradip under the administrative control of the ministry for ports, shipping and waterways.

Two non-major ports at Dhamara and Gopalpur are in operation and two non-major ports at Subarnarekha and Astaranga are under development.

BJP, BJD concern over Hirakud dam siltation

Bhubaneswar, Dec 4: The ruling BJP and Opposition BJD Thursday agreed on the urgent need to tackle massive siltation at Hirakud reservoir, which poses a potential threat to the safety of the dam. The issue was raised

during Zero Hour by BJD deputy leader of Opposition Prasanna Acharya, who expressed concern over a recent survey showing a 27 per cent reduction in the dam's water holding capacity due to silt accumulation.

He said apart from safety aspects, the siltation problem could also affect power generation, irrigation activities and flood management as well. 'There is heavy silt accumu-

lation in the dam and lack of proper maintenance may pose a major threat to both the state and the country in the coming years," Acharya said.

He also criticised the state's BJP government for allocating land near the reservoir for construction of big hotel projects and alleged that the decision grossly ignored the safety needs of the dam. Responding to the BJD lead-

er's concerns, Revenue and Disaster Management Minister Suresh Pujari said the state government is equally worried over the siltation problem of

Hirakud. "The Centre has already brought Dam Safety Act in 2021 as such matters are quite serious. I have discussed the matter with the Union Jal Shakti Minister. We are finddesiltation of the reservoir, the minister said. He informed the House that a Japanese firm was once engaged for silt removal, but the effort remained incomplete because of the presence of trees inside the dam.

ECoR takes safety measures for dense fog

Bhubaneswar, Dec 4: With dense fog conditions reported in several sections under its jurisdiction, East Coast Railway initiated a comprehensive preparedness drive to ensure safe and smooth train operations during the winter months. As per a press release, it has strengthened round-the-clock monitoring and deployed additional manpower to tackle challenges posed by reduced visibility during night and early morning hours.

During dense fog, Loco Pilots have been instructed to regulate speed strictly based on visibility conditions. Safety Counsellors and Railway Officers are continuously briefing running staff to maintain utmost caution during train operations. Emphasis is placed on safe speed—even if it results in loss of punctuality—placing passenger safety as the highest priority, the Railways said in the press release. To assist Loco Pilots in identifying signals in low visibility, luminous and fluorescent strips


have been applied on OHE masts, level crossing gates, and locations ahead of critical stop signals. These reflective indications enable train crew to spot signal positions well in advance, even under dense



fog conditions. Railways further said, to enhance safety during low visibility, FSDs (Fog Safe Devices) have been provided to Loco Pilots for advance signal announcements, while detonators are being deployed at severely fog-affected locations to deliver audible warnings through pressure-activated blasts as trains approach signals.

East Coast Railway has reportedly ensured adequate fog safety equipment availability across all divisions. Waltair Division has been provided with 471 FSDs, Khurda Road Division with 125 FSDs, and Sambalpur Division with 210 FSDs, it said.

Since the safety of the travelling passengers is topmost priority, Loco Pilots have been instructed to take precautions during fog. When the loco pilot in his judgment feels that visibility is restricted due to fog, he has been given the authority to run at a speed at which he feels that he can control the train or stop the train whenever required without taking any risk. This speed will not in any case be more than 60kmph. The loco pilots have also been advised to whistle frequently to warn the nearby gateman and road users of approaching train.

He noted that India has achieved the fastest rollout of 5G services globally, supported by over 1.23 billion telecom subscribers and nearly 99 per cent 4G coverage. He emphasised that India continues to record high data-consumption levels while maintaining affordable tariffs that ensure broad digital access across socio-economic groups.

He highlighted TRAI's QoS Rating Framework for Buildings (Digital Connectivity Rat-



ing) as an important initiative to enhance transparency in service-quality assessment and noted the growing need to strengthen indoor connectivity, given the significant share of data usage occurring within buildings. 
Govt tries to revive BSNL, Vodafone-Idea

Man sets mother on fire for denying cash to buy liquor

Bhadrak, Dec 4: An elderly woman suffered severe burn injuries after she was allegedly assaulted and set on fire by her son in Bhadrak district, police said Thursday. The incident took place at Galaganda village within Tihidi police limits.

The accused, identified as Debashish Nayak (45), a known substance abuser, fled the spot after allegedly setting his mother ablaze, police said.

According to preliminary reports, Debashish had asked his mother, Jyotsnarani Nayak (65), for money to buy liquor. When she refused, he allegedly attacked her. After she collapsed, he poured petrol and set her on fire, police said, quoting local residents.



When neighbours rushed to the spot hearing her screams, the accused escaped before being detained, Tihidi police station officer-in-charge Satyabrata Graharai said.

The woman was first taken to Bhadrak District Headquarters Hospital and later shifted to SCB Medical College and Hospital, Cuttack, after her condition worsened, police

"Debashish and his mother used to get into arguments often. But we never imagined that he would set his mother on fire for refusing to give money to buy liquor," neighbour Subrata Nayak claimed.

Bhadrak/Chhatrapur, Dec 4: Two young women lost their lives in separate road accidents along the busy National Highway-16 Thursday, triggering public outrage, protests, and renewed calls for stronger road-safety measures.

In Bhadrak district, a college student, Shraddhanjali Panda of Bhandaripokhari College, was killed after a sand-laden tractor allegedly hit her bicycle from behind while she was on her way to campus. The impact reportedly dragged her under the vehicle, killing her on the spot. She was taken to a nearby hospital, where doctors declared her dead.

Enraged locals and college students immediately blocked the NH-16 for nearly five hours, demanding the arrest of the tractor driver and stricter action against reckless driving. The protest caused massive traffic congestion, leaving hundreds stranded. Police officials later held discussions with the agitators and restored normal traffic. An investigation has been initiated, said Bhandaripokhari IIC Rajlakshmi Behera.

District Collector Dillip Routray, who was in the area for a meeting, handed over Rs 30,000 to the victim's father from the District Red Cross Society.

Meanwhile, in Ganjam district, another fatal accident occurred at DRDA Square in Chha-

Andhra-bound container truck reportedly rammed a scooter from behind. The collision caused J. Swati, who was returning to Berhampur with her father after completing work at the Ganjam RTO, to fall on the road. She was crushed to death instantly in front of her father, who narrowly escaped. The police have detained the truck driver and seized the vehicle. A case (763/25) has been registered, and the body was handed over to the family after post-mortem.

The Chhatrapur stretch of NH-16 has witnessed multiple fatalities in recent months. A biker from Balasore died near Science College Square earlier this week, while a schoolgirl was killed by a truck at the same DRDA Square in August. Locals describe both junctions as "death traps" and have been consistently demanding flyovers and round-the-clock traffic policing.

Following Thursday's incident, Ganjam Collector V. Keerthi Vasan and SP Suvendu Kumar Patra visited the accident site and instructed the consultancy agency to expedite the ongoing highway construction work.

The youth was identified as Dashmant Mahakud, 29, of Kamarmora village under the Patana police limits. He finally came down after having a talk with

ship for three years with a woman from an area under the Navakote police limits. Her parents reportedly disapproved of their relationship and prevented the two from

Around 6am Thursday, Mahakud climbed the tower to pressure the woman's parents. He threatened to end his life if he was not allowed to speak with her. On being informed, local residents througed the spot and alerted police, who arrived with the fire services personnel. A safety net was set up as rescuers tried to persuade him to come down. After several hours of nego

tiation, Mahakud finally spoke to his girlfriend and her family over the phone around 9:30am. He later climbed down with assistance from fire personnel. Police detained him for questioning and later handed him over to his father after he arrived, officials said.

Balasore, Nov 4: A nine-year old tribal student was found chained to his bed in a staterun school hostel in Balasore district, triggering public re sentment after a video of the incident went viral on social

The authenticity of the video, however, could not be verified by PTI. The incident took place at Begunia UGUP School in Nil agiri block. After the video drew the attention of the district administration Thursday, a senior official visited the hostel run by the Tribal Welfare department

"We found the Class IV student chained to a bed. We re corded the statements of the headmaster, hostel superintendent and teachers. They claimed that the boy was chained following suggestions by his parents, Balasore Sub-Collector Madusmita Samantray said.

School authorities claimed the boy was restrained to pre vent him from frequently flee ing the hostel and returning home. The boy's mother, Lili Singh, defended the act and said they had requested the school authorities to keep her son chained as he often fled from the hostel.

"We counselled him several times, but the boy did not understand. Therefore, the school was requested to keep him tied and free only during school hours,



Sambalpur: Kin cry murder after girl's mysterious death had been filed at that time, and

Sambalpur, Dec 4: A day after the body of a 15-year-old girl was recovered from a drain in Shantinagar under Ainthapali police limits here, her kin Thursday alleged that she had been murdered.

The deceased, identified as Saishraddha Mishra, was the granddaughter of Ashok Kumar Mishra and Surekha Mishra of Shantinagar. Sources said, her father Ganga Prasad Mishra had died in an accident a few years back while her mother died under mysterious circumstances in 2017.

She had been living with her grandparents and was studying in Class X, according to police.

Her death has raised suspicion among residents and kin, as her mother had died allegedly by suicide a few years earlier. News



of Saishraddha's death has triggered shock and unrest across the town. Her maternal uncle Asit Kumar Nanda and his wife, who live in Angul, reached Sambalpur Thursday morning and alleged that the girl had been murdered. They claimed that Saishraddha's father, Ganga Prasad Mishra, died in an accident several years ago, and her mother's death in 2017 was considered suspicious. A complaint an investigation into that case remains ongoing. According to the relatives, Ganga Prasad had transferred all his property to his wife's

name before his death. They al-

leged that after Ganga Prasad's death, his wife was harassed and murdered, and it was made to appear as a case of suicide. They now suspect a similar pattern in Saishraddha's death. "Police have registered a case and launched preliminary investigation. A forensic team



Woman's decapitated body found

Malkangiri: Police Thursday recovered the body of a woman with its head severed near Poteru river under the Korukonda police limits in Malkangiri district. The deceased was identified as Lake Padiami, 50, of Rakhalguda village. The incident has sparked shockwaves and fear as residents and family members suggested murder. Family members alleged at the police station that she was murdered and her head was severed. A preliminary finding by police also suggested the possibility of homicide. According to reports, Padiami had been missing for the past two days. Her family members searched multiple locations but had been unable to trace her. Elephant attacks claim two lives

Chhendipada, Dec 4: Two persons of Joradanga village under the Chhendipada forest range in Angul district were killed in separate elephant attacks Thursday, triggering tension

The deceased were identified as Cheru Dehuri, 70, and Rajani Behera, 35. Forest officials recovered Cheru's body from the Chhendipada forest border, while Rajani's body was

found near the Kundheigola forest boundary. According to reports, Cheru was heading to a nearby farmland to relieve himself when he came in the way of a herd of elephants. An elephant picked him on its tusk and trampled him to death.

In a similar incident, Rajani from the village was going to the farmlands when she was attacked by an elephant. She suffered critical injuries and collapsed at the site. Locals attempted to rescue her but were unable to reach her due to the herd's presence.

On being informed, forest personnel from Chhendipada and Riamal reached the spot and managed to drive away the elephants. Rajani was rescued and taken by an ambulance to the district headquarters hospital in Angul, where she succumbed to her injuries during treatment. Villagers have alleged that two people died

because the Forest department failed to act despite a herd of 16 elephants roaming near the forest-side villages for several days. Tension flared up at the scene after the deaths.

A Just Transition

ith the United Nations Climate Change Conference (COP30) and the G20 Leaders' Summit now concluded, attention turns to this week's gathering of the UN Convention to Combat Desertification (UNCCD) in Panama. Whether the event delivers progress on sustainable land management and drought resilience in a just and equitable manner hinges largely on one familiar factor: finance.

Insufficient funding has emerged as a stumbling block in advancing multiple Sustainable Development Goals, with SDG15 - focused on the protection, restoration, and sustainable use of land and terrestrial ecosystems – receiving some of the lowest levels of finance. But human well-being, and progress toward many other SDGs, depends directly on healthy soil, water, and terrestrial biodiversity.

Already, up to 40 per cent of our planet's lands are degraded and deteriorating, jeopardizing the health and livelihoods of more than three billion people, especially poor rural communities, small-scale farmers, women, youth, Indigenous peoples, and other at-risk groups. Annual economic losses linked to desertification, land degradation, and drought amount to \$878 billion – far more than the investments needed to address them. A just transition from an exploitative land economy to one that is restorative, inclusive, and resilient is urgently needed.

The concept of a just transition has become central to discussions on climate action – in particular, the energy transition. For example, it is understood that European communities dependent on coal production need support, so that they can secure good jobs in emerging clean industries. Globally, numerous initiatives have been created to support a just energy transition. But no equivalent exists for the land sector (which includes agriculture, forestry, and other land use), even though

the need for a "just land transition" to support interconnected climate, nature, and human-development imperatives is at least as great.

Land-related activities account for nearly a quarter of greenhouse-gas emissions and employ over 20 times more workers than the energy sector globally. Moreover, unlike energy-sector workers – who tend to be formally employed, with regular, reasonably strong wages - many land workers are self-employed or seasonal, meaning that they have minimal safety nets and low financial resilience. In fact, extreme poverty is typically concentrated in degraded rural communities, which are often among the most exposed to climate and non-climate shocks.

Now, these communities are being forced to pursue their own transitions, with minimal support from the international community – including the countries that are most responsible for climate change. For example, climate change has left nomadic pastoralists in the Horn of Africa, whose own carbon footprint is negligible, with no choice but to alter millennia-old migration routes, owing to water scarcity and land deg radation. Such unstructured and risky transitions exacerbate poverty, inequality, and marginalization, increasing the risk of instability, out-migration, and conflict – and un-

derscoring the need to support vulnerable communities and ecosystems on the frontline of climate change, nature loss, and land degradation. But the news isn't all bad. Momentum is gathering around land and

soil restoration. China has long been a land-restoration pioneer, exemplified by the Three-North Shelterbelt Forest Program that began in 1978. And a growing number of countries are emulating such initiatives with local efforts to strengthen resilience increasingly complemented by national plans for halting and reversing land degradation and improving drought management.

Progress is also being made at the regional level. Africa's Great Green Wall initiative - which aims to restore 100 million hectares of degraded land, sequester 250 million tons of carbon, and create ten million green jobs by 2030 – is being implemented in 22 countries. The Middle East Green Initiative, backed by up to \$2.5 billion in seed funding from Saudi Arabia, includes the world's largest landscape-res-

At the global level, frameworks like the 30x30 land conservation goal, the UNCCD-led Land Degradation Neutrality initiative, and the G20 Global Land Initiative point to a growing consensus on the importance of land protection and restoration. The recently announced Riyadh Global Drought Resilience Partnership aims to support the world's most drought-vulnerable countries. Yet finance is still lagging behind ambition. At last year's UNCCD gathering in Rivadh, participants pledged over \$12 billion in funding for "drought resilience, land restoration, and the fight against land degradation," which is a step in the right direction, but nowhere near enough to meet global goals. For that, the world must mobilize \$278 billion annually.

To address this shortfall requires an innovative combination of financing mechanisms. Private finance can be mobilized through specialized debt instruments, such as green or restoration bonds. These are already gaining traction: the global sustainable bond market reached \$1.1 trillion in 2024. Moreover, companies can invest in land-based communities, in order to secure sustainable commodity supply chains, restore soil health, and support resilient livelihoods.

Blended finance models - which combine, say, philanthropic grants with concessional lending – can ensure that support reaches remote communities. Meanwhile, development institutions can back national efforts, and parametric (index-based) insurance linked to early-warning systems can provide a safety net when shocks arrive. Other possible sources of finance include emerging carbon and biodiversity markets, remittances, crowdfunding, Islamic finance, and special-purpose financing vehicles. The embrace of digital platforms and AI tools may facilitate improvements in access and affordability.

Policy also has a crucial role to play. Unlocking financing at scale requires efforts to lower capital costs, remove barriers to access, and create the right incentives. Stronger land tenure, fiscal reform, and targeted subsidies and tariffs can also help to support sustainable land and soil systems. Policies that empower women, youth, and Indigenous communities are critical. At the global level, UNCCD, the Convention on Biological Diversity, and the UN Framework Convention on Climate Change should not each operate in a vacuum; land, biodiversity, and climate are inextricably linked, and should be treated as such.

Like the climate transition more broadly, a land transition is occurring, whether we like it or not. The question is whether it will be unfair, chaotic, and reactive, or whether world leaders, development institutions, and other stakeholders will act now to ensure that it is just, effective, and leaves no one behind.

GAME OF THRONES

f there was a contest for scoring political selfgoals, the Congress would almost certainly strike gold. The Karnataka 'nataka' or 'Game of Thrones' has kept the news wheel churning for weeks. Kaun Banega Mukhya Mantri, DK Shivakumar (DKS) or Siddaramaiah (Sidda), is only the latest Congress political soap opera being played out in full media glare: even the breakfast menu at the meetings between the two leaders has been dissected in some detail. Ambitious regional satraps and a weakened high command are a potent mix for creating a rather messed-up, spicy Kannadiga thali. So who is responsible for the growing perception of drift and chaos in the Congress' one last remaining large state fortress?

Let's start with the highly skilled Bengaluru power players first. DKS and Sidda are like chalk and cheese. The former is a quintessential party strongman, resourceful and rumbustious in equal measure. DKS' swagger has a Big Boss look to it, an astute deal-maker who doesn't hide his vaulting ambition in any false piety. Sidda, on the other hand, is the old-style neta, much more cautious in his moves but very crafty at the same time. Where DKS won't hold back from speaking his mind, Sidda chooses to couch his mono-syllabic interventions in ambiguity, carefully designed to keep his opponents guessing all the time.

In an ideal world, the Congress would have found space to accommodate both leaders relatively amicably. But these are far from good times for a moth-eaten Grand Old Party. its once insatiable appetite for power and conflict resolution now sapped by years of inertia and ineptitude. Take for example the idea of a two and half year each rotational chief ministership. It is, frankly, a bizarre concept, one that is mostly unworkable in the Indian context. No one leaves any 'kursi' voluntarily in this country. The

The problem is that the socalled Congress 'high command' is unwilling or unable to take tough decisions that are required in tough times. The Congress' 'revival', or more likely survival, in the 2024 general elections had earned Rahul Gandhi the goodwill and, more crucially, the respect of his own party cadres. A copy of the Constitution in hand, he had led from the front to challenge the BJP juggernaut. His opponents may have mocked him but within the Congress, Rahul's unwavering resolve to take on the Sangh Parivar firmly established him as the party's unquestioned leader. But instead of enforcing his writ within the party organisation as a hands-on politician. Rahul chose to outsource knotty organisational issues to his loyalists, more specifically to KC Venugopal, now the second most powerful person within the Congress 'system'.

As a result, the gains of 2024were quickly squandered. Haryana's debacle was the result of sheer over-confidence, Maharashtra was effectively 'bought' by the BJP with cash transfers to women playing a major role in the last minute heist while the Congress campaigns in Delhi and Bihar were always non-starters. With

every defeat, the Congress 'high command' appears even more reluctant to make hard political choices, living by the old Narasimha Rao dictum that 'sometimes in politics, not taking a

decision is the best decision'! But who really is the high command because it now seems a rather archaic term to use for an entity that is neither 'high' nor in 'command' any longer. The 'high command' isn't Sonia Gandhi any longer since she is in semi-retirement; it isn't Malikarjun Kharge since he isn't the kind who will rock the boat; it surely isn't Priyanka Gandhi Vadra since she hasn't been given any specific responsibility within the party. Which leaves Rahul Gandhi as the one Congress leader who has the authority to take crucial decisions. But all indications suggest that Rahul's self-image is that of an ideological warrior and not an organisation nuts-and-bolts man that the Congress so desperately needs.

Which brings one back to the Congress' Karnataka conundrum. To be fair, there are no easy options here. Sidda still enjoys the support of a majority of MLAs and his OBC credentials make him an invaluable asset to Congress' professed commitment to being a party that seeks to empower the backwards. DKS is 63, 14 years younger and far more energetic than his rival who will early next year become Karnataka's longest serving CM. A transition from Sidda to DKS would mean a generational change of sorts in a party that has been notoriously reluctant to send its veteran leaders into a 'Marg-Darshak Mandal'. Previously, in MP and Rajasthan, the Congress baulked at the idea of a generational change and lost out. Karnataka presents another opportunity although Sidda is no pushover who will retreat into the shadows quietly.

Even if there is a sem-

blance of a smooth handover some time in 2027 as is now widely speculated, how long will the truce last? The BJP can get away with forcing the resignations of all its Gujarat ministers overnight without a murmur of dissent. This is because the real 'high command' in Indian politics is at 7 Lok Kalyan Marg and 6 A Krishna Menon Marg where all major decisions affecting the BJP are taken. The Congress doesn't have anything remotely quite like Gujarat's Jodi number one who can have their way on almost every issue. There are intense power tussles in several BJP states too, most notably Goa, but no leader dare say a word publicly because of the fear factor that prevails in the party. In the Congress, on the other hand, this is open season for all stakeholders to slug it out without any fear of retribution. When the high command goes missing or is enfeebled, the rules in the political jungle change. As Karnataka has shown, it's now a case of 'each man for himself' where

only the fittest will survive. Post-script: For history buffs, it might be useful to remember that the Congress decline in Karnataka began in the early 1980s when its original mass leader, Devaraj Urs was peremptorily ousted by an imperious Sanjay Gandhi. Unlike his uncle, Rahul Gandhi clearly doesn't believe in 'off with his head' ruthless power politics. It may be both his strength and

observe Human Rights commemorating the adoption of the Universal Declaration of Human Rights, the moment demands more than just a ceremonial nod to freedom and dignity. It compels us to confront the stark human rights crisis festering within the very heart of our society, a crisis often hidden in plain sight: the profound neglect and suffering of persons with mental illness in India. We count our dogs, meticulously track the numbers of our tigers and elephants for conservation and policy, yet there remains no reliable, national enumeration of the thousands of mentally challenged individuals abandoned, destitute and left to wander the streets and byways of our cities and villages. This glaring absence on our census sheets is a chilling testament to the systemic devaluation and dehumanisation of a segment of the population whose basic rights like the right to health, dignity and life itself are routinely violated.

The pervasive stigma associated with mental illness re-

mains the primary, unyielding barrier. Across India, mental Day on 10 December, suffering is often wrongly perceived as a personal failing, a spiritual deficiency or a character weakness, rather than a medical condition. This societal judgment often leads to the isolation and abandonment of individuals by their own families, who are crippled by

shame and a lack of resources. In recognition of India's obligation under the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD), the country enacted the progressive Mental Healthcare Act (MHCA) of 2017. This landmark legislation marked a significant shift from a custodial approach to a rights-based approach to mental health. The Act's core philosophy is to protect, promote and fulfil the rights of persons with mental illness during the delivery of mental healthcare and services. Furthermore, the MHCA 2017 decriminalised the Attempt to Commit Suicide, presuming the individual to be under severe stress and requiring treatment rather than investigation or prosecution. It also details the Right to ProtecDegrading Treatment, prohibiting practices like compulsory tonsuring, chaining and forced isolation, while also ensuring rights like informed consent, confidentiality and free legal aid.

While the legal framework exists, the gap between the law's lofty intent and its grim reality remains vast. The government has attempted to bridge this gap through initiatives like the National Mental Health Programme (NMHP), launched in 1982 and subsequently re-strategised to expand community-based care through the District Mental Health Programme (DMHP). More recently, the launch of Tele Mental Health Assistance and Networking Across States (Tele MANAS) in 2022 offers a promising digital lifeline, providing 24/7 free mental health support through a national toll-free helpline. These programmes, alongside the integration of mental healthcare into primary health services under the Ayushman Bharat Health and Wellness Centres. demonstrate a clear, policy-level acknowledgement of the crisis. However, the Achil-

the cripplingly low budgetary allocation for mental health which is a fraction of what is spent in developed nations, compounded by a severe shortage of qualified mental health professionals like psychiatrists, clinical psychologists. and social workers.

The lack of a simple census for this most vulnerable group, means their needs are not quantified, not budgeted for and not addressed in a meaningful, targeted way. They are statistically invisible and therefore, politically

irrelevant. India must treat the human rights of its mentally ill population as a national emergency, not a niche social welfare concern. A national-level, urgent census of the destitute mentally ill on our streets must be mandated and executed to ensure that every forgotten soul is counted, rescued and provided the dignified care they are legally and morally entitled to.

Yet the undeniable fact remains: BLOs, the backbone of India's electoral machinery, are being sacrificed to bureaucratic rigidity and political indifference. This unfolding crisis is not merely administra-

Chhatrapati Sambhajinagar, Dec 4: A farmer in Maharashtra's Chhatrapati Sambhajinagar has found out a way to raise his income - by adding a touch of doorstep service instead of solely depending on the traditional agricultural

This farmer-turned-entrepreneur, Shivaji Kurhe, who hails from Washim district in the Vidarbha region, has added a unique service, in which he



grinds the turmeric cultivated in his farm before people as per their order, providing a winwin situation to both.

Talking to PTI, Kurhe said, "I grow turmeric in my farm and take the ready crop to the doorstep of people. As per the order, I grind the turmeric before the customers with the help of a grinding machine fitted on my vehicle. On an average, I sell around 50 kilos of turmeric powder each day.

If farmers sell their cultivated crops to traders in the market, then they get low returns But if they reach out to people and sell their produce, their earnings will rise significantly, and there will be no need for a

farm loan waiver, he said. "If I sell this turmeric to a trader in the market, they will offer me ₹130 per kilogram in return. But as I go door-to-door to grind the turmeric then and there as per the order, it gives me ₹300 per kilo in return, which is almost double." Kurhe added.

"Earlier I used to sell 20 kilograms of turmeric per day and

on a two-wheeler. But now I got a vehicle from Punjab at a cost of ₹2.5 lakh, which provides storage space so I am able to sell at least 50 kilos of turmeric powder every day," he said.

Farmers can increase their income if they take their products to consumers directly in a similar way, he opined.

But the government needs to provide uninterrupted power supply to farmers so that the crops can be watered any time, Kurhe demanded.

The added service provided by Kurhe is making customers happy, as they feel that they do not need to worry about the authenticity.

Sandhya Waghmare, who purchases turmeric powder from Kurhe, told PTI, "The turmeric I purchased is organic and he grinds it in front of us. This turmeric powder is genuine with natural colour, while the one sold in the market could be adulterated. This powder is cleaner and softer as compared to the one sold in the market.'

Ajanta Caves must be preserved for generations: Robert Gill descendant

Robert Gill, a British army officer, was commissioned by the Royal Asiatic Society to create a pictorial record of the Ajanta cave murals in 1845-46

Sambhaii-Chhatrapati nagar, Dec 4: The Ajanta cave complex is a heritage that must be cherished and preserved for generations to come, according to Kenneth Ducatel, the great-great-grandson of renowned photographer and painter Major Robert Gill, who had documented the caves for years.

Robert Gill, a British army officer, was commissioned by the Royal Asiatic Society to create a pictorial record of the Ajanta cave murals in 1845-46. He lived in these ancient Buddhist monuments for decades to complete this task. Four of his paintings are preserved at the Victoria and Albert Museum of London, an official said.

Kenneth arrived in Chhatrapati Sambhaiinagar with Catharina, whom he married two months ago, and visited Ajanta Caves Tuesday. They went to Ellora, Bibi Ka Maqbara and Devgiri (Daultabad fort) Wednesday. The couple is on a

three-week tour of India, their guide Bharat Joshi told PTI.

"He visited the grave of Paro, who assisted Major Robert Gill in his work inside Ajanta caves in the 19th century," he added. In the visitors' book at

Aianta Caves, Kenneth wrote, "Safeguarding this magnificent treasure of the world is a great responsibility, and you are fulfilling it with exceptional passion and expertise. This heritage must be cherished and preserved for generations to come."

Kenneth, who lives in Belgium after retiring from a government job there, said visiting the UNESCO World Heritage site was a long-held wish he has finally fulfilled. "While I was growing up, I

knew that we had an Indian connection and one of my cousins did research and reached back to Robert Gill. Later, I went through his work and the four paintings preserved in the Victoria and Albert Museum of London," he told PTI.

"Kind reception by the people

speechless after seeing the caves. The cultural heritage here is very clear to see. It is also amazing that Major Robert Gill stayed in such a remote location (Ajanta) for so many years," he said.

Recalling a photograph of Robert Hill in a suit, Kenneth said he wondered how his great-great-grandfather could survive in this heat with such clothing.

"He had a love affair with India and Indians. Ajanta is something which you can visit many times. I will invite the rest of my family here," he said. When asked about his visit to Paro's grave in Ajanta Village, he said there are many stories concerning Paro there. "As far as I understand, Paro was a lady who understood how things worked in this area. She helped prepare colours (for Major Robert Gill). She was an unseen assistant but an important lady for Gill and

Ajanta Caves," he said. About his visit to other monuments in Chhatrapati Sambhajinagar, Kenneth said, "The cultural heritage here is very interesting. We were also surprised to see non-Indian visitors here. It deserves a bigger reputation than it has.

Wildlife group to reintroduce 2 vulture species in Assam

Mumbai, Dec 4: A leading Mumbai-based wildlife research organisation is working on a plan to release vultures in Assam as part of its conservation breeding programme across India targeted at the protected bird species.

The Bombay Natural History Society (BNHS) said so far, it has raised over 800 vultures in its conservation breeding centres across India. The 142-year-old research organisation is giving final shape to its plan of releasing vultures in Assam, where they will be serving common cattle owners, farmers and people of the state, a BNHS release said Thursday.

BNHS scientists intend to release Slender-billed and White-rumped vultures in the north-eastern state next month, said the release. A team from the conservation group, supported by the Royal Society for Protection of Birds (RSPB) and the Assam Forest Department, is working consistently to prepare ground for the release of the birds. As part of the programme, multiple BNHS teams are conducting village-level meetings and educating villagers about vultures and their importance, it said.

Senior scientist and BNHS deputy director Sachin Ranade said, "Two species of vultures - Slender-billed and Whiterumped, have been successfully bred in captivity. We are working with local communities to save the vultures in their natural habitats. Currently, we are working on the reintroduction of these two species.



The release of aviaries is set now, and the vultures will be released in a scientific way termed as 'Soft Release Method'.'

Problems such as using non-steroidal anti-inflammatory drugs (NSAIDs) like diclofenac, aceclofenac, ketoprofen and nimesulide, and pesticides were highlighted during BNHS's educational campaign on vulture conservation, he maintained. Notably, vultures can die from eating the

carcasses of cattle that were given certain anti-inflammatory drugs. These birds are scavengers and consume carcasses, thus preventing the spread of diseases and contamination of water sources.

Ranade explained how veterinarians have to play an important role in practising the right way of treating domestic cattle. "They and their assistants (parayets), who actually handle medicines for livestock, play a valuable role. We are requesting them to advocate and use only vulture-safe medicines like meloxicam, tolfenamic acid in cattle treatment, and ensure the cattle and their carcasses do not have any harmful residues for vultures," insisted the senior scientist.

BLOs seek deadline extension

Kolkata: Chaos and tension prevailed yet again before the central Kolkata office of the Chief Electoral Officer, West Bengal, Thursday afternoon after a group of over 400 Booth Level Officers (BLOs) breached police barricades to march towards the building, blocking its main entrance and holding a sit-in. Seeking an audience with CEO Manoj Agarwal, the protesters demanded further extension of the enumeration deadline of the ongoing SIR exercise by at least three months, citing 'inhuman work-related stress". Accompanied by family members of the four BLOs in the state, who allegedly died unable to cope with SIR-related work stress, the agitators - rallying under the banner of the TMC-leaning 'BLO Aikya Manch' (BLO Unity Forum) - also demanded adequate compensation to the next of kin of the deceased. This is the second such protest at the CEO's office in 10 days despite the Election Commission directing Kolkata Police Commissioner Manoj Kumar Verma to ensure safety and security of officers and staff at the office of the CEO, following a security breach by protesting BLOs on the premises November 24. The EC has already extended the deadline of the enumeration phase of SIR, and the subsequent publication of draft and final rolls by seven days.

Sankaranarayanan said moreover, the EC officials are also getting FIRs lodged against the BLOs if they fail to perform their duties

The CJI said the states may consider deploying additional staff, so that the work pressure is eased.

"In case they are facing hardships, including being overburas well as the additional duties assigned by the Election Commission, the state government can obviate such hardships,' the bench noted.

The states may consider the 'desirability of deputing additional staff at the disposal of the EC, so that the working hours can be proportionately reduced", an order issued by the court said.

The bench said if any employee has any "specific reason" for seeking exemption from the SIR duty, the competent officer of the state can consider such requests on a case-to-case basis and replace such an employee with another.

"However, it shall not be construed or understood as if they can withdraw the employees who have been assigned the duty if their substitutes are not provided," it added. The court further said the

states where the Special Intensive Revision (SIR) of the electoral rolls is underway, "shall be obligated to deploy the requisite workforce at the disposal of the EC, though the strength of such employees can be increased as explained above".

The bench disposed of the plea, saving the other pravers like seeking ex-gratia compensation for the BLOs who died during SIR duties can be revived later, either by the aggrieved persons or the petitioner, by filing another application at a later stage.

No cess on essential goods; states to share revenue: FM

New Delhi, Dec 4: Finance Minister Nirmala Sitharaman Thursday said the proposed Health and National Security Cess will be levied only on demerit goods, like pan masala, and not on essential commodities, and revenue from the levy will be shared with states for spending on health schemes.

The purpose of the Health Security se National Security Cess Bill, 2025, is to create a "dedicated and predictable resource stream" for two domains of national importance -- health and national security, Sitharaman said while moving the Bill in the Lok Sabha.

"This is a cess, and it is placed not on any essential commodity. The purpose of this Bill is to levy a cess on demerit goods, which are associated with significant health risks. We wish to impose such a cost, so that it is a deterrent, so people tend not to use it," the minister said. Sitharaman said pan masala will be taxed at the maximum 40 per cent rate under Goods and Services Tax (GST) based on its consumption, and there will be no impact of this cess on GST revenues.

The proposed Health and



National Security Cess, which will be over and above the GST will be levied on the production capacity of machines in pan masala manufacturing factories.

"The cess liability will be different for every factory, depending on their production capacity," Sitharaman said.

Since GST is levied at the consumption stage, and excise duty cannot be levied on pan masala, this cess is being sought to be levied on the production capacity of pan masala units, which is a demerit good."Part of the revenue from this cess will be shared with states through health awareness or other health-related schemes/activities," Sitharaman pointed out.

Sitharaman said that since excise duty cannot be levied on pan masala, the government is bringing a separate cess bill to ensure that production of pan masala is taxed, along with GST which is levied on consumption

Russian Edu Agency opens Indian branch to deepen cultural ties

New Delhi, Dec 4: The Russian Education Agency, a joint initiative of Synergy Corporation and Innopraktika.India announced Thursday the opening of its branch here to deepen cultural and educational ties between India and Russia and support Indian students seeking admission to Russian universities.

According to the agency, the New Delhi office will function as a dedicated support centre for Indian applicants, offering guidance on choosing academic programmes and universities, completing admission formalities, securing visas and handling other required documentation. The initiative is expected to streamline the process for Indian students as piring to pursue higher education in Russia. Mamkootathil ousted from Congress

Court dismisses bail plea in rape case

Thiruvananthapuram, Dec 4: The Congress Friday expelled suspended MLA Rahul Mamkootathil, who is accused of rape, from the party's primary membership, shortly after a local court dismissed his anticipatory bail plea.

The party, which has been under attack from the CPI(M)led LDF and the BJP over the issue at a time when it hopes to establish dominance in the local body polls next week, urged Mamkootathil, who is currently absconding, to resign from his Palakkad Assembly seat.

The party's action also followed a fresh rape case registered against Mamkootathil a day earlier on the basis of a complaint received by the party from a 23-year-old woman. The Congress leadership had forwarded the complaint to the police.

"Rahul Mamkootathil, who is currently under suspension, has been expelled from the primary membership of the Congress based on the serious complaints and the cases registered against him," KPCC president Sunny Joseph MLA said in a statement.

He said the expulsion was



carried out with the approval of the All India Congress Committee (AICC). Mamkootathil, who was sworn in as an MLA December 4, 2024, was expelled from the party exactly one year later December 4, 2025

Earlier, tightening the noose around Mamkootathil, Thirutrict and Sessions Court Judge Nazeera S, after hearing the prosecution and defence counsels for two days, decided to dismiss his anticipatory bail plea.

Both sides produced several pieces of evidence, including audio clips and chat details.

Mamkootathil's counsel maintained that the relationship was consensual, while the prosecution focused on the allegation that he forced the woman to abort the pregnancy by consuming pills.

As the prosecution had relied on material not previously submitted before the court, the judge directed counsel to present the additional documents.

New Delhi, Dec 4: A new study has found that the number of hours when Delhi recorded air quality in the "severe" category has tripled since 2010, with the shift in stubble burning timing due to the 2009 Groundwater Conservation Policy implemented by Punjab and Haryana.

The 2009 Groundwater Conservation Policy in Punjab and Haryana delayed paddy sowing, shortening the harvest and planting cycle and forcing farmers to burn crop residue in early to mid November instead of late October

The study, 'The role of atmospheric feedback and groundwater conservation policies in degrading air quality in Delhi',



says the shift raised the daily 4 pm air quality index (AQI) by around 90 points and increased the number of "severe" hours

by 275 per cent -- rising from 89 hours to 334 hours after the change in burning patterns. According to the research

conducted by the Indian Institute of Tropical Meteorology, the National Centre for Atmospheric Research in the United States and the Commission for Air Quality Management, the timing shift in burning of crop residue intensified Delhi's exposure to crop fire smoke during a period of naturally poorer atmospheric ventilation.

According to the study, this new burning window coincides with cooler temperatures, weaker winds and a much lower boundary layer, conditions that trap pollution near the surface. The research notes that this shift in burning timing

contributed to a significant rise

in daily average PM 2.5 levels in Delhi. The study reports that in the post-2010 scenario PM 2.5 levels increased by about 60 micrograms per cubic metre, which is an increase of 36 per cent compared to the pre-2010 period. The researchers examined Delhi's air quality during the stubble burning season for five years from 2017 to 2021 using a high resolution atmo spheric model.

They compared post-groundwater conservation policy timing, when fires occur in early to mid November, with a scenario where fires were shifted 15 days earlier as they did before 2010, the study said.

Singh was contacted by 'Ankita Sharma' when he was still a Subedar in the Indian Army in the Nagaland city of Dimapur in 2022, said the official in a press conference here. "Singh then took up the job of

a security guard in Goa after his retirement. After befriending him and winning his trust, the Pakistani agent requested sensi tive information, such as move ments of regiments and transfers of key Army officers," he said.



Xi-Macron pledge deeper cooperation

Beijing: China and France pledged deeper cooperation on global issues like the war in Ukraine and trade, as France prepares to take on the presidency of the Group of Seven next year. French President Emmanuel Macron met with China's Xi Jinping Thursday morning as part of a three-day state visit focusing on trade and diplomacy. The French leader is seeking to involve Beijing in pressuring Russia toward a ceasefire with Ukraine after a recent burst of diplomacy around a US-led peace plan."We are facing the risk of the disintegration of the international order that brought peace to the world for decades, and in this context, the dialogue between China and France is even more essential than ever," Macron said Thursday.

Hong Kong blaze toll climbs to 159

Hongkong: The death toll in Hong Kong's deadliest fire in decades hit 159 Wednesday, with police revealing that victims included an infant and a 97-year-old as they continued their search for remains in the scorched apartment complex. Residents forced to flee the only block of the eight not engulfed in flames a week ago returned briefly to their homes to retrieve belongings, as hundreds of others housed in temporary accommodation struggled to rebuild their lives. Meanwhile, investigators uncovered more bodies in the ruins, some of which have been found on rooftops and stairwells and others reduced to nothing more than ashes, authorities said. Of the 159 bodies found, 140 have been identified. They comprise 91 females and 49 males, aged between one and 97 years.

UK targets Russian

spy networks London: The UK unveiled sanctions in a new crackdown on Russia's spy networks in the country after a public inquiry concluded Thursday that a Novichok poisoning attack in Salisbury over seven vears ago was authorised by President Vladimir Putin. Prime Minister Keir Starmer condemned Russia's "reckless aggression" in the March 2018 assassination attempt targeted at former Russian spy Sergei Skripal, who survived the poisoning attempt, which later claimed the life of British national Dawn Sturgess. The UK Foreign Office said that the Russian Ambassador to the UK, Andrey Kelin, had also been summoned to answer for "Russia's ongoing campaign of hostile activity against the UK", "The Salisbury poisonings shocked the nation and today's findings are a grave reminder of the Kremlin's disregard for

innocent lives." Starmer said

After fee blow, Trump hikes H-1B visa vetting

US administration orders H-1B, H-4 visa applicants to make social media profiles public

Washington, Dec 4: The US government has expanded screening and vetting measures for H-1B visa applicants and their H-4 dependents, directing them to keep the privacy settings on all their social media profiles set to "public". In a new order issued

Wednesday, the State Department said beginning December 15, a review of the online presence for all H-1B applicants and their dependents will be conducted. Students and exchange vis-

itors were already subject to such scrutiny, which has now been extended to include those applying for H-1B and H-4 visas.

"To facilitate this vetting, all applicants for H-1B and their dependents (H-4), F, M, and J nonimmigrant visas are instructed to adjust the privacy settings on all of their social media profiles to 'public'," the State Department said.

Underscoring that a US visa is a privilege and not a right, the department said it uses all available information in screening and vetting to identify visa applicants who are inadmissible or pose a threat to America's national security or public safety.

"Every visa adjudication is a national security decision," it said. The department said the

US "must be vigilant" to ensure applicants do not intend to harm Americans and that all visa applicants credibly establish eligibility and intent to comply with the terms of their admission.

The directive is the latest in a series of steps by the Trump administration to tighten immigration rules. The administration has launched a massive crackdown to check abuse of the H-1B visa programme, used largely by US technology companies to hire foreign workers.

Indian professionals, including tech workers and physicians, form one of the largest groups of H-1B visa holders.

In September, US President Donald Trump issued a proclamation, titled 'Restriction on Entry of Certain Nonimmigrant Workers', imposing a one-time \$100,000 fee on new H-1B work visas, an order that could significantly impact Indian workers seeking temporary employment in the US.

Separately, Washington has also paused with immediate effect Green Card, US citizenship and other immigration applications for people hailing from 19 "countries of concern", following the shooting of National Guard soldiers by an Afghan national. A policy memorandum issued Tuesday directs the US Citizenship and Immigration Services (USCIS) to "place on hold", effective immediately all asylum applications, regardless of the immigrant's country of nationality, pending a comprehensive review.

The pause also applies to all immigration applications from nationals of 19 countries previously covered by the administration's travel ban.

The applications will be on hold "pending a comprehensive review, regardless of entry date", the directive said.

The new guidance follows the shooting of US Army Specialist Sarah Beckstrom, 20, and US Air Force Staff Sgt Andrew Wolfe, 24. Beckstrom succumbed to her injuries, Trump said Thursday during a Thanksgiving call with service members, while Wolfe remains in critical condition.

Doc who sold ketamine to 'Friends' star Perry gets 2.5 years in prison

Los Angeles, Dec 4: A doctor who pleaded guilty to selling ketamine to Matthew Perry in the weeks before the "Friends" star's overdose death was sentenced to two and a half years

Judge Sherilyn Peace Garnett handed down the sentence plus two years of probation to 44-vear-old Dr. Salvador Plasencia in a federal courtroom in Los Angeles Wednesday.

The judge emphasised that Plasencia didn't provide the ketamine that killed Perry, but told him, "You and others helped Mr Perry on the road to such an ending by continuing to feed his ketamine addiction.

You exploited Mr Perry's addiction for your own profit," she said. Plasencia was led from the courtroom in handcuffs as his mother cried loudly in the audi ence. He might have arranged a date to surrender, but his lawvers said he was prepared to do it today. Perry's mother and two half sisters gave tearful victim impact statements before the sentencing. "The world mourns my brother," Madeleine Morrison said "He was everyone's favourite friend." Plasencia was the first to be sentenced of the five defendants who have pleaded guilty in connection with Perry's death at age 54 in 2023.

The doctor admitted to take ing advantage of Perry, knowing he was a struggling addict. Plasencia texted another doctor that Perry was a "moron" who could be exploited for money. according to court filings



India abstains on UN call to return Ukrainian children

United Nations, Dec 4: India abstained in the UN General Assembly from a draft resolution that demanded that Russia ensure the immediate, safe and unconditional return of all Ukrainian children forcibly transferred or deported since the start of the war.

The 193-member General Assembly adopted the draft resolution 'Return of Ukrainian children' Wednesday, with 91 votes in favour, 12 against and 57 abstentions.

India was among the nations that abstained in the UNGA on the resolution, along with Bahrain, Bangladesh, Brazil, China, Egypt, Maldives, Nepal, Pakistan and Sri Lanka.

The resolution expressed deep concern about the impact of the war on children, in particular the fate of all Ukrainian children who have been separated from their fam-

ilies since 2014. including those forcibly transferred within the temporarily occupied territory of Ukraine by Russia and those deported to Russia.

The resolution demanded that Russia "ensure the immediate. safe and unconditional return

of all Ukrainian children who have been forcibly transferred or deported" and urged Moscow to cease, without delay, any further practice of forcible transfer, deportation, separation from families and legal guardians, change of personal status, including through citizenship, adoption or placement in foster families, and indoctrination of

Pakistan PM formally asks prez to appoint **Munir as first CDF**

Islamabad, Dec 4: Prime Minister Shehbaz Sharif Thursday formally asked President Asif Ali Zardari to appoint Chief of the Army Staff (COAS) Field Marshal Asim Munir as the first Chief of Defence Forces (CDF) of Pakistan.

Last month, the parliament passed the 27th Constitutional Amendment providing to create the post of CDF with the objective to create unity of command and expedite the decision making in any critical situation.

The CDF replaced the Chairman, Joint Chiefs of Staff Committee (CJCSC), the post for which was abolished.

According to a statement by the PM Office, the prime minister approved the summary for the appointment of Field Marshal Munir as the army chief and the CDF, and then referred it to the President House.

After approval by the president, the COAS would also become the CDF as the changes in the constitution vested the dual authority in the same person.

CALLS GROW TO FIGHT DEFORESTATION

Asia flood death toll surpasses 1,500

Padang, Dec 4: Deaths from last week's catastrophic floods and landslides in parts of Asia surged past 1,500 Thursday as rescue teams raced to reach survivors isolated by the disaster with hundreds of people still unaccounted for across the region.

The tragedy of so much death and destruction was compounded by warnings that decades of deforestation caused by unchecked development, mining and palm oil plantations may have worsened the devastation. Calls grew for the government to act.

"We need the government to investigate and fix forest management," said Rangga Adiputra, a 31-year-old teacher whose home in West Sumatra was swept away. The hills above his village on the outskirts of Padang city had been scarred by illegal logging.

'We don't want this costly disaster to happen again," he said. Authorities said 837 people were confirmed dead in Indonesia, 479 in Sri Lanka and 185 in Thailand, as well as three in Malaysia.

Many villages in Indonesia



and Sri Lanka remained buried under mud and debris, with 861 people still unaccounted for in both countries. Thousands reportedly faced severe shortages of food and clean water in cut off areas. The floods and landslides washed away roads and bridges and knocked out telecommunications, leaving many communities inaccessible.

Indonesian television showed images of huge amounts of felled timber carried downstream in North Sumatra, West Sumatra and Aceh provinces.

The leading Indonesian environmental group WALHI said that decades of deforestation driven by mining, palm oil plantations, and illegal logging — stripped away natural defences that once absorbed rainfall and stabilised soil.

"The disaster was not just

nature's fury, it was amplified by decades of deforestation, said Rianda Purba, an activist with the group. "Deforestation and unchecked development have stripped Sumatra of its resilience.

The group recorded more than 240,000 hectares (nearly 600,000 acres) of primary forest were lost in 2024 alone, leaving Sumatra's small river basins dangerously exposed. Another environmental group, Global Forest Watch has said the flood-inundated Indonesian provinces of Aceh North Sumatra and West Suma tra have since 2000 lost 19,600 sq km (7,569 square miles) of forest an area larger than the state of

New Jersey. "Unless restoration begins now, more lives will be lost, Purba warned. Massive piles of neatly cut timber lay scattered among the debris across Parkit Beach, a sight that stunned emer gency crews deployed to the area

"From their shape, it was clear these were not just trees torn out naturally by the flood, but timber that had been deliberately cut," said a member of a clean-up crew, Neviana, who goes by a single name

Root ends century drought Down Under

England great's first century in Australia tops Starc's 6 wickets as England takes honours on Day 1

Brisbane, Dec 4: Joe Root posted a long-awaited first Ashes century in Australia to give England the honors on Day 1 of the second

Mitchell Starc's six wickets. Starc removed Ben Duckett and Ollie Pope to have England reeling at 5-2 in the

third over Thursday. That's when Root went to the crease and set about restoring the England innings, and confidence, following the series-opening eight-wicket loss in Perth.

His unbeaten 135 led England to 325-9 at stumps, with No 11 Jofra Archer at a career-best 32 in an unbroken 61-run last-wicket stand.

Zac Crawley, who helped Root get England's revival going in a 117-run third-wicket stand, described his teammate's century as a "phenomenal "He

coming off two ducks in Perth, scored 76 from 93 balls and was outscoring Root before he attempted an extravagant pull shot and got an under edge through to the keeper just after the first interval. Brook was caught at slip

slashing outside off stump and falling for 31 from 33 balls to end a 54-run fourth-wicket partnership with Root just as the sun was going down.

Root's highest test score in 15 previous Ashes tests in Austraia was 89, and the local media had taken every chance in recent weeks to remind him of his missing milestone.

Jaipur, Dec 4: Young women's hockey player Nikita Toppo stands out not just for her exploits in the midfield but also for her resilience in overcoming tough times and a career-threatening injury early

in her playing career. The 22-year-old skipper played a pivotal role in helping Kalinga Institute of Industrial Technology (KIIT) clinch the women's hockey gold in the institution's maiden appearance at the Khelo India University Games here

Nikita lost her parents when she was five years old, while one of her elder brothers died in an accident when she was on her way to U-23 Five-Nations Cup in Ireland three years ago. A year later, she suffered a career-threatening injury and soon after her other brother met with an accident and suffered a skull injury from which he hasn't completely recovered vet.

But instead of getting bogged down by the series of setbacks, Nikita found solace in hockey.

"Before this (success at the KIUG), we would not clear our zone as there are many good university teams in Odisha. But from last year onwards, me and my coach have been working on building a strong team by getting good players to take admission in our university. Before we came here,



we were determined to win the title here," Nikita said after her team defeated ITM University, Gwalior, to take the top spot.

Nikita controlled the pace of the game in the final in the defensive midfielder's role and ensured the ITM players could not penetrate her team's citadel.

However, it's not just Nikita's hockey skills but the clarity of thought and resilience that set her apart.

"I believe what happened, happened, and we can't change it. I focus on the present and accept the situation. I remain strong for my team and my family, or what's left of it, and I don't shed a tear because I don't want my insecurities and unfortunate incidents to take over me and cloud my mind," she said

about her personal setbacks.

"What happened to my brother

in 2022 was heartbreaking. But I didn't let it pull me down, and I didn't want my team to suffer because of me. No matter how much I miss him, he won't come back," added Nikita, who could not even attend his last rites.

The Indian team then won a silver medal in the U-23 Five-Nations Cup.

Nikita, whose hockey career started when she joined the Government Sports Hostel in Panposh, Rourkela, in 2016, was also part of the Indian U-21 team that won four matches and drew one during their South Africa tour in 2023.

Nikita's short-term goal now is to participate in the Senior Nationals for Odisha and win a medal, while her long-term ob jective is to represent India in major competitions and secure a stable job.
