Leopard rescued from trap dies



Angul, Dec 9: A middle-aged male leopard died Tuesday after being rescued from an illegal trap set by suspected poachers in a forest under Karatapata beat of Purunagada section in Angul Range.

Forest officials said the leopard was caught late Monday night in a trap made of galvanised wire near Chanamalina Nullah, close to Dimiripal village. Locals reportedly heard the big cat's roar early Tuesday and alerted the Forest department personnel, who located the trapped leopard using a drone camera. Officials said the animal sustained severe iniuries while attempting to free itself from the trap. It was tranquilised and rescued before being taken to Kulasingha nursery near Purunagada for treatment. However, the leopard died

due to internal bleeding caused by pressure wounds on its abdomen, confirmed Angul divisional forest officer (DFO) Nitish Kumar. The postmortem was conducted by departmental veterinary officer Debasis Panda.

The incident has raised serious concerns about poaching and forest surveillance, especially given the forest's proximity to Satkosia Wildlife Sanctuary. Villagers expressed shock at how poachers managed to set traps so close to protected areas. They said they had never noticed any traps or leopards in the area and discovered the animal after hearing dogs bark and the leopard roar while heading to their farmlands.

Forest authorities are investigating the matter and have intensified patrolling in vul-

CAG flags dropout, infra woes in schools

Bhubaneswar, Dec 9: The Comptroller and Auditor General (CAG) of India has found student dropout, lack of proper infrastructure, and low student-teacher ratio in government-run schools in the state, and observed that the objective of universal access to school education was not achieved in

The CAG carried out a performance audit of 108 government schools in 12 blocks of Bhadrak, Koraput, Nabarangpur, Nuapada, Sambalpur and Subarnapur districts. It noticed that the objective of universal access to school education was not achieved in the state due to the dropout of students at different levels of education.

Teachers, who play a pivotal role in the schooling system, were not available in schools according to norms, hampering the quality of education in government and government-aided schools.

Gross enrolment ratio in secondary and higher secondary school levels declined in the state, compared to a rise at the

The CAG also found that the student dropout across the classes (Class-II to XII) ranged from 3.12 to 7.26 per cent between 2018 and 2023.

Reacting on the issue, edu cationist Naba Kishore Pujari said, "The CAG report highlights government's negligence toward school education. Surrender of 18% funds, poor util isation of Samagra Shiksha Abhiyan, declining enrolment and over 21,000 schools with inadequate pupil-teacher ratio show the poor state of school education. Strengthening School Management Committees proper budgeting, teacher re cruitment, and meeting teachers' demands are essential to address these issues.'

Similarly, another educationist Basudev Bhat said. "The report exposes a systemic collapse in Odisha's school education. Less than 50% of Samagra Shiksha Abhiyar budget is used, and hundreds of crores go unspent each year Schools lack basic facilities like ramps and toilets, and funds for CwSN children are misused. Threat to BLOs will Winter Session ends 18 cause anarchy: SC days ahead of schedule

New Delhi, Dec 9: At a time when the country has witnessed at least 30 booth-level officer (BLO) deaths under duress across 12 states during the Election Commission's second-phase Special Intensive Revision (SIR) exercise, the Supreme Court Tuesday voiced serious concern over the alleged lack of cooperation from state governments. The bench asked the EC to report any instance of non-cooperation or obstruction affecting the work of BLOs, assuring that the court would intervene wherever necessary. When the EC's counsel suggested that the pressure on BLOs stemmed partly from interference by political parties and other external factors, Chief Justice Surya Kant made it clear that the court does not wish to be drawn into a political blame game. "Deal with the situation or it will cause anarchy. Bring the impediments to the functioning



of BLOs to our notice, and we will address them," the CJI said. A bench of CJI Surya Kant

and Joymalya Bagchi said, 'What we want to ensure is that the SIR is done on the ground without any glitches.' "Bring to our notice instanc-

es of lack of cooperation, hindrances to work of BLOs and we will pass appropriate orders,' the bench told senior advocate Rakesh Dwivedi, appearing for the Election Commission (EC). Dwivedi submitted, "The

state governments are supposed to cooperate with us and give us protection. If the state government refuses to do so, then we have no option other

Justice Bagchi said the poll panel cannot take the police under its jurisdiction until the commencement of the poll process.

Dwivedi said the EC has all constitutional powers to deal with instances of BLOs and other officials engaged in SIR work being threatened.

"Deal with the situation or it will cause anarchy," CJI Kant told Dwivedi, terming the situation "very serious"

Senior advocate V Giri, appearing for petitioner Sanatani Sangsad and others, pointed out that the petitioners have alleged violence and threats against BLOs and other officials engaged in SIR work and sought directions to the EC to protect them. Justice Bagchi said the poll panel cannot take the police under its jurisdiction until the commencement of the election process.






Odisha Assembly adopts resolution; Salary, allowance for legislators hiked Oppn stages walkout after 2 stanzas

Bhubaneswar, Dec 9: The Odisha Assembly Tuesday unanimously adopted a resolution authorising the state government to undertake a year-long celebration of the 150th anniversary of the national song, 'Vande Mataram', to instil patriotism among the youth, children and

The resolution was moved by Culture Minister Suryabanshi Suraj and was adopted with support of both the BJD and Congress after a brief discussion.

'Vande Mataram' was then being played on the speaker system, and all the legislators, standing in respect, sang it. However, after the two stanzas which have been adopted by the Constituent Assembly as the national song -- the members of the two opposition parties staged a walkout. The remaining portion of the song continued to be played and BJP MLAs remained standing. The BJD and Congress members later returned to the

Kadam lashed out at the BJP government at the Centre and in the state, and accused them of adopting a ploy to divert attention of the nation from burning issues like falling value of rupee, SIR of the electoral rolls and the Indigo fiasco. By

Mataram is a symbol of patriotism, sacrifice and devotion to the country. This song became so popular that the British government banned it out of fear. Although it has been given the status of the national song since independence, there have been attempts by some

vested interests to diminish its importance, especially in post-independence India".

Therefore, Majhi said that Prime Minister Narendra Modi has decided to celebrate 150 years of 'Vande Mataram' to rekindle the feelings of patriotism among the countrymen.

"Whatever language we belong to, whatever religion we belong to or whatev-

er region we belong to - if there is no feeling of patriotism among us, then the inclusive development of the country is impossible," Majhi said.

Stating that 'Vande Mataram' is also a source of collective resolve, he urged everyone to unite and work towards making India a fully developed nation by 2047. The culture minister said that Odisha's was the 'karma Bhoomi' of Bankim Chandra Chaterjee, as he worked as a government officer in Jajpur district.

518 migrant workers died in past 5yrs

Bhubaneswar: At least 518 migrant workers from Odisha died while working outside the state between 2021 and November this year, the Assembly was informed Tuesday.

Replying to a written question by BJD MLA Arun Kumar Sahoo, Labour and Employees' State Insurance Minister Ganesh Ram Singkhuntia said the mortal remains of 395 workers were brought back to their native places during the period.

Khuntia said Kalahandi reported the highest number of deaths at 60, followed by Berhampur in Ganjam district with

56, Bolangir (38), Nabarangpur (35), Kalahandi and Rayagada (34 each), and Chhatrapur area in Ganjam district (26). The minister said 1,107 contractors were issued licenses in 2025 (till November) under the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979, facilitating the migration of 70,360 workers to other states. According to the minister, 5,45,816 workers from Bolangir district migrated to other states for work in 2025, followed by Nuapada district (8,655), Ganjam (2,553), Bargarh (1459) and Dhenkanal (1064).

HC notice to state over OAS, ORS officers' strike

Bhubaneswar, Dec 9: The Orissa High Court issued notice to Chief Secretary Tuesday, acting on a public interest litigation seeking legal action against the government officials who went on strike to paralyse the administrative functions for several days in June. A division bench of Chief Jus-

tice Harish Tandon and Justice MS Raman, taking cognisance of a PIL filed by Cuttack-based social activist Pratap Chandra Sahoo, asked the government to comply with a report in this Registering a strong protest

against the assault on a senior official of the Bhubaneswar Municipal Corporation (BMC) June



30 by local BJP men, the Odisha Administrative Service Association (OASA) and Revenue officials resorted to cease work by availing en masse leave seeking arrest of a local BJP leader and protection of officers for smoothly discharging their official duty. With the administrative officers abstaining from duty, the day-to-day functioning of public

offices in the district headquarters, sub-division, and blocks have come to a near-standstill for several days, affecting the general public. The agitation of this nature undermined the rule of law and the directions of the Supreme Court and High Courts. It was also a flagrant violation of the Orissa Government Servants Conduct Rules, 1959, which also prohibits any kind of strike by the government officials, the petitioner's counsel Anup Kumar Mohapatra noted in the petition.

Though several months have passed since the launch of the 'illegal' strike by officials, the state government is sitting over the matter and is yet to initiate disciplinary proceedings against the officials who resorted to the strike to paralyse the admin-

istrative function, Mohapatra argued. The Odisha Administrative Service (OAS) and Odisha Revenue Service (ORS) officers are the backbone when it comes to delivering public services at the block, tehsil, and district level government and their action against hit governance.

The government employees who participated in general strikes, affecting the normal life of the public and public exchequer, are not entitled to be protected under Article 19 (C) of the constitution and are also a violation of the provisions of the Odisha Government Servants' Conduct Rules, 1959, the petition maintained seeking stringent action against those who violated the legal provisions, the petition maintained.

Malkangiri violence: BJD draws parallel with Manipur

Bhubaneswar, Dec 9: Senior BJD MLA Ranendra Pratap Swain Tuesday raised serious concern in the Odisha Assembly over the deteriorating law and order situation in Malkangiri district, describing it as rapidly turning into a "mini-Manipur".

Swain raised the issue of violence in Malkangiri district during the Zero Hour in the Odisha Assembly Tuesday.

Speaking to media persons outside the House, Swain said the district was witnessing growing tribal and ethnic tensions among communities, posing a grave threat to constitutionally guaranteed rights.

He urged the Speaker, as the custodian of the House, to direct the Chief Minister to apprise the Assembly about the prevailing situation in the district where incidents of arson, looting and murders were allegedly taking place in broad daylight. "The situation is extremely

volatile. People are openly mobilising, and it could explode at any moment. Such acts must be controlled with a heavy hand and should not be allowed to continue," Swain said.

Drawing a parallel with the violence in Manipur, the BJD legislator said Malkangiri, being a far-flung and border district of Odisha, require urgent and focused attention from the government. Swain demanded that the state government to clearly outline the steps being taken to restore peace, promote harmony among communities, protect lives and livelihoods, and prevent further escalation.

Two MoUs inked for agri, digital farm services push Centre okays ₹44,771cr for Odisha roads to be a game-changer, significantly improving port access

Bhubaneswar, Dec 9: The Centre Tuesday approved ₹44,771 crore for major national and state highway projects in Odisha, giving a substantial boost to the state's infrastructure. The Ministry of Road Transport and Highways cleared the proposals, aimed at improving connectivity and driving economic growth.

Odisha Law Minister Prithviraj Harichandan and Union Road Transport and Highways Minister Nitin Gadkari reviewed the projects in New Delhi. The projects are expected to be completed in the 2025-26 fiscal, significantly strengthening the state's road network.

One of the major highlights is the 8-lane expansion of the Bhubaneswar-Puri highway, which is expected to ease rising traffic and ensure faster, smoother travel between the twin cities. Another key project is the 6-lane upgrade of the 140 km Tangi–Puitola–Ichhapuram stretch, which will significantly improve regional connectivity



across multiple towns. Additionally, the 400 km Rourkela-Barbil-Paradip corridor, a key route for freight movement to Paradip Port, will be expanded to 8 lanes. A 68 km stretch of NH-149, from Palalahara to Pitiri, will also

be upgraded to 4 lanes to ease

congestion in the area.

Alongside national high ways, several key state highways are also set for upgrades. The Barpali-Bolangir, Kesinga-Bhawanipatna-Junagadh,

and Brahmapur-Kalushundhpur roads will be widened to 4 lanes, ensuring smoother travel across major cities and districts. The Brahmapur-Kalushundhpur stretch, in particular, will further strengthen industrial and commercial connectivity.

In another major development, the government has approved a new Greenfield Road Corridor connecting Bhubaneswar directly to Paradip Port. The corridor is expected cantly improving port access and accelerating trade and economic activity. By linking the state capital with one of Odisha's most crucial ports, the project will greatly strengthen regional connectivity.

Minister Harichandan thanked Union Minister Gadkari for his continued support in strengthening Odisha's road infrastructure He noted that the upcoming expansions will significantly ease transportation across urban and rural areas, while giving a strong push to the state's economic growth.

The approval follows pro ductive deliberations at the Indian Road Congress held in Bhubaneswar in November 2025, where the Centre had al so cleared a ₹1,500-crore plan under the Central Road Infra structure Fund (CRIF). With these fresh sanctions. Odisha's road network is poised for a ma jor upgrade, improving travel efficiency, boosting industrial activity, and strengthening con nectivity across the state.



Girl student consumes poison in classroom, hospitalised

Kashinagar, Dec 9: In a shocking incident, a Class-IX student at Varanasi Government High School in Kashinagar of Gajapati district allegedly attempted suicide by consuming rodent poison in her classroom Tuesday, triggering shockwaves in the area.

The girl, who hails from a nearby village and studying in Class-IX, reportedly consumed the poison while lessons were underway in the class room. She began vomiting, prompting the teacher to check on her. The teacher noticed a packet of rat poison lying near the student and immediately rushed her to the local CHC and later shifted to the district headquarters hospital (DHH) in Paralakhemundi, where her condition is stated to be critical.

When reporters and media personnel arrived at the health center, a teacher present there allegedly refused to share details and prevented them from taking photographs or recording video. This led to allegations that the school is attempting to cover up the incident.Zilla Parishad Chairperson, G Tirupathi Rao visit-



teachers and students about the incident, Assistant Block Education Officer (ABEO) Narmada Das, who was alerted to the situation, also visited the school and discussed the matter with the in-charge Headmaster.

District Education Officer Mayadhar Sahu was also informed about the incident. Acting headmaster R Dilip Kumar said he was not at the school Tuesday. "I was attending a JNV meeting. While I was there, I received information that a girl student at our school had attempted suicide by consuming poison," Kumar said.

After the meeting, he went to the district headquarters hospital in Paralakhemundi to check on the student. He spoke with doctors about her condition and discussed her recovery. Kumar later visited the girl's home, informed her mother about the incident and sought details.

According to the mother, the girl consumed poison due to family discord. However, the exact reason behind the suicide attempt is still unclear.

The school has been without a permanent headmaster for a long time, and Kumar has been serving as in-charge. Residents say the absence of a full-time headmaster has led to repeated complaints about mismanagement. They have urged authorities to take the matter seriously and appoint a permanent headmaster.

District Education Officer Mayadhar Sahu said the girl had been involved in a family dispute since Monday. Upset over the matter, she reportedly bought rodent poison from a shop near the school and consumed it. An investigation is underway, and the exact cause will be known after the inquiry, Sahu said. Her mother also admitted of family dispute.

Fire erupts on moving bus; all passengers safe

Singhpur, Dec 9: A fire broke out on a moving passenger bus at Fatepur under Binjharpur block in Jajpur district Tuesday. All passengers escaped unharmed after quickly jumping off the vehicle.

The private bus, Rahi, had departed from Baramunda bus stand in Bhubaneswar at around 5am and was travelling towards Singhpur. As the bus reached the Fatepur Pokhari Chhak, flames suddenly erupted from the engine.

Locals who noticed the fire immediately signalled the driver to stop the vehicle. The driver, assisted by residents, swiftly brought the blaze under control. Passengers rushed out of the bus moments after it halted.

More than 30 passengers were travelling on the bus at the time of the incident.

The exact cause of the fire is yet to be determined. According to the driver, an electrical wiring fault may have triggered the incident.

He said the vehicle undergoes regular maintenance checks, and the sudden outbreak of fire despite no prior issues has left everyone surprised.

The rider reportedly lost control of the motorcycle while trying to avoid the animal, resulting in a collision that killed the barking deer and left both men seriously injured. Bhanjanagar Police arrived at the scene upon receiving information, rescued the injured duo and admitted them to Bhanjanagar Hospital for treatment. The Forest department seized the carcass and sent it to the local veterinary hospital for post-mortem examination.

Man, son get life terms for murder

Sonepur, Dec 9: A local court in Subarnapur district Tuesday sentenced a man and his son to life imprisonment in the high-profile murder of a co-villager Chaitanya Rana of Tithipali village under Tarabha police limits. The District and Sessions

Judge Dhanurdhar Senapati convicted Daman Rana and his son, Gajapati Rana, based on witness testimony and other evidences. The court also imposed a penalty of ₹10,000 on each of them. If they fail to pay the fine,

they will have to serve an additional six months of rigorous imprisonment, the judge observed while delivering the order. This was stated here by public prosecutor Madhumita Amatya, who pleaded the matter on behalf of the state government

The court acquitted another accused, Santosh Rana, due to lack of evidence.

According to the complaint filed by Chaitanya's wife, the



incident took place March 13, 2018 evening. She alleged that while she and her husband were at home. Daman and Gajapati arrived and dragged Chaitanya outside. They hurled abuses at him and attacked him. Daman allegedly struck Chaitanya on the head with a lathi, while Gajapati attacked him with an axe. Chaitanya died on the spot.

Police registered a murder case over the complaint and arrested Daman, Gajapati and Santosh before producing them in court. The case went to trial in the District and Sessions Court, where the statements of 12 witnesses were recorded.

Stolen idols to return to Gopaljee temple after 42-yrs GOPALJI TEMPLE

Sonepur, Dec 9: Twelve rare and ancient idols stolen 42 years ago from the Gopaljee temple in Sonepur town are finally expected to return to the shrine.

The hope was revived Monday after the Khurda ADJ-3 Court in Bhubaneswar delivered its judgment in the case. Judge Himanshu Mallik issued the order, triggering widespread joy across Subarnapur district.

The Gopaljee Temple, located directly opposite the Sonepur royal palace, houses Lord Gopaljee, the presiding deity of the former royal family. After India's independence and the end of monarchy, the responsibility of the temple fell on the government.

In 1982, 12 valuable idols — including those of Radha, Gopaljee, Garuda and nine other associated deities — were stolen from the temple. The same year, the CBI arrested the thieves at the Delhi airport. The idols were seized near Fatehpuri in Chandni Chowk and were later identified as belonging to the Gopaljee Temple. Since then, they have remained in the CBI storehouse in Bhubaneswar.

Although media reports over the years highlighted the issue, administrative steps to bring the idols back were lacking. The temple committee made several attempts, and the matter eventually reached the courts. The court had advised that the idols be reinstated at the Gopaljee Temple, but the transfer did not take place due to various delays.

However, current district Collector Nruparai Sahu renewed efforts to bring the idols back after learning of the issue. Sonepur sub-collector and endowment officer Soumyarupa Rath also pushed the process forward. With support from Mahant Bansidhar Das, legal advisers and devotees, officials say, the idols are likely to return to the Gopaljee Temple within a day or two.

Concert of Europe

t a crucial juncture when US President Donald Trump seems to be too eager to make Ukraine a sacrificial lamb to the aggrandisement of Russian President Vladimir Putin, three European countries – the UK, France and Germany – made a reassuring gesture by organising a summit of sorts in London December 8 to throw their weight behind Ukraine's President Volodymyr Zelenskyy. UK Prime Minister Sir Keir Starmer, French President Emmanuel Macron and the German Chancellor Friedrich Merz held talks with Zelenskyy. The meeting came in the wake of US efforts to get Kyiv and Moscow to sign up quickly to a plan to end the war in Ukraine.

Kyiv is in an existential crisis as the US brokered plan wants it to cede territory to Russia. While Ukraine doggedly opposes the idea of forking out its own territory, it also wants security guarantees to ensure that Moscow respects an eventual agreement. Starmer lent his voice to the second proposition when he said Ukraine needed "hardedged security guarantees". He has also repeatedly said that Kyiy must determine its own future and not have conditions imposed on it. This is only natural if we understand the current situation that the three European countries are concerned not only for Ukraine's future, but also for the security of the continent as a whole. Their anxiety stems from the fact that if Russia is "rewarded" with Ukrainian territory as part of a peace deal, it could then attack other European countries in the future with similar demands.

The question is whether the three European countries will eventually be able to stand up to Trump's pressure tactic. The visuals of Europe's arguably most influential nations standing shoulder-to-shoulder with Zelenskyy in Downing Street tell only one part of the story. The other part will unfold when they come to Washington. For, the US has made its intentions clear in its National Security Strategy published on December 5 by slamming Europeans for having "unrealistic expectations" as to how the Ukraine-Russia war might end. The three European countries fear, as experts point out, that Trump is interested only in thrashing out a quick fix formula for peace in Ukraine, whereas that could only be a temporary truce which will give fillip to even more Russian intrusions into Europe.

Recent incidents show ominous signs pointing towards that direction. For example, unmanned drones caused chaos in civilian airports in Germany, Denmark, Belgium and elsewhere, while an act of railway sabotage was reported in Poland that could have cost lives. There have also been significant cyber-attacks across the continent. Russia is suspected to be the author of such acts. War in Ukraine seems to be just the tip of the iceberg for Europe. This has strengthened the fears that Russia would like to weaken their continent as a whole.

However, till now such European concerns are not expressed loudly and Europe is walking a tightrope while dealing with Trump. Zelenskyy too is circumspect. He needs both the US and European powers for the survival of his fellow countrymen. He can ill afford to antagonize the unpredictable and bullying US President whereas the three European countries alone may not be able to provide him a sense of security to ward off Russia.

European countries can do nothing independent of the Trump-led US. This is evident from the words of Starmer who praised the US President for his peace negotiations. In a compliment to Trump he said this is "the furthest we've got in the four years" in just a few weeks. German Chancellor Merz, however, expressed scepticism about the peace deal and said it needs to be carefully examined.

In short, European leaders are in no position to incur Trump's wrath even after his flip flops over the US stand on Putin's treatment of Ukraine. Obviously the US is the biggest and most powerful member of Nato. Europe relies on Washington for intelligence, military command and air force capabilities.

The difference in the perception of Russia between Trump and European leaders is making the peace process in Ukraine tortuous. Trump holds the key. He does not have a high opinion of European powers even though he cannot turn his trusted allies into enemies. The question is how long he will listen to them. Putin too may be counting on

air pollution across major urban centres has found that none of the country's top cities met safe AQI levels at any point between 2015 and November 2025. The report, prepared by Climate Trends, analysed long-term pollution patterns across 11 major cities. The case with India is no different with its capital Delhi, as always, remaining the most polluted city throughout the period of study with average AQIA levels peaking above 250 in 2016 and hovering around 180 this year.

Cities such as Lucknow Varanasi and Ahmedabad, which recorded high average AQI values - often above 200 in the first half of the decade, showed some improvement in the second half. While southern and western cities such as Mumbai, Chennai, Pune and Bengaluru recorded relatively moderate AQIA levels, even they did not meet safe thresholds. A recent government report found over 2 lakh cases of acute respiratory illness in six major hospitals in Delhi though other metros such as Mumbai and Chennai find similar increases during periods of high pollution. Experts stressed the need for better planning and data-driven interventions to at least check the problem.

Referring to stubble burning which has gradually gone down in Punjab, Haryana and Rajasthan and that this happens for just a fortnight, the Supreme Court asked the Union and NCR governments to detail the measures taken on other pollution sources such as vehicles, industries, construction, dust and the tangible results through implementation of effective steps in this regard. It was very critical of construction activities and wanted quality public transport to reduce air pollution.

It is worth noting here the report of the Centre for Research on Energy & Clean



As per a study published in The Lancet **Public Health, long-term exposure to air** pollution heightened mortality by 1.5 million deaths per year in the country. Air which has rightly pointed out that, the scale of the crisis far exceeds what is generally assumed. As per the report, about 60 of India's 749 districts breach the national annual PM2.5 standard of 40 micrograms per cubic metre that has been prescribed by the National Ambient Air Quality Standards.

Not a single district meets the far stricter guidelines of WHO, which recommends 5ug/m, about eight times more stringent than India's standards. In fact, air pollution is an annual threat. The northen states such as Punjab, Haryana, Delhi, Himachal Pradesh and the UT of Chandigarh as well as the north-eastern state of Meghalava maintained 100 percent district-level exceedance in all seasons except for

The top 50 most polluted districts are mostly concentrated in four northern and eastern states – Delhi, Haryana, Punjab, Bihar and Assam. The perennial nature of poor air in the country has grave consequences for public health and this has been revealed in various studies, from time to time. Long-term exposure to PM 2.5 is associated with a range of serious diseases including stroke, lung and heart ailments. As per a study published

long-term exposure to air pollution heightened mortality by 1.5 million deaths per year in the country. Despite such alarming findings, public attention and policy urgency remain disproportionately focused on metropolitan India, chiefly the national capital. Along with cities, it is imperative that Indian districts should have robust air-quality monitoring, local emission-control plans, cleaner public transport, stricter regulation of industrial and agricultural emissions, dust & waste management.

and continuity. According to the Air Quality Life Index, it has been found that long-term exposure to current pollution levels cuts almost three-anda-half years from an average Indian's life. Though it is most visible during the winter months, it is active all year round.

China and the United States

have been successful in dramatically cleaning up their environment over time. Smaller nations and younger democracies like The Gambia in Africa have made meaningful progress. Other Asian countries like Japan, Thailand and Singapore have progressed as well. Ultimately, it is for India to take positive steps in this regard as clean air is a true national priority. Experts have suggested that India should work towards a more unified system like US's Air Now and the EU's CAMS for dedicated atmospheric monitoring with the help of air quality sensors, aviation advisories and meteorological data integrated into a single geospatial platform.

Whether the apex court's stricture will help the state governments in implementing the graded action plan (GRAP) in scrupulously enforcing both short-term and long-term measures in tackling air pollution remains to be seen. However, it evident that in most metros and big cities private transport rarely follows government guidelines and there is virtually very little monitoring and enforcement of pollution norms. The state governments do not want to take drastic action against these private operators as otherwise the transport system may collapse. Food choices prove recipe for marital disaster

Ahmedabad, Dec 9: A Gujarat-based couple's 23-year-old marriage ended in a divorce over a long-standing dispute that started in kitchen and was centred around the wife's dietary choice of non-consumption of onion and garlic.

The Gujarat High Court has upheld the divorce verdict of an Ahmedabad family court, capping the long-simmering conflict between the couple over consumption of two of the most common ingredients, onion and garlic.

A division bench of Justices Sangeeta Vishen and Nisha Thakore dismissed the woman's appeal challenging the dissolution of the marriage after she no longer opposed it, as per a HC order dated November 27.

The "trigger point" between the couple was the wife not consuming onion and garlic. The wife submitted in her appeal that the issue revolved around her following a particular re-



ligion (Swaminarayan sect). Followers of this sect do not eat onion and garlic. Since the Ahmedabad-based couple got married in 2002, the husband's mother used to cook food separately for the wife, without onion and garlic, while dishes for other family members were prepared with these two ingredients, as per the court order.

"Following the religion and consumption of onion and garlic was the trigger point of the differences between the parties," it noted.

Though the petition in the HC was filed against the family court order of divorce during hearing, the wife did not object to the dissolution of the mar-

Earlier, the husband had filed an application with the Mahila Police Station in Ahmedabad, stating "torture and harassment" by the appellant (wife). Eventually, the wife left her matrimonial home

with their child in 2007 due to differences with her husband.

In in 2013, the husband filed for divorce in the Ahmedabad family court on the grounds he had been "subjected to cruelty and the wife had deserted him", as per the order.

The family court allowed the divorce in May 20024.

During the HC hearing, the woman submitted that despite a direction by the family court maintenance has not been paid to her for 18 months, it added.

The wife's counsel informed the court that the total outstanding maintenance was ₹13,02,000, of which she had received ₹2,72,000 as interim maintenance. The man had deposited ₹4,27,000 earlier during the litigation.

The HC directed that this amount be transferred to the wife after verification and instructed the husband to deposit the remaining amount with the family court, which will transfer the funds to the woman's bank account.

99.97% SIR work in Gujarat complete

Ahmedabad: The ongoing Special Intensive Revision (SIR) campaign in Gujarat is now 99.97 per cent complete with the verification of all of the state's 5.08 crore voters almost over, in which more than 11.50 lakh duplicate entries were found, the state Chief Electoral Officer (CEO) said Tuesday. The SIR process in the state had begun October 27. More than 11.58 lakh demographically similar entries (DSE) -- or voters whose names are found registered in two or more places -- have been identified with the help of advanced software, and are being verified at the BLO and ERO (booth level and electoral roll) levels, it said in an official statement. In addition, more than 18 lakh deceased voters were found in the electoral rolls, and more than 10.37 lakh voters found absent from their addresses. A total of over 40.47 lakh voters have permanently migrated, the CEO office said. The list of absent, migrated and deceased voters placed on the CEO and district level websites, it added. During the work so far, verification of a total of more than 4.21 lakh senior citizens (above 85 years of age) across all 33 districts of the state is being done, it said. The entire process is scheduled to end on December 11. But even before that, the hard work of the entire election staff from the BLO level to the CEO office has paid off, the release said.



Elaborating on the "result of controlling" the chief election commissioner and the EC, Gandhi said "we have a set of election campaigns that are tailored for the prime minister".



Lockheed Martin to set up C-130J hub in India

New Delhi, Dec 9: US aerospace major Lockheed Martin Tuesday said it plans to set up a facility for the co-production of the C-130J Super Hercules heavy-lift military transport aircraft in India that will be the first such global hub outside the United States.

With the Indian Air Force (IAF) beginning its hunt to procure up to 80 tactical lift transport aircraft, Lockheed Martin pitched the C-130J plane as the best choice for the force as it has been a "reliable workhorse" in India and over 20 other nations.

Robert Toth, the vice president (business development. air mobility and maritime missions) at Lockheed Martin Aeronautics, said the IAF's Medium Transport Aircraft (MTA) programme gives the company an opportunity not only to bring capability to India, but also to further its industrial base.

'We are continuing to invest ahead of MTA in the C-130Js and posturing ourselves for building aircraft in India," he told PTI in an interview.

Union minister V Somanna flags off Tirupati-Sainagar Shirdi Express

New Delhi, Dec 9: Union Minister of State for Railways and Jal Shakti, V Somanna flagged off the Tirupati-Sainagar Shirdi Express through video conferencing from Rail Bhawan, New Delhi, Tuesday.

Victims' families struggle to come to terms with grief

New Delhi, Dec 9: Clocks have ticked, days have passed but grief sits in homes of Red Fort blast victims like dust that refuses to lift.

What looked like a single violent moment has unfolded into an entire month of numbness -- of unanswered questions, hollow rooms, and lives permanently scarred.

Among those killed was Amar Kataria, a pharmaceutical businessman who worked in Chandni Chowk's Bhagirath Palace.

That evening, Kataria stepped out after finishing work, unaware that within minutes the world he had built

will fall apart. In the first days

after the tragedy, his threeyear-old son kept running to the door at every tiny sound. "He used to turn around ev-

ery time someone walked past, Amar's relative Swadesh Sethi had said. "You could see he thought his

father was coming." A month later, the child's confusion has not eased but has simply changed shape. While he no longer waits by

the door, he still does not know that his father will never return. He thinks he is out somewhere and will return soon. Inside the Kataria home,

Amar's wife Kriti has barely spoken since that fateful night.



Sharjeel Imam seeks bail in SC

Interpol Blue Notice issued against owners

New Delhi/Panaji, Dec 9: The Interpol has issued a Blue Notice against Saurabh and Gauray Luthra, the owners of a Goa nightclub, who are believed to have fled to Thailand just hours after a Saturday blaze claimed 25 lives, while the Goa Police put out a Look Out Circular against another set of owners.

The LOC was issued against Ajay Gupta and Surinder Kumar Khosla, a British citizen, Deputy Inspector General (DIG) of Police Varsha Sharma told reporters.

Saurabh Luthra and Gauray Luthra, the two primary owners of the nightclub, are believed to have fled to Phuket in Thailand following the Saturday night tragedy at 'Birch by Romeo Lane' nightclub in Arpora.

Two days after the horrific tragedy, state authorities Tuesday demolished a beach shack illegally constructed by the Luthras in Vagator area, and appointed a fire safety audit panel for tourist establishments.

The Goa Chief Minister's office said that an Interpol Blue Corner Notice, meant to gather information about the accused, has been issued against the Luthras.

"A Look Out Circular (LOC) was issued against another set of owners of the nightclub. Ajav Gupta and UK citizen Surinder Kumar Khosla, hours after the Luthras fled," said Deputy Inspector General (DIG) of Police Varsha Sharma.

"All attempts are being made to get the Luthra brothers back to India...they were not in Goa at the time of the incident," she added. Then Director of Pan-

chayat Siddhi Halarnkar and then Goa State Pollution Control Board Member Secretary Shamila Monteiro have been asked to join the investigation, the DIG said.

The Goa Tourism Department demolished 'Romeo Lane', a beach shack illegally constructed at Vagator by the Luthras, on the directive of Chief Minister Pramod Sawant, and reclaimed the 198 sqmt of land.

The structure, made of wood, was razed using machines, a senior official said, adding the

demolition was carried out within two hours in the presence of police.

Police have so far arrested five persons -- the nightclub's chief general manager Rajiv Modak, general manager Vivek Singh, bar manager Rajiv Singhania, gate manager Rivanshu Thakur and employee Bharat Kohli.

Kohli, a resident of Delhi. was allegedly responsible for overseeing the daily operations of the nightclub and was arrested in the national capital.

With the investigation brought to the fore several violations at the nightclub, Pradeep Ghadi Amonkar, the original landowner, claimed he had fought a legal battle for 20 years against Khosla. alleging persistent illegalities on the property.

Talking to PTI, Amonkar said he had purchased two plots of land in Arpora village in 1994 and signed an agreement for sale with Surinder Kumar Khosla in 2004, but it was withdrawn within six months as the latter failed to pay the money.

Belgium SC rejects **Mehul Choksi's appeal** against extradition

New Delhi, Dec 9: Belgium's supreme court -- the Court of Cassation -- Tuesday rejected the appeal of fugitive diamond trader Mehul Choksi challenging the extradition request of India in connection with the ₹13000-crore alleged bank fraud in Punjab National Bank, authorities in that country said.

Choksi, who escaped to Antigua and Barbuda in January 2018, days before the scam was detected, was spotted in Belgium, where he had purportedly sought treatment. India had sent an extradition request to Belgium August 27, 2024, based on arrest warrants issued by a special court in Mumbai.

Responding to PTI, Spokesperson for Court of Cassation, Advocaat-generaal Vanderlinden, said, "The Court of Cassation rejected the appeal. So, the decision of the Court of Appeal stands." The process of his extradition will begin now, officials said

A four-member indictment chamber at the Court of Appeals in Antwerp did not find any infirmity in the orders issued by the pre-trial chamber of the district court November 29, 2024, terming the arrest warrants issued by the Mumbai special court in May 2018 and June 2021 as "enforceable", allowing Choksi's extradition.

The Court of Appeals had ruled that Choksi, the main accused in a ₹13,000 crore PNB scam, faces "no risk" of being denied a fair trial or subjected to ill-treatment if he is extradited to India. The Court of Cassa tion only checks the decision of the court of appeal "on legal aspects" such as whether the court of appeal correctly applied the legal dispositions. and whether they follow the right procedure, Vanderlinden had said in response to PTI questions last month.

Top court quashes HC order on revenue map correction

New Delhi, Dec 9: The Supreme Court Tuesday stressed that any unnecessary remand of a matter for fresh consideration by a higher court should be avoided as it generates fresh round of litigation.

The idea is to curtail the litigation and not generate it, a bench of Justices Raiesh Bindal and Manmohan said, as it set aside an order of the Allahabad High Court, which had remanded back a matter -- related to authorities rejecting a man's application for correction of a revenue map -- for fresh consideration after hearing all parties

While dealing with the appeal, the top court noted that court had taken the wrong premise and interpretation of Section 30 of the Uttar Pradesh Revenue Code, 2006, which deals with maintenance of map and the field book. The bench said this could have generated unnecessary further litigation.

"We may also add that earlier view by this court was that in case there were violations of principles of natural justice. the matter was to be remanded for affording opportunity of hearing to the party concerned. However, with the passage of time, the view changed," the bench said. It further said, "The idea is

to curtail the litigation and not generate it. Any unnecessary remand by a higher court generates fresh round of litigation, which should be avoided."

Initially, the application filed before the collector seeking correction of map for a plot was dismissed. Later, the Additional Commissioner also dismissed the appeal against the collector's order. After around 17 years, again an application was filed seeking correction of revenue map but the same



was rejected by the concerned authority.

The matter had then reached the high court which remanded the issue for fresh consideration after affording due opportunity of hearing to all concerned.

Referring to Section 30 of the Code, the apex court bench noted the collector is duty-bound to maintain, in the manner prescribed, a map and a field book for each village and any changes made in it have to be recorded annually or after such longer intervals as may be pre-

It said after the purchase of the land, an effort made by the private respondents to get the revenue map corrected had failed and they could not be permitted to raise the same issue after a gap of over 17 years

The bench said it was not a case where any error was found in the revenue record which deserved correction under Sec tion 30 of the Code.

While allowing the appeal the bench set aside the order passed by the high court.

New Delhi, Dec 9: 2025 is currently tied with 2023 to be the second-warmest year on record, according to new data published by Europe's climate agency Copernicus.

Copernicus Climate Change Service (C3S) said the year is virtually certain to end as the second- or third-warmest ever recorded, behind 2024. C3S said the global average

temperature anomaly for January to November 2025 stands at 0.60 degree Celsius above the 1991-2020 average or 1.48 degree Celsius above the 1850-1900 pre-industrial level.

The agency also said November 2025 was the third-warmest November globally.

The month saw warmer-than-average temperatures across northern Canada and the Arctic Ocean, along with several extreme weath-

er events, including tropical cyclones in Southeast Asia that caused widespread and catastrophic flooding and loss of life. "For November, global temperatures were 1.54 degrees Celsius above pre-industrial levels and the threeyear average for 2023-2025 is on track to exceed 1.5 degrees

US, Mexico to meet today

Mexico City: Mexican President Claudia Sheinbaum said Tuesday she expects to reach an agreement with the United States over a water dispute as Mexican officials will meet with their US counterparts later in the day. US President **Donald Trump Monday accused** Mexico of violating a treaty that outlines water sharing between the neighbors and threatened to impose an additional 5% tariff on goods from Mexico if it doesn't immediately provide additional water. Sheinbaum said during her morning press conference that Mexico is limited in delivering more water by the country's own needs under the treaty and by the size of the pipeline carrying water to Rio Grande, which she described as a physical constraint.

Border battle expands

Thailand, Cambodia clash for second day

Bangkok/Phnom Penh. Dec 9: A fierce border battle between Thailand and Cambodia raged for a second day and spread to new fronts Tuesday, as both countries accused each other of shelling civilian areas and Bangkok vowed to push on with its planned military operations.

With the neighbours trading blame for starting Monday's renewed clashes, it was unclear how or if a fragile ceasefire brokered by US President Donald Trump in July could be salvaged. Thailand's military said its

tanks fired shells into a border casino complex being used by Cambodia's army as a firing position and weapons storage area, while fighter jets conducted air strikes for a second day on what the air force said were strategic military targets.

Cambodia's defence ministry said its troops had no choice but to take defensive action Tuesday and accused Thailand of "indiscriminately and brutally targeting civilian residential areas" with artillery shells, allegations Bangkok rejected.

'WE CAN'T STOP NOW,' SAYS THAI PM

Thai Prime Minister Anutin Charnvirakul ruled out dialogue and said the military had a plan that it would carry

The fighting is the most intense since a five-day exchange of rockets and heavy artillery in July that marked their heaviest clashes in recent history, when at least 48 people were killed and 300,000 displaced before Trump intervened to broker a ceasefire.

Tensions have simmered since Thailand last month suspended de-escalation measures agreed at a summit and overseen by Trump, which included withdrawing troops and heavy weapons, after a Thai soldier was maimed by a landmine that Bangkok said Cambodia had recently laid. Phnom Penh rejects the allegation.

FIGHTING ON NEW FRONTS

It is unclear what triggered the latest round of hostilities and the prospects of resolution appeared dim Tuesday, with both countries vowing to fight on and defend their sovereignty.

India should not be dumping rice into US market: Trump

New York/Washington, Dec 9: US President Donald Trump has said that India should not be 'dumping" rice into the United States market and he will "take care" of it, while stressing that tariffs will solve the "problem" easily. Trump held a roundtable in the White House Monday with representatives of the farming and agriculture sector as well as key members of his cabinet, including Treasury Secretary Scott Bessent and Agriculture Secretary Brooke Rollins.

He announced \$12 billion in federal aid for farmers.

Meryl Kennedy, who runs her family's agribusiness Kennedy Rice Mill in Louisiana, told Trump that rice producers in the southern part of the country are "really struggling" and that other nations are "dumping" rice into the US.

When asked by Trump which countries are dumping rice into America, Kennedy, sitting next to the President, replied, "India, and Thailand: even China into Puerto Rico. Puerto Rico used to be one of the largest markets for US rice. We haven't shipped rice into Puerto Rico in years."

Kennedy said that this has been happening for years and did not start during the Trump administration. "But unfortunately, we're seeing it in a much bigger way now," she said.



She said that tariffs imposed by the Trump administration are working, "but we need to double down", to which Trump said, "You want more, I understand"

Trump then turned to Bessent and said, "India, tell me about India. Why is India allowed to do that? They have to pay tariffs. Do they have an exemption on rice?" "No sir, we're still work ing on their trade deal," Bessent replied. Trump then said, "But they shouldn't be dumping. mean, I heard that. I heard that from others. They can't do that.'

Kennedy then told Trump there's a World Trade Organisation case against India.

Trump asked Kennedy to give him the names of the countries dumping rice into the US and instructed Bessent to note down the names. "India. Who else?" Trump said. "India, Thailand, China into Puerto Rico, not into the continental US, but into Puerto Rico. Those are the main culprits," Kennedy said, adding that American farmers can feed the US as well as nations around the world, but "we need fair trade, not free trade".

Fire rips through seven-storey building in Jakarta, killing 22

Japan assesses damage from 7.5 magnitude quake that hurt 34

Tokyo, Dec 9: Japan was assessing damage Tuesday and cautioning people of potential aftershocks after a late-night 7.5 magnitude earthquake caused injuries. light damage and a tsunami in Pacific coastal communities.

At least 34 people were injured, one seriously, the Fire and Disaster Management Agency said. Most of them were hit by falling objects, public

broadcaster NHK reported. Prime Minister Sanae Takaichi told reporters an emergency task force was formed to urgently assess damage. "We are putting people's lives first and doing everything we can," she said.

At a parliamentary session Tuesday, Takaichi pledged the government would continue its utmost effort and reminded people they have to protect

their own lives.

The 7.5 magnitude quake struck around 11:15 pm in the Pacific Ocean, around 80 kilometres (50 miles) off the coast of Aomori, the northernmost prefecture of Japan's main Honshu island. The US Geological Survey measured the quake at 7.6 magnitude and said it occurred 44 kilometres (27 miles) below the surface.

Lithuania declares state of emergency

Vilnius, Dec 9: Lithuania Tuesday declared a state of emergency and asked parliament to authorise military support for police and border guards after a wave of smuggle balloons from Belarus repeat edly disrupted air traffic in recent months. Vilnius airport has been closed several times due to the weather balloons which Lithuania says are sent by smugglers transporting cigarettes and constitute a "hybrid attack" by Belarus, a close ally of Russia. "The state of emergency is announced not only due to civil aviation disrup tions but also due to interests of national security," Interior Minister Vladislav Kondratovic told a government meeting broadcast live Tuesday.

Belarus has denied responsibility for the balloons and accused Lithuania of provocations, including sending a drone to drop "extremist mate

now offer services across civil aircraft maintenance, general aviation MRO, defence MRO and complete flight training under one umbrella. India's airlines are expected

to add more than 1,500 aircraft in the coming years. This will sharply increase the need for certified pilots. At the same time, the government's push for advanced defence training and mission rehearsal is creating fresh opportunities in military simulation and training services.

By boosting training capacity and improving simulation-based skill development (both civil and defence), the Adani-FSTC deal could help address pilot scarcity — potentially reducing future risks like those faced by IndiGo.

The deal may benefit the entire aviation sector in medium to long-term — but it doesn't directly fix the immediate restrule exemption or safety concerns raised by pilot-fatigue and staffing shortages.

Microsoft to invest \$17.5 billion in India

New Delhi, Dec 9: Microsoft CEO Satya Nadella Tuesday announced plans to invest \$17.5 billion in India to help build infrastructure and sov ereign capabilities for the country's AI-first future, mark ing the third major AI-driven investment in the country in the past two months.

Microsoft said that the \$17.5 billion (around ₹1.58 lakh crore) investment builds on the \$3 billion (around ₹26,955 crore) funding announced ear lier this year, which the company is on track to spend by the end of CY (calendar year)

"To support the country's ambitions, Microsoft is committing \$17.5B—our largest investment ever in Asia—to help build the infrastructure skills, and sovereign capabil ities needed for India's AI-first future," Nadella said on X after meeting Prime Minister Nar endra Modi.

Microsoft, in a statement said it plans to invest \$17.5 billion in India over the next four years (2026-2029) to drive AI diffusion at a population The announcement follows

Nadella's meeting with Modi, ahead of the Microsoft India AI tour. "In their meeting, both leaders discussed the country's AI roadmap and growth prior ities," Microsoft said. Microsoft's funding com-

mitment is the third major AI-driven investment announced in the country in the past two months.

On October 14, Google an nounced plans to invest \$15 billion over the next five years to set up an AI hub in India, which will include the country's largest data centre in partnership with Adani Group. It was followed by a \$11 billion investment plan announced by Digital Connex ion-- a joint venture between Brookfield, Reliance Indus tries and US-based Digital Realty.

Mumbai, Dec 9: Indian equity benchmarks fell for a second straight session Tuesday, led by information technology stocks, as caution ahead of the Federal Reserve's rate decision and lingering uncertainty over a US trade deal weighed on sentiment.

The Nifty 50 fell 0.47% to 25,839.65 and the BSE Sensex lost 0.51% to 84.666.28. Both indexes have lost about 1.2% so far this week and sit nearly 1.8% away from the lifetime highs hit early this month. 'Failure of the market to

hold on to the recent all-time high and absence of fresh triggers for a rally have resulted in some sort of fatigue among investors," said VK Vijayakumar, chief investment strategist at Geojit Investments.

IT firms which earn a significant share of revenue from the US, lost 1.2% as the focus shifted to the Fed's meeting later in the day.

Eleven of the 16 major sectors logged losses. The broader small-caps and mid-caps added 1.1% and 0.3%, respectively, following sharp losses Monday.

While the Fed is expected to cut rates Wednesday, Wall Street banks have pencilled in fewer reductions for 2026 amid lingering inflation concerns and expectations of a more resilient US economy.

Higher US interest rates typically support the dollar and lift Treasury yields, making emerging-market equities less attractive to foreign portfolio

Pandya, bowlers light up Barabati

Ace all-rounder's blistering fifty, ruthless bowling hand South Africa historic defeat

Cuttack, Dec 9: Hardik Pandya made a memorable comeback to competitive cricket, striking a mood-lifting unbeaten fifty and then took a key wicket as India etched a dominant 101-run win over South Africa in the opening match of the five-match series here Tuesday.

The victory helped India take a 1-0 lead in the rubber and it also pushed South Africa to their lowest-ever T20I total. Their previous lowest was also against India -- 87 all out in Rajkot in 2022

India had been pushed onto

the back-foot after SA asked them to bat first on a tacky red-soil surface, but Pandya's commanding 59 not out off 28 balls rescued them from early turbulence. India posted a competitive 175/6.

On a pitch that demanded discipline, South Africa showed none, to be all out for a mere 74 in 12.3 overs, as the hosts' bowlers ran through them with relentless accuracy.

Arshdeep Singh, Jasprit Bumrah, Varun Chakravarthy and Axar Patel grabbed two wickets each, while Pandya fittingly chipped in with the prized scalp of David Miller.

It was also South Africa's first defeat in three T20Is in Cuttack, and if India had started shakily, South Africa began disastrously.

Arshdeep set the tone with a superb away-swinger that kissed past Quinton de Kock's tentative prod for a two-ball

In his next over, Arshdeep produced another beauty -- a length ball that jagged back into the in-form Tristan Stubbs (14).

Aiden Markram, shuffling back to work a skiddy, straight delivery, was beaten on the inside edge to get bowled. At 28/3 in six overs. South Africa were

already in a hole. Pandya then added to their misery, dismiss-

ing Miller.

Marco Jansen, who had fielded brilliantly earlier, was undone by Chakravarthy's googly as South Africa slid to 68/6. The end arrived quickly thereafter with Bumrah cleaning up Dewald Brevis and Keshav Maharaj in the space of four deliveries.

Earlier, coming back after 74days following a left quadricep injury that forced him out of the Asia Cup, Pandya walked in at No 6 and immediately changed the tempo of the match.
